#### **Over 300 Vehicles Stuck On Banihal Highway**

**JAMMU:** A massive landslide blocked the strategic 270km Jammu-Srinagar national highway in Udhampur district early Monday, leaving hundreds of vehicles stranded, officials said.

The landslide struck the highway, the only all-weather road linking Kashmir with the rest of the country, at Dewal near Samroli around 2.45 am, the officials said.

Senior Superintendent of Police, traffic (national highway), Shabir Ahmad Malik said road clearance agencies have pressed men and machinery and efforts are on to make the highway traffic worthy.

'No fresh traffic was allowed either from Jammu or Srinagar this morning in view of the closure of the highway, he said, adding over 300 Jammu-bound trucks and some passenger vehicles were left stranded due to the closure of the highway.

#### WAR IN UKRAINE Stranded Kashmiri Students Make Frantic Calls For Evacuation

#### 'If This War Doesn't Kill Us, I'm Sure We'll Die Of Hunger'

SRINAGAR: Hundreds of Kashmiri students stranded in the war-torn Ukraine and at the surrounding borders are consistently sending frantic messages to the Government and the Indian embassy in the neighbouring countries, urging them for evacuation without any further delay as "staying in the turbulent country is turning fatally risky with each passing minute". Most of these students are stranded in three major cities of Ukraine including Kharkiv and Kviv–two of those main regions where the Russian forces first moved in after the war broke out as they are closer to the Russian border.

Notably, India has evacuated hundreds of students since Russia started its military operation last week. The students who had managed to cross the border into Romania and Hungary were shifted on a special evacuation flight that was arranged by the Indian government.

Pertinently, majority of those

evacuated students were from Ukraine's western and south western parts which are comparatively peaceful in comparison to Ukraine's east. It is here in the three main cities-Sumy, Kharkiv and the capital city, Kyiv, where the majority of Kashmiri students are stranded either in their apartments or in underground shelters.

As per reports, the first special evacuation flight had lifted 219

stranded Indian students who had made it to Romanian capital Bucharest. The second flight carrying 250 students had arrived in New Delhi on Sunday afternoon from Romania. Many other students who had managed to reach Hungary border mostly by walking, are being evacuated through Hungarian capital Budapest.

"The Indian embassy has issued an advisory claiming that the curfew has been lifted and asking us to leave and reach the border in either Hungary, Romania, Poland or Moldova." Shahid Habib told Kashmir Observer over a phone call from Kharkiv, the theatre of fierce fighting. "But what the embassy isn't

telling people is that we've to cross either through Kyiv or Sumy to reach the border, that too, by walking as no cab is available here. More on P6

# How to Stop Overthinking Everything: 5 **Expert Strategies to Calm Your Mind**

e all ruminate sometimes. But if you're still kicking yourself because your kid caught COVID at a family gathering last year or replaying that awkward Zoom meeting on a loop in your brain, you're trapping yourself in your own head which can be exhausting and harmful for your mental health. Overthinking is a common trap to fall into, and there are ways to break the habit.

Overthinking is closely connected to unhappiness. Yale psychologist Susan Nolen-Hoeksema famously linked rumination, the clinical term for overthinking, to depression. Unlike concern or even worry, which can lead us toward productive action, overthinking is circular, an endless cycle of chewing over what's already happened, from small social missteps to lifechanging choices.

Now, it's important to further understand the distinction between overthinking and worrying. "Worrying is helpful when it can lead to an action that will actually reduce risk in some way," explains Katie Gordon, Ph.D., a licensed clinical psychologist who specializes in cognitive-behavioral therapy and author of The Suicidal Thoughts Workbook. A parent who is worried about a proposal to lift a mask mandate at their child's school, for example, may feel motivated to speak out at a school board meeting.

But if you're kind of repeating thoughts over and over again once you've done those things in your control and you find that it's amplifying the anxiety without leading to a helpful action, then that, per Gordon, can be an indication that its rumination.

Signs that you've crossed the line from productive concern to troublesome overthinking include sleeplessness and disruptions in your relationship, according to Alice Boyes, Ph.D., a former therapist and author of The Anxiety Toolkit:



Strategies for Fine-Tuning Your Mind and Moving Past Your Stuck Points. If you're thinking yourself in circles instead of sleeping, it might be time to consider some changes. The same is true for irritability. If, per Boyes, "you're finding that you're getting irritable with people because you've got this second level of stress that's making your fuse shorter," then it's worth taking some steps. So if you are stuck in a cycle of overthinking, what can you do to break the habit? Here are a few straightforward strategies to con-

#### 1. Go easy on yourself

Adopting the habit of self-compassion, or treating yourself with the same empathy that most of us would naturally offer to someone else in distress, is one way to beat rumination. "It's basically acknowledging what you're feeling, not pushing it away, not making it bigger or smaller," said Boyes. 'It's naming the specific emotions that you're feeling, like feeling anxious or feeling embarrassed or guilty."When you reflect on your feelings, remember that how you're feeling is human and that all people experience the same kinds of feelings.'

Rumination is being stuck in your head, and by helping you connect with others, self-compassion, helps you escape.

Psychologist Kristin Neff, who studies self-compassion, acknowledges that people are often reluctant to treat themselves empathetically. She suggests taking a self-compassion break when you feel pain or other emotional turmoil. Pause for as little as two minutes, speak to yourself with kind words, place your hands over your heart, and remember that even if you feel alone, you aren't.

#### 2. Hey, look over there! Distraction is an excellent way to

get back on track when you find yourself overthinking. Practice a new song on an instrument. Cook a new recipe. It's best to try something new when you're trying to distract yourself, as it will demand more of your focus and keep you out of your head. "If you're an experienced knitter, you can do that and ruminate at the same time," Boyes warned. "But if you're never knitted before, and you are watching a video and trying to knit along, then it is a good cognitive distraction.'

#### 3. Embrace "worry time" The concept of worry time is one

tool used in cognitive behavioral therapy to help people manage overthinking. To try it, set aside 10-20 minutes a day. Per Gordon,

you want to tell yourself that's the time you're going to let your mind just go and think about whatever is causing you to overthink. The trick is to then do your best to confine your rumination to the time you've set aside. "Any other time during the day when I start thinking about it, I'm going to just gently remind myself that I have a time aside time later," she says. Though this technique may sound overly simplistic, it does seem to help. "You're not telling your mind, just push away the thoughts," she says. "You're just kind of saying, I'm going to ad-dress that later."

#### 4. Acknowledge your lack of control

Rumination, according to Gordon, is one of the most common reasons why people see a therapist. Interestingly enough, she thinks the pandemic may have helped some of her patients with their overthinking tendency because the ongoing uncertainty of the past two years has forced us to acknowledge that we have limited control over our circumstances. That acknowledgment means we spend less time agonizing over choices we have already made. This far into the pandemic, we understand that we are doing the best we can with the - often imperfect – information at hand.

Gordon suggested a strategy from the therapist Dr. Russ Harris, author of The Happiness Trap. "Identify what's in your control, what are your values, and the actions that best align with that,' Gordon explained. "And then it's cultivating acceptance that you can't know for sure what the best action was."

Accepting a lack of control is hard, per Gordon, particularly for parents who have had to make big decisions under less-than-ideal circumstances throughout the pandemic. No one wants to say "I took all the information I had, and I'm going to have to make my best guess," she noted, especially when we're thinking about our kids. Nevertheless, "we don't know for sure what's going to be the best thing."

"That acceptance," she added, "can be a meaningful lesson."

#### 5. Consider seeking therapy

When Boyes was a practicing therapist, she started sessions with a new client by asking them how long they'd been experiencing their issues before they sought therapy. "It was almost always years," she said. "The general pattern is for people to wait far, far too long." If you are thinking about going to therapy, that's a good sign that you should go to therapy, Boyes added.

People tend to think of therapy as a long-term commitment, Boyes said, but it doesn't have to be a months- or years-long process. "There is a type of therapy they call single-session cognitive behavioral therapy, which is just based on a single session." People can use the session to make a plan to tackle overthinking and consider coming back in a month or so to talk about how the plan is working or how it needs to be tweaked. The toe-dipping is certainly something to consider. A benefit to using these strategies

for combating overthinking, Boyes added, is that your child gets to see you working through some challenging situations and emotions. And that will help your kids develop these essential skills, too.





From KO Archives **Distress Power Cut** As GT Supply Stops

RINAGAR Barely a few hours after the power development department PDD finalised revised curtailment schedule for the valley assuring around 12 hour power supply, authorities gave it an quit burial this evening. Even after the power minister, S S Slathia, directed continued 4-hour daily (7 pm to 11 pm) operation of gas turbines to improve power availability, the 5-unit Pampore turbines screeched to an abrupt halt following orders from above.

According to reports authorities were forced to resort to 'distress load shedding of ru¬ral areas to enable maintain¬ing minimum supply to the city and some major towns besides the essential services. The 'revised' programme is to be further revised in keeping with the

reduced availability ordered by the power managers in Jammu. Reports said the revised schedule, drawn up for 10 days. February 26 to March 7 had been worked out on the premise that about 100 megawatts of power would be available in ad-dition to that imported from northern grid and local genera tion. The valley was divided into two groups. A and B. Calculat-ing a net availability of 430 mw to 460 mw, the revised schedule on even 'odd basis envisaged a fairly improved supply position.

Meanwhile, according to sources, the power generation from Uri project had improved over the past few days following a marginal rise in the water level of the river. From a meagre 50 mw, it shot up to 140 mw on Saturday and Sunday. Even to-day, it hovered around 120 mw. The generation from the Lower Jhelum hydel project and other stations had also gone up ap¬preciably.

Contrary to governments claims of heavy dependence on im-ports from the northern grid, and even the common belief, sources said, the valley exported 40 mw of power to northern grid for a brief while on Saturday and Sunday However, the PDD preferred to keep

a tight lid over the report to avoid any embarrassment On Saturday, the power minister had himself told Kashmir Observer that uni¬form supply would be ensured between rural and urban areas of the valley with the avail¬ability of 200 mw to 230 mw from northern grid. He had assured supply for nine hours on an average However, he okayed a further improvement to make it about 12 hours in 24 hours for which he ordered continued operation of (.he gas turbine.

Interestingly, the official handout issued after Slathia's Pampore visit yesterday boastfully screamed, "gas turbine in opera-tion despite whop¬ping daily expenditure". Reminis¬cent of Mirza Galib's famous cou¬plet ke merey qail ke baad us my jafa se tauba / hai us zood pashaiman ka pashaiman hona," he (Slathia) expressed regrets on the inconvenience faced by the people in the valley due to blast¬ing of the transmission towers.

Now that the 'generosity' has been unceremoniously withdrawn the minister's (read government's) regret has proved to be shock ingly short-lived

Even as, in the absence of permanent restoration, the 220-K V and 132-KV transmission lines may prove to be too fragile, like a slender thread, to ensure sustained import of power, a question mark will continue to hang over the state government's role in ensuring an equitable distribution of electricity between Kashmir and Jammu

# The Stakes In Ukraine

our days after it began, the war in Ukraine looks nowhere closer to any resolution. Parties to the conflict - Russia on one side and NATO on the other - are in no mood to back down. Russia is unlikely to withdraw until it has achieved its strategic objectives. And which are to stop Ukraine from becoming a part of the western sphere of influence by joining NATO. The US and the European Union, on the other hand, have asked Russia to withdraw from Ukraine. They have also imposed severe economic sanctions on Kremlin. But immediately the sanctions are going to make little difference to Russia's pursuit of its military and strategic objectives. The war thus looks set to drag on for some time unless better sense prevails on all the parties including Ukraine and they see reason in negotiating their way out of the problem.

In a positive development, Russia and Ukraine have agreed to hold talks. However, Ukrainian President Volodymyr Zelenskyy has rejected Belarus as a venue for talks saying the country is a party to the Russian invasion of Ukraine. He has named Warsaw, Bratislava, Istanbul, Budapest or Baku as alternative locations. But wherever the talks are eventually held, they could offer a way out of the current crisis, provided both sides are able to hammer out a compromise. But the positions of Russia and west-backed Ukraine have become so irreconcilable over the years that it looks highly unlikely that a solution is imminent.

The situation, meanwhile, is becoming fraught. Russian troops have already entered Kharkiv in Ukraine's secondlargest city. Its aim seems to be to dislodge the current Ukrainian government and install a Russia-friendly government. Russia's objectives are unlikely to stop there. It also wants gauantees from NATO to stop its eastward expansion and NATO is unlikely to do so. This makes the situation very complicated and not amenable to an early solution. More so, when the west has already put economic sanctions on Russia and contemplating more of them.

At the larger level, the war has become a great power battle royale. America faces one of its severest tests as the world's sole superpower. Some western experts have already written the epitaph of America's unipolar moment. In that sense, it would be interesting to see who blinks first in this great power war of nerves. And that could decide the new super power of the world. But America, despite its recent setback in Afghanistan, its failure to have its way in Syria in the teeth of the opposition from Russia and Iran, remains the world's No 1 power. Its GDP and defence expenditure remains several times higher than its nearest competitor China. But in Ukraine we are at an interesting moment in history. The outcome of the war will determine the new global geopolitics if not the new super power of the world.

# From Barren Land To Thick Jungle

# Success story of Community Forest Management by Korku Tribe of Maharashtra

ast several days have been very hectic for me. I along with some colleagues including Chairman District Development Council Budgam Nazir Ahmad Khan are on a visit to Maharashra's Vidarbha region to see the best practices on community based forest management. The Community Forest Management (CFM) has turned out to be a powerful approach in the management of forests across the globe. During the last few decades, the community based forest conservation methods have received a lot of international appreciation as there are a large number of success stories with regard to it. In response to some of the adverse effects of state forestry and commercial timber production, the community forest management (CFM) improves local livelihoods and helps to conserve forests as well. International organizations like the UN, donors NGOs, and governments are the great advocates of CFM. The idea of enacting the Forest Rights Act in 2006 by the Indian parliament was to accept the fact that without community involvement the forests cannot be conserved or protected. Our Govt's have spent huge funds for fencing of forests but in spite of doing all that we have not been able to get the desired results.

In 2012, Payvihir which is a small tribal village with mere 600 population under Upatkheda panchayat in Amravati district of Maharashtra was awarded 182 hectares (3600 kanals approx) of degraded land to exercise its community forest rights under the Forest Rights Act (FRA) 2006. Along with Payvihir, the adjoining villages of Upatkheda, Jamda and Khadijapur also got the community forest rights (CFR) under Forest Rights Act (FRA). All these villages are inhabited mostly by Korkus which is a tribal community found around Amravati and some parts of Chhattisgarh and Madhya Pradesh. A Non-Governmental Organisation (NGO) Khoj played a great role to create awareness about Forest Rights Act and other rights based legislations among the residents of Payvihir and adjoining villages in 2009 -2010. As the locals became aware of their rights, the tribal Jaati Panchayat also called Chawdi got involved in this activism. Within 3 to 4 years, the Govt was forced to hand over a huge chunk of forest land to the local Gram Sabha under the Community Forest Rights-CFR. In only Payvihir hamlet, 182 hectares of barren forest land was handed over to local gram sabha in 2013. Within 3 to 4 years under joint forest management (JFM) programme and convergence with schemes like MG-NREGA more than 30,000 trees were planted on this 182 hectares of forest land. The solar based tube wells were also provided under the JFM programme by the Govt to locals and in the last 5 to 6 years the entire area has seen a huge transformation. The barren land has now turned into a full fledged forest with the help of the Forest Rights Act.

undertook a lot of afforestation programmes by convergence with MG-NREGA. A small lake in Upatkheda which had a good number of fish in it was also handed over to local gram sabha after a long fight with the private firm that was earning profit from it through fishing. The firm was giving some lease amount to Maharashtra Fisheries Department and the local community used to get nothing. Uttam Shanware, a local resident and former Sarpanch of Upatkheda had to fight a long battle for it and he was even arrested by police for raising his voice against the private company. At the end, the fishing rights were given to the community and from the last 3 years the income generated from fishing goes to local gram sabha. The lake is now surrounded by thick forest managed by the local Korku tribe community.

#### CFR Titles in Ranpur

Last year in November, I visited Odisha where a dozen villages in Ranpur block of Nayagarh district received around fourteen (14) community forest right (CFR) titles. The villagers also received the same number of community forest resource right (CFRR) titles as well. During that visit also Chairman DDC Budgam had also been invited to participate in the event that was held in a remote forest village of Surkabadi in district Nayagarh which is around 100 kms from Odisha's capital city of Bubaneshwar.

The event was more like a festival as this was a historic day for the residents of two dozen villages. Hundreds of men , women , children wearing traditional colourful clothes had assembled in an open field as early as 9 am on Nov 22nd , the day when people were supposed to get the title. The actual event started in the afternoon, but

est dwellers (OTFD) as well. In the past the titles were mostly conferred on scheduled tribes (ST's) in India but due to local community mobilization by civil society groups all this was possible. The community rights conferred on the 24 villagers which includes joint title for a group of villages to collect and use the firewood and household implements within and outside traditional boundary. The villagers have the right to collect, process, use and sell minor forest produce, such as bamboo, kendu leaves (making beedis), tubers, green leaves etc. The villagers are allowed to undertake value addition, storage and transportation of the products. The rights on the water bodies along with fishing and grazing rights have also been given to the 24 villages. This was not the case in the past. Many villagers would be sent to jail as the forest department would invoke various sections under the Indian Forest Act of 1927.

#### **Community Management**

Under the Forest Rights Act the local Gram Sabha are empowered to protect and conserve or even manage the forests or forest resources. The act gives the local communities like forest dwelling scheduled tribes or other traditional forest dwellers (OTFDs) the rights to protect and preserve the forest's biodiversity and wildlife as well. The section 5 of the Forest Rights Act 2006 reads

"That holders of any forest right, Gram Sabha and village level institutions in areas where there are holders of any forest right under this Act are empowered to - (a) protect the wild life, forest and biodiversity; (b) ensure that adjoining catchments area, water sources and other ecological sensitive areas are adequately pro-

# The Abstention

ndia's abstention on the United Nations Security Council draft resolution "deploring in the strongest terms" Russia's invasion of Ukraine was in continuation of its balancing act on the crisis since the escalation began in January, keeping in mind its own interests, strategic imperatives and partnerships on both sides of the conflict. It was a foregone conclusion that Russia would use its veto against this resolution. Still, the vote on the draft offered India the opportunity to articulate in clear and strong terms its position on the issue — that there should be no messing with territorial integrity of states, and that the UN Charter and international law are sacrosanct — without taking sides despite pressures from both sides to do so. The tempering of the draft resolution over 24 hours from "condemnation" to "deploring", and the replacement of Chapter VII that authorises the Security Council to take measures including the use of force with Chapter VI that speaks of a peaceful resolution showed that nuance is everything in international realpolitik. India omitted reference to "legitimate security interests", a phrase that appeared in its previous formulations at the UNSC, giving them a pro-Russia tilt. Ukrainian President Vlodomyr Zelenskyy's appeal to Prime Minister Narendra Modi, hours after the vote in the Security Council, for political support in the UN to "stop the aggressor", helped Delhi further sharpen its position, conveying anguish at the loss of lives, reiterating the demand for a cessation of hostilities and a return to dialogue, and significantly, expressing a willingness "to contribute in any way towards peace efforts"

For sure, none of these statements and positions, whether in phone calls or at the Security Council horse-shoe, are etched in stone. The Ukraine crisis is developing by the minute, and Delhi will need to review its position accordingly. The Ukrainian president, who was hardly believed to be the right fit for high national office, is clearly a hero, one who knows how to use social media. Using these platforms to great effect, he has singlehandedly marshalled the sympathy of people around the world in this David vs Goliath battle, inviting comparisons with how just a few months ago, the Afghan President upped and left the people of his country to deal with the Taliban on their own. Stories of brave Ukrainians taking on Russian soldiers has underlined how international law counts for nothing when weak countries are up against powerful nations. Casualties are bound to rise. As it fine-tunes its position, India will have to factor all this, particularly Russian President Vladimir Putin's international isolation and his loss of moral high ground as a "victim" of NATO's machinations. Even Putin's fast friend China, which has its own territory problems, spoke about "territorial integrity" and abstained from the vote, even while nodding in the direction of Russia's legitimate security interests. And Germany, India's ally and an ever-reluctant power, is coming out of its long European cold to turn the heat on.

#### Intervention of NGO Khoj

Due to the efforts of Purnima Upadhyay the founder of Khoj, the gram panchayat of Upatkheda especially the local youth fully got involved with FRA activism which led to revival of the local forest biodiversity. The 182 hectares of forest land that was handed over to the local gram sabha of three hamlets under Upatkheda panchayat is now visited for different species of birds. I witnessed this myself recently, as I, along with other visiting colleagues from Rajiv Gandhi Foundation, were putting up in Payvihir village. The Govt has constructed a beautiful training center in the middle of the forest which is also known as Interpretation Center. Several NGOs and Govt officials visit this center regularly for workshops and training. A nominal fee is charged from them that helps locals to maintain the center.

Local youth like Ramlal Kale, Amit Sonare, Krushna Belsare, Ravi Yewale and many others became the torch bearers of the FRA movement in Payvihir, Upatkheda, Jamda and Khadijapur Pur village in 2009 -2010. All these youths were trained by Khoj and now they are working independently. The villagers took up several soil and water conservation works, plantations, and protection from forest fires and grazing. They also

the enthusiasm of the people was so charged that they kept waiting for their MLA and other officers of the administration under scorching sunlight for several hours. The local MLA of Ranpur Satyanarayan Pradhan and Chairman DDC Budgam Nazir Ahmad Khan jointly gave away the CFR titles to villagers. The officers from forest , revenue and tribal affairs department were present on the occasion.

#### Confederation of forest villages

The people around Ranpur forest area in Nayagarh district have already been working for conservation and protection of their forests and forest resources including the wildlife for last 24 years under the banner of Maa Maninag Jangal Suraksha Parishad (MMJSP) which is a confederation of around 132 community based forest protection groups in 132 villages. Arkito Sahu the Secretary of the Maa Maninag Jangal Suraksha Parishad has been putting his sincere and tireless efforts to organize the people in 132 villages for protection and conservation of forests. To give them institutional support V Giri Rao the Director of Vasundhara a reputed NGO based in Bhubaneshwar has also been working with people like Arkito Sahu for the last many years. Vasundhara has been working around the Ranpur area since 1995. This NGO has helped MMJSP with institutional support like the documentation of their great work and to involve women in forest committees which has been a very tedious task. After enactment of the Forest Rights Act in 2006 Vasundhara and MMJSP have been working more rigorously to ensure the benefits of this legislation reach out to the forest dwellers around Ranpur block.

It was for the first time in last 14 years since the enactment of the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 commonly known as Forest Rights Act 2006 (FRA) that community forest rights (CFR) or community forest resource rights (CFRR) were conferred on other traditional fortected; (c) ensure that the habitat of forest dwelling Scheduled Tribes and other traditional forest dwellers is preserved from any form of destructive practices affecting their cultural and natural heritage; (d) ensure that the decisions taken in the Gram Sabha to regulate access to community forest resources and stop any activity which adversely affects the wild animals, forest and the biodiversity are complied with "

#### Conclusion

A wrong assumption has been built by some forest officers and conservationists that forest dwellers are a threat to forests. Tribals in India are used to being called encroachers but Governments in the past never tried to involve them in conservation. After the Forest Rights Act was enacted , all this became possible. Successive Governments in Jammu & Kashmir never took any steps to enact FRA type legislation in the past. The way people of Upatkheda panchayat particularly residents of Pavihir village have regenerated their barren forest land with thousands of trees is an eye opener for those who have been opposing giving forest land to the local communities under the Forest Rights Act 2006. If a small tribal community can do such wonders why can't others follow this model? The FRA is not meant for forest encroachment but has been basically enacted to give the control of the forests to local communities who can well manage their forests and its resources. There are many success stories wherein local communities are seen doing better watch and vigil of forests and earning their livelihood as well from forest produce.

# **Eight Changes The World Needs To Make To Live With Covid**

ore and more people have been asking for a return to normal, and with omicron waning, governments are starting to act. The UK, for example, is removing its remaining public health measures, including mandatory selfisolation of COVID cases and free testing. However, the inescapable truth is that – unless the virus mutates to a milder form the "normal" life we are returning to will be shorter and sicker on average than before.

We've added a new significant disease to our population. COVID is often compared to flu, as if adding a burden equivalent to flu to a population were fine (it isn't). In fact, COVID has been and remains worse. COVID's infection fatality rate - the proportion of people who die once they've caught it - was initially about ten times higher than for flu. Treatments, vaccines and prior infections have since brought the fatality rate down, but it's still almost twice as high as for flu - and yes, this still holds for omicron.

The impact is then worsened because COVID is so much more transmissible. It also has a similar or worse longer-term impact on the heart, lungs and mental health than other respiratory diseases, and a higher rate of long-term symptoms. Vaccines have been incredibly effective at reducing severe illness and death, but they're not perfect. New variants have tested vaccine defences, and protection against infection – and to a lesser extent severe illness – wanes after a few months.

While we're unlikely to lose all protection against severe illness and death, the sort of return to normal being attempted in countries such as the UK, Denmark and Norway will result in many people facing repeated COVID reinfections over the coming years. The large majority will cope, but some will die, and more will be left with lasting ill health. Many with mild illness will still need time


How to live post-COVID The last 150 years have seen vast improvements in public health, with dramatic reductions in deaths from malnutrition, infectious diseases, environmental diseases, smoking and road traffic accidents to

name a few. For communal problems we have developed communal solutions, from vaccines to controls on pollution, passive smoking, unsafe driving and other ills. There's nothing normal about upending decades of progress by simply accepting a

what we have learned from the last two years. Here are eight key changes that can reduce the future impact of COVID:

1)

Outdoors is pretty safe so let's make indoor air as much like the outdoors as possible. This will involve large investment in infrastructure to improve ventilation and to filter and clean the air. This isn't simple, but neither was bringing clean water and electricity to every home. We know how to do it and it will be effective against



new variants. We also need to keep working towards vaccines that are longer lasting and more variant proof.

We've learned that acting 3) sooner rather than later is crucial to containing outbreaks and preventing spread to other countries. So we need to invest in global surveillance of new COVID variants and other

new infectious diseases. Most countries already routine surveilhave lance for serious infectious diseases (such as flu and measles) and plans in place to mitigate their impact. Countries need to add permanent surveillance of COVID infection rates to existing programmes, to keep track of how much COVID is circulating, where and in which communities.

5) We still know too little about the long-term impacts of COVID, though we do know it can cause longlasting organ damage and result in long COVID. We need to invest in understanding, preventing and treating these impacts. 6)

Many health systems were already struggling be-fore COVID hit, and have since had their resilience further depleted by the pandemic. Investment in health systems is urgently needed, particularly in winter seasons where the additional burden of CO-VID will be most acutely felt.

COVID has hit the most disadvantaged the hardest. Those least able to afford to self-isolate are also more likely to work outside the home, use public transport and live in overcrowded housing - all risk factors for catching the virus. Increased exposure is coupled with lower vaccination rates and poorer health among disadvantaged groups, leading to worse outcomes if infected. Countries need to invest more in reducing inequalities: in health, housing, workplaces, sick pay and education. This will make all of us more resilient to future outbreaks and reduce

ill health and death – not just from COVID but everything else too.

Finally, there will still be future waves of COVID - the above will simply reduce their frequency and scale. We need to have a plan to deal with these. Excellent national surveillance systems will help rapidly identify an outbreak and understand how much ill health is being caused and immunity evaded - all of which will help tailor an appropriate temporary response. A response might, for in-stance, include escalating testing, reintroducing masks and working from home where possible.

Such plans should enable us to avoid long widespread lockdowns. Refusing to learn to live with COVID by pretending the old normal exists is in fact the biggest risk for future lockdowns.

We need to move on from the denial and anger stages of grief and on to accepting that the world is different now. Then, we can take control and build a way of living that is designed to contain the virus while allowing all of us – including the clinically vulnerable – to lead freer and more healthy lives.

# The Seven Habits That Lead to Happiness in Old Age

Your well-being is like a retirement account: The sooner you invest, the greater your returns will be.

magine yourself 10 years from now. Will you be happier or less happy than you are today? I ask my graduate students-average age, late 20s-this question every year. The majority think they will be happier. But when I ask about their prediction for 50 years from now, it seems a lot less rosy. Being in their late 70s doesn't sound so great to most of them.

They are shocked when I show them the data on what happens to most people: Happiness tends to decline throughout young adulthood and middle age, bottoming out at about age 50. After that, it heads back up again into one's mid-60s. Then something strange happens. Older people split into two groups as they get old: those getting much happier, and those getting much unhappier.

Right around this same time of life, many people realize the importance of having made good financial decisions in their earlier decades. Those who planned ahead and saved up are more likely to be able to support themselves in comfort; many of those who didn't, can't. Something similar happens with happiness, as I show in my new book, From Strength to Strength: Finding Success, Happiness, and Deep Purpose in the Second Half of Life.

Each of us has something like

a "Happiness 401(k)" that we invest in when we are young, and that we get to enjoy when we are old. And just as financial planners advise their clients to engage in specific behaviorsmake your saving automatic; think twice before buying that boat—we can all teach ourselves to do some very specific things at any age to make our last decades much, much happier.

In 1938, researchers at Harvard Medical School lit upon a visionary idea: They would sign up a bunch of men then studying at Harvard and follow them from youth to adulthood. Every year or two, researchers asked the participants about their lifestyles, habits, relationships, work, and happiness. The study has since expanded to include people beyond men who went to Harvard, and its results have been updated regularly for more than 80 years. Those results are a treasure trove (and I've referenced them several times in this column): You look at how people lived, loved, and worked in their 20s and 30s, and then you can see how their life turned out over the following decades. And from this crystal ball of happiness, you can learn how to invest in your own future well-being.

As the participants in the Harvard Study of Adult Development have aged, researchers have categorized them with respect to happiness and health. There is a lot of variation in the population, but two



distinct groups emerge at the extremes. The best off are the "happy-well," who enjoy good physical health as well as good mental health and high life satisfaction. On the other end of the spectrum are the "sadsick," who are below average in physical health, mental health, and life satisfaction. When they were young, the happy-well senior citizens

tended to have accumulated certain resources and habits in their Happiness 401(k)s. Some of these are, like generational wealth, difficult for each of us to control: having a happy childhood, descending

from long-lived ancestors, and avoiding clinical depression. But some are, to varying degrees, under our control, and

these can teach us a great deal

about how to plan for late-life happy-wellness. Using data from the Harvard study, two researchers showed in 2001 that we can control seven big investment decisions pretty directly: smoking, drinking, body weight, exercise, emotional resilience, education, and relationships. Here's what you can do about each of them today to make sure your accounts are as full as possible when you reach your later years:

- ► Don't smoke—or if you already smoke, quit now. You might not succeed on your first try, but the earlier you start the quitting process, the more smoke-free years you can invest in your happiness account.
- ▶ Watch your drinking. Alcohol abuse is strongly corre-

lated with smoking in the Harvard study, but plenty of other research shows that even by itself, it is one of the most powerful predictors of winding up sad-sick. If you have any indication of problem drinking in your life, get help now. If you have drinking problems in your family, do not take your chances: Keep that switch turned off. Although forgoing alcohol can be difficult, you'll never be sorry you made this decision.

Maintain a healthy body weight. Eat a diet with lots of fruits and vegetables and moderate serving sizes, but avoid yo-yo diets or intense restrictions that you can't maintain over the long run.

Prioritize movement in your

life by scheduling time for it every day and sticking to it. Arguably the single best, time-tested way to do this is by walking daily.

- Practice your coping mecha-nisms now. The earlier you can find healthy ways to deal with life's inevitable distresses, the more prepared you'll be if ill luck strikes in your 80s. This means working consciously-perhaps with assistance from spiritual practices or even therapy-to avoid excessive rumination, unhealthy emotional reactions, or avoidance behavior.
- Keep learning. More education leads to a more active mind in old age, and that means a longer, happier life. That doesn't mean that you need to go to Harvard; you simply need to engage in lifelong, purposive learning. For example, that can mean reading serious nonfiction as part of a routine to learn more about new subjects.
- Do the work to cultivate stable, long-term relationships now. For most people, this includes a steady marriage, but other relationships with family, friends, and part-ners can fit in this category as well. The point is to find people with whom you can grow, whom you can count on, no matter what comes

your way. The best way to maximize your chances of happiness in your 70s is to pursue all seven

of these goals with fervor, sort of like balancing your 401(k). But if you can choose only one to pour your heart into, let it be the last. According to the Harvard study, the single most important trait of happy-well elders is healthy relationships. As Robert Waldinger, who currently directs the study, told me in an email, "Well-being can be built-and the best building blocks are good, warm relationships.'

The seven funds of happiness are all based on population averages, which means, as they say in the commercials, your results may differ. Maybe, for example, you just can't quit smoking. You won't necessarily be doomed to misery in your 70s, but you'll be better off if you can bolster your happiness through one of your other investments-say, by finding meaning and community in your faith.

If you want to ascend to that upper branch of happiness, following the seven steps as best you can is the most reliable way to do so. Take an inventory of your habits and behaviors today, and see where you need to invest a little more time, energy, or money to start moving in the right direction.

Everyone loves a happy ending, especially in the story of their own life. Start writing that ending today.

# Girls With Hijab And Burga Denied Entry To Colleges Citing HC interim Order Press Trust of India nen in Udupi with the co

BENGALURU: Hijab and Burga wearing girls were denied entry to educational institutions in Shivamogga and Udupi by the authorities citing the Karnataka High Court's interim order on Monday.

According to information received, 15 students were not allowed inside the DVS College in Shivamogga as they insisted that they should be allowed not only putting on Hijab but also with Burga.

The college authorities told them that they cannot attend the classes as the HC interim order was in force, sources said.

The girls then gathered at the college gate but the policemen deployed there said they cannot form any group as the prohibitory orders were in place under Section 144 of the CrPC.

Similarly in Udupi, Muslim girls were not allowed inside the Government PU Girls College and hence, they were not allowed to attend the science practical tests held as part of the preparatory exams.

The practical examinations for second-year science students began at the government pre-university college for



lege not allowing three students to appear for the examinations wearing hijab.

The controversy over the hijab dress code spread to other colleges in Karnataka from this pre-university college after six students demanded permission to wear hijab in the classroom. Of the six students, three, A H Almas, Hazra Shifa and

Bibi Ayesha, are in the science stream. They arrived in the college Monday wearing hijab to appear for the examination. But Principal Rudre Gowda did not allow them to enter the exam centre wearing a hijab citing the interim of order of the High Court. The students returned

Almas said, "Today was our final practical exam. We had completed our record books and went in great hopes to attend the practical exam. It was so disheartening when our principal threatened us saying 'you have 5 minutes to leave, if you don't leave, I will have to file a police complaint, the principal told us," she said.

"Right now, we should have been in our labs attending the practical exams, not compelled to leave. The hopes I had from my college and my dreams are getting shattered due to the hatred sowed against hijab." Denying the allegation of

the student, the principal told

reporters that he tried explaining to the students on the need to follow the interim order of the High Court. They opted to return home without appearing for the examinations, prinicipal Rudre Gowda said.

Meanwhile, Bharath composite pre-university college at Mastikatte, on the outskirts of Mangaluru, which declared a holiday from February 25 following protests by students over hijab, did not open for classes on Monday.

The Hijab row started in December end when a few girls denied entry into the college with Hijab.

On January 1, six girl students of a college in Udupi attended a press conference held by the CFI in the coastal town protesting against the college authorities denying them entry into classrooms wearing hijab.

This was four days after they requested the principal permission to wear hijab in classes which was not allowed. Till then, students used to wear the headscarf to the campus, but entered the classroom after removing it, college principal Rudre Gowda had said.

"The institution did not have any rule on hijab-wearing since

no one used to wear it to the classroom in the last 35 years. The students who came with the demand had the backing of outside forces," Gowda had said.

As the issue of Hijab versus saffron scarves spread to several educational institutions in many parts of Karnataka, the state government announced holiday from February 9 to 15 in all the pre-university college and from February 9 to February 16 in degree and diploma colleges.

The girls then approached the Karnataka High Court seeking relief and quashing the government order on February 5 restraining students from wearing any cloth that could disturb, peace, harmony and public order.

The full bench of the High Court comprising CJ Awasthi, Justice J M Khazi and Justice Krishna S Dixit, which has been hearing the case on a day-today basis since February 10, in its interim order asked the state government to reopen the educational institutions, which were hit by the agitation, and restrained students from wearing Hijab and saffron scarves in the class-room till the final order is delivered.

NEW DELHI: Delhi Metro services with full passenger capacity resumed on Monday as authorities lifted all curbs following improvement in the COVID-19 situation in the city.

Till 8 pm, the DMRC had registered nearly 32.9 lakh jour-neys for the day, officials said. Journey or line utilisation is calculated by the number of corridors passengers use to reach their destinations. The corresponding journey figures for the three preceeding Mondays were -- 23.66 lakh (February 7), 27.93 lakh (February 14) and 31.95 lakh on February 21, the officials said. Delhi The Disaster Management Authority (DDMA) had on Friday decided to withdraw all Covid restrictions from Monday, reduce the fine amount for not wearing masks from Rs 2,000 to Rs 500 and resume physical classes in schools from April 1. "Delhi Metro services have resumed today without any restrictions on passenger occupancy after a long time," the

DMRC said in a statement. "DMRC expresses its thanks and gratitude to its passengers for following the protocols during the pandemic. Indeed,

without your cooperation, we could not have operated the metro despite the constraints posed by the pandemic," it said.

All the gates have been reopened as the restrictions have been lifted, the officials said. Earlier, only a limited number of gates were operational. The urban transporter also tweeted to inform commuters about the development. In the days ahead as well, Delhi Metro shall continue to try its best to provide a safe and comfortable journey.

"However, let us remember that Covid is not over yet. In order to ensure a safe journey, let us follow all necessary protocols such as: Wearing of masks regularly, adequate social distancing, frequent hand sanitisation," it said in a tweet.

The DMRC said it shall also continue to maintain the highest level of hygiene and cleanliness for the passengers. The trains and stations are being frequently sanitised and all the guidelines in place shall be stringently followed, it added. # Depleting Food Stocks Add To Trauma Of Stranded Students In Ukraine Amid Reports Of Some Being Roughed Up

**INDORE/AURANGABAD/DEHRADUN:** Depleting food stocks and long queues for water are adding to the trauma of stranded Indian students in war-hit Ukraine awaiting evacuation amid reports of some being roughed up by security personnel and spending freezing nights out in the open.

As Indian and Ukrainian authorities on Monday described the situation as "complex" and "very difficult" in terms of evacuation of people, the students, joined by their parents, appealed to the Indian government to expedite efforts to evacuate them. Russia launched its attack on Ukraine last Thursday.

I want my son in front of my eyes as soon as possible," said Kamini Sharma, who is praying for the safe return of Vibhor Sharma (22), a resident of Indore in Madhya Pradesh. Vibhor is pursuing a medical course at the Ternopil National Medical University.

Payal Panwar, a final year medical student who returned to her Kotdwar home in Uttarakhand, said the stranded students need help of the Indian government and the Indian embassy people more while they are still inside Ukraine rather than when they have moved out of the war-torn country.

Ukraine it is really difficult with food supplies running out and no cash in ATMs. Stranded students need the help of Indian authorities while they are still inside Ukrainian borders," said Payal, who studies in Ivano-Frankivsk city in western Ukraine.

Recounting her ordeal, she said around 60-70 Indian students had to book a bus and also walk a distance of 8-10 km in freezing cold to reach the Romanian border to get out of Ukraine. Many ATMs could not dispense cash

and long queues of men and women waiting for their turn for food supplies were seen at several points, she said.

Though happy and relieved to be reunited with her parents, Payal and her parents are worried about her brother who was still stuck in Kharkiv.

An Indian student who managed to reach the Kyiv train station said Ukrainian guards were not allowing students to board trains and also beating up people and made a fervent appeal to the Indian embassy to evacuate them as soon as possible.

It's getting difficult for us to stay here, Ansh Pandita told PTI, as scores of Indian students including women sat huddled together at the teeming Vokzal railway station in the Ukrainian capital, holding a large tricolour aloft so they could be recognised in the crowd and also so no one from the group gets lost.

The group of about 100 students managed to reached the station but no one could board a train.

Ukrainian soldiers are not allowing us to board the train to Hungary. In fact, they are not allowing any international resident to get out, Pandita, a student of Taras Shevchenko National Medical University in Kyiv, said over the phone from the station.

We requested them to at least allow the girls to go but that request too fell on deaf ears.

The opposition Congress also alleged that Indian students were assaulted by security personnel on the Ukraine-Poland border.

"Students are crying out for help, requesting the Modi government to intervene but to no avail. We saw a video last night on the Ukraine-Poland border where students are being beaten up," party spokesperson Ragini Navak told reporters.

India managed to accelerate its efforts to get its nationals out of Ukraine in the last 24 hours, though the situation on the ground continues to be "complex and fluid" in terms of evacuation of people, the Ministry of External Affairs (MEA) said.

the total number of Indians who have left Ukraine since India issued the first advisory earlier this month is around 8,000. An estimated 20,000 Indian nationals, mainly medical students, reside in Ukraine.

As the battle for Kharkiv rages on, at least three students from Maharashtra pursuing medicine in the city located in northeast Ukraine, narrated how they had to stand in long queues for a can of water, drink soda, stay in bun-kers, and risk their lives to fetch food items amid bomb blasts.

Hritik Bapulohar, a first-year medical student from Palghar, said he had reached Kharkiv city only a couple of months back.

"We can hear bomb explosions as they are taking place in a periphery of around 500 metres from where we are currently staying in Kharkiv. We are struggling even for basic needs. As many as 500 students are staying in two bunkers for the past four days. When the curfew was lifted some of them left the hostel. The situation is worsening fast. I appeal to the Indian government to evacuate us urgently," he told a Marathi news chann

for drinking. After standing in queues stretching up to 2 km, we can get a can of five-litre water. Food prices have tripled since the war began. We are taking huge risks by stepping out to purchase food items. We are hiding as bomb blasts are happening here. During nights, we are given an hour for cooking by authorities. We cook using mobile flashlights," she said.

Shivanjali Yadav, also from Sangli, said students and other Indians are asked to stay in bunkers in Kharkiv even though we don't have much food and water with us.

The students trapped in a bunker in the Kharkiv region are facing difficulties in arranging food, water. Some of them have fallen sick in freezing temperatures, few blankets, and dipping oxygen. There are also no transportation facilities available for them, said one of the students who returned to Odisha.

Several students wanting to return to India from Ukraine had to spend two days under the sky in severe cold weather at the Romanian border after travelling by bus and then walking for 25 km, a mother of one of the students said.

The nearest border is at least 800 kilometers away from our place, so are we going to walk up to that place? If the Indian embassy doesn't change its evacuation plan, they will not be able to save us."

"They have asked us to leave Kviv but there's absolutely no way that we can leave because almost after every 30 minutes, a massive bombings rattle this city. They should have come up with a practical idea of evacuating us rather than playing safe for their own sake. The most practical solution for our evacuation is that the Indian government contacts the Russian Government and asks it to allow us to travel to its border because on three sides of Kharkiv lies the Russian border and that's the nearest border for us unlike Romanian border which is 800 KMs away," he adds

Pertinently, the Indian embassy in Ukraine has stayed active on Twitter and tweeted regularly, asking its stranded citizens to stay "patient and safe" as it attempts to evacuate all of them.

On Monday, it also issued an advisory and asked those stuck in Kiev to proceed to railway stations where there were special trains for evacuees. But there was no such communication for students who are stranded in the basements and underground shelters of the Kharkiv battle zone.

Several Kashmiri students stuck in Kharkiv have told this reporter that they are planning to leave the city and try to make it to Odessa port city on their own as they fear that the Embassy official will keep on delaying their evacuation.

"We fear that war in Kharkiv will take an ugly turn as Russians may try to intensify their military operation here in an attempt to reach capital Kiev faster," a Kashmiri student, who wished not to be named said.

Several Kashmiri students along with those from the other parts of the country have also alleged that even though the Embassy has issued an advisory asking them to leave and reach Kyiv but the hostel authorities have denied them permission citing no such order has been issued to them

Other foreign embassies have already coordinated with University officials and evacuated their citizens. But unfortunately we've been left to God's mercy." said another student.

With war nearing a week another crisis staring at stranded students is the food shortage.

"Almost all the halal food in Kharkhiv's supermarkets has ended. What's left is something that none of us can eat. The basic amenities like rice, beans and vegetables are completely out of stock. The embassy guys haven't been able to arrange these things for us, how exactly are they going to evacuate us," said Asif.

"Some supermarkets still have these items available but unfortunately as soon as we try to enter, the shop is shut on us and we are asked to leave. They're only providing these essential items to local Ukranians. We are literally eating the leftover food. If this war doesn't kill us, I'm pretty sure we'll die of hunger," he said.



# **PCB Claims Online Threat** Sent To Aussie Player Agar's Partner But Wasn't Credible

LAHORE: The Pakistan Cricket Board (PCB) has claimed that a threat was sent to the partner of touring Australian cricketer Ashton Agar on social media but it was not found to be "credible" after investigation.

Australia are touring Pakistan after 24 years amid tight security.

"The PCB is aware of a social media post, of which the nature and content has been investigated by the PCB, CA and combined Government security agencies," the board said in a statement.

There are extensive security plans in place for this type of social media activity, which, in this case, is not considered a risk. No further comment will be made at this time," it added.

The message was sent to Agar's partner, Madeleine, on social media, which was immediately reported to Cricket Australia and the PCB.

"The Australian team security



also investigated the matter and do not believe it is a credible threat," the source said.

When New Zealand toured Pakistan last September threats were sent out to the team social media.

Eventually, the Black Caps abandoned the tour without playing their white-ball series on the advice of their government which said there was a direct security threat to the touring side.

Pakistan has hosted only six Test matches since 2009 due to security reasons after the Sri Lanka team was attacked by terrorists in Lahore in March, 2009.

# **Olympic Body Calls For Russia To Be Excluded From Sports**

**GENEVA:** In a sweeping move to isolate and condemn Russia after invading Ukraine, the International Olympic Committee urged sports bodies on Monday to exclude the country's athletes and officials from international events. The IOC said it was needed to

"protect the integrity of global sports competitions and for the safety of all the participants." The decision opened the way for

FIFA, the governing body of soccer, to exclude Russia from a World Cup qualifying playoff match on March 24. Poland has refused to play the scheduled game against Russia.

The Olympic body's call also applied to athletes and official from Belarus, which has abetted Russia's invasion by allowing its territory to be used to station troops and launch military attacks.

The IOC said it acted "with a heavy heart" but the impact of war on Ukrainian sports outweighed the potential damage done to athletes from Russia and Belarus.

It was not a total blanket ban by the IOC. Where exclusion was "not possible on short notice for organizational or legal reasons," then teams from Russia and Belarus should compete as neutral athletes with no national flag, anthem or symbols, including at the upcoming Winter Paralympics in Beijing.

The IOC also withdrew the Olympic Order it gave Vladimir Putin in 2001, and other Russian officials since.

Sports bodies across Europe had

already moved against Russia on Monday by refusing to host or play against teams from the country.

Finland wants the Russian hockey team to be banned from the men's world championships it will host in May, the Swiss football federation said its women's team will not play Russia in July at the European Championship, and German football club Schalke said it had decided to end its long-standing partnership with Russian stateowned energy giant Gazprom.

FIFA declined to ban Russia from the World Cup over the weekend. Instead, the football body said the country's national team will have to compete as Football Union of Russia as punishment. Besides Poland, both Sweden and the Czech Republic, Russia's next potential opponents, have said they would refuse to take the field against them.

Another of Russia's future opponents, Albania, also said Sunday it would not play against that country in any sports. Russia and Albania are scheduled to meet twice in June in the UEFA Nations League soccer tournament. The group also

includes Iceland and Israel. In hockey, the sport's governing body has come under pressure from Finland and Switzerland to ban Russia and Belarus, which are both due to play at the world championships in May in Helsinki and Tampere.

Finnish Hockey Association chairman Harri Nummela said in a statement Monday it had talks with the Zurich-based IIHF to exclude the two countries from the sport internationally. (AP)



CHITTAGONG: Opener Rahmanullah Gurbaz struck a brilliant 106 not out as Afghanistan avoided a clean sweep by sealing a seven-wicket win against Bangladesh in the third one-day international on Monday.
