India 'Accidentally' Fires Missile Into Pak, Orders Probe

Islamabad Summons Indian Diplomat Over Airspace Violation

ISLAMABAD: India on Friday regretted the accidental firing of a missile into Pakistan, barely hours after Islamabad summoned India's Charge d'Affaires and conveved its strong protest over the alleged unprovoked violation of its airspace and sought a thorough and transparent investigation into the incident that could have resulted in a serious aviation accident.

The Indian diplomat who was summoned to the Foreign Office was told about the alleged violation of its airspace by an Indianorigin super-sonic flying object which entered into Pakistan from Suratgarh in India at 6:43 PM (local time) on March 9, the Foreign Office said in a statement.

The object later fell on the ground near Mian Chunnu city in Pakistan's Punjab province at around 6:50 PM on the same day, causing damage to civilian property. In New Delhi, India's defence

ministry on Friday said a technical malfunction in the course of a routine maintenance led to the accidental firing of a missile on March 9.

The ministry said the missile



landed in an area of Pakistan and noted that the "incident is deeply regrettable". The Defence Ministry said the Government of India has

taken a serious view of the incident and ordered a high-level Court of Enquiry into it. In Islamabad, Pakistan's Foreign Minister Shah

Mahmood Qureshi also voiced concern over the incident. In a statement, Qureshi

alleged that India had endangered innocent lives by violating Pakistan's airspace as flights of Saudi and Qatar airlines, as well as domestic flights, could have been hit.

He said Pakistan would decide its next step after receiving India's explanation, adding that envoys of P-5 countries (China, France, Russia, the Kingdom, and the United United States) will be called to the Foreign Office and briefed about the incident.

"India will have to be answerable for this," he said. Air Vice Marshall Tariq Zia,

who addressed a press conference on Thursday, said that at the time the projectile was picked up by the Pakistani military, there were two active airway routes and several commercial airlines were in the area.

"If you look at the speed and height of the projectile, it was 40,000 feet high, and the airlines were between 35,000 to 42,000 feet. This could have been very detrimental to the safety of passengers."

The projectile travelled 124 kilometres inside Pakistani territory in three minutes and 44 seconds, he added.


The FO also said the flight path of the flying object endangered several domestic/ international flights within the Pakistani airspace and could have resulted in a serious aviation accident as well as civilian casualties, it said.

Sarpanch Shot Dead By Militants In Kulgam 3 Panchayat Members Slain In 9 Days

SRINAGAR: In a second killing of a Panchayat member in the last two days, unidentified militants on Friday shot dead a Sarpanch in Adoora area of south Kashmir's Kulgam district.

According to officials, unknown militants fired upon the Sarpanch Shabir Ahmad Mir from a close range near his home in Adoora village on Friday evening. Mir, who collapsed on the ground after receiving gunshots, was removed to the district hospital Kulgam for treatment. However, the doctors there declared him dead. "He had bullet injuries in abdomen and was brought

dead to the hospital," Medical Superintendent of the hospital Dr Muzaffar said. Mir is the third Panchayat

SRINAGAR: An Army helicopter on its way to pick up sick BSF personnel crashed near the Line of Control (LoC) in north Kashmir's Gurez Sector on Friday, killing its co-pilot and critically injuring the pilot, officials said.

It crashed around 11:30 am with officials saying that it drifted away while descending and tumbled into a 'nallah' flowing nearby.

The 'Cheetah' helicopter was undertaking a rescue sortie to evacuate a sick Border Security Force (BSF) jawan deployed in the forward area in the mountainous region.

"An Army Cheetah helicopter crashed in the Baraub area of Gurez in Bandipora district this afternoon while on a routine mission to evacuate an ailing soldier from a forward post,"



Srinagar-based defence spokesman Col Emron Musavi said.

He said the helicopter lost communication with the forward post at Gujran in Baraub before airlifting the trooper.

The slain co-pilot has been identified as Major Sankalp Yadav (29), while the injured pilot, a Lieutenant Colonelrank officer, was rescued from the crash site and rushed to the Command Hospital in Udhampur. More on P6

Pvt Schools Get Govt Nod For 12% Bus Fee Hike

SRINAGAR: A committee for fixation and regulation of school fees in Jammu and Kashmir has allowed private institutions to hike transportation fees by 12 per cent, officials said on Friday.

The increase was allowed after the committee received complaints that private schools had hiked transportation fees significantly following their reopening. "It is also al-

leged that private school managements are demanding payment of advance

transport fees either for the full session or 50 per cent of the total fees. The schools also seek an undertaking from the parents regarding the advance payment of fees," the committee said in an order.

As a temporary measure and till such time that a final decision is taken, school managements shall hike the transportation fees that was being paid by the students who were availing the transport facility in October 2019 in the winter

It's Time to Stop Pre-Rinsing Your Dishes

You might think it helps the dishwasher get them cleaner, but it actually does the opposite.


I always pre-rinse my dishes. While I'm no nutcase-I don't actually wash them before placing them in the dishwasher racks-leaving the remains of a runny egg, clingy sauce, or (gasp) oatmeal on my

crockery simply feels wrong. But it turns out there's good reason to avoid the temptation to rinse away lingering food particles before using your dishwasher. Most appliance and dishwasher soap manufacturers recommend against rinsing every remnant of food off your dishes, saying doing so can actually inhibit proper cleaning. Here's why.

Why your dishes need to be dirty to get clean

Perhaps the reason so many of us pre-rinse is because that's how our mothers did it. But dishwashers have come a long way from the ones our parents used. According to Consumer Reports, "pre-rinsing isn't necessary with modern dishwashers because they have sensors that adjust the wash cycle based on how dirty the dishes are." They don't need our help, and by pre-rinsing "you could be making matters worse by causing the built-in soil sensor to misread the amount of dirt in the water."

Additionally, as reported by the Wall Street Journal, many Whirl-pool dishwashers have a "Target-Clean" setting equipped with sensors to determine whether food remains on dishes; as many as 40 focused spray jets are set to attack baked-on food. Skip that step and your dishes won't wind up as clean. And that's just how water func-

tions in your appliance. When it comes to detergent, the WSJ reports, "Cascade, made by Procter & Gamble Co., warns against prewashing, except for removing large pieces of food. Enzymes in Cascade detergent are designed to attach themselves to food particles. Without food, the enzymes have nothing to latch on to." Pre-rinsing wastes a lot of water

(and energy) Consumer Reports estimates we use 2 to 6 gallons of water per minute we rinse our dishes. Cascade estimates pre-rinsing wastes up to 15 gallons of water per load. With the average household running 215 loads of dishes per year, that's 3,225 gallons of water per year that could be saved.

According to CNET, dishwashers

built before 1994 use 10 gallons or more of water per cycle, while newer models are far more efficient. "In 2013, new standards were put in place that required dishwashers to use...5 gallons per load." And an Energy Star certified model can use as little as 3 gallons. Not to mention the energy it takes to heat all those gallons. As CNET reports, "most newer dishwashers

have heaters inside that warm up water more efficiently than your water heater. Overall, if it is Energy Star certified, it can use less than half the energy of washing dishes by hand."

In the words of the National Resource Defense Council, "if you have a dishwasher, put down the sponge." Experts advise we should scrape large food scraps off our dishes rather than rinsing each one before loading.

Don't overload the machine (but make sure it's full)

Of course, getting the best func-tionality out of your dishwasher is predicated on proper use. All those high-tech sensors and spray jets need adequate space to do their job. After checking your owner's manual for loading instructions specific to your washer, place cups, glasses, small bowls, and plastic items in the top rack, and plates, serving pieces, and larger bowls in the bottom rack. Make sure cutlery is mixed among the baskets to avoid "nesting." Leave space for water and soap to flow properly, but be sure your washer is full enough to merit being run. According to the EPA, "Running the dishwasher only when it's full can eliminate one load of dishes per week and save the average family nearly 320 gallons of water annually.'

Of course, there are some more delicate items that should never go in the dishwasher. For these, we have little choice but to handwash. For everything else, you can safely stop pre-rinsing and let your dishwasher do the work from here on out.



Mufti Stages A Come Back In Kashmir Politics

rinagar-Former union home minister and senior Congress leader Mufti Mohammad Syed turned tables on ruling National Conference, when he defeated the party nominee, Mohammed Yusuf Taing, with a convincing margin of over 48, 000 votes. Mufti who succeeded in establishing lead over his rival, from the very beginning of the vote count, on Monday afternoon, maintained the same till he was officially declared elected in the wee hours of Tuesday morning.

Mufti polled 1,17, 152 of 2,12,337 total valid votes polled, while Taing could manage just 68,447 votes. Union state minister for home affairs, Mohammad Maqbool Dar, a Janata Dal candidate finished a poor third by securing 11,063 votes while BJP, which admitted political front of surrendered militant group JK Ikhwan into its fold, on poll eve, got 6861 votes. All the 13 candidates in the fray, excepting Taint of the National Conference, lost their security deposits.

Mufti's victory is seen as his comeback in Kashmir politics, after remaining out of it for quite a long time. In the wake of 1987 Rajiv-Farooq accord, Mufti was relieved as state Congress chief by Rajiv Gandhi and in turn inducted into union council of ministers with a cabinet rank. From that day, Mufti virtually remained aloof from Kashmir politics, especially after he joined Janata Dal and rose to become the chief of party's central parliamentary board, besides holding sensitive portfolio of home affairs. It was only in mid-1996, when Mufti left Janata Dal to join back the Congress, that he started taking keen interest in Kashmir affairs again. He played an important role in finalising the list of party candidates for 1996 assembly elections. Though Congress performed very badly in those elections, it was more because of factionalism within the party with a section of Congress owing allegiance to Ghulam Nabi Azad, openly canvassing for National Conference candidates.

Now with having won the Anantnag Lok Sabha seat with a comfortable margin, Mufti is all set to give sleepless nights to his political opponents especially National Conference, which left no stone unturned to stop him from marching to Delhi.

Up In Flames Revisiting Safety Norms

hat shall one make of the assessment which describes the recent accident of humongous fire at Barzulla bone and joint hospital as a "wake – up call"? Shall it be assumed as a hint and clue pointing the negligence and state of slumber of concerned agencies and authorities towards the comprehensive safety of hospitals and by analogy to public buildings like schools, colleges, universities, malls, shrines, mosques? This is what has been hinted at, at least partially by some of the agencies entrusted with overall evaluation and estimation of safety parameters of hospitals. A statement from fire and emergency department reads that "Around 70 percent Government as well as private hospitals in the UT do not have basic fire safety measures in place. They lack smoke & fire management system and in many health institutions, unreliable fire management systems have been noticed". That is the scenario of hospital safety for you, for me and for all of us. This is how poorly our hospitals are assessed to perform when weighed against the scale of safety and security. It needs to be borne in mind that hospitals aren't picnic sports or holiday resorts, where one ventures in pursuit of joy, adventure or thrill. It is a place to which we rush in hours of health crisis, medical emergency and state of utter helplessness. The very idea of hospital invokes in us a sense of reliance, relief and escape from the suffering we are caught in. Stated in other words, hospitals are meant to be niches of safety, security, dependence, reliability and care of supreme order. But shall the thought not pause us to think for a while that the places we rush to in search of shield and safety, are themselves unsecured and susceptible and vulnerable to various natural and man-made disasters.

The recent episode of fire at Bone and Joint hospital awakened us to one of the dozens of safety lapses which our hospitals might be harbouring and which might culminate in disaster/s of unforeseen and unaffordable magnitude if not given due attention and plugged the earliest. One lacuna of unforgivable proportion which underlies human response is our proclivity for reactive instead of proactive measures. Because the fire engulfed Bone and Joint Hospital recently, now all attention seems to be diverted to the fire audit and fire fighting systems in place at hospitals. And this reaction usually comes at the cost of ignoring other safety parameters or considering them less hazardous till they cause a damage and destruction of higher proportions, some other day. So let us expand our canvas and try to identify the broader contours of "Safe Hospitals", and this description shall, by extension and little customization apply to all the buildings of public usage, as alluded to above. But before we can proceed with suggestions to ensure proper safety measures, our first task is to define hospital safety in most comprehensive and inclusive way possible. Hospital safety can be defined as the sum total of all procedures adopted and measures taken to ensure the safety and security of Patients, Staff, Attendants and visitors. This safety implicitly assumes in definition its extension both to tangible and intangible aspects of safety and security. When we try to conceptualise the tangible vectors of hospital safety, we come across three broad categories: the structural safety of hospital, the safety of patients, staff and attendants and the safety of equipment installed inside a hospital.

The structural safety of hospitals in turn involves making hospitals cope-up and mitigate the unforeseen calamities like earthquakes, ensuring proper fire fighting mechanism in place and foreseeing any possible future floods and to design hospitals such that they withstand these contingencies. Let's see how earthquakes influence the structure of hospitals and how can various structural features be added or subtracted to ensure that in any case of earthquake occurrence, damage to life and property is reduced to the minimum. The first point of departure is to consult structural engineers and seismic resistant structure experts before any structure is raised on ground. Their opinions and expert advices need to be incorporated into the weaving of building at each step. Well, this is a routine standard process and these things are scrupulously observed while a structure like hospital, college etc is under construction. But what happens later is that

these buildings are left in a state that can be described as "seismic ignorance". It is not enough to have a seismic resistant place in building, but it calls for frequent timely inspections, evaluations, assessments and identification of faults and flaws, if any Living in earthquake-prone region as we are, and given the unpredictable nature of earthquakes, all necessary measures ought to have taken to avoid any mishap. But as we get to know from experts, though our hospitals and constructed with the hindsight of meeting any earthquake related emergency, but there are many flaws like emergency exists do not function properly or remain blocked, even in events of earthquake. In similar vein, the absence of ample emergency exits and multi-flooring of hospitals multiplies the magnitude of damage in event of earthquake. A professor in Structural Engineering and specialist in Seismic Micro-zoning said

on conditions of anonymity that most of our hospitals constructed in past, including the main three-storied main building of government SMHS hospital lack the necessary structural features necessary to provide them a degree of resistance in instances of earthquake.

This applies more radically to colleges, shrines, mosques and malls too, which house a large number of people at any instant of time.

Fire safety of hospitals has caught our imagination once again, with the eruption of fire at Bone and Joint Hospital, Barzulla. Earlier, the fire safety and safety au-dit became talk of the town when the famous Shrine of Dastgeer Sahib, Khanyar was gutted down in massive fire. But the fervour decayed and even on this date, the holy shrines, which consist of entirely wooden structures are ill equipped to fight any fire related emergency. The fire extinguishers installed therein have usually been found dysfunctional and even if they happen to function, where are the people who know how to use these devices, if the need arises. Same holds true about schools, colleges, universities and other places where people in large numbers assemble together. But there's some topicality about fire safety of hospitals and that is associated with the fact that whereas students in schools and people in mosques can move on their own, run and rush and save themselves, the patients in hospitals aren't usually able to move on their own and rely entirely on the mercy of others to move and escape them in any event of fire emergency, lest they be charred and marred by fire. This brings us to the crucial question that do we have smoke detectors, fire alarms and proper fire fighting equipments in place in hospitals? When you see a fire extinguisher hanging by wall in any hospital draped by a sheath of dust, that shall alarm you and all of us that the magnitude of negligence is beyond forgiveness. What do experts say on the resilience of our hospitals to meet the emergency situation of fire.

A statement from the fire and emergency department in the wake of the recent incident reads "there are no fire-fighting measures, no emergency power supply and the public address system is also dysfunctional. Time and again, we use to advise the hospital authorities to install adequate fire safety equipment in their premises and conduct mock drills at regular intervals, but least interest is shown on their part to conduct mock drills which are necessary to prepare the hospital staff to control fire". Let's not get stuck in blame games, mudslinging and passing on the buck but rise up to the challenges which hospital safety posits in its multifarious forms and dimensions.

There are other equally important, but less talked about parameters of hospital safety. How often do we speak of the awkward and at times rudimentary behaviour of hospital staff towards attendants? Gripped in stress and anxiety, as these attendants usually are, their distress multiplies manifold while they withstand the rude behaviour of hospital staff. But the coin has other side too and that seems much darker. The incidents of attendants beating doctors have been on the rise and no civilised society shall leave any space for these gore episodes. A single patient is accompanied by multiple attendants and that has a cascading effect in setting problems on roller coasters in any eventuality and in otherwise normal situations too. The highly disproportionate doctor-patient ratio, the safety and security of equipment installed in a hospital, the frequent incidents of theft at hospitals, the oft-reported medical negligence all come under the ambit of hospital safety and there are many other aspects that call for separate space for discussion.

Let it be reiterated that safe hospitals do not imply only safety against fires, for we have witnessed a fire in one of our hospitals recently, but it calls for comprehensive inclusion of all the parameters discussed above. And while we talk about safety, it shall not be restricted to hospitals, but shall include in its scope all structures of public importance.

Mere appeals will not serve the purpose; what is required is tough action, and aggressive promotion of alternative mean.

Given the dismal record of successive governments over the relatively simple polythene issue, it is not clear how the powersthat-be can tackle the more complex matters of scientific treatment and disposal of garbage, rampant commercialization of residential areas, copy-cat urbanization of rural Kashmir and the degradation of the valley's ecological wealth in the countryside.

In more enlightened societies it is the leaderships that set a benign agenda, mode and trend of development, and sell it to the public who cooperate willingly and wholeheartedly in what they rightly perceive to be in their ultimate interest. But Kashmir is a study in contrast. Here a remiss leadership is more than matched by an unthinking public who see the stark face of their depredations every day but don't lift a finger to arrest it.

The weaknesses of a Congress led by the Nehru-Gandhis are particularly visible during general elections. For instance, in the 191 seats in the 2019 elections when they were in a head-to-head fight with the BJP, the Congress won just sixteen. With Rahul Gandhi posited as its prime ministerial alternative to Narendra Modi, the Congress's strike rate was a mere 8 per cent.


So far as the BJP is concerned, the Gandhis are a gift that keeps on giving. On the one hand, they do not remotely represent an effective electoral challenge to it. 

GALILEO FROM "THE

Life of Galileo" exemplifies his Marxist belief of a socially and economically constructed individual as opposed to an infallible and heroic protagonist of the bourgeois novels.

tric ethical truth-seeker; Galileo is shown to be gluttonous, deceptive and inconsiderate. His quest is tercepted by the indulgent pursuit of life and pleasure. This holds his status as a Knowledge seeker in tandem with his corporeality. However, the hurdles which he faces are not an outcome of his lack of heroism. His circumstances are determined by the social, political and economic conditions of his times and the authority which limits and dictates his actions. This is a quintessential instance of Brechtian Gestus which affirms that it is social relations and not ones psychology which dictates our actions. Galileo's recantation is best suited to explain the purpose of this deflation of the heroic and is a significant catch to understand Brecht's politics. It was an obvious comment on the fascist Nazi Germany from which Brecht sought a voluntary exile. Galileo's desire to seek knowledge was agential and revolutionary, but his discoveries could not be established as truth in an era with its own "regimes of truth" which buttressed the ruling ideology. Hence, he could not evolve as a hero who would singlehandedly vindicate the system that systematically coerced everyone. Additionally, Brecht had only two tangents to place his hero in accordance to the norms of his times. In Germany, being "heroisch" or heroic was closely related to Hitler's violent individualism, "it had always worn a uniform, three different uniforms, but had never been seen in civilian clothes" (Klemperer). Hitler thrived in propagandist literature like "Triumph of Will" which projected him as a divine and likeable ruler. On the other hand, American mass culture especially the comics industry showed Supermans and Captain Americas fighting the system by virtue of their idealised selves and national identity. Brecht was against any of such violent, vile and idealised notions of heroism.

Newly Devised Human Family Tree Reveals The 'Genealogy Of Everyone'

WASHINGTON:- From bustling Tokyo to the Isle of Man in the Irish Sea, from Novosibirsk in Siberia to the equatorial city of Quito, from congested Cairo to the desert town of Truth or Consequences, New Mexico, people everywhere comprise a single family.

Researchers on Thursday underscored that point, unveiling the most comprehensive family tree for Homo sapiens ever devised, based upon both modern and ancient genome data from more than 3,600 people from around the world. They dubbed the results the "genealogy of everyone."

The study helps delineate human genetic diversity and map out how people globally are related to one another, with our species arising in Africa before fanning out worldwide. what we try to do is to trace how genetic mutations, which occurred in our ancestors, and the bits of genome in which they occur have been passed down through the generations to the present day," Wohns said.

"Moreover, we can estimate the date and approximate geographic location of ancestors," Wohns added.

Other studies have indicated that groups of Homo sapiens departed Africa at various times in the ancient past. The new study suggests that the timing of the most significant departures occurred roughly 72,000 years ago.

The study raises the possibility that our species populated the Americas and Oceania well before the earliest archaeological evidence of human pres-

he Russia-Ukraine war and the process of eulogising one side and demonising the other is all out in the open. The racist tirades that have followed have also thrown into question how the labels of "heroic" and "villainous" have all been manufactured and are accorded to certain people on account of their identity. The white west and its allies are always invariably seen in the positive light and all others are seen as vile and degraded.

Additionally, in times where populist right wing leaders rule the roost, one wonders whether the possibility of "hero" exists.

This reminds us of political theatre that questioned the very idea of the possibility of heroes. In this context, Brechtian theatre was strongly political. It was a creative praxis of Brecht's politics which was typically anti-capitalistic. Brecht was against Romantic, Naturalist and Expressionist theatre which were largely

bourgeois. The thrust of each of these lay in the subjectivity and individuality of their protagonist. Brecht disapproved of the idea of this "free" individual, which appeared at the centre of most bourgeois literature. Galileo from "The Life of Galileo" exemplifies his Marxist belief of a socially and economically constructed individual as opposed to an infallible and heroic protagonist of the bourgeois novels. He explores the impossibility of a "hero" in an authoritarian system which incapacitates individuals to maintain the status quo. Additionally, the play also stands in stark opposition to the popular culture of the Third Reich with the hero and the heroic corresponding to either Hitler's persona or a Hitler like persona. It is also pertinent to mention that the absence of a conventional hero in Brecht's theatre reiterated the presence of the Captain Americas who could thrive in the American mass culture. At the beginning, the play invites the faith of the spectators/readers in Galileo's quest for scientific truth. Yet, unlike the conventional, eccen-

His characters are not romantic heroes, whose triumphs conceal the underlying play of power .They are agential in so far as they are constantly regurgitating the politics of the "obvious" and are fighters in their endeavours to critique. The oldest roots of present-day human genetic variation reach back to northeastern Africa at a time before our species originated, according to Anthony Wilder Wohns, a postdoctoral researcher in genetics at the Broad Institute of the Massachusetts Institute of Technology and Harvard University and lead author of the study published in the journal Science.

"The very earliest ancestors we identify trace back in time to a geographic location that is in modern Sudan. These ancestors lived up to and over one million years ago - which is much older than current estimates for the age of Homo sapiens - 250,000 to 300,000 years ago. So bits of our genome have been inherited from individuals who we wouldn't recognize as modern humans," Wohns said.

This million-year-old genetic contribution likely came from the species Homo erectus, Wohns said. Homo erectus, which lived from about 1.9 million years ago to 110,000 years ago, was the first species in the human evolutionary lineage with body proportions resembling our own.

The study, spearheaded by the University of Oxford's Big Data Institute, also documented how extinct human species such as the Denisovans and Neanderthals left genetic descendants among modern-day people around the world, though not in Africa.

"For example, people in Papua New Guinea and Oceania have quite large amounts of Denisovan ancestry, but even people living in Europe have some ancestry that looks like these ancient people," Wohns said.

The study helped shed light on when and where major population developments unfolded, such as the large-scale "out of Africa" migration that led our species to distant locales and occasional interbreeding with Denisovans and Neanderthals.

"Our method uses DNA sequences to learn about the ancestral relationships between individuals. Informally, ence in those regions.

"Our method estimated that there were ancestors in the Americas by 56,000 years ago. We also estimated significant numbers of human ancestors in Oceania - specifically Papua New Guinea - by 140,000 years ago," Wohns

added. "But this is not firm evidence like a radiocarbon-dated tool or fossil."

The researchers built the genealogy using 3,601 genetic samples from people around the world and eight ancient samples, the oldest coming from Neanderthal remains about 110,000 years old from a Siberian cave. They examined genome fragments from 3,500 ancient humans but did not directly incorporate these into the genealogy.

"The story of humanity is written in our genes," Wohns said, "and reconstructing our genealogy allows us to read that history."

Nothing Wrong In Judges Being Pro-Govt Or Against Govt, Says Delhi HC CJ

NEW DELHI: There is nothing wrong with judges being progovernment or against the government as they may have different outlooks and approaches towards the issues before them and it leads to the development of law, said Delhi High Court Chief Justice DN Patel on Friday.

Some judges are pro-labour, pro-employer, pro revenue, against revenue. Nothing is wrong. You see people are criticising... There is nothing wrong that you are pro-labour, proemployer, pro-tenant, pro-landlord, pro-government, against the government. There is always the development of law by these types of judgement, said Justice Patel, who will demit the office of Delhi High Court Chief Justice after attaining the superannuation age of 62 years on March 12.

The Chief Justice, while speaking at the farewell reference organised by the high court, said that judges are only interpreters and are not here to make the law or to evolve a policy and a balance has to be maintained between judicial activism and restraint.

Whenever there is a gap between law and justice, as an exception, there is bound to be judicial activism and the same cannot be a matter of role, he added.

On November 3, 2020, a bench headed by Justice Patel took suo motu cognizance of the clash between lawyers and police at Tis Hazari court and ordered a judicial inquiry by one of its retired judges into the incident.

Born on March 13, 1960. Justice Patel enrolled as an advocate on July 28, 1984, and practiced at the Gujarat High Court.

He was appointed as Additional Central Government Standing Counsel in 1999 and as Senior Central Government Standing Counsel in July 2001.

Justice Patel was elevated as an Additional Judge of the Gujarat High Court on March 7, 2004. and took oath as its permanent Judge on January 25, 2006.

PAK VS AUS 2nd Test: ICC Rates Rawalpindi Wicket 'Below Average'

KARACHI: The International Cricket Council rated the pitch for the first Test between Pakistan and Australia below average after the match ended in a dull draw earlier this week.

There were only 14 wickets taken over the five days of Australia's first Test in Pakistan since 1998. Pakistan scored 476-4 declared and 252 without loss with Australia replying with 449 all out as bowlers toiled and batters dominated on a lifeless flat track.

"The character of the pitch hardly changed over the course of five days and there was no deterioration apart from the bounce getting slightly lower," Ranjan Madugalle, the match referee for the Test, said in a statement issued by the ICC.

"The pitch did not have a great deal of pace and bounce in it for the seamers nor assisted the spinners. In my view this does not represent an even contest between bat and ball. Therefore, in keeping with the ICC guidelines I rate this pitch as below average.'



PARIS: The Ballon d'Or will now be awarded based on performances over the course of a regular European season, rather than a calendar year, France Football magazine said Friday. A reduction in the number of voters was among other changes announced, with the goal of streamlining the process. Voters also will no longer consider a player's career accomplishments.

France Football magazine has given out the award to men every year since 1956 and to women each year since 2018, though both were canceled in 2020 because of the pandemic.

"No more January to December," the magazine said on Twitter. "The (Ballon d'Or) will now be awarded on the basis of a classic football season: August to July.

Paris Saint-Germain and Argentina great Lionel Messi won for a record-extending seventh time and Alexia Putellas of Barcelona and Spain became the third winner of the women's award for 2021. Messi edged out prolific Bayern Munich and Poland striker Robert Lewandowski.

The switch means the next Ballon d'Or award will encompass the 2021-22 season, ending with the women's European Championship in July. The next award ceremony will be in October. (AP)

Russian Olympic Body Challenges Ban From Winter Sports Event

LAUSANNE, Switzerland: The Russian Olympic Committee made an urgent appeal Friday to overturn a ban on its athletes competing at a European winter sports festival in Finland.

The Court of Arbitration for Sport said it was setting a timetable for the case ahead of the Winter European Youth Olympic Festival being held from March 20-25. The ROC appeal challenges a March 2 decision by the executive committee of the European Olympic Committees to exclude Russian and Belarusian athletes because of the war in Ukraine.

In a separate Russian case at CAS, the national soccer federation has appealed against bans on national and club teams by FIFA and UEFA. Those suspensions were imposed March 1 within hours of the International Olympic Committee urging sports bodies to act to isolate Russia after the military invasion. (AP)
