**Srinagar:** Police on Wednesday claimed to have killed three Lashkar-e-Taiba (LeT) militants involved in the recent killing of a Sarpanch in the city outskirts, besides two policemen, including an Inspector in Srinagar and south Kashmir's Anantnag district.

army's 50RR Police, launched a cordon and search operation in Nowgam area of the city on the basis of specific input about the presence of militants, a police spokesperson said Wednesday. The hiding militants, he said, opened heavy fire upon the search team when they were moving towards the suspected spot.

The joint team, he said, retaliated effectively to the militant fire setting off an encounter.

The spokesperson said that later paramilitary CRPF personnel also joined the operation in which three categorized militants were killed and their bodies were retrieved from the encounter site.

### **Govt Restructures State** Marriage Assistance Scheme

**One Time Financial** Help Of Rs 50K Extended To AAY, PHH **Ration Card Holders Observer News Service** 

Jammu: The Jammu and Kashmir administration on Wednesday restructured the State Marriage Assistance Scheme to provide the benefits to all Antyodaya Anna Yojana (AAY) or Priority Household (PHH) ration card holders with a one-time financial assistance of Rs. 50,000.

The decision to restructure the scheme was taken in the Administrative Council meet chaired by Lieutenant Governor, Manoj Šinha here on Wednesday, an official spokesperson said.

As per the restructured scheme, he said, any girl of legally marriageable age belonging to the families of Antyodaya Anna Yojana (AAY) or Priority Household (PHH) ration card holders, will be eligible for one-time financial assistance of Rs. 50,000.

"The assistance will be given before her marriage, for which she will be required to apply at least one month in advance to the concerned District Social Welfare Officer," he said.

Deputy Director, Fire and Emergency services (Kashmir) Bashir Ahmed Shah told Kashmir Observer that the city being congested is one of the main reasons that it witnessed the highest number of fire incidents.

## What You Eat Can Reprogram Your Genes – An Expert Explains The Emerging Science Of Nutrigenomics

People typically think of food as calories, energy and sustenance. However, the latest evidence suggests that food also "talks" to our genome, which is the genetic blueprint that directs the way the body functions down to the cellular level.

This communication between food and genes may affect your health, physiology and lon-gevity. The idea that food delivers important messages to an animal's genome is the focus of a field known as nutrigenomics. This is a discipline still in its infancy, and many questions remain cloaked in mystery. Yet already, we researchers have learned a great deal about how food components affect the genome.

I am a molecular biologist who researches the interactions among food, genes and brains in the effort to better understand how food messages affect our biology. The efforts of scientists to decipher this transmission of information could one day result in healthier and happier lives for all of us. But until then, nutrigenomics has unmasked at least one important fact: Our relationship with food is far more intimate than we ever imagined.

#### The interaction of food and genes

If the idea that food can drive biological processes by interacting with the genome sounds astonishing, one need look no further than a beehive to find a proven and perfect example of how this happens. Worker bees labor nonstop, are sterile and live only a few weeks. The queen bee, sitting deep inside the hive, has a life span

that lasts for years and a fecundity so potent she gives birth to an entire colony.

And yet, worker and queen bees are genetically identical organisms. They become two different life forms because of the food they eat. The queen bee feasts on royal jelly; worker bees feed on nectar and pollen. Both foods provide energy, but royal jelly has an extra feature: its nutrients can unlock the genetic instructions to create the

anatomy and physiology of a queen bee. So how is food translated into biological instructions? Remember that food is composed of macronutrients. These include carbohydrates or sugars – proteins and fat. Food also contains micronutrients such as vitamins and minerals. These compounds and their breakdown products can trigger genetic switches that reside in the genome.

Like the switches that control the intensity of the light in your house, genetic switches determine how much of a certain gene product is produced. Royal jelly, for instance, contains compounds that activate genetic controllers to form the queen's organs and sustain her reproductive ability. In humans and mice, byproducts of the amino acid methionine, which are abundant in meat and fish, are known to influence genetic dials that are important for cell growth and division. And vitamin C plays a role in keeping us healthy by protecting the genome from oxidative damage; it also promotes the function of cellular pathways that can repair the genome if it does get damaged.

Depending on the type of nutritional information, the genetic controls activated and the cell that receives them, the messages in food can



influence wellness, disease risk and even life span. But it's important to note that to date, most of these studies have been conducted in animal models, like bees.

Interestingly, the ability of nutrients to alter the flow of genetic information can span across generations. Studies show that in humans and animals, the diet of grandparents influences the activity of genetic switches and the disease risk and mortality of grandchildren.

#### **Cause and effect**

One interesting aspect of thinking of food as a type of biological information is that it gives new meaning to the idea of a food chain. Indeed, if our bodies are influenced by what we have eaten – down to a molecular level – then

what the food we consume "ate" also could affect our genome. For example, compared to milk from grass-fed cows, the milk from grainfed cattle has different amounts and types of fatty acids and vitamins C and A . So when humans drink these different types of milk, their cells also receive different nutritional messages.

Similarly, a human mother's diet changes the levels of fatty acids as well as vitamins such as B-6, B-12 and folate that are found in her breast milk. This could alter the type of nutritional messages reaching the baby's own genetic switches, although whether or not this has an effect on the child's development is, at the moment, unknown.

And, maybe unbeknownst to us, we too are part

of this food chain. The food we eat doesn't tinker with just the genetic switches in our cells, but also with those of the microorganisms living in our guts, skin and mucosa. One striking example: In mice, the breakdown of shortchain fatty acids by gut bacteria alters the lev-els of serotonin, a brain chemical messenger that regulates mood, anxiety and depression, among other processes.

#### Food additives and packaging

Added ingredients in food can also alter the flow of genetic information inside cells. Breads and cereals are enriched with folate to prevent birth defects caused by deficiencies of this nutrient. But some scientists hypothesize that high levels of folate in the absence of other naturally occurring micronutrients such as vitamin B-12 could contribute to the higher incidence of colon cancer in Western countries, possibly by affecting the genetic pathways that control growth.

This could also be true with chemicals found in food packaging. Bisphenol A, or BPA, a com-pound found in plastic, turns on genetic dials in mammals that are critical to development, growth and fertility. For example, some re-searchers suspect that, in both humans and animal models, BPA influences the age of sexual differentiation and decreases fertility by making genetic switches more likely to turn on. All of these examples point to the possibility that the genetic information in food could arise

not just from its molecular composition - the amino acids, vitamins and the like – but also from the agricultural, environmental and economic policies of a country, or the lack of them.

## ADC Sgr Imposes Fine On Food **Business Operators**

In a statement, a spokesperson said that those fined include Edible Oil manufacturing company namely M/S Shree GRG Oil Mill, from Shri Ganganagar, Rajasthan having brand Name "Ulfat Mustard Oil" on whom Rs. 40,000/- has been imposed.

The statement reads that these complaints were filed by Food Safety Officers of District Srinagar after obtaining prosecuting Authority from Assistant Commissioner Food Safety.

"Moreover, 22 complaints against various Food Business Operators who do not adhere to the requirements of Food Safety and Standards Act were prepared for presentation before competent court. These include 4 butchers and 4 milk manufacturing units," it reads. (KNS)

**Students Decry Mandatory Mask Mandates At Educational Institutes**

rinagar: As the number of Covid cases hit an all-time low in Kashmir, students across various educational Institutes are urging the administration to do away with the compulsory face masks.

Students from various Institutes said the authorities ask them to wear face masks as they enter the premises of their Educational Institutes.

SahilIbn Sultan a B.Ed. student at Government College of Education said the college administration forces them to wear masks as they enter the college.

"I have taken both the shots of the covid vaccine and I don't feel the need to wear mask at the moment' Sahil said.

"With day temperatures increasing, wearing a mask is nauseating. he added. Students from other Educational Institutes also voiced similar concerns.

"The doctors association has also

suggested that most people in Kashmir can do away with the masks" said Muneer Hussain a student of Cluster University.

"I think it is not necessary anymore" he added.

The Doctors Association Kashmir (DAK) had recently suggested that most people in the Valley do not need to wear masks now due to the low number of Covid cases. The association, while referencing Centers for Disease Control (CDC) and Prevention guidelines, said that Kashmir is a low risk area now.

Doctors Association Kashmir (DAK) on Monday said most people in Kashmir valley do not need to wear masks under new guidelines.

"Masks can come off in schools too," said DAK President and influenza expert DrNisarul Hassan.

Dr Hassan said according to new CDC guidelines, people who are living in areas of low Covid-19 levels no longer need to wear masks.

"Under new norms, masks are not recommended if average new cases fall below 200 per 100,000 population, there are fewer than 10 Covid hospital admissions per 100,000 people over the past one week and Covid patients are taking up less than 10 percent of available hospital beds, based on seven day average," he said.

"If cases exceed 200 per 100,000 people, masks are recommended if new weekly Covid admissions exceed 10 per 100,000 people and patients are taking up 10 percent or more hospital beds based on a seven day average," he added.

With the UT of Jammu and Kashmir recording negligible number of covid cases, students have urged authorities not to force students to wear face masks.

Meanwhile, UT of J&K reported 17 new positive cases of novel Corona virus on Wednesday, 8 cases were reported from Jammu Division and 9 from Kashmir Division.

## Living with Covid

Just as we were thinking that Covid-19 pandemic is on its way out, its resurgence in China and Hong Kong has taken the world by surprise. Nearly 30 million people have been put under lockdown across China, as surging virus cases prompted the return of mass tests and health officials to city streets on a scale not seen since the start of the pandemic.

China reported 5,280 new Covid-19 cases on Tuesday, more than double the previous day's tally, as the highly transmissible Omicron variant spreads across a country that has, so far, stuck to a "zero-Covid" strategy. But this time China is finding itself struggling to reign in the new outbreak. Although Omicron has turned out to be milder than the Delta variant, it is several times more transmissible. So, its outbreak is difficult to control immediately. At the same time, the spread of Omicron infections doesn't take a toll on the healthcare infrastructure as hospitalizations are fewer and far between. But not necessarily so.

Hong Kong has witnessed a sudden steep spike in cases since December despite being the country least affected by the pandemic over the last two years. Officially, there have been more than 740,000 cases since late December, out of a population of 7.4 million. But researchers at the University of Hong Kong have estimated that 3.6 million people - almost half the population - have contracted the virus. The country has also recorded 4000 deaths, mostly among the elderly, which is the world's highest per capita rate. Similar outbreaks but on a smaller scale have been reported in places like Singapore and New Zealand, which effectively means that the Covid-19 pandemic is not going anywhere.

This brings us to the question of the future of the Covid-19 virus. Over the last two years, the world has been through several successive waves of the pandemic which have infected millions and claimed hundreds of thousands of lives. With the abating of the Omicron wave in India which broke out early this year, there was now a sense of relief across the world. The economies are re-opening. There is a realization that the worst is over and the pandemic is gradually on its way out.

But is it really so, going by the fresh outbreaks in China, Hong Kong, Singapore and New Zeeland? Not necessarily. The virus is still potent enough to cause widespread havoc. As of now, it is difficult to imagine what future shape the virus will take. Whether herd immunity will save us? Whether the virus will become endemic in some milder form like our everyday cold. Or whether deadlier variants of the virus are on their way. The current situation in China and Hong Kong gives little cause for confidence. For now, there is no other way to safeguard ourselves but to continue to follow the Standard Operating Procedures.

## **Between Guns and Roses** J&K's Film Policy and Bollywood's Depiction Of Kashmir

ollywood rekindles romance with J&K as filmmakers find picture-perfect", read a news report that appeared just a day ago. The chartering of J&K Film Policy 2021, the active intervention, advocacy and appraisal of the honourable governor, pitching Kashmir as the finest destination of filmmakers and roping in bureaucrats, public figures and celebrities to promote Kashmir on the filmmaking map has resurged the interest of stakeholders. The unveiling of Kashmir Files, for better or worse, has reignited the perception of Kashmir and its influence of forthcoming movies on Kashmir shall be the object of interest for cinema lovers, film critics and commoners. But in the midst of all this, while Kashmir continues to serve as the canvas or colour of Bollywood, the question of characterization and portrayal of Kashmir in Bollywood, its people and issues topical to it deserve special revisit and revaluation.

When Europeans landed in Asian and African countries, they started to reconceptualise the identity, ethos, values, modes of life and existence of the natives. They thought of native cultures as laboratories and juxtaposed the notions they had developed in their homeland. This enterprise was so demeaning and dehumanising that centuries after, the approach was bracketed within the hateful academic adventure of "Orientalism". The Europeans objectified the natives to the point of representatives of inhumanity, barbarism and backwardness. The approach has backfired though and an entire corpus of Oriental literature has come to be received with a pinch of salt and even the genuine and impartial works of Oriental scholars have come under scrutiny. Something similar is shaping the relationship between Bollywood and Kashmir and this calls for an immediate attention lest it translates itself into a snowball effect.

Described as the "Paradise on Earth", Kashmir has been for long a sought after and cherished shooting place for Bollywood players. The decades of 70s and 80s witnessed a boom in Bollywood's influx to Kashmir and films like Kabhi Kabhi, Noorie, Silsila and others, saw the light of the day and further augmented and strengthened the position of Kashmir on film shooting map.

However, the chain of events, as it unfolded in the 1990s, changed the situations in the valley and this led to abandoning of the valley by filmmak ers. While Valley came to be vacated by filmmakers, it grabbed the ideas and ideology of Bollywood in other ways. The events unfolding in Valley started to be seen in the backdrop of narrative building and ideological warfare and removed from the paradigm of scenic beauty and filmmaking, the spot came to be seen as the space of violence, bloodletting and aggressive shooting. Let's try to understand how Bollywood has chronologically portrayed Kashmir and what are the cautions that need to be observed in this schema of portrayal.

featured lush green rolling hills and verdant meadows, gently flowing streams, snow-capped mountains and nature in all its splendour. The vale was portrayed as a wonderland, far removed from the tensions and turmoil that characterized the rest of India in particular and World in general around these times.

This, in a way, represented the collective subconscious to escape the tragedies that characterised everyday life in search of tranquillity, ecstasy and Utopian ideals of Joy and merrymaking. Prateek Sur, in his article, characterizes this era by saying that "The location was so much in demand that, at a time, there were at least six-seven shoots happening in Kashmir. The number went up more so during the winters when all the locales used to get covered in snow. There was a colloquial saying from that period which stated that the entire film industry used to be chilling together in Kashmir during the winters"

There were both visible and hidden agendas playing behind this emphasis on the scenic and serene aspect of Kashmir and it was driven by the multiple engines of narrative building, economic considerations and political contestations. The grim and gore aspects of abject poverty, underlying political instability and regional uncertainty were brushed under the carpet in these movies. But this representation, character izing valley by serenity and calm was to change soon and forever and the cascade of events erupting in 90s, suddenly gave way to the portrayal of Kashmir in Bollywood movies that radically differed from the prevalent characterisation. The first prominent change was that the Valley ceased to be a scenic background and the canvas on which were projected the outside incidents. The incidents, political events in particular, began to occupy the central stage in Bollywood cinematics and the gentle happy-go-lucky attitude of the Kashmiri locals gave way to characters who were shown as potential terrorists

"The shots of tribal women grazing sheep in the valley were soon changed to heavily armed forces", notes Prateek.

Representation of Kashmiris has thus oscillated from overly passive and generalized to overly aggressive, mirroring India's political discourse of the disputed valley as dangerous. Romance gave way to danger as guns replaced sheep and heavily armed forces replaced tribal women in a politicized narrative twist.

Kashmir's pure white snow now drips with blood. There has been a flurry of Bollywood films from the 1990s onwards keen to capitalize on Kashmir's violence. These films conflated Kashmiris with terrorism and positioned Islam as dangerous threat. Mission Kashmir (2000) offered a tragic revenge narrative where a young Kashmiri man was driven to violence, though the film shied away from depicting the horrors of statesponsored violence. Also released in 2000 was Fiza, about a Kashmiri family living through the 1993 Mumbai riots where the son joins a terrorist organization.

Similarly, Fanaa (Destroyed in Love, 2006) features a Kashmiri terrorist who ultimately sacrifices his life for his cause. "Director Vishal Bhardwaj extends the trope of a tragic avenging young man in Haider (2014), his critically acclaimed adaptation of William Shakespeare's Hamlet The film is set amidst Kash mir's insurgency in 1995 and features Shahid Kapoor as Haider, a young student and poet, searching for answers about his father's disappearance and haunted by years of violence between militants and the army. Neither side comes across well, with enforced disappearances and state-sponsored violence depicted in one of the most realistic interpretations of the violence seen on screen to date. Seemingly unable to move on from his haunted past, Haider loses himself to revenge and in the process advances the association of Kashmir as troubled, violent, and unable to escape from itself", Writes Alexander D. Bhattacharya. The later generation films have largely revolved around the conflict and

the issues arising there from. Raazi, a movie released in 2018, is a representative sample from this genre of films. These pictures have swung on the perennial theme of classifying the Muslim subjects of the state as the defining "Other" and an icon of political and security threat for the rest of the country.

Thus, we see the repetition of the archetype of violence, identified with the Muslim subjects of the state, as the dominant theme permeating the oeuvre of Bollywood industry post 90 incidents. The aesthetic objectification of valley during the first wave and the vulgar depiction of people as agents of violence and disorder and thwarting them against the rest of India has created a pandemonium of sorts by paving the way for misrepresentation and mischaracterization of Muslim subjects and by analogy, of the entire valley. This uncensored and uncorrected representation awakens us to the fallacies of film-makers and the first of which is the objectification of people. Films have bereft the native people of their inherent agency of action and have been assigned the character and agency suitable to the theatrics of Bollywood, no matter how anti-polar it stands to the reality. Another error on part of Bollywood has been to posit the natives as ever-serving "Political Other" and what Rene Girard defines as the "Scapegoat of violence". This has significantly defined the attitude and behaviours of people from other cities towards the people from Kashmir and the repercussions thereof have been terrible.

Media can't speak too much of its impartiality and value neutrality. It has a definite, long lasting and sometimes most powerful impact on the psyche of viewers. It thus needs to be careful in its portrayal and representations. This public image and influence of media, and Bollywood in this case, demands high standards of accuracy – historical, political and ideological on part of producers and other men at the helm of affairs. This sense of responsibility demands higher attention when it comes to Kashmir - the place which has already been subject to contestations and negative portrayals. Referring to and benefitting from authentic historical sources, eye-witnesses and authorities - across the religious and ideological divide shall be the task of premier importance in any adventure that aspires to the representation of Kashmir. It is incumbent upon filmmakers to represent their characters with neutrality and without framing them in any value-judge ment framework. More important is to shun away the exotic representation and presaged portrayal of people to avoid any misadventures arising from these characterizations. Lest Bollywood wakes itself to these responsibilities, there is an imminent danger of Bollywood seeing itself characterised as propaganda engine and hate mongering industry with reference to Kashmir.

### Growing price pressures: On need to tame inflation

nflation in India continues on a worrying uptrend with the consumer price index-based reading accelerating to an eight-month high of 6.07% last month, while wholesale prices logged a double-digit increase for the eleventh straight month. February's headline WPI inflation spurted to 13.11%. Retail inflation remained stuck above the RBI's upper tolerance threshold of 6% for the second month, as food price inflation quickened to 5.85%. Households in the hinterland bore a bigger brunt of the burden as price gains measured by the consumer food price index for rural areas surged by 69 basis points from January's level, to 5.87%. Price gains in the key protein source of meat and fish jumped by almost 200 basis points from the preceding month to 7.45%, while nutrient-rich vegetables also logged inflation of 6.13% in February, belying the central bank's prognostication last month of an "expected easing of vegetable prices on fresh winter crop arrivals". And even though inflation in oils and fats eased by more than 220 basis points to 16.44%, there is little room for cheer, given that one can expect a spike again this month in the wake of the abrupt disruption in the supply of edible oils from war-torn Ukraine, which is the largest source of sunflower oil imported into India. With price gains in clothing and footwear, fuel and light and transport and communication all running well above 8% levels, the overall trend in retail inflation is now clearly broad-based across consumption categories and disconcertingly way above tolerance levels.

Also, with the pump prices of fuels yet to reflect the recent upsurge in international oil prices in the wake of Russia's invasion of its southwestern neighbour, transport and communication inflation is certain to climb sharply once state-run refiners reset prices to reflect crude costs. The price of India's crude basket had already risen by over \$20 a barrel since December to \$94.07 last month and with global crude prices currently in uncharted territory on account of the war, and the rupee having weakened by about 2.5% against the dollar since the start of the conflict, it is hard to see any near-term relief on the fuel price front. A glance at last month's producer prices of the energy basket shows inflation in the fuel and power category of the wholesale price index was at 31.5%. And in a sign that manufacturers are no longer able to keep absorbing cost pressures, inflation in manufactured products accelerated to 9.84% presaging more pain for consumers. RBI Deputy Governor Michael D. Patra had last week cited the headroom available for the Government to cut taxes on fuels as a source of comfort on the inflation front. With the RBI's latest consumer confidence survey showing most households reporting further increases in overall spending on essentials and remaining far from sanguine on the prices outlook, policymakers need to act expeditiously to tame inflation or risk it undermining the very growth they are currently focused on supporting. ## **Facilitate Drug De-Addiction**

recent study conducted by Srinagar based Institute of Mental Health and Neuroscience (IMHANS) in a Drug De-addiction centre in Srinagar, found that over two-third of patients in the study had started substance abuse in the age group of 11-20 vears. The most common substances of abuse identified included nicotine (94.4%), medicinal opioids (65.7%), cannabis (63.6%), benzodiazepines (45.5%), other prescription medications (43.4%), alcohol (32.5%), inhalants (11.1%), and cocaine (7.5%). The study revealed that poly-substance abuse was found in 91.9% of the studied patients. Inhalant use was seen predominantly among adolescents (54.5%) whereas nicotine (50.2%), cannabis (49.2%), alcohol (51.1%), opioids (58.4%), and benzodiazepines (53.48%) were more predominant in the age group of 21 to 30 years. According to a survey conducted by the Ministry of Social Justice and

Empowerment (MoSJE) in February 2019, 600,000 people, i.e. 4.6 percent of the total population of Jammu and Kashmir use opioid drugs, 80 percent of the drug addicts in Kashmir use heroin and morphine.

The problem of drug abuse not only affects the physical, mental and social health of the individuals but it disturbs and burdens the whole family. It also gives great threat to family happiness and creates individual, family, economic and social disorganization.

## The future of work is hybrid – here's an expert's recommendations

COVID-19 has changed the way we work.

ven before the pandemic, the U.S. workforce increas-✓ingly relied on remote collaboration technologies like videoconferencing and Slack. The global crisis accelerated the adoption of these work tools and practices in an unprec-edented way. By April 2020, about half of companies reported that more than 80% of their employees worked from home because of COVID-19.

That shift was made possible by decades of research into, and then development of, technologies that support remote work, but not everyone uses these technologies with the same ease. As early as 1987, groundbreaking research identified some of the challenges facing women working from home using technology. That included the difficulties of child care, work-home separation and employee growth opportunities.

Since that time, we have learned much more about virtual collaboration. As an associate professor of information systems, I'm interested in what we can expect as we eagerly anticipate a post-pandemic future. One thing stands out: Hybrid work arrangements – that is, employees who do some tasks in the office and others virtually - is clearly going to be a big part of the picture.

One survey from April 2021 shows 99% of human resources

leaders expect employees to work in some kind of hybrid arrangement moving forward. Many have already begun. As just one example, Dropbox, the file hosting service, made a permanent shift during the pandemic, allowing employees to work from home and hold team meetings in the office.

The definition of "hybrid" varies in other organizations. Some workers might be in the office a couple days a week or every other day. Other businesses may require only occasional face-to-face time, perhaps meeting in a centralized location once each quarter.

Either way, research does show many companies fail in their implementation of a virtual workforce.

#### **REMOTE WORK VERSUS IN** THE OFFICE

In-office work promotes structure and transparency, which may increase trust between management and workers. Developing an organizational culture happens naturally. Casual office conversations - a worker walking down the hall for a quick and unscheduled chat with a colleague, for instance - can lead to knowledge-sharing and collaborative problem-solving. That's difficult to replicate in a virtual environment, which often relies on advance scheduling for online meetings - although that's still feasible with

enough planning and communication

But if you look at different metrics, in-office work loses out to working from home. My recent research discovered remote workers report more productivity and enjoy working from home because of the flexibility, the ability to wear casual clothes, and the shortened or nonexistent commute time. Re-

mote work also saves money. There is a significant cost savings for office space, one of the largest budget line items for organizations.

Hybrid arrangements attempt to combine the best of both worlds.

#### **IT'S NOT PERFECT**

It's true that hybrid work faces many of the same obstacles of face-to-face work. Poor planning and communication, ineffective or unnecessary meetings and confusion about task responsibilities happen re-

motely as well as in-person. Perhaps the largest issue when working at home: technology and security concerns. Home networks, an easier target for cyberthreats, are typically more vulnerable than of-

fice networks. Remote workers are also more likely to share computers with someone else outside of their organization. Hybrid organizations must invest upfront to work through these complicated and often expensive issues.

With hybrid work, managers cannot see the work taking place. That means they must measure employee performance based on outcomes with clear performance metrics rather than the traditional focus on employee behavior.

Another potential pitfall: Fault lines can develop within hybrid teams - that is, misunderstandings or miscommunication between those in the office and those at home. These two groups may start to divide, potentially leading to tension and conflicts between them an us-versus-them scenario.

#### **ESTABLISHING A HYBRID ENVI-**RONMENT

Numerous recommendations exist on the best way to develop a hybrid model. Here are a few of the best ideas.

Meeting too often or with little purpose – that is, meeting for the sake of meeting - leads to fatigue and burnout. Not everyone needs to be at every meeting, yet finesse from management is required to make sure no one feels left out. And meeting-free days can help with productivity and allow

employees a block of uninter-

rupted time to focus on complex projects.

Listening to employees is critical to making sure the hybrid environment is working. Continually seeking feedback, through one-on-one conversations, focus groups or human resources surveys, is important too. So is recognizing and rewarding employees with inperson or virtual kudos for their achievements. Performance incentives, such as financial rewards or tokens of appreciation including food delivery, help develop a supportive culture that increases employee commitment.

Finally: Both managers and employees must be transparent in their communication and understanding of hybrid plans. Policies must be in place to define what tasks happen in the office and remotely. Access to reliable communications is essential, particularly for remote work. All employees must receive the same information at the same time, and in a timely manner. After all, whether in the office or online, workers don't want to feel they're the last to know.

## What Is An Nft And How Does It Work? The 'Bitcoin For Art' Explained

Digital images are being sold for thousands of dollars, but critics point to the harm it does to the environment

value - the scarce nature of NFTs, and the thick wallets of people with enough cryptocurrency to purchase them.

Moreover the volatility of the market, where NFTs can surge and drop very rapidly, means that only people with enough disposable income to be protected from a bad investment. This, once again, puts it in favour of the rich.

Chris Torres, the artist who first created Nyan Cat, recently 'minted' a new GIF of the famous internet meme which sold for over \$470,000 worth of the Ethereum cryptocurrency in February 2020.

Mrs Trump put a "breathtaking water-color art" for auction entitled "Melania's Vision". Priced at \$186, the image is a closeup of the former First Lady's eyes. It also includes a includes an audio recording of Trump, and a portion of the proceeds will go to "assist children aging out of the foster care system".

Grimes sold 10 images of digital artwork, the most expensive for nearly \$400,000, to someone who wanted ownership of the online goods.

These artworks are called NFTs, or "nonfungible tokens", and they exist on a similar blockchain technology to bitcoin as a way to prove "ownership" of them.

On an internet built on spreading images for free over social media platforms, the idea of tying ownership to a specific, single image that one did not create is peculiarbut it is not new.

The idea has exploded into popularity recently based on the rise of cryptocurrency technologies, and the desire for digital artists to have greater ownership - and monetisation options - over their craft.

#### WHAT IS AN "NON-FUNGIBLE TOKEN"?

A non-fungible token (NFT) means a digital item that belongs to the person that purchased it. In economics, fungibility is the property of a good being interchangeable, or replicable. For example, if you shared a photo from your phone to another person over a text message, the data and image would be replicated.

The NFT does not stop that replication - WHAT ARE SOME EXAMPLES OF NFTS? you could still take a screenshot of a digital artwork, or share a Nyan Cat GIF - but it does show who 'owns' an original image - in the same way your passport image also contains your name, age, and an identifica- ferent 'characteristics' and users swapped tion number. #### WHAT ARE THE DRAWBACKS?

The obvious drawback is that, unlike a one-of-a-kind painting or a sculpture, ownership of a digital artwork does not stop anyone else from also 'owning' it. You can download the content from Grimes' Twitter page and 'own' it, in that you have a copy that you can distribute.

"I don't find NFTs enticing as a platform for releasing art on," v buckenham, a London-based digital artist, told The Guardian.

"The point of owning a piece of art is to look at it and enjoy it – and buying an NFT doesn't do anything to help you do that. An NFT is just an entry in a fancy database somewhere asserting that you 'own' the artwork. The only thing it's good for is allowing you to sell on that database entry to someone else later on."

There's also the environment, which cryptocurrency technology is currently at odds with. It is estimated that the energy used to mine bitcoin is more than that used by entire countries. ## HC Allows Reopening Of Nizamuddin Markaz During Shab-e-Barat

NEW DELHI: The Delhi High Court Wednesday allowed reopening of three floors of Nizamuddin Markaz, where the Tablighi Jamaat congregation was held in March 2020 amid the COVID-19 pandemic and has remained shut since then, to enable devotees to offer prayers during Shab-e-Barat.

Justice Manoj Kumar Ohri removed the restriction of putting a limit of 100 people at one floor and said it has been agreed that the management of the mosque will ensure that COVID-19 protocols and social distancing will be followed while allowing devotees to enter the mosque to offer namaz.

While Delhi Police had imposed various conditions to be followed during the reopening of markaz on the occasion of Shab-e-barat, several of them were modified during the court hearing with mutual agreement between the police, Delhi Waqf Board and the management committee of the mosque.

The court noted that the ground floor and three other floors of the mosque building will be opened at 12 PM one day prior to Shab-e-Barat, which is on March 18, and will be closed the next day at 4PM.

The court, which was hearing an application by the Delhi Waqf Board seeking to open the mosque in view of Shab-e-Barat

and Ramzan in March and April, listed the matter for March 31 to decide on the issue of reopening the mosque during Ramzan which will begin from April 2.

Regarding the condition imposed by the police that foreign citizens and OCI card holders will not be allowed inside the markaz premises and if some devotee of foreign origin or OCI card holder intends to offer namaz at Masjid Bangley Wali, his identity details along with ID proof will be taken by the management and submitted to the SHO, the management said it a notice will put on the display board at the entry gate specifying this restriction.

While the police, through advocate Rajat Nair, initially said no tablighi activities will be

permitted during the reopening period, it was later agreed between the parties that opening of the mosque will be restricted only for offering prayers.

The court was informed that CCTV cameras have already been installed at the entry and exit points of the premises and the management will ensure that there will be screening of devotees with hand held thermal scanners at the entry point.

As senior advocates Sanjoy Ghose and Rebecca John, representing Delhi Waqf Board and the managing committee of the mosque respectively, initially submitted that the police letter was silent on the arrangement to made during Ramzan, Nair said

the modalities for that will be worked out after Shab-e-barat.

The high court had on March 14, asked the Delhi Waqf Board, represented through advocate Waqeeh Shafiq, to file an application before the SHO of Hazrat Nizamuddin Police Station seeking permission to open the other three floors of Nizamuddin Markaz to enable devotees to offer prayers during Shab-e-Barat and Ramzan.

The counsel for the police had earlier said he has no objection in allowing 50 persons to offer prayers at the mosque's first floor but the opening of the entire mosque cannot be permitted.

He had referred to the high court's April 15, 2021 order by which it had permitted 50 persons to perform

the Namaz five times at Masjid Bangley Wali on the first floor.

The Centre, in its recent affidavit, has opposed fully re-opening the Nizamuddin Markaz and stated that a few people may be allowed to offer prayers on the upcoming religious occasions.

The counsel for the Delhi Waqf Board had earlier said that the mosque, which is under the lock of Delhi Police, should be opened as the Delhi Disaster Management Authority (DDMA) has now lifted all restrictions that were imposed on account of the pandemic.

conscience forms a part of the right to privacy, it said.

The plea said the petitioner had approached the high court seeking redressal for the alleged violation of their fundamental rights against the state government order of February 5, 2022 issued under Sections 7 and 133 of the Karnataka Education Act, 1983.

The impugned government order directed the college development committees all over the state of Karnataka to prescribe a student uniform' that mandated the students to wear the official uniform and in absence of any designated uniform the students were mandated to wear an uniform that was in the essence of unity, equality and public order, it said.

The plea said the high court failed to note that the Karnataka Education Act, 1983 and the rules made thereunder do not provide for any mandatory uniform to be worn by students.

The plea claimed that the high court has failed to note that right to wear a Hijab is protected as a part of the right to conscience under Article 25 of the Constitution.

It said since the right to conscience is essentially an individual right, the Essential Religious Practices Test' ought not to have been applied by the high court in the case.

Assuming the Essential Religious Practices Test' does apply, the high court has failed to note that wearing of Hijab or headscarf is a practice that is essential to the practice of Islam, the petition said.

It claimed that the high court has failed to note that Indian legal system explicitly recognises the wearing/carrying of religious symbols.

The plea said Section 129 of the Motor Vehicles Act, 1988, exempts turban wearing Sikhs from wearing a hel-met and under the rules made by the Ministry of Civil Aviation, the Sikhs are allowed to carry kirpans onto aircraft. This public order was passed with

an indirect intent of attacking the religious minorities and specifically the followers of Islamic faith by ridiculing the female Muslim students wearing Hijab. This ridiculing attack was under the guise of attaining secularity and equality on the basis of uniform wherein the college development committees prohibited the students wearing Hijab from entering the premises of the educational institutions, it said.

Accordingly the instant bail application is dismissed and shall be attached with the Final Report of the instant case. Applicant/CICL may renew his praver for bail before this Board after the statement of victim is recorded by the Board during the course of enquiry," it said.

**SRINAGAR:** The High Court of J&K and Ladakh on Wednesday issued a notice to Ministry Home Affairs, Government of India and J&K administration on a petition filed by J&K's former Sadr-e-Riyasat and ex-Rajya Sabha member Dr Karan Singh, seeking directions for vacation of his property–Lake Pavilion, popularly known as Kabootar Khana, at Dal Lake Srinagar.

A single bench of Justice Dhiraj Singh Thakur issued the notice after hearing senior advocate Syed Faisal Qadiri on behalf 90-year-old son of Maharaja Hari Singh, stating in his plea that the property– 21 Kanals and 19 Marlas- be vacated from security forces as is the absolute owner of it.

The court has issued notice to Union of India through Secretary Ministry of Home Affairs, J&K through Secretary Home Department, Director General of Police, Central Reserve Police Force, Director General, Border Security Force, Director General of Police, Divisional Commissioner, Kashmir, and Deputy Commissioner, Srinagar. They have been asked to file response by April 20.

Dr Karan Singh said that in 1990 his property was taken over "unilaterally without fixation of any rent or the assessment of rental value" by Border Security Force until 1993.

He said Additional Secretary to 15 September 1993 accorded sanction to the grant of rent at Rs. 1464/ month for the entire property.

"Between the year 1990-2003, the property was under the occupation of Border Security Force and later it was handed over to Central Reserve Police Force on 11.12.2003, while BSF Water Wing also remained on the property."

Even at this stage, he said neither consent has been sought from occupation till the time the same is him nor was he informed about the handed over back to him. (GNS)

KARACHI: Pakistan captain Babar Azam hit a career-best 196 before the tailenders hung in to escape with a draw in the second Test against Australia on Wednesday.

Veteran off-spinner Nathan Lyon grabbed three late wickets to finish with 4-112 but Pakistan vice-captain Mohammad Rizwan thwarted Australia with an unbeaten 104 off 177 balls to guide Pakistan to 443-7 in a sensational last hour on the final dav

No. 9 batter Nauman Ali suc-cessfully defended 18 balls without scoring and saw off the last eight overs with Rizwan after Pakistan had slipped to 414-7.

With 13 overs left in the game, Lyon made inroads into Pakistan's lower order when Babar gloved a catch close to the wicket after defying Australia with his knock off 425 balls over 10 hours.

Left-hander allrounder Faheem Ashraf edged a low catch in the slip off Lyon's next delivery and Sajid Khan also offered a tame catch to Smith before Rizwan and Nauman batted patiently.

Debutant legspinner Mitchell Swepson (0-156) had provided Australia with another chance with 19 balls left in the game, but Usman Khawaja dropped a low catch off Rizwan at short extra cover.

Rizwan raised his deserved century by hitting Lyon for two boundaries on either side of the wicket in the penultimate over before running a single to reach the three-figure mark.

Babar's marathon effort, dur-ing which he hit 21 fours and a straight six, was the highest ever by any captain in the fourth innings of a Test match and surpassed Michael Atherton's 185 not out against South Africa in Johannesburg in 1995. Babar shared two solid stands

on the last day, adding 228 runs began. with Abdullah Shafique (96) and then, after losing Fawad Alam in

It was a remarkable escape by Pakistan at the fortress of its Test venues — the National Stadium – when it was out for 148 in the first innings on the third day against the reverse swing of Mitchell Starc and conceded a massive 408-run lead.

Australia then stretched its lead to 505 before declaring its second innings at 97-2, but its bowlers couldn't rattle the confidence of Babar, who batted almost five sessions and denied the visitors from taking a 1-0 lead in the threematch series.

Babar stayed firm and blunted the reverse swing of experienced fast bowlers Pat Cummins (2-75) and Starc (0-58), while also negating the spin threat of Lyon and Swepson for most of the last day.

Australia had its chances to dismiss Babar but Travis Head and Marnus Labuschagne dropped two sharp catches close to the wicket off Swepson's successive deliveries before tea just after the Pakistan skipper had surpassed his previ-ous Test best of 143 made against Bangladesh in Rawalpindi in 2020.

Cummins got both wickets on either side of the first two sessions after Pakistan resumed on 192-2 with Babar resuming on 102 and Shafique on 71.

Shafique grinded out Australia's bowlers for almost eight hours. When it looked like Pakistan will go unscathed at lunch. Cummins got the breakthrough in the penultimate over.

### Novak Djokovic, Russian Players **To Compete At French Open**

PARIS: Novak Djokovic will be allowed to play at the French Open even if he is not vaccinated against COVID-19 as long as the coronavirus situation in France remains stable, organisers said

Wednesday.

Russian tennis players, including top-ranked Daniil Medvedev, will also be admitted to play in the tournament but as neutral athletes because of the war started by their country in neighbouring Ukraine.

Organisers said there is nothing at the moment preventing Djokovic from defending his title at the clay-court Grand Slam. France this week lifted measures requiring the need to wear face masks in most settings and allowing people who aren't vaccinated back into restaurants,

sports arenas and other venues. "At this stage there is nothing to stop him returning to the courts," French Open director

Amelie Mauresmo said at a news conference.

Djokovic was deported from Australia in January after a legal battle over whether he should forcing him to miss the Aus- tral athletes. (AP)

tralian Open. He told the BBC last month that he was willing to miss upcoming Grand Slam tournaments as well if they required him to get vaccinated.

Djokovic has won the French Open twice and has a total of 20 major titles, one short of the record held by Rafael Nadal after the Spaniard won this year's Australian Open.

French tennis federation president Gilles Moretton said that although Djokovic is now free to play, French authorities might be forced to introduce new restrictions if the virus situation deteriorates before the tournament starts on May 22.

"It is not up to us," Moretton said
