

NEW DELHI: The Delhi Police on Wednesday filed a case against a hotelier after a Kashmiri man was allegedly discriminated against and denied accommodation despite advance booking.

Commissioner Deputy of Police (northwest) Usha Rangnani said a complaint was received at Mahendra Park Police Station stating that some people from Jammu and Kashmir were denied accommodation in a hotel in the area. A case under section 153-B(1)b (any member of a re-

ligious, racial, language or regional group or caste or community denied of rights) of the Indian Penal Code has been registered and investigation is in progress, the DCP said. The Delhi Police also clari-



### LG Unveils Rs 34,829 Cr Potential Linked Credit Plan Of NABARD **Observer News Service**

### **Lessons From Volcano Warnings In Predicting The Next Pandemic**

ovid-19 alerts and warnings can be better developed by bringing to-gether lessons learned from natural hazards like volcanoes.

Just a year after Covid-19 was identified, the world's pandemic warning system was deemed a failure by both the World Health Organisation and its independent panel, which found the world was not prepared for what lay ahead, despite the warnings. There are still no standardised alert systems for viral threats that cut across borders, but many lessons can be learned from the management of other hazards and threats. Warning systems for volcanoes are well established, and can provide bestpractice lessons' for the development of much-needed pandemic-alert systems at all scales.

Volcanoes have the most diverse range of any hazard. They are subject to one of the world's most frequently used warning systems, which consists of more than 80 volcano observatories that have been reviewed and improved to enhance their effectiveness over decades.

Though pandemics unfold differently to volcanic crises, volcanic eruptions involve many of the same issues. Scientific uncertainties, large at-risk populations, different industries, government bodies and nonprofit organisations are all involved. We do not have time to reinvent the wheel and fine-tune global health warnings.

Volcanoes are incredibly complex and require constant anticipatory monitoring. It is often too late to evacuate the surrounding region once a volcano erupts, when pyroclastic flows at temperatures over 1000 degrees Celsius can travel at the speed of a jet plane.

Volcanologists use a wide range of monitoring equipment to detect the movement of magma under the earth, the movement of the ground as the magma rises (ground deformation), gas emissions (gas trapped in the magma escaping to the surface) and water chemistry (mixing of the magma with groundwater).

All this data provides clues about what a volcano is doing, but combining it is ex-

tremely challenging, so alerts are often issued in anticipation of potential activity. Scientists, emergency and disaster special ists, local communities and different levels of government must cooperate well to prepare and immediately respond.

The 1985 tragedy of Nevado del Ruiz in Colombia, where warnings were not acted upon, resulted in more than 23,000 deaths. The White Island Whakaari volcano eruption in 2019 killed 22 people who were part of a tour group exploring the New Zealand island. These events taught the hard lesson that, despite improvements in scientific data and warnings, tragedy can still result if no action is taken in response.

The level of monitoring and warning we apply to volcanoes is needed to detect future pandemics. Most pandemic warnings focus on the event once it has spread to the community, but a radical shift to anticipatory warnings is needed. Too little attention is paid to the prevention of circumstances that increase health risks, such as deforestation, land-use change, intensive livestock production and climate change. Many nations have devised alert-level systems to protect local populations during the shift from full Covid-19 lockdown precautions to normality. To be effective and

timely, these alerts must be embedded in an extensive system of observation and communication that integrates different expert cohorts, tipping points, communication channels and iconography.

Existing warning systems are already used for hazards and threats such as severe weather, tsunamis, terrorism or chemical accidents. They often follow a traffic-light colour structure or numerical order (as commonly used in military contexts) and are standardised at national and international level.

Numerous alert systems were devised or used during the Covid-19 pandemic, there is no comparative study to establish which were most successful, and why.

However, there have been some success stories seen in New Zealand, South Africa, and South Korea amongst failures as seen in the UK, and the US.

Covid-19 alerts and warnings can be better developed by bringing together lessons learnt from the warning world from a range of hazards and threats to review elements of what makes warnings succeed and what makes them fail. There are three key lessons.

Firstly, warning systems can be effective in generating general awareness and acting as triggers for initial communication, policy and action. But they require everyone in the scientific and decision-making communities to understand and effectively communicate all relevant information both

Mind the gap': this phrase bellows out of most London Underground stations but captures the essence of the second key lesson learnt the challenges of negotiating gaps between hazard and risk information. Alert levels can change due to the perceived threats at hand, but the decision to progress or downgrade these levels can be challenging due to difficulties in interpreting scientific data and understanding what response is required.

Finally, the decision to move between alert levels requires negotiations of perceived political, livelihood and environmental factors rather than just evaluation of the scientific data.

Standardisation of alert systems is also vital to convey information across communities, but systems need to be designed according to national and international policies while considering local threats.

This is very hard to achieve due to the diversity and uncertain nature of hazards across different geographical areas, as well as cultural and political factors. But many volcanic communities globally can do this for volcano ash hazards, particularly in the context of aviation hazards.

Decision-makers at all levels have often failed to recognise or act upon early warnings. This lack of action is a huge problem for all hazard and threat warnings, and will inevitably play a role in the next big pandemic, which will arise sooner than we might think. Plenty of examples exist of excellent science communication but lack of action.

Action depends on collaboration across the many silos that exist in organisations, disciplines and hazards, and the newly founded UCL Warning Research Centre aims to foster such collaboration. We can draw on hard lessons learnt from other hazards and threats to be more resilient to single, multiple and cascading hazards.

It is action that is needed the most, yet the ability to make the necessary changes remains our biggest challenge, especially if we don't go beyond the silos.

"We were promised payment as soon as work is started but even after finishing our assignments, no payments have been made. The officials resort to dilly dally tactics," a group of artists said.

We are now being threatened of losing our future contracts in case we continue to press for the payment," they alleged.

Pertinently, some works carried out under Srinagar Smart City Project had drawn flak when netizens alleged that money is being wasted for no reason.

## **Srinagar Qualifies For Sub National Certification For Reduction In TB: DC**

Srinagar: The District Tuberculosis Control Society, Srinagar, Department of Health Services Kashmir today organized a grand function at Govt Dental College, Srinagar to observe World Tuberculosis Day with a theme "Invest to End TB. Save Lives" and to celebrate milestones achieved in elimination of TB by district besides commit-

ment towards making Nation TB free by 2025. On the occasion, Deputy Commissioner (DC) Srinagar, Mohammad Aijaz Assad was the chief guest while Additional Commissioner Kashmir, QaziSarwar was the guest of honour.

Speaking on the occasion, the DC said that the theme is a call to invest to eliminate TB and make India TB free for which resources have to be channelized which includes finances and diversified efforts.

He said, "Due to the pandemic, our efforts to eliminate TB got dented during the last two and half years, and underlined that steady, persistent and collaborated efforts are required to get results for TB free Srinagar". In this regard, District Srinagar has a vibrant TB centre which is playing its role efficiently.

He said our TB elimination score is 91.22 percent which is higher than guidelines of the National Tuberculosis Elimination Plan which is fixed at 80 percent hence district Srinagar qualifies for Sub National Certification.

The Sub National Certification is an initiative to mark the progress of districts, states and UTs towards the TB free status which was initiated in 2020 to achieve the target of TB free India by 2025.

Meanwhile, DC congratulated District TB Officer and her entire team for putting concerted efforts for achieving the milestone in elimination of TB.

He said that unfortunately society has attached a social stigma with TB for which he said that awareness among people is to be spread to eradicate this attitude and create a conducive environment so TB patients do not face any inconvenience.

He said those patients do not only need medical treatment but social and emotional support.

#### Additional Commissioner Kashmir while speaking on the occasion said that we should take every step to eliminate TB by 2025 for which he impressed on continuation of dedicated efforts by the health department.

A couple of patients who have recovered from TB also spoke about the symptoms of disease and treatment and appealed to all to go for medical examination when symptoms emerge.

Among others present on the occasion were Chief Medical Officer, Srinagar; Epidemiologist DrTalat. Doctors, Paramedics, ASHA Workers and Students.

On the occasion, a skit was presented to create awareness among the people regarding TB infection, treatment and assistance to be provided by the government including free tests, medicine and monthly Rs. 500 assistance to patients.

The speaker Ali Mohd Naik however ignored the shouts of opposition and instead named the member. on top of the list of questions slated for today, to ask his question. But the agitated opposition continued with slogan shouting and amidst unruly noisy scenes in the house, nothing was audible. As the protest continued. CPM member Yusuf Tarigami was heard inviting the attention of the speaker about the "environment of the house" saying "we want to speak about environment of the state but the environment inside the house is not well"

When the speaker disallowed all pleas of the opposition, the agitated members walked to well of the house and staged a dharna shouting slogans against ministers and ruling party members. Harsh Dev Singh (NPP) Mohd Yusuf allies Kuka Parrey (AL) Satpal Lakhitra and Jagdish Dubey (JD) also joined the dharna and continued shouting slogans demanding scrap of list. The BJP and Congress members including Mehbooba Mufti, Ashok Sharma, Balbir Singh, Lal Singh. Searing Dorjay and Tara Chand also joined the BJP legislators headed by Shiv Charn Gupta and demanded suspension of question hour and a reply from the government. At one stage some opposition mem bers were seen rushing towards the Speaker's podium amidst shouts of slogans.

At this stage Law minister P L Handoo, who also hold Parliamentary Affairs portfolio, moved a motion seeking expulsion of all the members for rest of the session. The motion was seconded by Finance Minister Mohd Shafi carried by a voice vote and then followed Naik's order expelling all the 17 members. indulging in "uncalled for behaviour" for remaining period of the current session of the assembly. As the house re-assembled, after stipulated time, the opposition was there in the well busy in slogan shouting and making it impossible for the Speaker to go ahead with the proceedings.

The Speaker at this stage ordered the Marshall of the house to remove the expelled members physically with the help of watch and ward staff, this resulted in violent clashes between the members and the watch and ward staff with the former offering stiff resistance. Chairs and microphones were used in the melee that followed leading to multiple injuries to Ashok Sharma, Ch. Lal Singh,

Shiv Charn Gupta, Prithvi Chand, Bali Bhagat, Ch Chuni Lala, Ch Piara Singh and Satpal Lahotra. Seven members of the watch and ward staff also received injuries.

The Chief Minister and his ministerial colleagues did not respond to opposition members' demand for scrapping the list or discussion over the issue.

## Biden in Europe

'S President Joe Biden is on his visit to Europe to rally the European leaders to respond to the Russian invasion of Ukraine. The war in Ukraine is now one-month old and it has not only caused widespread devastation in the country but has also confronted the dominance of the US its most formidable challenge since the end of the cold war in 1990. So Biden's visit to Europe is very consequential in nature. Europe has been most worried about its energy supply in the wake of the US-led sanctions on Russia, one of the major global producers of oil. Though Europe now wants the Gulf kingdoms to compensate for their boycott of Russian oil supply, it will take time before the former are in a position to increase the production. Besides, Arab kingdoms are seeking long-term contracts as generating more oil will need more investment into the infrastructure.

But for the west or the US-led world order, the Russian invasion of Ukraine is nothing short of an existential challenge. Even a negotiated settlement let alone the Russian victory will re-order the world and shift the balance of power away from the US. So, for the west, the war basically is not about Ukraine, at stake is its own dominance of the world.

Meanwhile, the war is causing a humanitarian catastrophe in Ukraine. Millions of people have fled the country and they are painting a horrible picture of the state of affairs prevailing back home. Considering that the west has shown no sign of backing down let alone make calls for negotiations to address mutual concerns, the war is looking set to continue.

Russia too has shown no signs of being mellowed by the sanctions. But the war so far seems to have not gone according to Putin's calculations. Russia appears far from taking control of Kyiv, the capital of Ukraine. West has, meanwhile, armed Ukrainian forces with the latest weaponry which is believed to be mainly responsible for stalling Russian advance.

The coming few weeks would be crucial. It needs to be seen whether Russia makes more advances or suffers reverses from the territory it has captured so far and this would determine how each side would calibrate its response. Though Ukrainian president Volodymyr Zelensky has called for direct talks with Russian President Putin, the latter is in no mood for such a meeting. West has also been cautious not to join the war directly, so as not to expand the conflict which could culminate into a nuclear exchange, a frightening scenario that could bring about doomsday for the world. This makes it urgent for the world powers to climb down from their hubris and work together to find a way out of the ongoing war. But going by the tough postures adopted both by the US and Russia, such an outcome looks unlikely in near future.

## **Parenting Gone Rogue?** Parenting Practices and Mental Health of Children

n Kashmir, a lot of importance is pinned on the treatment of elders by kids. The discipline to treat elders with a certain level of respect is inculcated in children from a very young age. Children are taught the rights of elders, especially parents, over them. However, rules and ways of parenting are either inherited, adopted or adapted without much thought. Some children get lucky and others face the brunt of bad parenting all their lives. The bad parenting practices often go unnoticed because our society only places importance on the rights of parents over kids while ignoring the rights of children. Therefore, bad parenting practices are neither flagged not chided — it continues unabated without correction.

Since at least the 1920s, developmental psychologists have been interested in finding how parents impact the development of children's social and emotional competence. In this regard, a construct known as "parenting style" has been under study for all these years as it is one of the most important constructs that has helped researchers to understand the link between parenting and its impact on various developmental aspects of a child's life.

The term "parenting style" refers to the strategies that parents employ when raising their children. It's about how you engage with your kids, as well as how and why you raise them the way you do. The way you parent your children depends on many factors such as the philosophy you have about parenting, the experiences you had about parenting you received when you were growing as a child at your home, your own personality etc. Parenting style is also influenced by subconscious factors that you are unaware of. Your parenting style may have an impact on your child's or adolescent's mental health, as well as their academic, social, and emotional development, no matter how it develops.

There are various types of parenting styles that have been described. The four major recognized parenting styles are:

In the Authoritative Parenting style, parents are loving, responsive, and supporting, but they also set firm boundaries for their children. They use rules, discussion, and reasoning to try to manage their children's behavior. They consider a child's point of view but do not necessarily accept it. Parents who practice authoritative parenting provide clear guidelines and are democratically responsive to their children's needs. Rather than behaving like a rigid boss, they are communicative and willing to listen to their children. Authoritative parents are able to understand their children's emotions and teach them how to manage them. Misconduct is punished in a measured and consistent manner, rather than in an arbitrary or violent manner. Rather than punishing the inappropriate behaviors, the natural repercussions of indulging in various inappropriate behaviors are discussed with the child, helping him/her to recognize that the behavior is wrong and should not be repeated. Thus child may stop the behavior because he/she understood that continuing the behavior is not healthy for him/her rather than simply for avoiding negative consequences. Authoritative parents set boundaries and expect maturity from their children, and they are more likely to explain why they are punishing their child in a particular situation. In some situations, this may lead to the child's better understanding and compliance. This parenting style elicits cooperation from the children. Growing up in an authoritative family not only gives a child a firm foundation, but it also ensures that they keep a close bond with their parents throughout their lives. This parenting style produces children who are pleasant, energetic, joyful, self-reliant, self-controlling, curious, cooperative, and goal-oriented. Yet another type of parenting style is the Authoritarian Parenting style. Children are expected to follow the firm rules established by the parents under this parenting style. Failure to observe such regulations is frequently met with punishment. The reasons for these rules are never explained by authoritarian parents. If asked for, the parent may simply say, "Because I said so. Despite their great expectations, such parents are not very responsive to their children. They want their children to behave extraordinarily and avoid making mistakes, but they give very little guidance on what they should or should not do in the future. Children of such parents who make mistakes are punished often

harshly, but they usually are unable to understand what mistake they have made.

Such parents confuse respect with fear. They expect their children to be fearful of them than to be respectful towards them. Authoritative parents are more interested in inducing obedience in their children, and they expect their commands to be followed without question. They are frequently seen as autocratic and overbearing. "Spare the rod, spoil the child" is their philosophy.

Such parenting practices may have various adverse effects on the mental health of children who receive such a type of parenting. Because the authoritarian parent generally tells the child what to do rather than allowing the child to choose for themselves, such children have less social competence, making such children appear to excel in the short term but limits development in ways that become increasingly apparent as direct supervision and control from parents decline with the passage of time. Children reared by authoritarian parents are more likely to be conformists, obedient, silent, and unhappy. These kids are vulnerable to depression and self-blame. These traits might persist throughout adulthood for some children raised by authoritarian parents. Children who are bitter or angry about being reared in an authoritarian household yet have developed high behavioural self-confidence frequently fight back in adolescence and/or early adulthood.

Children who experience anger and resentment, as well as the negative effects of low self-efficacy and high self-blame, are more likely to engage in avoidance behaviours, such as substance abuse, and are more likely to commit suicide.

It is important to note that our society unfortunately praises this type of parenting practice without understanding its adverse effects on the mental health of children.

Diametrically opposite to the authoritarian style of parenting is the Indulgent/Permissive/permissive/non-directive/libertarian/ anti-authoritarian parenting. The parent in this style is responsive but not demanding. Indulgent parenting is defined as having little behavioral expectations for the child. "Indulgent parenting" is a parenting style in which parents are very involved with their children yet do not impose many demands or limits on them. Parents are loving and accepting of their children, and they respond to their wants and desires. Indulgent parents don't expect their children to self-regulate or act responsibly. Children of indulgent parents will pay less attention as adults to avoid behaviours that cause others to be aggressive.

Parents with permissive style try to be "friends" with their children rather than playing their role as parents. The child's expectations are modest, and there is little discipline. Permissive parents also allow their children to make their own decisions while providing friendly guidance. There are little punishments or regulations in this form of parenting. Permissive parents also offer their children whatever they want in the hopes that their accommodating be havior would be noticed and appreciated by their children. Other permissive parents make up for what they lacked as children by providing their children with the freedom and resources they lacked in their own childhood. Researchers have observed that pre-school children with permissive parenting later turned out to be immature, lacked impulse control, and were unruly. Children of permissive parents never learn to control their own behaviour and always expect to get their way and as adolescents may get involved in various delinquent behaviors such as substance abuse. Yet another parenting style, albeit poor is Neglectful/uninvolved parenting. Here the parent is indifferent and undemanding. Such parents let their children do anything they want. Neglectful parents, unlike indulgent/permissive parents. do so because they are disconnected from their children's needs. Neglectful parents are unaware of what their children are up to, and if they do find out, they are unconcerned. It has been seen that parents who have an uninvolved parenting style were frequently raised by parents who were uninvolved and disapproving. They may find themselves repeating the same patterns as they received when they were growing as children. Other parents who exhibit this style may simply be so preoccupied with their own life that they find it simpler to interact with their children in a hands-off manner. In some situations, parents may be so preoccupied with their own issues (e.g., being overworked, dealing with depression, or battling substance abuse) that they fail to recognise how uninvolved they are with their children or are simply unable to provide the emotional support that their children require.

In practically every sphere of life, the children with uninvolved parents fare poorly. Deficiencies in cognition, attachment, emotional skills, and social skills are common in these children.

Children raised by uninvolved parents may struggle to build healthy attachments later in life due to a lack of emotional responsiveness and love from their caregivers.Children with uninvolved parents are more prone to misbehave since there are no boundaries in the home, making it difficult to learn proper behaviors and limits in school and other social contexts. As a result, children of such parents are generally lonely, depressed, and immature, have poor self esteem and have a hard time adjusting to societal norms. They are more prone to fall victim to abusive relationships, engage in dangerous behaviors such as substance abuse, promiscuity, and sustain injuries

Some lesser known parenting styles include Helicopter parenting in which parents are excessively focused on their children. It involves involvement in a child's life in an overprotective, overcontrolling, and overperfecting manner. Helicopter parenting refers to parents who assist high school or college-aged children with chores that they are capable of completing on their own (for instance, calling a professor about poor grades, arranging a class schedule, managing exercising habits). In toddlerhood, a helicopter parent may continually hover over the child, playing with and controlling his actions, leaving him with no time alone. Helicopter parents in elementary school try to ensure that a child has a specific teacher or coach, choose the child's friends and activities, or provide excessive help with homework and school projects.

Children of such parents may have low self esteem and self-confidence, they may have underdeveloped social, emotional and other coping skills, may experience more anxiety and may feel entitled to have their desired positions in almost every area of their life.

Additionally, there is Lawn mover/snow pillow/bulldozer parenting. Snowplow parents are willing to drop everything to meet their child's wishes and demands, no matter how insignificant they are. They essentially "plow down" anything that gets in the path of their child. Lawnmower parents frequently have good intentions and do not want their children to suffer through hardship. These practices, however, do not provide a basis for long-term happiness, and they might actually exacerbate a child's fear of failure.

So what can parents do to improve their parenting skills?

Looking at the impact parenting can have on the mental health of children; parents have a huge responsibility towards their children so that they become effective parents and help their children live a mentally healthy and respectful life. To understand more about effective ways that are beneficial to children, parents should read books, websites, and articles devoted to childrearing. They should join workshops to understand and listen to the experts in the field of child rearing. Additionally, research has shown that parent training can help parents become more involved in their children's lives in an effective and scientific way. Moreover, speaking with a mental health expert such as a psychologist can help you put your own experiences into context and learn new skills that will help you form healthy ties and limits with your children. One must also make a concerted effort to spend more time with your kids. Listen to what they have to say and gain insight into their lives. It's not simple to change, and it's even more difficult if you're a busy working parent. Focus on carving out as much time as you can to give your children your undivided attention.

### Media repercussions for Israel, post-Ukraine coverage

western media's framing of fundamental aspects of what constitutes invasion and legitimate resistance will have negative long-term repercussions for Israel's informational narrative.

The western corporate media's glorification of Ukrainian resistance has shown the reality that in many situations, the notion of journalism being a 50-50 reporting affair is inapplicable. This notion was long championed by the prominent global affairs journalist, the late Robert Fisk.

The veteran journalist famously stated that "we must be neutral and unbiased on the side of those who suffer, would we give equal time to the stories of the slaves and the stories of those slaves thrown overboard with the slave-ship captain and interview him for 50% of the report? Our job is to have a moral conscience when we are reporting; the occupier and the occupied should not necessarily have an even playing field." Fisk's framing of what journalism is, instead of what it ought to be in theory peddled by western academia used to be applied in a less obvious manner.

However, the ongoing war in Ukraine has propelled Fisk's understanding of journalism into practice of journalism on a mass scale.

Post-Ukraine war, it will be very difficult for western media to hide behind the objectivity excuse and not view Palestinian resistance through the angle of self-defense and liberation struggle. Media coverage of the war in Ukraine established that impartiality is not as sacred a principle that many assumed it to be, which one must uphold at all costs.

When covering the right of the invaded people, the impartiality notion can become a method of delegitimization of occupied people.

As the world's media scene has become more even and the multipolar global order is here to stay, together these two notions will further undermine Israel's narrative as it will not be able to shed its role as the occupier

SRINAGAR- Not everyone can go to Hogwarts and be honoured by the Sorting hat, but in the old city of Srinagar Kashmir, a traditional hat maker has been making "Qarakul" for the world leaders and the locals alike, and the build quality is no

less than magic. The Jan family has been designing, crafting and manufacturing the esteemed Qarakul caps for about a hundred and twenty-five years today. Ever since their inception, the Qarakul caps have been an accepted symbol of prestige. The Czars fashioned it atop their scalps, as did the African monarchs and other people of such ilk. "I make different styles of Qa-

rakul at our shop that include caps from Russian, Turkish, Afghani, Persian, Jinnah style and I am even adapting to the contemporary styles of caps like the one worn in Ertugrul", says Muzaffar Ahmad Jan, the owner of the shop.

From the Late Mohammed Ali Jinnah (in 1942) to Rajiv Gandhi (in 1984) to Narendra Modi (in 2014) and also to the Late King of Oman, Qaboos bin Said, the Jan Cap house has made Qarakul caps for all of them. From the political leaders like Farooq Abdullah to the separatists like Late Syed Ali Shah Geelani, the list goes on. Rumour has it that the UFC Champion Khabib as well would have been added to

the list of the prominent figures

whom the Jan House serves, if

only the then circumstance would have allowed for the assimilation of the proper arrangements. "Sometimes a politician spe-

cifically wants me to make his Qarakul cap taller than some rival politician. That is why I always ask about the height of the cap. I know it matters a lot," says Jan.

It is common knowledge that the globalization of the western culture is often held responsible for the demise of our traditional attire. Jeans have conquered a lot that once used to be the culture of the land. In times like ours when the youth are swaying away from the fashion choices of their ancestors, it is no surprise that the Jan Cap House's major clients

are seasoned politicians locally. From a business perspective, Jan says "The Qarakul sales locally are not what they once were, as the age-old design fails to appeal to the youth." The Jan Cap House, however, is cashing in on the trend of the Ertugrul style Caps, which are popular among youngsters.

"I constantly try to evolve and experiment with my craft to keep up with the pace of the ever changing world", says Jan. The Qarakul cap is peaked and folds flat when taken off. With the introduction of circular caps, they have managed to dam the loss to a certain limit.

Jan is the only one from his generation of his extended family who decided to carry forward the de-



cades-old family business. Unlike his cousins, he took up the craft of making Qarakul when his father, Ghulam Mohammad Jan, passed away.

"I never formally trained to learn this craft, it came to me naturally, and I see my 6-yearold son showing quite the similar interest in this craft"

"Earlier, I would get all of my raw material directly from Afghanistan, the quality there is superior to other places. But as fate would have it, ever since the new regime came into power there, India has stopped trading with them. So, naturally, I cannot import the material that the customers are looking for", says Jan.

On the other side of the plain, multiple animal rights organizations have raised questions about how the material that goes into the making of the Qarakul cap is procured. Where certain reports suggest that the lamb whose skin is flayed in order to obtain the material required for the making of the Qarakul is aborted as it lies in the womb, others suggest that this could not be true as the skin of the foetus is not vet developed enough to make the Qarakul. Thus, another word follows that the said lamb must be at least 5 to 6 months old (gestation period of a lamb is 152 days) to produce the quality material that is required for producing the Qarakul of sound quality.

"Had there been any inhuman practices involved in the process, I would not have been making so many Qarakul caps for religious leaders and Islamic scholars," says Jan, pointing out that it is not only politicians who wear his sought-after headgear.

The good quality Qarakul lambskin costs around 5 to 10 thousand rupees. One skin usually makes one cap. Jan says that on average he spends around another 3000 on the raw material and labour of the cap, which usually fetches him anything in between Rs 5000 to Rs 20000. It takes him four to five hours to make a single piece and on an average he makes about two a day.

"This business runs on your eye for the skin. We get most of the skin from Afghanistan and Central Asia," Jan says. "We tried to get some Qarakul lambs to breed in Ladakh mountains but it didn't produce very good resultsresults", he added.

Though Mr. Jan's local clientele is diminishing but the sales are not slowing down outside of the Valley.

"I keep getting requests for making Qarakul from Uttar Pradesh, Lucknow, Jaipur. People that I have never personally met, call me and place an order. I am grateful for each client that I get to have, for each sale made, I thank the Almighty."

## **Sustainability Crisis of Fast Fashion**

he fashion industry has some major sustainability problems. By 2030, it is predicted that the industry's water consumption will grow by 50% to 118 billion cubic metres, its carbon footprint will increase to 2,791m tonnes and the amount of waste it creates will hit 148m tonnes



closer to a disposable fashion industry? The desire for new clothes is something that may be impossible to change. So instead of trying to appeal to the



These predictions are in spite of significant progress being made by brands and retailers to minimise their impact. Many are using sustainable cotton initiatives to reduce water. energy and chemical use, new dyeing technology to reduce water consumption by up to 50% as well as numerous energy and chemical saving schemes throughout the supply chain. In the UK, the result of this work is percolating through to stores, with a reduction in the carbon and water footprints per tonne of clothing of 8% and 7% respectively since 2012.

So the industry is reducing the environmental footprint of its products. But the problem has now shifted to the consumption side: the insatiable appetite for fashion means people are buying more and more clothes. Since 2012, there has been a 10% increase in the amount of clothing purchased in the UK alone. And not only are British consumers buying more; more of their clothing gets discarded quicker as they chase the latest fashion trends. It is estimated there is over £30 billion of clothing sitting in wardrobes across the UK that has't been used for over 12 months.

Fast fashion is seen by many as the fundamental cause of all the sustainability issues the industry faces. And so it has been suggested by numerous commentators, academics and NGOs that ethical consumerism can and will lead to a paradigm shift in behaviour. Over time, it is thought, slow fashion will become the norm, with consumers wearing classically styled garments that last for ten years. This, so they say, will minimise the need to make new purchases of the latest fashion fad, therefore reducing impacts. The logic of this argument is predicated on the idea that consumers are rational

animals with behaviour that is controlled and predictable.

But the growth of ethical consumerism has not materialised in mainstream fashion. Ethically minded brands believe the single biggest issue stopping them becoming more sustainable is the consumer; either through their lack of awareness of the issues faced by the industry or through an unwillingness to pay for sustainable products. So can ethical consumerism really exist in the mainstream fashion market? Psychology and behavioural science may suggest that ethical fashion consumerism is a pipe dream. We believe our purchasing decisions are based on rational, conscious and well thought out deliberations. But the complexity of human behaviour and the fundamental nature of fashion

implies that ethical consumption may not be an attainable

#### goal **FASHION AND EGO** Why is this the case?

First, it is important to explain that marketing tools such as questionnaires and surveys used to predict the growth of ethical consumption are problematic. They are good for identifying purchase intention but poor for predicting actual behaviour. Surveys tend to illicit a response that presents the participant in a positive light: non ethical shoppers tend to state they are ethical to protect their external image. And surveys are reliant on the participant being truthful and knowledgeable about their behaviour. How truthful we are is debatable and research shows we are not as knowledgeable as we think we are about the drivers for our fulfilling life. behaviour.

Our behaviour is far more selfish than we might like to believe. Rational models of consumption are based on the idea that individuals make choices that balance costs and benefits. An ethical consumer will make rational judgements about purchases on the best outcome in terms of costs and benefits for them and the environment.

But consumption, and in particular fashion consumption, is quite irrational. Purchase decisions are more likely to be driven by desires linked to pleasure and excitement. Fashion is a social activity for setting our status (the egoistical drivers) but it is also an activity that is driven by emotional desires such as the fantasy, excitement and aspirations of living a better, more

These hedonistic subcon-

scious forces are what make shopping for clothes exciting and pleasurable. They create a less rational approach to consumption which ultimately reduces the influence of rational thoughts about ethics and the environmental consequences of our purchases.

### **FAST AND ETHICAL FASHION**

Ethical campaigners, journalists and even some brands have argued that consumers would be able overcome these subconscious forces of fun and excitement if they had more information about the ethical issues. But evidence shows that this does little to increase ethical behaviour. In fact, more information tends to reduce the influence of ethical issues due to the complexity of the issues.

This complexity is doubled by the amount of conflicting information produced by NGOs, the media and brands themselves: cotton is bad for the environment; microfibres are poisoning the oceans; bamboo is ethical (it's not). When the experts can't agree on the big issues for fashion, it's that much easier for the consumer to turn a blind eye and buy that new shirt.

An alternative, radical approach may be to recognise that humans have always used fashion to satisfy emotional, egoistical desires. So the challenge should be shifted from trying to control these primeval, irrational behaviours to finding a systemic and ethical approach to embrace them.

Can we find sustainable solutions that actually move ever

consumer's supposed ethical streak, perhaps brands should aim instead to use new tech-nology and business models to design products that can be recycled or re-engineered into new styles with minimal use of virgin materials, water, energy and chemicals.

In this model, we would not aim to change thousands of years of evolution in the space of a generation, but use innovation and creativity to make industry bend to our inherent needs. It is a major technical and commercial challenge, but shifting to such a consumerdriven model may open up new opportunities for business, as well as becoming more sustainable.

### **Upload 'The Kashmir Files' on YouTube: Kejriwal** to BJP MLAs seeking movie be made tax-free

New Delhi: Chief Minister Arvind Kejriwal on Thursday said the BJP MLAs demanding 'The Kashmir Files' be made taxfree in Delhi should upload the movie on YouTube and make it free for all.

During his address in the elhi Assembly, Kejriwal Delhi also accused Prime Minister Narendra Modi of using the movie for political gains.

Hitting back, Delhi BJP president Adesh Gupta said that Kejriwal, by his remarks over the issue, has crossed all limits of political decency. The movie, based on the exo-

dus of Kashmiri Pandits from the Kashmir Valley due to terrorism, has kicked up a political storm. It is being actively pushed by BJP-ruled states by either offering tax concessions or giving government employees special leave to watch it.

The Opposition has, however, termed the film one-sided and too violent.

Kejriwal said the BJP leaders were demanding to make 'The Kashmir Files' movie taxfree when Lieutenant Governor Anil Baijal was speaking in the House on Wednesday.

"They (BJP) are demanding that the movie be declared tax-free in Delhi. Upload it on YouTube, the movie will become free and everyone will be



able to watch it," he said in the Assembly.

Kejriwal slammed Prime Minister Modi, alleging that even after ruling the country for eight years he has to take the help of the movie for political gains.

Prime Minister Narendra Modi, referring to the response to 'The Kashmir Files', had said the film has rattled the "entire ecosystem" which claims to be the torchbearer of freedom of expression but does not want the truth to be told.

Kejriwal, who is also the AAP national convener, further alleged that the entire BJP machinery was busy sticking posters of the movie across the country.

"Some people are earning crores in the name of Kashmiri Pandits and you (BJP) have been sticking posters of the film," he said in the House.

"Even Hitler gave jobs to his lackeys. What did he (Modi) give you? Kejriwal works even for you. If someone in your family is ill, Kejriwal provides you medicines, not Modi. Open your eyes, leave BJP and join AAP."

Reacting to Kejriwal's response to the BJP MLAs'

demand, the party's Delhi unit chief Adesh Gupta said that Kejriwal's response showed his insensitivity towards the pain of Kashmiri Pandits.

"The AAP had in the past supported the demand for a plebiscite by Kashmiri separatists. "So, appreciation fo 'The Kashmir Files' movie cannot be expected from him (Kejriwal)," he said. Later in the statement,

Kejriwal appealed to the BJP MLAs not to promote 'The Kashmir Files' film.

"Do whatever you want to do, but for the sake of god, stop wasting your time and position to promote this movie. It doesn't look good for the position you command. Don't act like children on the Internet, please," the statement quoted Kejriwal as saying.

He also claimed that the opposition "cannot digest" that AAP governments in Delhi and Punjab are honouring Babasaheb Ambedkar and Shaheed Bhagat Singh. "BJP asks why didn't you put up Savarkar and Hedgewar's portraits while Congress asks for those of Indira and Rajiv Gandhi. Is this a joke?

"The BJP and Congress can put up whoever's portraits they want. We want to honour Shaheed Bhagat Singh and Babasaheb Ambedkar and no one can stop us," Kejriwal stated.

### Parallel dialogues with different groups not to help resolve Naga issue: Zeliang

Kohima: Parallel dialogues with the NSCN(IM) and Naga National Political Groups (NNPGs) comprising seven organisations and signing separate pacts with them will not help in finding a common solution to the Naga political issue, United Democratic Alliance (UDA) chairman T R

Zeliang said on Thursday. All 60 members of the Nagaland Assembly came together to form the UDA, an opposition-less government in September 2021 to pursue an early solution to the Naga political issue (NPI).

The Union government has been holding two separate parleys with the NSCN(IM) since 1997 and PGs since 2017. The Centre signed a framework agreement with the NSCN(IM) on August 3, 2015, and also entered into an agreed position withPGs in December 2017.

"There cannot be parallel dialogue and two different agreements for one common solution to the Naga political issue," Zeliang, a former chief minister, said in the Assembly. The framework agreement came after over 80 rounds of negotiations spanning 18 years, with the first breakthrough in 1997 when the ceasefire agreement was sealed after decades

of insurgency in Nagaland

which started soon after Independence in 1947.

The framework agreement signed in presence of Prime Minister Narendra Modi in New Delhi gave high expectations but the problem still remains unresolved, he said.

The Centre's then interlocutor R N Ravi had declared that the demand for separate Naga constitution and flag cannot be granted, leading to a stalemate, Zeliang said.

The Centre is not willing to accept the demands probably because it had abrogated Article 370 which gave a special status to Jammu and Kashmir. With the annulment of the special status in 2019, the separate flag and the Constitution of Jammu and Kashmir cease to exist.

On the initiatives of the Core Committee of the State Government on the Naga issue, Zeliang informed the House that after this Budget session, the panel would go to Delhi and meet Union Home Minister Amit Shah to know the latest position of the Centre on the matter.

The members of the House should mediate between the two parties - the NSCN(IM) andPGs - so that they can come together and in that case, the Centre will succumb to the pressure, he said.

were identified by the police are those where encounters took place or the ones where militants took shelter.

When asked what if the shelter wasn't voluntarily given by the people, he said "the families need to inform the police when the militants leave the house and if the information wasn't given it will be considered a crime,"

Balwal further said that most of the houses that have been identified are those where the owners or other family members have provided the shelter to the militants voluntarily.

"We carried-out the exercise carefully and kept all this thing into consideration that any person who hasn't voluntarily provided the shelter to the militants are exempted," he said, adding that "at the same time, we haven't left anyone who has committed this crime.'

Balwal added that they will carry out the exercise every year now.

Earlier in a tweet, the Srinagar police said "Don't give shelter or harbour terrorists/ terror associates. Legal action will be supplemented by property at

"We appeal to all the democratic forces, let us keep our differences aside. We can discuss what we want for the country only when this country is saved. Come forward, this is very important for the future of India and its citizens," he said.

The CPI(M) leader claimed the country has witnessed the "worst degeneration" of the economy under the BJP's rule.

"Unemployment is the worst in history. Over 50 per cent of our youth have stopped searching for jobs as they see no point in doing so. There are economic attacks on people, there is hunger, unemployment, price rise... India is down on every index in the world. It means that India's situation is declining very fast," he claimed.

Referring to last year's report by Sweden's V-Dem Institute that classified India as an "electoral autocracy", Yechury said the BJP is using the legitimacy of election victories for the "complete destruction" of the Constitution's fundamental pillars.

"That is what is happening (in the country) today. How you (BJP) win elections is a different matter, but you use the legitimacy and there is complete destruction of the fundamental pillars of the Constitution be it the secular democracy, social justice, federalism, and economic sovereignty.

"Nothing is left in the country which is not being sold... and profits go to a few people. Everyone knows who they are. Even farms are being handed over to them," he alleged.

He said the BJP has "legitimised political corruption" through electoral bonds.

### Dhoni Steps Aside, Hands Over CSK **Captaincy To Jadeja**

MUMBAI: Twelve seasons, four title triumphs and five runner-up finishes later, the iconic Mahendra Singh Dhoni has decided to hand over the captaincy of Chennai Super Kings to his trusted lieutenant. Ravindra Jadeia.

After spearheading the bowling unit for four seasons at the Delhi franchise, where he also won the Purple Cap in 2020. Rabada will now turn out for Punjab Kings.

Known for his breathtaking fast bowling and toe-crushing yorkers, South Africa's premier pace bowler Rabada has established himself as a force to reckon with.

At Punjab, the 26-year-old will be their most experienced pace bowler and will be expected to produce some remarkable performances with the ball in hand.

With ample bounce expected at Wankhede and the match-winning spells in tan-Brabourne Stadium, Rabada, dem with senior India spin-

#### YUZVENDRA CHAHAL (RAJ-**ASTHAN ROYALS)**

the list of all-time leading wicket-takers in the league, having claimed 139 scalps in 114 games since 2013, speaks volumes about his skills.

#### **JASPRIT BUMRAH (MUMBAI** INDIANS)

One of the best bowlers in modern-day cricket across all formats there is no denying that Bumrah is an impact player.

The death overs specialist and perhaps the best T20 bowler around the world right now, Bumrah has been a consistent performer for Mumbai Indians with an abil-

ity to take wickets at will. Since his debut in the IPL in 2013, Bumrah has taken 130 wickets in 106 games at an economy of 7.42

A consistent performer, Bumrah has been among the top 10 leading wicket-takers in every season since 2016. His brutal pace and movement up front, and accuracy at the death, makes him one of the most dangerous bowlers in the league and he is expected to continue troubling the batters on Mumbai and Pune pitches.

#### **RASHID KHAN (GUJARAT** TITANS)

After serving as the bowling mainstay of Sunrisers Hyderabad since his arrival in the league in 2017, Rashid Khan will now ply his trade for new entrants, Gujarat Titans.

The star Afghan leg-spinner boasts of the best economy rate of 6.33 in the history of the tournament while also taking 93 wickets in 76 matches.

He is known to choke the opposition for runs every time his captain hands him the ball, as batters often just opt to play out his four overs without taking any risks. And this season is expected to be no different for Rashid.

The 23-year-old, currently ranked number five in the world in the shortest format of the game, is proficient in bowling flighted leg-spinners,

googlies, flippers alongside other variations as well which make him a lethal player. With the league phase being played in Mumbai and Pune where the conditions would aid the spinners, Rashid could be lethal.

#### **HARSHAL PATEL** (ROYAL CHALLENGERS **BANGALORE)**

Having made his IPL debut way back in 2012, Harshal Patel enjoyed his breakthrough season last year with Royal Challengers Bangalore. He picked up a record-equalling 32 wickets in 15 games to win the Purple Cap in the 2021 edition of the league.

The 31-year-old was extremely effective in the death overs, a department RCB had lacked in before and that was the reason why the franchise shelled out a whopping Rs 10.75 crore to secure his services once again.

A right-arm seamer with a big outswinger, Patel uses smart angles and variations to make up for his medium pace. Slower bouncers, variations in yorkers and cutters are all part of his arsenal.

Having played eight T20Is for India, Patel would look to continue in similar vein as last season.

**Mumbai** Police Says It Will **Ensure Full Security For IPL**

MUMBAI: Mumbai Police is geared up to ensure full security for the Indian Premier League (IPL) which will kick off this weekend, an official release said here on Thursday.

There have been no intelligence inputs about any terror threat to the cricket extravaganza that will begin at the Wankhede stadium in South Mumbai from March 26, it added.

Adequate security arrangements will be made at the two stadiums in the city (Wankhede and Brabourne) where matches will be played as well as the hotels where the players and support staff will be staying, police said.

Some unverified viral messages on social media had said that `terrorists' had conducted recce at Hotel Trident, the Wankhede Stadium and along the bus route between these two locations, but the police release said they had not received any such information.
