# **Cab Crash Kills** 9 Wedding **Guests In Poonch**

**SRINAGAR:** At least nine people, returning from a wedding cer-emony were killed and four others injured on Thursday as the cab carrying them plunged into a gorge in the mountainous Surankote area of Poonch district.

According to reports, a sumo (JK12- 2725) carrying guests from a marriage ceremony was on its way towards Bufliaz, when the cab skidded-off the road and rolled down into a 300-feet gorge at Tarran Wali area of Surankote on Thursday afternoon.

The people on-board the ill-fated cab were returning home after attending a wedding at Morah when the driver reportedly lost control over his vehicle.

Reports said that six occupants died on the spot while three others succumbed to their injuries on their way to the hospital. Four other injured are being treated by the doctors at the Government Medical College (GMC) Rajouri.

The victims have been identified as Ghulam Rabani,

Mohammad Fazal, Mohammad Mushtaq, all residents of Salian, Fazal Ahmed, Gulab Din, both Gursai, Mohammad from Jahangir, Mohammad Akbar Abid Kohli and Showkat Hussain, all residents of Dingla.

The injured including driver of the vehicle- Zaheer Abass of Gursai besides Anava Shoket of Dingla, Haroon of Gursai and Mohammad Zabir of Gursai were referred from Sub-district hospital (SDH) Surankote to GMC Rajouri, Block Medical Officer (BMO)Surankote Dr Zulfikar Choudhary told a local news agency GNS.

ISLAMABAD: A defiant Imran Khan on Thursday indicated that he will not resign from the post of Pakistan's prime minister despite losing the majority in the National Assembly and insisted that he will face the vote of no-confidence which would take place on Sunday.

In a live-address to the nation, 69-year-old Khan also discussed a 'threat letter' that purportedly showed "evidence" of a foreign conspiracy to topple his coalition government. He named the US as the country behind the threat in what appeared to be a slip of tongue.

"...Our policy was not anti-US, -Europe, or even India [...] it became anti-Indian after New Delhi revoked the special status of Kashmir and broke international law in August 2019." said Khan, who insists that the Kashmir dispute remained a big issue between the two countries. # How 'Honour Killing' Sealed The Fate Of Kupwara Boy

t was a routine outing for 8-year-old Talib Hussain Khan on 15th February 2022 when he left home for playground. But as dusk fell over his hometown Kupwara that day, his missing whereabouts didn't just mobilise his parents, but

who's who in town. For the next week or so, the boy's missing status would even trigger the security apparatus as well as activate the civil society.

In Kashmir's 'missing history', it was the first collective pursuit-broadcasted, bellowed, bolstered—by big reward money announced by multiple players. But before the massive hu-

man hunting began, Talib parents had searched him in every nook and corner of his native Awoora village of Kupwara. Fearing for his life, his family

starting what became one of the most deliberated missing cases in the recent Kashmir history following the unending enigma of Mehran— the Habba Kadal boy who "vanished into thin air" in 2008.

"For the next six days, we weren't getting any clue despite pulls and pressures on Rashid Younis, Deputy Superintendent of (DySP) Headquarters, Kupwara, told Kashmir Observer.

The cluelessness was baffling as the police had formed different teams of 10 cops each to trace the missing child. Over 300 suspects were rounded-up and grilled. But when it didn't help, Yougal

Manhas, Senior Superintendent of Police (SSP), Kupwara, formed a Special Investigation Team (SIT) to probe the matter. Headed by additional SP



Kupwara Pardeep Singh, the SIT had DySP Rashid Younis, Inspector Nazeer Ahmad (SHO PS Trehgam) and Azhar Shakeel(IC PP Awoora) as its members.

Apart from the probe pack, the

police announced Rs. 1 lakh reward for any information about the missing child. Even former Rajya Sabha member and senior Peoples Conference leader, Mir Mohammad Fayaz decided to give Rs. 2 lakh to anyone informing police about Talib. But when even rewards failed

to help, the army was called to widen the search operation.

Soon the team comprising of a toparmy officer, three junior commissioned officers and 160 territorial army men scanned frontier areas of Reshwari, Gore Nallah, Pt 1957, Nayem Shah Zyarat, Gujjar Patti, Mir Muqam, Frasduban Forest, JodaTalab, Khan Mohalla and Awoora village. Even the con-flict-hardened combatants returned empty-handed.

# Twinkle, Twinkle Giant Star, **Astronomers See How Far You Are**

stronomers have discovered the farthest star yet, a super-hot, super-bright giant that formed nearly 13 billion years ago at the dawn of the cosmos. But this luminous blue star is long gone, so massive that it almost certainly exploded into bits just a few million years after emerging. Its swift demise makes it all the more incredible that an international team spotted it with observations by the Hubble Space Telescope. It takes eons for light emitted from distant stars to reach us.

"We're seeing the star as it was about 12.8 billion years ago, which puts it about 900 million years after the Big Bang," said astronomer Brian Welch, a doctoral student at Johns Hopkins University and lead author of the study appearing in Wednesday's jour-

"We definitely just got lucky." He nicknamed it Earendel, an Old English name which means morning star or rising light - "a fitting name for a star that we have observed in a time often referred to as `Cosmic Dawn.

The previous record-holder, Icarus, also a blue supergiant star spotted by Hubble, formed 9.4 billion years ago. That's more than 4 billion years after the Big

While Hubble has spied galaxies as far away as 300 million to 400 million years of the universeforming Big Bang, their individual stars are impossible to pick out. "Usually they're all smooshed together ... But here, nature has given us this one star - highly, highly magnified, magnified by factors of thousands — so that we can study it," said NASA astrophysicist Jane Rigby, who took part in the study. "It's such a gift really from the universe. Vinicius Placco of the National

Science Foundation's NOIRlab in Tucson, Arizona, described the findings as "amazing work." He was not involved in the study. Placco said based on the Hubble data, Earendel may well have been among the first generation of stars born after the Big Bang. Future observations by the newly launched James Webb Space Telescope should provide more details, he said, and "provide us with another piece of this cosmic puzzle that is the evolution of our

Current data indicate Earendel was more than 50 times the size of our sun and an estimated 1 million times brighter, outsizing Icarus. Earendel's small, yet-tomature home galaxy looked nothing like the pretty spiral galaxies photographed elsewhere by Hubble, according to Welch, but rather "kind of an awkward-looking, clumpy object." Unlike Earendel, he said, this galaxy probably has survived, although in a different form after merging with other

"It's like a little snapshot in amber of the past," Rigby said.

Earendel may have been the prominent star in a two-star, or binary, system, or even a tripleor quadruple-star system, Welch said. There's a slight chance it could be a black hole, although the observations gathered in 2016 and 2019 suggest otherwise, he

Regardless of its company, the star lasted barely a few million years before exploding as a supernova that went unobserved as most do, Welch said. The most distant supernova seen by astronomers to date goes back 12 billion years. The Webb telescope -100 times more powerful than Hubble should help clarify how massive and hot the star really is, and reveal more about its parent galaxy. By studying stars, Rigby said: "We are literally understanding where we came from because we're made up of some of that



# **Midnight Inferno Leaves 37 Noorbagh Families Homeless**

Srinagar: At least 37 families were rendered homeless after their residential houses were reduced to ashes in a fire incident at Noorbagh area of the city.

Official sources said that 20 structures including 10 single-storey, nine two-storey and one three-story houses got damaged in the blaze.

Sources said that fire broke out in the intervening night of Wednesday-Thursday at Gata Colony Noorbagh. There was no loss of life, however, a

The ADC who was accompanied by the Tehsildar Eidgah, Ishfaq Ahmad and

other concerned Officers met the fire victims whose residential houses were completely damaged in a massive fire

While interacting with the fire sufferers, the ADC expressed sympathies with them on behalf of the District Administration Srinagar. He also assured that every kind of possible support shall be provided from the District Administration for their immediate rehabilitation.

The ADC was informed that 25 residential houses comprising 37 families

were gutted in the devastating fire incident in Sheikh Colony Noorbagh.

On the occasion, essential assistance in the form of 185 blankets, 111 mattresses, 111 bed sheets and 37 kitchen sets, besides Rs 185000 to 37 families was provided out of Red Cross as an interim relief to the fire victims.

Similarly, the District Administration Srinagar also provided the immediate assistance of Rs 15000, besides 15 blankets, 9 mattresses, 9 bed sheets and 3 kitchen sets to the fire victims of Rajouri Kadal area in Shaher e Khaas of the district in which one house was gutted in a fire incident on Wednesday rendering 3 families homeless.

Meanwhile, the DC has also sanctioned structure wise financial assistance of Rs 25, 47,500 in favour of 25 house owners of Noorbagh and Rs 1, 01,900 in favour of Rajouri Kadal house owners under SDRF.

Further, the District Administration has appealed to the General public to follow all precautionary measures while handling electric gadgets, LPG cylinders and other appliances being used for heating and cooking purposes to avoid such fire incidents. (KNO)

Autonomy Committee Report 'Soon': Farooa

Asks Centre To Honour

ammu- Chief Minister Faroog Abdullah today reiterated his commitment to get the maximum autonomy restored to Jammu and Kashmir and expressed the hope that new government at the centre would honour the state's recommendations on this issue. The report of high level state committee and the other concerning regional autonomy though delayed, would be tabled in the state legislature as, soon as possible, Farooq told legislative Assembly during question hour. The report, after being discussed in the two houses of the

state legislature, would be submitted to centre for final decision chief minister said adding that restoration of autonomous state to Jammu and Kashmir will solve many a problems faced by the state, Abdullah said. The main objectives of the state committee on autonomy

was to examine and recommend measurers for the restoration of autonomy consistent with the instrument of accession, the constitutional application order, 1950 and Delhi agreement of 1952. The committee on the issue of regional autonomy with Balraj Puri as its chairman was set up to examine the issue of granting internal autonomy to the three regions of the state, Jammu, Kashmir and Ladakh. The committee has also been asked to recommend any change in the state's constitutional structure, for this purpose, Abdullah said in his reply.

Chief Minister said that functioning of the state committee was affected following the resignation of its chairman, Dr. Karan Singh. However the committee, now headed by Works minister Mohiudin Shah, had held 14 meetings so far while 19 meetings were held by regional autonomy committee, he added. # War's long shadow

s the war in Ukraine prolongs, the world economy is finding itself under increasing stress. The European Union has been the most impacted. The war has aggravated a shortage of natural gas that has already sent inflation up in most European countries. The bloc is now urging the Gulf countries to compensate for the energy shortfall as a result of the boycott of Russian oil. This calls for a sweeping and costly restructuring of its energy system. Besides, the Russian aggression has also forced the European countries to increase their military spending which, in turn, is adding to the inflationary pressure. For example, Germany plans to raise military spending to 2 percent of its GDP from

Russia and Ukraine are also the major producers of food. Ukraine is the world's biggest producer of sunflower oil, and Russia is number two, according to S&P Global Platts. Together they account for 60 percent of global production. The two countries also account for 28.9 percent of global wheat exports. This has already caused the wheat prices to trade at their 15year highs and its impact will be felt across the world. .

Indian economy could be severely impacted, although it is too early to predict how deep this impact would be. As things stand, the war has caused higher than expected inflation, supply chain disruptions and volatility in financial markets. And India can't be immune to this for long if the war drags on. And this is happening at a time when the world economy was gradually recovering from the debilitating fallout of the Covid-19 pandemic, a once-in-a-century event. The countries were slowly opening up and letting the economy function normally. International travel was also returning to prepandemic levels. India was taking taking steps toward a selfreliant economy also called Atmanirbharta. This is expected to drive economic momentum and growth. The resumption of economic activity is also important to restore the millions of jobs lost to the pandemic. More so, in India where the successive virulent waves of the pandemic have hemorrhaged the economy. In 2021, India's GDP slipped by over 7 percent. The gaping dent in the GDP meant that lakhs of jobs were lost. a disproportionate number of them the people living at the bottom of the pyramid.

If the war drags on in Ukraine, India's economy is likely to come under severe stress again. Skyrocketing oil prices will also wreck the European economy and that of India too which imports two-thirds of its energy needs. Therefore it is incumbent on the world to come together to resolve the crisis in Ukraine and find a solution that addresses the concerns of all the parties involved.

# Centralising tests: On common entrance exams and merit

The decision to conduct a Common University Entrance Test (CUET) for admission in undergraduate programmes in all University Grants Commission-funded Central Universities (CUs) from 2022-23 has triggered concerns. No doubt, the proposal is influenced by the National Education Policy, which advocates common entrance examinations by the National Testing Agency for undergraduate and graduate admissions and fellowships. The concept as such is not alien to the CUs. Over a dozen CUs admit students to undergraduate programmes using Central Universities Common Entrance Test (CUCET) scores. The proposed CUET, in 13 languages, seeks to make it mandatory for 45 CUs — there are 54 such institutions — to conduct admissions using a single national level test score. This would spare aspirants from taking multiple entrance tests and also eliminate unfair advantage gained from disproportionate scores in class XII. Critics are evidently viewing this development through the prism of the Narendra Modi government's obsession with pushing the 'one nation, one standard' maxim in different sectors. But as early as 1984, the Madhuri R. Shah Committee, looking into the working of CUs, recommended a national merit examination. In the instant case, the UGC has clarified the existing scheme of reservations in individual universities would not

Yet, the CUET may not qualify as a wholesome determinant of merit given the educational and regional disparities in India. While a vast majority study in State Boards, the test would be based on the NCERT syllabus, followed largely in CBSE schools. The policy limits the Class XII marks as a qualification benchmark and not a co-determinant of merit. With the test being introduced just ahead of an admission season, students, whose learning process was disrupted by COVID-19, may find it challenging. Education Ministers from Tamil Nadu, Meghalava and Arunachal Pradesh have flagged some legitimate concerns. In the North-east, the argument about the test possibly affecting the interest of State domiciles to secure admission in a university in the region cannot be ignored. There are genuine apprehensions about CUET serving as a precursor to introducing a nationwide entrance test for all undergraduate courses — the UGC has said all institutions are free to use the test scores for admissions. It has been sufficiently demonstrated that common entrance tests spawn the coaching industry and induce cost-heavy hybrid courses from class VI onwards, creating a divide between the haves and have-nots. The country has miles to go in enabling access to entry-level higher education and bridging the gender and economic gap in its university portals. In such circumstances, it needs to be dispassionately examined if prescribing a single entrance test as a sole determinant of merit, either for CUs or for the higher education system as a whole, is pragmatic.

elcome to the brave new world of securo-feminism\*. In the long tradition of systems of patriarchal violence representing themselves as the solution to patriarchal violence, the ongoing expansion of draconian "war on terror" measures is being advertised as an advance for women's rights.

For instance, countries like the United Kingdom have extended anti-terrorism provisions to now not only strip citizenship from "terrorists", but also from (some of) those convicted of sexual abuse: a "double punishment" reserved exclusively for dual nationals and suspected dual nationals, predominantly Muslims and other racialised targets from former colonies in the Global South.

Simultaneously, the British government itself is threatening the rights and safety of abuse survivors and others fleeing violence, with its proposed new bill to "secure the borders" by penalising asylum seekers for arriving by unauthorised routes (never mind that such penalties flagrantly violate international refugee law).

In the United States, President Joe Biden's "feminist" credentials include the introduction of new justice mechanisms to address sexual assault within the military: packaged in the same piece of legislation escalating American "defence" spending to unprecedented heights, surpassing even the previous record set by his predecessor Donald Trump.

As for the women, men, and children on the other side of the US military's operations – they continue to be denied any legal avenue of restitution from the American state for the rapes, tortures, and massacres they have endured. Instead, they have been offered paltry "condolence payments" in lieu of justice, if anything at all (and only if they are "friendly to the United States").

Now, many are advocating for states to consider violence against women as a form of "terrorism" - ignoring how counterterrorism itself has functioned globally to sanctify state violence against women as well as men.

Among the women placed in the crosshairs of the "war on terror" are Palestinian women's rights defender Khitam Saafin, sentenced last month by an Israeli military court to 15 months in prison after her organisation, the Union of Palestinian Women's Committees, was listed alongside several other Palestinian human rights groups as "terrorist" entities by Israel; Sudanese women's rights defenders including Amira Osman, arrested and detained in January on "terrorism" accusations by the military coup government; Saudi activist Loujain al-Hathloul, tried in a special "terrorism court" for her work in service of women's rights (she was released last February after being tortured and imprisoned for almost three years); Aafia Siddiqui, abducted, disappeared into a US "black site", and sentenced to 86 years for "attempting to shoot" an American soldier (although she was the one who was actually shot); Indigenous Mapuche land and rights defenders like Patricia Roxana Troncoso Robles, criminalised as "terrorists" by the Chilean state; and Indian activists such as Hidme Markam and Ishrat Jahan imprisoned under sweeping an ti-terrorism laws for protesting against the Hindutva government's assault on Adivasi (Indigenous) and Muslim communities.

Such cases are not simply an "abuse" or "misuse" of counterterrorism, but an expression of its original function: to suppress resistance to the colonial, capitalist status quo, whether on the 20th-century British killing fields of India and Kenya, or in the current-day open-air concentration camp of Gaza.

Likewise, the collusion of some strains of feminism with the "war on terror" is not an "aberration" or "co-optation". Rather, it is the continuation of a long history of Western feminist collaborations with white supremacist and imperial rule - from penetrating colonised women's harems, to promoting moral panics about Black and brown men for violence against women, to providing ideological cover for expanding policing and prisons.

According to this version of feminism, the intensifying criminalisation of women under counterterrorism is to be hailed as a sign of "progress". As a claimed corrective to the stereotype of the "oppressed Muslim woman", academics and policymakers have been urging for Muslim women's "agency" to be recognised by treating them as "terrorists" on a par with Muslim men.

As "feminist demands for equality within the prison system ... have ironically resulted in demands for more repressive conditions in

Exemplifying the perversities of "equalopportunity" criminalisation, Syrian migrant woman Rehab Dughmosh was charged with 14 terrorism offences and sentenced to seven years imprisonment by a Canadian court, for waving a golf club and a knife around in a store – despite having caused only one minor injury, and having been diagnosed as experiencing paranoid schizophrenic delusions at the time.

Dughmosh's "attack" has been cited by women security scholars to critique male-centric agencies for overlooking Muslim women as threats; although Dughmosh was in fact punished much more harshly than many white men responsible for more damaging racist assaults.

Similarly, the UK has stripped citizenship from young Muslims like Shamima Begum who travelled to join ISIL (ISIS) at the age of 15 – while teenaged British Nazi bomb plotters and cell leaders have been offered rehabilitative measures and spared.

Courts have been ordering children removed from the care of "radicalised" Muslim mothers and fathers, while parents' membership in neo-Nazi and far-right groups has been deemed irrelevant to their child-rearing abilities - or in the words of one British court, "neither here nor there".

Germany has been prosecuting women for 'war crimes" for living in houses on land illegally occupied by ISIL in Iraq; while at the same time working to shield Israel from accountability for its crimes of occupation before the International Criminal Court.

The US has set precedents barring women from an asylum for having been kidnapped and forced to cook and clean for violent rebel groups "material support for terrorism" - even as the US's own (very) material support for regimes inflicting mass terror on civilians in Yemen, Palestine, and elsewhere persists.

Despite the proliferation of fascist parties and movements across Western states, the United Nations' 2020 "global" consultations on "the gendered dimensions of violent extremism" focused on every region of the world except for North America and Western Europe perpetuating the colonial geography of "the West and the Rest", in which the Rest have extremism while the West has enlightenment.

Apparently, in the pursuit of securo-"equality", some people are "more equal" than others.

While Muslim women are pathologised for their participation in or proximity to violence, the "war on terror's" women drone warriors and torturers are exalted: celebrated not only for their own prowess, but also as markers of the superiority of the civilisation that produced them.

Senior CIA analysts are feted by Oprah as "superwomen" for writing books on how counterterrorism is like mothering - replete with such wisdoms as "the moms of America will [defeat Osama] bin Laden and all terrorists like him", "don't give in to a bully" (in which the US is supposedly not the bully but the bullied), and 'the hand that rocks the cradle rules the world".

Surveillance drone manufacturers hold free drone giveaways for International Women's Day, while websites such as Women And Drones honour "trailblazers" like Miriam Foxx: manager of the Chula Vista Police Department's drone programme, who previously "oversaw detainee operations" at the torture camp of Guantanamo Bay.

Hollywood productions lionise all-woman

US military units like Team Lioness, whose exploits will soon be coming to a screen near you in a series co-produced by Zoe Saldana and Nicole Kidman.

According to the plot summary: "Saldana plays Joe, a strong-willed, hard-nosed, station chief of the CIA's Lioness program, tasked with training, managing, and leading her female undercover operatives working to assassinate the world's most dangerous terrorists." Of course, the real-life Team Lioness was established to search and surveil not "the world's most dangerous terrorists", but Iraqi and Afghan women under occupation - pitched as an act of "cultural sensitivity" on the part of the occupiers.

Meanwhile, the Organization for Security and Cooperation in Europe's (OSCE's) 2019 guide on understanding gender and violent extremism praises Western armies in Afghanistan for engaging with Afghan women to find out about local events like weddings – which otherwise "could easily be interpreted as an insurgent tactic", which "in turn could have led to violence", thus "result[ing] in longer-term risk to the force from a resentful community.

The disturbing underlying premises -1) that the weddings and other community gatherings of the occupied may be assumed to be "insurgent tactics" and targeted unless proven otherwise, and yet 2) that it is the "resentful community" that is the source of "risk" to the occupying military, and not the other way around - remain unquestioned.

Since the launch of the "war on terror", the world has been fixated on the problem of "Muslim rage." Yet, to invoke the great Black feminist Audre Lorde, it is not "our" rage that has constructed the world's largest mass incarceration system, encircled the globe in military bases, amassed a nuclear arsenal sufficient to destroy life on earth several times over, and consigned those fleeing war and environmental devastation to die by the thousands crossing borders and seas.

"Anger is an appropriate reaction to racist attitudes, as is fury when the actions arising from those attitudes do not change," Lorde wrote in The Uses of Anger. "It is not the anger of women that will destroy us, but our refusals ... to listen to its rhythms, to learn within it, to move beyond the manner of presentation to the substance, to tap that anger as an important source of empowerment.

The other side of "Muslim rage" is the power of radical Muslim love – as manifest in the women who care and mourn for counterterrorism's supposedly "ungrievable" casualties, while confronting death, torture, loss, and displacement themselves; who continue to challenge multiple forces of violence and oppression, even though impeded and imperilled by the "war on terror" waged in the name of women's rights; who are charting out new paths of justice and freedom, beyond the false horizons of "equality" and "empowerment" delineated by the national security state.

Because in a "civilised" world order driving itself towards military conflagration, nuclear annihilation, and ecological collapse, it is not Muslim women who urgently need to be saved from their own extremism.

The stages of emotional healing

Emotional healing faces emotional pain objectively. As a result, the emotional issue that was avoided is confronted. Running away from difficulties can make things worse, therefore relief is sensed at this time. Prepare yourself to deal with the emotional blockage. To understand emotional problems, engage in honest self-talk. Determine your emotional triggers and then confront them. When confronted with negative emotions, try to accept them and you will feel bet-

### 4. INEVITABLE EXPRESSION:

After confronting the emotions, they may disturb us. Learn to honor the pain at this time, and in order to heal, one must learn to express their emotions. When you're depressed, in that situation, crying, yelling, and screaming in an empty room might help you release your unspoken anger and make you feel better. Allowing emotions to persist in the physical body for an extended period of time leads to mental tiredness and withdrawal. Movement toward recovery will take place over time and with patience.

### 5. ACCEPTANCE OF EMOTIONS:

Acceptance is the stage at which you can feel emptied of emotions. It's possible to be numb to all of your traumatic experiences. It's as if it's become a part of the soul. There is mastery over negative emotions when they are accepted. By relinquishing control over current thoughts and sensations, the pain will fade away. After the struggle is finished, the growth can begin. This stage puts your emotional stamina to the test and brings out the best in you. Old habits go away, and one is ready to embrace change. Emotional healing ushers in a new life full of vigour, optimism, and hope.

Making the decision to heal emotionally from the old familiar pattern of hurt and disappointments, followed by acceptance and awareness, is a step toward healing and recovery. The soul is frees itself from emotional shackles and moves forward toward growth and well-being, allowing for significant spiritual development.

# How does it work and why is it lunar?

or Muslims, a month starts when a new moon is sighted. Here Middle East Eye explains why the Islamic calis different to the one most people are used to

More than 1.8 billion Muslims around the world follow the Islamic calendar in some form, meaning key dates, such as New Year's Day, are marked at different times to the rest of the world, the majority of whom follow the Gregorian calendar.

For Muslims, the Islamic calendar, also called the Hijri calendar, holds religious significance and was the main calendar of day-to-day life until the process of westernisation across the Islamic world made the Gregorian calendar dominant.

However, Muslims continue to mark religious events using the Islamic calendar, as well as historic anniversaries relating to the life of the Prophet Muhammad.

The hijri calendar is used to determine the start dates for events, such as the start of Ramadan, the celebrations of Eid, and the Hajj pilgrimage.

The lunar calendar is mentioned in the Quran in Surah Yunus (the Chapter of Jonah). In this chapter, Muslims are told to mark the date based on the stages of the moon.

Here, Middle East Eye answers key questions about the calendar: WHY IS IT CALLED THE HIJRI

**CALENDAR AND WHAT ARE ITS** 

The Islamic calendar is also commonly referred to as the Hijri calendar, a word that comes from the Arabic word hijra, meaning migration.

It refers to the Prophet Muhammad's migration from the city of Mecca, his birthplace, to Medina in 622 CE to escape persecution by his tribe, the Quraysh.

The city of Medina is significant for Muslims, as it was where the early Muslim community, known as the ummah (nation), was established.

Since the migration, 1,443 lunar years have passed, meaning we are now in the year 1443, according to the Hijri calendar.

# **HOW DOES IT WORK?**

The Islamic calendar is governed by the movements of the moon, meaning that each month starts with a new lunar cycle, marked by the "birth" of a new crescent moon.

As it is based on the lunar calendar, the Islamic calendar only has 354-355 days, due to fact that a lunar cycle typically lasts for 29 or 30 days rather than the 30 or 31 days per month used in the solar calendar, which the dominant Gregorian calendar is

If a new crescent moon is spotted on the 29th day, this marks the end of the lunar cycle, hence a new month starts the next day.

# WHAT ARE THE ISLAMIC CALEN-

**DAR MONTHS?** Muharram: The Islamic calendar started with the month of Muharram, Arabic for "forbidden". The month is called that because all forms of fighting are prohibited and worshippers have to refrain from doing anything that would violate the sanctity of the month.

Some Muslims believe that the month signifies new beginnings, as it initially came after Muslims performed the Hajj pilgrimage, and would come back from the ritual having their sins forgiven.

The 10th day of Muharram, known as Ashura, is significant for both Sunni and Shia Muslims. For the Sunni majority, the day is marked with fasting and special prayers in mosques. For Shia Muslims, it marks the anniversary of the killing of the Prophet Muhammad's grandson Hussein during the Battle of Karbala, and is therefore a day of

mourning. Safar: The second month of the Islamic calendar means "void" in Arabic and was given the name because. before the formation of Islam, Arabs would leave their homes in search of



food during this month.

Many would also use this time to travel, leaving their homes empty. Rabi al-awwal: Meaning "first

Spring", the month's name symbolises a period when cattle would start grazing. Muslims believe that the Prophet Muhammad was born during this month, making it particularly special.

Rabi al-thani: named "second Spring", this month symbolises the end of the spring.

Jumad al-awwal: Meaning "first (month) of the parched land".

Jumad al-thani: Meaning "second (month) of the parched land" this signifies the end to dry and arid weather.

Rajab: This month is seen as sacred, and marks the second month in which fighting is forbidden for the faithful. The word rajab means respect or honour, but can also mean "to remove". Some believe that the month gets its name as during this time, people would remove

The name symbolises scorching temperatures and serves as a reminder for Muslims to reflect on their behaviour and try to improve their character, as well as to let go of worldly desires.

The month, in which practising Muslims will fast from dawn to sunset, is one of the most important times of the year for worshippers.

During this month, Muslims will place emphasis on giving to charity, visiting the poor and sick, as well as engaging in extra prayers and asking for forgiveness.

Shawwal: Meaning "raised", the name refers to when female camels raise their tails when they are ready

The first of the month is Eid al-Fitr, a time of celebration after Ramadan. Some Muslims may also choose to fast an optional six days during this month, with the belief that they are rewarded as if they fasted the whole

Dhul Qida: Meaning "the possessor of the truce", the month is another in which fighting is prohibited.

Dhul Hijjah: The final year of the Islamic calendar means "the possessor of the pilgrimage". The Hajj is one of the five pillars of Islam, mandatory for every Muslim who is physically and financially able to undertake it in their lifetime.

Most Muslims will spend the period taking part in supplications and deriving lessons from the lives of the Islamic prophets.

The Hajj pilgrimage ends with Eid al-Adha, the festival of sacrifice, which falls on the 10th day and commemorates the willingness of the Prophet Ibrahim (Abraham) to sacrifice his son Ismael in accordance with a command of God. This is the fourth month in which fighting is prohibited in Islam.

# **WHICH MONTHS ARE SACRED?**

There are four months that are seen as particularly sacred for worshippers. These are Muharram, Rajab, Dhul Qida and Dhul Hijjah.

These months are revered and fighting a war is prohibited in them, except in circumstances of extreme self-defence.

The reason behind the ban on fighting during these four months was to allow pilgrims and merchants to safely travel to houses of worship and return home without the risk of being attacked.

During these months, Muslims are encouraged to be more mindful of their actions and carry out good deeds. Many will spend their time reflecting on pious acts and educating themselves on Islamic teachings. WHICH COUNTRIES STILL OPERATE

In a series of tweets, Shah said: "In a significant step, GoI decisive leadership of PM Shri @ NarendraModi Ji has decided to reduce disturbed areas under Armed Forces Special Powers Act (AFSPA) in the states of Nagaland, Assam and Manipur after decades."

"The Committee has concluded that no purpose would be served by allowing the officer to continue in service in the larger interest of the public," the order said, and subsequently ordered his premature retirement. Detailed orders have been issued as regards four other officers.

"All the procurement of Goods and Services shall be made through GeM portal in terms of relevant provisions of GFR 2017, Manual for Procurement of Goods 2017 and Manual for Procurement of Consultancy and other Services 2017. '

The process of e-tendering, wherever required as per GFR, shall be initiated immediately in the month of April, 2022 and completed by or before 31st May for the year 2022-23. "No diversion shall be made under any pretext unless expressly authorized by the Finance Department."

The Controlling Officer(s)/DDOs, it said, shall strictly monitor revenue collection as per fixed targets on monthly basis which can be viewed in the Annual Financial Statement, 2022-23 available on Finance Department's website and shall also be communicated through BEAMS.

Director Finance(s)/ FA & CAO(S) shall ensure submission of monthly revenue realization

statements and they shall also monitor the expenditure statements on BEAMS and furnish the same before 5th of following month for monthly review by the Finance Department, it said.

All the Government transactions, it said, shall be made through electronic mode without involving any cash transactions in the Government offices or other offices which are directly or indirectly controlled by the Government, excepting for few small denominations. All the Controlling Officers/DDOs,

it said, shall conduct periodic reconciliation of remittances and drawals with Treasury and the Office of the Accountant General (A&E), J&K to ensure correct reflection of income and expenditure in the Finance and other

The funds so released shall be utilized by the concerned authority only for the purpose specified after observing all prerequisite formalities/procedures as per GFR and shall not be available for further re-appropriation/ diversion at any level and for any reason whatsoever, it said.

Treasury Officers concerned have been asked to ensure that releases have been made by DDO(s) through BEAMS. "Treasury Officers shall also be personally liable for making any payment not authorized and accepted on BEAMS application."

The Departments shall ensure that the expenditure out of allotted funds are made in stipulated time-frame within the quarter(s) for which the funds have been released, it said.

The advance drawal of funds in respect of Grant-in-Aid to Autonomous Bodies/PSUs/Boards etc. shall be simultaneously processed with the fund release proposals by the Departments containing the details of available bank balances, status of holding BoD's meeting, status of updation of annual accounts and status of previous UCs, it said. "The ban on engagement of casual workers, need based workers. daily wagers etc shall continue to be in

The expenditure shall be debited to the appropriate head of account as provided in the Demands for Grants and available on the BEAMS portal, it said. "Treasury Officers shall not entertain cases of parking of funds under 'Civil Deposits' unless sanctioned by the Finance Department." Strict action shall follow where any DDO or Treasury Officer violates these norms, it said.

"No bills on account of rent shall be entertained in the Treasury without Rent Assessment Order issued by the competent authority," it said, adding, "The rent payable should not exceed the rent assessment."

Power Development Department, it said, shall furnish online electricity bills on monthly basis to each DDO. "The DDOs in-turn shall contra-credit the monthly billed amount to Major Head: 0801- Power through JKPAYSYS."Under no circumstances electricity bills shall be drawn in cash, it said.

All Departments have been asked to ensure uniform pace of expenditure during the financial year 2022-23. On receipt of this complaint, he said, an enquiry was initiated. "The

enquiry conducted revealed that the accused Shoiab Ashraf Khan is running Tour & Travel companies under the name and style 'EDRAAL Tour & Travels' and 'A&Y' at Nigeen and Kangan respectively for Haj and Umrah purposes in partnership with another accused namely Ashiq Hussain Mir," the spokesman said in a statement.

The accused induced the complaint and his associates to credit an amount of Rs 8 lakh for managing Haj Pilgrimage for them. However, he said, after receiving the money accused persons closed their Tour and Travel office and could not be traced by the complainant despite his incessant efforts.
