



Spurt In Militant Attacks

DGP Calls For Stepped Up Anti-Militancy Ops

JAMMU: Amid a spurt in militant attacks on government forces and non-locals in the Kashmir Valley, the Director General of Police J&K, Dilbag Singh on Friday directed his officers to continue action against militants and their helpers, besides keeping suspicious elements under watch to foil their "ill designs aimed at disrupting normal lives of the people".

Singh made these remarks while chairing security review meetings with senior officers of police and CRPF in the twin districts of Pulwama and Shopian in south Kashmir, a police spokesperson said by

Pak Court Gives Hafiz Saeed 31 Yrs Jail Term **Press Trust Of India**

LAHORE: An anti-terrorism court in Pakistan on Friday sentenced banned Jamat-ud-Dawa (JuD) chief Hafiz Saeed to 32 years in jail in two more terror financing cases.

Earlier in five such cases, the 71-year-old cleric had already been convicted for 36 years imprisonment in five terror financing cases.

The total sentence of 68 years imprisonment will run concurrently. Saeed may have to spend not many years in jail because his sentence will run concurrently, a lawyer told PTI.

On Friday, anti-terrorism court (ATC) judge Ejaz Ahmad Bhuttar handed down 32 years jail term to Saeed in two FIRs -21/2019 and 90/2019 registered by the Counter More on P6

China Tried Hacking Ladakh Power Grid Systems Thrice: Gol

NEW DELHI: China launched "probing cyber attacks" on India's power grid in strategically located Ladakh thrice since December 2021 but did not succeed because safeguards were in place to thwart such intrusions, Union Power Minister R K Singh

said on Thursday. Amid reports of Chinese state-sponsored hackers targeting the power grid, the Ministry of External Affairs asserted India has systems in place to safeguard critical

infrastructure.

According to the reports, the hackers targeted seven Indian state centres responsible for carrying out electrical dispatch and grid control near a border area contested by the two

nuclear neighbours. The group reportedly used the trojan ShadowPad, which is believed to have developed by contractors for China's Ministry of State Security, leading to the conclusion that it was a state-sponsored hacking effort. Asked about the reports at a media briefing More on P6

New Delhi: The NIA on Friday filed a charge sheet against 25 accused before a special court here for a conspiracy to recruit "hybrid terrorists" for Pakistan-based militant groups to carry out attacks in Jammu and Kashmir.

The case pertains to hatching a conspiracy, both on physical as well as cyberspace, for under-taking violent militant acts in Jammu and Kashmir and other parts of the country, by cadres of Pakistan-based proscribed organisations like Laskhar-e-Taiba (LeT), Jaish-e-Mohammed Hizb-ul-Mujahideen Al-Badr and their af-(HM). filiates such as The Resistance Front (TRF), People Anti-Fascist Forces (PAFF) among others, a spokesperson of the NIA said.

The accused, all residents of Jammu and Kashmir, have been charged with sections of the Indian Penal Code and the Unlawful Activities (Prevention) Act, the NIA official said. Investigation has unearthed

a deep-rooted conspiracy of Pakistan-based proscribed organisations joining hands in form of a united group and shifting of their modus operandi by floating pseudo-offshoot outfits portrayed as indigenous resistance groups, in whose name "terrorist acts" are being committed with an intention to claim deniability at the international level, the spokesperson said.

After the abrogation of Article 370, this shift was discernible in claims of militant acts done in Jammu and Kashmir, the National Investigation Agency (NIA) official said.

cientists have found important insights into how SARS-CoV-2, the virus that causes Covid-19, can lead to long-term pain, an advance that could lead to a potential therapy for the disorder.

The experiments involved a hamster model of intranasal Covid-19 infection that closely reflects symptoms experienced by

"A significant number of people suffering from long Covid experience sensory abnormalities, including various forms of pain," said Randal Serafini, a PhD candidate at the Icahn School of Medicine at Mount Sinai in the US.

"We used RNA sequencing to get a snapshot of the biochemical changes SARS-CoV-2 triggers in a pain-transmitting structure called dorsal root ganglia," Serafini said.

Using a hamster model of SARS-CoV-2 infection, the researchers found that infection left a gene expression signature in the dorsal root ganglia that remained even after the virus cleared.


The signature matched gene expression patterns seen in pain caused by other conditions, they

The research was presented at the American Society for Pharmacology and Experimental Therapeutics annual meeting held between April 2-5 in Philadelphia, US.

"Our findings could potentially lead to new therapies for patients suffering from acute and long CO-VID, as well as other pain condi-

tions," said Serafini. "Our study also shows that SARS-CoV-2 causes long-term effects on the body in drastically new ways, further underscoring why people should try to avoid being infected," the scientist said.

How Covid-19 Can Cause Long-Term Pain Found



The researchers observed that SARS-CoV-2-infected hamsters showed a slight hypersensitivity to touch early after infection, which became more severe over

time, up to 30 days. They then performed similar experiments with the Influenza A virus to determine if other RNA viruses promote similar respons-

In contrast to SARS-CoV-2, Influenza A caused an early hypersensitivity that was more severe but faded by four days post-infection, according to the researchers.

Analysis of gene expression patterns in the dorsal root ganglia showed that SARS-CoV-2 caused a more prominent change in expression levels of genes implicated in neuron-specific signalling processes compared to influenza, they said.

The researchers also found that four weeks after recovering from viral infection, flu-infected hamsters had no signs of long-term

hypersensitivity while SARS-CoV-2-infected hamsters showed worsened hypersensitivity, reflecting chronic pain.

The hamsters that recovered from SARS-CoV-2 had gene expression signatures similar to those seen in the dorsal root ganglia of mice affected by pain that was induced by inflammation or nerve injury. The researchers also predicted that SARS-CoV-2 downregulates the activity of several previously identified pain regulators and

a protein called interleukin enhancer binding factor 3 (ILF3). This downregulation occurs at times when pain behaviours in SARS-CoV-2-infected hamsters were very mild, despite heavy systemic inflammation, they said. The researchers hypothesised that mimicking the acute effects of ILF3 could serve as a new pain

treatment strategy. They administered a clinically tested anti-cancer drug that inhibits ILF3 activity, and found that it was very effective at treating pain in a mouse model of localised inflammation.

"We think therapeutic candidates derived from our gene expression data, such as ILF3 inhibitors, could potentially target pain mechanisms that are specific to Covid patients, both acutely and chronically," Serafini added.

"The Crime Branch Kashmir received a complaint from Branch Head J&K Bank Residency Road Srinagar wherein it was stated that on the basis of Preliminary Enquiry conducted by the Bank, it has been established that one Zahoor Ahmad Khan S/o Ghulam Rasool R/o New Colony, Saida Kadal Srinagar, working as Associate Executive in the said Bank has dishonestly and fraudulently raised eight unauthorized loans against the deposits which do not exist in Bank records," a statement issued reads.

AMAN POST, (LOC) -India and Pakistan for a change engaged in a different game other than cricket on Thursday when the passengers from both the parts of divided Kashmir crossed sides at the Aman Sethu (Peace Bridge) here.

Besides the 49 passengers from – 19 from India and 30 km Pakistani part of Kashmir- a large number of media persons gathered from across the globe, leaders of some political parties and of course the soldiers saw the two countries lock horns -in a poster and banner battle.

"Pakistan se rishta kya...la-ilaha-il-Allah" read a huge hoarding erected just

across LoC "Mazhab nahin Sikahat Aapas Mein Bair Rakhna" countered a banner from India. Then there was one from i Pakistan which read. "We welcome our Kashmiri brethren". "Every Step on April 7 will strengthen the bonds between India and Pakistan," was the Indian reply.

However Pakistan gave | an edge over India in display of flags. While the tri-colour was not at all seen at the last Indian military outpost, the green and white dominated the entire area: across the border. Hundreds of Pakistani and 'Azad Kashmiri flags were seen on the other side.

The other count where Pakistanis seem to have scored over India was the errection of a signboard indicating direction and distance to various cities. While the Indian sign showed the distance to Srinagar, the Pakistani one indicated direction to Islamabad, Tehran and Makkah.

The Jammu and Kashmir government presented a momento to the passengers on board the "karvaan-e-aman (Caravan of Peace)" from India and also to those from Muzaffarabad, 'The wooden memento had carvings of two Kashmiris embracing each other. Bouquets were also presented to them

Words Of War

t is familiar territory for the sub-continental neighbours to be locked in tensions and teetering on the brink of war. Aggressive posturing, tough talk, movement of troops, and worse, have all been seen before. As one side blows hot and cold by asserting that no one wanted war but all options were open, the other, naturally, commits itself to a befitting reply in case of a misadventure.

Ironically, the basic issue of bringing the Mumbai perpetrators to book takes a back seat as the antagonists calculate the risks in strikes and counter-strikes. By wisdom of hindsight, it is easy to say that the situation could have been handled better and in a much more productive way had the exigencies of domestic politics not governed the approach to the cricis

The severe clobbering New Delhi has been giving Pakistan right from the start in full view and hearing of the world was bound to make Islamabad feel hurt and humiliated. Its retreat into a bristling, defensive shell, and rebounding accusations with combative denials, is characteristic of an already beleaguered entity being pushed to the wall. If the government in New Delhi has domestic compulsions in being seen to be taking action, if not actually acting, the regime in Islamabad is more hard pressed not to appear succumbing to outside pressure. After all, the Zardari dispensation's indulgent view of US forces targeting its territory has not exactly earned it popularity in Pakistan. And it is not the easiest of tasks to be var in tribal areas in the face of growing resentment at home. Before going hammer and tongs at Islamabad, New Delhi would have done well to take the latter's sensitivities and vulnerabilities into account if it really wanted Pakistan to act meaningfully. By airing its demands openly for all the world to hear and asking for action that amounted, under the circumstances, to nothing less than abject capitulation, New Delhi has painted Islamabad into a corner, foreclosing any chances that there might have been of the latter cooperating

India had been wounded gravely – that is undeniable, but in the interest of the broader and all-important goal of getting the perpetrators collared, wiser counsel should have prevailed. Quiet, persuasive diplomacy, out of sight of the world, with available proof being presented convincingly, would have yielded better results as Pakistan would have been more amenable to India's requirements if approached with sensitivity and understanding. How could New Delhi not have sensed the acute susceptibility of its most important neighbour that is engaged in a highly unpopular military operation in the west and paying a heavy price in bloody terrorist reprisals?

War in the subcontinent would be the recourse of the insane as it entails mutually assured destruction; and having been mercifully recognized as such by both sides, it is incomprehensible that rhetoric has overtaken temperance. Even if the two sides limit themselves to tit-for-tat surgical strikes, nothing would have been achieved and much lost. Needless to say, the painstakingly built composite process would be one of the many casualties and it is doubtful it would ever take off again. Howsoever hemmed in Pakistan may feel, it has to be fair in addressing Indian concerns, and putting at rest the grievances the latter has. The current situation sorely demands an approach of understanding of each others concerns from both sides. Pakistan cannot ignore entirely the apprehensions voiced by India as it has itself suffered at the hands of rogue forces springing from its soil. In any case, it can put its point more effectively through established channels of communications between state rather than shouting

Both neighbours need to get out of the trap of the chequered history of their relations. The temptation to play to the domestic galleries can spin out of control, and if, heavens forbid, it reaches the point of no return, it would be impossible even to pick up the pieces. Terrorism is not the exclusive preserve of any one nation, but both, India and Pakistan, have internal factors that have contributed to the growth of the scourge. New Delhi would win half the battle if it acknowledged that the excuse for attacks on it partly stems from the targeted violence on the minorities, including the Muslims, and that the slaughter in Mumbai in the nineties and later on in Gujarat constitute terrorism as much as the carnage in the Taj and the Trident. Islamabad, in its turn, cannot remain an idle spectator as extra-constitutional forces undermine the authority of the state, and even put the very existence of the nation in peril.

The Energy Stalemate

What is it that is actually needed to ensure energy sufficiency of UT and how to achieve that state?

he last one year and more has seen developments of all sorts crisscrossing the power sector and allied departments in the UT of Jammu and Kashmir. From unbundling of GENCO, TRANSCO and DISCO to speculations about privatisation of power distribution and transmission, to the more recent identification of power sector by the government as one of the economically fertile sectors in J&K, the power sector has occupied headlines for all the good and bad reasons.

The scenario of the power sector in J&K is a complex one both from producer's as well as the consumer's end and the multiplicity of issues revolving around it, call for immediate attention.

From the explicit will and wish of the government to rope in private players into generation business, to unabated pilferage and the mammoth debt which PDD is incurring, all are issues of concern. From the consumer's end, the low power quality and low power supply, shutdowns at times when electricity is needed most and the erratic pattern of electric supply generally throughout the year and particularly during winters, are pressing issues and deserve immediate attention. The tussle between the service provider's and consumer's interests and the multifarious issues arising there-from border on economy, technology, governance and administration.

To smoothen these points of encounter and to arrive at optimal and economic solutions, measures both from government and public side are needed and these measures shall concern us in what follows.

At the very outset, one is beset with paradoxes of sorts. Let's look at these figures before we venture further. According to a report published by Economic Times, only 3,263.46 MW, about 20 percent of the identified potential of 16.475 MW and only about 16 percent of the estimated potential of 20,000 MW has been exploited until now which comprises 1,211.96 MW in the state sector, 2,009 MW in central sector and 42.5 MW in private sector. Another report by Livemint maintains that, "J&K leads in power losses in India " with "a record aggregate technical and commercial (AT&C) losses of 60.5%"

Recently, UT Governor Manoj Sinha said that "at present we are purchasing electricity for Rs 6,000 crore but only getting revenue of Rs 2,600 crore. We are suffering a loss of Rs 3400 crore annually". What do these numbers hint at? It is easy to infer that they describe the state of

technical backwardness, burden on state treasury and persistence of outmoded transmission and distribution networks coupled to heavy pilferage.

Why is it that as of now, less than 20% of the total hydel potential has been explored despite the fact that the first hydropower plant in the UT was established in the last decade of the 19th century? More than a century has passed and we are yet to tap the umpteen hydropower resources that lie scattered across the state, thereby reflecting the lack of fervour on part of the government to enhance, exploit and extend the presence of hydropower in our larger power scenario.

Recently, the LG headed administration expressed its intent to "harness the region's hydropower potential to make the union territory power surplus in the next five years". But have not these promises and assurances struck our ears before?

What is it that is actually needed to ensure the energy sufficiency of the UT and how to achieve that state? Let's invoke simple arithmetic. The cost of installation of one MW of hydel-power is pegged around Rs. 10 Crore INR, according to prevalent techno-economic considerations. By that standard, how much amount will it take, for example, for installation of a 100MW hydel powerhouse?

Simple algebra reveals it to be Rs 1,000 Crore INR. The cost will escalate in accordance with the size of the plant and here lies the first challenge. For an economic deficit state like ours, with state treasury already under various pressures, the question remains whether the state could afford its ventures into large scale hydel projects on its own? And our previous experience has revealed that it can't.

Anytime, the state conceives of higher order projects, it faces off the hard challenge of the economy which obliges it to extend its bowl to the centre and once the centre jumps in, the projects end up in central monopoly, much like what happened to projects like Uri I and II. This leads us back to square one on how to assure self-sufficiency.

The Government has recently been working on small hydel power and captive power plants and inviting private players into the fair play but this itself comes at the risk of increased cost per MW, thereby affecting the consumer preference and energy consumption patterns. The way out of this dilemma is to strike a balance and to chalk a midway between unrestrained centralisation and unwanted privatisation. Privatisation of generation front in terms of engaging private players in small hydel power projects and captive power seems a viable option only as long as it doesn't disturb the existing tariff structure and doesn't put the consumer under unnecessary burden. tance can also be had from central agencies on the precondition that they don't hijack these indigenous power plants. An understanding can be reached between the centre and states and conditions can be arrived at which assure that states'

rights are properly guarded and any attempt to hijack and takeover these projects is strictly met out by the law.

The next major breakthrough is to be sought in upgrading the transmission and distribution networks. It is these networks, their uneconomical performance and outdated technologies and equipment they employ which leads to transmission and distribution losses. We will continue to suffer losses as long as we don't subject our transmission and distribution networks to upgradation.

Yet another face of the same coin is that the pilferage is to be effectively plugged which calls for patrolling by PDD field staff and intermittent inspections. Lest these pilferages and electricity thefts by illegal means of hooking are checked and choked, the prospect of effective transformation of the electricity sector remains bleak. A step has been initiated in this direction by installing smart metres in some areas and the accompanying networking has been claimed to reduce losses and eliminate pilferages. But the persistent complaint that has been accompanying this move is that the tariffs are too high to be affordable by the populace at large. So, a middle ground has to be reached and the interests, both of service provider and consumers are to be taken into consideration. It is only in reaching this middle ground that the impasse can be broken and optimization achieved.

There are some essentials to be learnt and followed by us as consumers. Our ways of energy utilization are both unscientific and uneconomical. Engineering practices teach us that utilizing electricity for heating purposes is the most uneconomical and least desired method of electricity utilization. But in our day to day lives, we use electricity not only for essential heating purposes, but also for purposes like heating huge water tanks, which are later ridiculously left to cool down. Heating gadgets, which consume energy in kilowatts, are left operative even when not needed. To use electric bulbs during the daytime is a common spectre, notwithstanding the cumulative energy losses these practices incur. All these steps are to be taken in unison by the energy producers (Government) and energy consumers (People) to take our state out of the present electricity moras

s India Inc braces itself for return to office, employees, specially in sectors like IT, consulting, etc, have been demanding continuation of 'work from home' (WfH). A recent survey by CIEL HR Services found that of close to 2,000 employees in 600 companies, 67% were even ready to quit jobs if denied the WfH option.

With the pandemic came the world's biggest-ever workplace experiment. The immediate popular verdict was: remote working works. and has benefits too. Soon enough, WfH gave way to WfA (work from anywhere). Companies, of course, expected WfH to yield to a returnto-office regime once the infections seemed to be abating-only, the second Covid surge soon negated any such plans. When large cities faced reverse migration, smaller ones offered more space at less expense. Many opted for professional coworking spaces, for WfA. With links enabling companies and people to engage beyond geographies, WfH/ WfA was not just location-agnostic, but also cheaper and greener too.

Notwithstanding its benign effects, WfH in most cases was viewed as a temporary fix. Defining WfH as "home-based teleworking as a temporary alternative working arrangement", the ILO estimated around 18% of workers worldwide engaged in occupations suitable for WfH with requisite infrastructure. Those working in plants, warehouses, supply chains, or in hospitality businesses, etc. perforce needed to be physically present. Terming remote work an "aberration", Goldman Sachs, Morgan Stanley, JP Morgan Chase, etc got counted among the most ardent supporters of the status quo ante. For many, prolonged work from home, missing the buzz of the

office and spontaneous interactions with colleagues with occasional light banter, tends to create stress.

Meetings on Zoom or Teams can't provide energy, warmth and understanding that physical gettogethers do. Recreating social connectivity, that enables people to be collaboratively productive, is not easy in virtual and hybrid settings. Technology is vital, but not enough. Apple co-founder Steve Jobs had said, "Technology alone is not enough. It's technology married with the liberal arts, married with the humanities, that yields the results that make our hearts sing".

Many tech CEOs fret that strict return-to-office mandates will put off restless software engineers, warn that employees will jump ship if rules are too restrictive. A growing trend indicates employees want more choices on when and from where to work. While most are keen to attend office, especially for collaborative work, they want flexible and fewer workdays. Employer expectations appear in line with the seismic shift in employees' thinking. Tata Steel intends to continue with its 'Agile Working Model", enabling WfA for employees; even those based at designated locations can work from home.

The pandemic's disproportionate impact on women, in terms of increased unemployment and domestic responsibilities, makes WfH

a favoured option. The flexibility of location and work schedules would indeed attract more women. Team-Lease reports a 25-37% increase in the number of women applying for jobs and getting employed in IT, ecom, healthcare, retail, knowledge process outsourcing, pharma, automotive—it is likely that the WfH has played no small role in this.

A Mint-Bain India survey of some 105 CEOs found less than onethird thinking of remote work to be the present and not the future. According to a report on India's job market, The Pandemic and White Collar Migration, 67% of the country's large and 70% of mid-size firms would not continue remote working, post the pandemic—asserting the credo that culture outweighs convenience. In contrast, BCG's recent Workplace of the Future survey found 60% of employees wanting flexibility in where and/or when they work, autonomy to decide WiO (work in office) or WfH. The new workplace will perforce be modular and agile, online as well as offline, multi-locational, facilitating collaboration and productivity.

As Peter Drucker often maintained, an organisation must evolve strategy that enables it to derive results in an uncertain environment; corporates are re-imagining the new future of work, to be future-ready. Today, the fusion of business and technology unfolds immense new

possibilities; collaborative virtual workspaces are becoming a new normal; companies are embracing hybridisation as never before. Citing studies, PepsiCo maintains employers who offer flexible work see a 15% rise in productivity, 31% less absenteeism, and 10% less turnover.

absenteeism, and 10% less turnover. "Remote" work wouldn't mean that all or most employees always work from home; employees may split their time between home and the workplace. As the recent PepsiCo policy under 'Work that Works' delineates, company managements can choose what work can be done remotely, and what needs be done in offices. Like Mercedes-Benz India opting for a hybrid model with 50% of non-production staff on campus, Tata Consultancy Services is transitioning into a 25X25 hybrid mode with no more than 25% of its associates working from an office at any given time, spending no more than 25% of their time in the office.

With change now happening so rapidly, it gets tough to predict what the deep future may hold. Paul McDonald of consulting firm Robert Half anticipates that employers will be more open to flexible work formats, including combining time at the office and working from home, workers having the flexibility of working from home and going to office occasionally for team planning, capability building, and social connect.



For A Better Future For Islam, Muslims And West

Reading John L. Esposito's 'The Future of Islam'

'The Future of Islam' is an insightful and perceptive work proposing the way forward for a better future for Islam, Muslims and the West

Today Islam is the fastest-growing religion in Africa, Asia, Europe, and America. More than 1.5 billion Muslims are living in 56 majority Muslim populated countries worldwide and some significant minorities in Europe and America (where it is second and third-largest and fastest-growing religion respectively). That is, presently, Islam is more dispersed around the globe, and its capitals and major cities cover a global expanse from Cairo to Jakarta in the Muslim world and from New York and Los Angeles to Paris, London, and Berlin in the West

But, at the same time, over two decades (21 years) have passed since the tragic events of 9/11, but still many speak of—and still believe in—the 'clash of civilizations', 'What went wrong?' or 'Why do they hate us?' At the same time, there are a number of questions raised and asked about Islam, as if everything good is related to the other part of the question and as if whatever is wrong, is part of Islam.

Professor John L. Esposito (Georgetown University, USA)—who is regarded as one of the most important and influential leading scholars of Islam and the Muslim politics—in this new edition of The Future of Islam (Forwarded by Karen Armstrong) seeks to understand the "struggle for reform in Islam to "explore the religious, cultural, and political diversity of Muslims facing daunting challenges in Muslim countries and the West, to clarify the debate and dynamism of Islamic reform, to examine the attempt to combat religious extremism and terrorism, and to look into the future of Muslim-West relations" (p. 3).

For Esposito, from 1970s especially, "Islam and Muslim politics have moved from offstage to center stage" and thus one witnesses "an explosion of interest in and coverage of Islam" (p.4), because the topic of Islam and of Muslims is political as well as religious, and Islam is "not only a faith... [but] also an ideology and worldview that informs Muslim politics and society" (p. 4). The Future of Islam, in this direction, is about "all of our future", because, as Esposito puts it: "Islam and Muslims today are integral players in global history. They are part of the mosaic of American and European societies. In a world in which we often succumb to the dichotomy between 'us' and 'them', we are challenged to transcend (though not deny) our differences, affirm our common humanity, and realize that 'we', whether we like it or not, are interconnected and co-dependent, the co-creators of our societies and our world" (p. 5).

Through this book, Esposito wants to tell the story about "how we got to where we are and what we need to understand and do to create... 'a new way forward'" (p. 6). Divided into four main chapters, the book is preceded by Foreword (by Karen Armstrong, pp. ix-xi), Preface (pp. xvi-xviii) and Introduction (pp. 3-9), and is followed by a precise but perceptive 5-page Conclusion (pp. 195-9).

Chapter 1, "The Many faces of Islam and Muslims" (pp.10-55) provides a brief introduction of Islam and Muslims, and of Islam in/and the West. Esposito, here, clearly points out that while we commonly speak of "Islam", in fact "many Islams or interpretations of Islam exist", and the images and the realities of Islam and the Muslims are multiple and diverse: religio-culturally as well as politico-economically (p.11). He also highlights the fact that Islam, like other faiths, has historically been a "source not only of compassion, morality, and virtue but also of terror, injustice, and oppression." (p.12)

Chapter 2, "God in Politics" (pp.56-87) provides the background and the context for understanding political Islam, the role of religion in politics and society, and its impact on Muslim societies and the West. Esposito here examines the reassertion of Islam in Muslim politics and society, looking at its impact and global implications, seeking to answer various questions, like what is political Islam? Are all Islamic movements a threat? For him, Muslims today face twofold challenge of religious and political reform, both of which are integral to the development of Muslim communities and the marginalization and containment of religious extremism and terrorism, and thus the ongoing challenge is "to formulate and implement doctrinal and educational reforms (in schools, madrasas, and universities) that more effectively respond to the challenges of globalization in the twenty-first century with its need for all religious faiths to emphasize inclusive rather than exclusive theologies, theologies that foster mutual understanding, respect, and religious pluralism"

Addressing the critical questions and issues in Islamic reform, Chapter 3, "Islam Needs a Reformation" (pp. 88-141), looks at the roots of reform and the extent to which it continues today from Egypt to Indonesia as a broad array of Muslim religious leaders and intellectual, men and women, traditionalist and more modern-oriented reformists, discuss and debate in a dynamic process of reinterpretation and reform. He presents the views of a globally and intellectually diverse group of reformers—like Tariq Ramadan, Amr Khaled, Sheikh Ali Goma'a, Mustafa Ceric, Yusuf al-Qaradawi, Nurcholish Majdid, Timothy Winter, Farhat Hashemi, Amina Wadud, Heba Raouf, and Abdullah Gymnastiarworking and speaking out on issues of religious and political reform. In the beginning of this chapter, Esposito ardently argues that the questions "Is Islam capable of reform?" and "Are there Islamic reformers?" are not only "strange, [but] even absurd" (pp. 88-9) because the issue is not "whether there will be change but rather how much and what kind" of change is needed and necessary. For him, given the human nature and dynamic historical and social context of a religion, "change [in interpretation] is inevitable" (p. 89).

It is in this context (of this message) that Karen Armstrong (in her Foreword) has pointed out and appropriately emphasized that there are many "reformers" in the present Muslim world, who like Martin Luther (1483-1556) articulate, by challenging the common Western view of Islam, an important trend in Muslim thinking, which, on one side, "does not clearly regard a literal interpretation of scripture as normative"; and on the other, regards "self-criticism as creative, necessary and religious imperative", "abhors terrorism and violence" and is anxious to initiate a "gender iibad" (p. x)

to initiate a "gender jihad" (p. x). Esposito argues that although these intellectuals have addressed the "role of Islam in contemporary society" (p. 89), but a major challenge for all these reformers is the "importance of linking, of showing continuity, between proposed changes and long-held Islamic beliefs and traditions", and thus "The legitimacy of Islamic reformist thought, its acceptance or rejection, hinges on its perceived Islamic character and authenticity. Therefore, the "how" is as important as the "what"; the process of change (methodology) is often as important as the actual reforms themselves" (p. 94).

Moreover, in Chapter 4, "America and the Muslim World: Building a New Way" (pp. 142-194), Esposito makes an analysis of the challenges of Islamophobia, failed American foreign and domestic policies, the roles of militant Christian Zionists and the media, and the continued threat posed by religious extremism and terrorism. It also throws light on interfaith and inter-civilizational dialogue and such initiatives as the Amman Message and "A Common Word" (pp. 186-191) as well as at the role of public diplomacy in new paradigm to rebuild America's image and role in the Muslim world. Appreciating the conviction of Esposito's present book, Armstrong in her Foreword supports this view also when she argues that the "future of Islam does not simply depend the effectiveness of a few Muslim reformers but that the United States and Europe also have a major role to play" (p. xi).

Finally, in the "Conclusion", Es-

posito makes the following key and important arguments, and it is not necessary that one should agree with his presumptions.

- 1. In the 21st century, Muslims—throughout the world—stand at "major crossroads", as they face a world of multiple modernities, and thus struggle with living and practicing their "faith in a rapidly changing world"(p.195);
- 2. Reform-minded Muslims—
 equipped to reinterpret Islamic
 sources and traditions to meet
 the challenges of modernization and development, leadership and ideology, democratization, pluralism, and foreign
 policy—are articulating a "progressive, constructive Islamic
 framework" (p. 195);
- 3. The fundamental problem for the development and long-term stability in the Arab and Muslim worlds "is not the religion of Islam or Islamic movements but the struggle between authoritarianism and pluralism" (p.196):
- 4. The future of Islam and Muslim-West relations remains a key political and religious issue; and that inter-civilizational dialogue is not only a prerogative of religious leaders and scholars but is now "a priority for policymakers and corporate leaders" and is "the agenda for international organizations" (p.198);
- 5. It is necessary to recognize that the Children of Abraham are part of, not only the Judeo-Christian heritage, but of a rich Judeo-Christian-Islamic history and tradition; therefore, steps should be taken—and efforts be made—to hook up this "missing link", for the "peoples of America, Europe, and the Muslim world have many shared values, dreams and aspirations" (pp.198-9)

The book ends with this striking (inspiring and perceptive) message: "The future of Islam and Muslims is inextricably linked to all of humanity. All of our futures will depend on working together for good governance, for freedom of religion, speech, and assembly, and for economic and educational advancement" (p.199).

In sum, The Future of Islam is very insightful, perceptive, and comprehensive work that proposes the way forward for a better future for Islam, Muslims and the West. It is highly recommended for all those interested in knowing about the past, present, and future of Islam and the Muslims, and of the Muslim-West relations.

The Powerful History of Zakat

ach year, Allah presents us with an opportunity to purify our hearts and wealth through fasting and Zakat. Our deen has been formed in a way where we are given endless opportunities to reflect, turn to Allah and contribute to our communities through an array of practices, with Zakat being a key element.

Zakat is also the third pillar of our faith. The importance of community is embedded into the five pillars that we strive to uphold in our daily lives. After we have affirmed our belief in Allah as One, we are strongly recommended to offer our obligatory prayers in congregation. The Prophet said, "The reward of the prayer in congregation is twenty seven times greater (than that of a prayer offered by a person alone)." [Bukhari]

After this, we are obliged to give back to our communities and better the world through Zakat. In this article, we take a deep dive into the history of Zakat, how it changed the communities it was implemented in and how the world, as we know it today, can still be changed for the better through the power of Zakat.

THE POWER OF ZAKAT

Zakat literally means "to cleanse". Through Zakat, our wealth is purified, increased and blessed. The Prophet said:

"Whoever pays the Zakat on his wealth will have its evil removed from him." [Ibn Khuzaimah and at-Tabarani]

The evils are removed from our wealth, our sins are forgiven, we are rewarded for our obedience to Allah and when we trust Allah to pro-

vide for us, we can never be disappointed.

"And He (Allah) will provide him from (sources) he never could imagine. And whosoever puts his trust in Allah, then He will suffice

him." (Qur'an 65:3)

While Zakat is a means to get closer to Allah and invite barakah into our lives, its effects reach even further than us as individuals.

There are two types of Zakat that we are obligated to pay annually if we have the means to do so. Zakat Al Fitr is paid at the end of Ramadan and must reach its recipients on the day of Eid. Zakat Al Mal is paid annually on 2.5% of your net wealth.

This way, Allah ensures the redistribution of wealth so that it reaches our Muslim brothers and sisters who truly need it. In the Qur'an, Allah reminds us that our community also has a right over our wealth, that when we have the ability to alleviate the suffering of others with our financial support, then we are not only recommended but obligated to do so.

THE HISTORY OF ZAKAT

Historically, the concept of Zakat was seen as a financial system amongst Muslims that ensured every single member of the Muslim community was looked after. It was established in 2 A.H., shortly after the Prophet ## migrated to Madinah.

Soon after, Zakat was made obligatory with the revelation of an ayah from Surah Al Taubah. Allah said: "Take, (O, Muhammad), from their wealth a charity by which you purify them and cause them increase, and invoke [Allah 's blessings] upon them. Indeed, your invocations are reassurance for them." (Qur'an 9:103)

Before this, charity had only been highly recommended. With the enjoinment of Zakat, a new system of collection and distribution of wealth was implemented by the Prophet in the city of Madinah and people were employed to ensure the smooth running of these systems. Zakat was one of the most important catalysts in making Madinah a thriving, prosperous city

focused on adhering to the rules of Allah and ensuring the welfare of every single member of the community.

Allah also explained the benefits of Zakat in

Surah Baqarah, He revealed: "And establish prayer and give zakat, and whatever good you put forward for yourselves – you will find it with Allah." – (Qur'an 2:110)

Zakat has actually completely transformed society in the past. In 98 AH, Umar ibn Abdul Aziz, 8th Ummayad Khalifah and one of the most renowned leaders of Islam organised a strict collection and distribution of Zakat. Within two years of his rule, the state was in such prosperity that they were unable to find anyone within the rule of Umar ibn Abdul Aziz who was eligible for Zakat!

If Zakat was implemented at a global scale, with everyone in the entire world giving 2.5% of their wealth to those in need, world poverty could end altogether. Even if it is not that simple, it helps to remember that at the end of the day, we will be asked only about what we did to help where we are obligated and we will be rewarded for our intentions and efforts and the positive changes brought about in the world through our Zakat and voluntary charity.

ZAKAT AND RAMADAN

Since good deeds are multiplied by 70 in the last ten days of Ramadan and the Prophet (ﷺ) is said to have been his most generous during this month, many people calculate their Zakat year to start in Ramadan.

Connecting with our communities is a need instilled in our hearts, an obligation set by Allah and a right our Muslim brothers and sisters have over us. By following the guidelines that Allah sent down with our beloved Prophet set, we can earn His love, His shade and the companionship of the Prophet all while contribut-

Ex-J&K Minister, Ex MLA Join Kejriwal Party

New Delhi: In a boost to the Aam Aadmi Party's plan to strengthen its base in Jammu and Kashmir, a former state minister, an ex-MLA and a former Congress leader joined the party here on Friday.

Along with them, more than hundred local leaders including village heads, block development council (BDC) members and district development council (DDC) members also

joined the party.

They were officially inducted into the AAP by Delhi Deputy Chief Minister Manish Sisodia and Environment Minister Gopal Rai in the presence of Durgesh Pathak, in-charge of party's political affairs in Jammu and Kashmir, and other leaders at the party headquarters.

Former Jammu and Kashmir minister Yash Paul Kundal, ex-legislator Balwant Singh Mankotia, DDC member Taranjit Singh Tony and former Congress leader Surinder Singh Shingari were among the prominent faces who joined the Arvind Kejriwal-led party.

Tony had defeated for-mer BJP minister Sham Lal Choudhary in the DDC election in Suchetgarh constituency in 2020.

The joining of these leaders was seen as a shot in the arms of the AAP with the party working with an increased focus to expand its base in Jammu and Kashmir, with an eye on the assembly elections expected to be held in the Union territory after completion of the ongoing delimitation exercise.

According sources, Kejriwal is likely to visit Jammu and Kashmir soon.

"By joining the Aam Aadmi Party in such a large number, you have sent out a message of 'inquilab' (revolution) to the central government. You have announced that Jammu and Kashmir wants change, senior AAP leader Rai said while addressing the newly inducted leaders from the Union

SRINAGAR: Chief Secretary, Dr Arun Kumar Mehta on Friday chaired a meeting to review progress on implementation of Bharat Net scheme in Jammu and Kashmir.

The meeting was attended by Divisional Commissioner, Kashmir, GM BSNL Srinagar, BBM, Srinagar while as Principal Secretary to Lieutenant Governor, Divisional Commissioner, Jammu, Secretary IT, GM BSNL Jammu, GM BBM Jammu and others participated online.

While chairing the meeting, CS directed the officers to expedite the process for implementation of Bharat Net scheme in the UT so that all the Gram Panchayats are provided broadband connectivity within the shortest possible time frame.

Under the ambitious Bharat Net Programme, Government of India has envisaged to provide broadband connectivity to all gram panchayats throughout the country.

While reviewing implementation of Bharat broadband scheme in rural parts of Jammu and Kashmir, Chief Secretary was informed that Optical Fibre Cable (OFC) Connectivity has been provided to all 427 GPs planned under Phase -I in 13 blocks of JKUT. Besides, 673 GPs have been connected through V sat in remote areas of all the districts under Phase I.

Dr Mehta said that all the 427 panchayats, which have been connected through OFC, can have multiple connections and will extend Internet facility to a school, nearest hospital and a CSC centre (which can work from gram panchayat).

Emphasizing the importance of digital inclusion at the grass roots level, CS impressed upon the concerned to ensure that net enabled gram panchayats function properly so that they could be used as hubs to connect youth clubs, anganwadi centres and other important public sector installations for awareness campaigns on government schemes.

He said that all the gram panchayats should be maintained well in all respects and the VLW should take adequate steps for its proper maintenance. He directed the concerned officers to iron out all the difficulties on this account maintaining that all panchayats should have a power connection. He cautioned the officers of any laxity in proper functioning of gram panchayats.

He asked the concerned to verify the functionality and efficiency of internet facilities already established in 1092 gram panchayats by holding interactions with the officers either through video conferences or google meet on regular basis.

Chief Secretary also directed the concerned to work in close coordination so that phase second of Bharati Broadband Scheme progresses smoothly under which rest of the gram panchayats in JK would be provided internet connectivity.

Secretary IT gave a detailed presentation about the progress on Bharatnet project Phase 1 saying that several initiatives have been taken up to improve the performance of BharatNet project. She informed that satisfactory VCs were arranged in 39 GPs including those connected with V-Sats. She added that physical verification of 267 V-Sat sites has been done to ascertain their working.

J&K Adds 1900MVA **Transmission Capacity In Year 2022**

SRINAGAR: While marching towards realizing the dream of proconsumers the Power Development Department (PDD) has been successful in adding about 1900 MVA transmission capacity to its kitty in the year 2022 alone, an official spokesperson said Friday.

He said that the unprecedented achievements in power generation, transmission & distribution sectors in the last year have completely overhauled J&K's power infrastructure which remained dilapidated for several decades.

"This reflects the remarkable progress attained by the UT in mission capacity on March 31, 2021, was 9153 MVA and in oneyear the capacity reached 11016 MVA," he said.

"With the focused intervention the UT government is working to make Jammu and Kashmir power surplus in the next four years as the electricity generation capacity in the union territory is set to be doubled in the coming three years," he added.

Moreover, he said, the Transmission and Distribution projects worth Rs 2000 crore are being execution. These measures will completed and an additional amount of Rs 6000 crore has been allocated by the central government to strengthen the Sub-Transmission and Distribution network across the UT.

To provide quality electricity to all citizens and businesses, the spokesperson said, augmented facilities will address the imporviding 24×7 power supply to its tant need of the growing economy. Since August 2019, 3806 MVA has been added to the total capacity as compared to the 8394 MVA capacity achieved in seven decades.

The government is planning to invest Rs12,000 cr for capacity augmentation and upgrading the transmission & distribution systems to remove all supply constraints, and strengthening electrification assets, an official said.

"Electricity will be delivered through underground wires in the capital cities of Jammu & Srithe power sector. The total trans-nagar," he added. It is pertinent to mention that Rs 5000 cr investment in system strengthening has yielded impressive outcomes in power distribution.

According to the statistics provided by the power department, 226 substations of 33/11Kv capacity were installed or augmented besides the installation of 6702 distribution transformers."The distribution network is being strengthened as 2243 CKM HT The spokesperson said that as Lines were laid, 5253 CKM LT lines were laid last year" revealed the officer. He said that with augmentation work on 21 Sub-stations completed last year and another 21 completed by 31 March 2022 the power scenario in the UT is going to change for better.

According to a senior official, the present administration is eliminating the legacy of delays and all the languishing projects hanging for long are being completed in a record time.

SRINAGAR: The Higher education department should strive to make the current year the year of academic excellence, Principal Secretary, Higher Education Department, Rohit Kansal said Friday.

He was chairing a review meeting with principals of Degree Colleges of Kashmir division at Government College for Women, M A road,

Badyal, Director Colleges, Professor Yasmeen Ashai, Nodal Principal, Kashmir division colleges, Dr. Khurshid Ahmad Khan and Principals of all degree colleges of Kashmir Division attended

Speaking on the occasion, Principal Secretary shared his vision of giving a fillip to higher education sector of J&K. He listed out the priority areas including academics, research, on and collaboration to improve quality of education in colleges.

Referring to relevance and importance of New Education Policy 2020, Principal Secretary instructed the principals to ensure its implementation in letter and spirit. He added that in the spirit of the NEP, the colleges should strive towards quality and employability. He also informed that while admissions for the current session would be shortly initiated by the universities and colleges, the academic calendar throughout J&K would be made uniform and synchronized with the national calendar.

Principal Secretary stressed on enhancing the employability of college pass outs in line with NEP-2020. He said colleges have to act as real agents of change and the success of NEP 2020 depends on how well they implement it at the ground level.

He said, as envisaged by NEP, the curriculum must include basic arts, humanities, languages, literature, culture and values in addition to science and mathematics to develop all aspects and capabilities of learners.

Principal Secretary said the main thrust of NEP is to end fragmentation of higher education by transforming higher education institutions into large multidisciplinary universities, colleges, and knowledge hubs.

He exhorted upon the college authorities to give equal emphasis on teaching and research. He said research ecosystem can be improved and enhanced through a holistic and multidisciplinary education approach. He added that the colleges need to enable and encourage multidisciplinary/cross-discihigh-quality plinary research.

He referred to decision of the UT administration of ensuring that all higher education institutions move progressively towards greater autonomy. He said all the degree colleges would apply for accreditation or pro-visional registration (PAC) under the NAAC framework this year.

Principal Secretary said research and teaching collaborations and faculty and student exchanges with reputed foreign institutions will be facilitated through mutually beneficial and relevant MOUs.

He said student feedback shall be solicited online to ensure valuable input at regular intervals to ensure efficiency in working of the colleges.

He emphasized the need for revitalization of the career counselling cells of the colleges and directed that each college should ensure workshops and lectures by professionals to guide the students in the placement process. He also advised the colleges to encourage and



guide the students to access higher learning and research opportunities not just in the rest of the country but reputed institutions overseas too.



NYON: Chelsea got 5.1 million euros (\$5.55 million) from European Championship revenues for releasing players to their national teams, UEFA said Friday.

UEFA had a fund of 200 million euros (\$217.5 million) to pay clubs a daily rate per player involved in the Euro 2020 tournament and qualifying, plus Nations League games since 2018.

The list of payments was announced one day after UEFA approved an increased total of 240 million euros (\$261 million) for clubs whose players are called up to national teams through the Euro 2024 tournament in Germany.
