Sarpanch Shot Dead In Baramulla LG Says Perpetrators Will Be Punished Soon, NC

Says 'Unending Cycle Of Violence Heartbreaking'

SRINAGAR: Unidentified militants on Friday shot dead an independent Sarpanch in Pattan area of north Kashmir's Baramulla district.

Manzoor Ahmad Bangroo, an independent Sarpanch was shot dead by unknown militants in an orchard in his native Goshbug village of Pattan on Friday evening, officials said. They said Bangroo had re-

ceived multiple bullet injuries in the militant attack and was taken to the hospital, where the doctors declared him brought dead. Soon after the incident, po-

lice and army reached the spot and launched a search operation to nab the attackers. However, no one was arrested when the last reports came in. "#Terrorists fired upon &

#killed one Manzoor Ahmad Bangroo (an Independent #Sarpanch) at Goshbugh area of Pattan, #Baramulla. Area has been cordoned off & search to track the involved #terrorists is in progress. Further details shall follow," Police posted on its official Twitter handle

The killing of Bangroo comes over a month after militants shot dead a Sarpanch inside his home in Khonmoh area of the city outskirts here.

March 9, militants On barged into the house of Sarpanch Sameer Ahmad Bhat in Khonmoh area of Srinagar indiscriminately fired upon him. Bhat, who sustained critical gunshot injuries in the

attack, was immediately shifted to SMHS hospital for the treatment where he succumbed.

Meanwhile, J&K Lieutenant Governor, Manoj Sinha and several mainstream parties condemned the killing of Sarpanch and expressed solidarity with the bereaved family. "Perpetrators of this despi-

cable act shall be punished. My deepest condolences to the bereaved family in this hour of

grief," LG Sinha said in a tweet. Taking to its official Twitter handle, the National Conference said that the "vicious cycle of violence" seems to be unending.

CAG Raps J&K For Failing To Submit Utilisation Certificates

JAMMU: Jammu and Kashmir has failed to submit 2,205 utilisation certificates (UCs) for an amount of over Rs 10,441 crore as on March 31, 2020, the Comptroller and Auditor and General of India (CAG) has said, noting that of-ficials should be held accountable for the lapse. It said the non-submission of the UCs means that authorities have not explained as to how funds

were spent over the years and is fraught with the risk

of misappropriation. As per the CAG's latest report on state finances, a total of 2,205 UCs involving Rs 10,441.58 crore was outstanding in J and K, of which 1,370 UCs amounting to Rs 5,972.99 crore was outstanding for more than a year. Stone Crushers In Rajouri: NGT Seeks Report

NEW DELHI: The National Green Tribunal has formed a committee and sought a report on a plea against operation of stone crushers in violation of environmental norms in Jammu and Kashmir's Rajouri district. A bench headed by NGT Chairperson Justice A K Goel said it is clear from the report of the district magistrate that there have been serious violations in operation of stone mining to the detriment of the environment.

"Steps so far taken to prevent illegal mining and further pollution are inadequate. So are the steps to make the violators accountable for past violations.

Confessions Of Coldblooded Murderers Who Shocked Kashmir

nside a police lockup in Srinagar, the two brothers had defied their chilling crime akin to some thick-skinned felons. Sporting a fasting faithful's signature symbol including a skullcap, they kept denying their role even as the sleuths persisted grilling.

Hours later into the questioning and they were behaving as if they had never "slept with the dead body" for 24 hours before dumping it in the murky waters of Dal Lake.

"They were acting as coldblooded killers-covering up the

act of petrifying patricide," says Lateef Ali, SHO Nigeen Police Station, who was part of the team who investigated the sensational murder that shocked Kashmir in the beginning of Ramadan.

"But in a bid to outwit police, they confessed one of the shocking crimes in Kashmir."

Before taken to the police custody, the siblings-Junaid Khursheed, a private lab technician, and Omair Khursheed, a jobless young man-had conceived the crime to end their father, a retired employee at HMT, Srinagar. On the night of the murder,

the local mosques were reverberating with special prayers of Ramazan. After offering eight rakats of Taraweeh at Elahibagh Soura's local mosque, Khurshid A. Tota, 62, came back home at around 9:30pm.

The elder was still feeling bitter after facing his spiteful family members earlier that day. He didn't speak to anyone and quietly retired to his room. "But both his sons had

planned to finish him off that night only," SHO Lateef says. With loud speakers booming

inside their i-20 car and drove towards the Dal Lake.

They took the Foreshore Road and pulled over near a deserted path. Sensing the opportune time to coverup their crime, they took out the cold and pale body of their father and threw it into the lake.

These Are The Most Useless Car Tech Features

Some tech systems in new cars are helpful. Others are not. Here's what's good.

ars are getting smarter. While you can't buy a true self-driving car at a dealership, the vehicles that are available are still crammed full of the newest tech-even if some features are gimmicky. There's just one problem: hardly anybody is actually using it.

Many seasoned drivers remember their first car with cruise control, or air conditioning. Heck, some people who started off in a Ford Model T have even gotten the chance to sit behind the wheel of an all-electric Mustang Mach-E. Technology has changed the way that the world uses the automobile, but some of the features found in modern cars seem to be a tad egregious. According to a 2021 study from J.D. Power, based on a survey of more than 100,000 new-car owners, drivers seem to agree.

More than one in three advanced technologies go unused during the average vehicle's first 90 days of ownership. The biggest reason? Most people say that they simply don't need fancy features like an infotainment system that can pay for their coffee, driver-topassenger communication devices, and gesture controls.

For example, General Motors' aptly-named Marketplace app and others like it are infotainment-based tools where drivers can pay for food and fuel, make reservations at a nearby hotel, or check-in to a store for curbside pickup. These seem like things that the majority of people would do from their phones instead of their car, and most new vehicle owners who have a marketplace-equipped vehicle seem to agree. A total of 61 percent of those owners say they have never used their in-car marketplace, and 51 percent of those also say that they have no need for it at all.

Driver-to-passenger communication devices seem to be another gimmick, at least according to owners. These features typically are reserved for larger vehicles and allow the driver and passengers a way to better hear one another without raising their voices-the Honda Odyssey has CabinTalk, the Toyota Sienna calls it Driver Easy Speak, and Cadillac's premium Escalade SUV refers to this as its 'Conversation Enhancement System." Still, at least 52 percent of owners have never tried this at all in their feature-equipped vehicle, and 40 percent of those say they don't need it, period.

Then there are the features like BMW's gesture controls, which some people find intuitive. Instead of reaching forward to tap on the infotainment screen, drivers can use their hands to navigate menus, change the volume, and more. Unfortunately, this tech also gives buyers the most trouble, with 41 problems reported per 100 vehicles. It also leaves owners the least satisfied of any in-car tech, ranking last in J.D. Power's satisfaction survey for the second year in a row.

There are a core set of must-have features for



many new car buyers. Two of the most-loved technologies revolve around vision. Owners say that a camera-based rear-view mirror and ground-view camera are both ranked as the most well-executed tech feature in their vehicle. The systems are also highly desirable for owners, with 62 percent of US buyers saying that they would want the ground-view camera to be equipped in their next vehicle.

Interestingly, one-pedal driving-allowing the driver of an electric car to utilize the regenerative braking of the electric motor to avoid taking their foot off the accelerator pedal to brake-also ranked extremely high among EV buyers.

On the topic of electric cars, J.D. Power says that Tesla ranks highest in its Innovation Index. The all-electric automaker has

made a name for itself from its new and innovative features, from an advanced Level 2 semi-autonomous driver's aid to its minimalist screen-focused interior. This ranking is unofficial, however, as Tesla doesn't qualify for an actual place on the board since it doesn't allow J.D. Power to survey owners in 15 states.

Officially, Genesis has the highest Innovation Index score of any luxury car maker, and its sister brand, Hyundai, ranks highest in the mass market segment. Mitsubishi ranks last, followed by a tie between Mini and Jeep. So just what does all of this mean for the average car buyer's wallet?

"New-vehicle prices are at an all-time high, partly as a result of an increased level of content," said Kristin Kolodge, J.D. Power's executive director of human machine interface, in a press release. "This is fine if owners are getting value for their money, but some features seem like a waste to many owners.

Car prices are indeed rising, and have been for years. In fact, the average price of a brand new car topped \$45,000 for the first time in history in September, according to a study by Kelley Blue Book. For comparison, this is up from around \$40,000 in December 2020-a 12.5 percent increase in just nine months. Granted, the semiconductor shortage isn't helping, but neither is all of the unused tech that lies dormant in many new vehicles.

Mental Health May **Impact Chances Of Breakthrough Covid: Study**

eople who are vaccinated against Covid-19, and have a history of certain psychiatric conditions. face an increased risk of break-

through disease, according to a study. The researchers from the University of California (UC) San Francisco, US, noted that the risk may be related to impaired immune response as well as risky behaviours associated with some disorders. The study, published in the journal JAMA Network Open on Thursday, found that patients over 65 with substance abuse, psychotic disorders, bipolar disorder, adjustment disorder and anxiety, faced increased risks of up to 24 per cent for breakthrough Covid.

For those under 65, risks were up to 11 per cent higher than for those without a

However, the risk was 24 per cent higher for over-65s with substance abuse, 23 per cent higher for those with psychotic disorders, 16 per cent higher for bipolar disorder, 14 per cent for adjustment disorder and 12 per cent for anxiety, they said. Given the greater incidence of breakthrough infections among younger people, the study showed significantly smaller effects in the under-65s group. Risks were 10 per cent lower in participants with psychotic disorders compared to those without a psychiatric diagnosis, the researchers said. They attribute this decrease to possible

lower socialisation among younger peo-ple with psychotic disorders compared with older people who "may be less socially isolated because of their greater burden of ill health and contacts with caregivers.

psychiatric history, the researchers said. They tracked data from more than 2.5 lakh US Department of Veterans Affairs patients, who had completed their vaccine regimen and had at least one test for SARS-CoV-2.

Just over a half (51.4 per cent) of the pa-tients had received at least one psychiatric diagnosis within the last five years and 14.8 per cent developed breakthrough COVID, confirmed by a positive test.

"Our research suggests that increased breakthrough infections in people with psychiatric disorders cannot be entirely explained by socio-demographic factors or pre-existing conditions," said senior study author Aoife O'Donovan from UCSF. "It is possible that immunity following vaccination wanes more quickly or more strongly for people with psychiatric dis-orders and they could have less protec-tion to newer variants," O'Donovan said in a statement.

The average age of the 263,697 par-ticipants was 66 and 90.8 per cent were male.

Overall, those participants with psychiat-ric disorders had a 3 per cent increased risk for breakthrough Covid infections in 2021, when adjusted for both demographic factors and pre-existing conditions, compared with participants without a psychiatric history, the researchers said.

The higher incidence of breakthrough infection among older participants may be due to "decreased immunological response to vaccine that has been associated with some psychiatric disorders. which may be more substantial in older adults," said study first author Kristen Nishimi from UCSF.

It is also possible that older adults with psychiatric disorders "may require more frequent in-person care, which could increase their interactions with the health care system," she noted. Breakthrough risks for other non-psy-

chiatric conditions were also calculated and adjusted for factors like obesity and smoking status, as well as other underlying conditions.

The researchers found that patients with chronic kidney disease had an increased risk of 23 per cent, compared with 20 per cent for HIV, 19 per cent for cardiovascular disease, 18 per cent for COPD and 13 per cent for sleep apnea. This shows that certain psychiatric conditions, particularly in the 65-plus group, face risks that are on a par with other conditions, said O'Donovan.

'Mental health is important to consider in conjunction with other risk factors and some patients should be prioritised for boosters and other critical preventive efforts," she added.

From KO Archives Pervez Visit To **Begin With Prayers** India to fire new CBMs At Pak

ew Delhi - Pakistan President Pervez Musharraf will begin his two day India visit Saturday with prayers at dargah of Sufi saint Khwaja Moinudin Chisti at Ajmer before commencing extensive talks with Prime Minister Manmohan Singh on all outstanding issues, including Kashmir, on Sunday

Seeking to break fresh ground. Prime Minister Manmohan Singh is expected to place new confidence building measures to carry forward the peace process in his talks with Pakistan President, who visits India on his first visit after the failed 2001 Agra Summit

Singh, who will hold parleys with Musharraf after witnessing the last one-day Indo-Pak cricket match for over an hour in the morning, is likely to suggest opening of additional bus routes and ways to promote tourism in Kashmir to enable people-to-people contacts. A joint statement after the talks is not ruled out.

Official sources said that Musharraf, who will he accompanied by his wife Sebha and a 40-member delegation, has been conveyed Singh's suggestion that providing full security to the Srinagar-Muzaffarabad bus service-was the "joint responsibility" of the two countries and signals from that side have been "positive'

On the eve of Musharraf s visit, the Prime Minister told a Chief Ministers' conclave here that "it is the joint responsibility of the Governments of India and Pakistan." to provide full security to the bus passengers. The two countries should fight the scourge of terrorism in the region, he added.

FIGHTING TERROR TOGETHER: India and Pakistan can work together in fighting the sources of terrorism in the region making it clear it was their joint responsibility to ensure full security to the passengers of Srinagar-Muzaffarabad bus service. He said "I do believe that it is the joint responsibility of the

Governments of India and Pakistan, and of the local authorities on both sides of the line of control, to work together in providing full security cover to the bus service which is a service for peace and for promotion of reconciliation.

"I sincerely hope we can work together in protecting the lives of innocent people and in lighting the sources of terrorism in the region," Singh said.

Strike And Bad Sense

hat began as a campaign for the genuine rights of government employees in Jammu and Kashmir has fast taken on the overtones of extortion and blackmail, with the general public as the ultimate victim.

The ordinary tax-payer, who shells out hard-earned money as duty on every purchase, and funds the huge salary bill of the government, finds himself short-changed at both ends - the services of the so- called public servants were far from satisfactory to begin with, and now the public has been saddled with the additional burden of frequent strikes, the five-day lockdown beginning on Tuesday being the latest example. Had the striking employees been liable to bear a financial penalty for the workdays lost, they would have thought a hundred times before going on an extended shutdown, but assured as they are of their full salary at the end of the month, they find themselves at liberty to milk the already impoverished exchequer. It is time that the employees were unambiguously told that they have been playing the victim for far too long, and now with very little justification. Their pose as the injured party no longer carries conviction, as a bulk of their demands has been met to the extent allowed by the economics of the state. There salaries have swelled disproportionate to their performance in comparison to the private sector where even highflying executives burn out prematurely due to work stress. Government employees, on the other hand, have an extremely easy time of it, with minimal demands, and no monitoring of performance, not to speak of the uuper kee kamayee which they consider their birthright. Government employees are not aliens from outer space not to know the state of the government's coffers or the heavy dependence of Jammu and Kashmir on regular dozes of financial inputs from the center, so it does appear unreasonable of them to insist on disbursements which they know the state to be in no position to make. The fundamental mistake appears to have been made by the authorities who are said to have committed themselves last year to conceding certain demands within a particular timeframe. It is unrealistic to hold the government to its purported word when the latter appears to have miss-projected its accruals. The strikers have perversely ignored subsequent clarifications by the government which has made it more than clear that any movement forward on the release of arrears was subject to receipts from the center. In light of the stark realities, employees' unions appear to be motivated by concerns other than those doing with the immediate welfare of their members. A peculiar aspect of employees' agitations that merits notice is that they primarily revolve round pecuniary benefits, and never ever touch upon what has become the hallmark of officialdom in Kashmir – rampant corruption at all levels of the administration and the political leadership. Union bosses have never been heard stressing on virtues like punctuality, uprightness and other elements of a healthy, productive work culture, or exhorting their followers to take to the streets against political and administrative corruption. This could speak of a relationship where the employee leadership co-exists comfortably with widespread venality, or, in fact, owes its very positions to it. It is no secret that the chai-pani and bakhsheesh culture has a stranglehold over the state's officialdom at all levels, and files rarely move from one table to another without money changing hands. The union bosses have never been heard to denounce such practices or take steps to discourage them. It is unheard of in any government office for unions to have ostracized or censured corrupt elements, or inculcated a sense of duty among their members. The noise the unions have been making for months over patently selfish reasons has begun to grate in the ear, and alienate the public from what are increasingly seen as selfserving motives.

n the fourth decade of the last century, Alexis Carrel, a French Surgeon, Nobel laureate and Sociologist bemoaned the lack of integrated and comprehensive "science of man". Carrel went on to write an entire treatise "Man The Unknown" to circumscribe the lacunae, flaws and misgivings arising out of the unprecedented progress in Positive (Material) sciences and the lag experienced by Normative (Social) sciences. Carrel had truly predicted that galloping progress in science and technology, with little or no attention to social sciences endangered the entire society and posed challenges like social chaos, hyper-consumerism, unchecked capitalism, large scale poverty, crimes and social and international paranoid.

The predictions have turned true and an asynchronous relationship between material and social sciences has thwarted our society and world against the issues and conundrums of all breeds. Our society, based on and driven by the principles of Capitalist economy as it is, has asymmetrically favoured sciences that result in increase of capital and material productivity and ignoring social sciences to the point of neglect.

What picture does emerge in our minds as we try to think of social sciences? It is usually an image dominated by the graphics of armchair scholar, skimming through abstract ideas and given to theories least pertinent to human lives. These images of a sociologist, which remove him farther away from the orbits real social business and project him into some abstract space are both inadequate and incorrect. If atoms are the constituents of matter, individuals are the constituents of society and call for Sociological investigation and understanding as much as atoms call for scientific understanding.

Society is neither the domain of biology nor physics, but rests on principles that are called Sociological principles and by their nature call for Sociological understanding. It is society and men living therein which form the raison de etre of sciences, of all technological adventures and all other activities implied by the term "Positive Sciences". In any case of Social disequilibrium, any episode of social disaster or any accident of social import, the material prog-



tity, individuality, lack of meaning and such are conspicuous, the role and responsibility of Social Sciences is augmented multi-fold. Having said that, the importance of Social Sciences is so obvious that our policy makers, administrators, educationists and governments should have been proactive about the same.

But the dismal state of social sciences is a cause of concern not only from an academic point but social point of view too. As we entrust our material well being to scientists and technocrats, so is it obligatory to make Sociologists and Social scientists the trustees of our social health, lest we discover our society in the throes of anarchy and disorder.

The responsibility of tilting the academic bob towards social sciences is something incumbent upon all the stakeholders – public as well as governments. In a society like ours, festering as it is with social diseases of all sorts, the urgency to take social sciences seriously gathers more importance and indispensability. Having witnessed widespread wars and violence, systemic exclusion of people, humanitarian issues of humongous order, the task can't be delaved.

Can Indian Start-Ups Beat The Funding Slowdown In 2022?

Indian start-ups had a phenomenal year in 2021. Venture capitalists (VC) invested a record high of \$38.5 billion in Indian start-ups, with the country minting 44 unicorns in 2021. The start-ups have got a headstart in 2022, mopping up about \$10 billion during the first quarter (January-March), up from \$5.7 billion in the same period in 2021, as per data collated by Venture Intelligence.

But there are some grim concerns about whether our start-ups can sustain this investment tempo. Global headwinds like a hike in interest rates by the US, geopolitical tensions arising from the escalating Russia-Ukraine conflict, crude oil prices going uphill, and battering of tech stocks have induced caution among investors.

Globally, the macroeconomic headwinds have slowed the pace of deal-making in the start-up ecosystem. This phenomenon has a ripple effect on Indian start-ups, too. According to a Bain and Company report released in collaboration with Indian Venture and Alternate Capital Association (IVCA), the Indian start-up ecosystem is likely to witness a shift in the pace and quality of VC deals in 2022.

Indian start-ups are gradually feeling the heat of a subdued investment climate. SoftBank founder Masayoshi Son has reportedly advised his executives to go slow on investing in tech start-ups. The news doesn't bode well for the incumbent and aspiring Indian tech unicorns. SoftBank has invested in many successful unicorns like Oyo Rooms and Paytm. Some of the notable tech stocks have seen

an erosion in stock valuations post their euphoric listing on the stock markets. Companies like Zomato, Nykaa, CarTrade, Policybazaar and others have witnessed a 40-60 per cent slump in their stock prices. Paytm, India's biggest IPO, has seen its stock nosedive by over 70 per cent since listing.

The lacklustre stock performance of tech unicorns has spurred Delhivery (logistics start-up) and Oyo to delay their listing plans. Ride-hailing major Ola has kept its IPO plans in abeyance due to the bearish sentiment for tech stocks and is considering a fresh round of funding.

The funding winter means Indian tech start-ups will come under the lens of investors for their business practices, governance and growth trajectory. Still, I feel the Indian start-up story is one of buoyancy and resilience and can beat the funding blues. Ours is a robust start-up ecosystem with more than 57,000 start-ups launching operations and creating value worth \$450 billion. An interesting catch is in the route tapped by the start-ups to raise funds. They have raised \$112 billion between 2014 and 2021, but fundraising is largely concentrated in VC and angel funding space.

When funding by VCs and private equity (PE) players is getting mired in uncertainty, it's time for the start-ups to leverage the other funding channels. Family offices or private wealth management advisory firms have emerged as a viable

option. Backed by industry titans like Narayana Murthy, Ratan Tata and Azim Premji, they are investing in the start-up growth story. Murthy's Catamaran Ventures has invested in start-ups such as Paper Boat and Udemy. Ratan Tata's RTN Associates has made investments in ventures such as Car Dekho. Ola and Snapdeal. PremjiInvest's portfolio includes brands such as Flipkart, Snapdeal and Lenskart. According to a report by 256 Network and Praxis Global Alliance India, family offices have invested over \$5 billion in Indian start-ups in the past few years. By 2025, it is estimated that family offices in India will account for 30 per cent of the total \$100 billion in start-up funding. That's a considerable funding potential waiting to be tapped. The other option is in Ultra High Networth Individuals (HNIs), who are likely to invest up to \$30 billion in tech start-ups in India by 2025, says the same report.

Indian start-up companies in the e-commerce, Fintech, and Edtech sectors can beat the funding slowdown with their disruptive nature, scalable business potential and problem-solving capacity. By shifting gears to strong financial metrics and defining a clear path to profitability, the tech start-ups can survive the funding winter and emerge stronger.

Book Review

Family's Pillar, Humanity's Maker: Reading Maulana Wahiduddin Khan's *Aurat: Maemaar-e-Insanniyat*

The book highlights the dignified status of women in Islam, exhibits the positive role women have played (and have to play) in the society and in building humanity, and criticises women liberation/ gender equality on rational grounds

n the present times, 'Women in Islam' is one of one of the fiercely debated issues. Like other scholars across _the globe, Muslim scholars of India have also contributed, and are contributing, to this discourse (for more details, see my column, "Defying 'Misconceptions' and Defining 'Real Status' of Women in Islam", Kashmir Observer, 24th September 2021). Maulana Wahiddudin Khan (d. 2021)—an Indian Muslim (spiritual) scholar, a Qur'an commentator, an ardent advocate of peace, interfaith dialogue, social harmony, and gender justice, and author of over 200 books on Islam and its diverse aspects-is a significant contributor to this discourse. His significant works on this theme are: Women between Islam and Western Society (1995; republished in 2014 and available in Arabic and Urdu versions as well); Woman in Islamic Shari'ah (2020; originally published in 1995); and Aurat: Maemaar-e-Insaniyat/ Woman: The Builder of Humankind (2018; originally published in 2004). Here I intend to present a summary of the main contents and themes discussed in 2018 edition of his last mentioned book.

First published in 2004 and republished in 2018, Woman: The Builder of Humankind attempts to highlight the positive role played by women in the society through historical instances, rational analysis as well as by presenting the accounts of some ideal models and historically prominent women figures as well as in the light of his experiences. The book consists of fourteen (14) chapters, excluding a brief Conclu-sion, and spans over 208 pages, it also highlights some theoretical discussions on women issues, both past and present.

In its opening two chapters, the book highlights the "System of Nature"/ Fitrat ka Nizam (pp. 7-12) and the 'Principle of Pairs"/ Zawjain ka Usul (pp. 13-18), respectively, arguing that the "basic principle for the advancement of life is that being compatible with nature is success tion to natural system results in failure" (p. 7). He also states that "in the modern times, the advocates of women's liberation movement have preached the

principle of gender equality, which is totally an unnatural principle, as it has resulted in creating anarchy in the family system" (p. 9). He, thus, rejects the term "gender equality" (pp. 9, 13) which holds "men and women to be equals" (p. 13) and labels it with the term "Gender Complementality", which he defines as "men and women as part of one another" or "to be lifelong partners of each other", but not the "equals" (p. 14).

The next two chapters (3 and 4) discuss the women's position and place, respect and regard, in the light of the Qur'anic verses (pp. 19-53) addressed to her directly and thus "brings to the fore the real picture a woman has in the Islamic system of life" (pp. 19, 20), and selected Ahadith (pp. 54-70), which "reveal what place and position woman possesses in the human society" (p. 54). This is followed by a chapter on Guiding Principles of the Marital Life" (5th chapter, pp. 71-89) gleaned from the Qur'anic principle (as mentioned in Q. 90: 4: "We have created man for toil and trial")-a natural principle which, in Khan's understanding, applies to men and women equally

In the 6th chapter, Khan focuses on "Test Design"/ Nagsha-e-Imtihan (pp. 90-93) in the light of the principle that "this worldly life is a temporary phase and thus a testing place for humans and its results are to be borne by each in the Hereafter according to one's deeds and performance done in this life" (pp. 90-91).

The next two chapters (7 and 8) describe the life, upbringing and intellectual contribution of "Aishah Siddiqua" (pp. 94-115), especially her contribution in hadith narration in the light of authentic narrations from the Hadith collections and other Islamic sources and in the next chapter the "Issue of Age at the time of her Marriage" (pp. 116-125) is discussed and he provides rational explanation and justification for her marriage at an early age. Based on the Qur'anic verses like Q. 3: 195 and 9: 71 and mostly on the discussions and evidences garnered from 8th chapter, Khan discusses "Woman as an intellectual Partner" in the 11th chapter (pp. 159-170), wherein he argues that husband and wife are not just companions, but are actually "intellectual partners" and a woman, who is generally expected to be an expert in the "domestic science or professional education", must learn and be an expert in the "art of intellectual partnership" as well through the smooth "intellectual exchange" between them (pp. 160-68).

In chapters 9, 10 and 13, "Some Exemplary (Muslim) Women" (pp. 126-46), "Character of (Muslim) Women" (pp. 147-58), and "Examples of some (Historically Famed) Women" (pp. 179-196), respectively, Khan presents an account of some prominent Muslim women of Islamic history-before, during and after the Last Prophet's time, and from his (own) family: in 9th chapter he presents an account of Hajrah, the wife of Prophet Ibrahim (AS); Asiya Binte Mazahim, wife of the Egyptian Pharaoh; Maryam, the mother of

Prophet Isa (AS); and Khadijah bint Khuwaylid and Umm Salmah (RA), the wives of the Prophet. He argues that "all these women are ideals and role models for the whole humanity from different perspectives as all of them have passed through different situations and have faced different circumstances" (pp. 126, 146).

In 10th chapter, he refers to such promint historical figures, like Umm ad-Dartive role in different arenas. In 13th chapter, he first refers to the examples of women of his own family, including his mother (Zaibun Nisa), for her role in his "character building" (p. 19); his wife (Sabia Khatun) for "showing enduring patience" during his ups and downs (p. 185); and his daughter (Farida Khanam-who served as professor of Islamic Studies in Jamia Milia Islamia New Delhi) for her "un selfish services", "dedication", for being his "intellectual assistant" and much more (pp. 188-92). In the second part of this

chapter he provides a brief profile of some women from India, Pakistan, Bangladesh and Dubai who are actively contributing through their missionary activities in their countries and the author has well acquain-

tance with them (p. 193). The major objective of this chapter is to reveal that "what the author [Khan] believes and expounds on the topic of women in Islam is a matter of actual fact and he has experienced it himself as well" (p. 179).

The remaining two chapters (11 and 14) throw light on two significant themes, Woman—The Builder of Humanity" (pp. 171-78)—which is the title of this book as well-and "Women in Contemporary Times" (pp. 197-204), respectively: in the former, he discusses (in the context of Q. 2: 158) the significance of the rite of sa'i (the act of running back and forth seven times between Safa and Marwah during the Pilgrimage). 'What was the significance of this act by Hajar? He raises the questions and answers it as: "The significance of this act lies in the fact that it was an act of sacrificing one's life for the sake of nurturing a new generation" (p. 172). He further remarks that it was aimed "to bring into being a live community which, free of all superstitions and all other corruptions of civilization, would play a revolutionary role led by the last Prophet [pbuh]. ... Through this Abrahamic plan it was thus demonstrated that what role a woman plays in human history-the role of preparing and guiding the future generations" (Ibid.). From this historical, but revolutionary

should not confine her naturally bestowed feminine qualities to her offspring (sons and daughters) but the whole humanity should benefit from them. Thus, God has created a woman as the builder of humanity and it would be her under-use if role is restricted for her offspring only" (p. 177).

In the last chapter, "Women in Contemporary Times" (pp. 197-204), Khan starts with the quote, "There is a woman at the beginning of all great things", and maintains that "the greatest example in human history for its proof is of Hajra, wife of Prophet Ibrahim [AS]; her marvellous sacrifice gave rise to a new era in the human history. It was a revolutionary act whose imprints were felt by the whole world" (p. 197). Her extraordinary sacrifice was aimed "to bring into being a new generation that would be free from all kinds of polytheistic thoughts and concepts" and the fruits of this sacrifice were attained by the humanity till the modern times, "but from last two centuries, humanity is again surrounded by a maelstrom—i.e., the wave and whirl of materialism. While in the previous era humanity was facing the evil of idolatry, but in the present times world is affected by the curse of materialism, which has resulted in humanity's destruction and most affected aspect of this destruction is (seen in) the collapse of value system" (pp. 198-99). Therefore, he suggests that "present situation demands woman like Hajar who will change the course of history by their extraordinary sacrifices, and will turn the materialistic world into the world of monotheism" (p. 199).

He further asserts that the slogans of gender equality by the women's liberation movements have added to the miseries of social life and both men and women have neglected their original role of being "each other's lifetime companions" as well as the principle of "division of labor", which has "never been intended as a form of discriminatory treatment, but its main purpose has always been to preserve the distinctive characteristics of both sexes". Therefore, what is actually required is "division of labor, not gender equality", and it is on the basis of this principle that "a balanced system comes into existence" (p. 204). The book ends with a "Summary" (pp. 205-208) and puts forth many arguments in the light of previous discussions, which are related to the past, present and future of women and their role in the society

Keeping in view the contents and topics addressed and discussed, Woman: The Builder of Humankind highlights the exalted status of women in Islam, discusses and demonstrates the positive role women have played in the society and in building humanity-both at social and intellectual levels—as well as reflects on the role she has to play in the present times.

s someone who teaches Russian literature, I can't help but process the world through the country's novels, stories, poems and plays, even at a time when Russian cultural productions are being canceled around the world.

THE IMPORTANCE OF ACTION

If Dostoevsky would insist that one not look away, it is fair to say that Tolstoy would contend that people must act upon what they see.

During the Russian famine of 1891 to 1892, he started soup kitchens to help his countrymen who were starving and had been abandoned by the Russian government. He worked to help Russian soldiers evade the draft in the Russian empire, visiting and supporting jailed soldiers who did not wish to fight. In 1899 he sold

Doukhobors, emigrate to Canada so they would not need to fight in the Russian army.

These writers have little to do with the current war. They cannot expunge or mitigate the actions of the Russian army in Ukraine. But they're embedded on some level within the Russian cultural fabric. and how their books are still read matters. Not because Russian literature can explain any of what is happening, because it cannot. But because, as Ukrainian writer Serhiy Zhadan wrote in March 2022, Russia's war in Ukraine marked a defeat for Russia's great humanist tradition.

As this culture copes with a Russian army that has indiscriminately bombed and massacred Ukrainians, Russia's great authors can and should be read critically. with one urgent question in mind: how to stop the violence. Russian opposition leader Alexey Navalny noted during his March 2022 trial that Tolstoy urged his countrymen to fight both despotism and war because one enables the other.

And Ukrainian artist Alevtina Kakhidze cited "War and Peace" in a February 2022 entry in her graphic diary.

"I've read your f—ing literature," she wrote. "But looks like Putin did not, and you have forgotten."

RAM NAVAMI VIOLENCE Bulldozers Brought In To Remove 'Illegal Encroachments' In **Gujarat's Khambhat**

AHMEDABAD: Days after communal violence rocked Khambhat town of Gujarat's Anand district, the administration on Friday brought in bulldozers to remove illegal encroachments along a road in Shakarpura area of the town where a Ram Navami procession came under attack on April 10.

Apart from the illegal encroachments, including wooden cabins and some concrete structures, the administration was also clearing bushes from the land in Shakarpura, as miscreants had used these to hide after throwing stones at the procession, Anand District Collector MY Daxini said.

"Miscreants had used the bushes and thick vegetation to attack the procession. Hence, we have launched a drive from today to clear bushes and illegal structures built on government land alongside a road in Shakarpura. This drive will continue in the coming days till the entire area is cleared," Daxini said.

On March 10, clashes erupted between two communities in Khambhat after stones were pelted on a Ram Navami procession in Shakarpura.

Anand district superintendent of police Ajit Rajian had earlier said that communal violence in Khambhat town was a "pre-planned conspiracy" hatched by a sleeper module to achieve the dominance of the Muslim community in the town.

The police have already arrested 11 persons involved in the entire conspiracy.

The perpetrators had planned to attack the procession and spread violence to teach the members of Hindu community a lesson to not take out any such procession in the future, the police said.

As planned, some of the accused, including Maulvi Ayyub Malek and Vasim Malek, intentionally started arguments with organisers of the procession over the issue of music and asked them to turn it off when the procession reached Shakarpura.

Police said the mob torched the house in the city's Runakta locality, where Sajid, a gym owner, stayed. An adjoining house belonging to the family was also set on fire.

The mob was demanding his arrest for 'kidnapping' the woman, who police said is 22 years old but still in school. Shops in the local Runakta market also downed shutters, with traders making the same demand.

There were no reports of any injuries in the attack on the gym owner's home.

The woman, who is a class 11 student, went missing on Monday. She was traced two days later by police, but Sajid's whereabouts were not known. Her family members had lodged a missing person's report, prompting a police search. Apparently on the basis of their complaint, a case was also registered under section 366 of the Indian Penal Code.

The section relates to kidnapping of a woman with the intention of compelling or seducing her into sex or marriage.

But in a video that surfaced on social media, the woman said she is an adult and had gone willingly with the man, according to police.

Both are adults, Agra's Senior Superintendent of Police Sudheer Kumar Singh told reporters.

He said police will produce the woman in court. They couldn't do that so far because of the court holidays.

PRO CRPF Kashmir, Junaid Khan told Kashmir Observer that akin to routine years, this year too, there will be no change in the arrangements made for peaceful conduct of Yatra.

"The foolproof security that had been arranged in the past several years including ROP's for safe passage of convoys won't change this year. In fact, the camps that are put intact on the trekking route from Chandanwari & Baltal [to the holy cave] will also remain the same," Khan said.

However, the CRPF spokesperson said that this year the number of arriving pilgrims has doubled and it subsequently poses a challenge but that won't hamper the security arrangements.

He said that the only change the forces may have to do will be to increase the size of camps for pilgrims besides that no other changes in the arrangements are required.

"As of now, we don't have an exact figure of armed deployment for Yatra as the forces are still being inducted. But as per MHA, we're supposed to arrange 40,000 joint security personnel from CRPF, ITBP, BSF and SSB. Some of these battalions are already conducting their routine activities in the valley and some are still in the process of deployment from other parts," Khan said.

Besides, he said, there will be some additional deployment in the Pahalgam axis and an additional deployment in the Baltal-Srinagar axis depending on the requisition sent by the local police to MHA on the number of personnel required for Yatra related deployment.

'The process of inducting extra battalions from other parts is currently going on. The additional deployment has been called in as many axis require an increased manpower. The Khanbal-Chandanwari axis require an additional deployment for road protection and camp establishment. Similarly, the Srinagar-Ganderbal-Baltal axis also needs extra manpower," the CRPF

I cannot say openly what they (Indian soldiers) did and what decisions we (the government) took. But can definitely say that a message has gone (to China) that India will not spare anyone, if India is harmed. (Bharat ko agar koi chherega to Bharat chhorega nahi, he said.

The Ladakh border standoff between the Indian and Chinese militaries erupted on May 5, 2020, following a violent clash in the Pangong lake areas. The face-off escalated after the Galwan Valley clashes on June 15, 2020. As many as 20 Indian soldiers and an unspecified number of Chinese troops were killed in the clashes.

India and China have held 15 rounds of military talks so far to resolve the eastern Ladakh standoff. As a result of the talks, the two sides completed the disengagement process last year in the north and south banks of the Pangong lake and in the Gogra area.

Without making any direct reference to the American pressure with respect to Russia because of the Ukraine war, Singh said India does not believe in a zero-sum game diplomacy.

If India has a good relationship with one country, it does not mean that its relationship with any other country will deteriorate, he said. India has never adopted this kind of diplomacy. India will never opt for this (kind of diplomacy). We don't believe in the zero-sum game in international relationships, he said.

India, he said, believes in having a bilateral relationship which is based on win-win for both the countries.

His remarks came amidst some disquiet in Washington over India's position on the Ukraine crisis as well as its decision to procure discounted Russian oil.

The image of India has changed. The prestige of India has improved. In the next few years, no power in the world can stop India from becoming the world's top three economies, Singh said.

In his address to the Indian community, Singh said that in the past, if any country in the world wanted to develop and prosper, they always thought

"There have been several prime ministers in India who became the leader of the country after they occupied this post. But like Pt Jawahar Lal Nehru, the first prime minister of India, Atal Bihari Vajpayee and Narendra Modi were the country's leaders even before they became the prime minister," he said.

Today we have a new and confident Bharat, he said, adding that India is now headed towards becoming a selfreliant country and the Modi government is taking several important steps in this regard, including in the defence sector, he said.

India has taken several key steps towards indigenisation of its defence sector, he said as he briefly described some of such decisions being taken by the government.

Observing that India has a lot of faith and confidence in the country's IT sector, the defence minister said that Indian talents are playing a major role in the world's IT sector and the Modi government has taken steps towards massive digitisation.

India today, he said, is marching ahead to become an economic power and the government is not only working towards the welfare and prosperity of its people, but also helping people in other parts of the world as well.

India is now among the world's fastest growing economies. Our economy did suffer a setback due to the pandemic. But now we are having a fast recovery, he said.

LONDON: Joe Root stepped down as England's Test cricket captain on Friday, ending his five-year spell in a role that became increasingly challenging because of the team's long run of series defeats -- including 4-0 in the Ashes over the winter.

"I have loved leading my coun-try," Root said, "but recently it's hit home how much of a toll it has taken on me and the impact it has had on me away from the game." Root leaves his post holding the record for the number of wins

as England Test captain -- at 27 -- while his status as one of the world's leading batters is secure after scoring eight centuries since the turn of 2021. However, his captaincy has

come under scrutiny with England having only won just one of its last 17 Test matches -- the country's worst run since the 1980s.

Losing heavily in Australia, England's biggest rival, was followed last month with a 1-0 series defeat to the West Indies. That made it four series defeats in a row -- and it could be five unless England can beat India in July in the remaining test left over from their unfinished series from last year.
