

Railway Cop Killed, ASI Injured **By Militants**

SRINAGAR: Unidentified militants on Monday shot dead a Railway Protection Force (RPF) personnel and injured another in an audacious attack in south Kashmir's Pulwama district.

Around 6:00pm Monday, unknown militants opened gunfire upon two RPF personnel Assistant Sub-Inspector (ASI) Devraj Kumar and Head Constable Surinder Kumar outside the Kakpora railway station in the south Kashmir district, officials said.

In the surprise militant attack, both the RPF personnel sustained grievous injuries. They were removed to the nearby hospital for treatment. However, the Head Constable Surinder Kumar succumbed to



J&K's Debt Pile Grows To Rs 83,536 Crore: CAG

SRINAGAR: The Comptroller and Auditor General of India (CAG) has pulled up Jammu and Kashmir government for its debt situation, stating that the union territory's overall debt has gone up to Rs 83,536 crore by October 2019.

The CAG expressed concern over J-K government's action of using borrowed funds for meeting current consumption and repayment of interest on outstanding loans. "Using borrowed funds for

meeting current consumption and repayment of interest on outstanding loans is not sustainable," it said, stressing that borrowed funds should ideally

Pak Militants With Aadhaar Cards Worry Security Agencies

Srinagar: With militants groups misusing Aadhaar card to camouflage the identity of their Pakistani cadres, the Jammu and Kashmir Police will request the Unique Identification Authority of India (UIDAI) to strengthen safety features of the biometric ID, officials have said.

The police force will also pitch for devising a mechanism for getting real-time information on an Aadhaar card being

misused by militants.

The misuse of the biometric ID came to light following the recent killing of two Pakistani militants in Bishembhar Nagar, adjacent to the Dal Lake, in Srinagar.

The militants, who had been involved in the killing of CRPF jawans earlier this month, were identified as Mohammed Bhai alias Abu Qasim, who had been active in Kashmir Valley since 2019, and Abu Arsalan alias Khalid, who was present since 2021.

I&FC Dept Gears Up To Meet Possible Flood Threat

SRINAGAR: The irrigation and flood control (I&FC) department has issued flood duty chart to its staff, besides acquiring over one lakh sand bags to plug weak spots along Jhelum river and its tributaries to prevent any imminent threat of floods in the

Kashmir Valley. Despite no looming threat of flood situation, the I&FC department has carried out a safety audit of Jhelum embankments and identified the weak spots, the officials said. The audit, they said, was conducted last month as part of the department's advanced planning in meeting any possible flood situation.

Executive Engineer I&FCD. Srinagar Ajaz Ahmad Keen told Kashmir Observer that they will keep over one lakh sand bags ready at different weak spots to block the flood threat if any.

"We have started the tendering process for the sand bags and it will be completed within days," he said.

He further added that the department has issued the flood duty chart for the employees and they will be deployed to the specific areas.

"In this regard we had a meeting with Divisional Commissioner Kashmir and his orders will be implemented within the coming days," he added.

Electric Shocks Killed 113 PDD **Workers In 12 Years**

SRINAGAR: Over 110 regularized as well as temporary employees of Power Development Department (PDD) have lost their lives due to electrocution in the past more than one decade in Kashmir, figures reveal.

According to the figures available with the news agency-Kashmir News Observer (KNO), a total of 113 regularized as well as casual laborers, daily wagers and need-based workers have died due to electrocution while performing their duties in Kashmir.

These deaths due to electrocution have occurred since 2010 to April 18, 2022.



Novel Antiviral Coating Inactivates Covid Variants Even In Dark

cientists in Japan have developed a new antiviral coating that inactivates various types of coronavirus variants under both indoor light and dark-

The coating developed by researchers at Nara Medical University, Kanagawa Institute of Industrial Science and Technology, and Tokyo Institute of Technology is made using a combination of titanium dioxide (TiO2) and copper oxide (CuxO) compounds.

They noted that the main transmission pathway of the SARS-CoV-2 virus is through droplets released by infected people into the air, adding these droplets exist on various surfaces as well.

Viral infections mainly occur in indoor environments where many people gather, the researchers said.

Antiviral chemicals, such as alcohol and hydrogen peroxide, are often used to decontaminate regularly touched surfaces, they

These chemicals essentially render the virus inactive by breaking down its proteins. However, they are volatile in nature, and therefore evaporate away.

As a result, the disinfection process has to be carried out regularly.

The study, published in the journal Scientific Reports, described a solid-state photocatalyst as an alternative defence against the virus. Unlike chemical disinfectants, solid-state

coatings remain for a long time, and have the advantage of being non-toxic, abundant, and chemically and thermally stable, the researchers said. Many of these solid-state coatings use TiO2

photocatalysts, that when exposed to ultraviolet (UV) light, cause oxidation reaction that can destroy organic matter like the spike protein that helps the coronavirus to enter and infect human cells.

However, these coatings are activated only when exposed to UV light, which is not present in typical indoor environments.

To get the coating to work under visible light as well dark conditions, the team developed a composite consisting of TiO2 and CuxO nanoclusters.

CuxO nanoclusters are composed of a mixed oxide, in which Cu(I) and Cu(II) species are present.


The Cu(II) species in CuxO contributes to the visible-light-driven photocatalysis reaction, whereas the Cu(I) species plays a crucial role in denaturing virus proteins, thereby causing their inactivation under dark conditions.

By coating the CuxO/TiO2 powder on a glass, the researchers showed that it could inactivate even the highly virulent Delta variant of SARS-CoV-2.

They also confirmed the inactivation of Alpha. Beta, and Gamma variants by CuxO/ TiO2 in addition to the wild type strain.

The team's analysis strongly suggests that the Cu(I) species in CuxO denaturalises spike proteins and also causes RNA fragmentation of SARS-CoV-2, even under dark

NEW DELHI - Prime Minister Manmohan Singh today said that it is the joint responsibility of India and Pakistan as also the local authorities on both sides of the Line of Control (LoC) to ensure full security cover to passengers of the Srinagar-Muzaffarabad bus service.

"Notwithstanding the recent dastardly attempt to disturb the bus service between Srinagar and Muzaffarabad by terrorists, the people of Jammu and Kashmir came out on the streets as one to welcome this gesture of reconciliation." he said addressing the Chief Ministers' Conference on Internal Security here.

"I hope the terrorists and extremists in the region have grasped the mood of the people and will not try to disturb this bus service again." he said

Singh said it was the joint responsibility of the governments of India and Pakistan and the local authorities on both sides of the LoC to work together in providing full security to passengers.

Two Months Of War

he Russian invasion of Ukraine is almost two months old and it is showing signs of getting worse by the day. In one of the biggest blows to Russia last week, the country lost its flagship warship Moskva in a missile attack by Ukrainian forces. Moskva had the capacity to carry 16 long-range cruise missiles, reducing Russia's firepower. In response, Russia has intensified its attacks on Ukraine, particularly its capital Kyiv. It has claimed to have "liberated" Ilyich steel and iron plant in Mariupol, Ukraine's second-largest steel maker. Russia's effort so far has been to take over the key port city of Mariupol in the east of Ukraine.

The CIA has warned of Russia resorting to using tactical or low-yield nuclear weapons in Ukraine in view of the military setbacks faced by the country. Meanwhile, European countries are trying to replace Russian energy with imports of gas from other countries, particularly those in the Gulf like Saudi Arabia, Qatar and the UAE. Russian President Vladimir Putin has warned that he will redirect his energy supplies eastwards if European countries stop buying its oil and gas.

The past two months have witnessed a complete break-up in the relationship between the West and Russia. The west which until before the war had differences about how to tackle the then brewing Ukraine crisis has united against Russia. NATO has put its all might behind Ukraine which, as a result, has so far been able to slow down the Russian assault, if not stall it.

The coming few weeks would be crucial. It needs to be seen whether Russia makes more advances or suffers reverses from the territory it has captured so far and this would determine how each side would calibrate its response. Though Ukrainian president Volodymyr Zelensky has repeatedly called for talks with Russia, the latter is in no mood for such a meeting. West has also been cautious not to join the war directly, so as not to expand the conflict which could culminate in a nuclear exchange, a frightening scenario that could bring about doomsday for the world. This makes it urgent for the world powers to climb down from their hubris and work together to find a way out of the ongoing war. But going by the tough postures adopted both by the US and Russia, such an outcome looks unlikely in near future. And considering both sides see an existential crisis in the defeat, the war is likely to drag on.

Take two: On dual degree programme

he UGC has done well to mandate that open/distance learning and online mode courses should be pursued only in higher education institutions recognised by statutory bodies. This would also eliminate dubious players in the online education segment.

Granting students the liberty to enhance their skills and scope of employability through an additional degree is welcome. But the guidelines call for critical evaluation given the nature of competition, accessibility and academic-cum-physical infrastructure issues in colleges and universities. The UGC has said a student can also pursue two full-time programmes in physical mode. This is problematic as it might prompt students, who are academically proficient or with the economic wherewithal, to corner seats in two in-demand courses. Such a situation is best avoided in the context of the country's poor college density — colleges per lakh population (in the 18-23 age group). In the All India Survey on Higher Education Report 2019-20, the national average college density stands at 30. The UGC's Furqan Qamar Committee, which a decade ago recommended dual programmes with a second degree in open/distance mode, had ruled out offering simultaneous degree courses under regular mode "as it may create logistic, administrative and academic problems". Against this backdrop, the UGC may reconsider its guidelines for the physical mode option, while implementing the other two choices, strengthening and streamlining the open/distance learning courses in parallel. Alternatively, it may look at its 2004 document for initiation of double/multiple degree programme in engineering disciplines, where it had proposed a "gap" before an engineering degree holder could enrol for an additional or add-on degree course. That approach is pragmatic as it also sought to reduce the duration of the add-on degree by eliminating about 33% to 38% (52 to 60 course credits) of the "common curriculum" of the BE/B.Tech course (a total of 160 credits). This logic could be applied to allied courses in arts and science and reduce the duration of the second degree for students who desire pursuing dual programmes in physical mode. The more practical a policy, the better its results.

Emperor's New Clothes

Public Information Officers or Post Offices?

sum of Rs 1.05 crores made the news recently when it was revealed that the sum was collected by the Government in Srinagar from fines imposed for flouting Covid norms

In the midst of the emergency created by Covid-19, this uncanny penalty exercise was carried out by cops in Kashmir. It was observed that cops on duty were imposing fines but were handing out Red Cross receipts in return.

The details of this exercise came to fore when this author filed an RTI last month. However, the effort has only yielded incomplete results on account of a lackadaisical postponement from the end of the authorities

The RTI was forwarded from the Divisional Commissioner Kashmir's office to all DC offices. However, barring DC office Srinagar, no other office has divulged data on the matter.

In Pulwama, the RTI application couldn't find home as it was forwarded to all the Tehsildars of Pulwama district by invoking section 6 (3) of RTI Act 2005. The Additional DC (ADC) who is also PIO under RTI Act 2005 had forwarded the application according to a letter correspondence to the applicant.

While this process seems to be all in form related to norms, it is hardly so. The PIOs, in this case, the Additional DC had acted as a "post office" without following duties in spirit. The comment is hardly random and is infact from Delhi High Court's statement in the Rakesh Kumar Gupta vs Central Information Commission case (2021) in which it said that Public Information Officers (PIOs) cannot "function merely as post

The court observed that Central/state PIOs cannot withhold information without a reasonable cause and evade disclosure of information. The order reads:

"Every effort should be made to locate information, and the fear of disciplinary action would work as a deterrent against the suppression of information for vested interests," the HC said while stressing the PIOs "cannot function merely as post offices", but ensure information is provided to the applicant"

The PIO has to "apply his/her mind, analyse the material" and then direct disclosure or give reasons for non-disclosure of information, the

While the case in point is recent, the misuse of Section 6 (3) is not new.

Last year, in November, an application under RTI Act 2005 in Raj Bhavan filed by this author also faced a similar ordeal. The designated public information officer (PIO) in Raj Bhavan under section 6 (3) forwarded my RTI application to the Civil Secretariat Tribal Affairs Department. The officer was under the notion that the Tribal Affairs Department was the nodal agency for implementation of FRA in J&K, which isn't

Then, the PIO in Tribal Affairs Department Civil Secretariat, on 2.12.2021 forwarded the RTI application to all Deputy Commissioners and Divisional Forest Officers (DFOs) and asked them to provide the information about individual and community forest rights claims decided in their respective areas. Only the Deputy Commissioner Office Kishtwar and some DFOs provided the information satisfactorily.

The PIOs in DC offices Udhampur and Ganderbal further forwarded my RTI applications to their Tehsildars by invoking section 6 (3) of RTI Act 2005. Ironically, Tehsildars have nothing to do with the Forest Rights Act.

One wonders at the reason behind the PIO's decision to send the said RTI application to the Tehsildar's in the case of Ganderbal and Udham-

The consequential inference points at the possibility of evading the responsibility to provide information and the subsequent unavailability and lack of transparency related to FRA information.

Invoking Section 6 (3) Loophole


In spirit, Section 6 (3) of the RTI act has a noble intention, in keeping with the RTI Act 2005 which allows every citizen of India an access to information from public authorities

Section 6 allows a citizen "to obtain any information under this Act" by requesting in writing or through electronic means accompanied by such fees as may be prescribed.

Subsection 3 of Section 6 shares the same intention and for the sake of saving the applicant's effort and time it holds that if the information

sought from a public authority is with another department, then, the Central/state public information officer (CPIO/PIO) must transfer the application to the authority possessing the required information within five days of receiving

it and inform the applicant accordingly.

However, this 'loophole' in the Act is being increasingly used by government departments to deny information to RTI applicants by passing the buck. Even if the PIO possesses the information, the application is forwarded to other public authorities mostly subordinate to the officer.

Need Responsible and Responsive RTI PIOs

The expectations of professionally satisfactory dispersal of duties isn't too much to ask for. Infact, Section 5(3) and (4) of RTI Act 2005 make it mandatory for a PIO to deal with requests of citizens seeking information and render reasonable assistance to them while taking the assistance of any other officer, if considered necessary by him or her, for the proper discharge of duties.

PIOs have to render "all reasonable assistance" where requests for information cannot be made in writing to the applicant making the request orally to reduce the same in writing.

Infact, Delhi High Court in its 2014 judge ment in Ministry of Railways through Secretary & others vs Girish Mittal observed that Section 6(3) doesn't mean that a Central PIO's responsibility is only limited to forwarding applications to departments/offices.

"Forwarding an application by a public authority to another public authority is not the same as a public information officer of a public authority arranging or sourcing information from within its own organisation," the court ob-

The case relates to an RTI application filed by one Girish Mittal, who had sought information on the Garib Rath trains in all the zones from the ministry of Railways but didn't get a reply within the stipulated 30 days. The Railways CPIO had forwarded his application to the Research Designs and Standards Organisation. Subsequently, he filed a complaint with the Central Information Commission (CIC), which directed the CPIO to furnish the information and imposed a fine of Rs 25,000 on him. The CPIO challenged the CIC order in the court.

Emphasising that he cannot escape his responsibility by merely forwarding the application to other officials under Section 6 (3), Justice Vibhu Bakhru dismissed the CPIO's pe tition. Maintaining that the information would be available with the Railway Board, the court directed the CPIO to furnish the information sought by Mittal.

These reflections on legislation make one question the responses one gets to RTI applications time and again. It raises genuine concerns over digressions such as those done in the case of DC office Pulwama's decision to misdirect the RTI application to Tehsildars and mess the ordeal to one's Right to Information.

Ramadan is not merely about fasting, there is more to Ramdan.



3. The misconception regarding one's own saliva:

It is generally believed that swallowing

one's own saliva nullifies the fast.
No, swallowing one's own saliva does not invalidates the fast as the saliva is produced through the natural process of one's body. However, swallowing large amount of saliva intentionally for nourishment breaks the fast.

4. Muslim couples are not allowed to indulge in sexual intercourse for the entire



month

Sexual intercourse is HARAM during the day while fasting, but it is allowed in the night. Kissing, hugging or embracing each other does not invalidates the fast as long as there is

no ejaculation because of these actions.

5. Muslims are not allowed to brush during the fast and this makes their breathe bad :

One is not allowed to use toothpaste dur-

ing the fast, as one is likely to swallow it. However, it is advisable to use Siwaak, infact Siwaak is Sunaah and also helps the person do away with the bad breathe!

Also, one is allowed to gargle, and use the

toothbrush (without the toothpaste) if he/she feels uncomfortable.

6. Muslims are required to fast regardless of their physical condition :

Not true. Islam is quite a liberal religion (Allhumdullaih)

As I have already mentioned in my previous article, fast is not obligatory on a person whose body cannot tolerate fasting, either due to old age or because of severe illness. Science of Authenticity

fter following a white rabbit down a hole in the ground and changing sizes several times, Alice finds herself wondering "Who in the world am I?"

This scene, from Lewis Carroll's "Alice's Adventures in Wonderland," might resonate with you: In a world that's constantly changing, it can be challenging to find your authentic self.

I am a social psychologist, and over the past few years my colleagues and I have been conducting research to better understand what it means to be authentic. Our findings provide some valuable insights that not only shed light on what is meant by authenticity – a somewhat vague term whose definition has been debated – but can also offer some tips for how to tap into your true self.

WHAT IS AUTHENTICITY?

In "Sincerity and Authenticity," literary critic and professor Lionel Trilling described how society in past centuries was held together by the commitment of people to fulfilling their stations in life, whether they were blacksmiths or barons.

Trilling argued that people in modern societies are much less willing to give up their individuality, and instead value authenticity.

But what, exactly, did he mean by authenticity?

Like Trilling, many modern philosophers also understood authenticity as a kind of individuality. For example, Søren Kierkegaard believed that being authentic meant breaking from cultural and social constraints and living a self-determined life. The German philosopher Martin Heidegger equated authenticity to accepting who you are today and living up to all the potential you have in the future. Writing many decades after Heidegger, the French existentialist Jean-Paul Sartre had a similar idea: People have the freedom to interpret themselves, and their experiences, however they like. So being true to oneself means living as the person you think yourself to be.

Common among these different perspectives is the notion that there is something about a person that represents who they really are. If we could only find the true self hidden behind the false self, we could live a perfectly authentic life.

This is how contemporary psychologists understood authenticity as well – at least at first.

THE AUTHENTIC PERSONALITY

In an attempt to define authenticity, psychologists in the early 21st century started to characterize what an authentic person looks like.

They settled on some criteria: An authentic person is supposed to be self-aware and willing to learn what makes them who they really are. Once an authentic person gains insight into their true self, they will aim to be unbiased about it – choosing not to delude themselves and distort the reality of who they are. After deciding what defines the true self, the authentic person will then behave in a way that is true to those characteristics, and avoid being "false" or "fake" merely to please others.

Some researchers have used this framework to create measurement scales that can test how authentic a person is. In this view, authenticity is a psychological trait – a part of someone's personality.

But my colleagues and I felt there was more to the experience of authenticity – something that goes beyond a list of characteristics or certain ways of living. In our most recent work, we explain why this traditional definition of authenticity might be falling short.

THINKING IS HARD

Have you ever found yourself trying to analyze your own thoughts or feelings about something, only to make yourself more confused? The poet Theodore Roethke once wrote that "self-contemplation is a curse, that makes an old confusion warse"

And there's a growing body of psychological research supporting this idea. Thinking, on its own, is surprisingly effortful and even a little bit boring, and people will do almost anything to avoid it. One study found they'll even shock

do, our reflection and introspection abilities are rather poor.

Fortunately, our research gets around this problem by defining authenticity not as something about a person, but as a feeling.

WHEN SOMETHING FEELS 'RIGHT'

We propose that authenticity is a feeling that people interpret as a sign that what they are doing in the mo-

themselves to avoid having to sit with their own thoughts.

This is a problem for a definition of authenticity that requires people to think about who they are and then act on that knowledge in an unbiased way. We don't find thinking very enjoyable, and even when we ment aligns with their true self.
Importantly, this view does not require people to know what their true self is, nor do they need to have a true self at all. According to this view, an authentic person can look many different ways; and as long as something feels authentic, it is. Although

we are not the first to take this view, our research aims to describe exactly what this feeling is like.

This is where we depart a bit from tradition. We propose that the feeling of authenticity is actually an experience of fluency.

Have you ever been playing a sport, reading a book, or having a conversation, and had the feeling that it was just right?

This is what some psychologists call fluency, or the subjective experience of ease associated with an experience. Fluency usually happens outside of our immediate awareness – in what psychologist William James called fringe consciousness.

According to our research, this feeling of fluency might contribute to feelings of authenticity.

In one study, we asked U.S. adults to recall the last activity they did and to rate how fluent it felt. We found that, regardless of the activity – whether it was work, leisure or something else – people felt more authentic the more fluent the activity was.

GETTING IN THE WAY OF FLUENCY

We were also able to show that when an activity becomes less fluent, people feel less authentic.

To do this, we asked participants to list some attributes that describe who they really are. However, sometimes we asked them to try to remember complicated strings of numbers at the same time, which increased their cognitive load. At the end, participants answered some questions about how authentic they felt while completing the task.

As we predicted, the participants felt less authentic when they had to think about their attributes under cognitive load, because being forced to do the memory task at the same time created a distraction that impeded fluency.

At the same time, this doesn't necessarily mean you're not being authentic if you take on challenging tasks.

While some people may interpret feelings of unease as a hint that they aren't being true to themselves, in some cases difficulty might be interpreted as importance.

Research by a team of psychologists led by Daphna Oyserman has shown that people have different personal theories about ease and difficulty when carrying out tasks. Sometimes when something is too easy it feels "not worth our time." Conversely, when something gets difficult – or when life gives us lemons – we might see it as especially important and worth doing.

We choose to make lemonade instead of giving up.

This might mean that there are times when we feel particularly true to ourselves when the going gets tough – as long as we interpret that difficulty as important to who we are.

TRUST YOUR GUT

As romantic as it sounds to have a true self that's merely hiding behind a false one, it probably isn't that simple. But that doesn't mean authenticity shouldn't be an something to strive for.

Seeking fluency – and avoiding internal conflict – is probably a pretty good way to stay on the path to being true to yourself, pursuing what is morally good and knowing when you're "in the right place."

When you go searching for the self in a sea of change, you might find yourself feeling like Alice in Wonderland.

But the new science of authenticity suggests that if you let feelings of fluency be your guide, you might find what you've been looking for all along

Top Army Commanders Begin Deliberations On National Security Challenges

New Delhi: Top commanders of the Army on Monday began deliberating on India's national security challenges along the borders with China and Pakistan as well as the implications of the Russia-Ukraine war for regional security at a five-day conclave.

Army Chief Gen MM Naravane is chairing the conclave in the national capital. It will conclude on April 22.

The Army Commanders' Conference is an apex level biannual event that is held in April and October every year. The conference is an institutional platform for conceptual level deliberations, culminating in making important policy decisions for the Indian Army.

Officials said detailed deliberations have been planned to assess the possible implications of the war in Ukraine for regional security as well as various military aspects of the conflict.

The commanders are also carrying out a comprehensive review of India's military preparedness along the



3,400-km-long Line of Actual Control (LAC) in view of the lingering military standoff with China in certain friction points in eastern Ladakh, they said.

The anti-terror operation in Jammu and Kashmir as well as the overall situation in the Union Territory are also being reviewed extensively at the conference, the officials said.

Defence Minister Rajnath Singh is expected to interact with the senior Army commanders and address the conference on April 21. "During the conference, the senior leadership of the Indian Army will review the operational situation along the active borders, assess threats in the entire spectrum of conflict and undertake analysis of capability voids to further focus on capability development and operational preparedness plans," the Army said on Sunday.

The officials said the commanders also delved into infrastructure development along the LAC.

India has been ramping up infrastructure development in the border regions in view of China building new bridges, roads and related structures in key sectors along the frontier.

India and China have been holding high-level military talks to resolve the face-off in the remaining friction points in eastern Ladakh.

On March 11, India and China held the 15th round of high-level military dialogue to resolve the pending issues in the region.

As a result of a series of military and diplomatic talks, the two sides completed the disengagement process last year on the north and south banks of the Pangong lake and in the Gogra area.

Each side currently has around 50,000 to 60,000 troops along the LAC in the sensitive sector.

MHA Mulls To Re-Designate 'Second-In-Command' Rank In CAPFs

NEW DELHI: The Ministry of Home Affairs has sought comments from central security forces on a proposal received from the CRPF to re-name the officer rank of 'second-in-command' as 'additional commandant' and end the "embarrassment" these personnel suffer in explaining their designation, officials said.

A second-in-command rank officer of Central Armed Police Forces (CAPFs) and the Assam Rifles is an analogous post to the superintendent rank in the regular police establishment.

Officers are inducted in CAPFs like CRPF, BSF, ITBP, SSB and CISF in the entry rank of Assistant Commandant and with the first promotion, they are designated as second-in-command (2IC in short) and subsequently as commandant which is equal to senior SP rank of the police.

The Central Reserve Police Force (CRPF), country's largest paramilitary with about 3.25 lakh personnel on its rolls, has recently written to the home ministry, stating officers of this rank find it "difficult to explain their rank and profile in civil society".

"Even in various government organisations, the rank of second-in-command is difficult to be explained. It goes without saying that a CAPF officer should take pride in his rank, but the rank of 2IC fails to add to the pride of the officers and rather becomes a matter of embarrassment," the CRPF proposal accessed by PTI said.

The paramilitary force has sought re-designating the 2IC rank as additional commandant, following which the Ministry of Home Affairs (MHA) has written to the other four CAPFs and the Assam Rifles to furnish their comments.

A home ministry officer said the issue was not that "tricky" and the ministry may issue a notification once the comments are received from all the forces and a decision is made.

A second-in-command rank officer, as the name goes, is the deputy of the commanding officer of a CAPF unit or battalion. So, it will be appropriate if this designation is given a proper name, a senior CAPF officer said.

Subsequently, the police carried out a thorough search and found that the Aadhaar numbers were genuine but the cards had their passport-sized pictures superimposed on them, an official said.

A genuine Aadhaar card contains a picture clicked on a webcam, he added. Such camouflaging attempts by the Pakistan-based militant groups and their masters in the ISI are aimed at painting the militancy in Kashmir Valley as an indigenous movement, the officials said.

Alarmed by the blatant misuse

of Aadhaar cards, the Jammu and Kashmir Police has decided to write to UIDAI requesting it to include more safety features, the officials said.

Privacy guidelines of Aadhaar are very stringent, thereby preventing the law enforcement agencies from verifying any particular card. A basic check can only provide the age bracket of the card holder without revealing the exact identity, the officials said.

The police will also cite the case of Mohammed Ismal Alvi alias Lambu, one of the masterminds of the 2019 attack on the CRPF convoy that left 40 personnel dead. A forged Aadhaar card was recovered from the site of the encounter in which he was killed.

Several forged Aadhaar cards have also been found from various hideouts of militant groups in the past few months, the officials said.

been designated as a "terrorist" by the Centre in the last fortnight.

In a notification, the Union home ministry said Nengroo has been involved in the infiltration of militants into Jammu and Kashmir and has also been responsible for perpetrating various "terror incidents" in the Union Territory

Nengroo (34) is running a terror syndicate in Kashmir and is now "engaged in a perilous campaign to orchestrate terror in Jammu and Kashmir", remote controlled from Pakistan, the ministry said.

In view of the danger that Nengroo poses to the security of India and in order to deter him from perpetrating "terror acts", he has been designated as a terrorist under the provisions of the Unlawful Activities (Prevention) Act, 1967 (37 of 1967), the ministry said.

Nengroo, who was born on November 20, 1987, hails from Pulwama in Lammu and Kashmir

Pulwama in Jammu and Kashmir.

His brother Abbass Ahmed Nengroo
was an active militant of the JeM and
was killed in 2013. In February 2020,
after the National Investigation Agency
(NIA) summoned Nengroo, he along
with his family went missing.

Nengroo was involved in cases related to the killings of a police personnel in Pulwama in 2013 and a civilian in 2020. He has allegedly been funding militancy acts and illegal supplies of weapons to militants.

The Centre believes that Ashiq Ahmed Nengroo alias Nengroo is involved in militancy and is to be notified as a terrorist under the UAPA, the notification said.

With the declaration of Nengroo as a "terrorist", the law-enforcement agencies can now attach his properties, besides booking any person associated with him.

Nengroo is the 36th individual to have been declared as a "designated terrorist" by the Centre.

"Now, therefore, in exercise of the powers conferred by clause (a) of sub-section (1) of section 35 of the Unlawful Activities (Prevention) Act, 1967, the central government hereby makes the following amendment in the Fourth Schedule to the said Act, namely:- In the Fourth Schedule to the said Act, after serial number 35 and entries relating thereto, the following serial number and entries shall be inserted, namely:- '36. Ashiq Ahmed Nengroo @Nengroo @Ashaq Hussain Nengroo @Ashaq Moulvi," the notifi-

Nengroo was also instrumental in helping JeM chief Moulana Masood Azhar's nephew Idrees infiltrate into Jammu and Kashmir via the Samba border. His activities clearly point towards his proximity with the JeM chief. His effort to take his family along with him manifests that he has no plans of returning and his aim is to continue inflicting violence on the hapless civilians of Jammu and Kashmir to keep the terror-running factory up and running, an official said. On April 8, the government had des-

ignated Hafiz Talha Saeed, a key leader of the Lashkar-e-Taiba (LeT) and the son of 26/11 Mumbai attacks mastermind Hafiz Saeed, as a terrorist. Three days later, on April 11, Pakistani national Mohiuddin

Pakistani national Mohiuddin Aurangzeb Alamgir, who was involved in a attack on a Central Reserve Police Force (CRPF) bus in Pulwama in 2019, was designated as a terrorist. On April 12, Ali Kashif Jan, the

Pakistani handler of the militants involved in the 2016 attack on the Pathankot airbase, was designated as a terrorist by the Centre.

On April 13, Mushtaq Ahmed Zargar, who was involved in a series of attacks

in Jammu and Kashmir and was one of the released militants in the hijacking of Indian Airlines flight IC-814 in 1999, was declared as a designated terrorist. The JeM has been responsible for a

The JeM has been responsible for a series of deadly attacks in India, mostly in Jammu and Kashmir, in which scores of civilians and security personnel have been killed over the years.

JeM founder Azhar who was re-

JeM founder Azhar, who was released by India in exchange for the release of the passengers of a hijacked Indian Airlines flight from Afghanistan's Kandahar in 1999, is one of the most wanted terrorists in India, along with LeT founder Hafiz Saeed and the LeT's "operational commander", Zakiur Rehman Lakhvi.

India has been consistently seeking Azhar's custody, but Pakistan has refused to comply.

The JeM is listed as a terrorist organisation under the First Schedule of the UAPA.

The UAPA has been enacted to provide for more effective prevention of certain unlawful activities of associations and individuals, dealing with terrorist activities and matters connected therewith.

The Act empowers the Centre to notify the name of an individual in its Fourth Schedule if it believes that he is involved in terrorism.

Javid even suggested Iqra to shrug off naysayers.

"And he had a point," she says.

"Had he himself listened to them, he wouldn't have been here today. So, yes, these small encouraging talks boosted my morale for doing this with more resolve."

Iqra is quite assertive about how her workplace is filled with comfort in contrast to the generally hyped apprehensions society tries to install in young girls like her. "Out of 10 people I meet in a restaurant, only one person might question my profession," she says.

"But largely, one can see people and

"But largely, one can see people and their point of view is changing which is a good thing for us as a society. Having said that, I was always assured that I hadn't done anything wrong by choosing this field. People treat me with respect wherever I go and that motivates me to work hard every day."

Today, as Saika's and Iqra's tribe is growing, the duo believes that women should aspire for new goals and fields in life with the support of their families and friends.

"We should never let people dictate our choices," Saika says.

"What matters is your happiness you derive from doing the right thing with resilience and resolve."

NDRF, SDRF Men To Join **Mountain Rescue Teams**

JAMMU: With the Amarnath pilgrimage starting from June 30 after a break of two years, NDRF and SDRF personnel are getting specialised training to be part of the Mountain Rescue Teams (MRTs) of the Jammu and Kashmir Police to ensure the safety and convenience of devotees, officials said on Monday.

The MRTs comprising personnel of the Jammu and Kashmir Police, State Disaster Response ter Response Force (NDRF) and Central Reserve Police Force (CRPF) will be deployed at nearly a dozen identified critical spots on the twin routes to the 3,880-metre-high holy cave shrine, they said.

The 43-day yatra is scheduled to start from the traditional twin routes 48-km trek from Nunwan to the cave shrine from Pahalgam in south Kashmir's Anantnag and 14-km shorter but steep Baltal route in Ganderbal district of central Kashmir.

The administration is preparing to welcome about eight centre remains open for six lakh pilgrims during the yatra this year.

The officials said NDRF and SDRF personnel are presently undergoing the specialised mountain rescue training at the Jammu and Kashmir Police facility at Nud in Samba district and some of the NDRF personnel deployed in the Union Territory will be part of the MRTs.

He said this is for the first time that they are training NDRF personnel at the facility which has the latest gadgets and equipment of international

A total of 13 highly professional instructors, including two more Everesters' -- selection grade constables Nazir Ahmad and Falil Singh -- are involved in the training of the selected batches. The training months from November-December, Singh said.

Ahmad and Singh were part of the 11-member All India Police Sports Control Board team that scaled Mount Everest in May 2019.

The training included climb-

Singh said police first deployed the MRTs during the yatra in 2008 and since then, each year MRTs are deployed along with teams from NDRF, SDRF and CRPF. As many 1,200 jawans of J&K

Police are trained in mountain rescue operations in rocky and snow-bound terrain, while training was imparted to 90 CRPF personnel and 200 SDRF personnel, while it is in progress for 240 NDRF personnel, Singh said. The officer, who is leading the

MRTs during the upcoming yatra, said over 1,600 pilgrims were rescued by them in 2019 with the personnel braving life-threatening challenges in the snow-bound and high-altitude tracks.

He said each MRT team is deployed in such a way that it covers the entire yatra track from both sides, including Sheshnag, Mahagunus Top, Poshpatri, Dardkote, Sangam Top, Brarimarg and Railpathri.

"Each member of the team is well-equipped having individual kit with gaiters, overmitts and mountain rescue equipment like carabiners, jumars, descending rappels, avalanche rods, helmets, oxygen cylinder and first-aid kit besides latest communication facility," Singh said.


