

Kashmir Residents See No Relief From Power Outages

Srinagar: There seems to be no relief in sight for the residents of Kashmir facing electricity outages for the past several days, with the authorities citing the early onset of summer and sub-optimal hydro power generation as reasons for unscheduled power cuts.

Kashmir is going through one of

its worst power crisis as unscheduled and prolonged cuts in supply in the holy month of Ramazan have left the people distraught.

Officials in the electricity department said the supply in April was around 900 to 1100 MW while the demand was 1600 MW, thereby, creating a deficit which has forced them to go for unscheduled power cuts. People in the valley complain that power supply often get disrupted at the time of sehri (when pre-dawn meals to begin the day's fast are taken) and iftar (when the fast is broken).

"There has been hardly a day when we have had electricity at the time of sehri or iftar. During the day, the situation gets worse. We have never faced such a situation before," Javid Ahmad, More on P6



JSW To Set Up Rs 150-Cr Steel Plant **In South Kashmir**

JSW Steel Ltd & Apollo Hospitals First Major Corporations To Buy Land In Jammu And Kashmir

JAMMU: JSW Steel Limited and Apollo Hospitals became the first major corporations to buy land in Ĵammu and Kasȟmir after the scrapping of Article 370 in 2019 to set up their units in the region.

While JSW steel limited is all set to come up with its Rs 150 crore project in south Kashmir's Pulwama district, Apollo Hospitals will set up its medicare facility in Jammu district, officials said.

"The possession of 70 kanals of land (8.75 acres) has already been handed over to JSW Steel Limited in Pulwama's Lassipora industrial area to set up a Rs 150-crore steel plant," a senior official said.

Apollo Hospitals is

setting up a 250-bed super speciality hospital in the Jammu region, he added.

The administration has already earmarked 100 kanals (12.5 acres) at Jammu's Miran Sahib for a medi-city, which will accommodate the country's top health sector corporates to invest here, the official noted.

In Kashmir, Medi-city is coming up on 368 kanals (46 acres) in Sempora in Pulwama district as many groups have also shown equal interest to invest in the medi-city, the officials said.

The Administrative Council had approved the transfer of land measuring 750 Kanals in favour of the Industries and Commerce Department for setting up Medicity.

Army-Run School Tweaks Hijab Order After Outrage

SRINAGAR: An Army-run school in Baramulla district on Wednesday amended its earlier order asking its staff to avoid wearing hijab during school hours after facing massive outrage and criticism in Kashmir Valley.

In a circular dated April 25. the principal of the Dagger Parivar School Baramulla, a school set up under the aegis of the Army and the Indrani Balan Foundation,

asked the teachers to avoid wearing hijab during school hours "so that students can feel comfortable and are forthcoming to interact with teachers and staff".

However, on Wednesday, the school issued an amended version of the circular, replacing the word hijab (head cover) with niqab' (face veil). The April 25-dated circular has been widely shared



Calling Kashmir 'Occupied' Does Not Enjoy Protection: J&K HC

JAMMU: The Jammu and Kashmir High Court ruled on Wednesday that calling Kashmir "occupied Kashmir" and its residents as "slaves" does not enjoy protection under the Constitution's Article 19 (A), on right to freedom of speech and expression.

A bench of Justice Sanjay Dhar, hearing a petition filed by advocate Muzamil Butt seeking quashing of an FIR against him under the Unlawful Activities (Prevention) Act, remarked: "It is one thing to criticise the government for its negligence and express outrage on the violation of human rights of the



people, but it is quite another to advocate that the people of a particular part of the country are slaves of the government of India or that they are under the occupation of armed forces of the country," online portal Bar and Bench reported.

Omar Welcomes SC Decision To List Art-370 Petitions

SRINAGAR: National Conference (NC) leader Omar Abdullah on Wednesday welcomed the Supreme Court's announcement that petitions regarding the abrogation of Article 370 of the Constitution would be listed after the summer vacation and appealed to the Chief Justice of India to hold the hearings on a

fast-track basis. "We welcome the decision of the Supreme Court to constitute a bench after the summer vacation. We understand that due to COVID-19, the petitions could not be listed earlier but we would now request the CJI that the hearings be held on a fast-track basis.

"Since August 2019, many changes have taken place, which should not have happened. Any further delay would mean that it would be difficult to reverse the changes,' Abdullah told reporters here.

The Centre abrogated the provisions of Article 370 on August 5, 2019 and bifurcated the erstwhile state of Jammu and Kashmir into the Union territories of Jammu and Kashmir and Ladakh.

Abdullah was interacting with the youth leaders of the NC at the party headquarters here. Asked if the meetings were related to elections in Jammu and Kashmir, the NC vicepresident said there was no

Unvaccinated People Increase Covid-19 Risk For Those Who Are Vaccinated: Study

nvaccinated people threaten the safety of those who are vaccinated against Covid-19 even when the immunisation rates are high, according to a modelling study published on

Researchers from the University of Toronto in Canada used a simple model to explore the effect of mixing between unvaccinated and vaccinated people to understand the dynamics of an infectious disease like SARS-

They simulated mixing of like-with-like populations in which people have exclusive contact with others of the same vaccination status as well as random mixing between different groups.

"Many opponents of vaccine mandates have framed vaccine adoption as a matter of in-dividual choice," said David Fisman, from Dalla Lana School of Public Health at the University of Toronto. "However, we found that the choices made by people who forgo vaccination contribute disproportionately to risk among those who do get vaccinated," Fisman said in a statement.

The study, published in Canadian Medical Association Journal, found that the risk to vaccinated people was lower when unvaccinated mixed with unvaccinated.



However, when vaccinated and unvaccinated people mixed, a substantial number of new infections would occur in vaccinated people, even in scenarios where immunisa-

tion rates were high. The findings remained stable even when they modelled lower levels of vaccine effectiveness for prevention of infection, such as in those who have not received a booster

dose or with new SARS-CoV-2 variants. The findings may be relevant to future waves of SARS-CoV-2 or to the behaviour of new variants, according to the researchers. "Risk among unvaccinated people cannot be considered self-regarding. In other words, forgoing vaccination can't be con-

sidered to affect only the unvaccinated, but

also those around them," the authors of the

We found that the choices made by people who forgo vaccination contribute disproportionately to risk among those who do get vaccinated

"Considerations around equity and justice for people who do choose to be vaccinated, as well as those who choose not to be, need to be considered in the formulation of vaccination policy," they said.

The researchers noted that the anti-vaccine sentiment, fuelled in part by organised disinformation efforts, has resulted in suboptimal uptake of readily available vaccines in many countries, with adverse health and economic consequences.

Although the decision not to receive vaccination is often framed in terms of the rights of individuals to opt out, such arguments neglect the potential harms to the wider community that derive from poor vaccine uptake, they added.

7 In 10 Indians In Favour Of 'Warning Sign' On Unhealthy Packaged Food: Survey

Seven out of 10 Indians are in favour of a "red warning sign" on packaged food containing high fat, sugar, and salt, according to a new survey.

The study conducted by Local Circles, a community social media platform, showed

ple in India die due to NCDs every year. One of the solutions to address this fastgrowing problem is the introduction of regulations that will help consumers make informed choices when they are planning to consume processed foods, the survey



31 per cent of the 11,439 consumers are in favour of a "red warning sign" on such packaged products.

Another 39 per cent said that in addition to the red sign, "there should be a green or orange sign on healthy products" while 20 per cent said every product should have a star rating based on its contents.

Only 8 per cent of the respondents said that "none of the above is needed, packaged food products must continue to be sold without any warnings or signs".

There has been a significant rise in consumption of junk food, especially, packaged and processed food, among Indians over the last two decades.

This has led to an adverse effect on public health as most of these foods contain a high amount of sugar or salt and bad fat ingredients, which result in an increase in non-communicable disease (NCDs) like obesity as well as rise in conditions, such

as diabetes and heart disease. It is estimated that nearly 5.8 million peo-

tween packaged and processed foods and the one that contains a high amount of salt, sugar, fat (HFSS) content, it said.

The Food Safety and Standards Authority of India has proposed a plan to introduce Health Star Rating (HSR) for packaged food products.

The HSR rates foods on a five-star scale are based on factors such as energy, saturated fat, sodium, total sugar, and healthier aspects such as protein, and natural ingredi-

The regulator has decided to go ahead with a new star rating system for packaged foods and beverages, despite criticism from consumer activist groups and food experts. Consumer activist groups have written to the Ministry of Health and Family Welfare warning that such a system can be easily manipulated by the industry, compromising public health.

They point out that though the 'nutrition information' provides some idea about the product, it does not help consumers in making a healthy choice.

D&FCO Seals 13 food Business **Operators In** Last 7 Days

rinagar: Food Safety wing of Drugs and Food Control Organization has intensified market checking on the eve of Eid-ul-Fitr and during the last seven days 13 food business operators who mainly include the bakers have been sealed and the bakery items which were found unfit for human use worth thousands of rupees were destroyed on the spot.

Moreover, a fine of Rupees 1, 76,500 has been imposed by the Adjudicating Officer, Additional District Commissioner Srinagar to 15 food business operators for not complying with the various provisions of Food Safety and Standards Act.

The food business operators especially the bakers and confectionery manufacturers, nanwaiees, poultry sellers and butchers have been directed to maintain high standards of hygiene failing which stern action under relevant laws of the Food safety and Standards Act shall be taken against the offenders.

It is pertinent to mention that kneading of dough at maximum places by bakers is being carried out by machines and not manually.

The department is in the process of allotting hygiene ratings to all food manufacturers especially the bakery and the confectionery units and the process shall be completed soon.

Meeting For Registration And Renewal Of Houseboats Held

While emphasizing coordination among various line departments, Chief Secretary directed for the constitution of a committee at senior level for registration, renewal and operation of house boats in Dal and Nigeen Lakes besides legal framework for enforcing the policy.

The committee shall be responsible for inspection of the houseboats to ensure compliance to all laid down norms and procedures including structural safety, fire hazard, sewage and waste disposal. It will also be mandated with scrutinizing all documents of the houseboat for registrations/renewal of the registration.



10 Residential Houses Damaged In Nawa Kadal Blaze

Srinagar: At least ten residential houses were damaged in a fire incident which broke out in Kanimazar locality of Nawa Kadal area in central Kashmir's Srinagar on Tuesday evening.

An official said that a fire broke out in a residential house at around 7:35 PM and soon after spread to other structures

in the vicinity. Despite timely efforts launched by the Fire and Emergency Department alongside locals, at least ten houses received substantial damage in the inferno, the official said.

'The area is highly congested which hindered the rescue operations", he said.

Farooq Ahmad Dar is one of the victims who lost his house in the blaze. A businessman dealing with handicrafts, he says he has lost all his goods.

'All the handicrafts that I had in my house are lost, It has rendered me a loss of at least 9 lakh rupees", Farooq says.

He also said that around thirty families have been ren-

dered homeless by the blaze. Meanwhile, a Fire and **Emergency Department official** said that three of their employ-

ees received minor burn injuries and were given first-aid at the site", the official said.

It has been independently learnt that few civilians have also received burn injuries in the incident, though the veracity of such reports could not be immediately ascertained. Meanwhile, the families have appealed to the administration to provide them with assistance.

Sumo-borne Men Abduct, Beat Cop

RINAGAR: A traffic police constable was admitted in the hospital in a critical condition after being dropped half dead by some unidentified abductors outside the Batwara gate of the army headquarters in Badamibagh cantonment here this afternoon

According to reports, Ghulam Muhammad (belt No1556), a constable in the traffic control department deployed in the Regal chowk to enforce one way movement stopped a white Sumo from proceeding in the wrong direction. At this, the unidentified persons pounced on the constable and beat him.

Watching the scuffle, some shopkeepers tried to rescue the policeman. But, the Sumo-borne men putted him in and fled away. The incident took place in broad day light at 3:45 p.m. At about 6.30 p.m. the army authorities informed the police about the constable lying at the mail gate of the BB Cantt almost half dead. However, the police refused to pick up the injured constable and instead demanded the in¬spector general of police or any other senior officer to go to the spot for the purpose. Eventually, it was the superintendent of police traffic, Riyaz Ahmad Bedar, who went to the BB Cantt gate and removed the constable to the SMHS hospital where the doctors attending on him said, late in the evening, that his condition was stable.

Power Crisis

ammu and Kashmir has been reeling under a severe power crisis over the last two weeks Power is available only for a few hours in a day. Some places get it for even a lesser time. And this too during the holy month of Ramzan. This has severely inconvenienced the people. What is more, there is no sign that the situation will improve anytime soon. In fact, the situation might get even worse before getting better. Ironically, the power shutdowns are associated with winter in Kashmir, but now we have them in spring also.

Not only that, ours is also a state that exports electricity and imports the same at a hefty cost for its own consumption. And for this, successive state governments are squarely to blame. They cannot escape the responsibility for saddling the state with an eternal power crisis. True, Indus Water Treaty has fundamentally hobbled J&K's capacity to exploit its water resources for power generation and there is little that the union territory can do so far as righting the wrongs under IWT are concerned. But the successive governments have shown little imagination to harness the water resources within the restrictions of the treaty. Situation is unlikely to improve on this score in future.

The ongoing power outage in Jammu and Kashmir, however, is not borne out of the local factors. Several states are facing this And the reason for this is reported to be the continued heat wave, and a coal shortage at over 150 power plants. States such as Punjab, Uttar Pradesh, Maharashtra, Haryana and Andhra Pradesh are witnessing powercuts. The coal stock position at the 173 power plants stands at 21.93 million tonnes, which, according to a report, is less than the regulatory requirement of 66.32 MT. The coal inventories, according to media reports, have dipped to the lowest since 2014 to nine days as against the Centre's mandated 24 days' worth of stocks. The heat wave, on the other hand, has exponentially increased the power demand, widening the demand-supply gap.

Kashmir, this year, has also witnessed an early onset of warmth. March turned out to be the warmest month in decades. Temporarily though, it must have raised discharge in our rivers due to early snowmelt leading to increase in the generation of hydroelectricity. But it doesn't directly benefit J&K. Here's hoping that the power situation improves from hereon. Going forward, as the Valley heads into summer, erratic power supply will not only adversely affect the everyday life but also the economy, and more importantly the tourism.



Buying free speech: On Elon Musk's Twitter buy

he world's richest man talking about free speech and humanity's future after buying one of the most influential social media platforms seems to be the most politically correct thing to do. But it is certainly ironic considering that the billionaire buyer had no qualms over the years about using the social media platform to aggressively promote his business interests as well as block and, some may say even bully, critics. But in saying what he has said, Mr. Musk has put the spotlight on what has been a sensitive issue for Twitter in recent years — its inability to convincingly come across as a platform where healthy conversations can take place. Often, those indulging in hate speech and threatening violence have found full play on the platform until authorities put in a request for withholding of the offensive tweets. Whatever it did toward that goal — from creating policies around abuse and disinformation to unleashing technology for spotting problematic content early — did little to change the perception. One need not even consider its move to permanently ban the then U.S. President Donald Trump to make the point that it, at times, has come across as an interested player rather than a disinterested platform — its inconsistencies in labelling content

as problematic would alone suffice. What Mr. Musk does next toward promoting free speech on the platform would be keenly watched. The first challenge to this is the fact that free speech is understood differently by people belonging to different political ideologies. But, Mr. Musk is all for a light touch in moderating content. CNN quoted him as saying in a recent TED conference that, "If in doubt, let the speech exist." He added, "If it's a gray area, I would say, let the tweet exist. But obviously in the case where there's perhaps a lot of controversy, you would not necessarily want to promote the tweet." He is also in favour of increasing trust by making the algorithms open source and using technology to spot spam bots. Would that improve the situation? Perhaps. Would he do away with the safeguards Twitter has built over time? One hopes not. But Mr. Musk may realise in the journey that the issue of free speech is not so black-and-white from the vantage point of a platform owner. For, he is no longer just only a Twitter user with over 80 million followers.

Make Mosques Inclusive Again

HE life and teachings of the Prophet of Islam and the Quran demonstrate the inclusive, merciful and compassionate nature of Islam. Within the holy life of the Prophet itself, we come across incidents where the Prophet embraced not only marginalised and oppressed but his enemies and the enemies of Islam too, with the spirit of extending the canopy of mercy to all. This tradition has lately waned away and what we see is stark and ugly growth of ideology in the guise of Islam that is interested in exclusion more than inclusion - a circle under implosion. When one talks of Islam, one is inadvertently driven to the institution of the mosque and the overt and covert manifestations of exclusion in this Islamic institution of primary social importance. Mosques in Islam, aren't simply sacred spaces devoted to worship, but importantly, they function as indispensable social institutions within Islamic society with diverse social functions attached to them. But what has been tragically happening for quite some time now is that Mosques are turning more and more exclusive, closing their doors, literally as well as symbolically to those who otherwise need these spaces the most. A halo of hollow piety and misplaced religiosity has turned spaces of inclusion into spaces of exclusion, thereby violating the very essence of Mosques and demeaning their role and importance in Muslim societies.

Quran described the Prophet as one who cleanses people's hearts of filth, removing the unwanted substances from their souls and teaching them the book (The Quran). This explicitly translates into the fact that the responsibility of the men of the pulpit (Maulanas) isn't only to dispense, like a machine, the subtleties of religion to people. They are expected and supposed to act as models as well as sculptures of moral sublimity and ethical perfection. But this is possible only when our preachers are ready to accept humans as humans with all their fallacies and shortcomings. It is very much antithetical to the spirit of Islam to engage in "moral profiling" and ignore those who do not fit into these profiles. The need is instead to open hearts for those who stand in need of support and guidance, those who want to turn to their creator, mend their ways and rebuild themselves but are not shown acceptance at the Mosques or by religious clerics. This has had a regressive impact

on how our youth engage with religion and in turn with society and ultimately themselves. The exclusion and rejection they endure stiffens them in their behavioural patterns and having been deprived of their right to mercy, participation and inclusion, they end up messing their lives, the lives of people around them and the society at large. This is not merely a hypothetical construct, but a real life issue which plays out in society now and then. It is not the prerogative of fallible humans to enumerate the criteria for inclusion/exclusion and then classify people into either of these classes. The realistic and only acceptable attitude for a preacher (Da'ee) is to leave open all dynamism. But a crass misgiving characterising these movements was that like their predecessors, they paid little or no attention to gender inclusion and left out of the religious sentiments and issues of half of the population unaddressed. The fact was glossed over and forgotten that Islam rose to the occasion as an emancipatory and inclusive movement, including within the horizons of its messages all diversities of Cast, Creed, Gender, Geography and Ethnicity. But the passage of time blinded Muslims to these brighter of their religion and Muslim obsession with issues of little importance blinded them to the compassionate and ever embracing aspects of religion.

It is no impossibility that the religion which harbours inclusion, equality, social dynamism and the cultural compatibility will rise and reassert these liberating values again. But this path to liberating praxis is beset with ignorance of the fundamental and essential teachings of religion both on part of scholars and the youth

portals of mercy and all avenues of inclusion. The transformation that the Prophet ushered by embracing those who were otherwise apparently not eligible for the same initiated one of the greatest revolutions in human history. A historian has described the companions of the Prophet as "nursery of heroes", but when one looks at their pre-Islamic career, they appear to be no more than ordinary tribesmen, at perpetual war with one another. Thus Islam is an alchemy of transformation, transforming the baser humans into paragons of humanity. It is not intelligible to Islam to pre-classify people into pious and wicked and prefer former over latter in an attempt of social Reformation and moral upliftment. It is an eye-opener to those religious men of our times who behave otherwise and in so doing tamper the spirit and essence of religion and scripture.

The last century has seen the sprouting of various religious movements in Islam emphasising inclusion and participation of one and all in the marathon of salvation. In the wake of these movements, the Mosques turned more inclusive, participatory and liberating, extending themselves to socially marginalised, religiously oppressed and underprivileged. In this way, the Mosques to some extent restored their social functionalism and cultural

It is no impossibility that the religion which harbours inclusion, equality, social dynamism and the cultural compatibility will rise and reassert these liberating values again. But this path to liberating praxis is beset with ignorance of the fundamental and essential teachings of religion both on part of scholars and the youth. Our scholars, well versed in the traditional sciences as they are, are equally unaware of the challenges that modern world has thrown open at the religion. The young generation, raised up in modern academia as they are, are condescending about religion, despite their poorer understanding of the same. This bilateral ignorance has widened the gulf between the youth and the scholars, bringing them at loggerheads with one another. The way out to bridge this gap lies in revisiting the schemes - both of religious and secular education. The path to reconciliation and inclusion has to pass through the meadows of learning and understanding.

Did Covid Lockdowns Work?



so much attention and controversy as this decision to grind social and economic life to a halt. Was it the right thing to do?

Properly evaluating the effectiveness of any health-oriented treatment, be it a new medicine, vaccine or lockdown measure, involves comparing its introduction with a counterfactual situation where everything is the same except for what's being tested. This is why medical trials have a control group, whose members are given a placebo and whose characteristics match the testing group as closely as possible.

Unfortunately, this isn't possible for lockdowns. There are no directly equivalent parts of a country or the world that can act as true test and control groups, and so no possibility of a controlled trial. Instead, researchers must resort to other methods to try to measure lockdowns' effects.

Mathematical models can be used to produce "what if" scenarios, where applying various different COVID control measures is simulated to estimate what would work best, essentially comparing the value of lockdown to other measures or doing nothing at all. Such models are very useful and have been used throughout the pandemic.

However, they've also been heavily criticised for their pessimistic predictions about the impact of the virus. Their outputs depend on making assumptions and estimates, including about human behaviour, which is notoriously difficult to capture accurately.

An alternative is to use a datadriven method that doesn't rely so strongly on the assumptions of models. For example, the "difference-indifference" method compares outcomes from countries or regions that are similar in all respects except the implemented control measures. A common approach has been to compare data from US states that differed in the stringency, timing and extent of their control measures but otherwise share many characteristics.

But of course, this runs into our initial problem. While often similar, no two states are directly comparable. And for other countries, like the UK, its even more difficult to find good pairings for comparison.

Imperfect assessments, clear results

Despite these difficulties, a lot of researchers have worked to try to analyse the impact of lockdowns. While accepting that no method of assessment is perfect, most published studies have found evidence to support lockdown measures being effective. They also point out that different actions achieved different things in different countries

Limiting gatherings, closing businesses with high exposure rates, and closing schools and universities effectively reduced the spread and limited deaths. These places are associated with increased transmission rates and superspreader events.

But perhaps surprisingly, stay-athome orders appear to have had only a modest effect in slowing transmission. This may, though, be down to people already limiting their activities voluntarily before being told to do so. Closing airports somewhat limits the disease impact, but land borders much less.

The danger of delaying

So, were lockdowns appropriate strategy, or should governments in future rely purely on voluntary isolation? Or is the best response to do

nothing? In evaluating the 2020 lockdowns. we need to remember that the decisions were taken with high uncertainty of what the consequences could be. It is easy to criticise the scientists and politicians in hindsight, but under the precautionary principle, the strongest possible measures should have been applied given the unknowns that were being faced.

Despite substantial variability across countries, there's little doubt that lockdowns successfully slowed COVID's spread in spring 2020, reducing cases in the first wave. There's enough evidence to show that countries and regions that quickly introduced substantial and multiple restrictions also had fewer cases and deaths. Compare New Zealand's and the UK's responses.

In both cases the introduction of lockdown regulations (first graph above) resulted in a rapid drop in mobility (second graph above). Reported cases peak soon after. Deaths in turn took another week or two to respond.


But New Zealand responded very quickly to its first reported case, with its lockdown introduced well before the first death in the country. Its resulting case numbers and deaths were low. In contrast, the UK delayed its lockdown response until almost two weeks after its first death.

Although British people reduced their mobility before lockdown was officially introduced, the virus had ample time to spread. The fact that delaying lockdown had such a large impact is further proof of its power to control the spread of the virus.

sons to keep in mind. Firstly, applying protective measures as early and hard as possible consistently led to better outcomes. Less stringent interventions risked increasing deaths; more severe responses lowered fatalities.

Plus, unless it's possible to eliminate the virus in a region, measures will need to continue. This requires public acceptance and economic support, particularly in areas of high deprivation. And finally, for the greatest effect, different restrictions must be lockdowns can be seen as a failure of other, more gradual public health policies. A lockdown should be seen as an efficient but also very blunt public health tool, to be used in necessity but as part of a wider strategy.

Extreme heat in store for Delhi, temp rises by 2-3 deg C in most parts

New Delhi: Amid a punishing heatwave building up in large parts of India, Delhi saw a jump of two to three degrees Celsius in the maximum temperature at most places on Wednesday.

The Safdarjung Observatory --Delhi's base station -- recorded a maximum temperature of 41.5 degrees Celsius as against 40.8 degrees Celsius on Tuesday.

Pitampura (43.6 degrees Celsius) and Mungeshpur (44.1 degrees Celsius) reeled under a searing heatwave.

The weather stations at Najafgarh, Ridge, and Sports Complex recorded their maximum temperature at 43.7 degrees Celsius, 43.6 degrees Celsius, and 44.2 degrees Celsius, respectively.

The mercury at the Safdarjung Observatory is expected to breach the 43-degree mark on Thursday and touch 44 degrees Celsius by Friday, according to the India Meteorological Department (IMD).

The maximum temperature may even leap to 46 degrees Celsius in parts of Delhi, a Met department official said.

Delhi may also see a partly cloudy sky, light rain, and a dust storm with winds gusting up to 50 kmph on Friday and Sunday, which may provide a temporary

The capital had recorded a maximum temperature of 43.2 degrees Celsius on April 21, 2017. The all-time high maximum temperature for the month was

45.6 degrees Celsius on April 29,

The city has recorded eight heatwave days in April this year, the maximum since 11 such days witnessed in the month in 2010.

Delhi falls in the Core Heatwave Zone (CHZ) -- the most heatwave-prone areas in India -- along with Telangana, Andhra Himachal Pradesh, Uttarakhand, Haryana, Uttar Rajasthan, Madhya Pradesh, Maharashtra, Bihar, Chhattisgarh, and West Bengal.

Northwest India has been recording higher than normal temperatures since March last week, with weather experts attributing it to the absence of periodic light rainfall and thundershowers, which typify this time of the year, due to the lack of active western disturbances.

The region had got some respite last week owing to cloudy weather due to the influence of a western disturbance over Afghanistan. A yellow alert warning has been issued for a heatwave spell in the national capital starting April 28.

The IMD uses four colour codes for weather warnings -green (no action needed), yellow (watch and stay updated), orange (be prepared) and red (take action).

The IMD said the heatwave could lead to "moderate" health concerns for vulnerable people -- infants, the elderly, people with chronic diseases -- in affected areas.

"Hence, people of these regions should avoid heat exposure, wear lightweight, light-coloured, loose, cotton clothes and cover the head by use of cloth, hat or umbrella etc," it said.

For the plains, a heatwave is declared when the maximum temperature is over 40 degrees Celsius and at least 4.5 notches above normal.

A severe heatwave is declared if the departure from normal temperature is more than 6.4 notches, according to the IMD.

Based on absolute recorded temperatures, a heatwave is declared when an area logs a maximum temperature of 45 degrees Celsius. A severe heatwave is declared if the temperature crosses the 47-degree mark.

Amid Row Over Loudspeakers, 5 Pune Mosques Say No To DJ Music **During Upcoming Eid Festival**

Pune: In the wake of a controversy over the use of loudspeakers at religious places, authorities of five mosques in Pune and some other senior Muslim community members here have decided to shun DJ music during the upcoming Eid celebration and utilise funds collected for it to help the poor and needy people.

They also appealed to youth from the community not to play loud DJ music during the Eid al-Fitr celebration on May 2.

Everyone knows the ill-effects of such loud DJ music, which is not good for sick people and

those with a weak heart, said Maulana Mohsin Raza, the imam of the Bhartiya Anjuman Qadariya Mosque in Lohiya Nagar area here in Maharashtra.

"So, we formed a core committee of five mosques in the area and convened a meeting of their imams and functionaries along with other senior members of the community and decided not to have DJ music during the Eid celebration," he told PTI.

The funds usually collected to procure the DJ music system during the celebration will be used to provide aid to the needy and poor people in the area. he said

Meanwhile, leaders of opposition parties have been blaming the administration for failing to provide relief to the residents.

Former J-K chief minister and National Conference (NC) vice president Omar Abdullah said seeking electricity was the right of the people and that the situation in the Union Territory was contrary to the tall claims of the administration about development.

"It is our right to get electricity. They (the administration) made tall claims about development in J-K. Let them show where it is," Omar

The NC leader said the power situation was no better in Jammu.

"I was in Jammu a few days ago and right before 'sehri' and 'iftar', the electricity was snapped. The situation is similar here (in the Kashmir valley)," he added.

Abdullah alleged that the power department looks for excuses to snap the electricity.

"When (the director of Meteorological Department) Sonam Lotus forecasts winds in the valley for the next day, the power department happily snaps the electricity right away. There are no winds, but there is no electricity still," he said.

The power scenario is not better even in Jammu and Kashmir's summer capital Srinagar where many areas are metered.

"In winters, we used to get power supply as per the schedule. But as soon as we entered the holy month, we began facing issues in electricity supply. We pay bills on time, but rarely have we had power (supply) at sehri and iftar. This has created a lot of inconvenience, Mohammad Yusuf, a local, said.

The situation was far worse in non-metered

"We have more hours of power cut than supply. Most of the evenings, our areas go dark," Umar Ahmad, a resident of downtown Srinagar

The locals have been regularly taking to social media to flag their concerns. However, it has not helped, they alleged.

The Kashmir Power Distribution Corporation Limited (KPDCL) said load served during April has been around 900 to 1,100 MW against a de-

'This deficit has forced the corporation to go for unscheduled cuts," it said.

The early onset of summer in the rest part of the country has led to highest ever power demand. Besides, reduced thermal power generation coupled with sub-optimal generation of hydro power due to less rains has resulted in deficient power availability leading to unscheduled and prolonged power cuts, it added.

It said hydro power generation currently is around 50 per cent of the installed capacity and load supplied by the KPDCL is in the range of 900-1,100 MWs against the peak demand of 1.600 MW.

"Attempts have been made to fill the deficit gap through peaking up of hydro power plants to meet peak demand load at sehri and iftaar times," it said.

KPDCL said the situation is going to be the same in coming days till availability improves nationally and hydroelectric generation picks

"Kashmir power discom is trying to cope up with this unprecedented situation by making all efforts to keep supply at critical times of sehri and iftar by rationalisation of allocation skewed in favour of domestic consumer base,' the corporation said, asking consumers to tackle the situation by way of judicious use of electricity especially in peak hours.

of Northern Region Pool to Jammu & Kashmir. "The order in this regard will come into the effect from midnight and the UT is expected to receive the additional supply by tomorrow," an official spokesperson said Wednesday.

He said that the J&K's Power Development Department is also making dedicated efforts on all fronts to meet the rising demand for the power supply in the UT, exploring practical and viable solutions to address the needs of the end consumers.

According to the spokesperson, it was informed that, between 1st to 25th April, the Power Development Department allocated additional Rs.52 Crore to purchase power from the open market, also known as Energy Exchange, however, due to increased number of bidding, electricity worth only Rs.10.41 Crore could only

be supplied to the Union Territory of J&K. He said that owing to the early onset of summer and an unprecedented heatwave in the month of March and April, experienced for the first time in the last 122 years and 50 years respectively, the Power Development Department took the decision to place maximum bid at the energy exchange to meet the shortfall amidst the surging power demand. Eventually, the

additional allocation was made in March to en-

sure maximum power supply.

"The Power Development Department is also ensuring optimal output from available power sources. However, it is pertinent to mention that thermal plants account for 70% of the country's power generation capacity. Thermal and Hydropower contribute 50%-50% to meeting the demand of the Union Territory of J&K. Hydropower plants operate at reduced capacity during the month of March and April due to the accumulation of snow which starts melting only in the month of May," the spokesperson

In April 2021, he said, the power demand for Jammu division was 830 MW per day. The demand has increased to 900 MW this year. He said that the Power Development Department is using all its resources including purchases from the Energy Exchange to ensure 770 MW, which is being supplied to the people of Jammu division.

"Between, 1st to 26th April of this year, only 6.17% less power units have been supplied in comparison to the same period in 2021. The PDD officials are bidding at the Energy Exchange on an hourly basis to ensure that even this gap is bridged," he added.

In the light of the increasing power demand in Jammu and Kashmir Division, the spokesperson said that Kumar is reviewing the position of power availability on an hourly basis.

He said that a meeting was also held earlier today in which senior officials of PDD and Engineers were present. It was noted that as compared to April 2021, energy consumption this year for the same period has increased.

"After detailed deliberations in the meeting, Nitishwar Kumar directed the deployment of middle management level officers at grid stations to monitor the power schedule. It was advised that the area-wise curtailment schedule be communicated to the public using all available platforms," the spokesperson added.

countrymen safe. Admitting that the search and vigil along the IB have been intensified after the recent encounter in Jammu, another jawan said, They always perform their duties with full responsibility. Over the past few days, there has been an increase in duty hours due to intensified

The BSF personnel were seen patrolling the area along the border fence and also using iron rods to check wild grass and bushes for the possible underground tunnel.

The anti-tunnel drive is going on up to 400 meters from the border fence. The tunnels have been dug in the past from the Pakistan side to push militants. We are alive to the threat and the anti-tunnelling operation is part of our duty, he said.

He said they are making every effort to keep the borders safe and ensure no infiltration takes place. If the borders are safe, our countrymen are safe as well.

Besides detecting two tunnels, the BSF killed five infiltrators, detained three others and recovered a huge cache of weapons, narcotics and fake currency notes last year.
