# 'It Doesn't Feel Like Home': Nostalgia, Nightmare In Kashmir Orphanage

ife inside an orphanage is an emotional roller-Locaster—"always testing the tested"—Musaib says

without blinking an eye. The orphan yet to observe his 18th birthday narrates his nightmare that comes to haunt his stay in the house of orphans.

The nightmare starts with an Azaan that suddenly turns into a resounding scream. A siren-wailing ambulance can be heard next in that dusk hour. It unsettles Musaib who leaves his prayers and embraces his mother tightly. His mother Fozia quickly

folds the praying mat, mumbles prayers for everyone's safety and runs downstairs to make sense of screaming. Musaib follows her like a scared kitten. He then wakes up to an awful reality.

He sees himself in a strange shelter bereft of his mother's comforting presence. He gets up and prays in the masiid of the orphanage he now lives in. The nightmare repeats ever

since his father's death in a road accident landed him in

an orphanage. After offering prayers and completing his meals at Iftar, Musaib came back to his room and sat in a corner to study. But his melancholic mood couldn't let him concentrate. He was continuously drifting back and forth into the past. After trying for a few more minutes to concentrate on his studies, he gave up and left

the room for an evening walk. Roaming in the orphanage courtyard, he wished that he could go out on the street to feel a little freedom but the rules won't let him. Frustrated by this thought he kicked a little stone and wiped off his tears and came back to his room. But the flashbacks did not leave him.

"I've an episodic memory of that incident," Musaib said. "Even though it was 14 years ago, I remember it like it was yesterday. How my father was carried out of the ambulance and how his body was fully bandaged. When I saw him I asked my aunt what happened to him. Why was he sleeping? And she said he's a little sick and he has to go somewhere for treatment. More on P6

# Over Rs 9,000 Crore Spent On Security Till 2021

New Delhi: In 28 months since the abrogation of Article 370, the Centre spent over Rs 9,000 crore, especially on security expenditure, in the Union Territory (UT) of Jammu and Kashmir.

The amount was paid to the Jammu and Kashmir government under the security-related expenditure (police) scheme since the inception of the UT on August 5, 2019, the day when Jammu and Kashmir was bifurcated into two Union territories of Jammu and Kashmir and Ladakh, and Articles 370 and 35 (A) were nullified that gave the erstwhile state its special status and the mandate to define its domicile rules.

MHA's recently published annual report 2020-2021 mentions these facts, mentioning "in order to strengthen the security apparatus, the Government of India has provided Rs 9,120.69 crore to the Government of Jammu and Kashmir under the Security Related Expenditure (Police) scheme since its inception".

As per the report, the amount includes Rs 448.04 crore that was spent till December 31, 2020 since the bifurcation



of Jammu and Kashmir.

Besides, the report says, the MHA has also approved the raising of five India Reserve (IR) Battalions, two Border Battalions and two Women Battalions for Jammu and Kashmir, "The recruit ment has already been completed for five IR Battalions.

Officials in the MHA told news agency ANI, "The security situation in J-K is monitored and regularly reviewed by the Government of Jammu and Kashmir, Army, Central Armed More on P6

#### **Hajj Aazmeen Asked To Deposit Cash, Papers**



**NEW DELHI:** The National Medical Commission (NMC) has advised Indian students not to enrol themselves in medical colleges in Pakistan.

The public notice issued by the NMC came days after the University Grants Commission (UGC) and the All India Council for Technical Education (AICTE) through a joint advisory urged Indian students not to enrol themselves in any college or educational institution in Pakistan, failing which they will not be eligible to find a job or pursue higher education in this country.

'All concerned are advised not to travel to Pakistan for pursuing Medical Education.

"Any Indian national/Overseas Citizen of India who intends to

# **How Much Garden You Would Need to 100% Survive On**

ardening is often pitched as a relaxing, therapeutic activty—and it is relaxing and therapeutic! But it's also a sign of how advanced society has become that we can regard growing food as a charming hobby instead of an absolute necessity. On the one hand, that's a clear sign of mankind's mastery over the world. On the other, it's left us remarkably dependent on a system of farming and delivery logistics that has been shown to be distressingly fragile.

Anyone who has ever successfully grown a tomato plant in their backyard has wondered if they could go "off-grid," grow their own food, and be done with their local supermarket. The answer is yes, but that's the wrong question. The question isn't whether it's possible—the question is how. It's all about the logistics: How much space do you need to grow enough crops to feed you and your family? Math will help you figure this one out.

Calculate the necessary square footage

If you've only ever gardened for fun, or to supplement your storebought groceries with some tasty home-grown treats, you might not be aware of just how much space is required to feed someone. You may have noticed that family farms are kind of large, and there's a very good reason for that (though some of that space was

vary. Different crops require different amounts of space, for example, and some gardening gurus estimate you'd need at least 4,000 square feet per person, with more space allotted for stuff like lanes between crops.

Most of us don't have 4,000 square feet to dedicate to gardening, but you probably don't need quite that much as long as you're efficient. A good rule of thumb is that you need about 200 square feet per person for a self-sustaining garden. So if you're a family of four, figure you'll need about 800 square feet, or a space about 20x40 or 10x80.

That's ... still a lot of space, especially if you're in an urban setting. The key is planning your garden out, because different crops take up different amounts of space, and if you're going to live off of those crops you have to include a wide variety of plants for nutritional completeness. Your garden will need to include these:

Proteins. If you're going to survive on a garden, you won't be eating meat. While nuts are an excellent source of protein, nut trees take up a lot of space, so make sure you plant beans. Growing lima beans on poles will require about six square feet of garden per person. Snap beans will take about 10 square feet and soybeans will eat up about 30 square feet.

Carbohydrates. You'll need some starch in your diet. The good news is that you have a lot of options. Beans will pull double duty here, in fact. Potatoes will require about 25 square feet per person,

corn will require about 30 square feet per person, squash will need about six square feet, and peas need about eight square feet. Vitamins. A complete diet requires a load of nutrients beyond protein and carbs, so plan on including stuff like spinach (eight square feet per person), broccoli (eight square feet), kale (one square

foot), or cabbage (10 square feet). Fruits. You can live on vegetables alone, but having some fruits is a great idea. Melons are great (six square feet per person), as are pumpkins (10 square feet), strawberries (10 square feet), and wa-

termelons (six square feet). Medicinals & Spices. Some plants don't offer much nutritional value, but make life a lot better by providing seasoning or health benefits. Some examples include cilantro (one square foot per person), garlic (four square feet), onions (eight square feet), and mustard (two square feet).

If you grow every plant we just discussed for a family of four, you'd need a garden space of approximately 754 square feet of gardenso the 200 square-foot rule tracks pretty well

are the caveats to surviving on your own food There are a few caveats here, or aspects of a survival garden you really need to think about before you decide that just because your backyard is precisely 200 square feet you'll be able to pull this off. First of all, the list above isn't comprehensive and only included a few examples. You might want things like carrots, okra, or cauliflower. This garden size calculator will give you some idea of how

much square footage each crop requires. When planning your garden, the main rule is this: Grow stuff you want to eat. Growing food you despise is no way to live. Other things to consider:

Variety. Keep in mind that growing just enough food to survive on will wear on you over time. Sure, you could go full Mark Watney and try to live on potatoes alone (and you just might be able to with some supplements thrown in), but if you think entering year two of nothing but potatoes won't be depressing, you're kidding yourself. Keep in mind that variety is the spice of life, and diet variety will require more square footage.

Seeds. Make sure you always select open pollinated seeds so you can recover seeds from your crops and re-plant.

Spoilage. Growing food is a battle against nature. The moment your crops start to grow, hungry things will show up to eat them in the middle of the night, bugs will nest in them, and diseases will somehow find them. You're going to need a margin of error if you're going to live off your garden—and you will likely need a year or two to figure out what not to do and make adjustments to your plan.

Design. There are many ways to lay out and manage a survival garden. Square foot gardens use raised beds and a grid system to maximize space, keyhole gardens are drought-resistant, and homestead gardens utilize a farm-like layout (and require more space). When planning a survival garden, look at the space you have and consider what kind of garden design will maximize your yield.



#### Market Checking **Intensified Across Srinagar City**

Srinagar: In order to prevent profiteering and black marketing by business establishments operating in Srinagar, the special Market Checking teams of District Administration Srinagar on Saturday conducted market checking across the Srinagar City to ensure all essential commodities are sold at Government approved rates as per the quality standards with sufficient availability of consumables.

The checking squads comprising of senior officials from Revenue, Police, Food Safety Wing of Drugs & Food Control Organization, SMC, FCS&CA and Legal Metrology Departments under the supervision of SDM East and SDM West conducted intensive market checking in all Tehsils of Srinagar City and inspected various markets within their jurisdiction.

During the drive dozens of food business units were sealed, while several erring shopkeepers were also booked found failing to maintain the quality of food items, not displaying rate lists of essential commodities, selling expiry products, besides indulging in practices of illegal profiteering and sale of underweight products.

A fine to the tune of over Rs 2 lakh was also imposed on the erring shopkeepers for violating different provisions of Food Safety and Standards Act.

During the market checking over 2 dozen Food Business Operators that mainly include the Bakers who were operating without license and under unhygienic conditions were prohibited from further manufacturing.

The kneading of dough was checked at all the bakery units and it was found that at maximum places the same is being done mechanically.

The Date of Manufacture, Use-by Date, Ingredients, Nutritional information and Temperature Controlled system in the Display Panels was also checked. While other food items especially Mutton and Chicken were also inspected along with the team of Veterinary Assistant Surgeons.

Meanwhile, the Deputy Commissioner stressed on owners of all Business establishments and shopkeepers to maintain quality and standard of essential commodities and ensure all essential commodities are sold at Government approved rates. He asked the Market checking teams to continue the drive even after Eid-ul-Fitr.

Another reason which people cite is the unprecedented inflation which is making it hard for people to shop ahead of the festive season.

"Usually around a dozen customers would visit our shops on daily basis which has increased to around 20 but ahead of Eid hundreds of customers were visiting our shops" said Zahoor Ahmad, a shopkeeper from Amira Kadal

He said that a number of people are thronging to the market but due to inflation they are unable to buy the desired items.

"A person takes an amount and thinks that he will buy three or four items from it but once he reaches the market he is unable to buy even a single item from it".

Traders from other areas also echoed the same voice and said after three years Eid is being celebrated without restrictions and were expecting good sales this year but inflation has pinched poor people very much and they are taking only important items to meet their two ends.

They said that the dent caused to "our economy since 2019 due to lockdowns is coming to the fore now as it has made poor people poorer and they are struggling to meet their two ends.

"Constant price rise is hitting the common man where it hurts the most and the administration has failed to take meaningful steps to curb the trend," they said.

It has wreaked havoc on people, particularly daily wagers, hawkers, laborers, middle, BPL and salaried classes and depleted their savings.

In Lal Chowk, Srinagar, less number of people were seen on roads which otherwise presented a bustling look ahead of the Eid-ul-Fitr.

As per Ministry of Statistics and Programme Implementation's report on monthly retail inflation, J&K has an inflation rate of 7.59 percent which is even higher than the national inflation rate of 6.95 percent. (With KNO Inputs)

# 2 Teenaged Brothers Shot Dead

aramulla: Two brothers in their teens were killed and their cousin injured when the security forces allegedly fired upon them in Devar (Lolab) of Kupwara district According to reports Sajjad Ahmad and Parvez Ahmad

sons of Muhammad Anwar Khan of Devar village in Loalb area were busy picking up guchhies (a mushroom) in the forest in the afternoon yesterday. While one of them was a 9th class student, another was reading in 7th class. On seeing them, reports said, the security forces on a patrol in the jungle, opened fire upon the children killing the two brothers on the spot while injuring their cousin. Identity of the latter could not be ascertained immediately. Reports further said the security forces got the case hushed up by paying Rs 1,500 as hush-money for each of the de¬ceased.

It may be recalled that, in a similar incident, security forces had allegedly killed a student in the Kupwara forests recently and later claimed that his body had been picked up from the forest during a routine patrol. In that case, however, the family of the victim had refused to accept any money.

# Flying The Coop

ith the curtain about to ring down on the government's half-yearly sojourn in the summer capital, the somewhat pretentious officialdom, politicos included, of the state is all set to take its soothing ministrations to the more conducive climes of Jammu in a seemingly endless repetition of an ante-diluvian practice. Obviously, the chill descending this side of the Pir Pantsal range freezes the creative and innovative currents within our masters, and they need warmer air to keep their beneficent and benevolent souls going.

Jammu and Kashmir has the distinction of being the only state with two capitals with the government migrating between them after every six months. In between, it helps itself with a neat 10-day break as if after a `tiresome' performance in either region even as the drain on public exchequer in the shape of inconsequential touring and resultant expenses on petrol and allowances goes on without any respite. In fact, some kind of a 'seasonal' inertia sets in throughout the move offices about a month earlier as the officials begin packing up for the bi-annual trek up and down the highway. The files and records of various move offices are a mute witness to the common refrain during these days: "put up after durbar move." Thus, by any calculation, the state government remains in a comma for about a month in every six months. It hardly mat ters if by the same token the government gives an emphatic lie to its own claim of being "a government that works every day". In the process, the near-empty state exchequer is made to cough up a few crores of borrowed money to sustain a patently primitive tradition of 'durbar move' the erstwhile Dogra ruler, Maharaja Ranbir Singh, had initiated 133 years

Remember, in the eighties, the then happy-go-lucky chief minister, Dr Farooq Abdullah, had taken a bold decision to dispense with the time-consuming and expensive practice only to spark off massive protests in the winter capital which forced him to lick the dust by withdrawing the order. Apparently, the main argument put forth to retain the practice is that it promotes emotional integration between the Muslim-dominated Kashmir region and Jammu having a substantial Hindu population. Partly, it also contributes a great deal in boosting trade and commerce in Jammu region. Over the decades, however, both the pleas have become almost totally irrelevant. The emotional integration between Kashmir and Jammu is just a farce as the two regions are not always on the same wave length in respect of quite some crucial issues.

The rise and groundswell of regional groups like the Jammu State Morcha has left nobody in doubt that the disturbingly saffronised regional and separatist sentiments are eating into the shrinking secular base, particularly in the two and a half districts of Jammu, Kathua and Udhampur. The growing influence of the RSS and its Hindutva outfits like the Shiv Sena and Bajrang Dal is no music for Kashmiris and certainly cannot even tolerate, leave alone nourish, any emotional bonds between the two regions. It is an open secret the RSS has been organizing regular shakhas in certain areas while the Bajrang Dal distributes trishuls to militarize the Hindu mind against Muslims.

It is no wonder that the Congress and the National Conference, who have lost no opportunity in making a travesty of their secular credentials at the regional and the national levels for the petty profits of power, should hold on to a tenuous artifice, a fig leaf, rather, to flaunt a virtue both have sacrificed time and again for the spoils of office. So, sensing themselves lacking in moral authority in deciding an issue on hard practical sense, they try to compensate by keeping up appearances. As both are deeply compromised in dealing body blows to the foundations of the nation's philosophy, they have no other option but to keep up outdated notions to avoid having to grapple with hard facts.

Otherwise also, the half-yearly migration of the government out of the problem zones affects its performance rather adversely leaving the deserted areas' people high and dry. The sooner the practice is abandoned, the better it would be for the entire state and its people. Indeed, in an era when the entire world has been reduced to a global village, the government can evolve a mechanism through which to administer the state quite effectively and efficiently without having to move between two capitals. It goes without saying that most ministers and top functionaries even otherwise keep routinely flying between the two capitals regardless of where the seat of power happens to be.

# **Schools are Drug Kiosks**

oday, if you think it is impossible for your child to have easy access to drugs, you are terribly mistaken. Being a recent high school graduate, I can attest that schools have become the hub for facilitating drug culture. They serve as hosts to the discreet yet abundant exchange of contacts, information and even the substance itself.

Otherwise deemed to discipline, schools have become kiosks for dope and drugs. Not only do these kiosks sell the substance that spoils students but they also furnish impressionable adolescents with the inspiration to abuse and consume drugs.

Peer pressure is the key contributing inspiration behind drug abuse. Curiosity of young adolescents is weaponised against them. They become real life cases of "Trial and Error" as in many instances, a friend or the dealer provides some substance without any cost, for the individual to 'taste' or 'try'. They give youngsters the apt amount to make them an addict in one single dose. This then facilitates an uninterrupted sale of drugs to the dealer and a unending loop of despair for the young addict.

Similarly, the popular culture image of drugs and dope which glorifies it especially as "masculine" and "manly" also contributes adversely to the situation. Students who have already given to abuse make it look desirable for others to consume it. It then becomes a "fashion" statement that young boys in school ties take up readily. Then these students become suppliers and this cohort increases. The chain further grows, involving as many students as approachable.

The dictum in school goes that Heroin is as available as a bottle of water. It is no wonder then that teenagers as young as 14-15 years old have taken to drug abuse. In recent times, it has been witnessed that teenagers as young as 14-15 year olds too are getting involved in this trend.

In addition to being a fad, in many instances, drugs are consumed owing to emotional and mental plight. It is very evident that the youth of Kashmir has witnessed inhumane conditions for many years now. As a consequence of conflict trauma, the rate of prevalence of post traumatic stress disorder (PTSD), depression and chronic anxiety has risen unprecedentedly. The youth is confused, scared, wounded, caged and helpless. Add to this the prolonged lockdowns following the abrogation of Article 370 and Covid pandemic which kept youngsters out of schools for over three years.

Moreover, lack of opportunities and unemployment, even lack of recreation further adds to their misery. Students can't seem to be able to escape their thoughts and thus resort to drugs.

Decades of uncertainty have deeply implanted hopelessness into the minds of general masses.

Recent lockdowns which resulted in financial and economic drawbacks have also added to the misery of all, pushing more and more youth towards this menace. The kashmir case is a typical case in point for the saying, "It's not the drugs that make a drug addict, it's the need to escape reality".

No wonder then, drug addiction is spread-

ing across Kashmir like an epidemic outbreak. A Government report says there are at least 6 lakh people in the 17-33 age group affected by drug related issues in Kashmir. According to a report published by the United Nation Drug Control Programme (UNDCP) around 70 thousand people are drug addicts alone in the Kashmir division. According to a survey conducted by the J&K administration in 2019, some 600,000 people—over 4.5 per cent of the total population of the Union territory (as per Census 2011)—are into some form or other of drug addiction. Of them, 90 per cent were found to be in the 17-33 age group. The substances consumed range from pharmaceutical opioids to heroin and brown sugar. The consumption of opioids in J&K is estimated to be among the highest in the country.

What needs to be understood and exterminated is the structure and system of supply of these substances.

As responsible adults and members of a community and society, everyone must realise their responsibility and make amends to help fight this wave of drug abuse outbreak. We must realise that drug abuse does not only affect and impact the user but also the whole community. Car accidents as a result of driving under influence, burglary, assault, instances of break-ins and other criminal behaviours threaten the safety and security of the whole community.

The question is why and how are these substances so easily available in the first place? How and why have parents become so ignorant in parenting and raising their child that they do not realise their child is going the wrong way?

Strict and stern actions need to be immediately taken by the authorities to curb and in fact put down this structure of supply and distribution. This outbreak can only be put down if we nip the evil in the bud. Excessive amount of freedom, both social and financial, is not healthy in any way. It is important to keep a check on where your child is going, who he is meeting and where he is spending his money especially when he would need thousands of rupees to be able to purchase a substance. Easy access to social media and messaging apps has made it more convenient for people to approach or contact anyone, even drug dealers. These substances can be procured over a phone call, in fact a single text message.

Parents must keenly supervise their children and also improve the environment they provide to them. In many instances, the communication gap between the parent and child breeds barriers in their relationship. And thus pushes the child towards depression for he/she cannot even confide in their parents. Lack of support, warmth and love can particularly contribute towards pushing them to the edge.

Drugs will not only wreak havoc on your child's future, but their present and past too. It is the responsibility of every parent to help in preventing the spread of this virus which does not only jeopardise a person and his family but the whole society.

akistan's former Prime Minister Imran Khan's fate was sealed when Army Chief General Qamar Javed Bajwa used the word 'invasion' when Russia attacked Ukraine on February 24, when Khan was in Moscow.

The regime change in Islamabad is a big win for Washington since it retreated from Afghanistan. Interestingly, India and China, the otherwise bêtes noirs, have been guarded not using the word "invasion". The winds of change were evident in Pakistan after General Bajwa shadowed the Washington line.

However, the second change in Pakistan politics came when Turkey, whom Islamabad considered an allay to form a new Organization of Islamic Countries, drifted towards the US

Turkey's President Recep Tayyip Erdo an, in a clear pro-US signal, even refused to provide airspace for flights to Russia from Syria. This will affect Moscow's plans to recruit Syrian mercenaries to fight inside Ukraine.

Turkey's shift has also hit Islamabad's plan to build a new Islamic block, away from the influence of the Kingdom of Saudi Arabia. However, Crown Prince Muhammed Bin Salman and US President Joseph Biden were unable to iron out their differences and hence, KSA is now considering some of its oil sales to China in Yuan, reported Wall Street Journal.

What Imran Khan did inadvertently in the process is bringing together Muhammed Bin Salman and Chinese President Xi Jinping together.

#### Syrian Shockwaves

Moscow's plan to recruit Syrian soldiers has sent shockwaves throughout European nations, who stand behind Ukraine. It is believed that Russia has deployed up to 20,000 mercenaries from Syria, Libya, and elsewhere in its new offensive in Donbas.

An official told the Guardian newspaper that estimates of mercenary involvement on the ground in eastern Ukraine range from 10,000 to 20,000 and that it was hard to break down that figure between Syrians, Libyans, and other fighters recruited by the Russian security company, the Wagner Group.

Syrian ex-soldiers have been offered monthly salaries of between \$600 and \$3,000, depending on rank and experience, to fight in Ukraine.

Wagner is a private military company where mercenaries are hired to fight for money irrespective of national interests. However, what may be added Syrian president Bashar Al Assad, could survive only because Russia lend these fighters.

Therefore, Turkey came to the rescue of Europe, which joined hands with France, to help curb Russia in the war. Turkey also had finished with an upper hand over Russia in the recent Azerbaijan-Armenia war and also has historical differences with Russia.

Turkey had also closed the straits at the entrance of the Black Sea for Russian warships. How Russia is now to interpolate to this latest Turkish diktat is to be seen, but right now Russia is 'all-ahead' to take over the Black Sea, and turn Ukraine into a land-locked nation, to monopolize Black Sea's oil and natural gas resources. In such a scenario, Russia will have to turn toward its trusted friend Iran.

#### Russia In A Spot?

Will Russia now take any stand against Turkey? The possibilities are minimal as Moscow stands isolated and in fact, could only register a complaint that Turkey was selling its Bayraktar TB2 UAVs to Ukraine.

Meanwhile, India too stopped a Japanese military aircraft carrying humanitarian aid to Ukraine. New Delhi argued that India would allow only civilian aircraft and will not let foreign military aircraft in its airspace.

The move did not antagonize Russia, and India due to its diplomacy could strike a balance in the last two months. Right now, India plays host to Raisina Dialogue, in which speakers from 90

nations are participating, Polish Foreign Minister Zbigniew Rau, has urged India to reconsider its stance on the Ukraine war.

Poland which is on alert since the war began, is now into a massive 'Stop Russia Now' campaign and wants Russia to be out of G-20, and does not want Russian President Vladimir Putin to be present at its next summit to be held in Indonesia in October.

Poland has already supplied millions of dollars worth of military aid to Ukraine. However, India is not likely to lend an ear to Polish calls as India has its priorities.

The war will soon end but the pyrrhic victory that the US has notched over the regime change in Pakistan has sent shivers inside China, as the billions of dollars it has invested in the China-Pakistan-Economic-Corridor (CPEC) is at stake





amazan is a month of self-regulation and self-training. Muslims fast in accordance with our religious requirements, but there are medical benefits as well. #### Can't implement reform in a day, says CJI Ramana over using local language in courts

New Delhi: Chief Justice of India N V Ramana on Saturday said reforms such as the introduction of local languages in courts cannot happen in a day as these things take time due to logistical difficulties and hiccups.

"Sometimes, some of the judges are not familiar with the local language. The chief justice will always be from outside. Senior-most judges sometimes are also from outside," Justice Ramana said.

"There are several hurdles and bottlenecks or hiccups in the implementation of a regional language," he said in reply to a query during a joint press conference along with Union Law Minister Kiren Rijiju.

At the press conference, held following a day-long joint conference of chief ministers and chief justices of high courts, the CII said that sometime in 2014, a plea to use local languages in courts was rejected by the full court of the Supreme Court.

Thereafter, no concrete proposal came before the Supreme Court. Now recently, the debate over allowing regional languages has started," he said.

Tamil Nadu has raised the issue of using regional language in judicial proceedings, the Chief Justice of India said.

Justice Ramana also referred to a similar request by a senior

politician from Gujarat but said he has not received any proposal yet.

"It has to reach from the village level to the Supreme Court. It takes some time." he said.

"Secondly, we do not have that technology or systems where the entire records have to be translated to local language or from local language to English. The logistic support is the biggest problem," Justice Ramana said.

To some extent, artificial intelligence is the way out, he said, adding that former CJISA Bobde and Justice Nageswara Rao Committee had tried to do something in the matter.

"We cannot implement reform in one day. I think it will happen only over a period of time," he said.

The Union law minister, in response to the query, said the government was committed to promoting regional languages in the technical and legal field and consultations with stakeholders have to be held for that.

When asked what is stopping the government from using local languages in courts, Rijiju said, "Nothing is stopping. It is a process which requires wider consultations with the judiciary."

"Use of other languages in courts not only for arguments but also passing orders will require approval of the Chief Justice of India. That is why it needs wide consultation," Rijiju said.

# ED seizes Rs 5,551 cr deposits of Chinese smartphone giant Xiaomi for FEMA violation

**New Delhi:** The Enforcement Directorate Saturday "seized" over Rs 5,551-crore worth fund of Chinese mobile manufacturing company Xiaomi for violating the Indian foreign exchange law, officials said.

In a press release after the ED's statement, Xiaomi Technology India Private Limited said its operations in the country are "firmly compliant with local laws and regulations".

The company (also called Xiaomi India) is a trader and distributor of mobile phones in the country under the brand name MI.

"Xiaomi India is a wholly-owned subsidiary of

China-based Xiaomi group. This amount of Rs 5,551.27 crore lying in the bank accounts of the company has been seized by the Enforcement Directorate," the agency said in a statement.

The seizure has been done under sections of the Foreign Exchange Management Act (FEMA) after a probe was launched by the federal agency against the company in con-nection with alleged "illegal remittances" sent abroad by the Chinese firm in February, it said.

Xiaomi began its operations in India in 2014 and started remitting the money the next year, the agency said.

# **Mobile Internet Services** Suspended In Punjab's Patiala, 3 Senior Police Officers Transferred

Patiala: The Punjab government on Saturday suspended mobile internet and SMS services in Patiala district, a day after clashes between two groups over an anti-Khalistan march left four people injured.

The government also transferred the inspector general of police (IG) Patiala Range, the Patiala senior superintendent of police and the superintendent of police with immediate effect.

spokesperson of the Chief Minister's Office said Mukhwinder Singh Chinna has been appointed as the new IG-Patiala while Deepak Parik will be the new Patiala SSP. Wazir Singh has been appointed as the new superintendent of police of Patiala.

Chinna replaces Rakesh Agrawal as IG (Patiala Range) while Parik takes over the post of SSP-Patiala from Nanak Singh. Police and district administra-

tion authorities claimed that the situation is under control and peaceful in the city. Heavy police security has

been deployed at the site of the clashes outside the Kali Mata temple in Patiala, while various Hindu outfits have given a call for a bandh here.

The order to suspend mobile internet and SMS services, except voice call, was issued by the state's home affairs and justice department.

In exercise of power conferred upon me by virtue of temporary suspension of telecom services (public emergency or public safety) rules, 2017, I Anurag principal secretary, home affairs and justice, do here by order suspension of the mobile internet services (2G/3G/45/ CDMA), all SMS services and all dongle services etc provided on mobile networks except voice calls in the territorial jurisdiction of the district of Patiala from 9:30 AM to 6 pm on April

30, said the government order. And, where there is an imminent danger of loss of life and or damage to public/ private property, and widespread disturbances of public tranquillity and communal harmony, as a result of inflammatory material and false rumours which are being/ could be transmitted/ circulated to the public through social media/ messaging services on mobile internet services, all SMS services and dongle services," it

To thwart designs and activities of "anti-national and anti-social groups or elements", maintain peace and communal harmony and to prevent loss of life or damage to public or private property, the order said, it has become necessary to take all necessary steps and measures to maintain law and order due to "unavoidable circumstances" in Patiala district in public interest. Describing the measures, it

said that this being done "by stopping the spread of misinformation and rumours, through various social media platforms such as WhatsApp, Facebook, Twitter on mobile phones and SMS, it said.

It was also mentioned in the order that the Patiala deputy commissioner and SSP have hinted towards a situation where data services could be grossly misused by certain unscrupulous elements.

Talking to the media, Patiala Deputy Commissioner Sakshi Sawhney said the situation is calm and peaceful.

We have deployed force here. The situation is peaceful right now and the situation is under control. We are constantly monitoring the situation, Sawhney said.

On suspension of mobile internet services, the official said this step was taken to prevent any rumour mongering but appealed to people not to panic.

Inspector General (Patiala Range) Rakesh Agrawal, who has now been transferred, said two FIRs have been lodged in the matter and Harish Singla, working president of a group called "Shiv Sena (Bal Thackeray)" has been arrested.

During the violence on Friday outside the temple here, the groups hurled stones at each other and police fired in the air to bring the situation under control.

### Delhi reels under heatwave, max temp settles at 43.5 Deg C

New Delhi: Delhi continued to reel under a heatwave on Saturday as the maximum temperature here settled at 43.5 degrees Celsius, five notches above the season's average, the India Meteorological Department said.

The IMD, however, predicted dust and thunderstorm on Monday and Wednesday which is likely to give some respite to residents from the scorching heat.

"Heatwave is likely to sweep across the region on Sunday too. People are likely to get some respite from the heat as the city would witness dust or thunderstorm on Monday and Wednesday. There will be partly cloudy sky on Tuesday," IMD officials said.

For the plains, a heatwave is declared when the maximum temperature is over 40 degrees Celsius, and at least 4.5 notches above normal. According to the weather office, city's minimum temperature was recorded at 25.7 degrees Celsius, two notches above the normal on Saturday morning.

"Maximum and minimum temperatures of the day are likely to hover around 43 and 25 degrees Celsius on Sunday," IMD officials said.

The relative humidity at 5.30 pm on Saturday was 17 percent, the weather office said. Addressing a press conference earlier in the day, IMD

Director General Mrutyunjay Mohapatra said night would be warmer in May in most parts

of the country, including Delhi. Private weather forecasting agency, Skymet Weather said Palam recorded highest maximum temperature of the season.

"Delhi Palam recorded maximum temperature 44.6 degrees Celsius, highest of the season and also highest after 2017 when it was 44.9 degrees Celsius. Record is 45.3 degrees Celsius on April 25 in 1970. @SkymetWeather @JATINSKYMET (sic)," Vice President, Meteorology and Change, Climate Weather, Mahesh Palawat said in a tweet.

According to the IMD, Delhi recorded its second hottest April in 72 years with a monthly average maximum temperature of 40.2 degrees Celsius. The city's normal monthly average temperature in April is 36.30 degrees Celsius. In 2010, Delhi had logged an average monthly maximum temperature of 40.4 degrees Celsius.

The national capital experienced three prolonged heatwaves this month in the absence of periodic light rainfall and thundershowers which typify this time of the year due to lack of active western disturbances.

It recorded a monthly average maximum temperature of 37.30 degrees Celsius in April last year, 35.30 degrees Celsius in 2020, and 37.30 degrees Celsius in 2019.

I was really calm at that time because I was unaware of the fact that life ends, that there is something called death. I did not realise that my father had died and my life's changed forever."

Musaib came to an orphanage in Srinagar when he was in Class 5.And now when he's in his 12th standard, he's still there-following the same old

Before becoming orphan, he used to study at his father's academy. But after his death, Musaib was enrolled in an orphanage in Kishtwar but couldn't make peace there because of homesickness.

"I used to make excuses that they don't teach well there. So, my mother withdrew me from there and enrolled me in this city orphanage," the fatherless boy says. "Even here I was not able to settle well and tried to make excuses but then I realised that it is not right. My mother sacrificed her life for me and my siblings. I need to do something good."

Despite living in the orphanage for the past seven years, the place still doesn't feel like home for him. "I want to go home and be with my family. On occasions like Ramazan, I become homesick.'

Musaib's Ramazan for many years has been set on the same timetable. From waking up for sehri to forming a long queue for iftar everything needs to be done accordingly.

The boy spends his Sundays washing clothes and cleaning his dorm. "I always have this thought that if I was at home my mother would have taken care of all these chores," he said. "Of course, I would've helped her but you know that feeling of someone doing things for you. It's missing here. It's Sunday and most children my age would be out there enjoying, playing and shopping but I'm not even allowed to leave this place. I'm not complaining. People here are good. But these thoughts cloud my mind and

bother me sometimes. Deep in thought, Musaib started to hang his clothes on the rope. Wringing off a cloth a few droplets splashed over his face, disrupting his trail of thoughts and he snapped back

He left for Masjid to offer Zuhr Namaz and returned to sleep for the whole afternoon. If it would have been a Sunday in any other month, all the kids would have spent the afternoon together playing or studying.

I used to go to the top floor to look outside. The sound of cars and buses calmed me. But now the construction of new buildings blocked my only source of relief at those moments of

**NEWCASTLE:** Liverpool kept its quadruple hopes alive with a 1-0 win over Newcastle on Saturday to maintain pressure on Premier League title rival Manchester City.

Naby Keita's classy first-half goal at St. James' Park was enough to send Liverpool two points ahead of City, which plays at Leeds later.

Even with Trent Alexander-Arnold, Fabinho, Thiago Alcantara and Mohamed Salah rested from the starting lineup ahead of Tuesday's decisive Champions League semifinal game at Villarreal, Liverpool could have won more comfortably as Newcastle's hopes of a fifth straight league win wilted in the face of almost constant pressure.

Newcastle was also bidding for a seventh straight win at home and the game kicked off amid a raucous atmosphere that might have increased had Jonjo Shelvey managed to make a better connection with a second-minute shot.
