Supreme Court Puts Sedition Law On Hold

- Says No FIRs Or Any Other Proceedings **Till Govt Completes Review**

New Delhi: In a landmark order, the Supreme Court on Wednesday put on hold the contentious sedition law till the Centre completes its promised review of the colonial relic and also asked the central and state governments not to register any fresh cases invoking the offence.

A bench headed by Chief Justice of India N V Ramana

directed that ongoing probes, pending trials and all proceedings under the sedition law across the country will also be kept in abeyance, Those in jail on sedition charges could approach the court for bail, it said. Delivering its 10-page order

13% Women In J&K Experience Post-Marriage Violence: Report

SRINAGAR: Despite being counted as progressive otherwise, the latest National Family Health Survey findings are a sobering call to action against spousal violence in J&K, as the latest report has revealed that 13 percent women in the erstwhile state have experienced violence after their marriages.

Amid a multi-pronged strategy devised by the state & police administration to protect the women from violence, the latest

figures are now a sign of worry. While domestic violence against women has declined from 14%(NFHS-4) to 13%(NFHS-5) in J&K in past almost six years, 9.3 percent women between the age of 18 and 49 have experienced physical violence in J&K from 2019-21, while 3.9percent of married women have experienced sexual violence committed by their husband in their post marriage life, finds the report that was released by Union Health Minister Dr Mansukh Mandviva last week.

The survey finds that 12.8 percent of married women (18-49 years) have experienced physical, sexual, or emotional spousal violence. The most common type of spousal violence in J&K is physical violence, followed by emotional violence (7.2 percent) and sexual violence (3.9 percent).



Pertinently, J&K currently stands at seventh lowest position in post-marital violence against women across India. However, violence against

women is highest in Karnataka at 48%, followed by Bihar, Telangana, Manipur and Tamil Nadu. Lakshawdeep has the least domestic violence at 2.1%.

The latest NFHS report has further noted that the experience of physical violence is more common among women in rural areas where the percentage was recorded at32 percent in comparison to their counterparts in urban areas where the rate stood at 24 percent.

Across India, the survey savs that 40% women with no schooling are subject to physical violence compared to 18% who completed their schooling. The experience of physical violence ranges between 39% among women in the lowest wealth quintile and 17% in the highest wealth quintile.

Notably, Domestic violence has been recognized since

1983 as a criminal offense under Indian Penal Code 498-A. However, it was not until the enactment of the Protection of Women from Domestic Violence Act 2005 (PWDVA), which came into effect in 2006, that civil protections were afforded to victims of domestic violence.

The PWDVA also provides a definition of domestic violence that is comprehensive and includes all forms of physical, emotional, verbal, sexual, and economic violence, and covers both actual acts of such violence and threats of violence.

NFHS-5included a module of questions on domestic violence that was administered to sample of households selected for the state module. A similar module was also

included in NFHS-4, although the NFHS-4 module was administered to women aged 15-49. The report has also noted that in terms of domestic violence, 9.9 percent women in J&K have suffered physical or sexual violence.

"7 percent of women (18-49) in J&K were subjected to physical violence in 2019-21, while 0.4 percent were subjected to sexual violence." says the report.

However, in over 80% cases of physical violence against women, the perpetrator is found to

be the husband.

New Drug That Halts Recurring Brain Tumour Growth Identified

n international team of scientists has identified a drug that blocks growth of the most aggressive brain tumour and how to most accurately identify which tumour will respond to the drug.


When a non-metastatic brain tumour - Meningioma - recurs after surgery and radiation treatment, a patient is out of options. No drugs are approved for these aggressive tumours, which occur in up to 20 per cent of cases and can lead to patient disability or even death.

But the new drug called abemaciclib, detailed in the journal Nature Genetics, is a cell cycle inhibitor, meaning it blocks the cell division cycle and inhibits tumour growth.

The scientists at universities of Northwestern, California, and Hong Kong demonstrated the effectiveness of the drug in select patients, mouse models, a 3D living tissue brain tumour (organoids) and cell cultures.

Investigators discovered that Meningiomas can be divided into molecular subgroups with different clinical outcomes and recurrence rates. This new method of classifying tumours allows scientists to predict recurrence more accurately than the current method of classifying the tumour.

Currently, after surgery, doctors examine a



specimen of a tumour under a microscope and grade it one, two or three in its aggressiveness. But the grade is only about 70 per cent accurate, meaning some tumours will behave in a way that doesn't fit with how it appears under the microscope.

"Our study identifies which patients we should treat with this drug, because their tumours will likely respond to it," said Dr

Stephen Magill, Assistant Professor of neurological surgery at North-western's Feinberg School of Medicine.

"We now have the potential to give them options and hope for a longer, symptomfree life." The team found that mice with Meningiomas treated with the medication lived longer and their tumours didn't grow

The drug was also used off-label as compassionate use in several patients whose tumours decreased in size and whose symptoms improved, suggesting the drug should be considered for clinical trials, Ma-

Eventually we hope to tailor medical therapy to the genetic changes within each individual person's meningioma," Magill

Ukraine-Hit Economy

'ndia is among the four nations in Asia that feature in the basket of 'hot' economies wherein the inflation rate is on the higher end of the spectrum, according to the research firm Nomura. Other economies are Singapore, South Korea, and Taiwan. This is apparent on the ground also with people complaining of being overwhelmed by the high inflation. According to a recent Reuters poll, India's retail inflation surged to an 18-month high in April. There has been a record hike in fuel and food prices. The situation has been worsened by the Indian rupee touching an all-time low against the US dollar. Every 5 percent fall in the rupee adds about 10-15 bps to the inflation. So, Rupee's continuing slide will further push up the prices of goods.

Another guage of the deteriorating health of the economy is the declining stock markets. Foreign investors have pulled out a whopping \$19 billion from the Indian markets in this calendar year so far. On the contrary, the markets witnessed net inflows of \$7 billion in 2021, \$14 billion in 2020 and \$19 billion in 2019.

One major reason for this is the ongoing war in Ukraine. As the war prolongs, the world economy is finding itself under increasing stress. The European Union has been the most impacted. The war has aggravated a shortage of natural gas that has already sent inflation up in most European countries. The bloc is now urging the Gulf countries to compensate for the energy shortfall as a result of the boycott of Russian oil.

Indian economy, as a result, could be severely impacted, although it is too early to predict how deep this impact would be. As things stand, the war has caused higher than expected inflation, supply chain disruptions and volatility in financial markets. And India can't be immune to this for long if the war drags on. And this is happening at a time when the world economy was gradually recovering from the debilitating fallout of the Covid-19 pandemic. The countries were slowly opening up and letting the economy function normally. International travel was also returning to pre-pandemic levels. India was taking steps toward a self-reliant economy also called Atmanirbharta. This is expected to drive economic momentum and growth. The resumption of economic activity is also important to restore the millions of jobs lost to the pandemic.

More so, in India where the successive virulent waves of the pandemic have hemorrhaged the economy. In 2021, India's GDP slipped by over 7 percent. The gaping dent in the GDP meant that lakhs of jobs were lost, a disproportionate number of them the people living at the bottom of the pyramid. Therefore it is incumbent on the world to come together to resolve the crisis in Ukraine and find a solution that addresses the concerns of all the parties involved.


Don't Step Back

fter at least two high courts — Punjab and Allahabad - struck down the sedition law as an exception to free speech in the 1950s, a five-judge bench of the Supreme Court in Kedar Nath Singh vs State of Bihar (1962) upheld its constitutionality. However, the SC restricted it only insofar as seditious speech tended to incite "public disorder", a phrase the provision itself does not contain but was read into it by the Court. In its "guidelines" on using the new, restrictive definition of sedition law, the Court said not all speech with "disaffection", "hatred," or "contempt" against the state but only speech that is likely to incite "public disorder" would qualify as sedition. It is a welcome sign that the government, after its initial defence of the law, has told the Supreme Court that it would re-examine the provision.

On Monday, referring to the prime minister's views on shedding colonial baggage as the country marks 75 years since independence, the Home Ministry asked the SC to defer the hearing for now till a "competent forum", presumably Parliament, deliberates on the issue. The sedition law became obsolete in the UK in the 1960s and was finally repealed in 2009. Last year, Singapore, which like India inherited colonial English law, repealed the law stating several new laws can sufficiently address issues that were under the ambit of the sedition law. Hopefully, the government's changed stance is not meant to foreclose the prospect of review and push reform into cold storage.

The government emphasises the "need for balance" in affidavits before the Court but not while invoking the provision against comedians, journalists and ordinary citizens expressing their dissatisfaction with the government. Successive reports of the Law Commission and even the Supreme Court have reported the rampant misuse of the law. The authority to identify and distinguish genuine expression of speech from seditious speech cannot be the police. Magistrates who are the first defenders of citizen's rights in the judiciary often allow the pleas of the state as a matter of routine and without proper application of mind. Whether the government decides in favour of repealing the law or not, the Court must take this endeavour to its logical conclusion. The matter is too significant to be put on ice.

No Band-Aids for Brain?

chools can be tough. Worse now, as students are exposed to a world which is beyond the walls of their homes or their schools. It is evident then that students today face challenges which are not only much more but quite new. School counselors often double up as the moral police of school administration and are rarely ever trained to counsel students the right way.

Perhaps this complete disregard of mental health stems from an overall ignorance of our society towards mental health issues

While growing up, everyone has been taught to take care of their health and wellbeing. We have been taught that 'health is wealth', taught to eat healthy foods to avoid catching a disease, we tend to adopt lifestyles that aid physical wellbeing. But has anyone ever exactly explained what is meant by 'health' and a 'healthy life' holistically? Is it a state of physical wellbeing only? Does it simply mean the absence of disease? The World Health Organisation states that the word 'health' determines "a state of complete physical, mental and social well-being and not merely the absence of disease and infirmity"

However, we mostly tend to ignore the part that says "mental and social wellbeing". As a community, we have stigmatised even the mere suggestion of mental health. We have somehow created an impression that mental health is a hoax and it does not exist. WHO statistics say that over 7,00,000 people die due to suicide every year induced by depression. Suicide is the fourth leading cause of threat in 15-29-year-olds. About 14.3% of deaths worldwide, or approximately 8 million deaths each year, are attributable to mental disorders.

Can we declare coronavirus a hoax while we clearly see millions dying and suffering due to the disease? Then why do we ignore the importance of mental health even after we have data suggesting that millions suffer from depression, anxiety, trauma and people even killing themselves because of it. Our idea of a healthy individual is restricted to physical aspects only even as so many continue to remain mentally crippled.

habits and prolificacy depend directly upon the ability of our mind to concentrate and interpret. A healthy state of mind promotes productive outputs and thus makes a person more capable of achieving his ends. Living with a constantly anxious and tumultuous mind can be very confusing and at times can take a toll on your daily life chores and even your social life. An unhealthy mind can lead you to struggle for survival while you could rather be live ing your best life.

Yet the whole idea of mental wellbeing is an alien concept to most people especially in Kashmir. Our society normalises potentially criminal and unethical behaviour but has unfortunately stigmatised the idea of mental health. Our society views people with mental illnesses as 'outcasts', completely oblivious of the fact that it is rarely uncommon in a place like Kashmir. Having a mentally healthy mind does not only mean that there is an absence of a major mental illness such as dementia or bipolar disorder, it also means a mind free of concerns that we disregard as 'little' or 'insignificant', such as anxiety and depression.

The cause of concern is not the existence of mental illnesses but denial about the significance of a healthy mind. In the 21st century, while humanity has peaked in developmental spheres, it is condemnable that something as important as mental health is still being stigmatised. While we should have been enroute to developing more and better ways to help people cope with illnesses such as depression, anxiety, trauma, psychosis, paranoia, obsessive compulsive disorder, bipolar disorder and other mental health issues, we are still only finding ways to spread awareness about it.

While the process of spreading ample education regarding the importance of psychological wellbeing should have been sped up, it is the

least rapid. It is high time that society de-stigmatises the concept of mental health. While the society may stigmatise or discriminate against a mentally unhealthy individual, at times, it is internalised stigma that affects individuals making them believe that their concerns and problems are invalid.

Moreover, the generational gap also caters to stereotyping of mental health. Generation Z or Gen Z is the only generation that contemporarily emphasises on the issue. Thus, your sibling and friends may be supportive pillars for you to identify and seek help for your mental health issues but your parents don't. Many people among the older generations may not have even heard about the notion of psychological health, because it is like a little clan of the new generation that keeps talking about it on platforms that older generations mostly don't even know about. But significantly, generation Z became the largest generation, constituting 32 percent of the global population — or 2.47 billion of the 7.7 billion people on Earth. Which also signifies that many taboos and stereotypes will itself wither away in a set time frame, with the advancement of civilisation, these taboos will no longer remain relevant. It is extremely foolish of us to let ourselves suffer owing to a set of non-permanent stereotypes.

People suffering with any sort of mental disorder, even anxiety or stress should seek help from their family, friends and most importantly professional mental health experts. The stigma around mental wellbeing is diminishing every day, but it cannot end until we pledge to normalise it ourselves, by incorporating ways and means of achieving a healthy mind into our daily lives. We have to normalise the concept of psychological health, visiting a psychiatrist or counsellor, treating mental illnesses, talking about it, raising more awareness, and most importantly acknowledging the importance of keeping a check on our mental health. One should adopt habits that prevent stress, anxiety and depression.

Pleasing someone at the cost of your mental health is indeed a very foolish choice. People in our society, mostly tend to ignore their own psychological needs, and rather cater to people who may at times be responsible for the unhealthy mental state of that person. We have to realise that people-pleasing is not as important as taking care of our psyche. We have to start prioritising ourselves rather than those whose actions affect us negatively. An unhealthy mind will never let a person be at peace, it is almost as if a voice inside your brain constantly repeats all the bad things to you, making you uncomfortable and miserable. Some preconceived notions are not more important than your wellbeing. You have to acknowledge mental health and fight for yourself to lead a happy and healthy life- physically, mentally and socially.

Four Keys to Well-Being That May Help You Live Longer

as we get older, we become more prone to serious illnesses, like heart disease, dementia, and cancer. We may become frailer and suffer falls and broken bones or other complications, which ultimately cut our lives short.

If we want to live a long, healthy life as we age, it's important to keep physically healthy by eating right, exercising, and getting enough sleep. But what about our psychological health? Does that matter for our longevity?

gevity? A new study suggests it does.

In this study, researchers drew survey data from over 21,000 adults over 50 who'd participated in the University of Michigan's Health and Retirement Study, where every four years they were asked to report how happy, optimistic, and satisfied with their lives they were, and how much they experienced social support from others and a sense of purpose—all indicators of good psychological health.

Between 2006 and 2020, nearly 5,000 of them died, giving researchers a chance to see how psychological health may have contributed to their longevity. First, the researchers ruled out other things that could have shortened someone's lifespan, like their gender, race or ethnicity, marital status, education level, and socioeconomic status as a child. They also considered if people drank alcohol or smoked, had mobility issues, or had pre-existing health conditions (like high blood pressure or cancer)-all of which can affect our risk of death.

Then, they compared the psychological well-being of people who had died to people the same age who were still living, averaging their well-being scores prior to their deaths. They found that those who lived had better psychological health—even after controlling for those factors that increased their risk of early death.

"How people feel about the way their life is going is important for their health and survival," says lead researcher Jennifer Boylan. "Doing things that promote these good feelings and these abilities to function well and effectively have tangible,

significant effects on how long someone lived."

Boylan and her colleagues also figured out how much longer someone might live if they had greater psychological health. People with significantly higher than average life satisfaction, positive feelings, purpose in life, or optimism at age 50 lived an average of five to eight additional years—an advantage comparable to what highly educated people enjoy.

"Achieving high levels of these aspects of well-being have really important impacts on people living longer and healthier lives," says Boylan. "Their presence is worth focusing on more than it has been."

How well-being increases longevity is not known for sure. But Boylan says people who are psychologically healthy tend to take better care of themselves by being physically active, sleeping better, and engaging in more preventative health care. Also, being mentally healthy might help people cope better with stress, reducing the harmful physiological responses (like increased heart rate or blood pressure) that come with it.

The aspect of well-being that was most protective was having a purpose in life. Boylan says this is

intriguing, as purpose in life is not necessarily about stress reduction and may, in fact, require facing challenges.

"Sometimes things that give us purpose and meaning might not feel good 100% of the time, but they still tend to be good for us in terms of our health outcomes," she says.

Having greater social support was the least important contributor to longevity in the study—a finding that seems to contradict past research and surprised Boylan. But, she says, this may have been due to the way she measured social support, neglecting to ask about difficulties within supportive relationships (like strain, criticism, or conflict) that could dampen their helpful effects

could dampen their helpful effects.
Otherwise, many of her findings are in line with past research showing a connection between psychological health and longevity. In fact, optimism, purpose, and happiness have all been tied to living longer, suggesting we may want to cultivate these in our lives.

Because less educated people tend to die earlier than more highly educated people, Boylan and her colleagues wondered if greater psychological health might mitigate that, helping less educated people to live longer. Unfortunately, having greater happiness or purpose in life increased highly educated people's longevity but didn't benefit the less educated. On the other hand, having more social supports, optimism, and life satisfaction were helpful to both more and less educated people.

"These might be good things to target," says Boylan. For example, she mentions how public policies and individual practices like gratitude, mindfulness, and social skills that foster supportive relationships could help people lead happier lives—and extend them, too.

"Regardless of which aspect of psychological well-being you target, there might be really tangible mortality benefits from achieving high levels of it," she says. "We should be promoting these in everyone's life."

East coast to receive heavy rain as 'Asani' may become depression

BHUBANESWAR/KOLKATA: Several parts of Odisha and West Bengal are bracing for heavy rain as severe cyclone Asani weakened to a cyclonic storm on Wednesday, barrelling towards north coastal Andhra Pradesh, packing a wind speed of 85 km per hour, the Met

Department said. The weather system is likely to further lose steam and turn into a depression by Thursday morning, it said.

It is very likely to move nearly northwards for next few hours and recurve slowly north-northeastwards along Narsapur, Yanam, Kakinada, and Visakhapatnam coasts during noon to evening on Wednesday, and emerge into west-central Bay of Bengal off North Andhra Pradesh coasts by night, the India Meteorological Department said in a bulletin.

In this situation, the Odisha government said the system will have no major impact on the state except heavy rainfall in some southern districts.

The Odisha government has put five southern districts - Malkangiri, Koraput, Rayagada, Ganjam and Gajapati - on high alert , as they are likely to be affected by the system. It is unlikely to have

much impact on Odisha. It is likely to make landfall between Kakinada and Narsapur of Andhra Pradesh on Wednesday night, Odisha Special Relief Commissioner (SRC) P K Jena said.

Mrutyunjay DG Mohapatra in Bhubaneswar said southern Odisha will experience wind speed up to 40-50 kmph as the cyclone would make the landfall.

Fishermen should not venture into the sea till May 12, he said.

Light to moderate rain or thundershower was experienced in Malkangiri, Koraput, Rayagada, Kalahandi, Ganjam, Gajapati, Kandhamal, Nayagarh, Khurda, Puri, Cuttack and Bhubaneswar, the Regional Meteorological Centre said.

Jena said 60 ODRAF (Odisha Disaster Rapid Action Force) units and 132 teams of fire service personnel have been deployed in the state, considering the emerging situation.

The National Disaster Response Force (NDRF) has earmarked a total of 50 teams for undertaking rescue and relief operations in areas affected by Asani, the federal

Israeli Troops 'Shoot Dead' Al Jazeera Journalist **In Occupied West Bank**

Israeli army has shot and killed an Al Jazeera reporter in the occupied West Bank, Palestine's Health Ministry and the Oatarbased news channel said.

Shireen Abu Akleh was "assassinated" on Wednesday by Israeli forces while reporting on a raid in the city of Jenin, which has seen intensified army raids in recent weeks as violence has surged, a Palestinian official said.

Palestinian Health Ministry confirmed Abu Akleh's killing and said a second reporter, Ali Samodi, working for the Jerusalem-based Al Quds newspaper had been wounded.

The shooting by the Israeli occupation forces on Shireen was deliberate and the bullet hit her below the ear in an area not covered by the helmet she was wearing, the director of Al Jazeera's office in Palestine said.

In a statement, the Israeli army confirmed that it had conducted an operation early on Wednesday in Jenin refugee camp, saying its troops had shot back after coming under



"massive fire" in Jenin. It added that "there is a possibility, now being looked into, that reporters were hit - possibly by shoots fired by Palestinian gunmen.'

"In a blatant murder, violating international laws and norms, the Israeli occupation forces assassinated in cold blood Al Jazeera's correspondent in Palestine," the channel said in a statement, calling on the international community to hold the Israeli forces accountable for their "intentional targeting and killing" of the journalist.

Qatar's deputy foreign minister condemned the killing in a Twitter post called for an end to "state sponsored Israeli terrorism."

Israel has carried out neardaily raids in the occupied West Bank recently.

Tensions have soared in the past weeks after a series of fatal attacks in Israel and deadly Israeli arrest raids across the occupied West Bank.

In Jenin, the Israeli army has blamed some of the attacks on residents and has stepped up operations in the area.

Rampur court issues NBW against Azam's wife and MLA son in fake birth certificate case

Rampur: A special court on Wednesday issued non-bailable warrants against Samajwadi party MLA Abdullah Azam and his mother Tanzeen Fatima here after rejecting their applications for exemption from appearance in a fake birth certificate case against the legislator.

The warrant was issued after the two failed to appear for the hearing in the special court for MPs and MLAs, District Government Counsel Arun Saxena said.

The case relates to the issuance of a fake birth certificate for Abdullah Azam in which an FIR was filed with Ganj police station here by the BJP leader Akash Saxena.

The court fixed May 16 as the next date of hearing, the DGC said.

According to the FIR lodged in 2019, the complainant had alleged that SP leader Azam Khan and his wife had got a fake birth certificate issued for their son Abdullah Azam.

In 2020, after the bail applications of Azam Khan, his wife and son were rejected, they surrendered in court and were sent to jail in the case.

They were lodged in jail for about 10 months, after which the three were granted bail on the condition that they shall not tamper with the prosecution evidence or intimidate or put

pressure on the witnesses during the investigation or trial.

They were directed to cooperate in the trial sincerely without seeking any adjournment.

During the hearing on Wednesday, the witness was present but he could not be examined as Abdullah Azam and Tazeen Fatima failed to appear. The two instead applied for a leave from the hearing, which was dismissed and the NBW was issued.

Abdullah Azam had won the Suar assembly seat in Rampur for the second consecutive time in the recent state polls.

The counsel said the issuance of NBW means the police can arrest the two and produce them in court in the matter.

Meanwhile, the sleuths of the Enforcement Directorate on Wednesday carried out a probe into the allegations of "illegal fundraising" and misappropriation of funds & undervaluation of the Trust property by the Jauhar Trust which runs Muhammad Ali Jauhar University founded by jailed Samajwadi party leader Azam Khan.

Saxena had levelled the allegations in this regard also. A senior district official said that the officials of the Enforcement Directorate have carried out an inspection of the campus of the Muhammad Ali Jauhar University.

cases till the government's re-examination of the penal law is over, the court also spoke of the need to balance the interests of civil liberties and citizens with that of the State.

This Court is cognizant of security interests and integrity of the State on one hand, and the civil liberties of citizens on the other. There is a requirement to balance both sets of considerations, which is a difficult exercise."

The offence of sedition, which was included in Section 124 A of the Indian Penal Code(IPC) in 1890, has been under intense public scrutiny for its use as a tool against expressions of dissent, including on social media. The British government during its colonial rule had used the sedition law primarily to suppress dissent and imprison freedom fighters such as Mahatma Gandhi and Bal Gangadhar Tilak.

The case of the petitioners is that this provision of law pre-dates the Constitution itself, and is being misused, the bench, also comprising Justices Surya Kant and Hima Kohli, said in its interim order.

Taking note of the concerns of the Centre, the apex court said the rigours of Section 124 A (sedition) of the IPC is not in tune with the current social milieu and permitted reconsideration of the provision.

We expect that, till the re-examination of the provision is complete, it will be appropriate not to continue the usage of the aforesaid provision of law by the Governments

Any affected party is at liberty to approach concerned courts, which are requested to examine the reliefs sought taking into the consideration the present order, the apex court said.

CJI Ramana, writing the order, referred to the attorney general(K K Venugopal) earlier giving instances of glaring misuse of this provision, like in the case of recital of the Hanuman

The Editors Guild of India welcomed the court order.

The Guild welcomes this interim order as sedition law has been used far too often by central and state governments against journalists in an effort to curb independent reporting, it said in a statement.

The Guild was one of the petitioners who had challenged the sedition law. The other petitioners included Major General(Retd) SG Vombatkere, former union minister Arun Shourie and People's Union for Civil Liberties (PUCL). The petitions contended that the law causes a 'chilling effect' on free speech and is an unreasonable restriction on free expression, a fundamental right.

"We are looking for the entire (sedition) law to be struck down," Vombatkere told NDTV. Senior advocate and former Attorney General Mukul Rohatgi told the channel that the sedition law has outlived its life and that the apex court order was a "very bold step".

The court listed the pleas for further hearing in the third week of July, and said its directions shall continue till further orders.

While the Opposition hailed the decision, saving the voice of truth can no longer be suppressed, the Centre invoked the "Lakshman Rekha" to assert that none of the institutions should not cross the "boundary"

The ruling BJP on its part said the order must be viewed in the context of the overall positive suggestion of the government that it wishes to examine the matter which has been "duly accepted" by the court.

The offence of sedition provides for life term as maximum penalty for creating "disaffection towards the government".

Over the years, the number of sedition cases has been on the rise, with Maharashtra politician couple Navneet and Ravi Rana, author Arundhati Roy, student activist Umar Khalid and journalist Siddique Kappan among those charged under the provision.

The British brought sedition laws to target freedom fighters. A sedition charge was imposed on us just for reciting Hanuman Chalisa. We got justice from the Supreme Court today. I thank the court, the law minister, and the prime minister for this, said Navneet Rana, a Lok Sabha MP from Amravati.

The court order referred to the Centre's affidavit, which accepted there were divergent views on the law and had also said that Prime Minister Narendra Modi was strongly in favour of protection of civil liberties and respect for

In view of the above, it is clear that the Union of India agrees with the prima facie opinion expressed by this Court In light of the same, the Union of India may reconsider the aforesaid provision of law."

The order said the interim stay granted to some petitioners by the apex court would continue to operate till further orders.

All pending trials, appeals and proceedings with respect to the charge framed under Section 124 A of IPC be kept in abeyance. Adjudication with respect to other Sections, if any, could proceed if the Courts are of the opinion that no prejudice would be caused to the accused, it added.

If any fresh case is registered, the affected parties are at liberty to approach the courts for appropriate relief and the courts are requested to examine the reliefs sought, taking into account the present order passed as well as the clear stand taken by the Centre, it said.

The court did not agree with the Centre's suggestion that a superintendent of police ranked officer be made responsible for monitoring the registration of FÎRs for the offence

Solicitor General Tushar Mehta, appearing for the Centre, had also said the registration of FIRs on the matter cannot be prevented as the provision dealt with a cognisable offence and was upheld by a Constitution bench in 1962.

With regard to pending sedition cases, the Centre suggested that hearing on bail pleas in such matters may be expedited as the government did not know the gravity of the offence in all the cases and they may have terror or money laundering angles.

"Ultimately, pending cases are before the judicial forum and we need to trust courts," the law officer submitted.

The bench, which rose for a few minutes to discuss the orders after taking note of the Centre's response, came back to pronounce the directions and said it has considered the issues elaborately.

Between 2015 and 2020, 356 cases of sedition -- as defined under Section 124 A of the IPC--were registered and 548 persons arrested, according to data compiled by the National Crime Records Bureau (NCRB). However, just 12 persons arrested in seven sedition cases

were convicted in this six-year period.

authorities from registering FIRs, continuing any investigations or taking any coercive measures under section 124A (sedition).

The court also ordered that appeals and proceedings under Section 124A should be kept in abeyance for the time being.

According to the data, one case each under the sedition law was registered in Jammu and Kashmir in 2015 and 2017.

As per data, not a single case was registered under the law in J&K in 2014 and 2016.

The data lays bare that 12 cases were registered in 2018 when the erstwhile State was ruled by the PDP-BIP coalition government for nearly six months before imposition of Governor's Rule on June 20 that year after BJP withdrew support to Mehbooba Mufti-led government citing "deteriorating security situation" in the state.

In the year 2019 when the Government of India abrogated Article 370 and reorganized the erstwhile state of J&K into two Union Territories, 11 cases were registered under sedition law in J&K.

It is worthwhile to mention that section 124A of IPC states that whoever "brings or attempts to bring into hatred or contempt, or excites or attempts to excite disaffection towards the government established by law in India" can be held to have committed sedition.

While IPC became applicable to J&K after its reorganization, the provisions of sedition law were also existing in the Ranbir Penal Code (RPC), which was applicable to J&K till October 30, 2019-(KNO)

The Central Reserve Police Force (CRPF) has deployed as many as 60 battalions in J&K for undertaking counter-terrorist operations and rendering law and order duties. It is part of the security grid that comprises the CRPF, Army, J&K Police and central intelligence

As per official data, security forces likes the CRPF, Army and J&K Police killed a total of 71 militants this year out of which 19 were "foreign terrorists".
