Declared Eco-Sensitive Zone

62. 2 Square Km Area In Gulmarg

SRINAGAR: The Union Ministry of Environment, Forest and Climate Change have declared 62.2 square kilometers around Gulmarg Wildlife Sanctuary as eco-sensitive zone (ESZ).

In a notification, the Ministry has notified that ESZ shall be of 62.2 square kilometers, with an extent of zero to 4.1 kilometers around the boundary of Gulmarg wildlife sanctuary.

"The 'zero' extent of eco-sensitive zone is proposed towards eastern side as it adjoins the Ferozpura watershed comprising Gulmarg wildlife sanctuary which is bifurcated geographically by geological features like high mountains, peaks and glaciers. The eco-sensitive zone is kept 0.05 kilometers towards Southern side, 0.012 kilometers towards South-Western

side and 0.012 kilometers on Western side of the Gulmarg wildlife sanctuary because the area is well known tourist spot with large tourist footfalls all around the year and there is no scope of eco-sensitive zone extent possible on these sides," reads the notification.

According to the ministry, there is no village/township which falls within the proposed eco-sensitive zone of Gulmarg wildlife sanctuary.

As per mandatory requirements, the UT government shall prepare a zonal master plan for the purposes of the eco-sensitive zone.

"The Union territory government shall, for the purposes of the eco-sensitive zone prepare a zonal master plan within a period of two years from the date of publication of this notification in the More on P6

Meet 'The Only Mason' Face-lifting Temples, Churches, Shrines In Kashmir

n a chilly December morning last year, Naseer Ahmad Gilkar was busy cementing the dislodged bricks at St. Luke's Church, Kashmir's oldest Cathedral.

At the cusp of completing the renovation project, Naseer did not shy away from showing his happiness.

Wintry breeze did not deter the mason in his early fifties from arriving early at his workplace. He has been showing this work commitment for over three decades now while working at religious sites belonging to people of different faiths.

Before working at the Cathedral, Naseer face-lifted Hazratbal shrine and renovated Shri Chandra Chinar Udasin Ashram, a Hindu temple at Lal Chowk, Srinagar.

"Masonry is in our blood," Naseer said."My father and grandfather were both masons." Naseer lives in Dalgate's Daesil Mohalla, a locality known for having produced experts in masonry.

Among other things, the mason termed the experience of working at religious sites different from other places.

"I've seen everyone coming to their place of worship with intention to bow before their creator," he said."I've the same amount of respect for the church as I've for a mosque."

By working at religious sites of people other than your faith, he said, one gets to know about the belief of other people as well. While renovating the St.



Lukes Church at Dalgate, Naseer talked about the importance of reviving old structures and said they're part of Kashmir's collective legacy. "Faith is personal and I'm

of the belief that everyone should've the freedom to practice his or her religion freely," the mason said.

"Respecting people of other faiths and their places of worship is a prophetic practice and we're obliged to do that. I've seen every person looking for creator in their own way. I believe religious people are better than those who deny the existence of God. While our ways of worship are different, the

creator remains the same." Naseer believes at present he's the only one working in Muslim shrines, in a Protestant church

and a Hindu temple. "I think other than me it's hard to find a person who has worked at so many places with so much diversity," he said. Naseer is amazed by the architectural differences seen at

different religious places. "Every religious place has a different style of architecture," he said."Even two churches aren't built in the same manner. Whereas the architecture is different, the masonry work remains the same."

Naseer is fascinated by the historical structures like Jamia Masjid and believes that a craftsmanship void has been created in Kashmir over the time.

"Masons in the past were craftsmen of high calibre," he said."They knew their job well. Their kind of work cannot be done in contemporary times."

Pointing towards the wooden arches of the historic St. Lukes Church, Naseer attributed the fading craftsmanship to the use of technological equipment and non-availability of time.

"Due to availability of time in the past, masons used to work altogether for More on P6

'Half Of Covid Survivors Show One Symptom Even Two Years After Infection'

Beijing- More than half of people hospitalised with COVID-19 still have at least one symptom two years after they were first infected with the SARS-CoV-2 virus, according to the longest follow-up study published in The Lancet Respiratory Medicine journal. The research followed 1,192 partici-

pants in China infected with SARS-CoV-2 during the first phase of the pandemic in 2020.

While physical and mental health generally improved over time, the study suggests that COVID-19 patients still tend to have poorer health and quality of life than the general population.

This is especially the case for participants with long COVID, who typically still have at least one symptom including fatigue, shortness of breath, and sleep difficulties two years after initially falling ill, the researchers said. The long-term health impacts of CO-VID-19 have remained largely unknown, as the longest follow-up studies to date

have spanned around one year, they said. "Our findings indicate that for a certain proportion of hospitalised COVID-19 survivors, while they may have cleared the initial infection, more than two years is needed to recover fully from COVID-19," said study lead author Professor Bin Cao, of the China-Japan Friendship Hospital, China.

"Ongoing follow-up of COVID-19 survivors, particularly those with symptoms of long COVID, is essential to understand the longer course of the illness, as is further exploration of the benefits of rehabilitation programmes for recovery," Cao said in a statement. The researchers noted that there is a clear need to provide continued support to a significant proportion of people who have had COVID-19, and to understand how vaccines, emerging treatments, and variants affect longterm health outcomes.

They evaluated the health of 1,192 participants with acute COVID-19 treated at Jin Yin-tan Hospital in Wuhan, between January 7 and May 29, 2020, at



six months, 12 months, and two years. Assessments involved a six-minute walking test, laboratory tests, and questionnaires on symptoms, mental health, health-related quality of life, if

they had returned to work, and healthcare use after discharge, the researchers said.

The median age of participants at discharge was 57 years, and 54 per cent were men.

Six months after initially falling ill, 68 per cent of participants reported at least one long COVID symptom, according to the researchers. By two years after infection, reports of

symptoms had fallen to 55 per cent, they said. Fatigue or muscle weakness were the

symptoms most often reported and fell from 52 per cent at six months to 30 per cent at two years, the researchers said. Regardless of the severity of their initial illness, 89 per cent of participants had returned to their original work at two years, they said.

The researchers noted that two years after initially falling ill, patients with COVID-19 are generally in poorer health than the general population, with 31 per cent reporting fatigue or muscle weakness and 31 per cent reporting sleep difficulties.

COVID-19 patients were also more likely to report a number of other symptoms including joint pain, palpitations, dizziness, and headaches, they

Around half of study participants had symptoms of long COVID at two years, and reported lower quality of life than those without long COVID.

In mental health questionnaires, 35 per cent reported pain or discomfort and 19 per cent reported anxiety or depression.

Long COVID participants also more often reported problems with their mobility or activity than those without the disorder.

The authors acknowledge some limitations to their study. Without a control group of hospital

survivors unrelated to COVID-19 infection, it is hard to determine whether observed abnormalities are specific to COVID-19, they said.

The slightly increased proportion of participants included in the analysis who received oxygen leads to the possibility that those who did not participate in the study had fewer symptoms than those who did, according to the researchers.

Why Award Honorary Doctorates, And What Do The Choices Say **About Our Universities?**

niversities like to associate themselves with exceptional individuals through the awarding of honorary doctorates, but this practice has often attracted controversy, creating headaches for university administrators. Honorary doctorates highlight uncomfortable but important questions about the purpose of the university and its role in reinforcing and perpetuating social inequality. The tradition and purpose of honorary doctorates Honorary degrees (usually, though not always, doctorates) are awarded by universities to recognise outstanding achievement in a particular field, or service to the broader community. While some universities have established separate honorary degrees, such as the Doctor of the University at Griffith University, most Australian universities have maintained the traditional system in which a range of degrees may be awarded honoris causa. This means no degree is actually undertaken, but the nominee

In Australia, especially since the post-World War II dawn of federal funding for universities, honorary doctorates have occasioned public debate and sometimes protest. In August 1962, the Australian National University declined to award an honorary degree to King

Bhumibol of Thailand, reportedly because of his lack of academic qualifications. This created diplomatic embarrassment for the Australian government in the context of an impending royal visit.

The University of Melbourne stepped into the breach to make Bhumibol an Honorary Doctor of Laws in September 1962, which was judged a bad look in university circles. The Vice-Chancellor of Monash University, Louis Matheson, commented a little smugly in an internal memo that There is no subject to which a university should bring more delicacy and sureness of touch than the selection of its honorary graduates.

Matheson was forced to eat humble pie when in 1967 a furore erupted over his university's honouring of Victorian Premier Henry

Universities gain a number of benefits from conferring honorary doctorates. The acceptance of an honorary degree by an exceptionally distinguished person often generates publicity and brings reflected glory on the university, in the words of one former Vice-Chancellor, preserved in the Monash University archives. Honorary doctorates have long been used to foster advantageous connections with individuals, countries or organisations. The University of Oxford awarded the first recorded honorary doctorate in around 1478 to a brother-in-law of Edward IV in a clear attempt to obtain the favour of a man with great influence. Honorary degrees have. unsurprisingly, usually been awarded to well-known individuals. The honouring of less-known individuals, and members of socially disadvantaged groups, has been much rarer. Controversy and protest

Bolte, shortly after Bolte had sanctioned the controversial execution of Ronald Rvan. Outsmarts Scammers, **Retrieves 58 Lakhs**

Srinagar: Cyber Police Kashmir on Thursday said they saved Rs 58 lakhs from scammers.

Cyber Police Station Kashmir Zone, Srinagar said they received two complaints from men hailing from North Kashmir's Bandipora District and South Kashmir's Awantipora District respectively, a police spokesman said.

The complainants alleged in their complaints that they were defrauded by online scammers of an amount of Rs 44 lakhs in online investment, trading scam. Both complainants received links of fake investment websites on their cell numbers wherein they were promised to get double monetary benefits.

The victims fell prey and accessed the website where they got themselves registered on said websites by opening e-wallets. After registration, duo victims were made to transfer the hefty amount of Rs 44 lakhs in the said wallets through various UPI/IMPS transactions. The victims after depositing the said amounts were unable to get benefits and also were not able to withdraw even their own amounts from the said wallets. The complainants then tried hard to reach out on available contact details of said company but all in vain.

"Accordingly, both complainants approached Cyber Police Kashmir Zone, Srinagar for redressal of their grievance. Subsequently, the matter was taken up with bank authorities to ascertain the details of UPI/IMPS transactions. During analysis of transactions, it came to fore that the said amount had been settled through online payment gateways.

The strenuous and timely intervention by the team of Cyber Police Kashmir Zone. Srinagar led to holding of the payment of Rs 44 lakhs in two different payment gateways and later on, the whole amount also got refunded into both these victim's bank accounts.

"In another complaint received from one businessman hailing from Srinagar vicinity wherein the victim was cheated by online fraudsters on the pretext of transportation of goods, services through an e-Commerce company web portal. The complainant was looking for goods-carrier services to transport the goods of his firm. Enticed by the offer, the complainant made an online payment of Rs 16 lakhs. On receipt of the money, the complainant was not able to contact the company again. Upon realizing that he was cheated by fraudsters through the above fake web portal, the complainant approached Cyber Police Kashmir Zone, Srinagar for redressal of his grievance."

Installation Of Smart Meters

Allochi Bagh Residents Protest

rinagar: Residents of Allochi Bagh Srinagar on Thursday staged a protest demonstration against the "installation of smart electric meters in the locality.

The Residents, including men, women and children assembled at the main road and raised slogans against the installation of smart meters in the area. The protestors said that the

Mushtaq Ahmad, a protester said.

"Sometimes we are not getting

the power supply for days together and still the department is deliver-ing us tariff bills, and we are paying the same." He added.

He said we won't allow authorities to install these meters at any cost that will make their conditions much worse.

Another protestor said that we don't have issues with the current system of installed meters and we are paying the bills despite power outages

The protesting residents have urged Lieutenant Governor Manoi Sinha to revisit the decision of installation of smart meters in the area. (CNS)

Shoots at Two Govt Employees, Goes Absconding

ammu- Two government employees were injured when a Central Reserve Police Force personal posted in highly guarded Koth Bhalwal jail- opened fire on them with his service weapon in Purkhoo area, here this morning.

The assailant reportedly fled with the official weapon and four magazines from Kot Bhalwal jail before attacking the gov-ernment employees. Though police and CRPF have launched a massive man hunt for his arrest he was said to be absconding till the last report came in.

Sources quoting, eyewitnesses said that Constable Dhokuo Dhmingel from Manipur of 26 Battalion was on guard duty when he went out of control and entered into verbal dual with his seniors at around midnight today.

"Dhmingel was dead drunk and all of a sudden he started teasing his senior officers", sources said adding, "The jawan fired few shots in air and later ran away with his official weapon and four magazines".

On reaching Purkho area along Jammu-Poonch road the accused entered into the premises of reservoir-cum-overhead water tank and demanded some cash from the employees of PHE posted on duty on gun-point. It was reliably learnt that one of the employees Sham Lal

gave him Rs 50 but it did not satisfied the dunked jawan. "He opened the nozzle of his gun injuring the PHE employees", sources said.

They injured were identified as Sukhdev Singh Dailywager and Sham Lal Pump operator, bot employees of the PHE. They were rushed to Government Medical College Hospital Jammu, where their condition was stated to be critical.

The accused trooper; ran away with the gun from the spot and disappeared from the area. A massive man hunt was imme diately launched by police and CRPF to track down the jawan but no breakthrough made till filing of this report

Beware, More Covid Outbreaks

nlike some other countries, the Covid-19 pandemic in India is well under control. In the last twenty four hours, just 2,827 coronavirus infections were reported in the country. This has created hope that the pandemic may be on its way out. But there is also a danger that there could be more region-specific or nationwide outbreaks. It won't be prudent to rule out the fourth wave and go about our lives without following Standard Operating Procedures or take lightly the advent of new highly transmissible virus strains. In January-February, the third Covid wave triggered by Omicron caught on despite a predominant majority of the country having been vaccinated. However, the vaccination did substantially reduce the hospitalizations and deaths. It remains to be seen what level of transmissibility and the virulence the new variants possess. More so, when vaccination is already over one year old and its effect may be wearing thin. This is already happening in China and some other major countries.

As things stand, despite the sudden spike in the cases, the number is too low in India to be taken seriously yet. So, the coming days and weeks will be crucial as to the trend of infections. Any significant rise in the cases will require government intervention just as China has done in Shanghai. The world's biggest city has been under lockdown for some time. However, India is unlikely to go that far as unlike Beijing, New Delhi doesn't follow zer-Covid policy.

It is thus premature to rule out more Covid waves and we have to be prepared for them. The world has been through several successive waves of the pandemic which have infected millions and claimed hundreds of thousands of lives. With the abating of the Omicron wave which broke out early this year, there was a temporary sense of relief across the world. The economies started re-opening in most parts of the world. But fresh surges in some countries should be a warning that the virus is here to stay for some more time. In fact, it has already become endemic now. So far, Covid-19 has turned out to be a very stubborn virus. Despite full vaccination by a large mass of people across the globe, the outbreaks have not stopped. Here's hoping that the new Covid variants become milder so that people can live with them. But meanwhile, the governments and the people can't afford to let their guard down. There is a need to continue to follow Covid precautions in public.

How US Domestic Terrorism Policy Perpetuates Islamophobia

attribute this to the social construction of terrorism, nearly universally accepted in the vears since the launch of the "war on terror". Who gets investigated for suspected terrorism, who gets prosecuted, and who gets convicted are all inextricably linked to the social constructions that have primed us to feel we know who "does" terrorism; who is a terrorist



During his inaugural address last year, US President Joe Biden cited "a rise in political extremism, white supremacy, domestic terrorism that we must confront and we will defeat". Speaking in the shadow of the Capitol Hill insurrection that had occurred just two weeks earlier, Biden added that "to restore the soul and to secure the future of America requires more than words".

It was no surprise that he addressed this issue, as the aim of the Capitol rioters was to overthrow the results of the election and keep former President Donald Trump in office at all costs. But many wondered whether Biden would truly act, and what that response might look like. The US has no domestic terrorism statute - and existing tools to prosecute homegrown terrorism have rarely focused on the threat posed by white extremists.

Extremist violence can no longer be swept under the rug by diverting attention towards the threat of so-called Islamic terrorism

In June 2021, the Biden administration released its "National Strategy for Countering Domestic Terrorism". This apparent prioritisation of the issue came as white supremacist violence was occupying a more central place in the public imagination and the political landscape, both due to the Capitol insurrection and violent clashes in cities across the country during the Trump administration.

A shift in media coverage was certainly part of the explanation, but this new policy focus was also rooted in a distinctly changing reality. As white nationalist rhetoric has gained steam in mainstream political discourse, extremist violence can no longer be swept under the rug by diverting attention towards the threat of so-called Islamic terrorism. But the Biden administration's agenda largely ignores the glaring reality that those criminalised by the existing legal structures for combating domestic terrorism have almost exclusively been Black, indigenous and people of colour, especially Muslims. Biden benefits from the perceived newness of both the threat of domestic extremism and efforts to combat it. This administration has centred the tumultuous political environment of the Trump years, and especially the rise of violence from his supporters in groups such as the Proud Boys.

During the Obama administration, widespread surveillance of Muslim communities was authorised and normalised, as law enforcement <u>agencies targeted Mus-</u> lims who had neither committed a crime nor given any indication of planning to do so, on the basis of blatantly Islamophobic criteria such as religiosity or having a beard - presented as an indication that they were prone to extremism and violence.

In 2018, Trump cancelled the CVE programme, a move widely seen as a pre-emptive attempt to shield his base from potentially being targeted for white nationalism. Yet, given the programme's history - alongside two decades of "war on terror" infrastructure that almost exclusively targets Muslims - this possibility still feels remote. It would certainly constitute a major break from US law enforcement history, in which Black and Muslim communities have been consistently targeted at far greater rates than whites.

The fact is, neither the threat posed by domestic terrorism, nor the specific menace of white supremacist violence, is remotely new. In his strategy document, Biden seemingly acknowledges this, stating: "This is the domestic terrorism threat America faces today - one with the distinctive imprint of today's digital age as well as longstanding roots in domestic terrorism challenges throughout our country's history. Tackling that threat comprehensively and persistently demands appreciating both its historical lineage and its distinctively modern form.'

In large part, we can attribute this to the social construction of terrorism, nearly universally accepted in the years since the launch of the "war on terror". Who gets investigated for suspected terrorism, who gets prosecuted, and who gets convicted are all inextricably linked to the social constructions that have primed us to feel we know who "does" terrorism; who is a terrorist.

For more than two decades, since the Bush administration invaded Afghanistan, we have been told repeatedly that "the terrorists" are Muslim - and this association has been fully absorbed into the domestic landscape. The national-security-obsessed paradigm that grew out of those early days has expanded to transform a wide variety of US institutions and policies, from immigration services, to surveillance, to the widespread use of informants to obtain federal terrorism prosecutions.

Simply put, there was an intentional effort post-9/11 to construct terrorism as a uniquely Muslim crime, meaning that efforts to designate white supremacist violence as terrorism have never really stuck.

A recent court verdict illustrates how far the reality of our approach to domestic terrorism is from the language of the Biden administration and others who insist that the threat of white supremacist violence can and should be countered under that label. Two men charged with plotting to kidnap Michigan Governor Gretchen Whitmer in 2020 were acquitted on all charges last month, while two other defendants saw the case end in a mistrial.

Their lawyers had raised the trapment defence based on the use of FBI informants. An entrapment defence generally always fails with a Muslim defendant in the US. Rather, the use of informants and provocateurs has been enabled by policies such as CVE, and has largely gone unexamined by courts, which have accepted that the government's stated interest in national security should be taken at face value, even when the facts do not align. The leeway granted to the Justice Department and its lawyers in such cases apparently does not extend to those with white defendants - and that comes as no surprise.

And hereafter, on such and such date, we shall observe a minute's silence nationwide in their memory. We shall grieve in unison and work while we grieve because the pandemic has taken away much but it has also left behind learnings."

Historical roots

It was during the Obama administration, however, that the US launched its Countering Violent Extremism (CVE) programme to facilitate domestic counterterrorism efforts. While the growing threat posed by white supremacist ideology was largely ignored - despite the fact that its growth has been credibly attributed to a backlash stemming from Obama's election - CVE has been devastating to speak to the historical roots of white terrorism, going back to slavery and Jim Crow. Instead, he seemingly aimed to promote the perception that the historical threat has been replaced with something new and different. White supremacist violence is a threat that has been with us from the founding of the country, and in that sense, Biden was right to invoke history - but his committed attempts to link this particular threat to the Trump era, and his obscure language, point to an unwillingness to address the issue for what it is.

Targeting Muslims

Of course, Biden's use of the word "history" could denote a deeper understanding of the shape of American violence. Still, history gives us no evidence that such a theoretical understanding has ever resulted in anything remotely consequential being done to address white supremacist violence. That's why these efforts to curb domestic terrorism have rightly been critiqued for what the assumed consequence will be: further and continued targeting of BIPOC communities, and Muslims in particular, in the context of national security.

ince children do not have a vocabulary and/or mental fac-ulty available to them to express how they feel when they are neglected by their parents/family members/caregivers, we as adults may overlook the impact of our neglect on the mental health of such neglected children until the neglect they felt during their childhood does not show it's detrimental effects vividly in their lives as adults and by that time, it might be too late or it might become too difficult to undo the damage. The failure of parents or caregivers to respond to a child's emotional needs is known as childhood emotional neglect. Neglect like this can have long-term as well as short-term,

WHAT ARE THE CAUSES OF CHILDHOOD EMOTIONAL NEGLECT?

Parents who are not physically violent but emotionally neglect their children are usually going through a difficult time themselves in their personal lives. Connecting with others becomes incredibly difficult in times of stress, and parents may find themselves unable to create secure bonds with their children. When parents are dealing with mental illness, intense stress, or external pressures such as work, spousal abuse, poverty, or police service, they may be unaware that they are neglecting their children emotionally

have difficulty in relationships later in life, feeling chronically distant and misunderstood. They may not know how to deal with their emotions as adults because their emotional needs were not met as children.

WHAT IS CHILDHOOD EMOTIONAL NEGLECT (CEN)?

When a child's parent or parents fail to adequately meet their child's emotional needs, this is known as childhood emotional neglect. Emotional neglect is not the same as emotional abuse in children. Abuse is frequently premeditated: it is a conscious decision to cause harm to another person. Emotional neglect can range from a deliberate disrespect for a child's feelings to a failure to act or notice a child's emotional needs. Parents who emotionally neglect their children may still provide care and all the necessities, such as good food, good schooling, toys etc to their children. They just miss out on or mishandle the emotional needs of their children.

An example of CEN would be a child who tells their parent how sad they are about a friend at school. Instead of listening and helping the child to deal with the difficult feelings, the parent dismisses it as a childhood game. Such a child may gradually learn that their emotional needs are unimportant and

hence may cease asking for help. Children's reactions to emotional neglect can be subtle. It's possible that parents are unaware of their actions. Similarly, other important people in the lives of children such as teachers may

struggle to identify the subtle signs. Severe cases are more easily detected and may attract the most attention. Less se-

rious ones may go unnoticed.

- Parents may emotionally neglect their children for the following reasons:
- Parents who have been neglected 1. or abused as children may not know how to care for their children
- 2. A parent's absence from the family may be due to work, military service, or jail.
- 3. Addiction or mental illness might make it difficult for a parent to pay attention to their child.
- Extreme stress and/or violence in 4. the family can disrupt parent-child relationships.
- A parent's death, or any traumatic 5. death in the family, might create an outpouring of grief throughout the family.

HOW DOES CHILDHOOD EMOTIONAL **NEGLECT AFFECT THE MENTAL HEALTH OF CHILDREN?**

Emotional neglect in children can manifest itself in a variety of ways, from subtle to overt. At first, much of the damage caused by emotional neglect is undetectable. However, the consequences may become apparent over time.

The following are the most common symptoms of emotional neglect in children

- Depression
- Anxiety
- Apathy
- Failure To Succeed
- Aggressiveness
 - Hyperactivity
 - **Developmental Delays**
- Substance Abuse
- Low Self-Esteem
 - Withdrawing From Social Interactions And Activities
 - Seeming Uncaring Or Uninterested
 - Poor Emotional Intimacy Or Close-ness

WHAT IMPACT DOES CHILDHOOD **NEGLECT HAVE ON ADULTS?**

Adults who have been emotionally neglected as children may have to face its consequences as adults. They may

- **Dissociative Tendencies**
- Increased Likelihood For Eating Disorder
 - Avoiding Intimacy And Closeness
 - Feeling Deeply, Personally Defective
- Feeling Empty And Hollow Inside
- Lacking In Self-Control
- Feeling Shame And Guilt
- Hostile And Aggressive Behaviors
- Having Trouble Trusting Or Relying On Others
- Lack Of Clarity About What Others Expect Of You And What You Expect Of Yourself

Adults who were emotionally neglected as children may become parents who neglect their children emotionally. They may not know how to nurture emotions in their children since they never learnt the value of their own emotions while growing up as children.

People of all ages can overcome the effects of emotional neglect in the short term and prevent future complications by receiving effective treatment and recognizing their own experiences of childhood emotional neglect.

HOW TO TREAT CHILDHOOD **EMOTIONAL NEGLECT?**

Childhood emotional neglect may make it hard for such an individual to understand emotions and relationships, hence effective healing from Childhood Emotional Neglect should include activities such as working on and building emotional intelligence, developing appropriate emotional regulation skills, and forging healthy relationships. Certain symptoms may be alleviated by medication prescribed by a psychiatrist, but healing from neglect requires more effort than just taking medicines.

There are certain modes of therapy that can be offered to such individuals who have been affected by Childhood **Emotional Neglect:** 1)

INDIVIDUAL THERAPY:

One of the best methods to heal the effects of Childhood Emotional Neglect is to find a therapist who has an experience of working with attachment, trauma, and neglect. Individual therapy

PARENTING WORKSHOPS:

Parenting workshops can be a great approach to help parents develop the skills they need to nurture their children emotionally. Attendees learn about child development, healthy discipline, and strategies to emotionally nurture and support their children in parenting programmes. Parenting workshops can be especially beneficial for parents who have been abused or neglected as children. There are also several parenting books and tools available on the internet that can help such parents to develop healthy parenting practices. Childhood Emotional Neglect can

harm a child's self-esteem and mental health. It can instill in them the belief that their feelings are unimportant. The effects of this neglect might be severe and long-lasting. Treatment for Child-hood Emotional Neglect can help such neglected children overcome feelings of emptiness and inability to manage their emotions. Parents can also improve their relationships with their children in order to break the intergenerational cycle of abuse.

SC Says Right To Live In Shared Household Not Restricted To Matrimonial Home

New Delhi: In an important verdict safeguarding the interest of woman victims of domestic violence, the Supreme Court Thursday gave a wide interpretation to the term right to reside in a shared household' under the law, holding it cannot be restricted to only actual matrimonial residence, but can be extended to other homes irrespective to right over the property.

A bench of justices M R Shah and B V Nagarathna, while hearing a plea of domestic violence victim after she was widowed, dealt with the unique situation of Indian women who live at places different from matrimonial homes, such as the workplaces of their husbands,.

"There could be several situations and circumstances and every woman in a domestic relationship can enforce her right to reside in a shared household irrespective of whether she has any right, title or beneficial interest in the same and the said right could be enforced by any woman under the said provision as an independent right...," the bench said.

It held that the even in the absence of a Domestic Incident Report of a protection officer under the Protection of Women from Domestic Violence Act, reliefs such as right to reside in the shared matrimonial homes can be enforced.

"It is held that Section 12 (under which a woman seeks reliefs under the Act), does not makes



it mandatory for a Magistrate to consider a Domestic Incident Report filed by a Protection Officer or service provider before passing any order under the D.V. Act.

It is clarified that even in the absence of a Domestic Incident Report, a Magistrate is empowered to pass both ex parte or interim as well as a final order under the provisions of the DV Act, to Justice Nagarathna said, writing 79-page judgement.

The bench also answered a legal question whether it was mandatory for the aggrieved women to reside with those persons against whom the allegations have been levied at the point of commission of domestic violence. It is held that it is not mandatory for the aggrieved person, when she is related by consanguinity, marriage or through a relationship in the nature of marriage, adoption or are family members living together as a joint family, to actually reside with those persons against

whom the allegations have been levelled at the time of commission of domestic violence, it said.

If a woman has the right to reside in the shared household under the law and such a woman becomes a victim of domestic violence then she can seek reliefs under the provisions of DV Act including enforcement of her right to live in a shared household.

bealing with the question whether there should be a subsisting domestic relationship between the victim and the accused family members, it said there should be a subsisting domestic relationship between the aggrieved person and the person against whom the relief

is claimed with regard to the allegation of domestic violence. However, it is not necessary that at the time of filing of an application by an aggrieved person, the domestic relationship should be subsisting, it said, adding if the accused, at any point of time, had lived with the victim then she is entitled to file an application claiming relief under the law.

The bench set aside the verdicts of the High Court of Uttarakhand and the trial court which had held the widow was not entitled to any relief under the law as there was no Domestic Incident Report of a protection officer before the trial magistrate.

The top court dealt with the expression the right to reside in a shared household' in the context of Indian women and said it needed expansive interpretation and cannot be restricted to actual residence.

Even in the absence of actual residence in the shared household, a woman in a domestic relationship can enforce her right to reside therein, it said.

The interpretation can be explained by way of an illustration, it said, adding if a woman gets married then she acquires the right to reside in the household of her husband which then becomes a shared household within the meaning of the D.V. Act.

In India, it is a societal norm for a woman, on her marriage to reside with her husband, unless due to professional, occupational or job commitments, or for other genuine reasons, the husband and wife decide to reside at different locations. Even in a case where the woman in a domestic relationship is residing elsewhere on account of a reasonable cause, she has the right to reside in a shared household, it said.

Kolkata Metro Rail Works Blamed For Cracks In Houses; 87 People Shifted

Kolkata: Kolkata Mayor Firhad Hakim on Thursday visited Bowbazar area where cracks appeared overnight in a number of houses when tunnelling was going on to extend the underground Metro Rail network and blamed the agency executing the project for the problem which has led to evacuation of people

from the damaged buildings. Hakim, also the urban development minister, claimed that the cracks on houses at Durga Pitury Lane were likely to have occurred owing to continuing soil settlement in the area triggered by an accident over two and half years ago during tunnelling work by the Kolkata Metro Railway Corporation (KMRC).

Stating that its priority is to prevent further cracks in buildings, the KMRC said that 87 people of 21 families from at least nine damaged houses at Durga Pituri Lane in the congested Bowbazar area have been shifted to nearby hotels.

A top KMRC official said that the situation occurred despite precautionary measures as the agency had faced a similar situation earlier.

There is some irresponsibility on their (KMRC) part. During a meeting following the accident in 2019, the KMRC had said that it took the total engineering responsibility of that area," the mayor told reporters during a visit to the spot.

A tunnel boring machine (TBM) had hit an aquifer on August 31, 2019, in Bowbazar area leading to severe ground subsidence and collapse of several buildings.

Soil settlement can occur after two to three years, Hakim said. The KMRC, the executing agency for the East-West Metro project, has failed to take the responsibility, Hakim claimed and added that it should have taken care of the buildings before cracks developed in them. Tunnels of the long awaited

corridor, which will connect Salt Lake Sector-V in the East and Howrah Maidan in the West, pass under Bowbazar. Most of the buildings in that area are over a century old.

The mayor said that the director general of the Building department of the Kolkata Municipal Corporation has been asked to assess how safe it would be to let the damaged buildings exist and a decision will be taken soon.

He said that the KMC and the KMRC will hold joint meetings to assess the fate of those buildings. KMRC general manager, administration, A K Nandy said that engineers have been working in the Metro tunnels passing below the affected area since Wednesday night and the reasons for the cracks can be ascertained only after their assessment.

"We are assessing the reasons for the cracks and working to prevent damage to any more buildings in the area. Our main priority now is to prevent any further cracks in the affected houses and other buildings in the area," he told PTI.

The Peoples Conference led by Sajad Lone also condemned the killing and extended sympathies and unwavering support to the family of the victim.

While strongly condemning the attack, Apni Party President Syed Mohammed Altaf Bukhari said that it is very tragic to see this senseless bloodshed of innocents.

"Our fellow Kashmiris are suffering due to acts of violence and there seems to be no end to this madness, he said.

"Such targeted killings of members of minority community is reprehensible and the people of Kashmir won't accept this bloodshed," he added. (With PTI inputs)

Chanting slogans, the protesters alleged that the government has failed to secure lives of the community members in the Kashmir Valley. The protesters also blocked the highway, leaving hundreds of vehicles stranded on the either side.

"Are we brought to Kashmir to face bullets? Is this our rehabilitation? We don't want such jobs where we have to lay down our lives. We will resign enmass and move back to Jammu," a woman protester said.

"We have been brought here to work, to teach students. What's our crime? Why are we being killed?" another protester said, adding that they have nothing do to with the politics and are simply in Valley to do their jobs.

The protesters alleged that for over a decade, the BJP government has failed to rehabilitate the Kashmiri Pandits who left the Valley after eruption of militancy in early 90s. He said it was the responsibility of the deputy commissioner to at least inform the family as his employee was killed inside his office chamber in broad-daylight. If a person is shot inside his office, nobody

If a person is shot inside his office, nobody is safe in the valley when such a thing has happened it is a glaring example of the government's failure. Those serving (among the Kashmiri Pandits) there are doing it at their own risk as the government has failed to provide security to them, he said.

A relative of Bhat broke down before the media. They have taken our children for dying there and not for jobs.

Bhat is survived by his parents, wife and a minor daughter. His wife and daughter were putting up with him at Sheikhpora migrant colony in Budgam district.

Rakesh Koul, the BJP municipal councilor in south Kashmir's Mattan, said the selective killings by militants is a cause for concern for the whole community, especially those who are serving in the valley.

We have risked our lives and returned to Kashmir with a hope to rebuild a connection with our roots, he said, as he tried to console the bereaved family members.

Bhat's neighbours said he was a thorough gentleman and the news of his killing came as a shock for them.

Ukraine Returns To Football Field With Friendly Win In Germany
