

Policeman Shot Dead In Pulwama

SRINAGAR: A policeman was shot dead by militants at his residence in Gudoora area of Pulwama district of South Kashmir on Friday, an official said.

Around 8:20 am Friday, Constable Reyaz Ahmad Thoker was fired upon by the militants inside his residence in Gudoora area of the district, a police spokesperson said.

Thoker, he said, received critical gunshot injuries in the militant attack and was evacuated to the district hospital, Pulwama for treatment

However, from there, the injured cop was rushed to the Army's 92 base hospital in Srinagar, where he succumbed.

Soon after the attack, police,

army and CRPF reached the village and launched a search operation to nab the attackers. Senior police officers also rushed to the spot to take firsthand account of the situation.

"Police has registered a case in this regard under relevant sections of law. Investigation is in progress and officers continue to work to establish the full circumstances of this terror crime," the spokesperson said.

He said to pay honor and respect to the slain Constable, a wreath laying ceremony was held at District Police Lines, Pulwama.

This is the second attack by militants within 24 hours.

Govt Sacks KU Proffesor, Policeman For 'Terror Links'

SRINAGAR: Jammu and Kashmir administration on Friday sacked three government employees, including a professor and a policeman, for their alleged links with militant groups, officials said.

The trio was terminated from services based on the recommendation of a designated committee constituted under Article 311 (2) (c) of the Constitution that allows dismissal from service without an inquiry in the interest of the State's security.

Those sacked are Altaf Hussain Pandit, chemistry professor at Kashmir University, Mohammed Maqbool Hajam,

tion department, and Ghulam Rasool, a constable with the Jammu and Kashmir Police.

"Altaf Hussain Pandit is actively associated with the proscribed Jamaat-e-Islam (JeI). He had crossed over to Pakistan for terror training and remained an active militant of the Jammu Kashmir Liberation Front for three years before his arrest by the security forces, sometime in 1993.'

He continued to be an active cadre of JeI and worked as a mili-

tant recruiter. Pandit was instrumental in organising stone pelting and violent protests over the killing of militants in 2011 and 2014, the officials said. More on P6

'TERROR FUNDING' CASE

NEW DELHI: The National Investigation Agency (NIA) on Friday filed a charge sheet against seven people, including its former officer Arvind Digvijay Negi and Kashmiri human rights activist Khurram Parvez, in a militant funding case.

The charge sheet was filed in a special NIA court in New Delhi against former Superintendent of Police Negi, Parvez, Muneer Ahmad Kataria and Arshid Ahmad Tonch of north Kashmir, Zaffar Abbas of Bihar, and and Rambhawan Prasad Chandan Mahato of West Bengal under relevant laws, a

Negi was arrested in February this year and Parvez in November last year in connection with a case related to a conspiracy hatched by the Pakistan-based Lashkar-e-Taiba (LeT) to fund and recruit operatives and over-ground workers (OGWs) for providing support in planning and execution of militant activities in various parts of the country,

Diabetes Almost Doubles Risk Of Death From Covid-19: Study

People with diabetes were almost twice as likely to die with Covid-19 and nearly three times as likely to be critically or severely ill compared to those without the disease, according to a study.

The researchers from the University of Aberdeen in the UK reviewed data from hundreds of thousands of people from all over the world, and found that good management of disease can mitigate the risks.

The team, including researchers from King's College, London, found that while diabetes presents a significant risk of severe illness and death with Covid-19, good control of blood sugar in these patients can significantly reduce this risk.

The researchers reviewed findings from 158 studies that included more than 270,000 participants from all over the world to determine how Covid-19 affects people living with diabetes.

The pooled results showed that people with diabetes were 1.87 times more likely to die withCovid-19, and 1.59 times more likely to be admitted to ICU, according to the researchers.

They were also 1.44 times more likely to require ventilation, and 2.88 times more likely to be classed as severe or critical, when compared to patients without diabetes, they said.

The study, published in the journal Endocrinology, Diabetes and Metabolism, looked at the risks



of Covid-19 in patients with diabetes while factoring in the patients' location and thereby highlighting potential healthcare resources available as well as possible ethnic differences and other societal factors.

Data was gathered from all over the world including China, Korea, US, Europe and the Middle East. The researchers found that patients in China, Korea and the Middle East were at higher risk of death than those from EU countries or the US.

They suggest this may be due to differences in healthcare systems

and affordability of healthcare which may explain the finding that maintaining optimal glycae-mic control, significantly reduces adverse outcomes in patients with diabetes andCovid-19.

"We found that following aCovid-19 infection, the risk of death for patients with diabetes was significantly increased in comparison to patients without dia-betes," Stavroula Kastora, who worked on the study, explained. "Equally, collective data from studies around the globe suggested that patients with diabetes had a significantly higher risk

of requiring an intensive care admission and supplementary oxygen or being admitted in a critical condition in comparison to patients without diabetes," said Kastora.

However, the researchers, including Professors Mirela Delibegovic and Phyo Myint, found that the studies that reported patient data from the EU or US displayed less extreme differences between the

patient groups.
"Ultimately, we have identified a disparity inCovid-19 outcomes between the eastern and western world. We also show that good

glycaemic control may be a protective factor in view of Covid-19 related deaths," said Kastora. "In light of the ongoing pandemic, strengthening outpatient diabetes clinics, ensuring consistent follow up of patients with diabetes and optimising their glycaemic control could significantly increase the chances of survival following aCovid-19 infection,

the researcher added.

Private Schools Association Decries New Govt Order

Srinagar: Private Schools Association of Jammu and Kashmir (PSAJK) has expressed its anguish over a series of new government orders issued by the government recently.

The Association said that there seems to be some kind of ploy to demolish all small and big private schools in Kashmir. "Be it transport issues, order to get NOCs, retrieval of land order which has affected 100's of community schools, everything is being used to crush private schools. Now the latest government notification S.O 233 dated 10th May, 2022 is aimed to target new schools with futuristic vision who have invested huge money in different districts to give quality education to students," said a spokesperson of PSAJK.

The Association said that the latest notification issued by the government has disempowered all private schools and entrusted the Fee Fixation and Regulation Committee (FFRC) with sweeping powers to determine fees for every school and impose heavy penalties. "This is a bizarre order. Schools are providing services and people who do not have an idea of accounts and finance have been given powers to determine how much they can charge. Every school is different with different sets of facilities, teaching aids, logistics, skilled manpower etc. Fee is a major incentive to upgrade facilities for a school and enhance quality of education. When fee fixing power is snatched from schools, then why will a school invest and upgrade its facilities," said G N Var president PSAJK.

Srinagar: A 21-year-old girl from come a lawyer, has made her name as a Mehandi artist and at times provides free of cost services to the people, who cannot afford to pay hefty sums, aiming to assist the poor in need.

Sheema Lateef, who hails from Soiteng locality of Nowgam in the outskirts of Srinagar city, is pursuing her Bachelor's degree in Law from Vitasta School of Law and Humanities in Srinagar and at the same time she is also pursuing her hobby of being one of youngest and certified Mehandi artist in the Kashmir Valley.

Originally hailing from Khayam locality of Srinagar, Sheema wants to work for the welfare of the people both as a lawyer and a Mehandi artist.

"Being a lawyer and a Mehandi artist, I want to work for the welfare of the people. Nowadays artists, be it makeup artists or Mehandi artists, charge hefty amounts, which sometimes people cannot afford. So keeping that in mind, I have

kept a cap at Rs 2500 for every person and for those who cannot afford even this amount, I offer the services free of cost Sheema said.

Being a self-taught article, Covid-19 lockdown helped her hone her skills in this art and she would offer services to the people during lockdown at her home.

She said that she had created an Instagram page and she would get bookings through this and people would come to her home.

"During lockdown people would come to my home. Since I knew this art from the beginning, it was not difficult for me to learn more about it. But I had to fight a lot of stereotypes as people would sometimes look down upon artists like us as people think we belong to lower

class families," she said. She said that a lot of people gave up on their professions of being Mehandi or makeup artists as people would often mistreat them, forcing them to give up.

"But I overcame such stereotypes and moved on with my hobby as well as my profession. I am pursuing law and I am currently doing an internship at District court Srinagar as I am in 5th semester of my course. At the same time I am pursuing my hobby of being one of the youngest Mehandi artists in the Kashmir Valley" she said.

Though, field of law was not Sheema's choice, she ended in this profession after opting out of Robotics course at IIT Delhi. where she had secured 2nd position in the entire Kashmir

She said that even though this course was a fully-funded scholarship by the government, she still ended up being an aspiring lawyer as this was written in her destiny.

"Being a lawyer was by chance and not by choice as I had not thought about this profession, but destiny had something else in store for me. But while pursuing law I learnt about working for the welfare of the people and this is what motivated me to take up the hobby of being a Mehandi artist. As through this I also want to work for the welfare of the people," she said.

RINAGAR- The police has arrested two persons and is looking for another five for branding two married women with red-hot iron rods in a village on the outskirts of Kokernag. Some people in the Dardyu village of the Larnu area in

Kokernag yesterday accused two local women, Mubeena Akhtar and Meema, of having an illicit relationship with one Riyaz Ahmad Paddar, a youth living in the neighbourhood.

The villagers caught the three accused and awarded punishment to the two women on their own.

According to, the police, the villagers took the law into their own hands and shaved the heads of the two women, and later branded their bodies with reds-hot irons. The women were stripped by their accusers, reports said.

The area is seething with anger at the incident. The women lodged a case with the Kokernag police, who arrested two persons, Syed Javed Ahmad Shah and Muhammad

Ashraf Shah for causing injury, to the women. A hunt has been launched for five more villagers identified as Syed Arshad Ahmad, Syed Nisar, Naseeb Ahmad, Basheer Ahmad and Manzoor Ahmad. Raids were conducted at several places to nab the suspects whose arrest has been demanded by the people of the area



Cluttered Academy

he cultural academy's unseemly haste to shoo prominent Kashmiris into their graves shows how keen the undertakers of this region's art culture and languages are to preside over the funeral of its heritage.

Even in this ghoulish enterprise, the academy cannot avoid the overarching element of farce which many believe has become its hallmark.

One could take a charitable view of the whole unsavoury episode and attribute the academy's death notice of the editor-in-chief of the Srinagar Times, Sofi Ghulam Muhammad, to a genuine mistake, but to compound it by seeking to make amends by announcing the demise of another well known Sofi when that gentleman, too, was still with this world is incomprehensible. The academy did not even have the grace to go red in the face at this dual faux pas, but resorted to the stock official response of "inconvenience is regretted," as if it had erred in notifying the price of mutton and poultry.

The academy seemed to have no appreciation of what it means to lose the founding chief editor of one of the oldest surviving newspapers of Kashmir, or a musical legend like Ghulam Hassan Sofi, both of whom have had deep associations with the institution. Apparently, the academy is so overloaded with literary and cultural geniuses that it can't tell one from the other. One Sofi can do as well as another. The learned bosses of the academy could not even manage a decent blographical sketch of either of the victims of its necro-predilection, leave alone a graceful obituary worthy of the contributions of the supposedly departed subjects. What it eventually coaxed out of itself after a disingenuous condolence meeting of its babus in Jammu after Ghulam Hassan Sofi actually passed away was an atrocity on the soul of that gentle singer. Shot through with grammatical errors bordering on the obscene, the grudging press release was a rehash of news reports of the previous day. Evidently, the pillars of erudition in charge of the academy have such a low opinion of others that they deem it beneath themselves to monitor what the institution brings out about people who have made some mark in public life. Or else, the academy has become a den of incompetence and mediocrity exemplified by its atrociously drafted handouts, which, by the way, the press has been generously silent about.

That such travesty finds its way out of the academy unchecked is a scandal by itself for which big heads should roll, as the picture presented of the guardians of the state's art, culture and languages is one of unconscionable ineptitude. And greater still is the scandal of such undeserving elements finding a place in an institution requiring at least a nodding acquaintance with the

nuances of language. The fiasco does nothing to instill confidence that the institution as currently run is qualified to do justice to the creative and literary talents in Kashmir or be a genuine platform for genuine talent to surface and flower. Rather, the cosmetic theatrics the academy sponsors in the name of native culture are a death knell for whatever survives of Kashmir's unique ethos. Successive governments have done pitiful little in making the academy a true repository of native genius, often foisting people with dubious qualifications and credentials on this highly sensitive institution. More often than not, the academy and its exalted positions have become a means of dispensing favours to politically convenient elements or rewarding people useful in advancing some nefarious agenda. One such strand in this sneaky design is the pathetic state of the Kashmiri language, spoken in most of the state. The academy could have been a patron for the promotion of this language, if only it could disentangle itself from the shackles of bias and sycophancy.

Domestic Violence in Kashmir is Deadlier than Ever, What is the Way Ahead?

heart-wrenching image of an injured Muslim married woman, Zahida Bano, Lying in a hospital was being circulated on social media reportedly after getting beaten up by in-laws at Baramulla just a day after Eid. The 28 years newly married woman soon died and was buried along with her hopes, dreams, and pangs. In her death, Kashmiri men and women saw an avoidable murder, a criminal offence. Though the headlines continued using the term 'Domestic Violence' for the offence. the unwritten part said her in-laws were not among us, they were not humans at all and deserved punishment, probably not for domestic violence-a symptomatic of the more general oppression on women in a patriarchal society, but the murder. This anger is not new, nor such bruised images of victims of domestic violence. Though all forms of violence against women is a global phenomenon, the surge in domestic violence cases in Kashmir, has emerged as a grave issue for women in last 15 years. The anger of the common masses translates into protests only when they hear about the death of domestic violence victims- 'officially recognised' crimes against women.

Lately, a women-only, private Facebook group called @Yakjut Kashmiri Ladies has been instrumental in creating spaces fairly comparable with consciousnessraising groups of second wave feminism. Within this group, women from different backgrounds discuss their domesticity issues. child-raising issues, dealing with abusive relationships, work experiences, etc. violence in the conjugal homes abuses in Kashmir is reflected in most of the discussions and debates on this page regularly, which appears to have only revived in recent years. The stories reveal that an important part of the power relationship between spouses and their families is related mainly to dowry related issues and older gender order. Surprisingly domestic violence is not a priority area of research in Kashmir among the major disciplines. We hardly know about the violence within the familv, there is no information about the nature and kind of violence that is perpetrated against women in Kashmir within the family or community. We know almost nothing about the structural patterns of violence that are culturally specific. Even though features like, wife-beating, economic abuse, and psychological abuse are some recognized sub-themes under domestic violence in academic circles; it hardly translates into the 'collective anger' or 'collective shame' enabling resistance to patriarchy. What I figured out while working as a women's studies scholar in Kashmir is that patriarchy is never seen as a potential source of oppres-

sion for women in Kashmir. While patriarchy may not be the overarching cause of all abuse, it is an enormously significant factor, because in traditional patriarchy males have a disproportionate share of power. Many abusive men, in order to maintain their fragile sense of masculinity, use physical force to keep their wives in their proper place. However, Kashmir has seen the emergence of a 'new patriarchy' to control women in public as well as in private domains. Gender violence in

overarching cause of all abuse, it is an enormously significant factor, because in traditional patriarchy males have a disproportionate share of power. Many abusive men, in order to maintain their fragile sense of masculinity, use physical force to keep their wives in their proper place

Kashmir has a social context that is informed by shifts in perceptions of gender identities, and the role of women in marking/ preserving community honor. It is also tied to the shifts in the organization of the family and household, for the tensions that emerge in the outside, public/ political spaces create new anxieties, leading to a renewed assertion of masculine authority in the spaces of the household. The unprotected social and political environment has turned women vulnerable to violence from their own

Why don't women speak up? Even though the images of women are changing and apparently, she is as never before, represented as more active with ideas and purposes of her own and women seem to have become more individualized in the age of economic specializations and social media outlets. It is annoying for them to bear violence and discrimination on a daily basis due to the misuse of social and cultural values and religious norms in the Kashmiri society. The irony is that this violence is a highly stigmatized issue as society often blames women for the violence that they experience. This form of violence is so regular and normalized in our society that the majority of women consider it a 'normal' act. Clearly then, married women have more reasons to remain silent on issues of violence till the matters get worse. While we have a lot of legal measures assuring an escape from domestic violence under various law enactments such as Domestic Violence Acts 2005 and Section 498A etc, a growing consensus is being formed that women mostly misuse these provisions and frame false charges against their in-laws. While there is no denying the fact that a negligible number of such cases were proved false, the blame is not entirely on women. It is mostly the male law-

agreeable that domestic violence is experienced by both men and women, and no one deserves domestic abuse irrespective of their gender. Yet women and men are differently vulnerable to domestic violence. Men's violence and coercive control is linked to wider social norms and messages that support men's control over their female partner. No such social acceptability is granted for such behaviour in women. There are social norms that continue to grant male entitlement, that grant men control over female behaviour, masculinity is linked to the legitimate use of violence, whereas violence is not legitimized by femininity. Domestic violence is the leading cause of death and injury for married women. Clearly then physical violence, as well as other forms of aggression is used as a method to ensure obedience from women. Unsurprisingly, an overwhelming majority of women who experience physical or emotional abuse in conjugal relationships do not report it to the police. While men retain their primary relations (mother, father, sisters and brothers) after their marriage, women usually become the 'other' while taking up the new roles and attempting to embrace the family of their husbands as their own Unsurprisingly owing to the social stigmatization the victims are sensitive to the judgment they fear from others, whether they are suffering domestic violence. Sometimes women have difficulties in revealing embarrassing and humiliating details and might choose to remain silent. A domestic violence victim may stay silent because of various other situational factors. However, when they speak up, their vulnerability increases most often. Women often lack a support system that could sustain them financially and emotionally both in times of crisis in relationships, consequently, they are at the receiving end. Another major factor is that women are threatened that children will be taken away from them if they think of isolation from the abusive husband. The economic dependence of women on their abusive husbands and in-laws also prevent women from accessing legal redress. As we go more into the issue of domestic violence-it turns more and more complex than it is perceived generally. Despite the fact that domestic violence cannot be seen as an issue of gender only, it is an important analytic category in understanding the domestic violence against women. Other identity markers like religion, class, caste also play a vital role in determining how the victims of domestic violence will be treated. Likewise, illiteracy and poverty also serve to restrict the access of victims of domestic violence to legal remedies.

The irony is that this violence is a highly stigmatized issue as society often blames women for the violence that they experience. This form of violence is so regular and normalized in our society that the majority of women consider it a 'normal' act

support systems legally available for women such as police and judiciary are less likely to approach them for redress, because of their inherent violent natures experienced by the common masses. In addition to this an atmosphere of global Islamophobia also prevents the members of the community at large to accept the fact that issues such as domestic

violence exist in our society. As a community, we need to build strong indigenous spaces to support the marginal sections, especially women. Combating domestic violence requires us to collectively promote structural changes. We need to challenge social norms surrounding domestic violence through properly organizing ourselves not against the individuals but against the system of patriarchal oppression that normalizes humiliating women on a daily basis which eventually results in heightened violence in the later phases. There is a dire need of feminist organizations that are capable of collaborating with other forms of organizations fighting different kinds of oppressions in the valley. Once women have a reliable and understanding support system and they are able to confide their grievances without the fear of being judged, women will definitely speak up. She will be strong enough to leave the abuser and prioritize her own life and happiness which she

Covid **Pallbearers** of Scanty Funerals

Excerpts from ' To Hell and Back: Humans of Covid' by Barkha Dutt published by Juggernaut Books (2022)

'I am more scared of the living than the dead. The bodies – before they are Hindu or Muslim – they are human.' At any other time, this would have been a truism, a selfevident do-gooder statement that may have even been overlooked for its obvious good manners. But Indian public discourse had already been coarsened by a communal, poisonous conversation around the role of the Tablighi Jamaat, an orthodox Sunni sect, as a super-spreader. The proselytizing organization, which urged believers to return to Islam as practised in the age of the Prophet, was spread across eighty countries with its markaz or centre in Delhi. In early March 2020, roughly ten days before India was offi cially locked down, a religious congregation was organized in the capital's Nizamuddin area, a Muslim-dominated neighbourhood made up of untidy, byzantine lanes where

fourteenth-century domes built from red sandstone and inlaid marble shared space with overcrowded slums, pavement dwellers and child beggars. An advisory from the Delhi government had warned against gatherings of more than 200 people but did not specifically ban religious events. Hundreds of foreigners had also entered India from COVID hotspots like Indonesia and Malaysia to attend the congregation held between 13 and 15 March. A few thousand pilgrims attended the event. Thereafter, the oblivious Tablighis fanned out in diff erent directions of India, carrying the virus with them. pilgrimages when the lockdown was announced by the prime minister – Sikhs at the gurudwara in Nanded in Maharashtra, Hindus at Vaishno Devi in Jammu - but the language used for them in mainstream media was very diff erent. When they were brought back to their states, it was a homecoming. By contrast, multiple headlines spoke of the Tablighis as having been 'hiding' in mosques across the country.

The pandemic reinforced prejudices, both obvious and latent. It did so not just in India, where differences of class, gender and religion were magnified in an almost macabre, bare-boned way; but also in societies globally, including America, where Trump's characterization of the virus as 'Chinese' led to a spate of attacks on Asian Americans.

In Îndia, paradoxically, in a Dickensian besting and worsening of times, the breakdown of social and community structures ran parallel to extraordinary displays of

courage and compassion. And nowhere was this more evident than in the stories of those who stepped up to be the pall-bearers of COVID. It was a job no one else was ready to do...The COVID pallbearers -Hindu, Muslim, Sikh and Christian – were the handymen tasked to repair and reassemble the broken bits of our humanity. Nearly all were poor or of modest means. Many had spent years at the very bottom of the caste or economic ladder, socially discriminated against, even though it is in their hands that we place the bodies of those who have our hearts. They are the gravediggers, the body washers, the corpse burners and the furnace cleaners, the conduit between the end of this life and whatever lies on the other side.

s a culture, we often fetishize the debut writer as some sort of self-arising wunderkind, someone that comes "out of nowhere" or had "splashed onto the scene" unannounced, seemingly without a pre-history or predecessors. This is compounded for writers of color, who seem, according to this narrative, to arrive at the literary table by "transcending" their ultural economic or racial milieu into the hegemonic literati. I want to take a moment, in light of this, to put some shine on 10 books that made my debut, On Earth We're Briefly Gorgeous, possible.

Some of these texts (in no particular order) are canonical, some are not—but they each had an idiosyncratic force on my education as a writer and informed and enriched On Earth We're Briefly Gorgeous, and in particular, supported the novel's metaphor-rich approach. The metaphor, heavily used in the 19th century as a means toward the ecstatic sublime, became more passé after the World Wars, when the pastoral dream was no longer feasible amidst European fields rotting with cattle corpses. I wanted to use the metaphor differently, on terms removed from a Eurocentric worldview.

Vietnamese refugees, for example, use metaphor as a coping mechanism; metaphor provides a way to talk about trauma without stating the experience outright. An abortion is described as having "papaya seeds scraped out of you," or sexual assault as having "the doorway of your body broken into." To die is to" get on the road." Likewise, when Abel Meeropol wrote the poem "Strange Fruit" about the lynching of African Americans in the South, he was not reaching for the Romantic sublime—but to render the horrific via an alternative speech act. The metaphor in the mouths of survivors became a way to innovate around pain.

These texts also helped in formulating the novel's shape. Using Kishōtenketsu, a narrative structure used in Chinese poetry, then later developed in Japanese storytelling, I was able to write about American violence without it becoming vital to the novel's arc. It was important to me, at least in this book, that violence remain independent from any character's self-worth, rendering it inert, terrible, and felt—but not a means of "development." Through Kishōtenketsu, violence becomes fact and not a vehicle towards a climax. Having been a student mainly of Western literature, it became clear to me that the most perennial protagonist is not necessarily the main character, but conflictdriven plot. In Western narratology, the plot is the dominant mode to which all characters are subordinate. But I wanted a novel to hold these characters thoroughly and, most importantly, on their own terms, free from a system of governance, even one of my own making. I could not employ the plotheavy strategy because I needed these people to exist as they are, full of stories but not for a story.

The truth is no writer comes "out of nowhere" and wunderkinds are only as real as our aversion to a more sobering—albeit less glamorous—reality: that a writer's growth is often a slog, the slow burn of reading and trying and failing when, finally, by some luck or mercy, the book you're reading turns into a torch in your hands. And with it you make a sentence so new and exacting to your desire that it startles you into a new vision,

I Needed to Write My Novel elders before you, both here and gone and some

nearly forgotten but never lost. These authors and their books found me. They helped realize my thinking. Hopefully they will do the same, however large or small, for you.

Theresa Hak Kyung Cha, Dictee

This book is one of the most radical approaches to the novel that I've read, one where time-honored narrative decrees for cohesion, fluidity, character development, plot and arc, are refused in order to privilege a necessary, orchestrated sense of disorientation as a method of enacting displacement, trauma, and national and private grief. The novel gave me courage to stop seeing historical trauma as something that has to be refurbished in order to achieve "fine art," and more so that fracture, even incomprehensibility, can be a powerful conscious mode of storytelling, one that interrogates colonialist gauges of successful art-making without forsaking its central thrust: to tend and hold close the bodies expelled by canonical narratives.

Because Cha was also a visual artist, the book can be read as an exhibit, both in the curatorial sense (images and calligraphy often interrupt the text) as well as a judicial one-where documents and family albums are scanned as evidence of

Toni Morrison, Beloved

There is not more I can say about Beloved that has not been said much more concisely and eloquently. When I first came to the book, I discovered something I did not expect coming in: that, along with the myriad things that Beloved is and does, it is also a refugee narrative. The novel positions survival as an act of creation, particularly how mothers who witnessed a generation of a horrific trauma acquire the power of protection through love-even if it means committing the ultimate act of rescue: death. It is a treatise wherein literary violence can—and is at times obligated to-match that of history, that nothing is "too much" or "indulgent" if it is true. I saw in Morrison's characters the thinking and innovation of women in my family. Although Morrison's characters inhabit a completely different historical sequence, incomparable to anything else, the novel taught me to see Vietnamese refugees as survivors with agency, like Sethe, who must now furnish a future within incomprehensible aftermaths. It gave me the confidence and determination to see Vietnamese American life as worthy and exceedingly beautiful in the project of literature.

Anne Carson, Autobiography of Red

This hybrid book (a novel in verse) taught me what can happen when a fictive story is contextualized through other texts, where it can collabo-

also gaining its own life. In Carson's case, it was the recasting and expansion of the classical myth of Geryon. But what's more, it uses Geryon's anecdotal life in a larger male-dominated narrative as an epicenter, thereby decentralizing the Greek original into Carson's contemporary vision of rural queer life, the isolation of art making and the

patriarchal system But perhaps what's most inspiring to me about this book is Carson's refusal to enact her protagonist's development via a false and forced inhabitation of heteronormative ideals. Gevron, a quiet, small, artistic mama's boy, does not become a masculinist hero in order to "solve" his outcast position. Instead, he bravely embodies his otherness, or "monstrosity," as Carson writes, through emotionally-informed aesthetic vision. It's a book that insists on the necessity of alterity as agency instead of succumbing to the readily assimilative.

Herman Melville, Moby-Dick I have always felt that Melville was the writer who enacted Whitman's decree for American multiplicity in ways far richer and complex than Whitman did himself. A book that simply refuses to compromise, that employs the autobiographical gaze to suggest radical modes of queerness, polytheism as progressive self-knowledge, expansive meditations on whiteness, both in regards to the whale's purity and to race, Moby-Dick forges the allegory of the hunt as a doomed American quest for self-knowledge. Reading it, I thought, What would happen if a queer Asian American decided, in Melville's vein, to also not compromise? What would happen if all modes of voices, themes, were potent in equal measure within the novel's

temporal investigation? Because I knew I did not want to write a 600page tome, the epistolary mode allowed me the quick detours and returns, while still retaining the vital urgency and vulnerability of a direct address. In this way, the voice, the letter itself, became the main plot, the digressions in memory, cultural investigations, and vignettes its tributaries. And the whale, ever fleeting, out of reach, and finally impossible, is the mother's readership of the letter.

A truly innovative book that centralizes oscillation and destabilization as a mode of inquiry and storytelling. Moving through multiple points of view, voices and non-linear time, thúy builds a narrative that feels, at times, more like landscape art than writing—all to a tremendous embodied effect. This book was so important to my education as a novelist because it shows how easily writers of color can be relegated incomprehensible if they choose to enlist unconventional, noncanonical models to work from.

thúy not only breaks the rules of traditional Western narrative; she insists that such rules can be consciously rejected because their rubrics were made without considering the bodies her book holds—even at this risk of rendering it, in the eyes of critics trained to recognize and celebrate hegemonic styles, as nonsensical or wrong. The result is a bold and empowering refusal of conformity in search of other ways of speaking and being.

Virginia Woolf, To the Lighthouse

This book still feels anachronistically bold in its total recalibration of conventional plot-making as a means of privileging characters, people and ideas over "story," all of it a treatise for a woman's interior life as a central motif for fiction. It's subtly subversive but also starkly innovative in action—or inaction (the entire narrative can be summed up—with a touch of, but not much, hyperbole—as five people crossing a lawn while a woman tries to finish her painting). What's so illuminating to me is Woolf's insistence on the extended metaphor (near Homeric at times) as a means of destabilizing the temporal function of plot. What is real when the metaphor becomes just as felt, if not more so, than the narrated life,

when it becomes a portal? And Woolf did this at a time where overly metaphorical writing, a style that once represented the pinnacle of masculine achievement in the 19th century (James, Melville, Dickens, Whitman), was feminized via epithets like purple, florid, flowery, and unrestrained so to be rendered defunct or passé. In other words, a set of tools can be considered useless only once it has been retroactively prescribed to women. Using that "florid" style in a novel that negotiates a woman's inner life within the restrictions of patriarchy while also erroman—an artist novel. In Baldwin's hands, Go laying bare the arbitrary gendering of style, was and is incredibly radical to me.

David Wojnarowicz, Close to the Knives: Memoir of Disintegration

If a personal queer bible could be such a thing, this would be mine. The potent beauty in this col-

lection of essays is evident in its wide swath of styles and range of diction and modes. Wojnarowicz oscillates between essayistic rages against the Reagan administration to deeply lyrical mediations on queer loneliness, illness, artmaking and the mourning of lovers and friends lost to the

AIDS epidemic. It feels at times as if Wojnarowicz's sentences are attempts at laying ground within a community disintegrating before his eyes and voice. What tire life is a testament to queer innovation and survival—but also the residue of a boy's coming of age in broken homes in New Jersey to an equally blighted yet life-savingly vibrant New York. This book shines as one of the most vital prehistories of how queer art is possible today and its impact is still felt all around you, even if you've never read it. I will forever be indebted, not only to this book but also David's life and work

Scott McClanahan, Crapalachia: A Biography of Place

Scott McClanahan is one of those rare writers who achieves Kafka's credo that a book should be the axe that shatters the icv soul of our interior. Crapalachia, with its tongue-in-cheek title, is anything but refuse and detritus. In fact, it's a broken and half-sung ode to place and people and history, a personal reclamation of falsehoods cast on rural communities in West Virginia. It shows that just because the place you live in has been written about by others ad infinitum, does not mean it was written with you or your folks in mind. This book gave me the courage and power to write about Hartford, a city both haunted and adored by the specters of literary giants like Wallace Steven, Mark Twain, and Harriet Beecher Stowe.

But what's most indelible about this book is its commitment to wonder and awe. It looks at a region that is deemed blighted beyond repair by outsiders and insists that the sublime, under the writer's honest and unflinching gaze, is made as true and palpable within the text as it is for those who live, dance, and die there.

Jenny Offill, Dept of Speculation A modern testament to the power of the vi-

gnette as a narrative strategy. This book collapses Sherwood Anderson's story cycle novel into Marguerite Duras's elliptical, episodic style to fashion something entirely its own. What ensues is a refreshed demand for the reader to participate in the novel's arc, each gap, like stanza breaks in a poem, both asks and allows us to feel the emotional pressures made resonant through associative leaps. This strategy is incredibly difficult to pull off as it demands charged and complicated emotive renderings to carry into white space without thorough bridges and narrative connections.

In other words, it operates using a continuous stream of thematic ricochets that compound as the vignettes increase. It takes a master to wield a book like this without it disintegrating into arbitrary "entries." As such, reading it is a masterclass in the power and ramification of space and distance. An inexhaustible classic.

2 Militants Killed

Aragam area of Bandipora following inputs about the presence of militants there, a police official said.

He said the search operation turned into an encounter after the hiding militants fired upon government forces personnel, who retaliated.

In the ensuing exchange of fire, two militants were killed, he said. The official said the identi-

ty of the slain militants was being ascertained. Earlier in the day, Inspector General of Police (IGP) of Kashmir Vijay Kumar said the two militants trapped in Brar were Pakistani and belonged to the

"They had infiltrated into Jammu and Kashmir recently. They had managed to escape during an encounter in the Salinder forest area on Wednesday, he said.

The militants were tracked down and trapped in Brar in Bandipora on Friday, the IGP

However, in a statement issued late Friday night, police claimed that the two Pakistani militants Faisal alias Sikander alias Mohsin and Ukasha were behind the killing of a Kashmiri Pandit government employee in his office in Budgam a day ago.

The duo came under the scanner of the security forces during tracking of a local LeT militant, named Lateef Rather alias Osama, who was involved in militancy incidents in Srinagar and Budgam in the last two months, the police spokesman said.

A week ago, the movement of Rather was confirmed in the Salindar area of Bandipora where he had gone to receive a fresh group of LeT militants who had infiltrated into the union territory, the spokesman said.

He said that the presence/movement of these militants was confirmed and shared with the Bandipora police. Accordingly, an operation was launched on May 11 resulting in the elimination of a local militant, identified as Gulzar Ahmed Ganaie of district Baramulla.

However, the two Pakistani militants managed to escape from the spot. A police team kept following their footprints and their presence was confirmed technically in the Chadoora area of Budgam where the Kashmiri Pandit government employee was killed on Thursday.

Thereafter, the spokesman said, their footprints were again confirmed in Brar and accordingly the operation was launched on Friday, resulting in their killing.

A hunt was underway for Rather alias Osama, the spokesman said. (PTI)

They were requested to disperse but they refused to budge and insisted on marching ahead, following which the police used batons and fired some tear smoke shells, the officials said.

There are no reports of any casualty, they Bhat (35), a Kashmiri Pandit employee. was

shot dead by militants inside his office in the Chadoora area of Budgam on Thursday.

In a statement issued here on Friday evening, a police spokesperson said that a few tear smoke shells were fired to disperse the protesters as inputs suggested militants might attack them in order to create communal clash and tension.

He said the community members protesting Bhat's killing since Thursday afternoon at Sheikhpora, Budgam, started moving towards the airport road around 11:00 am on Friday.

"Although the magistrate repeatedly requested & tried to pacify the protesters not to proceed towards the very busy & over crowded Airport road, however, protesters while ignoring such persuasions and repeated requests from the administration, kept on moving towards the said road while forcibly breaking all the physical barriers en-route and pushing the police & Security Forces who were peacefully trying to persuade/stop them from moving

The protesters, he said, who were adamant to block the Airport road however did not pay any heed and instead managed to travel a distance of about one kilometre from Sheikhpora.

"Given the topography of the area and huge rush at the Airport road there were inputs that terrorists may take advantage of the same and may attack the protesters in order to create communal clash/tension," the spokesperson said.

"Therefore in view of this, while sensing the security of the protesters who had resorted to violence and neglected the pacification requests by administration and to thwart evil designs of ANEs, police were constrained to finally hurl few teargas smokes to disperse them," he added.

However, the spokesperson said that the protesters again re-assembled at Sheikhpora road

and sat on protest & blocked the main road. "Later on all of them went back to their

home," he added. The community has been protesting since Thursday against the "failure" of the government to protect their lives.

PDP president Mehbooba Mufti, meanwhile, claimed that she has been placed under house arrest to stop her from visiting Budgam to express

solidarity with the protesting Kashmiri Pandits. In a tweet, Mufti said she was put under house arrest as the BJP did not want Kashmiri Muslims and Pandits to empathise with each other's pain.

"Wanted to visit Budgam to express my solidarity with Kashmiri Pandits protesting against GOIs failure to protect them. Have been put under house arrest as the fact that Kashmiri Muslims and Pandits empathise with each other's pain doesn't fit into their vicious communal narrative," the PDP chief said.

Police officials, however, refused to comment over Mufti's claim.

Later, in a video message, Mufti said the situation in Kashmir was getting from bad to worse. She also urged the majority community in the valley to stand by the minorities.

"While the central government is playing a game of pitting Hindus against Muslims to hide its failures and presenting them as the biggest enemies of each other, Jammu and Kashmir is the only state where Hindus, Muslims, Sikhs, Christians and Buddhists are living together as one," Mufti said.

"So, it is the duty of all people of Jammu and Kashmir to stand together with those who live among us -- be it Kashmiri Pandits or Sikh

brothers, like the way we had protected their lives and properties in 1947 when Gandhiji also had seen a ray of hope from Kashmir at that time," she added.

Mufti also urged the people to uphold Jammu and Kashmir's legacy of brotherhood and unity.

"We have to stand with our minorities, and so, I appeal all the people to strongly advocate Hindu-Muslim brotherhood across all the mosques on the occasion of Friday congregational prayers.

"We need to give a message to the whole country of J-K's brotherhood and its history that we are a secular state and a united people so that the government does not get a chance to defame Muslims," Mufti said.

National Conference (NC) vice-president Omar Abdullah said it was shameful that legitimate and justified protests are met with a heavy-handed response.

"This is not new for the people of Kashmir because when all the administration has is a hammer every problem resembles a nail. If the LG's Govt can't protect KPs they have a right to protest," he wrote on Twitter.

"Tourism is not normalcy, it's a barometer of economic activity. Normalcy is the absence of fear, the absence of terror, the inability of militants to strike at will, the presence of democratic rule & by any yardstick you choose to use, Kashmir is far from normal today," Abdullah said.

Condemning the killing of a policeman in Pulwama on Friday, the NC leader said targeted killings were continuing unabated in the valley.

"Rahul in his office yesterday, Riyaz Ahmad Thoker, a SPO with J&K police, in his own home today. Targeted killings continue unabated. I can't condemn this killing strongly enough. May Allah grant Riyaz a place in Jannat," he

Such people are sitting ducks for militants who are using them for target practice, he added.

Jammu and Kashmir BJP president Ravinder Raina and other party leaders, who attended the funeral, had to face the ire of the community members as they raised slogans against Prime Minister Narendra Modi, Jammu and Kashmir Lieutenant Governor Manoj Sinha and the saffron party.

The protesters also blocked a stretch of road. On Thursday, Rahul Bhat's father Bita Bhat had demanded a probe into the incident.

An inquiry should be ordered into the incident to identify all those who are involved in his cold-blooded murder, Bita Bhat said at his Durga Nagar residence.

"I was at a hospital accompanying my ailing brother when a family friend called from Kashmir and informed me about the incident. I tried to contact the deputy commissioner of Budgam and the concerned police officers but my calls went unanswered, the father told the mediapersons, trying to put up a brave face and hold up his emotions.

He said it was the responsibility of the deputy commissioner to at least inform the family as his employee was killed inside his office chamber in broad-daylight.

If a person is shot inside his office, nobody is safe in the valley when such a thing has happened it is a glaring example of the government's failure. Those serving (among the Kashmiri Pandits) there are doing it at their own risk as the government has failed to provide security to them, he said.

Population Not

He was responding to questions on criticism from certain quarters that going by the population ratio, Kashmir Division got a lesser number of seats as compared to Jammu.

"Population is only one of the criteria of the delimitation. Besides population, there are four other criteria as per provisions of the Delimitation Act and the Jammu and Kashmir Reorganisation Act which say that consideration will also have to be given to the physical conditions, and communication facilities, public conveniences and the administrative units of that area. So these are four other criteria that have to be looked into. It (population) is one of the important criteria but not the sole criteria. That one should keep in mind," Chandra told

Chandra, who demits the office of CEC on Saturday, said Jammu and Kashmir should be seen as one unit. "It cannot be (seen) in different parts. It is one single union territory. The whole population will have to be given representation in 90 constituencies. The (Kashmir) valley has been given less or Jammu (division) has been given less -- it is one whole unit comprising 20 districts and 207 tehsils. We will have to see it as one whole unit."

The Delimitation Commission on Jammu and Kashmir, formed in March 2020, notified its final report on May 5 giving six additional assembly seats to the Jammu region and one to Kashmir Valley and bringing areas of Rajouri and Poonch under the Anantnag parliamentary

Jammu Division will now have 43 assembly seats and Kashmir 47 in the 90-member house. The changes will come into effect from the

date to be notified by the central government. Earlier, the erstwhile assembly had 87 seats - 46 in Kashmir, 37 in Jammu 37 and four in Ladakh.

Ladakh, in the reorganisation of the erstwhile state, was declared as a union territory without an assembly. The population of Jammu Division is 53.72

lakh and Kashmir Division 68.83 lakh, according to the Census of 2011. Out of the 90 assembly constituencies, nine have been reserved for Scheduled Tribe -- six in

rected now. "There were only 12 districts when the earlier delimitation was done. Now there are 20 districts. Many constituencies were spread in more than one district. Many villages were spread into two or three constituencies. So these things will have to be rectified," he said.

The bench said that it is asking a specific question under Article 32 of the constitution why you have not challenged the formation of the commission itself and do you challenge the abrogation of Article 370 also.

The bench told the counsel, who was making objectionable submissions, to choose his words properly and said that Kashmir was always part of India and just a special provision was removed.

Solicitor General Tushar Mehta said that effectively the plea is two-fold and that delimitation can be conducted only by the Election Commission of India and not the delimitation commission

Mehta said that secondly, they have raised questions about the census.

The answer to the questions is in the reorganisation Act. There are two types of delimitations. One is geography which is conducted by the delimitation commission and the second is by election commission with regard to reservation of seats, he said.

Mehta said that the petitioners' case is that once Article 370 is gone, the census will only take place in 2026.

The bench then noted that the petitioners have not challenged the abrogation of Article 370 of the Constitution and therefore pleadings concerning Article 370 are to be ignored. It said that the challenge is about the delimi-

tation pursuant to the notifications of March 6, 2020, and March 3, 2021, and directed the Centre and ECI to file their replies. Counsel for the petitioners said that the government will place the delimitation order before Parliament and it further complicates the

The bench told the counsel that he wants the court to stop the government from tabling the paper before Parliament, If you were too anxious, then why didn't you take it up two years

It posted the matter for further hearing on August 30.

The plea sought declaration that the increase in the number of seats from 107 to 114 (including 24 seats in Pakistan controlled Kashmir) in Jammu & Kashmir is Ultra vires the Constitutional Provisions such as Articles 81, 82, 170, 330, and 332 and Statutory Provisions, particularly under Section 63 of the Jammu & Kashmir Reorganisation Act, 2019.

It said that while Article 170 of the Constitution of India provides that the next delimitation in the country will be taken up after 2026 then why has the Union Territory of Jammu and Kashmir been singled out?

The plea said that the last Delimitation Commission was set up on July 12, 2002, in the exercise of powers conferred by Section 3 of the Delimitation Act, 2002, after the 2001 Census to carry out the exercise throughout the country and the commission had issued guidelines and methodology for the Delimitation of Assembly and Parliamentary Constituencies vide letter dated July 5, 2004, along with the Constitutional and Legal Provisions.

It clearly stated that the total number of existing seats in the Legislative Assemblies of all states, including UTs of the National Capital Region and Pondicherry, as fixed based on the 1971 census shall remain unaltered till the first census to be taken after the year 2026, the plea settled by senior advocate Ravi Shankar handhyala said.

It sought to declare the notification dated March 6, 2020, constituting the delimitation commission to take up delimitation in the UT of J&K and states of Assam, Arunachal Pradesh, Manipur, and Nagaland by the Centre and consequential omission of Assam, Arunachal Pradesh, Manipur and Nagaland from the process of delimitation vide., notification dated March 3, 2021, and conducting delimitation only for Union Territory of Jammu & Kashmir is unconstitutional as it amounts to classification and violates Article 14.

On March 6, 2020, the Union Government, Ministry of Law and Justice (Legislative Department) had issued a notification in exercise of power under Section 3 of the Delimitation Act, 2002, constituting a Delimitation Commission, with former Supreme Court judge (Retd) Ranjana Prakash Desai as Chairperson, for the purpose of delimitation of Assembly and Parliamentary constituencies in the Union Territory of Jammu and Kashmir and the state of Assam, Arunachal Pradesh, Manipur, and Nagaland, for a period of one year.

Kashmiri Pandit Protesters Vent Anger At Admin, BJP Leaders

JAMMU: Protesting against the killing of Rahul Bhat by terrorists, members of his Kashmiri Pandit community members on Friday vented their anger at the J-K administration and BJP leaders, alleging they had failed to ensure their security in the valley.

BJP leaders had to face the ire of mourners at the Jammu house of Bhat, the Kashmiri Pandit government employee who was shot dead by militants inside his office in the Chadoora area of Budgam on Thursday.

Jammu and Kashmir BJP president Ravinder Raina and other party leaders, who attended the funeral, were heckled and roughed up and police had to intervene when they visited the cremation ground in Jammu.

Raina said security forces have broken the "back of terrorism" and the few remaining militants will also be eliminated.

Those who lost their loved ones to terrorism will be angry.. they will speak.. but only we have come here because we feel the pain, they are our brothers... No one else will come, neither the Congress, nor NC nor PDP," he told reporters when asked about the anger against the BIP.

Hundreds of protestors blocked roads and burnt tyres at Muthi, Hazuribagh and Buntalab in Jammu. They raised slogans against Jammu and Kashmir Lieutenant

dits be rellocated from the valley. Residents of Muthi camp led by its president Anil Bhan took out a rally and blocked a road for hours.

"The BJP is ruling this Union Territory through the LG and every failure on the part of LG is theirs. How long will we receive coffins from our homeland. Our boys and girls joined the services in Kashmir in national interest and to serve Kashmir," Bhan said.

In Kashmir, hundreds of Kashmiri pandits employees blocked a highway in the Vessu area of Kulgam district and went on an indefinite pen-down strike, accusing the government of failing to ensure their protection and safety.

"Our dharna which started last evening will continue till the government does not attach us all with the office of Relief Commissioner. We are not going to serve places where we face threats to our lives. We are not here to get killed but to serve people", Sanjay Kumar of Vessu camp said.

There were claims that several hundred KP employees have tendered en-masse resignation and sent the letter with their signatures to the LG for acceptance. However, there was no official word on it. "Home Minister Amit Shah claimed in parliament about the start of a rehabilitation plan. Since then, dozens of Hindus were killed and four temples suffered damage. 20 New Hostels Coming Up For Tribal Students In J&K

SRINAGAR: Twenty new hostels with an intake capacity of 3,000 tribal students will start functioning from the current financial year in Jammu and Kashmir, an official said on Friday as the Tribal Affairs Department finalised various proposals for the community at a meeting here.

The administration has initiated a process for special projects to focus on tribal students' education which includes establishment of 20 new hostels, model residential schools and special scholarship scheme for students among other key sectors on the directions of Lieutenant Governor Manoj Sinha, the official said.

Secretary, Tribal Affairs Department, Shahid Iqbal Choudhary chaired the union territory level committee meeting which approved establishment of 20 new hostels with intake capacity of 3,000 students to be started in the current financial year, he said.

He said the state land will be provided by respective district administrations to the department for setting up the new hostels.

The step is aimed at providing quality residential facilities to tribal students enrolled in colleagues and other institutes of higher secondary education. The government intends to establish 50 new hostels over the next two years for

mittee constituted for devising a special scholarship scheme for students enrolled in seasonal centres was also reviewed.

The new scheme offers incremental scholarship up to Rs 2,400, replacing the existing slab of Rs 450 for boys and Rs 675 for girl students, the official said.

Benzema Draws Level With Raúl As Madrid's 2nd-Highest Scorer

MADRID: Karim Benzema continues to add his name to Real Madrid's record books, scoring his 323rd goal to draw level with Raúl González as the club's secondhighest scorer behind Cristiano Ronaldo.

Benzema netted in the first half of the team's 6-0 rout of last-place Levante in the Spanish league on Thursday, with Madrid having secured the title a few rounds ago.

The result sealed Levante's relegation after five consecutive years in the first division.

Vinícius Júnior, Benzema's trusted attacking partner all season, scored a hat trick for Madrid as it continues to prepare for the Champions League final against Liverpool in Paris on May 28, when it will try to win a recordextending 14th European title.

Benzema is now 128 goals shy of the 451 scored by Ronaldo, who played at the club until 2018. Raúl, the coach of Madrid's "B" squad, played for the club in the 1990s



and 2000s.

Benzema's close-range header in the 19th minute off a cross by Vinícius gave the French striker his league-leading 27th goal, which is nine better than any other player in the competition this season. He has scored more than a third of Madrid's 79 league goals so far.

It was the 20th goal in the last 15 matches in all competitions for Benzema, who has been key in the team's run to the Champions League final, scoring decisive goals in every knockout round of the European tournament - including two hat tricks. (AP)
