SRINAGAR: Protests by Kashmiri Pandits over the killing of Rahul Bhat by militants inside his office last week continued in Ganderbal and Anantnag districts of Jammu and Kashmir on Monday, officials said. Scores of Kashmiri Pandits assembled at Tulmulla in

Ganderbal district to protest against the killing of their community member, the officials said.

The protesters held photographs of Bhat, who was shot dead by the gunmen inside his office at Chadoora in Budgam district on May 12, and shouted slogans like "we want justice", the officials said.

Similar protests were also held in Anantnag where the protesters also set afire effigies depicting the present government.

The union territory administration has ordered a probe by a Special Investigation Team into Bhat's killing.

How Early Summer Cost Kashmir Its Lucrative Harvest This Year

Tith sweltering summer yet to peak in Kashmir, the intense heat-waves this spring already made the season of rejuvenation a "season of suffering" for Saleem Dar and his clan in Kashmir Himalayas.

His tribe's troubles equally stemmed from the record-breaking scanty rainfall that ended their early-morning jungle jaunts for the lucrative harvest.

"Heat-waves and scanty rainfall this past spring robbed us of our traditional livelihood," Saleem, a native of Srinagar's Harwan area, told Kashmir Observer. "Our prized crop had hardly mushroomed this time around and thus ended our springtime visits on disappointed note. It was truly a heartbreaking season."

The morel or guchhi collection starts from March and April every year. But the summer-like situation this spring, experts say, didn't let guchhis to grow. The scanty spring rainfall further doomed the crop.

As the hottest spring month in 131 years, March 2022-the starting time for morel collectionrecorded 80 per cent less rainfall than average, with Srinagar receiving only 21.3mm of rain, against a normal of 117.6mm.

"This is a clear sign of climate change now impacting our flora and fauna in Kashmir," said Dr. Imtiyaz Dar, an Environmental Science lecturer from Srinagar. "What's alarming is that this change is coming at a huge cost, impacting the livelihood of highaltitude residents of Kangan,



Anantnag and Kupwara." As the world's costliest mushroom, morels are found in Kashmir apart from Himachal Pradesh and Uttarakhand.

Characterized by their honeycomb heads and oblong-bulbous appearance, they grow on the bark of old trees and in grasslands in cold wet weather

"But now, their growing pattern is also changing in Kashmir,' Dr. Imtiyaz said. "Most of the morels grow on old and rotten apple trees, now being replaced

by high-density small trees in various Kashmir orchards. This orchard change is also adding to the overall production woes.

Climate change and shifting farm scenario apart, Kashmir's geographical position in the north-west Himalaya range makes it an ideal place for guchhi growth, Dr. Imtiyaz continued."And then," he said, "because of its profitability [Gucchis are sold at around Rs 30,000 per kilogram in the market], a large section of countryside people are actively involved in morel collection. In this backdrop, the current season has only come as a shocker for large number of people in Kashmir."

What makes this mushroom equally marketable is its immedicinal value."Its mense rich nutrient content makes it

antitumor, antimicrobial, antiinflammatory and antioxidant crop," said Dr. Shabnum Rashid, a nutritionist."It's equally good for heart and liver."

But before the early-summer spoiler this year, the experts have been decrying the growing urbanization and habitat destruction for the decreasing morel crop in Kashmir.

Morel production, according to the 2018-19 Digest of Forest Statistics from the Jammu and Kashmir Forest Department, fell from 2,000 quintals in 1991 to 88 quintals in 2018.

And while the latest figures remain 'work in progress', many are already painting a grim picture of the wild mushroom quietly fading inside the climatechange hit Kashmir forests. "The spring used More on P6

Stem Cell Therapy Offers A New Hope To Repair Brain Damage In Newborns

few hours after Tom (not his real name) was born, he became restless and did not want to be breastfed. His mother noticed that his left arm and leg were shaking rhythmically something was not right.

Tom was immediately transferred to the neonatal intensive care unit. An MRI scan revealed that he had suffered a severe stroke. Doctors told Tom's parents that there was no treatment they could give the child. He would probably be disabled.

Most people think of stroke as something that mainly affects the elderly, but it can also oc-cur in newborn babies. These perinatal strokes happen when one of the major arteries to the brain becomes blocked, leading to a lack of blood supply and hence oxygen to certain brain areas. About one in 5,000 newborns have a stroke. It usually happens in the first few days after they are born.

Most of the babies will have problems later in life, with the severity of the problems depending on which brain areas were injured. These problems can include muscle tightness in the arms and legs (cerebral palsy), behaviour prob-lems, learning difficulties and epilepsy.

No therapy exists for newborns with stroke. Researchers, including our own team at University Medical Center Utrecht, have been working on new treatments, one of which involves stem cells.

Stem cells have the ability to turn into many different cells in the body, and they are little factories of several growth factors (proteins that stimulate the growth of specific tissues). The theory is that if we can get stem cells into the damaged part of a baby's brain, the stem cells' growth factors will stimulate the brain to repair itself.

Effective in animals

Earlier studies in animals showed that injecting stem cells into the brains of newborn mice with



stroke dramatically reduced the amount of brain damage and disability they suffered. The experiments showed that the treatment was safe and had no side-effects in the mice. These animal studies gave us hope that the treatment would work in newborn babies, too, preventing a lifetime of disability.

But how do you deliver stem cells to a baby's brain without having to use needles or surgery? We decided to try an intranasal route (through the nose), which was tested in mice. After we delivered the stem cells intranasally, the cells travelled rapidly and specifically to the injured brain areas. The injured brain area sends out

alarm signals which guide the stem cells to the right spot in the brain.

Once the stem cells arrived at the damaged area, they secreted growth factors that boosted the repair systems of the mice's brains. Within a few days, the stem cells were broken down and not traceable in the brain any longer. After several experiments with this method, we concluded that dripping stem cells in the nose is the safest and most efficient way to deliver them to the brain.

Ten babies

After many years of laboratory research, we

have finally tested the treatment in babies. The results have been published in The Lancet Neurology.

Baby Tom, mentioned earlier, was the first baby to participate in the study and received stem cells within a week of being born. To ask parents to enrol in an experimental therapy in the first week of their newborn child's life is a very delicate process.

After we had a long conversation with his parents, they decided to let their son take part in the study. He received stem cells via nose droplets, a procedure that took only several minutes. Afterwards, Tom was monitored closely for a few days before he went home.

We treated ten newborns who were transferred from hospitals across the Netherlands to the University Medical Center Utrecht after suffering from a stroke. In all ten newborns, the stem cell droplets were administered without any complications. There was one baby who had a mild fever after the treatment, which quickly cleared up on its own.

A follow-up MRI scan of the brain made three months after the stroke showed less injury than expected, possibly because of the stem cells. At four months, the treated babies, including Tom, performed well when the quality of their movements was tested. When the children are two years old, we will check their development again.

We are now looking for opportunities to pro-ceed with a randomised controlled trial (the gold standard for medical studies) to prove that stem cell therapy can effectively repair brain injury after perinatal stroke.

The discovery of a new and safe therapy with stem cells also opens up opportunities for other babies with brain injury, such as babies who are born too early, or babies that suffer from a lack of oxygen during birth (perinatal asphyxia). Stem cell therapy gives hope to the most vul-nerable patient group, with possible lifelong benefits.

This Smartphone App Helps Locate Mosquitoes, Eradicate Malaria



mud or vegetation, based on their fingerprints. Each image is then processed and gridded with identified sources of water on those surfaces.

The data is then classified into different categories based on the presence or absence of mosquito larvae and whether the water is positive for mosquitoes. Paired with Jacob's algorithms, the drone was 100 per cent accurate in locating bodies of water where mosquitoes are most likely to breed. "Instead of spraying entire fields, we can now just target the areas where the mosquitoes are," he noted. With the ability to pinpoint exactly where habitats are, harmful insecticide usage is decreased and the risk of mosquitoes building up a resistance also lessens.

Implementation of the programme on a county or state level could save taxpayers' money because it costs thousands of dollars less than aerial fumigations.

A novel app that identifies locations of previously unknown mosquito breeding habitats and helps treat them within the same day has been developed, and is helping several countries fight the menace of malaria.

The smartphone app, created by a public health researcher at University of South Florida (USF), pairs an algorithm with

a drone and satellite images to identify locations of previously unknown mosquito breeding habitats.

The system works by identifying specific environments and organisms by their unique "fingerprint" - a red-green-blue value associated exclusively with a species or habitat.

Benjamin Jacob, Associate Professor at the USF, trained the drone to sense and capture image datasets through his algorithms that allow the system to understand key features, like

The technology's success led Jacob to launch Seek and Destroy, a programme that enables him to train government agencies how to use the app in infectious areas in Cambodia, Uganda, Kenya and Rwanda - allowing them to quickly and efficiently direct resources to vulnerable areas before disease outbreaks can occur.

What those countries are dealing with is a tragedy beyond describing," Jacob said.

He has focused much of his research in Uganda, where malaria is the leading cause of death, especially among children under five. As published in the American Journal of Entomology, he discovered that each of the 120 homes he studied was infested with at least 200 mosquitoes. With the help of the local insect control officers he trained, Jacob destroyed 100 per cent of the identified habitats in 31 days and eliminated the blood parasite level in previously treated and suspected malaria patients in 62 days.

Nano-sized robots manipulated using a magnetic field can help kill bacteria deep inside the teeth, and boost the success of root canal treatments, according to a study by researchers at the Indian Institute of Science (IISc) Bengaluru.

Root canal treatments are routinely carried out to treat tooth infections in millions of patients. The procedure involves removing the infected soft tissue inside the tooth, called the pulp, and flushing the tooth with antibiotics or chemicals to kill the bacteria that cause the infection.

However, many times, the treatment fails to completely remove all the bacteria -- especially antibiotic-resistant bacteria such as Enterococcus faecalis -- which remain hidden inside microscopic canals in the tooth called dentinal tubules.

"The dentinal tubules are very small, and bacteria reside deep in the tissue. Current techniques are not efficient enough to go all the way inside and kill the bacteria," said Shanmukh Srinivas, Research Associate at the Centre for Nano Science and Engineering (CeN-SE), and co-founder of IISc-incubated startup, Theranautilus.

IISc Scientists Develop Tiny

In the study published in the journal Advanced Healthcare Materials, the researchers designed helical nanobots made of silicon dioxide coated with iron. which can be controlled using a device that generates a low intensity magnetic field.

Robots That Can Deep Clean Teeth

These nanobots were then injected into extracted tooth samples and their movement was tracked using a microscope.

By tweaking the frequency of the magnetic field, the researchers were able to make the nanobots move at will, and penetrate deep inside the dentinal tubules.

"We have also established that we can retrieve them we can pull them back out of the patient's teeth, said Srinivas. "Crucially, the team was able to manipulate the magnetic field to make the surface of the nanobots generate heat, which can kill the bacteria nearby. No other technology in the market can do this right now," said Debayan Dasgup-ta, Research Associate at CeNSE, and another co-founder of Theranautilus. Previously, scientists have used ultrasound or laser pulses to create shock-waves in the fluid used to flush out

bacteria and tissue debris, in order to improve the efficiency of root canal treatment.

However, these pulses can only penetrate up to a distance of 800 micrometers, and their energy dissipates fast. The nanobots were able to penetrate much further -- up to 2,000 micrometers.

Using heat to kill the bacteria also provides a safer alternative to harsh chemicals or antibiotics, the researchers said.

They tested the dental nanobots in mice models and found them to be safe and effective.

The researchers are also working on developing a new kind of medical device that can easily fit inside the mouth, and allow the dentist to inject and manipulate the nanobots inside the teeth during root canal treatment. "We are very close to deploying this technology in a clinical setting, which was considered futuristic even three years ago. It is a joy to see how a simple scientific curiosity is shaping into a medical intervention that can impact millions of people in India alone, Ambarish Ghosh, Professor at CeNSE added.

RINAGAR - Even as the proposal to shift the summer capital of Jammu and Kashmir is yet to take off, controversy dogs the idea with debate rag¬ing for and against the govern¬ment move.

Giving vent to the opposi-tion to shifting of the capital, several political parties, includ¬ing main opposition National Conference, said the massive expenditure needed for moving the secretariat and other offices could be diverted to building schools, hospitals and roads in the state.

"We need no new capital at an exorbitant expenditure of Rs 3.500 crore which could be uti-lized for the betterment of Kashmiris by constructing schools, colleges, hospitals and roads which are in a dilapidated condition across the valley.' NC President Omar Abdullah told PTI.

Ridiculing the idea, another senior leader of the party Ali Mohammad Sagar said "instead of finding ways and means to mitigate the problems of the people the PDP-led coalition government is trying to squan-der the funds for unproductive projects.

He asked the coalition gov¬ernment to desist from chang-

ing the capital for "petty politi-cal gains." CPI(M), which supports the coalition government from out-side, opposes the idea. State Secretary of CP1(M) M Y Tarigami said "I don't think it is a very serious move vet

The government complexes should be moved a little away from the market and the beauti¬ful city but not relocated in any other place. Why go there (Parihaspora) to Lalitaditya. The kings are buried there let them rest in peace.

"It is wrong to assume that government wants to benefit villagers by moving the capital city. The government has in fact done very little for the upliftment of rural areas," he said. Author of the proposal to shift the capital and Finance

Minister Muzaffar Hussain Baig said the basic objective behind a new capital was to decongest and develop Srinagar as an exclusive tourist resort 'with heritage villages and other amenities to make it among the most attractive tourist destinations on the globe.

The proposal for a new capital has received the Centre's nod which would be ready within next three years at an. estimated cost of Rs 3.500 crores, he said.

Opposing the idea, Chair¬man of National Democratic Front and former MP Abdul Rashid Kabuli accused the gov¬ernment of not attending to the problems of Srinagar, a city of 15 lakh people.

Shifting capital from Srinagar to Parihaspora and moving government offices to rural areas is like shifting of Union capi-tal from Delhi to South India, Kabuli said.

The city of great antiquity has had a chequered history which dates back to 250 BC when king Ashoka founded Srinagar as capital which occupied the site of the present Pandrethan about five runs from Srinagar and named it as Srinagari. The place was the venue of the Buddhist conference during

the reign of Kanishka and Muslim preachers, Syed Sharifuddin Bulbul and Mir Syed Ali Hamdani chose this place to spread Islam, he said, adding the latter capitals of Kashmir founded by successive rulers lost their importance to the city. It was during the Dogra rule (1846-1947) that Srinagar

besides being the capital of Kashmir was elevated to the status, of the summer capital.

Congress' existential crisis

he Congress organized three-day brainstorming conclave or Chintan Shivir in Rajasthan's Udaipur to find ways to rejuvenate the party. The need for the session has been occasioned by the party's recent poll debacles which has threatened its standing as a viable pan-India party. What is more, the parties like AAP which now rules New Delhi and Punjab are stepping into the breach.

Ahead of the conclave, Congress president Sonia Gandhi, slammed Prime Minister Narendra Modi for keeping the country in a permanent state of polarisation, brutalising minorities and threatening political opponents. Incidentally, some leaders of G-23 like Ghulam Nabi Azad were also present at the session.

Now the question is whether the ideas from Chintan Shivir will be implemented. And if the party will make the leadership and organizational changes so necessary for its survival at a time when PM Modi reigns as an overarching political demigod immune to anti-incumbency. And Congress in its current avatar is not even a distant challenge to him. The party now lacks the support base to pull off polls in a minor state as its abysmal performance in recent elections in five states would have us believe.

This is such a sorry state of affairs for a party which ruled India for over fifty years after independence. And its chances look slim in the upcoming state polls this year. This is why a breakaway group led by Ghulam Nabi Azad and Anand Sharma and calling itself G-23 is demanding serious reforms in the party. But this has split the Congress down the middle with Gandhi family supporters and opponents at loggerheads with each other. However, G23's rebellion marks a break from the passivity of the last eight years with the party apparently seeming to have resigned to its current lot. But it won't also be easy to elect a non-Gandhi president. And the party has its own reasons for this: a Gandhi not being at the helm will run the risk of breaking the party up. Also, in the present circumstances, Congress doesn't boast of many a mass leader - albeit, there are many senior politicians who can be worthy successors to Gandhi. Gandhi's term at the helm has shown that he is not just up to the task. The PM Modi, meamwhile; is becoming unassailable by the day. Beyond a few reverses here and there over the last seven years, his appeal has only grown stronger. He looks favourite to win many more Assembly polls, more so, the upcoming election in several states unless Congress and wider opposition gets its act right. That is, if no credible opposition emerges from the shadows in the near future, a prospect that looks bleak.

Lands in Limbo

Judiciary intervenes to the rescue of land owners in Banihal but why aren't central laws standing on their own

• Not making Right to Fair Compensation Act (RFCTLARR Act 2013) applicable on the ground makes it clear that bureaucracy in J&K doesn't want to give benefits of central laws to the people of J&K. As the High Court has come up with a fresh direction in Banihal land acquisition case, it seems that judiciary is the only hope for aggrieved land owners of J&K whose land and property is being forcibly acquired by Government

he Jammu & Kashmir High Court has come to the rescue of a land owner in Banihal area of Ramban district by quashing an 11-year-old notification issued under repealed J&K Land Acquisition Act 1934 (samvat 1990). The division bench of Chief Justice Pankaj Mittal and Justice Moksha Kazmi in an order issued on April 25th 2022 said that notifications issued under Sections 4 and 6 of the repealed act have lost all efficacy and have been rendered meaningless. The division bench order read:

"Section 11-B of the (repealed) JK Land Acquisition Act specifically provides that the Collector shall make an award under Section 11 of the aforesaid Act within a period of two years from the date of publication of the declaration and in case no such award is made within the period prescribed, the entire proceedings for the acquisition of the land shall lapsed"

The order further stated:

"It may be pertinent to mention here that in respect of the above acquisition, the urgency provisions under Section 17 of the Act were not invoked and the enquiry under Section 5-A of the Act was not dispensed with. It is not even the case of the respondents that the land acquisition proceedings had remained stayed by any order of the court. 11. In view of the aforesaid facts and circumstances, it is evident that no award has been made under Section 11 of the Act within a period of two years from the date of the declaration issued under Section 6 of the Act. There is no dispute to the date of declaration which happens to be 29.06.2011 and, therefore, the period of two years has clearly expired but with no award. Accordingly, we are of the opinion that the aforesaid land acquisition proceedings have lapsed'

Background of the Case

Division Bench of High Court comprising Chief Justice Pankaj Mithal and Justice Moksha Khajuria Kazmi quashed the notifications issued by Collector Land Acquisition Ramban for acquisition of land for construction of new Bus-Stand at Banihal located in village Devgole and Krawah vil-



Technology (IUST) Awantipora. The awards issued under repealed act were declared null and void and HC division bench headed by Chief Justice said that fresh notification be issued under the existing law that is Right to Fair Compensation Act (RFCTLARR Act 2013) wherein there is provision of fair compensation which is estimated as per the market value of land and property with 100% solatium (jabirana). Under the repealed law (J&K LA Act1934), the rate was estimated as per circle rate/stamp duty rate with only 15% solatium.

Curious Case of Srinagar Ring Road

Now, the affected land owners of Srinagar Ring Road in Budgam are also demanding the same treatment. In their case too, the declaration issued by Collector Land Acquisition Budgam under section 6 of repealed act in August 2017 got lapsed in July 2019.

The land owners have moved multiple petitions before J&K High Court and a status-quo was asked to be maintained by the court last year. However, this was violated by the district administration Budgam by misinterpreting a recent HC judgement of J&K High Court wherein Justice M A Magrey had mentioned that the construction work on Srinagar Ring Road be taken up. This order was to be implemented in those areas where affected landowners had taken compensation. Unfortunately, JCBs owned by contractor M/S NKC Projects Pvt Ltd, NHAI and local administration de stroyed standing crops and fruits trees in such areas where farmers are yet to get compensation of their land. Even the mustard crop was destroved in such areas where land wasn't even notified (Mohammad Ramzan Bhat R/O Batpora Chadoora).

The then Deputy Commissioner Budgam Tariq Hussain Ganai who is signatory to the communication No: DCB/LAS/20/300-10 Dated 18th May 2020 is a senior officer having served as Deputy Commissioner in Ganderbal and Ramban before being posted as DC Budgam. If he has given a true picture about the land acquisition matters of his district, the Collector Land Acquisition Budgam in his written response told the High Court that former Deputy Commissioner Budgam had misrepresented and misinterpreted the facts. The officers had provided a complete list of the villages where land acquisition proceedings had lapsed due to efflux of time and the same communication was made the main annexure to the petition of Abdul Salam Bhat v/s JK Govt. The DC's letter and annexures sent to Divisional Commissioner on May 18th 2020 was supported by documentary evidence in respect of notification under section 4 followed by declaration under section 6 and 7 of the Repealed Land Acquisition Act. He had invited the attention of the Divisional Commissioner Kashmir to express provision of section 11-B of the repealed act, whereunder, the proceedings were to be deemed as lapsed in the event of failure of pronouncement of an award. The District Collector has categorically admitted that no award within the stipulated period of 2 years from the date of declaration of section 6 has been pronounced. His opinion was based on legal data. By no standards can his legal and factual opinion be termed as misinterpretation and misrepresentation of facts.

Debating the Exception

hile Justice Shakdher relies on the understanding that the foundation of a modern marriage is equality between spouses, Justice Shankar ignores basic principles of equality, agency and autonomy. His disturbing observation that marriage necessarily involves surrendering certain rights in varying degrees — in this case, the right of a woman to her bodily integrity — needs to be strongly contested.

In defence of the law, both Delhi government and the Centre have argued that marital rape cannot be criminalised unless there is societal consensus on the issue. Arguments for retaining the provision have ranged from protecting the institution of marriage to potential misuse of any change in law. These are concerns that should be debated. There must be a wider and more participatory discussion. At the same time, it is also crucial for the Courts to answer another legal question — whether striking down the exception in marital rape under law would amount to treading on the domain of Parliament. In this context, the central government's stand that the marital rape exception will be reviewed is a welcome step. In the UK, as in South Africa, Australia and Canada, which have removed the exception in marital rape, judicial decisions were followed by changes in legislation.

The split court verdict may not move the needle too far, but it has ignited a much-needed conversation on marital rape, both within and outside courts. Significantly, the Karnataka HC ruling in March allowed a man to face trial for marital rape for the first time. Although courts have, in passing, expressed views on the issue and urged the government to look into it, Justice Shakdher's opinion is the first acknowledgement in a high judicial forum that the exception is at odds with the Constitution.

Indian Express

The land owners Ghulam Mo-

hiudeen and others through their counsel Advocate Irfan Khan challenged the notifications issued by Collector land Acquisition as the same had lapsed due to efflux of time. This rendered the entire land acquisition proceedings invalid. It was submitted before the High Court that declaration under Section 6 of erstwhile J&K Land Acquisition Act 1934 (samvat 1990) was issued on 29-06-2011 for land measuring 13 Kanals 4 Marlas situated at village Devgole and Karwah. Under section 11 -B of the repealed act, the final award had to be made within a period of 2 years but in this case the said award was not made even after 11 years

After hearing Advocate Irfan Khan for petitioners and Senior Additional Advocate General S S Nanda for respondents, the High Court Division Bench observed that the proceedings initiated under repealed act have lapsed and the same can't be concluded after elapse of the requisite time period.

In the recent past, the High Court Division Bench gave similar orders in case of land acquisition by J&K Housing Board at Baramulla Kanili Bagh and Islamic university of Sciences and

In the case of Ali Mohammad Akhoon v/s Govt of J&K, the Collector Land Acquisition Budgam through a written reply supported by an affidavit, disputed the communication made by the District Collector/Deputy Commissioner Budgam addressed to the Divisional Commissioner Kashmir in May 2020.

The then Deputy Commissioner Budgam Tariq Hussain Ganai prepared a village wise position of the land acquisition for Semi Ring Road in Budgam and conveyed to the Divisional Commissioner that proceedings initiated under the repealed J&K Land Acquisition Act 1934 (samvat 1990) had lapsed due to efflux of time under section 11-B of the act. The DC had recommended initiation of fresh proceedings under the Right to Fair Compensation Act 2013 which was extended to J&K after the abrogation of Article 370

The Deputy Commissioner of a District is supposed to be a responsible officer and as a District Collector he is supposed to be conversant with all the land acquisition matters in the district.

Several commitments were made to the people of J&K after the abrogation of Article 370 on the floor of Parliament. The Prime Minister, Home Minister and other leaders of the Bharatiya Janata Party said that the extension of the central laws to J&K would confer upon its people benefits, especially under the flagship programmes. Unfortunately, the practice of depriving people of their rights persists in J&K.

Not making Right to Fair Compensation Act (RFCTLARR Act 2013) applicable on the ground makes it clear that bureaucracy in J&K doesn't want to give benefits of central laws to the people of J&K. As the High Court has come up with a fresh direction in Banihal land acquisition case, it seems that judiciary is the only hope for aggrieved land owners of J&K whose land and property is being forcibly acquired by Government.

How Fast Can We Stop Earth From Warming?

Gibbal warming doesn't stop on a dime. If people everywhere stopped burning fossil fuels tomorrow, stored heat would still continue to warm the atmosphere. Picture how a radiator heats a home. Water is heated by a boiler, and the hot water circulates through pipes and radiators in the

house. The radiators warm up and heat the air in the room. Even after the boiler is turned off, the already heated water is still circulating through the system, heating the house. The radiators are, in fact, cooling down, but their stored heat is still warming the air in the room.

This is known as committed warming. Earth similarly has ways of storing and releasing heat.

Emerging research is refining scientists' understanding of how Earth's committed warming will affect the climate. Where we once thought it would take 40 years or longer for global surface air temperature to peak once humans stopped heating up the planet, research now suggests temperature could peak in closer to 10 years.

But that doesn't mean the planet returns to its preindustrial climate or that we avoid disruptive effects such as sea level rise.

I am a professor of climate science, and my research and teaching focus on the usability of climate knowledge by practitioners such as urban planners, public health professionals and policymakers. Let's take a look at the bigger picture.

How understanding of peak warming has changed

Historically, the first climate models represented only the atmosphere and were greatly simplified. Over the years, scientists added oceans, land, ice sheets, chemistry and biology.

Today's models can more explicitly represent the behavior of greenhouse gases, especially carbon dioxide. That allows scientists to better separate heating due to carbon dioxide in the atmosphere from the role of heat stored in the ocean.

Thinking about our radiator analogy, increasing concentrations of greenhouse gases in Earth's atmosphere keep the boiler on – holding energy near the surface and raising the temperature. Heat accumulates and is stored, mostly in the oceans, which take on the role of the radiators. The heat is dis-

tributed around the world through weather and oceanic currents.

The current understanding is that if all of the additional heating to the planet caused by humans was eliminated, a plausible outcome is that Earth would reach a global surface air temperature peak in closer to 10 years than 40. The previous estimate of 40 or more years has been widely used over the years, including by me. It is important to note that this is only the peak, when the temperature starts to stabilize – not the onset of rapid cooling or a reversal of climate change.

I believe there is enough uncertainty to justify caution about exaggerating the significance of the new research's results. The authors applied the concept of peak warming to global surface air temperature. Global surface air temperature is, metaphorically, the temperature in the "room," and is not the best measure of climate change. The concept of instantly cutting off human-caused heating is also idealized and entirely unrealistic – doing that would involve much more than just ending fossil fuel use, including widespread changes to agriculture – and it only helps illustrate how parts of the climate might behave.

Even if the air temperature were to peak and stabilize, "committed ice melting," "committed sea level rise" and numerous other land and biological trends would continue to evolve from the accumulated heat. Some of these could, in fact, cause a release of carbon dioxide and methane, especially from the Arctic and other high-latitude reservoirs that are currently frozen.

For these reasons and others, it is important to consider the how far into the future studies like this one look.

Oceans in the future

Oceans will continue to store heat and exchange it with the atmosphere. Even if emissions stopped, the excess heat that has been accumulating in the ocean since preindustrial times would influence the climate for another 100 years or more.

Because the ocean is dynamic, it has currents, and it will not simply diffuse its excess heat back into the atmosphere. There will be ups and downs as the temperature adjusts.

The oceans also influence the amount of carbon dioxide in the atmosphere, because carbon dioxide is both absorbed and emitted by the oceans. Paleoclimate studies show large changes in carbon dioxide and temperature in the past, with the oceans playing an important role.

However, today, countries aren't anywhere close to ending their fossil fuel use. Instead, all of the evidence points to humanity experiencing rapid global warming in the coming decades.

Our most robust finding is that the less carbon dioxide humans release, the better off humanity will be. Committed warming and human behavior point to a need to accelerate efforts both to reduce greenhouse gas emissions and to adapt to this warming planet now, rather than simply talking about how much needs to happen in the future.

BADMINTON: How India Won The Thomas Cup

India's Thomas Cup win wasn't a fluke. It was long overdue. Much of the delay stemmed from the lack of professionalism in running Indian sports. You could argue that it's far better than what it was two



A devastated Indonesia, the tournament's most successful team having previously won it 14 times, could not keep pace with the fire brought by the Indian team, who joyfully rushed to the court following Srikanth's win. India were already 2-0 up, with Lakshya Sen beating Anthony GintIndian Prime Minister Narendra Modi led the praise back home and personally rang the team in the Thai capital to congratulate them.

"The Indian badminton team has scripted history! The entire nation is elated by India winning the Thomas Cup!" he tweeted.

decades ago. It should be, and two decades is a long time. And evidence of that improvement is the Thomas Cup triumph.

What exactly is the Thomas Cup? It's badminton's equivalent of the Davis Cup in tennis. But the format is different. A team competition of five matches — three singles and two doubles — the format doesn't allow a player to play in more than one singles and one doubles match. That makes winning a challenging proposition, requiring a pool of world-class players.

Take a look at the roster of previous champions. All of them are badminton powerhouses. Indonesia, China, Denmark, Malaysia and Japan keep churning out high-calibre players by the dozen that they are regulars in the battle for silverware. Earlier, the contest was tougher with nine matches in each tie.

With only one or two quality players, India could never match the depth and strength of champion sides. That explains the delay in winning the Thomas Cup — India's first in the 74-year history of the tournament.

Why did it take so long? Why was the depth lacking in Indian badminton? More so in a sport that's wildly popular. Even in the UAE, check out the badminton halls, and you will find them crowded, except during office hours. Most of the players are from India. These are recreational players who play for the love of the game and fitness. That's how popular the sport is.

Popularity was never a problem. But the quality was. India had talents of international class, but not many at a time. Nandu Natekar was independent India's first, making it to the quarterfinals of the 1954 All England Championships. The first Indian to win an international badminton championship (Selangor International in Kuala Lumpur, 1956), Natekar's high profile scalps included the great Dane Erland Kops.

That was long before I started following badminton. Long before Prakash Padukone captured India's imagination.

Padukone's game was sublime. We

marvelled at his effortless artistry, deft touch-play and immaculate deception; he taught us to win without power. I never saw him play a fullblooded smash; the putaways were always a half-smash. We celebrated his wins and lamented his losses. The All-England win over Lim Swie King of Indonesia in the 1980 final and the 1981 World Cup final triumph over Han Jian of China were seared into our memories.

He was a rare gem. Padukone's successors, Syed Modi and Vimal Kumar, promised much but never scaled the same heights. After India struggled for 21 years to find a new champion, Pullella Gopichand came along. More than his talent, his passion was unmatched. An All England champion in 2001, his bigger contribution to Indian badminton was in the role of a coach. The Gopichand Badminton Academy in Hyderabad turned out to be a factory for world-beaters from India.

Saina Nehwal, P. V. Sindhu, Srikanth Kidambi, Parupalli Kashyap, H.S. Prannoy, Sai Praneeth, Sameer Verma and several others benefited enormously from Gopichand's tutelage. Some of them were part of the Indian squad that won the Thomas Cup, 43 years after the previous best showing when an Indian team starring Padukone and Modi lost to Denmark in the semi-finals.



What Gopichand left unsaid is that many of these top 10 players came from his academy, and the competition between them is driving the standard higher. So a large part of the credit for the victory should go to India's chief coach

India now has around 10 players in the top 25 in the world, and that's the secret of India's Thomas Cup triumph. Gopichand is quick to credit the Badminton Association of India, Sports Authority of India and the Government for helping to develop an array of world-class players. "If there were five more singles, India would have still won," wrote Gopichand in the Indian Express.

What Gopichand left unsaid is that many of these top 10 players came from his academy, and the competition between them is driving the standard higher. So a large part of the credit for the victory should go to India's chief coach. Ever humble, Gopichand insists that the players and their teamwork won it. But his firm hand on the wheel was evident when India defeated defending champions and 14-time winners Indonesia in the final. A historic win indeed.

Take a bow, Gopichand. You thoroughly deserve it.

Bangkok: India made history by winning the Thomas Cup for the first time with a ruthless 3-0 upset of reigning champions Indonesia in Bangkok on Sunday.

India, competing in their debut final of the men's team championship, sealed the title when world No 11 Kidambi Srikanth defeated higherranked Jonatan Christie 21-15, 23-21. ing in the first singles match and then Satwiksairaj Rankireddy and Chirag Shetty defeating Mohammad Ahsan and Kevin Sukamuljo in the doubles.

EARLY NERVES

It fell to Christie, an Asian Games gold medallist now in his fourth Thomas Cup campaign, to save Indonesia's flagging title hopes.

But the eighth-ranked Christie couldn't do it and seemed overcome with nerves at the onset of his do-ordie match against Srikanth.

The 29-year-old Srikanth took full advantage, bearing down relentlessly on Christie in the second game.

Srikanth praised his teammates for their performance individually and as a team, noting: "I think everyone really stepped up when it was required.

"A credit goes to the whole team, players, coaches, support team. I love them, they have been fantastic. It's one of the best teams that I have been part of," he said.

"Thomas Cup is something that India has never won and now to be part of a team that won the Thomas Cup and to contribute to the team's win just gives me a lot of happiness," he added.

Srikanth, who told reporters the team's WhatsApp group was called 'it's coming home', said while the team hadn't got any firm plans for celebrations that evening, "it's definitely going to be crazy".

A dispirited Christie said it wasn't easy coming into his match 2-0 down in the tie, but that he had given his all.

"We already tried our best, I think, and we will try our best the next time," he said.

PRIME MINISTER ON THE PHONE

In the first match of the tie, world No 5 Ginting grabbed the first game in style over Sen, 21-8.

But he then wobbled, and with Sen growing in confidence, the Indian world No 9 won the next two games 21-17, 21-16.

"I think this one is for the team, they have been backing me throughout my performances," the 20-yearold Sen said.

"In the closing stages I was really nervous and trying to calm myself with deep breaths."

MORE CONGRATULATIONS

President Ram Nath Kovind, Home Minister Amit Shah and BCCI secretary Jay Shah also congratulated the Indian team.

The President of India appreciated the skill, resilience and temperament of the Indian men's team.

"Heartiest congratulations to the Indian badminton team for firstever Thomas Cup victory! The team has created history, setting highest standards for the future. I have high appreciation for the skills, resilience & amp; temperament shown by the team. India is proud of the champions," said President Kovind in a tweet.

CASH AWARD

The Central Government has announced a cash award of Rs10 million for the victorious Indian team, Sports Minister Anurag Thakur announced the cash award in a tweet.

"As #TeamIndia defeats 14-time #ThomasCup Champions Indonesia to win its 1st ever #ThomasCup2022, @India_Sport is proud to announce a cash award of ?1 crore for the team in relaxation of rules to acknowledge this unparalleled feat! Congratulations Team India!!," the minister said in his tweet.

LOTS OF MISTAKES

A subdued Ginting admitted there were things he could have improved on.

"I play in a rush today and that's why I make a lot of mistakes," he said. South Korea sprang an upset of their own in the women's team championship, the Uber Cup, when they defeated holders China in their final on Saturday.

India had defeated Malaysia and Denmark by identical 3-2 margins in the quarter-finals and semi-finals to storm into the final for the first time in the history of the tournament.

India became only the sixth country ever to win the Thomas Cup title. Only Indonesia, China, Malaysia, Denmark and Japan have won the title in the prestigious event since its format was changed and China started participating in 1982.

Heat Waves, Floods And Heavy Rain: India Battling Climate Change And It Is Getting Worse, Warn Experts

New Delhi: The spectre of climate change is here to stay and even worsen, say climate scientists as searing winds blow across swathes of north India, including New Delhi where temperatures have crossed 49 degrees Celsius, and flash floods ravage parts of the northeast.

A day after two weather stations in Delhi saw temperatures of more than 49 degrees Celsius and neighbouring Gurgaon registered 48 degrees Celsius, the highest since May 1966, experts on Monday analysed the incidence of extreme weather events and sounded a dire warning.

With increasing temperatures as a result of global warming in South Asia and the consequent exceeding levels of heat and humidity, it is predicted that we will have more intense, longer and frequent heat waves in India, environmentalist and climate scientist Shakil Ahmad Romshoo told PTI in a phone interview from Srinagar.

According to the University of Kashmir professor, one indicator of climate change is the increasing frequency of climate extremes. A heat wave, he said, is a climate extreme and a direct indicator of climate change.

Over the last few decades, global warming has been on an accelerated pace and its marks can be seen in any single day of global weather since the 2000s. Generation Z has never lived a day without feeling the influence of global warming, added Roxy Mathew Koll from the Indian Institute of Tropical Meteorology in Pune. The national capital recorded its second hottest April this year since 1951 with a monthly average maximum temperature of 40.2 degrees Celsius. Other north Indian states, including the hill areas of Uttarakhand, Himachal Pradesh, Jammu and Kashmir and Ladakh, also recorded temperatures way above the normal level this season.

While north India battled high temperatures, parts of Kerala and Lakshadweep islands saw heavy rainfall on Sunday. Besides, the weather office sounded a red alert across five districts in Kerala. And in the east, Assam's Dima Hasao district has been hit by flash floods and massive landslides at sev-

eral places, snapping rail and road links. According to Indian Meteorological Department data, the average maximum temperature over northwest and central India for April this year has been the highest in 122 years.

A 4.5 to 6.4-degree departure from normal is considered to declare a heat wave and over 6.4-degree departure for a severe heat wave.

Regardless of local weather interactions, Koli explained, the root cause for increase in such events in the India-Pakistan region is global warming due to human-made carbon emissions. March 2022 was India's hot-

test March in recorded history (1901-2022). The temperatures were high in entire India, especially the northwest regions that underwent a heat wave. Temperatures continued to run significantly above normal in April 2022 over large parts of

India, excluding south India, Koll v told PTI in an email interview.

The Earth's average temperature has increased by 1.2 degrees Celsius above pre-industrial levels, said global climate change expert Harjeet Singh.

The Intergovernmental Panel on Climate Change (IPCC) Report released in 2021 warned that rising temperatures will lead to increased incidence of heat waves, longer warm seasons and shorter cold seasons, Singh, senior advisor, Climate Action Network-International (CAN-I), told PTI over phone.

(CAN-I), told PTI over phone. The experts added that climate change is not only raising temperatures and making India's heatwaves hotter, but also changing weather patterns that further drive dangerous weather extremes. The low pressure anomaly

The low pressure anomaly caused by the weather event know as La Nina over the Indian subcontinent has been inviting westerly winds and the blast of hot air from the Middle East into India.

The north-south pressure pattern has been persisting over India, with La Nina extending its stay over the Pacific. This has definitely impacted the weather over India, which has been seen even during 1998-2000 when La Nina had persisted for three years, said Raghu Murtugudde, professor, department of atmospheric and oceanic science,

University of Maryland, US. We did see some strange weather activities this year as well which include duststorms over Mumbai, early deep depressions out of which one even became feeble cyclone and the heatwaves... all part of this weird and extended persistence of La Nina, Murtugudde said.

The impact of severe heat waves on different sectors, including health, work, quality of life and the economy, is well documented.

According to official records, heat waves have caused over 24,000 deaths from 1992 to 2015 across the country. A recent report from the Ministry of Earth Sciences pointed out that the mortality rates per million for heat waves have increased by 62.2 per cent during the last four decades.

Heat waves affect work productivity by reducing performance and increasing the heat-related illness. A decline of 30-40 per cent in the work performance is projected over India by the end of the century due to the elevated heat stress levels, Murtugudde explained.

Extreme heat causes several health impacts, such as severe dehydration, acute cerebrovascular accidents and contributes to thrombogenesis (blood clots). People with chronic diseases, older people and children are more vulnerable to the effects of heat waves, added CAN-I's Singh.

The impact of climate change is amplified in cities, since urban areas are usually warmer than their surroundings due to concentrated structures and less greenery, he said.

In Romshoo's view, heat waves, which are predicted to be more frequent, deadly and longer in the country, will affect every sector of the economy.

Look at the severity of the heat wave this year, it is concentrated in both Indus and Ganges river basins which produce and supply much of the food supplies in Pakistan and India. Heat waves are also projected to enhance the melting of glaciers in the region which is already facing water scarcity.

The scientists said if the frequency of heat waves continues as is predicted, these will adversely impact food, water and energy security in the region.

As the globe hurtles towards climate disaster, what is the way out?

Romshoo said the impact on cryosphere (snow and glaciers) and the predicted increase of hydro-meteorological disasters are worrisome.

these need to be addressed sector-wise through development of robust and judicious strategies and policies based on scientific inputs and guided by knowledge.

Koll said the need is to adopt a long term vision with policies that help in managing work hours, public infrastructure, schools, hospitals, workplaces, houses, transportation, and agriculture for heat waves to come.

Harjeet Singh stressed on better early warning and communication systems to prepare citizens through community outreach programmes.

The government must take proactive measures in urban planning by investing in green and blue infrastructure, such as green walls, greenways, urban forests, green roofs, and water bodies to cool urban areas. Street trees must be planted at a large scale to reduce heat stress and the urban heat island effect, Singh added.

Abdullah said during a meeting with ieutenant Governor Manoi Sinha on Sunday PAGD leaders raised the issue of killing of Kashmiri Pandit employee Rahul Bhat inside his office at Chadoora on May 12. "We wanted to go to Kulgam where a Rajput was killed, we wanted to go to Budgam (Rahul Bhat's residence) but you did not allow it. We did not want to go there to do politics but to express solidarity with the bereaved. How can this continue? How will we come close to each other? he asked. PDP president Mehbooba Mufti, who was part of the PAGD delegation, said the National Conference, PDP and Congress governments ensured the safety of Kashmiri Pandits even at the peak of unrest in the valley in 2010 and 2016. "Even during the peak unrest in 2010 and 2016, there was no killing of Kashmiri Pandits. But the atmosphere of hate they have created, especially after 'The Kashmir Files' movie, a narrative is being pushed to poison minds. Muzaffar Shah, during our interaction with the LG, told him that this constant Hindu-Muslim debate on TV channels for four hours is further fuelling this. It also directly affects the people of Jammu and Kashmir because when you target Muslims, it widens the gap, Mehbooba said. Asked about the ongoing survey at Gyanvapi mosque complex, she said the BJP should give a list of all mosques they want to take over. Babri mosque was brought down and now they want to build something else there...These claims on mosques are only to fuel hate, she said. As per reports, as many as 17 Kashmiri Pandits (KPs) and non-locals have been killed by militants in Kashmir after the special status of J-K was revoked in 2019. In 2021, three KPs, one Sikh and five non-local laboures were killed.

Ten KPs and non-local labourers have been shot at and injured by militants in South Kashmir and Srinagar so far this year.

Three Kashmiri Hindus have been targeted since March this year. Two of them --Satish Kumar Singh and Rahul Bhat, a revenue department employee were killed in the attacks. A Kashmiri Pandit, Bal Krishan, who did not migrate in the 1990s and ran a medical shop, was also shot at and injured in Shopian in April.

It was informed in the meeting that during the previous **SRINAGAR:** Additional Chief Sec- financial year (2021-22) an amount of Rs 25.00 crores were released for implementation of JKREGP in the UT. It was given out that the Board has disbursed margin money (subsidy) of Rs Level Monitoring Committee 24.62 crores to 893 income generating units involving bank loan of Rs 66.84 crores and providing employment avenues to 5358 persons.

Elucidating it was said that the target of Rs. 25.00 crores has been approved for the current financial year under this employment generation programme. The meeting was apprised that this margin money is earmarked for establishing 1231 income generating units throughout the UT.

It was further informed that the distribution of this subsidy amount is going to be done proportionately based on the rural population and previous performance of various Micro-Industrial schemes in each district.

It is envisaged that overall the scheme is slated to generate employment opportunities for about 7500 workers/artisans in the UT during the ensuing fiscal, as was disclosed in the UTLMC.

'Just Don't Know What He Was Doing': Andrew **Symonds' Sister**

LONDON: The mystery around Australian cricketer Andrew Symonds's final hours before his death in a car crash on Saturday has deepened with his sister revealing to dailymail.co.uk that the family "just don't know" what the 46-year-old was doing on a deserted stretch on the night of the mishap.

The report said that his sister, Louise Symonds, "left a touching letter at the crash site" and said she wishes she could spend "just one more day" with her brother.

Quoting Louise, the report said, 'It's (mishap) just awful. We just don't know (what Andre Symonds was doing there)," she said, adding, "I wish we had one more day, one more phone call. My heart is broken. I will always love you my brother." Symonds' two dogs survived the crash. According to the report, two locals, Babetha Neliman and Waylon Townson, were the mishap and saw the former cricketer "hanging partially out of



The former all-rounder died in a with the car still running and music playing.

The duo tried to approach Symonds but one of the dogs wouldn't allow them to. "One of them (dogs) was very sensitive and didn't want to leave him. It would just growl at you every time we tried to move him or go near him," the report quoted Neliman as saying.

"My partner tried to get (Sy-monds) out of the car, to put him on to his back. He was unconscious, not responsive and had no pulse," added Neliman.

The report added that, "a shattered window could be seen where Symonds' 4WD (4-wheel drive) hit the embankment, with the contents of his car strewn in at the scene within minutes of the weeds. A single fishing lure was half buried in the grass -tangled in undergrowth, cable ties the vehicle on the passenger side" and broken glass.

Sao Tome & Principe Thrown **Out Of African Cup Qualifying**

CAIRO: Sao Tome and Principe was thrown out of the African Cup of Nations qualifying tournament on Monday for breaching COVID-19 protocols in a preliminary tie against Mauritius in March.

Sao Tome and Principe fielded a player in the two-leg tie who hadn't submitted to a compulsory pre-match COVID-19 test or gualified for the African Cup provided proof of a recent test, the Confederation of African Football said. That constituted a breach of CAF's medical rules. Sao Tome and Principe won the tie 4-3 on aggregate.

Mauritius was awarded Sao Tome and Principe's place in the main qualifying stage for the 2023 African Cup in Ivory Coast and will go into a group containing former champion Nigeria, Sierra Leone and Guinea-Bissau. Those qualifiers start at the end of this month.

Mauritius, an Indian Ocean island better known for being a luxury holiday destination, has only once before, in 1974. It lost all three of its games.

Intense Schedule Taking Its Toll On Quad-Chasing Liverpool

iverpool is heading into the 61st game of a potentially hisseason and the intensity of the schedule is taking its toll on the players.

"They are pretty much sleeping on their massage beds," Liverpool manager Jurgen Klopp said Monday. The problem is, the games

are getting bigger and bigger for Klopp's team. And staying in contention for an unprecedented quadruple of major trophies is getting harder and harder.

It's two down, two to go for Liverpool after winning the FA Cup on Saturday — in a penalty shootout against Chelsea – to add to its League Cup triumph from February. The team is already booked in for the Champions League final against Real Madrid on May 28.

Attaining the third leg of the quadruple before that is the toughest ask, simply because the Premier League title is out of Liverpool's hands with Manchester City four points clear heading into the final week of the campaign. City's 2-2 draw at West Ham on Sunday allows Liverpool the chance to trim the gap to one point by beating Southampton on Tuesday, before the two title rivals play their last games on Sunday. But Klopp is being realistic.

"I don't know the last time City dropped points two games in a row, historically," he said. Well, that hasn't happened in

the league this season. It last happened in December 2020, when back-to-back draws – against Manchester United and West Bromwich Albion – preceded a run of 21 straight wins in all competitions

But Klopp doesn't just need Aston Villa, managed by Liverpool great Steve Gerrard, to pull off a major upset on Sunday. He also needs Liverpool to beat Southampton and then Wolverhampton, a task Klopp says won't be easy given the tiredness in his players' legs.

While Liverpool is playing barely three days after 120 intense minutes against Chelsea, Southampton will have had 10 days since its most recent game and is known for its high-energy, heavypressing style of play under Ralph Hasenhuttl.

Southampton drew both of its games against City this season and eat Liverpool at home last season. "They'll be completely fresh," Klopp said. "We cannot go there, fall into this game and go, 'What's

going on here?' Southampton is a really well-drilled team, full of energy ... and playing their last home game of the season."

Then there's the injuries sustained by Mohamed Salah and Virgil van Dijk during the FA Cup final that makes them doubts for the game. Their fitness status will be checked on Monday, but Fabinho is definitely missing because of a hamstring injury. However, Liverpool always

seems to find a way this season, in whatever match and whatever competition. Unsung heroes are popping up all the time – on Saturday, it was back-up left back Kostas Tsimikas converting the clinching penalty — so Klopp sees no problem having to rotate his team for the Southampton game.

"We sit here and we've won two cup competitions and there's one reason for it. Only one," Klopp said. "It's that we have this group of players that have all stayed on track, all stayed in line ... the atmosphere the group has created is exceptional."

He just wishes Liverpool could have been given an extra couple of days to recover before playing Southampton. Why, Klopp asked, couldn't the game have been played on Thursday, when three other league games are taking place?

"Come on, 120 minutes then we play again on Tuesday. That's massive," he said. "We will see. But I can't wait to play the game. The boys who start the game will go with all they have.'

There's no second chances now, though. If Liverpool loses, City is the champion and dreams of the quadruple are over.

CHITTAGONG: Offspinner Naveem Hasan claimed a career-best 6-105 and denied Angelo Mathews a double century by one run before Bangladesh looked to respond against Sri Lanka on Day 2 of the first test on Monday.

Sri Lanka was bowled out for 397 with Mathews the last batter out for 199. Bangladesh openers Tamim Iqbal and Mahmudul Hasan then batted fluently to end the day on 79 for no loss.

Tamim was batting on 35 with Mahmudul on 31 as Bangladesh trails by 321 runs.

Before being the 12th batter to finish with 199 in the test history, Mathews led the Sri Lankan attack astutely against Bangladeshi spinners, who took all 10 wickets with varied pace.

"Obviously it would have been nice to get that one run but you have to take what God gives you," Mathews said. "I am thankful that I was able to play a good knock. Hopefully it will help us win the game.'
