HM Shah Orders Pro-Active Ops Against Militants

Asks UT Administration To Ensure Hassle-Free Amarnath Yatra

New Delhi: Union Home Minister Amit Shah on Tuesday advocated pro-active coordinated counter-militancy operations in Jammu and Kashmir as he held three back-to-back meetings to review the situation there as well as arrangements for the forthcoming Amarnath Yatra and asked security forces to ensure zero cross-border infiltration to "wipe out terrorism" in the union territory.

The marathon meetings held by the home minister came in the backdrop of recent targeted killings in the valley which included a Kashmiri pandit Rahul Bhat, who was gunned down by militants last week.

During the meetings, which was attended by Lt Governor

of JK Manoj Sinha, police chief Dibag Singh and other top central and union territory officials, Shah was informed that this year's 42-day-long yatra, beginning on June 30, will have a Radio Frequency Identification Card (RFID) for every pilgrim besides an insurance cover of Rs 5 lakh.

While Sinha was present in all the three meetings, National Security Advisor Ajit Doval and Army Chief Gen Manoj Pande attended the meetings to discuss the security situation in the union territory.

An official spokesman in a statement said the home minister directed security forces and the police to conduct coordinated counter-militancy operations pro-actively.

The home minister said in order to fulfil Prime Minister Narendra Modi's vision of a prosperous and peaceful Jammu and Kashmir, security forces should ensure zero cross-border infiltration to "wipe out terrorism" in the union territory.

In another statement, the spokesman said the JK chief secretary informed the meeting that each pilgrim will be provided with a RFID and will be insured with Rs 5 lakh. Earlier, RFID was provided to vehicles only.

Shah said a "hassle-free" journey for the pilgrims is a priority of the Modi government and More on P6

External Affairs Ministry Spokesperson Arindam Bagchi categorically rejected the resolution and asked Islamabad to stop cross-border terrorism and shut down its "infrastructure of terrorism".

"We categorically reject the farcical resolution passed by the National and Kashmir," he said.

J&K Has Second Lowest Coverage Under Health Insurance

14% Households Across UT Have Just One Member Covered

SRINAGAR: Government of India's recently released health report has shown a worrying percentage of health insurance coverage in Jammu and Kashmir, as only 14 percent of households in the region are covered under a registered health insurance, which still remains far from satisfactory.

Despite, the central Government's flagship Ayuhsman Bharat Pradhan Mantri Jan Arogya Yojna (AB-Pmjay) which has been an indication of the impact of a bettering health care access in India, J&K has the second worse coverage of households under a health insurance across India, the report revealed.

The latest survey-NFHS-5which provides data by socioeconomic and other background characteristics that remains useful for policy formulation and effective programme implementation, was released by Union Health Minister Mansukh Mandaviya in Vadodara, Gujarat, on May 5.

As per the report, after Andaman & Nicobar where the percentage of "households with at least one member covered by a health insurance" was recorded at 1.8 percent, J&K has the second lowest percentage of



such households as only 14 percent households have at least one family member who is covered under a health insurance.

However, besides being the second lowest across India, J&K still lacks behind 27 percent than the national average of

such cases, which itself reveals J&K's drastic hesitancy towards having health insurance. A superficial look at the data

ance coverage in J&K among both men & women was 13.8 percent where rate for men was recorded at 10.9 percent while for women, the rate stood at 2.3 percent. However, bringing forth the details about the hesitancy towards having health insurance, NFHS noted that 45.5 percent have not acquired the insurance because of the long waiting time. "42.6 percent had not acquired insurance due to poor quality, 40.8 percent ignored it due to lack of nearby facility, 16.4 percent hadn't witnessed a convenient facility time, 8.9 percent usually don't More on P6

Heatwaves, Floods And Heavy Rain **India Battling Climate Change And It Is Getting Worse, Warn Experts**

The spectre of climate change is here to stay and even worsen, say climate scientists as searing winds blow across swathes of north India, including New Delhi where temperatures have crossed 49 degrees Celsius, and flash floods ravage parts of the northeast.

A day after two weather stations in Delhi saw temperatures of more than 49 degrees Celsius and neighbouring Gurgaon registered 48 degrees Celsius, the highest since May 1966, experts on Monday analysed the incidence of extreme weather events and sounded a dire warning.

"With increasing temperatures as a result of global warming in South Asia and the consequent exceeding levels of heat and humidity, it is predicted that we will have more intense, longer and frequent heat waves in India," environmentalist and climate scientist Shakil Ahmad Romshoo told PTI in a phone interview from Srinagar.

According to the University of Kashmir professor, one indicator of climate change is the increasing frequency of climate extremes. A heat wave, he said, is a climate extreme and a direct indicator of climate change.

"Over the last few decades, global warming has been on an accelerated pace and its marks can be seen in any single day of global weather since the 2000s. Generation Z has never lived a day without feeling the influence of global warming," added Roxy Mathew Koll from the Indian Institute of Tropical Meteorology in Pune.

The national capital recorded its second hottest April this year since 1951 with a



monthly average maximum temperature of 40.2 degrees Celsius. Other north Indian states, including the hill areas of Uttarakhand, Himachal Pradesh, Jammu and Kashmir and Ladakh, also recorded temperatures way above the normal level this season.

While north India battled high temperatures, parts of Kerala and Lakshadweep islands saw heavy rainfall on Sunday. Besides, the weather office sounded a red alert across five districts in Kerala. And in the east, Assam's Dima Hasao district has been hit by flash floods and massive landslides at several places, snapping rail and road links.

According to Indian Meteorological Department data, the average maximum temperature over northwest and central India for April this year has been the highest in 122 years.

A 4.5 to 6.4-degree departure from normal is considered to declare a heat wave and over 6.4-degree departure for a severe heat wave. Regardless of local weather interactions,

Koli explained, the root cause for increase in such events in the India-Pakistan region is global warming due to human-made carbon emissions.

"March 2022 was India's hottest March in recorded history (1901-2022). The temperatures were high in entire India, especially the northwest regions that underwent a heat wave. Temperatures continued to run significantly above normal in April 2022

over large parts of India, excluding south India," Koll told PTI in an email interview. The Earth's average temperature has increased by 1.2 degrees Celsius above preindustrial levels, said global climate change expert Harjeet Singh.

The Intergovernmental Panel on Climate Change (IPCC) Report released in 2021 warned that rising temperatures will lead to increased incidence of heat waves, longer warm seasons and shorter cold seasons, Singh, senior advisor, Climate Action Network-International (CAN-I), told PTI over phone.

The experts added that climate change is not only raising temperatures and making India's heatwaves hotter, but also changing weather patterns that further drive dangerous weather extremes.

The low pressure anomaly caused by the weather event know as La Nina over the Indian subcontinent has been inviting westerly winds and the blast of hot air from the Middle East into India.

The north-south pressure pattern has been persisting over India, with La Nina extending its stay over the Pacific. This has definitely impacted the weather over India, which has been seen even during 1998-2000 when La Nina had persisted for three years," said Raghu Murtugudde, professor, department of atmospheric and oceanic science, University of Maryland, US.

We did see some strange weather activities this year as well which include duststorms over Mumbai, early deep depressions out of which one even became feeble cyclone and the heatwaves... all part of this weird and extended persistence of La Nina," Murtugudde said

City's Civil Service Coaching Centre Faces Fee Harassment Charge

Police Arrests 3 Gamblers, Srinagar: Shabir Ahmed Mir, a graduate from Budgam studying to become a civil servant, has accused "Ignited Minds" of harassment over of Rawatpora, Hakeem

pending fee installment. The said coaching centre is an uptown Srinagar-based Institute offering preparatory courses for civil service examinations.

For civil services examinations, the Institute has a norm of accepting fees within two Installments. But after Shabir's request, it agreed to take the fee in three segments.

Shabir was entitled to pay an amount of Rs 78,000 in three installments, of which he paid Rs 32,000 as first installment. After attending classes for a month. Shabir was told to pay another installment.

"I failed to pay the second in-

stallment in time and that is when the harassment started," Shabir told Kashmir Observer.

Due to financial restrictions, he sought more time to pay the fee but he said his request was denied.

"On 16th April, I was called out of the class for not paying the fee on time," he said.

Let down by what Shabir calls "marginalizing behavior" of the Institute he did not feel like studying at the Institute anymore.

However, talking to Kashmir Observer, Ignited Minds Director Waseem Raja denied the accusations and said that students are entitled to pay a fee within two installments.

"In case of Shabir, we agreed to take a fee within three installments as requested by Nazir who happened to be faculty member at the Institute," Waseem said.

"The student not only failed to pay the fee on time but also misbehaved with the faculty members at the Institute and his brother threatened me with severe consequences.'

Waseem said he reported the issue at Police Station Baghat. In charge SHO Police Station Baghat Mukhtar Ahmad told Kashmir Observer that he talked to both the parties and the issue has been resolved amicably.

"The Institute has agreed to give more time to Shabir to pay the fee, no further action is needed,' the SHO told Kashmir Observer.

Meanwhile, another student, Adil Rasheed from Khan Sahab Bud gam said that he paid an amount of Rs 80,000 as fee for a year and was denied a refund by the Institute.

"I was not satisfied with the level of teaching, so I requested them to change the faculty or refund the fee, they denied both," said Adil, who is no longer interested in joining classes at the Institute.

As Mariupol falls

s the Russia-Ukraine war is due to complete its third month, there are no signs that it will wind down anytime soon. In the latest development, Russia has strengthened its control over the besieged city of Mariupol. Ukraine has confirmed that hundreds of its fighters trapped for more than two months in Mariupol's Azovstal steelworks have been evacuated. Russia, on the other hand, said that 265 Ukrainian soldiers, including several dozen wounded troops, surrendered. Does this change anything fundamentally on the war front in Ukraine? Not necessarily.

It is apparent now that Kremlin's war effort has stalled or remarkably slowed down in recent weeks after the NATO-backed Ukrainian Army put up stiff resistance to Russian advances. The capital Kyiv still remains out of bounds for Moscow. Russia has now focussed more on the East and South of Ukraine but the gains it is making are still very feeble. So, the war is likely to frag on. The stakes for Russia and NATO are too big to be seen as losing the war. Russian president Putin has already signaled, that he is prepared to use nuclear weapons. And the west, on the other hand, is not ready to blink.

But for the west or the US-led world order, the Russian invasion of Ukraine is nothing short of an existential challenge. Even a negotiated settlement let alone the Russian victory will re-order the world and shift the balance of power away from the US. So, for the west, the war basically is not about Ukraine, at stake is its own dominance of the world.

Meanwhile, the war is causing a humanitarian catastrophe in Ukraine. Millions of people have fled the country and they are painting a horrible picture of the state of affairs prevailing back home. Considering that the west has shown no sign of backing down let alone make calls for negotiations to address mutual concerns, the war is looking set to continue.

Russia too has shown no signs of being mellowed by the sanctions. But the war so far seems to have not gone according to Putin's calculations. Russia appears far from taking control of Kyiv, the capital of Ukraine. West has, meanwhile, armed Ukrainian forces with the latest weaponry which is believed to be mainly responsible for halting Buggie compared week to mourn the killing of iconic Al Jazeera journalist Shireen Abu Akleh. But amid our grief, we are forced to witness how western media outlets, yet again, are failing us. When a Palestinian is killed by Israeli forces, the act is always described in passive

is always described in passive terms. We just die on our own; no one kills us. Sometime, we die as collateral damage in "clashes", with no context given as to how the altercation broke out or the power imbalance at play.

Then comes the automatic adoption of Israeli talking points, which are always manipulative. Israel's strategy is to immediately deny responsibility, then to cast doubt on Palestinian testimonies, laying the groundwork for the assertion that there are "two versions" of the story. The media then repeats this uncritically.

On the day Abu Akleh was executed, I listened to the BBC World Service for a couple of

the matter independently. Palestinians have every reason to distrust Israel, which habitually uses such investigations to bury cases - but western media do not appear to care about this vital context.

Digging deeper

The skewed coverage continued even during Abu Akleh's funeral. After Israeli forces attacked Palestinian mourners, with live footage showing a deliberate and unprovoked killing, are not accepted without further validation from Israeli rights groups such as B'Tselem or news sources such as Haaretz.

Even then, when the western media can no longer avoid exposing Israel's lies, they may add a few lines to their stories here and there - but when the integrity of these stories is truly crucial, in the hours immediately following these types of events, reporters habitually stick to Israel's propaganda.

The PA initially denied having been contacted by Israeli authorities, but the media continued to report what Israel had said.

Most international media adopted the same lines, almost as though they had written their pieces collaboratively on a joint Google doc.

While being sure to air all of Israel's talking points, however, western media failed to give the same consideration to the Palestinian side. On Thursday, the PA explained why it had refused to participate in an investigation alongside Israel, seeking instead to probe reporters instead help Israel to shroud events in ambiguity. And no matter what comes next - even if the next story includes a line about the Palestinian response - the first impression has already been set.

In Abu Akleh's case, little effort was needed to debunk the Israeli version of events. She was accompanied by several other journalists whose testimony aligned. They all said the same thing: Abu Akleh was targeted by an Israeli sniper. Unfortunately, it would seem that the words of Palestinian journalists are not sufficiently credible for western media.

Testimony from journalists such as Shatha Hanaysha, who was next to Abu Akleh when she died; Ali al-Samoudi, who was also shot and wounded in the incident; and Mujahid al-Saadi, who also witnessed the mediately cite Russian shelling. Ukrainian sources and journalists are considered credible enough to quote on their own, and a Russian response is not needed, nor are there calls for an investigation to determine who was at fault.

This double standard exposes the complicity of western media in covering up Israeli crimes. Ending this complicity would not require much - just for international media to treat Palestinians, including journalists, with the respect they have earned.

Smoking affects the stomach-lining and intestines, and creates severe digestive problems. The smoke that goes in contains not only nicotine, but also soot (carbon particles) that is deposited on the walls of lungs. This reduces the capacity to breathe to a great extent and ultimately leads to diseases such as emphysema and chronic bronchitis. Tar, which is a residue of burnt cigarette paper, is a carcinogen. This can lead to cancer of lungs and oesophagus. However much the thrust is on this anti-social practice, hardened smokers are re-

luctant to shun this pernicious habit.

There is a perceived notion among smokers that smoking keeps them brisk all through the day. On the contrary, cigarette smoking does make one lazy, as it affects the area of the brain responsible for motivation. This is one piece of legislation that India should get right by all means, lest we legalise snooping and profiling by the government.

Between Grief and Grieving How your brain copes with grief, and why it takes time to heal

The "we" is as important as the 'you" and "me," and the brain, interestingly, really does encode it that way. So when people say "I feel like I've lost part of myself," that is for a good reason. The brain also feels that way, as it were, and codes the "we" as much as the "you" and the "I."

work or getting dinner on the table for their kids or they're not able to, say, listen to music because it's just too upsetting. So these types of concerns suggest it would be helpful to intervene and get them back on the healing trajectory where they will still feel grief, but they will adapt to it differently. The older term that we were using for a long time was "complicated grief." And although prolonged grief disorder is the term we've settled on, there's a reason that I like the term complicated – because it makes you think of complications. As an example, one of those is the grief-related rumination that people sometimes experience. The better term for that that people will recognize is the "would've, should've, could've" thoughts. And they just roll through your head over and over again. The problem with these thoughts – we sometimes call "counterfactuals" - is that they all end in this virtual scenario where the person doesn't die. And that's just not reality. And so, by spinning in these thoughts, not only is there no answer – there are an infinite number of possibilities with no actual answer of what would have happened – but it also isn't necessarily helping us to adapt to the painful reality that they did die. And so our virtual version is not really helping us to learn how to be in the world now. It's less than 10% of people who experience prolonged grief disorder. And what that means is 90% of people experience difficult grief and suffering, but don't have a disorder after losing a loved one. I think it's so important to remember that ... because we don't want to hide grief away ... in a psychiatrist's office or a counselor's office, except in indications where that would be helpful to get people back on track.

small aspects of a birthday or a Christmas celebration – an empty seat at the dinner table, one less gift to buy or make – can serve as jarring reminders of how our lives have been forever changed. Although these realizations are hard to face, clinical psychologist Mary-Frances O'Connor says we shouldn't avoid them or try to hide our feelings

"Grief is a universal experience," she notes, "and when we can connect, it is better."

O'Connor, an associate professor of psychology at the University of Arizona, studies what happens in our brains when we experience grief. She says grieving is a form of learning one that teaches us how to be in the world without someone we love in it. "The background is running all the time for people who are grieving, thinking about new habits and how they interact now."

Adjusting to the fact that we'll never again spend time with our loved ones can be painful. It takes time - and involves changes in the brain. "What we see in science is, if you have a grief experience and you have support so that you have a little bit of time to learn, and confidence from the people around you, that you will in fact adapt.'

O'Connor's upcoming book, The Grieving Brain, explores what scientists know about how our minds grapple with the loss of a loved one.

INTERVIEW HIGHLIGHTS ON THE GRIEVING PROCESS

When we have the experience of being in a relationship, the sense of who we are is bound up with that other person. The word sibling, the word spouse implies two people. And so when the other person is gone, we suddenly have to learn a totally new set of rules to operate in the world.

ON THE DIFFERENCE BE-TWEEN GRIEF AND GRIEVING

Grief is that emotional state that just knocks you off your feet and comes over you like a wave. Grieving necessarily has a time component to it. Grieving is what happens as we adapt to the fact that our loved one is gone, that we're carrying the absence of them with us. And the reason that this distinction makes sense is, grief is a natural response to loss – so we'll feel grief forever. A woman who lost her mother as a young person is going to experience that grief on her wedding day because it's a new moment where she's having a response to loss.

But "grieving" means that our relationship to that grief changes over time. So the first time, maybe even the first 100 times, you're knocked off your feet with grief, it feels terrible and awful and unfamiliar. But maybe the 101st time, you think to yourself, "I hate this, I don't want this to be true. But I do recognize it, and I do know that I will get through the wave.'

ON THE EMOTIONS INVOLVED IN GRIEVING

The range of emotions that someone experiences when they're grieving is as long a list as the range of emotions we have in any relationship. Commonly there's panic, there's anxiety, there's sadness, there's yearning. But what we sometimes forget is that there's also difficulty concentrating and confusion about what happens

next. I am often struck by the intensity of the emotions. Grief is like someone turned up the

volume dial all of a sudden. The emotion that I think often interferes with our relationships and friendships when we're grieving is anger, because the anger feels so intense. You have someone blow up at a dinner party and you think, "What's happening with them?" And then to try and remember, "Oh, they're grieving and everything is amped up a little bit."

ON WHAT IS HAPPENING IN OUR BRAINS

We have neuroimaging studies basically of grief, of the momentary reaction where you have that emotional yearning experience. There are less than

a handful of studies looking at more than one moment in the same person across time - so looking at their grieving trajectory. What we know right now in these early days of the neurobiology of grief is really coming from snapshots.

Having said that, one of the things that we know is that grief is tied to all sorts of different brain functions we have, from being able to recall memories to taking the perspective of another person, to even things like regulating our heart rate and the experience of pain and suffering. So lots of different parts of the brain are orchestrating this experience that we have when we feel grief.

ON PROLONGED GRIEF

When you're knocked over by that wave of grief, you want to know, "When will this end?" From a research perspective, there is a very small proportion of people who might have what we now call prolonged grief disorder, something we start looking for after six months or a year [after a death or loss]. ... And what we are seeing, [in such cases], is that this person has not been able to function day to day the way that they wish that they could. They're not getting out the door to

One of the topics I think is not much in the national conversation is that so many of the deaths of our loved ones happened in hospitals, emergency rooms and ICUs – and we weren't there to see it. And that is for a very good reason, because we were trying to stop the spread of COVID. So having family members in hospitals did not make sense.

But it means that people are without these memories of watching their loved one become more ill and watching those changes that happen in their body that prepare our mind for the possibility that they might die. To go through that process without those memories makes it much harder to learn what has happened. So many people feel it hasn't really sunk in yet that they're gone.

What I don't hear very often is the fact that with CO-VID, the loved ones that are left behind made the sacrifice of not being with their loved ones in the hospital in order to stop the spread. And that sacrifice needs to be recognized, I think. In part to help people heal, so that it's understood why they're having such a difficult time. And to elevate the understanding that they did something for the greater good and they gave up something while they did it.

Clashes Break Out In Tripoli, Drive Rival Libyan PM Away

Cairo: An attempt by one of Libya's rival prime ministers to seat his government in the capital of Tripoli triggered clashes Tuesday between competing militias, forcing the newly appointed premier to leave the city.

The development underscored the fragility of the situation in the war-wracked country while the two rival prime ministers traded accusations for the escalation. Prime Minister Fathi

Bashagha's office said he had arrived in Tripoli with a number of Cabinet ministers early Tuesday three months after his appointment to lead an interim government.

The move was likely to fuel more tensions between Libya's rival administrations and in the morning, local media reported clashes between different militias and rival forces in central Tripoli and elsewhere in the city.

The Tripoli-based govern-ment of embattled Prime Minister Abdul Hamid Dbeibah slammed his rival, describing Tuesday's developments as an armed group's desperate attempt to spread terror and chaos in the Libyan capital a reference to Bashagha.

Residents reported hearing heavy gunfire across the city. There was shooting and gunfire everywhere, said Salim Ahmed, a schoolteacher. Some Tripoli schools suspended classes.

Bashagha's office said he and his ministers later left Tripoli for the sake of the security and safety of citizens and to stop the bloodshed. Bashagha tweeted that they had entered the city peacefully, without using violence but were met with a dangerous military escalation from armed groups loyal to his rival.

The U.N. special adviser on Libya, Stephanie Williams, urged calm and for rival parties to engage in talks to resolve their disputes.

Conflict cannot be solved with violence, but with

dialogue and mediation, she tweeted, adding that the United Nations is ready to host all parties in helping Libya find a genuine, consensual way forward towards stability and elections.

Bashagha, a former interior minister, was named prime minister by the country's eastbased parliament in February. But Dbeibah, a wealthy businessman, has refused to step down, insisting he will hand over power only to an elected government. Both hail from the power-

ful western city of Misrata. Jalel Harchaoui, a Libya researcher, said the violence that unfolded during Bashagha's brief presence inside Tripoli" reflected his clear failure." Dbeibah enjoys the support of well-financed armed groups not only in the capital but also in Misrata that are fierce opponents of east-based military commander Khalifa Hifter, with whom Bashagha is now aligned, said Harchaoui.

The latest violence is likely to undermine ongoing talks in the Egyptian capital between east-based parliament and the High Council of State, an advisory body from western Libya, on constitutional amendments for elections.

The U.S. Embassy urged Libya's rivals to agree on a constitutional basis leading to presidential and parliamentary elections in a realistic but aggressive timeframe.

The only viable path to legitimate leadership is by allowing Libyans to choose their leaders. The constitutional talks underway in Cairo are now more important than ever, it tweeted.

Over the weekend, rival militias clashed in Tripoli's neighborhood of Janzour. No casualties were reported but local authorities said there was damage to infrastructure,

including a power plant. The U.N. mission in Libya condemned the clashes, and said they involved indiscriminate fire and the alleged use of heavy weapons in the densely

populated neighborhood.

Govt Extends April GST Payment Deadline Till May 24

New Delhi: As taxpayers face technical glitches on the GST portal, the government on Tuesday extended the due date for April tax payment till May 24 and has directed Infosys for early resolution of the problem. The due date for filing FORM

GSTR-3B for the month of April 2022 has been extended till 24th May 2022, the Central Board of Indirect Taxes and Customs (CBIC) said in a latenight tweet.

Earlier in the day, the CBIC had said that a technical glitch has been reported by Infosys in the generation of April GSTR-2B and auto-population of GSTR-3B on the portal. "Infosys has been directed

by Govt for early resolution. Technical team is working to provide GSTR-2B & correct auto-populated GSTR-3B at the earliest," the CBIC tweeted.

GSTR-2B is an auto-drafted Input Tax credit (ITC) statement

which is available to every GST registered entity based on the information furnished by their suppliers in their respective sales return form GSTR-1.

GSTR-2B statement is usually made available to businesses on the 12th day of the succeeding month, based on which they can claim ITC while paying taxes and filing GSTR-3B. GSTR-3B is filed in a stag-

gered manner between 20th, 22nd and 24th of every month for different categories of taxpayers.

"Considering the difficulties faced by taxpayers in filing their GSTR-3B for the month of April 2022, a proposal to extend the due date of filing GSTR-3B for April 2022 is under active consideration," the CBIC tweeted.

On Sunday, GST Network, which provides the technology backbone for Goods and Services Tax, had issued an advisory saying that in a few cases, certain records are not

reflected in the GSTR-2B statement for the period of April 2022 and asked taxpayers to file GSTR-3B return on a selfassessment basis.

"The technical team is working to resolve this issue for the impacted taxpayers and generate fresh GSTR-2B at the earliest. In the interim, affected taxpayers interested in filing GSTR-3B are requested to file the return on a self-assessment basis using GSTR-2A," the GSTN had said. GSTR-2A is a system-generated statement of inward supplies.

In 2015, Infosys was awarded a Rs 1,380 crore contract to build and maintain the GST system.

Hezbollah, Allies Lose **Their Majority In Lebanon** Parliament

Beirut: Lebanon's militant Hezbollah group and its allies have lost the parliament majority they had held since 2018, according to final results from the Lebanese elections released Tuesday. Hezbollah's most vocal opponents and more than a dozen independents have made gains, the results show.

The Hezbollah-led coalition won 61 seats in the 128-member legislature, a drop of 10 members since the last vote was held four years ago. The loss was largely due to setbacks suffered by Hezbollah's Christian partners, the Free Patriotic Movement founded by President Michel Aoun, and several of Hezbollah's traditional allies who lost seats.

The biggest winner turned out to be the nationalist Christian Lebanese Forces party led by Samir Geagea, one of the harshest critics of Hezbollah and its Iranian backers. Another big winner is Druze leader Walid Joumblatt whose group won all eight seats they were running for.

The Lebanese Forces now has the largest bloc in parliament with 19 seats, overtaking Hezbollah's main Christian allies of the Free Patriotic Movement. The movement now holds 17 seats, a drop of three seats from the previous vote.

Despite the setback, Hezbollah and its main Shiite ally, the Amal group of Parliament Speaker Nabih Berri, retained the 27 seats allocated to the Shiite sect.

Independents and newcomers, including those from the 2019 protest movement, scooped 14 seats. That was a major achievement considering they went into the vote fragmented and facing intimidation and threats by entrenched mainstream parties.

Their showing sends a strong message to ruling class politicians who have for decades held on to their seats and despite an economic meltdown that has impoverished

the country and triggered the biggest wave of emigration since the 1975-90 civil war.

The results also portend a sharply polarised parliament, divided between pro and anti-Hezbollah lawmakers who will find it difficult to work together to form a new government and pass laws needed to to enact reforms for a financial recovery in Lebanon.

With two main blocs Hezbollah and the Lebanese Forces opposed to each other, analysts said the results could lead to more paralysis at a time when the country desperately needs unity.

The spokesman for the UN Secretary-General, Stephane Dujarric, called for the swift formation of an inclusive government that can finalise an agreement with the International Monetary Fund and accelerate the implementation of reforms necessary to set Lebanon on the path to recovery.

The UN urged the new Parliament to urgently adopt all legislation necessary to stabilize the economy and improve governance, Dujarric said.

The biggest loss came to Hezbollah's allies with close links to Syrian President Bashar Assad's government, including deputy parliament speaker Elie Ferzli, Druze politician Talal Arslan who had held a seat for three decades, Asaad Hardan and Faisal Karami, son of late premier Omar Karami.

Sunday's parliamentary elections were the first since Lebanon's economic meltdown began in late 2019. The government's factions have done virtually nothing to address the collapse, leaving Lebanese to fend for themselves as they plunge into poverty, without electricity, medicine, garbage collection or any other semblance of normal life.

He also stressed for enhancement of mobile connectivity along the yatra route as he directed that earth moving equipment should be placed at vantage points to clear the route in case of landslides.

This is the first yatra after the COVID-19 pandemic and due to the high altitude, adequate arrangements will have to be made for yatris who have any health-related problems, he said.

The home minister asked for an adequate number of oxygen cylinders, medical beds at an altitude of more than 6,000 feet and deployment of ambulances and helicopters to deal with any emergency medical situation.

All categories of transport services should be increased during the Amarnath Yatra for the convenience of passengers.

During the meeting, it was also decided to enable WiFi hotspots to ensure connectivity throughout the 39 km of the yatra route from Pahalgam in south Kashmir. The other route is through Baltal in central Kashmir where a pilgrim treks for nearly 15 km.

The yatra, which presents a big security challenge for the government, could not take place in 2020 and 2021 due to the coronavirus pandemic and was cut short in 2019 just before the abrogation of Article 370.

About three lakh pilgrims are likely to take part in the pilgrimage that is expected to end on August 11.

About 12,000 paramilitary personnel (120 companies) in addition to Jammu and Kashmir Police are expected to be deployed along the two pilgrimage routes, one from Pahalgam and the other via Baltal, officials said.

Drone cameras will help the security forces to ensure the protection of the pilgrims.

Besides the Amarnath pilgrimage, the meetings also reviewed the security arrangement especially in the wake of several targeted killings, including of Kashmiri Pandits, in Kashmir.

There has been a spurt in attacks on non-Muslims and outsiders living in the Kashmir valley since the abrogation of Article 370 of the Constitution in August 2019 which accorded special status to Jammu and Kashmir.

The security review comes following a spate of killings in the union territory.

On May 12, Bhat, a government employee, was killed by militants inside his office in Budgam district. A day after, police constable Reyaz Ahmad Thokar was shot dead by militants at his residence in the Pulwama district.

Also last week, four pilgrims were killed and at least 20 injured when the bus they were travelling in caught fire near Katra in Jammu. Police suspect a sticky bomb might have been used to trigger the fire.

Pertinently, a year after abrogation of Jammu and Kashmir's special status, the government in 2020 identified 183 places, including 67 spots in the Kashmir Valley for opening up liquor outlets on a large scale.

IGP Vijay Kumar, who visited the protestors at two sites, urged Kashmiri Pandits not to leave the valley under fear as it would be a victory for "Pakistan and terrorists".

"You don't have to be scared, you should not leave from here. If you go to Jammu or any other place, that is the agenda of Pakistan and terrorists. So we have to work together to defeat the agenda of the enemy," he said.

Kumar said there will be a permanent peace in Kashmir in the near future.

"Police, army and CRPF together will eliminate all of them (terrorists) within one-anda-half year. A permanent peace will come by eliminating the militants, for that you will have to be patient and not get carried away by political parties," he added.

The IGP asked the protestors to vacate the road at Anantnag and hold the sit-in protest inside their colony due to safety concerns.

"I have visited the other camps also, they are protesting there as well but within the colony. Sitting on the road is dangerous as the militants can throw a grenade while passing by on a bike or in a cab," he said.

Kumar told the protestors that protesting is no crime or sin. You should protest but not on the road .

"There are two aspects one is to provide security and the second is to follow the standard operating procedure. This is totally unsafe to going on with respect to the security of the migrant employees.

"The security of the camps (colonies) will be enhanced. Employees posted in remote areas will be brought to the district headquarters.

"Besides providing security, the other aspect is to reduce the number of terrorists. Right now their numbers have come down significantly out of frustration they are hitting soft targets like off-duty policemen or minority community members or migrant labourers," he added.

KP Couples
