'TERROR' FUNDING CASE **Delhi Court Convicts Yasin Malik** Quantum Of Sentence To Be Announced On May 25

NEW DELHI: Chief of banned JKLF Yasin Malik was on Thursday convicted by a Delhi court under the stringent antiterror law in a case related to funding of militant activities in Jammu and Kashmir, after he pleaded guilty to all charges framed against him, news reports said.

Special Judge Praveen Singh posted the matter for May 25 to announce the quantum of punishment and also directed the National Investigation Agency (NIA) to assess Malik's financial condition to determine the amount of fine that could be

imposed. After the charges were framed in March, Malik on May 10 informed the court that he would not be contesting the charges levelled against him, including section 16 (terrorist act), 17 (raising funds for the terrorist act), 18 (conspiracy to commit terrorist act), and 20 (being a member of terrorist gang or organisation) of the Unlawful Activities (Prevention)

New Delhi: Union Home Minister Amit Shah said on Thursday that Prime Minister Modi abrogated Jammu and Kashmir's semiautonomous status with the snap of a finger in August 2019, showing how change comes if someone keeps the nation as a priority

"Prime Minister Modi abrogated Article 370 and Article 35A with the snap of a finger on August 5, 2019. Those who had said that there would be a bloodbath (khoon ki nadiyaan bahengi) could not even indulge in stone-pelting," Shah said here on Thursday.

He made these remarks while addressing the inaugural session of a three-day



international seminar on "Revisiting The Ideas of India from Swaraj' to New India'' at the Delhi University.

Kashmiri Women Have Cellphone Edge Over Their Metropolitan Counterparts

utting speculations to rest, fresh figures have revealed that women in Jammu and Kashmir are more advanced in using technology like cellphones than their counterparts in the much populous and progressive metropolitan cities of India.

This was revealed by a new data by Stats of India-an independent e-resource providing socio-economic statistical information of India.

According to the data, 75.2 percent women in Jammu and Kashmir own a mobile phone which is the 12th highest ratio in India.

Saudi Arabia Bans Carrying ZamZam Water In Bags

MAKKAH: Amid the restrictions that are currently still imposed on Hajj and Umrah pilgrims, Saudi authorities have now also banned the carrying of bottles of ZamZam holy water in checked-in baggage ahead of Dhul Hijjah, the holy month for the Islamic pilgrimage of Hajj.

On Tuesday, the General Authority of Civil Aviation (GACA) issued a notification of new guidelines officially banning Hajj and Umrah pilgrims from bringing bottles of ZamZam water inside checkedin baggage back to their countries.

Checked-in baggage is the luggage delivered to an airline for transportation. It is inaccessible to the passengers during the flight. Pilgrims usually carry ZamZam bottles inside checked-in baggage and carry-on baggage.

The advisor dated May 17 obliges all airlines operating in Saudi Arabia to strictly ensure that no passengers traveling through Jeddah or any other airport in the Kingdom carry bottles filled with ZamZam water.

If any violation of the circular issued by GACA is found, it will be considered an explicit violation of the Government's orders. Strict legal action will be taken against violators who are caught violating the circulars.

Climate Change Making Extreme Heat Waves In India 100 Times More Likely: Study

limate change has made the record breaking heat waves in India and Pakistan over 100 times more likely, and also increased the chances that such events will occur more frequently in the future, according to a study by the UK Met Office.

The analysis released on Wednesday means extreme temperature events once expected every three centuries are now likely to happen every three years.

The study estimated the chances of exceeding the record temperature witnessed in April and May in 2010 -- which saw the highest combined average April and May temperature since 1900.

The attribution study, which determines the influence of climate change on a particular weather event, shows that the natural probability of a heat wave exceeding the average temperature in 2010 was once in 312 years. However, in the current climate scenario that accounts for climate change, the probabilities increase to once in every 3.1 years. The scientists estimated that by the end of the century, the probability of heat wave will increase to once every 1.15 years.

"With temperatures exceeding 50 degrees Celsius in recent days, it is clear the current heat wave is an extreme weather event affecting communities and livelihoods," Professor Peter Stott, Met Office Science Fellow in Climate Attribution, said in a statement.

Although a new record is thought likely, climate scientists will have to wait until after the end of the month -- when all the temperature records for the April-May period have been collated -- to see whether the current heat wave will exceed the levels experienced in 2010.

Spells of heat have always been a feature of the region's pre-monsoon climate during April and May," said Nikos Christidis, who produced the study.

This method of detection is likely to be valuable, not only in the early stages of a pandemic when other resources might not yet be available, but also to help contain an ongoing pandemic, the researchers said. A key finding was that the dogs were less successful at correctly identifying the Alpha variant as they had been trained to detect the wild type. This just goes to show how good dogs are at distinguishing between different scents, they said.

It is thought that dogs are able to detect distinct volatile organic compounds released during various metabolic processes in the body, including those generated by bacterial, viral, and parasitic infections.

The researchers from the University of Helsinki and Helsinki University Hos-pital, Finland, trained four dogs to sniff out SARS-CoV-2 in 2020.

Each of the dogs had previously been trained to sniff out illicit drugs or dangerous goods or cancer.

To test the dogs' detection skills, 420 volunteers provided four skin swab samples each.

The four dogs each sniffed the skin samples from 114 of the volunteers who had tested positive for SARS-CoV-2 on a PCR swab test and from 306 who had test-

ed negative. The samples were randomly presented to each dog over seven trial sessions. The diagnostic accuracy of all samples sniffed was 92 per cent: combined sensitivity -- accuracy of detecting those with the infection -- was 92 per cent and combined specificity -- accuracy of detecting those without

ing that 25 of the 28 (just over 89 per cent) were correctly identified as positive: the lack of symptoms did not seem to affect the dogs' performance, they said. The four dogs were then put to work sniffing out 303 incoming passengers at Helsinki-Vantaa International Airport, Finland, between September 2020 and April 2021. Each passenger also took a

PCR swab test. The PCR and sniffer results matched in 296 out of 303 (98 per cent) of the real-life

samples. The dogs correctly identified the samples as negative in 296 out of 300 (99 per cent) PCR negative swab

tests and identified three PCR positive cases as negative, the researchers said. After re-evaluation with clinical and serological data, one was judged to be SARS-CoV-2 negative, one SARS-CoV-2 positive, and

one a likely post-infectious positive PCR test result, they said.

Similarly, the dogs indicat-ed four PCR negative cases as positive.

These were all judged to be SARS-CoV-2 negative.

Because the prevalence of SARS-CoV-2 among the airport passengers was relatively low (less than 0.5 per cent), 155 samples from people who had tested positive on a PCR swab test were also presented to the dogs.

The dogs correctly identified just under 99 per cent of them as positive. Had these spike' samples

Srinagar: After missing several deadlines in the past nearly one decade, the work on the muchawaited Noorbagh-Qamarwari Bridge is going at snail's pace. The "New Noor Jahan

Bridge" is being constructed at a cost of Rs 957 lakhs and the allotment cost of the approach roads is Rs 398 lakhs. Although the work on ap-

proach road from Noorbagh side of the Bridge has begun, work on approach road from Qamarwari side is yet to kick off. Officials say the Qamarwari

side of the bridge hosts some concrete structures including the Fire Service Station which have to be raised to the ground to pave way for a smooth landing from the bridge.

For city dwellers and people from other towns thronging the city, the ride on the "cement bride" is bumpy as it is full of potholes.

Speaking on anonymity, an R&B official said the contractor who was alloted the Bridge construction delayed the work many times. 'The contract for approach roads has been allotted to an-

other contractor and work is going on in full swing" he added. **Executive Engineer**, Roads

and Building Department, Division I Srinagar Mohammad Masood Mir said there were many reasons the construction of the bridge got delayed.

"There were several reasons behind the stoppage of the work and it took a long time to remove the bottlenecks,"Masood said.

"There were several issues, which took long to be rectified,' he said, adding that the land issue was among the main bottlenecks that halted the work for a longer period.

'Many structures are to be removed and we are already on it." he said.

Grenade, Firing On Fateha Function

2 Killed. 18 Injured As Gunmen Attack Gathering

RINAGAR- Unidentified gunmen attacked a memorial service In Bagh-e-Mahtab on the outskirts of the city this afternoon leaving two people dead and eighteen othersinjured.

The attack was carried out during the fourth day ceremony of the Kashmir Salvation Movement (KSM) chief's brother. Abdul Ghani Bhat, who was shot dead by gunmen on Saturday.

The gunmen struck at around 2:30 pm at Bhat s residence when the KSM chief and former Hizb-ul-Mujahideen divisional commander Zafar Abdul Fatah, was addressing a large number of people gathered there for Fateha khwani, the CNS said

The attackers first hurled a grenade and then opened indiscriminate fire on the gathering, leaving two people, including Fatah and his two brothers Haji Ghulam Muhammad and Basheer Ahmad, injured.

Local residents and the police rushed the injured mourners to the SMHS and the Bones and Joints hospitals

Two of the injured succumbed to their injuries at the SMHS hospital The deceased have been identified as Mirza Aslam Beig, son of Khizir Muhammad a resident of Bagh-e-Mahtab and Imtiyaz Mohi-ud-din son of Ghulam Mohi-ud-din of Lal

Nagar Meethan. The police cordoned off the area and conducted house-to-house searches after the attack but the gunmen had made good their escape before the search operations began

Among the injured where Special Police Officer Basheer Ahmad, Bilal Ahmad of Kralpora. Farooq Ahmad Dar and Mushtaq Ahmad Dar of Naupora. Sopore, Manzoor Ahmad Waar of Handwara, Shahnawaz Ahmad of Parravpora. Manzoor Ahmad of Dagarpora, Handwara, Aijaz Ahmad of Barzulla and Farooq Ahmad Parray and his son Basheer Ahmad of Parravpora

Talking to the CNS. Kashmir's inspector general of police, Javed Makhdoomi, said that a gunman had lobbed a grenade

and opened fire on a mourner's gathering in Shankarpora. Police and the BSF had been deployed in the area, but the assailants opened fire immediately after hurling the grenade, and guards deployed with Zafar Abdul Fatah also fired back, but the attackers escaped during the exchange of fire.

Abdul Ghani Bhat, for whom the memorial service was be ing held, was the elder brother of Zafar Abdul Fatah.

Fatah, whose real name is Zafar Akbar Bhat is a former divisional commander of the Hizb-ul-Mujahideen who was a key figure in the failed talks between Hizb and the Centre in 2000. He launched a separatist political party, Jammu and Kashmir Salvation Movement after giving up violence. He joined the moderate faction of Hurriyat Conference led by Mirwaiz Umer Farooq as a general council member. No militant outfit has claimed responsibility for today's attack or the killing of Bhat on Saturday.

The attack on the mourners came just minutes after several senior leaders' of both factions of Hurriyat Conference had left the house of Bhat after expressing sympathy with the bereaved family, the sources said. Chairman of National Front Nayeem Ahmad Khan, chief of Anjuman-e-Shaire-Shiayan Syed Agha Hassan Jamaat-e- Islami leader Mohammad Ashraf Laway all belonging to hardline faction headed by Syed Ali Shah Geelani and Peoples Political Front president Fazal Haq Qureshi and Ghulam Nabi Shah, of Awami Action Committee, constituents of the moderate faction led by Mirwaiz Umar Farooq had just left the house when the attack took place, the sources said. KO VIEW Inflation Monster

n April, the wholesale inflation in India rose to over 15 percent on an annual basis. Higher fuel and energy prices have contributed to this. The record inflation is affecting the common man badly, more so the lower middle class and poor families. Figures by the department for Promotion of Industry and Internal Trade (DPIIT) present a grim picture. Food articles inflation in April stood at 8.35 percent, up from 8.06 percent in March. Similarly, fuel and power basket inflation rose to 38.66 percent from 34.52 percent in the previous month. The retail inflation in April has been the highest since May 2014 at 7.8 percent. This has meant that the cost of food, transport and healthcare have all risen by 50 percent since the middle of last year forcing people to cut down on their spending to make ends meet.

One major reason for this is the steep escalation in the cost of oil in the wake of the Russian invasion of Ukraine in February. As things stand, the war has caused higher than expected inflation, supply chain disruptions and volatility in financial markets. And India can't be immune to this for long if the war drags on. And this is happening at a time when the world economy was gradually recovering from the debilitating fallout of the Covid-19 pandemic. The countries were slowly opening up and letting the economy function normally. International travel was also returning to pre-pandemic levels. India was taking steps toward a self-reliant economy also called Atmanirbharta. But the war has unraveled it all somewhat. It has set off destabilizing factors that are beyond any country's control as long as the war continues.

The United Nations on Wednesday said India is expected to grow 6.4 percent in 2022, well below the 8.8 percent growth in 2021. On the ground, this would translate into loss of lakhs of jobs at a time when the country is reeling from rampant unemployment. Coupled with inflation, this makes a combustible situation unless the government takes urgent steps to address it. More so, in India when the successive virulent waves of the pandemic have hemorrhaged the economy. The resumption of economic activity to pre-pandemic levels is important to restore the millions of jobs lost to the pandemic. At the same time, the world needs to work together to end the war in Ukraine. That alone will make a redeeming difference to the global economy and in turn to inflation.

In "Kashmir at Crossroads", Sumantra Bose chronicles the situation in J&K following the abrogation of Article 370

The prevailing situation in Kashmir confirms Bose's assessment: the last two years, as the police data reveals, have witnessed a drastic reduction in the influx of foreign militants even while over 500 militants

Sumantra first visited Kashmir as an adult in 1994 to learn about the conflict in the region as part of his studies at Columbia University, Kashmir was in the throes of an all-out separatist struggle. On average, ten people would die every day in militancyrelated incidents. Massacres were not infrequent. Traveling through the region was hazardous. One could run into a cross-fire, bomb explosion or grenade attack, which have since killed thousands of innocent civilians. One could also rest assured of being stopped at security checkpoints every ten kilometers and frisked. Or worse, being put through an identification parade before an informant, a practice perfected in the then ubiquitous military crackdowns across the Valley. This didn't deter Bose. He spent weeks in the Valley to

make sense of the situation as it existed on the ground. This resulted in his first book on the region, The Challenge in Kashmir. The book endures as an authoritative account of the nineties' Kashmir. Ever since, the author has made regular visits to the region to follow the evolving situation and bear an impartial witness to it in his books. It is thus only appropriate that the first book to appear about the situation in the Valley since the erasure of J&K's autonomy on August 5, 2019, be his. In "Kashmir at Crossroads". Bose records the evolving situation in Kashmir after the abrogation of Article 370 that granted J&K its semiautonomous status within the Indian Union. Although much of the book may sound familiar to the local journalists who have witnessed and covered Kashmir in the last two and a half years, Bose's is by far the most objective account of the situation in the region. That said, some narratives about the BJP's Article 370 move that have gained wide currency over the last two years have been more or less uncritically reproduced in the book. One such narrative is that the re-

vocation of Article 370 was the outcome of the BJP's push to fulfill its long-standing ideological agenda and electoral promise. It certainly is that but now largely in a rhetorical sense. More than an ideological goal, the withdrawal has turned out to be a part of an alternative settlement formula for Kashmir, one which does away with Pakistan as a party to the issue. What is more, so far the plan seems to be succeeding, with New Delhi largely crushing the separatist struggle within the Valley.

As for Pakistan, Bose traces its inaction following India's Kashmir move to the country's lack of options. Both war and escalation of sub-conventional warfare in Kashmir are said to

doesn't account for another widely circulated theory that Pakistan assisted the Taliban in driving out the US, still the world's sole superpower, whose ally it ironically was and from whom it received funds to fight the very Taliban.

Where do we go from here? As always, Kashmir is too volatile a place to predict what comes next. The protean nature of armed violence and civilian uprisings often sneak up on us unawares. And as rightly pointed out by Bose, an incendiary escalation of the conflict could be triggered by one or some combination of three eventualities: "Major insurgent strikes in Indian Jammu and Kashmir, largescale deaths from Indian action

OTHER OPINON **Costly Affair**

n Tuesday, data released by the government showed that inflation at the wholesale level had risen to a staggering 15.08 per cent in April, up from 14.55 per cent in March, despite a high base effect. With this latest print, wholesale inflation has now been in double digits for 13 consecutive months. Coming just days after data released by the National Statistical Office that showed retail inflation as measured by the consumer price index had risen to an eight year high of 7.8 per cent in April, this latest data print only reaffirms the inflationary pressures in the economy.

The sharp spurt in wholesale inflation is driven by all major categories - primary articles, fuel and power and manufacturing - indicating how broad-based the price pressures are. All three sub-groups registered double digit inflation in April. The WPI food index has also risen to 8.88 per cent in April on the back of higher prices in vegetables, fruits, milk and spices. Considering that an increase in food inflation at the wholesale level tends to have a "significant" impact on inflation at the retail level, this is a matter of concern. As per the recently released report by the RBI on the state of the economy, high frequency price data on food items for the first half of May (1-12) indicates "an increase in cereal prices, primarily on account of a surge in wheat prices", a hardening of potato and tomato prices, and a "broadbased increase" in edible oils. This is worrying, as Ashima Goyal, member MPC, points out, "the history of past shocks in India shows food and oil price inflation together can give rise to second round effects". On the non-food side, the latest data also shows that manufacturing inflation rose to 10.85 per cent in April, up from 10.71 per cent the month before. With cost pressures on manufacturers continuing to rise, they are likely to pass them further on to end consumers, exerting upward pressure on prices at the retail level. And then there are also concerns over services inflation firming up as demand picks up.

In the first week of May, the monetary policy committee of the RBI had held an off-cycle meeting to raise the benchmark repo rate by 40 basis points to 4.4 per cent to tackle inflation. This implied that hikes of another 75 basis points would be needed just to revert to the pre-pandemic level - MPC member Jayanth Varma has said that "more than 100 basis points of rate increases need to be carried out". Considering current price trends which suggest that inflation will continue to remain elevated, and likely to breach the upper threshold of the RBI's inflation targeting framework for three consecutive quarters, the MPC is likely to frontload the rate hikes. The prevailing situation in Kashmir confirms Bose's assessment. It's Okay to Mess Up

How to stop obsessing over mistake at work

A sking mistakes happens to all of us in our careers. But some of us hold on to these mistakes longer than others.

Maybe you lie awake at night still feeling queasy and anxious over the way you frustrated a client by accidentally giving them the wrong information. Maybe you are avoiding co-workers on your team because you feel like they are all judging you for that error, even though it happened last week. If either of these scenarios sounds familiar, you may be prone to obsessing over mistakes.

What fuels these constant worries is the shame of feeling completely inadequate and fear of others discovering your lack of capabilities, said Tanisha Ranger, a Nevada-based clinical psychologist. Once you start obsessing over mistakes because of your shame, it can steamroll into bigger problems like perfectionism.

"Shame often gives way to perfectionism, and perfectionism makes mistakes feel monumental. Essentially, 'If I don't do everything perfectly right then I am a failure and everyone will see my defectiveness," she said. "I've had many clients who struggled with obsessing over mistakes at work. [They lay] awake at night ruminating and beating themselves up over a mistake, not an intentional or careless mess-up, but a mistake.

There's a better way to acknowledge a mistake while still letting it go. Here's how:

1. PUT THE MISTAKE IN PERSPECTIVE.

After you make an obvious mistake at work, you may want the ground to swallow you up to save you from the embarrassment, shame and anxiety of facing your co-workers again.

If these worries are keeping you up at night, challenge those thoughts by getting more realistic with your thinking, suggested Shannon Garcia, a psychotherapist at States of Wellness Counseling in Illinois and Wisconsin.

"Will the world end? Nope," she said. "Will you get fired? Highly unlikely. Will you receive constructive feedback from your boss? Maybe. Will owning up to your mistake be uncomfortable? Probably. Have you survived past mistakes? Seems like it, if you're reading this. Will you survive this one? Yes!"

Sometimes accidental oversights do hurt your job performance, but it's important to not catastrophize what happened. "Sure, it caused a delay. Yes,

it may have cost the company some money. OK, it negatively impacted job performance. But is it actually the end of your career? Really? Likely not," said Ranger. "Shrinking things down to their right size, not ignoring/suppressing and also not overblowing or exaggerating, is an important part of letting things go."

If it helps, try putting yourself in the shoes of co-workers who have also made mistakes. Once you see the compassion and sympathy you hold for their slip-ups, you may be more inclined to be compassionate about your own.

"When a co-worker has made a mistake in the past, is it something you've judged them immensely for? Did you spend your day thinking endlessly about their mistake? No. People at work are likely reacting the same way," Garcia said. "No one is thinking about this more than you are."

2. LEARN THAT YOU DON'T HAVE TO BEAT YOURSELF UP AS PENANCE. To move past a mistake, you also need to rethink what it means to learn from a mistake. If you think turning over every angle of how an interaction with your boss could have gone better, for example, take a deep breath. Give yourself permission to release those thoughts, said organizational psychologist Laura Gallaher of the consulting firm Gallaher Edge. People ruminate because

they believe there are payoffs

to worrying so much; they think "A conscientious person would worry about this," Gallaher said.

"When you know that you can simultaneously be a conscientious person, and also forgive yourself to move forward, it will be easier to do so."

What Garcia tells her clients the most is "be nice to yourself," she said. Reframe your worries in a more positive light. "The fact that you are anx-

ious about it means you care. That's what your boss, coworkers and customers care about the most," Garcia said. "Try not to beat yourself up over it. Create an affirmation to repeat to yourself whenever those negative self-talk thoughts pop up: 'I accept my mistake, I choose to learn from it, and I am moving forward."" If you are stuck in the world of "could've/should've" in regards to your error, be honest with yourself about what you did not know.

Ranger says she works with some clients by asking them to consider why they supposedly "should have known better." "It's always so enticing to impose our current knowledge and wisdom on a past version of ourselves that could not have known to make that decision with the information we had at that time," she said.

3. DON'T HIDE THE MISTAKE. OWN WHAT HAPPENED, BUT DON'T TAKE ON OTHER PEOPLE'S JUDGMENT, TOO.

"If it was something that inconvenienced them, apologize for it," Garcia said. "Then it's a conversation happening where you are involved, people are likely to be gracious, and everyone can move on from there."

It may sound counterin-

tuitive, but being transparent about your mistake and its impact can be healing. "It can feel like a cold shower — before you do it, you fear it and feel uneasy or anxious," Gallaher explained. "In the moment of being open, it can feel unpleasant at first, but once it's over, you actually feel more refreshed 99% of the time. Taking accountability without blaming anybody is the most healing."

ing." Once you model being open and accountable, it may encourage others to do so as well. "Most of the time, when you lead with self-accountability, that vulnerability is courageous, and courage is contagious: People usually respond with their own self-accountability as well," Gallaher said.

Of course, sometimes being honest about a mistake can also inspire eye-rolling judgment and harsh criticism from mean-spirited colleagues. You should hold yourself accountable for your mistake, but the judgment of your peers is not something you need to take on, too.

"Let them know what you intend to do differently to try to prevent something like this from happening in the future, and then accept that they may move on or they may not. It is outside of your control," Ranger advised. "Taking on other people's emotions is detrimental to yourself and makes it difficult for you to treat yourself with the kindness and compassion you deserve from you."

Finally, Fuller says concern from family or friends should be taken seriously, particularly since people in toxic relationships are often the last to realize it. Brocke says that was true of her relationships, which perpetuated the damage for years. "By the time I actually started realizing I was in something that wasn't healthy, it was so normal to me that it didn't seem like that big a deal," Brocke says. "You get paralyzed in it, because you're just used to it."

It's a common refrain: relationships are hard work. Fights are normal and rough patches are par for the course.

True as that may be, however, these platitudes can distract from legitimate causes for concern in one's social and romantic life — including signs that a relationship may have become, or always was, toxic.

Here's what you need to know about toxic relationships, and how to tell if you're in one.

WHAT IS A TOXIC RELATIONSHIP?

Dr. Lillian Glass, a Californiabased communication and psychology expert who says she coined the term in her 1995 book Toxic People, defines a toxic relationship as "any relationship [between people who] don't support each other, where there's conflict and one seeks to undermine the other, where there's competition, where there's disrespect and a lack of cohesiveness."

While every relationship goes through ups and downs, Glass says a toxic relationship is consistently unpleasant and draining for the people in it, to the point that negative moments outweigh and outnumber the positive ones. Dr. Kristen Fuller, a California-based family medicine physician who specializes in mental health, adds that toxic relationships are mentally, emotionally and possibly even physically damaging to one or both participants.

And these relationships don't have to be romantic: Glass says friendly, familial and professional relationships can all be toxic as well.

WHAT MAKES A RELATIONSHIP TOXIC?

Fuller says people who consistently undermine or cause harm to a partner – whether intentionally or not – often have a reason for their behavior, even if it's subconscious. "Maybe they were in a toxic relationship, either romantically or as a child. Maybe they didn't have the most supportive, loving upbringing," Fuller says. "They could have been bullied in school. They could be suffering from an undiagnosed mental health disorder, such as depression or anxiety or bipolar disorder, an eating disorder, any form of trauma."

That was the case for Carolyn Gamble, a 57-year-old, Marylandbased motivational speaker who says she fell into toxic relationships after a tumultuous childhood marked by losing her mother to a drug overdose, and suffering physical abuse at the hands of her father. When she grew up, she found some of the same themes in her marriage to her now-ex-husband, who she says became verbally and emotionally abusive. "I realized in this life, regardless of the cards that we're dealt, sometimes there are things that we have to let go," she says.

Sometimes, Glass says, toxic relationships are simply the result of an imperfect pairing — like two people who both need control, or a sarcastic type dating someone with thin skin. "It's just that the combination is wrong," she says.

Heidi Westra Brocke, a 46-yearold chiropractor living in Illinois, is familiar with these mismatches. Brocke considers herself an empath and a people-pleaser, and grew up "assuming everybody was nice and everybody wanted what was best for you." Instead, she says her personality attracted controlling partners who forced her to sacrifice her needs for theirs, and constantly work for approval that never came.

Though they had very different stories, both Brocke and Gamble say they endured toxic relationships for years — underscoring that no two bad relationships are exactly alike.

WHAT ARE THE WARNING SIGNS OF A TOXIC RELATIONSHIP?

The most serious warning signs include any form of violence, abuse or harassment, which should be dealt with immediately. But in many cases, the indicators of a toxic relationship are much more subtle.

The first, and simplest, is persistent unhappiness, Glass says. If a relationship stops bringing joy, and instead consistently makes you feel sad, angry, anxious or "resigned, like you've sold out," it may be toxic, Glass says. You may also find yourself envious of happy couples.

Fuller says negative shifts in your mental health, personality or self-esteem are all red flags, too. These changes could range from clinically diagnosable conditions, such as depression, anxiety or eating disorders, to constantly feeling nervous or uncomfortable — especially around your partner. Feeling like you can't talk with or voice concerns to your significant other is another sign that something is amiss, Fuller says.

You should also look out for changes in your other relationships, or in the ways you spend your free time, Fuller says. "You may feel bad for doing things on your own time, because you feel like you have to attend to your partner all the time,"

WHAT SHOULD YOU DO IF YOU'RE IN A TOXIC RELATIONSHIP?

If any of those red flags sound familiar, it's time to take action. If you feel that you're in physical danger, you may need to involve the authorities. The National Domestic Violence Hotline is also available for 24/7 guidance at 1-800-799-7233.

If the harm is emotional or mental, you'll have to decide if it's possible to work through the issue. If underlying triggers such as depression or trauma are influencing one or both individuals' behaviors, Fuller says therapeutic or medical treatments may help. Glass agrees that getting to the root of the problem is important, but says that sometimes, the answer may be to walk away.

"I really am a firm believer that you have to try to work everything out and understand why the person is toxic. You may be able to live with it — but on the other hand, you may not," Glass says. "[If you can't], you've got to get out of it. We have to not put ourselves in that position."

Brocke and Gamble took that advice in their own lives, and both say they're better for it. Brocke is now happily remarried and coaches women who are leaving toxic relationships. Gamble is purposefully single and runs a nearly 7,000-person toxic relationships support group on Facebook.

"Love should never cost you your peace. It should never cost you your joy. It should never cost you your happiness," Gamble says. "If there's more negative in the situation than positive, something has to change."

SC asks Varanasi civil court not to proceed with Gyanvapi hearing till May 20 as counsel indisposed

New Delhi: The Supreme Court on Thursday asked the civil court in Varanasi to not proceed with hearing the Gyanvapi case till it

takes up the matter on Friday. A bench of Justices DY Chandrachud, Surva Kant, and PS Narashima was informed by advocate Vishnu Shankar Jain that lead counsel Hari Shankar Jain for the Hindu devotees in the civil suit is indisposed for Thursday, as he was discharged from the hospital on Wednesday.

We accordingly direct the Trial Court to strictly act in terms of the above arrangement and to desist from taking up further proceedings in the suit in view of the consensus which has been arrived at between the parties, the bench said in its order

The bench directed for the listing of the matter before it on May 20 at 3 pm and said that the Registry may seek the administrative directions of the Chief Justice of India so that the Bench may be constituted.

At the outset, advocate Vishnu Shankar Jain mentioned the matter and urged the court to take up the matter for a hearing on Friday.

Ahmadi, appearing for the Committee of Management Anjuman Intezamia Masjid, said several applications have been filed across the country to "seal" various mosques, and in the Gyanvapi case in Varanasi, the hearing is going on and an application has been filed to "demolish" a wall around the wazukhana' (ablution room).

Ahmadi said he cannot oppose adjournment on the grounds of the health of a counsel but an undertaking should be given that Hindu devotees will not proceed with the civil court proceedings.

He said that it is necessary that the Trial Court which is continuing to hear the proceedings today may desist from doing so until this Court takes up the proceedings on Friday.

Advocate Vishnu Shankar Jain said they are assuring the bench that the Hindu parties would not proceed with the hearing before the civil court at Varanasi and would not press any further until the Court takes up the matter on Friday.

The bench noted in its order that the proceedings have been mentioned by advocate Vishnu Shankar Jain, who appears on behalf of the original plaintiffs, namely, the first to

The original suit was filed in 1991 in the Varanasi district court for the restoration of the ancient temple at the site where the Gyanvapi mosque currently stands.

Foreign Office, in a late-night statement on Wednesday, said that Kashmiri Hurriyat leader Malik is currently imprisoned in Delhi's Tihar jail.

The Indian diplomat was conveyed Pakistan's grave concern that in a bid to suppress the voice of the indigenous Kashmiri leadership, the Indian government has resorted to implicating them in fictitious and motivated cases, it said

The Indian side was also conveyed Pakistan's deep concern over Malik's incarceration in Tihar Jail since 2019 under inhuman conditions , it said.

Pakistan calls upon the Government of India for acquittal of Malik from all baseless charges and immediate release from prison so that he can be reunited with his family, recuperate his health and return to normal life, the Foreign Office said.

Malik recently pleaded guilty to all the charges, including those under the stringent Unlawful Activities Prevention Act (UAPA), before a Delhi court in a case related to alleged terrorism and secessionist activities that disturbed the Kashmir Valley in 2017.

India has repeatedly told Pakistan that Jammu and Kashmir was, is and shall forever remain an integral part of the country. It also advised Pakistan to accept the reality and stop

Minister Modi, India did not have a defence policy. Even if it existed, it was a shadow of foreign policy.

One of the injured persons succumbed to iniuries while one critically injured person was shifted to SKIMS Soura, where his condition is reported to be stable.

During investigation of the attack, police assessed various evidences at the scene of crime and some critical leads came to the fore including the grenade lever, the spokesman said.

'CCTV footage from nearby cameras was also obtained which helped to reconstruct the sequence of events pre and post the incident. On the basis of human and technical intelligence, few suspects were picked up and interrogated," he said.

The spokesman said during sustained interrogation, the breakthrough was achieved by arresting four militants and one of their associate of the so-called "Falcon Squad" module of the LeT.

"On the basis of further investigation and disclosures made by these militants, various locations were raided and multiple recoveries were effected including one motorbike, used in the commission of the militant act," he added.

The spokesman said the consignment of weapons and explosives was received by these militants a few days before they carried out the attack on the wine shop.

"The same group was earlier involved in various militant acts as was disclosed and brought out during the investigation which include last year's grenade attacks in town Baramulla, various firing incidents in and around Baramulla, transportation of proscribed weapons and explosives etc," he added.

Non-subsidised LPG costs Rs 1,002.50 per 14.2-kg cylinder in Mumbai while it is priced at Rs 1,018.50 a bottle in Chennai and Rs 1,029 in Kolkata.

Rates differ from state to state depending on the incidence of local taxes such as VAT. Prices are higher in states with higher taxes.

Alongside, oil firms also hiked the price of commercial LPG cylinders - the ones used by establishments like hotels and restaurants - by Rs 8 per cylinder to Rs 2,354 per 19-kg bottle. On May 1, the price of a commercial LPG cylinder was increased by Rs 102.50 to Rs 2,355.50 but on May 7 it was reduced to Rs 2.346.

International oil prices have been on the rise this year. They jumped to a 13-year high of USD 140 per barrel in March before shedding some of the gains. Brent was trading at USD 110.13 per barrel on Thursday.

To compound things, the Indian rupee tumbled to Rs 77.74 to a dollar, making imports costlier.

India relies on overseas purchases to meet about 85 per cent of its oil requirement, making it one of the most vulnerable in Asia to higher oil prices.

While India has surplus oil refining capacity, it does not manufacture enough LPG to meet domestic demand and imports significant quantities from nations such as Saudi Arabia.

On Wednesday, an oil ministry official stated that the Saudi LPG prices have gone up by 33 per cent while domestic rates have increased by only 11 per cent.

Safe sanitation is one of the foundations of a healthy, comfortable, and dignified life. Households without proper sanitation facilities have a greater risk of diseases like diarrhoea, dysentery, and typhoid than households with improved sanitation facilities that are not shared with other households, the survey notes.

"Six percent of all households and 8 percent of rural households do not use a sanitation facility; they use open spaces or fields. In Jammu & Kashmir, 94 percent of households have access to toilet facilities, with higher accessibility in urban areas (99%) than in rural areas (93%). Access to a toilet facility ranges from 85 percent among scheduled tribes to 96 percent among groups that are not scheduled tribes, scheduled castes, or other backward classes," the NFHS survey reports.

"Access to toilet facility exceeds 80 percent in all districts of Jammu & Kashmir. It varies widely across the districts, ranging from 82 percent in Kathua district (79% in the rural areas) to 100 in Shopian district," it adds—(KNO)

"AAO SCHOOL CHALEIN" Drive Records 1.50 Lakh Enrolment In Govt Schools

SRINAGAR: Fulfilling its commitment towards ensuring inclusive education in Jammu and Kashmir, the government has transferred Rs 165.09 lakh into the bank accounts of eligible Children with Special Needs (CWSN) through DBT in 2022, an official spokesperson said Thursday.

He said these allowances have been disbursed on account of different allowances like escort allowance, reader allowances and stipend for girls.

Besides, he said, a 3 day workshop in collaboration with JKBOSE was organized in March 2022 to extend board accommodations to CWSN on the pattern of CBSE. The workshop was attended by more than 30 experts in the field including from CBSE and NCERT.

"The Right to Education (RTE)

Act, introduced in 2012, allows Children With Special Needs to pursue mainstream education (inclusive education) irrespective of their impairment. The Act says that a child with 'disability', as defined by the Persons with Disability Act 1995 and the National Trust Act, has the right to free and compulsory education as per the provisions of Chapter V of the PWD Act," he said.

Under the Special Enrollment Drive "AAO SCHOOL CHALEIN", the spokesperson said that 1.50 lakh students were enrolled in government schools of Jammu and Kashmir during the winter session.

He said that the drive emphasized on strengthening of preschooling of children in the age group of 3 to 5 years and focus on increasing overall enrollment in government schools by re-enrolment of dropout

students and the children who have never been enrolled in school

"Besides, TALAASH APP has been launched for digitized survey of out of school children to mainstream them. All the drop out and out of School Children shall be mapped with the nearby Educational Institutions so that they may also get the job opportunities after getting proper education," he added.

According to the spokesperson, the School Education Department would soon be launching "Students Mentorship"- Student Teacher Engagement for Educational Reinforcement (STEER) programme. Under the initiative, he said, the teachers shall play the role

of Mentor for every ten students of Primary School in the first phase. He said the idea is to achieve excellence in the education sector besides improving the academic standards in the basic classes.

"The same shall be replicated among the higher classes in a phased manner while evaluation and assessment shall be monitored through Mentoring portal developed for the purpose," he added.

Terming Education as a catalyst for growth and development of the Nation, Lieutenant Governor, Manoj Sinha, underlined the importance of making new educational reforms so that no one remains deprived of this fundamental right of education.

"We are working hard towards bringing in reformative innovations in the education sector to achieve bigger goal like "Education for All", he maintained.

The government is taking comprehensive measures to bridge the social and gender gaps in school education besides ensuring equity and inclusion at all levels to streamline J&K's literacy rate, observed the LG.

Significantly, J&K topped the country under National Initiative for School Heads and Teachers Holistic Advancement (NISHTHA) programme with 80600 Elementary Teachers Trained through online mode using DIKSHA portal.

Emphasizing for capacity building of teachers, Lieutenant Governor asked the School Education Department to rationalize the Pupil-Teacher ratio besides conducting regular training of teachers in order to make them acquainted with the know-how of the modern educational tools which will go a long way in improving the quality of education and enhancing learning outcomes.

PARIS: Record champion Rafael Nadal is locked in an all-time Grand Slam battle with world number one Novak Djokovic going into the French Open but both could end up being upstaged by teenage sensation Carlos Alcaraz. Nadal, a 13-time title-winner on the Parisian red clay, is far from his unstoppable best as he nurses a chronic foot injury that flared up again in the build-up to Roland Garros. The Australian Open champion suffered early exits in Madrid and Rome with his most recent tournament win back in February.

Counting out the wounded 35-year-old Spaniard, however, comes with a risk warning as his comeback win from two sets down over Russia's Daniil Medvedev at this year's Australian Open final proved. Nadal's astounding triumph
