22% Students In J&K Have **Never Attended School: Report**

SRINAGAR: As the fifth and latest round of the National Family Health Survey (NFHS) flagging doubts and questions about various sectors, J&K's education sector is the latest casualty as 22 percent people in Jammu and Kashmir have never attended school, besides the 11 percent population who have attended school for just five years.

Several of J&K's nutritional indicators have worsened since the fourth round of the NFHS, which was held in 2015-16. But the erstwhile state has hit a major demographic

29.9 PERCENT OF FEMALES IN J&K have

never attended school while 15.3 percent of men have never attended school in J&K. However, when compared with the National average, both genders have relatively higher rates.

milestone when the percentage of people in J&K without schooling was found to be 22 percent, according to the latest survey conducted by the

Ministry of Health and Family Welfare between 2019 and 2021.

The data in NFHS 2019-21, the fifth in the series, show that among all age groups, around 6.7 percent of the population who have never attended school is of 0-4 age group and 0.8 percent population is above 80 years of age.

I and University of Sydney colleagues have published a new study showing treating sleep apnoea in older adults with mild cognitive impairment can improve memory, but not other areas of cognition, in the short term.

As there is no current treatment or cure for dementia, increasing efforts have focused on developing novel approaches to slow its progression. Mild cognitive impairment is the stage between the expected cognitive decline of normal ageing and the more serious decline of dementia.

In mild cognitive impairment, the individual, family and friends notice cognitive changes, but the individual can still successfully carry out everyday activities. Mild cognitive impairment is associated with an increased risk of developing demonstration associated was a successful.

Researchers believe this is the optimal time to intervene to help prevent a future dementia diagnosis. Finding new ways to

slow cognitive decline in those with mild cognitive impairment is therefore impor-

How is sleep important for our brain health?

Sleep optimises the ability of our brains to stabilise and consolidate newly learned information and memories. These processes can occur across all the different stages of sleep, with deep sleep (also known as stage 3 or restorative sleep) playing a key role.

We also now know the glymphatic system, or the waste management system of the brain, is highly active during sleep, especially during deep sleep. This process allows waste products, including toxins, our brain has built up during the day to be cleaned out.

Toxins in the brain include beta-amyloid, one of the key proteins in the development of Alzheimer's disease. Disturbing sleep could disrupt this cleaning process and lead to more accumulation of beta-amyloid in the brain.

The important role of sleep in these vital processes has led to the investigation of whether sleep disruption, including sleep disorders, could be associated with chang-

es in our cognition when we age, and a possible link to the development of dementia.

What is sleep apnoea?

Sleep apnoea is estimated to affect 1 billion people worldwide. In Australia, 5-10% of adults are diagnosed with the condition. Sleep apnoea causes the throat (also called the upper airway) to close either completely (an apnoea) or partially (a hypopnoea) during sleep.

These closures or obstructions can range from ten seconds up to one minute and can lead to a drop in blood oxygen levels. To start breathing again, a short awakening occurs without the individual being aware.

In a person living with severe sleep apnoea this process can happen 30 times or more an hour, causing very fragmented sleep. People with sleep apnoea may snore, toss and turn, and others may notice them stopping breathing, choking or gasping for air during sleep.

These repeated disruptions to sleep can cause sleepiness and reduce alertness during the day which, for some people, leads to difficulties performing tasks. Does sleep apnoea increase our risk of dementia?

The sleep fragmentation, as well as the drops in blood oxygen at night time, are a double blow in dementia risk. Studies have shown sleep apnoea to be associated with a 26% increase in the development of cognitive impairment, as well as greater amounts of beta-amyloid in the brain.

However, it is not clear if treating sleep apnoea could reduce this risk.

The gold-standard treatment for sleep apnoea is continuous positive airway pressure therapy, commonly known as CPAP, in which a mask connected to a pump blows continuous air down the upper airway, keeping it open.

When the machine is being used it stops the airway from closing. It is not known whether treating sleep apnoea will reduce the risk of dementia. Our new research, however, shows CPAP could be beneficial for memory in the short term.

Our study aimed to understand whether treating older adults with both sleep apnoea and mild cognitive impairment could improve thinking and memory skills in the short term.

The trial assessed the effect of CPAP

treatment on memory and thinking skills compared to no treatment. This was a crossover study, which means all participants had both CPAP and no treatment during the trial, but at different times. Some had CPAP first, then swapped.

The others had no treatment first, then swapped. Trained staff helped participants get established with the therapy, and after using it for three months, participants underwent a series of cognitive tests.

The researchers found that compared to not treating sleep apnoea, thinking skills were not improved with CPAP, whereas some improvements in memory were observed. This suggests treating sleep apnoea could potentially improve outcomes in the short term, but it is unknown whether it would have any impact on long-term cognitive decline.

A previous study suggested CPAP could slow cognitive changes over one year in older adults with mild cognitive impairment and sleep apnoea. However, studies of longer duration are needed before we can say what the long-term effects look like.

Kids Who Play Adventurously May Have Better Mental Health

hildren who spend more time playing adventurously may have lower symptoms of anxiety and depression, finds a new study.

The study, published in Child Psychiatry and Human Development, indicates that children, aged 5-11, who spent more time playing outside had fewer "internalising problems", characterised as anxiety and depression. Those children were also more

positive during the first lockdown.
"We are more concerned than ever about

children's mental health, and our findings highlight that we might be able to help protect children's mental health by ensuring they have plentiful opportunities for adventurous play," said researcher Helen Dodd from the University of Exeter, who led the

study.

"This is really positive because play is free, instinctive and rewarding for children, available to everyone, and does not require special skills. We now urgently need to invest in and protect natural spaces, well-designed parks and adventure playgrounds, to support the mental health of our children,"

Dodd added

The researchers said that the study sought to test theories that adventurous play offers learning opportunities that help build resilience in children, thereby helping to prevent mental health problems.

For the study, the research team surveyed nearly 2,500 parents of children aged 5-11 years. Parents completed questions about their child's play, their general mental health (pre-Covid) and their mood during the first Covid-19 lockdown.

The research was carried out with two groups of parents, a group of 427 parents living in Northern Ireland and a nationally representative group of 1,919 parents living in the LIK

With No Govt. Jobs In Line, Kashmir's Special Educators In Limbo

Srinagar: In absence of government jobs, special educators from Kashmir say the School Education Department (SED) is putting their careers at stake as the Department has failed to advertise posts.

A Special Educator works with children who have a variety of disabilities.

Children with special needs require unique instruction by "specially trained professionals" to help them achieve their highest potential and progress beyond their limitations.

Special Educators from Kashmir say they have a B.Ed. degree in Special Education but in absence of government jobs they are forced to work for NGOs who pay a small portion of money as salary.

They also say the School Education Department is violating the directions of the Supreme Court as the Apex court had long back directed states across the country to recruit special educators in government run Institutions.

According to reports, In Jammu and Kashmir there are around 20,000 speciallyabled children, 5,000 of which are enrolled in government schools for which the department has availability of only 70 to 80 special educators.

In 2016 more 200 posts were advertised and accordingly only 50 were filled, in 2017 154 were again advertised and

more than 100 posts remained unfilled", said Sajid Rasool, a special educator.

"There are a large number of specially-abled children who need care but in absence of government schools they are forced to get admission to private clinics who charge hefty amounts of money," he

Special educators have pressed for their recruitment as special educators in the School education Department saying that barring J&K many States in India have implemented SC guidelines for recruitment of special educators.

"In absence of special educators in

schools, specially-abled children are suffering" said Irshad Ahmad who aspires to work for children with special needs.

"Only well-off families can afford to send their children to private schools and NGO's" he added.

Samagra Shiksha is an Initiative launched by Government of India for the school education sector extending from pre-school to class 12. It has been initiated with the goal of

improving school effectiveness measured in terms of equal opportunities for schooling and equitable learning outcomes. It subsumes the three schemes of Sarva Shiksha Abhiyan (SSA), Rashtriya Madhyamik Shiksha Abhiyan (RMSA) and Teacher Education (TE).

Talking to Kashmir Observer, Deep Project Director Samagra Shiksha said that he heads the project and not the government department.

"It is a project and all the posts are contractual. The validation of the current project is till 2025-2026". Deep Raj said.

"The number of contractual posts that were available have already been fulfilled. As of now no new posts are available", he said. "Around 110 special educators are en-

rolled in different institutions and giving their services" he added. Despite repeated attempts, the Commission Secretary Education did not re-

spond to phone calls.

The Tourist **Second Coming**

ITH the third wave abating across India, tourist arrivals in Kashmir have accelerated in recent weeks. According to the official estimate, the arrivals are set to reach a 10-year high this year. Since January alone, more than 340,000 tourists have come. In March, around 1.8 lakh tourists arrived which is an unprecedented number over the last so many years. One of the biggest draws for the tourists is the Tulip Garden, Asia's largest, and also the resorts like Gulmarg, Pahalgam and Dal lake. Most of the tourists visited Gulmarg where the hotels remain booked ever since January. Similarly, the tourist spots like Pahalgam are seeing the rush. But it is Gulmarg which is the go to place. This is because Gulmarg has received most of the publicity. Prospects for tourism are getting better by the day.

But the excessive focus on fewer resorts are drawing tourists away from other equally scenic places, some of them like Aharbal, Yusmarg, Tosamaidan, Gurez, historic old city in Srinagar have only recently found a prominent place on the tourist map of Kashmir. These places need development of tourist infrastructure and also a wider publicity for people to visit. The Tourism department has said that an advertising campaign across major Indian cities and the opening of new destinations were attracting more tourists.

Tourism, one of the mainstays of the Kashmir economy, is one of the sectors that has been hit the hardest. There is a large section of people who have largely been without employment over the last two and a half years. Their savings have already been depleted. For example, the transporters: the drivers and conductors were among the worst-hit. This includes also the people associated with tourism. In 2021, many cases of suicides and suicide attempts took place as a result. The major cause of suicide attempts was financial distress in the families caused by the turmoil of the preceding two years and also by the extended successive lockdowns, two of them the result of the Covid-19 pandemic. Here's hoping that with the abating of the pandemic, the economic situation would return to normal, both in the country as well as in Kashmir. This alone will prevent further misery.

Tourism sector forms 6.8 percent of Kashmir's GDP and employs 2 million people. The sector has the potential to shore up our beleaguered economy. Here's hoping that things improve from hereon. The waning pandemic wave is once again creating conditions for unhindered tourism in the Valley. This is also the hope of the people associated with the tourist sector. They hope there is no fourth Covid wave so that the tourists continue pouring into Kashmir and help resuscitate the economy and generate jobs.

Who can resist the pull of a hard-boiled egg with a spicy deep-fried coating of minced meat, dusted in flour and deep-fried till crispy? Call it by any name — Dimer Devil or Scotch Egg or the rich-gravy-laden Nargisi kofta. Or simply cook it in a pot with onions fried till brown, add tomatoes and your choice of spice and have them with appams, rotis, or parathas. Trust us, Kangana next time, you will look for a better simile for "weird" Bollywood babas and babies.



Regulate Gaming

The sunrise industry needs regulatory clarity to build on the good, minimise the bad and eliminate the ugly associated with it

mposing a 'ban' and impos-ing a 'rule' on an activity often meet very distinct ends. A ban, more likely than not, turns out to be a bane than a boon because coercive measures are most likely to breed negative outcomes over time. Society is said to function within what public policy experts define as a 'critical range'—the limits within which society operates in terms of legalities associated. 'Absolute' restrictions trigger humans to behave in a way that defies the norms establishing that critical range. More often than not, people are tempted to do what is prohibited.

Another noteworthy aspect is that apart from attracting high FDI and ensuring high revenue to the exchequer, online gaming platforms generate employment opportunities for technical experts, which has a ripple effect on bolstering the growth of the animation, visual effects, gaming

and comics sector. There has been lot of controversy over addiction and financial losses as th extreme ramifications of online gaming. However, one needs to acknowledge that the gains from online gaming outweigh the anomalies

(which stand out as exceptions in the larger spectrum of events). Further, in order to call out what is ugly, there is an urgency for the Centre to identify and impose penalties on real sites where people indulge in betting or gambling. In fact, offshore gambling sites have been misused for money laundering. The unpredictable 'ugly', therefore, calls for a regulatory system defined by pro-

India-made games, acknowledging the growth potential of this sector. While the finance minister also spoke in favour of gaming, an inclusive outlook towards online gaming-amendments to the IT Act 200— would help the sunrise industry thrive with new laws and regulatory frameworks that would enable building on the good, minimising the bad, and eliminating the ugly.

Is it our biological destiny to only exist and then to not, that deserves depiction on our epitaphs which don't bear our names most of the times? Born as someone's daughter and die as someone's wife.

What about our survival stories? Where must they be recorded?

Browbeaten and predictably spoken about as many would like to believe, women and their survival stories in personal and professional space bookended by culturally accepted norms, if reality is anything to go by, can never be browbeaten enough.

Law, as a profession for women, was and is still not considered as naturally suited to our abilities. Reasons bordering patriarchal protectionism myths that women need to be "protected" from the rigors and dangers that the practice entails; majorly for not being considered cerebrally capable, assuming that aggression and tenacity is what this profession demands and simultaneously considering them contrary to a woman's virtues. Both notions misplaced and informed only by a false sense of entitlement

Not considered a "dignified profession for women", the discouragement a female law student faces, begin from passive suggestions in classrooms of law practice not meant for women, to the struggle of finding a safe place to start our careers. Once graduated and faced with a myriad difficulties and quandaries as to our next right step ahead, even if some of us decide to go against the tide and start with the practice; gender biases and extreme patriarchal encounters run through our everyday professional experiences. All of this happens while we are looking for ways to navigate social and familial pressures to simply do our jobs. Decision to practice law in Kashmir is particularly met with scoff and scorn and at this stage, it is infact, a response both the genders get. However, when such a desire is expressed by a woman, these comments are coupled up with a range of suggestions bordering ridicule to friendly advices only meaning to demoralise you.

My brief experience of 2 years in the court so far, has comparably been smooth and I often rave about it to friends and relatives. When I

say this, I am quickly but consciously reminded of my privilege of never having to worry about looking for a senior because I knew I had to start practicing with my father. All of this does not qualify me to speak about the struggles of this extremely stressful profession.


However, the obviousness of discriminatory practices against women lawyers in the court exist within and beyond privileges which only goes on to amplify one fact that if all women feel secure, safe and are remunerated proportionally for their hard work; then sky really is the only limit. But there is a reason we speak about the glass ceiling visible only to us that weighs our wings down. Hence, a conversation around it especially in the legal profession is long overdue.

Going back in time, the presence of women lawyers in the courts was scanty in Srinagar and almost nonexistent outside of it. However, today, we have more women choosing to practice law than ever before, and it is heartening, how most of them make it on their own and how far, with all the difficulties that mar their journey. One reason for this increase is also in the fact that the number of female and male law graduates across India have almost equaled over a decade. However, this should have ideally translated into more women coming into the practice and more climbing up the ladder and being designated as senior advocates. The reality however couldn't be further from this.

To begin with, the task of finding a senior lawyer to work with, poses one of the biggest challenges and this is where I have known many female law graduates give up. The challenges are two fold; personal safety /comfort and professional growth. In fact, more often than not one becomes a casualty for the other. Only a handful are lucky to find both and thereafter everyday experiences often run counter to the ideas of a professional life one had harbored.

Institutionally, women are not unwelcome in the courts and a lot of those who practice will vouch for the regard they often receive from the Judges, well-meaning lawyers and clientele; pervasively, there is constant othering. Not only do women lawyers have to work twice as hard to 'prove' their worth, but law practice is metaphorically as much as physically/mentally an over hurried profession

profession. By the time various obstacles are overcome, one misses out on work and recognition.

Women lawyers working in Kashmir, particularly face stereotyping in the kind of briefs they get. Even when they're on an equal footing of merit and experience with their male counterparts; they're still mostly entrusted with family matters and rarely with anything having to do with other civil and criminal matters.

Two factors that play a very important role in success of any lawyer are 'networking and self-promotion', and there is no way that any woman lawyer can afford to do both, without it costing her reputation. It is a tightrope walk to appear sturdy, and avert constant pontificating on character and reputation. We just cannot afford to ride roughshod.

Every single day, is a struggle in trying to find a balance between not being too assertive and strident, and not too soft and docile, in the former case, we are not well mannered and discourteous and in the latter under

confident and do not have it in us to be successful.

Going back in times, close to a decade or so, women's presence in the courts in the valley was few. While some of them made their way up the ladder, at a time and in an environment determined to push them out of the cadre, some simply couldn't find a harmonious balance between work and life and ultimately quit. (A study by the associated Chambers of Commerce and Industry of India, showed that about a quarter of women do not return to work after childbirth)

Here I try to sum up various accounts narrated to me by women lawyers about their day-to-day experiences in the court these days (*names changed):

The "Good Women Don't Choose Law" prejudice

According to Advocate Subreen Malik, "An oft- heard statement, 'Good Women don't choose law', is an offshoot of patriarchy and Law profession is not immune from it". She is now working independently and runs

an organization by the name 'Mehram: Women's cell Kashmir", that works for women in distress.

Another female lawyer from North Kashmir has also had the same experience. According to her, two years into law practice, she's seen less than ten female lawyers "survive" in this unconducive environment for women.

Working with Male Clients and Senior Lawyers

Advocate Mysa*, who has been in law practice for close to 2 years in the Srinagar district court and High Court, opines that, "It's hard for women in litigation and a dearth of female senior lawyers compels them to work with senior male lawyers and the experience isn't always 'pleasant'"

Unequal Wages and Inadequate Facilities

Both Advocate Subreen Malik as well as Advocate Sadiya* from North Kashmir feel that there's the issue of income disparity as well. According to them, male and female lawyers are

paid differently.

Many other female lawyers also complained about the lack of basic facilities such as hygienic washrooms and sitting arrangements for women. According to them, libraries and chambers are still farfetched for lady advocates.

Gradual Improvement in Gender Sensitivity and Work Conditions

On the other hand, Advocate Quratul-ain describes her experience as 'having been through hell and heaven at the same time' but reiterates that there is a huge scope for women lawyers in Kashmir and staying strong is the only way forward.

Interestingly, Advocate Ulfat Jan from District Court Anantnag says that she has been respected and her work acknowledged from well-meaning members of the Bar as well as her clients but emphasizes that women still face problems.

Many other female advocates from other district courts have also felt a gradual change and feel that there are considerable senior lawyers and judges who are supportive and gender sensitive now.

As is evident from varying accounts of women lawyers working across the valley, there is a marked homogeneity in the pattern of struggles.

In J&K, given the unique Geo-political realities, a protracted conflict has had an adverse impact on various aspects of legal profession as well. Even then, our share of concerns must not make us lose sight of hardworking, dedicated and feisty women lawyers who wear their resilience as their armor, spread across the lengths and breaths of valley. All of which also goes on to show that we have some genuine allies across the gender divide.

However, we need to reflect on normalizing one gender being permanently 'othered'. This is because women's presence in law courts presents a unique opportunity to correct the historic disequilibrium that exists in the representative character of our society. It is a valve through which the re-humanisation of what is today more than ever been seen as an unresponsive institution, can be attained.

Intermittent Fasting: Fad or Fact?

hat if I told you all you need to do to lose weight is read a calendar and tell time? These are the basics for successfully following an intermittent fasting diet.

Can it be that simple, though? Does it work? And what is the scientific basis for fasting? As a registered dietitian and expert in human nutrition and metabolism, I am frequently asked such questions.

Simply stated, intermittent fasting

is defined by alternating set periods of fasting with periods in which eating is permitted. One method is alternate-day fasting. On "fast days," followers of this form of fasting are restricted to consuming no more than 500 calories per day; on "feast days," which occur every other day, they can eat freely, with no restrictions on the types or quantities of foods eaten.

Other methods include the increasingly popular 5:2 method. This form of fasting involves five days of feasting and two days of fasting per week.

Another variation relies on timerestricted eating. That means followers should fast for a specified number of hours – typically 16 to 20 per day – while freely consuming foods within a designated four- to eighthour period.

But what about eating breakfast and then small meals throughout the day to keep the body's metabolism running? After all, that's the conventional wisdom that many of us grew up with.

To answer these questions, it helps to understand the basics of human metabolism.

HUMAN METABOLISM 101

The human body requires a continual supply of energy to sustain life, and the foods we eat provide us with this energy. But because eating is often followed by periods of time without eating, an intricate set of biological pathways is in place to meet the body's energy demands between meals

Most of the pathways function at some level all the time, but they fluctuate following a meal in a pre-



dictable pattern called the fed-fast cycle. The time frames of the cycle can vary, depending on the food types eaten, the size of the meal and the person's activity level.

So what happens, metabolically

Once energy needs are met, leftover glucose is stored in the liver
and skeletal muscle in a condensed
form called glycogen. When glycogen stores are full, excess glucose
converts to fatty acids and is stored

About three to 18 hours after a meal – again, depending upon a person's activity level and size the of the meal – the amount of circulating blood glucose and lipids returns to baseline levels. So tissues then must rely on fuel sources already in the body, which are the glycogen and fat. A hormone called glucagon, secreted by the pancreas, helps facilitate the breakdown of glycogen and fat to provide energy for the body between meals.

Glucagon also initiates a process known as gluconeogenesis, which is the synthesis of glucose from nondietary sources. This helps maintain the right level of blood glucose lev-

When the body reaches a true fasting state – about 18 hours to two days without additional food intake – the body's stores of glycogen are depleted, and tissues like the heart and skeletal muscle start to rely heavily on fats for energy. That means an increase in the breakdown of the stored fats.

"Aha!" you might say. "So intermittent fasting is the key to ultimate fat burning?" Well, it's not that simple. Let's go through what happens next.

THE STARVATION STATE

Though many tissues adapt to using fats for energy, the brain and red blood cells need a continual supply of glucose. But when glucose is not available because of fasting, the body starts to break down its own proteins and converts them to glucose instead. However, because proteins are also critical for supporting essential bodily functions, this is not a sustainable process.

When the body enters the starvation state, the body goes into selfpreservation mode, and a metabolic shift occurs in an effort to spare body protein. The body continues to synthesize glucose for those cells and tissue that absolutely need it, but the breakdown of stored fats increases as well to provide energy for tissues such as the skeletal muscle, heart, liver and kidneys.

This also promotes ketogenesis, or the formation of ketone bodies – molecules produced in the liver as an energy source when glucose is not available. In the starvation state, ketone bodies are important energy sources, because the body is not capable of solely utilizing fat for energy. This is why it is inaccurate when some proponents of intermittent fasting claim that fasting is a way of burning "just fat" – it's not biologically possible.

What happens when you break the fast? The cycle starts over. Blood glucose and lipids return to basal levels, and energy levels in the body are seamlessly maintained by transitioning between the metabolic pathways described earlier. The neat thing is, we don't even have to think about it. The body is well-equipped to adapt between periods of feasting and fasting.

POSSIBLE DOWNSIDES

If an "all-or-nothing" dietary approach to weight loss sounds appeal-

ing to you, chances are it just might work. Indeed, intermittent fasting diets have produced clinically significant amounts of weight loss. Intermittent fasting may also reduce disease risk by lowering blood pressure and blood lipid levels.

On the flip side, numerous studies have shown that the weight reduction from intermittent fasting diets is no greater than the weight loss on a standard calorie-restricted diet.

In fact, the weight loss caused by intermittent fasting is due not to spending time in some sort of magic metabolic window, but rather to reduced overall calorie consumption. On feast days, dieters do not typically fully compensate for lack of food on fasted days. This is what results in mild to moderate weight loss. Approximately 75% of the weight is fat mass; the rest is lean mass. That's about the same ratio as a standard law salerie diet.

low-calorie diet.
Should you still want to go forward with intermittent fasting, keep a few things to keep in mind. First, there are no studies on the long-term safety and efficacy of following this type of diet. Second, studies show that intermittent fasters don't get enough of certain nutrients.

Exercise is something else to consider. It helps preserve lean muscle mass and may also contribute to increased weight loss and long-term weight maintenance. This is important, because nearly a quarter of the weight lost on any diet is muscle tissue, and the efficacy of intermittent fasting for weight loss has been demonstrated for only short durations.

Also, once you stop following an intermittent-fasting diet, you will very likely gain the weight back. This is a critical consideration, because many people find the diet difficult to follow long-term. Imagine the challenge of planning six months' worth of feasting and fasting around family dinners, holidays and parties. Then imagine doing it for a lifetime.

Ultimately, the best approach is to follow an eating plan that meets current dietary recommendations and fits into your lifestyle.

Member of Iran's IRGC Assassinated In Armed Attack In Tehran

Tehran: One of the members of Iran's Islamic Revolution Guards Corps (IRGC) has been assassinated in an armed attack by two motorcyclists in Tehran.

According to Iran's official IRNA news agency, the incident took place around 4 p.m. local time on Sunday, when the IRGC member was dismounting his car to enter his home in an eastern neighborhood of the Iranian capital.

The IRGC member, who has been identified as Hassan Sayyad Khodaei, was assassinated after two motorcyclists



shot him five times before fleeing the scene.

IRIB news agency reported that three bullets hit him in the

head and two bullets hit his hand. The IRGC issued a statement soon after the assassination, saying that its former member was assassinated in a terrorist attack by counterrevolutionary elements.

The statement condoled with his family, adding that necessary measures have been taken to identify and arrest the assailant or assailants.

Following the assassination, head of Tehran Court of Justice, Ali Alqasi, ordered Tehran prosecutor to speed up efforts to identify and arrest those behind this criminal act.

Alqasi also stressed the need to expedite judicial measures aimed at the identification of the perpetrators of this assassination.

Pakistan's ex-PM Imran Khan calls for march to Islamabad on May 25; seeks fresh elections

Peshawar: Pakistan's ousted prime minister Imran Khan on Sunday asked his supporters to march peacefully to Islamabad on May 25 to press for the dissolution of the National Assembly and fresh elections in the country.

Khan, 69, who served as prime minister for over three and half years, was removed from the position through a noconfidence vote in parliament by the Opposition parties last month. Since his removal, Khan has addressed several rallies in different cities.

Addressing a press conference after his party's core committee meeting in Peshawar, Khan said the march would convert into a sit-in and continue until his demands are accepted, the Dawn newspaper reported.

The main demands for the march to the capital were the immediate dissolution of the National Assembly and a date for the next general election, he said during the press conference.

Khan said he wants people from all walks of life to participate in the march to raise clamour against his removal as the prime minister which he called as illegal.

"On the 25th [of May] I will meet you in Islamabad on the Srinagar Highway. I want people from all [walks of life] to come because this is Jihad, and not politics. I've decided and told all my team that we have to be ready to sacrifice our lives," Khan said. Khan has accused the US of conspiring to topple his elected government, citing communication from the country's ambassador in Washington.

The US government has bluntly denied the allegations multiple times. Meanwhile, Interior Minister Rana Sanaullah on Sunday warned the Pakistan Tehreek-e-Insaf (PTI) of action if its protesters were to march towards Islamabad with the "intent to cause anarchy."

Addressing a press conference in Bahawalpur in Punjab province, Sanaullah said the government and its allies were mandated to decide about the line of action against the PTI's planned long march to Islamabad.

At the outset, the DDC briefed the meeting in detail about the physical and financial progress achieved in various schemes and programs being implemented by different departments in the district.

Taking stock of the financial progress under District Capex budget 2021-22, against the total outlay of 91959.16 lacs, the total expenditure incurred as of now is 83.87 percent. While taking note of meagre expenditure by some sectors, the Div Com directed to achieve the financial targets with the shortest possible time, and directed for 100 percent expenditure under different schemes.

Similarly, while reviewing the sector wise physical progress under District Capex budget 2021-22, the meeting was informed that out of 3956 works, 2629 works have been completed.

While reviewing the progress made under the PWD sector, it was informed that out of 06 schemes under CRF including three bridges and equal number of roads, the work on 01 scheme

is complete while the rest are under different phases of execution. Giving details of the progress under NABARD, it was apprised that out of 84 schemes, the work on 18 schemes is complete.

Discussing the progress under the PDD Sector, the Div Com took detailed stock of various schemes including PMDP-R, PMDP-U, DDUY and IPDS.

The Div Com asked the SE PDD to ensure that the unscheduled power cuts are avoided and proper schedule should be maintained while providing power supply to the general public so that they don't face any inconveniences.

He also asked to rectify the faults in electrical equipment as soon as possible as and when they occur. He also advised SE PDD to shorten the response time, and ensure that the Officials should be made available for the at gross root level.

tenders of the projects under District Capex budget.

Under Ayushman Bharat, it was informed that 443472 beneficiaries have been registered under the scheme. While taking stock of the progress under SBM, against the target of 4658 units, the work on 4100 units is complete. Similarly, while reviewing the progress regarding the construction of a community sanitary complex, the Div Com asked to take appropriate measures for the proper maintenance of the CSC.

Seeking the progress regarding the registration of the labourers on e Sharm portal, it was informed that 184592 labourers have been registered on the portal as on date.

The Div Com also reviewed the progress on various schemes being implemented in the district under Mission Youth and asked the concerned officers to ensure that maximum unemployed and educated youth of the district are covered under

these schemes.

Discussing the restoration of water bodies and water conservation efforts, He also asked the concerned officer from the RDD to make dedicated efforts to conserve and preserve water and also achieve the targets under the Amrit Sarovar Mission at the earliest.

Regarding the progress under PMAY-U, it was apprised that against the Target of 2155 houses, the work on 298 are complete. The Div Com instructed the EO MCs to expedite the progress and make sure that the set targets are achieved within the shortest possible time.

Taking stock of the progress under PMAY-G, it was informed that against the target of 30661, as many as 14428 houses have been constructed.

While reviewing the livelihood generation activities being carried out under NRLM, the Div Com asked the concerned officer to provide better market linkages to the SHGs so that they can sell their

products in a hassle free manner.

Regarding the implementation of JJM, the meeting was informed that as many as 293 schemes have been approved for the district at an estimated cost of Rs 1723 crores under the Mission out of which the work on 01 scheme is in progress. "On 20" of May, 2022, Ministry of Health & Family Welfare (MoHFW) Gol issued interim Health Advisory regarding the Monkeypox. This office has prepared a Power point presentation in detail on the subject. You are requested to kindly disseminate the advisory among all health care workers of your district for their sensitisation and further necessary action," it adds.

As per the advisory, the key points about the disease include that Monkeypox is a viral zoonotic disease that occurs primarily in tropical rainforest areas of Central and West Africa and is occasionally exported to other regions

is occasionally exported to other regions.

"Monkeypox typically presents clinically

with fever, rash and swollen lymph nodes and may lead to a range of medical complications and it is usually a self-limited disease with the symptoms lasting from 2 to 4 weeks. Severe cases can occur. Case fatality rate may vary from 1-10%.

Monkeypox can be transmitted from Animal to Humans as well as human to human. The virus enters the body through broken skin (even if not visible), respiratory tract, or the mucous membranes (eyes, nose, or mouth). Animalto-human transmission may occur by bite or scratch, bush meat preparation, direct contact with body fluids or lesion material, or indirect contact with lesion material, such as through contaminated bedding, it reads.

"Human-to-human transmission is thought to occur primarily through large respiratory droplets generally requiring a prolonged close contact and it can also be transmitted through direct contact with body fluids or lesion material, and indirect contact with lesion material, such as through contaminated clothing or linens of an infected person."

Similarly, the advisory said the clinical presentation of monkeypox resembles that of smallpox, a related orthopoxvirus infection which was declared eradicated worldwide in 1980.

"Incubation period is usually 7-14 days but can range from 5-21 days and the person is usually not contagious during this period and an infected person may transmit the disease from 1-2 days before appearance of the rash and remain contagious till all the scabs fall off," it adds.

As per the advisory the recommended public health actions include that health facilities to keep heightened suspicion in people who present with an otherwise unexplained rash and who have travelled, in the last 21 days, to a country that has recently had confirmed or suspected cases of monkeypox or report contact with a person or people with confirmed or

suspected monkey pox.

"All suspected cases to be isolated at designated healthcare facilities until all lesions have resolved and a fresh layer of skin has formed OR until the treating physician decides to end isolation and all such patients to be reported to the District Surveillance Officer of Integrated Disease Surveillance Programme."

"All infection control practices to be followed while treating such patient, laboratory samples consisting of fluid from vesicles, blood, sputum etc to be sent to NIV Pune for Monkey pox testing in case of suspicion and in case a positive case is detected, contact tracing has to be initiated immediately to identify the contacts of the patient in the last 21 days," reads the advisory—(KNO)

Croatian Police Fire Live Ammunition During Football Fan Clash

ZAGREB: Outnumbered Croatian police officers fired warning shots into the air and ground with live ammunition when soccer fans returning from a match in the capital attacked them on a highway with iron bars, bats and flares, authorities said Sunday. At least 35 people were injured, including four fans with bullet wounds.

The violence late Saturday happened when a convoy of more than 260 cars and buses was transporting Hajduk Split fans under police escort after their team lost 3-1 to Dinamo Zagreb. The two teams have a fierce rivalry - Split is Croatia's secondlargest city after Zagreb - and Hajduk fans may have been angry because police barred them from entering Zagreb's stadium with flares and banners.

About 2,000 fans refused to enter the stadium and remained outside throughout the match, police said. As they were traveling back to Split, which is about 355 kilometers (220 miles) blocked traffic and started at-

tacking officers on a section of the highway on the outskirts of the capital, police said. The road is the main Croatian highway leading from Zagreb to the Adriatic Sea coast. Police said the fans ignored orders to disperse.

"There were no signs something like this could happen," said Damir Baric, a senior police official in charge of public security. "They blocked traffic, suddenly ran out of their vehicles and advanced on the police who were 10 times outnumbered." Zagreb police chief Marko Ra-

sic said that three officers tried to find shelter inside a police van, but that the fans hurled a burning flare inside the vehicle forcing them to evacuate. He said the three police officers discharged their firearms, shooting about two dozen shots mainly into the air but also into the ground. These bullets apparently ricocheted and wounded the attackers, he said.

One fan struck by a bullet was seriously wounded and none of the other injured, including the south of Zagreb, a group of fans police officers, were in life-threatening condition, police said.




