Four Local Militants Killed In Twin Encounters

Two Among Them Were Involved In TV Artists Killing: IGP

Srinagar: The Jammu and Kashmir police on Friday claimed to have killed four Lashkar-e-Taiba (LeT) militants, two among them allegedly involved in shooting dead a TV artist, in separate encounters in Srinagar and Pulwama districts of the Valley.

Around 9:30pm Thursday, police, army's 55 RR and the personnel of CRPF 130 battalion launched a cordon and search operation in the Aghanzipora area of Awantipora on a specific input about the presence of militants in the village, a police spokesperson said Friday.

The search team, he said, came under heavy fire from the hiding militants when a cordon was being laid around a cluster of houses. He said the joint team returned the fire, set-

ting off an encounter. In the exchange of gunfire, the spokesperson said, two local militants of LeT were killed and their bodies were retrieved from the site of the encounter.

He identified them as Shahid Mushtaq Bhat of Hafroo Chadoora, Budgam and Farhan Habib of



INCRIMINATING MATERIALS, HUGE CACHE of arms & ammunition was recovered from both the sites of encounter. All the recovered materials have been taken into case records for further investigation."

Hakripora, Pulwama. Meanwhile, two militants were killed in a separate encounter in Soura area of this capital city, the spokesperson said.

Giving further details, he said that Srinagar Police developed an input about movement of militants from South Kashmir to Srinagar City and tracked their presence in Soura area of the city.

"A special & small team of Srinagar Police launched a cordon and search operation

in the said area," he said. During the search, the spokesperson said, as the presence of militants was ascertained and search party proceeded towards the suspected spot, the hiding militants fired indiscriminately upon search party which retaliated leading to | More on P10



Court Orders Exhumation Of Ramban Youth's Body

Srinagar: The Jammu and Kashmir High Court on Friday ordered that the body of a civilian, killed and passed off as a militant by government forces in the controversial Hyderpora encounter last year, be exhumed and handed over to the family for last rites

The single bench of Justice Sanjeev Kumar also directed the Union Territory administration to pay a compensation of Rs 5 lakh to the deceased Amir Magrey's father, the petitioner, if the body has been decomposed or is likely to pose a risk to public health and hygiene during the burial.

On November 15 last year, police claimed to have killed a Pakistani militant and three of his associates in the Hyderpora area of the city here. However,

Cell-Based Therapy Shows Promise Against Type-1 Diabetes

n islet cell transplant programme developed by a team of Canadian researchers is a safe, reliable and Life-changing treatment for people with hard-to-control Type 1 diabetes. Islets are clusters of cells which produce insulin, a hormone that allows the body to control the flow of energy from food, storing the excess after meals and releasing it to allow the body to function between

meals. In Type 1 diabetes, the immune system mistakenly destroys the cells within islets so patients have to take insulin by injection. Patients with hard-to-control or "brittle" diabetes face life-threatening low or high blood sugars and long-term complications.

"We've shown very clearly that islet transplantation is an effective therapy for

patients with difficult-to-control Type 1 diabetes," said James Shapiro, Professor of surgery at the University of Alberta. "This long-term safety data gives us confidence that we are doing the right thing." "This data shows really strong proof that cell-based therapies can deliver a meaningful and transformative impact for people with diabetes," added Peter Senior, director of the Alberta Diabetes Institute at the varsity. "We are delivering something which all other treatments for diabetes don't deliver-there's a comfort, a predictability, a stability to blood sugar levels that don't exist with anything else." In the study published in The Lancet Diabetes & Endocrinology, the researchers report on patient survival, graft survival, insulin independence and protection from life-threatening low blood sugars for 255 patients who have received a total of more than 700 infusions of islets at the University of Alberta Hospital between March 1999 and October 2019.



The results showed that 70 per cent of the grafts survived for a median time of nearly six years, 79 per cent of the transplant recipients were able to stop taking insulin after two or more islet infusions and a median time of 95 days following the first

About 61 per cent were still insulin-independent a year later, 32 per cent at five years and eight per cent after 20 years, the researchers reported. While most patients had to resume taking insulin injections, the doses were usually much smaller than their original needs and their diabetes control

"Being completely free of insulin is not the main goal," said Shapiro. "It's a big bonus, obviously, but the biggest goal for the patient - when their life has been incapacitated by wild, inadequate control of blood sugar and dangerous lows and highs - is being able to stabilise. It is transformational."

Covid Infection May Induce Severe Bone Loss, Study Suggests

nfection with the SARS-CoV-2 virus, which causes Covid-19, can lead to severe bone loss during the acute and post-recovery phases of the disease, according to a study conducted in hamsters.

The findings, recently published in the peer-reviewed journal Nature Communications, provide insights into the possible long-term complications

In addition to lung infection, complications of different organ systems in the long-term SARS-CoV-2 infection, or "long Covid," have been increasingly recognised in patients with disease, the researchers said.

However, the full spectrum of clinical manifestations, especially the influence of SARS-CoV-2 infection on bone metabolism, has yet to be fully understood, they said.

To study the effects of SARS-CoV-2 infection on bone metabolism, the researchers from the University of Hong Kong (HKUMed) infected Syrian hamsters with SARS-CoV-2.

They then collected their bone tissues after the infection and analysed them using three-dimensional microcomputerised tomography (CT) scans.

The study found that SARS-CoV-2 infection induced severe bone loss from 20 per cent to 50 per cent progressively in particular to the trabecular bone in the long bones and lumbar vertebrae.

This effect extended from the acute phase to the chronic phase of infection, according to the researchers.

The pathological osteopenia -- loss of minerals like calcium and phosphate by bones -- was found to be associated with the inflammatory activation of osteoclasts -- a kind of cell responsible for break down of the bone tissue.

The cytokine dysregulation or inability to control inflammation, induced by SARS-CoV-2, triggered an amplified pro-inflammatory cascade in the skeletal tissues to augment their breakdown.

The researchers said their team is the first in the world to report the effects of SARS-CoV-2 on bone metabolism using a well-established Syrian hamster model that closely mimics Covid-19 in humans.

The findings indicate that the pathological bone loss may be an important but neglected complication, which warrants more extensive investigations during the long-term follow-up of Covid-19 patients, they added.

ACB Raids Former SMC Commissioner's House

rinagar: After filing a disproportionate assets case against former Srinagar Municipal Corporation (SMC) Commissioner Showkat Ahmed, the Anti-Corruption Bureau (ACB) on Friday raided his residential house at Airport Avenue Link road in Humhama area of Srinagar outskirts.

Official sources said, ACB has charged the former top official with a disproportionate assets case. He allegedly acquired assets through 'dubious, unlawful means and illicitly' enriched himself.

Sources added that a formal case against the official vide number 21/2022stands registered at police station ACB Srinagar while the anti-graft body yesterday acquired a search warrant of his house from the Anti-Corruption Court.

Sources said that the official in question has constructed two palatial houses in Jammu and one in Srinagar during his tenure as Commissioner Srinagar Municipal Corporation.

An official speaking on anonymity said that preliminary searches so far have revealed that Showkat Ahmed has acquired movable and immovable assets to the tune of crores. 'Further verification of additional assets is underway and the case is under investigation," he added. (KNT)

Anjuman Augaf Terms Closure Of Jamia Masjid Unfortunate

9 Year Old Girl Charred To Death In Overnight Blaze At Dal Lake

Srinagar: A nine year old girl was charred to death in an overnight blaze that turned the houseboat into ashes in Dal Lake.

Official sources said that a 9 year-old girl identified as Nadia Bashir, daughter of Late Bashir Ahmad Goswani was charred to death in an overnight fire incident at Ghat number 16 Dal Lake Srinagar.

Fire broke out from the Kareem Houseboat opposite Ghat number 16 Boulevard, causing extensive damage to the houseboat.

'The family members were inside the houseboat when the fire broke out", said a family member. "Nadia along with other family

The Officers also took on the spot assessment of the damages caused due to the devastating fire incident.

Interacting with the fire sufferers, the ADC expressed sympathies with the affected families.

The administration sanctioned ex-gratia relief of 4 lakh to the next of kin of the deceased 8-year-old girl under SDRF. Essential assistance in the form of 15 blankets, 15 mattresses, 15-bed sheets and 3 kitchen sets and 3 tents, besides Rs 30,000 to all 3 affected families was also provided out of Red Cross as an interim relief.

Further, the DC also sanctioned structure-wise financial assistance of Rs 30,000 under SDRF in favor of the affected families separately under the District Red Cross fund.

Patient Stable As Controversy About 'Needless' Surgery Lingers On

RINAGAR: Even as the patient who was operated upon at the Sher-i-Kashmir Institute of Medical Sciences (SKIMS) for removal of suspected stones is stable, the controversy surrounding the surgery lingers on. While the doctors are almost unanimous there was no negligence in the matter, the was forced on her.

According to reports, Aaliya Liaqat w/o Liaqat Hussein of Court road here was operated upon Saturday for suspected stones in her kidneys though repeated X-rays taken on the fateful day did not show any de nite presence of the calculus. Her relatives alleged the surgery was not warranted after the X—rays were negative.

The surgery evoked instant protest from the relatives of patient, mother of an 8-month old baby. They alleged the head of concerned department, Dr' Baldey Singh, had insisted to have the surgery performed. They accused the doctor of having threatened them following a tiff a few days earlier.

In a communication to Kashmir Observer, Dr Singh denied he had conducted the operation and described the report, circulated by CNS news agency, as baseless and aimed at maligning his image. He said, "The fact is that I had advised an X-ray for the patient before any surgical intervention but a consultant urologist conducted the said surgery with my knowledge". Later on, he said, "on the request of Director SKIMS I helped the concerned urologist in closing the patient and stent was put for effective drainage'

Talking to Observer News Service, Dr Singh denied there was any negligence on the part of doctors. 'These things can happen in the medical profession", he said, adding the surgery was done with the written consent of a close relative of the Patient. He said the patient was admitted by Dr Tajamul the consultant who was not required to seek any directive from him. Denying that he has threatened the patients' relative, Dr. Singh Said he might have told them to leave the ward during the morning round.

When contacted Dr. Tajamul Fazili told Observer News Service that patients was admitted by Dr. Singh. The X-rays of the obese patient had shown stones at the OPD stage and admitted accordingly. On Saturday he said the first two X-rays revealed thre were no stones. A third one was taken with double exposure which showed a shadow coinciding with the X-ray taken at the 'OPD stage'. Dr Fazili said, "Most probably it was a friable (soft) stone which got crushed and passed down the ureter during the surgical manipulation." He said a small stent was kept inside to ensure safe passage of any small bit. Dr Fazili said 'Saturday was utilised as an additional the

atre day to make good for the hartal days. "We were convinced the patient did have stones. But when I could not locate it, I sought help from Dr Singh", he said. The director of the Institute, Prof Me'raj-ud-din, said there

was nothing abnormal about the surgery nor was there any negligence on the part of doctors. 'The stone must have been friable going down the ureter and the gravel coming out of its own", he said. He ruled out any enquiry into the episode.

Joining the issue, a close relative of the patient, pleading anonymity, told Observer News Service the surgery was absolutely uncalled for the moment the doctors knew there was no stone. The written consent had been given when she was brought to operation theatre in the morning. However, she was turned back from there and

asked to get in her X—ray done. After that an anesthesia was given to her for the second time and the surgery conducted despite the relatives' pleas against it and without seeking a fresh consent from them. The relative said the patient had suffered heavy blood loss which could have proved fatal. The relative alleged Dr Singh had visited the ward against asking them to return the X-rays which were lying with them.

Meanwhile, according to Dr Singh the patient was stable. (Kashmir Observer, 28 May, 2005)

"West Has Declared War On Us": Russia Foreign Minister On Sanctions

Moscow: Russian Foreign Minister Sergei Lavrov on Friday accused Western countries of waging a "total war" on Russia and its people and culture as Moscow pushes on with its military operation in Ukraine.

"The West has declared war on us, on the whole Russian world. The culture of cancelling Russia and everything connected with our country is already reaching the point of absurdity," Lavrov said at a ministry meeting.

He accused the West of banning Russian writers, composers and other cultural figures.

"It is safe to say that this situation will be with us for a long time," he added.

According to Lavrov, Washington "and its satellites are doubling, tripling, quadrupling their efforts to contain our country".

He said they are "using the widest range of tools -- from unilateral economic sanctions to thoroughly false propaganda in the global media space".

"In many Western countries, everyday Russophobia has become of an unprecedented nature, and, to our great regret, is encouraged by government circles in a number of countries," Lavrov said.

Western capitals slapped Moscow with unprecedented sanctions after President Vladimir Putin sent troops into Ukraine on February 24.

Palestinian Probe Finds Al Jazeera Reporter "Murdered" By Israeli Forces



Ramallah: An Al Jazeera journalist shot dead in the occupied West Bank earlier this month was murdered by an Israeli soldier in a "war crime", the official Palestinian investigation concluded Thursday.

The Palestinian Authority (PA) and Al Jazeera have blamed Israeli forces for Shireen Abu Akleh's killing on the morning of May 11, when she was covering an Israeli army operation in Jenin camp in the north of the West Bank.

Israeli authorities have countered that Abu Akleh could have been killed by stray fire from a Palestinian gunman in the area or mistakenly by an

Israeli soldier. All "proven facts constitute the elements of the crime of murder... according to national laws, they are a war crime and a violation c international laws," said PA attornev general Akram Al-Khateeb who presented the Palestinian

investigation's findings. The Palestinian-American iournalist, who was wearing a vest marked "Press" and a helmet, was killed after being hit by a bullet just below her helmet.

The report said Abu Akleh was killed with a 5.56 millimetre armour piercing round fired from a Ruger Mini-14 rifle.

The report also said that bullet holes on a nearby tree indicated the "targeting of the upper parts of the body with the aim of killing."

"All of these facts: the type of projectile, the weapon, the distance, the fact that there were no obstructions to vision and that she was wearing a press jacket lead us to conclude that (Shireen) Abu Akleh was the target of a murder," Khateeb

concluded.

"The only source of fire was the Israeli occupation forces,"

Senior PA official Hussein al-Sheikh said a copy of the report had been sent to US authorities, while copies would also be given to Abu Akleh's family and Al Jazeera.

A CNN report published this week, disputed by Israel, also pointed to a deliberate killing, citing the impacts on the tree.

"The number of strike marks on the tree where Shireen was standing proves this wasn't a random shot, she was targeted," Chris Cobb-Smith, an explosive weapons expert, told the US news network.

Israeli authorities were quick to decry the Palestinian report's conclusions, with Defence Minister Benny Gantz saving the Israeli army would never target journalists.

"Any claim that the IDF intentionally harms journalists or uninvolved civilians, is a blatant lie," he said in a statement, referring to the Israeli Defence Forces.

'Despite the Israeli side reaching out repeatedly, the Palestinians refuse to cooperate, which raises the question (of) if they really want to reach the truth," he said.

Palestinian authorities had refused to hand the bullet over to Israeli authorities for further investigation, citing a lack of trust. Gantz also hit out at CNN

Thursday. "Attempts to charge IDF soldiers with war crimes while promoting false assessments such as the one published by CNN, undermine the ability to achieve peace and stability in the region, while ultimately boosting terrorism," he said.

Iran Seizes 2 Greek Tankers In Persian Gulf, Tensions Spike

DUBAI: Iran's paramilitary Revolutionary Guard seized two Greek oil tankers on Friday in the Persian Gulf, just after Athens assisted the U.S. in seizing an Iranian oil tanker over alleged sanctions violations in the Mediterranean Sea.

The Guard's announcement comes as tensions remain high between Iran and the West over stalled negotiations regarding its rapidly advancing nuclear program. And while the Persian Gulf has seen a series of attacks since former President Donald Trump unilaterally withdrew America from the accord in 2018, there has not been a maior incident at sea in months.

The Guard issued a statement on its website, accusing the unnamed tankers of unspecified violations.

Greece's Foreign Ministry said it made a strong demarche to the Iranian ambassador in Athens over the "violent taking over of two Greek-flagged ships" in the Persian Gulf.

"These acts effectively amount to acts of piracy," a ministry statement said.

"A similar incident has been reported on another Greekflagged vessel, that was carrying seven Greek citizens, close to the coast of Iran," the ministry said.

A Greek official, speaking on condition of anonymity to discuss details of the attack with a journalist, identified the second ship as the Prudent Warrior. Its owner, Polembros Shipping in Greece, earlier said the company was "cooperating with the authorities and making every possible effort to address the situation effectively.

Greek officials did not identify the nationalities of the other crew onboard the vessels.

Fake Call Centre Scamming US Nationals Busted In Mumbai; 3 Arrested

Thane: The Navi Mumbai police busted a fake call centre operating at a business park and arrested three persons involved in running the establishment, an official said on Friday.

through VoIP, by posing as representatives of a renowned pharma company, he said.

Morning Of Horror: How Texas Shooter Spent His Final Hours

Washington: The day after his 18th birthday, Salvador Ramos, a troubled teenager from small-town Texas, bought an assault rifle. A week later, he walked into a local elementary school, where he shot and killed 19 young children and two of their teachers.

Authorities are still trying to piece together what drove Ramos to commit America's worst school massacre in a decade, but here is what is known so far about the shooting:

How the shooter attacked

Described as a long-bullied youth with a history of selfharm, Ramos turned 18 on May 16 and bought an assault rifle the very next day. He purchased 375 rounds of

ammunition on May 18, and then a second rifle two days after that.

Ramos -- a school dropout with no criminal history -- messaged on social media Tuesday morning that he planned to attack his grandmother, Texas Governor Greg Abbott said.

Ramos shot his 66-year-old relative in the face. She survived and was airlifted in critical condition to a hospital in nearby San Antonio. The shooter then messaged

again to say he had followed through on his plan to attack his grandmother, and that an elementary school was his next target.

He drove a little over miles (3.2 kilometers), crashing near Robb Elementary School, where more than 500 students in grades two to four -- aged around seven to 10 years old -- had just three days of class left before summer vacation.

He fired on bystanders at a funeral home, then climbed a fence, entered the school through a door that was apparently unlocked, and made his way to two adjoining classrooms. 'That's where the carnage

began," said Steve McCraw, director of the Texas Department of Public Safety (DPS).

How he was stopped

As a crowd grew near the school, police arrived on the scene.

Officers entered the school

minutes after the shooter, but were held back by gunfire and called for backup, according to Victor Escalon of DPS.

A tactical team that included US Border Patrol agents entered and killed the suspect "approximately an hour later," Escalon said.

In the interim, officers evacuated students and teachers from the school, and unsuccessfully tried to negotiate with the gunman, who held them back with rifle fire.

Texas police are facing scrutiny over the delay between the start of the attack and the death of the shooter.

When pressed by journalists on the law enforcement response -- and on contradictory accounts provided by officials -- Escalon said investigators were still conducting interviews and working to piece together what happened.

There were "numerous officers" involved, he said. "Once we interview all those officers, what they were thinking, what they did, why they did it... we'll have a better idea.'

Who was the gunman?

Ramos had been living with his grandmother for two months, McCraw said. According to Texas Governor Greg Abbott, no psychological problems were known to local health departments.

A cousin, Mia, told The Washington Post Ramos "wasn't very much of a social person" after being bullied for a stutter.

But two graduating seniors at Uvalde High School -- both of whom said they knew the shooter -- painted a different picture.

"We went to school with him... We all knew of him," Jaime Cruz, 18, told AFP.

"I do vividly remember him being a bully in school. It wasn't just that he was getting bullied, he was also the bully, said Cruz. "He was a bully. He was

mean," agreed Ariana Diaz, 17. Speaking to ABC News, Ramos's mother Adriana Reyes said her son could be aggressive when angry but was "not a monster" -- and that she was not aware he had been buying "I had an uneasy feeling

sometimes, like 'what are you up to?," she said. "We all have a rage, that some people have it more than others.

Man Poses As NRI, Promises Marriage To 300 Women, Arrested: UP Police

Noida: A Nigerian national staying in Delhi has been arrested by the Uttar Pradesh Police on the charge of cheating at least 300 women and duping them of crores of rupees on the pretext of marriage, officials said on Friday.

The accused befriended women through social media and matrimonial websites, where he introduced himself as a nonresident Indian (NRI) settled in Canada and a prospective groom, the officials said.

Garuba Galumje (38), who hails from Lagos in Nigeria, was staying in the Kishan Garh area of South Delhi and has been arrested by officials of the Cyber Crime police station in Noida, they said.

"The accused has been arrested in connection with a complaint from a woman who lives in Meerut district of UP. She claimed that she had registered herself on leevansathi website for marriage. A man approached her through the website and introduced himself as Indo-Canadian NRI Sanjay Singh," Inspector Reeta Yadav, incharge of the Noida Cyber Crime police station, said.

The man eventually gained her confidence and made emotional appeals as he tricked her into transferring 60 lakh in multiple instalments into his various bank accounts before she realised the fraud," Yadav told

When the matter was brought to the police, an investigation was taken up and the culprit tracked down to be operating from Delhi and arrested, said the inspector, who led the cyber police team. "During questioning, we came

Roots of Pay Crisis

tate employees have raised the stakes in their attrition with the government to a perilous level in threatening an indefinite lock-out should their demands on the implementation of the 6th Pay Commission report and other issues not be conceded. Even as we go to press, government functioning in the state has been paralyzed by a two-day strike, with a secretariat gherao planned for Wednesday. Employee unions are in no mood to give the government more time, dismayed as they are by the recent cabinet meeting sideling the issue totally.

Commentators have, perhaps with good reason, described the unfolding scenario as a grave crisis in the making, and indeed, the situation does show the signs of a showdown. The recently inducted National Conference-led coalition in Jammu and Kashmir would have been wishing for this particular hornet's nest not to be stirred, but couldn't have been unaware of the restive ranks of the employees who have been pursuing this issue aggressively for some time. The pay panel's recommendations have come as an additional boost to the agitation-prone employee unions who say that many of their genuine grievances have been left unaddressed for too long. What they decide on Wednesday during the secretariat gherao will determine what the Omar Abdullah government will have to face.

In any case, the state dispensation is confronted with its first major challenge where its avowedly good intentions clash with the reality of a serious resource crunch.

The state finance minister, Abdul Rahim Rathar, has already outlined the huge financial implications of implementing the 6th Pay Commission report, and tacitly admitted the state's limitations by stressing that the issue would have to be taken up with the center.

Remarkably, the demands about the Commission's recommendations took center stage when the agitation over the Shrine Board land transfer had taken on a much broader dimension. The governor, then ruling the state, himself gave audience to employees' delegations, notably to a hastily cobbled group of KAS officers who had actively begun to champion the cause.

These senior officers could not have been unaware of the shaky state of government finances and the protracted top-level wrangling it would take to make the center cough up the thousands of crores of rupees needed to meet the liability. The employees have been on the agitation path on a number of diverse issues, but the pay commission report has given their stir a cutting edge, turning the government-employee tussle into an affair of keen public interest. Bent on giving the government no further quarter by threatening an indefinite strike, attention is bound to be focused on developments concerning an estimated four-an-a-half lakh individuals. If carried out, the threat has wider ramifications, involve as it does the society in general which is heavily dependent on government functioning.

If the National Conference-led coalition government finds itself painted into a corner because of an indefinite pen-down strike by employees, the party has partly to answer to itself with respect to the weak state economy. The National Conference has been in power for long decades, and its sins of omission and commission have a direct bearing on the present state of affairs. It cannot absolve itself of responsibility of having giving the state no direction in the economic and social spheres to meet the demands of coming years. The state cannot even generate finances to meet its own salary bills, and has been kept dependent on outside injections in more ways than one. Right from the everyday necessities of life, including the food front where Jammu and Kashmir should have been self-sufficient, the state has to rely on imports, and can be brought to its knees in a matter of days as evidenced in the economic

blockade by communal fanatics in the Jammu region. The connection between salary issues and the self-sufficiency of the state is not far-fetched, as Kashmir's vulnerability comes to the fore every time the Srinagar-Jammu highway gets blocked for a matter of days. It bears repeating that the National Conference, which has been in power at what could have been a defining stage in Kashmir's development, has failed abysmally in providing the leadership nd vision required to put a people on the path of sustainable progress. What has been cultivated instead is a pervasive cult of consumerism and ostentation under which even the last remnants of producers, the peasantry and the farming community, are selling off their land to finance bribes for government jobs for their younger generation. The National Conference had lost no time in granting land to the tiller, but failed to give a sound agrarian philosophy that would have sustained the

state as agriculture does states like the Punjab.

The credit for the state's perennial begging bowl image, even for employees' salaries, goes fair and square to the National Conference which has been content with flowing with the drift, and seldom lifted up a hand to address the state's decline.

Between Culture and Fad

he past few years have witnessed a surge in cultural shows, musical fests and other allied activities carried under the impression of revival of culture and heritage. From schools to universities and from auditoriums to open fields, traditional forms of folk, eatery, clothes and utensils are displayed and promoted with the idea of cultural revival and reinforcing people's interest and attachment to the same. At times, we have been virtually lead to the precipice, where it seemed as if our culture, with all its attendant constituents is going to make a comeback and often reared the nascent dream of putting on traditional serape, leaning against mud wall and sipping Saffroni Kehwa in potter cups. Many elite restaurants actually sell this fantasy, where a separate space is designated to cultural and "primitive" ambience and oeuvre, where people relive their nostalgic dreams or have a sort of time travel experience. But one is pressed to ask the worth of all this and the role of these multiple exercises in the actual revival of culture - culture as something lived reality, not a fantasy or a figment of imagination. Kingsley Davis, an American Sociologist remarked that the only line of distinction between humans and animals is that humans possess culture, which no other crearure does.

The nature of argument that is about to unfold and what has already been said as preface obliges us as the very beginning to answer the most important question concerning this entire discourse and that is "What is Culture"? Edward Tylor sums up that culture is an umbrella term which encompasses the social behaviour, institutions and norms found in human societies, as well as the knowledge, beliefs, arts, laws, customs, capabilities, and habits of the individuals in these groups". This all-encompassing and inclusive definition of culture may violate our previously held beliefs about the same where culture is identified with some attire or merely consigned to the arena of folklore. That is the understanding of culture too narrow in scope and too feeble to adhere to. No real understanding of culture and by extension no real revival and preservation of culture is possible while holding to its narrow and superficial definition which leaves out the bedrock elements and essential features thereof. That may be the reason why despite many cultural shows and fests, musical events and cultural theatrics, we feel as if we are receding away from culture and vice versa with each passing day. The multidimensionality of culture makes its preservation an equally multidimensional challenge and lest an inclusive and comprehensive policy is chalked and walked upon, all attempts remain superficial and all dreams of revival elusive. A question, and therefore a genuine question may be raised here as to why should one worry about the preservation and revival of culture and it seems to serve no immediate ends?

Here it needs to be noted that culture is the collective memory of nation, and as the erasure of individual memory deprives the individual of his individuality, identity and personality, so the erasure or erosion of culture amount to collective amnesia and wipes away with its erasure, the identity and particularity of a nation and civilization. Having said that, we need to be aware of the fact that in the rhythmic movement of time,

culture is not something sedentary or immobile, but is itself manifest dynamism. It carries within its recess, the potential of change and continuity and from this balance between change and continuity does culture assert itself against the sweeping tide of time. To evolve and to adopt to the urges of age and time is the defining and definitive feature of any living and vibrant culture. To hold on tenaciously to the bygone mores is not characteristic to any living and evolving culture and therefore, while we talk of the preservation and perpetuation of culture, the dynamics and evolutionary nature thereof shall not be lost sight of. The question then arises as to what we mean by preservation and perpetuation of culture and how to chaff the transitory features from the permanent and timeless features of culture.

A culture and all the institutions and affairs revolving in its orbit do not stand in vacuum. They are rooted in some idea, an ideology, an underlying philosophy, the overreaching defining principle and a force of cohesion which binds

has been picked up as means of illustrating the larger principle, which applies to the culture as whole. On similar lines, let's think for a while what destiny has our language met and what direction the course of our linguistic evolution is heading in? A handful of people have remained who are able to read the Kashmiri script, still fewer who can write it and result? The terrifying result of all this linguistic alienation is that we have simultaneously barred ourselves from our rich, exquisite and marvellous literary heritage. While few of us are still able to hum Lal'e Vaakhs and Sheikh'e Shruki, the unfortunate day is not away when Lal Ded and Sheikh Ul Aalam, Shamas Fqir and Soch Kral, Mehjoor and Ahad Zargar will survive only as vestiges of our unconscious and we will find ourselves disqualified to read their rich verses, leave alone catching their subtleties and complexities. How many young and promising writers do we have writing in Kashmiri? The answer may alarm us to the threat of cultural alienation we are going through.

the otherwise apparently disparate modes and manifestations of life into an organic whole. Appearances may change, forms may evolve and additions and alterations may be made here and there, now and then. But as long as loyalty and concordance to the underlying defining principle is maintained, no change and no modification in any manifestation of cultural import shall be seen as regression or degeneration of culture. What wrong is therein if traditional costumes are given updation and brought in at par with the fashion in vogue, while at the same time maintaining its traditional aesthetics and originality? Like musicians have been bringing in many changes by virtue of their understanding and mastery over both the traditional and modern music. Is it not a judicious and better alternative instead of throwing away the baby with the bathwater? Between the dilemma of resisting any change and yielding to every change, we have, for instance ruined many of our traditional inheritances and things of cultural value and import. Look for example the architectural and structural changes we have bought in our residential houses. No doubt, they are at par with the time we are living in, but they are at complete discord with our geography and topology, weather and climate, our ways of life and manner of living. This is an illustration of mismanaged grafting and superimposing upon the local elements something which is out rightly alien to them. Same has been the case with many other aspects of our life and culture, where we have so much yielded to the change that we have almost abandoned the idea if the change is compatible to the place we are living at. Even seasoned engineers and geologists inform us that our vernacular architecture and structural make up of houses was at par with the geological and seasonal specifications of the place.

The intention is not to digress from the issue and get lost in the architecture and structure of our traditional and new houses. But the example The trail of culture is spread across the vast horizons of space and time. It can't suffice to summarise the entire scene in few lines and nor is it something like catching the ocean in the drop. But before we conclude this survey of the situation we are culturally in, pertinent does it seem to have some remedial suggestions. What needs never to be lost sight of is that culture, though a collective and social phenomenon, begins with the individual as society begins with the individual itself.

So the first responsibility lies on individuals to visualise themselves as cultural agents, possessing certain social and cultural roles and responsibilities beyond meeting one's basic life needs. Why shall a weaver, a carpenter, a woodcarver, a coppersmith, an artisan leave out his job out of the worry that these jobs don't hold position of esteem and respect in public imagination and retrospectively, why shall our thinking be so regressive as to ascertain the status and portfolio of people in accordance with what they do and simultaneously, out of our own misconstrual deem some jobs and modes of making livelihood inferior to others. Nothing worse can be thought of for a society which aspires progress and prosperity. So there has to be a bilateral shift of mind so as not only to retain our traditional artisanship, but to incorporate the same in preserving our culture, of which it is a definite and mundane propagator. Why shall our children and grownups feel ashamed of speaking Kashmiri and prefer languages with which we share no organic relationship except that learning those languages has become an economic necessity. Having given our economic necessity the status of our betoken cultural identity is nothing short of idiosyncrasy.

massacre at a Texas primary school has again drawn attention to the powerful gun lobby in the United States, with Democratic officials blaming Republican legislators for remaining beholden to influential pro-gun interests that advocates say have stalled national gun reforms.

President Joe Biden, speaking hours after an 18-year-old gunman stormed the Robb Elementary School in Uvalde, Texas, fatally shooting 19 children and two teachers on Tuesday, asked: "When, in God's name, are we going to stand up to the gun lobby?".

Former President Barack Obama, who was in office when a gunman killed 20 children and six adults at the Sandy Hook Elementary School in Newtown, Connecticut in 2012, said the US "is paralysed, not by fear, but by a gun lobby and a political party that have shown no willingness to act in any way that might help prevent these tragedies".

Meanwhile, Democratic Chairman of the House Intelligence Committee Adam Schiff tweeted: "Children are dying, and we could do something about it. But the GOP won't stand up to the gun lobby".

What is the US 'gun lobby'?

The so-called gun lobby in the US is a broad term that encompasses efforts to influence both state and federal policy on guns, usually through supporting candidates who have pledged opposition to gun control measures.

'It includes direct contributions to legislators, efforts to independently support elected officials, and campaigns to sway public opinion on issues related to firearms. Such lobbying is often carefully calibrated to navigate US election finance laws.

Several investigations have shown that major anti-gun control lobbying groups – notably the most prominent, the National Rifle Association (NRA) – have close ties with the multibilliondollar firearms industry in the US.

The NRA and similar groups often frame themselves as civil rights defenders, pointing to the Second Amendment of the US Constitution

that establishes "the right of the people to keep and bear arms".

Meanwhile, gun control groups like the Giffords organisation, founded by former US Congresswoman and gun violence victim Gabby Giffords, accuse NRA lobbyists of solely being motivated by the goal "to sell more guns and pad the bottom line of gun lobby executives".

Gun control advocates have long blamed the lobby's power for the dearth of federal gun control measures passed in the US in recent years, despite a series of prominent mass shootings and a recent spike in active shooter incidents.

Gun control advocates also blame lobbyists for helping to loosen firearms restrictions in Republicandominated state legislatures across the country.

Texas Governor Greg Abbott and Republican Texas Senator Ted Cruz, as well as former US President Donald Trump, are set to speak later this week at a meeting in Texas hosted by the NRA's Institute for Legislative Action, the organisation's self-described "lobbying" arm.

How influential is the 'gun lobby'?

is difficult to quantify the influence of the constellation of groups that make up the gun lobby, which provide both political cache and millions of dollars in direct support to candidates across the country. The NRA, which has run into financial hardship in recent years, has long maintained a grading system for politicians and undertakes advertising campaigns in support of its interests.

From 1998 to 2020, pro-gun groups paid \$171.9m in lobbying to directly affect legislation, according to OpenSecrets, a non-profit that tracks spending in US politics. Since 1998, the NRA alone paid \$63,857,564 in that category.

Meanwhile, pro-gun groups have paid a whopping \$155.1m in a 10-year span from 2010 to 2020 on so-called outside spending, according to OpenSecrets. Since 2000, the NRA has paid more than \$140m in such spending, which includes all spending that supports – but is not directly coordinated with – a candidate.

Unlike direct contributions to candidates, there is no cap on outside spending for corporations and nonprofits following the 2010 Citizens United v FEC Supreme Court ruling.

In 2016, the NRA reportedly spent \$50m in outside spending in support of Trump and six Republican candidates for Senate.

The money assured that one in every 20 TV ads that aired in October of 2016 in the influential swing state of Pennsylvania was sponsored by the NRA, according to an analysis by the Center for Public Integrity. In North Carolina, one in every nine ads was sponsored by the NRA that month, while in Ohio, one in every eight ads pushed the group's pro-gun interests.

The NRA's overall spending jumped \$100m in 2016 over the previous year with "no politician benefiting more" than Trump, OpenSecrets reported.

Trump repeatedly promised to support gun rights, in 2017 telling the NRA "I will never ever let you down"

NRA "I will never, ever let you down."

Pro-gun organisations have also paid a total of \$54.4m in direct campaign contributions, a category subject to restrictions on donations, from 1990 to 2020, according to OpenSecrets. The contributions

in recent years have been almost entirely to Republicans.

The top recipients so far in 2022 in the US Congress were Republican Senators Rand Paul and John Kennedy, who each received over \$38,000 from pro-gun groups, according to OpenSecrets. US House of Representatives Minority Whip Steve Scalise

received \$25,610 from pro-gun groups

during that period.

In 2018, during his re-election bid,
Texas Senator Cruz received \$311,151
in direct contributions from pro-gun
groups. In 2020, vulnerable Republican Senators Martha McSally, David
Perdue, and Kelly Loeffler received
over \$516,000, \$307,000, and \$298,000
respectively from pro-gun groups, according to OpenSecrets.

How powerful is the 'gun control lobby'?

Efforts to legislate gun control on a federal level have made little headway in the wake of the Sandy Hook massacre in 2012, but advocates have pointed to a growing gun control movement that they say could lead to change.

That movement was "essentially nonexistent" in 2013, when efforts to expand federally required background checks for firearms sales failed in the US, Senator Chris Murphy, who represents Connecticut, told the New York Times in mid-May.

"It's all about political power, and political muscle, and we're in the process of building our own," he told the newspaper.

Meanwhile, lobbying for gun control, while still dwarfed by pro-gun movements, has grown since 2013, led by groups like Giffords, the Mike Bloomberg-backed Everytown for Gun Safety, and the Sandy Hook Promise.


Overall annual spending on lobbying by gun control advocates jumped from \$250,000 in 2012 to \$2.2m in 2013.

In 2021, gun control groups spent \$2.9m on lobbying.

On "Tomb of Sand" and the International Booker Prize

Geetanjali Shree talks about her novel "Tomb of Sand", which, in its translation from Hindi by Daisy Rockwell, won the International Booker prize

"If you handle a heavy thing with lightness, you actually increase the poignancy, and it puts a different kind of focus on it." Geetanjali Shree is talking to me about her novel Tomb of Sand, which, in its translation from Hindi by Daisy Rockwell, won the International Booker prize on Thursday. It's now early Friday morning and Shree and Rockwell join me from London's Groucho Club - bright, fresh and talkative despite the night's festivities (Rockwell was still tweeting about it at 2am).

Shree has been writing for more than 30 years, and three of her previous books have been translated into English. Why did this one strike such a chord with readers and judges? "I think it speaks to the pluralism of the world, the polyphony of the world, and that somehow captures the imagination of people. I also think there's a lot of inventiveness in the language, which seems to have ap-

That is certainly true. Tomb of Sand is a sombre-sounding book - about an 80-year-old woman, Ma, who slips into depression after the death of her husband - and daunting at almost 750 pages. But it's playful and funny, light but not slight, a carnival of characters. "It's an important way to focus attention," says Shree. "It's also the best way to live! To get some fun in spite of the serious

The serious things in the book are borders and divisions: between religions, genders and nations – notably between India and Pakistan, as a result of the partition of India in 1947. Shree, who was born 10 years later, says that even though her generation does not remember the partition, "we very much live with it, particularly the ideology it has unleashed, [that supposes] that these two major communities in the subcontinent cannot live together."

Shree was born Geetanjali Pandey but changed her surname to her mother's forename. "It was in adolescence, when I got my first bank account, and with a great flourish I signed my full name. But my

father said, 'No, just sign your first name, because a woman's name will change after marriage.' He wasn't being nasty, but it stayed with me. And I thought, why is my mother's name nowhere? She's the one who played such a big role in bringing us up. So when I started writing, I thought, I want my mother's first name to become my second name."

The process of translation for Tomb of Sand was collaborative, via emails throughout the pandemic between Rockwell in Vermont and Shree in New Delhi. Shree speaks English ("like many Indian people, because of the Raj!"), which helped the process, though she insists that her English "may sound fluent, but it's a very formal, schooled English". As a child she was encouraged to read: "That was the time of the new independent India. There was a lot of idealism afoot and as a result we as children were exposed very much to our language and literature, compared to the children of today. The world has turned to corporate success stories, and they don't need India and its culture in the way that in my time, people felt they needed it."

One quality of the International Booker prize is that it recognises - and shares the £50,000 prize money between - both author and translator. In Rockwell's view the prize has "a lot to do with the recognition of the translator" that we are seeing now. This includes a campaign for translators to be named on the covers of the books, spearheaded by Jennifer Croft, who Rockwell notes is not named on the cover of her own International Booker-shortlisted translation, Olga Tokarczuk's The Books of Jacob. "I think she's pretty peeved."

An artist and writer as well as a translator, Rockwell comes from a creative family. Both her parents are artists and her grandfather was Norman Rockwell, the celebrated painter who held a mirror to American social history. Was she encouraged to pursue her creative impulses? "They wouldn't have known any other way to raise me. I tried to be an academic, but it didn't work!'

Indeed Rockwell painted the cover images for both Hindi and English editions of Tomb of Sand in India. Why didn't the UK publisher use her covers? "I don't know! I think they should issue a commemorative edition with my cover on it!"

A few years ago, when Rockwell had just agreed to translate Tomb of Sand, she spoke of how, having translated only men for some time, she was focusing exclusively on female writers. Since doing so, she says, "I think what's been really important to me is to realise how women's voices are left out of literature by men and are sidelined. So I've enjoyed really thinking about women's

experiences and women's lives. I'm not really that interested in going back." She laughs. "You know the way people can be annoying, they say, 'I've cut sugar out of my diet, and now I hate sweets.' So I'm kind of like that!"

How 'gate' became the syllable of scandal

n June 17, 1972, Washington, D.C., police arrested five men for breaking into the headquarters of the Democratic National Committee. Although the administration's press secretary, Ron Ziegler, dismissed the crime as a "third-rate burglary," its scope would grow to consume Richard Nixon's presidency and then bring it to an end 26 months later.

As with other infamous episodes, such as the Teapot Dome scandal or the Chappaquiddick tragedy, the event would come to be known by the place where it occurred.

But unlike those two precedents, the Watergate Office Building would be immortalized as the catchall term for political scandal.

"Watergate," in this context, is an example of metonymy. A part - the site of the break-in - comes to stand for the larger whole: the illegal acts committed by Nixon's administration, as well as the subsequent investigation into them.

Metonymy is a common way in which English is fortified with new vocabulary - think of "the Pentagon" as a stand-in for the U.S. military, or "Hollywood" as a way to refer to the motion picture industry.

What's unusual about Watergate is that one syllable splintered off to become the universally recognized designator for political malfeasance. When boozy government-sponsored parties that broke COVID-19 lockdown rules came to light in the U.K., the scandal quickly became known as "partygate." But the syllable has also migrated beyond politics, becoming a tag for wrongdoing of vir-

tually any kind. Other splinters have also been pressed into service to create new words. For example, "-athon," from "marathon," can emphasize an event's long duration - telethon,

dance-a-thon, and hackathon. Similarly, "-aholic," from "alcoholic," denotes an addiction: shopaholic, workaholic, sexaholic.

But in terms of sheer productivity, "-gate" has no peer. Wikipedia's list of -gates has over 260 entries.

During its remarkable career, it has often been wielded as a linguistic cudgel, and few other four-letter strings have such power to stigmatize and to demonize.

The early years

A year after the Watergate breakin, the humor magazine National Lampoon referenced "Volgagate" - a fictitious Russian scandal - in its August 1973 issue. This seems to have been the first use of -gate as a generic label for a political scandal.

A month later, Newsweek characterized a scheme to peddle cheap Bordeaux as "Winegate." Its extension to viniculture suggested that -gate might have a life outside of

But the real popularizer of -gate was William Safire, Nixon's former speechwriter. As a conservative political columnist with The New York Times for over 30 years, Safire created or promoted many such terms. These included Billygate, Lancegate and Briefingate to describe scandals that emerged during Jimmy Carter's presidency. He also popularized Travelgate and Whitewatergate dur-

ing the Clinton years. These episodes didn't rise to the seriousness of Watergate, of course. But by making them into -gates, Safire was implying that Democrats could be just as corrupt as Republi-

Apart from Safire's inventions, few episodes from the 1970s to the 1990s were referred to as -gates. Only about 10% of the terms on Wikipedia's list date from the 20th century. Even major political scandals of the period only occasionally received this epithet.



But even half a century later, -gate is still finding gainful employment in politics. It was used, for example, to tag several Trump scandals, from Russiagate to Ukrainegate. And President Joe Biden has had to contend with Kabulgate and #formulagate.

Consider the Reagan administration's scheme to use Iranian arm sales to fund the Nicaraguan Contras. All the attributes for a Watergatestyle comparison were present: illegal activity, conspiracy and an at-

tempted cover-up. Despite this, The New York Times referred to the episode as "Reagangate" just twice, "Contragate" only 11 times and "Irangate" about 100 times. In contrast, the paper used the phrase "Iran-Contra" nearly 6,000 times in its coverage.

Opening the 'flood-gates' In the new millennium, however, -gate became totally unmoored from

It has been employed to describe kerfuffles in almost every field of human endeavor – sports (Astrogate), journalism (Rathergate), technology (Antennagate) and entertainment (Nipplegate).

Already in 2022, hashtags referring to a number of events - such

as #slapgate and #lettergate - have trended on Twitter.

For those who value precision in language, this as a problem - because if everything is a scandal, then nothing is.

Consider "Ponytailgate." In 2015, New Zealand's prime minister, over a period of several months, repeatedly tugged on the ponytail of a young café waitress. He persisted despite repeated requests from both the waitress and the prime minister's wife that he stop. Such behavior is boorish at best.

But does it belong in the same category as events involving corruption, a conspiracy, or a cover-up?

A pleasing sounding suffix It may be that -gate is used because nothing better has come along. Replacement terms have enjoyed only limited popularity.

The splinter "-ghazi" arose in reference to the 2012 attack on the U.S. diplomatic post in Benghazi,

Libya. It was occasionally deployed against the Obama administration. For example, when President Obama wore a tan suit to a press conference, "Beigeghazi" was born. But -ghazi probably failed as a suffix for scandal because it was too much of a mouth-

This can be seen in the 2014 debate over what to call former New Jersey Gov. Chris Christie's lane closure scandal. Should it be "Bridgeghazi" or "Bridgegate" - or even "Bridgeaquiddick"?

Bridgegate won out - undoubtedly because it was shorter and simpler. Resonance also seems to apply for other scandals: "Deflategate" simply sounds better than "Ballghazi" as a name for the New England Patriots football scandal.

One size fits all?

Not content with its domination of English, -gate has also wormed its way into other languages, such as German, Serbo-Croatian, Greek and

But like most successful trends, the widespread use of -gate has engendered significant backlash. As with Ponytailgate, many of these coinages fail to differentiate the mundane from the momentous. This invites accusations of journalistic laziness, in which events are merely lumped together rather than analyzed.

In addition, overuse has transformed -gate constructions from the somewhat clever coinages of Safire's day into the tired clichés of today. It can also be difficult to tell when a -gate construction is intended ironically, which makes interpretation difficult.

Finally, sometimes shorthand is just too short. "Reagangate" may have failed as a label for Iran-Contra because it wasn't specific enough. The term could have referred to any of several different episodes during Reagan's eight-year administration.


At the other extreme, the same -gate has been applied to very different controversies. "Sharpiegate" referred to Terrell Owens' signing of a football in 2002. But it was also trotted out for President Donald Trump's edit of a map of Hurricane Dorian's path in 2019. And in 2020, it became associated with allegations of ballot

fixing in Arizona. But even half a century later, -gate is still finding gainful employment in politics. It was used, for example, to tag several Trump scandals, from Russiagate to Ukrainegate. And President Joe Biden has had to contend with Kabulgate and #formulagate.

No president has resigned since Nixon, arguably in the face of worse scandals than Watergate.

As with the wear and tear on an overused suffix, one has to wonder: Have voters become numb to political scandal, too?

Their findings, involving almost one million Danes, were more than an interesting correlation: the risk of mental health problems varied directly with the amount of green space available to the child. As more people move into cities and mental health diagnoses appear to be rising, the findings could have relevance for urban planning.

More than 450 million people suffer from a mental disorder, according to the World Health Organization. And this number is expected to increase. In some places, urban residents have almost a 50 per cent higher risk of developing anxiety and mood disorders compared with their rural counterparts, and the risk of schizophrenia is 200 per cent higher for children who grow up in the most urbanised environments.

Contact with nature has long been linked to better mental health — it's why sanatoriums strengthening social bonds in neighbourhoods.

Mapping using satellite data

Researchers from Aarhus University used satellite data from 1985 to 2015 to map the amount of green space around Danish childhood homes. Because Denmark collects detailed health data about its citizens, the researchers could compare this data with whether the children went on to develop one of 16 mental disor-

Children surrounded by the highest amounts of green space had up to a 55 per cent lower relative risk of developing a mental disorder — even after researchers adjusted for other known risk factors such as socio-economic status, urbanisation and family history of mental disorders. The more green space a child had, the lower the risk of poor mental health.

This 'dose-dependent' relationship was present across the country and the Danish population, indicating that the association is more than a simple correlation. Accounting for people moving to and from more urbanised areas,

further in a survey of Danish blood donors. Around 66,000 people answered questions about their access to green space and 'blue space' water bodies. Current mental well-being was associated with more green space around people's homes. Calm was particularly associated with 'blue space'. The researchers also found that more physically active people had even stronger positive associations with green space.

Green space in childhood is therefore extremely important, and it follows that urban planning for access to natural environments for all ages is likely to have benefits.

The very large datasets for both studies strengthen the findings. Across time, geography, 'dose' level and huge numbers of people, the patterns were the same. The results are part of a larger movement of scientific studies that have found a wide range of physical and mental health benefits of green spaces

These studies are supported by many experimental studies where scientists manipulated environments that showed green space is linked with stronger cognitive development Taking greener approach

This knowledge can guide future urban planning — important because by 2050 more than two-thirds of the world's population is expected to live in a city. Integrating more natural environments into urban areas may improve the mental health of city residents.

A greener approach to urban planning has the associated benefits of mitigating climate change, reducing the urban heat island effect, managing flood risk and conserving biodiversity. Working within and across research disciplines will ensure the multifunctional potential of urban green spaces is fulfilled.

Local governments around the world are already starting to make cities greener. Denmark's capital, Copenhagen, recently decided to transform one of its major roads into a park to improve green-space access, and Barcelona in Spain has launched an ambitious urban greening plan for the whole city to promote the health of its citizens and support biodiversity.

In a project in South Africa, Danish researchers are working with local collaborators

Nature-based solutions

Large international organisations such as the World Bank and the European Union have also seen the potential of green urban planning, including nature-based solutions — projects that tackle development problems while keeping the natural environment to the fore.

Since 2012, the World Bank has supported nature-based solutions in around 100 projects in 60 countries, allocating \$1.18 billion in 2019-20; and the EU is providing funding for such projects through its Horizons 2020 programme. Competition for space is intense in the world's densely populated cities, meaning innovative approaches to green space design will be needed for example, green walls and roofs.

Local perspectives and context are also important. Current studies on green space and mental health are mainly from developed economies, so they may not apply in developing economies. Involving local communities in planning decisions will help.

Fruits And Vegetables Plays Key Role In ADHD Symptoms In Children

ccording to a new study, eating fruits and vegetables can help children reduce inattention issues.

The findings of the study were published in the journal, 'Nutritional Neuroscience'.

As part of a larger study, researchers asked parents of 134 kids with ADHD symptoms to complete a detailed questionnaire about the typical foods the children ate, including portion sizes, over a 90-day

Another questionnaire asked parents to rate symptoms of inattention -- a hallmark of ADHD -- in their kids, such as having trouble staying focused, not following instructions, difficulty remembering things, and difficulty regulating emotions.

Results showed that kids who consumed more fruits and vegetables showed less severe symptoms of inattention, said Irene Hatsu, co-author of the study and associate professor of human nutrition at The Ohio State University.

"Eating a healthy diet, including fruits and vegetables, maybe one way to reduce some of the symptoms of ADHD," Hatsu said.

The data for this research was collected as part of the Micronutrients for ADHD in Youth (MADDY) Study, which examined the efficacy of a 36-ingredient vitamin and mineral supplement to treat symptoms of ADHD and poor emotional control in the 134 kids aged 6 to 12.

The study that evaluated the effectiveness of the supplement showed that children who took the micronutrients were three times as likely to show significant improvement in their ADHD and emotional dysregulation symptoms than those who took a placebo. That study was published last year in the Journal of the American Academy of Child and Adolescent Psychiatry.

Another study involving the same children, published earlier this year in the journal Nutrients, showed that kids whose families had higher levels of food insecurity were more likely than others to show more severe symptoms of emotional dysregulation, such as chronic irritability, angry moods and outbursts of anger.

The three studies all paint a similar picture, Hatsu said: A healthy diet that provides all the nutrients that children require can help reduce the symptoms of ADHD in children.

"What clinicians usually do when kids with ADHD start having more severe symptoms is increase the dose of their treatment medication, if they are on one, or put them on medication," Hatsu said.

"Our studies suggest that it is worthwhile to check the children's access to food as well as the

quality of their diet to see if it may be contributing to their symptom severity," he added.

Children in the MADDY study, all of whom met the criteria for ADHD, were recruited from three sites: Columbus, Ohio; Portland, Oregon; and Lethbridge, Alberta, Canada. The study took place between 2018 and 2020. Participants were either not taking medication or stopped using it two weeks be-



fore the study began.

The studies on fruit and vegetable intake and the role of food insecurity were based on data collected when the children were first enrolled in the study before they began taking the micronutrient supplement or placebo.

Why may diet be so important in ADHD?

Researchers believe that ADHD is related to low levels of some neurotransmitters in the brain -- and vitamins and minerals play a key role as cofactors in helping the body make those important neurochemicals and in overall brain function, Hatsu said.

Food insecurity may play an additional role. "Everyone tends to get irritated when they're hungry and kids with ADHD are no exception. If they're not getting enough food, it could make their symptoms worse," she said.

Also, the stress of parents who are upset about not being able to provide enough food for their children can create family tension that could lead to more symptoms for children with ADHD.

The MADDY study is one of the first to look at the relationship between ADHD symptoms and diet quality among children in the United States and Canada, Hatsu said.

That's important because Western diets are more likely than many others, such as the Mediterranean diet, to fall short on fruit and vegetable intake, she

MUMBAI: Reserve Bank on Friday said it is looking at pros and cons of introduction of a virtual currency in the country and it will adopt a graded approach for launching the central bank digital currency. Finance minister Nirmala Sitharaman while presenting the Budget 2022-23 had announced that the central bank will launch an Indian digital currency.

Introduction of CBDC (Central Bank Digital Currency) was announced in the Union Budget 2022-23 and an appropriate amendment to the RBI Act, 1934 has been included in the Finance Bill, 2022, RBI said in its annual report for 2021-22 released on Friday.

It said that the Finance Bill, 2022 has been enacted, providing a legal framework for the launch of CBDC. "The Reserve Bank is engaged in the introduction of a central bank digital currency in India. RBI's Balance Sheet Increased By 8.4% In FY 2022 To Rs 61.9 Lakh Crore

MUMBAI: The size of the Reserve Bank's balance sheet, which is reflective of activities carried out by it in pursuance of currency issue function as well as monetary policy and reserve management, has increased by 8.46 per cent during 2021-22, the annual report data showed.

While income for the year increased by 20.14 per cent, expenditure rose by 280.13 per cent, RBI said in its annual report 2021-22 released on Friday. The year 2021-22 ended with an overall surplus of Rs 30,307.45 crore as against Rs 99,122 crore in the previous year, resulting in its decrease of 69.42 per cent.

Last week, the central board of directors of RBI had approved transfer of Rs 30,307.45 crore surplus to the government.

"The size of the balance sheet increased by Rs 4,82,633.14 crore, i.e, 8.46 per cent from Rs 57,07,669.13 crore as on March 31, 2021 to Rs 61,90,302.27 crore as on March 31, 2022. The increase on the asset side was due to rise in foreign investments, domestic investments, gold, and loans and advances by 4.28 per cent, 11.67 per cent, 30.07 per cent and 54.53 per cent, respectively," said the report.

On the liability side, the increase was due to rise in deposits and notes by 16.24 per cent and 9.86 per cent, respectively.

RBI said that the domestic assets constituted 28.22 per cent while the foreign currency assets and gold (including gold deposit and gold held in India) constituted 71.78 per cent of total assets as on March 31, 2022 as against 26.42 per cent and



100 crore were made and transferred to Contingency Fund (CF) and Asset Development Fund (ADF), respectively," RBI said.

On gold holdings, it said as on March 31, 2022, total gold held by the Reserve Bank was 760.42 metric tonnes as compared to 695.31 metric tonnes as on March 31, 2021. "The increase is on account of addition of 65.11 metric tonnes of gold during the year," he said.

RBI said the value of gold (including gold deposit) held as asset of banking department increased by 37.11 per cent from Rs 1,43,582.87 crore as on March 31, 2021 to Rs 1,96,864.38 crore as on March 31, 2022.

This increase is on account of addition of 61.59 metric tonnes of gold and also due to increase in the price of gold and depreciation of INR vis-à-vis USD, said the report. On the expenditure side, the total expenditure of the Reserve Bank increased by 280.13 per cent from Rs 34,146.75 crore in FY21 to Rs

1,29,800.68 crore in FY22, it said. However, its total employee cost during the year decreased by 19.19 per cent to Rs 3,869.43 crore from Rs 4,788.03 crore in the previous fiscal. MUMBAI: India's forex reserves increased by USD 4.23 billion to USD 597.509 billion for the week ended May 20 on the back of a high accretion of core currency assets, according to RBI data. The country's foreign exchange reserves had declined by USD 2.676 billion to USD 593.279 billion in the previous reporting week ended May 13.

During the reporting week, the rise in the reserves was mainly on account of a drop in Foreign Currency Assets (FCA), a major component of the overall reserves, and gold reserves, as per weekly data released by Reserve Bank of India (RBI) on Friday.

"Incriminating materials, huge cache of arms & ammunition was recovered from both the sites of encounter. All the recovered materials have been taken into case records for further investigation," he said.

While interacting with media, IGP Kashmir Vijay Kumar said that both of the slain vouth had joined militant ranks recently and were involved in killing of artist Amreen Bhat on the directions of their Commander Lateef.

Kumar, according to the spokesperson, congratulated the joint teams for their valour and letermination to neutralize and avenge the killing of artiste Amreen Bhat within 24hrs.

"He also termed these operations as a big success and said that during past three days 10 terrorists including 3 from JeM and 7 from LeT proscribed terror outfits have been neutralized in the Kashmir valley," he added.

Between 2011 and 2012, the Board of Control for Cricket in India (BCCI) had given Rs 112 crore to the state cricket association for the promotion of the game in Jammu and Kashmir. It was alleged that Rs 46.30 crore from the grant was misappropriated.

In 2015, a public interest litigation (PIL) was filed by two cricketers -- Majid Yaqoob Dar and Nissar Ahmad Khan -- in the Jammu and Kashmir High Court in connection with the al-

leged scam that had surfaced in 2012. The case was subsequently handed over to the Central Bureau of Investigation (CBI) to probe the alleged embezzlement of funds in the cricket association headed by Abdullah.

The CBI had filed a chargesheet last year in the court of the chief judicial magistrate of Srinagar against Abdullah and other accused

The agency had in 2020 attached assets worth Rs 11.86 crore of Abdullah in this case.

The ED had alleged that Abdullah "misused" his position as the president of the JKCA in the past and made appointments in the sports body so that the BCCI sponsored funds could be laundered.

The case had gone into virtual cold storage and was revived after Malik was picked up by the National Investigation Agency in 2019 on charges of militancy funding.
In January last year, the CBI, with help from

Special Public Prosecutors Monika Kohli and S K Bhat, framed charges against 10 people, including Malik, in the Rubaiya kidnapping case that turned out to be a turning point in the Valley's volatile history. The release of the five IKLF members was seen as a morale booster for militant groups, which had started raising their heads at the time.

The CBI moved an application summoning Rubaiya Sayeed as she was listed as a prosecution witness. This was agreed to by the special court that has now ordered her to appear before it on July 15, the officials said.

Rubaiya Sayeed was kidnapped by JKLF members from Srinagar to ensure the release of their associates lodged in different jails.

Other charged in the case are Ali Mohammed Mir, Mohammed Zaman Mir, Igbal Ahmad Gandroo, Javed Ahmad Mir. Mohammedd Rafiq Pahloo, Manzoor Ahmed Sofi, Wajahat Bashir, Mehraj-ud-Din Sheikh and Showkat Ahmad Bakshi.

During the investigation, accused Ali Mohammad Mir, Zaman Mir and Igbal Gandroo voluntarily confessed before a magistrate about his role in the Rubaiya kidnapping. Besides, four others made confessional statements before CBI's Superintendent of Police.

"Since the accused persons besides admitting of their own guilt have also narrated about the participation of other accused persons namely Malik, Javed Ahmed Mir and Mehraj-U-Din Sheikh, which can also be used against them as one of the pieces of evidence," the court had said in January last year.

The 10 are among the two dozen accused named by the CBI in its chargesheet filed before the court. Among the others, top JKLF commanders Mohammad Rafiq Dar and Mushtaq Ahmad Lone are dead and 12 are absconding. These are Halima, Javed Iqbal Mir, Mohammad Yaqub Pandit, Riyaz Ahmad Bhat, Khursheed Ahmad Dar, Basharat Rehman Noori, Tariq Ashraf, Shafat Ahmad Shangloo, Manzoor Ahmad, Gulam Mohammad Taploo, Abdul Majeed Bhat and Nissar Ahmad Bhat.

In March 2020, the special court framed charges against the JKLF chief and six others in another case related to the gunning down of four IAF personnel on the outskirts of Srinagar in January 1990.

Sethu Raja V/s The Chief Secretary, Government of Tamil Nadu and others wherein the court dealt with paramountcy of Article 21 of the constitution of India which confers the right to life and personal liberty and its application to the dead through judicial pronouncements. The court therein had elaborated that the

right to human dignity is not restricted to a living human being but available even after The Court in its orders observed that right of the next of kin of the deceased to have their

dear one cremated or buried as per the religious obligations and religious belief that the dead person professed during his life time, is part and parcel of right to life guaranteed under Article 21 of the Constitution of India. "The parents and close relations of the deceased are well within their right to demand

the dead body of their dear one to be cremated

or buried as per their traditions, religious obligations and religious belief," the Court said. Liverpool Vs Real Madrid: Key Stats Ahead Of Champions League Final

PARIS: The following are key statistics ahead of Saturday's UEFA Champions League final between English side Liverpool and Spanish team Real Madrid.

KEY STATS

- The two teams have met eight times in the European Cup, with Real winning four times and Liverpool three.
- Their most recent meeting was in the quarter-finals of the 2020-21 Champions League season.
- This is the third time the teams will meet in the final -- Liverpool won 1-0 in the 1980-81 European Cup final, while Real won 3-1 in the 2017-18 Champions League final.
- Real have won the title on 13 occasions -- in 1956, 1957, 1958, 1959, 1960, 1966, 1998, 2000, 2002, 2014, 2016, 2017 and 2018 -- and have triumphed in their last seven finals.

- England's Liverpool have won the title six times -- in 1977, 1978, 1981, 1984, 2005 and 2019.
- For the second time in a row, an English team will play in the Champions League final after Chelsea beat Manchester City
- Real have never lost a final since the competition became known as the Champions League. This is their eighth
- Real's Carlo Ancelotti is the first coach to lead a team in five Champions League finals and is seeking a recordbreaking fourth European Cup victory. He shares the landmark of three wins with former Real boss Zinedine Zidane and Liverpool's Bob Paisley.

Babar Can Become The First Batter To Rank No.1 In All Formats: Karthik

DUBAI: Veteran India wicketkeeper Dinesh Karthik reckons Babar Azam will soon become the topranked batter across formats, adding that Pakistan skipper is reaping the benefits of the subtle changes made in his batting technique.

The 27-year-old, who has been a consistent campaigner across all three formats, currently holds the top spot among batters in T20Is as well as ODIs and Karthik is confident Babar can become the first player in the history of the sport to be ranked No.1 across all three formats.

"One-hundred per cent (he is capable of achieving the No.1 ranking in all three formats). He (Babar) is a high-quality player who is at the peak of his batting prowess and he has got some Test matches coming up," Karthik said on The ICC Review.

"He has been phenomenal in all three formats of the game and he has done well in different batting positions too. I think he has the potential. He has got all the following of Pakistan helping him in abundance to go on and do special things for his country," he added.

The seasoned wicketkeeperbatter feels Babar has tweaked his batting technique recently which has helped the right-hander become a better player and his timing of the ball is now on par with all modern-day batters.

"The two things that struck me when I watched him bat is his balance and his striking point when he plays a ball.

"Whether it is on the front foot or the back foot, his ability to strike the ball more often than not under his eyes, has been phenomenal.



Sehwag, the country's only cricketer to have struck two triple hundreds in Test cricket, eters have achieved this feat, is among the 11 Indians to have played 100 plus Tests and scored over 8500 runs.
