Two Militants Killed In Anantnag Gunfight

SRINAGAR: Two local militants of Hizbul-Mujahideen (HM) were killed on Saturday in a brief encounter with government forces in Bijbehara area of South Kashmir's

Anantnag district, police said. A joint team of police, army's 3RR and the personnel of CRPF launched a cordon and search operation in Shattipora village of Bijbehara on Saturday afternoon on the basis of a specific input about the presence of militants in the village, a police spokesperson said.

The hiding militants, he said, opened fire upon the search team when they started advancing towards the suspected spot. He said that the joint team returned the fire

triggering off an encounter. In the brief exchange of fire, the spokesperson said, two local Hizb militants were killed and their bodies recovered

from the encounter site. The police identified the duo as Ishfaq Ahmad Ganie son of Shalgam, Srigufwara and Yawar Ayub Dar of Dogripora Awantipora.

As per police records, the spokesperson said that both the killed militants were part of groups involved in several terror crime cases including attacks on Police/SF and "civilian atrocities"



J&K Has Fifth Lowest Total Fertility Rate In India: Survey

SRINAGAR: The erstwhile state of Jammu & Kashmir has hit a grueling demographic milestone in the past three years as the latest round of National Family Health Survey for 2019-21 has revealed that J&K has the fifth lowest Total Fertility rate(TFR) in the country besides the women's TFR slipping below the replacement-level by 0.6 percent.

As per the National Family Health Survey, the replacement level for the fertility rate has been fixed at 2.1 percent, below which, if the rate slips then the fertility crisis is probably in place and also explains the point at which a population exactly replaces itself from one generation to the next.

The NFHS data noted that the fertility rate in J&K has slipped down to 1.41 percent in the 2019-21 NFHS- 5 from 2.0 percent recorded in the

The fertility rate between the last

recently recently unveiled survey further notes that among the larger states in India, the high-

est decline of 0.6 percent in survey in 2015-16 and the latest one was recorded in J&K. The survey further states that in J&K, female sterilization

clined from 24.4 percent in NFHS-4 to 21.1 percent in NFHS-5 and male sterilization from 0.4 percent in NFHS-4 to 0.3 percent in NFHS-5. "The total fertility rate (TFR)

in Iammu & Kashmir is 14 children per woman, which is below the replacement level of fertility. Fertility has decreased by 0.6 percent between NFHS-4 and NFHS-5," the report added.

These figures were placed according to the findings of phase two of the National Family Health Survey (NFHS-5). The Government of India, in May,

released the key indicators on prevent preg-nancy population, reproductive and child health, family welfare, nutrition and others for India including J&K, clubbed under phase two of the 2019-21

Besides this, what looks like lack of awareness and existence of several taboos, about 60 percent of women aged 15-24 years still use cloth for menstrual protection in J&K as the former state ranks lowest in North India in regards of females using a hygienic method for menstrual protection, according to the NFHS report.

1500 Healthcare Workers To Be **Deployed For Amarnath Yatra**

SRINAGAR: The health department will deploy around 1500 healthcare workers from Jammu and Kashmir and other states of the country for the upcoming Amarnath Yatra being held after

a gap of three years. The details about the deployment of healthcare workers for the annual pilgrimage were shared by Director Health Services, Kashmir in a meeting chaired by the Principal Secretary, Health and Medical Education, Manoj Kumar Dwivedi at Civil Secretariat here on Saturday, an official spokesperson said.

Giving a brief presentation about the health care arrangements for the ensuing pilgrimage, the Director, he said, informed that 70 medical centres will be set up, including 6 base hospitals, 11 medical aid centres, 12 emergency aid centres besides 26 oxygen booths and 15 onroute facilities.

"He further informed that 17 onroute facilities will be kept on alert to meet any exigency. The training and deployment of medical staff has been worked out as per the current requirements," he said.

The Director, he said, gave a break up of staff for the Yatra and said that 739 staffers from the Union Territory, 155 from MoH&FW and 437 staff members from other states will offer their services to the pilgrims.

"The services of a total of around 1500 healthcare workers from J&K and other states shall be utilised to make the Yatra a success," he added.

Super Cyclones May Have Much More Devastating Impact In India In Future: Study

uper cyclones, the most intense form of tropical storms, are likely to have a much more devastating impact on people in India in the future due to climate change, according to a modelling study.

Researchers from the University of Bristol in the UK examined the 2020 Super Cyclone Amphan - the most costly cyclone to make landfall in South Asia -- and predicted its implications under several scenarios of sea-level rise caused by global warming.

The study, published in the journal Climate Resilience and Sustainability, showed that if greenhouse gas emissions continue at the current rate, more than two and a half times (250 per cent) of India's population would experience flooding of greater than one metre. compared to the event in 2020. "South Asia is one of the most

climate-sensitive regions in the world, with super cyclones causing tens to hundreds of thousands of deaths in historical cases," said study lead author Dann Mitchell, Professor of Climate Science at the University of Bristol. "Comparatively, very little climate impact research has been done in South Asia, despite the Intergovernmental Panel on Climate Change highlighting it as such a critical region," Mitchell said in a statement.

The study presents a critical piece of evidence in support of ramping down greenhouse gas emissions to achieve the Paris Agreement climate goals, where other lines of evidence all too often focus on high-income countries where impacts are lower, and adaptation is more easily achievable, the researchers said.

They used sophisticated climate model projections to anticipate the scale of those affected by cyclones in the rest of this century.



Although the increasing number of people at risk is anticipated to be more modest in Bangladesh, estimated to rise by 60 per cent to 70 per cent, this factors in declining coastal populations in the future, the researchers said.

They noted that if the Paris Agreement climate goals of 2 degrees

The main objective of the Paris Agreement, a global framework to tackle climate change, is to hold the global average temperature increase to well below 2 degrees Celsius above pre-industrial levels and endeavour to limit the tem-

perature increase to 1.5 degrees Celsius.

"The latest IPCC report has mentioned with high confidence that tropical cyclones with higher intense categories will be more frequent in the future," said Saiful Islam, Professor of Hydrology at the Bangladesh University of Engineering and Technology (BUET), and contributing author of the study.

"This study shows that population exposure in Bangladesh and India will be increased up to 200 per cent in the future for extreme storm surge flooding (greater than 3 metres) from intense cyclones under high emission scenarios,' Islam said.

The researchers noted that a strong, rapid and sustained greenhouse gas reduction is essential to achieve goals of the Paris Agreement and to reduce losses and damages of highly vulnerable countries.

We're Taken Unawares In Kargil, But Have No Regrets

UNMOGIP Relevant As Long As It Is Present Here: Col Turunan

RINAGAR: The acting chief of the United Nations Military Observer Group in India and Pakistan (UN-MOGIP), Colonel Ismo Turunan, has dispelled the fear of a Kargil-type clash between India and Pakistan. He doesn't think any party has plans for any major action'.

In an exclusive interview to Observer News Service, Col Turunan, however, hastened to say, "Anything can happen if the things are not sorted out and nothing can be said for sure as the situation is quite tense and any skirmish can lead to big trouble. Nothing can be predicted for sure".

He said it was because of the reports that had been appearing in the western media about the possibility of a second phase of Kargil that there is a hardly any western tourist in the Valley

He accepted that the UN group, which is primarily here to observe and monitor the ceasefire agreement of 1971 between India and Pakistan, was taken unawares by the Kargil conflict of last year, however, adding that they had no regrets for it. "When India with so big military presence and resources could not get even an inkling, how could it be possible for us to know about it. Besides, the terrain is difficult and it was not possible

The UNMOGIP had a field station at Kargil upto 1980, but again, keeping in view last year's incidents, he said that it was not politically possible. The Group has 11 field stations spread over both the countries. These are at Baramulla, Uri, Poonch, Bhimber, Rawlakot, Kotli, Muzaffarabad, Gilgit and Skardu. Commenting on the Kargil conflict, he said that although

it was very local, it was very fierce as compared to the previous wars between the two countries, because of the fact that the Indian side had double the casualties they had previously suffered in 1971 war. The intensity of Kargil incident has, however, not made much of a difference to the Group. Why so? The Colonel says that they— need advanced equipment and men for that. "But we don't pursue the ability for round-the-year observation in high mountain areas", he said, adding they were not an advance intelligence group who will warn about things. "We don't intend to it.

About the present situation along the line of control (LoC), the Colonel says that although the shelling is continuing, it was not of high intensity. Asked about their role to stop it or about the sufferings of the civilian population, he said that they could do nothing about it as it falls beyond the ambit of their mandate.

"We are not missionaries, not teachers but observers; the UN official said adding "We are not here to say who did what and when, but simply to observe. But we have enough evidence of the things that are happening here." And we know we are

Israel's World

he utter impunity with which Israel has unleashed its war machine on the defenceless Gaza population underscores once again the exclusive position Tel Aviv enjoys on the horizons of world powers who have vowed to bring peace and democracy to the planet.

As far as the terror wreaked by this rogue state is concerned, the self-appointed guardians of international justice have blinkered eyes, or else willfully choose to ignore the enormity of the transgressions committed again and again by successive Israeli regimes. The just world order that some in the international community would like to usher in evidently excludes Israel from its purview as it is left free to perpetrate atrocity upon atrocity on the Palestinian people. What escapes the custodians of global peace and justice is that the existence of Israel itself is in total contravention to all norms of morality. But even after the Palestinians have relinquished their legitimate and exclusive right to the lands from which they have been dispossessed, they are being targeted as if their persecutors would be satisfied with nothing less than their extermination.

The positions the world powers, mainly the US, have taken in the face of wanton slaughter of children in the Gaza Strip evoke unadulterated revulsion at the humanity, or rather the lack of it, of those who would lead the world. After their spoken and unspoken complicity in the Gaza terror, would-be-liberators of mankind are not left even with the fig-leaf of morality that would give them the authority and the stature to lecture to the world.

The latest flouting of all international norms by the Jewish state is tied to the tussle for power at home, and the cowardly military campaign in Gaza has already sent the popularity graphs of foreign minister Tzipi Livni and defence minister Ehud Barak soaring.

But the real reckoning will come when the ground as sault, launched on Saturday, begins to exact its toll. The weeklong aerial bombardment posed little risk to Israeli personnel, but a ground invasion where they would come face to face with Hamas fighters would be a different cup of tea altogether. Livni and Barak, both banking on the squashing of Gaza as a ticket to the top job in the coming elections, can put off their celebrations as the experience in earlier campaigns in Lebanon could serve as a lesson. The Palestinian are long accustomed to losing loved ones to Israeli aggression, but the Israelis, like the US, are highly sensitive to sons and brothers coming home in body bags. And that is where the public tide could turn for the prime ministerial hopefuls.

Just as it happened in Lebanon, the Jewish state cannot be sure of meeting its military objectives, but the bloodshed it has wreaked on civilians in Gaza will speak in the loss of credibility of the Israeli leaders at home. The Palestinians have nothing left to lose except their lives, and they are quiet inured to it in the past six decades of criminal violence they have faced. But Israel could face a military disaster like Lebanon that could further shatter its already battered myth of its invincibility. In part, the Jewish state is encouraged by the unconscionable inertia of the Muslim regimes that are beholden to the US for their power. But contrary to what monotheistic texts - one of which is scared to the Jews - say, Israeli leaders are quiet oblivious to the promise of natural retribution on crossing the limits of humanity time and again. But this is what they should be most afraid of.

Before they are done in by the Gaza campaign, Israeli leaders would do well to undo the invasion, and end the two-year-old blockade of the territory. They must come to the negotiating table with the Palestinians if they seriously want the rockets sporadically fired into their country to stop.

If the world powers, particularly the US, want to salvage what is left of their credibility in the world, they would be well advised to rein in Israel and compel it to create conditions for the Palestinians to live with peace and honour

We are young girls of today and we refuse to watch ourselves or our friends being harassed and labelled 'wayward'

Dear School, We Refuse To Be Morally Policed

ominantly, we link school life to a part of our lives which is stress free and is all smiles. It seems, however, that this connotation attached to school life is limited. The experiences of students run quite contrary. Students generally feel relieved and liberated when they finally leave school because what should have been the best experience of their lives is often mentally exhausting and horrifying.

Coming from the system itself, I cannot help but wonder about the horrors I have had to witness as a school captain, while having to implement the school 'decorum'. The system of schooling precisely lacks almost everything but disrespect for every student's self-image. Even when the underlying impulse is to 'guide' students, the ways are often outmoded and inappropriate. Although some 'reputed' schools have given up on physical punishments, the discipling of students remains violent as ever.

Schools here may rationalise this disciplining model but to the aware eye, it is mostly driven by a culture of shame and moral policing. Schools play a significant role in every individual's life as they spend their developmental and formative years here. However, schools have taken upon a role beyond them and often end up being the purveyors of morality, sometimes at the cost of doing the actual work of educating students in real sense.

In one instance, in my school, a 16-year-old girl's hair was forcefully trimmed by the teacher herself because her hair wasn't braided. In another incident, a male teacher asked a 15-year-old girl to take off her hijab and give it to him. He then used the hijab to clean his shoe and justified this harassment by guilt tripping the girl into thinking that since she wasn't wearing it 'consistently', she was hopeless and "characterless". Emotions aside, this amounts to harassing women and stripping them. It is not only inhumane but also illegal. It tantamount to physical and mental harassment of girls.

As a woman, I can speak for the negative fallout of such exercise on women students. They're morally policed to the extent of being slut shamed. They're classed into groups of "good girls" and "bad girls" – a shameful alienating exercise for children in their adolescent years.

Shockingly, it is not confined to mental harassment through words alone but actions too, especially for girls. They are often reduced to their appearance and are told that they don't deserve respect and won't achieve any success in life because they look or dress a certain way. Their caliber is reduced to dust irrespective of their merit and metal.

While the same schools organise extravagant events in the name of women's empowerment, numerous debates on women's rights and long speeches about gender equality; the hypocrisy is clearly evident.

In the name of 'discipline' and 'decorum', school teachers and administration usually label girls "characterless" for wearing something as normal as kajal/eye kohl. While it is true that students should follow a proper uniform and attend school in a formal style, teachers should know of better ways to deal with it rather than restorting to character assassinating young girls.

It is deplorable how young girls are treated 'in schools. They are brainwashed into thinking that they are somewhat inferior and are internalised with the notion which makes them think they have no control or stake on their bodies. Even as the educational system in the rest of the world is advancing in science, technology and techniques of teaching, our system is still stuck on promoting patriarchy and misogyny.

Such behavior towards young girls isn't detrimental to their growth and self-image alone. This treatment leaves an impact on young boys who learn such violent and misogynist values. We often wonder what cultivates tendencies in men which make them treat women unfairly. It is in schools that literate men learn that women are secondary, should be "shown their place" and "controlled" through whatever means available. This is how most end up committing

the worst crimes against women.

Why is it that highly educated men have little to no respect for their peers from the other gender? It is because school teaches young boys that women exist to be under constant supervision by practically policing women and showing young boys that girls should be 'pulled by the leash' if they cross patriarchal boundaries. When young boys see teachers who are the idols of righteousness in their eyes scrutinizing young girls, they learn the same sexist values.

Add to this the culture of hostility that schools breed between girls and boys. Socialising between girls and boys is considered so out of question that schools end up raising youngsters who have no etiquettes to respectfully engage with each other.

When schools make cross gender interaction impossible for children as small as 8-yearolds, they start to think that the other gender is somewhat alien. Should someone dare to have a casual or even formal conversation with a fellow student from the other gender, they're chided scornfully. In essence, this teaches students that the other gender is nothing more than their sexual selves. Adolescence is a sensitive age. You and growing children start their journey into adulthood with new experiences that they have no control over. By assuming that completely isolating girls and boys is the way out for reducing unwanted and unsurvellied interactions between them, we are fooling no one but ourselves. School is the only place where interaction between boys and girls can be monitored. There can be healthy interactions which may take different forms but will eventually stay just that - new adolescent experiences. It is especially more relevant for boys, who do not know how to productively channelise their feelings and end up making

them?

While the stereotypical 'good' girls are oppressed in a way they don't openly understand, the 'bad' girls are openly and evidently criticized and practically abused. They are forced into thinking that they are somewhat inferior to others because they dress or talk or behave in a certain manner. The school authority or teachers pronounce this judgment not understanding that school is entirely a place of learning and no judgments should be made for someone who is still in the process of discovering themselves and has a long way to go.

This kind of labelling and discrimination is extremely discouraging for young girls. We, as a society, should pave the way for women to be leaders and teach them the right values in a meaningful and positive way. What schools do instead, leads to them thinking that they are not capable and are in fact outcasts. This embeds in them a lack of self-confidence and gives them a lifetime of trauma.

What we don't realize is when we blame girls for provoking boys, we make boys think that they are not accountable for their actions, and somehow end up justifying their actions. This kind of apologia is not unfamiliar to our society as it is the same thinking that goes on to blame women for every crime against them.

Yet another negative aspect of contemporary schooling in Kashmir is that it does not acknowledge the concept of mental health which even small kids are aware of now. The school counselors who claim to be the epitome of psychological knowledge and present themselves as the flag bearers of mental health awareness in Kashmir, often aid school authorities in their quest of demeaning little girls. They often sully the sanctity of secrecy and aggravate the process of shaming

stalkers out of themselves.

Additionally, had schools facilitated healthy and decent ways for girls and boys to interact, we'd have a bunch of men who wouldn't have to rely on our society's skewed views of women. They would have learnt how to decently interact with the other gender and to respectfully engage or disengage. Boys should not be left to learn about women from popular culture which objectifies women and stereotypes them. When young boys grow up alongside intelligent and confident girls they'd not have to borrow their view of women from such harmful sources.

We can have our own views about the extent to which we want girls and boys to interact. These kinds of restrictions can infact be right as well. However, reprimanding, slut shaming, and character assassinating is not going to make the cut. It just makes adults look spiteful and ignorant.

Schools have a very different meaning of morals. Their fixation on student's sexual morality is almost perverted and sexualising. They care less about imparting the ideals of humanity, like the virtues of kindness, mercy, humility, sympathy, justice, truthfulness, tolerance which the human beings of today lack the most.

Isn't it bad that a place full of girls, instead of cultivating in them a sense of solidarity and sisterhood, encourages them to demean each other? Why are young girls who are yet to figure out anything about themselves dismissed as "bad" girls or "good" girls; as though there is something intrinsically irredeemable about

girls. Instead of providing students a safe space, free of judgment, they end up being a cog in the machinery of naming and shaming.

It is very easy to blame impressionable youngsters for falling prey to substance abuse when they find the entire process of growing up so isolating and hostile. Where are school authorities when students stray a bit? Why do schools have one and only one way of guiding - punishment?

Students of today are aware. Yes, we do have easy access to risky content through our phones. However, we also have access to information that teaches us to value ourselves and let one abuse us in the name of discipling. We refuse to play by the sexist, patriarchal and unethical books of schools which cannot step up to treat students respectfully. We need an education that teaches us values in a positive manner and trusts us with our choices. We want schools that raise women who uplift each other rather than shame each other. We are young girls of today and we refuse to watch ourselves or our friends being harassed and labelled 'wayward'. We deserve better. Guide us better. Step up!

Haller was proud of his profession even if it meant representing criminals as he believed every person had the right to be represented. For instance there comes a point where Haller discreetly posts security outside Maggie's and Hayley's house to ensure that him being Elliot's counsel does not pose a threat to their safety. The series during its entirety also digs into the mystery behind Jerry Vincent's death and his reason for leaving his practice under Haller's care.

Even though the show delves into a myriad of themes it carries out the storylines and plots successfully. It does not portray itself to be forced but rather seems to be a product of effortless execution and acting. In a sea of series being put on OTT platforms, The Lincoln Lawyer is not only a fresh break from the overhyped 'machismo' portrayed in law series but also gives insight into the flaws and gaping holes in the American justice system while providing the audience with a good introduction to the same.



Seven Charge-Sheeted For Selling Fake Helicopter Tickets To Vaishno Devi Pilgrims

Jammu: Seven persons allegedly involved in selling fake helicopter tickets to Mata Vaishno Devi pilgrims were chargesheeted on Saturday in a court in Reasi district of Jammu and Kashmir, police said.

While four of the accused were arrested from Rajasthan in March, three were held from Bihar in May during the investigation into complaints regarding duping of pilgrims who were sold online fake helicopter tickets for the journey from Katra to the hill shrine.

As many as fake websites were also identified and blocked during the investigation of the cases, a police spokesman said.

He said the charge sheets were filed in two cases registered under relevant sections of the Indian Penal Code and Information Technology Act against the seven accused.

The accused were identified



as Sunil Chawla, Monu Pankaj, Deepak Kumar and Gajanand Meghwal of Rajasthan and Ashok Kumar Sharma alias Mistri , Lakhpati Paswan and Santosh Kumar of Bihar



of complaints regarding fake online helicopter ticket bookings for Mata Vaishno Devi pilgrimage. After the registration of cas-

es, special teams were formed

under the supervision of Superintendent of Police, Katra, Amit Bhasin and dispatched to various parts of the country to nab the accused involved in the commission of the crime, the spokesman said.

"The police teams zeroed on suspected locations in Rajasthan and Bihar and arrested a total of seven accused, the spokesman said, adding police also seized "incriminating material" from their possession.

All the accused were brought to Katra after getting transit remand, the spokesman said.

Senior Superintendent of Police, Reasi, Amit Gupta advised all the intending pilgrims to use only the official website of the Shri Mata Vaishno Devi Shrine Board for booking services such as helicopter tickets and not fall prey to the fraudulent advertisements issued by unauthorised websites offering confirmed helicopter tickets and

Lanka On The Boil, Demand For President Rajapaksa's Resignation Intensifies As Protest Enters 50th Day

Colombo: Sri Lankan police on Saturday fired tear gas and water cannons to disperse antigovernment protestors here as the ongoing agitation demanding the resignation of President Gotabaya Rajapaksa over the worst economic crisis intensified as it entered its 50th day.

Sri Lanka is near bankruptcy and has severe shortages of essentials from food, fuel, medicines and cooking gas to toilet paper and matchsticks.



For months, people have been forced to stay in long lines to buy the limited stocks.

buy the limited stocks. Sri Lanka's economic crisis a protest occupying the entrance to the president's office demanding his resignation continuing for the past 49 days. The crisis has already forced prime minister Mahinda Rajapaksa, the elder brother of the president, to resign on May 9.

There has been an intense call for President Gotabaya Rajapaksa to also resign however, he has refused to do so.

Saturday marks the 50th day of the Go Rajapaksa protest which has also seen the death

Old-School's Tryst

Today, she's used to teaching online but the 'old school' does not feel satisfied with the new normal. Among other things she feels the eye to eye contact is missing in online classes.

Facing the same problems and challenges, senior assistant professor at Government College of Education, Dr. Nuzhat Nasreen has a story of her own.

She believes there are no two opinions about

the fact that online classes have provided students with an alternative but for professionals of her age conducting virtual classes was no less than a challenge.

Name also in her fifties recalls the

Nasreen, also in her fifties, recalls the day they were ordered by the Educational Department to resume classes in an online mode. "In the beginning it was tough," she recalls. "But my relative's much-needed help simplified the complex for me."

Despite putting all her efforts in teaching her students, she believes the emotional motivation a teacher can give in an offline class isn't possible in an online classroom. But she does acknowledge that online classes have become a "good substitute" in uncertain times.

One of the major problems she has faced over the course of the last two years is the anxiety created by the new-age learning. "From getting strain in the eyes to mental stress, one has to go through a lot if one spends long hours teaching," she says.

She attributes her mental fatigue to the absence of facing students in the class and the overuse of technological tools.

The lack of discipline and management in teaching online also turned out to be a headache for her. In college we used to have a proper break after classes but in online classes there were clashes in timings," she says. "There were times when we had to take classes during evenings."

After two years of hardships, Dr. Nasreen is comfortable teaching her students online but the guilt of not satisfying every student is what discomforts her.

"In a classroom environment, some students understand things easily while some take time," she says. "All that is missing in an online class, where every student without even understanding things is bound to feel obliged and responds positively."

In the last two years, a lot has changed for traditional teachers like Sameena Khan in

When the government first gave instructions that teachers had to teach online, most of them had no knowledge about it. "But eventually," says Sameena, a teacher at Government Boys Middle School Narbal. "we learned a lot."

She picked up the threads of technology and learned the use of teaching applications like Zoom and popular video-streaming website, Youtube.

However, overcoming her fear for technology did not end her woes. Her students from traditional belts of Kashmir were not allowed to share their contact details with teachers. In a bid to persuade their parents, Sameena went door-to-door and counselled them.

"The parents of students were reluctant to share their phone numbers," she recalls. "It was only after proper counselling that they gave us contact numbers of their children. Without those contact numbers, we couldn't have been able to teach them."

Before the pandemic, many students were unaware about the use of technology in teaching. For those students, teachers like Sameena had to walk an extra mile. "Even during the peak of the coronavirus pandemic, we would designate one or two days during a week and inform students about online classes," she says.

"While the coronavirus may have left innumerable woes for people, it made us teachers technocrats in letter and spirit."

But despite becoming tech-savvy during the pandemic, some of these traditional teachers had a hard time teaching a challenging subject like mathematics online.

"Teaching Mathematics is always a challenge," says Javeed Khan, a mathematics teacher from Srinagar. "But teaching it online is a lot more difficult. Unlike a theoretical subject, it has to be taught using a board."

Apart from technical difficulties, these

teachers faced challenges as some students resorted to fake ID's, pranks and even abusive comments during classes.

survey has also noted that merely 50.5 percent of women aged between 15-24 years use sanitary napkins. However, the number has substantially increased from 48.8 percent in NELS 4 (2015) 2016)

Pertinently, in the recently released NFHS-5 survey—which provides data by socio-economic and other background characteristics that remains useful for policy formulation and effective programme implementation—women aged 15-24 years in J&K were asked what method or methods they use for menstrual protection, if anything

With 2116 females answering the questions, it was revealed that 58.4 percent of women use cloth for menstrual protection, 23.1 percent use locally prepared napkins, only 50.5 percent use sanitary napkins, 3.3 percent use tampons, 1.3 percent uses menstrual cup while only 0.3 percent use nothing.

A superficial look at the national rate reveals that in India, 64 percent of females use sanitary napkins, 50 per cent use cloth and 15 percent use locally prepared napkins. "Overall, 78 percent of women in this age group use a hygienic method of menstrual protection." The report stated

As per the experts across India, locally prepared napkins, sanitary napkins, tampons and menstrual cups are considered to be hygienic methods of menstrual protection.

However, questioning the veracity of the data, Dr Bilquis Jameel, one of the seasoned gynecologists of Kashmir says that the percentage of women in J&K using cloth for menstrual protection as shown in the report looks fictionally higher than what the reality.

"I personally don't think that this many females are using cloth for menstrual protection. But, let's hypothetically believe it's true, so in that case, if an unclean cloth is reused without proper wash, it increases exposure to multiple severe infections." Dr Bilquis told Kashmir Observer.

On exposure to infections due to unhygienic menstrual practices, Dr. Bilquis said that in such cases reproductive tract infections like bacterial vaginosis or urinary tract infections (UTI) could occur which eventually become pelvic infections. "And if not treated at an early stage, these infections can travel up to the pelvis and can cause difficulties in getting pregnant or pregnancy complications." Dr Bilquis said.

1500 Healthcare

Meanwhile directions were also issued to streamline the registration of the Yatris by the District Administration.



Sharp spike in missing children cases: NGOs call for increased sensitisation, vigilance

hild rights NGOs have flagged a sharp rise in the number of children who have gone missing in the last two years due to the social impact of COVID-19.

In order to prevent the situation for worsening, the organisations have called for the immediate strengthening of child protection committees at the village level, sensitising and training parents, and urged the government to make adequate budget allocation in this connection.

As per the latest figures of the National Crime Records Bureau (NCRB), 59,262 children went missing in India in 2020. With 48.972 children remaining untraced from the previous years, the total number of missing children has gone up to 1,08,234.

There is almost a 13 times rise in the number of cases of missing children reported annually between 2008 and 2020, the NCRB said. As per the data, 7,650 cases of missing children were reported in 2008.

In the last two years, Bachpan Bachao Andolan (BBA), Kailash Satyarthi Foundation's sister organisation alone has rescued around 12,000 children from across the country Dhananjay Tingal, its executive director,

"This is ample proof to show

trafficking has increased manifold," he told PTI.

On average, 29 children in Madhya Pradesh and 14 in Rajasthan went missing every day in 2021, according to a new report by NGO Child Rights and You (CRY), which gathered the information through RTIs.

Tingal said some children were being trafficked with the consent of their parents, while few others voluntarily went with the traffickers.

"Ultimately, a large majority of these children went missing," he said.

He urged employees of railways, roadways and others to immediately intervene if they come across any unaccompanied child or a child who is begging in public transport systems.

'Subsequently, such children must be brought under the umbrella of the government's safety net," he said.

Prabhat Kumar, deputy director, Child Protection, Save the Children, said increased poverty has become an overarching reason for children to go missing or become victims of trafficking. He said the situation has worsened due to no schooling or lack of continuity in learning activities due to CO-VID-19-enforced lockdown and restrictions.

Soha Moitra, regional director

that after the pandemic, child (North), CRY, said many families in rural areas were already in debt, and the economic burden due to the pandemic increased further. The pressure of paying back loans contributed to the trafficking of children of such families, for labour and mar-

She said mandatory use of face masks often made it difficult to identify traffickers and kidnappers.

"The government departments concerned in collaboration with the local administrative bodies and civil society organisations should come forward to create regular awareness on the importance of education of children with constructive activities," Moitra

In 2020, despite the complete nationwide lockdown for nearly four months March to June 59,262 children (13,566 boys, 45,687 girls, nine transgender children) were reported missing.

The share of missing girl children has increased from about 70 per cent in 2018 to 71 per cent in 2019, and further to 77 per cent in 2020, according to NCRB data.

On the other hand, the share of untraced children from the previous years accounted for about 42 per cent in 2018. 39 per cent in 2019, and 45 per cent in 2020 of the total missing children.

Fuel price hike was necessary to avoid bankruptcy, says Pak **PM Shehbaz**

Pakistan Prime Minister Shehbaz Sharif on Friday said his government's move to increase fuel prices was necessary to avoid the country from facing bankruptcy.

Pakistan on Thursday increased the prices of petroleum products by Rs 30 per litre. Following the hike, price of petrol is now at Rs 179.85, diesel at Rs 174.15, kerosene at Rs 155.95 and light diesel at Rs 148.41.

In his first address to the nation after assuming power last month, Shehbaz talked mostly about the domestic problem faced by the government.

His main focus was the relief package for the vulnerable groups after the government increased the petroleum prices to get an assistance package from the International Monetary Fund (IMF).

The prime minister said the move to increase fuel prices was necessary to avoid Pakistan from facing bankruptcy.

Shehbaz said the decision to increase petroleum prices was tough. We with a heavy heart increased nomic puddle, not we, he said.

prices of petroleum; we have to take the decision in a difficult economic situation. It is due to the incredible price hike in petroleum prices in the global market, he said.

The previous government had announced a subsidy which could not be supported by the treasury. We took the decision by preferring the country on our own interest, he said.

To mitigate the impact of the hike in the petroleum prices, he announced a Rs 28 billion per month relief package to provide Rs 2,000 per month to about 14 million families.

These families comprise almost 80 million individuals which is one third of the total population of the country, he said.

Shhebaz also blamed the previous government for the current hike in petroleum as it has committed with the IMF for this
