Srinagar: Two Jaish-e-Mohammad (JeM) militants, one among them involved in killing a policeman, were shot dead by government forces in an overnight encounter in South Kashmir's Pulwama district, police said Monday.

Around 5:45pm Sunday, police, army's 55RR and the personnel of CRPF launched a joint cordon and search operation in Gundipora village

of the district on the basis of specific input about the presence of militants, a police spokesperson said Monday.

He said when the search team started advances, the militants hiding inside the house of Nazir Ahmad Mir opened fire upon them. The joint team, he said, returned the fire setting off an encounter.

### Jammu Police **Issues Alert Over Sticky Bombs**

JAMMU: A day after security forces shot down a drone carrying explosives, the Jammu and Kashmir Police on Monday asked residents of the Kathua district to inspect vehicles before turning them on.

A North Korea-made drone sent from Pakistan with a payload of seven magnetic or sticky bombs and an equal number of under-barrel launcher grenades was shot down by the Jammu and Kashmir Police in the Talli Hariya Chak area close to the International Border on Sunday.

"We request drivers and conductors of passenger vehicles to check their vehicles and buses thoroughly (before starting them)," a policeman announced from a vehicle-mounted with a loudspeaker in the border town of Hiranagar area.

The police informed the residents about Sunday's incident and said, "These (magnetic and sticky bombs) are used to cause damage to vehicles. You are requested to thoroughly check vehicles, particularly before starting them in the morning," the policeman said.

The cops also asked the people to check fuel tanks and vehicle parts made of iron for sticky or magnetic materials.

Further, they asked the residents to report any suspicious activity in the area.

According to the officials, Sunday's drone that was shot down was the third of its kind sent from More on P6

### NAS 2021 Report Card Puts J&K **Schools Ahead Of National Average**

Srinagar: Jammu and Kashmir has registered an impressive performance in the sample-based National Achievement Survey (NAS) conducted by the Ministry of Education for classes 3, 5, 8 and 10 on November 12 last year.

The survey, which took place in all 733 districts across the country, was a competencybased national-level large-scale assessment that aimed to provide information about students' learning achievement so that a system-level reflection on the effectiveness of school education in the country could be conducted.

Language, Mathematics, Science, and Social Science were chosen as subjects for assessment in classes 3 and 5, while Environmental Studies was added for class 8 and Social Science and Modern Indian Language for class 10.

A total number of 79256 students and 16260 teachers in 3650 schools from all the 20 districts of J&K UT participated in the survey.

According to the NAS report card published recently, the percentage ratio of boys to girls for class 3 was 51 and 49 respectively while it was 78 and 22 for urban to rural.

The performance percentage for Language stood at 66 as against the national average of 62. Similarly, More on P6

# Militancy In J&K In Last Stage: MoS Jitendra Singh

Srinagar: Senior Bharatiya Janata Party (BJP) leader and Union Minister Dr. Jitendra Singh said on Monday that the militancy in Jammu and Kashmir was in its last stage and the same is evident in the heavy influx of the tourists in the Union Territory.

Singh made these comments while speaking to the media persons on the sidelines of an event in Central Kashmir's Budgam district on Monday.

Replying to a question about the recent civilian killings, Singh said that from the beginning Pakistan has been indulging in these mischievous acts but the decisive action is being taken against militancy.

### Youngsters In J&K Grappling With Hypertension: Survey However, the report also

**Srinagar:** Decades of braving conflict, curfews, lockdowns, deaths and physical injuries have definitely cost Kashmir its health as the latest round of National Family Health Survey(NFHS) has revealed that J&K has 18.9 percent men and 20 percent women in the above 15 age group who are battling hypertension.

While 21.3% of women and 24% of men aged above 15 have hypertension in India, J&K has 20% women and 18.9% men in the same age group (above 15) who have hypertension.

In the pre-hypertensive category, while the prevalence is 39 percent women and 49 percent men aged above 15 in the country, J&K has 55.9 percent women and 60.3 percent men, in the same age



group, stated the latest report NFHS-5) which was recently released by Union Health Minister Mansukh Mandaviya in Vadodara, Gujarat.

According to the report, in J&K, 0.8 percent of women who are aged above 15 have normal blood pressure, while in the

same age group, 0.5 percent of men have blood pressure. As per NFHS, 1 percent of men are in the severely elevated range, 1.8 percent are in the moderately elevated range and 12.3 percent of men have mildly elevated blood pressure. Besides this, 24.7 percent of men have normal BP.

stated that among women aged above 15, 29.4 percent have normal blood pressure. In the same age bracket, 11.7 percent, 2.1 percent and 1 percent of women are in the mildly elevated, moderately elevated and severely elevated range. Among the Northern States,

the prevalence of hypertension among women is the sixth highest in J&K with 20 percent of women having been diagnosed with hypertension. For men, the report stated, J&K has the third lowest rate of men diagnosed with hypertension.

Notably, High blood pressure or commonly known as hypertension is a common condition in which the long-term force of the blood against the artery walls is high enough that it may eventually More on P6



# **Scientists Identify New Liver And Kidney Disease**

cientists have identified a new disease in a groundbreaking discovery that could help patients with unexplained liver and kidney problems.

Researchers at Newcastle University in the UK have established the inherited condition, called TULP3-related ciliopathy that causes kidney and liver failure in children and adults.

There are numerous reasons for kidney and liver organ failure, which if left untreated is lifethreatening, but often patients do not get a precise diagnosis which can make their best course of treatment unclear.

Research, published in the American Journal of Human Genetics, has revealed that a faulty gene is the catalyst for increased fibrosis in the liver and kidney, often resulting in the need for a transplant. "Our finding has a huge implication for better diagnosis and management of kidney and liver disease in some patients," said Professor John Saver, Deputy Dean of Clinical Medicine at Newcastle.

What we are now able to do is give some patients a precise diagnosis, which allows their treatment to be tailored to their needs for the best possible outcome

"What we are now able to do is give some patients a precise diagnosis, which allows their treatment to be tailored to their needs for the best possible outcome," Sayer added.

In the study, experts reviewed clinical symptoms, took liver biopsies and genetic sequencing from scores of patients, where a total of 15 patients from eight families were identified as having this new disease.

Urine samples from these patients were used to grow cells in a laboratory and then investigated to determine the precise defect causing TULP3-related ciliopathy. Over half the patients in the study had a liver or kidney transplant as their condition had deteriorated significantly.

In these patients, the original cause for their organ failure was unknown until the study.

"We were surprised at how many patients we were able to identify with TULP3-related ciliopathy and this would suggest that the condition is prevalent within those with liver and kidney failure," Professor Sayer said.

"We hope to provide a proper diagnosis for many more families in the future. This work is a reminder that it is always worth investigating the underlying reasons for kidney or liver failure to get to the bottom of the condition.

"Finding a genetic cause of liver or kidney failure has huge implications for other family members, especially if they are wishing to donate a kidney to the patient." The team will now work with cell lines taken from patients to study more in detail the disease process and to test potential treatments for TULP3-related ciliopathy.





### Faith moves mountains, stops rain in Kashmir

RINAGAR - Jabbar Mir 56, has walked barefoot with a pitcher full of water to the shirne of saint Sheikh Hamza Mukhdoom in Srinagar. It's an age old custom that he is sure will pull his village out of a "do or die situation". Mir, a resident of Ganderbal, 22 km from Srinagar, has

climbed the Koh-e-Maran hillock in the middle of the city with hundreds of villagers, all travelling on foot and carrying water Filled earthen pitchers from various parts of the Kashmir valley. They are seeking saint Mukhdoom's blessings so that the intermittent rains lashing the valley stop and the bright sunny days return.

'It's a do or die situation for us. Our paddy nurseries are turning yellow because of the cold and rain. Unless we have bright, warm sunshine there would be hardly any paddy saplings left to be transplanted into the rice fields." Mir said

According to a local tradition, water collected from parts of the valley and brought here in earthen pitchers by barefooted devotees is poured into the large pond outside the saint's shrine so that saint Mukhdoom is pleased and blesses the people.

However, the devotees must walk all the distance from their This is a practice that the people have resorted to whenever excessive rains, floods and other natural calamities have visited

Asked if it works, Ghulam Nabi. 48 gives a stare. "It is a heretic's question. The custom always works. It is my experience of over four decades that whenever Kashmiris visit

the shrine, their prayers are answered," says Nabi, who has come from Anantnag district. 54 kin away. Nabi's 20-year-old son is an epileptic whose seizures have

become frequent in recent days.
. "I won't say a doctor is not needed to cure my son. But finally it is somewhere else that the outcome of our efforts is decided. Whether a doctor succeeds or not in curing my son would be decided at the sheikh's shrine." Nabi says.

Mukhdoom who lived in the 15th century, is also reverred as the saint who was instrumental in ending the "tyrannical" rule of local king Yusuf Shah Chak. Mukhdoom is believed to have written to Mughal king

Akbar about the oppression of the people under Chak. This led to the invasion of Kashmir by the Mughals and the end of Chak's Visiting shrines and seeking the blessings of dead saints is

an old practice in Kashmir. A little away from saint Mukhdoom's shrine is the temple of Hindu deity Sharika Devi.

Before the migration of Kashmiri pandits following the insurgency in the valley, Muslims and Hindus could be seen buying flowers from the same vendors for their saints.

There are very few visitors to the temple these days, yet a

semblance of the eclectic Kashmiri culture is recreated "when the lone priest at the temple rings the bells - the sound blends perfectly with the voice of the muezzin calling the faithful to prayer at Mukhdom's shrine.

# **Aadhaar Conundrum**

n Sunday, the central government withdrew with immediate effect its recent advisory that warned citizens not to share photocopies of their Aadhaar cards with any organization as they can be misused. The government, in a statement, said that the UIDAI issued Aadhaar card holders are only advised to exercise "normal prudence" in using and sharing their UIDAI Aadhaar numbers. "Aadhaar Identity Authentication ecosystem has provided adequate features for protecting and safeguarding the identity and privacy of the Aadhaar holder," the statement

Earlier, the UIDAI had warned people not to share photocopies of Aadhaar with any organisations, saying that it could be misused. The authority had advised the use of masked Aadhaar which displays only the last 4 digits of your Aadhaar  $number\ and\ can\ be\ downloaded\ from\ UIDAI's\ official\ website.$ A release issued by the UIDAI had also called for avoiding using a public computer at an internet cafe to download an e-Aadhaar. And if one did so, the authority had urged the deletion of all the downloaded copies of e-Aadhaar permanently from that computer.

There was more. Only those organizations that had obtained a User License from the UIDAI could use Aadhaar for establishing the identity of a person. Unlicensed private entities like hotels or film halls were not permitted to collect or keep copies of Aadhaar card. And if a private entity demanded to see the Aadhaar card or sought a photocopy of the Aadhaar card, one had to ask whether they had a valid User License from the UIDAI.

This made privacy activists feel vindicated. And rightly so. Aadhar has been a controversial identity card since the beginning. A large section of the population thought it compromised their privacy. This understandably generated civil society and political opposition but to no avail as the government stuck to its guns. But as the latest review of the sharing of the Aadhaar card underlines, the government is rethinking

However, Aadhaar is not the only point of concern for privacy advocates. The government's alleged surveillance of computers and social media has long been a source of contention. The catch-all excuse for this action is the special security requirement for the state that is supposed to warrant the early neutering of the sources of trouble. Earlier also, the UPA government had sought to screen the "offensive" content on the social networking sites after having allegedly failed to get these websites to take it off themselves. But such moves have always been contested by the media and public quarters, which see the contemplated measures as a trojan horse attack on freedom of expression in the country, forcing the govern-

The issue here is not the objectionable stuff on the internet, of which there is plenty, and it is nobody's case to defend it in the name of freedom of speech, but the government's plan to play the judge. The problem is that this stuff comes in a variety of ways, so it is really a complex business to sift one part of it as offensive while justifying or overlooking another part. More so, when it is a government with its own interests which sits on judgment on this. So, the need is to get civil society on board before the laws impinging on privacy are enacted.

# Absolution: On need to compensate for unlawful arrests

special investigation team from Delhi, which took over the case after allegations of extortion surfaced against Mr. Wankhede, has now cited lapses in the initial investigation and the lack of prosecutable evidence, and absolved Mr. Khan and five others and excluded them from the charge sheet filed recently. The lapses include failure to video-graph the search of the ship, not conducting a medical examination to prove consumption, and examining Mr. Khan's phone and reading messages on it

without any legal basis. It is good that the agency made amends for the mischief done by the initial set of investigators by applying the standard of 'proof beyond reasonable doubt' while presenting its final report. At the same time, the NCB has to re-examine its priorities. It is an elite agency in the fight against international trafficking in narcotic and psychotropic substances. Its primary focus ought to be on trans-national smuggling networks, while the job of pursuing drug peddlers and raiding rave parties must be left to the local police. While strict disciplinary action is warranted if any officer is found involved in 'fixing' someone, it is also time that the Government came out with a legal framework for compensating those jailed without proof. The country does not have a law on the grant of compensation to those maliciously prosecuted. However, constitutional courts do exercise their vast powers sometimes to award monetary recompense; the remedy of a civil suit is also available in law, but it is time-consuming. The Law Commission of India has recommended enactment of a law to make compensation in such cases an enforceable right. Currently, Section 358 of the Cr.P.C. provides for a paltry fine to be imposed on a person on whose complaint a person is arrested without sufficient grounds. Such provisions should be expanded to cover just compensation by the state for unnecessary arrests. It is a sobering thought to note that even people with celebrity status and vast resources are not insulated from the misuse of police powers, even while recognising that it is still possible to vindicate one's innocence and force the estab-

lishment to adopt a course correction.

# **Holding J&K's Environment Impact Assessment Authority Accountable**

Authorities are allowing illegal riverbed Mining in Shali Ganga. NGT now shoots a notice

ne principal bench of the National Green Tribunal (NGT) recently shot a one month notice to the J&K Environment Impact Assessment Authority (SEIAA) as Environmental Clearance (EC) granted by them for riverbed mining in Shali Ganga in Budgam was violating all the environmental laws and guidelines of SEIAA. While hearing an appeal against the EC granted by J&K SEIAA, a division bench of NGT headed by Justice Adarsh Kumar Goel(Chairperson NGT) and Professor A. Senthil Vel (Expert member) noted that the division bench has found it necessary to seek a response not only from the SEIAA but also from the project proponent (PP) M/S NKC Projects Pvt Ltd as well who are involved in large scale illegal mining in the area. This author was forced to move an appeal before the NGT as both State Environmental Impact Assessment Authority and Project Proponent failed to act over repeated requests to stop illegal mining in Shali Ganga which has been looted and plundered for last six months.

#### Case before NGT

The appeal was moved against the grant of Environmental Clearance (EC) for minor mineral block No. 4, Panzan bridge to Trumbi Bagh (Lalgam), downstream Shali Ganga nallah, village Lalgam, Tehsil Chadoora District Budgam, JK UT (resized area – 2.90 ha.), under proposal No. SIA/JK/MIN/255737/2022 & SIA/JK/ MIN/233732/2021, vide order dated 19.04.2022 by J&K State Environmental Impact Assessment Authority (SEIAA), in favor of M/s NKC Project Pvt. Ltd which is a Gurgaon based construction company having been allotted a contract of Srinagar Semi Ring Road in Kashmir. The company is illegally extracting minor minerals from Shali Ganga which as per Mineral Rules 2016 and SEIAA guidelines is completely prohibited. The SEIAA too seemed unbothered.

This author prayed before the NGT that environmental clearance (EC) granted by J&K SEIAA was in violation of Rule 4(iv) of Jammu and Kashmir Minor Mineral Concession which states that the Licensee of a unit/plant/crusher should maintain all records of the minor minerals procured, processed and supplied to further destinations and submit monthly returns.


Besides, it was also a violation of Rule 4 of Mining Rules, 2016 which prohibits mining within 25 meters from the embankment. The width of the Shali Ganga is no more than 40 meters on an average and allowing mining in it is illegal as the river has to be at least 100 meters wide i.e 50 meters to maintain distance from banks and 50 meters to use the area for mining. The riverbed is already over-exploited and not fit for being a mining zone. It will result in disruption of flow and will subsequently impact Hokersar wetland.

No District Survey Report has been prepared, as per the Sustainable Sand Mining Management Guidelines, 2016. The NKC Projects Pvt Ltd & other project proponents as well are using JCBs, L&Ts for mining despite clear instructions for not using a JCB in these riverbeds. Above all, no replenishment study has been conducted as per Enforcement & Monitoring Guidelines for Sand Mining, 2020. The entire tendering process is flawed in fact. How can NKC Projects Pvt Ltd extract sand, muck and bajri (gravel) and use the same for its Ring Road project while Mining Rules and other guidelines say that a material extracted has to be sold locally on 50 % discount in

### EAC gives Green Signal?

The project proponent NKC Project Pvt Ltd had submitted the first set of proposals for extraction of river bed minor mineral from three blocks which were considered together in 81st meeting of Jammu & Kashmir Union Territory Expert Appraisal Committee (EAC). The proposals were rejected on the grounds that the area is already over-exploited and is depleted to a large extent due to heavy illegal mining as Shali Ganga nallah is a feeding channel to Hokersar wetland and the mining activity may be detrimental to natural flow and quality of the water flowing into Hokersar wetland and that irrigation kuhls are present within the mining site.

Thereafter, the project proponent submitted fresh proposals for the grant of environmental clearances for the three blocks and the proposals were placed before the Expert Appraisal Commit-

tee (EAC) for appraisal together in its 87th meeting held on 02.03.2022. The EAC without considering 1 the environmental issues recommended them for grant of Environmental Clearances (EC's). The Jammu & Kashmir Environment Impact Assessment Authority (EIAA), on the recommendation of Jammu & Kashmir Union Territory Expert Appraisal Committee (EAC) granted Environmental Clearances (ECs) to the projects on 19.04.2022.

### Reasons for challenging ECs

This author challenged the three Environmental Clearances (ECs) granted by J&K Environmental Impact Assessment Authority (JKE-IAA) dated 19.04.2022 before the National Green Tribunal (NGT) for the following reasons:

A) The Environmental Clearances are in violation of Rule 4(iv) of Jammu and Kashmir Minor Mineral Concession, Storage, Transportation of Minerals, and Prevention of Illegal Mining Rules, 2016 which prohibits any minor mineral concession being granted within a distance of 25 metres of any embankment

The Environmental Clearances were granted without taking into account the grounds on which the previous proposals of the project proponent were rejected and despite no change in the ground level situation, the EC was granted.

The Environmental Clearances have been granted despite the District Survey Report not being prepared in line with the Guidelines, as noted by the Jammu & Kashmir Union Territory Expert Appraisal Committee (EAC) . Violations of Conditions of the Environmental Clearance dated 19.04.2022 by the project proponent who undertook activities strictly prohibited under the Environmental Clearance.

D) The EAC while granting Environmental Clearances in its 87th meeting failed to consider the grounds on which it had earlier rejected the first set of proposals of the project proponent in the 81st meeting. The EAC failed to note its own observation made in the 81st meeting that the area is "already depleted to a large extent due to heavy illegal mining and hardly any material is available for exploitation without endangering the environmental setting of the nalla.

The J&K UT level EAC in its 87th meeting dated 02.03.2022 recommended the projects for grant of two Environmental Clearances without considering that only a short span of time has elapsed since the last meeting was held, in which it was concluded that the area is heavily exploited and not fit for mining. How is it possible for an area to be restored and replenished within a short period of two months and make it fit for mining?

Irrigation canals under threat

The Expert Appraisal Committee (EAC) also recommended the projects for grant of Environmental Clearances even when it has been noted by it in the 87th meeting that there are "feature indicative of Irrigation offtake point" in the site area. At the same time, it also notes that NOC from Irrigation Division Budgam has clarified that there are no Khul or canal present in the mining block. The Environmental Clearances have been erroneously granted by J&K UT level EAC on the basis of the NOC granted by the Irrigation Department even when irrigation points were visible inside the site area. The J&K UT level EAC also failed to note the fact that Shali Ganga Nallah serves as a feeding channel for the Hokersar wetland and the project proponent was only directed to submit an undertaking to the Wildlife Protection Department duly attested by the Judicial Magistrate first class to the effect that in case of any damage to the existing water course in terms of ecological and hydrological factors, the costs of rehabilitation of the same will be decided by the Wildlife Protection Department and will be borne by the project proponent. Hokersar wetland, a Ramsar site in India is also known as the "Queen wetland of Kashmir" and serves as a breeding ground for migratory birds in Kashmir Mining on the banks of its feeding channel and thereby disrupting the flow of water into the wetland will directly impact the ecology of the area, livelihood of the people living around the wetland and the breeding ground for migratory birds.

### Conclusion

Is it necessary that people have to seek judicial intervention or file petitions of appeals before the National Green Tribunal (NGT) when it comes to protecting our rivers and waterbodies? How many people can do that? What are our Govt officials doing? Don't they read rules and regulations that govern riverbed mining in J&K? The NOCs granted by Irrigation, Flood Control, Pollution Control Board, Fisheries department and other authorities are totally flawed. Shali Ganga like Doodh Ganga is not fit for riverbed mining and in fact the entire tendering process is illegal Those who have approved it will also be taken to task and I would be filing a formal complaint against them as well before the NGT.

# Will Machines Replace Weathermen?

century ago, English mathematician Lewis Fry Richardson proposed a startling idea for that time: constructing a systematic process based on math for predicting the weather. In his 1922 book, "Weather Prediction By Numerical Process," Richardson tried to write an equation that he could use to solve the dynamics of the atmosphere based on hand calculations.

It didn't work because not enough was known about the science of the atmosphere at that time. "Perhaps some day in the dim future it will be possible to advance the computations faster than the weather advances and at a cost less than the saving to mankind due to the information gained. But that is a dream," Richardson concluded.

A century later, modern weather forecasts are based on the kind of complex computations that Richardson imagined – and they've become more accurate than anything he envisioned. Especially in recent decades, steady progress in research, data and computing has

enabled a "quiet revolution of numerical weather prediction."

For example, a forecast of heavy rainfall two days in advance is now as good as a same-day forecast was in the mid-1990s. Errors in the predicted tracks of hurricanes have been cut in half in the last 30 years.

There still are major challenges. Thunderstorms that produce tornadoes, large hail or heavy rain remain difficult to predict. And then there's chaos, often described as the "butterfly effect" – the fact that small changes in complex processes make weather less predictable. Chaos limits our ability to make precise forecasts beyond about 10 days.

As in many other scientific fields, the proliferation of tools like artificial intelligence and machine learning holds great promise for weather prediction. We have seen some of what's possible in our research on applying machine learning to forecasts of high-impact weather. But we also believe that while these tools open up new possibilities for better forecasts, many parts of the job are handled more skillfully by experienced people.

PREDICTIONS BASED ON STORM

Today, weather forecasters' primary tools are numerical weather prediction models. These models use observations of the current state of the atmosphere from sources such as weather stations, weather balloons and satellites, and solve equations that govern the motion of air.

These models are outstanding at predicting most weather systems, but the smaller a weather event is, the more difficult it is to predict. As an example, think of a thunderstorm that dumps heavy rain on one side of town and nothing on the other side. Furthermore, experienced forecasters are remarkably good at synthesizing the huge amounts of weather information they have to consider each day, but their memories and bandwidth are not infinite.

Artificial intelligence and machine learning can help with some of these challenges. Forecasters are using these tools in several ways now, including making predictions of high-impact weather that the models can't provide.

In a project that started in 2017 and was reported in a 2021 paper, we focused on heavy rainfall. Of course, part of the problem is defining "heavy": Two inches of rain in New Orleans may mean something very different than in Phoenix. We accounted for this by using observations of unusually large rain accumulations for each location across the country, along with a history of forecasts from a numerical weather prediction model.

We plugged that information into a machine learning method known as "random forests," which uses many decision trees to split a mass of data and predict the likelihood of different outcomes. The result is a tool that forecasts the probability that rains heavy enough to generate flash flooding will occur.

We have since applied similar methods to forecasting of tornadoes, large hail and severe thunderstorm winds. Other research groups are developing similar tools. National Weather Service forecasters are using some of these tools to better assess the likelihood of hazardous weather on a given day.

Researchers also are embedding machine learning within numerical weather prediction models to speed up tasks that can be intensive to compute, such as predicting how water vapor gets converted to rain, snow or hail.

It's possible that machine learning models could eventually replace traditional numerical weather prediction models altogether. Instead of solving a set of complex physical equations as the models do, these systems instead would process thousands of past weather maps to learn how weather systems tend to behave. Then, using current weather data, they would make weather predictions based on what they've learned from the past.

Some studies have shown that machine learning-based forecast systems can predict general weather patterns as well as numerical weather prediction models while using only a fraction of the computing power the models require. These new tools don't yet forecast

the details of local weather that people care about, but with many researchers carefully testing them and inventing new methods, there is promise for the future.

#### THE ROLE OF HUMAN EXPERTISE

There are also reasons for caution. Unlike numerical weather prediction models, forecast systems that use machine learning are not constrained by the physical laws that govern the atmosphere. So it's possible that they could produce unrealistic results – for example, forecasting temperature extremes beyond the bounds of nature. And it is unclear how they will perform during highly unusual or unprecedented weather phenomena.

And relying on Al tools can raise ethical concerns. For instance, locations with relatively few weather observations with which to train a machine learning system may not benefit from forecast improvements that are seen in other areas.

Another central question is how best to incorporate these new advances into forecasting. Finding the right balance between automated tools and the knowledge of expert human forecasters has long been a challenge in meteorology. Rapid technological advances will only make it more complicated.

Ideally, AI and machine learning will allow human forecasters to do their jobs more efficiently, spending less time on generating routine forecasts and more on communicating forecasts' implications and impacts to the public – or, for private forecasters, to their clients. We believe that careful collaboration between scientists, forecasters and forecast users is the best way to achieve these goals and build trust in machine-generated weather forecasts

# Clear The Cobwebs Of Mind

As stress and Covid-induced negativity engulf our routine, it is critical we get rid of the baggage that has been accumulating in our minds — and making us live on the edge

very spring break, I get into this routine where I collect old clothes, old shoes, and gadgets that I am no longer using and send them off to a place which salvages what it can — and then the recycled stuff gets donated. It makes me happy that I am contributing my two-bit to the larger good.

With the pandemic and various stress points of life creeping in more often than one would want, a friend suggested I repeat the routine mentally. Initially, I was a bit sceptical, but, nevertheless, gave it a shot. I processed feelings, emotions, regrets and expectations. Many of them, I realised, had lived longer in my head than needed and deserved a quiet burial. Some emotions were harder to pack away but, with time, it's a routine I have created.

Thoughts — bitter ones sometimes — that would buzz in my head needed to be chopped off and sent away packing. Expectations were toned down and I reminded myself of what Louisa May Alcott once wrote: "Into each life some rain must fall, some days must be dark and sad and dreary."

But I was also curious how others dealt with these mental dragons. Mj Maria Uy Lami-in, a Filipina expat, has been living in the UAE for 15 years now; she works as a socio-civic HR consultant, among other jobs. When asked about how she usually de-stresses, she says, "Stress is usually any outside factor that we let in to affect and get to us — that is if we let it in, and to what degree. I might not have the conventional answer most would want to hear but I keep busy outside of what's 'affecting' me. I keep my mind and body active with something more pressing, preferably not my current issues."

Some will say it's avoidance, but, for her, it's a temporary rerouting and regrouping of her mental and physical energies until she gets the strength and mental capacity to face and deal with her actual stressor. "It might not be very practical as per some professionals, but it works for me. A good blow dry helps.

Look good, feel good still stands true. It's not being fake. It's a step towards self-care. You already feel horrible inside, why wallow in it on the outside?"

### A CHANGING SOCIAL MINDSET

An upside of current times is that we are discussing mental health issues more often — and more candidly — these days. Mj Maria points out that the issue of mental health and 'being' in that place has always been present. "What has changed is the shift of what is now openly acceptable in our social mindset. It is now more accepted and acceptable, we are even expected to talk about mental health and one's own mental wellbeing, much like all the other currently 'socially relevant issues' of the last decade or so."

On how to keep regrets and expectations in check, she points out, "Hope for the best, expect the worst. I know that sounds fatalistic but with recent global events, we've come to a point wherein our priorities and mindsets have shifted. And mine certainly has. I have come to that age and maturity where I am more appreciative and immensely grateful everyday of what I have been given in life and survived and manifesting graces.

Yes, it's great to expect and dream of great things but we also need to have that practical and realistic balance of life realities so we don't get dismayed and disappointed over false expectations."

When asked that one size never fits all so how is an individual expected to deal with these pressures on their own, Mj Maria says, "There is no right or wrong answer I guess, even though some would push more for what they believe in. Depending on who is vocal, more visible and gets it out there. There was a time in my life I was easily rattled; on career, relationships, finances and people's opinions. I felt so alone and very scared. But I kept it all inside because of generational social expectations and pressure. I guess I might be of one of the last generation wherein we were conditioned to keep 'our mess, our perceived weaknesses in'. To keep a brave and strong face for everyone else except ourselves because that is how it was done. I was even afraid to ask for help or open up. We were conditioned to be that way.'

Leonardo DiCaprio, one of the biggest success stories to have come out of Hollywood, while speaking to Rolling Stone, said that his anxiety comes from the small things, the "really stupid stuff, things that shouldn't make you anxious whatsoever. It's crazy how your mind will become this database to make you

worry about things that are so arbitrary. I have a well-organized life, and I've put a lot of thought into the things that I do, and then, you know, my stomach will be... I'll just be sitting there, totally anxious about something ridiculous. You have to stop yourself during the day and say, 'It's just not worth it'."

### A SELF-CARE KIT TO BEAT STRESS

In London, Priya Chandan has developed her own way of dealing with dark thoughts and seeking a bright, safe place in the sun. Born and brought up in Mumbai, India, today she calls London — where she has now lived for 16 years with her husband, three kids and their pet dog — her home

After Priya had her third child, she decided to take up something that would allow her to find a purpose in her life. "I came across a foundation course in counselling and here I am, four years later, doing my Level 4 diploma in integrative counselling." She calls herself a self-love and selfcare advocate, and truly believes in

taking care of herself first because "you can't pour from an empty cup".
"My first priority in life is my family and if I struggle and burn myself out, I will not be able to give my family the love and the affection that I so very much would love to shower them with."

Mental health has recently become the hot topic perhaps because of the realisation now that mental health is not just about mental wellbeing but it also includes physical wellbeing, emotional well-being, social wellbeing — basically, your overall wellbeing. "Ever since the pandemic struck, with lockdowns and isolations, losing our loved ones to the virus and so much more, everyone was forced to slow down the pace of their lives, to reflect and take that reality check

which was long overdue," she feels.
"People were forced to re-evaluate their pre-pandemic life," Priya adds.
"Somewhere, I believe it eventually dawned on people that it was actually a burnout from the hustle and bustle of life. It gave us a fresh perspective of

how we can 'live' the gift of life rather than just existing. In my opinion, it has given people a fresh lease to build a life of conscious choices. Choices that add value to this new life and for this very reason, it's important that one nurtures and replenishes their own cup of self-care."

In order to walk the talk, Priya has built her own customised, go-to self-care tool kit whenever she feels overwhelmed. "I am aware one size never fits all. Everyone has their own way of dealing with things but you can make your own kit with anything that you truly enjoy doing when you are feeling stressed or burnt out."

So, what's in her self-care tool kit? "Long walks that help me regulate my emotions. Nature is therapeutic, it is soul healing. Sometimes driving helps me too. Music and podcasts distract me from over-thinking. Speaking to family and friends helps me calm my mind. Journaling is one of the best tools of my survival kit: pouring out my thoughts and feelings on a note pad has been a game changer. You do

not need to save these if you are worried someone might read them: you can write your thoughts on paper, and then shred it or even burn it. Anything that's bothering you — let it out of your system, on to the paper and let it go. Crying is one of the best self-soothing mechanisms that helps uplift my mood. Crying is not a sign that you are too sensitive or weak. Crying releases toxins and stress hormones which help restore our emotional balance and soothe the soul."

Priya also suggests keeping one hour of the day — or even just 20 minutes — to spend time with just yourself, sit with your feelings and reacquaint yourself with the new you.

### UNLEASHING THE POWER OF POSITIVITY

Ahmed Mohammed Younis, a quality engineer in the UAE, has his own unique way of coping with stress. "Stress can cause severe mental pressure in many ways. When it comes to me, I try my best to address and overcome this by identifying what stressed me out exactly and find answers as to why this is affecting me. This helps me in finding positive actions of what to do next to de-stress. Moreover, I do things that help me: getting busy with my friends and talking about positive things that can motivate me, going to the gym and working out... also, [looking for] food online plays a big role in overcoming

stress for me!" Ahmed says.

Stress cannot be avoided completely, so we must try and find coping mechanisms, and zero in on proper solutions on how to deal with them in a healthy and productive way. "We need to be easier on ourselves too. Fortunately, now there are many professionals who can help us seek positive life changes with tools suited to us. Sometimes we are our own worst critic. In the resolution on the Gyanvapi Masjid and Mathura Idgah cases, the organisation expressed its "deep anguish at the attitude of the political parties who support the forces disturbing the peace and tranquillity of the country by repeatedly raising disputes over ancient shrines", the statement said.

"The country will not benefit from running campaigns to keep old controversies alive and in the name correcting the alleged excesses and mistakes of history." "At present, such campaigns

# Two Dead, Trees Uprooted, Buildings Damaged As Heavy Rains, Winds Batter Delhi

New Delhi: Two persons were killed and several injured as heavy rains accompanied by strong winds battered the national capital on Monday evening, uprooting hundreds of trees, disrupting road and air traffic and damaging vehicles and buildings, including the iconic Jama Masjid.

Waterlogging and power outages were also reported in some areas. Police and fire brigade personnel responded to scores of rescue calls as trees fell on vehicles and passersby and incidents of wall collapse occurred, while civic bodies were busy clearing roads.

Delhi recorded 17.8 mm of rainfall till 5.30 PM, according to the weather department.

A 50-year-old man died in the Jama Masjid area in centra Delhi after a portion of a balcony of a neighbouring house fell on him during the strong winds when he was standing outside his residence.

The victim, identified as Kailash, was declared brought dead at Sanjeevan hospital in Daryaganj, Deputy Commissioner Police (Central) Shweta Chauhan said.

In the Angoori Bagh area of North Delhi, a 65-year-old homeless man identified as Basir Baba died after a Peepal tree fell on him, the police said.

In another instance, three members of a family including a one-year-old child were rescued after a Neem tree fell on a Creta car near Kabootar Market in Chandni Chowk.

The historic Jama Masjid also suffered damage as the finial of its middle dome broke. Its Shahi Imam Syed Ahmed Bukhari said two people were injured as loose stones fell from one of the minarets and other parts of the mosque.

According to police, 294 calls about fallen trees were received till 8 pm on Monday Eight calls of house collapse

were reported by Delhi Fire Police. Commuters had a difficult time as traffic snarls were reported near ITO, AIIMS flyover, and DND. At least five flights were also diverted and 70 were delayed at the Delhi airport due to the thunderstorm, officials said.

The delayed flights included at least 40 departures, they said.

Delhi Lieutenant Governor Vinai Kumar Saxena visited some of the affected places.

"Distressed by the sight of uprooted trees, fallen branches and waterlogging at places after the early evening storm... Instructed officials to take immediate steps to remove debris and clear the roads immediately so as to mitigate the inconvenience to people," he

Residents posted videos of cars shaking in the gusty winds and of fallen trees. In many places, vehicles were damaged after the trees fell on them owing to strong winds and rain.

West Delhi BJP MP Parvesh Sahib Singh Verma's car was also damaged after the branches of a tree fell on the vehicle parked at his official residence at Windsor Place.

"Till 7.15 PM, a total of 101 complaints were received about uprooted trees and broken branches. Work is on to clear the areas where such incidents have been witnessed. Several areas, including Bhagwan Das Road, Connaught Place, SP Marg, have already been cleared," a senior NDMC official said.

A red Volkswagen car was damaged after a piece of metal pierced its windshield while another car was reported trapped under an uprooted tree at Connaught Place.

Several trees were also uprooted inside the Jamia Millia Islamia where the walls of a building were also damaged, officials said.

According to varsity officials, many solar panels installed in the administrative block were blown away by the winds.

The walls of Zakir Husain Memorial suffered damage due to the heavy downpour. Almost 200-300 trees would have suffered damage across the campus. The road outside the varsity campus witnessed traffic snarls.

The heavy rains and wind also damaged flags installed by the Delhi government at

various locations. Trees were also uprooted on the Bhai Vir Singh Marg in the Gole Market area near the Nepal Embassy and also near the Parliament Street police station leading to obstruction in traffic.

The Kasturba Gandhi Marg was completely closed for vehicular movement. There were also reports of poles damaging vehicles in the South Extension market while a Delhi Traffic Police booth at Vijay Chowk was damaged owing to strong winds.

Social media users tagged Delhi Traffic Police by sharing photos of various locations where trees had been uprooted.

The Delhi Police also assured people that their issues were being taken care of.

The wind was so strong that an air conditioners fell off a building on the Parliament Street, causing damage to cars and auto-rickshaws.

According to the spokesperson, the LG also announced the creation of 1500 Van Dhan Self Help Groups in the UT to make women of the tribal community financially independent. He said an amount of Rs 15 crores has also been made available.

On ensuring access to quality and affordable education for the children of tribal community, the LG, as per the spokesperson said that the UT administration has reviewed the scholarships of the students at various levels and hiked the same across the board in line with the contemporary realities.

He said that for students associated with the seasonal schools, children up to middle school were still being given an annual scholarship of Rs 450 to 675. A committee was formed to examine this, and now this scholarship is being increased to Rs 2400 annually, which will directly benefit about 34,000 students.

Similarly, he said, the review of scholarship in higher education had not been done from 2012 onwards, and technical courses and postgraduate students also got only 30 thousand rupees annual scholarship.

This is also being increased to Rs 60 to 80 thousand annually, which will benefit 12,000 youths of the tribal community," he added.

**SRINAGAR:** The Jammu and Kashmir High Court on Monday dismissed a petition seeking criminal proceedings against officer bearers of a company for allegedly duping a man from South Kashmir's Anantnag district worth Rs 3 crore.

A single Judge Bench of Justice Sanjay Dhar quashed a complaint and cheating proceedings director, director or any other initiated against office bearers office bearer of a body corporate of a firm 'Aizen Communication would arise only if there exists Pvt. Ltd.' for allegedly duping Nisar Ahmad Dar of Rs 3 crores.

The complaint against company's officer bearers comprising chief managing director, managing director, manager and clerk was filed before the Chief Judicial Magistrate, Anantnag, alleging that they had entered into a criminal conspiracy by forming the company 'Aizen Communications Pvt. Ltd'. to cheat the complainant.

# In A First, J&K Govt Facilitates Nomads' Journey To High Land Pastures

Transit Accommodations Coming Up At 8 Places At A Cost Of Rs 28 Cr

**SRINAGAR:** Come summer in Kashmir, nomadic population of Jammu and Kashmir start moving towards the valley for onward trekking to high pastures. Kashmir offers best and stimulant grazing for the livestock, which keeps roaming whatever the weather conditions prevail on higher reaches.

Thus far, the movement of shepherds and cattle breeders used to be

a common phenomenon in Jammu areas up to Khanabal via nearly 290 km national highway. However, the UT administration of Jammu and Kashmir, for the first time, put a halt to laborious exercise of moving over vehicularly congested roads and deployed 40 Road Transport Corporation trucks for onward journey of cattle and cattle breeders up to the high pastures.

Every year by ending March, thousands of nomads begin their annual seasonal journey with lakhs of sheep and goats from Jammu region to reach the Kashmir valley. These families embark on their journey towards the alpine pastures

for grazing during the summer before returning to warmer districts of Jammu region in October as the temperature goes down. The hard journey from Jammu

precious time for nomads leading to financial loss and physical strain. The hardships of these nomads further aggravated over the years due to dwindling number of on foot to greener pastures of primary source of transportation, Kashmir used to consume lot of horses. Transportation of their

household goods and cattle to the upper reaches through tricks and load carriers was a long pending demand of these nomads before the administration. On the directions of Lieutenant

Governor, Manoj Sinha, the department initiated a special project envisaging a transhumant support system including transit accommodations and transport facilities for the migratory population.

In line with the announcement made by Lieutenant Governor to minimize hardship being faced by the tribals during seasonal migration, the Tribal Affairs Department procured a fleet of 40 trucks for

transporting around 30,000 families from Jammu to Kashmir via Mughal road and National Highway-44 connecting Jammu with Srinagar. These trucks were procured by the department through J&K Road Transport Corporation.

This initiative has been taken on the direction of Lieutenant Governor Manoj Sinha who has announced various steps for welfare of tribals of J&K", Dr Shahid Igbal Choudhary, Secretary, Tribal Affairs Department said during the flagging of trucks.

He said that this initiative will minimize the hardships being faced by nomads during seasonal migration adding that this is for the first time in the history of J&K that livestock of tribals is being transported to highland pastures in trucks. Pertinently, Jammu and Kash-

mir government had earlier announced provision of transport/ freight services for the migratory tribal population during the annual migration to highland pastures. There was persistent demand from the migratory tribal community that they face a lot of hardships during migration due to traffic jams and other hindrances and to make their journey smoother they should be provided some transportation mode.

# France Blames Ticket Fraud For **Champions League Final Chaos**

**PARIS:** French authorities defended police on Monday for indiscriminately firing tear gas and pepper spray at Liverpool supporters at the Champions League final, while blaming industrial levels of fraud that saw 30,000 to 40,000 people try to enter the Stade de France with fake tickets or none at all.

After a meeting into Saturday's chaos, the ministers of the sport and the interior shifted responsibility onto the Liverpool fans while not providing details on how they were sure so many fake tickets were in circulation. People with legitimate tickets through Liverpool and UEFA reported struggling to access the

"There was massive fraud at an industrial level and an organization

filtering by the Stade de France and the French Football Federation, 70% of the tickets were fake tickets coming into the Stade de France," Interior minister Gérald Darmanin said. "Fifteen percent of fake tickets also were after the first filtering ... more than 2,600 tickets were confirmed by UEFA as non-validated tickets even though they'd gone through the first filtering.
