# **High-Level Delhi Meet Takes Stock Of Kashmir Situation**

KPs Security, Targeted Killings & Amarnath Yatra Discussed With Top Security Brass

New Delhi: The security of Kashmiri Pandits living in the Valley was discussed threadbare at a high-level meeting on Friday chaired by Union Home Minister Amit Shah, who took stock of the prevailing situation in Jammu and Kashmir, officials said.

The meeting was convened in the wake of eight targeted killings by militant groups especially Lashker-e-Taiba in the Kashmir Valley whose victims included non-Muslims, security personnel, an artist and local civilians.

National Security Advisor (NSA) Ajit Doval, Army Chief General Manoj Pande, and Lieutenant Governor of Jammu and Kashmir Manoj Sinha were among those who attended the meeting.

### 3 Soldiers, **Civilian Injured In Anantnag Encounter**

Two Non-Locals Injured In **Shopian Grenade Blast Observer News Service** 

**SRINAGAR:** Three soldiers and a civilian were injured on Friday in an ongoing encounter between militants and the government forces in Verinag area of South Kashmir's Kupwara district.

According to officials, the encounter broke out on Friday evening when a cordon and search operation was launched by the joint team of police and army's 19 RR in Rishipora in Kapran on the basis of inputs about the presence of militants in the village.

The militants hiding in the village, officials said, fired upon the joint team when they started advances towards the suspected spot. He said the forces returned the fire, setting off an encounter.

In the initial exchange of gunfire, the officials said that a soldier identified as Amandeep and a civilian Mukhtar Ahmad Malik sustained gunshot injuries. Both of them were removed to the hospital for treatment.

The officials further said that the intermittent exchange of fire was going on, even as additional reinforcements have reached the village to tighten the cordon and to thwart any attempt of militants to flee taking cover of darkness.

# **KP Body Moves HC, Seeks Relocation From Valley**

**Srinagar:** The Kashmir Pandit Sangarash Samiti (KPSS), an organisation of KPs has moved the ammu and Kashmir and Ladakh High Court seeking directions to the government to shift all the religious minorities to safer locations outside the Valley.

The KPSS in a representation to the Chief Justice informed that the government is not allowing them to leave the valley.

"The government blocked the roads, used electric currents to barricade the walls of the transit camps, the main doors of the transit camps are closed from outside with locks and similar,' reads the petition, a copy of which lies with Kashmir Observer.

The KP body sought intervention from the court regarding the killing of minorities.

The KPSS is a group of 808 families living in 272 villages of Kashmir. The group didn't leave the Kashmir Valley even after the height of the militancy in the 1990s. It is headed by Sanjay Tickoo.

In the petition, the body

alleged that the Union Territory administration and the Central government have failed to secure the life of Religious minorities staying in Kashmir Valley.

It noted that nearly twe attacks have been carried out on the local religious minorities living in the Valley apart from those who came to Kashmir to earn their bread and butter.

It said that apart from target killing number of threat posters and letters were issued by the militant organization operating in Kashmir Valley in which it has been clearly warned that they will kill religious minorities, specifically Kashmiri Pandits / Hindus who are living in the Valley.

It further informed the Chief Justice that the target killings have caused more fear and panic among them and alleged that the Government failed to protect their lives.

"That is a clear violation of the Right to life which is guaranteed under Article 21 of the Constitution of India as on the one hand, UT / Central

# **Hyderpora Encounter: Division Bench Stays HC's Exhumation Order**

**SRINAGAR:** A division bench of Jammu & Kashmir and Ladakh High Court has stayed the operation of a judgment directing the authorities to exhume the body of Amir Magrey, one of the four persons killed in Hyderpora encounter, till the next date of hearing.

As per news reports, a division bench of the High Court, comprising of Justice Ali Muhammad Magrey and Justice Wasim Sadiq Nargal, has stayed the operation of a judgment dated May 27, directing the authorities to exhume the body of Amir Magrey of Banihal.

While issuing notices to the respondents, the Court said that the matter requires a final decision after hearing all parties concerned.

The hate to sound like a bro-composition are lost," Reed says. "You freedom of movement. "It also strength-In fact, when it comes to exercise for older adults, strength training actually trumps cardio because preserving muscle is more important than losing fat as

"Every decade, starting in your mid 30s, you lose a percentage of muscle, which affects your metabolism, balance, and ability to brace yourself in the event of an injury," explains Larysa DiDio, a certified personal trainer and Prevention's contributing fitness editor. "By weight training, you build more muscle to protect your body against injury."

So, how often should you lift weights? Ideally, twice a week-whether you lift free weights, use machines, or do bodyweight exercises, says Rachelle Reed, PhD, CPT, Pure Barre's manager of training development and barre kinesi-

That said, as you get stronger and fitter, both Reed and DiDio agree that you should bump up your sessions to more than two times a week. "You can totally lift every day—just make sure to work on different body parts or train your body differently each day," DiDio says. Wondering which muscle groups

to focus on? Reed says that depends on your goals. For a full body workout, "many trainers will tell clients to focus on the upper body one day and the lower body a couple days later," she says. To help you get the most bang for your buck, consider folding in compound exercises and supersets into your routine. a form of strength training in which you move from one exercise to the next with no rest in between.

In addition to building strength, lifting weights has a host of benefits. Keep reading to learn all the reasons you covered that the hormone irisin, which should pick up a pair of dumbbells (or kettlebells, or dare we say, a barbell)

You'll lose weight and burn more calories

While cardio can help you get rid of belly fat, lifting weights helps you build more muscle, which can also help you burn more calories. That's because muscles are metabolically active, meaning they burn calories even when you're not exercising. "In fact, muscle tissue burns seven to 10 calories per pound daily, while fat burns only two to three calories per pound daily," DiDio explains.

What's more, a 2017 study in Obesity suggests that weight training combined with a healthy, low-calorie diet, can help preserve lean muscle mass that's lost through aerobic workouts. "When weight loss occurs in the absence of strength training, all facets of body

ken record, but it really is lose some weight in fat, some in muscle, ens your core, which keeps the back in crucial to incorporate lifting and some in bone—and it's unfavorable weights into your workout regimen. to lose weight that's coming from both muscle and bone." That's why strength training is so important. When people exercise to lose weight, the majority of the weight loss is fat loss.

#### You'll protect your bones

As you age, your bones become more brittle and weaker, especially if you're post-menopausal, which is due to lower estrogen levels-the hormone responsible for maintaining bone mass. But lifting weights can help you build bone mineral density through Wolff's Law, which states that bones can grow in response to forces that are placed upon it. In other words, creating pressure on your joints through weight-bearing exercises can actually help you build stronger, healthier bones.

"Strength training involves muscles contracting against the bones they're surrounding," Reed explains. "This force applied to the bones helps improve bone density overtime."

In fact, an October 2017 study from the Iournal of Bone and Mineral Research shows that high-intensity resistance training exercises, like deadlifts, overhead presses, and back squats, can help improve bone mineral density in women with osteopenia and osteoporosis.

You'll manage stress and boost your mood

Had a hard day at work and need to release some tension? Time to pick up those weights. Just like any form of exercise, strength training can enhance your mood by releasing feel-good hormones called endorphins.

Recent research also suggests that exercise, including weight training, may help protect against Alzheimer's and dementia. Researchers from Columbia University Irving Medical Center disis released during exercise, may help promote neuronal growth in the hippocampus—the area of the brain dedicated to learning and memory.

"Any type of exercise is a mood booster, but weight training makes you feel stronger and it builds the back and neck muscles that are most directly associated with stress," DiDio says.

### You'll improve your posture

If you have a desk job, chances are you're dealing with a case of rounded shoulders and a hunched back, which place additional pressure on your low back. This can lead to bad posture and limited range of motion in the shoulders, which are the most flexible joint in the body.

Your muscles work in a kinetic chain, so if there's a weak link. it can often manifest into a bigger problem in different areas of the body. But by building total-body strength, you can bypass most injuries.

For example, if you have weak hip flexors, it also means you have weak glutes-their opposing muscles. And, "typically they [muscles] don't weaken evenly, so this can also throw your pelvis out of whack, which could affect your gait," DiDio says. "As weak and tight muscles tug and pull, they can cause imbalances and pain, which is your body telling you that something is

A 2016 review from the British Journal of Sports Medicine shows that physical activity can help prevent or delay cognitive decline in people over 50, regardless of their current neurological state.

When you're moving, your body pumps oxygen-rich blood to your brain. boosting neuroplasticity-your brain's ability to create new neural connections and adjust to changes in environment. By increasing neuroplasticity, you can better handle stressful situations that come with life and stay sharp.

"Indeed, the American College of Sports Medicine has published several studies investigating the positive effects of different types of exercise on cognitive performance in older adults, and they agree that this is an area of research worthy of further pursuit," Reed



# **Doctors' Orders**

-ashmir has not escaped being a typical third world ghetto of frustrated aspirations and stifling systems that compel individuals to flee to more conducive shores for professional fulfillment and material satisfaction. The blame, as always, falls at the doors of successive leaderships for their abysmal failure to outline a vision to harness the latent intellectual and creative energies of the people for the overall benefit of the society. The state's health sector stands as a symbol of the paradox of talent in plenty rotting for want of opportunity. Coupled with a Kafkaesque officialdom that neither recognizes nor rewards ability and service, is it a wonder that Kashmiri doctors head in droves to more lucrative lands? Those that stay back in the state-run sector are too overwhelmed by the day-to-day battle with adverse working conditions like chronic shortages and immense patient overloads even to begin thinking about ushering in change.

Presiding over this demoralized, overworked and discontented pool of talent is a bureaucracy rife with nepotism, favoritism and downright incompetence that has been unable to streamline the system by, for example, a sustainable, fair and transparent policy on assigning duties in rural and far-flung areas. The peripheral health care system is in a state of collapse, for successive governments have failed to allocate sufficient resources and manpower to make it function up to a reasonable standard. Needless to say, government medical facilities in urban areas, particularly Srinagar, are stretched far beyond their capacity in dealing with the heavy influx that should have been screened at the place of origin. It is a tribute to the high competence and sheer doggedness of doctors serving government hospitals in Srinagar that major medical disasters, otherwise inevitable in the circumstances, are avoided. In contrast, the private sector, ironically manned by experts trained and taught at great public expense, is thriving on the government's failure to put its house in order. And there is no credible regulation in this sector to prevent exploitation of the poor masses who are driven to seek expensive alternatives because of a decrepit public service.

Amid this chaos come exhortations from the chief minister, Omar Abdullah, for non-resident Kashmiri doctors to return. Having had a cosmopolitan upbringing, Mr. Abdullah is bound to have a fair idea of what Kashmiri doctors working abroad have become accustomed to by way of technical facilities and remuneration. A top notch New York surgeon used to state-of the-art equipment is being asked return to perform in theaters known to run out of as basic an item as material for stitches in mid-surgery.

The government has been sending disturbing signals about effecting a paradigm shift in the health care philosophy in the state by encouraging the private sector on a large scale, which is unwarranted in Jammu and Kashmir where the per capita income is among the lowest in the country. Inspirations from the US system are totally out of place, and in any case the mercenary American model is under severe criticism from quarters more sensitive to the need of medi-care being easily and cheaply available to the needy. Transplanting ideas that are already being questioned and doubted in advanced societies does not serve any purpose except repeating mistakes that are being repented elsewhere.

One of the surest ways to arrest brain drain from Kashmir is to fashion a system that rewards merit and service, and has minimal deleterious interference from unscrupulous politicians and bureaucrats. The health care system in the state had been devised on the pattern of a welfare exercise and it must continue, and progress, in that vein. The government will have to come out with satisfactory remuneration packages and ensure a modicum of facilities to motivate young doctors to serve in the rural and far-flung areas.

True, doctors' salaries have to reflect the economic realities of the state, but a lot more talent could feel persuaded to be content with that if the unjust hiccups of a malfeasant officialdom were ironed out. It certainly does not help matters when an influential doctor manages plum postings perpetually solely because of his connections, and his better qualified counterpart is denied an opportunity to upgrade his skills at a higher institute for want of po-

Mr. Abdullah needs to cure the system of its ills – Kashmiri doctors working abroad will find that enough of an incentive to serve their own people. For, how can specialists in greener climes be motivated to come back when the heroic efforts of those who already work in Kashmir go unappreciated?

# Moral Quandaries of Ukraine war

ROUND the time Russia invaded Ukraine in February, a video clip of the Russian president Vladimir Putin recalling the US invasion of Iraq in 2003 started doing the rounds on social media: "They used the pretext of allegedly reliable information available in the United States about the presence of weapons of mass destruction in Iraq. As a result, we see a tremendous loss in human life, damage, destruction, and a colossal upsurge of terrorism," the transcription of Putin's statement

Russian foreign minister Sergey Lavrov, in another viral video also made fun of those who can't sleep over the Ukraine war: "there are advices to calm you down: Imagine this is happening in Africa, or the Middle East. Îmagine Ukraine is Palestine. Imagine Russia is the United States (sic)."

The point here is not to somehow justify the Russian invasion but whether, as the statements by the two leaders underline, the west is in a position to claim moral high ground on Ukraine. It certainly isn't world where social media involves almost everyone in the day to day issues of the world, this is obvious to all critical observers of evolving geopolitics.

Ever since the collapse of the Soviet Union in 1989 which made the US the sole superpower, the world has witnessed a series of US-led invasions geared to remake it in the American image. And in the process, not only were countries destroyed but lakhs of innocent people were also killed.

In the case of war in Iraq, it was the cooked-up intelligence about the then Iraqi president Saddam Hussain possessing the Weapons of Mass Destruction that became the basis for war. And the western media acted as cheerleaders for the destruction of the country. A similar script played out in US-led wars in, Afghanistan, Libya, Syria, and in the case of the US-backed Saudi war in Yemen.

The Ukraine war has rallied western nations and many other countries from around the world behind the US. And suddenly all we are hearing is a predominantly western narrative on the war. Social media companies have censored Russian state-sponsored media so there is little in the public domain that can be called an alternative discourse. And this is creating a situation we are all so familiar with. The west has again put on a moralistic lens on the war: a conflict between flawless virtue and pure evil. Putin is being projected as a reincarnation of Hitler. In fact, Time magazine's recent cover page showed Hitler's face lurking beneath that of Putin.

But this is not necessarily true. The conflict stems from Russ mate fears of being encircled by the west and the NATO military bases reaching its doorstep. Many of the Eastern European countries which were once a part of the USSR-led Warsaw Pact have become a part of NATO, heightening Russia's insecurity. The growing likelihood of Ukraine also joining NATO became the last straw for Putin. While it is nobody's case to countenance the invasion of a sovereign smaller country by its powerful

neighbour, the solution to the evolving fraught situation can be resolved if the US-led West and Russia sit down and work towards addressing each other's grievances and fears.

But that is not happening. Geopolitics is not a morality play and in international relations, moral concerns are also selectively and cynically used to advance national goals. This is why



The point here is not to somehow justify the Russian invasion but whether, as the statements by the two leaders underline, the west is in a position to claim moral high ground on Ukraine. It certainly isn't. And in a world where social media involves almost everyone in the day to day issues of the world, this is obvious to all critical observers of evolving geopolitics

all the western policymakers and the media are focused on what is happening to Uyghurs in China or for that matter how autocratic and evil Putin is. As for the rest of the world, all is supposed to be well: these are the things that can only be occasionally talked or written about but never be a trigger for any policy action. That is, as long as it suits the powerful countries and alliances. And in today's day and age, it is the US-led western countries. This bloc not only continues to wield a decisive military and economic dominance together with control of the global business and multilateral institutions but also commands a media that is fundamentally responsible for shaping world opinion.

True, China has come close to becoming a rival to the US but its power still largely rests on its economic progress. China is some time away from catching up as a military and a technological power. As for controlling the world's information order, or owning the globe-spanning corporate behemoths, China still has a long way to go. So, the west continues to exercise a carte blanche as far as what we think and how we think. As Sergey Lavrov says, it would certainly have made a difference had the United States and not Russia invaded Ukraine. Then, like Saddam Hussain who was falsely accused of stockpiling WMDs to make a case for invading Iraq, Zelensky would have been painted as an irredeemably evil figure who was a threat to world peace. And, of course, the invasion of . Ukraine would be considered a salutary hid to liberate the country and transplant true democracy. What is more, most of the world would have played along, the media too.

very time there is a crisis in the Global South, Western news organisations parachute their correspondents and photographers in to document the developments. What they report back, however, often ends up being something much different from what locals experience on the ground.

What creates this discrepancy? In most cases, these foreign correspondents and photographers arrive on location with little to no in-depth knowledge of the crisis, culture and locality they have been tasked with covering. Unable to offer a comprehensive report on the issue, they merely focus on capturing the most spectacular images and delivering the hottest takes to make the most of their few seconds on air, or few column inches on the front page.

is nothing unique to Sri Lanka – we often see Most news sources, for example, initially similar narratives of "clashes" and "riots" in the international coverage of protests and police actions against them across the Global South, most infamously evident in Palestine.

In Sri Lanka's case, however, the reality of the protests was not only misrepresented through narratives about "clashes". Due to the island's colonial past, and the fact that many news reports started referring to what was Europeans – Scandinavians, Germans, Russians and Britons - regularly holiday there, other problematic attitudes that reduce the protests into one-dimensional Orientalist fantasies have also crept into the coverage.

Sri Lanka's protest movement is idealistic and focused on collective care. Organisers at GotaGoGama, for example, set up a free food station that provides meals for protesters and the destitute, a medical aid tent, and a library, where anyone can come and read books or organise a "People's University" session hosting discussions on social and political issues. The protesters at the village have been consciously and strategically educating each other, through "teach-outs", about the conditions that created this economic crisis, and the way successive leaders have used ethno-nationalism to obtain votes and power. They have been working to bring together people who have purposefully, and for political ends, been divided across ethnic, religious, and class divides since Sri Lanka's independence. The protesters have also put on educational shadow-puppet shows, sung raucous island baila (catchy erage of these protests, I quickly recognised violence of groups dispatched by the state to tunes, often accompanied by cheeky lyrics some familiar discrepancies often seen in the intimidate and stop them", she added. This commenting on social conditions), chanted

inventive slogans, and made some of the most hilarious protest posters I've ever seen.

In some international news reports, however, these strategic and undeniably effective efforts to bring about change and bring a nation together have been portrayed as youthful naïveté, infantalising the movement and making it look somewhat less serious and impactful than its Western counterparts.

Throughout these protests, people from different religious and ethnic groups, who have been trained to be deeply suspicious of each other, broke fast together during the month of Ramadan, celebrated Easter, and had fun on the Buddhist holiday Vesak. On a few occasions, a (kattadiya, or an exorcist) came to do an exorcism ceremony to cast out evil demons from the island. They've educated each other about the state's violence against their communities – especially violence targeting the country's Muslim and Tamil people; Ambika Satkunanathan and others repeatedly noted why Tamil people, especially those in the North and the East could not, without inviting further state surveillance and bodily harm, protest as freely as did the Sinhala in Colombo. They honoured the Tamil victims of the civil war together, and invited the surviving families of those forcibly "disappeared" in the North and the South to speak.



istory is brutal. History is terrific too. History can L never be erased from memories. Historical facts and events cry to be documented for the future. History, always, has a lesson for the future. To revisit the past is to relive a time gone by, and learn from it. Partition is not an event of the past. Its consequences are still in operation. Its heaviness continues to weigh down. Its ingredients are personal and not negotiable with another. A partition divides families and friends, colleagues, and people who love one another. It creates turmoil. Partition of Hindustan in 1947 spilled blood on the streets. Innocents were trampled. A mad orgy of sorts it was. This painful history and the remnants left behind are beautifully weaved by Aanchal Malhotra.

The book titled 'Remnants of Separation' is a treasure of memories. It is one of the exceptional attempts by Aanchal to relive the past through material objects that refugees carried with them across the border when the great and biggest human migration happened on earth in 1947. It is an archive of memory, of stories, of violence, of lost friends and relatives.

A nicely woven collection of stories on either side of the border, the book is the toil of the author's years of painstaking and passionate research. It widely talks about familiarity and love between Hindus and Muslims which was seen as the precedent of two communities during undivided India. When Lahore and Amritsar, Karachi and Bombay, Phulkari and Pash-

mina, Topi, Tika, and Turban were all one. But then came to the unholy rush, brutality, and madness seeped in that turned homes into houses, friends into foes. Neighbours turned murderers, Burglars, and marauders. Relationships changed. The same Lahore and Amritsar drenched in the blood of all. In the smell of burning limbs and bones. People became strangers to the very place they called home. There are some passages in time whose horrors should never be repeated. The partition is one such horror. It has evolved people into stories.

Time swallows the past. The past can reside in odd heirlooms and fraying books, within the folds of clothes and the embroidered ends of hand-kerchiefs, in the pearl drop of an old erring, and the rustic of an ancient and abandoned lock. # **Defining Graphic Novels to Read**



Por someone who teaches about the graphic novel, compiling an all-time top five list is challenging. It's not just the way that such a list is compiled, making agonising decisions over which favourites to exclude, but also because it raises tricky questions of definition. That the term refers not just to fiction but to life-writing, as in all manner of memoirs, diaries and so on, is accepted – but beyond that there is little consensus.

If there are multiple volumes (as with Neil Gaiman's The Sandman or the Hernandez brothers' Love and Rockets series), should the whole series be counted as one epic graphic

novel, or should only individual volumes be eligible?

And what about a book like Phoebe Gloeckner's The Diary of a Teenage Girl(2002), which tells the story of an authorial alter-ego, Minnie, through a combination of prose diary entries, illustrations with captions, comic-strip narratives, letters, poems and photographs? Or Joe Sacco's comic-strip documentary journalism?

I've chosen five books that I (and many others) regard as central to the graphic novel canon. They are all richly textured, powerful, nuanced books that are immediately arresting but also reward repeated re-reading.


### 1. Watchmen (1987)

Alan Moore and Dave Gibbons' Watchmen works on so many levels – it is, among other things, a whodunnit, a love story, a commentary on Cold War politics and an exploration of fundamental philosophical and ethical questions.

Watchmen is an homage to – and a deconstruction of – the classic superhero comic-strip narrative, which in turn has inspired numerous subsequent revisions of the genre, from Pixar's The Incredibles (2004) to the

Marvel Comics (and later MCU's) Avengers civil war storyline.

Shifting points of view, disrupting chronology, layering texts within texts, Watchmen is a hugely ambitious narrative that discloses new details with every fresh reading. It's also a real page-turner.



### 2. Maus (1991)

Art Spiegelman's masterpiece, Maus, probably did more than any other graphic novel to make readers and critics take this genre seriously.

It's the story of the author's father, Vladek, who survived Auschwitz, as well as the story of Spiegelman's relationship with him. Controversially representing Jews as anthropomorphised mice, preyed upon by German cat-people and often betrayed by Polish pig-people, Maus nevertheless resists stereotypes. The novel represents both its author and his father as flawed, complex individuals who struggle in different ways to deal with the legacy of a trauma that makes itself felt in every aspect of their lives.

### 3. Ghost World (1997)

Daniel Clowes' Ghost World is the shortest – and at first glance the most straightforward – of my choices. It's a bittersweet tale of the friendship, and gradual estrangement, of recent high-school gradu-

ates Enid and Becky.

Cynical and vulnerable, with a sardonic sense of humour and a nostalgic streak, Enid is, in part, a portrait of the artist as a young girl grappling with her sexuality, ethnicity and her conflicting expectations of herself.


## 4. Jimmy Corrigan, the Smartest Kid on Earth (2000)

Chris Ware's Jimmy Corrigan was the first graphic novel to be awarded major literary prizes on both sides of the Atlantic – the American Book Award and The Guardian First Book Award.

Like Watchmen, Jimmy Corrigan has a complex, non-linear structure and subverts conventional notions of (super)heroism. Like Maus, it is a book about fathers and sons; and like Ghost World, it has a protagonist who is drifting aimlessly through life, alienated from the world around

Yet it is visually and formally more radical than any of the other books on this list. Chris Ware's dark palette and landscape format and his use of diagrams, instructions and definitions make the book, as an object and text, highly unusual. In terms of narrative, too, Ware is a great innovator - the absence of exposition and page numbering, the abrupt transitions between a historical narrative focusing on Jimmy's grandfather and the present-day narrative focusing on Jimmy, the use of surreal dream sequences and the disruption of conventional panel sequencing all make Jimmy Corrigan challenging.

But it's well worth the effort. It is



a beautiful, heartbreaking story that has been much imitated but never bettered.

### 5. Fun Home (2006)

Alison Bechdel's Fun Home is a self-consciously literary coming of age novel that pays homage to James Joyce, Marcel Proust and Oscar Wilde, among others.

It is a moving memoir about the author's relationship with her father, whose queer sexuality finds an echo in her lesbianism, and whose (possible) suicide haunts the book.

Adapted as an award-winning musical, Fun Home reached an audience that might never have encountered the bestselling graphic novel. Yet while Fun Home the musical is fun, just like the film adaptations of Watchmen and Ghost World, it can't quite do justice to the complexity of the original.

What I hope a reading of these titles will demonstrate to any newcomers is that these are not just great graphic novels but great works of art. The term graphic novel was initially deployed in order to confer intellectual credibility on what had been previously seen as a trivial form of entertainment aimed primarily at children. But the works listed above rival anything done in the novel form over the same period – some of the



fiction and life-writing is being done right now in the graphic novel form.

### **Ground-level ozone pollution in Delhi-**NCR in March-April highest in 4 years: CSE

NEW DELHI: The summer of 2022 -- one of the hottest in history -- has witnessed widespread ozone exceedance, making the air of Delhi-NCR more toxic, according to an analysis conducted by the Centre for Science and Environment (CSE).

The green think tank's assessment is based on the publicly available granular real time data (15-minute averages) from the CPCB's official online portal Central Control Room for Air Quality Management.

In Delhi-NCR, the researchers captured data from 58 official stations.

The analysis tracked exceedances at each station. Breach of the standard by even one station is considered exceedance by the city. Days with multiple stations exceeding the standard indicates the severity of the spatial spread and number of people exposed.

This year, due to the early onslaught of heatwaves, the spatial spread of groundlevel ozone started in March itself with April being the worst so far, the green

The dangerous build-up of groundlevel ozone can happen anytime during the year, but it is usually in small pockets. For it to have wider spatial spread, hot and sunny weather conditions are needed which are generally present in summer, especially during May. But this year, the frequency and spread of ozone exceedance started early -- in the month

Ground-level ozone usually exceeds the safety standard on all days of summer at some locations in Delhi-NCR every year. But the spatial spread (number of stations exceeding the standard across the city) has been much higher this year.

On an average, 16 stations have exceeded the standard daily this March and April, which is 33 per cent increase from March and April 2021. During 2020, when lockdowns had reduced the precursor gases needed for formation of groundlevel ozone, the number was down to 10 stations daily, the report said.

Dr K S Shooting Range in south Delhi is the most chronically affected in Delhi-NCR. The ground-level ozone concentration exceeded the standard at this location for 85 days this March-May.

JLN Stadium, RK Puram and Nehru Nagar followed close behind. Greater Noida is the major hotspot outside Delhi. Faridabad has least instances of groundlevel ozone exceedances in the region, it

Patparganj in East Delhi registered the highest increase in the number of days exceeding the standard as compared to the average of the last three years. It registered a dramatic jump of 68 additional days with exceedance. It was followed by Noida's Sector 116 and Mandir Marg, next to the President's Estate.

Siri Fort and Bawana in Delhi registered the most reduction in the frequency of exceedances compared to average of previous three years. Their exceedances were down by over 40 days this year. Gurugram Sector 51, Dwarka Sector 8, and Najafgarh were other locations with the maximum improvement.

After Delhi-NCR that recorded ozone exceedance on almost all days of this summer, Mumbai with 75 days of exceedance was the second-most impacted

Kolkata-Howrah and Hyderabad registered 43 days of exceedance each. Even though the number of exceedance days in Kolkata-Howrah has been lower than that of Mumbai, its citywide concentration is 30 per cent higher than in Mumbai for this summer season.

The CSE said the complex chemistry of ozone makes it a difficult pollutant to track and mitigate. Ground-level ambient ozone is not directly emitted from any source. It is produced from complex interactions between NOx and volatile organic compounds (VOCs) that are emitted from vehicles, power plants, factories, and other combustion sources.

These undergo cyclic reactions in the presence of sunlight to generate groundlevel ozone. VOCs can also be emitted from natural sources, such as plants.

This highly reactive gas has serious health consequences. Those with respiratory conditions, asthma, chronic obstructive pulmonary disease, and particularly children with premature lungs and older adults are at serious risk.

# Centre Asks U'khand, J&K, Odisha To Ensure Cleanliness During Amarnath, Kedarnath & Rath yatras

**NEW DELHI:** The Centre has asked Uttarakhand, Jammu and Kashmir and Odisha to take several steps, including identification of local swachhata brand ambassadors, to ensure high levels of cleanliness during Kedarnath Yatra, Amarnath Yatra and Rath Yatra in the respective states.

Union Housing and Urban Affairs Secretary Manoj Joshi has written to chief secretaries of these states in this regard and asked them to provide for sufficient numbers of public toilets throughout the approach roads to the shrines.

The move comes after Prime Minister Narendra Modi, in his 'Mann Ki Baat' address to the nation on May 29, expressed his concern regarding the heap of filth in Kedarnath.

According to a statement issued by the ministry on Friday,

the advisory suggests that plastics and SUPs (single use plastic items) should be stopped at the base-camp level for Kedarnath and Amarnath yatris at the time of registration itself.

"All eateries along the approach roads will need to be sensitised about garbage collection, in-situ processing of the food waste through waste to compost/waste to bio-gas units in their premises, usage of biodegradable cutlery and bags," the statement stated.

In order to prevent indiscriminate littering by visitors, segregated litter bins will have to be placed along the approach roads along with regular emptying of the same, the Ministry of Housing and Urban Affairs (MoHUA) said.

"Most importantly, the advisory stresses on large scale people participation, whereby all local NGOs/CSOs/voluntary organisations, self-help groups

from all villages and towns on the approach roads are to be identified, sensitised and tagged to work in designated area to ensure that cleanliness is maintained at every step," it stated.

The ministry said "local swachhata brand ambassadors" should be identified and designated for the swachh yatra', and spread the messages of cleanliness to motivate visitors to behave responsibly and help in maintaining cleanliness.

According to the statement, national teams from MoHUA are being deputed to Uttarakhand, Jammu & Kashmir and Odisha, starting this week, to take stock of the preparations underway and also to provide inputs for improving sanitation and garbage management.

Video-conferencing meetings have been scheduled early next week to discuss with state, city and district officials to discuss the preparedness, it added.

### **BSF Developing Counter Drone, Anti-Tunnel Tech: DG**

New Delhi: The Border Security Force is continuously working to develop counterdrone and anti-tunnel technologies to effectively check cross-border drugs and arms smuggling and militants infiltration bids along the India-Pakistan border, force chief Pankaj Kumar Singh said on Friday.

The BSF director general said the force has shot down a total of 7 drones over the last six months (December 2021-May 2022) and has detected three underground tunnels along the Pakistan border between January, 2021 to May, 2022.

"We are keeping a strict vigil on cross-border drone activities through which drugs and arms are smuggled and underground tunnels which are used for infiltration by terrorists. The BSF is also working to develop effective technologies to check drones and underground tunnels," he said.

Singh was speaking during an investiture ceremony and the annual 'Rustamji Memorial Lecture' of the border force. The about 2.65 lakh personnel strong force was raised in 1965 and it is primarily tasked to guard Indian borders with Pakistan and Bangladesh.

Minister of state for home Nityanand Rai delivered the keynote speech and also honoured a total of 16 personnel, including two posthumously, with the police medal for gallantry. Those decorated include second-in-command rank officer Deepak Kumar Mandal who laid down his life in 2017 while stopping cross-border cattle smuggling in Tripura.

Mandal, commanding the 145th battalion of the border guarding force, was grievously hit by a four-wheeler by the smugglers on October 16 that year and he succumbed to his injuries four days later. Thirteen BSF personnel were also awarded the gallantry medals for killing three militants who attacked the Srinagar (Jammu and Kashmir) airfield on October 3, 2017.

Those awarded for this operation include Assistant Sub Inspector Brijkishor Yadav (posthumously) and deputy inspectors general S S Guleria and Hari Lal among others.

A woman teacher hailing from the Samba district of the Jammu region was shot dead by militants at a school in south Kashmir's Kulgam district on Tuesday. "Kashmir problem is bigger than any law. You have to look at Kashmir holistically, you can't look at in a microscopic way.

"I had stated during the debate in Parliament that Kashmir is larger than Article 370. Article 370 is a law which has been diluted, but Kashmir is a larger issue than 370 and to address it you need a lot of statesmanship, which was lacking," he noted.

He also demanded that the government provide compensation to those killed while performing their official duties.

'If you want peace, if you want amity, you have to address the stakeholders. You cannot achieve peace in Kashmir without talking to stakeholders, and history speaks out. I have not seen any such attempt in Kashmir....what I have seen is that you thought of resolving Kashmir through propaganda.

"If things could be resolved through propaganda, then Hitler would have won the world. Propaganda is good, but to a limited extent, only as a means of reaching out...it can't be the basis of peace," the Congress leader said.

Tankha said what is now happening in Kashmir is targeted killings not just of Kashmiri Pandits but also of outsiders working in the Kashmir valley.

Citing data, he said around 10,000 outsiders are working in the Kashmir valley and it is the responsibility of the government to ensure

## Don't Give Money To NSFs Not Complying With Sports Code: Delhi HC To Centre

NEW DELHI: The Delhi High Court on Friday directed the Centre that no money or assistance shall be provided to national sports federations (NSFs) which are not functioning in compliance with the law concerning the administration of sports in the country.

No money will go henceforth to any entity which does not comply with the Sports Code. That is the long and short of it. What is suffering is the rule of law, said the bench, comprising Justices Najmi Waziri and Vikas Mahajan.

It is unsporting. (It is) not sporting at all not to comply with the rules. There are too many red cards coming up, the court remarked while hearing a petition by senior advocate Rahul Mehra to ensure compliance with the Sports Code by the NSFs.

The court said that compliance shall be done by the end of one month and in the meantime, assistance to sportspersons through the Sports Authority of India would be ensured and possibly augmented.

The NSFs which are not compliant shall be put on notice of suspension, it further said.

The court was informed by the Joint Secretary, Sports Ministry that concerted efforts are underway to ensure that compliances are made by the end of the month and that while 15 NSFs were adhering with the Sports code, six were granted the exemption.

Five NSFs need to amend their constitutions and 17 required major changes, it was further said. Lawyer Anil Soni appeared for the Centre.

The petitioner disputed the Centre's version and emphasised that at least 24 NSFs have super luminary persons in the management which is not envisaged by the code and that the mandate of 25 per cent of the management of NSFs being prominent sportspersons of outstanding merit was not being followed.

The court observed that the endeavour is that the NSFs comply with the legal framework and let them not say that the players are going to suffer.

In as much as there is an unclear picture as to which of the NSFs are fully compliant, it is therefore prudent that no

more money or assistance is extended to any of the NSFs till the next date unless they comply. The respondent shall ensure that monies, facilities, and patronage are extended to NSF only if they comply (with the sports code) and also the orders (passed by the high court and the Supreme Court), the court ordered.

It is hoped that the entire exercise of ensuring compliance shall be completed by the end of one month. In the interim, however, assistance directed to sportspersons through the Sports Authority of India would be ensured and possibly augmented. The NSFs which are not compliant shall be put on notice of suspension, it said.

In its earlier order, the court had noted in November 2021, the Centre had claimed to have recognised 59 NSFs and there



can be no latitude apropos expending monies on entities who do not qualify for it in

In view of the non-compliance with its previous orders, the court had sought the presence of an Officer of the rank of Joint Secretary before it.

On May 26, the court had asked the Centre to suspend NSFs that are not complying with the Sports Code, saying that it was prudent that no further exemptions be granted to or lenience be shown to such non-compliant entities.

It had stated that compliance with the Sports Code is a must for the grant of recognition as an NSF and unless the entity strictly adheres to the code, it would disentitle itself from any consequential benefits flowing from the public fund, such as the use of government-owned stadia and sports facilities, etc.

The matter would be heard next in July.
