

Saudi, Indonesia Join Chorus, Condemn BJP Leader's Anti-Islamic Remarks

ED Attaches Flats, Villa In Goa & Delhi

NEW DELHI: The Enforcement Directorate has attached flats and villas in Goa and Delhi and fixed deposits worth more than Rs 24 crore in a money laundering case linked to alleged bank loan default at the J&K Bank, the agency said

on Monday.

A provisional order for attachment of the properties belonging to the Sanskar Group-- proprietorship concern of Manish Sharma, Navin Beri, his partnership firm M/s Lavanya Travels, and Arvind Chadha-- was issued under the Prevention of Money Laundering Act (PMLA).

"The attached assets are in the form of villas and flats in Goa, flats and office space in Delhi and Faridabad, and fixed deposits," the Enforcement Directorate (ED) said in a statement.

The total value of the attached properties is Rs 20.39 crore, it said. The money laundering case stems from a

Goa Police FIR that was filed against the accused of allegedly "duping" investors to the tune of about Rs 10 crore by promising them villas in 'Banjara Hills project' that was to be developed by the Sanskar Group in Anjuna, Goa, it said. "Manish Sharma entered into an 'agreement to sale' and 'sale deed', executed before civil cum sub-registrar, with the buyers promising to deliver them the villas within the stipulated time. "However, when the project was completed to about 60-70 percent, Manish Sharma and Navin Beri in connivance with the manager of Jammu and Kashmir Bank mortgaged the Banjara Hills project in Jammu and Kashmir Bank Ltd, Panaji, and availed a loan of Rs 20 crore by submitting false documents,'

the agency alleged.

Thereafter, the loan amount was further "diverted" to the bank accounts of Manish Sharma, Navin Beri, his partnership firm Lavanya Travels and Arvind More on P6

How To Become More Grateful, And Why That Will Make You Happier, Healthier And More Resilient

f you really think about it, so many of us should be in a perpetual state of

Which of these do you have going for you right now? Family. Friends. Love. Health. Freedom from war and natural disaster. Imagination. Community. A roof over our heads. Common decency. Hope. Opportunity. Memories. Financial stability. Favorite places. Days off work. Good weather. The golden age of television. Books. Music. Ice cream. Weekends. A friendly exchange. Something good that happened today. Something bad that didn't happen today. A good cup of coffee. You may not have everything you want (or even need) on my list or yours, but that probably still leaves buckets -- nay, container ships -- full of tangible and conceptual items for which to be grateful. Things can always be better, but they can always be worse. It often depends on how you look at that proverbial glass of water.

To get in better touch with gratefulness -- and get the health benefits of doing so -- the trick is to find easy ways to count blessings more often than, say, over an annual turkey dinner. Keep your thankfulness boiling on the front burner of your mind, and you will increase your general appreciation of life.


Try to be more grateful for the small, mundane things that give you joy and meaning, as well as the big ones. Acknowledging just a handful each day will benefit you, and there are ways to make that a habit.

Grateful = healthful Perhaps the most obvious benefit of displays of gratitude is that they are closely tied to increased feelings of happiness -for both the givers and the receivers.

In this week's episode of CNN podcast Chasing Life, host Dr. Sanjay Gupta interviewed Christina Costa, a teacher and doctoral student at the University of Michigan who has studied neuroscience and psychology. She explained how you can see gratefulness on brain scans. The feeling lights up the "feelgood" neurotransmitters of dopamine and serotonin, which Gupta pointed out also decrease hormones like cortisol, associated with stress.

"The neurotransmitter reactions are pretty immediate," Costa said. "It is hard to feel bad when you are focusing on someone that you are so grateful for, something that changed your life or something that is going really well today."

Resilience, including the ability to cope with stress and trauma, is also correlated with gratitude. Studies have shown that counting blessings was a factor in managing post-traumatic stress for Vietnam War veterans and an effective coping strategy for many after the 9/11 terrorist attacks. Other research shows that the more grateful you are, the more you are likely to exhibit patience and self-control. It can even be good for marriages and relationships:



Couples good at exhibiting thankfulness tend to be "more committed and more likely to remain in their relationships over time." Our best selves, it seems, are our most grateful selves.

Studies have shown that gratitude can indirectly influence physical health, as well. "Gratitude strengthens your immune system and helps you experience less pain," Costa said in the Chasing Life podcast.

Those who have "dispositional gratitude" defined by one study as "part of a wider life orientation towards noticing and appreciating the positive in the world" -- are more likely to report good physical health, a propensity for healthy activities and willingness to seek help for health concerns.

In another study, New York teenagers who rated as the most grateful in their class - defined by "having a disposition and moods that enabled them to respond positively to the good people and things in their lives" -- were less likely to abuse drugs and alcohol. The benefits of having more gratitude also correlated with benefits to the heart among patients who had experienced heart failure.

Being grateful can even get you a better night's sleep. According to one study involving college students who instituted various methods for increasing gratitude, such as a gratitude journal, they worried less at bedtime and slept longer and better. In another study, adults in the United Kingdom (40% of whom had sleep disorders), reported that thinking about what they are grateful for at night led to falling asleep faster and staying asleep longer.

Convinced? Let's get to the fun part. How to up your GQ (gratefulness quotient) I'm currently conducting two completely unscientific thankfulness-boosting experiments. For nearly two years, I've been keeping a gratitude journal. And for the last five years or so, my family has engaged in a dinnertime ritual called "Roses, Thorns &

Buds" that surfaces the same details. A lot has been written about these and other thankfulness experiments, and it should be noted that there are no rules or even standards that govern them. We're in very, very soft science territory here. But reliable research does show that whatever you do to increase gratitude pays off, so it's worth it to find what is easy, enjoyable and effec-

A gratitude journal need not be any more complicated than keeping a notebook by your bed and starting a nightly habit of jotting down who and what you were grateful for that day. Journaling was the standard method for some of the studies cited above, so this is a simple but effective option.

I'm coming up on two years of trying this one, and I added a layer you may want to consider. After one year, I took the time to total up all the mentions. My wife and children were, predictably, at the top, reminding me not to take them for granted. But I was surprised to see that coworkers, neighbors and a city park all ranked highly. It was useful for me to review in that way, because when I see those people, I have this added layer of positive feeling about them at the forefront of my mind. It's hard to get annoyed by someone when you think, "I'm so often grateful for that person."

It was fun to play with the data, too. By category, "family" was the clear winner (1,011 instances) for me, followed by "places" (269 instances, with coffee shops being the biggest subcategory, "friends" (259), CNN "coworkers" (197) and "experiences" (133). Also, "Star Wars" (11) beat both beer (10) and books (8). It will be interesting to compare second-year totals against these. All of it is getting me closer to understanding and remembering what I'm most grateful for. Roses, Thorns & Buds (or RTB, among its devotees) has been part of so many family dinners since my older daughter was 4 years old that I've forgotten where we first heard about it. It's quite simple: Everyone at the table takes turns sharing "roses," which are something positive and happymaking about their day; "thorns," which are the opposite of that; and "buds" for something we're looking forward to and we anticipate will be a rose. Sometimes, the family meal and sharing these things itself is a rose.

Granted, the "thorn" doesn't necessarily increase gratitude -- though it's still useful from a family discussion, empathy and problem-solving perspective. And if you can fix a problem, a rose may grow in that thorn's place.

Here are our unscientific findings: Each time, we find that we have many roses and buds and usually only one thorn to share. Friends have told us about effective variations on this technique, so one size doesn't fit all. If the metaphor is too flowery for you, pick another. Home runs, strikeouts and on deck? The important thing is to connect to the thankfulness in this way, whether you do it most evenings or on the occasional weekend. It's also an easy way for kids to get into a thankfulness habit themselves.

Happiness jars, a strategy popularized by "Eat, Pray, Love" author Elizabeth Gilbert, is something of a hybrid of gratitude journal and RTB. The idea is to write down on a slip of paper the happiest moment of the day and drop it in a jar. The advantage of doing it this way is that in moments of unhappiness, you can reach into the jar and be reminded of those moments, perhaps becoming grateful for them anew. Gilbert was struck by how many of her fans shared photos of their decorated happiness jars see Pinterest if you need inspiration) and by how her happiest moments are "generally really common and quiet and unremarkable.

And there are other experiments to try. You could set alarms or reminders on your phone to pause and think of something you are grateful for at different times of the day: Mornings help set the tone of the day, and reflecting while at work can be particularly useful. You can then record them on a gratitude journaling app.

Or you could just focus on the simple act of saying thank you, and meaning it, more frequently. Writing letters of thanks (or emails if you want to be faster and more frequent) to those for whom you are grateful is worth doing with some regularity. You can also express gratitude with gifts, flowers and favors. Or simply make a list of all the things we take for granted but would be so unhappy to lose, such as job security, health, seeing loved ones. Review that list every week or so.

Whatever way you start infusing your life with more moments of gratitude, in the short and long term, you will be grateful that you did.

New Self-Powering Smart Pillow To Help Track Sleep Quality

Chinese researchers have developed a self-powering smart pillow that tracks the position of the head and quality of sleep.

Studies have linked chronic lack of sleep to physical ailments, such as diabetes and heart disease, as well as mental health issues.

People who are interested in getting a better handle on what's happening to them at night have two primary options. They can take a sleep test conducted in a medical facility, or they can use an app through a smartphone or smart watch - a much more convenient, but

less accurate choice. Recognising the need, many researchers have begun developing new sleep monitoring systems using triboelectric nanogenerators (TENGs).

These self-powering systems have taken the form of eye masks, belts, patches and even bed sheets. Researchers from Guangxi University and Chinese

Academy of Sciences wanted to adapt this approach to create a less restrictive, more comfortable version

that focuses on the move-

ment of the head during

sleep.

To construct this new smart pillow, the team formulated a flexible, porous polymer triboelectric layer.

Movement between the head and this layer changes the electric field around nearby electrodes, generating a current. They strung together several of these self-powering sensors to create a flexible and breathable TENG (FB-TENG) array that can be placed atop an ordinary pillow.

This system could generate voltage that corresponded to the amount of applied pressure, and it could track the movement of a finger tracing out letters.

The FB-TENG also could capture the pressure distribution of a fake human head as it shifted position.

This smart pillow could have uses beyond tracking sleep, the researchers wrote in the paper published in the journal ACS Applied Materials & Interfaces.

For example, the system monitor patients with diseases that affect the movement of the head, such as the degenerative neck disorder cervical spondylosis. The smart pillow could also be adapted to offer an early warning system for those at risk of falling out of bed,

Minority Killings

he killings of the members of the minority community in Kashmir have become a national issue with several major parties issuing condemnations and like Aam Aadmi Party holding public rallies to call for action. In his 'Jan Akrosh Rally' at Jantar Mantar on Sunday, Delhi Chief Minister Arvind Kejriwal called on the centre to "get over with the meetings" and "take action on the ground" in Kashmir. He demanded an "action plan for Kashmir". He called on the union government not to play politics in the name of Kashmiri Pandits.

Similarly, Maharashtra chief minister Uddhav Thackeray has said that the state will stand firmly behind the Kashmiri pandits who are fleeing the Valley, and will do everything possible to help them. Earlier, Congress leader Rahul Gandhi slammed the government of India over the killing of a teacher in Kulgam district of south Kashmir, saying Kashmiri Pandits are protesting but 'BJP is busy colobrating eight years of the Modi government'

busy celebrating eight years of the Modi government'.

The civilian killings in Kashmir have become a big issue in Kashmir and across the country. In Kashmir, the successive killings have become a deep source of worry for the security forces who are already stretched. According to an estimate, there are around 8000 minority employees including Kashmiri Pandits who are posted in Kashmir, and it would be a security nightmare to protect all of them. Hence the serious concern expressed by the various political parties across the country is understandable.

The concern has further been aggravated by the fresh exodus of Pandit families from various parts of the Kashmir Valley. They have demanded that the government waive off the bond requiring them to remain permanently posted in Kashmir. And if the government gave in to their demand, it would defeat the very purpose of the Pandits' employment in Kashmir: the purpose behind this was to somehow incentivize the return of Pandits to their homeland.

This is, thus, a very tricky situation and the government needs to do a tightrope walk to ensure both of its ends are served: killings stop altogether and Pandits also don't leave. But the achievement of these twin goals will hardly be possible by an exclusively security-centric approach, something that many analysts across the country are also advocating. Loosening rather than further tightening the stranglehold is the answer. People should be freed of their sense of siege and be allowed to express their legitimate grievances and expectations without fear of being punished for this. This alone can enable Kashmir to be a normal place again where people participate and also help address the issues and challenges facing them. That killings of minorities is a renewed and recent phenomenon is proof enough that something, somewhere has gone seriously amiss and the government needs to wake up and respond to it.

Hate and Apology

he government, from Prime Minister Narendra Modi down, and the party, from J P Nadda down, prefer silence as the baying gets more loud and shrill, as so-called dharam sansads advocate no less than mass murder and men, in saffron, claiming to redeem Hinduism, peddle hate and misogyny. Result: Every such act that is allowed to go unpunished and uncensured emboldens the payt

If the party acted to suspend spokespersons Nupur Sharma and Naveen Jindal on Sunday, it was because the anger against their remarks was not something that could be dismissed as expressions of "sickularism" but is resonating throughout the Islamic world threatening to upend India's most important relationships, alliances key to its strategic imperatives that Prime Minister Modi himself has nurtured. But the condemnation of hate speech for the sake of international optics is like sticking a band-aid on a festering wound. In the diplomatic embarrassment that Vice-President M Venkaiah Naidu had to suffer while on an official visit to Qatar — the Indian envoy was summoned and lectured to — is the second lesson. Such conduct is no longer protected by silos, and has wider repercussions. Prime Minister Modi once claimed that the Congress was upset that he had good relations with the Islamic world. All it took was 30 seconds of unadulterated hate spewed by the party's face on television to send that goodwill evaporating. External Affairs Minister S Jaishankar, whose erudition in Bratislava is being hailed as India's coming-of-age speech, will have to provide a better explanation for the conduct of his colleagues than reasoning that they mark the rise of the "non-elites" and "India's way" of "correcting historical wrongs"

India has the second largest Muslim population in the world, and irrespective of the fact that the BJP does not need their votes, as a party in office, it needs to show by word and deed that it is a government of all communities. On social media, the "trads" — hardline Hindutva trolls — are tearing up the BJP for caving in to international pressure. They are invoking the liberal posters of Salman Rushdie and Charlie Hebdo and the principles of free speech. The Government will be mistaken if it thinks two sound-bites are the problem and two suspensions the solution. Hate speech is unacceptable in itself, from the mouths of ruling party members targeting a minority it mainstreams bigotry, causes dangerous divisions, and is against the national interest. It is time this message went out from the very top. This doesn't — and shouldn't — need a prod from an ally in the Gulf.

Operationalising Biodiversity Committees

Create model BMCs at Village and District level so that Biodiversity Act 2002 is implemented in toto

n response to official communication by Chairperson J&K Biodiversity Council under letter No: JKUT/BC/BMC/2021-22/521-23 Dated: 7.12.2021, the Chairpersons of District Development Councils in J&K were asked to nominate a seven member team in every district for District Biodiversity Management Committee (BMC). Among these 7 members there has to be one Chairperson, two women members and one member from SC or ST community. A Secretary is also chosen from these members. In most of the districts these committees were constituted on the advice of DDC Chairpersons early this year but formal training has not been given to the members.

As weeklong activities in relation to World Environment Day are going on, it is the duty of Government particularly J&K Biodiversity Council to create model Biodiversity Management Committees (BMCs) at village panchayats , municipalities and district level so that Biodiversity Act 2002 is implemented in letter and spirit in these local bodies.

Members of BMCs are unaware of their role as of now. Consequently, the Biodiversity Act 2002 is not being operationalised on ground even after 20 years of its enactment.

The Biological Diversity Act, 2002 also called Biodiversity Act came into existence after India adhered to the objectives enshrined in the United Nations Convention on Biological Diversity (CBD) 1992. The CBD recognizes the sovereign rights of states to use their own biological resources.

Biodiversity Act, 2002

The Biodiversity Act was enacted in 2002. It aims at the conservation of biological resources, managing its sustainable use and enabling fair and equitable sharing of benefits arising out of the use and knowledge of biological resources with the local communities. The Act prohibits the following activities without the prior approval from the National Biodiversity Authority:

1) Any person or organisation (either based in India or not) obtaining any biological resource occurring in India for its research or commercial utilisation

2) The transfer of the results of any research relating to any biological resources occurring in, or obtained from, India.
3) The claim of any intellectual property

rights on any invention based on the research made on the biological resources obtained from India.

The act envisaged a three-tier structure to regulate the access to biological resources:

The National Biodiversity Authority (NBA)
The State Biodiversity Boards (SBBs) or Bio-

diversity Council in case of Union Territories
The Biodiversity Management Committees
(BMCs) at village, municipalities (towns, cities)
or district level

Biodiversity Management Committees

Under Section 41(1) of the Biological Diversity Act, 2002, every local body in the State shall constitute a Biodiversity Management Committee (BMC) within its area of jurisdiction for the purpose of promoting conservation, sustainable use and documentation of biological diversity including preservation of habitats, conservation of land races, folk varieties & cultivars, domesticated stocks and breeds of animals and microorganisms and chronicling of knowledge relating to biological diversity.

The Biodiversity Management Committee (BMC) is to be constituted under section 41(1), shall consist of a Secretary and not more than six persons nominated by the local body, of whom not less than one third should be women and not less than 18% should belong to the Scheduled Castes/Scheduled Tribes. Provided that the members of the committee shall be the proven resident of the local body and their names should be included in the electoral roll of the concerned local body.

The Chairperson of the BMC shall be elected from amongst 06 nominated members of the committee in a meeting to be chaired by the Chairperson of the local body. The Chairperson of the local body shall have the casting votes in case of a tie.

The Secretary of the BMC shall be the Gram Sachiv (Panchayat Secretary) in Gram Panchayat or any person nominated by the Pan-

chayat Department for Block and District BMCs.
The local Member of State Legislative Assembly and Member of Parliament would be spe-

cial invitees to the meetings of the Committee.

The tenure of the BMC shall be maximum of 05 years and shall be co-terminus with the tenure of the local body, however, the existing BMC shall continue to function, until a new committee is constituted.

The BMCs shall hold a minimum of 4 meetings in a year and meet at least once in every 3 months. The meetings shall be chaired by the Chairperson of the BMC, and in his/her absence, by any other member elected by the members present. The quorum at every meeting shall be 03 including the Chairperson and excluding official Member (Secretary).

Peoples Biodiversity Register

The main function of the BMC is to prepare the People's Biodiversity Register (PBR) in consultation with local people. The Register shall contain comprehensive information on availability and knowledge of local biological resources, their medicinal or any other use or any other traditional knowledge associated with them. The BMC shall be responsible for ensuring the protection of the knowledge recorded in PBR, especially to regulate its access to outside persons and agencies. In addition to preparation of the People's Biodiversity Register (PBR), the BMCs in their respective jurisdiction shall also be responsible for the following:-

A) Conservation, sustainable use and access and benefit sharing of biological resources and eco-restoration of the local biodiversity.

B) Feedback/information to the Board and the National Biodiversity.

C) Authority in the matter of Intellectual Property Right (IPR), Traditional Knowledge and local Biodiversity issues. Management of

As weeklong activities in relation to World Environment Day are going on, it is the duty of Government particularly J&K Biodiversity Council to create model Biodiversity Management Committees (BMCs) at village panchayats, municipalities and district level so that Biodiversity Act 2002 is implemented in letter and spirit in these local bodies

Biodiversity Heritage Sites including Heritage Trees, Animals/ Micro organisms etc and Sacred Groves and Sacred Water bodies.

D) Regulation of access to the biological resources and/ or associated Traditional Knowledge, for commercial and research purposes. Conservation of traditional varieties/breeds of economically important plants/animals.

E) Biodiversity Education and Awareness building.Documentation, enable procedure to develop bio cultural protocols.

F) To advise on any matter referred to by the State Biodiversity Board for granting approval, maintain data about the local vaids and practitioners using the biological resources.

Collection of Fees

The Biodiversity Management Committee (BMC) may levy charges by way of collection fees from any person for accessing or collecting any biological resource for commercial purposes from areas falling within its territorial jurisdiction. The Board shall provide guidance to the BMCs for the said purpose. As per sub section (1) of sec. 43 of the act, there shall be constituted a fund to be called "Local Biodiversity Fund" at the level of local body, which shall be maintained and used for conservation and promotion of biodiversity as advised by the Board in the areas falling within the jurisdiction of the concerned local body and for the benefit of the local community, in so far as such use is consistent with conservation of biodiversity. All funds of the BMC shall be operated jointly by the Chairperson and the Secretary of the BMC. The Board shall lay down the guidelines for operation of the fund including ways to make its functioning transparent and accountable.

District level BMCs

Formal training of the committees constituted must start soon so that the members of district level BMC implement the Biodiversity Act in letter and spirit. Infact, Biodiversity Council should also train the village and municipal level BMCs as well so that these institutions are operational as well. As on date, majority of these institutions are not aware of their role and responsibilities under Biodiversity Act 2002.

The members who get fully trained in these local bodies can go on to become master trainers who can then create more trainers in other villages, towns and districts. With the active support of Chairperson J&K Biodiversity Council, Jammu & Kashmir will become model Union Territory vis a vis adhering to the provisions of this law.

How Many or Too Many?

How many bots are on Twitter? The question is difficult to answer and misses the point

witter reports that fewer than 5% of accounts are fakes or spammers, commonly referred to as "bots." Since his offer to buy Twitter was accepted, Elon Musk has repeatedly questioned these estimates, even dismissing Chief Executive Officer Parag Agrawal's public

response. Later, Musk put the deal on hold and demanded more proof.

So why are people arguing about the percentage of bot accounts on

As the creators of Botometer, a widely used bot detection tool, our group at the Indiana University Observatory on Social Media has been studying inauthentic accounts and manipulation on social media for over a decade. We brought the concept of the "social bot" to the foreground and first estimated their prevalence on Twitter in 2017.


Based on our knowledge and experience, we believe that estimating the percentage of bots on Twitter has become a very difficult task, and debating the accuracy of the estimate might be missing the point. Here is

WHAT, EXACTLY, IS A BOT?

To measure the prevalence of problematic accounts on Twitter, a clear definition of the targets is necessary. Common terms such as "fake accounts," "spam accounts" and "bots" are used interchangeably, but they have different meanings. Fake or false accounts are those that impersonate people. Accounts that mass-produce unsolicited promotional content are defined as spammers. Bots, on the other hand, are accounts controlled in part by software; they may post content or carry out simple interactions, like retweeting, automatically.

These types of accounts often overlap. For instance, you can create a bot that impersonates a human to post spam automatically. Such an account is simultaneously a bot, a spammer and a fake. But not every fake account is a bot or a spammer, and vice versa. Coming up with an estimate without a clear definition only yields misleading results.

Defining and distinguishing account types can also inform proper interventions. Fake and spam accounts degrade the online environment and violate platform policy. Mali-

cious bots are used to spread misinformation, inflate popularity, exacerbate conflict through negative and inflammatory content, manipulate opinions, influence elections, conduct financial fraud and disrupt communication. However, some bots can be harmless or even useful, for example by helping disseminate news, delivering disaster alerts and conducting research.

Simply banning all bots is not in the

best interest of social media users. For simplicity, researchers use the

term "inauthentic accounts" to refer to the collection of fake accounts, spammers and malicious bots. This is also the definition Twitter appears to be using. However, it is unclear what Musk has in mind.

HARD TO COUNT

Even when a consensus is reached on a definition, there are still technical challenges to estimating preva-

External researchers do not have access to the same data as Twitter, such as IP addresses and phone numbers. This hinders the public's ability to identify inauthentic accounts. But even Twitter acknowledges that the actual number of inauthentic accounts could be higher than it has estimated, because detection is chal-

lenging. Inauthentic accounts evolve and develop new tactics to evade detection. For example, some fake accounts use AI-generated faces as their profiles. These faces can be indistinguishable from real ones, even to humans. Identifying such accounts is hard and requires new technologies.

Another difficulty is posed by coordinated accounts that appear to be normal individually but act so similarly to each other that they are almost certainly controlled by a single entity. Yet they are like needles in the haystack of hundreds of millions of

daily tweets. Finally, inauthentic accounts can evade detection by techniques like swapping handles or automatically posting and deleting large volumes of

The distinction between inauthentic and genuine accounts gets more and more blurry. Accounts can be hacked, bought or rented, and some users "donate" their credentials to organizations who post on their behalf. As a result, so-called "cyborg" accounts are controlled by both algorithms and humans. Similarly, spammers sometimes post legitimate content to obscure their activity.

We have observed a broad spectrum of behaviors mixing the characteristics of bots and people. Estimating the prevalence of inauthentic accounts requires applying a simplistic binary classification: authentic or inauthentic account. No matter where the line is drawn, mistakes are inevitable.

MISSING THE BIG PICTURE

The focus of the recent debate on estimating the number of Twitter bots oversimplifies the issue and misses the point of quantifying the harm of online abuse and manipulation by inauthentic accounts.

Through BotAmp, a new tool from the Botometer family that anyone with a Twitter account can use, we have found that the presence of automated activity is not evenly distributed. For instance, the discussion about cryptocurrencies tends to show more bot activity than the discussion about cats. Therefore, whether the overall prevalence is 5% or 20% makes little difference to individual users; their experiences with these accounts depend on whom they follow and the topics they care about.

Recent evidence suggests that inauthentic accounts might not be the only culprits responsible for the spread of misinformation, hate speech, polarization and radicalization. These issues typically involve many human users. For instance, our analysis shows that misinformation about COVID-19 was disseminated overtly on both Twitter and Facebook by verified, high-profile accounts.

Even if it were possible to precisely estimate the prevalence of inauthentic accounts, this would do little to solve these problems. A meaningful first step would be to acknowledge the complex nature of these issues. This will help social media platforms and policymakers develop meaningful responses.

New Work Place Rules?

veryone has their own experience of how the working week has changed.

And there's plenty of research out there from companies trying to understand how things have got better – or worse.

A little while back it was Microsoft bringing us the good news that we've created a third peak to the working day during the past two years - one at 10am, one at 3pm, and...one at 10pm.

That's the result of the switch to remote working that has allowed us to spread our duties across the working day, which is good in some respects (it makes vou more flexible during the day) and bad in others (you're still working at 10pm).

And now separate research from Asana has revealed another unexpected feature of the new world of work - one that is actually making it much harder to get

Instead of doing the work they were employed to do, it claims that workers find themselves spending half their time doing 'work about work', which means chasing updates or switching be-

tween apps. And for managers, it's even worse. They hardly ever get any work done, apparently.

"Excessive notifications are destroying employees' ability to concentrate by constantly vying for their attention, putting them in a state of near-constant multitasking while also filling up their days with menial micro-tasks and admin work," my colleague Owen Hughes notes in his story about the research from Asana.

For me the big issue is that while the tools we've introduced have fixed some of the problems that distributed teams create, they've introduced plenty of new

We're still trying to work out the right set of behaviours for the new



world of work and we're making some mistakes along the way.

After all, it's relatively easy to see if someone is working while they are sitting next to you in an office. It's a lot harder if you are working miles apart. That means now, working remotely, we're all keen to jump on any notification that arrives to prove we're actually at our desks and paying attention.

Hence the blizzard of alerts that keep distracting us. Part of the problem is that the

teamwork software we use is often inspired by social media. That makes sense - social media has shown itself (for better and for worse) to be very effective at building communities out of people who might rarely or

never meet in the real world. But social media companies have also worked really hard to design websites that make us want to keep scrolling and liking and spending as much time on there as possible.

That's great if you've got the time to look through pictures of your cousin's pets. It's less great if you are trying to find some information in a corporate teamworking tool.

Especially if you then find yourself agonising over whether to 'like' an update on somebody else's project, or figuring out which emoji to employ to indicate your approval of the sales forecast.

This, in short, is how you can spend half of your time doing 'work about work' rather than

getting on with your actual job. And in some cases, this might be the most rational response.

The danger is that, for some, the murky world of real-world office politics is being replaced by online office politics and your position in the team (and your chance for promotion) is going to be defined by who can do the funniest status update or dig out the right GIF to respond to the boss.

In that scenario, pouring more effort into your workplace digital identity might be more important than the actual work you do. Smarter teams and managers will be able to see beyond the frenzy of alerts and updates to see the real work you are doing, of course. But it might be wise to update your emoji skills, just in case.

Principal Secretary directed for expediting the finalization of tenders/ allotment and immediate execution of civil/ electro-mechanical works like Bore-wells/ tube-wells, Over Head Tanks, Filtration Plants, Laying of pipe network etc. for their completion before onset of the winter season.

"There should be optimal coordination between Deputy Commissioners, SE's and public representatives in finalization of District Action Plans (DAPs) within 15 days' time", he directed the officers.

The Chief Engineers and Superintending Engineers were directed to ensure that all the DPRs are accorded the Administrative Approval and Technical Sanctions as per the delegation of Financial powers.

He asked the Deputy Commissioners to facilitate the Jal Shakti department in obtaining timely clearances from Forest and other line departments for smooth implementation of works. BJP Forced To Act Against Party Functionaries Due To Pressure From Other Countries: Left Parties

New Delhi: Stepping up pressure for legal action against Nupur Sharma and Naveen Kumar Jindal, opposition parties on Monday demanded that they be arrested for their controversial remarks on Prophet Mohammad and accused the BJP of denting the image of the country.

While the ruling party faced more criticism at home, the diplomatic fallout of the row continued as Saudi Arabia, Bahrain, Indonesia, Jordan, UAE and Afghanistan joined several Muslim nations in condemning the alleged derogatory remarks.

The BJP had on Monday suspended its spokesperson Nupur Sharma and expelled Naveen Kumar Jindal, its Delhi media head, in a fire-fighting exercise, but the opposition parties like the Congress, AAP, BSP, SP and the Left dismissed it as mere "drama" and "sham" and demanded strict legal action against the two.

While Sharma is facing

cases in various cities over her remarks, the Delhi Police has now registered an FIR on her complaint that she is receiving death threats.

Delhi Police officials said the FIR has been registered under various IPC sections like 153 A (promoting enmity between different groups on grounds of religion, race, place of birth, residence), 506 (criminal intimidation), and 509 (word, gesture or act intended to insult the modesty of a woman) against the unidentified people.

Sharma will be summoned by the Mumbai police to record her statement in connection with an FIR against her on a complaint by Muslim outfit Raza Academyover her remarks, according to Mumbai police Commissioner Sanjay Panday.

The Congress hit out at the BJP, demanding the immediate arrest of those who have defamed India at the international level instead of enacting a drama of action.

Asking why those responsible for putting out offensive comments had not been arrested yet, the Congress said it was unacceptable for the nation to apologise for such mistakes.

"Divided internally, India becomes weak externally. BJP's shameful bigotry has not only isolated us but also damaged India's standing globally," Rahul Gandhi said on Twitter.
Congress chief spokesperson

Randeep Surjewala alleged the BJP leadership is pushing the country into the dark age of communal polarisation to serve its narrow political interests and asked. The AIMIM also demanded

the immediate arrest of the BIP functionaries and said the country's image has been dented internationally due to the "wrong policies" of the BIP.

The Aam Aadmi Party alleged that Prime Minister Narendra Modi's patronage of "hate politics" has brought disgrace to the country.

Delhi Deputy Chief Minister Manish Sisodia alleged the BJP has led the country to such a situation that even "small countries are now challenging the great nation of India". He claimed that every Indian is pained by it and "the sorrow is endless".

The opposition parties targeted the prime minister after the Organisation of Islamic Cooperation (OIC) slammed India for comments by the two Bharatiya Janata Party (BJP) functionaries. Countries like Qatar, Iran and Kuwait had summoned Indian ambassadors and handed

over protest notes on Sunday.

The party's action, however, has also drawn angry reactions from a section of BJP's faithful cheerleaders on social media, more so for Sharma, reflecting the dissonance between the army of supporters and its leadership, which acted to contain negative fallouts.

The Left parties alleged the BJP was "forced to act" and suspend Nupur Sharma due to pressure from other countries.
"Nupur Sharma publicly

thanked party leaders Amit Shah, PMO and others for support. Now under pressure from other countries, they are forced to act and suspend her. These are patrons of hate speech. Condemn Isolate Defeat them Save India," said CPI-M in a tweet. CPI-M general secretary

Sitaram Yechury questioned how BJP leaders speaking on behalf of the party can be called "fringe elements."

The opposition parties also said the country will not apologise for the mistakes of the BIP.

"Instead of doing a drama of action against anti-social elements in the party who have defamed India at the international level, it should immediately arrest them," the Congress said.

"The Islamic Emirate of Afghanistan strongly condemns the use of derogatory words against the Prophet of Islam (Peace be upon him) by an official of the ruling party in India," the agency quoted government Spokesperson Zabihullah Mujahid as saying in a tweet.

"We urge the Indian government not to allow such fanatics to insult the holy religion of Islam and provoke the feelings of Muslims," he

The Secretary General of the Gulf Cooperation Council (GCC), Nayef Falah M Al Ĥajraf, also condemned, rejected and denounced the statements made by the spokes-

person of the BJP against the Prophet. The Secretary-General affirmed his categorical rejection of prejudicing all the prophets and apostles as well as personalities and religious symbols, stressing the position that rejects provocation, targeting or underestimating beliefs and religions, the Council said in a brief statement.

The GCC is a regional, intergovernmental, political, and economic union that consists of Bahrain, Kuwait, Oman, Qatar, Saudi Arabia, and the United Arab Emirates. Millions of Indians work in GCC countries.

The 57-member Organisation of Islamic Cooperation strongly condemned and denounced the recent denigration of the Prophet by the BJP leader. It also urged the UN to take necessary measures to ensure that the rights of Muslims are protected in India.

Qatar, Iran and Kuwait on Sunday summoned India's Ambassadors and the key Gulf nations expressed their strong protest and condemnation of the controversial remarks of a BJP leader against Prophet Mohammad.

Pakistan said on Monday that it has summoned the Indian charg d'affaires to convey its categorical rejection and condemnation of the

controversial remarks.

Pakistan Prime Minister Shehbaz Sharif on Sunday also condemned the "hurtful" remarks against the prophet of Islam.

"Pakistan Armed Forces strongly condemn blasphemous remarks by Indian officials. The outrageous act is deeply hurtful and clearly indicates extreme level of hate against Muslims and other religions in India," the Spokesperson Pakistan Armed Forces tweeted.

Seeking to defuse a diplomatic row, spokespersons of the Indian Embassy in Qatar and Kuwait said on Sunday that the Ambassadors "conveyed that the tweets do not, in any manner, reflect the views of the Government of

India. These are the views of fringe elements." The controversial remarks also sparked a Twitter trend in the Arab world calling for a boycott of Indian products.

The Mumbai Police registered a case against the then BJP spokesperson Nupur Sharma on May 28 for allegedly making objectionable remarks against Prophet Muhammad during a television news debate based on a complaint lodged by Irfan Sheikh, joint secretary of Raza Academy, a Muslim outfit.

Sharma was charged under Indian Penal Code (IPC) sections 295A (deliberate and malicious acts intended to outrage religious feelings of any class by insulting its religion or religious beliefs), 153A (promoting enmity between groups) and 505(2) (statements conduc-

ing to public mischief), police had said. Sharma was suspended from BJP on June 5 over the allegedly insulting remarks against the Prophet that drew condemnation from sev-

eral Islamic nations. Meanwhile, Pandey said illegal dance bars will not be allowed to operate in Mumbai and those violating norms will invite stringent action.

We will not allow illegal dance bars to function in the city. We have already taken action not only on operators of such bars but also against certain officials of the police department." he said.

Pandey said that police officers have been directed to deal strictly against illegal dance bars if they are found violating rules.

"However, if somewhere such dance bars are operating and we don't know about them.. so I can't say anything in this regard," he said replying to a query.

Pandey said that Mumbai Police will implement the rule wherein two-wheeler pillion riders will also have to wear a helmet.

"This rule will be enforced strictly and

action will be taken against violators as per law," he added.

India Rejects

Pakistan after its Prime Minister Shehbaz Sharif reacted sharply on Twitter to condemn remarks by Nupur Sharma and Naveen Kumar Jindal, saying the "absurdity of a serial violator of minority rights" commenting on the treatment of minorities in another nation is not lost on anyone.

Reacting strongly to remarks by the

Organisation of Islamic Countries (OIC), External Affairs Ministry Spokesperson Arindam Bagchi said India accords "highest respect" to all religions and that the statement by the 57-member grouping exposed its "divisive agenda" which is being pursued at the behest of "vested interests."

The OIC also urged the UN to take necessary measures to ensure that the rights of Muslims are protected in India.

"We have seen the statement on India from the General Secretariat of the OIC.

The government of India categorically rejects the OIC Secretariat's unwarranted and narrow-minded comments. The government of India accords the highest respect to all religions," Bagchi said.

"The offensive tweets and comments denigrating a religious personality were made by certain individuals. They do not, in any manner, reflect the views of the government of India," he said.

Bagchi said strong action has already been taken against these individuals by relevant

"It is regrettable that the OIC Secretariat has yet again chosen to make motivated, misleading and mischievous comments. This only exposes its divisive agenda being pursued at the behest of vested interests," he said.

"We would urge the OIC Secretariat to stop pursuing its communal approach and show due respect to all faiths and religions," he said. Referring to criticism by Sharif and the Pakistan Foreign Ministry, Bagchi said the "absurdity of a serial violator of minority rights commenting on the treatment of minorities in another nation is not lost on anyone."

"The world has been witness to the systemic persecution of minorities including Hindus, Sikhs, Christians and Ahmadiyyas by Pakistan. The world has been witness to the systemic persecution of minorities including Hindus, Sikhs, Christians and Ahmadiyyas by Pakistan," he said.

Bagchi said the government "accords the highest respect to all religions. This is quite unlike Pakistan where fanatics are eulogized and monuments built in their honour.

In a tweet on Sunday, Sharif condemned the controversial comments and alleged that India is "trampling religious freedoms and persecuting Muslims.'

The Pakistan foreign ministry also criticised New Delhi over the remarks.

Also on Monday, Pakistan said it has summoned the Indian charg d'affaires to convey its categorical rejection and that the remarks are totally unacceptable and have not only deeply hurt the sentiments of the people of Pakistan but of Muslims across the world.

The comments by Sharma and Jindal triggered widespread anger in the Arab world as Qatar, Kuwait and Iran on Sunday summoned the Indian ambassadors. Saudi Arabia, Bahrain and Afghanistan also joined these nations on Monday to condemn the controversial remarks, stressing the importance of respecting all religious beliefs.

Blatter, Platini Finally Going To Court In FIFA Fraud Trial

GENEVA: Sepp Blatter and Michel Platini's 11-day trial on charges of defrauding FIFA starts Wednesday — finally bringing the epic downfall of soccer's former world leaders into criminal court. The fallout from the case ousted Blatter ahead of schedule as president of FIFA and ended Platini's campaign to succeed his former mentor. It also removed Platini as president of UEFA, the governing body of European soccer.

In 2015, federal prosecutors in Switzerland revealed their investigation into a \$2 million payment from FIFA to Platini from four years earlier. The pair will go on trial in Bellinzona. The subsidiary charges include forgery of the invoice in 2011 that allowed Blatter to authorise FIFA to pay the 2 million Swiss francs (about \$2 million) Platini had asked for. The claim was for the former France soccer great to be paid extra money for being an adviser — without having a contract for it — in Blatter's first presidential term from 1998-2002.
