CRPF Man Injured In Accidental Fire

Srinagar: A Central Reserve Police Force (CRPF) personal was injured on Thursday after his colleague's gun accidentally went off in South Kashmir's Anantnag district. A police official said that a driver with CRPF 63 battalion was injured when the service weapon of his colleague went off near the Srigufwara area of the district on Thursday evening. The trooper suffered injuries in his leg and was immediately evacuated to hospital. "His condition is stated to be stable," the officials added. (GNS)

J&K Logs 13 New Covid New Cases

Srinagar: Thirteen more people tested positive for Coronavirus in Jammu and Kashmir on Thursday while no fresh fatality due to the virus was reported from the Union Territory during the last 24 hours

According to officials, eight new cases of Covid-19 were detected in Jammu district and one each in Rajouri, Samba and Reasi in the winter capital. In the Valley, they said, a single case each was reported from Srinagar and Baramulla districts, taking the total number of people infected since the onset of the pandemic in J&K to 454314. School Bus Crushes Teen Girl To Death

Srinagar: A teenage girl was killed after being hit by a school bus in Ashmuqam area of South Kashmir's Anantnag district on Thursday. 17-year-old Shafia Jan was hit by the school bus near Grend Ashmuqam on Thursday afternoon, officials said. The injured girl was immediately shifted to PHC Ashmugam for treatment. However, the doctors there declared her dead, officials said.

Will Avenge Every Drop of Tear Shed by Families of Those Killed by Militants, Says LG Sinha

Orders Probe Into Allegations Of Irregularities In Sub Inspector Selection Process, Home Sec To Head Probe Panel; Says If Any Irregularity Found, Entire Recruitment Process To Be Conducted Afresh

Jammu: Jammu and Kashmir Lieutenant Governor Manoj Sinha Thursday vowed that the security forces will "avenge every drop of tear" shed by the families of those who lost lives in target killings by militants in Kashmir.

He also ordered a probe into the alleged irregularities in JKSSB Sub-Inspector post recruitment process stating that a committee headed by the Home Secretary will investigate the allegations.

"Administration led by me feels the pain and agony of families of those who were killed by militants in Kashmir recently. I assure the families that the security forces will avenge every drop of tear shed by them," LG Sinha said while addressing police passing out parade at Udhampur, as per news agency KNO.

About the allegations of irregularities into the J&KSSB SI recruitment process, the LG said: "All the recruitment process



held so far have been transparent and clean. But fingers have been raised against the J&K SSB list of SI posts. We have decided to constitute a committee that will be headed by Secretary Home to probe the allegations levelled by some people." He said that the committee will submit its report within the shortest possible time and if anybody is found involved in playing mischief, strict action will be taken and the entire process will be conducted afresh in a transparent manner.

EC Announces Presidential Poll On July 18

New Delhi: Election for the next President of India will be held on July 18 in which 4,809 electors comprising MPs and MLAs will vote to elect incumbent Ram Nath Kovind's successor, the **Election Commission announced** on Thursday.

Going by its strength in Lok Sabha and Rajya Sabha, as well as in many state assemblies, the BJP is in a comfortable position to ensure the victory of the candidate nominated by it in the upcoming election.

The nominations can be filed till June 29 after the issue of notification on June 15, Chief Election Commissioner Rajiv Kumar told a press conference.

Counting for the poll will take place in the national capital on July 21, after all ballots from states are brought here.

Kovind's term ends on July 24 and an election for the next president has to be held before that day.

With the EC setting the ball rolling, all eyes are now on who will be the BJP's choice for the top constitutional post as the party with the support of its allies has a More on P6

New Era Of Higher Education Flourishing In J&K: Prez Kovind



AMARNATH YATRA Sticky Bombs Worry Security Agencies

Srinagar: After a spate of killings of government employees and migrant workers at the hands of militants in the Valley, the government forces are bracing up to face the challenge of sticky bombs and drones ahead of the annual Amarnath yatra scheduled to begin from June 30.

An official from Central Reserve Police Force (CRPF) told Kashmir Observer that the security forces are reworking their standard

(SOPs) ahead of the pilgrimage being held after a gap of over two years.

"Several meetings were called in the last few months to mitigate the challenges," the official said. He said apart from

Centre Plans Third Chopper Route For Amarnath Pilgrims

New Delhi: The Centre is contemplating to start a new helicopter service from Srinagar to Panchtarni, which is the last drop-off point for pilgrims visiting holy cave shrine Amarnath, in addition to the two already existing chopper routes for the pilgrimage, officials said.

The move came in view of the anticipated rush of the pilgrims to the shrine dedicated to Lord Shiva located at an altitude of 3,888 metres in the upper reaches of Himalaya in Jammu and Kashmir.

The pilgrimage is scheduled to begin on June 30 and will continue for 43 days.

As of now, helicopter services are available for the pilgrims from Baltal and Pahalgam to Panchtarni. From this dropoff point, pilgrims either walk or ride a mule or travel in a palanquin to the Amarnath shrine 6 km away. Both Baltal and Pahalgam are about 90 km

from Srinagar. A new helicopter route is



being planned this year -- from Budgam (near Srinagar airport) to Panchtarni, an official said.

The Shree Amarnath Shrine Board (SASB), which manages the pilgrimage, has also been asked to check if it would be feasible to land the choppers at the foothill of the Amarnath cave.

As of now, only the choppers which ferry high level dignitaries land near the cave.

As per the Standard Operating Procedure (SOP) formulated following a direction of the Supreme Court, only 15,000 registered Shri Amarnath Yatra pilgrims are allowed beyond Pahalgam and Baltal in a day More on P6

Only 21.9% Women Currently Employed In J&K: Survey

Srinagar: Besides the worsening status of J&K's nutritional indicators especially among women, the fifth edition of National Family Health Survey (NFHS) series has revealed that the erstwhile state lacks a proper gender equality system when it comes to employment as only 21.9 percent of women between 15-49 age group are currently employed.

Last month, the government released the fifth part of the National Family Health Survey for India including J&K. Among others, several included indicators are of great importance to J&K in terms of female health. The report also contains indicators that are relevant to the Sustainable Development Goal of gender equality (SDG-5) in J&K.

Among the indicators released for the erstwhile state of J&K, several were based on education, educational



freedom, economic contribution, economic freedom, household management and decision-making, perceived status within the household, and health that have always maintained an influence on the status of women in J&K.

The report has noted that 21.9 percent of women in J&K are currently employed against 68.2 percent of men, expressing a great disparity in women's empowerment in the Union Territory. Moreover, in Northern India, J&K has the fourth lowest percentage of women who are currently employed. According to the survey, the

percentage of married women who were employed in the 12 months preceding the survey stands at 30.3 percent while for men in the same age group, the percentage was recorded at 97 percent. Among this, 60.8 percent earn cash while 98.3 percent men earn cash.

BSF Fires At Pak Drone Along IB In Jammu

Jammu: The Border Security Force (BSF) opened fire at a suspected Pakistani drone along the International Border (IB) in Jammu district in the early hours of Thursday, forc-

ing it to return, officials said. They said a massive search operation has been launched to trace any weapon or explosive that it might have dropped.

"A blinking light suspected to be from a drone was observed in Arnia area (along the International Border) about 04:15 hours today," a BSF spokesperson said.

Alert BSF troops fired at the flying object which was at a height of about 300 metres, causing it to withdraw, he said.

The security forces have been alert to attempts being made by Pakistan and militant outfits across the border to smuggle weapons, ammunition and explosives through drones via the International Border in Jammu More on P6

Remote Learning Was Even Tougher For Migrant Parents

hen COVID forced school closures, many parents found themselves more involved than ever with their children's learning. For some parents, it was hard work but broadly achievable. Many migrant parents, however, found themselves at a distinct disadvantage. Parental engagement is strongly linked to student learning outcomes.

With learn-from-home likely to return the next time there is a pandemic or other emergency, it's important we understand why many migrant families found this mode of education delivery so incredibly challenging and how the system can be improved.

We interviewed 20 migrant parents from Afghanistan, Ethiopia, Eritrea, Iran, Somalia, Sudan, and South Sudan who told us about the complex challenges they faced during lockdowns.

Many of our interviewees told us limited English language proficiency made it hard to engage with their children's learning. Understanding school and government messages was often a struggle. One parent said:

My daughter has a very native accent, and it is difficult for me to understand what she says Sometimes I do not understand what she wants or how I should help her. When I approached the school, they sent me

English emails that I didn't understand. The pandemic also highlighted Australia's digital divide; some participants struggled to set up their digital devices. Limited parental digital literacy makes difficult to monitor student learning, especially in large families. Some parents told us they knew their kids only pretended they were on school tasks, while really watching YouTube or playing games.

Our interviewees also reported intense financial stress during lockdowns. As children stayed home for an extended period, grocery and utility bills soared. One parent told us:

You need to spend more. They eat more; they want to play in the bathtub. They watch TV; I have to use the

vacuum cleaner and washing machine more often. Parents had to also buy tablet devices and printers for children to participate in remote learning. Worrying their children were not doing schoolwork properly, some paid for tutoring and spent more on books. Many parents worked full time during the pandemic and had limited time to educate their children. One

participant reflected: I have to work and be a teacher at the same time. It is not possible.

Another said: I am a single mum with four kids from Year 1 to year 7. [] I have to deal with four different age groups, four schools, four classes, and four iPads. [] Sometimes, I need to cut my sleep hours, which again makes me wake up tired.

Some parents eventually withdrew from their children's education:

I have asked my children to do their duties on their own. [] In the case of my little son, I only know that he progresses through his course, can pass his units, and proceed to the next year, but I am not aware of his academic situation.

Reflecting on his inability to support his children's learning during the lockdowns, one parent told us, it's out of my hands.

Another told her child's school:

Look, you need to provide me with simpler guidance. I'm not a teacher; provide me with a bit simpler communication; what they need to study, what they need to learn. Almost all parents who participated in our study reported remote learning was exhausting. One parent said:

You get tired of your children; you're connected to them, that is good, but now it's too much. I can't wait until they get back to school.

Some parents worried about the potential strain of remote schooling on their relationships with their children.

One single mother, working full time while her child was home alone, told us:

I had to teach him while he was very impatient and expected me to know the answer for everything. When I was a little unsure about any subject, he got angry and miffed. So, I decided not to help him [] I told him: Look, do whatever you can and leave the rest undone; when you get back to school, ask your teacher.' I came to the conclusion that the bond and the relationships between a son and a mother are far more important than schooling and learning.

Others in the study also reiterated the importance of not putting too much pressure on already distressed

Our research showed migrant parents faced myriad challenges during the remote learning period, with some only able to engage in a limited way with their children's education.

Remote learning may very well return in future when the next disaster strikes, so it's crucial we prepare for such disruption by improving equitable access to education delivered online and at home.

To achieve this, we must ensure: all students have access to digital remote learning devices disadvantaged families receive additional support (including financial and language support) during remote learning periods all parents are well informed about their roles and responsibilities, and school messages are easy to understand.

China Releases World's 'Most Detailed' **Map Of Moon**

hina has released a new comprehensive geologic map of the moon, the "most detailed" to date, which is expected to make a vital contribution to scientific research, exploration and landing site selection on the Earth's only natural sat-

Chinese scientists from multiple research institutes and universities have created the high resolution topographic map based on data from China's lunar exploration Chang'e project and other data and research findings from international organisations, the state-run China Global Television Network (CGTN) reported on Wednesday.

The new comprehensive geologic map of the moon is to a scale of 1:2,500,000, the "most detailed to date", the report said. The map includes 12,341 impact craters, 81 impact ba-



sins, 17 rock types and 14 types of structures, providing abundant information about geology of the moon and its evolution. It is expected to make a great contribution to scientific research, exploration and landing site selection on the moon.

The Institute of Geochemistry of the Chinese Academy of Sciences has led the project, along with other organisations such as Chinese Academy of Geological Science, China University of Geosciences and Shandong

The map was published by Science Bulletin on May 30. Previously, the USGS Astrogeology Science Centre had released a moon map to a scale of 1:5,000,000 in 2020, the report said.

On being contacted, Registrar Kashmir University, Dr. Nisar Ahmad Mir said the result for the post will be declared within a week.


Shahr-e-Khaas Traders Delegation Raise Developmental Issues With DC

From KO Archives Muezzin Murdered Inside Mosque Brutality Gives Blood-Soaked

RINAGAR- In an indication of the heights, brutality has scaled in Kashmir, a 40 year old villager was done to death in a local mosque in a Shopyan village on Friday night, and his bleeding body left on the floor for the locals to discover.

The victim, Muhammad Yaseen, was the muezzin (one who gives the call for prayer) for the Harpora village, who at usual, had left home to offer night prayers in the local mosque.

Concerned when he didn't return by 10 pm, Yaseen's family set out to search for him and were told by sev-eral villagers that he had been seen at prayer in the mosque.

When a group of people entered the premises, they found the muezzin lifeless on the blood-splattered floor. On being informed, the local po¬lice took the body for an

The police said that Yaseen, a farmer by profession, had been killed by a heavy, sharp-edged weapon, probably an ace, as

could be judged from the wounds on his head. The body was handed over to his family after a post-mor tem and other police formalities.

The police has registered a case under section 302 and started investigation, but no arrests had been made when

reports last came in. Sources said that police had ob-tained some vital clues. and taken down the statement of several villagers. The police expects to unearth the facts about the murder in

the coming few days. The wave of grief swept across the village when the Yaseen's body was handed over to his family. Hundreds of

people attended his funeral prayers, and staged demonstrations demand-ing the swift exposure of the killers. Top police officers have assured the family that the guilty would be arrested within the coming few days

Miracle Cancer Drug

n a major breakthrough, twelve rectal cancer patients who took the same drug for six months were completely rid of the deadly disease. The patients were found without any signs of the tumour after going through a series of medical exams such as physical exam, endoscopy, bioscopy, PET scans, and MRI scans. Also, none of the participants reported any severe side-effects either, says the research paper published in the New England Journal of Medicine recently. The researchers had set out to find whether dostarlimab, a new drug, followed by standard chemoradiotherapy and standard surgery is an effective treatment for solid tumours. And the result has pleasantly surprised the world now. However, it would be long before there is a comprehensive cure for the cancer. And until then prevention will remain the best approach to deal with the disease that is responsible for killing millions of people

In Kashmir, for that matter, the cancer has grown disproportionately over the last decade. Data over the last decade presents a grim picture. Around 3,075 cancer cases were reported in 2011, 3,288 in 2012, 3,157 in 2013, 3,940 in 2014 and 4,257 in 2015. The figures since have only grown bigger. In 2021 alone, Sher-i-Kashmir Institute of Medical Sciences alone registered over 5000 new cases of cancer in 2021 with breast cancer showing a conspicuous spike.

This calls for more pro-active handling of the situation from the UT government. In addition to generous allocation of resources for the treatment, there is an urgent need to investigate the reasons for the sudden increase in the number of cancers in the UT. People need to know as to what has changed in Kashmir that has led to the spread of cancer. It is a pity that our major healthcare institutions have been unable to put into public domain credible research about the causes for growing incidence of cancer in the region. Such studies will be immensely helpful as they will persuade people to take due precautions to reduce their vulnerability to the disease. The public awareness that the doctors have talked about will flow from this.

In recent years, food contamination and adulteration has emerged as major issue in Kashmir. Hazardous agents have been found to have been used even in the food products of some major corporate houses. Sadly, J&K Government has so far done little about the growing food adulteration in the UT, which has now been proven to be one of the factors leading to the rise in cases of cancer in the Valley. The rise in cancers is, therefore, a wake-up call. The government has to get cracking on the unscrupulous traders and expose the use of chemicals and dyes in the food. And at least, to start with, there has to be a campaign to create more awareness of the ways in which our food is adulterated. That is, until dostarlimab is proved to be effective in curing all cancers.

Service Charge, Please

o less than the Union Minister of Consumer Affairs, who is working hard to revitalise exports, has called the levying of service charge on a restaurant bill an act of deceit. Officials have held meetings with restaurant associations and called for a "robust framework" to ensure compliance with guidelines that forbid the levy of service charges by hotels and restaurants. According to the government, levying charges for anything other than "prices displayed on the menu card along with the applicable taxes", without "express consent" of the customer, constitutes "unfair trade practices". Such nonsense would be laughable — had it not been for the seriousness of its implications.

For, this is a throwback to the licence permit raj when ill-thought through and heavy-handed government interventions marked economic policymaking. Clearly, that attempt to intrude and micro-manage that which the government should leave well alone, continues to be all too frequent. Representatives of restaurant associations are right to stand their ground. Collecting service charge is neither illegal nor in violation of law. Restaurants pay GST on the entire bill, including service charge, so the government doesn't lose anything. In one form or another, service charges exist across sectors: Government transactions have processing fees; food-delivery services have "restaurant charges"; ticketing platforms charge a "convenience fee". The restaurant sector has been battered by the pandemic — as per latest GDP estimates, value added by trade, hotels, transport and communication at the end of 2021-22 is much lower than its 2019-20 levels. Few would object to a charge designed to help the countless men and women employed in the sector. Moreover, as this is not uniform across restaurants, the presence of alternatives implies no restrictions on choice — there is no coercion of the consumer. Restaurants clearly mark the service charge as such and waive it if the consumer does not wish to pay. Most collections from service charge go to the staff and are often seen as an incentive in lieu of tips.

Of course, the levy of the service charge should be — as it is in most cases — clearly communicated to the consumer. It's unclear what provoked this government intervention, where exactly are consumers being made to pay service charge kicking and screaming. The official action mirrors the arbitrariness with which a domineering state continues to wield power in economic matters. Considering the challenges the economy faces as it emerges out of the long Covid shadow, the finest financial minds in North Block should work on matters more pressing than how a restaurant tip should be paid — or not.

Get Ready for Reverse Currency Wars

Today, the most likely victims of a strengthening dollar are not other major rich countries, but rather emerging and developing economies. Many of them have substantial dollardenominated debts, exacerbated by the fiscal spending required to fight the COVID-19 pandemic

AMBRIDGE – The US dollar is up 12% against the euro over the past year and, at 0.93, is approaching parity. If prices of oil and other commodities now seem high in dollar terms, they look even higher in euros. With the greenback surging, and inflation in many countries currently at multi-decade highs, we may be entering so-called "reverse currency wars" - in which countries compete to strengthen their currencies' foreign-exchange val-

The term "currency wars" was originally a colorful description of what international economists had long called "competitive devaluations" or, after exchange rates began to float in the early 1970s, "competitive depreciations." In these situations, countries feel aggrieved that their trading partners are deliberately pursuing policies to weaken their own currencies in order to gain an unfair advantage in international trade. Competitive depreciation can arise when all countries' main macroeconomic goals, in addition to maximizing GDP growth and employment, include improying their trade balances. This generally describes the past few decades in the world economy.

A reverse currency war, on the other hand, involves competitive appreciation. Here, countries think their trading partners are deliberately trying to strengthen their currencies in order to rein in inflation. This could describe the period that began in 2021, when inflation returned as a serious problem in most countries.

In both cases, it is impossible for all countries to pursue such strategies, because they cannot all move their exchange rates in the same direction at the same time. Both competitive depreciation and competitive appreciation are often perceived as evidence of a lack of international cooperation to achieve exchange-rate stability, and sometimes lead to calls for a new Bretton Woods-type arrangement to promote greater policy coordination.

The United States has often been quick to allege that other countries' currencies are unfairly undervalued. Since 1988, Congress has required the Department of the Treasury to submit semi-annual reports on whether America's major trading partners are manipulating their currencies. China and other Asian countries are the most frequent targets. But Switzerland is also under suspicion, even though the Swiss franc is easily the most expensive major currency by other criteria.

In February 2013, the US Treasury spearheaded a sort of micro-Bretton Woods agreement whereby G7 countries would refrain from taking steps to depreciate their currencies. The 2013 pact is little known, but it has worked. Over the past decade, G7 members have not intervened to sell their own currencies on the foreign-exchange market.

China, which is not a G7 member, does intervene in the currency market. Since 2014, however, it has done so to slow the renminbi's depreciation, not to encourage it.

The phrase "currency war" was coined in 2010 by Brazilian leaders protesting the monetary policies of the US, Japan, and other countries. They did not accuse the US Federal Reserve and the Bank of Japan of explicitly devaluing the dollar or the yen, or of intervening in the foreignexchange market to drive down these currencies, but rather of adopting excessively loose monetary policies. US and Japanese policymakers, their Brazilian counterparts argued, had cut interest rates to zero, and then gone further by introducing quantitative easing, with the deliberate intention of depreciating their countries' currencies, boosting net exports, and exporting unemployment to their trading partners.

Similarly, nobody today accuses the US authorities of using foreign-exchange intervention to appreciate the dollar. The complaint is rather that the Fed's current interest-rate increases attract capital inflows to the US and strengthen the greenback, forcing up interest rates internationally and thus keeping global growth below where it could be.

There is ample historical precedent for fears of competitive devaluation, most notably the 1930s, when major powers devalued their currencies against gold and thereby against each other. Is there also a precedent for competitive appreciation?

Some have argued that the early 1980s provided such an example. When the Paul Volcker-led Fed raised interest rates sharply to fight inflation, it knew that it would be aided in that task by the dollar's appreciation. But

the corresponding depreciation of US trading partners' currencies worsened their inflation rates and forced them to raise interest rates as well.

Today, the most likely victims of a strengthening dollar are not other major rich countries, but rather emerging and developing economies. Many of them have substantial dollardenominated debts, exacerbated by the fiscal spending required to fight the COVID-19 pandemic. When the dollar appreciates, their debt-servicing costs increase in local-currency terms. The combination of rising global interest rates and a stronger dollar can trigger debt crises, as it did in Mexico in 1982 and 1994.

But not all fears of competitive appreciation are justified or merit a reform of the international currency system. Unlike most central banks, the BOJ kept its monetary policy very loose over the last year, in a continuation of its long campaign to raise growth and inflation. So, while the Fed is raising interest rates in an effort to slow US price rises, Japanese rates are still at or below zero. As one would predict, the widening interest-rate differential has caused the yen to depreciate by about 15% against the dollar over the past year.

Overall, this big change in the dollar-yen exchange rate is not really a problem. It has pushed up Japanese prices while exerting downward pressure on US inflation. That is what both countries wanted. Floating currencies allow each country to pursue the monetary policy that suits its own circumstances.

But with high global inflation likely to persist for some time, the prospect of reverse currency wars is looming larger. Instead of a race to the bottom in the foreign-exchange market, we may see a scramble to the top and poorer countries are likely to suffer the most.

Parenting in Exam Fever

xam time has never been an easy phase to go through. The feeling of a knot in your gut combined with parental and peer pressure, can be overwhelming. While some argue that a certain amount of stress and nervousness is necessary to keep the pressure on when studying for examinations, constant stress and anxiety can lead to some unpleasant scenarios.

When we're stressed, our brains release a lot of stress hormone-cortisol, which can muddle our thinking and prevent us from making reasonable decisions.

WHAT ARE THE VARIOUS SIGNS **OF EXAM STRESS?**

Children and young people who are stressed may:

- Worry A Lot
- Feel Tense Have Headaches And Stomach
- Not Sleep Well
- Be Irritable Lose Interest In Food Or Eat
- More Than Normal Not Enjoy Activities They
- Previously Enjoyed Be Negative And Have A Low
- Feel Hopeless About The **Future**

WHAT CAUSES EXAM STRESS?

Exam anxiety is caused by a vari-

Worry that they will fail

They don't feel ready. They want to do perfectly well. They feel they don't have a lot of

Need to achieve a specific out-

Find it difficult to comprehend

what they're studying Family puts a lot of pressure on them to do well in exams.

They believe they must compete with others. Some other stressors are bother-

ing their life at the same time. It can be beneficial to have someone to talk to about their exam pressure. Young people should be encouraged to discuss their anxieties and keep things in perspective with the support of a parent, tutor, or study buddy.

Encourage your child to speak with a member of the school staff who they consider to be helpful. If you believe your child is struggling, speaking with their teachers may



be beneficial.

Following are few strategies that might be helpful for parents to consider helping their children deal with exam stress:

1. MAKE SURE YOUR CHILD **EATS WELL.**

A well-balanced diet is essential for your child's health, and it can also help them feel better during exam times. High-fat, high-sugar, and high-caffeine meals and drinks, such as energy drinks, cola, candies, chocolate, burgers, and chips, cause hyperactivity, irritability, and moodiness in some children. If at all feasible, involve your child in grocery shopping and encourage them to select healthy snacks.

2. ASSIST YOUR CHILD IN GET-TING ENOUGH SLEEP.

A good night's sleep improves one's ability to think and concentrate. The majority of teenagers require 8 to 10 hours of sleep per night.

Allow your child to unwind for half an hour or so between studying, watching TV, or using the computer and going to bed to ensure a good night's sleep. It's not a good idea to study all night before an exam. Sleep is significantly more beneficial to your child than a few hours of frantic last-minute studying.

EXAMS REQUIRE YOU TO BE ADAPTABLE

Be adaptable when it comes to exam times. Do not be concerned about unfinished domestic chores or dirty bedrooms when your child

is revising all day. It is possible to help yourself by being calm. Exams do not last indefinitely

ASSIST THEM WITH THEIR STUDIES

Ascertain that your child has a comfortable place to study. Inquire about how you may assist them with their revision.

Assist them in coming up with practical revision ideas, such as creating a revision calendar or obtain-

ing former papers for practise. Encourage your child to consider their life goals and how their revision and tests relate to their goals in life to keep them motivated.

5. EXAM ANXIETY IS A REAL

Reassure your child that feeling nervous is normal. Exam anxiety is an understandable emotion. Validate their anxious feelings. The goal is to channel this anxiety for good. Encourage your child to practice the activities they'll be doing on exam day if nervousness is getting in the way. This will make it feel less frightening. Doing practice papers under exam settings, for example, or viewing the exam hall beforehand, are examples of this. This should be something that the school staff can assist with. Rather than avoiding these activities, encourage your child to face his or her concerns and complete them. Encourage them to consider what they already know and how much time they've already spent

studying to make them feel more confident.

ENCOURAGE YOUR CHILD TO EXERCISE DURING THEIR

Exercise can help your child feel more energized, clear their mind and make them feel relaxed. Walking, cycling, swimming, football, and dancing are all beneficial forms of exercise.

Activities that involve others can be especially beneficial.

7. SET UP PARENTAL RESTRIC-TIONS ON THE PHONES AND TABLETS OF YOUR CHILD.

Many teens may get distracted by digital devices at exam time. Parental settings in the form of various parental control softwares that can be installed in their electronic gadgets allow parents to disable apps and websites that are a distraction for children, allowing them to use their devices for what they were designed for - studying.'

8. DON'T AGGRAVATE THE SITU-**ATION**

Many children believe that their family is the major source of the pressure during exam time.

Listen to your child, encourage

them, and avoid criticizing them. Be reassuring and encouraging before they take a test or exam. Make sure they understand that failing isn't the end of the world. They may be eligible to retake the exam if things do not go smoothly.

Encourage your child to discuss with you what he or she did in paper after each one. Instead of focusing on the difficulties they faced or mistakes they made, talk about the parts that went well. It may increase their morale.

9. ALLOW FOR TREATS

Discuss rewards for doing revision and passing each exam with

Rewards do not have to be large or costly. They might be as basic as preparing their favorite food or watching their favorite show.

Help your child celebrate the end of the tests by planning an end-of-

THE FOLLOWING IS A LIST OF THINGS THAT YOU SHOULD NOT DO AS A PARENT DURING YOUR CHILD'S EXAMS.

- Asking the child if they are learning enough should be avoided at all costs.
- Anxiety and hanging around the child, offering obnoxious
- counsel. Never put the child down or make fun of them for not sticking to their own plan.
- Negative behaviors of children should not be criticized in an aggressive manner, such as by shouting and threatening severe consequences.
- Labeling your child as "irresponsible, thoughtless, or lazy" because of his or her actions is a big no-no.
- Never force the child to use your knowledge and study at your pace.
- During tests, never force the child to help around the house.
- When your child admits he is stressed, you become more anxious, take command, and decide what to do.
- Talking only about school, grades, and future success will put the child under even greater stress.
- Never make this a "make or break" situation by over-emphasising the importance of earning a good outcome and the blame and hardship your child will suffer if he does not.

Towards Affordability, Accessibility and Availability of Quality Health Care

ndia is geared up to celebrate August 15, 2022, as 'Azadi Ka Amrit Mahotsav', an initiative of the Government of India to commemorate 75 years of independence of progressive India and the glorious history of its people, culture, and achievements. As Hon'ble Prime Minister, Shri Narendra Modi, said, "...this Mahotsav is a festival of awakening of the nation; a festival of fulfilling the dream of good governance; and the festival of global peace and development."

And, the reforms in the governance of medical education have served as the foundation for remarkable achievements in the health sector. India now has the potential to change the global health landscape and become a leading provider of expert human resources for health for the world.

However, due to an increasing global demand for qualified doctors from India, the availability of medical doctors to cater to the changing epidemiology and health needs of the country posed a challenge. The Department-Related Parliamentary Standing Committee, in its 92nd report, suggested that India required medical reforms to strengthen the health systems to avoid social, political, and financial suffering in the country. From 2014, the Hon'ble PM has closely reviewed the progress of medical reforms which were brought about collaboratively by different teams - Board of governors of erstwhile Medical Council of India (MCI), NITI Aayog, the Ministry of Health and Family Welfare (MoHFW), and stakeholders from other ministries.

A momentous reform in medical education was the dissolution of the

MCI, and the inception of the National Medical Commission (NMC) in 2020 through merit-based selection of its members. The NMC brought about transparency, professionalism, grievance-redressal mechanisms, and honest assessments of the medical colleges. The revised norms and standard requirements by the NMC facilitated the creation of new medical colleges while maintaining the high standards.

The medical colleges in India have increased from 387 to 607 within the last eight years. The number of MBBS seats have almost doubled from 51,348 in 2014 to 91,115 in 2022. The postgraduate seats have also witnessed an increase of 80%, from 30,191 in 2014 to 55,595 in 2020. Over the last decade, all states in India have increased seat capacities in medical colleges, with Karnataka leading the admission capacity share with 13.6%, followed by Maharashtra (11%) and Tamil Nadu (10%). With almost 10.05 lakh registered allopathic doctors, and 6.3 lakh AYUSH doctors, India's doctor-population ratio has increased to 1:834, surpassing the

WHO's recommendation of 1:1000. The imbalanced geographical distribution of the medical colleges is being addressed at the core level for ensuring 'Sabka Saath, Sabka Vikaas'. 39 medical colleges have become functional in aspirational districts, where there was a scarcity of doctors and specialists. There has been a 2.21 times increase since 2004, in the number of medical colleges in Empowered Action Group (EAG) states. The EAG states include Bihar, Rajasthan, Jharkhand, Chhattisgarh, Madhya Pradesh, Odisha, Uttar Pradesh, and Uttarakhand. Furthermore, the eight states of North-East India, have 20 medical colleges now, as com-

pared to 5 in 2004).

Pradhan Mantri Swasthya Suraksha Yojana (PMSSY) was introduced for expanding excellence and ensuring equitable distribution of medical education by establishing 22 new All India Institute of Medical Sciences (AIIMS) across the country. The newer reforms have also made medical education affordable for economically weaker meritorious students by putting a cap on 50% seats for tuition fees and other charges in private colleges for MBBS and PG seats.

To ensure the holistic development of medical students, the Competency Based Medical Education (CBME) curriculum was introduced. It has a practical approach so that a medical graduate may function effectively as a first contact doctor of the community. This change in curriculum took

place after almost two decades, and mandated incorporation of skill labs. computerised simulations, and digital classrooms in the colleges.

In 2016, National Eligibility-cum-Entrance Test (NEET) was introduced to provide a platform for common counselling for admission with a single countrywide entrance exam. To bring transparency and uniformity in the medical education system, the National Exit Test (NEXT) is being introduced as well. The physicians trained in India and abroad will be required to qualify NEXT for obtaining a license to practice and for postgraduate admission.

The reforms aimed to ensure strengthening of the health systems for service delivery in remote areas also. The District Hospitals have been strengthened by the launch of two-year Diploma courses by the National Board of Examination (NBE) in eight disciplines. The District Residency Program addresses the crunch of medical personnel in hospitals by posting MD/MS students in the District Health facilities for three months. Bringing back the traditional concept of consulting one 'family doctor' for all ailments, the NBE is now promoting Family Medicine as a specialised discipline. To increase the availability of trauma care, all the colleges have been mandated to set up Emergency Medicine departments by 2022-23.

The vision of Hon'ble PM is to bring about advancements in the medical field with a long-term impact on primary, secondary and tertiary levels of care, catering to the needs of the entire country and the entire world: Heal in India as well as Heal by India. As he has mentioned in his addresses: The Indian health care sector has progressed significantly over the last eight years with the government's objective to achieve the 3As of health care - Affordability, Accessibility and Availability.

Delhi Police files FIRs against Sharma, Jindal and Owaisi for inciting people on divisive lines

New Delhi: Delhi Police has registered two FIRs - one against former BJP spokesperson Nupur Sharma and the other against 31 people, including AIMIM chief Asaduddin Owaisi and controversial priest Yati Narsinghanand - for allegedly spreading hate and hurting religious sentiments, officials said on Thursday.

The two FIRs were registered on Wednesday after an analysis of social media, they said.

Former Delhi BJP media unit head Naveen Kumar Jindal, who was expelled from the party over alleged remarks against Prophet Mohammad, and journalist Saba Naqvi, are among the people named in the second FIR.

"The cases have been registered against those who were posting and sharing messages against the maintenance of public tranquility and were inciting people on the basis of divisive lines," a senior police officer said

The cases have been registered under sections 153 (wantonly giving provocation with intent to cause riot), 295 (injuring or defiling place of worship with intent to insult the religion

of any class), and 505 (statements conducing to public mischief) of the Indian Penal Code, he said.

Reacting to the FIR, All India Majlis-e-Ittehadul Muslimeen (AIMIM) chief Owaisi said that he will not be intimidated by these tactics, asserting that criticising hate speech and giving hate speeches cannot be equated.

Owaisi attacked Prime Minister Narendra Modi, alleging that if he were sincere, he would have stamped out hate speech without indulging in "fake balance-vaad".

The AIMIM chief alleged that Delhi Police is suffering from "both side-ism" or "balance-waad" syndrome. One side has openly insulted our Prophet while the other side has been named to assuage BJP supporters and make it look like there was hate speech on both sides, he said.

According to police, one case has been registered against Sharma and another against multiple social media entities, including Owaisi, Jindal, Narsinghanand, Shadab Chauhan, Saba Naqvi, Maulana Mufti Nadeem, Abdur Rehman and Gulzar Ansari, based on the analysis.

Notices will be sent to the social

media intermediaries for the details, the police officer.

According to the FIR, 31 people named in it were also using hateworthy languages intentionally or having complete knowledge that use of such type of language, claim and assertion is not only discriminatory but more than sufficient to create a situation of animosity amongst different groups of persons having faith in different religions.

This will certainly be a serious threat to public tranquility and maintenance of public order in our country wherein people have been living peacefully, it stated.

Transmission and publication of such language has been done through electronic media which are filthy in nature and appeals to prurient interest and sufficient to deprave and corrupt any person who see it or hears the objectionable words, the FIR said.
"We have registered two FIRs un-

der appropriate sections on the basis of social media analysis against those trying to disrupt public tranquility and inciting people on divisive lines. One pertains to Ms Nupur Sharma and other against multiple social media entities. Delhi Police tweeted.

"Even as Notices are being sent to social media intermediaries for details of those behind these accounts/ entities, #DelhiPolice appeals to everyone to desist from posting anything that may disrupt social and communal harmony," it added.

The FIRs have been registered by the Intelligence Fusion and Strategic Operation (IFSO) unit of the Special Cell, police said.

On Wednesday, police said the unit would investigate the roles of various social media entities in promoting false and wrong information with an intention to create unrest on the cyber space, that have ramifications on the physical space thereby compromising with the social fabric of the country.

Earlier, Delhi Police had provided security to Sharma and her family after an FIR was registered on a complaint that she was getting death threats over her controversial remarks on Prophet Mohammad.

She had requested the police to provide security citing harassment and threats she had been receiving.

The BJP on June 5 had suspended Sharma and expelled its Delhi unit media head Jindal as the row over their alleged derogatory remarks against Prophet Mohammad escalated with protests from many Muslim countries.

In a series of tweets, AIMIM chief Owaisi said that he will consult his lawyers and address it as and when required.

"I've received an excerpt of the FIR. This is the first FIR I've seen that's not specifying what the crime is. Imagine an FIR about a murder where cops don't mention the weapon or that the victim bled to death. I don't know which specific remarks of mine have attracted the FIR," Owaisi tweeted.

"It appears that Delhi Police lacks the courage to pursue cases against Yati, Nupur Sharma & Naveen Jindal, etc. This is why the delayed & weak response," he alleged.

The AIMIM chief alleged that in fact, controversial Yati has violated his bail conditions repeatedly by inciting genocide against Muslims and insulting Islam.

"Delhi Police were probably trying to think of a way of registering an FIR against these people without offending Hindutvadi fanboys/girls," he alleged.

A BJP leader said the ruling NDA already has close to 50 per cent of votes in the electoral college. The alliance is hopeful of getting support from independent regional parties like the ruling YSRCP in Andhra Pradesh and the incumbent BJD in Odisha. The BJP is also counting on

support from AIADMK, its ally in the last Tamil Nadu assembly polls.

Despite not having numbers on its side, the Opposition is likely to put up a joint candidate for the election and consultations in this regard have already begun.

Sources said that Leader of Opposition in Rajya Sabha Mallikarjun Kharge has reached out to leaders of some opposition parties and sought their views for a joint opposition candidate who can be fielded.

Some opposition parties are of the view that they should not give a walkover to the ruling dispensation but put up a fight, the sources said.

CPI Rajya Sabha member Binoy Viswam said the Congress had reached out to him to discuss a "common candidate".

"Consultations for the presidential election have begun among various opposition parties," a senior opposition leader told PTI, adding that once a consensus is arrived at, a joint candidate may be put up.

Though the final list of electors will be notified after the bye-elections to three Lok Sabha seats and the Rajya Sabha polls to 16 seats, the NDA has 440 MPs in its favour while the opposition UPA has around 180 MPs, besides 36 MPs of Trinamool Congress who normally support the opposition candidate.

The Congress and the BJP are likely to win six more Rajya Sabha seats in the June 10 election and the UPA partners may bag three seats more.

According to rough calculations, the NDA has around 5,35,000 votes out of a total of 10,86,431 votes of all electors.

This includes 3,08,000 votes with the support of its MPs along with that of its allies.

Among the states, the BJP has the maximum of 56,784 votes from Uttar Pradesh where it has 273 MLAs. Each MLA in Uttar Pradesh has the maximum vote of 208. The NDA will get its second-highest votes among states from Bihar where with 127 MLAs, it will get 21,971 votes as each legislator has 173 votes, followed by 18,375 votes from Maharashtra where it has 105 MLAs and each has 175 votes.

With 131 MLAs, the NDA will get 17,161 votes from Madhya Pradesh, 16,464 votes of 112 MLAs from Gujarat and 15,982 votes of its 122 MLAs in Karnataka.

The UPA, on the other hand, has a little over 1,50,000 votes from among its MPs and will get around the same number of votes from its legislators in states. Opposition candidates in the past too have been getting a little more than 3 lakh votes in the previous elections for the highest post in the country.

The value of the vote of a Member of Parliament has gone down to 700 from 708 in the presidential polls this time due to the absence of a legislative assembly in Jammu and Kashmir

Kumar said the EC is fully geared to conduct the election in a free and fair manner, while all Covid-related safety protocol would be followed during the voting and counting of votes.

He further said that no political party will be allowed to issue any kind of whip in this election, which will be held on secret ballot.

"The Constitution has expressly provided that election to the office of President shall be by secret ballot. Therefore, the electors are expected to scrupulously maintain secrecy of vote. There is no concept of open voting in this election and showing the ballot to anyone under any circumstances in the case of Presidential and Vice-Presidential elections is totally prohibited," the CEC said.

Any violation of the voting procedure will entail cancellation of the ballot paper by the presiding officer, he said, adding that the marking of vote can be done only with the particular pen provided by the presiding officer to the electors at the place of polling.

"It is the resolve of the EC that there should be no malpractice of any kind in this election for the highest office in the country and if anything is found, it is a ground for election petition in the Supreme Court and could lead to cancellation," Kumar said, adding that the entire process of voting would be videographed.

He said as per Section 18 of the Presidential and Vice-Presidential Elections Act, 1952, the offence of 'bribery' or 'undue influence' as

defined in Sections 171B and 171C of IPC, by the returned candidate or any person with the consent of the returned candidate are among the grounds on which the election can be declared void by the Supreme Court in an election petition.

Scrutiny of nominations will take place on June 30 and the last date for withdrawal of nominations will be July 2.

If necessary, the voting will take place on July 18 and counting of votes on July 21.

Kumar said the total number of electors for the election will be 4,809, comprising 776 MPs and 4,033 MLAs. Voting for presidential election will take

place in Parliament and the premises of state assemblies, while Rajya Sabha Secretary-General will be the returning officer. The president is elected by the members

The president is elected by the members of the electoral college consisting of elected members of both houses of Parliament, and elected members of the legislative assemblies of all states including the National Capital Territory of Delhi and the Union Territory of Puducherry.

The nominated members of either Rajya Sabha and Lok Sabha or legislative assemblies of the states are not eligible to be included in the electoral college and therefore, they are not entitled to participate in the election.

Similarly, members of the legislative councils are also not electors for the presidential election.

He directed for increasing the space for parking by levelling the ground at important locations to avoid inconvenience to the pilgrims," a police official said.

Make Use Of Technology

During the meeting, he said, the LG stressed that all the work of yatra arrangements should be completed within the set timeline. Sinha, he said, also called upon the officials to ensure optimum use of technology to make the yatra safer and more convenient for the pilgrims.

Underlining the significance of the holy yatra, the LG, as per the spokesperson instructed all senior officials to periodically inspect the security and every aspect of world-class arrangements, including transport, lodging, sanitation, electricity, water, communication, health, convenience shops, food courts, vending zones etc. for Amarnath yatris.

"Pertinently, this year, the government is introducing RFID system for pilgrims to track their movement en-route to ensure their wellbeing, besides upgrading telecommunication channels to ensure better connectivity for the yatris," he said.

He further said that the concerned adminis-

trative secretaries and deputy commissioners briefed the LG about the up to date status of Yatra works within their jurisdiction.

"It was informed that maximum of the works are completed or near completion. Divisional Commissioner Kashmir apprised the meeting that around 7500 registrations have already been done for pony service," the spokesperson said.

PCI Demands Probe Against JKP For "Harassing" Journalist

NEW DELHI: The Press Club of India (PCI) on Thursday took serious exception to the alleged harassment of a journalist by Jammu and Kashmir police and demanded that an enquiry be "immediately" conducted against the force.

The journalist body also urged the Union government and Jammu-Kashmir Lieutenant Governor Manoj Sinha to immediately intervene to safeguard the freedom of the press and stop further harassment and targeted witch hunting of journalists.

The PCI's demands came after Shahid Tantray, a journalist with 'The Caravan' magazine accused the Jammu and Kashmir police of harassing him over his article on the Army's interference in activities in Kashmir, a charge denied by the force which said it had received a complaint against him for putting lives of some prominent individuals in danger

Issuing a statement, Tantray claimed that he and his family were being intimidated by the police for writing articles on daily developments in Kashmir.

The controlling officers immediately release the funds to the line departments within a period of one week from the date of authorization of funds by the Finance Department.

Paris Police Chief Issues Partial Apology Over CL Final 'Failure'

PARIS: The Paris police chief apologized for and justified the pepper spraying of fans and families amid the chaos that engulfed the Champions League final last month outside the Stade

de France. At a French Senate hearing looking for explanations for the organizational fiasco, Paris police prefect Didier Lallement admitted on Thursday that the evening in the suburb of Saint-Denis was "obviously a failure, because people were being pushed around or assaulted while we owed them safety.

"It's also a failure because our country's image ... was shattered."

However, Lallement maintained the police were responding to the presence of tens of thousands of supporters without tickets or with forged tickets, not in the immediate vicinity of the stadium but close to the main points of access to the venue.

"We made sure that the game was held and, most importantly, that there were no serious injuries and no deaths," Lallement

Taking full responsibility for the events, he acknowledged he did not anticipate the "massive use" of fake tickets, adding the only option at his disposal to make sure people did not get

"Perhaps I was wrong," he said. "Whether there were 40,000, 30,000 or 20,000, it didn't change the fact that there were tens of thousands of people who could not fit in." According to the French Football Federation (FFF), 110,000 people travelled to the Stade de France, which has a capacity of 75,000.

UEFA has already started gathering evidence about issues that marred one of the world's biggest games in sports. Real Madrid won the final beating Liverpool 1-0.

Florence Hardouin, the FFF director general, told senators that most of the fake tickets were found in the Liverpool fans' sector. She said all of the 20.000 tickets allocated to the Reds' supporters were in print - rather than digital - which made forgery easier.

Hardouin added that "on average, 57 fake tickets were scanned every five minutes" from 6 p.m. to 9:35 p.m. She said 66% of these 2,471 forged tickets were scanned at gates in the sec-
