# White Teeth Does Not Mean Good Teeth

hite teeth are the best teeth, or so we're led to believe. Discolouration is the devil, as is wonkiness, but a little character in your jaw can be forgiven provided your teeth are still bone white.

This belief – the whiter, the better – is delivered in many ways. Though teeth whitening has been part of human history for centuries, the practice was really cemented with the accidental discovery of the bleaching effects of Gly-Oxide (an antiseptic oral cleanser) in the 20th century and played a key part in the development of cosmetic dentistry. White teeth came to be another signifier of beauty and effortlessness, with desirable looks varying from 'so natural, they just look lucky' to the American preference for a blinding white, Hollywood smile. Veneers and whitening were originally out of reach for the majority of us but innovations in the industry and increased exposure through social media have made cosmetic dentistry more accessible - and more visible – to 'normal people'. For us Brits, there is also the impulse to reject the still-pervasive myth that our teeth are inherently 'bad' (compared to other nations) and therefore we should fix them.

It's no surprise, then, that teeth whitening in particular, and cosmetic dentistry in general, is booming. According to a 2020 survey, 22% of people (including 40% of 18 to 24-year-olds) said they would probably whiten their teeth and 10% said that they definitely would or already had. As with other cosmetic industries, the pandemic has prompted more people than ever to seek out straightening and whitening as part of the so-called 'Zoom boom'. Now, British people are eclipsed only by Americans in how much we search for 'teeth whitening' annually.

Healthy teeth, and access to proper dental care and hygiene, should be a right and not a privilege. Unfortunately this isn't the world we live in. Even in countries that have otherwise socialised medicine, like the UK and Canada, dental care is separate from general healthcare and has to be paid for in some capacity. This creates a society where access to dental care is determined by class and your



financial situation. In the UK, people from deprived backgrounds are twice as likely to be hospitalised for dental work that could have been caught by routine checkups.

Teeth don't have to be white to be healthy. As is often the case, what we now believe to signify health in people is actually an aesthetic preference (such as the constantly shifting but always slim definition of a 'healthy' body type). Treating tooth whiteness as a primary indicator of health encourages people to spend large sums of money on sometimes dangerous whitening procedures while ignoring basic dental hygiene.

If you're talking about healthy teeth you need to look for a few basic things, according to Dr Sahil Patel, dentist and founder of Marylebone Smile Clinic. You want an absence of decay, healthy gums, absence of illnesses that can affect your oral health (like oral cancer) and to monitor the wear on your teeth. You counteract these with proper daily cleaning (including regular flossing), finding ways to lessen or manage any grinding, and regular dental checkups to catch any sign of decay or disease before it gets worse. Even though the shade of the tooth isn't an

explicit part of that list, Dr Patel says there's a reason we see whiter teeth as healthier. 'White teeth show that you might be cleaning your teeth, and research shows that it has a measurable effect on how likely you are to want to work with that person, be friends or even be in a relationship with that person. As unfortunate as it may be, humans are social animals so we seem to unconsciously extrapolate from the first impression and that tends to be from a visual perspective of what the teeth look like, in addition to other aspects of the face.'

It is important to note that teeth staining can be a sign of disease or neglect. Dr Aneka Khaira, cosmetic dentist and founder of Vogue Dental, explains that staining is usually lifestyle- and dietary-related, and can be defined by two categories: intrinsic or extrinsic staining. "Intrinsic staining is internal within dental tooth tissue and can be due to trauma and pulpitis [when your dental gum becomes inflamed]. Extrinsic stains usually result from accumulation of [staining substances] which build up on the external tooth surfaces." The latter can come from food or drink, some medications, and habits like smoking.

Extrinsic stains have the potential to at-

tract plaque but they don't inherently. Additionally, staining can result from genetics as well as age, with the whiter enamel (the outer layer of the teeth) wearing away to show the yellower dentine underneath. Without proper oral hygiene and monitoring, this yellowing could indicate potential damage but equally it could be superficial. The important thing is to have a hygienist and dentist regularly examine your teeth to ensure there are no active dental diseases. Dr Khaira adds: "If the tooth surface is clean and the tooth appears darker or more yellow, this isn't necessarily unhealthy. You can have a perfectly healthy tooth as long as you maintain your oral health."

There is a further point to be made here, though. A person's inability to maintain their oral health often doesn't come from 'laziness' but from a lack of access to dentistry, which is a much wider problem. Teeth that show signs of disease or decay, which are obviously unhealthy, are grouped together with all discolouration as 'bad teeth'. And this idea of 'bad teeth' is loaded with class assumptions. Yellow teeth are associated with poverty, laziness and neglect, while gleaming white teeth are associated with health and wealth.

Unlike the various points in history when people would use acids or even urine to bleach their teeth, we understand far more about dentistry nowadays. 'Good teeth' don't have to be pearly white. But the idea persists because of the sale of the Hollywood smile worldwide, made more visible through social media and more accessible through dental innovation. We buy into the idea that big, white smiles are inherently 'good' and so we do what we can to chase that association of wealth, health and discipline.

But it is not a one-time investment. It requires constant maintenance. Even the best whitening will fade over the years, requiring regular top-ups as well as general dental hygiene. And if you have other cosmetic work like caps or veneers, they need additional monitoring and commitment. Once you have chosen to spend money on whitening your teeth, you have to maintain it with constant investment. It is another mark of 'middle class maintenance'. Shortcuts can be ineffective or, worse, dangerous.

## **Air Pollution Reducing** Life Expectancy By 5 Yrs In India: Study

New Delhi- Air pollution is the greatest threat to human health in India and the average Indian resident is set to lose five years of life expectancy if the WHO guidelines are not followed, according to the Energy Policy Institute at the University of

ticulate pollution in has increased by 61.4 cent since 1998, leading further reduction in th erage life expectancy of vears.

The study attributed rise in air pollution in dia to the industrialisa economic development population growth over the last two decades, which have led to a skyrocketing energy demand and fossil fuel use. All of India's 130 crore people live in areas where the annual average particulate pollution level exceeds the WHO guidelines. More than 63 per cent of the population live in areas that exceed the country's own national air quality standard of 40 micrograms per cubic metre. it said. The Indo-Gangetic plains, home to more than 50 crore people or about 40 per cent of the country's population, is the most polluted region in India, with an annual average PM2.5 concentration of 76.2 micrograms per cu-bic metre in 2020. The study said "510 million residents of Indo-Gangetic plains are on track to lose 7.6 years of life expectancy on average if current pollution levels persist. Residents of Lucknow stand to lose 9.5 vears of life expectancy". It said if the WHO norms for PM2.5 pollution are met, life expectancy can go up by 8.2 years in Uttar Pradesh, 7.9 years in Bihar, 5.9 years in West Bengal and 4.8 years in Rajasthan Across the world, 7.4 billion (740 crore) people -- 97.3 per cent of the global population -- live in areas where the PM2.5 level exceeds the WHO's new, stronger guidelines. South Asia stands to lose the most in terms of life expectancy. India, Pakistan, Bangladesh and Nepal -- where nearly a quarter of the global population lives -- remain among the top five most-polluted countries in the world. South Asia accounts for more than half (52 per cent) of the expected lost life years globally due to high pollution.

Chicago's (EPIC) Air Ouality Life Index (AQLI) released on Tuesday.

The residents of Delhi, the most polluted mega city in the world with the average annual PM2.5 levels exceeding 107 micrograms per cubic metre or more than 21 times the WHO guidelines, stand to lose 10 years of life expectancy if the current air pollution level persists, the report said.

According to the new World Health Organization (WHO) guidelines issued last year, the average annual PM2.5 concentration should be no higher than five micrograms per cubic metre. It was 10 micrograms per cubic metre earlier.

Measured in terms of life expectancy, the AQLI shows that ambient particulate pollution is consistently the world's greatest risk to human health.

Globally, air pollution re-duces 2.2 years of life ex-pectancy, relative to a world that follows the WHO guidelines. This impact on life expectancy is comparable to that of smoking, more than three times that of alcohol use and unsafe water, six times that of HIV/AIDS and 89 times that of conflict and terrorism.

"Of all the countries in the world, India faces the highest health burden of air pollution due to its high particulate pollution concentrations and large population," the report said.

"Since 2013, about 44 per cent of the world's increase in pollution has come from India, where the particulate pollution level has increased from 53 micrograms per cubic metre to 56 micrograms per cubic metre -- roughly 11 times higher than the WHO guidelines," it said. The average annual par-

## 5.1 Magnitude **Quake Hits J&K**

Srinagar: An earthquake measuring 5.1 on the Richter scale hit Jammu and Kashmir on Tuesday afternoon, officials said. They said that an earthquake, with an epicentre at Afghanistan-Tajikistan border was felt at 1.05 pm. Strong tremors were felt. causing panic among people, they said. However, there were no reports of any loss of life or damage to property so far, they further said.

## J&K Logs 18 New Covid Cases

Srinagar: Jammu and Kashmir's COVID-19 tally increased to 4,54,373 on Tuesday as 18 more people tested positive for the viral disease, officials said. The death toll remained unchanged at 4,752, they said. Of the fresh cases, 15 were reported from the Jammu division and three from the Kashmir division, they said. There are 99 active COVID-19 cases in the union territory, while the number of recoveries stands at 4,49,522, the officials said.

## **Electric Shock Kills Minor Boy**

Srinagar: A minor boy died on Tuesday after receiving an electric shock at his home in Mujpathri area of central Kashmir's Budgam district. Six-year-old Uzair Hameed Sheikh, son of Abdul Hameed from Mujpathri received an electric jolt at his home on Tuesday evening, reports said. The minor was soon after removed to sub district hospital where the doctors declared him dead. ### Auqib Javeed Tith Chief Secretary setting the 15-day deadline for Srinagar traffic plan, the man-in-charge has called for the inter-departmental coordination for streamlining the surging vehicular flow in the city.

"There're some engineering bottlenecks which lead to traffic jams in some city pockets but we [Traffic Department] aren't responsible for it as it doesn't come under our domain," Muzaffar Ahmad Shah, SSP Traffic, Srinagar, told Kashmir Observer in an exclusive chat.

"The ease of the traffic department is dependent on othdepartments like Srinagar er Municipal Corporation (SMC), Roads and Building department Power Development (R&B). Department (PDD) and others."



Srinagar, SSP said, is witnessing a massive footfall of tourists which the city has never seen. "The footfall of tourists is exceptional," he said. "Last month, as per official figures, over more 4 lakh tourists visited the city." Under the Smart City Project,

the city traffic chief said, Srinagar Municipal Corporation is making the smart, good-looking and presentable bunkers. "This is being done so that the security is not compromised," he said

interview follows:

The Chief Secretary has asked for a detailed traffic plan in the city within 15 days. What's your preparation and presentation?

Yes, the Chief Secretary has

a specific view of how traffic should ply in the city. To make it more hassle free, we're making some changes. The deployment will be reworked and we will brace up for the upcoming Amarnath Yatra.

But the city is in total traffic mess, people get stuck in jams for hours. Why has the traffic department failed to address the issue?

No, I disagree. It's not a complete mess, as you say. Yes, here're some engineering bottlenecks which lead to traffic jams in some pockets.

## Can you please explain it further?

See, there're many places dotted with potholes. It takes nearly two minutes for the commuters to pass on the patch when it should only take them some seconds. It ultimately leads to traffic jams.

We raised this issue with the concerned R&B (Roads and Building) department, they're looking into it.

#### Are you passing the buck?

No, I'm telling you the ease of the traffic department is dependent on other departments, like Srinagar Municipal Corporation (SMC), R&B, Regional Transport Office (RTO) Power Development Department (PDD) and others.

For example, you can see the hump near Dhar Medicate at Dalgate, which leads to traffic snarls. The R&B department has to clear the bottleneck to ensure smooth traffic.

## **New Nuclear Arms Race**

or the first time since the Cold War, the global nuclear arsenal is expected to grow in the coming years, the Stockholm International Peace Research Institute (SI-PRI) said in its report on Monday. The SIPRI, a leading conflict and armaments think tank, has warned that in the absence of immediate action by the nuclear powers, global inventories of warheads could soon begin rising for the first time in decades. Wilfred Wan, director of SIPRI's Weapons of Mass Destruction Programme, said that all of the nuclear-armed states are increasing or upgrading their arsenals and most are sharpening nuclear rhetoric and the role nuclear weapons play in their military strategies. The report comes in the wake of the invasion of Ukraine by Russia. Russian president Vladimir Putin has already put Russia's nuclear deterrent on high alert. He has also warned of consequences "such as you have never seen in your entire history" for countries that stood in Russia's way. Incidentally, Russia has the world's biggest nuclear arsenal with a total of 5,977 warheads, some 550 more than the United States.

Such a massive stockpile of nuclear weapons poses a great danger to the world at a time when the world is entering a particularly uncertain phase with the US power being challenged by Russia and China. The US which remains the world's No 1 power has sought to take on both the powers. Its GDP and defence expenditure remain several times higher than its nearest competitor China. But in Ukraine, we are at an interesting moment in history. The outcome of the war will determine the new global geopolitics if not the new superpower of the world.

The US has sought to demonstrate that far from being hemmed in by the Russian invasion, it would only further expand its global footprint. It is further encroaching into what China considers its sphere of influence in the east. And in response to Ukraine war, the US has sought to further aggravate the situation by encouraging Finland and Sweden, Russia's neighbours to join NATO. This has created a very fraught geopolitical situation and we can only hope that its end result is not more war. A defeated Russia won't also be in the interest of world peace, nor a China which feels cornered by the US-led west. The world needs resumption of a process of dialogue and re-engagement for a peaceful resolution of its conflicts, which alone will result in a long term peace.



# Indian Economy **Glass Half-Full Or Half-Empty For India?**

fter two years of being buffeted by the Covid pandemic and its fallout, the Indian economy is showing strong signs of resilience. Growth has returned rates above 7% and is expected to continue at this level for the next year or two. India is continuing to pursue the "formalisation" of the economy, and this push is helping some firms that might otherwise have remained stuck in old routines. At the upper end of the economy, the number of highly valued startups-often focused on or enabled by information technology-continues to increase. Foreign firms are bullish on India and the purchasing power of its consumers. The Centre is making progress on divestment, including the landmark sale of Air India and the sale of shares in the Life Insurance Corporation of India. There are signs that corporate balance sheets may be recovering, and this may help the financial sector recover as well. India has returned to being one of the fastest growing economies in

is recovering very robustly overall, with historically low unemployment rates (though labor force participation has fallen, as it has in India). In India, employment growth remains anaemic, with longstanding weakness in employment growth made worse by the recent economic shocks.

India is also more likely to suffer lingering negative impacts on the education of its children and youth, and it is being hurt more by the spike in oil prices. In a nutshell, the structural weaknesses that were hampering India's growth before the pandemic are likely to become more apparent once the initial bounceback from the pandemic has played out. It is not yet clear that India can achieve sustained growth of 7-8% for a decade, which ought to be a minimal goal. What needs to be done in the short and medium term?

vestment in digital infrastructure that goes beyond 5G cellphones is also desperately needed, to provide bandwidth at levels that will permit accelerated and more inclusive growth.

Another area where creative thinking is needed, rather than business as usual, is on the inflation front. The most unequalising aspect of inflation is in the case of food. Yet India has a foodgrain procurement and distribution policy that is dysfunctional, and doing little or nothing to help reduce food inflation. Instead, it has helped create a situation where farmers in states like Punjab are using free or subsidised electricity to pump groundwater to grow rice in a region where it is not optimal. Scarce electric power is being used to fill warehouses faster than they can be emptied, and to turn the area into a desert.

There are other areas where policy rethinking is needed. None of them really have anything to do with the rhetoric of self-reliance. Instead, the guiding principle of economic policymaking in India needs to be making the best use of India's resources, and doing so in an integrated manner. Investing in people means giving them effective access to knowledge, skills and the means of production. Investing in natural resources means reducing their depletion and degradation, as well as replenishing them where possible. everal factors are thought to have contributed to this achievement. Improved health services that prevent and timely treat causes of child mortality — complications during birth, neonatal sepsis, pneumonia. diarrhoea, low birth weight and such — have improved the count. The contribution of community caregivers such as anganwadi workers and Accredited Social Health Activists - these personnel are ignored by the incentive schemes of the government — must be acknowledged. There seems to be a gradual realisation among women about the importance of giving birth in hospitals: the last-mile coverage of hospital care must, therefore, be widened.

But the success has been uneven, as is borne out by the disparity among states: Kerala's IMR in 2020 was 6, while Madhya Pradesh's was 43. Expectedly, the IMR in rural areas is much higher than in urban areas — 31 and 19, respectively. There are other sobering indicators. In South Asia, the IMRs of Sri Lanka, Bangladesh, Nepal and Bhutan are lower than that of India. There is thus a case for India to learn from its smaller neighbours. Sri Lanka's highly effective domiciliary and institutional care system for expectant mothers and children has been a success; Bangladesh has also set a milestone in terms of its public-private partnerships in the healthcare sector. These can be good examples to follow. There is also the need for policy to connect the relevant dots. Improvements in IMR cannot be independent of improvements in other parameters such as malnutrition, maternal mortality ratio, dietary needs, inoculation of children and so on. India should now work on building the momentum that it has achieved in IMR to tackle other, overlapping health challenges. Progress on this front is also contingent upon strides taken in the social, cultural and economic spheres. Issues such as vaccine hesitancy, lingering reservations towards institutional care, unequal access to hospitals on account of gender and caste discrimination and the prohibitive cost of medical treatment demand urgent attention.

cles to economic growth is access to cost-effective, reliable electric power. This sector is one of the relative failures of India's economic reforms. Even now, electric power shortages are being addressed by increasing the use of coal-based generation, which has tremendous negative consequences in the longer run. By contrast, the Rockefeller Foundation is championing the idea of distributed renewable energy systems, using solar power. In India, it has created a subsidiary, Smart Power, which is investing \$75 million in Bihar, Jharkhand and Uttar Pradesh. But this is a drop in the ocean compared to what is needed, and is an obvious example of where public investment can make a difference at the scale and speed that India needs.

Reliable electric power is also a prerequisite for access to the internet, the modern delivery mechanism for knowledge and information of all kinds, including basic education and skill upgrading. In-

As a result, they sign relinquishment deeds without giving a second thought about it. This inheritance of property is mostly seen as a matter of money and wealth, but it goes beyond that, at least for women. Economically speaking, ownership of any kind of property by women is a very important determi-

nant in the quest for women empowerment. In the realist world wherever everyone is responsible for their own survival, women should not expect their male relatives to care for them. Unless women do not attach economical value to their lives, they will have no power. This is especially true for unemployed women who do not have financial independence. Since inheritance of property is a given-however small value it may have, they do not have to get an education or work for getting it. The only thing they need to do is not to sign the relinquishment deed

The right to inheritance also seems one of its kind means to women empowerment where people peddling religiosity may not find a reason to oppose it. # The Indian-American Spelling Bee Winning Spell

or some 11 million primary and middle school children in the United States, it is an annual rite of passage. For perhaps half a million or so children of Indian-origin in America, it is a mantra - a Sanskritic term for a word or sound repeated to aid concentration in meditation.

First held in 1925, the US National Spelling Bee championship has now become something of a yearly fixture in the country's sporting calendar, much like the US Opens in tennis and golf. There are expanding stakes, growing fan following, and wall-towall media coverage. Every year, after preliminary rounds in cities and towns across America, some 200 finalists converge late May on Washington DC, where over two intense days, they duke it out in full glare of live coverage spelling words that are often obscure and seldom heard or used in everyday exchanges. And invariably in recent years, the winner turns out to be an Indian-American kid.

Why children of Indian origin are so into spelling and so good at it to the extent of winning 21 of the last 23 titles (including last week's 2022 championship) has been a subject of op-eds, scholarly studies, academic papers, books, films, and documentaries. Explanations range from disciplined double parenting that is the norm in typically stable Asian families, to their emphasis on rote learning, and familiarity and comfort with the English language - the last underscored by the fact that East Asians (Chinese, Koreans, Japanese) seldom feature in the finals despite similar "tiger" upbringing.

Another understated reason: legacy. Once a country or community tastes success in a particular field or sport, it attracts a following that provides future winners — like Pakistan in squash for the longest time, China in table tennis, Russia in chess, Cuba



in boxing, Hungary in water polo, South Korea in archer, etc.

Shalini Shankar, head of the Asian American Studies Program at Northwestern University, who studied the phenomenon for her book Beeline: What Spelling Bees Reveal about the New American Childhood, reckons Indian-Americans got ahead of the pack by institutionalizing spelling bee as a community event, way back in the 1990s with its own competitions and training methods, paving way for a generation of winners. According to Shankar, the more visibility Indian spellers got with a winning streak that started in 1999, the more interest it generated in the community, producing more winners.

While parents beam with pride and pleasure at their children cracking absurdly difficult/rare/incomprehensible words, there has also been a furious debate about the usefulness of it all – what's the point in learning words that one will never use in daily life? Critics have derided the contest as a test of useless rote learning, and for the kind of pressure it puts on the kids. One year, a participant fainted on stage from tension and exhaustion. Counselors are on hand to manage meltdowns and breakdowns. But overall, it is the school kids themselves who seem to enjoy going through pedagogical hell. For the joy of the challenge? Bragging rights? Peer pressure? Who knows? Winning words in recent years include aiguillette (the metal tip of a lace tag), koinonia (a Greek-origin word for fellowship or joint participation), scherenschnitte (Germanorigin word for scissor cuts in paper design), and Laodicean (half-hearted or apathetic, especially with regards to religion or politics).

Past champions – all of whom seem to have done quite brilliantly in their careers – say it has helped them stay disciplined, stay focused, and broadly improved their knowledge and outlook. James Maguire, who tracked years of spellers for his book, American Bee: The National Spelling Bee and the Culture of Word Nerds, found that the winners carried their confidence into their future careers.

Balu Natarajan, who was the first Indian-American to win the title in 1985, and went on to become a sports medicine physician, says winning the title showed him that you can be an immigrant in America and win a competition about the English language. Raga Ramachandran, who won the title in 1988, went on to become a professor of pathology at the University of California in San Francisco. And Nupur Lala, whose victory in 1999 began the cascade of a score of Indian winners over the next two decades, and who was featured in the film documentary Spellbound, went on to study cognitive science and language processing. One past winner, 2002 champion Pratyush Buddiga even went on to become a professional poker player, explaining that he missed the competitive milieu of his spelling days.

The spelling bee success of Indian-American kids and the outsized coverage it receives obscures the broader success of the community in almost every sphere of life in America. Their winning ways are seen in a range of school and college competitions. Going forward, from medicine and industry to academia to industry to business, Indians in America are punching way above the one per cent they constitute of the US population. Tasting the nectar of success seems to begin in contests like the Bee.

**New Delhi:** Congress leader Rahul Gandhi was questioned for over eight hours by the Enforcement Directorate for the second consecutive day on Tuesday in the National Herald money-laundering case, while the opposition party continued its protests and sparred with the BJP, accusing it of vendetta politics.

Gandhi, 51, who was quizzed for over 10 hours on Monday, arrived at the ED headquarters on APJ Abdul Kalam Road in central Delhi accompanied by his sister and Congress general secretary Priyanka Gandhi Vadra and his questioning began at 11:30 am. After a session of about four

hours, Gandhi took a break for about an hour at around 3:30 pm and went home. He rejoined the questioning around 4:30 pm and was still at the ED office at 8.30 pm. The former Congress presi-

The former Congress president had left the federal agency's office at 11.10 pm on Monday after being questioned over multiple sessions and recording his statement under the Prevention of Money Laundering Act (PMLA).

Earlier in the day, Gandhi joined senior party leaders at a "dharna" at the Congress headquarters, where the chief ministers of Rajasthan and Chhattisgarh, Ashok Gehlot and Bhupesh Baghel, Priyanka Gandhi Vadra and party MPs interests of his "cronies".

"This entire exercise is illegal, unconstitutional, malicious and an exercise by a prime minister burning in the fire of political vendetta," Surjewala told a press conference here.

The Congress had alleged that its leaders were manhandled by police during Monday' protest as they tried to walk to the ED office. All approach roads leading to the agency office were made out of bounds on Tuesday for the public as prohibitory orders were imposed and barricades put up. A large posse of police per-

A large posse of police personnel including from the central anti-riot police force RAF and Central Reserve Police Force (CRPF) were deployed.

#### But how're you dealing with the surging volume of vehicles in the city?

See, the fact is Srinagar is witnessing a massive footfall of tourists. This tourist number is exceptional. Last month, as per official figures, over 4 lakh tourists visited the city. Srinagar has never witnessed this amount of traffic and isn't used to this kind of vehicular footfall.

There's also a dearth of infrastructure in place. Parking spaces remain full, forcing people to park their vehicles on the road leading to congestion. For pedestrians near the city center, there're four bridges but for vehicles there's only one bridge. Number of cars is increasing by the day. You've to have bridges across Jhelum for vehicles to cross to the other side of the river.

Plus, many unknown vehicles coming from other states are daily adding to the strain in the city. And don't forget that Srinagar also receives a good number of vehicles from other districts.

So, you need to understand the roads are the same, the vehicles are increased manifold. There're 23 lakh registered vehicles in J&K. A huge number of vehicles have been purchased from Delhi, Chandigarh, Punjab and other states and they are not-registered. I estimate the number of vehicles plying on the city roads to be around six lakh.

Notably, two minor boys fell prey to wild animal(s) in two incidents in last few days at Cholan Kalsi Ghati and Trikanjan Boniyar areas respectively. Meanwhile inhabitants of Boniyar blocked Srinagar-Muzaffarabad road for several hours after the girl was mauled to death by the wild beast.

Reports said that the family of the victim accompanied by locals kept the corpse on the highway outside Tehsil headquarters for several hours. The protestors shouted slogans against the Wildlife Department and civil administration for their alleged failure to contain the incidents in the area. "The authorities are not taking any strong steps to tackle the issue which unfortunately has led to back-to-back killings", a protestor said.

Likewise, while SMC needs to free the footpaths from vendors, PDD needs to remove electric poles in the middle of roads for smooth traffic flow.

In short, all the departments need to chip-in to help our department to ease the traffic mess. But sadly, it's our department which is being blamed for everything. People need to understand the whole scenario as well as actively participate in ensuring the smooth flow. Public welfare demands public participation.

## Did the traffic department take-up the issue with the government?

Yes, we've done it already.

But then, people complain that the surge in pickets and checkpoints in the city adds to traffic mess. In many places, vehicles need to slow down to navigate the curves on barricades. How is the department dealing with it?

I can't comment on that, but under the Smart City Project, SMC is making smart, good-looking

## But you aren't talking about the solution to this mess.

Look, when I took over the traffic management of Srinagar, we started a massive drive against the un-registered vehicles. In these five months, we filed over 1.25 lakh challans for wrong parking in the last five months. This is being done to deter people from creating traffic jams.

We implemented the order of Honourable High Court and banned commercial cabs to enter the city at Panthachowk and Parimpora Mandi. That saved us a lot of space. We tried to decongest the city by barring unwanted vehicles.

Also, we've stopped the unnecessary storage of commercial vehicles. We called heads of Tata minibuses and other cab operators and counselled them regarding the issue. We even filed 15,000 challans against Tata minibuses for obstructing traffic.

We also shifted to e-challan, which is proving very helpful for us in fining the people for wrong parking. We've 40 machines and it's done in a matter of seconds.

But the ideal situation for me will be less challans. It means least traffic violations. We're trying to change the mindset of people. But it won't happen overnight. It'll take some time.

We will also seize vehicles without Highsecurity registration plates (HSRP) after 15 June. It will help us in decongesting the city from the un-registered vehicles.

People coming from North Kashmir and Central Kashmir have a lot of complaints regarding traffic jams near Shalteng, Parmipora, Qamarwari and Bemina-Bypass. Although we have witnessed new diversions and rerouting of traffic on longer routes to manage the traffic flow, it has created new bottlenecks. Your response?

The government is constructing grade separators in these areas. In the phase–I, the work on grade separation is underway at Nowgam Chowk, Lasjan By-pass and Bemina Chowk.

In the phase -II, the government is likely to cover other junctions.

People also complain that the traffic signals aren't working in the city. Why is it so?

There're some technical issues in some places that are being addressed.

## Australia Beats Peru To **Qualify For World Cup**

AL RAYYAN (Qatar): Australia qualified for a fifth straight World Cup after in their intercontinental playoff on Monday.
