Jammu: Jammu and Kashmir administration on Friday sacked nine government employees, including five officers, on corruption charges.

All the employees have been sacked under 226(2) Article of Jammu and Kashmir Civil Service Regulations which allows the administration to retire government employees at any time after completing 22 years of service or attaining the age of 48 years, an official said.

They all belonged to the housing and urban development department.

The charges against the sacked officials were confirmed by the departmental committees and upheld by the designated review committee under article 226(2), including misappropriation of funds, falsification of records and raising fake bills and allowing illegal constructions, and making illegal appointments," the official said.

Despite Govt Grants, Royal Springs Golf Course Running in Losses

Srinagar: Kashmir's wellknown Royal Springs Golf Course (RSGC) is running in huge loss despite government grants supporting its expenditure.

As per the data provided by the Public Relation Officer (PIO) of RSGC, Srinagar, through a Right to Information (RTI) filed by Srinagar-based lawyer, Badrud Duja, the club hasn't earned any profit since 2010.

"In the last twelve years the club has spent Rs. 8874.66 lakhs as expenditure and earned only Rs. 1321.83 lakhs



in return," the data revealed. The RSGC is a decorated amount of Rs. 7 lakh as golf course on the foothills one time membership fee of Zabarwan in Srinagar. and Rs. 600 as monthly To apply for the mem-

subscription. While a govbership, a non-government ernment employee has to pay just Rs. 2 lakh for the membership and Rs. 1200 as monthly subscription.

Currently, the club has over 700 member subscriptions, majority of them are from the government sector. In the year 2010-2011, the data reveals, the club only earned Rs. 64.35 lakhs against the expenditure of Rs. 620.33 lakhs.

During 2011-12, against the expenditure of Rs. 545.82 lakh, the club could

only earn Rs. 69.37 lakhs. In 2012-13, the club earned Rs 109.44 against a spent amount of Rs. 576.47 lakhs. Similarly, the | More on P10

How Netflix-Style Algorithm May Help In **Personalising Cancer Treatments**

Just as Netflix algorithm generates data to determine the shows one can choose to binge watch next, doctors will soon be able to predict how tumours can behave and thus offer personalised cancer treatments.

A typical Netflix-style algorithm analyses data on how frequently a type of programme or film is watched, and whether it's liked or not. Based on the data, new films and TV series are recommended next time.

An international team of researchers from the University College London (UCL) in the UK and University of California, San Diego (UC San Diego) in the US have built a similar algorithm that can one day enable doctors to look at a patient's fully sequenced tumour and customise

their treatment, the Independent reported. The study, published in the journal Nature, showed that the algorithm deployed Artificial Intelligence (AI) to follow the changes to DNA from the time a cancer starts to how it grows. The team believes the insights into the genetic traits that the tumour picks up as it grows, will help doctors understand how a cancer is likely to behave.

"Just as Netflix can predict which shows you'll choose to binge watch next, we believe that we will be able to predict how your cancer is likely to behave, based on the changes its genome has previously experienced," Dr Ludmil Alexandrov, UC San Diego, was quoted as saying.

"Armed with that information, we believe that doctors will be able to offer better and more personalised cancer treatment in the



future," he added.

The new algorithm can sift through thousands of lines of genomic data and pick out common patterns in how the chromosomes organise and arrange themselves. It can then categorise the patterns that emerge and help scientists establish the types of faults that can occur in cancer, the team explained.

Using the algorithm, the team looked for patterns in the fully sequenced genomes from 9,873 patients with 33 different types of cancer and identified 21 common faults. These will now be used to create a blueprint researchers can use to assess how aggressive the cancer will be, find its weak spots and design new treatments for it. Of the 21 signatures identified by the algorithm, the scientists found that tumours where the chromosomes have shattered and reformed were associated with the worst survival outcomes. "To stay one step ahead of cancer, we need to anticipate how it adapts and changes. We've been missing the bigger picture of how vast swathes of genes can be copied, moved around or deleted without catastrophic consequences for the tumour," said Dr Nischalan Pillay from the UCL.

No Need To Panic Over **Rise In Covid Cases: DAK**

Observer News Srinagar

Srinagar: With the rise of Covid-19 cases in Kashmir valley over the last few days, Doctors Association Kashmir (DAK) on Friday said there is no need to panic.

"There is no increase in hospitalization, so the rise in cases should not be a cause of worry" said DAK President and influenza expert Dr Nisar ul Hassan.

Dr Hassan said case counts have lost relevance; hospitalization numbers are now reliable markers when it comes to assessing the threat from pandemic.

Daily case count was used as a barometer early in the pandemic because that time a rise in cases inevitably led to increase in hospitalizations.

"But that has changed now," he said. "With most being im-

mune either by way of vacci-

nation or natural immunity, even with a large number of infections we see miniscule numbers in hospitals.³

The DAK President said if we continue to highlight only the increase in cases, we run the risk of causing unnecessary public panic.

"The thinking around the pandemic and how we characterize and measure it needs to change," he said. "Covid-19 has entered into the endemic stage and the rise and fall in cases is going to be a routine

process," Dr Nisar said. "What we are seeing in terms of a spike in Covid cases is on expected lines," he said adding the current surge is not a wave but an endemic spike and we expect these fluctuations in future too.

"People need to learn to live with Covid-19 as the virus is going to stay with us." said General Secretary DAK Dr Arshad Ali.



New Terminal At Srinagar Airport To Increase Passenger Capacity To 6.5 Million

Srinagar: Authorities at Srinagar Airport are planning to increase the passenger area by around threefold to increase passenger capacity to 6.5 million. Top officials at Srinagar Air-

n Iranian court has found the US administration and doz-Lens of American institutions and officials guilty of supporting the Israeli regime's targeted assassinations of Iranian nuclear scientists, ordering Washington to pay \$4.3 billion in compensation.

Families of three martyred nuclear scientists, along with a wounded nuclear scientist and wives of three nuclear scientists who sustained injuries themselves in terror attacks on their husbands had filed a lawsuit with a Tehran court against the US government, institutions and authorities that were in office at the time of Israeli terror acts.

The crimes in question inflicted physical, psychological and financial damages on the families of the victims.

The US was ordered by the court to pay \$4.3 billion in total compensation, including fines.

The lawsuit, the court said, was aimed at countering violations of international obligations and instances of hostile behavior on the international stage through supporting Israel's acts of terrorism.

Those convicted are 37 American natural and legal persons, including former presidents Barack Obama and Donald Trump, former Secretary of State Mike Pompeo, former Iran envoy Brian Hook and former Defense Secretary Ashton Carter.

The verdict cited evidence of Israeli involvement in the assassinations and the US financial and military support for the regime, saying Washington have had an "effective" role in estab-

'Complex Multipolar World With No Regard To Rules Now': Air Force Chief

New Delhi: The global order is being increasingly challenged with little or no regard to rules and India must reassess its strategic priorities and realign its actions to ensure that it is not left behind, Air Chief Marshal VR Chaudhari said on Friday. Listing various national secu-

rity challenges, the Chief of Air Staff also said military strategists must not lose sight of the primary objective of "war-fighting". Air Chief Marshal Chaudhari's

comments at a seminar came in the backdrop of India's lingering border row with China in eastern Ladakh, the situation in Afghanistan and the geopolitical upheavals triggered by the crisis in Ukraine.

Without naming any country, he said "coercion" is the new strategy with cyber, information and space domains becoming the 'new battlefield". "Today, we are witnessing a

rapidly evolving international order that is increasingly being challenged by a complex multipolar world with little or no regard to rules or to the traditional processes of geopolitical interplays," he said.

The Air Chief Marshal said diplomacy, economy and information are becoming the "primary tools" of engagement with the military instrument being used as a deterrent. "Coercion is the new strategy with cyber, information and



space domains becoming the new battlefield. Therefore, we must reassess our strategic priorities and realign our actions to ensure we don't get left behind," he said.

The seminar marked the culmination of the first 'Warfare and Aerospace Strategy Programme' (WASP), which was conducted by the Indian Air Force. The WASP was rolled out with an aim to generate strategic thought and understanding amongst the midcareer air power practitioners.

The Chief of Air Staff hoped that the programme will enable officers to understand the whole-of-government approach and generate independent opinions in dealing with national security issues.

"We believe that such crosspollination of ideas from multiple disciplines can lead to critical thinking which allows a person to formulate solutions as well as

take more rational and effective decisions," he said.

"At the same time, a military strategist must not lose sight of the primary objective and that is war fighting. Hence our focus should remain on operational level critical thinking and strategy while developing a deeper understanding of the art and science of war fighting," he added.

Air Chief Marshal Chaudhary told the participants of the programme that a well-crafted strategy may not guarantee success in dealing with security challenges, but the absence of a coherent and sustainable strategy will surely lead to failure.

The discussions revolved around assessing the role of air power in the ongoing Ukraine conflict and revisiting the doctrinal and strategic precepts about India's air power capability.

Americans Have Right To Carry Guns In Public: US Supreme Court

Washington: The US Supreme Court ruled on Thursday that Americans have a fundamental right to carry a handgun in public, a landmark decision with farreaching implications for states and cities across the country struggling with a surge in gun violence.

The 6-3 decision strikes down a more than century-old New York law that required a person to prove they had a legitimate self-defense need, or "proper cause," to receive a permit to car-ry a handgun outside the home.

Several other states, including California, have similar laws -- and the court's ruling will curb their ability to restrict people from carrying guns in pul

Turkey, Israel Agree To Restore Ties To **Ambassadorial Level**

ANKARA: Turkey and Israel have begun work on restoring their mutual diplomatic representation to ambassador level, Turkish Foreign Minister Mevlut Cavusoglu said on Thursday as the two countries seek an end to more than a decade of strained ties.

The two countries expelled ambassadors in 2018 and have often traded barbs over the Israeli-Palestinian conflict. Energy has emerged as a key area for potential cooperation as they strive to mend their relations.

"We will continue the high-level mutual visits in the short term," Cavusoglu said at a joint news conference with his Israeli counterpart Yair Lapid. "We have launched work on raising our diplomatic representation to ambassador level."

Lapid was visiting Ankara after months of warming ties but amid worries voiced by Israel that its citizens could come under attack by Iranian agents in Turkey, a Nato member state.

Cavusoglu said he and Lapid were in close contact regarding threats to Israeli citizens. Lapid thanked Turkey for helping foil a suspected Iranian plot to harm Israelis in Istanbul and said the effort was still underway.

Israel has warned its citizens against travel to Turkey, citing suspected assassination or abduction plots by Iran, which has vowed to avenge the May 22 assassination of a Revolutionary Guards colonel in Tehran that it blamed on Israeli agents.

"In recent weeks, the lives of Israeli citizens have been saved thanks to security and diplomatic cooperation between Israel and Turkey," Lapid said. "We are confident that Turkey knows

how to respond to the Iranians on this matter." Cavusoglu visited Israel last month to encourage expanded economic cooperation. It was the first such visit by a senior Turkish official in 15 years.

Through the years of acrimony, Turkey and Israel have maintained trade, which stood at \$6.7 billion in 2021, up from \$5 billion in 2019 and 2020, according to official data.

Lapid is set to take over from Prime Minister Naftali Bennett at the head of a caretaker government, after he and Bennett acted on Monday to dissolve parliament and hold an early national election. Turkey has detained eight people allegedly working for an Iranian intelligence cell that planned to assassinate Israeli tourists in Istanbul, local media reported on Thursday.

The eight, who were not all Iranian nationals, were detained in a raid last week in three houses in Istanbul's popular Beyoglu district, the private IHA news agency reported.

Israel last week urged its citizens to leave Turkey immediately because of "possible" threats from Iranian operatives.

Iran and Israel have been engaged in a years-long shadow war but tensions have ratcheted up following a string of highprofile incidents Tehran has blamed on Israel.

The Islamic republic claimed Israel was responsible for the killing of Revolutionary Guards Colonel Sayyad Khodai in his Tehran home on May 22.

IHA said Iran sent agents disguised as businessmen, tourists and students to Istanbul to assassinate Israelis in retaliation for Khodai's murder and other attacks.

The Supreme Court on Friday dismissed a plea of Zakia Jafri, the wife of slain MP Ehsan Jafri, challenging the Special Investigation Team's (SIT) clean chit to 64 people, including then Chief Minister Narendra Modi, in the 2002 Gujarat riots case.

A bench headed by Justice A M Khanwilkar upheld the Special Metropolitan Magistrate's order rejecting Jafri's protest petition against the closure report filed by the SIT. The top court upheld the Gu-

jarat High Court order and said Jafri's plea is devoid of merit. Ehsan Jafri was among the 68

people killed in Gulberg Society in Ahmedabad on February 28, 2002, a day after a coach of the Sabarmati Express was burnt at Godhra killing 59 people and triggering riots in Gujarat.

Democratic President loe Biden denounced the decision, saying it "contradicts both common sense and the Constitution, and should deeply trouble us all."

"We must do more as a society --not less -- to protect our fellow Americans," Biden said. "I call on Americans across the country to make their voices heard on gun safety."

Despite a growing call for limits on firearms after two horrific mass shootings in May, the court sided with advocates who said the US Constitution guarantees the right to own and carry guns. The ruling is the first by the court in a major Second Amend-

ment case in over a decade, when it ruled in 2008 that Americans have a right to keep a gun at home for self-defense. It was a stunning victory for the

"Today's ruling is win for good men and women all across America and is the result of a decades-long fight the NRA has led," NRA executive vice president Wayne LaPierre said in a statement.

"The right to self-defense and to defend your family and loved ones should not end at your home."

New York Governor Kathy Hochul called it a "dark day," while California's leader Gavin Newsom termed the decision "shameful."

"It is outrageous that at a moment of national reckoning on gun violence, the Supreme Court has recklessly struck down a New York law that limits those who can carry concealed weapons," Hochul said.

"This is a dangerous decision from a court hell bent on pushing a radical ideological agenda and infringing on the rights of states to protect our citizens from being

Thomas said the New York law prevents "law-abiding citizens with ordinary self-defense needs from exercising their Second Amendment right to keep and bear arms in public for self-defense."

"We conclude that the State's licensing regime violates the Constitution." Thomas said.

The ruling comes as the US Senate is considering a rare bipartisan bill that includes modest gun control measures.

Democratic Senator Dick Durbin said the ruling "makes it all the more important for Congress to take actionable steps to protect our kids and communities from this nation's gun violence epidemic.

Chinese City Loses "Civilised" Status After Women Thrashed In Restaurant

Beijing: After a group of men assaulted four women outside a restaurant in China recently, the Tangshan city has been stripped of its honorary "civilized" status. The assault on the women had sparked public outrage with many demanding justice.

Footage from the barbecue restaurant's cameras on June 10 showed a man slapping and dragging a woman to the street by her hair after she appeared to reject his advances. Other men then joined in, assaulting her female companions and leaving two women sprawled on the side of the street.

Two of the women remain hospitalised in the Intensive Care Unit (ICU), officials said this week, while authorities said they had arrested nine people involved in the attack.

The incident, which was caught on CCTV cameras, also renewed a national discussion on violence



against women in China.

A hashtag on social media site Weibo started doing rounds after the incident in Tangshan in northern Hebei province. Soon after it grabbed the attention of the users, reported NBC News.

The video has been viewed hundreds of millions times. Hundreds of

thousands of people commented after videos of the attack were posted online with many of them demanding action against the accused.

The Civilization Office of the Central Communist Party Committee on Wednesday removed the city from the nation's honorary list of "civilised cities."

UN Says Aljazeera Journalist Abu Akleh Killed by Israel

he Office of the UN High Commissioner for Human Rights (OHCHR) says its findings have shown the bullets that killed veteran Palestinian journalist Shireen Abu Akleh last month were fired by Israeli forces.

"We find that the shots that killed Abu Akleh came from Israeli security forces," OHCHR's spokeswoman Ravina Shamdasani told reporters in Geneva on Friday.

"It is deeply disturbing that Israeli authorities have not conducted a criminal investigation. We at the UN Human Rights Office have concluded our independent monitoring into the incident. The shots that killed Abu Akleh and injured her colleague Ali Sammoudi came from Israeli security forces and not from indiscriminate firing by armed Palestinians, as initially claimed by Israeli authorities," Shamdasani added.

Stressing that the information came from the Israeli military and the OHCHR's spokeswoman said, "We have found no information suggesting that there was activity by armed Palestinians in the immediate vicinity of the journalists." Providing further details on the incident, Shamdasani said the OHCHR's investigation had found that Abu Akleh and her fellow

In video footage from the incident circulated widely online, Abu Akleh could be seen wearing a blue flak jacket marked with the word "PRESS" when being shot by Israeli troops, exposing the gruesome nature of the daylight murder.

People Of J&K Hail New Land Laws As Major Step Towards Development, Progress: Govt

SRINAGAR: The new land laws are being hailed by the people of Jammu and Kashmir as a major step towards development and progress of J&K, an official spokesperson said Thursday.

He said that the historic initiative of the government will revamp agriculture and allied sectors besides ensuring holistic development of all sectors.

He said that the Ministry of Home Affairs, through an order on October 26, introduced amendments to 14 laws of the erstwhile state of Jammu and Kashmir and repealed 12 others. Key amendments were made to four major state laws that

governed the ownership, sale, and purchase of land in the erstwhile state, like the J&K Development Act, 1970, The J&K Land Revenue Act, 1996, The Agrarian Reforms Act, 1976 and The J&K Land Grants Act, 1960.

"While progressive provisions of the repealed laws have been retained by including them in the modified Land Revenue Act, new provisions have been added to modernize existing laws. There are provisions for setting up of a Board of Revenue, Regional planning for regulating the use of land, alienation and conversion, land lease, consolidation and Contract Farming," he added

According to the spokesperson,

the Board of Revenue comprising senior officers will not only be the Developing Authority for preparing regional plans but can notify a scheme of consolidation of landholdings and also a scheme for restricting and regulating the fragmentation of agricultural landholdings to make agriculture viable.

He said that the designation of land for industrial purposes will open up greater employment avenues for the youth who have always yearned for industrial revolution in J&K so that they can get better employment opportunities.

Recently, Jammu and Kashmir government signed 39 Memoranda of Understanding (MOUs) with the National Real Estate Development Council to boost employment and per capita income.

"The NAREDCO will train 10,000 workers in various skills of the construction industry, electrical, plumbing, masonry, carpentry and the likes," the Lieutenant Governor said, during the MoU signing event. He said, "To facilitate transparent and accountable framework in the real estate sector, we have launched many portals - RERA portal, housing portal, integrated auction portal and these initiatives will help both developers and home buyers as one-stop portal for all their needs." Sinha said there were people who did not want Jammu and Kashmir to develop at par with other parts of India. "They want

industries without giving land for it and development without investments. But we will break all walls that will come in the way of Jammu and Kashmir," the Lieutenant Governor said.

Union Minister for Housing and Urban Affairs, Hardeep Singh Puri during the real estate summit said, "a large-scale infrastructure development, denied to the people of Jammu and Kashmir earlier, is now possible". "By combining rich natural resources with external investment and technical expertise, the citizens of Jammu and Kashmir will now have access to a higher quality of life", he added.

As a major initiative towards good governance and ease of convenience to the citizens, the Revenue Department started issuance of trilingual Land Passbooks in Hindi, Urdu and English to the landholders with effect from 19th of February 2022 from the districts of Jammu and Srinagar.

The land passbooks are being issued to every landholder which contain sentry from the Jamabandi in revenue estate so as to enable him to make its use for credit facilities and for other matters connected therewith or incidental thereto. The land passbook prescribed by the Revenue Department is true to the record and can be generated online by landholders without visiting a Patwari or Tehsildar or any Revenue office.

www.ernment's half-yearly sojourn in the summer capital, the somewhat pretentious officialdom, politicos included, of the state is all set to take its soothing ministrations to the more conducive climes of Jammu in a seemingly endless repetition of an ante-diluvian practice. Obviously, the chill descending this side of the Pir Pantsal range freezes the creative and innovative currents within our masters, and they need warmer air to keep their beneficent and benevolent souls going.

Jammu and Kashmir has the distinction of being the only state with two capitals with the government migrating between them after every six months. In between, it helps itself with a neat 10-day break as if after a `tiresome' performance in either region even as the drain on public exchequer in the shape of inconsequential touring and resultant expenses on petrol and allowances goes on without any respite. In fact, some kind of a `seasonal' inertia sets in throughout the move offices about a month earlier as the officials begin packing up for the bi-annual trek up and down the highway. The files and records of various move offices are a mute witness to the common refrain during these days: "put up after durbar move." Thus, by any calculation, the state government remains in a comma for about a month in every six months. It hardly matters if by the same token the government gives an emphatic lie to its own claim of being "a government that works every day". In the process, the near-empty state exchequer is made to cough up a few crores of borrowed money to sustain a patently primitive tradition of `durbar move' the erstwhile Oogra ruler, Maharaja Ranbir Singh, had initiated 133 years ago, in 1872 Remember, in the eighties, the then happy-go-lucky chief minister, Dr Farooq Abdullah, had taken a bold decision to dispense with the time-consuming and expensive practice only to spark off massive protests in the winter capital which forced him to lick the dust by withdrawing the order. Apparently, the main argument put forth to retain the practice is that it promotes emotional integration between the Muslimdominated Kashmir region and Jammu having a substantial Hindu population. Partly, it also contributes a great deal in boosting trade and commerce in Jammu region. Over the decades, however, both the pleas have become almost totally irrelevant. The emotional integration between Kashmir and Jammu is just a farce as the two regions are not always on the same wave length in respect of quite some crucial issues. The rise and groundswell of regional groups like the Jammu State Morcha has left nobody in doubt that the disturbingly saffronised regional and separatist sentiments are eating into the shrinking secular base, particularly in the two and a half districts of Jammu, Kathua and Udhampur. The growing influence of the RSS and its Hindutva outfits like the Shiv Sena and Bajrang Dal is no music for Kashmiris and certainly cannot even tolerate, leave alone nourish, any emotional bonds between the two regions. It is an open secret the RSS has been organizing regular shakhas in certain areas while the Bajrang Dal distributes trishuls to militarize the Hindu mind against Muslims. It is no wonder that the Congress and the National Conference, who have lost no opportunity in making a travesty of their secular credentials at the regional and the national levels for the petty profits of power, should hold on to a tenuous artifice, a fig leaf, rather, to flaunt a virtue both have sacrificed time and again for the spoils of office. So, sensing themselves lacking in moral authority in deciding an issue on hard practical sense, they try to compensate by keeping up appearances. As both are deeply compromised in dealing body blows to the foundations of the nation's philosophy, they have no other option but to keep up outdated notions to avoid having to grapple with hard facts. Otherwise also, the half-yearly migration of the government out of the problem zones affects its performance rather adversely leaving the deserted areas' people high and dry. The sooner the practice is abandoned, the better it would be for the entire state and its people. Indeed, in an era when the entire world has been reduced to a global village, the government can evolve a mechanism through which to administer the state quite effectively and efficiently without having to move between two capitals. It goes without saying that most ministers and top functionaries even otherwise keep routinely flying between the two capitals regardless of where the seat of power happens to be.

Should Climate Change Concern Muslims?

ave you ever contrasted the sparkling waters of Dal and other water bodies, as seen in pictures from the past, with their present day murky state? Have you ever contemplated the reasons behind this catastrophic and unhealthy change? And for that matter are you observing the change of pattern in our forest cover, conversion of eco-sensitive belts into industrial and residential areas? The emerging repercussions, as they manifest in calamities like extreme weather conditions, shifting of climatic belts and abnormal temperature deviation. must have caught your attention. While these things are happening locally, scientists warn us of much severe climatic concerns that await us and the recurrence of Ice Ages, which wiped out many species from the surface of Earth in its early history may again be around the corner and in one sweep on climatic catastrophe an overwhelming diversity of species may be erased from the planet. Almost every hour, a news item or a research article hits the internet that is directly linked to the environmental change and the consequences thereof - such is the gravity of the issue

What has been our response to these changes which can threaten our survival, safety and existence? The severity and seriousness may not have dawned upon us yet but the question of environmental stability and sustainability hinges the future course of humanity. Its gradual motion (though it has fast forwarded during the last few decades) deludes us into believing as if all is well, but the melting snow-caps, the fast vanishing glaciers, spiky flash floods and such other visible and tangible parameters awaken us to the deeper mess, the hidden danger and the inevitable tragedy that we might collide with if timely and necessary measures aren't brought into action without further delay.

The question pertaining to our response to climate challenges follows the top-down trajectory in a colossal problem like environmental degradation and its protection. That's precisely the reason that international organizations and their affiliated countries have risen to the task and have started adopting and implementing universal policies and methodologies to safeguard the precarious environmental balance and to minimise any further stress on the environment that may ultimately steer it to the point of rupture. As carbon and its compounds called Hydrocarbons are chief miscreants in destabilising the environment and causing temperature abnormalities, the global community has set before itself the primary task of reducing Carbon emissions. Alternatives are being worked upon and efforts are being made to harness the eco-friendly, sustainable and non-polluting energy sources like Solar, Hydel, Geothermal etc. The industrial wastes are being subjected to proper decomposition techniques, residues are ingested to treatment plants and parallels like electric vehicles, solar photovoltaics are explored to meet growing energy demands without compromising on environmental safety parameters.

With all the measures in place and new measures being explored, the question remains: To what extent can an industrial consumerist society cut down its carbon consumption/emissions? But man is placed in the ambit of accountability towards God for his relation with the environment and is allowed to benefit from the resources of the Earth within earmarked boundaries without subjecting the environment to undue stress.

2008 Recession A Terrifying History Lesson

ike everyone else, I have been watching global equity markets lurch lower with terror. Clearly, the Fed has been caught red-handed as the inflation tide accelerates outwards, with markets too high, pumped up on years of cheap money. The declines have been definitive. When will the decline stop? How will we know when it has gone far enough? The only truthful answer is: Nobody knows.

The graphic shows the percentage daily movement of the Dow from the peak (14,088, on October 1, 2007) to the trough (6,547, on March 9, 2009) during the 2008 crisis; I have superposed on it the percentage daily movement of the Dow from its last peak (36,489 on December 29, 2021) to its level on June 15, 2022 (30,669). The parallels are terrifying-in the first five and a half months of the 2008 crisis, the Dow fell by around 15%; we are currently down 16% (and this is before last Thursday's sharp decline, which took the Dow below 30,000 for the first time since December 2020). The paths have a correlation of 70%, and what is truly frightening is that, in 2008, the market continued to decline for another 12 months and later declines were sharper.

Another parallel is the "tem-

per" of the market—a term I have coined to show how many days the market reacted to the trend by more than 1%. There were 22 days (18% of the last 120 days) when the market jumped higher compared to just 17 times (14%) during the 2008 crisis over the similar period. Incidentally, the classic market lore-that a bear market ends with capitulation, which, I assume, means there are zero up days-was not borne out in 2008; the total number of 1% plus days during that period was 75 out of 370, with the bulk (about half) of these occurring in the last third of the bear market.

Surely, the macro circumstances during the two periods are completely different. Before the 2008 crisis, growth was strong (5% in October 2007), as the economy had recovered strongly from the dot com bust in 2000 under the Fed's enthusiastic cheap money policy. The ultralow rates (Fed funds had fallen to 1% in May 2004) and blind regulators led to an explosion of banks selling extremely risky investments into the retail market. By 2007, inflation was rising (peaking at 3.8% in 2008) and the Fed funds rate was climbing (reaching 5.25%). These added to the build-up of risk in every institution, leading to the collapse of Lehman Brothers on September 15, 2007. The economy rapidly closed down with

no one willing to lend since nobody knew who was caught in which web of mortgage-backed derivatives. Equities tanked, growth crashed.

The one-trick Fed once again flooded the market with money pushing rates down even more dramatically—the funds rate fell to 0.1% by September 2008. Growth, which had fallen to a low of -2.54% in 2009, picked up the following year and stayed steady (1-2.5%) for several years. However, this was jobless growth with unemployment uncomfortably high (>8%) till 2013; the Fed, of course, continued giving away money keeping rates flat on the ground (0.1-0.15%) for 7 years. This enabled the dramatic equity boom we have enjoyed and, of course, the current blowout of inflation. The entire misadventure ran for a year and a half, and, what is even worse is that the Dow did not recover to its earlier peak (of 14,088) till September 2013, a full four years after hitting bottom.

Circumstances are different today but certainly not comforting. First, as already mentioned, the market has been falling for just 6 months (as opposed to 18 back in 2008). Secondly, growth, which had picked up smartly after the pandemic, is slowing sharply as a result of the Russian invasion, surging commodity prices (particularly oil prices), and continuing supply-chain/ Covid difficulties. Third and most significant, US inflation is raging at 8-9% (as compared with a peak of 3.8% back then) and the Fed is in the midst of dramatic monetary tightening—the 75bps hike last week was the highest since 1994, with expectations of more to come. The trauma is not nearly over. All eyes and ears remain on the Fed (and other central banks) that has suddenly awakened to its primary job of controlling inflation. Unfortunately, inflation is like a runaway train, and since it has not been leashed in time, there is no telling where it will go or what damage it will do. Worse yet, it is possible and, indeed, likely, that the only antidote—steadily (or rapidly) raising interest rates and tightening money supply—will crash the economy further.

With zero visibility on the future, except that equities will fall further, the prayer is that history does not repeat itself.

understanding of what was involved in the process of finding a spouse was limited to the classics like Jane Austen's Sense and Sensibility. Through Austen's writing, I was emboldened to imagine that matrimony was guite basic, if you remove social classes and beauty that is.

As a South Asian Mulim woman when it comes to finding your other half, the contrast between expectations and reality cannot be more stark. There is undeniably some amount of disappointment attached to this worn-out, traditional practice of finding a spouse in South Asia. Many South Asian women find themselves at the edge of the cliff when they are forced to measure their beauty, a social construct that is absolutely out of their control, in order to find a spouse.

Young women without the genes that would deem them conventionally pretty are expected to forego their dreams in the name of matrimony. Some women are expected to lower their reasonable expectations and compromise simply because their skin tone or appearance is deemed unacceptable for an "ideal wife".

Over the years I have seen how more and more women in my community are advised to compromise their living standards, stuck with partners who are unable to provide them with the same level of comfort they were brought up in, or abusive partners with unmatched moral values. Smart women equipped with the skills to enrich their communities lose their youth, either in the hunt for a partner, or in dealing with the consequences of a bad marriage. In some houses, there are more dreams put to fire than fuel every day.

I come from a household where not being married by twenty-four is the first violation of the sacred notion that women are too old by the time they hit the benchmark of graduation. Much to my grievance, I discovered this at the said twenty-four. So what is it like to be a stay-at-home woman waiting in vain to get hitched, you may wonder? I pray your experi-

that we live in a world where people are neither good nor bad, they are either different or the same, a rosy notion that is now fast withering. My experiences as a prospective wife have certainly scarred me for a lifetime. The very calm of the sea that our family lived at the ebb of, now a roaring ocean, waiting for me to get hitched.

Pale skin is an expected mandatory, bi-partisan rule between the woman's and the man's family. One demands, while the other rubs turmeric and other household remedies on her skin until it is raw with pain. Why as a society, have we reduced ourselves to trying to undo the decree of our Creator?

The hypocrisy of our community is so well ingrained that we have come to defend these unrealistic ideals rather than upholding Islamic values. The insolence of how the very people we consider to be our loved loved ones, the same people who were once extremely keen to find us a righteous spouse, but who now attribute all these misgivings to our fate. is remarkable. Every transgression in a society manifests itself in the institution of marriage. It is no surprise that many women find themselves at the pinnacle of their emotional breakdowns either before or in the early years of their marriage.

In a society where a trophy wife is now considered a prerequisite by our men, where then do we find ourselves as women if we do not meet the impossible standards set by them? Why is it that we are quite unconsciously taught to find our worth in our spouse even before we meet him? We are expected to spend hours enhancing our appearance, our ideals, and our household skills; things we may or may not have an interest in. Did our Creator demand this of us? Why do we scrub our skin until we've scrubbed any bit of selfesteem along with it? Why do we starve our bodies until our soul feels dizzy?

flaws in my appearance. The anxiety weighs me down.

A question every South Asian Muslim woman needs to ask herself is: How deep-rooted is my disappointment in this system? Where am I projecting it? Have I fallen into this dark pit when none of it is my fault, to begin with?

Our fight against the system turns into a fight against ourselves. We are let down by our families, then some of our friends who seemingly fail to acknowledge the harshness of this system. Over the years, I've been constantly trying to find ways to quell my anxiety. How do we save our self-esteem in a society where good character is an admirable trait, only when physical appearances also bring pleasure to the eye?

For me, coming to terms with this conundrum and finding an answer to this question required some soulsearching. I have compiled a list of lessons that I learned in this journey that have made an immense amount of difference to me:

Take a breather. Accept that every part of your body is the way it is meant to be by the Decree of people who demand milky white skin or an hour-glass figure. Understand that your physical appearance is in no way a detriment to your finding a spouse. The right one has been decreed for you by Allah all along. Trust Allah, not the process.

- Have a tête-à-tête with your friend. Voice your insecurities and you'll soon see how frivolous they sound in the bigger picture. Dive into a nostalgic conversation, and remind yourself what you are capable of.
- Rather than investing your mental energy into the spouse hunting process, set out a time when you remind yourself of the greater purpose of life. This can be quite tricky when you have a marriage-obsessed family around. But remember, every hour you take out for yourself is an investment you make into your future-self, while every hour you spend being anxious is an hour you lose to society's fictional standards.
- If your anxieties are pushing you 4. into insomnia, make wudhu and spend some time on the prayer mat. Start with tasbih if you feel too exhausted and scatterbrained to stand up for qiyam.
- 5. Join a free Qur'an course, a personal development course, or connect with a life coach. Any amount of constant external positive reinforcement may help you to reclaim your sense of self. Seek professional help, if you can afford it. Work towards your career goals. Some families are downright abusive and force their daughters to give up any such ideas but don't listen to them. Do whatever you can to stay relevant to your field and acquire skills. Most importantly, don't give up on yourself.

If you are someone with friends who are going through this struggle, this is how you can support them:

If your friend is struggling and has been courageous enough to share their insecurities with you,

as dark as you. I'm not that lightskinned." Or "You are not fat, I am!" If you truly care, hear them out, address their concerns, and acknowledge their anxiety. Remind them that being unworthy of love and being unacceptable by prospective in-laws are not the same things.

- If you have a brother or any male relative seeking a spouse through this process, ask them to be kind. For some women, it takes a lot of patience to sit at home for years waiting to get married simply because of skin color or appearance. Use your influence to make your male relative see that their obsession with light skin or other conventional beauty standards is a character flaw within themselves and not within the women they come across.
- 3. Remind them of their rights that Islam has already granted them, and provide moral support if the person is having a hard time with their family. Oftentimes, women will compromise just to get out of the pressure put upon them by loved ones which leads to more harm being done than good.
- 4. Be the one who breaks the tradition. If you are involved in the matchmaking process, make the prospective spouse feel comfortable, ask better questions, and bring up issues that they may feel uncomfortable bringing up. If you think it will not work out for whatever reason, be kind in how you convey your decision.

We have been there in the past watching our aunts suffer the same humiliation, we are here now, with a stoic face as prospective in-laws scathe our self-worth with judgemental glances. The question is will we be there, desensitized to this culture when our own daughters are on the verge of womanhood?

Women Are At Greater Risk Of Stroke, **The More Miscarriages They've Had**

ew research shows women who have had a miscarriage or stillbirth, have an increased risk of stroke when blood can't get to the brain, because of a blocked or burst artery. That risk increases with each miscarriage or stillbirth.

Trying to establish this link is difficult because it requires following a large number of women over a long period of time and having reliable data on women's experiences. Our study, published by the British Medical Journal today, is the first to conclusively show the link between pregnancy loss and stroke.

Many women are unaware their experiences during pregnancy can be an early marker of later health dangers. Our findings show their doctors should be alert to their increased risk.

It's possible infertility, miscarriage, and stillbirth could increase stroke risk because of other health issues. These could include endocrine disorders (low oestrogen or insulin resistance), inflammation, problems with endothelial cells that assist in blood flow, psychological disorders, unhealthy behaviours (such as smoking) or obesity.

Heartbreak then stroke risk

Our research is based on pooled data from 618.851 women who took part in eight separate studies in Australia. China, Japan, Netherlands, Sweden, the United Kingdom and the United States

The women were aged between 32 and 73 when they were first enrolled in the studies and were followed up for an average of 11 years.

The study showed that over the time they were studied, 9,265 (2.8%) women had at least one non-fatal stroke and 4,003 (0.7%) women had a fatal stroke. Overall, 91,569 (16.2%) women had a history of miscarriage while 24,873 (4.6%) had a history of stillbirth.

Among the women who had ever been pregnant, women who had reported a miscarriage had a 11% higher risk



of a non-fatal stroke and 17% higher risk of a fatal stroke compared with women who have not had a miscarriage.

The risk increased with each miscarriage, so that women who had three or more miscarriages had a 35% higher risk for non-fatal stroke (from incidence rate of 43 per 100.000 person years to 58 per 100,000) and an 82% higher risk in fatal strokes (from 11.3 per 100,000 person years to 18 per 100,000) compared with women who had never miscarried.

Stillbirth also significantly increased the risk of stroke.

Among women who had ever been pregnant, women who had a history of stillbirth had a 31% higher risk of nonfatal strokes (from an incidence rate of 42 per 100,000 person years to 69.5 per 100,000) and a 7% higher risk of fatal strokes.

Again, the greater the number of stillbirths, the higher the risk of later strokes, with women who had had two or more stillbirths having a 26% higher risk of fatal strokes (rising from 11 per 100,000 person years to 51.1 per 100,000).

The study is the first to show links with stroke subtypes: stillbirths were linked to non-fatal ischaemic (blockage) stroke or fatal haemorrhagic (bleeding) stroke; miscarriages were

linked to both subtypes.

Our study strengthens findings from a previous systematic review that found similar results but showed limited evidence linked to stroke subtypes.

Of the possible explanations for these links, problems with endothelial cells (which control vascular relaxation and contraction as well as release blood-clotting enzymes) might lead to pregnancy loss through problems with the placenta. These problems also relate to how blood vessels dilate and get inflamed or blocked during stroke.

Adjusting for known risk factors

Our findings were adjusted for many of the known risk factors for stroke: body mass index, whether the women smoked or not, whether they had high blood pressure, or diabetes. The numbers were also adjusted for ethnicity and education level.

By adjusting for risk factors, we can isolate the increased risk likely linked to the number of miscarriages or stillbirths the women.

What should women and their doctors do with this information? When doctors do a heart health check, they look at the risk of cardiovascular disease overall that is, heart disease, heart failure and stroke. By considering these risks, doctors assess and predict the risk of future disease.

The current Australian guidelines recommend heart health checks should be conducted regularly for people aged 45 to 74, or for Aboriginal and Torres Strait Islander peoples from the age of 30 this is when the risk of cardiovascular disease starts to increase.

The guidelines recommend medication (blood pressure medication and/ or lipid-lowering medication such as statins) when the risk of cardiovascular disease is greater than 15% in the

ing updated by the Australian Chronic Disease Prevention Alliance (which includes the Cancer Council Australia, Diabetes Australia, Kidney Health Australia, National Heart Foundation of Australia and the Stroke Foundation), but more recent international guidelines recommend medication at lower levels of risk.

No matter what your risk of cardiovascular disease is, the best way to prevent having a stroke is by living as healthy a lifestyle as possible: stopping smoking, eating a healthy diet, having a moderate alcohol intake and doing

for everybody, but doctors will try particularly hard to help people do this who are at long term risk

Our research shows miscarriage and stillbirth are signals a woman is at increased risk of cardiovascular disease. These events occur many years before a woman develops other risk factors, such as high blood pressure, diabetes or high cholesterol.

Women who have experienced a miscarriage or stillbirth should discuss these with their doctor. Knowing you have a higher risk of stroke is opportunity to monitor your health and make lifestyle changes that can help prevent stroke.

GPs need to ask about women's reproductive histories and be aware of recurrent miscarriage and stillbirths as potential predictors of stroke risk.

Four Coral Species Recorded For First Time In Indian Waters

Scientists have recorded four species of azooxanthellate corals for the first time in Indian waters. The

four species named Truncatoflabellum crassum, T. incrustatum, T. aculeatum, and T. irregulare were recorded from the waters of Andaman and Nicobar Islands.

Azooxanthellate corals are a group of corals that do not contain zooxanthellae—unicellular, golden-brown algae. They are found in dark habitats especially within caverns. Their distribution is not limited to the upper layer of ocean alone, but are known from the tropi-

cal seas to polar seas and from the intertidal zone to over 6,328 metres depth. The study, published recently in Thalassas: An International Journal of Ma-

rine Sciences, was carried out in reef ecosystems of Andaman and Nicobar Islands. The researchers from the Zoological Survey of India (ZSI) reported four species of azooxanthellate corals from the shallow

water region. The previous studies carried out on the scleractinian coral resulted in the



"The four species named as Truncatoflabellum crassum, T. incrustatum. T. aculeatum. and T. irregulare under the family Flabelliiidae are recorded for the first time from India," the authors of the study noted.

All four specimens were previously recorded from Japan to the Philippines and Australian waters while only T. crassum was reported within the range of Indo-West Pacific distribution including the Gulf of Aden and the Persian Gulf, they said.

The study illustrates the morphological features along with the global mapping of zoogeographic distributional ranges of the four species of flabelliids.

A 2016 study by researchers at the Institute for Environmental Research and Social Education, Tamil Nadu reported three species of azooxanthellate corals, for the first time from the rocky outcrops off Goa, mid-west coast of India.

Food Can Be Produced Without Sunlight Via Artificial Photosynthesis

The technology uses a two-step electrocatalytic process to convert carbon dioxide, electricity, and water into acetate.

Food-producing organisms then consume acetate in the dark to grow. The hybrid organic-inorganic system could increase the conversion efficiency of sunlight into food, up to 18 times more efficient for some foods.

Photosynthesis has evolved in plants for millions of years to turn water, carbon dioxide, and the energy from sunlight into plant biomass and the foods we eat. This process, however, is very inefficient, with only about 1% of the energy found in sunlight ending up in the plant. Scientists at UC Riverside and the University of Delaware have found a way to bypass the need for biological photosynthesis altogether and create food independent of sunlight by using artificial photosynthesis.

The research, published in Nature Food, uses a two-step electrocatalytic process to convert carbon dioxide, electricity, and water into acetate, the form of the main component of vinegar. Food-producing organisms then consume acetate in the dark to grow. Combined with solar panels to generate the electricity to power the electrocatalysis, this hybrid organic-inorganic system could increase the conversion efficiency of sunlight into food, up to 18 times more efficient for some foods.

"With our approach we sought to identify a new way of producing food that could break through the limits normally imposed by biological photosynthesis," said corresponding author Robert Jinkerson, a UC Riverside assistant professor of chemical and environmental engineering.

In order to integrate all the components of the system together, the output of the electrolyzer was optimized to support the growth of



food-producing organisms. Electrolyzers are devices that use electricity to convert raw materials like carbon dioxide into useful molecules and products. The amount of acetate produced was increased while the amount of salt used was decreased, resulting in the highest levels of acetate ever produced in an electrolyzer to date.

"Using a state-of-the-art twostep tandem CO2 electrolysis setup developed in our laboratory, we were able to achieve a high selectivity towards acetate that cannot be accessed through conventional CO2 electrolysis routes," said corresponding author Feng Jiao at University of Delaware.

Experiments showed that a wide range of food-producing organisms can be grown in the dark directly on the acetate-rich electrolyzer output, including green algae, yeast, and fungal mycelium that produce mushrooms. Producing algae with this technology is approximately fourfold more energy-efficient than growing it photosynthetically. Yeast production is about 18-fold more energy-efficient than how it is typically cultivated using sugar extracted from corn.

"We were able to grow foodproducing organisms without any contributions from biological photosynthesis. Typically, these organisms are cultivated on sugars derived from plants or inputs derived from petroleum -- which is a product of biological photosynthesis that took place millions of years ago. This technology is a more efficient method of turning solar energy into food, as compared to food production that relies on biological photosynthesis," said Elizabeth

green pea were all able to utilize carbon from acetate when cultivated in the dark.

"We found that a wide range of crops could take the acetate we provided and build it into the major molecular building blocks an organism needs to grow and thrive. With some breeding and engineering that we are currently working on we might be able to grow crops with acetate as an extra energy source to boost crop yields," said Marcus Harland-Dunaway, a doctoral candidate in the Jinkerson Lab and co-lead author of the study.

By liberating agriculture from complete dependence on the sun, artificial photosynthesis opens the door to countless possibilities for growing food under the increasingly difficult conditions imposed by anthropogenic climate change. Drought, floods, and reduced land availability would be less of a threat to global food security if crops for humans and animals grew in less resource-intensive, controlled environments. Crops could also be grown in cities and other areas currently unsuitable for agriculture, and even provide food for future space explorers.

"Using artificial photosynthesis approaches to produce food could be a paradigm shift for how we feed people. By increasing the efficiency of food production, less land is needed, lessening the impact agriculture has on the environment. And for agriculture in non-traditional environments, like outer space, the increased energy efficiency could help feed more crew members with less inputs," said Jinkerson

This approach to food production was submitted to NASA's Deep Space Food Challenge where it was a Phase I winner. The Deep Space Food Challenge is an international competition where prizes are awarded to teams to create novel and game-changing food technologies that require minimal inputs and maximize safe, nutritious, and palatable food outputs for long-duration space missions.

GST Council May Consider Changes In Monthly GST Payment Form

NEW DELHI: The GST Council in its meeting next week is likely to consider a proposal for making changes in the monthly tax payment form - GSTR-3B, which would include auto-population of outward supplies from sales return and non-editable tax payment table, officials said.

The move would help curb the menace of fake billing, whereby sellers would show higher sales in GSTR-1 to enable purchasers to claim input tax credit (ITC), but report suppressed sales in GSTR-3B to lower GST liability.

Currently, GSTR-3B of a taxpayer includes auto drafted input tax credit (ITC) statements based on inward and outward B2B supplies and also red flags any mismatch between GSTR-1 and 3B. Rahul Gandhi's Office In Wayanad Vandalised By SFI activists, Kerala CM **Assures Stern Action Against Culprits**

Wayanad: A protest march of the SFI, the students wing of ruling CPI(M), against Congress MP Rahul Gandhi's office here on Friday turned violent as a group of activists allegedly entered the Lok Sabha member's office and vandalised it, prompting Chief Minister Pinarayi Vijayan to strongly condemn the incident and warn of stern action against the culprits.

Strongly condemning "the act of violence" by SFI at its top leader's office at Kalpetta in Gandhi's LS constituency Wayanad, the Congress party staged a statewide protest, which turned violent in some regions.

The incident occurred when the Students' Federation of India (SFI) activists held a march to Gandhi's Office alleging his inaction in the issue of buffer zones around forests.

The activists of the Left outfit allegedly barged into his office, vandalised it and attacked three Congress workers who were present there before police intervened to prevent them from the violent acts, the Congress alleged.

While the main opposition party claimed that the attack happened with the knowledge of the Vijavan, the chief minister, in a strongly worded message, said this land ensures space for freedom of expression and democratic protest but it was a wrong practice if it turns into violence.

CPI(M) General Secretary. Sitaram Yechury, also denounced the attack.

"Strongly denounce and condemn what happened in Wayanad, Kerala today. Kerala state CM has already condemned it. Police has initiated measures against those responsible," Yechury tweeted.

Police said around eight people were taken into custody following the ruckus in front of the MP's office and six police officials including a woman civil police officer have been injured in the attack.

"As of now, eight of the protesters have been taken into custody and brought to the station. A few policemen, including Kalpetta SI, were injured in the stone pelting following the march," police told PTI.

Congress leaders claimed three staff members in the office got injured in the "attack" by SFI. Gandhi has spoken to them over the phone and enquired about their health, the party said.

Television channels aired visuals of persons entering the

office, creating ruckus. Hitting out at the Left government and its workers for targeting their top leader over the buffer zone issue, the Congress organised a statewide protest and in some places including in Kottayam, it turned violent after Left party workers attempted to disrupt the march.

Senior Congress district leaders were injured in the violence occurred in Kottayam. AICC General secretary K C Venugopal strongly criticised the attack and alleged that the office was vandalised with the knowledge of the CM.

Venugopal said the police who witnessed the attack "remained a mute spectator" aiding the "SFI criminals" to vandalise the office of the senior Congress leader.

"Instead of fighting the BJP government at the Centre, the CPI(M) was attacking the Congress in the buffer zone issue. The Chief Minister is answerable to this violence planned by SFI criminals. The party strongly con-demns the attack," he told reporters at the KPCC office in Thiruvananthapuram.

Denouncing the attack, CM Vijayan said, "strongly condemn the attack against Congress MP Rahul Gandhi's office at Wayanad. This land ensures space for freedom of expression and democratic protest but it is a wrong tendency to turn such protests into a violent one."

"The government will take stern action against the culprits," he assured. president KPCC

Sudhakaran welcomed the Chief Minister's assurance but doubted his sincerity.

Sudhakaran alleged that the attack was with the knowledge of the CPI(M) leadership and sought action against the police officials who allegedly 'aided" the protestors.

10 More Die In Assam Floods; Silchar Under Water For 5th Day

Guwahati: Ten more people died in Assam's devastating floods that affected 33.03 lakh people in 28 districts on Friday, while Silchar town in Cachar district remained submerged for the fifth consecutive day, official sources said.

On Thursday, a population of 45.34 lakh in 30 districts had been affected by the deluge, according to the bulletin of the Assam State Management Disaster Authority (ASDMA).

The rivers are showing a receding trend though the Brahmaputra at Dhubri and the

Kopili in Nagaon are still flowing above the danger mark. After the death of 10 more

people - two each from Barpeta, Dhubri, Karimganj and Udalguri districts and one death each from Cachar and Morigaon, the toll due to floods and landslides reached 118 since mid-May.

The state government an-nounced that it has engaged additional resources to the severely affected districts, especially Cachar and the two other

districts in Barak Valley. Two drones have been deployed in Silchar for carrying out the flood inundation mapping as well as to provide relief materials to the affected people. Eight NDRF teams from Itanagar and Bhubaneswar

In addition, 10 personnel of the CRPF and four of the SDRF with boats have been airlifted to Cachar to rescue the stranded people, an ASDMA official said.

After making an aerial survey of Silchar town on Thursday, Chief Minister Himanta Biswa Sarma announced that additional columns of the Army will be sent to Silchar to evacuate marooned people.

The state government also launched helpline numbers 0361-2237219, 9401044617 and 1079 (toll-free) for the affected people of Cachar district.

The state government has airlifted 85.2 metric tonnes of relief materials from Jorhat and Guwahati to Silchar.

A population of nearly three lakh has been facing an acute shortage of food, clean drinking

the entire town has been submerged in flood waters.

Packets with food, drinking water bottles and other essential items are being airdropped in the town by Indian Air Force helicopters and this will con-tinue till the situation improves, an official said.

The three districts of Barak Valley - Cachar, Hailakandi and Karimganj - were severely af-fected by the rising water of the Barak and the Kushiara.

Other major flood-affected districts in the state are Barpeta with 8,76,842 affected people, followed by Nagaon (5,08,475), Kamrup (4,01,512) and Dhubri (3,99,945), according to the ASDMA bulletin.

Urban flooding was report-ed in Cachar, Karimganj and Morigaon districts.

The floods, caused by incessant rainfall, have affected 93 revenue circles and 3510 villages, while 2,65,788 people have taken shelter in 717 relief camps, it said.

The floods have also damaged 168 roads and 15 bridges while three embankments were breached in Nagaon district.

Crop area of 91,658.49 hectares and 25,99,756 animals have been affected in the current second wave of floods. Large-scale erosion was also reported from

"The Subject Expert Committee (SEC) on COVID-19 of the CDSCO deliberated on the EUA application of SII and recommended granting emergency use authorisation for Covovax for children aged 7 to 11 years," an official source said. The expert panel in its last meeting in April had sought

On June 3, a division bench of the High Court of Jammu and Kashmir and Ladakh stayed the single bench order for exhuming the body of Aamir Magrey and handing it to his family for last rites.

On May 27, the single judge bench had directed the Jammu and Kashmir authorities to make arrangements for exhuming the remains of the deceased from the Wadder Payeen graveyard in the presence of Latief Magrey.

The court, however, had said if the body is "highly putrefied and is not in deliverable state or is likely to pose risk to public health and hygiene, the petitioner and his close relatives shall be allowed to perform last rites as per their tradition and religious beliefs in the graveyard itself".

In that situation, the state shall pay petitioner Mohammad Latief Magrey a compensation of Rs 5 lakh for deprivation of his right to have the dead body of his son and give him a decent burial as per the family traditions, religious obligations and faith which the deceased professed when he was alive, the single judge bench order had said.

Bodies of two more civilians, Altaf Ahmad Bhat and Dr Mudasir Gul, who were killed in the controversial Hyderpora encounter, were exhumed and returned to the families following an outcry days after the gunfight.

Four people were killed in the alleged encounter on the outskirts of Srinagar on November 15, 2021.

While the police said all of them were militants and buried their bodies in Kupwara in North Kashmir, the families of the victims said that they were innocent civilians.

FIFA Tells AIFF To Hold Elections To Avoid Ban

MUMBAI: World governing body FIFA has told India's football association to complete changes to its constitution and elect new office bearers by Sept. 15 to avoid being banned, officials said.

the All India Football Federation (AIFF) executive committee last month after it failed to hold elections on time and amend its regulations in line with rules stipu-

lated by the national sports code. The court then appointed a three-member committee to run the body, amend the AIFF's constitution and conduct elections that have been pending for 18 months.

FIFA statutes say that member federations must be free from legal and political interference in their respective countries and the world governing body has previously suspended other national associations over similar cases.

FIFA and the Asian Football Confederation sent a team led by AFC General Secretary Wind-
