Hosting G-20 Summit Privilege For J&K: Sinha

Srinagar: Jammu and Kashmir Lieutenant Governor Manoj Sinha on Saturday said it was a matter of privilege for the union territory to host the G-20 summit in 2023 and asserted that the administration would put in every effort to make it a grand event.

Jammu and Kashmir will be hosting the 2023 meetings of G-20, an influential grouping that brings together the world's major economies, with the union territory administration on Thursday setting up a fivemember high-level committee for overall coordination. This will be the first major international summit to be held in J&K after its special status guaranteed under Article 370 of the Constitution was withdrawn and the erstwhile state was divided into two union territories in August 2019.

Massive Security Put In Place For Yatra

Srinagar: Security forces have made unprecedented security arrangements for Amarnath yatra as it apprehends a higher threat perception to the pilgrims this year, a senior Army official said here on Saturday.

The Army officer, who did not wish to be identified, said security personnel three to four times more in strength have been deployed around the yatra as there is credible intelligence of a likely militant strike. There is an increased threat perception to the Amarnath yatra this year. We generally receive inputs about militants

targeting the yatra every year,

but this year, there are more such inputs, the officer said.

He said the administration expects the number of vatris to go up this year especially since the pilgrimage is taking place for the first time in four years -it was cancelled midway in 2019 with the Centre's revocation of J-K special status, and suspended in 2020 and 2021 due to the COVID pandemic -- and also because of the increased number of tourist arrivals.

The security preparations have also been made keeping these factors in mind, the officer added.

'Almost all major vegetable and fruits prices have been increased because of less supply due to the continued closure of national highways" said Bashir

Ahmed who sells vegetables at Habba Kadal.

Another wholesale trader in Khanyar market, who buys vegetables from other states voiced similar views

'One of the main reasons behind the rise in vegetable and fruit price is the jump in transportation costs after reaching here and that too after a days gap we have to pay an extra charge due to which rates in markets have increased" he said.

He said that authorities should put their efforts to make Jammu Srinagar highway functional so that people associated with many businesses would not suffer.

200. The consumers are finding it hard to purchase groceries due to skyrocketing prices.

Nazir Ahmed a fruit seller in Amira Kadal market said that the fruits are from different parts of India and we have to struggle a lot to bring them here especially during this highway closure.

"Once we will get smoothly here on genuine charges obviously rates will be normal and when we are paying double the rates then rates will be a little bit increased", Ahmed added.

Affront To Amarnath

ficials of the Shri Amarnathji Shrine Board (SASB) appear to have messed up massively in regulating pilgrim inflow for the sacred annual journey to the holy cave in the Kashmiri Himalayas, turning this year's yatra into a case study of mismanagement, chaos and confusion. It is incredible that huge numbers of unregistered pilgrims should have got past the authorities, particularly when an extensive and elaborate network of registration counters exists specifically to avoid the disruption of painstaking government arrangements made at huge public expense.

There is nothing inadvertent in the fiasco this year – it is a wilful and calculated plan to bring the Board chairman, governor NN Vohra, into disrepute. Packed as it evidently must be with the protégés of the former incumbent, Lt Gen SK Sinha, who had turned the holy journey into a two-month-long moneyspinner for sangh parivar operators, the Board has struck back viciously at Mr Vohra for slashing the duration of the pilgrimage by a fortnight.

It should not be forgotten that not too long ago the SASB had boasted of mendacious bureaucrats like Arun Kumar whose infamous vituperation against Kashmiris voicing justified concern at the adverse environmental impact of Gen Sinha's unconscionable expansion of the scale of the pilgrimage remains, to this day, a classic example of saffronite spite against the valley. Evidently, the Board continues to be dominated by the acolytes of the Vishwa Hindu Parishad which specializes in defiling the sacred by exploiting the pure and simple faith of devotees.

What Caused a Floody-February Wednesday in June?

oth Kashmir and Jammu regions had been experiencing rather unnerving wet weather since the 18th of June. Emblematic of the weather unpredictability, people were quick to wear their best unpredictable gears. In Kashmir, the age-old Kash miri truism of keeping the Pheran ready by the hook, on-the-go, had new takers. Higher reaches recorded heavy snowfall, at the same time, plains were lashed by heavy spells of rain. Temperatures dropped untypically. The quiet Jhelum went tempestuous, bringing with it the currents of the turbulent memory of the 2014 floods.

These switches from high to low temperatures, from spring's sprint to summers and from uncanny rains to unbearable sun - what explains these volatile fluctuating temperatures?

In today's day-and-age, weather models developed by scientists help in knowing the future weather in advance. However, regarding the recent spell, weather models were divided in the forecasts.

As the weather event got closer, ambiguity continued among weather models. However, it got clear that Jammu and Kashmir was in for a major spell. Models had also forecasted a significant drop in day temperatures.

On 21 June, Srinagar recorded a maximum temperature of 15.0 degrees Celsius, which was 14.2 degrees below normal. In 2015, Srinagar recorded a maximum temperature of 15.2 °C. This broke the previous record as Kashmir registered the coldest June day since atleast 1975. Temperatures remained similar in other parts of the Valley. In A temperature of 15.0 degrees Celsius is common in February in Srinagar. So temperatures were quite comparable to a sunny day in Chillai-Khurd — a period of 20 days after Chillai-Kalan, the 40-day

Kupwara, the maximum tempera-

ture was 15.5 degrees below average.

harshest period of cold. As the evening of 21 June set in, it started pouring heavily. By the morning of 22 June, water levels of several Nallahs had crossed the 'danger mark'. Jhelum, later in the day at Sangam and Ram Munshi Bagh crossed the 'Flood Declaration' mark. From a drought-like situation a few days ago, it turned out to be a Floody Wednesday. Drought cold and flood are

In 2014, Kashmir witnessed one of the worst floods in its history. In 2015 again, the water level of Jhelum crossed five times above the 'flood declaration' level. On the complete opposite side of the pattern, in 2016, a prolonged dry spell lasted for 4 months.

Precipitation patterns have also been haywire. The otherwise driest of November is turning out to be the wettest month. The wettest season, Spring, this year saw the lowest rainfall in the last 2 decades.

In 2018, it snowed heavily in the first week of November. In 2019, it snowed even more heavily in November. Last year, on 23 October 2021, it snowed in south Kashmir plains. All these events caused a huge loss to people, especially people associated with the agricultural and horticultural sectors. • Drought, cold and flood are seemingly incongruent. Climate change isn't measurable. However, it is quite tangible when we look at climate changes over years and compare the weather we used to see in the 1980s and the weather we are experiencing from the last 10 years. Climate change isn't confined to bringing hot and warm weather only. It can bring the worst floods, extreme cold, unseasonal snow and the list goes on. Don't be surprised if it snows in the plains on a June day sometime in the future.

Climate change is directly linked to how humans have treated and are treating this earth. The carbon dioxide emissions are rising, heating the world and thus the world is witnessing never-beforeseen events.

Such things were never the norm in Kashmir's climate history. Not only are these extreme events going to happen again but their these extremes to happen again but their danger. The weather events that climate change could trigger won't care for anyone's luxuries or privileges — they're coming for all of us.

There's a lot that needs to be done at the level of policy decisions. The global community needs to be more alert and adept at tackling climate change issues. Developed nations have to take responsibility and do their share to discourage production patterns that aggravate climate change.

They say personal is political; in the case of climate change, indeed, the political is personal. Climate change is going to come for us all. Its effects aren't going to be restricted to only one community. Therefore, we must all mobilise and advocate for climate sensitive policies. The government of Jammu and Kashmir must ensure that environmental concerns don't remain restricted to the events and seminar alone. They must be taken up in spirit especially in an eco-sensitive place like Kashmir which has the burden of tourist influx and rapid industrialisation. Climate change advocacy must be instilled in the young and the fresh.

We need to make our voices heard by those in power. It will make the government take action and spend more on reducing the effects of climate change. Awareness programs, TV debates and workshops on climate change should be organized. This will help people to learn and understand better about it.

However, we also have an active role to play to mitigate the climate crisis. To begin with, we need to educate ourselves. Today we have Google on which thousands of articles regarding climate change are available. One needs to go through some of them and learn about the dangers of climate change and the things that are triggering it. The knowledge gained must be shared with others.

Instead of using private transport every time, public transport should be used or one can do cycling or go for a walk. Not only will it help in reducing carbon emissions but will also improve the health of every individual. Lights and appliances should be turned off when there is no need. Planting more trees can help in absorbing carbon dioxide.

Taking short showers and turning off the tap while brushing teeth can save a lot of water. Saving water reduces carbon pollution because it takes a lot of energy in pumping, heating and cleaning of water. Such small measures by an individual can help in mitigating the deadly effects of climate change. Better act now than tomorrow.

reminded of how powerful lobbies sidelined Mahant Deepinder Giri who had insisted on strict adherence to holy scripture in conducting the yatra, particularly in determining its timing, duration and route. Obviously, the sacred word has little significance for the Vishwa Hindu Parishad which has threatened a nationwide agitation to oppose any change in the extended pilgrimage schedule. Surely, the VHP would have been more heedful of sacred texts were it genuinely and sincerely concerned about upholding and promoting religious and spiritual values and practices.

Governor Vohra's exemplary record as an officer and administrator is under severe test in his chairmanship of the SASB. Granted that he, ostensibly, has the much bigger headache of negotiating Kashmir's tricky political terrain to worry about, but as head of the Amarnath Board he is duty-bound to take serious note of the disaster his predecessor, Lt Gen Sinha, has created for Kashmir both by extending the yatra and engineering an unsustainable influx for the pilgrimage to help dharm thekedaars to add to their already-overflowing coffers.

The governor would have justified his regular helicopter sorties over the yatra route if he took the trouble to set foot on the ground as well, not in orchestrated official visits, but surprise and impromptu inspections of the pilgrimage trek for a first-hand view of the high environmental costs of pushing hundreds of thousands of human beings along hitherto pristine streams and rivers, and into hitherto unspoilt meadows and mountains.

It is more than likely that a direct experience of the human waste and refuse littering what nature had meant to be inviolate and unpolluted would convince the governor about the dire need to scale the yatra down drastically in duration as well as magnitude. It would also help to have environmental experts conduct a real-time evaluation of the pilgrimage (while the ytara is still underway) rather than bring them in when the highly fragile ecological zone in undisturbed by massive human intrusion.

As the chairman of the SASB, Governor Vohra is the guardian of the sanctity of the pilgrimage as well as the ecological health and well-being of the vast tracts of natural assets it encompasses. His predecessor has severely compromised both by pandering to the greed and avarice of ruthless operators who have turned faith into filthy lucre besides using religion to advance their political agenda.

Kashmir looks to the governor to restore the Amarnath Yatra to its innocent and pure past, when politics, money and venality had no role, and the pilgrimage was a symbol of simplicity and devotion, posing almost no threat to the environment. Mr Vohra must use his immense experience and wisdom to convince India about the deadly import of having hundreds of thousands of people flocking fragile and endangered mountain zones for weeks on end. A reasoned and cogent exposition of the case before the masses would certainly neutralize the sangh parivar's venomous and false propaganda over any demand to revert the pilgrimage back to its original and religiously-sanctioned form.

Given the credibility he enjoys in the country, Governor Vohra is placed best to puncture the VHP's sanctimonious balloon, and keep its poisonous influence out of the Amarnath Yatra.

s the plea for sustainable development feasible and sustainable? More importantly, is it possible to keep it sustainable within the current socio-economic format? Integrating sustainable development into our lives is both urgent and inevitable. However, is the present strategy of conducting empirical case studies on the dangers of development an effective way of addressing this urgency? Unlike any other peril the world has faced so far, the present untenable form of development poses a danger that is as unpredictable as it is absolutely catastrophic in nature. It affects not only individuals but also entire societies. Not confined to any particular time or to a region, it threatens to destroy the entire world as we know it.

Harmful developmental practices are so pervasive and intricately interwoven with different aspects of human life at present that replacing them seems almost impossible. They operate outside the purview of freedom and choice. In fact, the majority of people are not aware of how they are unwittingly caught up in using the products of and contributing to the current form of development. Even products such as solar energy or electric vehicles that are offered by those advocating sustainable development use a lot of resources from hardcore elements of development, especially the hardware. There is a wide chasm between the implacable pace of development and the plea for sustainability, with the latter's chances of success looking increasingly bleak. However, people are not sufficiently convinced about the immediacy of the dangers. There is an urgent need to present a comprehensive picture of the extensive range and reach of irresponsible developmental practices and to correlate them with the effects on our daily lives and with the near future.

We are stuck between the inescapable need for sustainable development and the impossibility of at least reducing the scope of the present harmful practices. Those advocating for sustainable development have made serious attempts to highlight the dangers of global warming and the ensuing ecological crisis and demonstrated the utter ruination that they will bring about. Despite this, neither the empirical evidence of the dangers of uncontained development nor the scary picture presented of the inevitable destruction has been able to convince either the producers or the consumers to change their ways. Unless people are convinced about the imminent need for action to avert the looming crisis, there is no hope for survival.

Although the potential threat is massive and global, most empirical studies, by their very nature, focus only on specific aspects. However, compiling various specific studies does not lead to a complete picture of the impending catastrophe. For instance, chemical fertilisers are used to increase agricultural production, pesticides for protecting the crops, and preservatives to prevent spoilage during storage and distribution. Despite the wellknown hazards of using these chemicals, which are dangerous both to soil and human health, people still continue to depend heavily on them in modern agricultural practices. It is disheartening to see that even the most educated and enlightened sections of society are not able to envisage the catastrophic danger to humanity due to the consumption of chemically-contaminated food, or the havoc wreaked by global warming on the climate, leading to devastating natural calamities, or the dangers of air and water pollution. The list is rather long.

The empirical studies that are used to show the dangers of development arise from empiricism, a dominant school of philosophy formulated by Francis Bacon. Interestingly, it was Bacon who also provided the foundational ideas for what ultimately evolved into the modern form of development. He rejected the classical formula where knowledge is related to liberation and instituted an alternative formula where knowledge about nature is for use and exploitation by human beings. So using empirical case studies to critique modern development may not accrue desirable results. Scientists and social scientists, who are actively working for sustainable development, need to explore nonempirical and non-modern resources to present a strong critique of unsustainable development. It is possible to explore, in a selective manner, non-modern, traditional philosophies consisting of both classical and folk theories that present a non-exploitative attitude to nature. Such rich imaginative accounts can help in effectively presenting before the people the massive, unprecedented calamity and irreversible damage caused by development. There is a need to veer away from using empirical methods to critique development, which is itself a product of empiricism, and move towards non-empirical and metaphysical theories to present the critique.

How was it possible to sustain during premodern times what is now threatened by modern development? Exploring this need not be tantamount to endorsing the social evils justified and legitimised in non-modern theories and societies. On the contrary, this can lead to identifying the intellectual resources available in non-modern societies that allowed them to both sustain and nurture nature while also legitimising social evils like untouchability and slavery. Similarly, there is a need to recognise that while modern societies have endangered nature, they have also managed to eradicate many of the earlier social evils.

In this new debate, both virtues and vices of the modern and the premodern are critically evaluated. Both the empirical and the transcendental provide an alternative basis for the formulation of the critical discourse on sustainable development for nature and society. This critical scrutiny and assessment of the empirical and the non-empirical would explore the manifold aspects, extending the purview of the present debate on sustainability. This can provide a basis for relaunching sustainable development.

Guj Police Take Teesta Setalvad In Custody, Arrest Ex-DGP Sreekumar For `Fabricating Evidence' Day After SC Upholds SIT Clean Chit To Modi many of the allegations in Zakia

Ahmedabad: A day after the Supreme Court upheld the clean chit given by an SIT to Prime Minister Narendra Modi in the 2002 riots cases, Gujarat police on Saturday arrested former Director General of Police R B Sreekumar and took in custody social activist Teesta Setalvad for allegedly conspiring to falsely implicate innocent persons.

The First Information Report, based on a complaint filed by an Ahmedabad crime branch official, also named former IPS officer Sanjiv Bhatt, who is already in jail in another case.

Setalvad, who was picked up from her Mumbai residence, claimed her arrest was illegal and apprehended threat to her life.

She will be arrested once she is brought to Ahmedabad, police sources said. Bhatt is sentenced to life imprisonment in a custodial death case, and in another case he is accused of planting contraband to frame a lawyer in a false case

Setalvad was detained from her house in the Juhu area of Mumbai and later taken to Santacruz police station for informing the local police about her detention, sources said.

"She has been taken by the Gujarat Anti Terrorist Squad.... we were not informed in advance about the case. They barged into the house and assaulted her before taking her with them," alleged her lawyer Vijay Hiremath.

others. The complaint also accused Setalvad of influencing and tutoring witnesses and making them depose on pretyped affidavits. Even Zakia Jafri was tutored by Setalvad, as was clear from her statement before the Nanavati Commission on August 22, 2003, it said.

IPS officers Bhatt and Sreekumar -- who was addi-tional DGP of Armed Unit during the 2002 Godhra riot, and intelligence DGP soon after -- had made several depositions before the Nanavati Commission of Inquiry that were against the Gujarat government, the complaint said.

Bhatt allegedly forged various documents mailed to the SIT and also falsely claimed he attended a late night meeting on February 27, 2002, called by the then chief minister (Modi) at his residence, it said. Sreekumar's nine affidavits before the Nanavati-Shah Commission were the source of Jafri's petition, it claimed. In its judgment passed on Friday, the Supreme Court had

observed that "At the end of the day, it appears to us that a co-alesced effort of the disgruntled officials of the State of Gujarat along with others was to create sensation by making revelations which were false to their own knowledge. "The falsity of their claims had been fully exposed by the SIT after a thorough investigation ... As a matter of fact, all those involved in such abuse of process, need to be in the dock and proceed in accor-dance with law," the court order said. In its judgment, the apex court had also noted the objections raised by the respondents on Setalvad joining as petitioner number two in the plea after Jafri. The respondents objected on the grounds of Setalvad's "antecedents" and also for her 'ulterior design by exploiting the emotions and sentiments of appellant--Zakia Jafri, the real victim of the circumstances." However, no direct role of Setalvad was mentioned in the court verdict. Jafri's husband and former

Congress MP Ehsan Jafri was killed during the riots.

A police officer in Mumbai said Setalvad handed a written complaint to Santacruz police station (when she was taken there), and "they are processing it." Setalvad's complaint alleged that Gujarat police "barged into" her compound, did not show her a copy of the FIR or warrant against her, and there was a "big bruise" on her left hand.

"I fear seriously for my life," her complaint added.

Maha Crisis: Cops Deployed At Offices Of Political Parties, Leaders In Mumbai; **Prohibitory Orders Till July 10**

Mumbai: With tempers running high among Shiv Sena workers following the rebellion by party leader Eknath Shinde, the Mumbai police have deployed its personnel at the city-based offices of various political parties and leaders, including ministers, MLAs and MPs, and their residences as a security measure, an official said on Saturday.

The instructions to remain alert and to provide security was taken at a meeting chaired by Mumbai Police commissioner Sanjay Pandey, where senior officials including the joint police commissioner (law and order), additional commissioners and zonal DCPs were present, he said.

The prohibitory orders issued by the city police under section 37 of the Mumbai Police (MP) Act in the first week of June, ahead of the Rajya Sabha elections, will continue to remain in place till July 10. It bans the assembly of five or more persons at one place.

A police official clarified that he had referred to the section 144 of the CrPc earlier in the day by mistake, but later clarified that the prohibitory orders are in place as per the section 37 of the Act.

On Saturday, cadres loyal to the Thackerays staged protests against the rebels by defacing their banners, hurling stones, and vandalising the office of an MLA in various parts of the state. Majority of Shiv Sena MLAs have shifted their loyalty to

minister Eknath Shinde and

are camping in Guwahati, plunging the Maha Vikas Aghadi (MVA) government led by Chief Minister Uddhav Thackeray, who heads the Sena, into a crisis. A few incidents of attack on the offices of rebel MLAs have taken place in parts of the state.

"The city police personnel have been asked to remain alert and maintain law and order situation in the city. They have been instructed to coordinate with the local leaders of political parties and get in advance the information related to their programmes, movement and deployment of bandobast during the meetings and political events," the official said.

Officials of the special branch have been asked to monitor the social media platforms and take action against those persons who are found posting objectionable content, messages, videos, police said.

"The police personnel have been asked to ensure that the workers of political parties do not take law into hand, indulge in violence or damage public property. The officials have been asked to take stringent action against the violators," he said.

The police staff has also been asked to ensure that no objectionable banner and hoarding comes up anywhere, the official said.

The prohibitory order issued earlier this month by DCP Operations, prohibits the assembly of five of more persons in view of the likelihood of breach of peace and disturbance of public tranquility.

Officials said the searches were also carried out in R S Pura sector in Jammu district and Hiranagar sector in Kathua district to keep an eye on any suspicious movement.

"Incriminating materials, 01 Pistol and other ammunition have been recovered from their possession. Further investigation into the matter is in progress," he added.

According to the spokesperson, the Chief Secretary advised them to remain vigilant and use social and other media to create awareness among people so that no rumor mongering occurs.

Mehta, he said, also asked them to create digital health records of patients visiting hospitals and integrate the same with Rapid Assessment System (RAS) for quality feedback of public.

"The Chief Secretary also maintained that the health infrastructure of the UT was upgraded to a larger extent during past few years. He reminded them it is for this reason that in the past the UT faced no major problem dealing with the pandemic. He suggested them to work for promotion of medical tourism here as the UT is set to establish medical cities in both the divisions here," he added.

Group Asks For Living Wages, Labour Rights For 2026 World Cup

With this year's World Cup in Qatar clouded by labor and human rights issues, there's a push for the North American cities awarded games for the 2026 tournament to commit to livable wages, equitable hiring and worker protection.

The Dignity 2026 coalition has brought together groups including the AFL-CIO, Human Rights Watch and the Independent Supporters Council to work with FIFA and the individual host cities in the United States, Canada and Mexico.

The coalition has met several times in the past few months with soccer's international governing body to discuss its commitment to these issues. With week's announcement last of the 16 cities that will host games, the effort has become

more targeted. They say FIFA is listening, but has not pledged to require minimum standards.

"That means looking at fair living wages, targeted local hiring, strong health and safety protections and agreements that make sure workers have a voice on the job. So we have given them about nine points that we would like to see implemented across all of the host cities. Because one of the things we have found is the cities haven't gotten guidance about what the expectations are," said Cathy Feingold, director of the international de-

partment at the AFL-CIO. "And so we think the best way

to handle this is to make sure there are very clear binding frameworks that unify all of the host cities."

FIFA did not respond to a request for comment.
