

No Respite In Sight, Kashmir Swelters In Intense Heat Wave Mercury Hits Season's New High In Srinagar At 34.2 Deg Celsius

SRINAGAR: Kashmir Valley continued to swelter under heat wave with Srinagar recording season's hottest day at 34.2°C even as monsoon rainfall brought about some respite to Jammu *4* on Thursday.

As mercury hit a new high this season in Srinagar, it was over 0.2°C higher than yesterday and 5.1°C above the normal for this time of the season, a MET official said. It also remained third highest in the last 12 years in Srinagar. On 9 June 2021, Srinagar recorded 34.7°C. The highest b June temperature in Srinagar in the last 12 years was 35°C

recorded on 3 June

2018. The highest ever June temperature in Srinagar was 37.8°C, recorded on 29 June 1978. Meanwhile, Qazigund re-

corded a maximum of 31.9°C against 32.5°C on the previous day. The temperature was 4.2°C above normal for the gateway town of Kashmir, he said. Pahalgam recorded a maxi-

mum of 29.2°C against 28.9°C on the previous day. The temperature was 4.4°C above

normal for the famous resort in south Kashmir during this time of the season, he said

Kokernag recorded 30.9°C against 31.7°C on the previous day. It was 3.6°C above normal for the place in south Kashmir during this time of the season, the official said.

Gulmarg recorded a maxi-mum of 24.2°C against 24.0°C on the previous night, the official said. While 20.6°C is normal for

the world famous skiing resort during this time of the season, the official said that the temperature was 3.6°C above normal for the famous place in north

Kashmir's Baramulla district. With overnight monsoon rainfall, Jammu recorded a maximum of 31.7°C against

38.1°C on the previous night, the official said. The temperature was 4.6°C below normal for J&K's winter

capital, he said. Banihal recorded a maximum of 28.8°C, Batote 25.4°C, Katra 27.4°C while Bhadarwah had a minimum of 32.7°C, the official said.

Earlier the weatherman said that monsoon arrived in plains of Jammu this morning. "From today onwards, expect

PAHALGAM: Chants of Bam Bam Bhole' and Har Har Mahadev' reverberated the air at daybreak as ecstatic pilgrims began an arduous journey of faith to the Amarnath Cave Shrine housed among the mighty Himalaya peaks at an elevation of 3880 metres.

The first batch of about 2750 pilgrims left the Nunwan base camp here on the Pahalgam-Chandanwari route after being flagged off by Deputy Commissioner Anantnag, Piyush Singla, and secretary Tribal Affairs, Shahid Choudhary early in the morning.

Wearing their faith on their sleeves, the pilgrims men, in-cluding sadhus, women, old, young and children freshened by an early morning cool breeze of the famous tourist resort, assembled at the gates of the base camp after reaching here on

formed ice-lingam at the cave shrine, which usually takes three days on foot via this route with night halts at Sheeshnag and Panchtarni.

The pilgrims expressed happiness over the resumption of the annual pilgrimage this year after a gap of almost three years. In 2019, the Yatra was curtailed days ahead of the abrogation of Article 370. The pilgrimage did not take place in 2020 and 2021 due to the COVID-19 pandemic.

China Opposes India's Plan Of G20 Meeting In J&K

BEIJING: China on Thursday voiced its opposition to India's reported plans to hold the next year's meeting of G-20 leaders in Jammu and Kashmir, echoing close ally Pakistan's objection, and underlined that relevant sides should avoid "politicising" the issue.

"We have noted relevant information," Chinese Foreign Ministry spokesperson Zhao Lijian told a media briefing here on Thursday while replying to a question from the official media.

"China's position on Kashmir is consistent and clear cut. It is a legacy issue between India and Pakistan. It should be properly resolved in accordance with the relevant UN resolutions and bi-

lateral agreements," Zhao said. He said the "relevant parties should avoid complicating the situation with the unilateral move. We need to address the disputes through dialogue and consultation and jointly uphold

peace and stability." Stating that G-20 is a premier forum for international economic cooperation, Zhao said "we call on relevant sides to focus on economic recovery and avoid politicising the relevant issue so as to make a positive contribution to improving the global economic governance".

Asked whether China, a member of G-20, would attend the meeting, he said, "whether we attend the meeting, we will look into that."

To another question that China is building the China-Pakistan Economic Corridor in the disputed region in Pakistan controlled Kashmir (PcK) and India's objections over it. Zhao said the two matters are completely different in nature. China has undertaken projects to help Pakistan to grow its economy | More on P6

SRINAGAR: The daily Coronavirus cases continue to show a slight increase in Jammu and Kashmir as 83 more people tested positive for virus on Thursday while no fresh fatality was reported from the Union Territory during the last 24 hours.

According to officials, the Jammu division registered 59 fresh cases of novel Coronavirus while 24 others were reported from Kashmir Valley, taking the total number of people infected since the onset of pandemic in J&K to 455089.

Air Pollution Increases Risk Of Premature Death By 20%: Study

Exposure to above average levels of outdoor air pollution increases the risk of premature death by 20 per cent and mortality risk from cardiovascular disease by 17 per cent, according to a study.

The research, published in the journal PLOS One, shows that along with high blood pressure, diabetes, and smoking, environmental factors such as air pollution are highly predictive of people's chances of dying, especially from heart attack and stroke.

Using wood- or kerosene-burning stoves, not properly ventilated through a chimney, to cook food or heat the home also increased overall risk of death by 23 per cent and 9 per cent and cardiovascular death risk by 36 per cent and 19 per cent, the researchers said.

Living far from specialised medical clinics and near busy roads also increased risk of death, they said.

Researchers from NYU Grossman School of Medicine and the Icahn School of Medicine at Mount Sinai, US, collected personal and environmental health data from 50,045 mostly poor, rural villagers living in the northeast Golestan region of Iran. All study participants were aged over 40 and agreed to have their health monitored



during annual visits with researchers dating as far back as 2004.

The study not only identifies environmental factors that pose the greatest risk to heart and overall health, but also adds much-needed scientific evidence from

people in low and middle income countries.

Traditional research on environmental risk factors, the researchers noted, has favoured urban populations in high-income countries with much greater access to

modern healthcare services.

The study showed that the one-third of study participants who lived within 500 metres of a major roadway had a 13 per cent increased risk of death.

"Our study highlights the role that key

environmental factors of indoor/outdoor air pollution, access to modern health services, and proximity to noisy, polluted roadways play in all causes of death and deaths from cardiovascular disease in particular," said study senior author and cardiologist Rajesh Vedanthan.

"Our findings help broaden the diseaserisk profile beyond age and traditional personal risk factors," said Vedanthan, an associate professor at NYU Langone Health.

The study showed that other environmental factors included in the analysis -- low neighbourhood income levels, increased population density and too much night time light exposure -- were not independent predictors of risk of death, despite previous research in mostly urban settings suggesting otherwise.

The researchers analysed data gathered through December 2018. They then created a predictive model on overall death risk and death risk from cardiovascular disease.

The researchers plan to continue their analysis and hope to apply the predictive model to other countries with the aim of fine-tuning its predictive capacity.

Their new tool could serve as a guide for evaluating the effectiveness of environmental, lifestyle and personal health changes in reducing mortality rates worldwide, they said

pital with severe COVID-19, analysing their thyroid-stimulating hormone (TSH) and other indicators.

"Knowing that thyroid hormones VID-19 disease the occurrence of correlate with the disease severity is important, and the fact that the thyroid gland seems directly

in the COVID-19 patient population and the thyroid function, as well as inflammatory indicators, returned to normal in nearly all instances shortly after the end of their COVID-19 illness, the researchers said.

However, after 12 months thyroiditis regions remained visible at thyroid ultrasound in half of the individuals, even if reduced in size.

The thyroid uptake of technetium or iodine, an indicator of thyroid function, was still reduced in four out of six individuals at nine months, although it had mostly recovered after 12 months. The long-term clinical consequences, if any, are unknown, according to the researchers.

LCMA Demolishes Several Illegal **Constructions In Various City Areas**

Srinagar: Continuing with its demolition drive to remove illegally raised structures, the Lake Conservation & Management Authority (LCMA) through its Enforcement Wing on Thursday demolished several illegal constructions, structures in various areas of its jurisdiction.

The Enforcement Officer of LCMA said the structures were demolished at Harwan, Lal Bazar, Nigeen, Saida Kadal, Nishat, Braine Upper, Ishber & Nowpora.

During the demolition drive two 1st storey, one 2nd storey, one 3rd storey, one shed, one tin walling, two Plinths, one wall Block and pillars were demolished on spot. Further, illegally dumped earth filling in the areas of Tailbal and Saidakadal was also removed and seized.

Legal action was also initiated against the violators. The demolition team was accompanied by a police party from PCR.

'The demolition drive will continue and elements creating hurdles in the process will be dealt with under law"

LCMA has appealed to the people living within the jurisdiction of the Authority not to take any illegal construction in the prohibited area and warned of stern action against the violators as warranted under law.

Seeking public cooperation in saving the Dal and Nigeen lakes from falling prey to encroachers, LCMA Authority said that stern action shall be taken against those raising illegal constructions.

Valley Rivers Swell As Glaciers Melt Pulwama Areas Under Laar Waters

SRINAGAR Rivers and streams in the valley have registered an alarming increase in water levels due to the intense spell of heal gripping the region

Several government departments have been put on alert to deal with an imminent threat of floods, even as over two hundred households have been displaced in Pulwama due to waters from the swollen Laar nullah entering inhabited areas.

Glaciers melting under the abnormally high temperatures have raised levels in the Jhelum and other rivers and streams of the valley.

In Pulwama a sudden surge in the Laar stream has inundated a large area in Jora village displacing 250 of its six hundred households, a KNS report said.

uses have come under water and hundreds of kanals of land have been submerged, the report said. People have fled their homes seeking higher ground for safety.

The Aribal area, located on the banks of the Laar too has been inundated. Water has entered dozens of residential houses the report said. A delegation from the affected areas has met the additional

deputy commissioner Pulwama to apprise him of the situation. The ADC has directed the tehsildar concerned to dispatch a

team to review the situation and organise relief for the flood-hit population

Water has entered paddy fields in several places in the utile? because of rivers over-flowing their banks.

Experts fear that a flood situation is imminent if the heat spell persists with its present intensity. The govt has ordered the departments concerned at the district level to be on alert to deal with any eventuality.

The metrological department says that although the maximum temperature is 5 degrees Celsius above normal and the minimum temperature 7 degrees Celsius above normal, the present situation cannot be characterised as an intense or extraordinary heat wave

The rest of the Country is experiencing normal monsoons and rainfall can be expected in the valley within the next two to three days, a spokesman of the metrological department said. (Kashmir Observer, 01 July, 2005)

LG's Outreach ieutenant Governor Manoj Sinha on Wednes-

day pleasantly surprised everyone by inviting the heads of the political parties for an evening meeting at Raj Bhawan. The meeting discussed the arrangements for the ongoing Amarnath yatra. In a tweet, LG said he met representatives of political parties and discussed arrangements and management of Shri Amarnath Ji Yatra. "The sacred pilgrimage strengthens our faith in the goodness of mankind and its successful conduct is the responsibility of every citizen of J&K UT," a part of the tweet read. On their part, the J&K politicians said the yatra has remained part of Kashmir ethos and that it is a belief shared by all people in the union territory. The meeting was hosted by Sinha hours after he flagged off the first batch of Yatris from Jammu's Bhagwati Nagar base camp.

That said, it was the first time that the LG has invited J&K leaders for a meeting, among them the leaders of the PAGD with whose politics the government has differed with. But on the question of yatra, all of them, except a few, come together. Did the meeting discuss anything besides the Amarnath pilgrimage? Nothing is known so far. The meeting was brief and called at very short notice. The PDP leader Mehbooba Mufti chose not to go. Her party said that they should have been informed about the meeting days ago and brief about its agenda. However, the National Conference president Dr Farooq Abdullah attended the meeting together with the BJP president Ravinder Raina, the leader of the AAP party Altaf Bukhari, Muzaffar Hussain Beigh and the others. And according to the LG, the leaders, "speaking in one voice observed that Shri Amarnath Ji Yatra is like a big festival, a celebration of Kashmiriyat for common man of J&K and each and every citizen of UT will ensure warm hospitality & comfort of the pilgrims.'

It would be interesting to see what redeeming difference to the existing state of affairs would be made by the fresh engagement between the government and the major politicians of the UT. The situation has not been encouraging on this front over the last three years. Last year in June, heads of the political parties in the UT had met the prime minister Narendra Modi and the home minister Amit Shah in New Delhi. The PM had assured J&K leaders that his government will take steps to end "Dil ki doori aur delhi ki doori (distance between hearts and the distance with Delhi). But many J&K parties, particularly those from the Valley have often said that centre has taken no follow-up action since. Here's hoping that the situation changes for the better from hereon.

3 Mistakes That Damaged Uddhav Thackeray

There is no doubt that **Uddhav Thackeray** failed as a leader. In 2019, by dumping the BJP, he ended a trusted relationship of more than three decades. They were natural allies. Both had Hindutva in their hearts. His calculation was that the BJP. which had outperformed the Sena in elections, would have swallowed the regional party

an Uddhav Thackeray survive this debacle? That's the big question after he resigned last night as Chief Minister, cornered by his own party, a large faction of which has turned against him.

Many have already written the political epitaph of Uddhav Thackeray, alleging that does not have the talent of his father to fight back, that he is too simple a man to fight the sharks that swim in the political waters of Mumbai. Balasaheb was undoubtedly of a different mettle. He was aggressive, he was a dare-devil, he knew when to bend and when to roar (he was frequently called a lion or a tiger) to threaten opponents, including with street violence.

But the aggression was a development of the 1980s. During the Emergency, when he faced with Indira Gandhi's might and fury, he caved in meekly. He was told by the then Maharashtra Chief Minister that he had only half an hour to either publicly support the Emergency or go to jail; he did not waste time and chose the former. Balasaheb was young and nobody thought at the time that one day, he would rule Mumbai, the absolute power behind successive governments. Uddhav Thackeray, unlike his father, doesn't come across as flexible. If he had read the nature of the Modi regime and character of the BJP after 2014, he would not have been bested. Or at least it would not have caught him so unaware. There is no doubt that Uddhav Thackeray failed as a leader. In 2019, by dumping the BJP, he ended a trusted relationship of more than three decades. They were natural allies. Both had Hindutva in their hearts. His calculation was that the BJP, which had outperformed the Sena in elections, would have swallowed the regional party. He was right in that. The BJP under Narendra Modi is determined to expand its hold so that it greatly reduces any dependence on allies. Maharashtra is the country's richest state. Mumbai is the financial capital, and the BJP believes it must be able to take charge of the area without needing a partner of significance. In Devendra Fadnavis,

it has a leader who is aggressive about winning by hook or by crook, within the party and outside. Uddhav Thackeray found it too intimidating and insulting to play second fiddle to the BJP. But the mistake he made was that he broke Balasaheb's golden rule. Instead of being king-maker, he de-

cided to be the king. Balasaheb was powerful in Mumbai and in Maharashtra even before he allied with the BJP and formed the government in 1995. It was impossible to ignore him. He had an army of subalterns who were ready to do anything for him - including breaking the law. In a way he was a 'political underworld' who was accountable to none. Balasaheb was clever enough not to become the Chief Minister in 1995; he gave the job to Manohar Joshi. Everybody in Mumbai knew where the real power lay, who was the Sarkar, but this Sarkar was not accountable to the public. He was not responsible for the failures of the government. So when Manohar Joshi failed, he was replaced by Narayan Rane. Easy.

Once Uddhav Thackeray decided to be Chief Minister, he exposed himself to critics, including within his own Sena, of making compromises for power. Instead of being the arbiter for power-hungry Shiv Sena politicians, he was seen as competing with them for power. He was no different...the Thackeray mystique shredded. I don't know if he was guided by Pawar Politics, but he should have been guided by his father's strategy instead. Once Eknath Shinde revolted, Uddhav Thackeray realised his mistake. Leaving the Chief Minister's bungalow much before he resigned as Chief Minister was an attempt at course correction, but the damage was irreversible by then. Uddhav Thackeray made another mistake - in putting his son in his Cabinet. Like Balasaheb, Kanshi Ram was supremely powerful because he never sought to be Prime Minister or Chief Minister: with this moral authority. those who took office from their teams dared not defy them. In India, moral authority can be more effective than political power. Making son Aaditya a minister allowed allegations of nepotism and dynasty.

The third mistake was that he allowed for perception to build of Sharad Pawar as king-maker. He was the chief negotiator and trouble-shooter of the government, godfather of the three-party alliance. In a way Sharad Pawar replaced Balasaheb. He donned the role of senior Thackeray. The power centre moved away from 'Matoshree'. Instead of Thackeray, Pawar became the Sarkar. Balasaheb and Sharad Pawar were good friends, but Balasaheb was never seen to be dependent on anyone for advice. Even when Sharad Pawar became very powerful in Delhi politics, it was he who used to visit Balasaheb and not the other way around.

Uddhav Thackeray's inexperience in part allowed Sanjay Raut too large a space within the Sena, upsetting other senior leaders, who were already opposed to the new alliance with the Congress and Sharad Pawar.

But Uddhav Thackeray has made three important decisions:

1. He did not let himself be defeated on the floor of the House. He cannot be accused of seeking any unethical deal with the rebels or with the BJP. He showed maturity in his emotional appeals to the rebels to sit across the table and discuss things, he said he was ready to make amends. Sanjay Raut can be faulted for his language during the crisis, but Uddhav Thackeray

Frontiers of regulation

here are fears that this missive will immediately invalidate business models used by the large 'challenger' credit card players who use credit lines loaded by non-bank partners, to offer revolving credit facilities. Wallet and app providers who offer Buy Now Pay Later (BNPL) facilities for small-ticket transactions are unclear if this diktat applies to them.

Given that RBI has not shared this directive publicly, one only can only guess at the regulatory intent behind it which may be two-fold. One, given the systemic risks posed by unsecured retail lending, RBI may be keen not to allow too many non-bank players to enter the revolving credit business. The regulator has so far been quite conservative in authorising entities to issue credit cards; it recently clarified that NBF-Cs cannot issue credit cards without its express approval. Instruments such as challenger cards, which use tripartite agreements between a fintech player, bank and NBFC to offer revolving retail credit, essentially allow non-banks to bypass these rules. Burgeoning volumes of unsecured retail credit outside of Indian banks' books could turn a headache for RBI as this could pose systemic risks. Two, RBI could also be worried about opaque practices of wallet-based lenders offering unsolicited loans which put the borrower's credit score at risk. Many instances have surfaced of online shoppers being lured with freebies, into loans for small-ticket transactions with neither explicit consent nor disclosures on processing fees, credit period and interest. Given that most fintech lenders swear by 'instant processing' of loans and rush through the KYC process which requires sharing of sensitive Aadhaar and PAN details, there's high risk of ID theft and misuse too. To plug this, RBI must insist on fintech players putting in place water-tight security measures and making upfront disclosures on the terms of each loan.

Fintech players need to take this episode as a wake-up call on not predicating their entire business model on regulatory loopholes or grey areas, in the hope that RBI will look the other way. RBI on its part needs to recognise that new-age fintech players, warts and all, do offer innovative products that offer enormous ease of transaction to the consumer. They make credit and savings products accessible to the vast population of retail folk unserved by mainstream banks. It must thus strive not to throw the baby out with the bathwater, while cracking down on doubtful practices in the sector.

Increase Duration of Summer Vacations

NATO Vows To Guard 'Every Inch Of Territory' As Russia Fumes

Madrid: An unstable world could get even more dangerous if NATO does not remain strong and united, the head of the alliance said Thursday at the end of a summit where Western leaders labelled Russia a direct threat to the security of their nations.

During their three-day meeting in Madrid, NATO members confronted a geopolitical landscape marked by big-power competition and myriad threats, from cyberattacks to climate change. The leaders cast their sights around the world - drawing a rebuke after accusing China of posing serious challenges to global stability. But Russia's invasion of Ukraine dominated the summit.

We live in a more dangerous world and we live in a more unpredictable world, and we live in a world where we have a hot war going on in Europe," NATO Secretary-General Jens Stoltenberg said. At the same time, we also know that this can get worse.

That is why the Western military alliance has a core responsibility to keep the war in Ukraine from spilling into other countries while making clear to Moscow that it would protect every inch of NATO territory, Stoltenberg said.

That territory is set to grow. At the summit. NATO leaders formally invited Finland and Sweden to join the alliance,

after striking an agreement to end opposition from Turkey. However, Turkish President Recep Tayyip Erdogan said he could still block the Nordic countries' membership, if the Nordic pair do not keep their

promises. If the accession is approved by all 30 member nations, it will give NATO a new 800-mile (1.300 kilometer) border with Russia.

Russian President Vladimir Putin warned he would respond in kind if Sweden or Finland agreed to host NATO troops and military infrastructure. He said Russia would have to create the same threats for the territory from which threats against us are created. Estonian Prime Minister Kaja Kallas said Putin's threats were nothing

Of course, we have to expect some kind of surprises from Putin, but I doubt that he is attacking Sweden or Finland directly, Kallas said.

NATO leaders turned their gaze south for a final summit session Thursday focused on Africa's Sahel region and the Middle East, where political instability aggravated by climate change and food insecurity sparked by the war in Ukraine is driving large numbers of mi-

grants toward Europe. The U.S. and other Western nations also are seeking to counterbalance the growing influence of China and Russia in the

developing world. Stoltenberg said "Moscow and Beijing are using economic leverage, coercion and hybrid approaches to advance their interests in the region. Beijing government The

called the alliance a Cold War remnant and accused it of maliciously attacking and smearing China by including it on NATO's list of global challenges.

But Stoltenberg said it was Russia's invasion of Ukraine that had brought the biggest overhaul of our collective defense since the end of the Cold War. In response, NATO has poured troops and weapons into Eastern Europe on a scale unseen in decades.

The NATO leaders agreed at the Madrid summit to dramatically scale up military force along the alliance's eastern flank, where countries from Romania to the Baltic states worry about Russia's future

plans. NATO announced plans to increase almost eightfold the size of the alliance's rapid reaction force, from 40,000 to 300,000 troops, by next year though details of specific troop commitments remained vague.

Most of the troops would be based in their home nations but dedicated to specific countries in the east, where the alliance plans to build up stocks of equipment and ammunition. Member nations have given

Ukraine billions in military and civilian aid to strengthen its resistance. Ukrainian President Volodymyr Zelenskyy, who addressed the summit by video link, asked for more.

He urged NATO to send modern artillery systems and other weapons or face a delayed war between Russia and yourself.

The question is, who's next? Moldova? Or the Baltics? Or Poland? The answer is: all of them, he said.

US President Joe Biden, whose country provides the bulk of NATO's firepower, announced a hefty boost in America's military presence in Europe, including a permanent US base in Poland, two more Navy destroyers based in Spain, and two more F35 squadrons in the UK.

Before the war started, I told Putin that if he invaded Ukraine, NATO would not only get stronger, but would get more united, Biden told reporters. And we would see democracies in the world stand up and oppose his aggression and defend the rules-based order. That's exactly what we're seeing today.

Still, strains among NATO al-lies have emerged as the cost of energy and other essential goods has skyrocketed, partly because of the war and tough Western sanctions on Russia. There also are tensions over how the war will end and what.

if any, concessions Ukraine should make.

Money remains a sensitive issue just nine of NATO's 30 members currently meet the organization's target of spending 2% of gross domestic product on defense.

Britain, one of the nine, announced a further 1 billion pounds (1.21 billion) in military support to Ukraine on Thursday. Prime MInister Boris Johnson said the U.K. it would increase military spending to 2.5% of GDP by the end of the decade. Host country Spain, one of the lowest spenders in the alliance, aims to hit the 2% target by 2029, Prime Minister Pedro S nchez said.

The summit also produced a new Strategic Concept, NATO's once-a-decade set of priorities and goals.

The last such document, in 2010, called Russia a strategic partner. Now, NATO accuses Russia of using coercion, subversion, aggression and annexation to extend its reach.

The 2010 document made no mention of China, but the new one flagged Beijing's growing economic and military reach as a a challenge to NATO's members.

NATO said that China strives to subvert the rules-based international order, including in the space, cyber and maritime domains and warned of its close ties with Moscow.

CBI Registers Three FIRs Against Imposters Claiming To Be From PMO

New Delhi: The CBI has registered three FIRs based on complaints from the Prime Minister's Office that some imposters were trying to exert influence by claiming to be working in the PMO, officials said Thursday.

The CBI has taken over the investigation to look into the three complaints filed by the PMO.

It has registered three separate FIRs against unidentified persons, one Prince and Shiva Kumar, the officials said. "It has come to the notice of

this office that Manoj Kumar Meena, IPS(2012, AGMUT) posted in Chandigarh has been approached by a person claiming to be Rohit Yadav, Joint Secretary, Prime Minster's Office (PMO) using mobile number 7009808342 and soliciting transfer of a police constable," the complaint, now converted into the FIR against

unidentified persons, alleged. It said prima facie it appears to be a case of impersonation of PMO official since no such call was made by such official and the

number is also not of the official. The second case relates to a person claiming to be working as personal assistant in the PMO who assured a person named Ravikant Kharab that he would procure a job in Reserve Bank of India for a bribe of Rs 3

lakh, the officials said. It is alleged Kharab paid Rs 25,000 to a guy named 'Prince', they said.

The third case relates to Kerala-resident Shiva Kumar who calls himself a cardiac surgeon and health advisor to the Prime Minister of India and Nepal, they said.

"Scrutiny of the complaint has revealed that a person named Dr. Shiva Kumar from Kerala has been learnt to be impersonating as PMO official and making calls to people from his mobile number 080759-94461, allegedly claiming to be Personal Advisor to the Hon'ble PM," the complaint had alleged.

This will be the first major international summit expected to be held in Jammu and Kashmir after its special status guaranteed under Article 370 of the Constitution was withdrawn and the erstwhile state was divided into two union territories in August 2019.

Pakistan Foreign Office spokesperson Asim Iftikhar Ahmad said in a statement that Islamabad had taken note of news items appearing in the Indian media indicating that India might be contemplating to hold some G20-related meeting in Jammu and Kashmir.

"Pakistan completely rejects any such attempt by India," Ahmad said.

He said it was a well-known fact that Jammu and Kashmir is an internationally recognised disputed territory between Pakistan and India, and has remained on the agenda of the United Nations Security Council for over seven decades.

He hoped that in case of any such controversial proposal from India, the G20 members will be fully cognisant of the imperatives of law and justice and would reject it outright.

part of each year in all states and union territories so that the final publication of the electoral rolls could be made in the first week of January of the succeeding year.

However, due to various reasons, the annual revision of electoral rolls could not be undertaken in Jammu and Kashmir after special summary revision, 2019.

In the meantime, an exercise to redraw the boundaries of constituencies in the UT was in progress and the finally delimitated segments were notified by the Delimitation Commission on May 5 this year.

As the revision of electoral rolls was not conducted for the last three years in Jammu and Kashmir, new eligible electors could not get themselves registered in the electoral rolls, the letter noted.

... in order to update electoral roll on the basis of newly delimitated constituencies, so that all newly eligible young electors can have the opportunity to get themselves enrolled, the exercise of Special Summary Revision with reference to the next qualifying date is required to be undertaken without further delay," the letter said.

The electoral roll revision needs to be carried out before the first assembly election is conducted in the Union territory of Jammu and Kashmir.

Setting in motion the process of holding assembly polls in Jammu and Kashmir, the Election Commission had earlier this month initiated the revision of electoral rolls following the delimitation exercise in the union territory and the draft rolls will be prepared by August 31.

According to the timeline, integrated draft electoral roll will be published on September 1. The entire month of September has been kept for filing claims and objections which are to be disposed of by October 15.

The Catalan club said investment firm Sixth Street will invest 207.5 million euros (\$215 million) in exchange for 10% of the club's Spanish league TV rights for the next 25 years.

Barcelona called the agreement "a major step forward in the improvement of the club's financial resources and competitive positioning.'

The club said the transaction allows Barcelona to generate total capital gains of 267 million euros (\$277 million) for the current season.

tient, sustainable, and efficient strategy to strengthen the club's financial footing," club president Joan Laporta said. "Sixth Street is a proven supporter of football, an experienced investor across global sports and media, and a partner that will contribute significant knowledge and resources while allowing us to independently manage our operations.'
