Mercury Settles At 33.4 **Degree Celsius In Srinagar** 



### **Child Mortality Rate On Decline In J&K**

#### **IMR** Decreases From 49 In 2008 To 17 In 2020

Srinagar: The infant mortality rate in Jammu and Kashmir has decreased from 49 in 2008 to 17 in 2020, a survey has revealed.

As revealed in the Sample Registration System (SRS) 2020-22 (survey period), Jammu & Kashmir has registered considerable improvement in various health indicators including Infant Mortality Rate (IMR) during the last year. The IMR has decreased from 20 to 17 in a single year.

As per data, the earlier neonatal mortality rate in J&K has declined from 33 in 2008, 32 in 2009, 30 in 2010, 26 in 2011, 25 in 2012, 24 in 2013, 22 in 2014, 18 in 2015, 15 in 2016, 13 in

# **Lab-Grown Answers To Food's Triple Threat**

food crisis like few have ever seen could be the impetus for lab-grown and other food alternatives to thrive. But it won't be without its own challenges. Climate-related disasters, fall-

out from the pandemic and the Ukraine war are a toxic triple combination for food security. One recent global report estimat-

ed the number of people in food crisis has doubled since 2016. The problem is being exacerbated by rising fertiliser and energy costs and declines in regional grain supplies driven by droughts.

Supply chains bear the impacts of these cascading effects making it difficult for food systems to adapt sustainably. But technology startups and large food corporations are finding new ways to disrupt traditional food systems and supply chains for many, the toxic triple combination offers an opportunity.

Affordable, sustainable, alternative protein foods are gradually

becoming a commercial reality. We now see meat, seafood, dairy and eggs produced entirely from plant-based analogs or lab-grown foods. One company even creates alternative protein from the air we breathe.

Lab-grown meat involves a combination of tissue engineering, regenerative medicine, biomedical engineering, and biomaterials science enabling stem cells harvested from live animals to grow and proliferate in a bioreactor. As cells assemble into tissues,

natural or synthetic scaffolding material enables cell attachment, replicating the 3D multicellular structure of meat. Depending on the complexity of the final product, whether it be minced meat or steak, tissues can be harvested directly from the bioreactor or may undergo further design steps before final assembly.

Scientists are also producing meat using 3D bioprinting technology, where successive layers of cells (or bioink) are deposited on a substrate using computer-aided design and grown into muscle fibres. Japanese scientists at Osaka As cells assemble into tissues, natural or synthetic scaffolding material enables cell attachment, replicating the 3D multicellular structure

of meat. Depending on the complexity of the final product, whether it be minced meat or steak, tissues can be harvested directly from the bioreactor or may undergo further design steps before final assembly.

University recently created Wagyu beef using bioprinting, reproducing the uniquely beautiful Sashi marble design. They aim to automate cell-based meat production by 2025. But all that glitters is not gold.

While some companies aspire to end hunger and animal farm-

ing in large industrial manufacturing facilities - such as Upside Foods' new California meat plant - others imagine micro-carnery's , similar to craft breweries, focusing on niche markets and urban consumers. Either way, it signals a shift in the production of cellular-based products from rural to urban centres.

Despite advances, the field of cell-culture faces high production costs, bioreactor design flaws and food safety concerns. Many cellbased startups still rely on Fetal Bovine Serum as a source of nutrients, weakening the industry's animal-free ethical claims.

Lab-grown products combine new technologies developed for biomedical purposes with food production. Their arrival into the food space raises challenges about adequate regulations and labelling requirements.

Plant-based analogs represent another sustainable food path-Advanced fermentation way. technologies are currently being used in the production of plantbased meat, dairy and egg alternatives using synthetic biology or

genetically engineered protein in

yeast or bacteria. Fermentation provides large quantities of raw materials at relatively low cost, but also plays a key role in supporting plant-based and cultivated meat industries. For instance, the bleed in the Impossible Burger is created by leghemoglobin, a soy protein engineered in yeast. As the production of cultivated meat is scaled-up, fermentation will grow large volumes of nutrients and ingredients for cell culture.

While these new food techs may promising, plant-based seem meats still have unsustainable aspects. The narrow focus on protein as a solution obscures the diversity of animal and other farming practices that may contribute to climate-friendly food security. As startups race to normalise alternative protein products in our diets, massive layoffs in the biotech sector may threaten the expansion of these industries or at least reduce the number of companies currently operating in the space.

Another possible solution involves genome editing tech-niques such as CRISPR, which aim to increase crop yield and create animals resistant to disease. USbased firm Recombinetics recently bred genetically altered Angus cows to have short, slick coats, making them more efficient' in hot climates.

Gene editing promises to be cheaper than GM technology and faster than conventional breeding. Meat from gene edited animals is also on the horizon.

Gene editing does not insert foreign genes in plants or animal genomes; however, the technique may introduce unintended effects and potential risks with unknown health and environmental consequences. The US and the UK do not require an extensive review process to bring these plants and animals to market, however, the EU plans to regulate them as GMOs and demands stricter regulations.

While the promises made by high-tech foods to save the planet and feed the world rest on changing the dietary habits of consumers and their willingness to eat foods never previously eaten, the extent to which they will disrupt the global food system remains uncertain.

The challenges facing future foods revolve around the feasibility, transparency and reality of technology to effect social change and to solve environmental issues.

### Whole Lung Lavage **Performed First** Time In J&K

Srinagar: The therapeutic procedure Whole Lung Lavage (WLL) has been performed for the first time in Jammu and Kashmir for management of a rare lung disease.

The procedure was performed by a combined effort from Departments of Pulmonary Medicine and Anaesthesia of Government Medical College, Srinagar.

A male patient, 50, who presented with a one month history of shortness of breath on exertion and was found to have low oxygen saturation (60% on room air). On evaluation at CD Hospital with the help from Cincinnati Children' centre (USA) diagnosis of primary Pulmonary Alveolar Proteinosis was made. Pulmonary alveolar proteinosis is a rare lung disorder with an estimated prevalence of 0.2 -0.6 cases per 100000 individuals.

The disease is characterised by accumulation of milklike proteinaceous material in the Lung sacs affecting gas exchange and resulting in hypoxemia (low oxygen saturation). WLL is considered the standard of care for management of this rare disorder.

The procedure was successfully performed over three hours using 15 litres of sterile normal saline (to wash out the lung) in the theatre of Chest diseases hospital.

# Cabinet Okays Shahtoosh Trade Ban

#### **Observer News Service**

RINAGAR: The cabinet today approved in principle the proposal to ban Shahtoosh trade in view of the ban on it at national and international level and in pursuance of government policy on wildlife protection.

However, it was decided, be¬fore the ban comes into force, the state / government would re¬quest the Centre to provide one-time exception for sale of Shahtoosh stocks available with the traders in the state.

Announcing the decisions, the chief secretary said the trad-ers would be asked to declare their stocks and handover these to a nominated authority for all India auction to get competitive rates. The traders would indi-cate the reserve price for their produce and any return over and above that would go to a fund to be created for wildlife protection. The traders will get reserve price.

Jaily said that at the same time private owners of Shahtoosh shawls in the state may also be permitted on the basis of one-time exception to declare their stocks as there has been no ban in Jammu and Kashmir. This they will have to do before the ban comes into force.

The cabinet asked the indus¬try minister to invite Shahtoosh traders for discussion regarding modalities on imple menting this policy.

# Forced out

y putting in his papers, the first chairman of the State Accountability Commission, Justice (retd) R P Sethi, has exposed the chinks in the government's much-hyped war on corruption.

In absence of an official word, it is not clear whether the resignation has been accepted by the governor. Going by some sketchy reports that have trickled out, the governor has forwarded it to the chief minister seeking the advice of the government "on this important issue." At the same time, he is reported to have told Justice Sethi "to approach and seek the indulgence of the chief minister" on various issues which might have created an atmosphere of uncertainty over the fate of the Commission. However, the no-nonsense former judge of the Supreme Court rightly refused to do so asserting that "in view of the prevailing situation, it was not proper for him to speak to anybody in the government." Although the indications about the souring of relations between the government and the highest constitutional body charged with rooting out the canker were available only days after it was hesitatingly set up by the PDP-led government around the

end of its 3-year stint, the inevitable seems to have come at the most unlikely time, when the chief minister, Ghulam Nabi Azad, is in the midst of an all-out offensive against corruption in both administration and politics. The way the authorities have sought to create hurdles in the functioning of the high-profile body said to be a "deemed high court" ever since its creation did not leave even a grain of doubt in public mind that the government was not serious enough in its commitment to stamp out co ruption from public life. For some time past, the Commission did not hold its joint sittings as required under the Act, perhaps for the most trivial of the reasons; that it didn't have space on the dais for all its three members to conduct the hearings. Although Justice Sethi sought an amendment in its section 13 to enable constitution of separate benches to hold simultaneous sittings in Jammu and Srinagar, the government chose to sit over the proposal. Earlier, he had also asked for an independent investigating apparatus and the basic infrastructure in the shape of staff and accommodation Ironically, the ruling PDP, which led the coalition government for the first half of its 6-year incumbency, and established the State Accountability Commission not so much as a matter of conviction as to fulfill its main election pledge, never seemed to be serious in ridding the state of the cancer of corruption in public life. This was amply demonstrated by the delay it allowed in setting up the body for no strong reasons. By the time it was eventually formed, Jammu and Kashmir had earned the dubious distinction of being second most corrupt state after Bihar. Much was expected of the incumbent chief minister, who has vowed to give the people a corruption-free administration during his stint, for which the SAC could have been the most lethal weapon available to him. Sadly, however, it has been during his tenure that the Commission has encountered most roadblocks. Going by the reports, the sinister nexus between politicians, bureaucrats and criminals must have disenchanted Justice Sethi before he decided to take the harsh option. A large number of complaints the Commission received were against some sitting and former ministers and top bureaucrats who must have worked overtime to create the impediments. Indeed, Justice Sethi would not, on occasions, mind an unorthodox way to take on the corrupt which had even led to the raising of some eye-brows during the recent budget session of the state legislature inasmuch as the chief minister too was carried away by the insinuations of some members. Soon after his swearing in as SAC chairman, he had made no bones to even inspire sting operations to identify the corrupt. In his fight against corruption, he was keen to even assign a role to the Fourth Estate. Indeed, the gravity of the malaise would definitely call for an unconventional approach including a summary trial of the accused. Undeniably, the existing rules and procedures have proved to be totally ineffective to tackle corruption to the extent that various vigilance organizations find themselves embarrassingly unmatched for their daunting task. It is an open secret that they have themselves degenerated into corrupt outfits. With corruption cases accumulating by the day, the government has adopted a procedure under which the accused officials are even rehabilitated after some time of their suspension. All said and done, the government should come clean on its disposition towards the State Accountability Commission and its role as the premier constitutional body to rid the state of corruption in public life. The way the SAC, particularly its chairman, has been treated leaves one with an inescapable feeling that the government is not serious and sincere in rooting out corruption. The chief minister, in particular, needs to allay the misgivings created more so after the resignation of Justice Sethi.

# **Bilawal's Outreach**

AKISTAN'S foreign minister Bilawal Bhutto Zardari struck a blow for Ind0-Pak engagement by arguing during his recent speech at the Institute of Strategic Studies Islamabad that this was in Pakistan's interest. Bhutto-Zardari made his case by highlighting the failure of Pakistan's past policies which, in his opinion, had not helped his country achieve its objectives, "be it Kashmir, be it the rising Islamophobia (in India).' Pakistan, he contended, would be in a better position to influence Delhi's policy and prevent both countries from taking extreme positions through an economic engagement between the two. Bhutto-Zardari maintained that disengagement with India is ineffective despite "long histories of war and conflict".

Though the argument of Pakistan foreign minister for a sustainable Indo-Pak relationship is qualitatively different, the intention to reach out to India is not new. At the beginning of the last year, the now ousted Pakistan Prime Minister Imran Khan and the Pakistan Army Chief General Qamar Javed Bajwa had made similar conciliatory noises. Speaking at Islamabad Security Dialogue on March 17 last year, Khan said if peace was given a chance. India and the entire neighbourhood in South Asia could leverage economic dividends through trade in the resource-rich Central Asian region. In his speech at the same event on the following day, General Bajwa went a step further saying it was time for the two nuclear-armed countries "to bury the past and move forward."

Incidentally, these noises were made immediately following the re-affirmation of the 2003 ceasefire agreement along the Line of Control. But the two countries were unable to build on it to resume dialogue. Nor does it seem likely now. Overall, the neighbours haven't held a meaningful engagement since the 2008 Mumbai attack that killed 169 people. And between 2003 and 2007, the two countries had held sustained negotiations over Kashmir that had nearly culminated in the resolution of the Kashmir issue. No such possibility exists now. In fact, New Delhi has now changed the goalpost and may be perpetually so: After the withdrawal of Article 370 it has taken the issue of Kashmir off the table not only with Kashmiri separatists who no longer have a presence on the political scene but also with Pakistan. And as things stand, it looks unlikely that this situation will change anytime soon. Will geopolitical factors force New Delhi's hand? Not necessarily. There may be some intermittent modest re-adjustment in policy approach but not a fundamental shift.

For example, during last year's alleged back-channel dialogue with Pakistan, one could see regional geopolitics playing some role. Several factors were at play: India has been engaged in a tense stand-off with China along the Line of Actual Control, forcing New Delhi to mass its troops along the border to deter further ingress by the PLA.

The LoC agreement was also traced to the US nudging the two countries from behind the scenes. The US involvement in the relationship between India and Paki-



stan is a fairly complex affair. New Delhi wants the US to intervene to sort out the terror problem in Pakistan, but it brooks no meddling in Kashmir. Similarly, Islamabad wants US intervention on Kashmir but wouldn't like Washington to speak on behalf of India on terror. More so, at a time when the US is seen as partial towards India. This contradiction hardly makes the US an ideal mediator between the two countries. The starkness of this reality leaves India and Pakistan no choice but to engage and confront their problems themselves.

But here again, the two countries have exhibited a singular inability to talk sustainably. The suspension of the dialogue over the last decade is enlightening on this score. Today, relations between the two countries have reached a point where old equations not only between New Delhi and Islamabad but also between Kashmiri separatists and New Delhi no longer apply. Following the withdrawal of Article 370, Hurriyat has been obliterated abad can hide. And this inequality – accentuated further by a stronger India – is likely to leave a deep imprint on the content of the future dialogue. And of course, on the outcome of it too, if it is sustainably held. It will be an outcome that will not be completely satisfying of the expectations of the weaker parties. Or else, the logiam that has persisted for the past seven decades will linger on.

Returning to Bhutto-Zardari's speech, does this signal that Pakistan is ready to engage India? Quite possible since he is Pakistan's foreign minister, so his statements to this effect assume greater significance. More so, when Pakistan Army is believed to be an inextricable part of the country's foreign policy.

Is any back-channel dialogue taking place between the two countries? Again, it can be anyone's guess. But as for the overall approach of the leadership of the two countries towards each other, nothing even remotely suggests that any engagement is in the works. Or is it? The coming weeks should make things clear on this score. After a few months, Pakistan is likely to get into an election mode, making any engagement with New Delhi meaningless.

Both unbacked cryptocurrencies and national currencies are fiat money without intrinsic worth. They have value because of self-fulfilling expectations. But cryptocurrencies have benefits for users that national currencies do not. Rules, rather than political whim, determine their supply. For Bitcoin, the supply is capped. Payments can be made directly from one party to another instead of requiring a trusted intermediary, and can be anonymous. Their portability is helpful to those in precarious circumstances.

But any currency is subject to a network externality: the more people there are who are willing to accept it, the more valuable it is to those who hold it. This externality gives a powerful advantage to a national currency with a long history of use and legal-tender status. So, there is an incentive to hold that rather than a cryptocurrency. But if a cryptocurrency's user base increases, it becomes more appealing and more likely to persist. Complementary goods such as wallet services provided by financial institutions fuel further growth.

Network externalities mean that most cryptocurrencies will fail, but some will probably reach a tipping point where their wide acceptance ensures their survival. Still, there are challenges. Cryptocurrencies' exchange rates against key national currencies have been highly volatile, but this may change if they become more widely used. While some governments have embraced cryptocurrencies, others have discouraged their use because their anonymity promotes tax evasion, money laundering, and terrorist financing. And their proof-of-work verification mechanisms are environmentally costly.

Cryptocurrencies are not yet a widely used means of payment, but an estimated 221 million people globally owned crypto assets in June 2021. The desire for a stable store of value has enabled gold to survive as a mostly intrinsically worthless financial asset for thousands of years. There is a good chance cryptocurrency will replace it.

# THE DROPOUT: A Story of Failing Ambitions



With Facebook, Microsoft and Apple now dominating the global IT world, the names of such famous entities have become living proof for many on the lack of absolute need of college education to become successful. All three names are college dropouts and have become trailblazers for many to follow in their footsteps. One such person was Elizabeth Holmes who later went on to become the founder of Theranos, a health technology company.

Elizabeth dropped out of Stanford at the age of 19 with dreams of revolutionising the health industry. She dreamed of building a portable machine that could, with a single drop of blood, test a patient for health issues. This device, if successful, would render the usage of needles and big blood testing machine useless. The series 'The Dropout' starring, Amanda Seyfried as Elizabeth Holmes- the protagonist- is based on the reallife story of Holmes and her company Theranos.

The series begins with showing what fueled Holmes' dream to become a billionaire. It was financial issues. Her father had recently lost his job and they were forced to take help from a close friend who could be described as an egomaniac, Richard Fuisz. This coupled with her obsession of Steve Jobs, had Holmes chartering her future ambitions. Holmes disliked her family's dependability on Fuisz and wanted to make a place for herself in this world as an entrepreneur.

The series begins with a foreign exchange program in China which Holmes is a part of. She spends most of her time learning Mandarin for the exchange program. It is in China that viewers get introduced to the stark difference between Holmes and her peers. While her peers are seen partying and enjoying, Holmes is seen trying to make this trip as educational as possible. It is here that Holmes meets Sunny Balwani, a divorcee 20 years older than her, who in the coming years becomes her romantic partner. It is also Sunny who later goes to become an integral part of Holmes' company and a controlling agent of her life. Through the series, the relationship between



Homes and Sunny never sits well. Especially Sunny's overbearing presence and jealousy. Given the age gap and the dynamics that seeps in between this 19-year-old and almost 40-year-old man, it would be safe to call Sunny's behavior predatory.

The initial episodes also place central focus on Holmes' journey at Stanford. She immediately started approaching professors with her ideas for new products. She even got herself into a graduate research group after impressing one professor, a Channing Robertson, by solving a problem that senior students were unable to crack.

As a first-year student in college Holmes was making a place for herself. However, on October 5, 2003, Holmes reported that she was sexually assaulted on her university campus. In its initial episode, the series showcased that this occurred during a frat party. Like many sexual assault survivors, Holmes too was mocked by her peers and judged by her extended circles. However, the series showcased that this incident did not deter Holmes' ambitions. She finally went on to create an idea that was partially supported by Robertson himself, who would also later become a board member of Theranos.

However, when Holmes went to visit Professor Phyllis Gardner, a doctor and professor of medicine at Stanford university, her idea was shot down entirely as being inept and medically impossible. Gardner was one amongst the first people who saw through Holmes' deception. However, Holmes still decided to drop out of Stanford, convinced that her idea had merit, and began her company with the monetary help of her immediate and extended family members. After finally landing a big investment, the series delves into how Holmes gains enough legitimacy to hoodwink some of the biggest names in the business world. Without any genuine product to show she manages to gain large investments, hence also gaining credibility along the way. This continues till the point she runs a health technology company worth of billion dollars with renowned board members such as Apple's head designer, who caught on to Holmes' scam and left, William Perry, Sam Nunn and Henry

Kissinger himself. Holmes had received recognition from the then President of the United States, Barack Obama and Vice President Joe Biden. With increasing power came increasing wealth, that was also owed to Walgreens housing Theranos products in their stores under the scheme of 'wellness centers'.

The series also simultaneously delves into another character's role in Theranos. One of the earliest scientists with Theranos was one Eric Gibbons, who was later sidelined and forced to take a desk job when he started questioning Theranos' methods of functioning. Holmes looped him into a legal scandal when Fuisz came back to expose Holmes. Gibbons could see no way out of this and in between the mounting pressure of not testifying, by Holmes' legal team, due to signing NDA's and the risk of otherwise perjuring himself on stand, Gibbons, a cancer survivor could not take the pressure. He needed to stay in the company to retain his health insurance without which he could not afford his medications. During this chaos Gibbons overdosed on pills, committing suicide.

Simultaneously, the series showcases how this still did not stop Holmes. Instead, at this point of time Theranos was distributing portable blood testing machines that were churning incorrect results to patients jeopardizing the lives of hundreds of thousands of people. The tipping scale that went on to expose Holmes' lies were two whistleblowers, Erica Cheung and Joshua Schultz- grandson of George Shultz former secretary of state of the United States of America-, who were two recent graduates who landed work at Theranos. Erica saw that Theranos was duplicating the technology of another company whilst Joshua for a while knew that the testing was dubious. The duo decided to go public with this information, however, they were soon bogged down in legal constraints by Theranos' experienced team. Nonetheless the article exposing Holmes' scam was finally published in the Wall Street journal, post which Erica filed a complaint with the Security and Exchange Commission who after inspection released a report stating Theranos would have to close their operations for two years. It was from here that Theranos was exposed for what it was.

Elizabeth Holmes being convicted on eleven accounts of fraud has today impacted female entrepreneurs in the valley. The DotLab founder Heather Bowerman for instance has time and again had her legitimacy questioned by investors who doubted her technology to be the same as Holmes'. Similar issues were faced by founders across various industries, Alice Zhang founder of Verge Genomics had her start up event at Stanford derailed when people started joking about Holmes' failure. Similarly, EverlyWell's founder and CEO Julia Cheek was told to change her hair color so that she would not resemble Holmes and investors might find her more appealing that way. # Indian Chinese Cuisine & Its Rise To Popularity In India

hina and India are the world's first, and second largest populations respectively. These nations share a hotly-disputed border, located at the north-most point of India with tensions and skirmishes taking place in mid-2020. I have never been to China, but I assume that, much like India, it is a diverse nation with many cultures, languages and traditions developing from a history that goes back to ancient times.

It can go without saying that in many parts of India, the most popular 'foreign' cuisine is that of Chinese cuisine. Street stalls, dhabas and even fancy restaurants boast an array of finger-licking 'Chinese' dishes that are increasingly popular with India's younger generation. These so-called 'Chinese' dishes look, smell and taste very different from the western understanding of Chinese food because they are essentially a fusion of the popular base ingredients in Chinese cooking with the spicy and complex flavours of Indian food added in. The term 'Indian Chinese' or 'Indo-Chinese' therefore refers to the adaptation of specific Chinese dishes to cater to the average Indian palate that is easily tempted by spicy foods.

This fusion has its origins in the 18th century and to British India's then capital city, Calcutta, located in the east of India. Many members of the Hakka Chinese community migrated from China to Calcutta and established themselves in the community setting up thriving enterprises. They were silk traders, dentists, leather tannery owners and shoe shop owners. Their involvement in the community was integral in setting up India's first Chinatown and more importantly, setting the culinary foundations for what would become India's favourite cuisine.

#### **ADAPTING CUISINES**

The first Hakka Chinese restaurateurs would have recognised the importance of fresh and ground spices in Indian cuisine. So they took their traditional elements of Chinese cooking and modified the sauces to incorporate essential Indian ingredients like chilli, ginger and garlic and spices in general. In Indo-Chinese cuisine, use of condiments such as that of cumin seeds, coriander seeds and turmeric is common and not authentic to Chinese cuisine.

Soon enough, restaurants serving this modified cuisine became widespread across Calcutta and infiltrated to other cities and regions in India. The cuisine's popularity can be attributed to the creation of food with familiar flavours/sensations but prepared in an entirely different way. The versatility of the ingredients meant that Indo-Chinese dishes were easily adapted to the large vegetarian population.

Legend tells of Nelson Wang, an Indian chef of Chinese Hakka descent who is credited for inventing the Manchurian preparation of cooking in the 1970s. Mr Wang was a caterer at the Cricket Club of India in Bombay and was asked by a customer to create an off-the-menu dish. He obliged and cut up cubes of chicken, coated it in cornflour, deep-fried it and added it to a sauce cooked up with garlic, ginger and chilli and then finished off with soy sauce and vinegar and thickened again with cornstarch. The dish was a major hit and not long after, Mr Wang went on to open the restaurant China Garden in Bombay before branching out to other cities across

#### India.

Many Indians perceive Indo-Chinese food as authentic Chinese food, and are often surprised (and perhaps disappointed) when they experience 'real' Chinese cuisine which is usually a lot healthier, at times bland and usually meatfocused. The Indian diaspora has acknowledged the popularity of this unique hybrid cuisine and access to Indo-Chinese food is available outside of India where large communities of Indians reside. This is made possible by the demand of nostalgic Indians abroad who crave the simplicity and spiciness of their favourite 'foreign' cuisine.

The food fusion continues to evolve to this day with the creation of dishes like Schezwan dosa, chilli idli and Chinese bhel. This is a testament to both the popularity of Indo-Chinese cuisine and its ability to adapt to the local cuisine.

#### **TOP INDIAN CHINESE DISHES**

Some Indian restaurants have a section of their menu dedicated to Indian Chinese, and next time you go to your local Indian restaurant, you can check it out.

I, along with a dear friend, went to Amaravathi Restaurant in Harris Park (known as Sydney's Little India) and we ordered Dry Chicken Manchurian, Vegetable Chop Suey and Schezwan Egg Fried Rice. We also ordered plain paper dosa for good measure. The food took me back to my time in Delhi, when my housemates and I would finish our groceries after a day at the office and just outside the grocery store would be numerous street food stalls, some of which would sell Indo-Chinese items. We would munch on the likes of Hakka Noodles and Manchurian as a quick evening snack before heading home to prepare dinner.

► CHOP SUEY - Also called American Chop Suey, this is a mild dish that brings together noodles that are fried until they are crunchy and then topped with a thickened sauce made of cornstarch and thinly sliced vegetables.

► SWEET CORN SOUP - A mildlyspiced vegetable soup that gets its sweetness from the addition of corn kernels and is tempered by sourness of the vinegar and saltiness of the soy sauce.

#### ► MANCHURIAN - Much can be

said about the Manchurian style of cooking, which draws comparison to the deep-fried Indian snack pakora or bhajia. Pieces of meat, seafood or vegetable are battered and then fried in a brownish-red sauce consisting of ginger, garlic, onion and chilli to which soy sauce and vinegar are also added. Popular vegetarian variations include paneer (Indian cottage cheese) and gobi (cauliflower) Manchurian (the latter being one of my favourites). You can order this dish dry (the sauce is reduced) or wet (a thickened gravy). ► CHOW MEIN - Thin noodles stir-

 ► CHOW MEIN - Thin noodles stirfried with finely chopped veggies like capsicum, carrots and cabbage. The sauce that brings this together is a carefully balanced combination of contrasting flavours such as sourness from vinegar, saltiness from the soy sauce and spiciness from the fresh green chillies and pepper.
► HAKKA NOODLES - Similar to Chow Mein above in terms of the ingredients and seasoning used. The 'Hakka' noodle is even available at Indian grocery stores.
► SCHEZWAN RICE - Schezwan

refers to the spicy sauce made from dried red chillies soaked and then cooked in a paste of ginger, garlic and onions to which vinegar and soy sauce is added. It should probably read Sichuan to correspond with the landlocked province located in south-west China and famous for producing peppercorns. Cuisine from the Sichuan province is noted for pungent flavours and it is common for spices like garlic, ginger, chilli peppers and star anise to be used in the preparation of dishes.

# **NIA To Probe Killing Of Chemist In Amravati** In Maharashtra

New Delhi: The anti-terror probe agency NIA will investigate the killing of a chemist in Maharashtra's Amravati, the government said on Saturday, after it emerged it might be linked to his social media posts supporting suspended BJP leader Nupur Sharma. The chemist, Umesh Prahladrao Kolhe, was killed on June 21.

A Home Ministry spokesperson tweeted that the probe of the case relating to the "barbaric killing" of Kolhe has been handed over to the National Investigation Agency (NIA).

The federal probe agency would thoroughly investigate the conspiracy behind the killing and involvement of organisations and international linkages. Kolhe's killing had taken place

a week before two men hacked to death a tailor in Rajasthan's Udaipur before posting videos online saying that they were avenging an insult to Islam.

Days before his killing, the Udaipur tailor had told the local police that he had received threats over a social media post shared from his account, apparently supporting BJP leader Sharma's derogatory remarks on Prophet Mohammad.

The NIA is also probing the killing of the Udaipur tailor, Kanhaiya Lal.

The Maharashtra Police have arrested five people in connection with the Amravati killing and are looking for one Irfan Khan, who runs an NGO and is alleged to be the prime accused in the case.

According to the police, Kolhe had allegedly shared a post on some WhatsApp groups in support of Nupur Sharma, following which Khan is alleged to have hatched a conspiracy to eliminate him.

Kolhe was killed between 10 pm and 10.30 pm on June 21 when he was returning home on a two-wheeler after closing his shop.

# Judiciary Answerable To 'Constitution And Constitution Alone': CJI Ramana

New Delhi: In India a party in power believes that every governmental action is entitled to judicial endorsement and the opposition parties expect the judiciary to advance their political positions and causes but the "judiciary is answer-able to the Constitution and Constitution alone" Chief Justice of India N V Ramana said on Saturday.

He also expressed disappointment that even after 75 years of Independence people have not understood the roles and responsibilities assigned by the Constitution to each Institution.

"As we celebrate 75th year of Independence this year and as our Republic turned 72, with some sense of regret I must add here that we still haven't learnt to appreciate wholly the roles and responsibilities assigned by the Constitution to

each of the Institutions. "The party in power believes that every Governmental action is entitled to judicial endorsement. The parties in opposition expect the judiciary to advance their political positions and causes", the CJI said at a felicitation function organised by the Association of Indian Americans

in San Francisco, USA. He added that this flawed thinking of all hues flourishes in the absence of proper understanding among people about the Constitution and the functioning of the democratic institutions.

"It is the vigorously promoted ignorance among the general public which is coming to the aid of such forces whose only aim is to run down the only independent organ i.e., the judiciary. Let me make it

clear. We are answerable to the Constitution and Constitution alone, he said.

CII Ramana said that to enforce checks and balances envisioned in the Constitution, need to promote "we Constitutional culture in India. We need to spread awareness about the roles and responsibilities of individuals and institutions. Democracy is all about participation".

quoted He Lincoln and said, under the Constitution of India, it is the people who are entrusted with the task of passing judgment on the rulers, once every five years.

"...the people of India have done their job remarkably well so far. We should have no reason to doubt the collective wisdom of our people. CJI Raman said both India and the United States are known for their diversity which needs to be honoured and cherished, everywhere in the world.



# Udaipur killing: Cong Alleges One Of Main Accused 'BJP Member'

New Delhi: The Congress on Saturday alleged that one of the main accused in the brutal killing of a tailor in Udaipur is a "BJP member" and asked whether the Centre had moved quickly to transfer the case to the NIA due to this reason.

Addressing a press conference at the Congress headquarters here, party's media department head Pawan Khera said a very sensational disclosure has been made by a media group in connection with the Udaipur incident which pointed to the BJP links with Riyaz Attari. Some reports have also referred to the accused as Riaz Akhtari.

"The killer of Kanhaiya Lal, Riyaz Attari is a member of the BJP," Khera said in a tweet after the press conference.

Earlier in the day, responding to a tweet by a Congress leader referring to one of the accused's alleged BJP links, BJP's IT cell chief Amit Malviya dismissed the claim as "fake news".

"I am not surprised that you are peddling #FakeNews. The Udaipur murderers WERN'T

members of the BJP. Their attempt to infiltrate was like the LTTE assassin's attempt to enter the Congress to kill Rajiv Gandhi," he tweeted.

"Congress should stop fooling around with terror and national security," Malviya said.

Tailor Kanhaiya Lal was killed Tuesday afternoon by two cleaverwielding men, who posted a grisly video of the crime online claiming responsibility for the murder.

The two accused, Riaz Akhtari and Ghouse Mohammad, have been sent to judicial custody for 14 days. At the presser, Khera cited pictures and posts linking Attari with BJP leaders -- Irshad Chainwala and Mohammad Tahir.

"It has also come to the fore in the same disclosure that the main accused Riyaz Attari often participated in the programmes of Rajasthan BJP leader and former minister Gulabchand

regard to his age and antecedents the purpose of justice shall be served if the case is considered under Probation of Offenders Act, and accused is given benefit of probation," the court said.

The court added that the accused is directed to execute a bond to the tune of rupees two lakh for keeping peace and good behavior for the period of two years and in violation of any condition of bond during the period of these two years the accused shall receive the proposed sentence.

"Coming back to the violation by a juvenile, underage driving is one of the major causes of traffic accidents/snarls and causes danger to other motorists and pedestrians on the roads. Minors are often found driving bikes, Scooties, Cars etc," the court observed.

It added that it is important to realize that Parents/guardians or owners of vehicles are responsible for providing vehicles to their minor children. It is observed many times these minors are driving vehicle, riding bikes in and around schools or crowded places resulting accidents, loss of lives.

"It is the first and foremost duty of parents not to provide their minor children any vehicle unless they attain majority and have license to drive the vehicle. 
