

Remote Rx: Is Bangladesh Becoming New Russia For Kashmir?

Qayoom Shah knows exactly how a piercing perception pinches. When he faced the one, he dismissed it as a "stupidity of gullible masses" until his own daughter lived his fate and suffered for being a "lesser" doctor. Just like her father, Qayoom's daughter is being derided for being a remote medic – "the one who couldn't break into the meritorious ranks back home and got the degree from an overseas campus with money". Given the scathing notions



about their competency and expertise, these doctors tend to



face acceptance and identity issues in the vallev.

UPON THEIR RETURN WITH **DEGREES**, those medical doctors would be chided as Rou'es Kath, which literally means Russian Sheep."

Behind this trend and subsequent tagging, many believe, is the land-locked region's perennial dependence on some of these offshore campuses for medical degrees. Uncertain academic calendar and paucity of

professional training is only acting as a catalyst in this annual educational drive from the valley. Back in 1992, when his homeland was witnessing political tumult, Qayoom-then a dreamy teenager who was yet to grow his moustache—was quietly sent by his teacher-parents to Moscow for a medical degree. Fear of crackdown and crip-

pling lockdown in the valley then forced many middle class and elite families to send their children away to pursue the non-disruptive educational routine. Kashmir campuses were then mostly shut, or

serving as military barracks. Some of them were even rising up in smoke and flame following frequent firefights.

Amid that uncertain situation, Qayoom says, it became a distressing trend to pursue medicine in Russia. Kashmiri society known for its domino effect trait soon made Moscow a new medical capital of Kashmir. "And because everyone would send their aspiring doctor wards to Russia, the trend came under sharp criticism," Qayoom recalls. "Upon their return with degrees, those medical doctors would More on P6

Sticky Bombs, **Ammo Recovered** In Reasi: Police

JAMMU: A militant hideout was busted in Rajouri district of Jammu and Kashmir, leading to the recovery of six sticky bombs along with other arms and ammunition, police said on Monday.

The hideout was busted at the disclosure of Lashkar-e-Taiba (LeT) commander Talib Hussain Shah who along with his associate Faisal Ahmad Dar were overpowered by people and handed over to police in a remote village in Reasi district on Sunday, a police official said.

He said Shah revealed the presence of a hideout in his Draj village of Rajouri during questioning and accordingly a raid was carried out and the hideout was busted.

The search of the hideout led to the recovery of six sticky bombs, a pistol, three pistol magazines, 19 pistol rounds, an Under Barrel Grenade Launcher (UBGL), three UBGL grenades, 75 rounds of AK assault rifle and one IED remote with antenna, the official said.

Shah and his Kashmiri accomplice Dar were arrested from Tuksan Dhok after they were tactifully disarmed by local residents with Lt Governor Manoj Sinha and Director General of Police Dilbag Singh lauding their courage and announcing cash rewards for them.

However, a political slugfest erupted between the local units of BJP and Congress after Shah was reported to be an active member of the saffron party who was recently selected as its IT and social media cell in charge of the minority morcha in Jammu province.

Intense Heat Wave Conditions Hit Normal Life Brief Spell Of Rainfall Expected Today: MeT Dept

Srinagar: Kashmir Valley continues to reel under intense heat wave conditions with mercury settling at 34 degree Celsius mark in Srinagar on Monday, even as the weather department predicted a brief spell of light rain and thunderstorm in the region in the next 24 hours.

"As expected, the weather remained dry in the whole of Kashmir during the past 24 hours. Hot & dry weather is likely till evening whereas a brief spell of light Rain/ Thunderstorm is expected tomorrow," Deputy Director of MeT in Srinagar, Mukhtar Ahmed told Kashmir Observer. "There is no forecast of any major rainfall for next one week," adding that a downfall in temperature is also expected in the region in the next 24 hours. The official also said that scattered light to moderate rains in Jammu division are also forecasted for next 24 hours.

The meteorological department official also said that Srinagar recorded a maximum temperature of 34.0°C and a low of 24.0°C. The temperatures, he said, were 4.0°C and 6.3°C respectively above nor-mal during this time of the year for the summer capital.

"Scattered to fairly widespread light to moderate rain and thundershowers are also expected in Kashmir for subsequent two days," the deputy director told Kashmir Observer. The ongoing month has already seen a vicious heat across I&K, with stagnant air bearing

"We will contest the elections together. There is a political party that said that they have left the alliance. The truth is that they were never part of the alliance. They had come to break us from within." National Conference president Farooq Abdullah, who heads the PAGD, told reporters here.

Similar sentiments were expressed by PDP president and former chief minister Mehbooba Mufti earlier in the day.

"We intend to contest the elections together as it is the will of the people that we should strive together for the restoration of our lost dignity," Mehbooba said.

Responding to a question, Abdullah said elections can be held

whenever the government wants. "Elections were held when we had floods. Why can't elections be held now? The question is how they want to contest the polls," the former chief minister added.

Asked about the ongoing Amarnath Yatra, Abdullah said it was the people of Kashmir who have wholeheartedly ensured smooth conduct of the pilgrimage over the years.

'Who was the man who discovered the cave? He was a Muslim from Pahalgam, "he added.

Abdullah said the government of the time can hoist the national flag from every house. "They have the final say. But it would be great when people fly the tricolour on their own and not due to diktats, " he said.

Viruses Can Change Your Scent To Make You More Attractive To Mosquitoes

osquitoes are the world's deadliest animal. Over 1 million deaths per year are attributed to mosquito-borne diseases, including malaria, yellow fever, dengue fever, Zika and chikungunya fever. How mosquitoes seek out and feed on their hosts are important factors in how a virus circulates in nature. Mosquitoes spread diseases by acting as carriers of viruses and other pathogens: A mosquito that bites a person infected with a virus can acquire the virus and pass it on to the next person it bites.

For immunologists and infectious disease researchers like me, a better understanding of how a virus interacts with a host may offer new strategies for preventing and treating mosquito-borne diseases. In our recently published study, my colleagues and I found that some viruses can alter a person's body odour to be more attractive to mosquitoes, leading to more bites that allow a virus to spread.

Viruses change host odours to attract mosquitoes

osquitoes locate a potential host through different sensory cues, such as your body temperature and the carbon dioxide emitted from your breath. Odours also play a role. Previous lab research has found that mice infected with malaria have changes in their scents that make them more attractive to mosquitoes. With this in mind, my colleagues and I wondered if other mosquito-borne viruses, such as dengue and Zika, can also change a person's scent to make them more attractive to mosquitoes, and whether there is a way to prevent these changes.



To investigate this, we placed mice infected with the dengue or Zika virus, uninfected mice and mosquitoes in one of three arms of a glass chamber. When we applied airflow through the mouse chambers to funnel their odors toward the mosquitoes, we found that more mosquitoes chose to fly toward the infected mice over the uninfected mice.

We ruled out carbon dioxide as a reason for why the mosquitoes were attracted to the infected mice, because while Zikainfected mice emitted less carbon dioxide than uninfected mice, dengue-infected mice did not change emission levels. Likewise, we ruled out body temperature as a potential attractive factor when mosquitoes did not differentiate between mice with elevated or normal body temperatures.

Then we assessed the role of body odours in the mosquitoes' increased attraction to infected mice. After placing a filter in the glass chambers to prevent mice odors from reaching the mosquitoes, we found that the number of mosquitoes flying toward infected and uninfected mice were comparable. This suggests that there was something about the odors of the infected mice that drew the mosquitoes toward them.

To identify the odour, we isolated 20 different gaseous chemical compounds from the scent emitted by the infected mice. Of these, we found three to stimulate a significant response in mosquito antennae. When we applied these three compounds to the skin of healthy mice and the hands of human volunteers, only one, acetophenone, attracted more mosquitoes compared to the control. We found that infected mice produced 10 times more acetophenone than uninfected mice.

Similarly, we found that the odours collected from the armpits of dengue fever patients contained more acetophenone than those from healthy people. When we applied the dengue fever patient odours on one hand of a volunteer and a healthy person's odour on the other hand, mosquitoes were consistently more attracted to the hand with dengue fever odours. These findings imply that the dengue and Zika viruses are capable of increasing the amount of acetophenone their hosts produce and emit, making them even more attractive to mosquitoes. When uninfected mosquitoes bite these attractive hosts, they may go on to bite other people and spread the virus even further.

How viruses increase acetophenone production

Next, we wanted to figure out how viruses were increasing the amount of mosquitoattracting acetophenone their hosts produce. Acetophenone, along with being a chemical commonly used as a fragrance in perfumes, is also a metabolic byproduct commonly produced by certain bacteria living on the skin and in the intestines of both people and mice. So we wondered if it had something to do with changes in the type of bacteria on the skin.

To test this idea, we removed either the skin or intestinal bacteria from infected mice before exposing them to mosquitoes. While mosquitoes were still more attracted to infected mice with depleted intestinal bacteria compared to uninfected mice, they were significantly less attracted to infected mice with depleted skin bacteria. These results suggest that skin microbes are an essential source of acetophenone. When we compared the skin bacteria compositions of infected and uninfected mice, we identified that a common type of rod-shaped bacteria, Bacillus, was a major acetophenone producer and had significantly increased numbers on infected mice. This meant that the dengue and Zika viruses were able to change their

host's odor by altering the microbiome of the skin.

Reducing mosquito-attracting odours

Finally, we wondered if there was a way to prevent this change in odours.

We found one potential option when we observed that infected mice had decreased levels of an important microbefighting molecule produced by skin cells, called RELMa. This suggested that the dengue and Zika viruses suppressed production of this molecule, making the mice more vulnerable to infection.

Vitamin A and its related chemical compounds are known to strongly boost production of RELMa. So we fed a vitamin A derivative to infected mice over the course of a few days and measured the amount of RELMa and Bacillus bacteria present on their skin, then exposed them to mosquitoes. We found that infected mice treated with the vitamin A derivative were able to restore their RELMa levels back to those of uninfected mice, as well as reduce the amount of Bacillus bacteria on their skin. Mosquitoes were also no more attracted to these treated, infected mice than uninfected mice.

Our next step is to replicate these results in people and eventually apply what we learn to patients. Vitamin A deficiency is common in developing countries. This is especially the case in sub-Saharan Africa and Southeast Asia, where mosquitotransmitted viral diseases are prevalent. Our next steps are to investigate whether dietary vitamin A or its derivatives could reduce mosquito attraction to people infected with Zika and dengue, and subsequently reduce mosquito-borne diseases in the long term.

New Covid-19 Test Can Identify All Variants In Hours

Scientists in the US have developed a rapid Covid-19 test that can accurately detect all current variants of SARS-CoV-2 within hours.

The test, CoVarScan, detects the signatures of eight hotspots on the SARS-CoV-2 virus that causes Covid-19.

ual patients when we are dealing with variants that respond differently to treatments," SoRelle said. While a number of other tests for Covid-19 exist, they generally detect either a fragment of SARS-CoV-2 genetic material or small molecules found on the surface of the virus, and don't provide information to identify the variant. In addition, many researchers

In addition, many researchers worry that these tests are not accurate in detecting some variants, or may miss future strains. To determine which variant of Covid-19 a patient has, scientists typically must use whole genome sequencing, which is time-consuming and expensive, relying on sophisticated equipment and analysis to spell out the entire RNA sequence contained in the viruses. CoVarScan hones in on eight regions of SARS-CoV-2 that commonly differ between viral variants. It detects small mutations -where the sequence of RNA building blocks varies -- and measures the length of repetitive genetic regions that tend to grow and

shrink as the virus evolves. The method relies on polymerase chain reaction (PCR) -- a technique common in most pathology labs -- to copy and measure the RNA at these eight sites of interest.

SoRelle's team ran the test on over 4.000 Covid-19-positive nasal swab samples collected at UT Southwestern from April 2021 to February 2022 -- from patients both with and without symptoms. The tests were validated with the gold-standard whole genome sequencing, and the results were used by doctors to choose treatments in some critically ill Covid-19 patients. Compared to whole genome sequencing, CoVarScan had 96 per cent sensitivity and 99 per cent specificity.

Medical Center in the US tested CoVarScan on samples collected from more than 4,000 patients. The research, published recently in the journal Clinical Chemistry, shows that the test is as accurate as other methods used to diagnose Covid-19, and can successfully differentiate between all current variants of SARS-CoV-2. "Using this test, we can determine very quickly what variants are in the community and if a new variant is emerging, said Jeffrey SoRelle, an assistant professor at UT Southwestern, and senior author of the study.

SPS Library **Students Protest** Lack Of Internet, **Other Facilities**

rinagar: Scores of students from various districts Monday staged a protest in the premises of SPS Library Srinagar alleging that authorities are disinterested in resolving the problems they face on a daily basis in the library

The protesting students said they don't have internet access inside the library which is one of the biggest public libraries in the Valley.

"Washrooms are unhygienic, besides there is no canteen facility" they said.

They said the reading room space is not enough and in this scorching heat, there is no AC installed in the 'mega' library.

"Authorities don't offer any internet facility to the students inside the library. That is OK but the irony is that our own mobile internet doesn't work inside the library. This is the source of frustration for the students,' they said.

"We don't have any canteen facilities. We have to take lunch outside the library," they said, adding that toilets are unhygienic and nothing is being done to clean them.

One of the civil service aspirants said that they face a lot of inconvenience in this scorching heat. "There is no cooling system in the reading rooms which are always jampacked. The atmosphere inside the library is choking and not conducive for study. A peaceful reading room is every student's basic necessity. The congested rooms with no internet and cooling facilities mostly fail to provide a conducive study environment," she said.

The protesting students said that they brought these issues to the notice of authorities, but nothing was done to resolve them.

'We will continue our protest until our problems are resolved," they said. (KNT)

ACB Arrests Patwari For Accepting Bribe

Srinagar: The Anti-Corruption Bureau on Monday trapped and arrested a Patwari for demanding Rs 50,000 and accepting Rs15, 000 bribe for issuance of revenue extracts.

'Anti-Corruption Bureau received a written complaint wherein it has been alleged that Gulzar Ahmad Makloo, Patwari, Halqa Zakura. Srinagar is demanding Rs. 50,000 as bribe for

issuance of revenue extracts of land in favour of the complainant," ACB said in a statement to GNS

'The complainant alleged that he approached the Patwari for issuance of revenue extracts of land and the Patwari asked him to pay Rs50, 000 for the same. The deal was later settled for Rs 15,000 as first instalment for the same," it said, adding, "On this the complainant approached Anti-Corruption Bureau for taking legal action against the erring revenue official under

As the contents of the complaint prima facie disclose commission of offence as defined under section 7 of the PC Act 1988, accordingly a case FIR No 26/2022 was registered at PS ACB Srinagar and investigation was started, it said.

Towering Desperation Pushes Youth To New Heights

Jobless Electropaths Threaten to Jump Off Mobile Phone Tower

RINAGAR, JULY 02: To draw the attention of the govern-ment towards their plight, jobless graduates in electropahy who are on a relay hunger strike for the past two-Jumping off a mobile tower, while several strikers were taken into custody when they tried to set themselves ablaze. The strikers spent the day atop the tower and were still there late at night, with a couple of policemen keeping watch at the base.

The strikers demand that electropathy be recognized as a part of Indian Systems of Medicine and employment avenues be made avail-able to them. The government, how-ever, has been persistently refusing to recognize their degrees. The strikers, who have been camping in the press enclave here for the past two-and-a-half months, tried a novel method this morning to grab the attention of the government and to shake it out of its apathy: three of them, Rasheed Ahmad, Sajjad Ahmad, and Mushtaq Ahmad, scaled the mobile phone tower near the Khidmat Press, and drapped in white shrouds and waving the banner of their association, raised slogans against the Government As news spread that, the unemployed graduates intended

to leap off the tower as a mark of protest, scores of policemen, paramilitary personnel and news crews gathered at the scene The police established contact with the precariously perched strikers with a view to persuade them to come down, but they refused to do so unless the government gave some assurance about recognizing their qualifications and opening opportunities for their employment.

One of the strikers atop the tower, Arshad Ahmad, told the CNS on mobile phone that they had been forced to take this extreme step because no one had paid heed to their peaceful protests.

Accepting that suicide was expressly forbidden by religion. the graduate said that it was the government that had forced them to take this desperate course.

Earlier, when the strikers were climbing the tower, four of their col-leagues on the ground, Abdul Qayum, Hilal Ahmad, Nisar Ahmad and Abdul Hamid, tried to set themselves on fire.

The police, however, overpowered them just in time, and shifted them to the Kothi Bagh police station.

When contacted about the electropathy graduates' strike and their subsequent suicide bid, the divisional commissioner for Kashmir, Mahboob Iqbal, said that the administration had been activated, and a magistrate had been assigned to keep an eye on the situation in the press enclave.

He said that the strikers have held a meeting with the secretary health, Kulbhushan Jandial, and minister for health, Mangat Ram Sharma, and that he was hopeful of an acceptable solution to the issue soon

Polythene Ban

he Jammu and Kashmir government recently banned single-use plastic in the Union Territory. On June 30, the J&K Pollution Control Committee (JKPCC) issued a public notice prohibiting the production, stocking, distribution, sale and use of plastic. The government's move came following the blanket ban imposed by the centre on single-use plastic items from July 1 this year. The administration has given all the indications that it is serious about implementing the ban. And what better occasion to announce the ban and seek to enforce it than around the International Plastic Bag Free Day on July 3. But the government's resolve will be tested by what happens on the ground.

Our past experience with government bans on the use of plastic has been bitter. Successive governments haven't ever implemented them seriously. The truth is that the use of polythene bags is rampant across Kashmir, posing a serious threat to the environment. And this was despite the fact that legislation banning the use of polythene has been in place and the implementing agencies had to just do their job. But they were not doing this. The polythene bags were allowed to enter Kashmir at Lakhanpur Check Post and distributed across the region.

In 2014, expressing displeasure over the non-compliance of its directions on polythene ban, the J&K High Court directed 14 deputy commissioners of the then state to show cause as to why contempt proceedings should not be initiated against them "for defiance of the court orders."

Hearing a Public Interest Litigation on preservation of environment, a division bench of the then Chief Justice MM Kumar and Justice Hasnain Massodi had observed that the status report filed by the deputy commissioners was not in keeping with the earlier directions passed by the court. But this hardly made any redeeming difference.

Now the situation is such is that polythene is everywhere. There's hardly any shop in the Valley where you can't get polythene carry bags. Though polythene pollution is a worldwide phenomenon, in Kashmir the penetration seems to be even deeper. Research published in the journal Anthropocene in 2016 has revealed that no part of the planet is free of the scourge of plastic waste. Supermarket bags, compact discs, nylons and other plastics litter roads, croplands and water bodies. The impact has often been highly damaging. The study states more than 300 million tonnes of plastic is manufactured every year. But the study argues, that the humble plastic bag and plastic drink container play a far greater role in

High Court Rescues Right to Property in Kashmir

In a recent judgement, the High Court reiterated that Right to Property is a Basic Human Right but there's still executive delay in respecting judicial orders

ery recently, the High Court of Jammu & Kashmir imposed a penalty of Rs 10 lakh on the Government (Roads & Buildings Department) for not paying compensation to a land owner from Bandipora district whose land was used for construction of a bridge around 5 years back. In addition to imposing a penalty, the High Court division bench of Chief Justice Pankaj Mittal and Justice Javed Iqbal Wani directed the Government to assess and determine compensation for the land. Rs one lakh per year for five years as rent for 9.053 Marlas (2500 sq feet approx.) of the forcibly acquired land was also levied.

The land owner Shabir Ahmad Yatoo had moved from pillar to post to get land compensation to no avail until he sought judicial intervention through his counsel Advocate

Javaid Ahmad Parray.

'The aforesaid facts and circumstances clearly reveal that the private land of the petitioner has been taken over by the respondents forcibly without the consent of the petitioner and without taking recourse to any procedure prescribed in law. It is also an admitted fact that the petitioner has not been paid any compensation in respect of the said land though the determination/assessment of the compensation is under way as per the stamp duty rate. It is well recognized that Right to Property is a basic human right which is akin to a fundamental right as guaranteed by Article 300 A of the Constitution of India and that no one can be deprived of his property other than by following procedure prescribe in law", the High Court division bench observed.

Facts clearly reveal that the respondents (Govt) violated the basic human right of the petitioner and had deprived him of his property without following any procedure of Law. The division bench of High Court also said that the respondents were liable to be penalized for violating the basic human right of the petitioner and at the same time to pay compensation of the said land at stamp duty rate prevalent today as well as the rental compensation for its use and occupation from the year 2017 till date.

to property of the petitioner which is guaranteed by the Constitution, the respondents are directed to pay special penalty of Rs. 10.00 lacs to the petitioner within a period of three months. In the event, the aforesaid amounts are not paid within the time stipulated, it will be open for the petitioner to move an application and to bring it to the notice of the Court whereupon the Court will swing into action and take appropriate coercive measures against the respondents for the realization of the aforesaid amount may be as arrears of land revenue.

Forcible Land Acquisition in Ramban

disposed of'

The writ petition is, accordingly,

In the last few years, the Jammu and Kashmir High Court has issued several judgements and landmark orders on forcible land acquisition. One of these is the judgement dated 30th December 2021 wherein High Court Division bench not only penalized the Government but also directed the respondents to acquire land under the Right to Fair Compensation Act 2013.

Some years back, the Rural Development Department had illegally acquired land in village Pogal Paristan of Ramban district. The department also constructed a community hall on private land belonging to two brothers, Kishen Singh and Bishen Singh without paying compensation to the landowners. The aggrieved landowners filed a writ petition in Jammu and Kashmir High Court. A division bench of Chief Justice Pankai Mittal and Justice Javed Iqbal Wani ordered that non-payment of compensation to affected landowners in a remote village of district Ramban was a violation of human rights. The order said that it was an abuse of process of law if the petitioners were deprived of fair compensation for their valuable property. The court directed the Department of Rural Development Department to pay Rs. 10 lakh as penalty to the aggrieved land owners and directed the Collector, Land Acquisition to issue a fresh notification for acquisition of land. As I had been following the Ramban forcible land acquisition case for last 7 months, I spoke to Advocate Rajdeep Singh Thakur the counsel of the petitioners Kishen Singh and Bishen Singh. He

informed me that inspite clear directions from High Court division bench, the penalty amount has not been paid by the Govt even after 7 months of the order. Although the Department of Rural Development has sent the case to Finance Department for the release of funds but the money is yet to come.

This is yet another issue to mourn that High Court orders are not implemented unless people go for contempt proceedings. This takes a lot of time and energy.

Baramulla Land Acquisition Case

In February this year, the High Court of Jammu & Kashmir had imposed a fine of Rs.10 lakh on the Government for 'unnecessarily' dragging a litigation against a land compensation case that had hampered timely compensation to the landowners. In this case also, the division bench of Chief Justice Pankaj Mittal and Justice Sanjay Dhar while issuing orders in the case (OWP No. 2084 of 2018), had said that it was concerning that the state is acquiring private land without payment of full compensation to the rightful owners.

"This kind of action or omission on the part of the state authorities is not acceptable and cannot be allowed to continue for an indefinite period.", the division bench had observed.

The petitioners in the case, all residents of Kanli Bagh, Baramulla had invoked a writ in J&K High Court for the quashing of the entire land acquisition proceedings in re spect to about 150 Kanals of the land (19 acres approx.) which had been notified for acquisition for public purposes: the Government had to develop a Housing Colony at Sangri in Baramulla and the land was required for the same. The petitioners alleged that only a tentative award was made in 1998 but they were being denied compensation for their land. The court in this case too observed that the right to possess and occupy land/property used to be a fundamental right and is still a constitutional right akin to a fundamental right. It has been recognized even as a basic human right.

of law. Therefore, the non-payment of the compensation as provided under the statutes amounts to depriving the person of his right to the property. There is no dispute to the fact that the land measuring 150 kanals and 03 marlas stands acquired and that its possession has been taken over and handed over to the indenting department decades ago but till date final award has not been passed. The Collector, Housing and Urban Development Department, as per the draft award has disbursed the amount of compensation to the extent of 75% in respect of the land measuring 85 kanals and 02 marlas but no payment of land measuring 22 kanals and 06 marlas of the propriety land and 42 kanals and 15 marlas of the State and Shamlat land has been made to anyone.", reads the High Court order.

The division bench also stated that the aggrieved families had been deprived of proper compensation for the acquired land which is clearly violative of the statutory provisions of the Land Acquisition Act and Article 300 A of the Constitution of India. The court claimed that these amounted to a denial of basic human right to the villagers for about forty years.

Conclusion

Since the last few years, the Judiciary has been very serious about forcible land acquisition in Jammu & Kashmir. Inspite several landmark judgements/orders from High Court Judges and Chief Justice, the Government failed to implement the same. There is half a dozen more cases wherein High Court division bench has issued strict orders against the Govt for depriving people of fair compensation which the High Court said was the worst kind of human rights violation. In the case of the Srinagar Ring Road project, the Government not only acquired the land by force in many villages but they also damaged crop and chopped off fruit-bearing trees. The road is being constructed in many areas and land owners are helplessly watching the plunder of their land as they haven't yet received the compensation. The compensation is determined as per rates applicable in 2017 and the Right to Fair Compensation Act 2013 extended to J&K post article 370 isn't being applied at all. The aggrieved people's last hope is the Judiciary but the Govt keeps making unnecessary delays in implementing judicial orders. One can only hope that this is viewed seriously by the Judiciary and Executive both, as such actions defeat the legal process and the constitution.

Dogged by inflation

rovisional output in May across the eight core industries, spanning coal to electricity, grew by an average 18.1% from the corresponding month in 2021, when the COVID-19 pandemic's second wave had badly disrupted economic activity. Core output growth was led by double-digit year-on-year expansions in refinery products, electricity, steel and coal, which together account for threefourths of the index. The four sectors bearing weights of about 28%, 20%, 18% and 10%, respectively, posted expansions of 16.7%, 22%, 15% and 25.1%, respectively. Cement and fertilizers, too, saw robust growth of 26.3% and 22.8%. However, on a sequential basis, growth in output over April 2022's levels was significantly slower, reflecting the 'optical illusion' created by low production in the year-earlier period. While the index as a whole registered month-on-month growth of 2.6%, petroleum products expanded 1.9%, electricity grew by 1.5%, and steel by a relatively healthier 5%. Disconcertingly, cement, a key building material that reflects activity levels in the job-intensive sectors, actually saw output shrink 3.2% from the preceding month.

The more up-to-date June PMI data separately show price pressures dampened manufacturing growth to the slowest pace in nine months. June's PMI reading eased to 53.9, from 54.6 in May, amid a broad-based slowdown in orders, production, exports and input buying as customers cut back on spending amid inflation worries. Inflation, in fact, so dominates companies' assessment of the outlook that it depressed business confidence to the lowest level in 27 months. A majority 95% of the purchasing managers at the approximately 400 manufacturing companies polled by S&P Global cited the elevated price pressures as the main reason why they foresee no change in output from current levels in the year ahead. The silver lining in the survey, though, is that manufacturers reported their first shortening of input lead times since the onset of COVID-19, a positive augury for businesses' ability to scale up production quickly once demand revives. The onus is on policymakers to ensure that both monetary and fiscal action is focused on reining in inflation. Anything less risks affecting recovery

Covid Vaccine Efficacy and Weight Issues

WHAT WE DID

ince the pandemic began, more than 6 million people have died from COVID around the world. The good news is that we now have a wide range of treatments as well as highly effective vaccines which have helped reduce the number of severe COVID cases.

Still, some people are more likely to get very sick or die from COVID than others. Our research, carried out before vaccines became available, showed that obesity is one of the factors that increases a person's risk of being hospitalised or dying from COVID. We have now followed this up with a new study looking at how body weight affects the uptake and effectiveness of COVID vaccines, and discovered that being underweight can also be a risk factor for severe disease.

Obesity is measured using the body mass index (BMI). This is calculated by dividing a person's weight in kilograms by their height in meters, squared. A person with a BMI below 18.5 is considered underweight, in the range of 18.5–25 is considered healthy weight, above 25 is considered to be overweight, and above 30 is considered obese.

These early findings on the people most at risk were used to support policies that prioritised certain groups of people for vaccination. This included people with a BMI of 40 or above.

Other research from before the CO-VID pandemic has shown that people with obesity are less likely to take up seasonal flu vaccines. There's also evidence to suggest that some vaccines work less well in people with obesity, although we don't fully understand the reasons for this.

In our new study, published in The Lancet Diabetes & Endocrinology, we used anonymous health records from more than 9 million people aged 18 and older in England, Our data covered the period from December 8 2020 (the date the first COVID vaccine was administered in the UK) until November 17 2021. During this time, 566,461 people out of the 9 million tested positive for COVID, of which 32,808 were admitted to hos-

pital and 14,389 died. inves-То tigate vaccine effectiveness across different body weights, we looked at the risk of severe COVID outcomes

(such as hospitalisation and death) across the full BMI range. Within BMI groups, we compared people who were vaccinated with people of the same age, sex and other characteristics who hadn't been vaccinated.

We found COVID vaccines were highly effective against severe outcomes in all BMI categories, especially after the second and third doses. After the second dose, vaccinated people in healthy weight, overweight or obesity groups were almost 70% less likely to be hospitalised as a result of COVID than their

unvaccinated counterparts. Similarly, vaccinated people in the healthy weight, overweight and obesity groups were around 60%-74% less likely to die from COVID than unvaccinated people with the same BMI.

Our results indicate that COVID vaccines may be slightly less effective in people who are underweight. Vaccinated people who were underweight were around 50% less likely to be hospitalised and around 40% less

COVID vaccines were highly effective against severe outcomes in all BMI categories, especially after the second and third doses. After the second dose, vaccinated people in healthy weight, overweight or obesity groups were almost 70% less likely to be hospitalised as a result of COVID than their unvaccinated counterparts. Similarly, vaccinated people in the healthy weight, overweight and obesity groups were around 60%-74% less likely to die from COVID than unvaccinated people with the same BMI

to die than their unvaccinated counterparts. Of course, this still represents a good level of protection.

People who were underweight were also the least likely to get vaccinated in the first instance, and this was true across all age groups. The proportion of fully vaccinated people was highest among people who were overweight and obese. In our study, fully vaccinated meant having received two or three doses, as not everyone was eligible yet for a booster at the end of our study period.

We also looked at the risk of severe COVID outcomes only among the people who had been vaccinated

with at least one dose. Although vaccination massively reduced the likelihood of severe COVID, people who were underweight and those with obesity remained at greater risk of hospitalisation or death from COVID than people of a healthy weight. This was also the case before vaccines were rolled out.

The associations became less significant among those who had received a third dose. But as only a limited number of people were eligible for the third dose by the end of the study period, we'll need further research to better understand the effect of boosters.

The data also didn't allow us to explore any differences between the different COVID vaccines, or to assess the influence of different COVID variants.

People who have two doses of a COVID vaccine receive a high level of protection against severe outcomes, regardless of their body weight. Given the slight reduction in vaccine effectiveness in people who are underweight, targeted efforts may be needed in this group to increase vaccine uptake.

Even though severe outcomes were much rarer after vaccination, people in the underweight and obese groups were at significantly higher risk compared to people of a healthy weight.

Public health strategies to help people achieve and maintain a healthy weight have many benefits. One important one may be to help reduce the burden of severe COVID.

CS Directs Integration Of All Online Services With RAS By July 15

Calls Public Satisfaction The Yardstick For Measuring The Achievements

Srinagar: Chief Secretary, Dr. Arun Kumar Mehta on Monday chaired a meeting with the Administrative Secretaries of different departments to review the integration of Rapid Assessment System with the online services offered by the Government in Jammu and Kashmir.

Additional Chief Secretary Home, Additional Chief Secretary Finance, Principal Secretary, H&UDD, Principal Secretary, GAD, Principal Secretary Irrigation and Flood Control, Commissioner Secretary Rural Development &PR, Commissioner/ Secretary, FCS&CA and other senior officers attended the

meeting. IT, Deputy Secretary Commissioners and other officers attended the meeting through virtual mode. While chairing the meeting, the Chief Secretary directed the officers to ensure that offline processing of cases for the services offered online should be dispensed with completely and switchover to online mode for better monitoring and transparency with feedback from citizens be ensured by 15th of July. He maintained that the satisfaction of public with respect to service delivery should be the vardstick for measuring our

> achievements. v Regarding the services under PSGA, he passed on directions to the DCs to ensure all

services are made available to the citizens within the stipulated time frame. He said PSGA timelines of these services should be synchronized with the online portal and any default on providing services within notified timelines should be monitored by departments for taking action against the commission of willful derelictions.

The Chief Secretary directed the concerned to conduct surprise inspections and submit inspection reports with respect to the offline/online processing of cases. He also directed that all issues pertaining to complete switchover including the payment gateway issues shall be ironed out within a week's time. The Chief Secretary also

directed the concerned to involve the CSCs and Khidmat Centres to further facilitate ease of services to the citizens, besides directed for regulating the fee charged by the services providers.

The Chief Secretary took brief from DCs about the number of online services and directed them that people should feel assured about timely service delivery.

be chided as Rou'es Kath, which literally means Russian Sheep."

These remote medicos would be largely shrugged and snubbed in the strife society where cult medical status still draws and determines clinical patient footfall. Apart from being denounced as the "mediocre medics", they faced othering due to a wrong medical move.

"With the result," Qayoom says, "many of us wouldn't advertise our medical degrees for the fear of labeling and libels. At times, a quintessential Kashmiri wit pierces you so deep that it creates an existential crisis for you!"

Decades later, chickens came home to roost for many vocal critics of the Russian doctors in Kashmir, as it surfaced how most of the Kashmiri students are being trained as doctors in Bangladeshi medical colleges.

Amid the Covid lockdown situation, some of these stranded students sent home SOS involving civil society and ministerial intervention in clearing decks for their homecoming.

"I remember how some people thanked pandemic for exposing the socalled medical scam in Kashmir," says Ruqaya Ali, a medical student in Dhaka.

"All and sundry in Kashmir were suddenly wondering—'How come so many Kashmiri students are studying Medicine in Bangladesh?' Some even thought that most of us are there in Bangladesh on the controversial PMtype scholarship. It was a totally crass and canard attempt to disrespect our hardwork and talent."

That public spectacle, however, soon turned ugly when many dismissed these doctors as "second hand" professionals – thus confusing the secondhand clothes aka "Bangladeshi maal" with this budding medical force of Kashmir. "This mindset is problematic," continues Ruqaya. "People need to understand that Kashmiris have least opportunities available to them at home. Not all of us can quality NEET or make peace with the paltry education being imparted in North Indian institutes. Bangladesh for some of us is a preferred option, for its quality education and least distance. English as a medium of language further makes it a convenient campus for Kashmiris in the entire south and central Asian countries." Even as the tagging has since then thawed just like the pandemic, the growing culture for Bangladeshi campuses is now determining a new routine and reality in Kashmir. Apart from the preferred overseas campuses, like Ukraine, Singapore and Malaysia, Bangladesh has emerged as the most-desired medical destination for Kashmiri students since 2010. Around 8,000 students from the erstwhile state are reportedly studying in medical colleges across Bangladesh. Further, around 2,000-plus students from J&K annually move to Dhaka for medical studies.

to Seema. She was a brilliant student and everyone is coming up with their version of stories. I'm worried'."

Those who follow a grueling routine to bring home medical degrees from these overseas campuses know how vicious the campus life gets at times. The grading system is so ruthless that it even tests the best in business, says Hadiya. "It works on a simple formula," she explains. "Bigger the campus, bigger the burden. At the end of the day, these institutions are mostly concerned about impeccable results for their own brand building and promotion. Sadly, it all comes at the cost of the young medical students."

Such is the level of stress that a few days before Seema's death, a Kashmiri girl attempted suicide but was somehow saved by other roommates.

Back home when Hadiya's parents knew about it, they became worried. "If we've had enough options to admit our children in native medical colleges," Hadiya mother told Kashmir Observer, "then we would've never thought of sending our wards to Bangladesh."

Much of this classroom stress stems from the medieval mindset, says Sakeena, another Kashmiri student pursuing Medicine in Bangladesh.

"Teachers there hold grudges over little things," she says. "Sometimes they don't like your way of talking and sometimes they don't like your style of greeting. All this nonsense becomes too much to tolerate and takes a toll on our mental health."

Before caught in the vortex of tagging and tension, students come to Bangladesh with dreams in their eves. Not easy to pocket, few Kashmiri parents sell their land and some spend their whole life savings to fulfill the wish of their children. Same happened to Arshi, a girl from North Kashmir's Baramulla district. Her parents took a loan of Rs 40 lakh for supporting her medical education in Bangladesh. But in 2021, her father died due to Covid and she went into depression. When she went back to college, she faced hostility of her teachers. "I'm so afraid and even get anxiety attacks because I always think, 'What if my teacher fails me in an exam?' I can't afford to fail. I sometimes feel that we're just being treated as money-making machines but it's not so." Kashmiri students come from a disturbed place and are already harbouring a distressed mindset, Arshi adds. "Once a teacher asked me a question and I responded in the best possible manner. But I don't know what pinched him. He told me in front of the whole class: 'These Kashmiris have very weak English.' I was embarrassed in front of students of different nations. It's too much to bear. We're not there for facing this recurrent embarrassment." These silent classroom cases often take an ugly turn. In the beginning of the year 2022, the management of the International Medical College in Dhaka issued a notice to a Kashmiri studentsuspending him for six months. When the Kashmiri students approached the management and pleaded that the issue pertaining to a football match was solved on the pitch itself, their pleas fell on deaf ears. The cold response forced the student to do the unthinkable. On January 26, 2022, when the students were going for dinner, they heard noise coming from the hostel area. They rushed to the spot and found the suspended student hanging to the ceiling. Somehow his friends saved him. Regaining his senses after 12 hours, the student once again tried to commit suicide with the oxygen pipe. "We face a lot of problems in Bangladeshi colleges," says Saima, a Kashmiri student. "Students from other countries are also sailing in the same boat. I don't want to get expelled from college so please don't mention my full name.'

appear the routine campus matters, but their frequency in a stifled academic atmosphere is making Bangladesh a traumatic training institute for Kashmiri students.

"We don't complain much despite people calling us lesser doctors for choosing Dhaka as our medical training institute, but somewhere down the line some sanity should prevail to make these campuses as student-friendly," Saima says.

"Let me tell you an incredible account of my friend. In her fifth year, she appeared in the exams almost six times but couldn't make it. When she enquired about it, she was shocked to learn that she had passed the written exam but deliberately failed in her viva. Things like these take a huge toll on students. The movers and shakers of these campuses should go for some course-correction."

Kashmir Observer contacted many of these campuses for their take on the allegation leveled by students. Most of them either shrugged the matter or called it a routine campus matter "which will be tackled for the good of students".

But amid labeling and laborious routine, Kashmiri students in Bangladesh have a lot of stories to share but due to the fear of being expelled from college they don't want to share anything.

"How much can we say," says Hadiya. "We can't say everything. We only think about our parents and try hard to focus on studies. That's it."

"This year, we see higher demand led by the economic recovery and early summer. Since 2020, the AC market is going up year after year, and that trend has definitely increased at a massive rate this year," Baba added.

Industry players also say that higher prices are clearly no deterrent to sales. "Even though prices have risen, demand is good," says Yawar Yaseen, owner of M.YY dealers. "There has been strong retail demand in the past one week and I believe that Kashmir will see an unexpected AC sales this year, for the first time."

He further added that the highest demand is for 1.5 ton hot & cold AC. "The basic rate starts from 30k[Base end] and goes upto 60K. However, in the initial days, people were going for the base end AC but now that demand has increased and the availability has decreased, everyone is buying the premier AC. We're selling over 200 ACs in a day," Yawar told Kashmir Observer.

Besides this, the dealers also say that there's a surge in the demand for service of old Air conditioners. "Since mercury has risen, our fitters are literally finding ways to have lunch. We receive hundreds of daily calls for services of old ACs," a dealer based in Srinagar told Kashmir Observer.

He further added, "Customers typically have a budget in mind when they walk into the showroom. So they buy whichever model suits their pocket. But, when they reach our showroom and experience the dearth of AC availability, they're ready to buy even the premier one which may cost at least 60k. By Allah's grace, this is for the first time in the past one decade that we've done a profitable business," says the Srinagar dealer.

When asked about the average sale of ACs, he replied, "I sell at least 200 ACs every day including 100 high value ACs."

Pertinently, the Industry players have also noted that due to the high demand in ACs, few companies have delayed their new consignment to Kashmir till September. "A top AC brand has directly informed us that they won't be able to ship our new consignment till September given the high demand of ACs in Kashmir," Adnan Baba told Kashmir Observer.

According to a popular retailer of electronics in Srinagar's downtown, the huge demand in ACs has led to a shortage of the cooling gadget.

"The demand is so high that we're encountering a shortage of AC," says Aijaz Ahmed, owner of Cute electronics. "We're also expecting an increase in the demand in the coming days."

"On an average, we're selling over 200 Air-Conditioners in one single day," Adnan Baba, Director ALBA power private limited told Kashmir Observer.

"We procure ACs from four different companies including Blue Star. Since the rise in temperature, the demand has gone up. We are selling about 50-60 ACs per brand per day. So subsequently, for five brands the everyday sale is over 200 ACs." However, Baba immediately add-

ed that demand in AC buying had soared since the unprecedented Covid outbreak.

"In Kashmir ACs weren't always in demand. Only a few would buy it.
