J&K Has Highest Number Of Unmarried Youth In India: Report

SRINAGAR: A latest report from the Ministry of Statistics and programme implementation has observed that in 2019, J&K had the highest percentage share of youth who never married. According to the report titled "Youth in India, 2022", in 2019, 29.1 percent of youth in J&K were those who never married with the highest number recorded among males. For male gender, the percentage stood at 30.1 percent in 2019 while for

females, it stood at 28.1 percent. As per the report, J&K is followed by Uttar Pradesh (26.7 percent), Delhi (26.5 percent) and Punjab (25 percent). The report further said that the lowest was observed in Kerala (18.3 percent), Tamil Nadu (20.2 percent), Andhra Pradesh (20.7 percent) and Himachal Pradesh (20.8 percent). The national record, the report noted, stood at 23 percent with 26.1 percent men and 19.9 percent women falling under the "who never married" category.

Interestingly, the figures come at a time when J&K's Total Fertility Rate (TFR) has hit a

grueling demographic milestone as the erstwhile state has fifth lowest Total Fertility rate (TFR) in

the country besides the women's TFR slipping below the replacement-level by 0.6 percent. A superficial look at the figures clearly indicates that the percentage share of young people who are not married is on the rise in J&K with the trend being common among both men and women. The percentage of youth who are never married has shown an increasing trend in J&K from 25.3 percent in 2011 to 29.1 percent in 2019. The ministry of statistics and programme implementation

classifies persons between the age group of 15 and 29 years as 'youth'. According to the report, in J&K, for the age group (including both males and females) of 15-19, 9.5 percent are "who never married", for the 20-24 age group, the number was recorded at 10.7 percent and for 25-29, the percentage stood at 8.9 percent. The report has also said that India's population, which reached 1211 million in 2011 and projected to reach 1363 million in 2021, was one of the youngest in the **More on P6**

Covid Spikes In J&K, 165 Test Positive

SRINAGAR: The daily Coronavirus cases in Jammu and Kashmir continue to show a spike as 165 more people tested positive for virus on Thursday, even as no fresh fatality was reported in the Union Territory during the last 24 hours. According to officials, Jammu division registered 112 fresh cases of Covid-19 while 53 others were detected from parts of the Kashmir Valley, taking the total number of people infected since the onset of pandemic in J&K 456456.

In the Valley, officials said, Srinagar detected 43 new cases of virus, Ganderbal five, Anantnag two and Pulwama, Baramulla and Kupwara reported one case each. No cases of infection were **More on P6**

1.10 Lakh Trees Axed For Srinagar Ring Road: NHAI

JAMMU: More than 1.10 lakh private trees of Apple, Chinar, Walnut, Mulberry among other species valued at Rs 13.76 crore have been chopped down by the NHAI to lay down the Srinagar Ring Road, an RTI reply has revealed.

The response received by RTI activist Raman Sharma from the National Highways Authority of India (NHAI) on his queries said over 1,200 more private trees which form the lush green cover of the Valley will be chopped down in the coming days to build the new tarmac around Srinagar.

The NHAI did not give any estimate of the cost that will be incurred on planting trees along the ring road and said the project is under construction. It further said no plantation has been done till date and that it shall be carried out at later stage.

According to the NHAI, 50,616 trees along avenue and 25,308 trees along median are to be planted as a contract agreement with the EPC contractor for the Srinagar Ring Road project.

The 42.10 km project with a cost of Rs 939.41 crore was awarded by the NHAI to a private company on engineering, procurement and construction

(EPC) mode in 2018.

The ring road and bypass project traversing through 52 villages and five districts, including Pulwama, Budgam, Baramulla, Srinagar and Bandipora, was to be built in 36 months.

The entire greenfield alignment has been proposed on the western side of Srinagar to provide connectivity to the habitation on that side and provide smooth and easy traffic flow in and around the city.

As part of the similar ring road project in Jammu, 5,707 trees of Chir, Garna, Kamala, Ber, Shisham, Parli, Amla among others will be axed but no "afforestation" will be done by NHAI, the RTI said.

No such compensatory afforestation to be done by NHAI according to the forest clearance obtained under the Jammu and Kashmir Forest Conservation Act, it said.

"However, median and avenue plantation as per IRC SP:21:2009 by the provision plantation shall be done along Jammu Ring Road," it said.

The Indian Road Congress (IRC), an apex body of highway engineers in the country, came out with the standard code procedure related to all aspects of design, **More on P6**



Rescue Ops Called Off, 15 Dead; None Missing: LG

SRINAGAR: Jammu and Kashmir Lieutenant Governor Manoj Sinha on Thursday said the rescue operations launched following a flashflood near the Amarnath cave shrine -- that left 15 people dead -- has been called off and there was no report of any person missing.

Referring to reports about several persons missing in the aftermath of the flashflood on July 8, Sinha said the helpline number of the shrine board had received about 200 calls and it took some time to track the yatris as their mobile phones were switched off.

AstraZeneca, Pfizer Vaccines Saved Over 1.2 Crore Lives In First Year: Study

The AstraZeneca and Pfizer COVID-19 vaccines saved over 1.2 crore lives, while India's indigenous Covaxin averted over 3.7 lakh deaths in the first year of the global immunisation campaign, according to a modelling study. Researchers at UK-based life-sciences data firm, Airfinity, found that the Oxford-AstraZeneca and Pfizer/BioNTech vaccines saved the most lives among all approved preventives. Last month, a study on excess deaths from 185 countries and territories by the Imperial College London, UK, calculated that COVID-19 vaccines saved around 2 crore lives between December 2020 and December 2021. Airfinity has added further analysis to this work using its unique time series data set on vaccine distribution. Taking Imperial College London's research on deaths averted per country, the



analysts examined which vaccines were administered in each country to determine the breakdown of lives saved per vaccine. Using this methodology, the analysis found that AstraZeneca, known as Covishield in India, saved 6,341,861 (over 63 lakh) lives and Pfizer/BioNTech around 5,979,743 (over 59 lakhs) lives. Sinovac followed with 20 lakh lives saved while Mod-

erna saved 17 lakh lives, the researchers said. Hyderabad-based Bharat Biotech's Covaxin was at number 8 in the order of the lives saved, averting 371,591 (over 3.7 lakh) deaths. There was no separate data available for the number of lives saved by Covishield, one of the two main vaccines used in India alongside Covaxin. "AstraZeneca and Pfizer/BioNTech both succeeded in scaling

up production quickly and delivering doses before other manufacturers, Airfinity's Analytics Director Matt Linley said in a statement. "AstraZeneca may have saved the most lives due to where its primary series was distributed and who received it. Its vaccines first went to older age groups in high income countries and nations with less robust health care systems. "Both factors would have resulted in averting more deaths in the first year of vaccinations," Linley said. The imperial College London's study, published in The Lancet Infectious Diseases journal, had found that COVID-19 vaccines prevented over 42 lakh potential deaths in India in 2021. Globally, the study, based on excess deaths from 185 countries and territories, found that in the first year of the vaccination programme, 1.98 crore out of a potential 3.14 crore COVID-19 deaths were prevented worldwide.

"I know some candidates who are on the verge of developing mental health issues, we have already lost a lot of time due to the Covid 19 pandemic".

"If the entire list is scrapped, it will leave a thousand youth unemployed, disheartened and disappointed" he said.

The protests which started during morning continued when the report was filed with candidates lighting candles to protest the possible scrapping of the list of the selected candidates.

The candidates urged the LG administration to take note of alleged mismanagement in the JKSSB which, according to them, has put the future of qualified candidates at stake.

It is pertinent to mention, the JKSSB had advertised posts for the Finance Account Assistant (FAA), Junior Assistant, Sub Auditor and other positions in December 2020.

The exam for which was held in the month of March, 2022. JKSSB had published the merit list on 22nd April, 2022.

In Zone-III, as many as 30 Chemist Shops in the areas of Batpora, Danihama, Chatterhama, Khimber, Rangpora, New Thead, Burzhama, Gulab Bagh, Zakura and

Zoonimar have been designated for sale of ATT medicines.

Azad's Move Against Corruption Politicians Come Under SVO Scanner

SSRINAGAR- After getting the go ahead from the chief minister, the state vigilance organization (SVO) formally initiated moves to gather details about the assets of Valley politicians. The SVO is planning to put its plan into action very soon.

During a departmental conference of the SVO, the chief minister Ghulam Nabi Azad had indicated that the organisation could extend its reach to politicians, and later it got the formal nod.

The SVO is learnt to have begun compiling details of the incomes of the state's politicians, political functionaries and workers with a view to determine their movable and immovable property.

Sources said that the SVO would try to gather information about the property of these politicians before and after they assumed public office.

The SVO has formulated several teams and put them to work under cover. The teams will gather data about the incomes of politicians holding office in government departments and on the basis of this record the SVO will tighten the ring around wrongdoers.

Speaking on the condition of anonymity, a top officer of the SVO said that though the organization had intended to lay its hands on politicians as well, it was waiting for the green signal from the government.

"And that finally came from the chief minister," he said. According to reports, several politicians are feeling the ground slipping beneath their feet at the chief minister's decision, and have begun to transfer their property to other names. They have begun the process of shifting valuables and luxurious items to the homes of their relatives.

Lanka Lesson

Sri Lanka's once all-powerful President Gotabaya Rajapaksa has fled the island nation, which is reeling under an unprecedented economic crisis. He boarded a military aircraft and landed in neighbouring Maldives from where he has headed to Singapore in a Saudi plane. His younger brother and former finance minister Basil Rajapaksa, who is a dual citizen with an American passport, is also believed to have fled the country after his initial attempts to leave through Colombo airport were foiled by the immigration authorities. Former Prime Minister Mahinda Rajapaksa is believed to be still in the country. The downfall of the Rajapaksa family has been spectacular. Until last year, the Rajapaksa brothers were considered heroes for the success of the government run by them to defeat the Tamil insurgency and recapture the area which for around decades was a de-facto independent Tamil state in the island nation. But the Rajapaksa family's instant fall from grace has been brought about by the prevailing economic crisis in the country.

The last few months have pushed the country to the verge of economic ruin. The country has faced a severe shortage of foreign currency leaving it unable to pay for essential imports, including fuel. This has led to power cuts lasting up to 15 hours. The country is also beset with shortages and soaring inflation. Though country is in talks with the International Monetary Fund (IMF) for a loan programme, devaluing its currency in the process, there has been no headway so far.

One of the major aggravating factors has also been the ongoing war in Ukraine, which has triggered worldwide inflation and a shortage of fuel and food supplies. And this is happening at a time when the world economy was gradually recovering from the debilitating fallout of the Covid-19 pandemic. The countries were slowly opening up and letting the economy function normally. International travel was also returning to pre-pandemic levels. Take for instance India which was taking steps toward a self-reliant economy also called Atmanirbharta. But the war has unraveled it all somewhat. It has set off destabilizing factors that are beyond any country's control as long as the war continues. More so, in case of the smaller, fragile states like Sri-Lanka. On the ground, this has translated into loss of lakhs of jobs at a time when the country was already reeling from rampant unemployment. Coupled with inflation, this has made for a combustible situation leading to nationwide protests and occupation of the residences of the president Rajapaksa. The country has plunged into a state of chaos. If anything, the desperate state of affairs in Sri Lanka should be a wake-up call for us in India. The Ukraine war has also affected us badly, triggering steep inflation. The union government needs to get its act right if we are to prevent the situation from getting any worse.


Staying watchful

Year-on-year inflation in oils and fats decelerated last month by a whopping 390 basis points to 9.4%, with the index shrinking 0.7% on a sequential basis. And prices of pulses contracted both from a year earlier and the preceding month. The other major positive sign of a policy measure translating to softer prices was with transportation fuels. The Centre's reduction of excise duty on petrol and diesel in May manifested in a significant easing in inflation in the transport and communication index: year-on-year, the rate slowed by 260 basis points to 6.9%, while sequentially it shrank by 120 basis points.

Still, it would be way too premature for policymakers to drop their guard. With nine of the 12 items in the food and beverages basket, representing almost 80% of the sub index and spanning cereals, milk and meat to vegetables, sugar and spices, experiencing sequential price gains, the Government would need to maintain vigil to ward off any build-up of inflationary pressures in consumers' kitchens. Year-on-year inflation in cereals, meat and milk all accelerated in June from May's pace, and price gains in vegetables still remained in double digits at 17.4%. The progress of monsoon rains give hope that the prices of farm produce may moderate in the coming months, provided the extreme rainfall and flooding seen in some States does not adversely hit crop growing regions. And while an appreciable softening in global crude oil prices in recent sessions offers some respite, the rupee's sharp depreciation against the dollar means India will continue to face the spectre of 'imported inflation' as the bill for imports, including crude, keeps rising. The decision of the GST Council to raise tariffs on a range of goods including some items of mass consumption is also bound to add upward pressure on prices. Finance Minister Nirmala Sitharaman's remarks on Tuesday reflect authorities' recognition that any let up in the fight against inflation risks undermining growth and broader macroeconomic stability.

India, BRICS in Cold War Conditions

The phone conversation on Friday between Prime Minister Modi and Russian President Putin conveyed a big signal, coming on the morrow of the release of the new Strategic Concept by NATO which called Russia the alliance's "most significant and direct threat." The readouts from Moscow and New Delhi both highlighted the two leaderships' determination to carry forward the momentum of economic cooperation despite the western sanctions against Russia. (here and here)

Ironically, the West's "sanctions from hell" have given a big stimulus to India-Russia bilateral trade, giving it a dynamism that one never suspected would be recaptured in the post-Soviet era.

Friday's call was agreed upon in the sidelines of the BRICS summit (June 23-24). Curiously, it has come at a time when the Western powers have stepped up their efforts to create discord among the BRICS member countries, and brainwash India, in particular, to join their bandwagon in the new Cold War conditions. India is of course cherry-picking, as obstreperous as ever on the multilateral circuit — EU, G7, QUAD.

India's relationship with Russia was the leitmotif of Modi's visit to Japan in April (partly) and three visits to Europe in May as well as his two meetings with US President Biden during this period (mostly.) In the West's calculus, China and India are giving what analysts would call "strategic depth" to Russia, which nullifies its frantic efforts to "erase" Russia. Interestingly, the western attempts to create paranoia in the Indian mind about the close ties between Russia and China are no longer having the desired effect of Delhi becoming wary of Russia's intentions. India sees, on the contrary, great opportunities to tap into Russia's tilt to Asia-Pacific region for economic partnerships.

Without doubt, India is "balancing" between Washington and Moscow and BRICS summit was a great occasion to monitor that trapeze act. An unabashedly pro-western internet paper from Delhi had predicted that Modi would act as a vigilante for US President Biden, blocking any BRICS statement critical of the US. Whether that was true or not, Modi made a rather anodyne speech at the BRICS summit.

On the other hand, Putin had stated in his speech at the summit that "Considering the complexity of the challenges and threats the international community is facing, and the fact that they transcend borders, we need to come up with collective solutions. BRICS can make a meaningful contribution to these efforts."

Putin added, "We are confident that today, as never before, the world needs the BRICS countries' leadership in defining a unifying and positive course for forming a truly multipolar system of interstate relations... we can count on support from many states in Asia, Africa and Latin America, which are seeking to pursue an independent policy."

In his speech, Chinese President Xi Jinping made an even more direct appeal to the BRICS partners: "Our world today is overshadowed by the dark clouds of Cold War mentality and power politics and beset by constantly

emerging traditional and non-traditional security threats. Some countries attempt to expand military alliances to seek absolute security, stoke bloc-based confrontation by coercing other countries into picking sides and pursue unilateral dominance at the expense of others' rights and interests. If such dangerous trends are allowed to continue, the world will witness even more turbulence and insecurity.

"It is important that BRICS countries support each other on issues concerning core interests, practice true multilateralism, safeguard justice, fairness and solidarity and reject hegemony, bullying and division."

Frankly, no matter the impressive-looking XIV BRICS Summit Beijing Declaration, the fact remains that the grouping is performing far below its actual potential and one principal reason for this is India's zero-sum mindset regarding China, which makes it difficult for it to work with China collectively in any regional forum.

However, any apprehension in the Indian mind that China would "dominate" BRICS is unwarranted. Russia undoubtedly occupies a special place in the structure of the BRICS. In fact, BRICS was Moscow's brainwave and Russia was responsible for launching the format. The first ministerial meeting (in the BRIC format) took place at the suggestion of Putin in September 2006, on the sidelines of the UN General Assembly session in New York. Thus, the idea of creating BRICS matured in Russia.

Second, BRICS is a "de-ideologised" format. It shows no animus against America although it challenges western hegemony of the international political and economic order. The very fact that the Manmohan Singh gov-

ernment welcomed Putin's BRIC initiative at a most sensitive juncture when India's negotiations for a nuclear deal with the US (with eye on Washington's embargo on technology transfer) speaks for itself.

Moscow conceived the BRICS concept for the strengthening of the formation of a multipolar system of international relations and the growth of economic cooperation — and it has indeed contributed to the birth of a new economic system, based on the equal access of countries to financing and sales markets, a combination of state planning and market economy.

India has a problem to appreciate that the BRICS paradigm does not lie in expanding the capabilities or ambitions of the group's member countries, but in fostering a qualitative change in the economic development model of the Global South. India's dog-in-the-manger attitude — sulking and politicising the forum with extraneous issues (primarily to embarrass China) — doesn't make sense.

Unlike India, China takes BRICS seriously. The Chinese initiative to create a BRICS Vaccine Centre has been under development and the implementation of this project amid the current conditions can be a significant achievement that will bolster the entire format of the association. Ideally, India should cooperate with the project instead of teaming up with its QUAD partners which has turned out to be a wild goose chase.

Again, industrial innovation is slated to be a priority for China's BRICS Presidency in 2022. Expectations are high that during its presidency, China will come up with a number of breakthrough initiatives. Clearly, now that the construction of the BRICS' New Development Bank headquarters in Shanghai has finished, new proposals are expected from China on the development of its operations, including possibly an expansion of the number of shareholders of the bank.

Of course, China will promote its own projects, including Belt and Road initiative. But then, China is also putting into the projects the most financial resources. It is high time for India to have a serious reassessment of values within the BRICS framework, and the changing internal balance of power in the grouping in the new Cold War conditions.

BRICS is at the crossroads and this realisation has propelled the concept of a "BRICS+" format to the centerstage of discussions. China's BRICS chairmanship 2022 witnessed the launch of the extended BRICS+ meeting at the level of Ministers of Foreign Affairs. Participants included Egypt, Nigeria, Senegal, Argentina, Indonesia, Kazakhstan, Saudi Arabia, UAE and Thailand.

During the ministerial, China also announced plans to open up the possibility of developing countries joining the core BRICS grouping. Argentina and Iran have been mentioned as candidates for BRICS expansion. Be that as it may, "BRICS+" is certain to be on the agenda of global governance in times to come.

Cuffs and Courts

The Karnataka High Court deserves compliments as it recently ruled that no individual, whether he be an accused in a case, an undertrial prisoner or a convict, can be handcuffed unless the reason for doing so is properly recorded in the case diary. The ruling

was made by the court in effect of a cheque bounce case, involving a law student from Chikodi in Belgaum district who was handcuffed by the police. As per the directions of the SC, use of handcuffs by police is strictly prohibited in India, except when authorized by a court.

The indiscriminate resort to handcuffs when accused persons are taken to and from court and the expedient of forcing irons on prison inmates are illegal and should be stopped forthwith, save in a small category of cases. Manacles cause emotional and mental distress on human beings and excori-

ate those who are made to wear them. Reckless handcuffing and chaining in public degrades the accused, puts to shame his finer sensibilities, and it is an obloquy and a slur on our culture.

Could it be Religious Obsessive Compulsive Disorder?

Obsessive compulsive disorder (OCD) is characterized by intrusive, unwanted thoughts and anxiety (obsessions) about certain things, as well as the behavior (compulsions) that those with the disorder engage in to calm their anxiety. This specific anxiety disorder is a really severe condition that frequently fills the victim's mind with fear and, in a very real sense, takes control of their lives.

OCD is a broad mental health condition with many subgroups: in the case of religious OCD (also called scrupulosity), the individual is fixated on obsessions that are founded in religion and/or religious beliefs, or around beliefs about morality. This type of OCD is characterised by obsessive religious doubts and fears unwanted blasphemous thoughts and imagery, as well as compulsive religious rituals, avoidance, and reassurance seeking behaviors. When someone has religious OCD, they consistently have unfavourable or worried thoughts regarding their spiritual life. These obsessions frequently get in the way of daily functioning. People could find it difficult to ignore or conceal these thoughts.


Patients with religious OCD have a strong belief in and fear of divine or deistic punishment. According to experts, between 5% and 33% of OCD sufferers may exhibit scrupulosity and this percentage is likely to increase to between 50% and 60% among those who come from extremely conservative religious environments. Scrupulosity affects even those who are not very religious since they are concerned about compromising their morals or unintentionally offending others. People with scrupulosity believe their thoughts are the same as their acts, therefore they worry not just about what they have thought, but also about what they have done.

Examples of Religious OCD:

Many different types of religious OCD exist. An example would be a man who offers hundreds of prayers every day to be forgiven for his perceived transgressions. Similarly another example will be of a man who keeps on verbalizing abusive remarks against devil (shaitan) as he feels his anti religious thoughts and/or images are put in his mind by devil.

The following are some instances of religious obsessions:

1. Fear of lacking sufficient faith.
2. fear of entering hell.
3. Fear of being unclean or contaminated according to the rules of one's religion.
4. Fear of engaging in unethical/immoral behaviour.

Religious compulsions include examples such as:

1. attending religious services considerably more frequently than is customary for one's particular religion, praying more than 5 times for a muslim man with religious OCD to deal with guilt related to antireligious thoughts.
2. seeking out constant confirmation from religious leaders.
3. putting great self-denial or self-sacrifice into practise.
4. obsessive prayer, mantra repetition, or purification practises. (For instance, someone might practise saying a prayer until they get it just right.)

Spiritual compulsions, in contrast to ordinary religious engagement, are frequently driven more by fear than by faith. Many times, people understand that giving in to a temptation won't stop their concerns from coming true. However, individuals think that these compulsions are the only way to make their fear go away.

Religious OCD-signs and symptoms Scrupulosity rituals can involve the following behaviors:

1. Compulsive praying: When someone prays compulsively, they may repeat a prayer or restart it if they become

distracted or don't feel like they are paying attention to it or on its meaning correctly.

2. Observing your behaviour throughout the day to make sure you are acting "appropriately" or checking with others to see if you are acting appropriately or if you have "done the right thing"
3. excessive reading or study of religious works, books, or texts to find answers to various doubt inducing antireligious/blasphemous thoughts.
4. questioning your motivations in a variety of circumstances to check that your intentions were right.
5. excessively apologizing to God (such as God, Allah, etc.) and pleading for forgiveness for your behavior.

Causes of religious OCD:

There is no specific diagnosis for religious OCD. It is a particular example of OCD. Therefore, those who have OCD that is religious may also have OCD that is not religious. Some individuals with religious OCD discover that their obsessions and compulsions evolve over time.

The causes of religious OCD are not entirely understood, just like those of other types of OCD. According to research, serotonin levels in OCD-affected brains may be unbalanced. This could be caused by

genetic, environmental, or a mix of the two sources. For instance, someone with a family history of OCD may be more susceptible to the diagnosis genetically. OCD may manifest when anything in the surroundings causes the person to get anxious.

A person is more likely to have spiritual themes in their obsessions, if:

1. They reside in a neighbourhood where religion plays a significant role in both social life and one's sense of self.
2. They give transient religious doubts moral weight.
3. They think their moral or religious transgressions will be severely punished by God.

It's vital to remember that OCD cannot be caused by religion on its own. Members of any religion can be impacted by scrupulosity. Not religion, but anxiety, is the issue. OCD will persist even if a person rejects religion or becomes an atheist (The theme of their obsessions and compulsions may change though.).

Treatment of Religious OCD

Treatment for OCD frequently requires therapy. An individual can learn to control their anxiety in therapy in ways that don't undermine their quality of life. A therapist

just addresses a person's fear about their faith; they do not require that they abandon their beliefs.

The following therapies are effective in treating religious OCD:

1. Exposure and response Prevention Therapy (ERP): ERP involves exposing a person to their fear and then preventing them from acting on their compulsion. One can be asked to picture God being upset with them as an example. The therapist will next assist the patient in learning to relax as they face anxiety. ERP can teach people to cope with their religious anxieties. A person might gradually come to terms with uncertainty and experience less pressure to follow their compulsions.
2. Cognitive behavioral Therapy (CBT): Numerous types of anxiety, including OCD-related anxiety, can be treated with this kind of therapy. People who receive cognitive behavioural therapy are better able to recognise, comprehend, and handle automatic negative thoughts.
3. Acceptance and Commitment Therapy: People can develop greater mental flexibility by using acceptance and choosing behaviours based on values to help people become more flexible in their thinking. Clients are taught to stop denying their thoughts and feelings and to make a commitment to altering their behaviour, even if having mixed feelings about it.
4. Family Therapy: Family therapy can be helpful when religious OCD threatens the stability of the family. A therapist might employ age-appropriate strategies if the patient is a small child. Couples counselling might be beneficial when a marriage is threatened by religious OCD. Therapy may result in quick, long-lasting changes.
5. Medications: Specific Serotonin Reuptake Inhibitors (SSRIs) have been used to treat OCD symptoms. These can take some time to start working and are frequently used in higher doses than for depression. Some persons may benefit from the addition of additional types of drugs, such as certain antipsychotics, if their symptoms are not sufficiently eased by SSRIs.

Up Above the World So High

James Webb Telescope's one of a kind pictures: When, How and Whats

After decades of development and many trials and frustrations along the way, the James Webb telescope has finally started to deliver what it came for. On July 12, Nasa released the first scientific observations made by the suite of instruments carried on board the mission, marking what we eagerly anticipate will be the beginning of a new era in astronomy.

After the nail-biting launch on Christmas Day, a series of critical deployments followed to open up the telescope and its sun-shade. If any of these operations had failed, James Webb would have been an unusable disaster. But the programme was perfectly executed, a process that ran more smoothly and successfully than any one of us had dared hope, let alone expect.

This is not just a testament to the skill of the engineers, technicians and scientists in the project. It also highlights the tremendous importance of the testing programme carried out on Earth to verify the procedures and which occasionally revealed problems that needed to be fixed before launch. While this sometimes resulted in schedule slip-pages and cost increases, it has ultimately produced a perfect telescope. During July, the telescope moved from its checkout and testing phase to operation, as the amazing observatory it has long been planned to be. Those of us who have been involved in the journey and will work on the data, can hardly wait.

CRISP IMAGES

The new "early release observations", selected by an international



committee of representatives from Nasa, Esa (European Space Agency), CSA (Canadian Space Agency), and the Space Telescope Science Institute, are part of a programme designed to highlight the wide range of science the telescope will carry out. It is very exciting to see the new images – I was not prepared for the level of crispness and fine detail that can be seen. It's a joy to finally have such high-quality data.

Unveiled by US president Joe Biden, the stunning image of SMACS 0723, a cluster of thousands of galax-

ies, was released on July 11. The massive foreground galaxy groups magnify and distort the light of objects behind them, helping us to peer back in time at very faint objects.

The image shows the galaxy cluster as it appeared 4.6 billion years ago. But more distant galaxies in the image (the ones which appear stretched) are about 13 billion years old – and we already have more data on them than we have on any other ancient galaxy.

Images such as this will help us understand how the first stars and

galaxies formed. Some of these may be among the most distant objects known, from the beginning of the universe. The picture is a composite "colour" image made from observations made at different wavelengths. It was taken by the telescope's Near-Infrared Camera (NIRCam).

James Webb has also caught a glimpse of Stephan's Quintet, a group of five galaxies that are merging some 290 million light-years away in the constellation Pegasus. The image also suggests there's a supermassive black hole at the centre, and shows

stars being born. The data will tell us more about how galaxies evolve and the rate at which supermassive black holes grow.

The next picture shows the Carina Nebula, seen in the image below, which is one of the largest and brightest nebulas (clouds of dust and gas in which stars are born). James Webb can probe deep inside dust in the infrared light, to reveal the inside of the stellar nursery – which we've never seen before – to discover more about how stars are born.

The Carina Nebula is located approximately 7,600 light-years away in the southern constellation Carina. The image shows hundreds of completely new stars (every dot of light is a star), and jets and bubbles created by them. We can also see details that we cannot yet explain.

The next, spectacular image is of the Southern Ring or "Eight-Burst" nebula, a planetary nebula, which is an expanding cloud of gas, surrounding a dying star, or in this case two dying stars orbiting each other. It is nearly half a light-year in diameter and is located approximately 2,000 light years away from Earth.

The foamy orange shell in the image is molecular hydrogen (a gas which forms when two hydrogen atoms bond together), whereas the blue centre is an electrically charged gas. In the right-hand image, you can see the two dying stars in the centre, giving us an opportunity to study stellar death in unprecedented detail.

The new data is the result of months of painstaking measurement and testing to make the James Webb ready for use as a scientific tool following deployment. The first steps were to focus and align the images of each of the mirror segments. Each

of the telescope's scientific instruments – NIRCam, The Near InfraRed Spectrograph (NIRSpec) and Mid-Infrared Instrument (MIRI) – were also switched on and tested.

All these instruments, which look at deep space in different wavelengths, had to be cooled down, along with the telescope, otherwise they would radiate background heat which would interfere with the sensitive observations of astronomical objects. The last to be turned on was MIRI, which operates at the lowest temperature, just seven degrees above absolute zero, which took several months to achieve.

The size of a telescope – its aperture – is the key thing that decides the ultimate quality of the images and the detail that can be observed. Bigger is better. Large telescopes with apertures up to ten metres in diameter have been constructed on the ground.

However, the interfering effects of the atmosphere, which disturb the light reaching the telescope, make it hard to achieve the ultimate resolution. Also, on Earth, background light from the night sky limits the telescope sensitivity, the faintest objects we can see.

With its six-metre aperture, James Webb is the largest telescope ever launched into space and from its vantage point a million miles from Earth, free from the Earth's atmosphere, it is expected to deliver the best, most detailed views of the universe we have ever seen. There is no doubt that it will revolutionise our understanding of the cosmos, just as its predecessor, the Hubble Space Telescope, once did.

Ajmer Dargah Cleric Arrested From Hyderabad Over Hate Speech

Jaipur: The Rajasthan Police on Thursday arrested an Ajmer dargah cleric from Hyderabad for allegedly delivering a provocative speech at the main gate of the shrine last month.

Ajmer Additional Superintendent of Police Vikas Sangwan said an FIR was registered against Gohar Chishty on June 25 over the speech he delivered on June 17.

Chishty left Rajasthan on June 29 and had been on the run since then, he said.

"He will be brought to Ajmer on transit remand on Friday," Sangwan said.

Gohar Chisti, a "khadim" of the dargah, had delivered the hate speech shortly before a rally of the Muslim community against the BJP's now-suspended leader Nupur Sharma over her derogatory remarks on Prophet Mohammed.

After the gruesome murder of Udaipur tailor Kanhaiya Lal on June 28, the Ajmer police swung into action and arrested four people who were present with Gohar.

They allegedly raised controversial slogans.

Videos and audios of the hate speech were circulated on social media.

It was mentioned in the FIR registered by a constable of the Dargah police station that Gohar provoked people, calling for beheading of those who insult the Prophet.

The case was registered under IPC Sections 117 (abetting commission of offence by the public or by more than 10 persons), 143 and 149 (unlawful assembly), 188 (disobedience to order duly promulgated by public servant), 504 (Intentional insult with intent to provoke breach of the peace) and 506 (criminal intimidation).

Zubair Moves SC For Quashing Of Six FIRs Against Him In UP

How Many People Offended By His "Objectionable" Tweet? Delhi Court Asks Police

New Delhi/Hathras(UP): Alt News co-founder Mohammed Zubair on Thursday moved the Supreme Court seeking quashing of the six FIRs lodged against him in several districts of Uttar Pradesh for allegedly hurting religious sentiments, and also sought interim bail in all the cases.

The move by the journalist came even as a court in Hathras in UP remanded Zubair to 14-day judicial custody.

Zubair, who is in judicial custody in Delhi in a case that is related to an alleged objectionable tweet he had posted in 2018 against a Hindu deity, was brought to the Hathras court from Tihar jail with a Delhi Police escort and taken back after the court proceedings. His lawyer Umang Rawat argued that since the matter is four years old the journalist's arrest was "malafide" and made under "political pressure."

In a related development, Additional Sessions Judge Devender Kumar Jangala reserved the order expected to be delivered on Friday on the bail plea filed by Zubair in the 2018 tweet case lodged by the Delhi police. The accused has challenged the magisterial court order denying him bail.

Hearing arguments on the bail plea, the judge asked the prosecution if the Delhi police had collected statements of people who felt offended by the alleged objectionable tweet after Public Prosecutor Atul Srivastava claimed that Zubair wanted to incite people and create ill will among them.


"How many people felt offended? How many statements you've collected?" the judge asked.

The prosecutor responded to say that it would be done in the due course.

Advocate Vrinda Grover, appearing for the journalist, said Zubair's four-year-old tweet was dug out by one anonymous Twitter user, which was his first tweet since creating his account.

"Someone digs out the four-year-old tweet, and I (Zubair) am being accused of creating unrest in the country," she added.

A magisterial court on July 2 dismissed Zubair's bail plea and sent him to 14-day



judicial custody after the end of his five-day custodial interrogation. The Delhi Police had arrested Zubair on June 27 for allegedly hurting religious sentiments through one of his tweets.

In the Supreme Court, Zubair's petition also challenged the constitution of the Special Investigation Team (SIT) by the UP government to probe the six cases lodged against him in the state.

The petition contended that all the six FIRs filed in UP that have been transferred to the SIT for investigation are the subject matter of the FIR which is being probed by the Delhi police special cell.

In the alternative prayer, the plea drafted by advocate Vrinda Grover, Soutik Banerjee, Devika Tulsiani, and Mannat Tarnis and filed through advocate Aakarsh Kamra, also sought clubbing of the six FIRs with the FIR lodged in Delhi.

On July 12, the UP Police constituted a SIT for a "transparent" and expeditious probe into cases lodged against Zubair in various districts of the state.

Separate FIRs have been lodged against Zubair in Sitapur, Lakhimpur Kheri, Ghaziabad, Muzaffarnagar, and Hathras districts on charges of allegedly hurting religious feelings, making sarcastic remarks on news anchors, disrespecting Hindu gods, and inflammatory posts.

At the Delhi court, the prosecution opposed the bail plea, saying the website of the accused's company says only Indian

citizens "should" pay, but they are also receiving money from others.

"Someone is paying and you're accepting it Rs 56 lakh rupees has been received in violation of FCRA," the prosecution claimed.

The prosecutor further alleged that forgery was also committed in the case which is being probed.

This case needs further probe, and if he comes out he may delete information and influence, other persons, not to help in the probe, he added.

"Gumnaam (nameless) will remain Gumnaam if he comes out We have given notices to banks. There might be chances that his people might have sent money to his account, to evade liability of Income Tax Act," he said.

Advocate Grover told the court that no foreign contribution was received by Zubair personally or his company Pravda media.

"Our website says we do not receive foreign contributions since we are not registered under FCRA provisions. All this is on my website and in the public domain. My website says only Indian citizens with Indian accounts can contribute. We ask for all information of donor, including PAN number, e-mail i.d.," the counsel said.

She further said the CEO of Razor Pay, through which the company received money, put out a statement after his arrest that Alt News was enabled to receive only domestic payment.

Best Interests, Welfare Of Child Of Paramount Importance In Deciding Custody Case: SC

New Delhi: A child's best interests and welfare are of paramount importance in a custody battle and courts must choose a course which will provide "healthy growth, development and education" and equip the youngster to face problems of life as a "mature adult", the Supreme Court said on Thursday.

Observing that the "dominant consideration to which all other considerations must remain subordinate must be the welfare of the child", a bench comprising justices A M Khanwilkar and J B Pardiwala granted the custody of two minor children to their US-based mother and asked their father, living in Tamil Nadu, to apply for the US visa in a week and travel there to hand over the kids to his estranged wife in a week thereafter.

The woman, whose husband came back to India with their two children allegedly without her consent, had moved habeas corpus (bring the person) plea in the top court here seeking a direction to authorities to "immediately trace and produce the minor children ... and deliver their custody" to her for their repatriation to the US in compliance with the order passed by a local court there.

Justice Pardiwala, referring to the laws on custody of children and the writ powers of the apex court, said, "There is complete unanimity that the best interests and welfare of the child are of paramount importance."

"We would therefore hold that in the case at bar the dominant consideration to which all other considerations must remain subordinate must be the welfare of the child. This is not to say that the question of custody will be determined by weighing the economic circumstances of the contending parties. The matter will not be

determined solely on the basis of the physical comfort and material advantages that may be available in the home of one contender or the other.

"The welfare of the child must be decided on a consideration of these and all other relevant factors, including the general psychological, spiritual and emotional welfare of the child. It must be the aim of the court, when resolving disputes between the rival claimants for the custody of a child, to choose the course which will best provide for the healthy growth, development and education of the child so that he or she will be equipped to face the problems of life as a mature adult," Justice Pardiwala said.

The bench, in its 77-page judgement, said, "We would like to convey to the parties that their two minor children are watching them very closely. Showing the children that their parents can respect each other and resolve the conflict respectfully will give them a good foundation for the conflicts that may, God forbid, arise in their own lives. The parties should try to do their best to remain relaxed and focused." It is critical to maintain boundaries between the adult problems and children, it said, adding that it is of utmost interest to protect the innocence of children and allow them to remain children.

"They must not be burdened by any adult problem. Minor children do not have the coping skills or the intellectual ability to understand any issues like the financial constraints, adult relationship issues or their parents' unhappiness," it said.

While granting the custody of the children to the mother, the court considered the fact that the minor children are residents of the US and "the son is a natural citizen and the daughter is a permanent resident of the US".

"The team shall work closely with the State Health Department and take stock of on-ground situations and recommend necessary

public health interventions. The Government of India is taking proactive steps by monitoring the situation carefully and coordinating with states in case of any such possibility of outbreak," it said.

According to the World Health Organisation (WHO), monkeypox is a viral zoonosis (a virus transmitted to humans from animals) with symptoms similar to those seen in the past in smallpox patients, although it is clinically less severe.

With the eradication of smallpox in 1980 and subsequent cessation of smallpox vaccination, monkeypox has emerged as the most important orthopoxvirus for public health.

Earlier, the yatra was stopped for three days following a cloudburst on July 8 which left 16 people dead and over 30 missing. It had resumed via the Pahalgam route on Monday and through the Baltal route on Tuesday.

the matter and submit periodical action taken report before the court, who can monitor the whole investigation in attending peculiar facts and circumstances of the case.

The petitioners pleaded before the court to direct the SSP Crime Branch, Srinagar, to produce CCTV footage of Police Station Nowgam of Saturday last before the court with regard to the whole incident so that the same can be preserved for evidence. Besides it, the petitioners submitted to conduct a test identification Parade under the Supervision of Executive Magistrate 1st Class so that accused are identified at an earliest and brought to book.

According to Shafiq, on the morning of July 9, some policemen in civvies came in a private vehicle and entered her house without any notice and whisked away her son.

When countered, the cops told Shafiq that they are taking her son for questioning and will be released immediately.

"The applicant despite in her old age managed to chase the vehicle of the accused persons, and begged for release of her son, however the applicant was asked to return home with an assurance that her son will be released soon after completion of some investigation," reads the petition.

It further adds that the Shafiq was restless all along the time till four plain-cloth policemen brought Muslim home in state of unconsciousness. The petitioner alleges that policemen told her that unconscious son will regain his consciousness soon.

Shafiq, according to the petition also alleged that she was forcibly made to sign a blank paper and given Rs 400 by the cops before fleeing from the scene.

"The applicant thereafter touched the body of her deceased son and found the same in very cold state, however the applicant further tried

to pump the chest of her deceased son, however, he could not regain his consciousness," the petition reads.

According to the petition, Shafiq raised hue and cry due to which neighbours and some of the relatives gathered at the residence of and took the deceased to nearby Florence Hospital at Chanapora Srinagar where the doctors after conducting ECG of the deceased declared him brought dead.

"There were visible marks of violence and torture seen on the body of the said deceased which makes it clear that the deceased son of the applicant was brutally murdered in the police custody, the petition reads.

The petition submitted to the court that despite assurance from the higher authorities of the police, no FIR was lodged in this connection yet.

It is pertinent to mention here that Post mortem of the deceased was conducted by a team of doctors at Govt. Medical College Srinagar on July 10, and the report is still awaited.

"It is further to mention that the MRI was also conducted by the doctors but copy of the report has not been provided to the family yet," reads the petition.

The family alleges that the police officials in order to "cover up" the accused have assassinated the character of the Muslim by dubbing him a drug addict in a presser.

Meanwhile, Advocate Tasduq Hussain Reshi told Kashmir Observer that the court gave a patient hearing to the petition and the order has been reserved for July 15.

Meanwhile, Srinagar recorded a low of 17.3°C against 18.8°C on the previous night. The temperature was 0.8°C 'below' normal during this time of the year for the summer capital, the MeT official said, as per news agency GNS.

Qazigund recorded a low of 16.5°C against 17.2°C on the previous night. The temperature was normal for the gateway town of Kashmir, he said.

In Pahalgam, the mercury settled at 11.7°C against 12.8°C on the previous night and it was 0.3°C below normal for the south Kashmir resort. Koker-

nag recorded a low of 15.3°C against 16.6°C last night and it was 0.6°C below normal for the place, he said.

World famous Gulmarg resort recorded a low of 10.6°C against 11.5°C and it was 1.2°C below normal for the place. Kupwara town saw a low of 15.1°C against 16.1°C on previous night and it was 1.5°C 'below' normal for the place during this time of the season, the official told Global News Service.

Jammu recorded a low of 23.1°C against 27.2°C on the previous night. It was 1.7°C below normal for J&K's winter capital, he said. Banihal recorded a low of 17.4°C, Batote 18.0°C, Katra 22.2°C while Bhadarwah had a minimum of 17.8°C, the official added.

J&K Govt Issues Guidelines for Schools

SRINAGAR: Authorities on Thursday issued guidelines and do's and don'ts to all the government and private educational institutions of Kashmir Division to contest the ill-effects of the heat wave.

The guidelines were issued as a precaution that all government and private schools have to be observed by schools to combat the ill-effects of the heat wave. The guidelines come at a time when schools are re-opening after the 10-day long summer break.

The Director of School Education Kashmir (DSEK), Tassaduq Hussain said that the department while keeping in view the prevailing heat wave in Kashmir division may at times pose risk to the health of the school going children.

The heads of all the educational institutions of Kashmir division have been placed under strict instructions to adhere to instructions and guidelines issued by the department in this regard.

Following are the modifications, Do's and Don'ts issued by the DSEK for students and staff

MODIFICATIONS IN DAILY ROUTINES:

Morning assembly should be brief and conducted in such an area or in classrooms where students are not exposed to direct sunlight.

Sports and other outdoor activities shall be adjusted in early hours. Care shall be taken during assembly and dispersal of students.

TRANSPORTATION: Overcrowding in school buses shall be strictly avoided and students as per seating capacity be carried in school buses.

Drinking water and first aid kits must be available in buses and the school buses or vans shall be parked in shaded areas.

Parents shall be sensitized to pick up the children personally wherever applicable.

HYDRATION: Sufficient potable water shall be kept available at multiple places preferably in water coolers or

earthen pots. Students should be sensitized regarding proper hydration and advised to sip water at regular intervals.

Increased hydration naturally results in increased use of washrooms so washrooms need to be kept in clean and hygienic conditions.

FOOD AND MEALS: Meals served to students under PM POSHAN must be served hot and fresh.

Students carrying food in Tiffin are advised to bring light food for lunch which would not become stale easily.

Lunch of the students should be checked before consumption.

DO'S: Drink sufficient water even if not thirsty;

Use Oral Rehydration Solution (ORS), homemade drinks like Lassi or lemon water etc to keep yourself hydrated. Cover your head with a hat, umbrella or scarf etc. Stay indoors as much as possible. In case of illness or faintness, consult a doctor immediately.

DON'TS: Don't go outside empty stomach or immediately after consuming food. Avoid direct sun especially in the afternoon. Don't go outside bare-foot. Don't eat junk or spicy or stale food.

Meanwhile, former West Indies cricketers, Lendl Simmons and Denesh Ramdin have joined the league's player draft for the upcoming season.

The inaugural edition of the tournament featured former cricketers from India, Pakistan, Sri Lanka, Australia, England divided into three teams representing India, Asia and Rest of the World respectively.

Spain's Running Of The Bulls Ends With Swift Race, 6 Hurt

PAMPLONA: Bulls from Spain's revered Miura ranch starred in a fast and uncomplicated final running of the bulls at this year's San Fermin Festival on Thursday.

The Navarra regional government said six people were treated for minor injuries following Thursday's run that lasted just over two minutes. Initially, the Spanish Red Cross said two people needed treatment.

No horn gorings were reported as the Miuras, known for their alertness and speed of reaction, kept mainly in a pack and took little notice of the runners as they raced to the bullring.

One runner escaped serious injury when one bull's horn appeared to graze the right side of his head before he fell to the ground.

The festival's eighth and final 8

a.m. run saw hundreds of people, mostly men and far fewer than usual, test their agility to accompany six fighting bulls and their guiding steer along an 875-meter (956-yard) route through Pamplona to the city's bullring. The bulls are killed by professional bullfighters later in the day.

Tens of thousands of visitors attend the Pamplona festival, which was immortalized in Ernest Hemingway's 1926 novel "The Sun Also Rises." The festival is also popular for its 24-hour partying.

During this year's festival, which started July 6, four people were gored, none seriously.

Eight people were gored in 2019, the last festival before a two-year hiatus because of the COVID-19 pandemic. Sixteen people have died in Pamplona's bull runs since 1910, with the last death in 2009.

No Kohli, Bumrah In India's T20 Squad For Windies

NEW DELHI: India's star batsman Virat Kohli and seamer Jasprit Bumrah have been left out of India's Twenty20 squad for the team's five-match tour of West Indies beginning later this month, the country's cricket board said on Thursday.

Former captain Kohli has endured a lean run of form across formats and is without a century in international cricket since November 2019.

The Indian cricket board (BCCI), which rarely explains team selection, did not specify if Kohli had been dropped or rested.

Bumrah, currently the top-ranked ODI bowler, has likely been rested considering the workload of India's all-format pace spearhead.

Batsman KL Rahul and spinner Kuldeep Yadav were selected in the Rohit Sharma-led squad subject to their fitness. Kohli, currently with the ODI squad in England, missed Tuesday's series opener with a groin injury.

With a number of in-form



batsmen pushing for a top order berth, Kohli's place in the Twenty20 squad has been questioned, especially ahead of this year's World Cup in Australia.

Former coach Ravi Shastri has advised Kohli to take a break from the game and return rejuvenated. BCCI president Sourav Ganguly has backed the 33-year-old to regain his form.

"He himself knows by his own standards it has not been good and I see him coming back and doing well," Ganguly told ANI.

"But he has got to find his way and become successful, which he has been for the last 12-13 years or more and only Virat Kohli can do that."

Will Asia Cup Be Moved To Bangladesh Amid Sri Lanka Crisis?

NEW DELHI: Ahead of Asia Cup scheduled to be held in August in Sri Lanka, Board of Control for Cricket in India (BCCI) president Sourav Ganguly on Thursday said that the board will keep monitoring the situation in the island nation amid the ongoing political and economic crisis there.

"I cannot comment at the moment (about the possibility of India hosting the event). We will keep monitoring (the situation in Sri Lanka). Australia is

playing there. The Sri Lankan team is also doing well. I cannot comment at the moment. Let us wait for a month," the BCCI president told ANI.

Sri Lanka had recently hosted Australia for a multi-format series. The series was highly competitive and saw good cricket from both sides. Australia won the T20I series 2-1, the ODI series was won by Sri Lanka 3-2, while the Warne-Murli Trophy in Tests was shared after the two-match series ended in a 1-1 draw.

Ganguly also spoke about

the challenges posed by the COVID-19 pandemic during his tenure as BCCI president.

"But we managed to get cricket going and as you know, broadcast rights have gone exceptionally well. Although I never equate money with the sport, but it is always good to have money because infrastructure is built that way. Indian cricket is in a solid position. As and when we will finish, someone else will come in and take it forward. It is the players and administrators who will take the game forward," said Ganguly. (ANI)

Barça Reaches Deal With Man United For Reluctant De Jong

BARCELONA: Barcelona has reached an agreement with Manchester United for the potential transfer of Netherlands midfielder Frenkie de Jong, who would still need to approve the move, a person at the Spanish club with knowledge of the deal told The Associated Press on Thursday.

United has agreed to pay Barcelona 75 million euros (\$75 million) plus another potential 10 million euros in variables for the 25-year-old De Jong, according to a club official who spoke under condition of anonymity because he was not authorized to talk publicly about the deal.

De Jong, who is under contact with Barcelona through June 2026, would still need to agree to the transfer to the English Premier League side. So far, he is reportedly reluctant to leave Camp Nou.

Barcelona would prefer for a definite deal to be reached immediately before the team leaves on Saturday for a pre-season tour in the United States.

Barcelona has been working to reduce its payroll as it seeks to reduce its debt. De Jong's salary, the club official said, was no longer in line with its new financial priorities.

De Jong has made 140 appearances, mostly as a regular starter, since Barcelona bought him from Ajax in 2019 for 75 million euros (then \$85.5 million). (AP)

UK Police Launch Probe Over Mo Farah's Revelations

LONDON: London's Metropolitan Police said it had opened an investigation after multiple Olympic and world champion athlete Mo Farah told a BBC documentary that he was a victim of child trafficking.

The 39-year-old said he was brought to Britain from Djibouti at the age of nine and was forced to do housework in exchange for food.

"Specialist officers have opened an investigation and are currently assessing the available information," the Metropolitan Police said in a statement, adding that no reports had yet been made directly to the police.

"Where offences are reported in the media which are deemed significant public interest and there is no cause to disbelieve then the Met can create a crime report."

Farah said his name had been changed from Hussein Abdi Kahin in the fake travel documents used to fly him to Britain by a woman he had never met before.

Once he arrived in the UK, the woman took him to her home in Hounslow, west London, and tore apart a paper with the contact details of his relatives. Her family did not allow him to go to school until the age of 12.

"Deciding to speak out and making the film has been a difficult and emotional journey, as I didn't fully understand what had happened to me," Farah said about the documentary "The Real Mo Farah" in a post on Instagram.

"But, now that my twins have reached the age I was when I came here, I felt it was the right time to ask these questions and discover more about my childhood." (Reuters)

Nelson Mandela's 'World Boxing Championship Belt' Stolen From Museum

JOHANNESBURG: A World Boxing Council championship belt belonging to former South African President Nelson Mandela has been stolen from a museum in Soweto, according to police.

The belt was given to Mandela by American boxing legend Sugar Ray Leonard during one of his visits to South Africa.

It was one of many artifacts inside the Nelson Mandela National Museum museum, a major tourist attraction for local and international travellers.

Mandela, a former amateur boxer, revered the belt and it was prominently displayed in the museum in a house where he once lived in Soweto township, west of Johannesburg.

The museum is one of the top attractions on Vilakazi Street,

the only street in the world to claim two Nobel laureates as former residents.

Mandela and the late anti-apartheid stalwart Archbishop Desmond Tutu both lived on the street.

According to police, the belt was stolen when thieves broke into the museum, popularly referred to as Mandela House, and the theft was reported to police on July 1.

No suspects have been arrested and police have appealed for any information related to the theft, police spokeswoman Dimakatso Sello said.

Mandela became South Africa's first democratically elected leader in 1994 after spending 27 years in prison for his battle against apartheid, the brutal system of white minority rule in effect in the country from 1948 to 1994.

Dembélé Signs New Contract With Barcelona Through 2024

BARCELONA: Ousmane Dembélé has agreed to sign a new contract with Barcelona through June 2024.

The deal on Thursday comes a day after club president Joan Laporta said Dembélé would stay on during the presentation of new signing Raphinha.

Dembélé, now 25, joined Barcelona in 2017 on a then club-record transfer from Borussia Dortmund that with variables was set to reach 147 million euros (then \$173 million) as the club sought a young talent after the unwanted exit of Neymar.

After suffering serious injuries early in his stay at Barcelona, Dembélé consolidated himself as one of its most irreplaceable players thanks to his speed and playmaking.

The new contract concludes a drawn-out negotiation between player and club that appeared to have broken down in January when Dembélé rejected Barcelona's renewal offer, prompting the club to tell his agent to find the France winger a new club.

Dembélé continued to play well for coach Xavi Hernández and remained one of his most used players.



But with his contract expiring this summer, it appeared he would leave. Dembélé was linked to possible moves to England's Premier League or to Paris Saint-Germain, the team of Neymar and former Barcelona great Lionel Messi. Now he will be considered one of Xavi's pillars as the coach tries to build a winning side following a season without a title.

The forward has 32 goals and assisted on 34 more in 150 appearances for Barcelona.

As usual, Barcelona did not make his salary public. It is reported Dembélé had one of the highest wages on the squad under his previous contract. Barcelona has successfully convinced several players to take a wage cut as it tries to reduce its enormous debt.
