# **Govt Survey Paints Grim Picture Of Drug Abuse In Kashmir** 25% Unemployed Youth Involved In Substance Abuse, Addicts Spending Rs 88,000 A Month To Procure Heroin

Srinagar: A survey conducted by the Union Territory administration has brought to fore sensational revelations about rampant drug abuse in the Kashmir Valley, where over 25.2 percent of unemployed youth are found involved in substance abuse.

The survey has been conducted by the Institute of Mental Health and Neuro Sciences (IMHNS), Government Medical College, Srinagar, in collaboration with the social welfare department and Directorate of Health.

Although the report is yet to be made public, sources

all 10 districts of Kashmir and provides a summary of prevalence of various substances in the districts and its associated factors.

The primary objective of the study 2022 in all the districts was to estimate the prevalence of various substances in Kashmir. The study also aimed to assess the pattern of illicit substance use with a particular focus on injection opioids. The most commonly used

psychoactive substance was opioids in every district of Kashmir, the report says. "In all ten districts, 67,468

individuals were having dependence patterns on psychoactive

substances and among them 52,404 individuals were opioid dependent and heroin was the predominant illicit drug that was being used among the opioid users," it finds.

It also mentions that on an average, a user spends around Rs 88,000 a month to procure heroin. Overall prevalence of substance use was 2.87 % while as for any opioid was 2.23%. The age of initiation of heroin was 22 years, the report says.

It further finds that the substance use is predominant in young males with mean age of 28 to 15 years.

'Custodial Killing' **Court Orders** FIR Against Munshi, Others Auqib Javeed

Srinagar: A local court on Friday directed the Crime branch to file an First Information Report (FIR) against police in connection with the alleged "custodial killing" of a youth in Natipora area of the city last week.

While passing the order, the court of City judge, Srinagar directed the Station House Officer (SHO), Crime branch to get the case investigated by an efficient police officer to bring the 'culprits' to book.

The court order came a day after mother of 21-year-old Muslim Muneer filed a petition before the Chief Judicial Magistrate (CJM) seeking a probe into the alleged custodial killing of her son by police.

The petition was filed by Advocate Tasaduq Hussain Reshi on behalf of Shafiqa Muneer, the deceased youth's mother.

While issuing the order, the court noted that police are bound to register an FIR and start the investigation when any information is given in relation to the commission of a cognizable offence.

"The police are mandated under law to register FIR of every cognizable offence once the same is disclosed and investigate the same. In the present case, the police have not done so," reads the order issued by the court.

It further adds that "The police are only to examine the matter from the point of registration of a case for the purposes of proper investigation and not for the purpose of finding merits of the case on appreciation of the facts stated and information brought to its notice by any person with



## **Simple Test Can Identify Blood Clots Related To Covid-19: Study**

Researchers have used a minimally-invasive test to identify clots in small blood vessels in the skin of patients with severe CO-VID-19 that appeared normal, according to a study. These clots were not seen in the skin of patents with other types of severe infectious lung disease, or in individuals with only mild or moderate COVID-19, the


researchers said. A skin biopsy is a proce-dure to remove cells or skin samples from for laboratory examination.

The researchers said a skin biopsy can help assess tissue damage related to COVID-19 as well as help distinguish this blood vessel pathology from other forms of severe respiratory illnesses.

Prior to this study, recently published in The American Journal of Pathology, invasive procedures such as nerve, kidney, or lung biopsy would have been required.

"We were the first group to recognise that the lung disease of acute COVID-19 was different from other severe critical respiratory infections, and that the unusual pathology was systemic," said study lead investigator Jeffrey Laurence, from Weill Cornell Medicine institute in the US.

An antiviral protein capable of blocking SARS-CoV-2 growth, MxA, was found in all six mild to moderate CO-VID-19 patients, indicating that their immune systems were actively fighting the virus, versus only two patients with severe to critical disease, according to the re-

searchers.

An interferon-induced inflammatory protein, SIN3A, was prominent in the mi-

crovascular of normal-appearing skin from patients with severe or critical CO-VID-19, but not in similar samples from normal control subjects, they said. Interferons and cytokines are molecules crucial for

appropriate response to pathogens, damaged cells, or irritants in inflammatory response. Increased SN3A levels in plasma and expression in

the small vessels of skin were associated with the severity of the patient's disease and could contribute to the cytokine storm characteristic in such patients. A cytokine storm is a severe immune reaction in which the body releases too many cytokines into the blood too quickly.

Laurence notes that these results have clinical implications. 'Although anticoagulants

were used in the pre-COV-ID-19 era in sepsis-associated pneumonias to reduce macrovessel thromboembolism, most randomised

trials to date have not found this treatment benefits hospitalised patients who are critically ill with COVID-19 acute respiratory distress syndrome. These drugs may not be

capable of reducing the microvessel thrombosis found with SARS-CoV-2 infection," he added.

There are no explicit mentions of climate change in the Australian primary school curriculum and it is mainly taught through STEM (science, technology, engineering, mathematics) subjects in high school.

More broadly, the main ways we talk about climate in the community and media are focused on science and economics. They tend to involve abstract ideas such as the planet is warming or rainfall is more unpredictable. While these are important components, they overlook the social, cultural and psychological ways people around the world are affected by climate change.

So, how can we better support schools and teachers to approach climate change in a way that will suit young people's interests and concerns?

#### Our comic

We are geography and environment researchers who have written a comic that looks at how people around the world experience climate change. This is aimed at high school students, but will also appeal to university students and the broader public.

Called Everyday Stories of Climate Change, it looks at the ways lowincome families have had to adapt to climate change in five countries across three continents.

It begins with a student, waking up in Australia and heading to school. Here the teacher notes that climate change is impacting people around the world, today we are going to explore some of these places.

The characters in the comics are fictionalised but their stories are based on research via interviews and surveys the comic authors did about people's experiences of climate change in Bolivia, Puerto Rico, Barbuda, South Africa and Bangladesh.

The importance of stories Researchers have long argued we need to put a human face on climate change and communicate in ways that resonate with people. This means, we need to do more than present a graph or rattle off statistics.

Comics are an effective way to put a human face on issues because

adversely impacted by climate change in the so-called global south, which often portrays them as helpless victims.

The comic also allows people to see the tangible, everyday ways people around the world live with, respond to and adapt to climate change.

For example, the family in Puerto Rico raise their own chickens and grow their own vegetables so they can eat the food they want during food shortages after hurricane Maria. In drought-stricken Cape Town, people save the bathwater for the garden and plant droughttolerant aloes.

It is important to show these solutions as research suggests it gives people a sense of agency and hope they can adapt to climate change.

## **NIRF RANKINGS 2022 KU Maintains Top Slot Among J&K Varsities**

Srinagar: The University of Kashmir has figured at 53rd rank in the assessment under National Institutional Ranking Framework (NIRF) of the Union Ministry of Education. The varsity has shown remarkable qualitative improvement in key parameters related to academics and research. The University continues to be among top ranked universities in the Union Territory of Jammu and Kashmir, with an overall point score of 48.27 in the current ranking as compared to 46.97 in the previous one from amongst the universities ranked across the country.

In comparison to the figures of the last NIRF assessment, the University of Kashmir in the current assessment has shown a significant progress in several key parameters including Financial Resources and their Utilization (FRU) where the varsity has scored 7.42 points as against 4.25 in the previous ranking. In key parameters under Research and Professional Practices ((RP), the University has got a



point score of 8 in the PU (Publications) sub-category where it had scored 7.35 in the previous ranking. The University has also shown good progress in the QP (Quality of Publications) sub-category, scoring 11.34 in the current assessment as against 10.3 in the previous one.

In the Graduation Outcome (GO) category, the University has once again improved its score in the GPHD, which concerns the matrix for number of PhD students who have graduated from the institution, scoring therein 19.56 as against 17.03 in the previous ranking. Also, the University has scored better in the Women's Diversity as well as Peer Perception.

## Soldier killed by CRPF men

Mistaken for a militant after girl's murder

RINAGAR - A soldier was shot dead by CRPF personnel in an Anantnag village on Wednesday night minutes after he killed a local girl.

The soldier from the 49th RR was shot dead by a patrol party who mistook him for a militant on account of his plain clothes and furtive movements

while fleeing from the scene of his crime. Outraged by the killing of the girl, thousands of people came out into the streets today holding protests against the security forces and demanding that the body of the RR man be handed over to them.

The soldier had sneaked into the house of Muhammad Akbar Dar in village Changoo

in Doom area through a window after climbing over a walnut tree, and demanded food and a place for the night.

Enraged when the family refused his demand, the soldier had shot and injured Dar's 19-' year-old daughter. Zahida, who fell down in a pool of blood?

The family tried to catch hold of him, but he pumped a fatal shot into the girl and managed to escape from the scene A CRPF patrol outside the village ordered the fleeing Soldier to stop, and opened fire taking him to be a militant, the KNS, quoting police sources as having said. He died on the spot after identifying the soldier, the CRPF left his body and weapons lying in the field.

The defence spokesman, Col V.K Batra, however, told the KNS that the soldier had committed suicide after killing the girl. The local population surged into the streets in a huge demonstration against the security forces, sitting on a dharna and disrupting traffic

Demanding that the soldier's body be handed over to them, the villagers said he had entered Dar's house with evil Intentions and had molested his daughter before shooting her dead.

The senior superintendent of police in Anantnag, Aashig Hussain Bukhari, however said, that no molestation had taken place. (Kashmir Observer, 16 July, 2005)

## Misplaced Tantrums

ver a dozen persons, including two former and senior bureaucrat, accused of involvement in the infamous exploitation scandal and lodged in Srinagar's central jail at present, went on an indefinite hunger strike last week against what they termed as 'denial of justice' to them 'at all levels.' They refused the breakfast on Saturday and handed over a letter addressed to the superintendent of jail which, however, did not carry the signature of the prime accused, Sabeena. "We are on a hunger strike. (We) protest against denial of justice 'at all levels,' the letter said. Among other things, the accused jail inmates listed a number of grounds for the protest, including "denial of forum to project our cause, denial of legal assistance and non-consideration of bail applications." They also took an offence at the handcuffing of seven of the accused when they were produced in the court of chief judicial magistrate on Friday besides protesting the 'lack of security' en-route and inside the court premises. A day earlier, some of the high-profile accused in the scandal created unruly scenes in the court, even repeatedly shouting at the judge inside the court room as some of "their relatives" tried to attack his office from outside. Seven accused, including the former additional advocate general, Anil Sethi, the DIG of border security force, K S Padhi, and the kingpin Sabeena, were brought to the court hooded and handcuffed which they contended was "against the Supreme Court guide lines." Anil Sethi even objected to the presence of mediapersons in the court. Amid all the shouting, however, there was pin drop silence for a while after the judge warned the accused of "landing in trouble." Some persons even tried to attack the court and banged its doors forcing the police to resort to a mild lathicharge to disperse the crowd. Having thrown the tantrums, the accused relented later and called off their strike after the jail superintendent forwarded their memorandum to the director general of police and the divisional commissioner. Nevertheless, the court has initiated action, including contempt proceedings, against Anil Sethi and some others for "using intemperate language against the judge and the court." Obviously, the accused must know that no civilized society can countenance the heinous crime they are accused of. By creating a ruckus within and outside a court, they certainly cannot escape from the legal consequences of their alleged deeds. It goes without saying that a mere statement of the victims in the sexploitation case is more than enough to take legal action against the accused. Judicial pronouncements have made it abundantly clear that no further evidence would be required to proceed against a rapist. In the sex scandal that rocked Kashmir in April this year, India's premier investigating agency, the Central Bureau of Investigation, which has been entrusted with perhaps the most challenging of criminal cases, is understood to have taken all the precautions to ensure that no innocent person was implicated. For that matter, its sleuths corroborated the evidence provided by the victims again and again to lay their hands at the accused after being convinced about their involvement. On their part, the courts too are leaving nothing to chance. Indeed, the investigations and the trials are being carried out under the watchful eyes of people, who are equally concerned in the case which has shattered their faith in the entire system they breathe in. Nobody can deny that the act of forcing scores of unsuspecting girls, many of them minor, into prostitution after administering drugs and filming them nude, cannot be taken as an ordinary crime. By any stretch of imagination, it is an extraordinary crime of an enormous import and calls for an equally extraordinary response not merely from the established legal system but from the society as a whole. Based on sheer common sense, indeed the dictates of mass conscience, like it is in certain Muslim countries, a summary trial followed by capital punishment could be the most deterrent and effective response in such a case, if the prospective victims of such barbarity were to be insured against similar risks at the hands of beasts who are present in the society aplenty and who will always be on the prowl for them. There is no denying that those who are never tired of painting such deterrent laws as barbaric have themselves demanded death penalty for rapists. The home ministry in New Delhi is already seized of the matter and is believed to be contemplating an amendment in the constitution to provide for such a punishment for rapists. One would expect the government in Jammu and Kashmir to bring in such a legislation to ensure that flaws do not have the better of the law in the instant case and that a deterrent law is put in place before the judicial process reaches its final stage.

## **Skills Enhancement: Way Forward for Indian Madrassas**

ver since their emergence, the Madrassas in India have persisted with a curriculum that has seen few changes. The fact that literally, lakhs of Muslim children acquire their primary, and perhaps their only formal education, in these Madrassas where only literature and Islamic studies with a cursory knowledge of social sciences thrown in, are taught, should be a matter of concern not only to their parents but also to anybody concerned with education in any manner. The format of education imparted to the students of Madrassas ought to be modified keeping in view the shifting demands of the job market - a concern that can no longer be under-played. And this is perfectly possible without an erosion of the cultural and religious identity.

Developing suitable answers for today's dilemmas requires an examination of the essentials of education. Education involves transference to others, of knowledge and values accumulated by mankind. Even though schools and teachers have been part of the process of education for hundreds or even thousands of years, it is the spirit of inquiry that has enriched mankind with knowledge. We learn through reading, experience by watching others and by observing the world in general. Inculcating a spirit of scientific enquiry in students will perhaps be the best manner of propelling them on the path of learning.

Even though this may be the general agreement, it is a fact that in this country particularly, whenever an attempt is made to institute any profound change, a resistance begins to act from its very inception. The critics flinch at the vision of a Madrassa system where modern education or skills enhancement would jettison religious knowledge and make education "worldly" and "impersonal".

It is a matter of satisfaction to note that of late, some Madrassas have realised the significance of modern education, and have introduced teaching science, English and Computer skills in their curricula. For example the two largest Madrassas in India, Darul Uloom-Deoband and Nadwa-tul Ulema-Lucknow have braced themselves to be the harbinger of change and have introduced English language teaching and computer skills as part of their curriculum. But both have not been able to bring about any noticeable improvement in the quality of education they impart to their students.

It is often argued that if modern education is so sensational, why hasn't it brought any notable improvement to education in the few Madrassas that have adopted it? In reality, in spite of modern education being imparted, thousands of Madrassas don't have a well-formulated cur-



riculum, and/or couldn't implement it even if they wanted to, as they don't have sufficiently trained and proficient staff.

It is also a fact that in the earlier years of madrassa education, the founders of Darul Uloom-Deoband, insisted on imparting skills enhancement to their students. Thus enabling them to earn their livelihood and also continue with their religious duties. These skills enhancements included calligraphy, book binding, printing and tailoring. However, over time these components were removed from the madrassa training.

But as it is, the wheels of history continue turning round and round, and indeed now-adays Skills Enhancement has become a buzzword for the whole world, not just for madrassa students.

In the given scenario, madrassa authorities could very well take advantage of different skills enhancement programmes run by the GoI, government and private institutions and different universities and colleges throughout the country.

Madrassa authorities across India can collaborate with National Skills Foundation of India, National Skill Development Corporation, NSIC, Delhi Skill & Entrepreneurship University, Jamia Millia Islamia, AMU and Jamia Hamdard University to name a few, to initiate skills enhancement and development programmes for their students.

In addition, madrassas can also collaborate with various NGOs, who have a credible record

of delivering Skills Enhancement and personality development courses over the years.

Madrassa students have an edge over students of the modern education system, their memorisation capacity is honed so well that this capacity can be utilised to guide them through various skills enhancement courses related to computers and IT, like data analytics and programming. In the past, organisations, which had embarked on this path, reported highly encouraging results.

If the madrassa authorities in collaboration with central bodies like the Ministry of Minority Affairs and Maulana Azad National Foundation carry forward such successful programmes, whose results have been quantified and documented well, then this could augur well both for the country and madrassa. It will also ensure taking the sting out of the critic's blame that madrassa students are inferior to the students who have pursued courses under the modern education system.

They blocked economic reform and imposed corrupt employment practices. Their industrial muscle meant they were above the law. That is why I, with millions of others, voted for Margaret Thatcher.

This time, it's not the over-mighty trade union barons. It's the feral rich. They own this Tory government

Half a century later, we in Britain face a similar - but not an identical - problem. This time, it's not the over-mighty trade union barons. It's the feral rich. They own this Tory government in the same way that trade unions owned the Labour government in the 1970s. When former Prime Minister Harold Wilson tried to reduce union power through legislation with his "in place of strife" reforms, the union barons humiliated him.

There are comparisons to be made with the way big Tory donors paid for the campaign to block former Prime Minister Theresa May's EU deal three years ago - then went onto back Boris Johnson's rise to power. Some donors later received government contracts, and others favours.

Back in the 1970s, Len Murray, a war hero who became general secretary of the Trades Union Congress, was the key intermediary between the Labour government and its trade union bankers.

Today, a comparable role is played by a figure who is almost unknown to the general public. One of Johnson's first acts after becoming prime minister in July 2019 was to make Ben Elliot the Tory co-chairman.

#### 'Access capitalism'

Elliot, an old Etonian and nephew of the Duchess of Cornwall, Britain's future queen, is at ease with the global super-rich. His business, Quintessentially, is a concierge service for oligarchs and other rich people who want introductions and invitations at the top level of British society.

As Tory chairman Elliot is the umbilical chord which links the

Tory Party to its financial backers. Like many senior members of the government front bench, he's done business offshore, jointly owning a film financing business that cropped up in the Pandora Papers.

In the days when trade unions called the shots, there were frequent meetings at 10 Downing Street between Wilson, Murray and the union bosses to thrash out counterinflation policy over beer and sandwiches, which I've been told were often prepared in the tiny Downing Street kitchen by Mary Wilson, the prime minister's wife.

Under the Johnson/Elliot regime, the prime minister and his cabinet meet their financial supporters at lavish London parties. The most recent of these plush events took place at the Victoria & Albert Museum last month, where prizes were auctioned off for Tory funds. An African safari trip reportedly went for £65,000 (\$77,000), a shooting weekend for £37,000, a wine tasting for £30,000, and a dinner with Johnson and two former Tory prime ministers for £120,000.

What a message this sends out at a time when a growing number of British people don't know how to pay for their next meal.

Few billionaires are soft touches. They tend not to write cheques out of the goodness of their hearts, so I suspect some want a return for their money: contracts, access, planning consent, legal changes.

#### The begging bowl

Now let's look at the Tory leadership campaign. The super-rich fought hard to keep Johnson, with 22 of the richest donors declaring "unwavering support" for the now disgraced prime minister as recently as a month ago. Meanwhile, some had been carefully nursing alternatives: an investigation for the Byline Times last week showed that 14 front-runners for the leadership contest had secured £307,000 in donations over the last 12 months.

That included £65,000 for Tom Tugendhat, with a large proportion from Lord Michael Spencer, a shareholder in GB News. Priti Patel, whose campaign flopped, received £140,000, including a £100,000 donation from oil trader Pierre Andurand.

Meanwhile, the limit for spending on leadership campaigns has been quietly lifted to a prodigious £300,000. No wonder candidates are forced to hand out the begging bowl to donors.

Other candidates receive payment in kind. Aristocrat Baron Howard of Rising, a former private secretary to Enoch Powell, allowed candidate Liz Truss to base her campaign headquarters in his grand and convenient Westminster home.

The Tory leadership campaign has seen vicious personal infighting, but precious few policy differences. All accept Johnson's policy of deporting migrants to Rwanda. None have challenged his attacks on the basic tenets of liberal democracy, including on judges and the rule of law.

None has spoken out against attacks on the European Convention on Human Rights, the privatisation of Channel 4, or the stealthy privatisation of the BBC. None has called out the stench of big donor money at Tory central office. It is perhaps significant that Rishi Sunak, the only candidate not to advocate hefty tax cuts, has a family fortune estimated at £700m, so he has no need for donor support.

#### Too much power

For the Labour-supporting union barons 50 years ago, read today's Tory billionaires. They have been allowed too close to power. They have too much power. It is the job of a responsible government to keep billionaires at bay, not to obey their orders.

This structural surrender to the interests of the super-rich, part of the wider problem of the Americanisation of British politics, has corrupted the Conservative Party. Not one Tory candidate has even dared to say this. When I rang one up to suggest he do so, he showed no interest, and brought our conversation to a speedy end.

The postwar era in Britain can be divided into two parts. In the lapsed, and Britain entered a period of mortal crisis that ended with the rise of Thatcher. She established a new system that some commentators labelled neoliberalism.

It's one measure of the irresponsibility of the Tory leadership battle that not one candidate mentions this

Thatcherism was so successful that it ended up being championed by former Prime Minister Tony Blair's New Labour. But today, it is in collapse. It pains me, a onetime admirer of Thatcher, to acknowledge this. But the system she championed has degenerated into an obscene system of government by and for the super-rich.


Recently, I asked myself who I preferred: the Tory donors who pull the strings in the modern Conservative Party, or Mick Lynch, general secretary of the National Union of Rail, Maritime and Transport Workers.

The answer is Lynch. Every time. He's loyal, palpably decent, straight-up, and stands up for his people. He knows what he talks about. He pays British taxes and isn't based offshore. I suspect that most people feel the same.

There's an enormous opportunity here for Keir Starmer's Labour. Britain has already embarked upon the early stages of a massive - and hugely painful - economic and social crisis. It's one measure of the irresponsibility of the Tory leadership battle that not one candidate mentions this. Nor does Starmer. The economic system created by Thatcher - and her disciple Blair has finally failed.

# Sunless: Our Own Vampire Diaries?

Sunless is a tale of loyalty and betrayal; love and animosity; justice and tyranny. Dominated by a blend of misery, suffering, and loss, the story evokes a mixed bag of emotions in the reader's mind

That happens when a band of bloodthirsty thugs in the town of Divilton conspire against mankind? The story narrated in Sunless, a thriller novella, revolves around the protagonist, Zuke, who was orphaned at a very young age and sets out on a stupefying adventure to unravel his true identity. Initially oblivious to the dark past haunting his murdered family, he leads a life plagued with the untimely losses of his loved ones, as his soul alternates between periods of hope, courage, anger, and sorrow. As he wanders in the jungles of Divilton, the 118-page novella introduces mysterious, supernatural characters who inspire and more often, agitate him to unearth the legacy of his parents from within his heart and join the battle against evil. The book also presents an account of the power struggle between two rival factions of vampires, the Red Skulls and the Black Skulls. The former is sympathetic to humanity and vows to protect them against the latter till their last breath. However, due to the gullible and complacent nature of human beings, as alluded to in the book, the dark forces momentarily triumph over the light of truth. But in the end, there is a clear victory of good over evil, which chalks out a perfect conclusion to the story. The final pages of the book leave the reader on the edge of their seats as Zuke finally attains salvation after fulfilling his mission on earth.

Sunless is a tale of loyalty and betrayal; love and animosity; justice and tyranny. Dominated by a blend of misery, suffering, and loss, the story evokes a mixed bag of emotions in the reader's mind. One can remark that the title of the novella accurately describes the mood of the book, portraying Zuke as a resilient character who, in spite of being deprived of the light of hope and happiness throughout his life, chooses to side with humanity and its allies for the sake of peace, and seek revenge for the cold-blooded killings of his beloved and his family.

Although the book is divided into 4 parts, the author, Hibban Showkat, has made a beautiful attempt to knit the plot in a manner so as to preserve the sui generis nature of each of these parts. I have observed that the subdivision of the book into 26 distinct chapters plays a minimal role in enhancing the overall plot of the story, as it can be observed that the partitioning has been arbitrarily carried out. However, it does not negatively impact the reading experience in any way. The setting of the novel is predominantly rural and heavily dotted with references to the natural beauty and landscape of Divilton and its adjoining areas, which kindles a plethora of imagery in the reader's eyes. As indicated in the prologue, the story is completely detached from reality and is heavily dominated by fictional characters, notably the vampires, John, Alex, and the antagonist, Jordon. Its fictional details are devoid of any underlying values and wisdom, but the tale is genuinely engaging and easy to follow. The story is narrated in firstperson, which immerses one into the world that the author is trying to depict. There is a structural consistency within the text, through which each segment of the story unfolds in a way that reveals new details with an aura of mystery, intensity, and suspense.

When I first read the novel, I could sense that Hibban is heavily imbued with the writing style of Western writers like Dickens and Bukowski. It was so refreshing to observe the beauty of the syntax of the English language that was portrayed by the young writer in his work. While engaging in an informal chit-chat a few months ago, Hibban confided in me that he was apprehensive about pouring in all of his thoughts and ideas into the novel, for it could be a bad idea to exhaust all your creativity in your first novel. According to me, the end result was nevertheless a masterpiece for a young boy of age 16.

Hibban was in 10th grade when he published Sunless three years ago, in 2019. The book came into existence after a year of excruciating hard work and perseverance. "I must have rewritten the entire novel a number of times, until I was confident about submitting it to a publishing house. I was on an emotional rollercoaster that year."

Hibban's work, despite having an excellent plot and emotional appeal to it, is unable to manifest its true grace owing to a lack of revision and editing by an external agency.

In recent years, a culture of selfpublishing has prevailed in the Kashmiri literary circles, especially among young writers and novelists. Self-publishing has in fact attracted criticism due to the absence of proper reviewing authority to weed out inappropriate and copied content, which can be done only by carrying out proper due diligence. The imprints of traditional publishing giants have swarmed the market, resulting in an unhealthy glut of unedited and plagiarized books. Sunless has been an unfortunate victim of this vicious situation. Its pages are full of obvious grammatical errors, which could have been easily sifted out with sincere efforts. The characters, especially that of the Hermit, should have been given expository backstories to further elaborate on the motive of their actions. In chapter 4 of part 3, John refers to an 'ancient curse' of their ancestors, which has been casually used to change the entire course of the story without providing any further context. Such discrepancies could have been avoided by the author.

To conclude, the novel is very unique for the region, having been inspired by the famous show, The Vampire Diaries. Individuals looking for thriller novels with a similar storyline should definitely check out the book on e-commerce sites. Hibban Showkat was one of the earliest teenage authors of Kashmir, heralding the era of young writers being celebrated and publicized in the valley. Such prodigies time and again illustrate the amount of talent veiled in the Himalayan mountains, waiting to be tapped for the welfare of our society.

# **Can Too Much Happiness Or Sadness Kill?**

ying of a broken heart was just a figure of speech until 2002 when Dr Hikaru Sato and colleagues at Hiroshima City Hospital described it in a study. Sato named the condition takotsubo cardiomyopathy. It was quickly dubbed "broken heart syndrome".

More recently, scientists have discovered that you can also die of an excess of happiness. And it is the same condition: takotsubo cardiomyopathy. Naturally, it's being called "happy heart syndrome".

So what is takotsubo cardiomyopathy – or takotsubo syndrome, as it is also known? And why do some people die of it?

First, it should be stressed that takotsubo cardiomyopathy is rarely fatal. As with other cardiomyopathies (disease of the heart muscle), most people recover within a couple of months without long-term heart damage.

It is so named because people with the condition have an abnormally shaped left ventricle – the main pumping chamber in the heart. Sato thought the shape – narrow at the top and ballooning at the bottom – resembled the ceramic pots used to trap octopuses (takotsubo), hence the name.

This ballooning weakens the heart muscle, affecting its ability to pump blood effectively.

## MORE CASES OR BETTER AWARENESS?

A study of around 135,000 people in the US found that the number of people diagnosed with this condi-



tion increased steadily over the 11 years that the study was conducted (2006-2017). It is more common in women (88%) and seen most commonly in people aged 50 and over.

Doctors are probably finding more cases now because there is better awareness of the condition, people are living longer and there are better diagnostic tools to detect it. Until recently, this "broken heart" syndrome was shown to be associated with significant emotional or physical stress. The exact mechanism by which the stress causes the change in the heart's shape and the subsequent symptoms – chest pain and shortness of breath – is still not fully understood.

Doctors have noted similar harm-

ful changes to the heart in people with conditions, such as pheochromocytoma (a rare tumour on the adrenal glands) and central nervous system disorders. In these conditions, there is an excess of catecholamines, which are hormones, such as adrenaline, noradrenaline and dopamine, made by the adrenal glands. This provides a hint of the possible role of these hormones in takotsubo cardiomyopathy.

The role of these hormones in broken heart syndrome has been further cemented by the exact same ballooning of the heart's left ventricle being witnessed in patients treated with these catecholamines while undergoing cosmetic rhinoplasty ("nose job"). In stressful situations, these catecholamines are increased and they affect the body, particularly the heart where they are involved in increasing the heart rate and strength of the heartbeat. This effect in stressful situations is not a surprise, as often the body and mind go into a fightor-flight mode, which triggers the release of these catecholamines.

Stressful events that can trigger takotsubo syndrome include receiving bad news (such as a cancer diagnosis), the loss of a loved one, domestic violence, a car accident and even public speaking.

#### THE FLIP SIDE

Most recently, researchers in Germany have described patients with takotsubo syndrome triggered by happy events, such as a wedding, the birth of grandchildren and winning the jackpot.

Of 910 patients in the study who had an emotional trigger for takotsubo syndrome, 37 had happy heart syndrome and 873 had broken heart syndrome. Unlike broken heart syndrome, which mainly affects women, happy heart syndrome was mostly observed in men.

The researchers found that deaths and complications from happy heart and broken heart syndrome are about the same, that is to say, rare. So don't worry about getting emotional about life's big events. They're very unlikely to kill you. But if you do feel pain or pressure in your chest, always seek medical help.

## Delhi Court Grants Bail To Zubair; "Voice Of Dissent Is Necessary For A Healthy Democracy"

New Delhi: A Delhi court on Friday granted bail to Alt News co-founder Mohammed Zubair in a case related to his alleged objectionable tweet in 2018 on a Hindu deity, observing that "the voice of dissent is necessary for a healthy democracy".

Zubair, however, will remain in jail as he has been remanded to judicial custody in some of the FIRs registered against him by the UP Police for allegedly hurting religious sentiments.

Zubair will be sent to the concerned jail in Uttar Pradesh after his release, according to a Tihar jail official here. The journalist is currently lodged in Tihar jail since July 2.

Granting relief to the journalist, Additional Sessions Judge Devender Kumar Jangala said Indian democracy and the political parties are open for their criticism and that merely criticism of any political parties is no ground to invoke section 153A (promoting enmity between different groups) and 295A (outraging religious feelings) of the Indian Penal Code(IPC).

"Undoubtedly free speech is

the proper foundation of a democratic society." The court further said the

Hindu religion is one of the oldest religion and most tolerant and that followers of the Hindu religion are also tolerant. Six separate FIRs have been

lodged against Zubair in Sitapur, Lakhimpur Kheri, Ghaziabad, Muzaffarnagar and Hathras districts in UP.

The court directed Zubair to furnish a bail bond of Rs 50,000 and one surety of like amount, and directed him not to leave the country without its prior permission and not to repeat the offence. The journalist was also ordered to ensure that his tweet or retweet, or any material on social media content is not even touching boundaries of the offence punishable under Section

153A and 295A of IPC.theIt said the accused is not required for any custodial interrogation and the alleged act wouldGodcome into the category of offence only when it is done withof comea guilty intention.the

The judge noted that till today the police have failed to establish the identity of a said Twitter user who felt offended by the

tweet of the accused and based on whose complaint the present case was filed.

In response to prosecution's argument that the words "Before 2014" and "After 2014" used by the accused in his tweet have hurt the sentiments of the Hindu community and is sufficient to incite the feeling of hatred among people, the court said the followers of the Hindu

religion are tolerant. "Hindu religion is one of the oldest religions and most tolerant. The followers of the Hindu religion are also tolerant. Hindu religion is so tolerant that its followers proudly name their institution/organisation/facilities in the name of their Holy God or Goddess," the judge said. A large number of Hindus

proudly name their children in the name of their Holy God and Goddess, he added. "The website of Ministry of

ld Corporate Affairs, Government of India reveals that the number of companies is incorporated, in the name of Holy Hindu God or Goddess. Therefore naming of an institute, facility or organisation, or child in the name of Hindu Deity on the face of it, is not violative of Section 153A and 295A IPC unless the same is done with malice/guilty intention," the judge said.

The court noted the use of words "Before 2014" and "After 2014" by the accused in his tweet was meant to point towards a particular political party. The BJP-led NDA came to power in 2014.

"In Indian democracy, the political parties are open for their criticism. The political parties are not shying away from the public to face the criticism of its policies. The voice of dissent is necessary for a healthy democracy. Therefore, merely for the criticism of any political parties, it is not justified to invoke sections 153A and 295A of IPC," the judge said. He said that democracy is a

government by the people via open discussion.

"The democracy can neither work nor prosper unless people go out to share their views. Article 19(1)(a) of the Constitution of India gives freedom of speech and expression to its citizen."

He said that a free exchange of ideas, dissemination of information without restraints, dissemination of knowledge, airing of differing viewpoints, debating and forming one's views and expressing them, are the basic indicator of a free society.

"This freedom alone makes it possible for people to formulate their own views and opinions on a proper basis and to exercise their social, economic, and political rights in a free society in an informed manner. The liberty of speech and expression guaranteed by Article 19(1)(a) brings within its ambit, the corresponding duty and responsibility and puts limitations on the exercise of that liberty."

"The applicant has posted the image of the scene of a movie 'Kisi se na kehna' released in the year 1983. This movie was certified by the Central Board of Film Certification, which is a statutory body of the Government of India, and is available for the public view since then. No complaint is stated to have been filed till today that the said scene of the movie has hurt the feelings of a particular community of society," the court noted.

The talks took place over a week after Germany, a key member of the EU, criticised Indian authorities over fact-checker Mohammed Zubair's arrest saying "Journalists should not be persecuted and

## imprisoned for what they say and write." India had trashed the comments made by a German

foreign ministry spokesperson. "India and the EU reiterated their commitment to protecting and promoting all human rights. In this context, as open and democratic societies, they emphasised the universality, indivisibility, interdependence and interrelatedness of all human rights," the statement said.

It said the two sides exchanged views and concerns on civil and political rights, rights of persons belonging to minorities and vulnerable groups, freedom of religion or belief, freedom of expression and opinion both online and offline.

## Creation Of Standalone Air Defence Command May Prove Counter-Productive: IAF Chief

**New Delhi:** Creation of a standalone air defence command may prove counter-productive as all elements of the nation's air power need work in close coordination to confront all possible future security challenges, Air Chief Marshal VR Chaudhari said on Friday. The Chief of Air Staff also said

that independent air defence systems in the field will have very little relevance in tomorrow's wars unless they are a part of a larger integrated air defence system.

His comments at a seminar came amid ongoing deliberations on the ambitious theaterisation initiative that entailed creation of an integrated air "While there is a need for close coordination between all elements within the same airspace to ensure aerospace safety as well as effective air defence, creation of an AD (Air Defence) command may prove counterproductive because air defence operations are inextricably linked to counter air operations and all offensive operations, as the success or failure of one, will dictate the demands on the other," the IAF chief said.

"The AD and offensive missions are interdependent and if executed in isolation, these would not only be disjointed but also ineffective in design or execution of the joint strategy," he added. Air Chief Marshal Chaudhari said modern 4.5 and fifth generation aircraft have omni-role capability and to restrict those aircraft to any one role would lead to their underutilisation. "Flexibility, one of the character-

istics of air power, gives a planner the freedom to swing roles depending on the air situation and this must be capitalised on," he said.

The theatre commands are being planned to integrate the capabilities of the three services and to ensure optimal utilisation of their resources.

The Department of Military Affairs headed by India's first Chief of Defence Staff Gen Bipin Rawat last year had asked all the three services to carry out independent studies on the theaterisation plan for its rollout.

In this survey, a standard and validated tool, WHO ASSIST (v3.0) was employed to elicit information about the pattern of substance use as well as injection pattern of substance use Respondent Driven Sampling (RDS) was used to collect a sample of 1500 participants- 150 from each district.

"Appropriate measures were taken in order to ensure genuineness, high ethical standards and proper procedures to be followed during data collection," the report says.

The study analysed alcohol, opioids , cannabis, and sedatives. The survey was conducted independently for each district and the findings projected for the population of Kashmir Valley, the report said.

## Soldiers Train

The official said that one soldier [Sepoy Ibrar Ahmed] died on the spot while the three injured personnel were airlifted to army hospital in Udhampur.

"However, upon reaching the hospital another soldier [Naik Imtiyaz Ahmed] succumbed to his injuries. Naik Khalil Ahmed and Sepoy Makhan Singh are stable now," the defence official said, adding that the army has ordered a court of inquiry to ascertain the facts related to the incident.

Pertinently, the incident took place when the soldiers were being deployed for Road Opening Party (ROP) duty.

As per a data compiled by The wire from different sources, between January and August 2020, 18 members of the security forces died by suicide and six died in fratricidal incidents, making a total of 24 such deaths.

The report further stated that in 2019, according to the annual human rights review by the Jammu Kashmir Coalition of Civil Society (JKCCS), 19 members of the armed forces reportedly died by suicide while three were killed in a fratricidal incident in Udhampur district. The total number of deaths by suicide and fratricide for all the 12 months of 2019 was 22.

On June 20, a police spokesperson had claimed that four Lashkar-e-Taiba militants — Bambar Khan, Al-Bakash, Aftab Bhai of Pakistan besides Showket Ahmad Sheikh of Sedow village in Shopian were killed in an encounter in Chandigam area of Lolab.

He had further claimed that it was on Sheikh's disclosure that the operation was carried out. Sheikh, he had said, was the mastermind behind an IED blast in a private vehicle in which one soldier was killed and others injured.' K Bhat, framed charges against 10 people, including Malik, in the Rubaiya kidnapping case that turned out to be a turning point in the Valley's volatile history. The release of the five JKLF members was seen as a morale booster for militant groups, which had started raising their heads at the time.

During the hearing, Rubaiya recorded her statement before the special judge and during the course she identified Malik, who was recently sentenced to life imprisonment in a funding case, and three others as her abductors.

Ahead of Rubaiya's statement, Malik had appeared in the same case on July 13 during which he asked the court for ensuring his physical appearance so that he could cross question the witnesses in the case or else he would sit on indefinite hunger strike in prison.

Malik told the court that he was awaiting a response from the government till July 22 failing which he would start his indefinite hunger strike.

The JKLF chief is at present lodged in the high-security Tihar Jail after he was sentenced by a special NIA court in Delhi in May. He was arrested in early 2019 in connection with the 2017 militant-funding case registered by NIA.

Rubaiya was abducted near Lal Ded Hospital on December 8, 1989 and freed from captivity five days later on December 13 after the then V P Singh government, supported by the BJP at the Centre, released the five militants in exchange.

"Since the accused persons besides admitting of their own guilt have also narrated about the participation of other accused persons namely Malik, Javed Ahmed Mir and Mehraj-U-Din Sheikh, which can also be used against them as one of the pieces of evidence," the court had said in January last year.

The 10 are among the two dozen accused named by the CBI in its chargesheet filed before the court. 

## Asia Cup: PCB Wants Sri Lanka **To Retain Hosting Rights**

KARACHI: The Pakistan Cricket Board will support Sri Lanka in its bid to host the Asia Cup from August 27 despite civil and political unrest in the island nation.

Sri Lanka have managed to successfully host the Australian cricket team without any security breach despite civil unrest after former president Gotabaya Rajapaksa fled the country in the midst of an acute financial crisis. A PCB source said that chair-

man Ramiz Raja had spoken to top SLC officials and assured them that Pakistan will push for the Asia Cup to remain in Sri Lanka as scheduled from August 27 to September 11.

"The PCB chairman has assured his counterpart that Pakistan wants Sri Lanka to host the regional event as it would mean revenue earnings for the host country and will also boost their tourism," the source said. The source also said that the

PCB had also assured Lankan cricket authorities that the Pakistan team will play its Test matches in Galle and Colombo despite the ongoing unrest in the country.

He informed that although no official Asian Cricket Council (ACC) meeting is scheduled in in the coming days, all the members being present during upcoming ICC Board meeting in Birmingham from August 22, will give them a chance to discuss a range of issues including hosting rights for the next Asia Cup in Pakistan.

"Since all the ACC members will be present, there will be discussions on the sidelines and Pakistan is clear that Sri Lanka must host the Asia Cup unless their board decides otherwise," the source added

"Pakistan's point of view is clear that it has a long-standing relationship with Sri Lankan cricket and both have always supported each other in times of need.'

## **Tokyo Chosen To Host 2025 Track World Championships**

**EUGENE:** Track and field officials awarded the 2025 world championships to Tokyo on Thursday, bringing runners, jumpers and throwers back to the home of last year's Olympics, where they competed in front of mostly empty stands.

The World Athletics Council awarded the championships in a bidding contest that also included Nairobi, Kenya; Silesia, Poland; and Singapore.

World Athletics President Sebastian Coe said it was a close vote, but Japan won on the strength of, among other things, "human resource" available in Tokyo to put on the event and strong commercial partnerships.

MANCHESTER: Manchester United signed Denmark playmaker Christian Eriksen to a three-year contract on Friday.

The 30-year-old Eriksen played for Brentford in the second half of last season, joining the London club almost eight months after collapsing from cardiac arrest at the European Championship.

The former Tottenham player is United's second major signing under manager Erik ten Hag following the arrival of left back Tyrell Malacia from Dutch club Feyenoord.

"Manchester United is a special club, and I cannot wait to get started," said Eriksen, who has also played for Inter Milan.

Eriksen said he has spoken with Ten Hag "and learned more about his vision and the way he wants the team to play, I am even more excited for the future."

Eriksen's contract with Inter Milan was terminated by mutual agreement last December since Italian regulations prevented him from playing with the implantable cardioverter-defibrillator that was fitted.
