Neuroscience Says These 5 Simple Tricks Will Calm Your Anxiety Instantly

We live in anxiety-ridden times. What's going to happen to the economy?

Is political strife going to get worse? Am I doing the right things with my life?

Fortunately, we can point to simple techniques that neuroscience suggests work effectively to make people much less anxious--quicker than you think

Here are five of them:

1. Listen to this specially designed song.

I'm putting this first because it's my favorite and I'm still shocked at how well it works.

A decade ago, British musicians teamed up with sound therapists to record a song called Weightlessness that stimulates specific neurological reactions: lower heart rate, lower blood pressure, and reduced levels of the stress hormone, cortisol.

"The song...contains a sustaining rhythm that starts at 60 beats per minute and gradually slows to around 50," explained Lyz Cooper, founder of the British Academy of Sound Therapy. "While listening, your heart rate gradually comes to match that beat."

It's just eight minutes long, and it works like a charm. I first tried it several years ago, and I've kept it bookmarked on my computer ever since. I'll embed a YouTube version at the end of this column.

2. Use the 4-7-8 breathing method.

Another very easy, almost toogood-to-be-true method that actually works. In short, by breathing in a very simple way, you can kick-start your parasympathetic nervous system, which causes the body to become calmer.

In short, just do this: Find a place to sit comfortably,

back straight. Put your teeth on the back of

your tongue, and exhale completely through your mouth, making a sound like "whoosh" as you breathe out.

Breathe in through your nose for 4 seconds

Hold your breath for 7 seconds. Breathe back out again as you did

at the beginning, for 8 seconds. Repeat steps 3, 4 and 5 a total of

three times. Bonus: If you're ever lying awake at night unable to sleep, the 4-7-

8 method of breathing works wonders for that, too.

3. Get 45 minutes of vigorous exercise.

This one is fairly recent, and it comes from the International Journal of Environmental Research and Public Health. Researchers studied 66 college students during the pandemic, and concluded that negative thoughts and anxiety were appreciably less prevalent when participants exercised:

lightly for just under 2 hours per day moderately for 80 minutes per day, or vigorously for 45 minutes per day.

Choose whatever works for your ambition and schedule; I tend to recommend the 45 minute version, simply because if part of what is creating anxiety is concern about getting things done, adding a 2-hour habit to your day might be a bit self-defeating.

Get some nature.

We have all kinds of studies to point to here. Two of my colleagues on Inc.com have written pretty extensively about how taking an "awe walk" in nature can make people feel less anxious -- even one lasting just 15 minutes.

You don't even have to walk, necessarily; researchers found that simply commuting to work through "outdoor spaces that contain 'green' and/or 'blue' natural elements" (think trees, grass, and bodies of water) made people less anxious.

For that matter, researchers at the University of Hyogo in Japan say that simply putting small plants on workers' desks in an office "contributed to their psychological stress reduction regardless of their age or plants choice.

Bottom line, it's a lot harder to be anxious when you're surrounded by green and blue.

5. Save it for later.

This last trick is less about shutting off anxiety than it is about making it manageable. In short, make a note about the things that make you anxious -- even a literal, written note -- and then promise yourself that you'll set a block of time later in the day to be worried about them.

Seriously, pick a time and put it on your schedule: "From 2 p.m. to 2:20 p.m. is my "worry time." Any other time of day, I jot down my worries so I can feel anxious about them at the appropriate time.'

"This strategy focuses on not postponing your worries," psychologist Dr. Regine Galanti explained to Time, "[instead] setting up a time where you can worry all you want. ... [I]t sets boundaries, so when a worry comes up at 9 a.m., you can say, 'Hey, not now, your time is coming.'

Perhaps the best part about this trick? By whatever time you've set Reels Facebook's clone of aside for worrying, you'll often find TikTok. you're no longer worried.

Facebook Gives Users New Way To See All **Their Friends' Posts**

enlo Park (US)-Facebook is rolling out an update that enables its two billion daily users to more easily view their friends' posts in chronological order

The new feature is the company's latest attempt to keep people coming back to its social network amid intensifying competition with its trendier rival TikTok.

The changes announced on Thursday will offer up two different perspectives.

When Facebook users open the app, they will initially see the usual news feed featuring posts selected by an algorithm that the company says is designed to highlight topics and friends most likely to appeal to each individual's tastes and interests.

Meta Platforms, is trying to address those concerns with a new Feed tab located to the left of the notifications tab on the shortcut bar in both the iPhone and Android versions of its mobile app.

After clicking on the Feed tab, users will be able to toggle over to a chronological presentation of their Facebook favourites, Facebook groups they have joined or feeds consisting exclusively of posts from all their Facebook friends in the order they were shared

The new option is designed to address complaints from users who believe they have been missing interesting posts because Facebook's algorithm omitted them from their feeds.

One of the most requested features for Facebook is to make sure people don't miss friends' posts," Facebook founder and Meta CEO Mark Zuckerberg said in the announcement.

Facebook is giving users



more control at a time when it has been struggling to grow, partly because other social media such as TikTok have become more popular, particularly among young

generations. That stagnation, in turn, is making it more difficult for corporate parent Meta to boost its profits from the digital ads that appear in users' feeds.

A Better Way To Walk Nordic Walking Improves Quality of Life, **Depression, and Functional Capacity**

ordic walking, also known as pole walking, requires more effort to be applied to the poles with each step than conventional walking does. Upper body muscles are stimulated more during Nordic walking than they are during regular walking, which may cause considerable increases in heart rate at a given speed. When compared to walking without poles, it has been reported that Nordic walking may increase energy consumption by over 40%

A recent study published in the Canadian Journal of Cardiology shows that Nordic walking is superior to other kinds of exercise in cardiovascular rehabilitation for improving long-term functional capacity

In comparison to standard high-intensity interval training and moderate-to-vigorous intensity continuous training, researchers found that Nordic walking in patients with coronary heart disease resulted in a greater improvement in functional capacity, or the ability to carry out activities of daily living. Their randomized clinical trial's findings have recently been published in the Canadian Journal of Cardiology.

Following severe cardiovascular events, cardiovascular rehabilitation and exercise training programs are linked to significant gains in functional ability, cardiorespiratory fitness, and mental health. However, some people find monotonous exercises like stationary cycling and walking to be boring and may quit working out after their cardiovascular rehabilitation program is over. In order to find out whether they might encourage more people to keep exercising and what advantages might be obtained, researchers looked at more appealing workout choices that would appeal to a wider audience.

A growing body of research indicates that non-standard exercise interventions, such as Nordic walking and high-intensity interval training, are superior to conventional exercise methods for increasing functional capacity as evaluated by the six-minute walk test, a key indicator of cardiovascular events in people with



coronary artery disease. Nordic walking is a more advanced kind of walking exercise that employs poles with specialized designs to better involve the muscles in both the upper and lower body.

"Patients with coronary artery disease frequently demonstrate diminished functional capacity, low quality of life, and increased the risk of subsequent cardiovascular events and mortality," explained lead investigator Jennifer L. Reed, Ph.D., Exercise Physiology and Cardiovascular Health Lab, Division of Cardiac Prevention and Rehabilitation, University of Ottawa Heart Institute; Faculty of Medicine; and School of Human Kinetics, Faculty of Health Sciences, University of Ottawa, Ottawa, ON, Canada.

Investigators compared the prolonged effects of 12-week rehabilitation with 1) high-intensity interval training; 2) moderateto-vigorous intensity continuous training; and 3) Nordic walking, on functional capacity, quality of life, and depression symptoms in patients with coronary artery disease. One hundred and thirty patients were randomized to a 12week training in one of these three groups followed by a 14-week observation phase.

While all exercise programs improved depression symptoms and quality of life, the improvement in functional capacity was greatest after Nordic walking (+19%) when compared to highintensity interval training (+13%) and moderate-to-vigorous intensity continuous training (+12%).

"This is a key finding because lower functional capacity predicts higher risk of future cardiovascular events in people with coronary artery disease," noted Dr. Reed. "Nordic walking engages core, upper and lower body muscles while reducing loading stress at the knee, which may have resulted in greater improvements in functional capacity.'

"No previous study has directly compared the long-term effects of high-intensity interval training, moderate-to-vigorous intensity continuous training, and Nordic walking," commented Tasuku Terada, Ph.D., Exercise Physiology and Cardiovascular Health Lab, Division of Cardiac Prevention and Rehabilitation, University of Ottawa Heart Institute, Ottawa, ON, Canada.

'This study is novel in that it simultaneously compared the sustained effects (i.e., 14 weeks after the completion of cardiovascular rehabilitation) of different exercise programs that can readily be incorporated into daily exercise. When prescribing exercise for patients with coronary artery disease, patients' preferences should be considered. Our findings can impact patient care by providing alternative exercise options based on their interests and needs," he concluded.

While most of the protesting candidates are unmarried, a handful of them are married and have kids


Unmarried candidates say if the exam is quashed their hopes of getting married early will die, those married question who will take care of our wives and children.

Tunnel Beneath Kohi Sulaiman

Govt exploring feasibility to ease traffic

RINAGAR - Jammu and Kashmir government would explore feasibility of constructing a tunnel across the Shankaracharya (Kohi Sulaiman) hill to address the acute traffic congestion on the Boulevard and Dalgate.

"We will explore the possibility of constructing a tunnel in the Shankaracharya hill to connect the Gupakr road with the Boulevard," Chief Minister Mufti Mohammad Sayeed said here this morning at a function organised to name the road from Jehangir Chowk to Batmalu as Mohammad Yusuf Rathar Avenue. He unveiled a black marble plaque to announce the new name of the road.

Rathar a brilliant-engineer who headed the R&B department in Kashmir lost his life in a grenade blast in the south Kashmir village of Kapran on July 19, 2004.

The Chief Minister said traffic congestion in the Srinagar City is assuming alarming proportions and movement of vehicles on busy routes has become a real problem. He cited the instance of Dalgate and the Boulevard and said his government, apart from planning a flyover near the J&K Bank Corporate Office, is also contemplating construction of a tunnel in the Shankaracharya hill so that some of the traffic is diverted through it. This would ease the traffic congestion at the busy traffic junction of the city. He said technical and environmental feasibility of the tunnel would be explored.

The Chief Minister said he has asked the R&B department to repair on priority the city roads which have been damaged due to heavy snowfall last winter. He said the city is the heart of the valley and its roads should present a beautiful picture. He alluded to the efforts made by his government in the beautification of the city and said the various development measures taken during the last about 3 years would soon transform Srinagar into a city of international reckoning.

Mufti Sayeed paid rich tributes to late Engineer Mohammad Yusuf Rather and said he was an honest, dedicated and upright officer. He said he had excelled himself as an able and efficient officer. He said the rechristening of the Jahangir-Batamalu Road after his name is a tribute to this son of the soil. He also remembered other victims of the Kapran blast including Abdur Rashid, Special Assistant to Minister for Power and paid tributes to them

Urban Chaos

he United Progressive Alliance chairperson and Congress president, Sonia Gandhi, has expressed grave concern over the large scale migration of population from rural to urban areas in various parts of the country. She attributed the trend to availability of inadequate employment opportunities in the countryside which has been forcing people to migrate to urban centers. "Since independence, there has been a three-fold increase in the country's population, but the urban population has multiplied by five times," she said after launch of the Jawaharlal Nehru National Urban Renewal Mission at Bhopal on Monday. People, she said, were moving from rural to urban areas in search of employment which cannot be checked in the circumstances. In her opinion, the solution lies in providing jobs in the rural areas and that the National Rural Employment Guarantee Act was an important step in the direction. She said the centrally-sponsored schemes like the Sarva Siksha Abhiyan and the mid-day meal programme was aimed at checking migration from rural areas. The situation in Jammu and Kashmir, when looked at in this backdrop, is more serious. In the past one and a half decade, the migration from rural areas to the two cities of Jammu and Srinagar has been unprecedented. In fact, it has been worse in the valley where thousands of families have deserted their homes and hearths in the village to settle in and around the Srinagar city. Apart from lack of employment avenues, the other reasons that contributed to the large scale migration are the unpredictable security situation that obtains in villages in spite of the government's claims to the contrary, and availability of better and modern facilities of health and schooling in the city. Obviously, scores of new residential colonies have sprouted all around the capital city over recent years with many of them exclusively inhabited by the rural migrants. Unless the government is happy to look the other way, it certainly cannot shy away from the nasty fallout which has thrown almost entire city life out of gear, not just for a short while but almost permanently. As a consequence, various civic amenities, such as water and power supply, education, sewerage and drainage, health and hygiene, transport and traffic control systems, have been affected with the state authority pathetically oblivious of the worsening situation. There can be no denying that the improvement and expansion of civic facilities has not kept pace with the rapidly increasing population in the city. The total disconnect between the need for, and availability of, various facilities has given rise to what looks like an urban chaos with the accompanying hardships to the town dwellers, whose individual and collective life has been impacted badly. Although the employment avenues too have been elusive, particularly in the valley where, unlike in Jammu, a viable industrial climate has existed mostly in official handouts, the migrants find themselves at odds with the inadequate civic amenities. It goes without saying that a sizeable number of people, particularly youth, both among natives and migrants, have fallen into bad habits, including drug addiction and other crimes, primarily as a result of stress-related disorders and accompanying frustration. In fact, the growing urban indiscipline and anarchy tend to de-stabilize the entire social order whose traumatic impact is already visible to the naked eye as the townspeople become restive in the all pervasive suffocation that has overtaken the city's landscape almost everywhere. On their part, the Municipal Corporations of the two principal cities, which were expected to take care of the diverse needs of the people, have been faced with an acute shortage of resources and the wherewithal for the purpose, mainly because of the political hues of their incumbent dispensations. Although in place for one and a half years, the coalition government is yet to part with all the departments the civic bodies are supposed to control. Pertinently, the migration from rural to urban areas has a much more devastating impact on the socio-economic life of the society. What a great Egyptian scholar has said decades ago, the migrant from a village to city overnight turns from a producer into a consumer. While deserting his home and hearth, he also abandons his landed property, his livestock and other assets from which he would produce most necessities of his life like food, milk, vegetables, fruit, and their products. On reaching the city, he becomes a consumer, if not an outright parasite. One is reminded of the ban the state government had imposed on the conversion of agricultural lands around urban centres into residential areas. However, the order was eventually consigned to the dustbin of official apathy with the result that vast areas around cities and towns turned into residential colonies. Before the situation turns more chaotic, it is time the government took a holistic view of the emerging scenario and initiated an effort to regulate the influx of people from rural to urban areas particularly by bridging the wide disparities between them.



What Religions Demand From Us

A case for tolerance

he recent incident of a clerk slapping a boy inside a mosque has taken social media by storm. Its echoes have travelled well beyond social media and in mosques and at shops, in offices and at homes, people are debating the issue, its genesis, consequences and the larger impact it tends to have on overall built up and characterization of religion – Islam in particular. Are religions, and in this case Islam, springboards and arenas for rhetorical gymnastics? Is it the manifesto of religion to thwart people against one another? Pit them in incorrigible polarities and sow such animosity in society and amongst people that they reach to each throat's and harbour such covert hatred and animosity for each other that raises them to the ranks of fanaticism? While question like these do not encompass the scope of the question raised in the title of this article, but for the immediacy and inevitability accompanying these questions, we shall mainly explore the nature and call of religion in its relation to these questions. Let's start our investigation from the question of vice and virtue, on which are hinged almost all the schisms of religious order and the difference of opinion wherein leads to contestation, conflict and confrontation. What is the Quranic concept of virtue and what are the area it emphasises upon? The Quran replies "Righteousness is not that you turn your faces toward the east or the west, but [true] righteousness is [in] one who believes in Allah , the Last Day, the angels, the Book, and the prophets and gives wealth, in spite of love for it, to relatives, orphans, the needy, the traveller, those who ask [for help], and for freeing slaves; [and who] establishes prayer and gives zakah; [those who] fulfil their promise when they promise; and [those who] are patient in poverty and hardship and during battle. Those are the ones who have been true, and it is those who are the righteous" Seen in the backdrop of this vast and encompassing framework, our narrow and self-defined notions of virtue fall flat and the importance of trifling issues which we glorify, zoom in and focus on are reduced to naught. Our ritual-centric notions of virtue, which focus on peripheries and amplify them to the size of whole, prove self-contradictory in the light of this verse and the concept of virtue it sets before us. It only needs our intellect and will to reconcile with this Qurancentric notion of virtue that we will see most of the difference and divergences vanishing away, which otherwise posit us in a state of constant friction. The verse also spells out the ideal of Islam in general and identifies the true belief in God, his apostles and the concept of moral accountability as cornerstones of faith. This is not to say that the issues of Fiqh, the debates of Kalam, the intricacies of Hadith are to be discounted and done away with. But the point shall not escape our understanding that these are not the issues on which are pegged the fate of belief and disbelief. At a time, when fellow Muslims are being labelled as infidels, the inter-sectarian schisms have risen to apogee and the fanatical tendencies have become the hallmark of religious discourse , one is immediately reminded of the Quranic dictum that "Surely those who believe, and those who are Jews, and the Christians, and the Sabians, whoever believes in Allah and the Last day and does good, they shall have their reward from their Lord, and there is no fear for them, nor shall they grieve." (2:62). This shall serve both as a shutup call and an instant of awakening for those who claim monopoly over salvation and in the dizziness of their bigotry went on to identify everybody as disbeliever, heretic or apostate. The Quranic concept of vice and evil is a strong corollary of its concept of virtue. It is true that there are sins of theological order and the Quran does often speak of moral evils and their disastrous consequences – all these occupy a place of their own in Quranic theodicy. But the sin which God himself identifies as one of terrible consequences, in addition to associating partners to him, is spreading discord on Earth. This discord can be moral, military or it can result from the perversion of scholars, as happened with Bani Israel. So before battling for the size of trousers, the correct way of offering prayers, the issue of intercession and such, scholars need to guard themselves against the evil of being agents of mischief and discord on the land of God, for this act enmeshes them in a sin of greater order with its repercussions overflowing to societies and civilizations. What has been underscored above highlights the broader scope of Islam and its approach to human salvation in terms of its theorization of vice and virtue. Having said that, one is obliged to investigate the broader question which characterizes this article. What does Islam want from its followers and what are the liabilities that it puts upon its followers in pursuance of this ideal? Islam doesn't demand from its followers a bigotry and religious zealotory infringing upon the rights and lives of others, nor does it warrant of any religious compulsion. We all know that Islam emphasises on ethics and morality, on virtue and piety, but how many of us recognize that Islam was historically the first religion to guarantee freedom of conscience, the freedom to choose religion of one's choice and the freedom to exercise intellect in matters of faith. It emphasised reason and rationality at the cost of sentimentalism, hyperbole and rhetoric. Bypassing and shunting the primitive elements of war and violence accompanying the human psyche, it made pen might-

ier than sword in the true sense of the word by according to argument a place much higher than force. It initiated the process of dialectic in the matters of faith and enjoined on its followers the usage of "beautiful and wise means of propagation". Quran the magnum opus of Islam advocates reason and rationality and when it touches upon the themes of war and violence, it takes them up to put a cap and limit on them, instead of granting them blind legitimacy or celebrating the cult of violence. Emancipation from error, liberation for tyranny and oppression, globalization of sympathy and empathy are some of the dominant leitmotifs that recur in Quran and that were catalytic in shaping the movement of liberation theology in Africa against Apartheid in late 80s and 90s. But how much of it we get to listen to in our sermons and religious speeches. When did you last hear from a religious cleric a sermon on environmental consciousness, on gender equality, on poverty and egalitarian world, on the ills that our society is festering with? Does Islam not concern itself with the human life here and now with its all issues of spectral diversity? Of course it does - but unfortunately talking on these issues doesn't fetch our clerics the audience and applause they dream of and that is precisely the reason that they engage in sectarian strife and drag down Islam from its pedestal to the marsh of non-sense it has nothing to do with. The creed of Islam has no pantheons, no evolved complex of rituals and neither does there exist an abysmal chasm between man and God which will need a cleric to fill up. The respect we accord to our religious scholars derives its legitimacy from the fact that they inform and explicate for us the word of God. but they shouldn't take this occasion as an opportunity to interject themselves between man and God and on occasions "Play God". The responsibilities of Ulema are manifold in comparison to the masses in general for they are capable of setting up an example and their word usually has a wider outreach, but on each instant they need to introduce mankind in general and Muslim audience in particular to the true and unadulterated precepts of God. Any failure therein has a consequence and a price, the price too heavy in spiritual terms, the price which Biblical verse sums up as "Woe to the world because of its stumbling blocks! For it is inevitable that stumbling blocks come; but woe to that man through whom the stumbling block comes"

Books: Why The Internet Hasn't Killed Them Off

e stand amazed by the vitality of printed books, a more than 500-year-old technique, both on and offline. We have observed over the years all of the dialogue which books have created around themselves, through 150 interviews with readers, bookshops, publishers, bloggers, library assistants, 25 participant observations, 750 responses to an online questionnaire and 5,000 mapped sites in France and the francophone world. An impressive collective activity. So, yes, your book carries on living just by staying on your shelf because you talk about it, remember it, and refer to it in conversation. Even better still, you might have lent it to a friend so that she can read it, perhaps you have spent time with people who have spoken about it before buying it, or after having read it. You will have encountered official reviews, of course, and also blogs about it. The conversation goes on even when the book is no longer in circulation.

PAPER BOOKS CIRCULATE BETTER THAN THEIR DIGITAL VERSIONS


What first struck us was the very active circulation of books in print, compared with digital versions which do not spread so well. Once a book has been sold either in a bookshop or through an online platform, it has multiple lives. It can be loaned, given as a present, but also sold on second-hand, online or in specialist shops. And it can go full circle and be resold, such journeys made in a book's life are rarely taken into account by the overall evaluation of the publication.

The application Bookcrossing allows you to follow books that we "abandon" or "set free" by chance in public places so that strangers take possession of and, then, you hope, get in touch to keep track of the book's journey. Elsewhere, the book will be left in an open-access "book box" which have popped up across France and other countries. Some websites have become experts in selling second-hand books like Recyclivre, which uses Amazon to gain visibility.

Yard sales, antiques fairs, book markets give a new lease of life to countless books which remained forgotten because they were a quick one-time read. The book as a material object, regardless of its age, retains an unequalled sensorial pleasure, and brings with it special memories, bygone times, a sacred piece of craftsmanship with its fragile bindings, or, the nostalgia offered by children's books or fairy tales.

Whole professions are dedicated to the web, and increasingly so, since it first came into existence. This has turned the second life of books and the recycling of them into a money-making machine for online retailers, and as a result books are kept alive. Some people have become eBay sellers, experts only thanks to the books they sell on this platform. Sometimes even, these books' lives are extended by charity shops, such as Oxfam. At some stage however, there is only the paper left to give a book its value, once it has been battered and recycled.

weight, volume, and physical space occupied by books in print, that the digital book ought to have wiped the floor with its print counterpart. This has been the case with online music, for example, which practically handed a death sentence to the CD, or for films on demand which have greatly shrunk the DVD market. However, for books, this simply has not happened. In the United States like in France, the market for online books never surpasses the 20% mark of the sales revenues of books in print. And that is without including the sales revenue of the second-hand book market as we previously mentioned. The digital book seldom goes anywhere once purchased, due to controls imposed on the files by digital-rights management (DRM) and the incompatibility of their formats on other digital devices (Kindle and others).

PAPER PLEASURES

Our interviews revealed the pleasure of giving books as presents, but also of lending them. The exchange of the physical item with its cover, size and unique smell bring much more satisfaction than if a well-meaning friend offers you digital book files on a USB stick containing... a thousand files already downloaded! Indeed, the latter will seldom ever be considered a present but rather a simple file transfer, equivalent to what we do several times a day at work. This also gives rights holders reasons to thus decry "not paying is theft", in this case the gift of files would also become theft.

Bloggers who exchange books as presents (bookswapping) show that goodwill prevails and puts stress on the backburner. This is done on the condition that the book is personalised in some way: a poignant quote, a meaningful object associated in some way with the book (cakes for example!), and the surprise of receiving a completely random gesture of kindness.

A DENSE AND THRIVING NETWORK RELIANT ON THE INTERNET

What travels even better than books are conversations, opinions, critiques, recommendations. Some discussions are created within or around reading groups or in dedicated forums online such as the Orange Network Library, for example. There are recommended reading lists, readers' ratings, and book signings with authors are organised. These networks are digital, but they existed well before the Internet, and they remain dynamic today.

However, the rise of blogs at the start of the 2000s led to an increase in the number of reviews by ordinary people. This provided visibility, even a reputation for some bloggers. Of course, institutional and newsworthy reviews continue to play their role in guiding the masses, and they are influential prescribers protected by publishers. But websites like Babelio, combine a popular expertise, shared and distributed among many bloggers who are sometimes very specialised themselves. The website was created in 2007 and has over 690,000 reader members.

The proliferation of content and publications can easily disorientate us; the role of these passionate bloggers, who are often experts in given literary fields, becomes important because they are "natural" influencers one might say, as they are the closest to the public. However, some publishers have understood the benefits of working with these bloggers, especially in so far as concerns specialist genres like manga, comics, crime novels or youth fiction. Sometimes a blogger, YouTuber and web writer is published like Nine Gorman.

Some bookshops contribute even more directly in coordinating these bookworms, they "mould" their audience, or at least they support the books both online and in their shops with face-to-face meetings. Conversation is a unifying force for fans who are undoubtedly the best broadcasters across a broad sphere.

Platforms encourage readers to expand their domain, in the guise of fanfictions, which are published online by the author or his readers. The relationship with authors is closer than ever and is much more direct, the same can be said of the music industry. On particular platforms like Wattpad, texts which are made available are linked with collective commentary.

But above all, the dialogue about reading has often been transformed into writing itself. It might be published on a blog and may be likened to authorial work but at the other end of the spectrum, it might be something modest like the annotations one leaves in their own book. These annotations, more common in non-fiction texts, can form a sort of trade. For example if you lend or sell on a book, which is also stocked and shared with the online systems of Hypothes.is, it allows any article found on the web to be annotated, and the comments saved independent to the display format of the article. This makes it easier to organise readers into groups.

Printed books have in fact become digital through the use of digital platforms which allow them to be circulated as an object or as conversations about the book. The collective attention paid creates a permanent and collaborative piece of work, very different to frenetic posts on social media. Readers take their time to read, a different type of engagement altogether to social media's high frequency, rapid exchanges. The combination of these differently paced interactions can, though, encourage one just to read through alerts from social media posts then followed by a longer form of reading. Networks formed by books constitute as well

Networks formed by books constitute as well a major resource for attracting attention. This is still not a substitute for the effects of "prize season" which guides the mass readership, but which deserves to be considered more critically, given the fact that publishers increasingly take advantage of these active communities.

It would thus be possible to think of the digital book as part of the related book ecosystem, rather than treating it as just a clone. To call it homothetic, is to say that it is an exact recreation of the format and properties of the book in print in a digital format. Let's imagine multimedia books connected to, and permanently engaged with, the dialogue surrounding the book – this would be something else entirely, affording added value which would justify the current retail price for simple files. The Marital Rights of Women in Islam

his piece was written in reflection to close friends experiencing abuse in marriage. I wrote the piece after some of my dearest childhood friends ended up in abusive and toxic marriages. As an empath, it broke my heart and affected me mentally to the point where I couldn't sleep properly for months. I tried to find solutions to their problems, but I realised it isn't always simple to leave these types of marriages. I also read the horror stories on various Facebook groups for mothers and every story shattered me. What I realised is that, it's important to prevent women from ever entering these toxic marriages by ensuring rights are met at the start of a spousal search. No doubt, it isn't always straightforward to filter out unsuitable men as some people are forced and pressured into marriages. However, I believe if even one person were to read the article and it made them think or reassess their marriage criteria then this would be a small positive step in protecting women against marital abuse.

Marrying your true love is an exciting chapter of life. It is the epitome of tranquillity, peace and comfort that humanity craves so deeply. The thought of two independent souls united through the holy state of matrimony with mutual love, respect and commitment brings me so much joy. I love the radiant facial glow of couples both young and old who are truly happy and in complete love. Love is the single greatest emotion that connects people together. When you have a similar spiritual, emotional, intellectual and mental capacity as your significant other, mountains become tiny humps and harsh waves appear as Zamzam water drops. That's not to say there won't be any challenges, but you will overcome any hardships as a team. How can we find a compatible spouse who will love us and journey with us through life's

How can we find an equal who will hold our hand and bring us solitude and calmness after a long day at the office?

many trials and heartache?

How can we find our happily ever after? The answer is very simple. Before you conduct lengthy background checks and converse with a potential spouse to see if your character and personality traits align, it's paramount you ensure the suitor is eligible to marry. Marriage is a legally binding contract – whether you marry legally or/and Islamically, it is a contract between the state or/and God. The step of checking marriage eligibility is similar to making sure an employee is a suitable candidate for a role at your firm. When hiring someone, you need to examine if the candidate has all the relevant qualifications, work experience, good character and references to qualify as an employee. Similarly, when you intend to marry someone, there are conditions from the Qur'an and sunnah which a man must meet before he can put a ring on your finger.

WHAT ARE THESE CONDITIONS?

- The prospective spouse must have a stable enough job in order to provide private accommodation for you and cover yours and your future children's expenses. [Mukhtasar al-quduri]
- The prospective spouse mustn't prevent you from going to the Mosque or to study. He mustn't stop you from worshipping God through prayer and fasting – even if he does not pray himself. He must possess sufficient emotional stability to control his anger – as anger is detrimental to a peaceful family life. [Bukhari]

If the prospective spouse meets these requirements – you should make sure he is able to fulfil your rights. As with any contract, there are rights and responsibilities laid down by state or Islamic law and marriage is no different. **WHAT ARE THE RIGHTS OF A WIFE?**

The husband must pay a dowry (mahr) to his wife. The amount of money

- to his wire. The amount of money should be what the norm is for women of a similar status in society. He can pay part of it upfront, and part of it later but it must be paid and cannot be taken back. The wife has the right to refuse sexual intercourse if the dowry is not paid. Allah SWT says in the Quran, "And give to the women (whom you marry) their mahr (obligatory bridal money given by the husband to his wife at the time of marriage) with a good heart..." [Qur'an 4:4]
- The husband must provide his wife with independent accommodation. What does this encompass? A private bedroom, kitchen and bathroom – it's a place where the wife is free to remove

all her clothing and it must be separate from her family home or her husband's family home. [Bukhari, k. Al-jumu'ah, b. Hal'ala man lam yashhad al-jumu'ah ghuslan]

In essence, a studio flat would suffice. With the cost-of-living crisis we are currently facing, it is understandable that not every man would be able to provide his wife with a studio flat at minimum. If a man is unable to afford a studio flat in areas where the rent or house price is high e.g London, he could relocate to a more affordable place if his circumstances allow. If a woman is unhappy with a studio flat and wants to live in a more spacious/luxurious home, she can contribute towards the difference. What's essential is that the husband is able to afford at least a studio flat and is willing to pay for it.

If a wife wishes to live with her husband's family, there will be no sin upon her husband. Living with the in-laws can work greatly for some people, and if a couple is happy with this arrangement, then there is no harm. If at any point, she decides she wants to move out, her husband must make arrangements for that. A husband must intervene if there is any ounce of oppression towards his wife, he must support her and resolve conflict harmoniously.

- The husband must provide food for his 3. wife. This right may be fulfilled in three ways: the husband can buy groceries and the wife may use it to cook herself food. If she does not want to cook food, he may cook food for her. If she is not happy with his cooking, then he must give her money so she can buy food for herself. Most jurists across all the madhahib are in agreement that it is the husband's duty to provide food and not the wife's. The meals must include: meat once a week, dessert after every meal, some fruits, bread and oil to add taste to the food. This can be tailored if the wife has different food preferences. (Ibn Nujaym, al-Bahr al-Ra'iq) The husband must pay all the bills (elec-
- The husband must pay all the bills (electricity, gas, water etc). (Ibn Nujaym, al-Bahr al-Ra'iq)

ALTHOUGH THE PRICE OF BILLS HAS RISEN SIGNIFICANTLY, IT IS STILL THE HUSBAND'S DUTY TO PAY THEM. The husband must provide his wife with feminine hygiene products. These include: shampoo, body lotion, shower gel and a monthly hammam visit postmenstruation. (Ibn Nujaym, al-Bahr al-Ra'ig)

The husband must pay for all expenses during his wife's pregnancy and childbirth. (Ibn Nujaym, al-Bahr al-Ra'iq) The husband must provide his wife with clothes. Ibn Nujaym says the husband must provide new clothes every six months (for summer and winter). He must provide the following: two long kamees, two headscarves, a thin overcoat, trousers, two pairs of shoes and a coat. If the wife wants silk clothing, the husband must provide it. (Ibn Nujaym, al-Bahr al-Ra'ig)

Shaykh Akram Nadwi comments that providing clothes every six months is a guideline and the type and amount of clothing varies depending on need and what type of clothing a wife wears. He also mentions if a woman doesn't want new clothing every six months, he doesn't need to provide it.

- The husband must provide his wife a bed with bedding for sleeping and a chair and a sofa to sit on during the day. These items become her property. His wife doesn't have to offer her bed to guests when they come to visit if she doesn't want to. Ibn Nujaym comments on this, 'Some husbands are so mean that sometimes they use the furniture of their wives and sometimes they allow guests to use the furniture of their wives (without her permission).' (Ibn Nujaym, al-Bahr al-Ra'iq)
- The husband must provide accommodation and cover the wife's servants expenses if she has one. Abu Hanifa says, "If the wife has a servant pre-marriage, then the husband must provide accommodation and expenses for the servant." Abu Yusuf, Abu Hanifa's student, comments, "If the wife has two servants, then the husband must cover accommodation and living expenses for both." (al-Kasani Bada'i al-sana'i)
- Housework is the responsibility of the husband; he can do it himself or hire someone to complete it. His wife may

do it if she wants, and this will be an act 5. of charity on her behalf. (Bukhari, k. Alsalah, b. man kana fi hajati ahlihi)

Hiring a house helper is common in some societies such as the gulf region, where it is more affordable compared to the UK. If a husband cannot afford to hire help for cleaning and cooking, he may live in a compact property so there's less to clean. He may decide to cook simpler foods in the oven or a pressure cooker if he doesn't have much time to cook before or after work.

If a wife wishes to contribute financially or if she wishes to cook, she can and this will be a great act of charity. This must however be her own wish, she must not be pressured or forced into doing so.

It is clear by the above-mentioned responsibilities of a husband that marriage is not easy. Marriage is an act of worship that requires much effort. Men must meet the conditions of marriage and be able to fulfil their marital responsibilities.

Once you have found a man who is able to fulfil your rights, you should then learn about his character, personality and goals. You can consider whether you have a similar mindset and envision a similar future. It is also important that you are physically attracted to your potential spouse. Unfortunately, people engage in long discussions with a suitor, speaking on topics that will determine compatibility without ensuring the man in question even qualifies for marriage. It is vital you only consider a man for marriage if he is financially able to provide vou with private accommodation - it is your God-given right and not a favour. Allah SWT says in the Ouran: "Men are the caretakers of women, as men have been provisioned by Allah over women and tasked with supporting them financially." (Qur'an 4:34) Allah SWT has given men this financial responsibility - it's in the nature of men to be a household leader and support their wife and children. Some people question what a wife is supposed to do with her time if it is not her responsibility to support the family financially nor do the housework. She is free to do the following:

- To work and spend her earnings as she wishes
- To study
- To raise her children
- To engage in charity work

To complete housework (if she wishes to)

So many women throughout Islamic history have built mosques and schools – as women don't have financial responsibility, they're able to spend their income on these incredible projects.

Marriage isn't only governed by laws but by Ihsan (striving for excellence) too. Couples should thrive in mutual respect, love and kind-

The Prophet ^{##}said, "The best of you is the one who is best to his wife, and I am the best of you to my wives." (Tirmidhi; Ibn Majah).

Allah SWT clearly states the importance of kind treatment in the Qur'an, "O you who believe! You are forbidden to inherit women against their will. Nor should you treat them with harshness, that you may take away part of the dowry you have given them. On the contrary, live with them in kindness and equity." (Qur'an 4:19)

I hope this guide serves as a useful tool in your spousal search. It is important for women to reclaim their rights to protect themselves from potential oppression. Men who are able and willing to fulfil your rights with love, will never intentionally oppress you. A man who fears God, will never harm you and will honour your rights. Every woman is worthy of finding a good man – a man who will treat you as a human being by fulfilling your rights and never abusing nor oppressing you.

May Allah SWT guide us towards righteous spouses, who will fulfil our rights, love us, protect us and never oppress us. When you fear there's no one suitable out there for you – remember the comforting words of your Lord, "Good men are for good women and good women are for good men." (Qur'an 24:26) Trust in God, make the effort to seek a God-fearing partner, have patience and make dua. Your high calibre husband will find you – respect yourself, love yourself, understand your worth and God-willing, true love will be yours.

ED Raids Unearth Rs 20 Cr Cash From Home Of Minister's Aide

Kolkata: The Enforcement Directorate (ED) on Friday carried out simultaneous raids at the houses of around a dozen people, including two ministers, in connection with its investigation into the teacher recruitment scam in West Bengal and seized around Rs 20 crore in cash.

Sources in the central agency said the money was seized from the residence of a close associate of senior minister Partha Chatterjee who was questioned by the sleuths for over 11 hours.

ED sleuths also visited another minister Paresh Adhikari's home in Cooch Behar district in the northern part of the state and talked to his family members. He is currently in Kolkata.

Besides, they carried out simultaneous raids in the houses of former advisor of the West Bengal School Service Commission (SSC) Shanti Prasad Sinha, ex-president of the West Bengal Board of Secondary Education Kalyanmoy Ganguly and nine others, the official said.

The CBI, as directed by the Calcutta High Court, is looking into the alleged irregularities committed in the recruitment of Group-C and D staff as well as teachers in governmentsponsored and aided schools on recommendations of the West Bengal School Service Commission. The ED is tracking the money trail in the scam.

"ED is carrying out search operations at various premises linked to recruitment scam in the West Bengal School Service Commission and West Bengal Primary Education Board," the agency said on its official Twitter handle.

The agency shared four photographs of piles of cash in the



denomination of Rs 2,000 and Rs 500 besides a number of sealed packets inside a room, without disclosing the quantity or the owner of the place.

ED sources, however, said that around Rs 20 crore in cash and more than 15 mobile phones were seized from the residence of a woman, a close associate of Chatterjee, in the city's Tollygunge area following a raid there in the

evening, an official said. It is learnt that she has acted in several Bengali, Odia and Tamil films in recent years.

At least 7-8 ED officials reached the Naktala residence of Chatterjee, the former education minister, at around 8:30 am with a few CRPF personnel keeping guard outside. They questioned him for more than 11 hours

about the alleged scam. At one point of time, the senior Trinamool Congress leader complained of uneasiness following which a team of doctors from the state-run SSKM Hospital were called by the ED

The agency sleuths, who aided Adhikari's residence raided at Mekhliganj in Cooch Behar district questioned his family members including his daughter Ankita Adhikari in his absence, he stated.

Ankita recently lost her job as an assistant teacher at a government school where she was appointed through the SSC two years ago after it was found "illegal" by the high court.

ED sleuths also carried out simultaneous raids at the residences of former chairman of the West Bengal Board of Primary Education, Manik Bhattacharya, as well as the board's interimpresident Ratna Chakraborty Bagchi, who is also its secretary.

The TMC described the concerted raids as a ploy by the BJP government at the Centre to harass political opponents.

"This raid by ED, a day after the spectacular Martyrs' Day rally that created ripples all over the country, is nothing but an attempt to harass and intimidate leaders of the TMC.

The CBI has already interrogated them (ministers) as part of a court directive and they are cooperating. Now, the ED is being invoked only to discredit them. The money laundering is-sue is being invented by the BJP," senior TMC leader and minister Firhad Hakim said.

The BJP, however, alleged that the TMC aided large-scale anomalies in the recruitment process of teachers at the primary, upper primary and secondary levels since coming to power in the state.

"TMC leaders and people close to them duped lakhs of qualified youths and handed over their jobs to ineligible ones. The CBI and ED are progressing on the right path. More skeletons will tumble out of the cupboard. The BJP has no role to play in the issue," the saffron party's national vice-president, Dilip Ghosh, added.

UN Court Rejects Myanmar Claims, Will Hear Rohingya Case

The Hague: Judges at the United Nations' highest court on Friday dismissed preliminary objections by Myanmar to a case alleging the Southeast Asian nation is responsible for genocide against the Rohingya ethnic minority.

The decision establishing the International Court of Justice's jurisdiction sets the stage for hearings airing evidence of atrocities against the Rohingya that human rights groups and a UN probe say breach the 1948 Genocide Convention.

In March, US Secretary of State Antony Blinken said that the violent repression of the Rohingya population in Myanmar, which formerly was known as Burma, amounts to genocide.

Tun Khin, president of the Burmese Rohingya Organisation UK, welcomed the decision, saying 600,000 Rohingya are still facing geno-cide, while "one million people in Bangladesh camps, they are waiting for a hope for justice.

The African nation of Gambia filed the case in 2019 amid international outrage at the treatment of the Rohingya, hundreds of thousands of whom fled to neighbouring Bangladesh amid a brutal crackdown by Myanmar forces in 2017. It argued that both Gambia and Myanmar were parties to the 1948 convention and that all signatories hade a duty to ensure it was enforced. Judges at the court agreed.

Reading a summary of the decision, the court's president, US Judge Joan E. Donoghue, said: Any state party to the Genocide Convention may invoke the responsibility of another state party including through the institution of proceedings before the court. of small group

Parl Panel Hits Out At Flood-Prone States For Not Enacting Model Bill For Flood Plain Zoning

New Delhi: A standing parliamentary committee has rapped flood-prone states like Assam, Uttar Pradesh and Bihar for not taking any initiative to enact the model bill for flood plain zoning despite witnessing huge losses of human lives, cattle and properties during deluge.

standing committee The on water resources, tabled in Lok Sabha, said only Manipur, Raiasthan and Uttarakhano and erstwhile state of Jammu & Kashmir had enacted legislation, though delineation and demarcation of flood plains are yet to be undertaken. Flood-plain zoning measures aim at demarcating zones or areas likely to be affected by floods of different magnitude or frequencies and probability levels, and specify the types of permissible developments in these zones, so that whenever floods actually occur, the damage can be minimised.



Bengal, Assam, Odisha etc have not taken initiative to enact any legislation with regard to flood plain zoning," the panel said.

The committee said it is "dismayed" to find that the action taken reply of the department is silent as to whether or not the major flood prone States viz Uttar Pradesh, Bihar, West Bengal. Assam, Odisha etc have taken any initiative/steps for enactment of the Model Bill for Flood Plain Zoning, as these States are witnessing huge losses in terms of human lives, cattle and properties, whenever the flood strikes.

Taking cognisance of the aforesaid facts, the committee said it believes that preparing and operating these long-term initiatives in a stand-alone manner may be difficult for individual states.

"Therefore, for integrated use of water resources, there is a need to move from the conventional, fragmented and localised approach to a comprehensive river basin approach. In order to provide coordinated river basin development including comprehensive flood control, it is necessary to set up river basin organisations, which would effectively provide immediate, short-term and long-term solutions in addition to the overall development of river basin," it said. The committee, therefore, recommended that Ministry of Ial Shakti take concrete measures on priority basis to enact the River Basin Management Authority for holistic management of water resources of each river basin.

The Committee are of view that merely issuing directions to states will not yield desired outcomes, unless protracted and vigorous efforts are made by the Department to persuade and goad the States for enactment of the Model Bill.

They, therefore, reiterated their recommendation that the Union Government should make renewed and concerted efforts for persuading the State Governments for enactment of the Model Bill on Flood Plain assistance to those States that are willing to implement floodplain zoning," it said.

The committee further said are not satisfied with the reply of the government as it merely states that the draft River Basin Management Bill, 2018 has been circulated among all states/ Union territories and related Union ministries for comments/ suggestions and is presently in public domain and does not mention about the concrete steps that have been taken by the department to persuade the states to enact this important bill.

"There's nothing to panic about as the rise in the number of cases is not a cause of worry at the moment. Rather, our focus should shift from case-counting to mortality rate and the hospitalization rate which as of now is low," Dr. Nisarul Hassan, president Doctors Association Kashmir (DAK) told Kashmir Observer.

Dr. Hassan further added that In the earlier waves, any number of positive cases were culminating into severe outcomes, both in terms of hospitalization and deaths.

"But now, we are in a different phase of Covid-19. With the widespread immunization, in the form of vaccination and natural infections, the new cases are not winding up into hospitals or deaths. It's just a mild infection, so there's nothing to panic about. If we talk about our region, the present variant of covid is as good as any other respiratory virus like influenza virus. The rise and fall of cases won't determine the severity of the virus," said Dr.Hassan, adding that vaccines and booster doses should not be ignored.

Meanwhile, with a steady rise in covid cases in J&K, the department of health has also chalked out a strategy to meet any possible challenge in the coming days.

"We don't have to worry about the rising cases as covid in Kashmir is already in its endemic phase. Only the hospitalization rate and death rate will determine the viciousness

of the infection. There are only a handful of cases admitted in hospitals, that too, with very mild symptoms. So, let's not trigger fearpsychosis among people," a practicing physician, Dr. Riyaz Ahmed Daga, told Kashmir Observer.

Dagga further said that during the unprecedented outbreak of the first wave, the numbers of covid positive cases mattered as the hospitalization rate and death rates were high.

"Since then, the two waves have boosted our immunity against the new variants of the virus. That's why the number of positive cases doesn't matter. This time, covid is very mild. Death rate and hospitalization rate is also very low. There are no new cases with any respiratory issue," Dr. Riyaz said, adding that people with morbid diseases are at risk.

In the Valley, Srinagar reported the highest 162 new cases of virus, followed by Baramulla with 30, Ganderbal 18, Budgam 12, Pulwama 10, Kupwara four, Bandipora 3, Kulgam and Anantnag two each.

In the winter capital, Jammu reported a maximum of 152 new cases of Coronavirus, Kathua 55, Udhampur 21, Poonch 16, Kishtwar 15, Rajouri 10, Samba and Doda nine each, and Reasi one.

Also, the officials said that the death toll remained unchanged at 4761in J&K-2336 in Jammu and 2425 in Kashmir, as no fresh fatality was reported during the last 24 hours in the Union Territory.

Barcelona Sells 2nd Package Of Spanish League TV Rights

BARCELONA: Barcelona has sold a second package of its television rights to an American investment firm for an undisclosed amount as the Spanish club claws its way out of debt

Barcelona said Friday it had agreed to sell an additional 15% of income from TV rights from Spanish league games for 25 years to Sixth Street. That gives the investment firm a total of 25% of the club's TV rights for La Liga games after Barcelona and Sixth Street struck an initial deal last month.

While Barcelona made public that the first deal for 10% of the TV rights would earn the club 207.5 million euros (\$210 million), it did not reveal the amount Sixth Street would pay for the next 15%.

The initial deal was followed by Barcelona signing Robert Lewandowski from Bayern Munich and tomeu, are blamed for ruining Bar-Raphinha from Leeds on transfers celona's finances.

In June, Barcelona earned the approval of its club members to sell 25% of its Spanish league TV rights for a projected total of around 450 million euros (\$457 million).

The club run by president Joan Laporta also said last month that it is seeking a buyer for 49% of the company Barcelona operates to negotiate its licensing rights and merchandising. The club hopes to get between 200-300 million euros (\$203-304 million) in return for that potential third deal.

Laporta has said that the drastic measures were necessary to "generate profits and have positive equity" as Barcelona struggles to recover its financial health after its debt ballooned to 1.3 billion euros (nearly \$1.37 billion). The huge salaries and transfer fees paid by Laporta's predecessor, Josep Bar-
