

Foreign Remittance Inflow In J&K Increased In 2020-21

RBI Data Reveals J&K Received Over Rs 1450 Cr From Diaspora

SRINAGAR: J&K's economy may have finally received a welcome respite from volatility, thanks to a rise in foreign remittance inflow that has increased up to 0.3 percent in 2020-21 compared to 0.2 percent in 2016-17.

As per a report released by Reserve Bank of India (RBI) in

July, while the share of the tra-ditional remittance recipient states of Kerala, Tamil Nadu and Karnataka-which have had a strong dominance in the Gulf countries-had almost halved in 2020-21, J&K's share in total remittances of India rose up 0.3 percent in the same period with majority of the remittances continuing to be routed through private sector banks and public sector banks. Pertinently, the latest edition

is RBI's fifth in a series based on foreign remittances. It was conducted for the year 2020-21

based on a census of all authorized banks and major money transfer entities engaged in transfer of foreign funds.

As per World Bank, India's total foreign money inflow for the year 2021 was \$87 Billion. And a quick breakdown of data underlines that J&K's total Foreign Money (inward remittance) is \$261 million in the same period. In 2016-17, India had received a total remittance of \$69 Billion dollars, which means, J&K had received about \$138 Million, that too, when rupee was

Srinagar Reports More Corruption Cases In J&K In 2022

Srinagar: Srinagar has reported more corruption cases compared to other districts of Jammu and Kashmir in the past seven months, officials said.

Every fourth case of graft or misuse of official position was reported from the city during this period, they said.

According to the Anti Corruption Bureau (ACB), a total of 94 graft cases were registered from January 1, 2022, till date.

Of these, 24 cases were registered in Srinagar district alone. The ACB police station in Srinagar, which also covers graft cases in Ganderbal and Budgam districts, had a total of 32 cases in the corresponding period. Baramulla police station of

the ACB, which also covers Bandipora and Kupwara districts, reported 23 cases while the Anantnag police station covering four south Kashmir districts had 13 cases, as per the ACB data.

In the Jammu province, the data showed that corruption is much less with only 19 cases registered in 10 districts.

Jammu police station of the ACB reported 11 cases in the first seven months while Doda police station reported five cases.

Earlier Wheat Planting Can Boost Yields In Eastern India: Study

armers in eastern India could increase yield by planting wheat earlier, helping them to ensure food security and farm profitability as the planet warms, according to a study.

The researchers at the Cornell University, US, noted that adjusting the sowing dates for wheat will increase untapped potential production of eastern India by 69 per cent. The team built dense data sets in collaboration with colleagues from the Indian Agricultural Research Council, allowing them to unravel complex farm realities through big data analytics, and to determine what agricultural management practices really matter in small-

holder systems.

"This process has confirmed that planting dates are the foundation for climate resilience and productivity outcomes in the dominant rice-wheat cropping systems in the eastern sector in India," said Andrew McDonald, an associate professor at Cornell University. The study, published recently in the journal Nature Food, found that farmers in eastern India could increase yield by planting wheat earlier -- avoiding heat stress as the crop matures -- and quantified the potential gains in yields and farm revenues for the region. The researchers also found that the intervention would not negatively impact rice productivity, a key consideration for farmers. Rice alternates with wheat on the cropping calendar, with many farmers growing rice in

the wet season and wheat in the dry season. The study also provides new recommendations for rice sowing dates and types of cultivars, to accommodate the earlier sowing of wheat. "Taking a cropping systems approach and understanding how things cascade and interlink informs our research approach and is reflected in the recommendations that emerged from this analysis. Climate resilient wheat starts with rice," said McDonald. The research is the result of years of collaboration with international groups and government agencies in India, which have identified the Eastern Ganges Plain as the area with the most potential growth in production.

The region will become essential, McDonald said, as the demand for wheat grows, and climate change makes production more difficult

and unpredictable.

This year, record heat waves in March and April and food shortages caused by the war in Ukraine -- both of which prompted India's government to instate a ban on wheat exports -- have highlighted the need for increased yields and more sustainable farming practices. "In the bigger sense, this research is timely because the hazards of climate change aren't just a hypothetical," McDonald said. "Many of these areas are stress-prone environments, and extreme weather already constrains productivity. Identifying pragmatic strategies that help farmers navigate current extremes will establish a sound foundation for adapting to progressive climate change," he said.

The researchers noted that poverty is endemic

in the Eastern Ganges Plain, and the region is dominated by small landholders, with varying practices and access to resources. The breadth and specificity of the data collected and analysed in the study -- including field and household survey data, satellite data, and dynamic crop simulations -- allowed researchers to understand regional small farms' challenges and the barriers to change.

"At the end of the day, none of this matters un-less farmers opt in," McDonald said. "There's a spatial dimension and a household dimension to opportunity. If we can target approaches accordingly, then we hope to position farmers to make management changes that will benefit the entire food system," he added

Waking Up To AI's Sleep Loss Potential

veryone sleeps, but we have few tools for measuring the sleep the world is getting at scale. AI and sleep could help us study global shocks in near-real time.

It's not unusual to hear people complaining about tiredness multiple times a day, but why? Sleep is fundamental to human health, but because it's so private, there are few tools for measuring how much sleep everyone is getting at scale. Existing methods use time diaries, sleep surveys, sleep laboratories or, more recently, wearable technology to measure sleep. But none of these approaches is ready to tackle a global sleep-loss pandemic.

A Monash University study asked a different question: could the massive data we all generate when connecting to and disconnecting from the internet help researchers understand sleep? As internet addresses go online and offline through the day, they track

the daily human behavioural cycle: a trough in the early hours, followed by rising activity through the day to a peak in the evening, and then a sharp drop-off overnight.

And yet, no two cycles are the same: day of the week matters (heading downtown Friday night depresses internet activity), stay-at-home orders certainly matter (we go online earlier and longer), and even dips in activity during prayer times during Ramadan are visible in traditionally Muslim regions.

The American Time Use Survey (ATUS) asks Americans about their previous day's activities, including when they woke up and when they went to sleep. The Monash study used survey data for 81 US cities over a six-year period to calculate when residents slept and woke up each year, then used internet activity-data to make the same calculation.

The researchers then trained a ma-

The researchers repeated this result when using daily electricity-demand data instead of internet data to predict sleep. But there's something fundamentally different about internetactivity measurements compared to electricity-demand data: global availability. The US has a highly functioning electricity bureaucracy, but not all fall down outside its borders. Another potential pitfall is internet patterns are likely affected by the technology mix at play the internet signature of a mobile-first' continent such as Africa could be vastly different to that of North America, which relies heavily on fixed broadband internet.

Like so many challenges in the application of AI to health sciences, the answer to both hurdles lies with wid-



countries do. Internet-activity measurement, on the other hand, can be remotely and consistently measured for any internet-connected device on the planet.

This suggests the amount of sleep we are collectively getting can be estimated for any (internet-connected) city on the planet in near real time.

This kind of research has a huge range of applications, including impact mapping during natural disasters, documenting internet shutdowns associated with human-rights violations, and ening the training pool for the model. The more measurements researchers have from traditional sleep studies, in more countries, cultures and technology contexts, the more confidence they can have in any model prediction. Should a global sleep observatory (from internet measurements) arise population health and sleep scientists will perhaps gain the most.

If major shifts in internet use reveal similar changes in sleep patterns, researchers may flock to the field and use more precise tools to investigate further. Likewise, significant globa

Srinagar: Scores of candidates who qualified the Finance Account Assistant (FAA) exam held by the Jammu & Kashmir Service Selection Board (JKSSB) continued with the sit-in protest for the twenty second day on Thursday

The protesting candidates braving summer heat and heavy rains during the past three weeks say they are undeterred by the weather conditions

For candidates belonging to the city and its peripheries, the protesting venue remains central and reachable, for those coming from far off places, the journey is far and expensive.

Adil Hussain Khan, 26 a FAA candidate from Salar, Pahalgam in South Kashmir has a post-graduation degree in Mathematics from University of Kashmir.

He says after the Jammu & Kashmir Service Selection Board (JKSSB) advertised posts for Finance Account Assistant (FAA) he applied for the job keeping in view the stability a government job offers Adil's family was jubilant after the selection list was declared and

their son had made it to the selection list. The joy of Abid getting 'employed' was short-lived as rumors started doing rounds that the exam may be scrapped.

Adil, left with nothing, started attending protests at the Press Enclave from day one.

"Protesting at the Press enclave has come at a huge cost for me as travel expenses are huge. Every day I have to spend around 500 bucks to reach the protest venue" he says.

"In order to travel to the city from my native village, I have to change at least four public transport vehicles to reach here. I leave home as early as 07:00 a.m. and get back at 08:p.m." he added.

Mohsin Rafiq, another FAA candidate from the South Kashmir district of Anantnag, says he has a Master's Degree in Physics.

"I left my actual field of study for the sake of this job but now I feel disappointed" he says.

"I spend so much money to reach this place, I can't afford to have lunch so I rely on tea and soft drinks" he added.

Tahira Rashid, 24, a civil engi-

Unable to bear the expenses, she had to rent an accommodation in the Barzulla area of the city.


'Travelling to and fro daily became a nightmare as I had to spend Rs 1000 per day as my travel expenses, so I was forced to rent a place for Rs 4,000 per month"

'Although the travel and food expenses are more than what I can afford, I am willing to pay a heavy price for the sake of my career" an undeterred Tahira says.

Yatris Flee Pahalgam After Massacre

AHALGAM: Hundreds of panic-stricken Hindu pilgrims were today fleeing this picturesque tourist resort, which has been converted into the base camp for the annual pilgrimage to the Amarnath cave up in the mountains, a day after suspected militants killed 33 devotees on their way to the holv cave.

Pahalgam witnessed the worst of a series of overnight massacres by suspected militants across the state which claimed a total of 100 lives, mostly Hindu civilians Officials said two suspected militants swooped down from

forests overlooking Pahalgam, some 100 km south of Srinagar, and shot dead 31 people. They Were killed in the retaliatory fire by the security forces.

The incident took place at a community kitchen (langar) on a road in the close vicinity of a security camp with an army camp just at a stone's throw.

"I could hear gunmen firing at the tents for at least 10 minutes without interruption," said Sanjeev Parishar of New Delhi, who added that local Muslims had helped the wounded in Pahalgam to go to hospital. Nissa Shah, a local Muslim shawl-vendor, said "I was doing

brisk business when all of a sudden firing started from two points. At least a dozen people were hit by bullets and three died on the spot.

Ashok Kumar, a surviving pilgrim, was in a state, of shock. "The shooting started at around 6:4/5 p.m. I rushed towards my burs but a bullet hit me in the leg; "It is due to God that 1 am still alive," he said. Speaking of the attackers, Kumar said: "They were firing at will and they looked visibly relaxed." Though the officials claimed the attackers to be foreign mil-

itants, police sources, on condition of anonymity, said the two persons were local youth from Anantnag, one of them a student of Aligarh Muslim University. The other youth was identified as Shabbir Ahmid Shah. One of rifles with a Lashker-e-Taiba sticker put on it, had been placed by the side of a 'slain youth.

Hundreds of pilgrim-packed cars, buses, trucks and jeeps were seen leaving this town, even as the sky was overcast. This is a valley of destruction," said Akash Chaad, a Chandigarh yatri.

Atma Ram, a Bihari pilgrim said he did not visit the Amarnath shrine. "I had come for darshan, But I am totally scared and have decided to return home without having it" Witnesses said blood-soaked clothes, caps and foot-wear still littered the camp where the gunmen struck. Police brought in sniffer dogs to the site today to look for concealed explosives. Meanwhile, scores of Kashmiri Muslims were flocking to

New Security Challenges

here is a growing concern in the security establishment that the militancy in Jammu & Kashmir has become faceless. It has been voiced by none other than the union territory's police chief Dilbag Singh. Though security forces have killed over 500 militants since the revocation of Article 370 in August 2019, the militancy continues to pose a formidable challenge. The militants have struck recurrently to announce their presence. The predominant targets of their attacks in the last two years have been civilians including those belonging to minorities.

As many as 118 civilians, including 21 Hindus, among them five Kashmiri Pandits, have been killed in Jammu and Kashmir since the abrogation of Article 370, the Union Minister of State for Home Nityanand Rai recently told parliament. The minister, however, informed the House that there has been a substantial decline in the militancy-related violence in the last three years.

On a positive note, the union minister said that around 5,502 Kashmiri Pandits have been provided jobs in different departments of the J&K government in the valley and no Kashmiri Pandit has migrated from the valley since August 2019. This is contrary to reports that many Kashmiri Pandits, including the employees, fled the Valley in the wake of the recent killings


The killings of civilians and Kashmiri Pandits in the Valley generated an outcry across the country. Many Pandits who had returned to Kashmir to take up jobs under the Prime Minister's Package temporarily left the Valley, putting the central government's project to resettle them in their homeland in jeopardy. However, Kashmiri Pandits have not been the only ones who have been attacked: Kashmiri Muslim civilians, Jammu and Kashmir Police personnel, migrant labourers, and also Hindus from Jammu and other parts of India have also lost their lives. According to home ministry figures, 128 security force personnel have also lost their lives in last three years.

But intermittent civilian killings remain a challenge. Making things further difficult for the J&K government is that there are around 5000 Pandit employees recruited under a special package. Similarly, nearly 8,000 employees from different districts of the Jammu division are working in Kashmir under an inter-district transfer policy and a predominant majority of them are non-Muslims.

This is where the rise of anonymous militancy has increased the challenge manifold. Security agencies also call it hybrid militancy. In this kind of militancy, a civilian doubles up as a militant and can go back to lead his normal life after carrying out an attack. Though many suspected hybrid militants have been arrested, it has not addressed the problem. The security brass is, however, hopeful that the situation would change for the better in the near future.

Enduring Crisis

The world economy in the doldrums

ver a century ago, the Marxist revolutionary, Rosa Luxemburg, had argued that the economy needed capitalist "outside" markets to keep its growth going; and she had seen pre-capitalist (colonial) markets as providing that stimulus. Some of the conclusions she had drawn were later criticised, but her overall insight was perfectly valid, as Michal Kalecki, the well-known economist, was to show later. The argument went as follows: imagine an economy with zero growth, where net investment too must be zero; since there is zero growth, the market is not growing and hence there is no incentive to add to capital stock; this continues to keep net investment at zero and perpetuates the economy's stagnation. A stagnant capitalist economy, unless there is some stimulus for investment from "outside" and not just from its internal market, will, therefore, continue to remain stagnant.

The history of metropolitan capitalism can be analysed with this insight into "outside" market. The period before the First World War which had witnessed a prolonged boom had relied on colonial markets. The exhaustion of colonial markets and the encroachment by a newlyindustrialising Japan into Britain's Asian markets had caused the prolonged Great Depression of the inter-War period. The post-Second World War years, however, saw a new market being opened up "outside" of the capitalist sector proper, namely State expenditure; and this underlay the long boom, sometimes called "the Golden Age of Capitalism", that lasted till the mid-Seventies. This boom, however, was accompanied by large accumulations of finance in metropolitan banks and other financial institutions, which went global in their quest for investment opportunities. And since finance is always opposed to any State intervention for boosting aggregate demand (for it undermines the social legitimacy of capital, especially of finance capital), this newly-globalised finance put pressure on countries to pursue neoliberal policies and eschew fiscal activism. The neoliberal period, therefore, left world capitalism without any

genuine "outside" stimulus, because of which the growth rate of the world economy slowed down compared to that of the 'Golden Age"

There was nonetheless a sort of pseudo-stimulus even under neoliberalism. This was the formation of asset-price bubbles, which operated in this manner: speculation in some asset markets pushed up their prices far above their true value; everybody knew that these prices would collapse, but people still bought these assets at such highly inflated prices in the belief that they would be able to sell them at even higher prices before the inevitable crash came, that is, before the bubble burst. This increased the apparent wealth of those who held these assets, and the euphoria of being rich caused them to spend more than they would otherwise have done, thereby raising activity and employment.

Two such bubbles in the United States of America boosted the world economy during the neoliberal era: the 'dot-com'

If any individual country wants to reduce unemployment through fiscal stimulation (since monetary stimulation via low interest rates, as experience shows, is too feeble), then the opposition of finance will take the form of flight of capital; the country will, therefore, have to impose capital controls. But then financing current account deficits on the balance of payments will become difficult, necessitating trade controls as well. In short, that country will have to roll back the neo-liberal regime

A group of advanced economies could undertake a coordinated fiscal stimulus, that is,

On Long Covid, Unknown Enemy

ome evidence suggests that those who were more acutely ill with Covid are more likely to suffer from lingering or recurring symptoms, and that older people and those with comorbidities are also likely to be worse affected. Vaccination appears to offer a slight protective effect. None of this is surprising. But some very fit people who did not appear to be severely ill have been hit too. Women seem to be more likely to suffer than men.

Scientists are delving into possible explanations for ongoing problems – such as pockets of the virus remaining in the gut, or the virus triggering an autoimmune disease and doctors are trialling different treatments. Yet the Royal College of Nursing has warned that services in Britain are woefully inadequate. Though long Covid clinics have now been set up by the NHS, demand far outstrips supply, and the treatments offered vary widely. Thousands of sufferers are travelling abroad to try unproven treatments, at huge expense, from sheer desperation.

In many regards, long Covid has echoes of existing autoimmune diseases and (usually post-viral) conditions such as ME/CFS, which are complex, poorly understood, hard to diagnose and tough to treat. The biggest difference may be that Covid's seriousness and its spread have ensured greater attention and resources this time; patients with ME/CFS and some autoimmune illnesses who have long complained about the lack of interest and investment in research hope that it may lead to breakthroughs that could help them.

But even if those materialise, there will be no miracle cure. Some may gradually recover with little help; others may benefit from a variety of treatments. Those who are still unwell need other forms of help. Shamefully, even British doctors left with long Covid after working on the frontline in the pandemic say that they have been denied disability benefits.

The Long Covid Support group says that delays to or denial of personal independence payments are affecting the recovery of patients as well as their state of mind. An appropriate response to long Covid must mean supporting people as well as trying to cure them, through measures such as flexible working and financial help.


bubble, which saw sky-rocketing share prices of dot-com companies, and the housing bubble. But with the collapse of the US housing bubble in 2008, even this pseudo-stimulus has come to an end. The growth rate of the world economy during the decade before the pandemic was lower than for any other decade since the Second World War.

The pandemic, which entailed serious economic disruptions, was superimposed upon this underlying structural crisis, of a growth slowdown caused by the drying up of "outside" stimuli for the system. Colonial markets can scarcely play this role now; State expenditure is not allowed to play this role under neoliberalism because of the hegemony of globalised finance; and even the pseudostimulus provided by asset price bubbles has become elusive as the dangers of asset-price speculation loom particularly large at present. And now, the Russo-Ukraine war, which has pushed up food and fuel prices, above all through commodity price speculation, has added to the woes of the world economy, where even the International Monetary Fund is talking of the prospect of the worst recession of the last fifty years.

they could synchronously raise State expenditure by increasing the fiscal deficit. Then the incentive for finance to flow out of any one of them will be less. But this would be politically opposed by finance; and what is more, it would revive the sort of inflation in the world economy that had characterised the early Seventies (of which the current inflation provides a foretaste). The way to combat such inflation without squeezing third world absorption of primary commodities is through enhancing the supply of such commodities. For this, however, third world states will have to play an active role, which again will entail a roll-back of neoliberalism. Thus, neoliberalism has brought the world to a crisis from which there is no escape without transcending it.

Pet Rearing and Mental Well-Being

6 A pet is an island of sanity in what appears to be an insane world. Friendship retains its traditional values and securities in one's relationship with one's pet. Whether a dog, cat, bird, fish, turtle, or what have you, one can rely upon the fact that one's pet will always remain a faithful, intimate, non-competitive friend, regardless of the good or ill fortune life brings us."

This statement by American child psychologist Dr. Boris Levinson will resonate deeply with anybody who loves animals.

The relationship between animals and humans dates back to the centuries. Animals were domesticated by the humans 15,000 years back for their services like hunting, farming, guarding and other routine activities, but over the time animals especially dogs became close companions to humans because of their social behavior, so both of them were benefited mutually. Human beings also developed a special interest in rearing pets very long ago and in this regard cats and dogs have been preferably reared for this purpose since the time immemorial. Animals have evolved to be highly sensitive to us, our behaviour, and our emotions. Dogs can comprehend many of the words we speak, for instance, but they are much more adept at reading our tone of voice, body language, and gestures. A loyal dog will also peek into your eyes, just like a close human companion would, to assess your emotional state and attempt to comprehend what you are thinking and feeling.

HEALTH BENEFITS OF PET REARING

The majority of pet owners are aware of the instant benefits that come from having pet animals in their lives. Though many of us are still unaware of them, cuddling with a furry buddy can also have positive effects on our physical and emotional health. Only recently have studies started to look into the advantages of the bond between humans and animals from a scientific standpoint.

Pets, especially dogs and cats, can help reduce loneliness, lower stress, anxiety, and depression, promote liveliness and exercise, and even enhance cardiovascular health. Children who take care of an animal tend to be more secure and active as they grow old. Pets may be a vital source of companionship for senior citizens. But most importantly, having a pet in your life can provide you true happiness and unconditional love.

Owning a pet has been shown to elevate mood, decrease blood pressure, reduce triglycerides and cholesterol in elderly patients. Research has shown that pet rearing increases levels of endorphins and oxytocin hormone both of which offer anti stress effects. Moreover, it reduced levels



of stress hormones, such as epinephrine and norepinephrine, the increased levels of which could otherwise put a person at high risk of cardiovascular and kidney diseases. Pets responding to the commands of their owners give them a sense of pleasure and feeling of satisfaction by release of the hormone "dopamine". Pets have also been shown to be of great support and an important part of the healing process for people who have experienced trauma or abuse in their lifetime. Studies have shown that pet owners perceive their pets as a supportive part of their lives and this perception seems to have a positive impact on behavior of the individual. Bonding with the pets not only helps reduce stress but also aids in mental and emotional balance. Positive interaction with the pets helps in developing positive social interaction skills, enhances communication skills, increases motivation for exercises and walks, improves social bonds, and these together could help in gaining good physical and mental health.

PET THERAPY

There is no denying the fact that humans and animals share a special bond, and it is this bond that inspired the development of animal-assisted therapy (AAT), which proposes that animals can support people in coping with or recovering from specific medical illnesses. This use of animals to assist people in coping with and recovering from a variety of physical and mental health disorders is also known as pet therapy. Positive interaction with the pets helps in developing positive social interaction skills, enhances communication skills, increases motivation for exercises and walks, improves social bonds, and these together could help in gaining good physical and mental health

In fact, American child psychologist Dr. Boris Levinson (whose quote we referred to in the beginning of the article) was the one who initially brought up the concept of AAT in the 1960s after observing that he could better connect with a reclusive 9-year-old kid whenever his dog, Jingles, was there. The presence of Jingles, whom Dr. Levinson referred to as his "co-therapist," allowed him to succeed where other therapists had failed by winning the boy's trust. Dr. Boris later published his work in a paper entitled "The dog as a Co-therapist". Since then it has become a part of psychotherapy and has helped many tackle various health issues like cardiovascular disease, psychiatric disorders such as depression, neurological diseases such as Alzheimer's disease, and even the emotional aspects of diseases such as cancer.

Pet therapy is a broader term which includes animal assisted therapy and animal assisted activity. Animal assisted therapy is goal oriented therapy that is used as a part of psychotherapy to help patients combat psychological disorders, physical pain and other health related issues whereas animal assisted activity has the general purpose of providing enjoyment and comfort to the animal owners.

Nowadays, the concept of pet therapy has come into vogue globally, although it was popular in European countries earlier. While dogs and cats remain the preferred choices, horses, exotic birds, reptiles (turtles), and fishes are also on the cards.

THE RESPONSIBILITY OF HAVING A PET:

Despite the propitious effects of animals as pets, certain factors need to be considered before animals are used for pet therapy.

Owning a pet requires a significant commitment that will last for the whole of the animal's life, which for dogs may be 10–15 years. And when that commitment is over, you'll have to deal with the sorrow and loss that come along with losing a cherished friend.

SOME OF THE OTHER COSTS OF PET OWNERSHIP INCLUDE:

. **Pets are expensive:** It can add up to pay for food, veterinarian care, licenses, grooming, toys, bedding, boarding, and other upkeep charges. It could be difficult to manage the

cost of pet ownership if you're elderly or unemployed and on a fixed income.

- 2. **Pets need your time and attention:** Coming home to a dog that has been left alone in the house all day is hardly therapeutic, as any dog owner will attest. The majority of other pets need at least daily care and attention, whereas dogs need daily exercise to keep calm and balanced.

The idea of pet therapy is still in its infancy in India because of the reasons like lack of awareness among the people, religious and cultural beliefs, expenses on the pets and lack of trained therapists who would use pet therapy. Moreover, people are not yet mindful about the rights of the animals after owning them such as timely vaccination and primary medical care whenever required to the owned pets. We can largely benefit from the therapeutic effects of pet rearing if we approach pet rearing in scientific ways that comes with greater responsibility and respect towards animal rights.

Depression Isn't Chemical Imbalance in Brain?

or three decades, people have been deluged with information suggesting that depression is caused by a "chemical imbalance" in the brain – namely an imbalance of a brain chemical called serotonin. However, our latest research review shows that the evidence does not support it.

Although first proposed in the 1960s, the serotonin theory of depression started to be widely promoted by the pharmaceutical industry in the 1990s in association with its efforts to market a new range of antidepressants, known as selective serotonin-reuptake inhibitors or SSRIs. The idea was also endorsed by official institutions such as the American Psychiatric Association, which still tells the public that "differences in certain chemicals in the brain may contribute to symptoms of depression".

Countless doctors have repeated the message all over the world, in their private surgeries and in the media. People accepted what they were told. And many started taking antidepressants because they believed they had something wrong with their brain that required an antidepressant to put right. In the period of this marketing push, antidepressant use climbed dramatically, and they are now prescribed to one in six of the adult population in England, for example.

For a long time, certain academics, including some leading psychiatrists, have suggested that there is no satisfactory evidence to support the idea that depression is a result of abnormally low or inactive serotonin. Others continue to endorse the theory. Until now, however, there has been no comprehensive review of the research on serotonin and depression that could enable firm conclusions either way.

At first sight, the fact that SSRItype antidepressants act on the serotonin system appears to support the serotonin theory of depression. SSRIs temporarily increase the availability of serotonin in the brain, but this does not necessarily imply that depression is caused by the opposite of this effect.

There are other explanations for antidepressants' effects. In fact, drug trials show that antidepressants are barely distinguishable from a placebo (dummy pill) when it comes to treating depression. Also, antidepressants appear to have a generalised emotion-numbing effect which may influence people's moods, although we do not know how this effect is produced or much about it.

FIRST COMPREHENSIVE REVIEW

There has been extensive research on the serotonin system since the 1990s, but it has not been collected systematically before. We conducted an "umbrella" review that involved systematically identifying and collating existing overviews of the evidence from each of the main areas of research into serotonin and depression. Although there have been systematic reviews of individual areas in the past, none have combined the evidence from all the different areas taking this approach.

One area of research we included was research comparing levels of serotonin and its breakdown products in the blood or brain fluid. Overall, this research did not show a difference between people with depression and those without depression.

Another area of research has focused on serotonin receptors, which are proteins on the ends of the nerves that serotonin links up with



and which can transmit or inhibit serotonin's effects. Research on the most commonly investigated serotonin receptor suggested either no difference between people with depression and people without depression, or that serotonin activity was actually increased in people with depression – the opposite of the serotonin theory's prediction.

Research on the serotonin "transporter", that is the protein which helps to terminate the effect of serotonin (this is the protein that SSRIs act on), also suggested that, if anything, there was increased serotonin activity in people with depression. However, these findings may be explained by the fact that many participants in these studies had used or were currently using antidepressants.

We also looked at research that explored whether depression can be induced in volunteers by artificially lowering levels of serotonin. Two systematic reviews from 2006 and 2007 and a sample of the ten most recent studies (at the time the current research was conducted) found that lowering serotonin did not produce depression in hundreds of healthy volunteers. One of the reviews showed very weak evidence of an effect in a small subgroup of people with a family history of depression, but this only involved 75 participants.

Very large studies involving tens of thousands of patients looked at gene variation, including the gene that has the instructions for making the serotonin transporter. They found no difference in the frequency of varieties of this gene between people with depression and healthy controls.

Although a famous early study found a relationship between the serotonin transporter gene and stressful life events, larger, more comprehensive studies suggest no such relationship exists. Stressful life events in themselves, however, exerted a strong effect on people's subsequent risk of developing depression.

Some of the studies in our overview that included people who were taking or had previously taken antidepressants showed evidence that antidepressants may actually lower the concentration or activity of serotonin.

NOT SUPPORTED BY THE EVIDENCE The serotonin theory of depression

has been one of the most influential and extensively researched biological theories of the origins of depression. Our study shows that this view is not supported by scientific evidence. It also calls into question the basis for the use of antidepressants.

Most antidepressants now in use are presumed to act via their effects on serotonin. Some also affect the brain chemical noradrenaline. But experts agree that the evidence for the involvement of noradrenaline in depression is weaker than that for serotonin.

There is no other accepted pharmacological mechanism for how antidepressants might affect depression. If antidepressants exert their effects as placebos, or by numbing emotions, then it is not clear that they do more good than harm.

Although viewing depression as a biological disorder may seem like it would reduce stigma, in fact, research has shown the opposite, and also that people who believe their own depression is due to a chemical imbalance are more pessimistic about their chances of recovery.

It is important that people know that the idea that depression results from a "chemical imbalance" is hypothetical. And we do not understand what temporarily elevating serotonin or other biochemical changes produced by antidepressants do to the brain. We conclude that it is impossible to say that taking SSRI antidepressants is worthwhile, or even completely safe.

If you're taking antidepressants, it's very important you don't stop doing so without speaking to your doctor first. But people need all this information to make informed decisions about whether or not to take these drugs.

India To Host UN Security Council Members For Special Meeting On Counter-Terrorism In October

United Nations: India will host diplomats of the 15-na-tion UN Security Council in October for a special meeting on counter-terrorism.

India is halfway through the second year of its two-year term as an elected non-permanent member of the UN Security Council. India's tenure at the Council

will end in December this year when the country will also preside as President of the powerful UN organ for the month.

India chairs the Security Council Counter-Terrorism Committee for 2022 and will in October host diplomats of the 15-nation Security Council, including US, China and Russia, for the counter-terrorism committee's special meeting. Current members of the Security Council

are Albania, Brazil, Gabon, Ghana, India, Ireland, Kenya, Mexico, Norway and the UAE, along with five permanent members China, France, Russia, the UK and the US.

Mindful of the increasing threat posed by the misuse of new and emerging technologies, the United Nations Security Council Counter-Terrorism Committee (CTC) has decided to hold a special meeting on this theme, with the support of its Executive Directorate (CTED), in India on October 29, 2022, according to information on the Committee's website.

It said the special meeting will specifically focus on three significant areas where emerging technologies are experiencing rapid development, growing use by member states (including for security and counter-terrorism purposes), and the increasing threat of abuse for terrorism purposes, namely Internet and social media, terrorism financing, and unmanned aerial systems (UAS).

It is not very frequent that the Counter-Terrorism Committee meets outside of New York but the meeting in India will be the seventh time that this is happening. The most recent special meeting of the CTC outside of United Nations headquarters took place in Madrid, Spain, in July 2015, focusing on foreign terrorist fighters (FTFs).

The Committee said further that with the prevalence of technology and rapid rise in digitisation, the use of new and emerging technologies to counter-terrorism is a topic of growing interest among the member states, policymakers and researchers, particularly in the context of the increasing role played by technology in terrorism and counter-terrorism.

Atal Dulloo Calls For Multiplying Efforts Under PMFME

dollar, almost \$87 Billion less than J&K's total share in the latest pie.

As per the same data, J&K ranked ninth lowest in 'share of International remittance' in India. The rural J&K contributed 0.11 percent while the urban J&K shared 0.34 percent. Notably, in 1993, rural J&K's share in International remittance was recorded to be 0.63 percent while urban J&K didn't contribute anything.

According to the World Bank Report on Migration and Remittances, remittance flows to low and middle-income countries declined marginally to US\$540 billion in 2020, only 1.6 per cent below the US\$548 billion in 2019.

India, being the top recipient country, was expected to be one of the worst affected (projected decline of 23 per cent) as its host country basket was vulnerable to the twin effects of economic slowdown and slump in oil prices. Defying the early projections, however, India remained the top recipient country, accounting for 12 per cent of total global remittances, recording a marginal decline of 0.2 per cent in 2020 and a growth of 8 per cent in 2021.

The share of inward remittances from Gulf nations dipped sharply during 2020-21 on account of the economic stress created by the COVID-19 pandemic, says the RBI research paper prepared by deputy governor Michael Debabrata Patra along with RBI officials Joice John and Deepak Kumar.

Speaking with Kashmir Observer, prominent economist, Ejaz Ayoub said that the latest percentile share of J&K in remittances is a pushing pillar for J&K's economy.

"Unlike the trade economy which snakes around a huge risk, remittances don't fluctuate and are also gradually growing. Export and remittances are two most stable pillars of our economy. When combined together, these two factors offer a boost of around Rs 3000 crores to our economy annually. The 2021 data reveals that J&K has received over Rs 1450 crores from diaspora. And in 2017, the same funds accounted for around Rs 960 crores. So, the change is quite evident," Ejaz Ayoub told Kashmir Observer.

The economic researcher further observed that one of the main factors that has led to an increase in J&K's total remittance inflow is the way Indian currency has weakened over a period of time.

"The global inflation on account of Covid has also impacted the remittances. As mentioned in the report, countries like Pakistan, Bangladesh or other economically weak countries have received more remittances during the Covid years. Similarly, India has also

simply say that the predicted dip didn't happen. Inflation's linked component is salary. Whenever Inflation is high, people including diaspora get a particular component in salary which is in line with inflation. So, the salaries of people working outside India have also increased, subsequently increasing remittances. said Ayoub, adding that remittances are a boost for J&K's economy as the state is already going through a rough patch.

Echoing similar views, Assistant Professor of Department of Economics University of Kashmir Dr. Javaid Iqbal Khan said that remittances have an immense contribution for any economy.

"Foreign remittances are an essential pillar in stabilizing any economy. As we know how unstable J&K's economy is, the available figures of remittances will help in stabilizing the economy. The share would've been higher but due to the massive inflation caused by covid, there's a cut in the overall percentage," Dr Javaid told Kashmir Observer.

Pertinently, the economists also noted that the overall percentage may show J&K among the lower ranks but the absolute value of the erstwhile state is pretty high.

PREMIER LEAGUE: 4 Challengers Look To Break Man City-Liverpool Stranglehold

LONDON: Maybe the Premier League's "Big Six" should actually be renamed the "Big Two."

Manchester City and Liverpool have finished as England's top two teams in three of the last four years, the exception coming in the 2020-21 season when an injury crisis in defense saw Liverpool only seal a top-four spot on the final day.

It has created the highest-quality rivalry ever seen in English soccer, given the points totals the teams push each other to achieve every season

The question now is who, if anyone, can break this City-Liverpool stranglehold in the Premier League?

The answer will likely be found among Chelsea, Tottenham, Arsenal and Manchester United, the other four teams making up the six English clubs who tried to become part of the now-defunct European Super League breakaway.

In their own ways, they have all been busy during the offseason: Chelsea has new ownership, United has another new manager, and Tottenham and Arsenal have been among the most active movers in the transfer market.

Here's a look at the prospects of the four title outsiders this season:

Chelsea became a major force in English soccer in Roman Abramovich's reign starting in 2003. Can that be maintained now that the Rus-

sian oligarch has been forced out? The post-Abramovich era has gotten off to a busy start under Chelsea's new American ownership, which has a quirky feature – the guy who fronts the club leadership, Todd Boehly, installed himself not only as chairman but as interim sporting director in control of offseason transfer dealings.

There were fears his lack of soccer knowledge might undermine him but a couple of early player arrivals looked promising. England forward Raheem Sterling came from Manchester City in one of the league's standout transfers of the offseason and Senegal defender Kalidou Koulibaly joined from Napoli to fill the void at center back left by the departures of Antonio Rudiger and Andreas Christensen.

Further strengthening of the squad has proved difficult, however, and manager Thomas Tuchel said after a 4-0 loss to Arsenal in a July 24 friendly that he "cannot guarantee we will be ready" for the start of the season, adding there were still some players in the squad "trying to leave us.'

Chelsea still looks a couple of



center backs short and there are question marks about whether there are enough goals in the likely front line of Sterling, Kai Havertz and Mason Mount.

TOTTENHAM

They've got one of the best managers in the world and, after something of an offseason spending spree, a deep and versatile squad. Maybe Antonio Conte's Tottenham could be the team to push into title contention?

With the front three of Harry

Kane, Son Heung-min and Dejan Kulusevski linking up to great effect, Tottenham had almost as strong a finish to last season as City and Liverpool, winning 11 of its last 16 games. That included a victory at City - completing the home-andaway double over the eventual champions - and a draw at Anfield that ultimately cost Liverpool the title

Conte, who took over in November and has quickly stamped his own style on the team with a 3-4-3 formation, demanded that he was

backed in the transfer market. And he was.

Brazil forward Richarlison has arrived from Everton to provide options across the front three. Yves Bissouma has joined from Brighton to offer much-needed strength in depth in central midfield, and Djed Spence is a highly rated wing back who might have been the best player in the second-division Championship last season.

ARSENAL

Arsenal's lack of squad depth

was highlighted in the way the team faltered at the end of last season, dropping out of the Champions League qualifying positions and getting replaced in them by north London rival Tottenham.

Arsenal manager Mikel Arteta was eager to rectify that this offseason and he has turned to the club he left to come to London. Manchester City, where Arteta was assistant coach under Pep Guardiola from 2016-19, has sold both Gabriel Jesus and Oleksandr Zinchenko to Arsenal

Crucially, both are versatile players, with Jesus able to operate on the wing or at center forward and Zinchenko a midfielder who mostly played at left back at City.

With Fabio Vieira, a young attacking midfielder, joining from Porto for potentially 40 million euros (\$42 million) and 19-year-old Brazilian striker Marquinhos also arriving, Arsenal has spent about \$150 million this offseason and has an even younger squad being nurtured by Arteta.

For that reason, a title bid looks highly unlikely but qualifying for the Champions League will be the target. And preseason results have been encouraging, with Jesus settling in quickly – scoring in a 4-0 win over Chelsea and a hat trick in a 6-0 victory over Sevilla.

MANCHESTER UNITED

A new manager in Erik ten Hag. An unsettled star in Cristiano Ronaldo. A bunch of new players with past or present links to the Dutch league in Lisandro Martinez, Christian Eriksen and Tyrell Malacia.

Who knows what to expect from United this season?

For sure, the fans will demand a finish higher than the sixth place of last season but that is not a certainty considering the competition in the league and the spending of United's rivals.

What happens to Ronaldo is the key. If he stays, will the 37-yearold striker bow to the demands of Ten Hag, or the other way around? He played 45 minutes in a 1-1 draw against Rayo Vallecano on Sunday, but questions remain. If he goes, does a likely front three of Marcus Rashford, Anthony Martial and Jadon Sancho have enough goals and staying power in a season that also includes an often-grueling Europa League campaign?

Eriksen will provide more creativity in midfield but United is still short of a top-class holding midfielder. There are also question marks about how guickly Martinez. a small, ball-playing center back who Ten Hag worked with at Ajax, fits in to English soccer. (AP)
