Srinagar: Jammu & Kashmir has registered a noted improvement in the implementation of innovative projects in the last two years.

It was revealed by a lat-est report by NITI Aayog-Government of India's apex public policy think-tank—and the Institute for competitiveness.

As per the report, J&K has achieved 12.83 score in the India Innovation Index (III). Out of the nine UTs, J&K ranks 6 in the "UT and City states" category of III, the report adds. While Chandigarh is the best performer with a score of 27.88.



J&K's overall indicators have substantially improved. Karnataka has retained the top spot in the 'Major States'

BJP Scores Again, Dhankhar Elected V-P

NEW DELHI: NDA candidate Jagdeep Dhankhar was elected as the 14th Vice President of India on Saturday as he defeated joint Opposition candidate Margaret Alva.

Dhankhar, a former governor of West Bengal, secured 528 votes while 80-year-old Alva got 182.

The numbers were stacked in favour of Dhankhar as the ruling BJP enjoys an absolute majority in Lok Sabha and has 91 members in Rajya Sabha. The BJP heads the National Democratic

Alliance (NDA). Even before the results were announced, celebrations had started outside the residence of Parliamentary Affairs Minister

including nominated ones, are entitled to vote in the vice presidential poll.

While the electoral college comprises 788 members, due to eight vacancies in Rajya Sabha, the actual strength is 780. The Trinamool Congress had abstained from voting claiming it was not consulted while naming Alva as the opposition pick. However, two of its MPs -- Sisir Kumar Adhikari and Dibyendu Adhikari -- broke ranks and cast their ballots. The party has 36 MPs, including 23 in Lok Sabha. The voter turnout this time was lower than 98.2 per cent recorded in the 2017 election

Smartphones Can Improve Memory Skills: Study

According to a new study led by UCL researchers, using smartphones, smart watches and other digital devices can improve the memory skills of a person.

The research, published in the Journal of Experimental Psychology: General, showed that digital devices help people to store and remember very important information. This, in turn, frees up their memory to recall additional less important things.

Neuroscientists have previously expressed concerns that the overuse of technology could result in the breakdown of cognitive abilities and cause "digital dementia".

However, the findings show that using a digital device as external memory not only helps people to remember the information saved into the device, but it also helps them to remember unsaved information too.

To demonstrate this, researchers developed a memory task to be played on a touchscreen digital tablet or computer. The test was undertaken by 158 volunteers aged between 18 and 71.

Participants were shown up to 12 numbered circles on the screen, and had to remember to drag some of these to the left and some to the right. The number of circles that they remembered to drag to the correct side determined their pay at the end of the experiment. One side was designated 'high value', meaning that remembering to drag a circle to this side was worth 10 times as much money as remembering to drag a circle to the other 'low value' side.

Participants performed this task 16 times. They had to use their own memory to remember on half of the trials and they were allowed to set reminders on the digital device for the other half.

The results found that participants tended to use the digital devices to store the details of the high-value circles. And, when they did so, their memory for those circles was improved by 18%. Their memory for low-value circles was also improved by 27%, even in people who had never set any reminders for low-value circles.

However, results also showed a potential cost to using reminders. When they were taken away, the participants remembered



the low-value circles better than the highvalue ones, showing that they had entrusted the high-value circles to their devices and then forgotten about them. Senior author, Dr Sam Gilbert (UCL Insti-

tute of Cognitive Neuroscience) said: "We device helped them to remember the in-

formation they had saved into it. This was hardly surprising, but we also found that the device improved people's memory for unsaved information as well.

"This was because using the device shifted the way that people used their memory to store high-importance versus low-importance information. When people had to remember by themselves, they used their memory capacity to remember the most important information. But when they could use the device, they saved high-importance information into the device and used their own memory for less important information instead.

"The results show that external memory tools work. Far from causing 'digital dementia', using an external memory device can even improve our memory for information that we never saved. But we need to be careful that we back up the most important information. Otherwise, if a memory tool fails, we could be left with nothing but lower-importance information in our own memory."

The research was supported by an ESRC grant and a grant from the Independent Research Fund Denmark.

DC Reviews Status Of Works Under National Clean Air Programme

Srinagar: Deputy Commissioner (DC) Srinagar, Mohammad Aijaz Asad, who is also the Chairman of District Implementation Committee today reviewed the implementation and status of City Action Plan taken under National Clean Air Programme in a meet ing held at Meeting Hall of the DC Office Complex, here.

At the outset, the DC took a detailed review of Rs 5 Crore Action Plan (Part Ist) being implemented under NCAP for execution of various interventions including procurement of 4 Road sweeping or Vacuum Cleaning machines for regular cleaning of City roads: Procurement of 3 Jetting Machines for water spraying of City roads; Installation of 9 Fountains at major intersections/ circles and Installation of Air Quality Monitoring System in the City to ensure strict implementation of mitigation measures for Prevention, Control and Abatement of Air Pollution and to improve the Air Quality in the non-attainment City of Srinagar District.

The DC was apprised that 3 water spraying Jetting Machines and 4 Road sweeping/ Vacuum Cleaning machines have been procur under


NCAP. In addition, authorization for procuring additional 10 Road Sweeping machines and 10 water sprinkle machines from Solid Waste component under Swachh Bharat programme has also been granted.

Further, it was given out that tendering process has been completed for installation of the Air Quality Monitoring System in the City, while construction of fountains under NCAP at 9 important locations particularly at heavy traffic volume intersections is being carried out.

The DC emphasized on the need for proactive actions by concerned implementing agencies. He asked all the line Departments to submit detailed action taken reports regarding measures undertaken regarding Air Pollution Control were also discussed.

The DC also stressed on increasing green cover in the city through plantations at appropriate places and other locations to improve the air quality.

From KO Archives Cong Unlikely To Extend

Mufti's Tenure

EW DELHI - As the date draws nearer for Jammu and Kashmir Chief Minister Mufti Mohammad Sayeed to hand over the baton to a leader from alliance partner Congress, the party today sought to put an end to all speculation by indicating that the PDP leader would not be asked to continue.

Virtually putting at rest speculation that Congress might not be willing to take over the reins of the government after ears in November as per an agreement between the two coalition partners, a senior leader said the party would suffer if did it.

"It will not go down well in the party," the leader close to J&K affairs said when asked whether the Congress would let Sayeed continue for remaining three years of six year term as has been suggested by some reports.

When the two parties forged post-poll alliance to form government in November 2002, they had agreed that one party would lead the coalition for three years and the other for rest of the term Congress, with 20 MLAs in the 87-member Assembly, had then allowed junior partner PDP, with 17 MLAs, to lead the alliance in the first phase. The Deputy Chief Minister was from Congress for the first three years and from PDP for the remaining tenure.

Although some sections in the Congress are believed to be inclined to allow Sayeed to continue, the state unit of the Congress strongly disfavours any reunification move. The state unit feels it was the much-awaited opportunity

for the Congress to have its own Chief Minister and it should not be allowed to fizzle away. On the question of whether the Congress had an ap-

propriate leader to become Chief Minister, the party leader said there would be no problem on this count. The Congress leader, however dismissed possibility of Mohammad Shafi Qureshi or Saifuddin Soz be given the charge as had been reported in some sections of media.

The disadvantage with Soz's candidature is that he has joined the Congress only three years back after being expelled from National Conference. Qureshi also has been out of the party for a long time.

The summer capital of Jammu and Kashmir, Srinagar, is dressing-up for what the government has begun trumpeting as a tourist boom. The city's civil lines areas and the Boulevard along the world-famous Dal lake in particular are getting a face-lift essentially to bring it in tune with its reputation as a beautiful place. Elsewhere too, way side market places both on Srinagar-Jammu highway and the newly activated Srinagar-Kaman Post sector of Muzaffarabad road, are getting a new coat of paint to lend them a better look. The tourist places like Gulmarg, Pahalgam, Sonamarg, Achhabal, Kokernag and the Mughal gardens wear a particularly festive look in anticipation of a heavy influx of visitors, domestic as well as foreign.

During recent months, the chief minister, Mufti Muhammad Sayeed, and his tourist officials went places across the globe, even when some nasty avalanches had caused widespread loss of life and property back home, to invite the pleasure-seekers to the state. During his meetings with visiting dignitaries and diplomats here or elsewhere, he has been urging the western countries to withdraw the adverse travel advisories to their nationals to visit Kashmir.

Regardless of the hellish conditions obtaining at present as a result of the on-going turmoil, Kashmir is popularly known as the paradise on the earth. And, Srinagar as the city of lakes and gardens.

Understandably, the better part of the valley's and city's social and economic lot is inter-twined essentially with their beauty. Hundreds of thousands of people draw their sustenance directly or indirectly from the tourist trade and allied sectors. They comprise hotel and restaurant owners, tour and travel operators, taxi and shikara owners, ponywallas and labourers besides a host of traders and manufacturers including those in the handicraft and related sectors.

Frozen Recruitment and Derailment of Ambitions

he December of 2018 was not all about snowflakes, icicles and the bone chilling chilla-i-kalan. It brought with itself, what later came as a rude shock to the competent youth of Jammu and Kashmir who had invested their time, money and energy to secure their ambitions of contributing to the nation's talented workforce in the education sector. This was the time when Satya Pal Malik; the last governor of erstwhile state of Jammu and Kashmir who is popularly known for his "Fax machine hoodwink" that hit the thriller packed 2018 political discourse of J&K, passed an order that quietly axed to death the dreams and ambitions of youth aiming to contribute in education sector as teachers and lecturers.

Background

In December of 2018, the then State Administrative Council, popularly known as SAC and headed by Satya Pal Malik, passed an order that approved the earlier action plan (which was recommended by a committee), in what it termed to streamline the issues of already regularised teachers in state education department. The order number 1263 GAD of 2018; Dated 13-08-2018 was approved to address the "grievances and immense difficulties" and "a host of other issues" faced by teachers which; according to the order, were directly or indirectly "impacting upon quality education" in government run schools.

The said order besides giving a "host of concessions and exceptions" paved way for hassle and competition free transition of already regularized Rehbar-e-Taleem (RReTs) teachers, besides creating a prized & separate level 5 cadre for their absorption; with 10+2 being the bare minimum criteria for such transition.

Besides the "arbitrary" concessions and exceptions, the order "froze" direct recruitment of teachers and lecturers through recruiting agencies with effect from December 2018 leading to dejection and dissatisfaction among deserving and competent teacher aspirants.

Ordered Injustice

Just a keen but unbiased read will tell how arbitrary and unjust the SAC order of 2018 is: all in its structure, existence and approval. The first argument is that by selectively closing doors for carrying out direct recruitment exercises of teachers and lecturers, the order has deprived the eligible aspirants who have necessary qualifications from their fundamental right to equality guaranteed under Article 16 (1) to participate in matters related to public employment. The SAC's decision to twist and turn the rules of recruitment was to suit the agenda of the executive and hide its failure to frame a comprehensive absorption policy for regularized RReTs and teachers appointed under Sarva Shiksha Abhiyaan, while at the same time keeping the doors for direct recruitment open. It had to be done according to a 50:50 ratio. By virtue of these concessions and relaxations, the then governor administration extended an olive branch to regularized RReT's and SSA teachers but at the cost of disempowerment of thousands of youth who possess requisite qualifications and a considerable number amongst them having cleared national level eligibility exams like UGC/CSIR NET. It should never be misconstrued that the aspirants pressing for revocation of the said order are per se against the regularization and cadre allocation to RReTs and SSA teachers but to freeze the entire direct recruitment process and hold hostage the degrees and hard work put in by thousands of deserving candidates, is something that will not be acceptable to tenets of transparency and justice in any sane society. It has given a widespread impression that merit and wilful intention to participate in completion are kept at back burner. Every year a considerable number of students pass teaching specific degrees viz, bachelors and masters degrees in Education (B.Ed and M.Ed) from recognized universities and their affiliated colleges but these degrees

have now been rendered useless. The freezing of teacher recruitment has defeated the very purpose of these "professional" degrees.

On the contrary, how bizarre does it sound when the SAC order of 2018 says that it will "encourage" the 7706 RReT and SSA teachers who DO NOT possess the "requisite qualifications" to acquire the same within time frame so as to "upscale" them as regular teachers? To put it simply, either those 7706 undergraduate teachers have to take one time study leave or pursue their degrees through distance mode or in a phased manner just to meet the eligibility criteria; forget about advanced specialization. In any of the cases, the already strained education sector reeling under staff shortage will have to bear the burnt of this exercise. Moreover, to talk of "stipulated time frame", it will be at least a decade before we see the undergraduates numbering 7706 passing out as simple graduates.

It won't be unjust to call out the then authorities at the helm of affairs for making highly qualified and educated youth scapegoats because of their failure and gross inability to chalk out a strategy to streamline the regularization process of ReTs in consonance with the principles of natural justice. Teachers engaged as ReTs have always been at loggerheads with successive man, It is no rocket science when one tries to ascertain the reason behind these drastically low enrollment rates in elementary government schools most of which are in rural pockets where the very objective of creation of ReT cadre was to ensure universal access to students. Sadly, Satya Pal Malik did not bother to devise a roadmap on who is to be blamed?

The fate of private B.Ed colleges and why no one bats an eye?

If one thinks that it is only government run schools which are reeling under disproportionate enrollment ratios, then he/she is absolutely mistaken and has very fragmented idea on what SAC order of 2018 has done to private B. Ed colleges of Jammu and Kashmir. Once blooming with "more than sufficient" enrollment ratios, the B. Ed colleges of JKUT are now high and dry since there are very less takers for this course. Analysts believe that apart from extended course duration , the unjust SAC order of 2018 is to be blamed for bringing to grinding halt the otherwise busy classwork in B.Ed colleges.

The genuine hesitancy of graduates to opt for B.Ed is a result of the fact that in a condition where teacher recruitment stands frozen, the professional teacher training courses have lost relevance. Except for teaching, where does after-

governments in the erstwhile state mostly over issues of regularization. Those issues are quite debatable but were never left at the disposal of best brains to decide their right and wrong sides. When SAC found nothing, it came up with the unjust order devoid of logic and justice.

Perception versus Reality – The Debate Continues

Three years have passed since the SAC order of 2018 came into force. "This initiative has been taken in the larger interest of teaching community and purely as a welfare measure", read the order. If "teacher welfare" was supposed to be the only resultant purpose for implementation of the said order, then it will be correct to say that the order has served its purpose. But, in a welfare state like the one we are living in, the ultimate purpose of reformative measures taken in education sector should be student centered rather than being reduced to mere profit and loss mathematics vis a vis the employees and their employers.

Strictly speaking through a student centered perspective, the very purpose of the order where it claims to ensure (and streamline) quality education in government run schools has not been fulfilled. This claim can be validated from the fact that there is a dwindling trend of student population in government run schools that even prompted the authorities to call for immediate action against those responsible for it. The "devas tating decline" in student enrollment has not only brought disrepute to the education department but has also defeated the basic purpose for which teacher centric welfare measures were taken. In 2019-2020 academic session only, the number of students in government elementary schools drastically fell by 1.75 lakh: a number that is enough to bust the myth of those who claim otherwise. The retention rate was just 84% at primary level, 64% at elementary level and 50% at secondary level. Even government ordered merging of almost 700 schools reeling under disproportionate student enrollment and almost recording zero or meagre enrollment. It remains quite debatable if merging of schools will actually translate to something productive. The preliminary observations suggest otherwise. Moreover, for dismal performance who should be held accountable the ball continues to swing between authorities and teachers.

all a teacher training course hold its utility.

The diminishing enrollment figures are disappointing to the extent that compared to earlier 500 students, the average enrollment in private B.Ed colleges now stands at 40 students only. The immediate fallout of disproportionate enrollment has led to job cuts in private run B.Ed colleges as a considerable chunk of staff has been laid off due to acute financial crunch.

In backdrop of this uncertainty almost 20 private B.Ed colleges have closed their operations sine die. The fate of their employees and employers; nobody knows?

Conclusion

The controversial SAC order of 2018 enjoys popular mandate from the teaching community, particularly from those who have been given the extended olive branch but popular morality and views of the majority do not dictate the constitutional rights. The injustice committed to hardworking, deserving and competent youth through execution of this unjust executive order is something that needs to be corrected without further delay. Like it was done, it can be undone too and there should be no hesitancy. To secure the future of those who believe in the tenets of welfare state viz, justice and equality; the lieutenant governors administration needs to reconsider and review the controversial SAC order much to the benefit and hopes of those who aspire to be future caretakers of education sector. By not giving the promising youth a chance to serve in their best capabilities, the then governors administration has self deflated its claim of being youth centric.

body's guess. In fact, the state's economy owes a great deal to this sector. Mercifully, the past couple of years witnessed some kind of a boom with even the available infrastructure falling short of the requirement and forcing the authorities to ask the inhabitants of various specified areas to throw their spare accommodation open to the visitors.

However, the atmospherics for ensuing season would seem to be not as inviting as one would perhaps wish them to be. The places that were considered to be almost entirely free for any kind of pollution, are

nauseatingly stinking. The city and most towns lack adequate sanitation with their civic bodies ill-equipped to match the requirement. In most cases they don't have enough manpower and equipment for disposal of ever increasing quantities of garbage.

Absence of a matching drainage and sewerage system only aggravates the problem. Most drains and water courses are almost entirely choked with filth and polythene with the authorities preferring to look the other way. The number of public conveniences is abysmally less and even in civil lines areas people are founding easing themselves in the open on the road side. A solitary community latrine along Partap Park is a mute witness to the incapability of the civic administration to address the problem. Most roads, lanes and bylanes in the city and elsewhere speak

volumes about the official neglect. Barring a few arteries in the civil lines like the Maulana Azad Road and Residency Road, both having stood the test of time ever since these were renovated not by any popular

government but by a governor, most other roads in the city and in towns present a sight as if these have been strafed. Passage of a vehicle raises columns of dust to force the pedestrians run for cover. Watering

of the roads is restricted to areas around the civil secretariat only. Following the recently conducted elections, the city and most towns have full-fledged and upgraded civic bodies to take care of amenities for the citizenry.

The city has a municipal corporation with a mayor and deputy mayor in place. Likewise, major towns of Baramulla, Sopore, Anantnag have municipal councils and others municipal committees. Most such bodies are yet to become fully functional due to the dicey security scenario combined with the alleged apathy and indifference of the coalition government. One would expect the state government to take the matter more earnestly. Unless it staged the civic polls to achieve a limited political objective of claiming the revival of grassroots institutions as a mark of normalcy restoration, it should provide them the required wherewithal for becoming fully functional. Denying them the promised administrative and legal powers and starving them of the needed material and financial resources would suggest the government is not sincere.

All said and done, tourist arrivals alone need not necessarily make one look at the situation. The natives are no less human to deserve a better environment to live in. Nobody would like to breathe in ugly and messy environs of a place, whatever its reputation. On the other hand, improvement in civic life is not the responsibility of the government alone. Nowhere in the world is civic sense perceived as something exclusive to the administration. It has to be a combined effort of the authorities as well as the citizenry to make the environs clean. Before the valued guests start arriving, it is time for both the government and the people to rise to the occasion and launch a vigorous drive for the purpose.

hina has to be exceptional in every way. The country where the coronavirus originated, bringing the world to a standstill, is now stigmatising those affected by the virus. No other country is doing that today, a prime reason for that being the vast numbers affected everywhere. You can't stigmatise lakhs of citizens across the country. But in China you can — because the number of those who've contracted Covid in the country of its origin remains small. Thanks to China's zero-tolerance policy, entire cities go into lockdown to prevent one person from spreading the virus. Whole buildings are forced into quarantine if even one resident has been exposed to an infected person. One infected employee could mean the closure of an entire work unit. This stringent policy has resulted in very few Chinese actually catching the virus. The numbers are so small, they can easily be identified. One

wonders whether this kind of overreaction to the virus has turned those affected by it into feared and despised carriers of disease. Could it be that they are also resented because of the terrible inconvenience they cause?

The stigmatisation isn't just at the level of pointing fingers and avoiding people, which could be a localised, uninformed, hysterical reaction. It's far more chilling: those who've had Covid are being denied jobs and there's no subterfuge about it. Job notices mention that only those who've never had Covid or, more shockingly, never volunteered at a makeshift Covid hospital can apply. Thanks to the Health Code installed on everyone's phone, it's easy for employers to find out whether you've had Covid.

It's ironic that this is happening in Shanghai, the most modern of China's cities. The two-month-long lockdown that ended in June, seems to have scarred the city more than it did any other. Jobless because they contracted Covid, many young workers have also become homeless. Some of them have had to move into Shanghai's public spaces.

One young man, after being turned down by many firms, ended up working as a daily wage loader. all the while terrified that his phone would be checked and his Covid positive past revealed. Unable to carry on paying his rent, he moved with all his belongings in two bags to one of Shanghai's biggest railway stations. To his surprise, there were already others like him there. One such woman had made the ladies' toilet her home. She survived on cheap snacks and had discovered a free WiFi zone in the nearby airport which she could access without having to enter the airport. Another young man had helped build a temporary Covid hospital. Once his work was done, the employer refused to pay him the 2,000 yuan fare to go back home. Meanwhile, he tested positive, putting paid to all hopes of getting a job. Nor could he go home: his hometown made it mandatory for travellers from Shanghai to quarantine at their own cost.

Soon, these homeless migrants, many of them university graduates, began to be turned out of railway stations and mall hallways onto the streets. This was in spite of the fact that a heatwave was sweeping Shanghai, with temperatures going beyond 40 degrees Celsius.

These stories were uncovered not by the media but by a blogger. The resultant uproar led to an official directive against "Covid discrimination" and an amendment in the Health Code. Now, only the record of the previous two weeks is available on it, down from the earlier two months. Citizens had willingly installed this app to prevent the spread of Covid. But it ended up becoming a tool to deny them their rights in every way.

Hurr and Karbala

The following excerpt from Dr Shariati's book examines issues of fate, choice, and predestination as portrayed by Horr's decision to switch sides during the fateful battle

Horr (also spelled as Hurr, full name: Al-Hurr ibn Yazid al Tamimi) was a commander of the army of Yazid during the battle. First involved in fighting Hussein, Horr defected from Yazid's army, joined Hussein, and was killed by Yazid's forces.

The following excerpt from Dr Shariati's book examines issues of fate, choice, and predestination as portrayed by Horr's decision to switch sides during the fateful battle.

Horr was the name of one of the highranking commanders of the army of Omar-e-Sad who faced the grandson of the Prophet of Islam Hussain-ebn-Ali (AS), with orders from Yazeed-ebn-Muawiah to either get Hussain's (AS) allegiance for his corrupt Khalifat, or kill Hussain and all his friends. It was Horr and his army who first faced Imam Hussein, and then kept them under siege, preventing them from getting water.

On theday of Ashoura, Horr made a huge decision. Right before the battle started, he left his position and the army he was commanding, and joined Imam Hussein, and was the first to be killed in the way of Allah, by the army he used to be a commander of just a few hours earlier. The name 'Horr' means free, freeborn, noble, freeman.

The fate, sometimes, plays a game. The factory of creation, constantly producing uncountable things, stones, trees, rivers, animals, insects, human beings, sometimes shows a scene of humor, creates an innovation or an exception: it writes a poem, paints a work of art, does something unique In one word, it can be said that these items have a 'character'. From among the houses, Kabeh, from all the walls, the China Wall, from the planets orbiting the sun, earth, and from all the martyrs: Horr.

The artistic hands of destination have composed this scene with utmost precision, and as if to emphasize the importance of the story, have selected all the characters of the play from the 'absolutes', to make the story most effective.

The story is about a 'choice', the most important manifestation of the meaning of human being. But what kind of choice? We are all faced with several choices in our everyday life: career, friend, wife, house, major.. But in this story, the choice is much more difficult: the good and the evil. And even so, not from a philosophical, scientific, or theological perspective. Instead, the choice here is between the truthful and the deceiving religion, between the just and unjust politics, with life being the price to pay. To further emphasize the sensitivity of

the situation, the author has not put the hero of this story in the middle, equally



the ability of the man to change, to show how it is possible for a common and even sinful man to reject all his social, family, and class ties and show a god-like change.

The history of Islam is full of contradicting features. The two lines starting from Habil and Ghabil, existing throughout the history side by side though in different faces, have also continued in Islam. Now, both these streams are dressed in Islam, but in opposite directions. Ironically, our hero is faced to choose between the most extreme ends in each of these parties: Yazid, and Hossein.

Indeed, had this story been created by an author, he should have been recognized for his genuine and art

What is the name of this hero? For a historic figure, what is important is the role he plays, and not his name, since his name is something chosen for him by his family, according to his parent's taste.. On the other hand, if the story is created by an ingenious writer, he would choose a name which is relevant to the role of his hero. In this story however, our hero has been named by his mother, 'Horr', as if he has been able to foresee the sensitive role his son is going to play. And thus, when the Imam of freedom attends his bloody body, just before his death, tells him: "O Horr! God bless you! You are free both in this world and in the world to come, just like what your mother called you!'

Although Horr has played a unique role in the history, the essence of his role is not just confined to himself. The meaning of his action, in fact, includes all human-beings, and indeed defines 'humanity'. It is what distinguishes the human-beings from other creatures, underlining the responsibility of man with respect to God, people, and himself. And Horr has not played this with words and concepts, but with love and blood. If one grasps the depth of this saying from Imam Sadegh(AS) that "All days are Ashoura, and all places are Karbala, and all months are Moharam" one readily feels the extension: "and all human-beings are Horr!" Our history, starting from Habil and Ghabil, is the manifestation of the eternal conflict between the two poles of God and Satan, though in each period of time these two poles have disguised differently. Therefore, in each period of time, every human-being finds himself just in the same position as Horr did: alone, in the middle, hesitating, between the same two armies. On the one side, the commander of the army of evil shouts on his soldiers: " O Army of God! attack!" and on the other side, an Imam, with a voice echoing throughout the history asks -and not commands- "Is there

anybody who wishes to assist me?" and you, the man, should choose.

It is by this choice that you become human. Before this choice you are nothing, you are just an existence without essence, you are standing in the middle. Thus, the man who has found 'existence' through birth, finds 'essence' through choice. It is by this choice, that the creation of man completes, and this is exactly when the man feels this heavy burden on his shoulders and finds himself alone, as God and the nature have left him on his own on this dangerous decision.

Now we can evaluate our hero, we can feel what a long journey he has gone through in what a short time, to change him from a Yazidian Horr, to a Husseinian Horr. If he stays with the army of Yazid, his world is guaranteed, and if he joins the small army of Hussain(AS), his death is eminent. It is the morning of the day of Ashoura, and although the battle has not yet started in the fields, Horr realizes that the opportunity would not last. Time goes by fast, and the moments count. The storm has already started within him.

From the beginning, Horr was hoping that the events would not lead to war, but now war seems to be unavoidable. Human-beings have limited capability in tolerating shame and scorn, except for those who are genius in this respect and can tolerate disgrace unlimitedly. Horr never had thought that being an 'employee' of the government of Yazid would mean collaborating in Yazid's criminal acts. For him his job was just a source of income without having anything to do with politics or his religion.

Horr now realizes that adding his position with his religion is impossible. Thus, hopelessly and as a last resort he talks with the commander of the Army (Omar-ebn-Sa'd) who like himself is reluctant to get in a war and has accepted the mission to become the governor of the province of Ray and Gorgan. What would then be better than coming up with some sort of a solution without getting involved in the blood of the grandson of the Prophet and his family. Horr and Omar-ebn-Sa'd both have come all the way from the palace of Yazid to Karbala together and they share the same status and social class. Horr asks Omar:

"Yes, by God, I will fight a battle the least consequence of which will be separated heads and broken arms!"

Now, it is evident that no longer can he play games with his religion. Now, the two separate their paths.

For Horr, Yazid's army of tens of thousand is now nothing more than a bunch of faces, without meaning. A crowd of men without selves, a group of people without hearts, those who shout but don't know why, fight but don't know for whom. Now the Jesus of love and conscience cures a blind and resurrects a dead, creating a martyr from a murderer. In a journey it is not enough to ask for the destination, but one should also ask from the origin. Thus, the length of Horr's journey becomes evident when one realizes from where he started, and to where he ended, all in halfa day's time. In his emigration from Satan to Allah, Horr did not study philosophy or theology, nor did he attend any lectures or schools. He just changed his direction, and it is in fact this 'direction' which gives meaning to everything: art, science, literature, religion, prayers, hajj, Mohammad, Ali Having started his journey, and riding his horse, he slowly leaves his Army toward Hussain. Muhajer-ebn-Ous, who sees him agitated and worried asks:

"Whats wrong with you Horr? I am puzzled by your case, by God if I were asked about the bravest man in our army I wouldnt hesitate to mention your name, and now you are so disturbed and worried?"

"I find myself between the Hell and the Heaven, and I have to select between them, and by God I will not choose but Heaven, even if I were cut to pieces or burnt to ashes!"

The creation of Horr was completed and the fire of doubt has led him to the verity of certitude. He slowly approaches the camp of Hussain, and as he gets closer he hangs his boots from his neck, and keeps his armor down (as a sign of remorse)

"You know that if it had been up to me I would have done as what you propose, but your master Obeid-Allah-Ziyad did not accept a peaceful resolution!"



Explosive Situation In Gaza Following Friday's Bloodbath

GAZA CITY: Israeli jets have pounded the besieged Gaza Strip for a second day following a wave of air strikes on the coastal enclave that killed at least 15 people, including a five-year-old girl and a commander of a Palestinian armed group.

The fighting, which began on Friday with Israel's targeted killing of a senior commander of the Palestinian Islamic Jihad, continued throughout the night, drawing the sides closer to an all-out war.

Israel struck Gaza and Palestinians fired rockets at Israeli cities on Saturday after an Israeli operation against Islamic Jihad ended more than a year of relative calm along the border.

Israel on Friday killed one of the group's senior commanders in a surprise daytime airstrike on a high-rise building in Gaza City that drew rocket salvoes in response.

Also on Saturday, Gaza's sole power plant shut down after running out of fuel, an electricity company spokesman said, five days after Israel closed its goods crossing with the Palestinian enclave.Additional bombings targeted five houses, witnesses said, sending huge clouds of smoke and debris into the air as explosions rocked Gaza City.

Palestinian militants fired at least 160 rockets across the border, setting off air-raid sirens and sending people running to bomb shelters as far as the central Israeli city of Modiin, between Tel Aviv and Jerusalem.

Islamic Jiĥad said it had targeted Israel's main international gateway, Ben Gurion Airport. But the rocket fell short near Modiin, around 20 km

away, and the Civil Aviation Authority said the airport was operating as usual with flight routes adjusted.

Most of the missiles were intercepted and there were no reports of serious casualties, according to the Israeli ambulance service.

Friday's strikes killed more than a dozen Palestinians including 5-yearold Alaa, who lived in the Shejaiya neighborhood in eastern Gaza.Her grandfather Riyad Qaddoum said: "What was the fault of this child? She was a kindergarten pupil who only needed a paper, a pencil and a school uniform." She was killed while playing in the street.

Israel launched the military operation, called Breaking Dawn, against Islamic Jihad on Friday afternoon with the assassination of Taysir Al-Jabari, a senior commander, in an apartment in Palestine Tower.

Al-Quds Brigades, the armed wing of Islamic Jihad, began firing missiles from the Gaza Strip toward Israeli cities and towns at 9 p.m. on Friday.

"The enemy bears full responsibility .. We will not be lenient in responding to this aggression, which represents a declaration of war against our people," Islamic Jihad said in a statement.

"We call on all the resistance forces and their military wings to stand in one front and one trench to respond to this aggression and confront this terrorism.

Hamas, which governs Gaza, has not officially announced its participation in firing rockets at Israel, but it has condemned the Israeli strikes.

Hamas spokesman Hazem Qassem said in a statement that this round of

Dozens of Gazans queued up in front of bakeries and grocery stores, fearing that the escalation could continue for a long time. "We couldn't sleep all last night. The shelling was heavy and the explosions were very loud, and we don't know how long this escalation will last and how many days we'll suffer. I hope it ends soon," said Rami Khudair, queueing in a bakery.

Israel closed the Erez crossing for individuals and the Kerem Shalom commercial crossing last week, follow-ing the arrest of Islamic Jihad leader Bassam Al-Saadi in the Palestinian city of Jenin in the northern West Bank.

The Palestinian Ministry of Health warned that its health services would be suspended within 72 hours due to the acute shortage of medicines and medical supplies, in addition to the lack of fuel to operate electricity generators in Palestinian hospitals.

"The coming hours are critical and difficult," the ministry said in a statement.Egyptian, UN and Qatari efforts to end the fighting are underway. Further escalation would largely depend on whether Hamas opts to join the fighting.

On Friday night, the Israeli military said it had apprehended 19 Islamic Jihad militants in raids in the Israelioccupied West Bank while targeting the group's rocket-manufacturing sites and launchers in Gaza.Gaza streets were largely deserted on Saturday afternoon

At the site where Al-Jabari was killed, rubble, glass and furniture were strewn along the street.A neighbor, Mariam Abu Ghanima, 56, said the Israeli military did not issue a warning before the attack, as it had done in previous rounds of violence.A spokesperson for the military said it had made efforts to avoid civilian casualties in the surprise attack, which had used precision means to target a specific floor of the building, Reuters reported.
