Migrant Worker Shot Dead In Bandipora

Policeman Injured In Bijbehara Attack

Srinagar: A young migrant worker from Bihar was killed while a policeman sustained injuries in two separate attacks by unidentified militants in the twin districts of Bandipora and Anantnag in the Valley, police said on Friday.

The attack took place around midnight, they said.

"During intervening night, #terrorists fired upon & injured one outside #labourer Mohd Amrez S/O Mohd Jalil R/O Madhepura Besarh #Bihar at Soadnara Sumbal, #Bandipora," the Kashmir Zone Police said on Twitter.

The police said Amrez was shifted to a hospital for treatment where he succumbed to injuries.

Mohammad Tamheed, who identified himself as Amrez's brother, said they were sleeping when they heard gunshots around 12:20 am.

"We were sleeping and it was 12:20 am when my younger brother woke me up, saying some shots were fired. I told him such things happen, so sleep. But he told me that he will take a look as another brother was not in the room.

"He went downstairs and saw him (Amrez) covered in blood. We called the Army. They came and took him to Hajin. The doctors there told us to take him to Srinagar, but he succumbed on the way," Tamheed said.

Tamheed and Amrez's colleagues appealed to the government to help them take his body back to Bihar.

Amrez is the fourth non-local filled in a targeted attack Kashmir so far this year.

India's Annual **Green Finance Is Just One-Fourth** Of Its Needs, Finds Study

n analysis and advisory organisation has released an update on India's **▲**"first-ever effort" to track green investment flows, which are falling far short of the country's current need for its ambitious climate targets. Climate Policy Initiative in its report titled 'Landscape of Green Finance in India', has claimed that "the tracked green finance in 2019-2020 was Rs 309,000 crore (nearly USD 44 billion) per annum, which is less than a fourth of India's needs". The report estimates that for India to achieve its Nationally Determined Contributions (NDCs) under the Paris agreement, the country requires approximately Rs 162.5 lakh crore (USD 2.5 trillion) from 2015 to 2030 or roughly Rs 11 lakh crore (USD 170 billion) per year, the US-based organ-



isation said in a statement.

The evaluation of finance flows

economy sectors like clean energy, clean transport and energy efficiency, the organisation said. The study tracks both public and private sources of capital -domestic as well as international -- and builds a framework to track the flow of finance right from the source to the end beneficiaries through different instruments with an emphasis on bottom up approaches based on actual flows rather than commitments, providing the most accurate analysis to date of where India's climate finance stands, the finance gaps it faces, and the opportunities that lie ahead, the statement said. This year, the report also provides a first-of-its-kind evaluation of adaptation financing for select sectors. "The report shows increased flows to renewable energy sectors. This indicates the positive role policy support has had on the renewable sector. We would also in the future hope to see a similar role being played in other sub-sectors like distributed renewable energy - rooftop solar and clean mobility." said Neha Khanna, project manager and lead author, Climate

Policy Initiative-India.

Costs of War

he second Gulf War has begun. How the war will progress, how Saddam Husain will respond, and how military and political events will unfold cannot be predicted.

And what after the war? The first casualty of the war has already occurred: it is the United Nations. America and Britain have fatally harmed it by stripping the world body of its international authority and by establishing a dubious principle - that if it suits a state or a group of states, the UN can be bypassed.

What matters is the unabashed pursuit of geopolitical and commercial interests. If the UN stands in the way, it should be brushed aside. By refusing to table a second resolution for fear it may not get a Security Council majority or it may be vetoed, the US and UK have seriously undermined the world body.

The world should now get ready to witness a descent into the law of jungle. All this talk about the war ushering in an era of democracy in the Middle East is poppycock. Democracy cannot be imposed from above; it has to grow from within as a result of a people's home-grown struggle.

Saddam may disappear from the scene, enabling the US to occupy Baghdad, install an interim administration there and pacify resistance elsewhere; or he may succeed in resisting at length, in Baghdad or elsewhere, forcing the US into a long fight. Or he could disappear, but others emerge to resist the US. The possibilities are endless.

If the United States is sincere in its assurance that all it wants is the destruction of Iraq's alleged weapons of mass destruction, it will have no difficulty in living up to the world's much reduced expectations.

However, only the ignorant or foolish believe in any of that anyway. America has more far-reaching goals in Iraq. It will not be content to stop at destroying Saddam's arsenal of weapons of mass destruction, if indeed such an arsenal exists. Nor will it be content to depose Saddam himself and then install a civilian government in his place. Nor will it rest once the mechanisms for a democratic future in Iraq are a reality, if in fact they are really a part of the vision.

Rather, US ambitions are for nothing less than complete control of Iraq and its oil reserves, and for a redrawing of the map of the entire region according to its own -- and crucially, Israel's -- agenda. On its way toward achieving that goal, the US has amassed the most terrifying arsenal of weaponry ever dispatched from its soil into the Persian Gulf.

The weapons themselves -- awesome though they may be in their destructive power and technical sophistication -- are of course not foolproof. Just how smart are the famed "smart bombs" the US are proposing to unleash on Iraq? Previous conflicts -- in Kosovo, for instance -- revealed that a large percentage of them go horribly astray. They have even landed in the wrong country on occasion. How safe will Iraq's civilians be when all hell comes raining down on them?

The prospect of a bombardment, the extent of which can barely be imagined, is terrifying. How can such a force fail to cause significant "collateral damage" -the Pentagon's deceptive euphemism for blowing into pieces men, women and children, whose misfortune it

is to have been born citizens of Iraq? As the region braces itself for a full fledged war, two images crystallize in the mind one is of Saddam Hussein -- isolated and perhaps long out of touch with reality in the identical bunkers between which he moves, all the time contemplating his lack of a future. We must not forget, after all, that he has ultimately brought this fate upon himself and upon the Iraqi people, whom he has for so long terrorized.

The second image is of an Iraqi mother with her small children in a small house, which has had only intermittent power supplies for the 12 years of sanctions, her children robbed of an education. They are caught in a situation for which she was never even given a chance of bearing responsibility, but for which they will pay the ultimate price.

Save Bungus From Feral Human Intervention

ne of the relatively undiscovered, but much-anticipated tourist Spots, 'Bangus' is receiving defining momentum related to tourism activities. This mesmerizing valley lies at an altitude of 10, 000 ft above sea level in Jammu and Kashmir's northern district, Kupwara. The name 'Bungus' comes from a combination of two ethnic words 'Bun' (wild forests) and 'Gus' (Grass), which explains its geographic location and topography. Bungus has a 'spine' of mountain ranges in annular design with gentle substantial, considerable cool temperate grassy slopes and subalpine meadows rolling between mighty snowy

As the Administration of Jammu and Kashmir is constructing roads through forests and rocky hills, it is more important to consider all possible measures which can minimize unabated human intervention with heavy machinery. Unless and until experts in environmental conservation and sustainable tourism management are not deputed for designing the most eco-friendly tourist infrastructure with modern structural values; Bungus will remain capricious with an inconceivable disastrous environmental situation. The administration has to take a full assessment of its current topographic, geographic sensitivity, social and economic impacts, providing remedies to the basic needs of its eco-friendly development.

Meanwhile, the authority in place should use resources according to the possibilities of its future-economic and socio-cultural per-

Some suggestions may be taken into consideration for the sustainable development of Bungus as an Eco-friendly Tourist spot.

For instance, less fuel-based automobile intrusion and development of Electric Transportation infrastructure. As roads leading to the main area are available for automobile movement, the carbon emission in the area will be prodigious and indomitable. A buffer zone or hostile parking area should be created far from the actual tourist spot, wherefrom e-transport can be used for transition or a shorter-term solution: light carriage (Tonga) will be beneficial for both environment and a source for local labor opportunity. It will not only restrict carbon footprint but also develop a chance for experiencing nature immensely with your companion. The vehicles of tourists should be charged a fair amount for the green development fund.

Another feasible suggestion would be ecofriendly night-stay infrastructure and a blanket ban on plastic. The development of infrastructure for Night Stays must be customized under the SOPs of Eco-friendly development. Solar energy must be made as the lone source of energy and programs for recycling should be established also for waste disposal management. The tourists should be strictly

prohibited from using plastic disposables or poly-related packing, instead reusable bags or paper bags shall be made available and encouraged to use. People must be motivated to opt for locally purified water in recyclable glass bottles and the usage of paper or jute bags can cut back on plastic waste and reduce carbon footprints.

Yet another way step in the direction would be to buoy up the local economy. If locals are provided better economic possibilities with basic conceivability, the community will not only participate in saving the environment but also act as gatekeepers. The engagement of the local population will be a pivotal factor in developing a better community for residents and money that tourists will spend in this area can be a source of reinvestment in local economic corridors. It will mature the local lifestyle and advance household income so that the community will accordingly provide better shelter, quality education, and nutritious food to their children. This economic sector is job-driven and has the possibility to float jobs from urban areas to suburban communities. According to the World travel council, in 2019 the sector employed 1 in 10 people on the planet and it created 1 in 4 of all new jobs globally in the last 5 years. A localized

tourism approach will not only support businesses but foster entrepreneurs and ideal business establishments with equal opportunities for all.

Tourism has immense capability to engage people related to all walks of life, it will especially support vulnerable sections of the community, women, and youth. The small Tourist Night Stay Cabin attached to local households can establish a mechanism for a sustainable financial system. It will help families become familiar with innovative solutions for ideas related to tourism and accelerate the integration of different communities.

It is now the responsibility of the Government to create a sustainable tourist place or let the place be vulnerable to a catastrophic disaster. As Winston Churchill rightly said: "Where there is great power there is great re-

he economic downturn caused by Covid-19 was the making of one class of business: the edutech industry. The closedown of schools created a need to teach students remotely. The electronic mode was the only possible means. But the way it was adopted prompts deep misgivings.

I am actively involved with computer applications in teaching and research. The promise held out by digital learning excites me. Its progress in India fills me with alarm.

The dismal backdrop to my discussion is the digital divide. We are content that for the poor, a single smartphone should be considered a sufficient educational tool for all students in a household. Even that, a parliamentary committee found last year, eluded 77 per cent of the nation's children.

But today, let us think about the fortunate ones with laptops and smartphones for their sole use. When the pandemic broke, their schools soon switched to online classes. But online teaching implies more than a Zoom meeting. It calls for audio-visual techniques for which most schools had neither expertise nor infrastructure. Plain vanilla classroom teaching falters without a classroom.

That is where edutech compa-

nies saw their chance. They applied digital technology expertly and intensively to the curricular content. Their instructors exuded a compelling onscreen presence, as conventional teachers had never learnt to do. The result was a package that captivated both children and parents footing the bill. Both parties were connoisseurs of onscreen content: the children from computer games, the parents from infotainment channels. The superstition is rife anyway that anything emerging from a computer is a superior option. In two short years, hitherto uncontested schooling methods acquired the negative label of 'offline

Edutech is the white flour and refined sugar of learning

But might not the new technology truly be superior? The digital revolution has transformed our lives. In intellectual and cultural matters, however, it has generally modified older practices instead of dislodging them altogether. More books are printed today than ever before, alongside the electronic text and the internet. Live performances flourish despite staggering advances in audio-visual recording. The equation between ageless human practice and digital innovation is subtle and complex. With education, the pandemic drastically short-circuited this adjustment.

Throughout history, teaching has implied an interaction between teacher and student. A child learns letters and numbers under a teacher's care among a group of peers. Every primary-school teacher I have asked agrees that small children cannot be taught online to read, write and count. If some learn to do so, it is because an adult is present to guide the process.

With older children, the challenge is subtler. Edutech planners will tell you that they allow for individual attention and interaction. Learners can follow their own pace, assess themselves by self-testing, and even ask questions. The interaction is largely through precoded exercises and bots, but the best (and costliest) courses find slots for human mentors. Yet all these features are worked into a pre-set, one-way system: an extended IT program, remote' in every sense.

To be sure, there are physical schools so ill-run that online instruction is a better alternative.

But even a halfway decent institution offers the imperative human exchange. A lecturer in a classroom subconsciously attunes herself to the faces in front of her. Students' queries cover a range that artificial intelligence cannot tackle — above all because it ignores individual psychology, the personal factors impacting a student's development. A packaged online program can never overstep its boundaries, never warm to a bold question or an out-of-the-box suggestion. At most, it fosters a competent mediocrity. Hence the best students benefit the least from online courses, which stunt their potential.

Edutech is the white flour and refined sugar of learning. To consume it is better than to starve, but it is no substitute for a wholesome home diet, even if indifferently cooked. (That is no excuse not to improve the cooking.) To vary the image, the stuff of digital learning is both literally and metaphorically behind a screen: you see it, but you can't reach through and grasp it.

Such charges are customarily made against private coaching. Coaching centres are reviled on principle but rife in practice. Edutech providers profess the same adjunct role. But given their reach, glamour and opulence, they play a much more visible and increasingly central role in India's education system.

This is because they blend with the current ecology of public services, cutting down State forests and planting corporate groves. Online teaching is vastly cheaper to provide: it does not need a standing army of teachers. The high demand

is fanned by both commercial and official publicity. The Union government has perfected a new rhetoric extolling online teaching, never mind the digital divide. PM eVidya, the grandest of many schemes, aims to provide online education to every student in India. This may or may not be the same as the 'digital university' promised in this year's budget, while actual universities languish for want of funds.

Education is following the path of our healthcare services, with an endlessly expanding role for the private sector. The economics drives the technology. State agencies have their own e-learning platforms: Diksha, ePathshala and Swayam, among others. Yet our rulers are warming more and more to private operators. Universities can outsource 40 per cent of course content for online degrees (themselves a recent innovation) and engage edutech companies to 'assist' even with the rest. There is even talk of such companies carrying out evaluation.

In today's India, practices once thought harmful or illicit are routinely legitimised and then made standard. Not so long ago, we deplored the possibility of commercial coaching empires influencing exam results and curricula. This might soon become normative and organic to the system.

No academically respectable country has surrendered its education sector to profit-seeking interests in this way. When all is said, Indian education has an honourable place in the world's eyes. We denigrate our public education system, but its alumni win success and acclaim everywhere. Let us not sell out on that legacy.



BOOK REVIEW

Dangerous Earth

The book makes absorbing reading on the unexpected, and acts as an alert on knowing how to protect lives, property and economic stability

s the earth becoming a dangerous place for human habitation or are recent extreme events a pointer towards the dreadful inevitability? Either way, it is a dangerous world out there about which not much is known with scientific certainty.

The history of human existence has been fraught with such exigent calamities that led societies from pre-historic times to offer prayers for 'peace to be in the universe'. Explained through religion or myth, such prayers have been a way of dealing with the dangers of living on earth. While the earth remains a wondrous planet, its frustratingly complex existence had a violent past to which it seems to be returning.

Marine biologist Ellen Prager examines the awesome forces of creation which are equally devastating, and remain perplexing. Through an illuminating look at the range of natural events, from earthquakes to volcanoes and from tsunamis to hurricanes, Prager lists the wish-we-knew about the dynamic phenomena that continue to remain unknown while frustrating and fascinating the scientific community.

Her book, Dangerous Earth: What we wish we knew about volcanoes, hurricanes, climate change, earth-quakes and more, seeks to respond to the most compelling question: Why can't we better predict the natural disasters? Part of the answer to this question is that the Earth's processes are dynamic, ephemeral, and their origin are hidden from view.

Furthermore, our historical record of events is a blip in the planet's billions of years of existence. Does that reflect upon human inability to predict the future? By studying some of the devastating events in recent times, Prager concludes that preparation and not prediction holds the key to prepare for what lies ahead. This could be disturbing news but she has valid reasons to extend her argument.

Take the case of Miami where since 2006 the average rate of sea level rise is three times the global average of about 3 mm rise per year. The sunny days flooding in Miami has forced the local government to spend hundreds of millions of dollars in infrastructure without being aware about how long the situation will continue to worsen. Given that there are more than 700 million people living in lowlying coastal areas across the world, the science of sea-level rise has yet to deliver a credible forecast about the impending threat. Consequently, how far and how fast will the sea rise remain open to speculation.

Prager writes with all the imaginative sympathy of a storyteller, with an overarching concern on the gaps in research to understand the nature of change better. Picking detailed stories of some of the game changing major events - Mount Pinatubo volcano of Philippines, Indian Ocean tsunami of Sumatra, Hurricane Harvey in Texas - the author highlights what remains unknown about these dynamic phenomena. In addition to giving insights on each of the events, one gets to know recent attempts at advancing scientific quest towards understanding earth's warning signals.

Dangerous Earth makes absorbing reading on the unexpected, and acts as an alert on knowing how to protect lives, property and economic stability.

Much has been written in recent times on climatic events, but it is the well-reasoned and engaging expla-

nation offered by Prager that makes it a riveting read. Given the recent spurt in extreme weather events, scientists now consider this a whole new field of science which may be with or without the influence of climate change. The list of climatic unknowns is only beginning to expand, throwing new challenges to understand dangers and the risks involved. No wonder, the recent thunderous development that caused widespread damage in some parts of Delhi during May this year had caught the India Meteorological Department (IMD) off guard. Prediction is indeed crucial, but preparedness is no less important.

While highlighting the need for focused research on climatic events and capturing the new areas of scientific enquiry, Prager points out towards the inevitability of dramatic change that is upon us - turning the beautiful planet against its own inhabitants. There can be no denying that there have been similar periods of warming in Earth's past, it is not the actual temperature that is the issue but the rapid pace at which the global thermometer is rising that is unusual and problematic. It is the comprehensive undertaking on the extreme events that will open new avenues of research in reducing the impacts of extreme events. Loaded with in depth narratives on recent catastrophic events, Dangerous Earth is an eye opener and a call to devise and develop ways and means of reducing the impacts of a violent planet on its inhabitants and infra-

In this direction the Government here had even amended the PSGA (J&K Public Service Guarantee Act, 2011) with the aim to reach out to the common public and make available the G2C services in a timely manner. It is the endeavour of the Government to facilitate dissemination of e-Services to the public on one hand and to monitor, analyse and - if necessary - penalize the defaulters in service delivery, as per the service delivery timelines defined in this Act.

The TEJAS Dashboard on e-UNNAT Portal would show, at a glance, the online e-service applications received, services delivered, applications pending, applications rejected et al, with the delayed services delivery break-up further displayed on the basis of time delay periods, i.e., less than one week, one to two weeks, more than two weeks and so on.

At the same time, eUNNAT Portal now also provides a glimpse into the My Scheme Portal of the Government of India by mapping, initially, six schemes of the Government of J&K and providing access to information on those by re-directing through a single URL. These six schemes are Marriage Assistance Scheme for Poor Girls, Credit Card Scheme for Artisans, Revised Educations Scheme for Children of Weavers, Karkhadar Scheme and Grid Connecting Rooftop Solar Plant, Pradhan Mantri Kissan Urja Suraksha evan Utthaan Mahabhiyaan(PM-KUSUM).

MyScheme is a repository for Government schemes and services. Using MyScheme the citizens of J&K can find various government schemes by checking his/her eligibility to apply for the schemes of his/ her interest.

It offers a convenient three step process for the citizens to discover the government schemes for which they are eligible. In three steps a user enters his / her attributes such as demographic, income, social details, etc. In next step his/ her eligibility is determined in My Scheme and lastly the user can select from the list of eligible schemes and get more information from the dedicated scheme page with detailed knowledge, FAQs, and application process and traverse to the application URL to apply.

With this J&K has become the first State and UT in the country to on-board on My Scheme platform.

Salman Rushdie, Author Of The Satanic Verses, Attacked On Stage In New York

Rushdie Was Taken By Helicopter To A Hospital, State Police Said. His Condition Was Not Immediately Known.

New York: Salman Rushdie, the author of 'Satanic Verses' considered blasphemous anti-Islam book, was attacked on stage during an event in New York on

Rushdie's condition was not immediately known, but video footage from the incident showed people rushing to his aid after he was attacked at the event in Chautauqua County.

A man rushed to the stage at the Chautauqua Institution and attacked Rushdie as he was being introduced, a witness told Reuters, adding the attacker was subsequently restrained. Police said Rushdie suffered

an apparent stab wound to his neck and was transported by helicopter to the hospital. The person interviewing

Rushdie also suffered a minor

head injury, the state police said.

Rita Landman, an endocrinologist who was in the audience, said that Rushdie had multiple stab wounds, including one to the right side of his neck, and that there was a pool of blood under his body, the New York Times reported.

"People were saying, 'He has a pulse, he has a pulse, "Landman said.

Bill Vasu, 72, who attended the event, said he had seen the man rush over to Rushdie and start attacking him. "I could just see his fists sort of pounding on Salman," he said.

"There was just one attacker," said Elisabeth Healey, 75, who was in the audience. "He was dressed in black. He had a loose black garment on. He ran with

lightning speed over to him." Multiple witnesses said the attacker was able to reach Rushdie easily, running onstage and approaching him from

Rushdie wrote "The Satanic Verses" in 1988 which sparked Muslims' outrage across the

Following the publication of the book, Ayatollah Ruhullah Khomeini, the founder of the Islamic Republic of Iran, issued a fatwa (religious decree) calling for Rushdie's death. Rushdie has lived life of a fugitive ever since.

China As A Superpower; India Has To Prepare For "Unsettling" Changes: EAM

Bengaluru: External Affairs Minister S Jaishankar on Friday said there could be 'very unsettling changes" and India will have to prepare for it, when a regional power like China is on its way to become a superpower.

The Minister was inter-acting with students at PES University here.

Responding to a question on the repercussions of the current situation with respect to China and Taiwan, he said, "if you are talking about a larger Chinese presence offshore including in the Indian Ocean, I think it is something that India has to evaluate and assess including the implications that it has for our own security, because historically we have always thought of China as a country to the north of us....it is the situation we keep evalu-

ating and monitoring."
"When you have a power which is beyond a regional power and on its way to become a superpower, then there could be very unsettling changes and these are changes which our country will have to prepare for. Wherever our interests are involved, I think it is very important that we are very clear and firm on defending our interests," he said.

Responding to a question, he said becoming permanent member of the UN Security Council is a "very big deal". laishankar said it is not going to happen easily because the world is not a generous place, and countries have to struggle for what they get.

"The current structure was formed in 1945, it kind of reflected the outcome of the second world war.... in 77 years that have passed the world has changed dramatically...very soon you will have a situation where the most populous country and third largest economy of the world is not in the security council, I then ask you how credible does it make the security council," he asked.



Noting that India's case for UNSC is widely acceptable, he said if there is a free and fair vote for membership it is assured that we will get a very high degree of support, but there are very deep vested interests.
"....but because it is hard is

no reason to give up."

The foreign policy today is very focused on "how do I use the world to drive my national development faster", Jaishankar said. It is about knowing the world and in a sense doing a risk assessment.

He said one of the areas where Prime Minister Narendra Modi is pushing very hard is to make sure the world opens up for India as a work place, so that Indian talent, skills and corporates are able to go out and work on equal terms with citizens of those countries, the minister said.

"One of our big focuses today is on mobility agreements and work opportunities for our students and interns abroad," he said.

Stating that the vision, leadership and ambitions that India has today are very different, Jaishankar said, "I'm not suggesting that the world is without challenges, it is a tough place, but it is a tough place that we in India face with confidence, because we have that leadership and experience today."

The decisions that this country is making are the right ones and that of experience, he said. They are decisions of prudence, but still decisions of ambitions, Jaishankar added.

As per report, under the commuawareness generation and advocacy on the SDGs, the UT realizes that capacity development is required at every level and sensitisation is very vital to integrate SDGs in all governance processes. In order to facilitate formulation of a localized indicator framework and capacity development at all levels, the UT government has partnered NITI Aayog and UNDP for conducting training programmes to help build capacity

on various aspects of monitoring the SDGs including methodology, identifying data sources, preparing metadata sheets etc.

"For sensitisation of officials, workshops are also organized by the UT government. Also, the Directorate of Economics and Statistics (DES) has been designated as the nodal agency for compilation, coordination and formulation of SDGs Action Plan.

"A Nodal Officer has also been nominated in the Secretariat for coordination on SDGs. Administrative and Departments Development Commissioners have been directed to device strategies/action plans for implementation, monitoring & achievement of SDGs at their respective level," the report said.

As per Niti Aayog, The government is planning to establish a Sustainable Development Goals Coordination Center (SDGCC) to fast track the progress on achieving the SDGs in the UT. Aligning plans with the SDGs: A separate chapter on SDGs, linking department priorities to various Goals and targets, is included in the Plan Document from 2018-19. SDG monitoring: Jammu and Kashmir has shortlisted 206 monitoring indicators covering 81 targets for UT level monitoring. This includes 23 UT-specific localized indicators.

The UT has also prepared the District Indicator Framework (DIF) for further localisation of the SDGs, the report noted.

The UT government is planning to develop an SDG dashboard, SDG Index

for the UT and its districts for monitoring the implementation. Detailed metadata sheets are being prepared to get a clear picture of the various indicators. SDG based budgeting: The budget

Pertinently, J&K's in place mechanism for attaining 2030 SDG goal is among the systems developed by top states in India to achieve the laid down agenda.

All the targets set in the SDGs are being addressed through annual budget and annual plans. The report has also noted that all the departments/ sectoral heads at the UT and district levels prepare the annual budget and annual plans which are targeted to achieve the desired objective under that particular sector.

"This results into loss of public exchequer under Ayushman Bharat/ SEHAT scheme and hence tantamounts to offence under the provisions of Prevention of Corruption Act, 1988," the government said, adding, "This is also to be construed a misconduct and violation of Civil Services Conduct Rules.'

It has further come to the notice of the Government that many Doctors are 3 indulging into private practice in other cities/towns which implies that they are not available at their places of posting in case any emergency arises, the government said.

"The doctors who are skipping their duties and indulging into private practices in other places is also being viewed very seriously," the government order reads, and impressed upon all HoDs and DDOs not to allow any Doctor borne on the establishment of Health and Medical Education Department to indulge into these malpractices resulting into loss of Government exchequer and weakening of public services.

"Strict vigilance shall be kept and such cases will be recommended for strict action by the Regulatory Authorities," the order reads, adding, "These instructions shall also apply to Para-medical staff who are found indulging in same practices.
