## Govt Clears Air On Voter Enrolment, Says New Voters Mostly To Be J&K Youth, Left Out Persons'

**Srinagar:** The Jammu and Kashmir administration on Thursday cleared air over the estimated 25 lakh new voters being enrolled in the Union Territory, saying that a large number of new voters will be the youth of J&K, who have attained the age of 18 years after January 2019, besides other left out persons.

According to government officials, who spoke to Kashmir Observer, it is projected that 18 plus population in J&K as on July 1, 2022 is expected to be 9896000, whereas the



registered electors in the UT of Jammu and Kashmir as on date are only 7602397, thus there is a gap of 2293603.

"It is this gap which was used to convey tentative expectation from the special summary revision," he said, adding that the last

SSR in Jammu and Kashmir was held with reference to January 1, 2019 as the qualifying date.

"Thus the youth of Jammu and Kashmir who have attained 18 years of age after 1st January 2019 are expected to be registered in the Electoral Roll during

this SSR, along with other left out persons," officials said.

They further said that prior to the abrogation of Article 370, the assembly electoral rolls in Jammu and Kashmir were made under the ambit of Jammu and Kashmir Representation of

People Act 1957, wherein only permanent residents of Jammu and Kashmir were eligible to get registered in the Assembly Rolls and possess consequential voting rights in Assembly Elections. "With the abrogation of Article 370 and applicability of Representation of

People Act 1950 and 1951, any citizen of India who has attained the qualifying age and 'ordinarily residing' at a place is eligible to get registered in the Electoral Roll of that place, if not disqualified otherwise," they said.

## Waqf Board Cracks Down On Unauthorised Khadims


Over 100 Khadims, Donation Boxes Removed From Major Shrines In Kashmir

## 'Drone Dropping Case' NIA Raids Multiple Locations In J&K

**SRINAGAR:** National Investigation Agency (NIA) on Thursday carried out searches at multiple places in Jammu and Kashmir in connection with the drone dropping of weapons.

News agency KDC quoting sources reported that NIA sleuths with the assistance of police and paramilitary CRPF personnel are carried out raids at over half-dozen locations in Jammu and Kashmir including Srinagar, Jammu, Kathua, Samba, Doda.

In Srinagar, the sleuths of NIA raided the residence of Sarjeel Ahmad Bhat son of Abdul Ahad, a resident of Rose Lane colony

Chanapora house no 152. The raids were also conducted at the residence of LeT militant Faisal Munir son of Sadiq Hussain, a resident of Talab Khatikan.

## Govt Blocks 8 YouTube Channels For 'Anti-India' Content

**NEW DELHI:** The government on Thursday ordered the blocking of eight YouTube channels, including one operating from Pakistan, for allegedly using "fake and sensational thumbnails" and spreading disinformation related to India's national security.

The channels that were blocked under the Information Technology Rules-2021 include seven Indian news channels, a statement from the Information and Broadcasting ministry said.

The blocked YouTube channels had over 114 crore views and 85.73 lakh subscribers and the content was being monetised, it said.

# How To Perfectly Answer The 'Tell Me About Yourself' Interview Question

The "tell me about yourself" interview question can be hard to answer if you're not prepared. Searching for a job is stressful enough without adding in a dose of self-perception. You might feel stumped on how to answer this question because it can be difficult to talk about yourself with no guidelines. Luckily, speaking confidently about your successes can be much easier when your answers have a good structure.

## Here are our best tips for formatting and nailing your response.

Why do interviewers ask, "Tell me about yourself?"

A job interview is all about getting to know you. Interviewers ask the "tell me about yourself" interview question as a way to transition from small talk into their technical and behavioral interview questions.

The interviewer wants to gauge if you are able to communicate clearly and professionally. Freezing up the first time you're put on the spot gives a bad impression.

The interviewer hopes the candidate can answer the question in a natural way that shows they are prepared and care about the interview. A great answer can help you stand out in a job interview.

If you're asked this question during a phone interview, you can have your answers in front of you. If the interview is in person, you should be prepared to answer without checking your notes.

## Other ways that interviewers might ask this question

The "tell me about yourself" interview question sometimes sounds different. Interviewers might ask:

- Tell me more about your background
- I'm interested in learning more about you
- Tell me about your time working at "x" company.
- Can you tell me more about your experience?
- Tell me something I don't already know from your resume

Be ready for any version of this question with your structured and practiced answer.

Breakdown: How to answer the "tell me about yourself" interview question There are many strategies for answering the "tell me about yourself" interview question. The way you choose

to structure your answer may depend on your previous experience. A recent graduate will have a much different answer to a director who has been employed for decades.

While it's important to prepare your answer, you should also leave room for spontaneity and make sure it doesn't come out sounding too rehearsed. Once you find a form that fits your experience the best, make sure you practice. Write down your answer so you can rearrange it, make sure it flows, and keep track of key points.

Whichever method you choose, be sure to tie it back to the specific job and company you're interviewing for. The answer should make the interviewer think it makes sense you are interested in the role.

## Components of your answer

Your answer to the "tell me about yourself" question should describe your current situation, your past job experience, the reason you're a good fit for the role, and how you align with the company values.

## Current situation

Tell the interviewer about your current position and a recent big accomplishment or positive feedback you received. Avoid speaking negatively about your current job.

The interviewer wants to hear how your current role is similar to the position you're applying for.

If you're currently a student, use this time to talk about relevant school experiences like classes you've taken, projects you liked, or internships.

## Past job experience

The interviewer likely has your resume in front of them, so don't just tell them what they already know. Use this question to touch on your past work history and highlight areas that are applicable to the position you have now.

Describe your past job experience in chronological or reverse-chronological order.

If you switched industries, explain why with a quick personal anecdote that demonstrates your passions or interests.

## Your "why"

Why did you choose this job to apply to? Why are you the best candidate for the role? Use this time to sell yourself to the interviewer and give them your "why." If you've tailored the other parts of your answer to the job you're interviewing for, this part will be easy.

Explain how this role aligns with your personal career goals to show you'll put

in the effort to be successful.

Aligning and connecting your goals, passions, and strengths with the company/role Research company culture. If you and the company both value working in teams or doing things individually, talk about that here. Be sure to mention if you have other interests or skills you've been working on that make you a better asset to the company.

Knowing the overall mission of the company to help you tailor your "why." If you're interviewing for an outdoor apparel company that values a good work-life balance, don't talk about how you love working nights and weekends to complete projects.

## How long should your answer be?

Remember that interviewers want to learn more about your work experience and your personality. Answering this question in a couple of sentences might seem less-than-thorough and talking for ten minutes is a red flag that you might do the same in meetings.

Try to keep your answer to one to three minutes. Watch your interviewer's body language and feel free to expand on any portions they look excited about.

## Do's and don'ts for answering "tell me about yourself"

There are some rules when answering the "tell me about yourself" interview question. Interviewers have certain expectations when it comes to how you answer this question, so you don't want to deviate far from them. One of the most important and basic interview tips is to stay professional. Being overly negative or oversharing about your personal life could end up costing you the job.

## Do Stay positive

No company is perfect. Talking negatively about other places you've worked for may give the interviewer the impression that you won't be happy at the new company either. If the interviewer asks why you left a job, keep it simple with an answer like, "I was looking for a new challenge."

## Avoid making long-term plans

You wouldn't talk about plans a month from now on a first date, so why would you bring it up in an interview? Rushing into conversations about future goals with the company can seem premature. Save these conversations for later stages in the interview process.

## Know your audience

Learning about the company you're

interviewing with ahead of time is crucial. You can tailor your answer to focus on where you align with the company culture and be able to ask more informed questions at the end of the interview.

## Concentrate on examples you can quantify

Saying that you brought in new customers is okay, but saying that you "increased website visits by 27% in one quarter" is much more meaningful and impressive. If you don't know the exact numbers, make a realistic estimate.

## Highlight your personality

Mentioning that you quilt or play chess reveals more about you than just what you do in your spare time, it shows a part of your personality. Interactive roles like volunteer work or being a part of a softball team demonstrate that you are friendly and are able to communicate well with others.

## Don't Get too personal

Avoid mentioning too much information about your private life. Talking about politics or your religious affiliation, marital status, or children might end up working against you. You wouldn't want the interviewer to pick a candidate based on the answers to any of these questions.

## Memorize your responses

Giving a canned response may sound inauthentic. Remember a few of your main points and fill in the gaps naturally. Memorizing answers might even make you more likely to make mistakes if you forget a few words and can't find where you left off.

## List your strengths without examples

Just saying that you are great at teamwork doesn't mean very much without an example to back it up. Add a sentence telling a story about a time you demonstrated each trait you highlight in your career.

## Overwhelm the interviewer

Pick three or four personal strengths and stick to them. Going on and on about yourself or getting too personal might spoil the interviewer's first impression of you. Keep it short, sweet, and professional to leave them interested. Summarize your resume point by point. The person interviewing you has already read your resume, so telling them exactly what's on it could make them lose interest. Tell them the high points that are most relevant to the position you're applying for and add a few things you liked about each one.

## After Witnessing Surge, Covid Cases Dip

Srinagar: After witnessing a surge in Covid cases from last month, Jammu and Kashmir is once again on decline as active cases have reduced from over 5,200 to around 3,300 in the last 12 days.

As per the data available the active in J&K presently are 3,327 while the cases reached 5,261 on 6 August and number of active cases in Jammu have reduced to 512 which were around 2,000 before some days.

The total number of active cases in Jammu and Kashmir

are 3,327 including 2,815 from Kashmir division and 512 from Jammu division

Officials told KNO the cases showed an upward trend in Jammu division first followed by Kashmir and similarly cases are on decline in Jammu first followed by Srinagar.

They said that the majority of affected persons were unaware that they had COVID as they never tested for it and despite being positive, they kept on doing their routine activities as symptoms were like the common flu.

## 2 IAF Jets Crash On Srinagar Airport

Airport Sealed Off, Pilot Killed, Inquiry Ordered

SRINAGAR: Two MIG-21 fighter jets crashed one after another shortly after takeoff this afternoon from Srinagar airport, killing a pilot and injuring another. A court of Inquiry has been launched to probe the crashes, official sources said.

The two MIG-21 'BIS' fighter jets belonging to the Indian Air Force, reportedly on training sorties took off at around 1330 hours from runway 31 with a safe distance of about 1000 meters, defence sources said.

The sources said that Flying Officer Dhinsa was directed to eject after the fighter jet he was piloting was seen getting out of control and drifting towards left side. The observations were reportedly made by the Control Towers.

Dhinsa could not eject from the zooming jet which had hardly gained any height. The jet crashed closer to runway in a ball of fire.

Meanwhile the pilot of the jet, Flight Lt. Deswal, baled out the reason for which is not known. Reading to the second MIG-21 also crashing, they said. Deswal was injured and rushed to hospital by the rescue teams.

The twin crash created panic among the airport officials and the airforce personnel living nearby.

A large number of fire tenders rushed towards the crash site as both the jets had caught fire after crashing. The two jets were not armed when they took off from the Srinagar airport on training sorties, sources said. Sources said the wreckage of the two planes was scattered in a one kilometer area of the airport.

The airport was immediately sealed off and removal of wreckage of the two destroyed fighters from the runway started to make it functional for the Air Force and civilian flights. Today's incident caused a considerable delay in the Indian Airlines and Jet Airways flights. The area was under cordon when reports poured in this evening. Journalists were not allowed to go near the crash site. Official sources investigating teams were collecting samples from the wreckage. Till this evening the body of the slain pilot was not recovered. "In such a crash there is always possibility of body being blowing into smithereens," one of the squadron leaders of Indian Air Force said this evening.

## Renewed Violence

The recent days have witnessed a sudden spurt in violence in Jammu and Kashmir, with militants escalating their attacks on minorities and outsiders. Two days ago, one more Kashmiri Pandit identified as Sunil Kumar was killed and his brother Pintu Kumar was injured after they were fired at by militants in the Shopian district. Grenade attacks have also increased in frequency. Last week, security forces killed two militants after they mounted an attack on an army camp in the border district of Rajouri in Jammu and Kashmir. Three Army personnel also lost their lives and two others were injured.

Attacks like these go alongside the targeted killings of policemen and migrant labourers. This has only further increased the security responsibilities of the UT government, which is already bogged down in fighting the militancy. The surge in violence has come despite the fact that the number of militants has dwindled to under 200 over the last year, the first time this has happened since 2015 when the militant commander Burhan Wani reinvigorated the then flagging militancy.

Ever since the withdrawal of J&K autonomy in August 2019, around 500 militants have been killed in the UT, most of them local youth. Though this has reduced the number of militants, the violence has continued unchanged. And over the last year, the violence has increased as militants have chosen to attack soft targets - civilians, panchayat workers, J&K police personnel visiting home, outsiders and minorities - instead of engaging security personnel. Security forces, as a result, now not only have to combat militancy but also protect a large section of population including many from among their own ranks.

The resurgence in the violence hasn't, however, dented the larger drift of normalcy in the Valley yet. While the violence has become more conspicuous in recent months, it is still on the margins in so far as its impact on daily life. Tourism is at an all time high after many years. Between January and June over 10 million tourists have visited the Valley. Most hotels, according to UT's tourism department, are booked through the summer. And as things stand, tourism will continue.

But, at the same time, it is important that the law and order doesn't deteriorate further. The coming weeks and months of summer will be crucial in terms of the evolving security situation in the Valley. Summer is usually the time when the infiltration takes place and a little more escalation in the influx of the fully equipped militants could change the ground situation in Kashmir for the worse. But on a positive note, the overall situation has by and large stayed stable and we are already drawing toward the end of summer. Here's hoping it stays that way and things improve further from hereon.

## Finding a home

A recent report, "Review of Guardianship and Adoption Laws", by the Parliamentary Standing Committee on Personnel, Public Grievances and Law and Justice has pointed to the huge mismatch between the number of people wanting to adopt children and the number of children legally available for adoption, and suggested that the way to remedy that would be to ensure that "orphan and abandoned children found begging on the streets... are made available for adoption at the earliest". To do so, it has suggested periodic district surveys to identify children who are orphaned/abandoned. The report argued that in a country with millions of orphans, only 2,430 children were available for adoption. It is true that there are always more people wanting to adopt children than the number of children actually available for adoption; it has been so historically, but the increasing chasm, as the report indicates, will undoubtedly have to be addressed. According to the report, there were 27,939 prospective parents registered with the Central Adoption Resource Authority (CARA) as on December 2021, from nearly 18,000 in 2017. There were 6,996 orphaned, abandoned and surrendered children residing in childcare institutions considered adoptable, but only 2,430 were declared legally free for adoption by Child Welfare Committees. It claimed that the waiting time for adoption had increased to three years from one year, in the past five years. The total number of children adopted in 2021-22 was only 3,175.

But the process of adoption in the country was tightened — procedurally and legally — in response to rampant malpractices and inter-country adoption rackets. CARA was installed as the nodal body for in-country and inter-country adoptions, to monitor and regulate the process, ensuring through stringent rules that the adoption is in the best interests of the child, and no illegality is involved. While the parliamentary committee has interpreted that there is automatic happiness when a child in an institution is placed in a home, it is important to exercise caution. No doubt, the country should take care of its children orphaned due to circumstances, but even as it acknowledges that institutionalisation may be detrimental over the long term, it should pay equal attention to the finer aspects of child care, and allow itself to be guided by a child-centric philosophy. There are no shortcuts in ensuring orphaned children come to no harm.

# Is India Ready for the Global Electric Vehicle Wave?

Can India's electricity grid and infrastructure suit electric vehicles?

Environmental pollution is currently a global concern. The rate of toxic emissions coming out from Internal Combustion (IC) Engines are suddenly increasing at dangerous levels, leading to Global warming and health related issues. The increasing cost of fuel is also giving researchers a think about India's Go-Green campaign. This has forced scientists, researchers and policymakers to start thinking of using green technology. Additionally, at the recently concluded COP26, India has pledged to reduce its carbon emission to net zero before the year 2070.

Hence, the 21st century is set to become the century for the evolution of various technologies with the main focus on the Automobile Sector. Electric vehicles, for example, are one among the many options being considered.

India is gearing up to attain 30% market penetration of Electric vehicles by 2030.

From 2035 onwards, no new petrol or diesel engine cars will be sold in the UK and similarly the US is aiming for half of all new vehicles sold to be electric. But there are a number of concerns about EVs that are still making people think twice before buying them. The output potential of India's electricity grid is one among them.

According to a report submitted by the Brookings Institution of India, electric vehicles will account for the most significant load capacity in the country compared to industries like steel.

As everything has its positive and negative impact, the demand for electricity to power EVs is projected to increase almost 640 Twh by 2030 and 1,110 Twh in order to meet the EV@30% goal.

The erratic and unreasonable power cuts across the country sets apart India's EV challenge compared to the international market.

Only 1% to 2% of the total supply demand of electricity which is currently 200-300 Gwh will be required to charge expected 1-2 Lakh electric vehicles by 2030.

Power quality is no longer a question as almost every electronic device today has built-in features to cope with power cut offs but reliability plays a role especially from infrastructure perspective. To ensure efficiency and optimisation of power, all the edifices of Electric vehicles must work shoulder to shoulder with electricity service providers.

To include the provisions of electric vehicle charging in buildings, the ministry of housing and urban affairs (MOHOA) also amended Model building bylaws (MBBL)2016.

The 84 GW of grid-connected renewable electricity out of the total 366 Gw of power generation in 2019 is proof of India's push to generate power from renewable sources.

Infrastructure has miles covered yet miles to go  
The growing demand of EVs will not only reduce emission levels but also the love affair between cars and oil is losing its spark too.

The study done by Accelerated e-Mobility Revolution for India's Transportation (e-merit) portal in India reveals that only 7,96,000 EVs have been registered till December 2021 and the installation of 1,800 charging stations on public places. It shows that the country needs to push the accelerator to achieve recommended ratio.

For the location of public charging stations, Ministry of Power (MOP) provides minimum requirements which include at least one charging station in a grid of 3\*3 Km. After every 25km, one charging station is to be setup on both sides of highways/roads.

With the roll out of Phase-II of FAME (Faster Adaptation and Manufacturing of Hybrid and Electric vehicles ) India scheme , Department

of heavy industries allocated Rs 1,00,000 cr for the development of charging infrastructure.

India currently has around 1,827 operational public electric vehicle charging stations out of which 940 EV charging stations are spread across the metro cities including Delhi, Mumbai, Kolkata, Chennai, surat, Ahmadabad, Bengaluru and Hyderabad. Government of India is taking measures to increase the public charging infrastructure further.

However, the EV charging infrastructure business is capital intensive. As per estimates the initial up front cost is approximately Rs 29 Lakh without subsidy , excluding land adding operating cost of Rs 10 lakh per year which makes asset utilization critical.

The EVs are not priced at par with ICE vehicles. This impacts the purchase decision of buyers. It is the rising price of batteries which is one of the reasons for the high price of EVs. The need of the hour is to manufacture batteries domestically which will help reduce the cost of EVs in India.

India oil corporation and Bharat petroleum have given a call of setting up of 22,000 EV charging stations across cities and on national highways. The IOCL has taken charge of 10,000 EV charging stations, BPCL taken responsibility of another 7,000 while the remaining will be installed by Hindustan petroleum corporation.

As of now, IOCL has installed 439 EV charging stations and devise to install 2,000 more over the next year ,BPCL has established 52 charging stations while HPCL has already inaugurated 382 Charging stations so far.

To multiple adaption of EVs and easy range anxiety of end users, India has an Ev super app coming. The government is working on launching a master application that will provide information on location and availability of vehicle charging station.

State run CESL is in the process of collating information from the private sector for the super app schedule to go live in 4-6 weeks.

The details app will provide include availability, charger type and charging tariffs. The app will also allow the customer to make and change reservations at nearby charging stations.

# Art of Asking About Someone's MENTAL HEALTH

Mental health can be a sensitive subject to discuss, whether you have a friend who seems anxious or a family member who seems depressed. However, you shouldn't ignore a possible mental health problem simply because you feel uncomfortable bringing it up. The other person can be eager to discuss their feelings but unsure on how to do so.

A few direct questions might encourage people to open up if they choose to. It also demonstrates your concern for others when you respond to their queries. While enquiring, you should keep in mind that you shouldn't use these questions as a checklist, because nobody wants to sense that they are being interrogated. However, try to start a discussion by posing a question or two. It's okay if they aren't interested in conversing. You can inquire once more later.

Below are some of the ways through which you can attempt to ask for somebody's mental health:

## 1. HOW ARE THINGS GOING?

When we ask somebody, "How are you?" it usually sounds casual and hence frequently results in a polite response like "Fine, thanks for asking."

However, if you're truly interested in finding out how someone has been doing, wait until later in the conversation. Cut through the small talk and let them know that you are genuinely interested in their wellbeing.

You could make the following observation: "I've noticed that lately, you haven't been taking your walks. Are things all right?"

Alternatively, you might bring up an emotionally upsetting experience the individual has gone through by saying, "I've been wanting to ask, how have you been doing since your son passed away?"

No interruptions should be made while the other person is responding. Try to



avoid cracking any jokes to lighten the mood. Show that, you can manage simply being by their side, if the other person chooses to share their pain.

## 2. HOW MUCH STRESS HAVE YOU BEEN EXPERIENCING LATELY?

As opposed to an internal issue like anxiety, it might occasionally be simpler to discuss an external factor like stress. In comparison to directly asking about someone's mental health, asking about someone's stress level may seem less intrusive. Yet it can result in a similar discussion about mental health.

## 3. HOW HAS BEEN YOUR APPETITE AND SLEEP LATELY?

Sometimes, even when people are hurting emotionally, they feel comfortable talking about outward signs of their emotional pain.

Additionally, mental health frequently has an impact on sleep and appetite. Therefore, a person going through a difficult period can say, "I haven't been feel-

ing hungry recently," or "I haven't slept in a week."

Your responses to their statements can provide you with a chance to speak further. Acknowledging their pain and expressing your wish for them to feel better can be a genuine way to express your empathy towards their current situation.

You can say something like, "That must be incredibly difficult. Have you considered discussing it with your doctor?"

## 4. IS THERE ANYTHING YOU'D LIKE TO TALK ABOUT?

People occasionally require assurance that it's okay to bring up difficult topics. By inviting them to do so, you can change the topic of the conversation from trivial to important issues.

But don't force them to talk about the issue if they seem uninterested in discussing about anything. Simply let them know you're available to listen if they ever want to speak about it in the future.

## 5. DO YOU FEEL COMFORTABLE TALKING TO SOMEONE?

Your loved one may be hesitant to talk to a therapist. Asking them in a nonjudgmental manner if they'd consider seeking professional help might persuade them to do so.

Talking about therapy as a viable option may at the very least help them become

open to the concept if they haven't been considering it.

Talking about this idea may also show that there is no reason to feel ashamed about visiting a therapist. If they indicate a desire to receive help, you can offer to take them or to assist them in making an appointment.

Reminding the person that they can talk to an online therapist might also be useful. Many people perceive online counseling as less threatening than face to face counseling.

## 6. HOW CAN I HELP YOU?

When you have a mental health issue, simple chores become much more challenging. Someone who is having a hard time feeling good would appreciate your help. Help can take many different forms, from getting groceries to providing emotional support through regular video calls.

However, if they are unsure of what they require, don't be shocked. Offer particular assistance if you observe something that could be useful, such as, "Can I assist you today with some household tasks?"

## 7. WHEN WOULD BE THE MOST IDEAL TIME TO CONTACT YOU ONCE MORE?

Don't force your presence in somebody's life by saying, "I'm going to call you several times a day simply to make sure you're OK". Over-involving yourself in someone's life will probably make them want to avoid you.

However, you can ask and let them know that you'd like to speak with them again. Find out when they would like you to call them or contact them by asking them about it. Its okay if they want you to text them today evening or see them in a few weeks. Just follow through and do what you claim you're going to do to show that you're sincere.

# How Much For an Ideal Life?

Money can't buy happiness. Many of us are told this at some point in our lives, but that doesn't seem to stop many people from wanting more of it – even very rich people. The question is, how much money do we each need to satisfy our desires?

Economists often treat people as having unlimited economic wants but limited resources to satisfy them – a foundational economic concept known as scarcity. This idea is often presented as a basic fact about human nature. Our recently published research found instead that only a minority of people actually have unlimited wants, and that most would be happy with a limited, if still significant, sum of money.

We surveyed people about this issue in 33 countries spanning all inhabited continents, obtaining responses from about 8,000 people in total. We encouraged participants to focus on what it would mean to have all their wants fulfilled by asking them to imagine their "absolutely ideal life", without worrying about whether it was realistically achievable.

To assess economic wants, we asked people to consider how much money they wanted in this ideal life. But money rarely comes for free, and we

thought their responses could be influenced by what they imagine it would take to obtain large amounts of money – working long hours, high-risk investments, or even criminality.

So we made it about chance, by asking them to choose a prize in a hypothetical lottery. They were told the chances of winning each lottery were the same so their choice was about how much money they wanted in their ideal lives, not which lottery they were most likely to win.

The lottery prizes started at US\$10,000 (converted to local currencies, so £8,000 for UK participants) with options increasing by a multiple of 10. At the time we ran the study, the top prize of US\$100 billion would have made them the richest person in the world.

## WHO WANTS TO BE A BILLIONAIRE?

Our prediction was straightforward: if people truly have unlimited wants, they should always choose the maximum US\$100 billion. But in all 33 countries, only a minority chose the top prize (8% to 39% in each country). In most countries, including the UK, the majority of people chose a lottery equivalent to US\$10 million or less, and in some countries (India, Russia) the majority even chose US\$1 million or less.

We also wanted to understand differences be-

tween people with limited and unlimited wants. Our analyses ruled out many personal factors – responses didn't vary meaningfully by gender, education, or socioeconomic status. However, more younger people reported unlimited wants than older people, although this varied across countries. In less economically developed countries, the influence of age was weaker.

We also examined cultural differences using an widely used model of major dimensions of cultural difference. We found that more people chose the US\$100 billion lottery in countries where there was greater acceptance of inequality in society (called "power distance"), and where there was more focus on group life (called "collectivism").

For example, Indonesia is high in power distance and collectivism and almost 40% of the Indonesian sample chose US\$100 billion. The UK is relatively low on collectivism and power distance, and fewer than 20% chose the maximum lottery prize.

Finally, we asked people about the most important change they would make if they won the prize, as well as to rank different values that were important to them, such as having power or helping others. Here there was some inconsistency. People with unlimited wants were more likely to tell us they would use the money to help others, but in terms of values they were no more concerned with

helping others than those with limited wants.

## THE CONSEQUENCES OF (UN)LIMITED WANTS

Assuming people have unlimited economic wants provides a rationale for policies that prioritise economic growth, such as interest rate policies, to allow people to achieve as many wants as possible. But the never-ending pursuit of wealth and growth has increasingly damaging consequences for our world.

Showing that unlimited wants is not a human universal, and that the level of people's wants varies with values and culture, suggests they are open to social influence. Advertisers already know this, spending huge amounts to try to convince us to want things we previously neither knew nor cared about. Even some economists have questioned whether wants produced by marketing should really be called wants.

The results of this research give us hope that human nature is not fundamentally at odds with sustainable living. Many are paying more attention to how to improve and even reorient society to live fulfilling lives without exhausting our planet's resources. Understanding the lives and motivations of people with limited economic wants may teach us something about how to achieve this.

## Rift Between Govt, Kerala Govt Widens As CPI(M) Accuses Raj Bhavan Of Making Move To Topple Left Dispensation

**Thiruvananthapuram:** Amid mounting tension between the Kerala government and Governor Arif Mohammad Khan on various issues, the ruling CPI(M) on Thursday alleged that Rajbhavan-based political moves are being made to "topple" the left dispensation.

CPI(M) state secretary Kodyeri Balakrishnan alleged that the RSS has a role in the anti-government moves. "CPI(M) is facing new political challenges (in the state). RSS is working on an agenda for the next three years. Delhi is the centre of such activities. RSS offices are headquarters of this (the anti-government moves)," Balakrishnan alleged at a party function here.

Accusing the Rajbhavan of also playing a role in the "planned move to topple" the LDF government, the senior CPI(M) leader said it would be resisted with the support of the people.

His statement came a day after Kerala Governor Arif Mohammad Khan stayed the controversial appointment of a Malayalam Associate Professor in Kannur University. The CPI(M) is also upset over the Governor's decision not to sign many ordinances.

Several ordinances, including the Kerala Lokayukta (Amendment) Ordinance, issued by the LDF government lapsed on August 8 as Khan had not signed them owing to paucity of time to go through them, sources said.

Meanwhile, the opposition Congress today backed the Governor's move on the Kannur University issue, saying he had acted legally in his capacity as Chancellor.

Chief Minister Pinarayi Vijayan's private secretary K K Ragesh's wife Priya Varghese had been proposed to be appointed as Associate Professor in the Malayalam Department by Kannur University, which triggered a huge political row as she had the lowest research score but the highest in the interview round and was declared as first in the selection process.

Justifying the Governor's action to stay the proposed appointment, Leader of Opposition in the state Assembly V D Satheesan said Khan had actually used his power to prevent the Kannur University's attempt to make an illegal appointment.

A comprehensive probe should be conducted into all similar appointments of close

relatives of ruling party leaders allegedly made in other universities across the state during the past six years, he demanded.

The senior Congress leader reiterated his charge that faculty posts in state universities are 'reserved' for the relatives of the CPI (M) leaders.

"Justice has been denied to deserving persons (job aspirants) openly. The same has happened in the past six years as well. The Governor should take steps to investigate and cancel all such appointments," Satheesan told reporters here.

Noting that as per the law passed by the state Assembly, the Governor has the power to cancel illegal appointments made in universities, he said the opposition would definitely oppose his actions if he acted against law.

The university's decision to approach the court against the Governor's action is to restore justice, he further alleged and said if they do so, the Congress-led UDF would also seek legal recourse to ensure that such violations don't take place again in the southern state.

Earlier, Balakrishnan in an article on CPI(M) mouthpiece "Deshabhimani" made a scathing attack against the Governor, saying that the BJP-led government at the Centre was trying to put the Left government in a dilemma using Khan.

In a detailed article, Balakrishnan charged the Governor with acting as a 'tool' of the Narendra Modi government and the BJP.

The senior Marxist leader pointed out that as per rules of the parliamentary democratic system of the country, the President and the Governor should act in accordance with the advice of the union and the state cabinets respectively.

On Wednesday, Khan, in his capacity as Chancellor of universities in the state, stayed the proposed appointment of Associate Professor in the Department of Malayalam in Kannur University.

He also invoked provisions of the Kannur University Act and issued show-cause notices to all the stakeholders.

The Governor's decision came shortly after he told mediapersons to wait for 30 minutes to know what had happened regarding the controversial proposed appointment of the wife of a Left leader in the varsity's Malayalam department.

## DGPs Should Keep Watch On Demographic Changes In Border Areas: Amit Shah

**New Delhi:** Union Home Minister Amit Shah on Thursday said police chiefs of border states should keep a watchful eye on the demographic changes taking place in the border areas.

Shah was addressing the National Security Strategies (NSS) Conference 2022, which was attended by the top brass of the country's police forces.

The two-day conference held in Delhi discussed subjects like cryptocurrency, counter-drone technology, cyber and social media surveillance, emerging challenges due to 5G, demographic changes and growing radicalisation in border areas.

Shah said it was the responsibility of the director generals of police (DGPs) to gather all technical and strategic information in their states, especially in the border districts.

The DGPs of border states should keep a watchful eye on the demographic changes taking place in border areas, he said.

The home minister further said that since becoming the prime minister in 2014, Narendra Modi has not only given a thrust to internal security of the country but has also strengthened the mechanism to face challenges.

He said states should give top priority to the issues related to national security as this is the fight for the future of the country and the youth, for which everyone has to come together and win at any cost.

Shah added that in the field of internal security, the government has achieved greater success in dealing with terrorism in Jammu and Kashmir, various extremist groups in the north-east and Left Wing Extremism.

Under Modi's leadership, the central government has enacted many new laws, increased coordination with states, increased budgetary allocations and made optimum use of technology, he said.

"The prime minister has tried to change the nature of the DGP conference since 2014, and we see that we have been successful in finding solutions to many problems," the Union home minister said.

Shah said a system has been developed for the first time in the country in the form of the National Automatic Fingerprint Identification System (NAFIS) and it should percolate down to the grassroots level.

Referring to the problems of circulation of narcotics, he said it was not enough to just catch a consignment since the complete uprooting of the drugs network and getting to the

bottom of its source and destination are of utmost necessity.

The home minister said the central government was preparing a database of different types of crimes, and for the first time, with a scientific approach, so much work has been done on so many fronts simultaneously.

"We have to make good use of 5G technology to strengthen the security system," he said.

Shah said the basic principle of a modern intelligence agency should not be "need to know" but "need to share" and "duty to share", because no success will come unless the approach changes.

"Along with technology, we should also give equal thrust to the use of human intelligence," he said, adding this conference helps young officers gather in-depth knowledge on issues of national security.

The home minister said the sessions selected for deliberation in the last two days were relevant and important, and discussions were held on counter-terrorism and counter-radicalisation, challenges of Maoist underground and front organisations, cryptocurrency, counter-drone technology, cyber and social media surveillance, protection of islands, emerging challenges due to 5G, demographic changes and growing radicalisation in border areas.

## Govt Hikes Windfall Profit Tax On Export Of Diesel; Cuts Tax On Domestic Crude Oil

**New Delhi:** The government on Thursday hiked the windfall profit tax on the export of diesel to Rs 7 per litre and brought back a tax on jet fuel exports, but slashed the levy on domestically produced crude oil in line with softening rates.

At the third fortnightly review, the government raised the windfall profit tax on the export of diesel to Rs 7 per litre from Rs 5 a litre and brought a Rs 2 a litre tax on ATF exports, a finance ministry notification showed.

Earlier this month, the government had scrapped the windfall profit tax on ATF (Aviation Turbine Fuel) exports. Alongside, the tax on domestically produced crude oil has been cut to Rs 13,000 per tonne from Rs 17,750.

The tax on exports has been raised as cracks or margins rose but the same on domestically produced oil was reduced as international oil prices slid to a six-month low.

India first imposed windfall profit taxes on July 1, joining a growing number of nations that taxes super normal prof-

its of energy companies. But international oil prices have cooled since then, eroding profit margins of both oil producers and refiners.

On July 1, export duties of Rs 6 per litre (USD 12 per barrel) were levied on petrol and ATF and a Rs 13 a litre tax on the export of diesel (USD 26 a barrel). A Rs 23,250 per tonne windfall profit tax on domestic crude production (USD 40 per barrel) was also levied.

Thereafter, in the first fortnightly review on July 20, the

export tax on diesel was cut to Rs 5 a litre and that on ATF scrapped, following a drop in refinery cracks or margins. But the levy on domestically produced crude oil was raised to Rs 17,750 per tonne in line with a marginal increase in international crude prices.

At the third fortnightly review, the taxes on fuel exports has been raised but that on domestically produced crude oil has been cut.

The reduction in taxes earlier this month came as India's trade gap swelled to a record high in July as elevated commodity prices and a weak rupee inflated the country's import bill.

The gap between exports and imports widened to USD 31.02 billion in July from USD 26.18 billion in June. This, as a result of exports falling and elevated commodity prices



together with a weak rupee, are inflating the import bill. Imports jumped 43.59 per cent in July from the year-ago month, while exports dropped 0.76 per cent.

International oil prices have since then slid to below USD 95 per barrel but cracks on diesel and ATF rose.

Industry sources said the government is working on a principle to leave some healthy margins, with both crude oil producers and refiners and taxing gains over and above that.

who fulfils the requirements of registration and is ordinarily residing in the UT of Jammu and Kashmir (owing to any reasons such as profession, studies, posting, etc), can get registered in the Electoral Rolls of Jammu and Kashmir, provided he gets his name deleted from Electoral Roll of his native constituency, as registration at two places is not permitted under law.

"It is worthwhile to mention here that, even prior to abrogation of Article 370, these people were eligible to get registered in the Electoral Rolls, if they were ordinarily residing in any of Assembly Segments of Jammu and Kashmir, but had the right to vote only in Parliamentary Elections and were categorized as Non Permanent Resident (NPR) voters," they said.

Giving reference of the last Parliamentary Elections held in J&K, the officials said that there were approximately 32000 such NPR voters. "The Procedure for getting registered in the Electoral Roll involves filing of Form-6 by the eligible person, which contains complete details of the applicant including his family trail. There are specified documents prescribed by the Commission which are to be submitted as proof of residence as well as proof of age," they said.

On receipt of any such documents along with requisite documents, he said, a Booth Level Officer, BLO (who happens to be a local officer of the polling area), is appointed by the Electoral Registration Officer (ERO), who conducts a detailed physical verification of the particulars mentioned in the Form 6, and submits his report.

The officials further said that it is based on the documents as well as the report of the BLO, the concerned ERO, if satisfied, grants registration to an applicant. Further, as a counter-check, there is also a provision in law to object to the inclusion of any name in the electoral roll through Form-7, by any elector of the concerned constituency.

"Thus there are multiple statutory safeguards existing in the present system against inclusion of an in-eligible person in the Electoral Roll," officials emphasised.

About the Kashmiri migrants, the officials said that there is no change in the provisions for their registration which the media was briefed about from last to many elections.

"They have the special provision of getting registered in the electoral rolls of their native (prior to their migration) assembly segments, though residing outside. For their facilitation, three AERO (Migrants) are designated, at Jammu, Udhampur and Delhi. Every SSR special camps are organized at the camps where these migrants are putting up," they added.

Regarding the members belonging to Armed Forces, including Army, BSF, CRPF, the officials said, it was told that there already exists a provision for them to get registered as Service Voters for their native Assembly Constituency and avail the facility of Electronically Transferred Postal Ballot System (ETPBS).

"However, for the Armed Forces personnel who are posted at Peace Stations there is an additional option available to get registered as a General Elector at the peace station," officials added.

### Dr Farooq Calls

Abdullah requested the leaders to attend the meeting to formulate a common position on the issue of the inclusion of non-local voters, the statement said.

Pertinently, the PDP president had earlier in the day said that she contacted Dr Farooq and asked him to call an APM over the issue.

Addressing a presser at her Gupkar residence here, Mehbooba said that, "Decisions are not being taken in the interests of the nation, but in the interests of BJP. We have been witnessing how the elections are being rigged everywhere in the country, even before and after the elections as well. The BJP is not going to change the country into Hindu Rashtra, but in BJP Rashtra," she said, adding that the way Article 370 was removed unconstitutionally and Indian constitution was subverted, it is all in the interests of BJP as after the decision, the party sold J&K plot in rest of the country.

"Despite spending a hefty amount for deradicalization, the decisions are being taken that will certainly radicalize the youth. The government cannot change the ground reality, but it needs to resolve the issue once and for all," she said.

"It's not about the legality but about the intentions behind it. The government is not following any rule," she said when asked about the voting rights of non-locals.

At a press conference on Wednesday, Jammu and Kashmir's Chief Electoral Officer (CEO) Hirdesh Kumar said the

Union Territory is likely to get around 25 lakh additional voters, including outsiders, after the special summary revision of electoral rolls being held for the first time after the abrogation of Article 370.

Bairstow went into the match in incredible form, having averaged 76.46 in 2022 with six centuries, but he was brought down to earth here, bowled for a duck by Nortje. Pope did his best to rectify matters but received precious little support as England went into the early tea break at 116-6 and did not re-emerge due to the weather.

Donning the blue jersey for the first time in six months after a long injury lay-off, Chahar hit the straps right away with

figures of 3/27, which was instrumental in India restricting Zimbabwe to a sub-par 189 in just 40.3 overs. With very little scoreboard pressure, it was a walk in the park for the Indians as the in-form opening pair of Shikhar Dhawan (81 not out) and Shubman Gill (82 not out) knocked off the target in just 30.5 overs. Prasidh Krishna (3/50) and Axar Patel (3/24) also got their share of middle and lower-

order victims while Kuldeep Yadav (0/36) was restrictive despite going wicket-less. It was the record ninth-wicket stand of 70 runs between Brad Evans (33) and Richard Ngarava (32) that took Zimbabwe close to the 200-run mark. None of the Zimbabwe batters looked comfortable during those opening overs as Chahar got a lot of deliveries to dart back late while some straightened after pitching.

## SC Stops CoA From Taking Over IOA

**NEW DELHI:** In an interim relief, the Supreme Court on Thursday ordered the status quo and said the Delhi High Court-appointed three-member Committee of Administrators (CoA) will not take over the affairs of the Indian Olympic Association. A bench comprising Chief Justice N V Ramana and C T Ravikumar took note of the submissions of Solicitor General Tushar Mehta, appearing for the Centre and the IOA, that the world sports body does not recognise any unelected bodies like the CoA and consequently, India may be barred from taking part in international sports events. "We direct the parties to maintain the status quo. It is made clear that the charge is not handed over to the CoA. We direct the matter to be listed before an appropriate bench on Monday (August 22)," the bench said in its order. Consequently, the Delhi High Court-appointed CoA, comprising former Supreme Court judge Justice Anil R Dave, former Chief Election Commissioner S Y Quraishi, and former Secretary of Ministry of External Affairs Vikas Swarup, will not be able to take IOA over.



## Barcelona Looks To Rebound After Early Setback

**MADRID:** The expectations were high for Barcelona coming into the new season. The club's financial maneuvers allowed for some high-profile signings that significantly boosted the squad after a trophyless campaign without Lionel Messi. Barcelona was back in its place, seen as a reference in world soccer again, Laporta boasted a few days before the league opener. But it didn't take long for the hype to turn into more disappointment, and the Catalan club enters the second week of the season reeling and looking for ways to rebound. Another setback in a tough visit to Real Sociedad on Sunday could leave the club in a deep hole early on. Laporta was not able to register all the new signings as he

had expected ahead of the opener, and on the field the team struggled yet again, beginning its league campaign with a 0-0 home draw against Rayo Vallecano at the newly renamed Spotify Camp Nou. To make it worse, Barcelona's closest rivals all won their openers, with defending champion Real Madrid defeating promoted Almeria and Atletico Madrid routing Getafe, both in away matches. It won't help that Barcelona will have to face Sociedad without veteran midfielder Sergio Busquets, who was sent off in stoppage time against Rayo. It was also unclear if newly signed defender Jules Kounde would be allowed to be registered in time. Of the team's top signings, only Robert Lewandowski and Raphinha were added to the squad ahead of the opener. (AP)

## Chelsea Investigates Incident Of Alleged Racist Abuse

Tottenham forward Son Heung-min was reportedly abused by a supporter while he took a corner during the second half of the 2-2 draw on Sunday.



"If identified, this individual will face the strongest action from the club," Chelsea said of the supporter.

## World Cup Ticket Sales Top 2.45 Million

**ZURICH:** World Cup ticket sales have reached 2.45 million, FIFA said Thursday, with more than 500,000 seats still available three months before the tournament starts in Qatar. FIFA said 520,000 tickets were bought in a first-come, first-served phase of sales that closed this week. Brazil's games against Serbia and Cameroon were among the most in-demand. The top 10 places ranked by ticket sales to their residents include Qatar and neighboring countries Saudi Arabia and the United Arab Emirates. The United States, England, Mexico, France, Argentina, Brazil and Germany are also on the list released by FIFA. The cheapest tickets for fans from outside Qatar are priced at 250 riyals (\$69). Fans need a confirmed ticket purchase to book places to stay in Qatar through an official tournament website. The 64-game tournament in eight stadiums in and around Doha starts on Nov. 20 and has a total capacity of about 3 million tickets. About 2 million tickets were placed on general sale and 1 million were allocated for FIFA stakeholders such as member federations, sponsors and broadcasters, plus hospitality programs. FIFA previously said it got 3 million ticket requests for the World Cup final on Dec. 18 — Qatar's national day — at the new 80,000-seat Lusail Stadium. Tickets sales are now paused with FIFA promising an update in late-September about the last round of selling that runs through the tournament. More seats typically become available as stakeholders return some of their allocation, and during the World Cup from fans of teams that are eliminated. (AP)
