Waqf Board Mulls Revised Rent Agreements

'Decision Taken In 4th Board Meeting Last Month, Agreement To Be Revised As Per Recommendations Of Rent Review Committee Of 2015-2016'

Srinagar: After removing the Mujavirs and their donation boxes from the shrines across Kashmir Valley, the Jammu and Kashmir Waqf board is now mulling revision of the rates of their properties across the Union Territory as per recommendations of Rent Review Committee of 2015-2016.

Official sources within the

Waqf said that many shopkeepers holding the Waqf properties are still paying a meager amount as monthly rent for the shops, fixed by the authorities decades ago.

"The rates were increased by 120 per cent on April 01, 2018, but still the rent is meager," they said, adding that there is no fixed rent for all the shops and other establishments as the rates vary from place to place.

They further informed that the authorities have now decided to revise the rent agreement of shops and other establishments More on P6

REVISION OF JAMMU AND KASHMIR ELECTORAL ROLLS

- Summary revision of electoral rolls are undertaken by Election Commission from time to time according to laid down process. This is to enable young persons who become eligible to register themselves as voters. Besides, it also allows a person who has changed his ordinary place of residence to enrol at new location by getting himself deleted at the old location.
- Number of Electors as published in Special 2 Summary Revision of J&K State in 2011 was 66,00,921; and number of electors as on today in the electoral roll of J&K UT is 76,02,397. This increase is mainly due to the new voters, who attained the age of 18 years.
- There have been media reports that more than 25 3 lakh additions will be there in the electoral rolls once the process of electoral roll revision starts.

This is a misrepresentation of facts, which is being spread by the vested interests. This revision of electoral rolls will cover existing residents of the UT of J&K and increase in numbers will be of the voters who have attained the age of 18 years as on 1.10.2022 or earlier.

- There is no change in the special provisions for 4 Kashmiri migrants for their enrolment in the electoral rolls of their original native constituencies. They will continue to be given option of voting at their place of enrolment or through postal ballot or through for specially setup polling stations at Jammu, Udhampur, Delhi, etc.
- It is further clarified that there is no change in 5 rules regarding buying of property and jobs in the Government of UT of J&K and have no link to representation of voters or otherwise.

Does Entitlement Make You More Likely To Cheat?

hy do people cheat? An intriguing study by two Israeli researchers in 2016 put forward a possible reason that has since become well established in the scientific literature and popular media.

The researchers reported a series of experiments apparently showing that people told they have won a skill-based competition, such as a visual task, subsequently cheat more than others in games of chance, such as dice games. The proposed explanation was that winners experienced a sense of entitlement that induced them to cheat.

The paper has been highly cited by other researchers. One scientific comment paper even pointed out its significance in the light of tax evasion costing governments US\$3.1 trillion (2.6 trillion) annually.

But does the finding hold up to scientific scrutiny? We decided to replicate the study and investigate more closely the reasons why people do or don't cheat.

Our new study, published in Royal Society Open Science, failed twice to replicate the original finding. We found that the original experiments were statistically underpowered, meaning they used far too few experimental participants (43 in their main experiment) to sustain the conclusions that were drawn.

There were also problems of experimental design and methodology, notably a failure to randomly decide which participants were winners, losers, or part of a control group that weren't told how they had done in the skill-based competition.

We began by replicating the original research as closely as possible, but in a large-scale experiment (252 participants) to achieve adequate statistical power. We also assigned participants randomly to conditions.

To assign winners and losers, we used the perceptual judgement test used in the original experiment. The test involves the difficult task of estimating which of several different symbols is the most numerous in briefly displayed slides similar to the one shown below.

We put the participants in pairs and told them whether they had a better or worse score than their partner in the skill task. They were then put in new pairs and played a game of chance. The pairs then played a game of chance, also identical to the game in the original research. This involved rolling two dice under an inverted cup and then peeking through a spyhole in its base to see the result.

The players were told to help themselves to money from an envelope provided depending on what numbers the dice showed 25 pence for each dice spot. While it was impossible to tell who in particular cheated, collecting much significantly more than the average amount was evidence of cheating.

We also assigned one-third of the participants to a control group. They were not told whether or not they had beaten their partner in the visual task before playing the the dice game.

Comparing the results to what we'd expect to happen by chance, a small but statistically significant amount of cheating seemed to have occurred, as in the original Israeli experiment. But our results showed no evidence that winning (or losing) had any statistically significant effect whatsoever on cheating, as can be seen in the graph below, where the dotted line shows the value expected by chance, without cheating.

We also ran an even larger online experiment (275 participants) in which we assigned participants randomly to be winners, losers or control participants using the same perceptual test as before.

In this experiment, each participant tossed a coin ten

times and claimed rewards (Amazon gift vouchers) depending on how many heads they tossed. The results were almost identical to our first experiment: we found a similar level of cheating and no evidence of any effect of winning or losing on subsequent cheating.

We used standardised psychometric tests designed to measure differences between people that might influence cheating, including a sense of entitlement, self-confidence, belief in personal luck, and a few other factors. But only one, turned out to be statistically significant in all treatment conditions.

Participants who dislike inequality cheated less than others. This is presumably because they had a stronger sense of fairness and considered cheating unfair. A sense of entitlement, on the other hand, was not significantly associated with cheating in any condition.

Ultimately, what makes some people cheat more than others is not fully understood. But our research suggests people's feelings about inequality is one part of the explanation. There are also momentary circumstantial factors that encourage some people, but not others, to cheat.

BCG Vaccine For Tuberculosis Protects Diabetics From Covid-19: Study

A widely used tuberculosis vaccine protected people with Type 1 diabetes from COVID-19, according to a study that demonstrates the potential of multiple doses of the Bacillus Calmette-Guerin (BCG) preventive against SARS-CoV-2 and other viruses. The study, published in the journal Cell Reports Medicine on Monday, was conducted on 144 patients with type 1 diabetes at the start of the pandemic, much before COVID-specific vaccines were available.

Researchers at Massachusetts General Hospital (MGH) in the US found that 12.5 per cent of placebo-treated individuals and 1 per cent of BCG-treated individuals had confirmed COVID-19, yielding a vaccine effectiveness of 92 per cent.

The BCG-vaccinated group also displayed protective effects against other infectious diseases, including fewer symptoms, lesser severity and fewer infectious disease events per patient.

will pave the way for a large scale study of the effects of the BCG vaccine in patients with type 1 diabetes, considered among the most vulnerable groups to COVID-19.

The BCG vaccine is an avirulent tuberculosis strain Mycobacterium bovis historically given to protect against tuberculosis and, since its introduction in 1921, has been the most widely administered vaccine in the history of medicine. Considered to be extremely safe, BCG is on the World Health Organization's List of Essential Medicines and is given to roughly 100 million children per year globally, the researchers said. BCG is also one of the most affordable medicines, costing less than a dollar a dose in many parts of the world, they "Multiple studies have shown that adults with type 1 diabetes who are diagnosed with COVID-19 are at increased risk of severe illness," said Denise Faustman, director of the Immunobiology Laboratory at MGH. "We found that three doses of BCG

"We found that three doses of BCG administered prior to the start of the pandemic prevented infection and limited severe symptoms from CO-VID-19 and other infectious diseases," Faustman said. The researchers noted that unlike the antigen-specific vaccines currently in use to prevent COVID-19, BCG's mechanism of action is not limited to a specific virus or infection. The participants in the COVID trial had previously enrolled in a clinical trial

testing the effectiveness of the BCG vaccine for type 1 diabetes.

Participants in the test group had received multiple vaccinations prior to the onset of the pandemic in early 2020.

"This data set is unique and exciting because the patients were all vaccinated with multiple doses of BCG prior to the onset of the epidemic," said Hazel Dockrell, from London School of Hygiene & Tropical Medicine, who was not involved in the study.

"Prior to the trial they had no known exposure to tuberculosis or prior BCG vaccination. This eliminates the major confounding factors that have limited other trials," Dockrell said.

The results support the idea that BCG needs time to have a clinical effect, but its effects may then be very lasting and durable, the researchers said. The 144 adult type diabetics (96 BCG treated and 48 placebo) analysed in the COVID-19 trial were part of an ongoing Phase IIb clinical trial testing BCG as a treatment for adults with established type 1 diabetes. Patients were followed for COVID-19 related outcomes for 15 months, the

'Smoking, Alcohol, High BMI Main Causes Of Global Cancer Deaths'

Smoking, alcohol use, high body mass index (BMI), and other known risk factors were responsible for nearly 4.45 million global cancer deaths in 2019, according to study published in The Lancet journal on Friday.

The findings can help policymakers and researchers identify key risk factors that could be targeted in efforts to reduce deaths and ill health from cancer regionally, nationally, and globally.

"This study illustrates that the burden of cancer remains an important public health challenge that is growing in magnitude around the world," said Christopher Murray, Director of the Institute for Health Metrics and Evaluation (IHME) at the University of Washington, US.

"Smoking continues to be the leading risk factor for cancer globally, with other substantial contributors to cancer burden varying," said Murray, a co-senior author of the study.

Using results from the Global Burden of Diseases, Injuries, and Risk Factors (GBD) 2019 study, the researchers investigated how 34 behavioural, metabolic, and environmental and occupational risk factors contributed to deaths and ill health due to 23 cancer types in 2019.

No BCG-related systemic adverse events occurred, according to the re-searchers.

BCG's broad-based infection protection suggests that, in addition to CO-VID-19, the vaccine may potentially provide protection against new SARS-CoV-2 variants and other pathogens, they said.

The researchers are hoping the results

Changes in cancer burden between 2010 and 2019 due to risk factors were also assessed.

Estimates of cancer burden were based on mortality and disability-adjusted life-years (DALYs), a measure of years of life lost to death and years lived with disability.

In addition to 4.45 million cancer deaths which made up 44.4 per cent of all cancer deaths in 2019, risk factors included in the analysis accounted for 105 million cancer DALYs globally for both sexes in 2019 - 42.0 per cent of all DALYs in that year, the researchers said.

Behavioural risk factors such as tobacco use, alcohol use, unsafe sex, and dietary risks were responsible for the vast majority of cancer burden globally, accounting for 3.7 million deaths and 87.8 million DALYs in 2019, they said.

The study shows that almost 2.88 million deaths in men (50.6 per cent of all male cancer deaths) could be attributed to the risk factors studied, compared to 1.58 million deaths in women (36.3 per cent of all female cancer deaths).

The leading risk factors globally for cancer deaths and ill health for both sexes were smoking, followed by alcohol use and high BMI, the researchers said.

Dal Weeds To Be Converted Into Biogas, Fertilizer

Srinagar: With excessive growth of obnoxious weeds hampering the beauty of the famed Dal Lake, the government has decided to commercialize weeds by converting them into biogas and fertilizer.

The unbridled growth of obnoxious weeds is giving ugly look to the picturesque Dal Lake.

"Around 2.5 lakh cubic

Presently, several harvesting machines are operating removing weeds from Dal Lake. The weeds are also being removed manually by people then dumped at several places

for rot. Experts believe that around 40,000-50,000 tons of material, including silt and nutrients, are added annually to the lake boosting the growth of weeds. The official believes

that sewage flowing into



meters of weeds are being removed from the Dal Lake annually and we can avail full advantage by commercialization of weeds," a senior official of Lakes and **Conservative Management** Authority (LCMA) said.

"The conversion of weeds into fertilizer and biogas would prove futile for the economy of Kashmir. On one hand, we can clean the lake while on the other hand we would benefit from it," the official said.

Sources said LCMA has signed an agreement with NAFED for 96 kanals for a period of 26 years, for the construction, operation and management of the disposal facility on the scheduled lease rent.

He said there are enormous nutrients like phosphate, methane in weeds, which are ideal for biogas and fertilizer purposes.

"There is a huge raw material of weeds available here and people can easily convert it for biogas and fertilizer purposes,' he opined.



IAF May Launch Air Strikes In Kupwara

RINAGAR- (AP) The higher authorities in India have given a green signal to the Indian Air Force to undertake ombardment of those areas in border sector of Kupwara in northwest of Kashmir Valley where hard-core mili-tants have been concentrating in a large number and have also struck at the army camps at least three times during the last three weeks

The army may launch helicopter gunship strikes against foreign mercenaries in Kupwara forests from where they have been targeting army camps," a report from New Delhi said Thursday

Indian Prime Minister Atal Bihari Vajpayee, however, has been a little reluctant to allow such extreme measures fearing that a large chunk of civilian population in the area might also be adversely affected. 'This is a very difficult task at hand which would require better skills than applied in the uninhabited mountainous Kargil-Drass sectors," Defence Ministry source said here Thursday. In Kupwara border district about one dozen places are having fighters hiding in the forests and upper reaches where even the army patrolling has been a difficult task in view of difficult terrain and mountain passes

The places where militants are hiding include Lolab. Nowgam, Handwara, Bungus, Rajwar, Trihgam, Keegam and Chekibal, all of them very close to line of control and covered by thick jungles.

The defence sources said further that in recent weeks the fighters, all of them of foreign origin, have played havoc with the Indian forces with two senior officers and about one dozen soldiers killed in three attacks mounted right on their camps, an activity unheard so far in the militancy-affected Kashmir Valley.

At the same time, the Indian Defence Ministry high-ups have taken strong exception of what Chief Minister Farooq Abdullah said here Wednesday what he alleged that it was due to weak defence system that militants were sneaking into Indian territory in thousands.

Official circles in New Delhi believe that it was yet another political gimmick of Farooq Abdullah who has failed on all fronts of public service and has brought the State of Jammu and Kashmir on the brink of financial disaster due to his government's rampant corruption and nepotism and favouritism. An army commander of the victor force, however, said

here that Kupwara border sector shall be taken care of fully so that there is no repetition of recent attacks on the Indian forces which sent shock waves among the rank and file of the forces.

Price Control

he state government is likely to frame a monitoring cell to keep vigil over the rates and promises that the rates of vegetables, which have been skyrocketing over the recent past, would come down within a week. The Consumer Affairs and Public Distribution depart-ment has said the rates of various essential commodities would be checked by keeping a strict vigil and ensuring that the prescribed rates are strictly adhered to. According to the reports, the rates of various vegetables in the state had gone up around six times over the past couple of weeks and people are miffed at the indifferent attitude of the government. The fluid situation is reported to have come as a boon to black marketers who are selling the mass consumption items at a high premium. And, there is no uniformity in the prices in that tomatoes sell at something between Rs 30 and Rs 60 a kg. Even as the alarm bells have been sounded in Jammu, the scenario in the summer capital, Srinagar, is reported to be worse, with the administration officials in deep slumber. Prices are soaring by the day not only of vegetables but of every other commodity or service as well. Mutton is selling at Rs 150 a kg although its official rate is believed to be just Rs 125. Unlike Jammu, the CAPD officials in Kashmir are conspicuous by their absence not only from city markets, but from all the towns and rural areas as well. Indeed, it is not for the first time that they have left millions of hapless consumers to the rs, perhaps as a policy for the o ipulous trad reasons. The director of the department is also believed to be the price controller for his area. Interestingly, however, majority of the consumers might not even know him, save for having seen him on an odd television show. Price control has been a nagging headache not so much for the state government as it has been for a vast multitude of people who find themselves helplessly sandwiched between the inert administration and unscrupulous traders. The law enforcing agencies do indeed show up periodically, particularly around some festival, to go round various markets not necessarily to book the economic offenders but allegedly to claim their pound of mutton with a quick buck to the boot. Come Eid, people watch the officials from the magistracy, police, weights and measures, and of course, the CAPD, checking the price lists, making queries from buyers and even taking some odd trader into custody. Immediately after the festivities are over, the law enforcing officials vanish from the scene like the proverbial horns from a donkey's head. What follows is common knowledge. It is a free for all for hoarders and profiteers who spare no meanness to fleece the hapless consumers even by precipitating an artificial scarcity. Even as the government has re-christened the erstwhile department of food and supplies as consumer affairs and public distribution department, ostensibly to make it into an effective tool for protection of consumer rights, the measure has miserably failed to create any impact on market behaviour. Whether it happens to be a commodity or a service, the consumer are fleeced with gay abandon by their providers. The key government outfit has proved to be incapable of even taking note of the adverse media reports highlighting the economic offences almost daily. The general apathy of the state government towards protection of consumer rights can be gauged by the fact that it has failed even to find the presiding officer for its consumer commission although the all important position has been vacant for several months now, reportedly for some regional considerations. Now that the government mulls constitution of monitoring cells to keep an eye on prices of essential commodities, it would be well advised to bring within their purview all sorts of commercially sold products and services, including passenger transport, cable service, water and power supply. One of the key ingredients in the proposed steps could well be the department of consumer affairs and public distribution itself which has been in need for a thorough revamp for quite some time now. Unless you have a well oiled apparatus armed with sufficient powers, equipped with the required wherewithal and manned with determined and motivated staff, the monitoring cells can be of no avail. And, the efforts of the department have not to be of a seasonal nature but, instead, have to be sustained in a manner that a perpetual awe is generated among the providers of various commodities and services, who over the decades have developed vested interests and even grown into mafias. Obviously, the government, which is never tired of holding out tall promises to provide good governance to people, should attach high priority to keep the market under a tight leash, more so as a pre-requisite to protect the consumer rights.

ilitants have struck in the Kashmir Valley once again. On Tuesday, they gunned down a Kashmiri Pandit and injured another member of the community. It seems that as soon as things appear to be improving for the few Pandits remaining in the Valley, things take a turn for the worse.

The numbers of Kashmiri Pandits started dwindling with the large-scale conversion of the population to Islam around the 13th century. Kashmiri is the mother tongue of both Hindus and Muslims from the Valley. The two communities have much in common in terms of eating habits, dress code and cultural heritage.

The survival of the community after these conversions depended on the whims of the rulers – the Mughals (1580-1750) and Afghans (1752-1819). The community appealed to Sikh Guru Tegh Bahadur in 1675 and Maharaja Ranjit Singh in the early 19th century to save them from becoming extinct in the Valley. The Dogra regime (1846 to 1947) is seen as a good period for the community when its members used education to improve their status vis-avis the Muslims. Many left the Valley for better opportunities and a large section of those who stayed back became professionals and got government jobs.

In 1948, the community comprised 8 per cent of the state's population. After the Land Reforms Act was initiated by the Sheikh Abdullah government, Pandit landowners lost their land and migrated. By 1981, their population in the Valley had come down to only 5 per cent.

The exodus in the 1990s was a result of the targeted killings of Pandits. An estimated 1,00,000 Pandits left the Valley under very difficult circumstances. However, Kashmiri Pandits were not the only community to be targeted by militants. According to information accessed by an RTI activist (IE, December 15, 2021), 89 Pandits have been killed by militants while 1,635 persons of other faiths have also lost their lives since 1990. These figures could be disputed but the fact is that both Muslims and Pandits suffered at the hands of militants. However, the killing of Kashmiri Pandits got greater media coverage. Of course, the fear is much greater among the minorities. This led to mass migration, bringing down their popu-

lation to less than 1 per cent in the Valley.

In 2010, as per government figures, there were only 808 Pandit families – 3,445 people in all — in the Valley. Several initiatives to attract Pandit families back to the Valley did not succeed. A Rs 1,168- crore package in 2008 by the UPA government couldn't draw even 2,000 youths from the community to return to the Valley. The recently-released film, Kashmir Files, seems to have made the life of the Pandits living in the Valley even more difficult. There seems to be a feeling amongst Muslims that they are blamed for what happened in 1990 when everybody suffered.

With the state under Central rule since August 5, 2019, it was hoped that things would improve for the Pandits. However, in the last few months, the problems seem to have increased for those who have chosen to be there. The killings of innocent people have petrified the community and there is a sense of demoralisation amongst them, especially because the militants who commit dastardly crimes manage to escape.

The empathy of Muslim neighbours is, no doubt, heartwarming. But the volatile political situation and the sporadic but continuous killings of Hindus since 2019 — including Bihari labourers — have increased the insecurity of Kashmiri Pandits. The tourist season this year has been exceptionally good with those involved in the industry doing well. There has been no attempt to disrupt it, indicating that the separatists do not want to antagonise the locals. Only a handful of persons have bought land in the UT after the abrogation of Article 370, and that's confined mainly to areas closer to Jammu province.

For a Kashmiri Pandit like me who continues to have an intimate and affectionate relationship with the Valley and its people — this includes Gauri Kaul Foundation's healthcare initiatives — these killings are worrying. The local population's encouragement, along with my strong Kashmiri roots, gives our group the confidence to quietly continue our mission to provide good healthcare. But we realise that these contributions are no solution to the vexed problem of the Pandits. Normal life remains a distant dream for them.

The T in Exploitation

OO often, as the government fails to accommodate all into the government sector, educated youth throng the private sector. In Jammu and Kashmir, one of the largest private sector employers are the private schools. Thousands of teachers are working in these schools. Every school tries to hire those among the best qualified vouth to make the teaching learning process in their institutions a success, They look for teachers who will cater and mutate according to the modern trends in the education sector and address the challenges of the ever growing competition. They look for those teachers who will satiate the knowledge thirst of the modern day students.

However, their quest is too often unethical. Job advertisements in Private schools are a symbolic fest that often tell the story in a glance. The "Qualifications" and "Experience" column against each teaching opening is written in bold letters, whereas, the "Salary" column is left ambiguous with an apparently generous "Pay is Negotiable". Honestly, the Ad reads like a PR of the school, hiring only the best. However, for the wise, it is a manifesto of exploitation.

All of us know the untold story of this "negotiable pay". The teachers have to undergo rounds of interviews and have to take oaths to follow terms and conditions of the institution to the T. However, god forbid, if the aspirant wants to discuss the specifics of the salary arrangement! They are told that they shall be put on probation for a month or more for a meager salary, until they prove their worth. A "suitable" salary is promised afterwards.

What is the suitable pay for a teacher who is to join a private school? A skilled labour earns at



least Rs 25000-30000 per month and a non skilled labour earns a monthly sum of Rs 15000- 20000.Skilled labours who have their own machinery and equipment earn more than the already stated figures. It is a known fact that the salary in most of the private schools does not even touch Rs 15000. There are many private schools where the salary of teachers is below Rs 5000. Many reputed schools are paying a salary to their teachers that puts a question mark on their name and fame. Despite having huge earnings and emptying the pockets of parents they pay only peanuts to the teachers. These helpless teachers neither have the provision of yearly increments nor are they provided any considerable hike on account of good performance. It is a sisyphean loop of hard work for empty appreciation. If anyone objects, they're deemed disposable and dismissed at the first instance

of protest. Behind every educated and qualified youth there is the blood, sweat and tears of their family. In lower middle class and middle class families, education is considered an investment. It is expected that a saviour is nurtured through quality education, who would grow on to shoulder the burden of the family at the time of need. This is especially true if the family is poor.

However, with all the education, when some end up working in private schools as teachers, they cannot even afford medicines for their ailing parents. Contributing for groceries or spending on personal expenses is a luxury they can't afford. Imagine the plight of turning up all brushed up with knowledge, in well creased clothes. Can they even afford these in the first place? Can they even afford the technology that they're required to be familiar with and teach? These are all dusted under the carpet as "asking-for-too-much" demands. A private school teacher can't even take the liberties to buy resources for the teaching-learning process. Apparently, their "passion" and "dedication" should pay the school supplies shop.

As though things weren't already worse, during the Covid-19 pandemic, the condition of Private school teachers got worse. Many private school teachers were not paid their salaries for months without any consideration. They were pushed to starvation. The hardships faced by a private school teacher were evident from a video that went viral on social media. The teacher in the video was walking by foot when a cab driver offered him a lift. It is then that he narrated his ordeal to the cab driver and stated that he had visited the school where he works for the very purpose of getting salary but to no avail. His condition was such that he had hoped to pay for a ride back to his home through the salary that never came. This is not the ordeal of only one helpless and poor private school teacher but a tale of almost all private school teachers.

The paying of low salary to the teachers puts a question mark on the very functioning of private schools. It rips apart the minimum wages guarantee act (MWGA). It is an exploitation of the asset of educated youth who are the life of successful nations. It is an insult to our education system. It is a joke on the literacy mission and its advocates. It falsifies the very purpose of imparting a sincere education.

The School Education Department and the Labour Department should come to the rescue of private school teachers and frame rules and regulations that will govern the basis of hiring of teachers by the private school owners. A salary fixation committee for private school teachers should be constituted and a respectable salary to be paid to private school teachers should be fixed. There should be a provision for a suitable and respectable yearly increment for the PST. A grievance redressal cell should also be put into place to look into the complaints logged by the private school teachers.



And this has been made possible by some local publishers who have now come up with some quality publications and standard books for schools. Paradise Publi-



cation House Srinagar is one such publish-ing house which is purely an educational publishing company and has been in the field for the last many decades.

Right now, the publishing house has come up with three interesting series on General Knowledge, Cursive Writing and Art. All the three series are strictly designed, printed and published on high quality paper with attractive get up and child friendly illustrations.


1. 'MY NAME IS RADHA: THE ESSENTIAL MANTO'

Partition in South Asia refers to that horrific year when an arbitrary red line was drawn across a map by British colonial rulers – namely, the last viceroy, Louis Mountbatten, and Cyril Radcliffe, a barrister from England who was given five weeks to draw the line that severed India and created Pakistan. The violence of that crooked line has traumatized an uncountable number of people. I know some of this history through the lives of my own parents.

While writing my memoir based in part on the Partition and my parents' childhood. I hunted for nonfiction books and memoirs written by witnesses, but when I found little, I turned to fiction and poetry. One of the most influential books for me was Saadat Hasan Manto's "My Name is Radha," a collection of translated short stories.

A former journalist and screenwriter, Manto was one among the millions who were displaced: Manto moved to Pakistan and wrote fiction about the lives of marginalized people. He wrote about Partition from the perspective of insane asylum residents and prostitutes and, in so doing, powerfully illustrated the un-



imaginable horrors and absurdities of Partition. He was tried in India for obscenity in his writing, but never convicted. He said, "With my stories, I only expose the truth."

2. 'MIDNIGHT'S CHILDREN'


Recommended by professor Geetha Ganapathy-Dore, "Université Sorbonne Paris Nord'

Salman Rushdie's "Midnight's Children," which won the Booker Prize in 1981, the "Booker of Bookers" in 1993 and was judged "Best of the Bookers" in 2008, has not aged one bit. Translated into over 24 languages, the book was adapted for the stage by British directors Simon Reade and Tim Supple in 2003. In 2012, filmmaker Deepa Mehta brought out a cinematic version of it.

It is a must read on the multiplicity of India: There are as many dreams of India as there are people in this dramatically diverse land - plus the "moth-eaten" Pakistan, as founder Muhammad Ali Jinnah described it, with a divided Punjab and Bengal.

History, in this novel, is inseparable from story, as its protagonist Saleem Sinai was born on the same day as the nation. The twin hero of "Midnight's





Children," Shiva, though he shares his name with one of Hinduism's most important deities, is ironically the son of a Muslim couple. Yet this embodies the hybrid nature of identity in the subcontinent, which is almost always multicultural. The epic narrative also incorporates the history of Pakistan and Bangladesh, which was carved out of Pakistan in 1971.

Writing back to the empire, asserting its independence in "chutnified" Indian English, this masterpiece of magic realism borrows the device of the storytelling scribe from the "Mahabharata," an ancient Indian epic.

"Midnight's Children" thus remains an incontrovertible narrative on decolonization and the birth of new nation states.

3. 'TRAIN TO PAKISTAN'

Recommended by professor Amitabh Mattoo, University of Melbourne, Australia

Khushwant Singh's "Train to Pakistan" is one of the most moving accounts of the Partition of India and the way local communities, which had lived peacefully for generations, were torn apart by the forces of communalism. As the Partition plan is announced in the summer of 1947, millions of Hindus, Muslims and Sikhs flee across the new border between India and Pakistan. Mass violence ensues.


"Train to Pakistan" is set in what at first seems like an island of hope: the imaginary village of Manmo Majra, on the border of India and Pakistan, inhabited primarily by Sikhs and Muslims. In the viciousness of the violence, this small village's traditional social structure and relative harmony is destroyed to a point where all sense of humanity is lost. There is still hope, however, in the resilience of love.

One day, a train arrives from Pakistan, "a ghost train" full of corpses of Hindus and Sikhs. The Sikhs are provoked to retaliate, with a plan to murder en masse Muslims leaving the village on a train traveling back to Pakistan. But a local outlaw, Jugga – a Sikh - sacrifices his life to save the train. He does so because be believes his Muslim lover, Nooran, is traveling on it.

4. 'EARTH'

Recommended by professor Ajay Verghese, Middlebury College, U.S.

Deepa Mehta's 1998 film "Earth" is a chilling story about the horrors



of the Partition. Based on Bapsi Sidhwa's novel "Cracking India," the film revolves around three friends in colonial Lahore, in present-day Pakistan: Shanta, a Hindu nanny to a young Parsi girl named Lenny, and two Muslim suitors, Hassan and Dil. The film portrays how their carefree friendship is upended by the violent division of India, slowly turning them against each other and finally into enemies solely on account of their religion.

Several aspects of the movie provide viewers with a unique window into the ground-level realities of the Partition, which included, as one grisly scene shows, an entire train car of slaughtered Muslims arriving to Lahore. The narrative is presented via the recollections of a young girl who lived through the event. Lenny is also from a wealthy Parsi family, a minority religion in India and one that is not normally featured in Partition discussions. Her family's naïve attempt to stay neutral during the conflict when the mob comes reflects the reality of times when not just Hindus and Muslims but every religious group was involved in some act of violence. It was almost impossible to stay neutral.

Finally, the film powerfully centers the narrative around Shanta. She's last

5. 'THE LONG GOODBYE' (ALBUM)

Recommended by professor Uditi Sen, University of Nottingham, U.K.

Riz Ahmed's album "The Long Goodbye" is a commentary on contemporary race relations in Britain. It explores British-Asian belonging in the context of rising racism and xenophobia, using the metaphor of a breakup. It takes a deeper look at the lyrical complaints of the dumped partner, whose pain and anger mirror the emotions of contemporary British Asian and Muslim communities – shot through with a historical awareness of the British empire and the Partition of India.

In the song "The Breakup (Shikwa)," "Brittney baby" is the partner who took the money ("my stash was a quarter of the cash in the world") and labor ("my people built the west", "fought for you in the war"), and yet seeks to disown "the new kids" (the South Asian diaspora in the U.K.). It's impossible to separate what Ahmed says of the now from the then as he evokes the history of the equally impossible Partition of India.

Ahmed raps that during the Partition, Britain "carved a scar down my middle just to leave me stretched out.' It's left a bloody legacy of conflict: "My Kashmir jumper still stained red" and "the bleeding never ends man."

He highlights how seemingly overnight, Muslims in India and Hindus in Pakistan became foreigners in their own home. Ahmed notes in the song "Where You From" that this racist question takes on a deeper meaning for British Pakistani Muslims, whose ancestors survived the Partition's displacement: "My ancestor's Indian but India was not for us."

Ahmed uses the Partition to lay bare the violence inherent in racist ideas of national belonging. "The Long Goodbye" dares listeners to learn from the past and imagine a form of belonging that celebrates being from "everywhere and nowhere."

Washington is currently studying the final text of the JCPOA-revival, which was approved by Iran and the EU earlier this week after 16 months of negotiations.

During a phone call with German Chancellor Olaf Scholz on 18 August, Israel's interim Prime Minister Yair Lapid demanded that Europe send a "clear and unequivocal message that there will be no more concessions to Iran," according to Israeli media.

Lapid also met with the US ambassador to Israel and the chairman of the US House Foreign Affairs Committee's West Asia Subcommittee, telling them: "In the current situation, the time has come to walk away from the table. Anything else sends a message of weakness to Iran."

Lapid specifically took aim at a clause in the draft text that allegedly posits that a UN investigation on Iran's nuclear program will be closed, if the nuclear watchdog concludes Tehran provided enough evidence to show they are not developing a nuclear weapon.

The interim premier reiterated that Israel "is not bound by any nuclear deal" and will continue targeting Iran's

SC Terms Dolo Makers Rs 1000 Cr **Freebies A Serious Issue**

New Delhi: The Supreme Court on Thursday described as a "serious issue" the matter raised by an NGO relating to the CBDT's allegation against the makers of Dolo tablets that they had distributed freebies worth about Rs 1,000 crore to doctors for prescribing their 650 mg antiinflammatory, fever reducer drug.

A bench of Justices DY Chandrachud and AS Bopanna was told by senior advocate Sanjay Parikh and advocate Aparna Bhat, appearing for petitioner 'Federation of Medical and Sales Representatives Association of India', that the market price of any tablet up to 500 mg is regulated under price control mechanism of the government but the price of the drug above 500 mg can be fixed by the Pharma company concerned.

Parikh alleged that to ensure a higher profit margin, the company manufacturing Dolo tablets distributed freebies to doctors to prescribe the 650 mg drug. The advocate also said he would like to bring more such facts to the knowledge of the court after a response is filed by the Centre. "What you are saying is mu-

sic to my ears. This is exactly the drug that I had when I had COVID recently. This is a serious issue and we will look into it," Justice Chandrachud said.

The bench then asked Additional Solicitor General KM Nataraj to file his response to the plea by the petitioner in ten days and gave one week time thereafter to the latter to file his

rejoinder It listed the matter for further hearing on September 29.

The Central Board of Direct Taxes(CBDT) had on July 13 accused the makers of the Dolo-650 tablet of indulging in "unethical practices" and distributing freebies worth about Rs 1,000 crore to doctors and medical professionals in exchange for promoting products made by the pharmaceutical group.

The claims were made after



the Income Tax department had on July 6 raided 36 premises of the Bengaluru-based Micro Labs Ltd. across nine states.

A counsel sought permission from the court to file an intervention on behalf of the Pharma companies, which the court allowed saving it would like to hear them also on the issue.

On March 11, the top court agreed to examine a plea seeking direction to the Centre for formulating a Uniform Code of Pharmaceutical Marketing Practices to curb alleged unethical practices of Pharma companies and ensure an effective monitoring mechanism, transparency, accountability as well as consequences for violations.

The top court had said that it wants to know what the government has to say on this issue.

Parikh had said that this is an important issue in the public interest. He submitted that Pharmaceutical companies are claiming that they are not liable for punishment as the bribetakers are the doctors.

Parikh said the government should look into this aspect and the code should be made statutory in nature as "we all know what happened with Remdesivir injections and other drugs of those combinations.

The top court had then asked the petitioner why can't a representation be made to the government to which Parikh had said they have already done it.

He had said that they have been pursuing the issue with the government since 2009 and till the time the government comes out with the code to regulate, this court may lay down some guidelines.

The petition said the Indian Medical Council (Professional Conduct, Etiquette and Ethics) Regulations of 2002 prescribe a Code of conduct for doctors in their relationship with the pharmaceutical and allied health sector industry, and prohibit acceptance of gifts and entertainment, travel facilities, hospitality, cash or monetary grants by medical practitioners from Pharmaceutical companies. "This Code is enforceable

against doctors. However, it does not apply to drug companies, leading to anomalous situations where doctors' licenses are cancelled for misconduct which is actuated, encouraged, aided, and abetted by pharma companies. The pharma companies go scot-free", it added.

The petition claimed that though termed as sales promotion,' in fact, direct or indirect advantages are offered to doctors (as gifts and entertainment, sponsored foreign trips, hospitality, and other benefits) in exchange for an increase in drug sales. It said unethical drug promotion can adversely influence doctors' prescription attitudes and harm human health by overuse/over-prescription of drugs, prescription of higher doses of drugs than necessary, prescription of drugs for a longer period than necessary, prescription of a higher number of drugs than necessary and prescription of an irrational combination of drugs.

Kerala Govt Fails To Persuade Fisherfolk To Withdraw From Vizhinjam Protest

Thiruvananthapuram: Kerala Fisheries Minister V Abdurahiman held talks with representatives of protesting fisherfolk on Friday over the construction of a port in Vizhinjam but failed to persuade them to withdraw from the agitation. Discussions were held to re-

solve the problems being faced by the people living in the coastal belt of Vizhinjam due to the under-construction port.

Emerging from the meeting, fishermen representative Msgr Eugine Pereira said they were "satisfied" with the discussions with the minister on various issues related to the coastal community.

However, the protest will continue till fully addressing the fishing community's major concerns of coastal erosion due to construction of the port, he said.

"When the minister asked whether the protesters would stop their agitation, we said one of the major concerns of the fishermen community was the construction of the port and its various impacts on the coastal region. We said they would only withdraw from the agitation if their demands had been fulfilled completely. So, the stir will continue," he told reporters here.

In the meeting, also attended by Transport Minister Antony Raju, the protesters were informed that a decision in connection with the construction of the port would be taken next week after consulting with Chief Minister Pinarayi Vijayan, sources said.

Expressing satisfaction over the government's assurance related to other issues of the fisherfolks, the representatives said the government has agreed to shift all the fishermen who have been staying in camps to rented houses, close to the upcoming Onam festival.

"The minister assured that a permanent housing facility would be set up for them and said suitable lands have already been identified in some places including a 17.5 acre land in nearby Muttathara for the same. It has also been assured that their rehabilitation process would be completed in a time-bound manner," Pereira said.

The priest said though the issue of kerosene subsidy was also discussed during the meeting, but the minister pointed out that a decision can be taken only by the Chief Minister and the state cabinet as it would impose a huge financial burden on the state exchequer.

However, he assured that the matter would be considered favourably by the government.

The meeting was held hours after a tense situation prevailed in the Vizhinjam port area as hundreds of fisherfolk, mainly women from the nearby coastal hamlets, pushed their way into the under-construction port site demanding the authorities to address their long-pending demands regarding livelihood issues.

A large number of coastal people have been staging an intense protest outside the main entrance of the multi-purpose seaport, located at nearby Mulloor, for the last four days pressing their seven-point charter of demands including to stop the construction work and to conduct a coastal impact study in connection with the multi-crore project.

Intensifying their agitation, the protesters took out a march this morning and pushed their way inside the project site and raised slogans against the government and the port authorities alleging that the unscientific construction activities were the cause of increasing coastal erosion in the region.

A group of protesters knocked down the barricades and entered the port site but the police and the priests of the Latin Archdiocese, who led the protest, tried to calm them down and brought them back to the protest venue at the entrance.

The protesters have been alleging that the unscientific construction of groynes, the artificial sea walls known as "pulimutt' in local parlance, as part of the upcoming Vizhinjam port was one of the reasons for the increasing coastal erosion in the district.

The Ramsar Convention on Wetlands is an international treaty for "the conservation and sustainable use of wetlands". It is named after the city of Ramsar in Iran where it was signed on 2nd of February 1971. Since then, February 2, every year is celebrated as World Wetlands Day. India is one of the contracting parties to the Ramsar Convention.

Dr. Arshad Jehangir, noted environmentalist, told Kashmir Observer that this was a much needed step to save the wetlands as the water bodies have witnessed rampant encroachment over the years.

"These wetlands will be demarcated and different types of activities like encroachment will not be allowed now." he said.

While welcoming the step, Jehangir added that these wetlands have rich diversity of microfiber and host a number of birds during winter season. Every year, thousands of migratory birds from different areas of the world arrive in Kashmir during winter when freezing temperatures in their sum-

mer habitats make food scarce. The birds include teal, common pochard, merganser, northern shoveler, northern pintail, Eurasian wigeon, red-crested pochard, tufted duck, sheldrake duck, mallard, coot, gadwall, Brahminy duck, cormorant, Greylag goose.

They start arriving in October and stay until the end of April but their home-wetlands are being encroached rapidly.

According to reports, many migratory birds are now leaving earlier because of the shrinking of the wetlands.

Advocate Qadri, however, argues that the wetlands need a strong action plan for their preservation.

"I must says the Hokersar wetland, being listed in Ramsar sites is not in a good condition and needs urgent attention from the government," Qadri added

He said there needs to be an action plan and strategy to conserve these wetlands and to enhance the bird diversity.

The government has also directed the agencies to provide monthly list of management and those engaged by the security agencies to the officer incharge of the concerned Police Station.

Further, the government has impressed upon all the government, semi-government, State/Central public sector undertakings and the private institutions including Banks who are hiring the services of private security agencies not to hire the services of those PSA whose employees' character and antecedents have not been verified according to the manner as prescribed in the Jammu and Kashmir Private Security Agencies (Regulation) Rules. 2022.

Dheeraj Gupta Chairs 86th Board Meeting Of JDA

Decisions Regarding Satellite Township, Housing Colonies, Commercial Projects Approved

JAMMU: In a major initiative for expansion of Jammu city, the Jammu Development Authority is going to develop an Integrated Smart Satellite Township for a population of about 50 thousand along ring road at Bhalwal.

The decision to develop the satellite township was taken in a meeting of the Board of Directors of the JDA under the chairmanship of Dheeraj Gupta, Principal Secretary Housing & Urban Development Department on Thursday, August 18, 2022. It may be recalled a similar township has been decided to be developed by the J&K Housing Board.

The proposed township will be a completely self-sufficient stateof-the-art satellite town with all modern infrastructure and amenities, including for commercial and institutional usage, and will also provide livelihood opportunities for its residents within the township. It will be for the first time in last three decades that the JDA will take up development of a housing colony of this scale in Jammu. The proposed township will fully take care of the expansion needs of Jammu city.

The Board further approved the revamping of drainage, road, water supply and power distribution infrastructure in under developed housing colonies of JDA viz Udheywala, Gole Gujral, Birpur, Kot Bhawal and Roop Nagar sector 6 with an estimated expenditure of Rs 66 crores which will touch the lives of population of more than ten thousand resi-

dents in these colonies. Grant of alternate plots to the allottees of Roop Nagar housing colony sector 6 (new) in other sectors of the same colony, who could not be handed over possession because of long legal disputes, was also approved by the Board.

Vice Chairman JDA, Pankaj Magotra presented a detailed agenda including the action taken on the decisions of the previous meeting before the Board for discussion covering several issues pertaining to the functioning of the JDA and new initiatives for the development of the urban in-

frastructure in Jammu city. The Board was apprised by VC JDA that top real estates consultants of the country like KPMG, Knight Franks Ernst and Young, CBRE, JLL have been empanelled as Transaction Advisors by JDA for the upcoming major infrastructure development project to be taken up in PPP mode which include Mass Flatted Housing Projects in Birpur, Samba for the construction of nearly 1200 housing units, development of prime commercial space in Rail head Complex, Development of Ecoresort and city forest at Sidhra, Redevelopment of Kalka colonv near Bahu fort, Redevelopment of old Bus Stand Jammu, IT Tower near Fourth Tawi Bridge, Jammu.

The Board considered and approved various proposals for allotment of JDA land to Govt departments, paramilitary forces and other non-government entities as per the approved policy.

This also included allotment of nearly 150 kanals land in Bhalwal to J&K Housing Board for the development of flatted accommodation for Economical Weaker Section (EWS) and construction of Demonstration Housing Project in association with the Central Govt Employees Welfare Housing Organistation (CGEWFO).

The Board constituted a committee headed by DC Jammu for evaluating the online applications received for more than 200 EWS flats proposed to develop by JDA so that only the rightful beneficiaries avail the benefits of this housing project.

The Board also directed VC JDA to identify land for the development of a housing colonies for different sections of the society. Approval was also accorded for the constitution of the new finance committee and establish-

ment committee for considering and settling the financial and employees related issues concerning JDA.

The Board advised Vice Chairman, JDA to personally monitor, actively pursue and secure the disposal of long pending legal cases involving JDA land and to sternly deal with the encroachers of JDA land. The Annual Audited Accounts of the JDA for the year 2018-19, 2019-20 and 2020-21 were also adopted by the Board.

The Board approved the construction of the 100 feet Tribute Wall with 100 feet height national flag in the Maharaja hari Singh Ii park for the commemoration of freedom fighters as part of Azadi Ka Amrut Mahotsav celebrations. The Tribute Wall will be one of its kind of the country with names of freedom fighters carved in granite stone with a QR Code which will carry the stories of freedom fighters.

The Iconic Tribute Wall will create awareness about nearly 1000 freedom fighters and instil spirit of patriotism among the current and coming generations, besides, promoting national integration and an added attraction for visitors/tourists to the park

Chairman, JDA Dheeraj Gupta concluded the meeting by advising that JDA should endeavour to speedily develop modern and affordable housing to meet burgeoning housing demand of all sections of society and to play a pivotal role in ushering in a new phase of infrastructure development in Jammu on the lines of most modern cities of India.

LONDON: South Africa skittled England out for 149 on Friday to win the first Test by an innings and 12 runs inside three days at Lord's and go 1-0 up in the three-match series.

South Africa had begun the day on 289/7 in response to England's first innings tally of 165 and batted for the first hour on Friday before being bowled out for 326 in their first innings, giving them a handy 161-run lead.

NEW DELHI: The Sports Ministry has requested the world football governing body FIFA and the Asian Football Confederation (AFC) to allow Indian clubs -- Sree Gokulam Kerala FC and ATK Mohun Bagan -- compete in the tournaments as scheduled despite the ban on AIFF.

The ministry wrote an email to FIFA and AFC. apprising them of the fact that Gokulam Kerala was already in Uzbekistan when FIFA's suspension of AIFF was announced.

He said he spoke with Casemiro and felt "there was no way back."

"He wants to try a new challenge, a new opportunity," Ancelotti said in a news conference. The club understands. With all he's done for this club and the person he is, we have to respect it. There are talks right now, he's still a Real Madrid player at this stage, but he wants to leave."

Ancelotti said he didn't try to change Casemiro's mind about leaving. "I haven't tried to convince

him, I just listened, because I have spoken to Casemiro throughout my time here and he has helped us so much," Ancelotti said. "Having heard what he wants, there's no way back. If he doesn't stay, we'll have an enormous sense of gratitude to him for all he's done."

US Open Raises Prize Money To \$60.1 Million

NEW YORK: This year's US Open will award a record USD 60.1 million in total player compensation, the US Tennis Association said on Thursday, with USD 2.6 million going to each singles champion, twice the runner-up total.

The prize money total tops the old mark of USD 57.5 million from last year, with an emphasis on boosting payouts for players in early rounds.

That means a boost to USD 80,000 for each singles competitor in the main draw first round and USD 121,000 in the second begin on August 29.
