The skies had shed their load after raining hard for four consecutive days. And now the sun was casting hues across, making every car and passerby on the road stop and capture the sublime moment

with their eyes and cellphones. Far from this cheery crowd, Haris—seated on the Dal Lake embankment, in one of the secluded corners where lay a mound of pebbles, perhaps for the construction work—looked sombre.

He looked at the mound with a grimace, got hold of a handful of pebbles and started throwing them into the calm lake waters, one after the other.

Right To Education, 890 Other Laws Made Applicable To J&K: LG

'At The Time Of Tribal Invasion, Women Played A Very Important Role In Keeping The People Together'



J&K Govt Allays Fears On **Electoral Roll Revision**

'Misrepresentation Of Facts By Vested Interests'

Srinagar: The Jammu and Kashmir administration on Saturday clarified that reports of a likely addition of over 25 lakh voters after the summary revision of electoral rolls is "misrepresentation of facts by vested interests".

The clarification was issued through an advertisement in local dailies after facing political backlash, including from parties perceived close to the government. National Conference chief Farooq Abdullah has called an all-party meeting over the issue on Monday.

Jammu and Kashmir's Chief Electoral Officer (CEO) Hirdesh Kumar recently said the Union territory was likely to get around 25 lakh additional voters, including outsiders, following the special summary revision of electoral rolls being held for the first time after Article 370 abrogation.

"We are expecting massive changes in the voter list given that a large number of youngsters have attained the age of 18 over the past three years.

Top Brass Security In Jammu Discusses 'Terror Threat'

Jammu: Amid a spurt in militant activities in Jammu and Kashmir's border districts of Rajouri and Poonch, a high-level security meeting was held on Saturday to devise an action plan to counter the emerging threat, a police official said.

The conference held in Rajouri was attended by Additional Director General of Police (ADGP), Jammu zone, Mukesh Singh and senior Army officers among others.

The meeting was convened nine days after two militants

attacked an Army camp in Rajouri, killing four soldiers in a pre-dawn suicide strike that marked the return of 'fidayeen' (suicide) attacks to Jammu and Kashmir after more than three years.

Both the militants, believed to be from the Pakistan-based Jaishe-Mohammed, were shot dead. The official said the meeting



To Be a Good Manager, You Have to Be a Good Teacher

s an early-career leader, one of the challenges you'll inevitably face is the moment you realize that someone on your team is struggling to do something you've asked. Some may be willing to acknowledge their need for help and readily ask for it. Others may not, instead frantically searching the internet for articles or videos to instruct them on how to tackle the task.

It's common for newer leaders to make assumptions about what their team can do, giving assignments without fully vetting whether someone has the skill, knowledge, or experience to succeed. Rather than leaving things to chance, effective leaders learn to be good teachers in moments when team members have the confidence and humility to ask, "Can you show me how?"

If you want to be an inspired teacher to the up-and-coming professionals you're charged with leading, here's what you can do.

Learn how others learn.

Not everyone learns the same way. Some people need extensive knowledge and preparation to build their confidence before tackling a new task, while others prefer to dive in right away and learn through trial and error. Some people learn well in groups, while others prefer the privacy to learn on their own. There's no one right way to learn, but if you know what your team members prefer, you can tailor your approach to each individual when it's time to offer guidance.

How do you figure this out? Just ask. In your one-on-one meetings with your direct reports, for example, you can say, "In the past, when you've learned something new, what's been the best approach for you? Do

you prefer a hands-on experience, or do you prefer some time to think on your own before trying?" Or if you notice someone struggling in the moment, you can simply approach them and ask, "What can do that would be most helpful to you right now?"

Ask questions to draw out learning needs and reservations.

Great teachers know that learning is not a consequence of teaching, it's a consequence of thinking. As you step into the role of actively teaching, begin by asking openended questions to draw out what specifically the person is struggling with. Are there aspects of the task that they have relevant experience with? What skills have they previously developed that they can use right now? Help them make those connections to build up their confi-

For example, let's say you're working with someone struggling to learn how to write technical content for a non-technical audience, but they've only written for technical readers before. You could ask, "Tell me about a time when you had to explain your work to a friend or family member who didn't understand it. How did you do it? Did you put yourself in their shoes in order to empathize with them? Did you use metaphors to illustrate your points?" By inviting people to reach back into similar experiences, you help them make connections and apply approaches they already understand to their current challenge. They will become a more confident learner and acquire the skill or knowledge at hand through their own thinking rather than only your "instruction."

Some people may be hesitant to tackle a task due to the fear of failure. If you sense this is the case, again, rather than offering reassurance, ask questions to draw out their deeper angst. Help them discover that the nightmare scenario playing out in their head is highly unlikely. Use probing questions to help them reason their own way through a learning challenge, like, "What's the worst-case scenario? What's the best-case scenario?'

Be judicious when comparing

your own learning journey.
Letting someone know that you struggled to learn the skill you're now teaching them can sometimes be comforting. It eases the pressure people may feel to "look good" in front of the boss. Stay empathic with your comparison - keep in mind, your struggles are in the past while theirs are current. Be sure that your comparison doesn't inadvertently dismiss the real angst someone is feeling.

For instance, saying something like, 'Oh, I fumbled through this pitch process too, but I got through it and so will you," may send the unhelpful message of, "Just be like me and you'll be fine." Instead, you can approach the situation more compassionately by saying something like, 'I know this is hard, and the fact that I'm here probably makes it harder. Would it help to hear an experience I had struggling to learn something similar, and how I got through it?" By asking permission to share your story, you demonstrate care and allow them to hear you in a way that suits their situation. You can finish by saying something like, "My intent isn't to make an erroneous comparison of my experience to yours, or imply that my example is worth following. You need to find a way through this that works best for you. I just wanted you to know that you aren't alone in the challenge, and having struggled with this myself, I'm especially sympathetic to what you're going through. I'd like to support you in a way that you'd

Demonstrate when helpful.

Sometimes it's helpful to demonstrate for learners how something is done. Always check in with your learner first by asking, "Would it be helpful for me to demonstrate this for you?"

Be sure that you're not conveying: "You should do this exactly the way I do it." Demonstrations of a new skill should enable the learner to bolster their own approach, not simply mimic the demonstrator.

After you offer a demonstration, ask your learner, "What did you see that was helpful?" This gives them a chance to focus on specific things they can incorporate into their ap-

Reinforce learning through observation, reflection, and coaching.

Once you've given someone "a lesson," they may be more sensitive to your scrutiny as they practice mastering their new skill or task. Rather than letting their hypervigilance run amuck, set expectations about how and when your next observation of their performance will happen. For example, if someone is working on their presentation skills, you don't want them thinking that every time they present, they'll be evaluated. Ask your learner, "Why don't you let me know when you're ready for me to assess your progress" so they feel more in control of their ongoing

Then, having observed them, begin your conversation with their reflections. Ask: "How did you feel that went? What did you feel went well? What would you do differently?" These questions will give you insight into how self-aware they are as a learner, and whether they tend to be overly harsh or overly lenient with themselves.



ACB Arrests SMC Ward Officer For Demanding, **Accepting Bribe**

Srinagar: The Anti-Corruption Bureau on Saturday trapped and arrested a ward officer of Srinagar Municipal Corporation (SMC) for demanding and accepting bribe from a complainant.

According to a statement, ACB received a written complaint alleging therein that Ward Officer SMC of Hawal area of Srinagar is demanding Rs 50,000/- as bribe for allowing construction in favour of the complainant.

The statement reads that the complainant requested the ward officer and pleaded for justice, who, however, remained adamant on his demand for a bribe.

"He had asked the complainant to pay a bribe of Rs 20,000 as first installment. However, before paying the bribe amount to the accused person, the complainant approached the Anti-Corruption Bureau for taking legal action against the accused

public servant under law,"

It reads that on receipt of the complaint a Case FIR No. 33/2022 U/S 7 PC Act 1988 was registered with this Bureau and investigation was taken up.

"During the course of investigation a trap team was constituted. The team laid a successful trap and caught the accused public servant Mohd Maqbool Bhat red handed while demanding and accepting a bribe amount of Rs 20,000 from the complainant as first instalment of Rs 50,000.

It further reads that he was arrested on the spot by the ACB team and bribe money was also recovered from his possession in presence of independent wit-

Kashmir Chapter Of 'Who Is Hussain' To Hold Blood Donation Camps On August 27

Srinagar: The Kashmir chapter of Britain -based charity organization 'Who is Hussain' is organizing a blood donation camp across the three districts of Kashmir Valley as part of the organization's world-wide blood donation drive.

The blood donation camps will be set up at Imambada Zadibal and Imam Bargah Ayatullah Yousuf Bemina here in Srinagar besides Markazi Imam Bargah Budgam and near Imam Bargah Gamdoo in Bandipora district on August 27.

The non-profit organization has it's chapters in 109 cities worldwide including Srinagar where around 25 volunteers have been tirelessly working in order to aware people about Prophet Muhammad's grandson Hussain ibn Ali.

The donation camp is part of the global campaign 'Be a global blood hero' being held across several countries. The aim of the campaign is to set a world record-breaking challenge of collecting 50,000 units of blood on one calendar day.

"We are hopeful that the blood donation drive will evoke an overwhelming response. We



have set up camps at three different locations in Kashmir for this purpose," Abrar Ali, one of the organizers said.

Some diehards still manage to get a job in one or the other department by manipulating records and documents, and by tapping the 'right' person and the 'tight' timer. An illiterate villager has got a government job allegedly by impersonation, and got away with it, assurance of the finance minister to get the wrong undone notwithstanding. In the process, the genuine claimant for the appointment continues to be jobless. Reports said Nazir Ahmad Dar r/o Abdul Kabir Dar R/o Badipore, has passed his 12th (TDC) clam examination. But, it is his name sake in the neighbourhood who, though illiterate, has allegedly got a government job. The only difference between the two is in the names of their grandfathers. While the former's grandfather is

named Abdullah Dar, the latter's name is Ahmad Dar. According to reports, the uneducated Nazir Ahmad Dar was appointed in the horticulture department in 1996. He is posted in the district office at Budgam. Sources in the department said Dar managed to procure the certificates of his educated namesake which he produced in support of his claim. The department did not entertain the 'genuine' claim of the

Though the serious case of alleged swap was brought to the notice of the state vigilance organisations, no action has been taken so far. The educated Dar approached the finance minister, Abdur Raheem Rather, who also happens to be his neighbour. He had assured him to get the right person appointed against the post. However, justice' still eludes hint despite lapse of

In another case, Mushtaq Ahmad Zargar s/o Ghulam Ahmad Zargar r/o Badipore has managed to secure a job allegedly by producing a fake certificate of academic qualification. According to reliable sources, he is barely read upto 4th standard. However, he managed to get a certificate of having passed his 9th class (under metric) examination from the government higher secondary school, Nagam, in 1996 allegedly, through his brother, Abdul Rasheed Zargar, who is a teacher at Badipore.

On the basis of the alleged fake certificate, Zargar was appointed as a peon in the animal husbandry department. He has been working at the veterinary dispensary here for about three years past. Sources said the department did not take any action to unravel the facts and bring the accused to justice even after the matter was brought to its notice.

De-controlled traffic

ore than 3,500 people were killed and nearly 32,500 others suffered injuries while 360 more were added to the increasing population of the physically challenged as a result of road accidents in Jammu and Kashmir during the past four years. The disturbing figures were given to the upper house of the state legislature by none other than the minister of transport, Mangat Ram Sharma, on Friday. As if he were counting his accomplishments, the ageing minister of the decaying ministry said Rs 31.40 lakh were distributed as ex-gratia relief to the next of kin of those killed in the mishaps during the period. However, suggesting that he was beating about the bush, he said the government had received five proposals from as many non-governmental organizations during the four years offering the moth-eaten department their services to administer road safety awareness packages. Of them, four NGOs were recommended to Ministry of Road, Transport and Highways, government of India, for sanction and release of grant-in-aid in their favour. The centre, he said, had sanctioned Rs one lakh to the four NGOs out of which Rs 50,000 each had been released as the first installment during 2004-05. Making the alarming revelations, the minister might have forgotten what he had told the legislative assembly a fortnight earlier: that the graph of road accidents had shown constant decline in the year 2005 in comparison to those in 2004. Responding to a query by a member, he said the number of accidents reported in 2005 was 5,664 as against 6,257 in 2004 recording decrease of 600 incidents. On the overloading issue raised by a member, he evasively responds thus: "The government has taken up the matter of overloading of vehicles with concerned transport groups for increasing the service on Udhampur-Ramnagar route and the State Road Transport Authority would operate the service on the route shortly. Meanwhile, ARTO, Udhampur, is taking care of the situation and has been directed to take action against the lawbreakers as per provisions of the

Motor Vehicles Act." Obviously, the transport minister betrays blissful ignorance of the root cause of road mishaps, a daily occurrence which has been taking a heavy toll on precious human lives. In fact, the local media carry such reports as a staple for their audiences. The four year period during which no less than 3,500 people lost their lives, 360 their limbs while over 32,000 others were wounded in road accidents, Sharma held the transport portfolio. One would have expected him to own moral responsibility for the grim scenario and quit his office, which he holds for the second time, albeit on humiliating terms for the reasons he alone should know. Incidentally, part of the blame should also go to the chief minister who holds the home portfolio under which the traffic control organization falls. Unless he too is nonchalant like his transport minister, the root cause of the road mishaps could be attributed to overloading in public transport vehicles. Although armed to their teeth with fairly deterrent laws, the policemen in blue deployed in the cities of Srinagar and Jammu as also in major towns rarely take any cognizance of dangerously over-crowded buses as if to suggest that the traffic system has been de-controlled and its violations legalized. Not long ago, a bus with 84 passengers drove right from Shangas in south Kashmir's Anantnag district to Damkund way ahead of Ramban in Jammu province, with better part of the route falling on national highway, without being intercepted anywhere by the traffic police, to end up with a nasty accident claiming no less than 45 lives. While the government ordered a probe in the nature of a mere ritual, the axe had fallen on some lower-rung police personnel, that too for a while. By now the good governance merchants must have forgotten the tragedy altogether. In the principal cities, overloading even means an outright denial of cheap transport to the vulnerable sections of the society like women, children, the aged and the infirm, who cannot afford to board a bus which has desperate passengers dangling dangerously from its outer frame, indeed, under the watchful eyes of hordes of unconcerned traffic policemen. It is time the government looked at the problem more earnestly and initiated concrete steps to stem the rot that has seeped deep into the transport and traffic control systems of the state. The chief minister and his predecessor's deputy will have to sit together, summon up their self-proclaimed "zeal" for public service and evolve a people-friendly system sooner than later. Then and then alone can one expect a perceptible reduction in road mishaps.

Nitish's Third About-face

As we look forward to the 2024 polls, Bihar chief minister has once again ditched the BJP. Is he seeing something that other politicians don't?

or the third time since 2013, Bihar's chief minister Nitish Kumar has switched sides: from the BJP to the RJD, back to the BJP and now back to the RJD. And along the way, Kumar has shaped and dictated Bihar's politics, even while support base of the JD(U), his party, has dwindled. In last year's Assembly polls, JD(U) was the third largest party. But despite that, Kumar was chosen as the chief minister by the ally BJP, lest he goes over to the RJD, the party of Lalu Prasad Yadav which is the largest single party in the state. But true to his form, Kumar eventually did He is now Bihar chief minister as part of the three-party combine of the RJD, Congress, and his own Samajwadi party.

Where does Kumar go from here? The question has generated a lot of interest. Some analysis of his latest move has focused on its implications for the 2024 general election. Kumar is being touted as a potential opposition leader to take on Prime Minister Narendra Modi. Speaking to the media soon after leaving the NDA, Kumar reinforced this view by reiterating his desire to work for opposition unity, a project he couldn't accomplish in his previous stint as a major opposition leader. Would he pull it off this time around? The chances remain moot. In fact, his ability to do so may be more diminished now than ever before. Kumar may continue to be a nationally-known high-profile leader, but the support base of his party in Bihar has considerably depleted, affecting his standing as a credible political opponent to the BJP.

But, at the same time, it would be a mistake to discount Kumar's ability to re-invent himself. He has proved himself as a great survivor while his one-time mentor, Lalu Prasad Yadav has fallen by the wayside. This makes Kumar a formidable challenger to the BJP, should he get his way with the opposition.

During his previous stint as the BJP opponent, Kumar had called for the formation of a Third Front to take on the saffron party in 2019.

It, however, didn't materialize. He also called for a "Sangh-mukt Bharat," twisting PM Modi's slogan of "Congress-mukt Bharat". He was the only leader to craft a secular narrative at the time and got noticed for it. He also made a bid for a key political role in national politics and tried to build alliances with other regional parties. But some of the leaders of these parties had parallel political standing and their own ambitions. For example, leaders like Akhilesh Kumar, Mamata Banerjee, Naveen Patnaik did not get on board. Nor did Congress. Despite efforts, the project of opposition unity turned out to be stillborn, forcing a disillusioned Kumar to return to the BJP despite differences with its ideology, which he saw as the reigning political creed that the splintered and discredited opposition couldn't dislodge

What has changed now? Does Kumar no longer see the BJP as invincible? There is, so far, no answer to these questions. Kumar reportedly quit the alliance with the BJP as he suspected the Hindutva party to split JD(U) on the pattern of what was done to Shiv Sena in Maharashtra. This could be true. But Kumar's politics has always been distinguished by its calculations. His persisting survival in politics against great odds makes him more or less an accurate predictor of the short-term political future of the country. In the run-up to 2019, he was convinced that the opposition and particularly the Congress under Rahul Gandhi stood little chance of beating the BJP. So, he went over to join the saffron party.

And now as we look forward to the 2024 polls, Kumar has again ditched the BJP. More so, at a time when the party is entrenched and looks invincible. Is Kumar seeing something that other politicians don't? Does he, by any chance, see the BJP losing? What appears to be a cakewalk for the BJP could turn out to be an uphill struggle. Who knows, he may be right again. The performance in Bihar, together with that in UP, would be critical to the BJP's retention of power at

the centre. With the JD(U)-RJD alliance, the battle for the 40 parliamentary seats of Bihar will become tougher for the BJP. In 2019, the BJP-JD(U) combine won 39 of these seats. And any reduction in the Hindutva party's tally in the UP, albeit unlikely, will affect its chances to retain national power.

But, for now, this is all in the realm of speculation. The opposition is unable to even unite over a governance issue such as inflation, let alone against the BJP. True, Kumar's departure from the BJP gives the opposition a boost, but it is debatable whether this will result in greater unanimity among the opposition ranks. And whether the opposition, at last, has an alternative political narrative. Things on this score are likely to get clearer in the weeks and months ahead.

World order looks different from Moscow, Beijing

he Chinese Defence Ministry announced today its participation in the Vostok 2022 strategic command and staff exercise in Russia, which is slated for August 30-September 5. The low-key statement in Beijing said China will send some troops and the participation is within the framework of the two countries' annual cooperation plan.

The statement mentioned that "India, Belarus, Tajikistan, Mongolia and other countries will also participate." It said the Chinese participation "aims to deepen pragmatic and friendly cooperation with the militaries of the participating countries, enhance the level of strategic coordination among all participating parties, and enhance the ability to deal with various security threats."

In what can be construed as an oblique reference to the conflict in Ukraine and the big power tensions in general, Beijing stated that the exercise is "unrelated to the current international and regional situation."

Vostok is one of the capstone events of the Russian Armed Forces' annual training cycle to test national preparedness for large-scale, high-intensity warfare against a technologically advanced peer adversary in a multidirectional, theatre-level conflict.

Vostok 2018 involved approximately 300,000 troops — as well as 1,000 fixed-wing aircraft and helicopters, 80 ships, and 36,000 tanks, armoured and other vehicles — and was unprecedented in scale. And 'Russian, Chinese and Mongolian forces were the sole participants and was hyped up as a carefully orchestrated Russian-Chinese military demonstration.

It seems the Chinese participation will be scaled down, notwithstanding the gathering storms on the horizon for both Russia and China. The Chinese announcement comes a day after Russian President Vladimir Putin used exceptionally harsh language to condemn the "Western globalist elites," accusing them of provoking chaos, "fanning long-standing and new conflicts and pursuing the so-called containment policy" in the pursuit of an agenda "to keep hold onto the hegemony and power that are slipping from their hands." Putin alleged, "They need conflicts to retain their hegemony."

The speech while addressing the 10th Moscow Conference on International Security in Moscow on Tuesday, also contained some pointed references to the Asia-Pacific region. Putin said:

"NATO is crawling east and building up its military infrastructure... US has recently made another deliberate attempt to fuel the flames and stir up trouble in the Asia-Pacific. The US escapade towards Taiwan is not just a voyage by an irresponsible politician, but part of the purpose-oriented and deliberate US strategy designed to destabilise the situation and sow chaos in the region and the world. It is a brazen demonstration of disrespect for other countries and their own international commitments. We regard this as a thoroughly planned provocation.

"They want to shift the blame for their own failures to other countries, namely Russia and China, which are defending their point of view and designing a sovereign development policy without submitting to the diktat of the supranational elites

"We also see that the collective West is striving to expand its bloc-based system to the Asia-Pacific region, like it did with NATO in Europe. To this end, they are creating aggressive military-political unions such as AUKUS and others."

Significantly, Putin called for "a radical strengthening of the contemporary system of a multipolar world." He said, "All these challenges are global, and therefore it would be impossible to overcome them without combining the efforts and potentials of all states...

"Russia will actively and assertively participate in such coordinated joint efforts; together with its allies, partners and fellow thinkers, it will improve the existing mechanisms of of international security and create new ones, as well as consistently strengthen the national armed forces and other security structures by providing them with advanced weapons and military equipment. Russia will secure its national interests, as well as the protection of its allies."

Notably, however, the Chinese commentaries generally steer clear of bracketing the Taiwan question and the conflict in Ukraine as analogous, as symptomatic of the birth throes of a multipolar world. In a commentary today, the senior editor with People's Daily, Ding Yang once again flagged that the real danger is that the US and China may "sleepwalk into conflict."

He wrote that the US is "like a runaway horse running wildly to the precipice of war," but the

aim is how to profit from a war, or rather "how to profit from someone else's war." Ding took a Marxian perspective that the US policy is driven by the interests of US capital and "Washington sees China as an enemy because it has moved the US cheese."

As he sees it, at its core the US strategy is "to squeeze China out of the global market and manufacturing chain." Thus, even with regard to Taiwan, "One of the main aims is to create tensions and further pulling Taiwan Semiconductor Manufacturing Company into the US chip siege against China."

Ideology, human rights, etc., are only alibis for the capital competition for markets. Plainly put, it unnerves the US that "Chinese capital is also starting to go global."

Deng is confident that "If we follow the logic of capital development as they see it, what matters is that Chinese manufacturing will eventually push them out of the global industrial chain, leaving them with no money to make and no work to do. So the first thing they want to do is to maximise their share of the Chinese market."

"Then the next thing to do is inevitably to implement a global stranglehold on Chinese capital and Chinese manufacturing." This is where the danger lies, as "the option of war is an inherent part of US capital export and expansion."

But China's advantage is that "in contrast to the historical path of Western capital's global expansion, there is a logic of "common development" behind Chinese capital going abroad."

Interestingly, the government newspaper China Daily reported today that China's holdings of US Treasuries have been further reduced through July, but China is only one of many other countries doing so, including Japan, reacting to the Fed's tightening cycle.

But "the decline may gradually decelerate."
The point is, it is "unrealistic" for China to give up on US debt holdings so long as the US Treasuries remain a critical international reserve asset!
This is diametrically opposite the revisionist path

She aimlessly roamed the bustling Iqbal Park Road in Srinagar in one summer day and caught everyone's attention. There was something about that woman with sunken eyes, skinny body and parched face that turned heads around.

But despite her blatant distressed state, she conveniently concealed the signs of the dreadful disease she was carrying inside her head

The woman's street slog ended when she boarded a bus. Her ensued phone call literally dropped a bombshell inside.

"Tell mother that I'm diagnosed with tumour," she informs someone with an unshakable voice cascading from her parched lips. "I'm travelling to SKIMS and they might admit me for some days. Tell her not to worry."

The inflection in her voice did not complement the seriousness of her situation. It felt like she was someone left with no hope to live and her disease was yet another tragedy she had to experience.

Her indifference narrated an unsaid story that made the people around her perplexed and intrigued to know the reason behind the numbness she poured.

An air of sympathy surrounded the vehicle and passengers started whispering among themselves to get certain answers that they did not expect to ask the stranger or receive answers for.

Upon disconnecting the phone call, she swiftly stretched her near crippled body on the ragged bus seat to find some comfort. She was unexpectedly intervened by a stranger who complained about her uprightness in putting forth her medical condition to the family.

An eerie silence grabbed the surroundings that broke only when she tried to put her emotions into words.

She introduced herself as Zoon—the moon—who wasn't even a pale shadow of her name. She was just a slogger in the swarm that routinely floods the streets of Srinagar.

A native of Budgam, she had left home early morning with her medical reports to meet a doctor in the city. But the results put her into a jaded journey.

She was diagnosed with cancer and was advised to get admitted in the hospital, as soon as possible.

Zoon voiced the tale of her tragedies as if trying to be heard once, even if by strangers. Every word that poured out her mouth detailed her dreadful life.

She adjusted her gown that seemed to slip off her shoulders depicting her sunkenness. The woman impassibly talked about her life that changed 10 years back when her husband divorced her and "kicked her" out of his house for not bearing a child.

Zoon felt lost in the moment but upon looking around in the surrounding with people encircling, she thwarted her lost state of mind and continued her journey all by herself.

"I don't know if the disease is my mother's prayers or curse," Zoon wondered.

"My mother has seen me struggling for everything in life. And the fact that I will be lonely after her death and might be left on the streets to survive, makes her worried."

She stopped for a while to regain her draining energy, stared at the ceiling of the bus where she tried to settle her paroxysm of emotions and recollected smilingly how she never failed to shower her nephews with love who have completely abandoned her in the fight for life.

Zoon would celebrate their academic success as a festivity and perform traditional rituals by garlanding them and showering them with sweets.

Traveling alone, walking on streets alone, switching from one vehicle to another to reach the hospital alone, she doesn't hope

Rise not to receive it please, I a pigmy and YOU ARE TALL O' HEETHERRIAY.



India Has Established Mechanism To Resolve Friction' On Indo-China Border: Lt Gen Kalita

Kolkata: India has an established mechanism to resolve any friction related to the international border with China in Arunachal Pradesh, GOC-in-Chief, Eastern Command, Lt General Rana Pratap Kalita said Saturday.

To a question about the past disputes between the two countries on the Sino-Indian border issue along Arunachal Pradesh, the senior army officer told reporters that the particular stretch of border is demarcated by the McMahon Line.

"That border is not marked in the same way as the Radcliff Line which demarcates the Indo-Bangladesh border. The Indo-Bangladesh border is demarcated by Radcliff pillars, everyone knows the alignment of those border areas. The Arunachal border is not demarcated in that way, so there can be differing perceptions (between two sides)...however, we have the established mechanism to resolve all such frictions. There are five agreements which

guide the way to resolve all such frictions whenever those take place," Lt Gen Kalita said.

Two days after the country's independence from British rule in 1947, the Radcliffe Line, a geographical marker was published that demarcated the boundary between India and the newly created dominion of Pakistan.

The senior army officer was in conversation with Air Chief Marshal (Retd) Arup Raha and members of Bharat Chamber of Commerce, Kolkata on securityrelated issues.

China claims Arunachal Pradesh as South Tibet which is firmly rejected by the External Affairs Ministry which has asserted that the state is an inseparable part of India . Beijing routinely protests visits of top Indian leaders and officials to Arunachal Pradesh to reaffirm its claim.

Asked about the threat perception along the Siliguri Corridor or Chicken's Neck in north Bengal in the wake of the Indo-China Doklam crisis in 2017, Lt Gen Kalita said "we are conscious about the importance

of the Siliguri Corridor to the nation as it connects the entire Northeast with the rest of the country and the narrowest part of it is only 20 km.

we have friendly relations with Bangladesh, Nepal, and Bhutan. But the distance from the tip of the corridor to the Chinese territory is over 40 km. We are conscious of the type of threat.....Requisite steps are being taken from the security point of view.'

The Siliguri Corridor is a narrow stretch of land bordering Nepal, Bhutan, and Bangladesh measuring approximately 170x60 km.

Asked about the Russia -Ukraine conflict, the senior officer said the armed forces and the government of India are aware of the developments and only time can say how it will further manifest itself.

"India is conscious of the dimensions of possibilities, lots of steps have been taken to address the concerns of both sides Our doctrines have also been reviewed," he said.

The Lt General said Indian

armed forces have also recently ensured "our capability enhancement takes place to cope with any type of challenge from any quarters. We are prepared to face contingencies...Our doctrines have also been reviewed."

On the 'Look East' and 'Act East' policy in the last couple of decades, he said as the first step to bringing peace and stability. there is a need for development and improving connectivity.

"For any sort of development, progress (the) first requirement is connectivity. One way to take forward the Look East policy is infrastructure development. We all need to contribute," he said, adding the infrastructure network has improved greatly in the region.

"The second issue is that of connecting with our neighbours and our armed forces are playing a big role. We have a rapport with the Myanmar army despite a problem persisting there now. We also have excellent ties with Bangladesh," he said.

He said the Look East, Act East policy entails conceptualising

and implementing various steps and promises, policies, and projects which should be taken forward.

On the repeal of the Armed Forces Special Powers Act from the entire Northeastern region, he said "it is not a constant thing. It is a dynamic process that is reviewed based on the situation and the ground reality, based on vital parameters. AFSPA has been totally withdrawn in many districts in certain states and partially in some other districts (in the northeast). Such decisions are based on the improvement in the ground situation. Wherever the situation has improved, AFSPA is withdrawn."

On the recent agitation and controversy surrounding the Agnipath scheme, he said "any new, big change coming in does take some time to settle in.

In June this year, the Agnipath scheme, relating to the recruitment of soldiers into the Army, the Navy, and the Air Force on a short-term contractual basis was unveiled.

31 Dead As Heavy Monsoon Rains Inflict Chaos On HP, U'khand; Odisha, Jharkhand Also Hit

Shimla: At least 31 people were killed, 22 of them in Himachal Pradesh alone, as heavy monsoon rains triggered flashfloods. landslides, and house collapses, upending normal life across large swathes of the country.

The fatalities included four each in Uttarakhand and Odisha, and one in Jharkhand.

Heavy rainfall in Himachal Pradesh since Friday caused landslides and flashfloods, with officials saying 22 people, including eight members of a family, died. Ten people were injured in the state which has reported 36 weather-related incidents.

As many as 743 roads, Manaliincluding the Chandigarh national highway at Mandi and the Shimla-Chandigath highway at Shoghi, have been blocked for traffic.

In Mandi alone, 13 people died and six went missing in flash floods and landslides triggered by heavy rainfall, Deputy Commissioner Arindam Chaudhary said. Those missing are feared dead, he said.

The Chakki bridge in Himachal Pradesh's Kangra collapsed due to heavy rains on Saturday, disrupting train services between Pathankot and Jogindernagar.

In Uttarakhand, a series of cloudbursts early Saturday killed four people, while 10 went missing as rivers breached banks, washed away bridges, and threw mud and waters inside houses, forcing evacuation of multiple villages.

As the gushing waters threatened more damage, a number of roads were blocked for traffic, while all Anganwadi centres and schools were ordered shut in the Pauri district of Uttarakhand.

Rains also pounded parts of eastern India, with Odisha - already reeling under floods in the Mahanadi river system with around 4 lakh people marooned in 500 villages reporting four deaths, and neighbouring Jharkhand one.

a change by stepping into the said field. The last time, owing to an unconventional question paper from the Jammu & Kashmir Public Service Commission (IKPSC), when Sumit was unable to get through his preliminary examination, his cousin had assured, "You'll crack it in the next attempt for sure. The first attempt is mostly a hit and trial."

Prior to the examination, Sumit had high hopes about it, given his level of preparation and the constant guidance

But hardly did he know that while his preparation was in accordance with the demands of the JKPSC, the latter had raised its standard up a notch and more, touching the heights of the Union Public Service Commission (UPSC) examination.

After the J&K Reorganisation Act came into effect on 31st October, 2019. post the annulment of the Article 370 in the same year, the first CCE was held by the JKPSC in the year 2021.

Much to the shock of aspirants, the question paper had shown an abrupt digression from the previous year papers. The level and standard had significantly gone up. The key observations included more reliance on the current affairs and an uneven distribution of questions from the various subjects that an aspirant is ought to prepare.

The bizarre thing though was the question paper demanding an exceptional knowledge of Science which ran contrary to the 'General Science' as mentioned in the syllabus.

Thus, while preparing their students for the upcoming year, the coaching centres and mentors thereby had kept the new standard set in by the JKPSC into consideration.

But considering the response of aspirants to the CCE of 2021, it was even floated that JKPSC had assured of not going out of the box while framing question papers in future. Whether what was floated in the name of JKPSC was true or not, the CCE 2022 was going to decide.

Thus, on the cloudy morning of 31st July, 2022, the many clouded minds of as many as 35000 aspirants were going to get the answer of the one guestion that had been haunting them for the past several months. The curtain was to be raised and this unveiling was decisive for all except few who were going to appear in the examination for the heck of it.

"As the clock struck 9:30 am and we were asked to open the seals of the question paper, my hands were trembling. As I took a glance at the entire paper, I was sure of not being able to qualify it," exclaims Zarnish while coming out of the examination centre. with a flustered face and a stammering tone.

Shaking his head in utter disappointment, Shakir, another aspirant, makes no bones aboutthe 'change' that has altered the exam.

"It was the toughest question paper ever," he says. "I had consulted the previous year question papers of the last 15 years and they were nowhere close to this one. I felt like I was appearing in the UPSC examination and not the StatePSC one."

In response to the weightage of Science in the paper which was anything but 'General' as mentioned in the syllabus, Gurdeep, a Post Graduate in Plant Sciences, says, "I wonder if JKPSC is planning to produce administrators or scientists! At one point of time, I felt like I am taking test for some kind of a Science Olympiad! Being a student of Science stream, I was unable to answer most of the questions, and that intrigues me to know about what others might've done!"

After the Paper-I shift was over, the aspirants were looking forward to the Paper-II (which happens to be of qualifying nature only).

The Paper-II aka the CSAT(Civil Services Aptitude Test) paper had never been much challenging and to qualify it was not so difficult a task considering the trend of the previous years' examinations, including that of the year 2021.

While Paper-I had dispirited some of the aspirants, others were stimulated to fight back in the next paper which was to be held in the second sitting of the day.

But then, again, the Paper-II was quite unexpected and hence as hard a nut to crack as the Paper-I for a majority of students, with a difficulty level of easy to moderate.

The second shift was over and scores of students came out of their examination centres grumbling and grousing about the exceptionally difficult exam that had left a disagreeable taste in their mouth.

Talking about this significantly altering-pattern of the CCE conducted by JKPSC and its close proximity with the UPSC exam, an Economics expert in 'Quintessence Classes for Civil Services', one of the reputed civil services coaching institutes of the valley. Tehleel Ahmad refrains from commenting on the JKPSC adopting a new standard in the afore-mentioned

But he makes it a point to mention that students opt for state-level PSC examinations for a reason. "They [students know that the standard is much more approachable here(state-PSC) as compared to UPSC," he says.

"In states like Haryana, Madhya Pradesh and Chhattisgarh, the state PSC exam is always a level lower than the UPSC exam and a level higher than other state-level exams.

However, commending JKPSC for taking its level of examination at par with the UPSC, Navdeep Singh-manager 'Bajirau IAS/KAS Academy Jammu' and a teacher of Indian Polity-believes that the factual and non-analytical nature of the JKPSC examinations in the past few years have rendered the J&K students incompetent to crack the UPSC-level examinations.

Singh welcomes the new standard ushered in by the JKPSC for its administrative examinations.

Vijay Kumar, a Bio-diversity, Environment and Ecology specialist at the Chanakya IAS Academy (Srinagar Wing), the leading institute in providing UPSC training to candidates all across the country, acquiesces to the fact that because the syllabi of UPSC and JKPSC are the same, students can expect a similar type of pattern but "raising the standard so much and so abruptly does not really go well with the students," he believes.

In response to the excessive thrust of JKPSC on Science since 2021 examination, Kumar believes that such guestions are consciously put there as part of a filtering technique, so that students are not able to solve them and the objective of preliminary examination is properly achieved.

Yet, he empathises with the aspirants, especially the ones who lack a Science background: "Now that JKPSC is conducting examination at par with the UPSC level, we need to train our students accordingly."

Seconding Kumar, Ishtiyaq Dar, who happens to be a civil services coach as well as an aspirant himself, identifies with the plight of the students. "We are not expecting a cakewalk

here," he says, "but if the level of our

state-PSC examination has been raised so much, let JKPSC raise the status of the job that the examination eventually aims at as well. Also, while other state-PSCs of the country have an upper age limit of 35, 37 and even 40 years in some cases, JKPSC should also take care of the same in case of J&K where the upper age limit to appear in the said examination is only 32 years. Justice should prevail."

Amid the debate over the changes, Peer Shujaat Amin, a serving KAS officer, believes that time has come to teach youngsters to keep up with the changing times and adapt themselves to the competitive era.

"We need to follow a proper way," Amin says."New systems and patterns should be ushered in gradually. Only then can they bring about a positive change. Abrupt changes are often

He said the projected 18-plus population in Jammu and Kashmir is around 98 lakh while the number of enlisted voters is 76 lakh.

"We are expecting an addition of 20 to 25 lakh new voters in the final list,' Kumar had said, adding the officials concerned have been asked to ensure the list is error-free and covers all eligible voters.

He had also said there is no need for a person to have a domicile certificate of Jammu and Kashmir to become a voter.

"An employee, a student, a labourer or anyone from outside who is living ordinarily in J-K, can enlist his or her name in the voting list. The documents will be scrutinised by government officials concerned who will take a decision after being satisfied with the claim," Kumar had said.

The advertisement published in local dailies by the Directorate of Information and Public Relations, stated the summary revision of electoral rolls is undertaken by the Election Commission from time to time according to the laid down process.

There is no change in the special

provisions for Kashmiri migrants for their enrolment in the electoral rolls of their native constituencies and the summary revision will cover existing residents of the Union Territory of Jammu and Kashmir, it said.

"They will continue to be given the option of voting at their place of enrolment or through postal ballot or through specially set up polling stations at Jammu, Udhampur, Delhi, etc," the advertisement said.

The administration said there have been media reports claiming over 25 lakh voters will be added to the electoral rolls once the revision process

"This is a misrepresentation of facts spread by vested interests. This revision of electoral rolls will cover existing residents of the Union Territory of Jammu and Kashmir and the increase in numbers will be of voters who have attained the age of 18 years as of October 1, 2022, or earlier," it said.

Mainstream political parties have alleged that "inclusion of non-locals was a clear-cut ploy to disenfranchise

the people of Jammu and Kashmir". To clear the air, the Jammu and Kashmir administration in the newspaper advertisement said the summary revision was to enable eligible young people to register themselves

Besides, it also allows a person who has changed his residence to enrol at new location by getting his name deleted from the electoral rolls at the earlier location, it said.

The number of electors in the Special Summary Revision of Jammu and Kashmir state in 2011 was 66,00,921 and the number in the electoral roll of the Union Territory now is 76,02,397, the Information Department said. "This increase is mainly due to the new voters, who attained the age of 18," it added.

The administration clarified there is no change in rules for buying property and getting jobs in Jammu and Kashmir and "have no link to the representation of voters or otherwise".

Welcoming the clarification, Jammu and Kashmir Apni Party chief Altaf Bukhari said "it was a victory for the people". He thanked Prime Minister Narendra Modi and Home Minister Amit Shah and said the clarification has put an end to the controversy. Earlier, the Congress said it will op-

pose the inclusion of non-local voters in the electoral rolls of Jammu and Kashmir and is mulling a legal challenge. The move is illegal, claimed AICC J-K in-charge Rajini Patil in Srinagar,

adding the Congress will attend the all-party meeting convened by Farooq Abdullah over the issue. The BJP defended the chief electoral

officer, saying his remarks are "legally and constitutionally" correct.

Chief spokesperson of the party's J-K unit Sunil Sethi said under law any citizen of India can choose to be a voter in any area, state or Union Territory. where he or she may ordinarily reside.

"The same is being made applicable to Jammu and Kashmir only. Post abrogation of Article 370, there has to be 'One India One Law'," he said and accused the other parties of trying to project a "wrong picture" while still living in pre-August 5, 2019.

"They are trying to create exceptions in Jammu and Kashmir which is not permissible. People have welcomed the decision (Article 370 abrogation) without exception or reservation. Political parties have to realise it and live with it," he said.

Pilgrimage To Mata Vaishno **Devi Shrine Resumes**

JAMMU: The yatra to the famous Mata Vaishno Devi shrine atop Trikuta hills in Jammu and Kashmir's Reasi district resumed on Saturday morning after remaining temporarily suspended overnight following heavy rains, officials said.

Over 1,500 devotees were allowed to resume the journey on the old track around 6.30 am from Darshani Dodi in Katra, the base camp for the yatra, they said.

However, the Himkoti (battery car) track which is also known as the new track, is still closed due to ongoing clearance operation, even as the helicopter service remained suspended due to bad weather, officials said.

The pilgrimage was temporarily suspended Friday evening following heavy rains in the Trikuta hills. Thousands of pilgrims were present at the shrine when it started raining heavily around 6 pm and continued till midnight.

Several videos shared on social media show flood-like situations on the Vaishno Devi track.

Chief Executive Officer, Shri Mata Vaishno Devi Shrine Board, Anshul Garg said there was no report of any casualty or damage due to the heavy rainfall.

gerly waiting to have darshan at the shrine," Kumar Yogesh, a resident of Madhya Pradesh, said while waiting in a queue of the yatra.

Delhi-resident Rita (45) said she heard about heavy rains at the shrine but still responded to 'Mata's' call. We are shortly leaving for the Bhawan to seek her blessings, she said.

Many pilgrims, however, were disappointed to return to the base camp without 'darshan' amid heavy rains.

"We were asked to return to the base camp by the security personnel. We are staying back to complete our yatra," Joginder Singh, a resident of Haryana, said.

He said panic had gripped the pilgrims on watching the water gushing down the hill but the shrine board management worked overtime for their safety.

The shrine board stopped the upward movement of the yatra from Katra late Friday evening as a precautionary measure in the interest of safety of the pilgrims.

It also accorded priority to yatris, who were holed up in Bhawan area, to come down towards Sanjichhat and then Katra under close watch of Shrine Board staff, police and CRPF officials.
