### **3 IAF Officers Sacked For Missile Misfire**

## **Two Shot Dead On LoC In Rajouri:** Army

## **1989 ABDUCTION CASE Court Issues Warrant Against Rubaiya Sayeed**

Jammu: A special court here on Tuesday issued a bailable warrant against Rubaiya Sayeed, the daughter of former Jammu and Kashmir chief minister Mufti Mohammad Sayeed, after she did not appear for cross-examination in a case related to her abduction by the JKLF in 1989.

Jammu Kashmir Liberation Front (JKLF) chief Yasin Malik, one of the accused in the case, appeared before the court from Delhi's Tihar Jail via video conference.

He once again insisted on his physical appearance while turning down the court's offer of legal aid or amicus, standing counsel for the CBI Monika Kohli said.

On July 15, Rubaiya had identified Malik and three others as the ones who took her captive.

Rubaiya was abducted near Lal Ded Hospital on December 8, 1989 when her father was the Union home minister and freed from captivity five days later on December 13 after the then V P Singh government, supported by the BJP at the Centre, released five militants in exchange.

Rubaiya, who stays in Tamil Nadu, is listed as a prosecution witness by the CBI, which took over investigation into the case in early 1990.

"Rubaiya had to appear before the court for cross-examination (on Tuesday) but she remained absent. The court has issued a bailable warrant against her to appear before the court on the More on P6

## Why You Should Really Stop Charging Your Phone Overnight

hat's the best way to charge an iPhone to get the longest possible battery life? I asked myself this question and decided to do some experimenting to find out. Before going to sleep, I used to do what millions of other people do: I put my iPhone on to charge overnight.

### But why do we do this?

An iPhone can go from zero to 50% charge in about 30 minutes using a 20W charger, and then go to being fully charged in under two hours.

Given that an iPhone can charge up so rapidly, it doesn't make sense that we hook it up to a charger for eight hours a day. That works out to a third of its lifetime.

Now, Apple has baked Optimized Battery Charging into iOS, which stops the iPhone from charging once the battery hits 80% and only adds the final 20% in time for you to wake up in the morning. But this still means that the iPhone is attached to power all night.

And it's still charging, albeit at a slower rate. This is how it stays at 80%.

#### Heat.

Heat is a killer of batteries. While there's nothing you can do about the normal wear and tear that a battery experiences from being charged and discharged, heat is something you can do something about. When your iPhone is connected to a charger, it gets warm -- warmer than if it isn't connected, and even though that increase might only be a few degrees above room temperature, doing this overnight, every night, doesn't seem smart to me.

So, I've radically changed how I charge my iPhone.

Rather than charge it at night, I give it a charge or two during the day. This is the charging schedule that works for me: I put it on for 30 to 45 minutes in the morning after I get up (I also charge up my Apple Watch at the same time).

Then I charge it around mid-afternoon for another 30 minutes or so to bring it to that 80% mark, which usually will be enough to see me through to the next morning.

Note that if I'm going to be spending a lot of time in the car or out and about, I'll also use a car charger or carry a power bank with me.

This system works well, and I believe it puts less stress on the iPhone's battery (time will tell) as well as the charger. It also makes me plan where I need my chargers, so I'm not just relying on a bedside charger.

And when I'm at home, working on the road, or traveling, this charging regimen hasn't let me down.

Because people always ask, I still charge using a cable rather



than wireless, and I use a 20W Anker Nano USB-C charger. For portable power banks, I've been using the candybar sized Anker 511 5,000mAh Power Bank and the larger 10,000mAh Anker PowerCore 10000 Redux. Both are portable, rugged, reliable, and fantastic power banks. Just don't forget to bring a charging cable!

As for in-car charging, nothing beats the super-fast, super-powerful 130W LinkOn USB-C charger, sporting both 100W and 30W USB-C ports.

### Update

There are so many good comments here that I feel it's worth taking some time to respond to some of the main themes. Several people have commented that "the battery does not charge all night," if you leave the device connected to a char-

Even with the Optimized Battery Charging feature enabled on an iPhone, it's still charging during the night. Why? Because even when it's just sitting on the nightstand the iPhone is using battery, and it's being topped up to stay at that 80% point. You can observe the charging/discharging on iOS chart by going Settings > Battery. Leave the iPhone off charge and it will lose charge overnight. When charging with Optimized Battery Charging enabled it will fast charge to 80% and then stay there until the final charge is added. It's only able to stay at that 80% because the battery is being topped up slowly.

And no, the iPhone doesn't run off the power being supplied to it over the cord, this is why the battery has to charge up a few percent before it will start up when completely flat. If you have a USB power meter handy, you can watch the iPhone draw charge periodically to keep the battery topped

up. Another point in this argument is that it doesn't matter how you charge the battery, and that Optimized Battery Charging somehow is a fix all for battery issues. But let's look at what Apple says about this feature:

With iOS 13 and later, Optimized Battery Charging is de-

signed to reduce the wear on your battery and improve its lifespan by reducing the time your iPhone spends fully charged. When the feature is enabled, your iPhone will delay charging past 80% in certain situations.

It reduces wear on the battery by limiting the amount of time the battery spends fully charged. It's a good mechanism, but by manually taking control of the charging, I find that I can choose to not push my battery into that fully charged place. There's also confusion in the comments about how many recharge cycles Apple rates the iPhone's battery as being good for before it's considered worn.

For the iPhone, it's not 1000 or 2000 recharge cycles, but 500.

"A normal battery is designed to retain up to 80% of its original capacity at 500 complete charge cycles when operating under normal conditions."

I also want to pick up on a point made several times about chargers, and how smart they are with all their double overcharge protections and all that.

Absolutely, modern chargers are good, with Apple's chargers probably being some of the very best. And even third-party switch mode power supplies are both very efficient and smart in that they can handle a variety of charging protocols. But I've seen the sketchy chargers that people use. I've also seen chargers "crash" and behave weirdly, which is why it's a good idea to occasionally unplug or switch off chargers so they "reboot" the chip that controls how they operate.

It's also worth bearing in mind that when it comes to chargers and the devices they charge up, the chargers, despite the brains that control charging protocols and watch out for overvoltage and overheating and such, are the dumber part of the equation.

While on the subject of chargers, a few people mentioned using slower 5W chargers to charge their devices. If you're someone who wants to charge overnight then this might be the better way to do it because it completely eliminates the issues associated with overheating and keeping the battery at 100% for extended periods.

Modern lithium-ion batteries are also incredibly smart, and they have safeguards in place against both overcharging and overdischarging (overdischarge is a very big deal because if you allow a lithium-ion battery to discharge below a certain voltage, it won't usually recharge by normal means). The final point I want to make here is that charging is com-

plex, and manufacturers are all boasting about how fast the battery charges and how long the battery lasts, and this is causing some manufactures to do things that aren't that smart (I'm looking at you, Android handset makers). But what hasn't changed are the habits and beliefs of the end users

Charging overnight used to be a necessity. Now it's a habit. But it seems to be a hard one to kick.







## Farmers Return

undreds of farmers from different reached Delhi on Monday to participate in a 'mahapanchayat' called by the Samyukta Kisan Morcha at Jantar Mantar, forcing the union government to beef up security at Delhi borders, including Singhu and Ghazipur. The farmer organizations have been demanding proper implementation of minimum support price (MSP) for crops. They have also sought the withdrawal of cases registered against the farmers during their year-long protest against the farm laws. Earlier on Sunday, farmer leader Rakesh Tikait was detained by the police at the Ghazipur border as he tried to enter the national capital to take part in the 'mahapanchayat'. One of the farmers' main demand is a legal guarantee for MSP. Rising unemployment is also one of the major issues. They are also seeking removal of the union minister Ajay Kumar Mishra whose son is an accused in the violence that took place last year in October in which four farmers and a journalist were among eight people killed. In addition, farmers are also demanding the withdrawal of cases against the protesters last year.

In November last year, Prime Minister Narendra Modi withdrew the three controversial laws following a year-long protest by the farmers against. Modi said the Acts were in the best interests of the nation and targeted to benefit large and small farmers, but it appeared the government had not been able to convince a section of the farmers and therefore, they were being withdrawn. The prime minister also promised that a committee of state and central representatives, farmers, and experts would be set up to make the minimum support price (MSP) mechanism more transparent and effective.

The protest was against the three farm laws: Farmers' Produce Trade and Commerce (Promotion and Facilitation) Act, 2020; the Farmers Empowerment and Protection) Agreement on Price Assurance and farm Services Act 2020 and the Essential Commodities (Amendment) Act, 2020. While the centre defended the laws as major reforms in the agriculture sector that will remove the middlemen and allow farmers to sell their produce anywhere in the country, the farmers contended that the legislations would eliminate the safety cushion of MSP and do away with the "mandi" system. They also feared that the laws would bring on the scene the corporates who would monopolize the trade and feel empowered to determine the market prices.

## **Not Hysterical**

## A Menstrual Disorder Suffered By Billions Of Women Is Still Dismissed Lightly

always suspected there was something wrong with the way I experience my periods. There were many days that I would feel the onset of PMS symptoms at least 10 days prematurely – bloating, mood swings, fits of rage. On some days I would be extremely motivated, on others I would find it hard to get the day started. There were times when I would isolate myself to prevent myself from bursting into tears or screaming at people. I always wrote off my symptoms as PMS, never questioning my experiences.

It was on Instagram that I first heard of Premenstrual Dysphoric Disorder (PMDD), and intuitively realised that this is what I was experiencing. The disorder has been defined in the Diagnostic and Statistical Manual (DSM-IV) of the American Psychiatric Association as "a cyclical, hormone-based mood disorder with symptoms arising during the luteal phase of the menstrual cycle [day 14 of the cycle] and subsiding within a few days of menstruation".

What I, and many of the women I spoke to, did not know was that PMDD is a serious condition that impacts 60 million worldwide and that it is reported by nearly 5.5% of women and AFAB (Assigned Female at Birth) individuals who are of reproductive age.

It is also a debilitating condition, as I detail later, which is barely recognised in India and many parts of the world: a global study by IAMPD of 591 patients diagnosed with PMDD published in BMC Psychiatry revealed that 34% attempted suicide.

However, I never went to a doctor because I could still deal with the symptoms. Things changed dramatically after my father passed away unexpectedly in April 2021. I then started experiencing a low I never felt before. These feelings were further triggered during periods and over the coming months, they worsened. On my birthday last year, I could barely function. I had bad meltdowns, could not talk to people, it was hard to even get out of bed and go to work.

At my lowest low, I forced myself to speak to a doctor who finally diagnosed me with PMDD.

### Dismissed As PMS

Poor awareness of the disorder and paucity of treatment options meant that on average, patients waited 12 years and visited at least 6.15 providers before receiving a diagnosis of PMDD, reported BMC Psychiatry.

"PMDD is a severe negative reaction in the brain to the natural rise and fall of estrogen and progesterone. It is a suspected cellular disorder in the brain. Symptoms can worsen over time and or around reproductive events such as menarche (the first menstrual cycle), pregnancy, birth, miscarriage, and perimenopause," states the International Association for Pre-Menstrual Disorders (IAMPD), a global research collective comprising those dealing with the syndrome states.

Delhi-based gynecologist Amodita Ahuiz tells me that PMDD is an aggravated form of PMS with some sharp differences. "PMS is something most women experience in their daily life, with a variety of symptoms ranging from 55 to 125 symptoms. These include feelings of bloating, fatigue, fluctuating moods, headaches, and cramps that generally last 2-3 days and then subside with the period. PMDD symptoms, on the other hand, are generally experienced 14 days before the start of the period. They are also more pronounced and take a physical, mental, and emotional toll on women leaving them unable to perform everyday activities. This may induce feelings of depression or anxiety," she said. PMDD, which falls in the DSM-IV Category of "Other Depressive Disorders", is unique because it is cyclic in nature. It can be diagnosed when a minimum of five symptoms are recorded during the premenstrual phase of the cycle or day 14 of the cycle. The symptoms generally worsen as menstruation closes in and they stop at the onset of the cvcle or a few days after the cvcle ends. "PMDD is an emotional distress disorder, it is almost like a temporary kind of depression that sets in during a certain phase of the menstrual cycle and then lifts when the cycle is over. It's different from other depression symptoms in a sense because it can cause symptoms such as restlessness, anxiety, catatonia, and irritability amongst other symptoms" says Nithya Rao, a counseling psychologist and the co-founder of Heart it Out, a counseling service based in Bangalore that also provides online consultations and therapy.

tary at Indian Institute of Health Management Research (IHEPA) and a youth advisory board member at IAPMD, she recalls that her experiences of PMDD were often dismissed by doctors.

"I always had symptoms of PMS growing up, which I knew was unique since I was a serious athlete who competed in several competitions including state- and national level competitions," she said. "As I grew older, my experiences and symptoms of PMDD began to worsen though I didn't know about the disorder then. When I approached doctors in India, my symptoms were always dismissed as PMS. I developed my own coping mechanisms. I started drinking more and this only worsened my condition. I eventually moved to the UK for my second Masters. Then as a result of a sudden Vitamin D deficiency, my periods became more irregular which further aggravated the symptoms. It was then that I went to a doctor, who unofficially diagnosed me with PMDD.<sup>3</sup>

The diagnosis that came after three months of tracking of symptoms, she said, came as a huge relief – finally she could put a name to her condition.

Among the earliest social media mentions of PMDD came from Shehla Rashid, a PhD student at JNU, who shared her story on Twitter.

"I always experience PMS. I find myself feeling upset or crying for no reason. The next day, I would get my period and I realized that it was happening because of that," she told me. "One night though, I was having a really bad episode. I was in so much pain, that all I could think about was killing myself and ending it all. I started reading into methods to make it as quick and painless for me. I fell asleep that night and when I woke up the next day, I started my period."

Rashid said she was disturbed enough by the experience to Google "periods and suicide" and stumbled upon PMDD. Her symptoms included acute psychological and physical symptoms. "My digestive system was completely thrown off, I would experience gastric issues and I would throw up. It was horrible. The diagnosis in itself was a relief but it brought with it another set of issues – at the time no one in India had spoken out publicly about PMDD, and there were few doctors in the country who knew about it," said Rashid. Her symptoms were later confirmed by a doctor.

It was after considerable search that she found support on social media and IMPD too reached out to her with help and resources. "As a student activist, I experience a lot of trolling on a daily basis. However, this was one space where I got support from all sections, both leftwing and right-wing," she said.

### Diagnosing PMDD

Korrapati tells me there is a lack of awareness in the medical fraternity about PMDD; it was only recently added to the International Classification of Diseases (ICD) created by the World Health Organization to code, classify and diagnose diseases. "Globally doctors are expected to undergo continuous examinations even after they get a degree so that they learn about new diseases or new lines of treatments." Birth control pills are not always effective in PMDD. "Before my PMDD was diagnosed, I was given birth-control pills which did not work for me at all. In fact, they only worsened existing symptoms. I was forced to stop after a month. When I was diagnosed I later realized that I had progesterone intolerance, which again is something that many people experiencing PMDD have experienced," said Korrapati.

My experience was similar – I was first treated with birth control pills and serotonin. But I reacted very badly to the pill and stayed with just serotonin though it did not entirely eliminate the symptoms of PMDD.

Korrapati told me she underwent a range of therapies and finally decided to go in for chemically-induced menopause. "I took cognitive behavioral therapy which worked really well for me. I also underwent EMDR treatment [eye movement desensitisation and reprocessing, a therapy commonly used to treat patients who have experienced trauma] which was really helpful. It is important to recognise that many people suffering from PMDD have experienced trauma. This really made a difference for me in the long run. However, I still experienced a lot of difficulties and issues with PMDD. I eventually decided to undergo chemical menopause," she said.

Chemical menopause is an alternative for PMDD patients who do not respond to available treatments. IAMPD defines it as a "temporary (and reversible) menopausal state created with the use of Gonadotropin-Releasing Hormone Analogues (GnRHa) – a type of drug which acts on the pituitary gland in the brain to suppress ovulation and production of ovarian hormones". By fully suppressing the menstrual cycle, the functions which lead to PMDD symptoms are eliminated.

"The key is to treat myself with kindness. I track my symptoms and I am aware of what happens during this period, and I make sure to substitute negative coping mechanisms with positive ones." Korrapati told me.

### **Problematic Narrative**

"It is important to recognize that our current health system is completely androcentric (malecentric)," said Korrapati. "Medical research for women is centered around the ideas of beauty and pregnancy, reflective of the larger sociocultural context. A large amount of research is focused on menstruation. The second feminist wave did bring a change in the perspective and it did lead to new research and documentation but even that, in a sense, was not concise. It was not patient-centric and contributed to a very problematic narrative that downplays the experiences of women during their periods."

Doctors point out that menstrual health continues to be a deeply stigmatized topic, discouraging women from being open. "Many were encouraged to make lifestyle changes, instead of the disease being treated as a serious condition," said Ahuja.

Rashid remembered having her problems mansplained to her "People told me that I

ers are not happy and remain skeptical about the government's intentions to meet their demand, especially the legal guarantee on MSP. Correct CUET Snags

of serving its stated purpose of simplifying the admission process to undergraduate courses, the new examinations have added to the stress of the youngsters. Server failures, admission cards being issued at the last minute and lack of clarity over examination centres have thrown unflattering light on the lack of preparedness of the National Testing Agency, the authority that conducts the CUET. Cancellations and rescheduling of the tests mean that the CUET will not be over before the last week of this month. Consequently, the admission procedure to the universities will stretch into September. This will, no doubt, have a spiralling effect on undergraduate timetables. The pandemic had upset academic schedules in the past two years. But the NTA must take much of the blame for this year's delay.

With an aspirant being allowed to appear in up to nine papers, resulting in more than 50,000 subject combinations, the CUET — conducted in more than 550 cities in the country and 13 foreign centres — is a much bigger exercise than the entry tests to the IITs or medical institutions. Over 1.4 million students have registered for admissions to undergraduate courses in 44 central universities, 12 state universities, 11 deemed, and 19 private universities. A lot of preparation should have gone into conducting an operation of this scale. For instance, the pivot to online education during the pandemic had shown up the country's digital deficits. The experiences of the past two years had given enough indications of the challenges the country's IT architecture would face in conducting the CUET. It's now apparent that the smooth conduct of the CUET will require an upgrade in the IT systems of at least the network of centres where the examinations are held. No time must be lost in making such improvements.

The CUET for post-graduate courses is scheduled to be held in the second week of September. Several academicians have questioned the MCQ format of these examinations. In an Idea Exchange with this paper, the Vice Chancellor of JNU, Santishree Dhulipudi Pandit, underlined that admission tests to masters-level programmes should assess the critical capacities of an aspirant and requested the government to rethink the format. The education ministry should take note of concerns such as hers. The CUET is a work in progress: The learnings from this year's experiences must not be lost on the NTA and other educational authorities. *Indian Express*

Rashid had to research on her own about the treatment for PMDD. "I was fortunate to receive a lot of resources from the online space which included IAMPD," she said.

According to Ahuja, for a PMDD diagnosis, it is important to figure out if the symptoms of depression or anxiety existed before or are linked to the menstrual cycle. But there are also resources available to track the symptoms and these can be shared with qualified professionals given the limited understanding of the problem. Services include a diagnostic app or a sheet that can be downloaded and printed and has been curated by IAMPD. The materials are also available on the website of Beyond Blood, a research and advocacy body set up in 2017 centered on menstruation and mental health.

### **Treatment Lines**

PMDD needs a comprehensive treatment plan that should ideally include a gynecologist, psychiatrist/psychologist, a lifestyle coach, and a dietitian, according to Ahuja. Since PMDD is linked to hormonal fluctuations, oral contraceptives may be prescribed. This stops ovulation and there will be no changes in the hormonal cycle. Counseling too is recommended to address the psychological symptoms of the condition.

Diet is also reported to have a significant impact on the condition: for example, a reduction in salt intake has been shown to reduce bloating; inclusion of Vitamin B6, magnesium, and essential fatty acids too is recommended. "It is important to recognize that the process of healing is not easy, that is why I would recommend a life coach who could help the patient incorporate all these changes in their life," said Ahuja. should not be having these thoughts and gave me advice without actually understanding the issue at hand. We continue to make fun of PMS." she said.

#### Looking Forward

Beyond Blood has launched programmes such as the Biological Reality Project, an auto photography storytelling project wherein participants photographed themselves so they could share their experiences of issues such as PMDD, Polycystic Ovarian Syndrome (PCOS), queer and trans menstruation, and menstruation among persons with disabilities.

"The landscape of medical research is slowly changing every day," said Korrapati. "Now, there are many more studies coming up that are qualitative and patient-centric. Many are conducted by PMDD patients themselves."

Working on this piece was a unique experience for me as a young journalist because I realized the commonalities of these experiences. I found solidarity and comfort in my conversations with Anuhya Korrapati and Shehla Rashid, who come from very different backgrounds. These solidarities have helped me find hope and given me the courage to be more outspoken about my own journey with the disorder.

## Muslim Leaders Should Focus on Social Issues

t seems as if every ruling party rakes up the issues related to the Indian Muslims deliberately over the years, before any elections particularly. Further, what confounds one is why do the Muslim religious leaders try to resolve the issues facing the community near these dates only, why don't they stick to their original plans? One fails to understand the reason that why did the AIM-PLB held a meeting to discuss the issue just two months before the assembly elections in some states.

The most recent example in this case is that of formulating the Model Nikahnama for the Indian Muslims, by the Muslim religious leaders, who had promised almost five years ago in 2017 that they'll draft the Model Nikahnama under the aegis of the All India Muslim Personal Law Board (AIMPLB), when they were rapped hard on the knuckles by the government on the issue of Talaq-e Biddat or the Triple Talaq.


In reality the religious leaders had drafted a model Nikahnama for the first time way back in 2003. But the ideological differences amongst different sects are such that they can't agree to have a consensus on any religious issue.

Though the Supreme Court had banned the practice of Triple Talaq in 2017 and in spite of several initiatives since 2003 to find a judicious process based on Islamic Fiqh (Islamic Jurisprudence), the leaders have been unable to do so and in fact none of them uttered any word either against the SC or the government when the SC gave its verdict in 2017, as they knew within their hearts that they had wrongfully given consent to or not spoken against the Triple Talaq.

Though after 2017, very few cases of Triple Talaq have been reported, yet the practice reportedly continues unabated, as it has not been condemned or banned by the Muslim leaders. Meanwhile, instead of focussing on how to find a way out of the impasse, the religious leaders continue with their slumber and feeding the community with rhetoriclaced pills.

They claim that the drafting of a new Nikahnama is being worked upon but shy away from mentioning any firm date by which it'll be finalised. This shows their commitment to the community, their followers and particularly Islam. They are unable to sit together and thrash out a strategy against an un-Islamic practice in one sitting of the learned ones. Yet they continue with the charade of safeguarding the Muslims of India.

The AIMPLB at one of its meetings earlier this month, continued with their obduracy

on not to insert a clause against instant Triple Talaq, as desired and dictated by the SC and which the Muslim Women (Protection of Rights on Marriage) Act, has made a criminal act.

Reportedly, they approached the issue in a round about manner and suggested amongst themselves to insert a clause on Talaq-e-Tafweez or delegated divorce. Thus, effectively trying to paint a picture that they haven't bowed to the government, but in fact turning a blind eye to an unIslamic practice, and suggesting yet another one on the applicability of which they'll have no say.

The new suggestion makes the issue not

only complex but also shows their desire to hoodwink the law. The leaders have proposed to insert a new clause called Talaq-e Tafweez based on Sharia. Talaq-e Tafweez is one of the most important forms of divorce under Muslim Law or Sharia, as it gives to Muslim women a right to divorce their husband without going to court of law. In this form of divorce a Muslim male can delegate his power of repudiation of marriage to a third person or to his wife also, at the time of marriage.

It further makes one wonder that if the religious leaders and jurists are unable to categorically ban the instant Talaq then what is the assurance that this new proposal will make the instant Talaq go away from our society? In fact, it makes them the butt of jokes and shows their obduracy and unwillingness to hear any sane word of advice.

Some members of the AIMPLB reportedly, even opined that Khula, the women's inalienable right to instant divorce, was a more viable alternative, so there was no need for the clause on Talaq-e Tafweez. Thus, in toto making a mockery of the whole issue.

In reality, a Nikahnama, which is essentially a contract between a groom and a bride, is based on the logic to specify to the women with all necessary terms and conditions of the marriage being solemnised. Its sanctity and the rights given to Muslim women is evident by the fact that the Wakeels (advocates) and two eye witnesses get the bride's consent to the marriage in absence of her parents to ensure avoiding any sort of pressure from her parents or relatives for the marriage. This is the practical and humane form of the Islamic Sharia, which tries to give every right to its women followers too, at par with her male counterparts.

But this and her other rights given to her by the Sharia, such as her Right to Inheritance in the assets and property of her father are often not followed and given to her by her male relatives. The religious leaders have also been unable to ensure that very bridegroom pays the Mehr (dower, which the husband has to pay to his wife) promised by him to his bride as soon as possible after the solemnisation of the marriage and preferably before the nuptial night.

The ponderable issue here is that when and how the old Nikahnama was given-up by the Indian Qazis. Historically, these earlier Nikahnamas used to contain every minor detail about the nuptial contract between husband and wife and very specifically listed out various rights of the wife.

Now a day, the Nikahnama, used in various Indian states varies from state to state and also from sect to sect, and is mostly a piece of paper stating the basic information about the two parties and contains no mention of the various rights and duties of both the husband and wife.

AIMPLB, which claims to be the highest decision making body of all sects of Indian Muslims should strive to get a modern Nikahnama drafted at the earliest. This should include the rights and duties of both the husband and wife and also guidance on how to ensure a long lasting marriage and if need be, then how to proceed with Talaq or divorce - a step which is despised most by Allah as mentioned in the Holy Quran. This document should not only have the social, economic guidance but also be guided by the Quranic teachings, otherwise it would be an effort in vain and will lead to further politicisation of the issue to be used by different political parties when it suits them.

## THE RISE OF 'DR. GOOGLE'

## The Risks Of Self-Diagnosis And Searching Symptoms Online

Virtual health care was adopted more widely during the CO-VID-19 pandemic, with many people accessing health-care providers remotely. However, easy and convenient access to technology means some people may choose to bypass health care and consult Dr. Google directly, with online selfdiagnosis.

Here is a common scenario: picture someone sitting at home, when suddenly their head starts pounding, their eyes start to itch and their heart rate rises. They reach for their phone or laptop to quickly Google what can possibly be wrong.

It's possible that the search results could offer accurate answers about the cause of the person's symptoms. Or the search might erroneously suggest they're well on their way to an early death.

As a researcher in the virtual care domain, I'm aware that online selfdiagnosis has become very common, and that technology has shifted the way health care is delivered.

### **PAGING DR. GOOGLE**

Online health information took on a new importance during the pandemic, when using online sources to assess COVID-19 symptoms and self-triage was encouraged. However, the act of self-diagnosis online is not new.

In 2013, it was reported that more than half of Canadians polled said they used Google search to self-diagnose. In 2020, 69 per cent of Canadians used the internet to search for health information, and 25 per cent used online sources to track their fitness or health.

Virtual care and online self-diagnosis share some beneficial traits, such as the convenience of not having to schedule an appointment, saving travel time to the doctor's office and avoiding waiting rooms. However, the key difference between virtual care and Googling symptoms is that there is no direct communication with a physician when self-diagnosing online.

Some may choose to self-diagnose because they feel it gives them greater control over their health, while others may find it helps them better communicate symptoms to their physician. Some patients may fear misdiagnosis or medical errors.

Over time, people can get better at diagnosing using the internet. Online sources can provide information and support for a specific medical condition. They may also be useful for people with ongoing symptoms who have been unable to get a diagnosis from health-care professionals.

Using the internet to learn more about a condition after being diagnosed by a health-care provider may be useful and may decrease the stress of a diagnosis if the sites consulted are trustworthy.

However, trying to select credible sources and filter out misinformation can be an overwhelming process. Some information found online has little to no credibility. A study focusing on the spread of fake news on social media found that false information travelled faster and wider than the truth.



### **RISKS OF SELF-DIAGNOSIS**

The risks of using online health resources include increased anxiety and fear. The term cyberchondria can be defined as someone experiencing a high amount of health anxiety from searching symptoms on the internet. Self-misdiagnosis is also a danger, especially if doing so means not seeking treatment. For example, if a person confidently self-diagnoses their stomach pains as the stomach flu, they may hesitate to believe their doctor's diagnosis of appendicitis.

There is also a risk of becoming so certain that one's self-diagnosis is

correct that it is difficult to accept a different diagnosis from a healthcare professional. Misdiagnoses can even be very serious if it results in failure to detect a possible heart attack, stroke, seizure or tumour.

Further risks may include increased stress on both the patient and doctors,

ineffectively taking or mixing medications and increased costs for treatments or medicines that may not be necessary.

### SOCIAL MEDIA AND MENTAL HEALTH

Social media has given people a voice to share personal health-related remedies and stories. The number of active social media users in Canada has increased by 1.1 million since 2021. This raises the question of how people may be influenced by what they see online and if it may affect health choices.

In 2018, a Canadian internet use survey examined reports of the negative effects of using social media. It revealed over 12 per cent of users reported feeling anxious or depressed, frustrated or angry, or envious of the lives of others.

Conversely, social networks have also enabled people with mental health problems to feel unity by sharing experiences and support. However, this may also have contributed to self-diagnosis (and potentially self-misdiagnosis) of mental health issues, such as anxiety and personality disorders. This can put people at physical and mental risk if it results in inappropriate treatments.

The reality is that online self-diagnosis cannot be prevented. But those consulting Dr. Google should be aware of the potential risks, confirm information found online with a healthcare provider and ask health-care providers for credible online sources of information about their diagnoses.

"We will decide whether to continue or end the protest hunger strike later in the day. We are prepared to fight till our last breath to compel the government to announce a holiday on September 23 on the birth anniversary of the Maharaja," he said.

Jammu and Kashmir Shiv Sena president Manish Sahni said the demand is linked to people's sentiments.

# J&K, New Zealand Governments To Jointly Develop Sheep Husbandry Sector In UT

Atal Dulloo Meets Delegates From NZ, Calls For **Giving Thrust To Mutton Production**

Chief Jammu: Additional (ACS), Agriculture Secretary Production Department, Atal Dulloo chaired a meeting with expert delegation from New Zealand in connection with survey of ruminant sector in Jammu & Kashmir. It is pertinent to mention that

a Memorandum of Cooperation has already been signed between Governments of Jammu & Kashmir and New Zealand for overhauling sheep husbandry sector in the region through transfer of technology, research and development, value addition and marketing areas.

The delegates from New Zealand included Consul General & Trade Commissioner, Ralph Hays; Director, Agribusiness Group New Zealand, Dr Stuart Ford; Science Impact Leader, AgResearch Ltd, Dr Warren King; and Senior BDM, New Zealand Trade & Enterprise, New Delhi, Sudha Palit.

In a powerpoint presentation, Technical Officer, Dr Rizwan Qureshi summarised the objectives of the collaboration. It was informed that due to past efforts, J&K has emerged as a major wool producing region of India.

The agreement between the governments, at present, involves development of model sheep farms, collaboration in the area of fodder production, addition of value to wool and mutton products and strengthening of disease diagnostics laboratories/ vaccine production units. It also aims at other areas like education of local veterinarians, artificial insemination and improvement of production and productivity of small ruminants through genetics.

Focus is also to be laid on bridging the deficit in domestic mutton production and consumption. At present, J&K procures a major part of its consumption quota from other states.

Speaking at the occasion, the Additional Chief Secretary called for giving major thrust to mutton production in J&K. We need to work with a vision for maintaining domestic advantage in wool production with the addition of features like processing, branding and marketing also, he said.

He said, 'over the years, we aim to produce a quality breed of sheep while becoming a net exporter of rams (male sheep) to other states'. He also assured of the government's inclination towards investing in development and improvement of farms as well.

The ACS welcomed assistance in the latest technology of artificial insemination and embryo transfer technology (ETT). Similarly, the ACS laid stress on increasing fodder production, incorporating improved disease control measures and for the capacity building of veterinarians. He also called for intervention of the experts in exploring untapped sectors like meat and carcass processing.

The visiting delegates also shared their aspirations and promised full cooperation for development of Sheep Husbandry sector in Jammu & Kashmir.

The officers present at the meeting included Secretary Agriculture Production in Department; Special Secretary, Agriculture Production Department; Director, Sheep Husbandry Kashmir; Director, Sheep Sheep Husbandry, Jammu; Director Finance/Planning, Agriculture Production Department and other concerned officers.

The incident had taken place on March 9 and Pakistan had lodged its protest with India the next day.

On March 11, the Defence Ministrv said the missile was fired accidentally and it landed in Pakistan.

The ministry had said then that it was caused by a technical malfunction in the course of the routine maintenance of the missile, adding the government has taken a serious view of the incident.

Defence Minister Separately, Rajnath Singh said in Parliament on March 15 that SOPs for operations, maintenance, and inspection of such systems were being reviewed.

Following the incident, Pakistan summoned India's Charge d'Affaires in Islamabad and conveyed its strong protest over the "unprovoked" violation of its airspace by the supersonic 'projectile" of Indian origin.

Maj Gen Babar Iftikhar, the Director-General of the Inter-Service Public Relations (ISPR) of Pakistan, said the unarmed projectile entered the Pakistani airspace travelling 124 km.

The Pakistan foreign office said the "super-sonic flying object" entered into Pakistan from India's Suratgarh and fell to the ground near Mian Channu city, causing damage to civilian property.

The Pakistan foreign office also called for a thorough and transparent investigation into the incident and demanded that its outcome be shared with Islamabad. (PTI)



Critically injured Assistant Sub Inspector Nandan Singh succumbed around 11:30 pm on Monday at the SKIMS hospital in Srinagar, an officer of the border force said.

A total of eight Indo-Tibetan Border Police (ITBP) personnel have been killed in this accident, he said.

Three critically injured personnel were recently flown in from Srinagar and admitted to the AIIMS trauma centre in Delhi for specialised treatment

Union Home Minister Amit Shah had visited them at the trauma centre last week and taken stock of the medical care being provided to them.

The border force, primarily tasked to guard the 3,488 km stretch of the Line of Actual Control (LAC) with China, was part of the comprehensive security deployment for the annual 43-day-long Amarnath Yatra that ended on August 11.
