Student Enrollment In Higher Classes Up During Last 3 Years In J&K

GER Increases To 7.7% In Higher Secondary Level In 2021, 1.7% In Secondary

SRINAGAR: In the last three years, Jammu & Kashmir's Gross Enrolment Ratio (GER) in higher secondary and secondary level has increased by over 7 percent and 1 percent, respectively, reveal the figures emerging from Government of India's latest Unified District Information System For Education Plus (UDISE+).

As per the reports accessed and analyzed by Kashmir Observer, J&K's GER since 2018 has increased to 7.7 percent in higher secondary level in 2021 and 1.7 percent in secondary

level in the past three years. The data available with Kashmir Observer states that in 2018-19 J&K's GER in higher

secondary level was 42.4 percent and in 2020-21 the figures increased to 50.1 percent. For the secondary level, in 2020-21, J&K recorded 59.8 percent against 2018-19's 58.1 percent. In 2019-20, J&K's GER in higher secondary level was recorded

THERE HAS BEEN A 14 PERCENT INCREASE **IN SCHOOL ENROLLMENT AGAINST** the previous year in J&K. Our earlier enrollment was 22,50,000 and today it is 24,24,000. Today, there are 10 lakh students enrolled in private schools and over 14 lakh in Government run schools. So, the change is quite evident."

Pertinently, in 2018-19 J&K had 28,654 schools including both secondary level and higher secondary level schools. However, in 2020-21, with an addition of 276 more schools, the total number of schools functioning in J&K increased upto 28,930. In 2019-20, J&K had

28,863 schools including both secondary and higher secondary level educational institutes.

Besides this, as per the reports, in 2020-21, J&K had a total 337787 students enrolled in secondary level, of which 179809 were boys and 157978 were girls. More on P6

NASA Tests New Moon Rocket, 50 Years After Apollo

Years late and billions over budget, NASA's new moon rocket makes its debut next week in a high-stakes test flight before astronauts get on

The 322-foot rocket will attempt to send an empty crew capsule into a far-flung lunar orbit, 50 years after NASA's famed Apollo moonshots. If all goes well, astronauts could strap in as soon as 2024 for a lap around the moon, with NASA aiming to land two people on the lunar surface by the end of 2025.

Liftoff is set for Monday morning from NASA's Kennedy Space Center.

The six-week test flight is risky and could be cut short if something fails, NASA officials warn. We're going to stress it and test it. We're going make it do things that we would never do with a crew on it in order to try to make it as safe as possible, NASA Administrator Bill Nelson told

The Associated Press on Wednesday.

The retired founder of George Washington University's space policy institute said a lot is riding on this trial run. Spiraling costs and long gaps between missions will make for a tough comeback if things go south, he noted.

It is supposed to be the first step in a sustained program of human exploration of the moon, Mars, and beyond," said John Logsdon. Will the United States have the will to push forward in the face of a major malfunction?"

The price tag for this single mission: more than \$4 billion. Add everything up since the program's inception a decade ago until a 2025 lunar landing, and there's even more sticker shock: \$93 billion. Here's a rundown of the first flight of the Arte-

ROCKET POWER The new rocket is shorter and slimmer than the Saturn V rockets that hurled 24 Apollo astro-

mis programme, named after Apollo's mytho-

logical twin sister.

nauts to the moon a half-century ago. But it's mightier, packing 4 million kilograms of thrust. It's called the Space Launch System rocket, SLS for short, but a less clunky name is under discussion, according to Nelson.

Unlike the streamlined Saturn V, the new rocket has a pair of strap-on boosters refashioned from NASA's space shuttles.

The boosters will peel away after two minutes, just like the shuttle boosters did, but won't be fished from the Atlantic for reuse.

The core stage will keep firing before separating and crashing into the Pacific in pieces. Two hours after liftoff, an upper stage will send the capsule, Orion, racing toward the moon.

NASA's high-tech, automated Orion capsule is named after the constellation, among the night sky's brightest. At 11 feet tall, it's roomier than Apollo's capsule, seating four astronauts instead of three. For this test flight, a full-size dummy in an orange flight suit will occupy the commander's seat, rigged with vibration and acceleration sensors.

Two other mannequins made of material simulating human tissue heads and female torsos, but no limbs will measure cosmic radiation, one of the biggest risks of spaceflight. One torso is testing a protective vest from Israel.

Unlike the rocket, Orion has launched before, making two laps around Earth in 2014.

This time, the European Space Agency's service module will be attached for propulsion and solar power via four wings. FLIGHT PLAN

Orion's flight is supposed to last six weeks from its Florida liftoff to Pacific splashdown, twice as long as astronaut trips in order to tax the sys-

It will take nearly a week to reach the moon, 386,000 kilometers away. After whipping closely around the moon, the capsule will enter a distant orbit with a far point of 61,000 kilo-

That will put Orion 450,000 kilometers from Earth, farther than Apollo. The big test comes at mission's end, as Orion hits the atmosphere at 40,000 kph on its way to a splashdown in the Pacific.

The heat shield uses the same material as the Apollo capsules to withstand reentry temperatures of 2,750 degrees Celsius.

But the advanced design anticipates the faster, hotter returns by future Mars crews.

HITCHHIKERS Besides three test dummies, the flight has a slew of stowaways for deep space research. Ten shoebox-size satellites will pop off once Orion

Commandos Deployed In Sensitive Areas

'AMMU- The Union Home Ministry has made all possible security arrangements to ensure incident free Lok Sabha elections in the state with the deployment of trained commandos of different para-military forces for the protection of VVIPs and candidates visiting sensitive and militancy infested areas of the state, especially Doda, Udhampur, and Rajouri-Poonch areas in the Jammu region.

According to well placed official sources, these measures have been necessitated in the wake of escalation of militant attacks on security posts and VDC and SPO pickets in these areas and Kupwara, Handwara and other places in the Kashmir valley.

The sources said that trained foreign militants, who had withdrawn from Kargil, had reportedly managed to reinfiltrate in the Kupwara and Poonch sectors with a 'definite plan of escalating violence and subversion in the state during the coming Lok Sabha elections.' These insurgents had formulated a special contingency plan of subversion and were waiting for the green signal from their masters from across, they sources said.

Besides deployment of commandos and additional troops in sensitive areas, the Village Defence Committees (VDCs) have been equipped with highly sophisticated and automatic weapons to counter possible militant attacks during the forthcoming elections, the sources said and added that constant vigilance was being exercised in sensitive border areas of the state.

Cosmetic Approach

The Mufti Muhammed Syed government is very similar to a beauty queen.

t has a cosmetic approach to dealing with people's problems; favouring slogans over intelligent solutions. It is more interested in frivolous issues that they believe will win them votes than the boring, basic problems of the state such as electricity and roads.

On Monday, the Jammu and Kashmir administration revived the dead guest control order to infuse austerity in marriages. Observing moderation on social occasions should be welcomed, but the question arises as to what prompted the government to invoke this dead order.

At this moment in time, there is no apparent reason. There was a good reason in the past.

The seeds of the 1973 Guest Control law lay in the states persistent shortage of food grains as a result of drought or floods.

In 1973, the state was providing subsidy on food grains to compensate for a bad harvest. Despite the shortage of food, people continued to throw marriage feasts. The state was basically subsiding the valley's parties, and the Guest Control law was introduced to stop the government incurring unnecessary losses. The law was repealed in 1984.

The government does not now subsidise food and the categorization of ration tickets on the basis of income has been abolished. Rice and other basic foods, which used to be distributed to the public through the Food and Supplies Department, now overflow the cities markets at cheaper prices than those fixed by the government. Indeed, the Food and Supplies department, previously such a lifeline for the valley, is now irrelevant in the eyes of most people.

The department, now known as the department of Consumer Affairs and Public Distribution System, is only important to those ministers and senior officials who like to take their fill of the public's money -- run by a mafia who have grown obese eating into the vitals of this organization.

Despite fierce competition from other departments, the CA & PDS has earned distinction in the field of scandals, working hard to cover scams as wide ranging as the disposing of gunny bags to the procurement of essential commodities.

Instead of wasting his breath on frivolous issues such as weddings and wazwan, the Minister of CA & PDS should be calling for a revival of the crumbled public distribution system, particularly in rural and kandi (dry) areas.

He needs to be reminded how many marriages actually take place in the city of Srinagar in the course of a year. And how many are celebrated with pomposity. It is a minuscule of number of affluent people who spend lavishly on marriages.

After 1990 there was a tide of change in people's attitude towards society; many did not feel like celebrating and people voluntarily observed austerity in marriages and deaths.

Greater extravagance in marriage celebrations should be seen in a positive light; as an indication of a healthy economy and a more optimistic people. And the money spent on these parties does not go to the moon, or even down the drain. It benefits ordinary people who are employed as decorators, painters and of course wazas.

The guest control order only provides another baton to police and officials of the CA & PDS to harass people.

Reading the Tectonic Clock in Kashmir

We must learn how to use the tectonic clock in our favour to avert devastating earthquakes



arthquakes occur when rocks fail to accommodate stress. Initially, rocks will deform and try to compensate for stress, which usually results in topographic changes such as uplift, subsidence etc. Once the stress exceeds what rocks can accommodate, they strain and eventually break. The sequence of earthquakes in the Jammu and Kashmir region should be experiencing strain release, which tells us that rocks are at a stage where breaking is possible. I have checked the depth of faulting, and it seems the rocks are breaking at 5 to 10 km depth, which is very shallow, and if it forms a significant fault, it could be dangerous.

Unfortunately, we do not know the type of faulting because of the small size of the quakes. However, the pattern of earthquake occurrence in the south of the Kashmir Basin is a reflection of internal faulting, which means that such earthquakes could be associated with faults other than the major Himalayan faults, such as the Himalayan Frontal thrust, Main Boundary fault, etc. It is good news because the maximum size of an earthquake on the fault that would accommodate the ongoing earthquakes in the J and K regions should not exceed magnitude 8.0 and would ideally be expected to fall between 6.0 and 7.0. If it reaches 7.0 and 7.5, it will cause considerable damage in the region, potentially cascading into a series of other issues such as landslides, floods, liquefaction, and so on.

Earthquakes in our part of the world are happening because of the ongoing collision between India and Eurasia, two continental plates that started their journey to collide a long time back. Therefore, no one can stop them from collisions, humans can not do that, and we have no technological advancement to stop it. Actually, stopping collisional tectonics would create more problems than solutions, which we can discuss later in another post. Therefore, we cannot stop earthquakes from coming; they will come, only time is unknown. I think that unknown time is a clock for us which is ticking. If we do not understand how to respond to the time given to us by the natural clock of faulting, we will turn a hazard into a major disaster, which will be our failure as a scientific, social, and responsible community.

Assuming there will be a big earthquake in the coming days, what could we do? Noth-

ing much. Our houses are a pack of cards with no structural integrity to withstand ground shaking, which will become a catastrophe. We are not ready to face a big earthquake, which is something we should think about, and it should give us sleepless nights until we find a way to deal with it.

It is a challenge for all of us, and we have to solve it together. How?

Let us start. The administration can draft

a possible document where auditing of buildings will be done within a few months, and action-oriented planning will follow the auditing procedures to ensure what needs to be done to prepare the region for significant earthquakes. It should ideally involve a committee on earthquake hazards, which will work on one goal, how to stop an earthquake from becoming a disaster. It is possible, and we have all the resources to do it, but what it needs is a will, which is where we are lacking.

We have to first draft in our mind a solution on how to live with earthquake hazards. It is where the will is needed; once we have it, the road towards achieving that goal will come nearer. As I said earlier, tectonic interaction between India and Eurasian plates gives us time to reflect, and if we don't, it will turn our region into what we saw in the neighbouring Muzaffarabad in the 2005 earthquake. Therefore, we must learn how to use the tectonic clock in our favour.

Earlier this month, British publication The Economist, published an article titled, "Why women are fatter than men in the Arab world". This overtly racist and sexist headline reflects a pandemic of focus on the appearance of Arab women that spreads beyond this one writeup to Western mass media and popular culture as a whole.

The piece didn't have a byline, so we have no notion of whether the author has ever visited the Middle East, let alone Iraq and Egypt — the two countries the article stereotypes with sweeping statements.

Generally speaking, it is scientifically accurate that women across the globe are biologically prone to a higher body fat content than their male counterparts. According to the Centers for Disease Control and Prevention (CDC), women in the United States are nearly twice as likely to be severely obese compared with men. Yet we don't see a flurry of articles published about the causes of obesity in American women using gross generalisations of lifestyle in the West, whether it is the drivethrough culture or an addiction to fast-food dining.

family members myself who compete in a variety of sports, I was saddened to read the author conclude that "in any case, headscarves and clothes that cover the female body make public exercise cumbersome". I cannot imagine how disillusioned this could make young hijab-wearing aspiring athletes feel. Olympic medallists like Ibtihaj Muhammad and Hedaya Malak, who wear the hijab, would probably have a lot to say about this writer drawing conclusions on their behalf. After all, the German gymnastics team was rightly praised for refusing to wear bikinicut leotards at the Tokyo Olympics in protest against the sexualisation of their sport.

Other stereotypes fuelling the article range from women opting to be housewives over a working life or submissive women crumbling to the demands of the oppressive men in their lives. These generalisations negate the trailblazing work of women role models across the region, such as Iraq's Thikra Alwach, who in 2015 became the first female mayor of a capital city in the Middle East, a feat yet to be accomplished in London, for example.

Whether it is the incessant push to ban them from wearing the headscarf in France or their over-sexualization in media, the mainstream Western emphasis on the appearance of Arab women masks their successes. The world's first university was founded by Fatima al-Fihri, an Arab woman, in 859 AD. More recently, architect Zaha Hadid left an indelible mark on her field. You'll rarely hear — or read — about them.

Films and TV shows have perpetuated this problem. According to a study by the University of Southern California Annenberg, only 24 percent of all Muslim characters in Hollywood (and there aren't that many) are women. They are usually characters who are weak, oppressed or are included for their perceived exotic beauty, according to the Geena Davis Institute.

Remember how Disney portrayed scantily dressed Princess Jasmine in Aladdin in hypersexualised refashioned Arab attire? In James Bond's The Spy Who Loved Me, the Arab women included were objectified to the point that their characters were credited as "Arab beauty 1, 2, 3"

and so on. Recent productions like Netlix's Elite or Apple TV's Hala have drawn criticism for perpetuating the trope that Muslim women need to break away from their traditions in order to enjoy any autonomy or agency.

autonomy or agency.

The Economist article cites Iraq's Enas Taleb, "an actress with ample curves," as the "ideal of beauty" that many in the Middle East supposedly aspire to. Surely, Taleb's popularity could also be related to the charisma she exudes on screen and not merely the objectification of her "ample curves"? Since the publication of the article Taleb has sued The Economist, accusing the publication of body shaming her publicly by labelling her fat.

Arab women have far more to offer than simply their superficial beauty. It's time we give them the credit they deserve and not fixate on their weight, dress or looks.

We should instead be highlighting stories like how Nelly Attar became the first Arab woman to summit K2 recently or how Ons Jabeur became the first Arab woman to reach the final of a Grand Slam at Wimbledon last month. Obsessing over these kinds of stories may inspire both Arab men and women to take up healthier lifestyles. They also remind us that the stereotypes perpetuated by Western mass media are just that: stereotypes.

Is Secondhand Screen Time The New Secondhand Smoking?

he Environmental Protection Agency first warned of secondhand smoke in 1991, some 30 years after scientists determined that smoking cigarettes causes cancer. Today, a growing body of research points toward a new indirect health hazard.

Just as frequently being around other people while they smoke can cause cancer, heart disease, lung disease and other ailments, what I call "secondhand screen time" could be endangering children.

By not limiting their own phone use, parents and other caregivers may be unwittingly setting kids up to be addicted to screens.

AN ADDICTION

A decade ago, the unwillingness or perhaps the inability - of the college students in my writing classes to stay off their phones for 50 minutes at a stretch catalyzed my interest in screen use. And my students have only grown more unwilling to put down their phones, a trend that has also gotten worse outside of my classroom

Curious about my students' phone use, I began researching screen addiction and conducting my own surveys. Roughly 20% of my students have used the word "addiction" when describing their phone habits, and many more have expressed misgivings about their phone use.

While I encourage them to examine their habits, I blame students less for their tech addiction than I did a decade ago. They've learned this behavior from adults – in many cases since the moment they were born.

Checking Twitter in front of kids is not the same as blowing smoke in their faces. Smartphones and cigarettes do, however, have some things in common. Both are addictive and both became wildly popular before researchers learned about their addictive properties and health dangers.

On average, American adults touch their phones over 2,500 times a day. According to the American Psychiatric Association, that fits the definition of addiction: "a condition in which a person engages in the use of a substance or in a behavior for which the rewarding effects provide a compelling incentive to repeatedly pursue the behavior despite detrimental consequences." While researchers continue to study the effects and ex-



tent of phone use, the scientific consensus is that phone addiction is real.

DESIRING OBJECTS

What's a parent to do while nursing or when an infant falls asleep on one's chest?

Perhaps they'll read the news, check email, text friends or scan social media parenting groups. A phone or tablet can be a portal to the rest of the world – after all, caring for small children can be isolating.

But kids, even babies, notice these habits. They see parents reach again and again for a seemingly magical object that glints and flashes, makes sounds and shows moving images.

Who wouldn't want such a wonderful plaything? Trouble is, if the desire for a phone builds in infancy, it can become second nature.

TROUBLING RESEARCH

Some researchers have already found links between excessive screen time, particularly phone use, and attention deficits, behavioral issues, sleep problems, impaired social skills,

loneliness, anxiety and depression.

Researchers from Cincinnati Children's Hospital Medical Center and Israel's Educational Neuroimaging Center recently published a study in JAMA Pediatrics that focused on cognitive-behavioral risks of exposing preschool-aged kids to screen-based media. That includes video games, TV, websites and apps. Phones are particularly problematic, the study found, because they provide mobile access to all of this media. They found that screen exposure impedes the formation of nerve systems involved in language development, expression and read-

These findings point to yet another consequence of excessive screen time, especially for younger kids. Since 96% of Americans have phones, many babies are exposed to screens soon after they're born and the stakes of such exposure are becoming better understood.

To be sure, it's hard if not impossible to assess how much time Americans are spending looking at

screens given the countless different ways that people use their devices. And because not all screen time is equally good or bad for you, some experts are calling for a "Human Screenome Project" to assess what we're doing on our screens and to figure out what the consequences might be.

DEVELOPING BRAINS

When younger kids are exposed to harmful, habit-forming behaviors, such as smoking cigarettes or gambling, they're more likely to become addicted to those same substances or behaviors. Exposure to secondhand smoke itself also can make kids prone to cigarette addiction.

While scientists don't yet know for sure if that happens to kids who observe their parents' phone use, there's ample evidence that kids learn from and mimic their parents' behaviors. If children see their parents do something they're not allowed to do, that behavior doesn't seem bad or wrong, and they may desire the "forbidden fruit" all the more.

My mom, a lifelong smoker, had her first cigarette when she was 12. After dinner one night, her parents, both of whom smoked multiple packs of unfiltered cigarettes each day, lit up and her dad handed her the pack. This was in the 1950s, before people knew the effects of smoking.

When she took a drag, instead of coughing, she felt like she'd "died and gone to heaven." My mom's parents smoked so often in front of her that she both wanted to do it and knew exactly how.

When I see toddlers navigate smartphones as though they were born using them, this story springs to mind.

I've seen parents hand over iPhones to 2-year-olds to placate them in restaurants, just as mine sometimes plopped me down in front of the TV to keep me occupied. The difference is that I couldn't bring the TV to the dinner table, or anywhere else.

John Hutton, a pediatrician who researches the effects of phone use, has found that roughly 90% of U.S. babies are exposed to screen time before their first birthday, and that it's not uncommon for 2- or 3-month-olds to watch phones.

BREAKING OLD HABITS

The human brain continues developing until we're roughly 25 years old, so teenage behavior can have a significant and lasting impact. Research indicates that the adolescent brain is particularly prone to risk-taking, peerseeking and lack of impulse control.

Between that and a lifetime of fetishizing screens, is it any wonder that so many teenagers won't put their phones down?

My college students describe the disconcerting and disappointing quiet that sets in when they're at a table in the dining hall or in someone's dorm room and everyone's deep into a phone. Phones facilitate an incalculable amount of important interactions for them, especially with friends and family back home.

But by the time they're in college, they can recognize and articulate at least some of what they're missing when they spend so much time staring at screens. They can assess their own habits and implement some changes if they so choose, but it makes sense that they, having been raised with this techno-magic, would never think of giving it up.

A 2-month-old or a 2-year-old, however, can't do that. Since the frontal cortex of an adolescent brain is still developing, teenagers aren't fully able to reason or control impulses.

Perhaps, most adults can't either. But since it's up to today's adults to shape younger generations, we should be aware of the secondhand effects of our own behavior.

People sometimes use a colon after a greeting in correspondence, famously after "To Whom it May Concern." This usage was cool

All the cool people add a spaces after a colon. Capitalizing after a colon is not cool, except in a few situations. If you're introducing a list, capitalize the first word after the colon only if it's a proper noun.

If the second phrase after the colon can stand as a complete sentence, you generally don't capitalize it, but some people maintain that you can capitalize it if it's a longer sentence. (Some people think Pablo Honey is a better album than OK Computer, but that doesn't make them right.) [Editor's note: This site's style is to capitalize standalone phrases after a colon, so. Also, OK Computer is overrated.

If you want to dig as deeply into the colon as you dig into the crates at your local used record shop, consider the double colon. It looks like this: "::" and is used in analogies, famously on SAT tests. When writing an analogy, instead of writing: "W is to X as Y is to Z," you can write "W: Z:: Y: Z" As in the following analogy:

Dag Nasty: 1986:: My Chemical Romance

Double colons are also used in some programming languages too, but I can't tell you how because I am not a nerd.

HOW TO USE A SEMICOLON: WE SHOULD PROBABLY GET RID OF THEM ENTIRELY

The semicolon has three uses: linking independent but closely related clauses, combining sentences with a conjunctive adverb followed by a comma, and replacing commas in lists if the comma would be confusing. Semicolons are not used to link an independent and a dependent clause like the colon or the comma.

If periods are too mainstream for you, you can use either a colon or a semicolon to separate two closely related independent clauses. It gets a little hair-splitty when you try to determine which to use when though. This mixed-up state of affairs is partly because these two marks tend to be used differently in the U.K. and the U.S., but overall, the semicolon reads as a little more conversational. The colon is a bit more formal. Compare the following:

That was the best show ever: Galaxie 500 played with its original lineup.

That was the best show ever; Galaxie 500 played with its original lineup.

Subtle, right? But if you're into semicolons, you have to be comfortable with ambiguity.

Things clear up a lot when you get into conjunctive adverbs like "moreover," "nevertheless," "however," and "also." These should include a semicolon, as follows:

She put on a Moby CD; consequently, I asked her to leave my home.

The semicolon's real starring moment comes when you are presenting a list that would be confusing if you separated it with commas, as in the following:

The lineup of Joy Division was Ian Curtis, vocals; Bernard Sumner, guitar and keyboard; Peter Hook, bass; and drummer Stephen Morris.

A FINAL, IMPORTANT NOTE ON COLONS

If you are old enough to understand the musical references I have been making, you should schedule a colonoscopy every five years.

Student Enrollment

In 2018-19, enrollment of students in secondary level in J&K was 3,22,717, of which, 171863 were boys and 150854 were girls. In 2019-20, J&K had a total of 328628 students enrolled in secondary schools of which 174451 were boys and 154177 were girls.

The report also added that in 2018-19, J&K's total student enrollment in higher secondary schools was 231398 including 123040 boys and 108358 girls. In the same category, in 2020-21, J&K had 276212 student enrollment including 149205 boys and 127007 girls.

As per the report, in 2018–19, there were 170449 total teachers in J&K including 90865 male and 79584 females. In 2020–21, there were 172129 teachers in J&K of which 90119 were males and 82010 females. In the same category, in 2019–20, J&K had 173183 teachers including 91087 males and 82096 females.

The report further added that in 2020-21 the Teacher Pupil Ratio (TPR) was 12 in secondary level and 26 in the higher secondary level. Similarly, in 2018-19, J&K's TPR was 13 in secondary level and 21 in higher secondary level. In 2019-21, J&K's TPR was 12.1 in secondary schools and 20.2 in higher secondary.

According to the data, the enrollment of Children with special needs (CWSN) was 21289 including 12312 boys and 8977 girls for the Primary to Higher Secondary (1 to 12) category in 2020-21. In 2018-19, the report said that total enrollment of CWSN was 26722, of which, 15271 were boys and 11451 were girls.

In 2019-20, the total enrollment of CWSN was 23629 of which 13319 were boys and 10310 were girls.

As per the data, in 2018-19, the Net Enrollment Rate (NER) of J&K in secondary level was 33.4 percent including 33.1 percent boys and 33.8 percent girls. In higher secondary, the NER was 24.4 percent including 24.6 percent boys and 24.1 percent girls.

As per UDISE 2020-21, J&K's NER was 67 percent including 67.4 percent boys and 66.5 percent girls in secondary level. The higher secondary's NER in the same year stood at 56.5 percent including 55 percent boys and 58.3 percent girls

It is pertinent to mention here that the School Education Department has been on toes for the last couple of years to enhance enrollment in schools especially in the far flung areas. One of the initiatives was the Enrollment Drive, run by the School Education Department to enroll more children in government schools in order to ensure universal enrollment and retention of children in government schools.

Talking to Kashmir Observer, Project Director, SAMAGRA Shiksha Deep Raj said that several initiatives from the Government have helped to improve the condition of the education sector in J&K.

"There has been a 14 percent increase in school enrollment against the previous year in J&K. Our earlier enrollment was 22.50.000 and today it is 24,24,000. Today, there are 10 lakh students enrolled in private schools and over 14 lakh in Government run schools. So, the change is quite evident. Earlier, J&K ranked 17th in the National ent Survey and today we[I&K] rank 6th in the survey," Deep Raj told Kashmir Observer, adding that the Education Department is working on an action Plan which will ensure that student enrollment in schools increases in next two years and no student drops out of school.

her as a nominal figurehead and alleging that all important decisions are being taken by Rahul Gandhi or rather worse his security guards and PAs".

Azad, whose resignation from all positions in the party, including its primary membership, comes ahead of crucial organisational elections, accused the leadership of committing a giant fraud" on the party in the name of "farce and sham" internal polls.

He said no such exercise had taken place at any level and lists were being prepared by the coterie that runs the

In his scathing criticism of the leadership, particularly Rahul Gandhi, the 73-year-old termed the former Congress chief a "non-serious individual at the helm". Proxies, Azad wrote

to Sonia Gandhi, are being propped to take over the leadership and they will be nothing more than "a puppet on a string".

Azad has been almost a constant in the party's decision-making processes through the decades -- the Sanjay Gandhi days and the tumultuous Emergency years under Indira Gandhi, the Rajiv Gandhi era, the Narasimha Rao period and eventually the tenure of Congress' longest serving president Sonia Gandhi who he addressed his blistering missive to.

A member of the G-23 group that sought change in the Congress, he told her the party had "lost both the will and ability under the tutelage of the coterie" running the affairs of the party to fight for what is right for India.

A "remote control model" had demolished the institutional integrity of the UPA government and now the Congress party, the former Jammu and Kashmir chief minister alleged in the often emotive, angry letter detailing his grievances.

"Unfortunately, after the entry of Rahul Gandhi into politics and particularly after January 2013 when he was appointed as vice president by you, the entire consultative mechanism which existed earlier was demolished by him." Azad wrote.

All senior and experienced leaders were sidelined and the new coterie of inexperienced sycophants started running the affairs of the party," he alleged.

Azad said the Congress at the national level has conceded political space available to the BJP and state level space to regional parties

"This all happened because the leadership in the past eight years has tried to foist a non-serious individual at the helm of the party," he alleged.

"The AICC leadership is squarely responsible for perpetrating a giant fraud on the party to perpetuate its hold on the ruins of what once was a national movement that fought for and attained the Independence of India," Azad lashed out.

"Does the Indian National Congress deserve this in the 75th year of India's independence is a question that the AICC leadership must ask itself."

In fact, before starting the Bharat Jodo Yatra -- the party's ambitious campaign across 12 states -- the leadership should undertake a 'Congress jodo' exercise across the country, he said.

"Unfortunately, the situation in the Congress has reached such a point of no return that now 'proxies' are being propped up to take over the leadership of the party. This experiment is doomed to fail because the party has been so comprehensively destroyed that the stiduation has become irretrievable," he

Azad also dwelt on the Congress' electoral debacles.

Under Sonia Gandhi's leadership since 2014 and subsequently that of Rahul Gandhi, the Congress lost two Lok Sabha elections in a humiliating manner and 39 of the 49 assembly elections held between 2014 and 2022, Azad wrote.

"Since the 2019 elections the situation in the party has only worsened. After Rahul Gandhi stepped down in a 'huff' and not before insulting all the senior party functionaries who have given their lives to the party in a meeting of the extended working committee, you took over as interim president, a position that you have continued to hold even today for the past three years, he went on to say.

The former Leader of Opposition in the Rajya Sabha also brought up the incident of Rahul Gandhi tearing an ordinance before the media during UPA

"This 'childish' behaviour completely subverted the authority of the prime minister and the Government of India. This one single action more than anything else contributed significantly to the defeat of the UPA government in 2014...,"" he claimed.

Referring to the letter written by him and 22 other leaders in August 2020 to flag the "abysmal drift" in the party, he said "the coterie chose to unleash its sycophants on us and got us attacked, vilified and humiliated in the most crude manner possible".

In its counterpunch, the Congress said the contents of Azad's letter were "not factual" and its timing "awful", coming when the entire party organisation was engaged in combating the BJP on key issues like price rise and polarisation.

A man who has been treated with the greatest respect by the Congress leadership has betrayed it by his vicious personal attacks which reveals his true character, Congress general secretary in-charge communications Jairam Ramesh tweeted, adding that "GNA's DNA has been Modi-fied".

Hitting out at his former colleague, the party's media department head Pawan Khera added that Azad became restless as soon his Rajya Sabha term got over. He can't stay without post even for a second, Khera said.

"We have seen the love between Narendra Modi and Ghulam Nabi Azad, it was also seen in Parliament. That love has been manifested in this letter," he

Asked about Rahul Gandhi tearing the ordinance brought by his party, Khera said Azad did not speak out then as he was holding a post.

"If you think it was wrong, you would have thought it to be wrong then also, why were you silent then. That means you are selfish, your mouth gets shut before a post. Now you don't have a post and therefore you are speaking," Khera

Congress sources also rejected Azad's reported criticism that he was not properly consulted before a rejig of the Jammu and Kashmir's Congress unit.

Azad participated in four meetings at the party's 15 GRG 'war room' on Kashmir unit rejig with the last one being on July 14, sources said.

8 Azad Loyalists

are contemplating to resign, the sources said.

Former ministers R S Chib, G M Saroori and Abdul Rashid; former MLAs Mohammad Amin Bhat, Gulzar Ahmad Wani and Choudhary Mohammad Akram; former MLC Naresh Gupta and party leader Salman Nizami have resigned in Azad's support, sources said.

"Over the years as a member of the Congress Party, it has been my sincere endeavour to work for the betterment of my State - Jammu & Kashmir. I feel that in the prevailing circumstances, the Congress Party has lost its momentum in contributing towards the future of my State.

"Keeping in view the turmoil that the State of J&K has witnessed over the past decades, the people require a decisive leader like Azad to guide them towards a better future. I feel that the Congress Party has not been able to play the role that is expected of it," Chib said in his resignation letter addressed to Congress president Sonia Gandhi.

Saroori, a former vice president of J&K unit of Congress, along with several other leaders met Azad in Delhi before submitting their resignation from the party, the sources said.

"Azad is a popular leader who served Congress for the last 50 years. He is a known face across the country for his contribution towards national building," Saroori told reporters after holding a meeting with Azad at his Delhi residence.

Earlier, Saroori uploaded a joint resignation letter on his social media account, announcing Rashid, Bhat, Wani and Akram were quitting the party.

"He cannot stay out of politics...his services are needed in J&K and we are sure that he will be the next chief minister of the state (UT). People of J&K also love their leaders and are ready to give any sacrifice for him," Saroori said, dropping enough hints that Azad is likely to float his own party.

Most of the Congress leaders, who are seen to be loyal to Azad, have already reached New Delhi and are camping there.

The sources indicated the veteran Congress leader is likely to float a new party next month as the union territory prepares for the first Assembly elections since the abrogation of Article 370 in 2019.

The sources said former deputy chief minister Tara Chand, former MP Jugal Kishore Sharma and Muneer Ahmad Mir from Kupwara are also mulling to resign from the Congress.

The leaders are also considered close confidents of Azad, the sources said.

"We, the senior party leaders, are holding a meeting in the aftermath of the new developments. We will be meeting Azad sahib as well," Chand said

Azad's Journey

"The situation has become irretrievable", Azad, 73, said in his parting shot to Sonia Gandhi, whose trusted confidante he remained right from the time of Sitaram Kesri's unceremonious exit as the party's chief in 2000.

Known for his ability to negotiate the challenging twists and turns of body politic, Azad was often sent by the leadership to fire fight any situation - be it a crisis in a faction-ridden state unit like Haryana or cobble up a new alliance and government in Karnataka with the

JDS.

But things were never the same between Azad and Gandhi after the summer of 2020 when he headed the 'group of 23', seeking a leadership and organisational change. Observers say the relationship broke irretrievably after the Congress chief denied Azad, the sitting leader of opposition in Rajya Sabha, a renomination to the upper house last

year.
Many an eyebrow were raised when
Prime Minister Narendra Modi profusely praised Azad while delivering an
emotional speech during the Congress
leader's farewell in Rajya Sabha in 2021.
In return, Azad was also effusive in his
praise for Modi.

Again the Congress did not take it easily when the Modi government conferred the Padma Bhushan on Azad. Senior leaders called it a political decision and not one on merit.

And very recently, Azad resigned from the post of head of the Jammu and Kashmir Congress campaign committee hours after he was appointed.

The writing was on the wall since then.

Azad's exit was simultaneously a shock and a surprise to sections across the Congress, considering he was a key figure in the party's decision-making processes through the Sanjay Gandhi days and the tumultuous times of the Emergency under Indira Gandhi, followed by the Rajiv Gandhi era, the Narasimha Rao period and eventually the tenure of the longest serving Congress president Sonia Gandhi.

Born in 1949 in Soti village of Bhadarwah in Jammu and Kashmir's Doda district, Azad made his way up the ladder in the Congress and went on to become the chief minister of his home state in 2006.

In his almost 50 years in politics, he has been a two-term Lok Sabha and a five-term Rajya Sabha member, besides occupying all top Congress positions and a union minister in all Congress governments since 1982. He also remained as two-term member of J&K Legislative Assembly in 2006 and 2008.

Many Congress leaders term Azad's move as an "outright betrayal", even as the old warhorse kept both his supporters and critics guessing about his future moves following his resignation from all Congress posts today.

"Some of my other colleagues and I will now persevere to perpetuate the ideals for which we have dedicated our entire adult lives outside the formal fold of the Indian National Congress," said the former chief minister of Jammu and Kashmir, who appears set for a fresh innings in the Union Territory where the election process has begun with the finalisation of the electoral rolls.

Azad's name will be etched in Congress history as a quintessential rebel who raised a banner of revolt against the formidable first family of the Congress and even managed to bring 23 leaders together in a group called G23.

The G23, dissenters to some, preferred to call itself the reformist panel which sought meaningful organisational overhaul, an advisory role for the Gandhis and a new full-time party chief

The letter G23 wrote to Sonia Gandhi in August 2020, under the leadership of Azad, laid the ground for the former minister's eventual divorce from the party today.

Azad entered the political fray as secretary of the Block Congress Committee in Bhalessa in Jammu and Kashmir in 1973 to 1975 and moved up the ranks to become the president of the J&K Youth Congress in 1975-76.

He won his first parliamentary election in 1980 from Washim in Maharashtra and became a minister at the Centre under Indira Gandhi in 1982. He later served under all Congress prime ministers - Rajiv Gandhi, Narasimha Rao and Manmohan Singh. Azad was first given a Rajya Sabha ticket in June 1991.

Azad said he joined the Indian National Congress in Jammu & Kashmir in mid 1970s when it was still a taboo to be associated with the party given its chequered history in the state from August 8, 1953 onwards the arrest of Sheikh Mohammad Abdullah being the nadir of its "political myopia".

He said he was inspired by the ideals of Mahatma Gandhi, Jawaharlal Lal Nehru, Sardar Patel, Maulana Abul Kalam Azad, Subhash Chandra Bose and other leading lights of the freedom struggle from his student days and joined the party at the personal insistence of Sanjay Gandhi.

From 1977 onwards he was general secretary of the Indian Youth Congress (IYC) led by Late Sanjay Gandhi and went to jail several times, his longest period in Tihar jail being from December 20, 1978 to end of January 1979.

After Sanjay's demise, he took over as the National President of IYC in 1980 and had the privilege of inducting Rajiv Gandhi into the Indian Youth Congress as a Member of the National Council on Sanjay Gandhi's first death anniversary on June 23, 1981.

Azad also served as AICC general secretary with every president of the Congress since the mid 1980s and was a member of the Congress Parliamentary Board headed by Rajiv Gandhi till his death in May 1991 and later with Rao till the latter decided not to reconstitute the Congress Parliamentary Board in October 1992.

He was also a member of the Congress Working Committee, the highest decision-making body of the Congress, continuously for nearly four decades both in an elected and a nominated capacity and served as AICC general secretary in-charge of every state and Union Territory of the country at one point of time or the other over the last 35 years.

Azad claimed that he won 90 per cent of states that he was in-charge from time to time and finally served as the Leader of the Opposition in the Rajya Sabha for seven years.

In his five-page resignation letter, Azad has also stated he and his colleagues will persevere to perpetuate the ideals they dedicated their entire adult lives for outside the formal fold of the Congress.

Azad ended his five-decade association with the Congress, terming the party comprehensively destroyed and lashing out at Rahul Gandhi for "demolishing" its entire consultative mechanism.

The Congress, dealing with the fallout of a series of high-profile exits, including that of Kapil Sibal and Ashwani Kumar, attempted to deflect the latest blow by alleging that Azad's DNA had been "Modi-fied" and linking his resignation to the end of his Rajya Sabha tenure.

Chinese Rifle

ammunition were recovered from the Pakistani militants killed in Kamalkote area of Uri while trying to infiltrate into the Indian side.

"Usually, we find AK series and at times, the M-4 rifles being recovered. This M-16 is a Chinese-made 9-mm calibre weapon. This is an unusual recovery," General Officer Commanding (GoC) of the Army's 19 Infantry Division Major General Ajay Chandpuri told reporters in Baramulla in north Kashmir.

He, however, said it would be premature to say if this hints at a probable nexus between the Pakistani Army, militants, and the Chinese Army.

"It would be too premature to speculate on the larger context of it. So, I think, we will have to really examine and go into the details," he said.

On the number of militants on the launchpads across the LoC, Maj Gen Chandpuri said based on multiple inputs "there were close to 100-120 terrorists attempting to infiltrate and present in 15-20 launchpads which are close to the LoC", opposite this sector alone.

"So, while the ceasefire understanding is largely holding good for the benefit of the people on the both sides, the presence of militants on the launchpads and their continuous attempts to infiltrate are on," he added.

The GoC said Pakistan is desperate and frustrated, and will continue to try to infiltrate militants and send in arms and ammunition despite a robust anti-infiltration grid in place.

"The LoC is over 740 km which includes very difficult terrain and then there were spells of inclement weather. So, despite the vigilance, there are gaps from where they try and infiltrate militants and war-like stores," he said.

However, he said, with each passing day, the level of technology and alertness is improving.

"So, the infiltration has come down significantly, which is also indicated by the peace in the hinterland. So, we feel they are getting more and more desperate to push in these people from anyway possible. This one attempt made early in the morning is indicative of their desperation and their frustration," he said.

He said the swift elimination of militants sends a clear signal of the level of preparedness of troops on the LoC.

Asked if there were any attempts to drop weapons using drones in the sector, the GoC said "not really".

"But, we are watching out for that and prepared to deal with it.

'New Gen Surveillance

Ajay Chandpuri said the operation was launched following credible inputs from various sources, including the military intelligence, the Jammu and Kashmir Police and the Army's own

sources on the ground.

"We have foiled an infiltration bid from from PcK in the area of Kamalkote in Uri sector, in which three foreign militants were neutralised and assault weapons and ammunition recovered,"

The GoC said the terrain where the operation was carried out was extremely challenging.

"It had a dense undergrowth. The weather was extremely foggy with heavy rain and the entire area was mined. So the multifarious challenges that were faced while conducting the operation could be well appreciated," he said

Giving details of the operation, Colonel Raghav, the commanding officer of 8 Rashtriya Rifles which carried out the operation, said the troops, including those from the BSF, deployed on the LoC in the sector spotted suspicious movements in the area on Wednesday.

"Based on that, Operation Mrityunjay was launched. Small ambush parties and surveillance detachments were inducted into the area. Our teams were not picked up by the enemy surveillance devices and surveillance mechanisms. Our teams were deployed at this location for over 25 hours and at 7:55 am on August 25, the teams spotted the militants crossing the LoC," he said.

The CO said the movement of the militants was ascertained by using latest aerial and ground-based sensors and surveillance equipment

and surveillance equipment.

At around 8:45 am on Thursday, the terrorists came to a distance of 40-50 metres from the ambush parties, which opened fire on them, and in a brief exchange of about 15 minutes, the three Pakistani militants were neutralised, he

Colonel Raghav said the search operation in the area was still going on.

"The search is on because of the constraints of the minefield. Right now, mine-clearing measures are being undertaken to ensure a proper search," he added.

He said two AK-series weapons, a Chinese M-16 weapon and their ammunition and other stores were recovered.

"It has also come to light that these terrorists were well treated and prepared for infiltration and also, their built and gait indicate that they had undergone formal military training," he

The CO said the new generation surveillance equipment and weapons were put to optimal use during the course of the operation.

Asked if the militants were identified, the GoC said according to the 19 Infantry Division, the slain ultras were not in possession of any documents from which their identity could be ascertained.

"It is our assessment that before pushing these militants for infiltration, their IDs were taken away from them and they were not in possession of any IDs. So we are not aware of their exact identity," he said.

Well placed health officials revealed that around 34,500 male baby births were reported at Lal Ded Hospital in last three years while as the number of female baby births in the same period was around 31,500

They said that in the year 2019-20 the number of male births at the hospital was around 12,000, however, in the same period the number of female baby births was around 11,000.

Azad's Resignation Creates Political Storm In J&K, Leaves **Cong In Disarray**

SRINAGAR: Ghulam Nabi Azad's resignation from the Congress created a political storm in Jammu and Kashmir Friday as former minister R S Chib and four other party leaders also quit, and more are likely to go, leaving the grand old party in disarray in the union territory.

As Azad ended his decades-old association with the party, leaders across political spectrum praised his contribution to Jammu and Kashmir, with the BJP hailing him as a "towering leader".

However, recently designated Jammu and Kashmir Pradesh Congress Committee president Vikar Rasool Wani -- also seen as an Azad loyalist -- and his predecessor G A Mir, who belonged to the rival camp, said they will work with double the resolve now to strengthen the party at the grassroots in the union territory.

JK BJP president Ravinder Raina said Azad was a "towering leader" and with his resignation, the Congress ship has sunk completely. He said the BJP's doors are always "open for all those who want to contribute to the nation".

Hours after Azad -- a former J&K chief minister -- announced his decision, former minister R S Chib and Ex-MLA Mohd Amin Bhat, both considered close to him, also decided to leave the party.

"Keeping in view the turmoil that the State of JK has witnessed over the past decades, people require a decisive leader like Azad to guide them towards a better future. I feel the Congress Party has not been able to play the role expected of it." Chib said in his resignation letter addressed to Congress president Sonia Gandhi.

3 Militant Associates Arrested in Sopore: Police

SRINAGAR: Police on Friday claimed to have arrested three militant associates of Lashkare-Taiba in Sopore area of North Kashmir's Baramulla district.

During evening hours, a joint naka was established by police, Army's 22 RR, 179 battalion CRPF at Bomai chowk. During checking a suspicious movement of three persons coming from Goripura towards Bomai was noticed and were subsequently asked to stop, a police spokesperson said Friday.

"But they tried to flee from the spot. However they were tactfully apprehended by the security forces," he said, adding, "Upon their personal search three Hand Grenades, nine posters and 12 relevant sections of law and fur-Pakistani flags were recovered

from their possession."

During the preliminary questioning, the spokesperson said they revealed their identity as Shariq Ashraf son of Mohammad Ashraf Wani of Hadipora Rafiabad, Saqlain Mushtaq son of Mushtaq Ahmed War of Warpora Sopore and Tawfeeq Hassan Sheikh son of Ghulam Hassan sheikh of Fatehgarh Baramulla.

"Preliminary investigations have revealed that the arrested persons are OGWs of LeT and were in a constant search of an opportunity to carry out attacks on security forces and civilians including outside labourers," he said.

Accordingly, the spokesperson said, a case has been registered at Police Station Bomai under ther investigation going on.



Premier League Clubs Shatter Summer Spending Record

remier League clubs have shattered their record for summer transfer window spending, according to analysis from sports finance experts De-

Gross spending by the 20 Premier League teams stood at £1.5 billion (\$1.7 billion) on Thursday, surpassing the 2017 record of £1.43 billion spent by English clubs in the close-season win-

It is also more than the £1.44 billion spent in the whole of last

With a week to go until the window shuts on September 1, the all-time record for an entire Premier League season, £1.86 billion from 2017-18, could be beaten in the current summer window alone.

"The record levels of spending that we've seen in this summer transfer window so far provides a sign that the business models of Premier League clubs are rebounding post-Covid," Chris Wood, assistant director in Deloitte's Sports Business Group

Premier League clubs have signed 135 players this summer, already more than in the 2019 or 2020 summer windows and closing on last August's 148.

That list is topped by Benfica forward Darwin Nunez's £85.5 million move to Liverpool.
