The death toll from the devastating floods in Pakistan neared 1,100 Monday. Pakistan Prime Minister Shehbaz Sharif-led cash-strapped government has made a desperate appeal for aid to deal with the crisis that has displaced 33 million or one-seventh of the country's population.

"Saddened to see the devastation caused by the floods in Pakistan. We extend our heartfelt condolences to the families of the victims, the injured and all those affected by this natural calamity and hope for an early restoration of normalcy," Modi said in a tweet. At least 1,061 are dead and

1,575 injured, according to the latest data issued on Monday by the Pakistan's National Disaster Management Authority, the chief national organisation tasked to deal with natural calamities.




## **J&K POWER POLITICS Azad's Return Creates Ripples Among Political Parties**

**Police Urges People Not To Fall Prey To Cyber Frauds**

Srinagar: The cyber wing of Police on Monday released a video with an aim to awaken the general public about the online cyber fraud taking place and ways to tackle it. Sandeep Chaudhary, SSP, Cy-

ber Crime Investigation, in a three minute long video explained the ways in which criminals trap innocent people and try to extort money from them.

'These days extortionists are using two ways to extort money from innocent people", Chaudhary said.

He said people receive fraudulent messages on WhatsApp with a WhatsApp profile picture similar to that of their boss, coworker or a near one.

The extortionist later asks for an Amazon gift card worth thousands of rupees.

"When a user receives such a message, he or she should block the number immediately" SSP said.




He further said that another type of cyber fraud is also taking place which is sextortion.

"This type of fraud is destroying people's personal, emotional and professional lives

"People receive video calls on WhatsApp from unknown numbers wherein the victim gets to see a woman in an inappropriate position and the extortionist takes a screenshot from the call and tries to mint money from the person"

Sandeep further said that the extortionists try to scare people saying they are from the Police and mint money from them. In these cases ordinary people are the victims, not criminals.

They added that the multi-level car parking will be constructed for parking of 1,000 vehicles.





## 'Illiterate' Appointed Instead Of Namesake

HADURA (BUDGAM) - Even as numerous scandals of fake appointments have surfaced in various government departments over the recent years, incidence of the wrong doing is far from being stamped out. Some diehards still manage to get a job in one or the other department by manipulating records and documents, and by tapping the 'right' person and the 'tight' timer.

An illiterate villager has got a government job allegedly by impersonation, and got away with it, assurance of the finance minister to get the wrong undone notwithstanding. In the process, the genuine claimant for the appointment continues to be jobless. Reports said Nazir Ahmad Dar r/o Abdul Kabir Dar R/o Badipore, has passed his 12th (TDC) clam examination. But, it is his namesake in the neighbourhood who, though illiterate, has allegedly got a government job. The only difference between the two is in the names of their grandfathers. While the former's grandfather is named Abdullah Dar, the latter's name is Ahmad Dar.

According to reports, the uneducated Nazir Ahmad Dar was appointed in the horticulture department in 1996. He is posted in the district office at Budgam. Sources in the department said Dar managed to procure the certificates of his educated namesake which he produced in support of his claim. The department did not entertain the 'genuine' claim of the educated Dar.

Though the serious case of alleged swap was brought to the notice of the state vigilance organisations, no action has been taken so far. The educated Dar approached the finance minister, Abdur Raheem Rather, who also happens to be his neighbour. He had assured him to get the right person appointed against the post. However, justice ' still eludes hint despite lapse of about four years

In another case, Mushtaq Ahmad Zargar s/o Ghulam Ahmad Zargar r/o Badipore has managed to secure a job allegedly by producing a fake certificate of academic qualification. According to reliable sources, he is barely read upto 4th standard. However, he managed to get a certificate of having passed his 9th class (under metric) examination from the government higher secondary school, Nagam, in 1996 allegedly, through his brother, Abdul Rasheed Zargar, who is a teacher at Badipore.

On the basis of the alleged fake certificate, Zargar was ap pointed as a peon in the animal husbandry department. He has been working at the veterinary dispensary here for about three years past. Sources said the department did not take any action to unravel the facts and bring the accused to justice even after the matter was brought to its notice

## **Congress After Azad**

he resignation of Ghulam Nabi Azad, a veteran Congress leader and once a Gandhi loyalist has come as yet another major setback to the Congress party. In a scalding letter, Azad has raised questions about the ability of the former Congress president Rahul Gandhi to win polls and squarely blamed him for the party's debacle in successive elections. He blamed Gandhi for the current plight of the Congress, saying the latter's "childish behaviour" more than anything else, contributed significantly to the defeat of the UPA in 2014. For the last two years, Azad was one of the leading lights of a rebel faction called G23, which sought reforms in Congress to no avail. Significantly, Azad's resignation came days after another Congress veteran Anand Sharma resigned from a key party position offered to him in the poll-bound Himachal Pradesh, citing "exclusions and insults."

Azad's resignation should certainly be a moment of deep reflection for Congress. The party that ruled India for over fifty years after independence is now finding it difficult to even win state elections. For example, it is not even in the distant reckoning in the upcoming Assembly elections in Gujarat and Himachal Pradesh. This is why G23 led by Azad and Sharma was calling for serious reforms in the party. But this has split the Congress down the middle with Gandhi family supporters and opponents at loggerheads with each other. The G23's rebellion marked a break from the passivity of the seven years after the 2014 defeat with the party apparently resigning to its current lot. But at the same time, Congress has found it difficult to elect a non-Gandhi president. And the party has its own reasons for this: a Gandhi not being at the helm will run the risk of breaking the party up. Also, in the present circumstances, Congress doesn't boost of many a mass leader - albeit, there are many senior politicians who can be worthy successors to Gandhi. Gandhi's term at the helm has shown that he is not just up to the task. It is now clear that the wave of Prime Minister Narendra Modi remains alive and kicking. After a few reverses here and there over the last seven years, PM Modi's appeal has only grown stronger. He looks favourite to win the upcoming Assembly polls, including even the 2024 national polls unless the wider opposition gets its act right. That is, if no credible opposition emerges from the shadows in the near future, a prospect that looks bleak. Congress, for one, is no longer the party that has either the will or the means to take on the BJP juggernaut.

## **Srinagar Ring Road's Cruel Mathematics**

Over one lakh fruit & non-fruit bearing trees have been axed for the Srinagar Ring Road. Construction work going on but the aggrieved have not even been paid paltry compensation

round 80% of the apples produced in India are grown in Kashmir. The apple industry is the backbone of Kashmir's rural economy. The commercial apple farming in Kashmir and cultivation of cherries, plums, pears and the likes, generates an estimated revenue of around Rs 10,000 crores annually

As per the Government estimates, around 10 to 11 Metric Ton (MT) of apple is produced per hectare in Kashmir, while this is 40 MT per hectare in European countries, like France and Italy. The per hectare yield of apples is 50 MTs in Chile, South America. To enhance the apple yield in Kashmir, the Horticulture Department says that they need more apple plantations. More and more farmers are shifting towards apple farming and converting their paddy farms and other types of fields in hills and Karewas into apple orchards but due to a scarcity of land, we haven't been able to create more farms

Infact, as agricultural land is now being converted into highways and other commercial hubs, it seems that the apple production in Kashmir will likely come down in the next decade only. Additionally, as agricultural land holding is also decreasing drastically, production is set to drop further. This is very dangerous for our economy as well as our environment.

#### 1 lakh plus trees axed

Recently, the Project Director of National Highways Authority of India (NHAI) Srinagar project revealed in a written response sought under Right to Information Act (RTI) that one lakh ten thousand forty three (1,10,043) private trees were axed for the Srinagar Ring Road project. The RTI reply further said that 1200 trees further be cut down. One lakh plus trees that were axed included fruit bearing trees like apple walnut,pear,plum,apricot, almond etc. In addition, non-fruit bearing trees like chinar, walnut, mulberry trees which are classified as specific trees were also cut down along with willow, kikar, popular and other trees. The NHAI reply says that all the trees valued around Rs 13.76 crore for which compensation has been disbursed to affected people. When we calculate the compensation paid per tree this comes to around Rs 1250 approximately (Twelve Hundred Fifty Rupees). This is a disappointingly meagre compensation. Additionally, the Jammu based noted RTI activist Raman Sharma who sought this information from NHAI was informed that 50.616 plants alongside avenue and 25,308 timber alongside median are to be planted as a contract settlement with the road construction company. This too is very little. Even under the Compensatory Afforestation Fund Act (CAF) the funds paid by user agency during deforestation is used for the treatment of catchment areas, assisted natural generation, forest management, wildlife protection and management, relocation of villages from protected areas, managing human-wildlife conflicts, training and awareness generation but this isn't being done in the execution of the Srinagar Ring Road project.

### Family matters: On the Congress and the Gandhis

y turning down the pleas of his ardent followers to return to the helm, he has challenged Congress leaders to adopt a new culture, moving away from the familiar habit of relying on the family as the lifeblood and a façade simultaneously. For the Congress party, this challenge is no less than the external challenge of extinction that it faces from the Bharatiya Janata Party. His discomfort with formal power might make him seem a reluctant politician, but he has expressed a desire to be in public life as a matter of his democratic duty.

Rajasthan Chief Minister Ashok Gehlot has emerged as the front runner for the post, for various reasons. Mr. Gehlot is an astute politician, a manager of conflicting interests, and deeply embedded in the Congress structure from the grassroots to the pinnacle. His charm, accessibility, clean image, and expertise in heartland politics make him a good fit. He wears his loyalty to the Gandhi family on his sleeve but remains acceptable to multiple groups within Congress. If at all there is a contest for the post of party president, that will only enhance the legitimacy of the winner. However, with the Gandhi siblings in active politics, the authority that Mr. Gehlot or anyone else can exercise within the party as president will remain a complicated question. If Mr. Gandhi and his sister Priyanka Gandhi Vadra continue to remain active decision-makers, as they have been in the recent past, the situation could turn out to be chaotic. Mr. Gandhi has done the honourable thing by refusing to buckle under pressure and return as president. But he, his sister, and their mother Mrs. Gandhi should all have very clearly defined contours of involvement in the functioning of the party. A non-Gandhi at the helm can be a good attempt at rebooting the Congress, but that by itself is no guarantee of its revival. The new president should have the authority, legitimacy, and vision to infuse new energy into the party. Ironically, the burden of ensuring that is upon none other than the Gandhi family, who will have to be supportive without being seen as interfering.

#### Compensation estimated as per year 1995 rates

About 90 percent of farmers in Jammu and Kashmir are officially marginal. According to Agriculture Census 2015-16, the size of small agricultural landholdings in J&K was estimated at 0.55 hectares. Yet, unofficially it seems to be only about 1/2 acre. The 2010-2011 Agriculture Census had declared the average size of operational land holdings in India as 1.15 hectares. This figure was also lower, at 0.62 hectares, for Jammu & Kashmir. Ten districts in Kashmir Valley

The government has acquired more than 600 acres of land for the Srinagar Ring Semi Road project. Several villages in Pulwama, Budgam, and Srinagar have been affected by the land acquisition process & axing of fruit trees (apple trees especially).

The Srinagar Ring Road project was inaugurated by PM Modi on 19 May 2018 at Srinagar. This 62-km alternate highway around Srinagar connecting Pampore with Ganderbal via Budgam is being constructed on highly fertile land. Budgam alone is losing 500

Act 1934 (samvat 1990). The Right to Fair Compensation Act 2013 (RF-CTLARR Act 2013) was not applied in spite of the fact that declaration made under J&K's repealed act lapsed in 2019 August due to efflux of time. Even the District Collector Budgam mentioned this in his written communication to the Government but nobody was bothered to abide by his suggestion.

However, the estimates were made as per the rates in the year 1995. Since 28 years, these rates haven't been revised.

The final compensation for fruit trees was fixed at Rs. 16 per kilo for apple trees, Rs. 13 per kilo for plum trees, and Rs. 14 per kilo for pear trees. This is unacceptable to the affected farmers, who want the valuation to be done according to the market rates available in 2018 when these estimates were made.

The market rate of apples is Rs 70 to 80 per kg these days and this was Rs 60 to 70 / kg in 2018 and farmers were forced to accept Rs 16 / Kg . The rate of plum is also the same. This is plain injustice. The farming community hasn't got the benefits of the central land acquisition law, the application of which was touted as a panacea post abrogation of Article 370.

Several writ petitions have been filed by farmers in the High Court of J&K from 2018 onwards. The court asked the Government in several interim directions to maintain status quo. But in March this year, the division bench of Justice A M Magrey and Justice Mohan Lal of High Court of J&K asked the Government to carry on with the construction on Ring Road. This was to be done in those areas where farmers or land owners had been compensated. The order read:

The respondents (government) shall proceed in the construction of the ring road by utiliz-

The District Administration Budgam where most of the land has to be acquired misinterpreted this order. Instead of going ahead with road construction in areas where the farmers had been compensated for land, the administration destroyed standing crops of mustard around mid-March this year and axed apple trees as well. The land was acquired by force and farmers were not even given an option to transplant their trees which is scientifically proven and several state Govt's have already adopted tree transplantation policies. Infact, many farmers who were ready to take compensation haven't been paid the same as the district treasury is dry.

#### Conclusion

In addition to payment of meagre compensation for fruit and nonfruit bearing trees, there are dozens of families in Budgam district, especially those who haven't been paid any compensation by the Government (not even the meagre compensation that is due to them under repealed land acquisition act of J&K). Ironically, their lands have already been acquired by NHAI and work on the project is being taken up by the construction company M/S NKC Projects Pvt Ltd. As many affected farmers in Budgam didn't accept the compensation estimated under erstwhile J&K land acquisition law, the Collector Land Acquisition Budgam deposited more than Rs 46 crores in District Court Budgam under the official communication No: DCB/LAS/2022/800-04 Dated: 04.06.2022.

This award money pertains to village Wathoora alone in Budgam but even after a lapse of 3 months the affected landowners are yet to get even this paltry compensation.

I f you ask people why they like their favourite animal, they will tell you about the incredible things the creature can do, its relatable characteristics or its interesting looks. Few would be likely to cite the pigeon as theirs. Many people think of them as vermin rather than wildlife.

People's utter disdain for feral pigeons breaks my heart. Sit in a park at lunchtime, anywhere in the world, and you're almost certain to witness people lashing out at pigeons.

I see people stamping their feet and kicking as the birds weave in and out of their legs to snaffle leftover crumbs. But few people stop to think why there are pigeons under the bench they're sitting on. We brought them into our cities, yet so many despise them. It hasn't always been this way; we have a rich and long relationship with the humble pigeon.

Feral pigeons are the descendants of wild rock doves. We domesticated them centuries ago, for food and their supreme navigation skills. They thrive in our cities because our tall buildings and window ledges mimic their natural home; caves and cliffs. Our waste provides ample food. People are enthusiastic about homing pigeons but there isn't much difference between homing pigeons and feral pigeons. It just depends on whether they live in someone's loft as a captive pigeon or the local town square.

#### WHO ARE YOU CALLING BIRD-BRAINED?

The homing abilities of pigeons are legendary. We are still learning about how amazing these birds are. They can do basic maths, on a par with monkeys, and can distinguish real words from made up ones.

Homing pigeons can find their way using smell, landmarks, Earth's magnetic field and infrasound (sound waves with a frequency too low for humans to hear). They can also follow each other and are able to learn routes from one another. Feral pigeons generally mate for life, and they are very attentive parents. The adults produce a crop milk, which they gently drip-feed to their chicks. Our fascination with their homing abilities continues today with tens of thousands

ties continues today, with tens of thousands of pigeon races around the world every year. Pedigree winners sell for over £1 million.

#### IMAGE PROBLEMS

We have such disdain for the pigeons living amongst us in our towns and cities. But not so long ago we were fascinated with these creatures. In the mid 1800s we started to appreciate pigeons for their good looks. During this period, many new breeds emerged, including fantails, Jacobins, tumblers and barbs.

Their exaggerated features attracted the attention of Charles Darwin. He was a pigeon aficionado and used this dramatic example of diversity within a species to convey his ideas about natural selection in The Origin of Species. It is almost as if we have seen feral pigeons too often to appreciate their rainbow throat feathers and cute, plump bodies. These features would be prized in a rare species.

#### WARRIOR BIRDS

Feral pigeons are true survivors. Having spent many hours observing pigeons in St James Park in London, I have seen them caked in oil, milk and human vomit. I have watched pigeons with one foot missing, both feet missing, with only one leg, or trapped in bits of litter. Yet they soldier on. The normal outpouring of sympathy towards animals in distress is absent for feral pigeons. Many people have told me that far from inspiring sympathy, pigeons' battle scars only add to their dislike: the birds look "messy". Feral pigeons are thought to be prone to losing toes and feet because human hair and netting tangles around them, cutting off the blood supply. They can also get their feet stuck in chewing gum. Our litter harms pigeons and then we treat them with contempt for the way it makes them look.

Pigeons are some of the most decorated animals in history. No less than 32 pigeons have won the prestigious Dickin Medal, the animal equivalent of the Victoria Cross. Homing pigeons were used intensively during both the first and second world wars, to deliver vital messages between battalions and fly with cameras on for reconnaissance missions. Perhaps the most famous war pigeon is Cher Ami, who in 1918 was awarded the French Croix de guerre medal, for delivering messages from an encircled battalion under heavy fire. Cher Ami was shot through the breast, blinded in one eye, and his right leg was only hanging on by a tendon by the time he delivered his messages.

For many people, feral pigeons are some of the only wildlife they interact with on a regular basis. These interesting birds live right on our doorsteps. Next time you're outdoors, give pigeons 30 seconds of your time. Watch them. Witness their intricate social interactions and see the tender moments between pairs as they preen each other and bring nesting material as gifts. However, if you really don't want them around during your lunchbreak the best advice is: be a less messy eater.

The internet is the most comprehensive compendium of human knowledge ever assembled, but is its size a feature or a bug? Does its very immensity undermine its utility as a source of information? How often is it burying valuable data under lots of junk? Say you search for some famous or semifamous person – a celebrity, influencer, politician or pundit. Are you getting an accurate picture of that person's life or a false, manipulated one?

These aren't new questions; they're actually things I've been wondering for about as long as I've been covering the digital world, and the answers keep changing as the internet changes. But a recent story got me fretting about all this once more. And I worry that it has become more difficult than ever to tune in to any signal amid so much digital noise.

Karen Weise, a New York Times reporter who covers the technology industry, had a blockbuster story last week documenting a pattern of hostile and abusive behavior by Dan Price, the CEO who became internet famous in 2015 for instituting a \$70,000-a-year minimum wage at his Seattle-based credit card processing company. "He has used his celebrity to pursue women online who say he hurt them, both physically and emotionally," Weise reported, interviewing more than a dozen women who recounted ugly encounters with him in detail. (Price denies the allegations.)

But this was not the first time that Weise punctured the mythos sur-

#### rounding Price. Late in 2015, months after he was first feted by media outlets around the world for his supposed do-gooder approach to capitalism, she published a piece in Bloomberg Businessweek uncovering many skeletons in his closet – among other things, an ex-wife who had accused him of extreme violence and an explanation for the employee raises that seemed more self-serving than he had let on. When Weise linked to that 7-yearold article in the new story, I clicked back to it and realized that I definitely read it at the time. I remembered its headline, "The CEO Paying Everyone \$70,000 Salaries Has Something to Hide," and I remembered that its details had been widely commented on. Price, who denounced Weise's Bloomberg article as "reckless" and "baseless," was canceled temporarily after the story appeared. Then, over the years, Price began to master Twitter, eventually collecting hundreds of thousands of followers and becoming a fixture in some left-leaning Twitter circles. "Tweet by tweet, his online persona grew back," Weise writes. The bad news faded into the background. It was the opposite of being canceled. Just as social media can ruin someone, so too can it – through time, persistence and audacity – bury a troubled past."

This isn't how the internet is supposed to work. In different ways, Google, Twitter, Facebook and other big tech companies have made it their mission to disseminate and organize online data. Weise's first story about Price contained important information about a semiprominent online figure; it should have been highlight-



ed, not buried, as he amassed his online following.

The more troubling thing is, how often is this sort of thing happening? In the abstract, the question is almost impossible to answer; by definition, you can't make a list of stories the internet is hiding from you. I would guess the Price story is an extreme example of information burying, but there's reason to suspect that some version of this sort of suppression is happening all the time online.

Why? Three things. Recency bias: Google is far more focused on highlighting information from the present than it once was, making events from the past more difficult to suss out. Organized manipulation: Online mobs are bent on shaping online reality – and although the platforms say they are attentive to the problem, the mobs seem to have the upper hand. And, of course, capitalism: Lacking much competition and keen to boost quarterly numbers, tech companies may have little incentive to solve these problems.

The first issue, recency bias, is mainly about Google, and it's one that journalists like me have been complaining about for years. Google's search algorithm heavily favors content that was posted most recently over content from the past, even if the older data provides a much more comprehensive story. There's a certain sense in this: Nobody wants to read ancient news. But as the Price story suggests, if you're searching for someone with an active online presence – someone who tweets a lot, who makes a lot of media appearances or whose whole persona is based on riling folks up the results get murky.

Try Googling Elon Musk. When I do so, I see a lot of evergreen stuff his Wikipedia page, links to his social media and corporate bio, index pages of articles about him at various media sites — and lots and lots of links to news about the latest Elon dust-up. At the moment, these headlines are about legal maneuverings in his attempt to undo his purchases of Twitter and Tesla's efforts to stifle video clips of its cars hitting child-size mannequins; by the time you Google him, the results might have moved on to the next controversy.

But for a controversy machine like Musk, is it really helpful for Google to return pages and pages of links to similar stories about the latest thing? What if the latest thing is not the most important thing? In the first several pages of links about him, I didn't see the Insider story published in May about the \$250,000 settlement he reached with a flight attendant who accused him of exposing himself to her. There also isn't much about his various fights with the Securities and Exchange Commission or the time he called the man who helped rescue 12 boys trapped in a cave in Thailand a "pedo guy."

I don't think Musk has actively tried to suppress this stuff; he's just very online, and every time he does or says something new, the old stuff goes farther down.

The situation becomes much worse when there are motivated parties trying to shape what the platforms show us. There has been no better example of this than the ugly turn the internet took during the recent defamation case between Johnny Depp and his ex-wife Amber Heard. If you scanned Twitter, YouTube or TikTok during the trial, you were flooded with memes, clips and trollish posts about how terrible Heard was and how righteous

#### Depp was.

This wasn't because Depp's case was so much stronger than Heard's; as researchers have shown, it was more likely because the platforms were overrun by bots and trolls associated with people on the misogynist right who made it their mission to paint Heard in the worst light possible. They seem to have succeeded; even now, you've got to dig around online to find information supporting her.

The platforms say they're constantly fighting such organized campaigns. But their efforts are opaque and seem halfhearted at best – and that's where we get to misaligned incentives. Because bots are a kind of engagement and engagement is what pays the bills, there are few reasons for the services to really fight such campaigns. As Peiter Zatko, a former security chief at Twitter, said in a recent whistleblower complaint, "Twitter executives have little or no personal incentive to accurately 'detect' or measure the prevalence of spam bots." In the same way, YouTube had little incentive to present a fairer, less manipulated picture of the Depp-Heard case – not when the Depp clips were doing big numbers.

For many readers, none of this will come as a surprise. I'm not breaking any news when I tell you not to trust everything you see on the internet. But after reading the story of Dan Price, I think it bears repeating: The internet probably isn't giving you a fair picture of what's happening in the world. And for any given story, you might never really know how much you aren't seeing.

## 'Journalists Are Not Terrorists' Says SC, Deprecates Arrest Of Scribe From Bedroom At Midnight

New Delhi: "Journalists are not terrorists", the Supreme Court said on Monday, as it deprecated the Jharkhand police knocking on the door of a scribe of a local Hindi news channel at midnight and dragging him out of his bedroom before placing him under arrest in an extortion case.

Calling the police action "excesses of the state", the top court said it seems that "complete lawlessness" is prevailing in Jharkhand.

A bench of Justices DY Chandrachud and Hima Kohli refused to interfere with an order of the Jharkhand High Court granting interim bail to the journalist and said it will not entertain the state's appeal.

"We have seen the facts of the case. These are all excesses of the State and it seems complete lawlessness is prevailing in Iharkhand. No, we are not going to interfere with the High Court order.

"You knock at the door of a journalist at midnight and pull him out from his bedroom. This is too much. You are dealing with a person who is a journalist and journalists are not terrorists," the bench told Jharkhand's additional advocate general Arunabh Choudhary, voicing strong displeasure over the incident.

The top court said the high court rightly granted interim bail to the journalist by a detailed order which does not warrant any interference.

"Sorry, we are not going to entertain your plea. Since it is an interim order and matter is pending there, you go and convince the High Court," the judges told Choudhary and disposed of the plea.

Choudhary alleged journalist Arup Chatterjee was involved in blackmail and extortion activities and a criminal case had been lodged against him. When the bench asked him about

how long Chatterjee was lodged in jail, Choudhary said he was there for two to three days.

"He is lucky that he was out in three days as many people like him have to spend two-three months in jail (before being enlarged on bail)," the bench said.

The Jharkhand government had approached the top court against the bail granted to Chatterjee by the high court on July 19.

The Jharkhand High Court, while granting interim bail to Chatterjee on a plea field by his wife, had said after getting a response from the State to her plea the court will consider if senior Dhanbad police officials including the SP are required to be issued notices for contempt of court in the light of the apex court's observations in Arnesh Kumar (2014) and DK Basu (1997) judgements in which guidelines had been laid down for the arrest of individuals.

Baby Chatterjee, the wife of Arup Chatterjee who is a director at the channel, had moved the high court, claiming her husband was arrested at 12:20 am on the intervening night of July 16-17, 2022 from their Ranchi apartment in violation of the provisions of the CrPC.

The high court had said in its order, 'Prima facie, it appears that the procedure prescribed under Sections 80 and 81 CrPC has not been followed in the case in hand. These two provisions provide that once the arrest is made beyond 30 Kms of the concerned court, the local Magistrate and the police are required to be informed, which has not been done in the case in hand.

is one of the world's largest producers of apples, the letter notes that about 70 per cent of households in Jammu and Kashmir are directly or indirectly dependent on the sector.

"There are more than 1.50 crore boxes of apple produce stored in different cold stores," the letter reads. "Similarly, there are additional 1.50 crore boxes of apple in godowns which belong to small and marginal growers who expect that after the harvesting season is over, the produce stored will fetch reasonable prices in the market."

The fruit growers requested the prime minister to restrict the flow of Îranian apples in India.

But two months after Tomar's assurance, Iranian apples started flooding the markets across India and unnerved the native growers. Since these imported apples cost less, they took over the market and started hitting the native growers hard.

As the new harvest season is around the corner, the impact of the freeflowing import is already glaring in the boroughs of Budgam.

While waiting to reap their "labour of love", the growers are conveying a sense of unhappiness. The harvest time festive vibes are also missing.

"What would you do with this bumper crop if you have no market available," says Rahim Bhat, an apple grower from Budgam. "We're staring at the bleak situation which has literally put our survival at stake.

The same concern is coming from Kashmir's Apple bowl–Shopian.

As growers are bracing up for the upcoming harvest season, the market blues are leaving many of them dissatisfied.

"The shifting market order is disheartening," says Kaiser Mir, a young grower. "We can't feed our entire produce to the limited local market, just like we tried to do last year. Losing the domestic market to these Iranian apples is a big blow to us.'

Apple cultivation and its value chain is one of the mainstays of the rural economy with revenue of around Rs. 1500 crores. The productivity of apple at present is around 11 MT/hectare compared to over 40 MT/hectare in Italy, Chile, France, etc.

"Since this import problem is damaging the revenues of Uttarakhand and Shimla as well," says Mudasir Ahmad, President Buyers' Association of Kashmir, "we want the government to put one hundred percent tax on these apples so that our own production won't lose the market."

The domestic markets, Mudasir says, should be reserved for the local growers and buyers first.

The same concern is coming from Bashir Khan's highway orchard where he's checking his crop.

"Azad Sahab didn't even approach his close MLAs. The leaders are coming to his support out of love and respect. His stature is very high and has a lot of acceptance among the people of the Valley," he added.
