Crimes Against Women In J&K Rose By 15.62% In 2021: Report

Jammu: Crimes against women in Jammu and Kashmir recorded an increase of 15.62 per cent in 2021 compared to the preceding year, with over 7,000 people being arrested, the National Crime Records Bureau (NCRB) said in its latest report.

However, the conviction rate remained low as only 95 people were awarded sentences, while cases under investigation touched 6,275 by the end of last year. These include 2,329 cases pending investigation from 2020 and nine cases that reopened for investigation, the report said.

It said crimes against women marked a steady rise from 2019 to 2021, with the highest 3,937 such

cases reported in 2021 against 3,405 cases in 2020. In 2019, there were 3,069 such cases.

According to the 2011 census, there are 64 lakh women in Jammu and Kashmir, and the crime rate per lakh population in 2021 stood at 61.6, the report said.

The report said 315 cases of rape, 1,414 incidents of attempt to rape and 14 dowry deaths were lodged in 2021, and incidentally, 91.4 per cent of the accused involved in rape were known to the victim, the report said.

SC Refuses Probe Into 'Genocide' Of KPs, Sikhs

Asks Petitioner To Make Representation To The Govt

New Delhi: The Supreme Court on Friday asked an NGO that raised the issue of the alleged genocide of Hindus and Sikhs in Jammu and Kashmir during 1989-2003 to make a representation before the Centre and the appropriate authority.

In its plea, the NGO We the Citizens sought the constitution a Special Investigation Team to identify the perpetrators who were involved, aided and abetted the alleged genocide.

The plea was heard by a bench of Justices B R Gavai and C T Ravikumar.

The petitioner's counsel argued before the apex court that the genocide and exodus of over one lakh Sikhs and Hindus from the Kashmir Valley during that period had never been noticed by the state administration at that time.

"Have you made a representation to the government?" the bench asked.

The counsel said they have not. "You withdraw it and make a representation," the court said. The top court, which disposed of the petition, allowed the


Need to Come Out of Discrimination Syndrome: LG

Around 60 per cent respondents have been delaying treatment due to lack of health cover and 67 per cent who have medical insurance find it difficult to understand, a study by Pristyn Care Data Labs said.

conducted during August 1-25, 2022 by the startup firm, a vast majority of people want alternative treatments such as ayurveda, unani, siddha, homeopathy and naturopathy to be covered under health insurance.

"India has the lowest rates of health insurance penetration and COVID-19 induced medical inflation has caused people to delay surgeries. Elective surgeries are not lifethreatening but any delay can impact the overall quality of life,' Pristyn Care co-founder Harsimarbir Singh said in a statement. With the rising costs of medical treatments in the country, as per the study, nearly 60 per cent of the respondents are delay-

and 17 per cent find the paperwork involved in the process complex.

"Among the dozens of healthcare pain points, long waiting time for the claim approval is the biggest pain point as one vastly underestimates the costs associated with medical treatments," Singh said. The study said that as per industry reports, 27.5 million couples in India suffer from infertility and many doctors believe that these numbers will increase.

"20 per cent of survey respondents also believe that IVF and infertility procedures should be covered under insurance given the rising costs," the study said.

People are requested not to pay heed to rumors. Maulvi Sahib has regained consciousness and his condition is improving now. People are requested to pray for his complete and speedy recovery," Masroor tweeted.

One of the most popular leaders in the Kashmir valley, Moulvi Abbas Ansari is the last surviving politician from the Plebiscite Front era.

A champion of Shia-Sunni unity, he founded Ittehadul Muslimeen in 1962 after returning to Kashmir following a decade long stay in Iraq where he studied theology at the famous Najaf Seminary. He also served as convener of the Muslim United Front (MUF) and later chairman of the All Parties Hurriyat Conference.

Moulvi Abbas retired from active political life in 2010 devoting his entire time to spiritual pursuits. He has not been keeping well for some time, family sources

J&K Favours 'Pro-Active **Decentralisation**

EW DELHI: The Jammu and Kashmir Government today strongly pleaded for restoration of autonomy to the State while favouring the "pro-active policy of decentralization and greater delegation of power to

The State's point of view was put forth by acting Chief Minister and Housing and Urban Development Minister, Ghulam Mohi-ud-din Shah while participating in the 8th meeting of the Standing Committee of the inter-state Council held here to discuss the recommendations of Sarkaria Commission.

Shah clearly stated that as far as J&K is concerned, "no discussion of Central-State relations can proceed without prefacing it with a reference to our case for restoration of autonomy that our Government has mooted within the frame-work of Article 370 of Constitution of India." He said that recommendations of the State Autonomy Committee are important to bring the pattern of relations between the Union of India and the State of Jammu and Kashmir within the ambit that obtained after signing of the instrument of Accession which lasted till 9th August, 1953. He said that Autonomy Report together with its endorsement by J&K legislature is now on the National Agenda.

He said that despite certain avoidable misgivings in certain sections within the Country, the State is confident that given an objective appraisal of our case, and with our continuing efforts to familiarize our enlightened brethren, there should soon be a far more receptive endorsement of the frame-work being suggested in the report He said "it is our firm and sincere belief that the proposals put forward by us mark the first step in ensuring that Jammu and Kashmir is restored to a state of tranquility enabling us to resume the path of development and well-being as a part and parcel of the Union of India'

Referring to the Article 370 which defines J&K relationship with the Centre, Shah said that many of Sarkaria Commission's recommendations do not fully apply to J&K, but the State is nevertheless strongly in favour of a pro-active policy of greater delegation and decentralization. The process of economic liberalization currently underway reinforces the case for wider role for the states in various spheres requiring governmental intervention" he added.

Kashmir's Cure for Air Pollution?

ecently in April this year, Erickshaws were introduced for the first time in Kashmir Valley. The chargeable battery-driven auto-rickshaws ply from Gawkadal to Bohri Kadal area of Downtown Srinagar. Ease of commute has been the overstated benefit of these newbies on roads. Popular opinions say, the more the merrier, given that such public transport can reduce traffic jams, help decongest public transport and make navigating in peak hours very easy. However, the most important element of its introduction in the valley has to be its potential to mitigate air pollution. In the face of an impending global climate crisis, e-rickshaws in the valley need to be seen as more than just another vehicle on

Understanding the science behind it is going to facilitate our appreciation of it as. Take this:

When carbon-based fuels are burned, incomplete combustion causes the emission of carbon dioxide (CO2) and other pollutants, including particulate matter (PM) (aerosols), which include particles that can cool or heat the Earth's climate by reflecting or absorbing the radiation of the sun. A particular type of PM, black carbon (BC), survives relatively for a short period (one week) in the atmosphere but absorbs vast amounts of solar radiation. Solid fuel burning, especially indoors, and highemitting diesel engines, emit high levels of BC which contributes to climate warming.

The high levels of BC pollution in urban air in developing countries are also attributed to polluting industries and the operation of older vehicles. Global temperatures are estimated to have been excessively warmed by more than 15% due to it. Evidence from modelling studies suggests that climate change is likely to increase ozone concentrations, a major cause of respiratory illnesses in urban areas. To protect current and future generations from the health effects of fossil fuel burning, it is essential to reduce emissions as quickly

Researchers say combining policies that address local air pollution and global climate change will provide enhanced climate change mitigation benefits. Mediumterm efforts to control air pollution will provide additional benefits to long-term strategies that aim to curb climate change. Short-term reductions in BC can potentially delay the impact of global warming by approximately 10 years, allowing researchers and policymakers to do more research and step up their efforts. As far as vehicle interventions go, reducing emissions from super-emitting diesel and buses is the most attractive option.

Poor air quality is causing people to become ill and die prematurely, especially in low- and middle-income countries. Air pollution is linked to an estimated 4.2 million premature deaths a year, according to the World Health Organization. When indoor air quality is considered, that number rises by an estimated 2.9 to 4.3 million deaths a year, according to The Lancet Commission.

High PM2.5 concentrations, particulate matter smaller than 2.5 microns, are a significant health risk in densely populated urban areas in most low- and middleincome countries. It has been linked to both acute and short-term illnesses, and increased rates of respiratory and cardiovascular disease, asthma, pneumonia, and other health problems over time. PM2.5, which is largely caused by carbon burning and exudes from power plant smokestacks, vehicle exhaust systems, and open

fires, was identified as the sixth highest risk factor for death worldwide in a 2018 report by the Health Effects Institute (HEI) and the Institute for Health Metrics and Evaluation (IHME).

In addition, as a growing body of evidence indicates, COVID-19 patients may experience worse outcomes from longterm exposure to air pollution. During the early stages of the COVID-19 pandemic, the European Public Health Alliance reported that cities with higher levels of air pollution also had higher mortality rates with more severe symptoms among CO-VID-19 patients.

Air pollution linked with cognitive decline and de-

As per the opinion (a 25 July 2022 report) from the authoritative Committee on the Medical Effects of Air Pollutants (CO-MEAP), science advisers to the UK government, have said for the first time that dementia and a declining mental ability in older people around the world may be caused by air pollution.

As a result of reviewing nearly 70 studies, the group concluded there was an association between exposure to air pollutants and "an acceleration of the decline in cognitive function often associated with ageing, and with the risk of developing dementia."

Due to a scarcity of investigative idies the committee wasn't able to estimate how many older people had proven to have mental decline following exposure to air pollution. However, according to a 2018 study of Londoners, air pollution may be responsible for roughly 60.000 of the 209,600 new cases of dementia in the UK every year.

The formation of acid rain is caused by elevated levels of sulphur and nitric acids in the atmosphere due to emissions of nitrogen oxides (NOx) and sulfur dioxides (SO2). Water molecules in the atmosphere combine with Sulphur dioxide and Nitrogen oxides, emitted from industries and vehicles, leading to the formation of mild sulfuric and nitric acids which fall back on land as acid rain.

In highly industrialized areas and urban areas with high car traffic, factories and automobiles emit high levels of gaseous emissions every day. As a result, these areas experience exceedingly high amounts of acid rain.

Acid rain is very harmful to agriculture, plants, and animals. It washes away all nutrients which are required for the growth and survival of plants. It causes respiratory issues in animals and humans. Aquatic ecosystems are adversely affected by acid rain that falls into rivers and ponds. It damages the buildings and monuments made up of stones and metals.

Situation in Jammu and Kashmir

Despite Srinagar's reputation for pristine environments, scientists from the Indian Institute of Tropical Meteorology (IITM) and the University of Kashmir found that air quality declines drastically during the winter in Srinagar.

As per Times of India, Shakil Ahmad Romshoo, Former Head of the Department of Earth Sciences at Kashmir University, now Vice-Chancellor at IUST Awantipora, and one of the authors of the study said, "The number of cars on the roads needs to be decreased to check the emission of fossil fuels. Every year, J-K adds up to 1.5 lakh vehicles. We are forced to use our own vehicles because of the lack of a very efficient transport system."

In 2018, according to the figures for 2016, Srinagar's air was declared the 10th most polluted in the world by the World

Health Organization. "From November onwards, we tend to have air quality issues. Air quality remains largely within permissible limits during summer and spring, but during autumn and winter, it's very polluted. During the cold months, our air is only clean when we have precipitation episodes (rain or snow). At this time, breathing Srinagar's air is equal to smoking 40 cigarettes a day," Mudasir Ahmad Bhat, an environmental scientist, and researcher based at the University of Kashmir said in a conversation with Rising Kashmir.

As per 'Preliminary Study on Air Quality of Srinagar, (J&K), India' by Mehvish Sheikh & Ishtiyaq Ahmed Naja, published in June 2018, there is a higher concentration of NO2 at Lal chowk which is a commercial area and vehicular emission could be one of the reasons for a higher

The concentration of NO2 varied

that can help reduce the concentration of particulate matter (pollutants) in the air, including proper road macadamization, dumping of agricultural waste, and using clean energy sources instead of coal and wood. Additionally, scientists recommend regulating fuel adulteration by petrol pump owners and introducing cleaner alternatives like CNG and battery-powered vehicles.

The Energy and Resources Institute (TERI) released a paper in April 2018 on the pollution caused by autos. According to it, approximately 1200 tonnes of carbon dioxide, 4 tonnes of NOx and 0.5 tonnes of PM10 are emitted from the total fleet of auto rickshaws plying in the city of Bengaluru per day, and auto rickshaws contribute to 0.44 million tonnes of carbon emissions per year. Switching to electric autos could result in a reduction of carbon emissions by 0.11 million tonnes per year, PM10 emissions by 114.5 million tonnes per year, and NOx emissions by 37.6 million tonnes per year.

A rickshaw powered by electricity requires little maintenance and is cheaper to operate than one powered by petrol or compressed natural gas. In North India, where deteriorating air quality levels have rendered urban areas uninhabitable, the emission-free e-rickshaw is being hailed as the humble agent of change for a cleaner, less fossil fuel-dependent future.

While e-rickshaws are behind the auto-rickshaws from a technological standpoint, they are more energy-efficient and less polluting. The use of e-rickshaws could reduce the consumption of fuel oil for passenger transportation, which is both economically and environmentally beneficial.

People in Kashmir have suffered various times when there has been a shortage of petrol and diesel in the Valley. Had there been e-rickshaws, people would have been less dependent on fossil fuels

Electric buses eliminate both CO2 and black carbon emissions, so switching from local buses to soot-free vehicles can be an effective carbon reduction strategy. As per a Forbes report, Shenzhen, China, has switched to an electric bus fleet and now

A recent study on the effect of vehicular pollution on the ambient concentrations of particulate matter and carbon dioxide in Srinagar City, by Nikhil Savio, Faroog Ahmad Lone, Javeed Igbal Ahmad Bhat, Nayar Afaq Kirmani and Nageena Nazir, published in April 2022, revealed that throughout the year from June 2019 to May 2020, CO2 concentration was seen to be increasing in Srinagar city

maximum of 19.01μg/m3 during January, which is clearly higher than the permissible limit of 10 μg/m3.

current WHO guideline value of 10 µg/ m3 (annual mean) was set to protect the public from the health effects of gaseous nitrogen dioxide.

As per another study 'Winter Burst of Pristine Kashmir Valley Air' by Zainab Q. Hakim, Gufran Beig, Srinivas Reka, Shakil A. Romshoo & Irfan Rashid, published in February 2018, indicates that the air quality of Srinagar deteriorates significantly, particularly during winter, where the level of PM2.5 touches a peak value of 348 µg/m³ against the Indian permissible limit of $60 \,\mu\text{g/m}^3$.

It revealed that the annual PM2.5 emissions are highest from coal burning which is around 1246.5 tons/year followed by the emissions from vehicular combustion which is 220.5 tons/year, and the least are the emissions from fuel wood burning which is around 8.06 tons/year.

A recent study on the effect of vehicular pollution on the ambient concentrations of particulate matter and carbon dioxide in Srinagar City, by Nikhil Savio, Farooq Ahmad Lone, Javeed Iqbal Ahmad Bhat, Nayar Afaq Kirmani and Nageena Nazir, published in April 2022, revealed that throughout the year from June 2019 to May 2020, CO2 concentration was seen to be increasing in Srinagar city.

On a monthly basis, the maximum average concentration of CO2 was found during December and Shalimar recorded the highest carbon dioxide value of 637.57 ppm.

The recorded maximum average values at other locations were 622.33 ppm, 614.40 ppm, 592.23 ppm and 579.33 ppm at Jehangir Chowk, Dalgate, Parimpora and Pantha Chowk, respectively.

On the other hand, the maximum average concentration in spring reached 626.86 ppm in Jehangir Chowk and the minimum average for the same season was recorded in Shalimar (592.06 ppm). The average value of all the sites during the spring season was 609.29 ppm.

This is clearly higher than the global average atmospheric carbon dioxide, 414.72 ppm recorded in 2021 based on analysis from NOAA's Global Monitoring Lab.


I recently talked to an e-rickshaw owner in Lucknow who claimed the cost of the vehicle to be around 1.5 lakh, which on a single full charge of 7-8 hrs, covered a distance of 80 - 100kms. His monthly earnings were about 10 thousand. The vehicle had a maximum speed of 30kms per hour.

There is a need to increase the number of e-rickshaws already introduced in J&K earlier this year across Jammu and Kashmir. However, E-rickshaws' low speed can add to traffic jams in the already congested cities of Jammu and Srinagar. So, proper planning is required to ensure hassle-free movement of vehicles and at the same time shift to these eco-friendly

The bottom line remains that electric cars, trains, buses, and rickshaws are essential for achieving cleaner air in urban centres and can contribute to the mitigation of climate change as well. They're ultraefficient and emit no exhaust. Also, It will require clean electricity to power them.

Can Diaries Get Digital?

The first time I taught a college course called "The London Diary" for young Americans studying abroad back in 2002, each student ended up with a tangible book of memories, a handwritten record of their semester in London. But when I taught the course 15 years later, the first question my students asked was whether they could keep their journals online. The question brought home to me how the image of a diary has shifted from words scribbled in a blank book to images and digital text on a screen.

WHY NOT GO DIGITAL?

Even while journaling apps like Penzu and Diaro become more widely available, estimates and surveys suggest that a sizable number of the world's diary keepers still keep handwritten diaries.

Fans of digital diaries grant them an edge in convenience, portability, searchability and password protection. Jonathan, one of my 2018 students, described in an essay for class how digital diarists can upload entries to multiple platforms, keeping some portions offline or restricted to a select audience while other parts go completely public. It's harder to control distribution, encrypt entries or

build an index with a journal kept on paper.
I already expected my students to use electronic devices to read course materials, to communicate with me and with their families back home, to write essays for class, and to navigate London. Why not let them keep digital diaries, too?

DIARY AS ARTIFACT

Poet and literary scholar Anna Jackson was researching the private papers of novelist Katherine Mansfield for her book "Diary Poetics" when she made an unexpected discovery. Jackson came across a "piece of the world" that was also an element of Mansfield's journal - a kowhai flower between two pages in a notebook:

"After all this time, there it still was, still yellow, still between the same two pages Mansfield had placed it between all those years ago. A piece of the world she wrote about was right there as a piece of the world

still, not a piece of writing."

Jackson's experience shows the power of holding in your hand the diary as a physical object. What scholars call the manuscript's "materiality" links writer to reader in an unexpectedly intimate way.

For historians and diary scholars, manuscripts are artifacts. A book's binding, paper quality and ink can signal an anonymous diarist's socioeconomic status. Changes in penmanship may show how the writer felt - drowsy, extra careful or agitated - while writing certain passages.

Some clues, like the bit of evidence provided by inserting a memento, relay intentional messages. Others, like crossed-out words, may reveal information the writer did not plan to share.

Physical evidence can also hint at what happened after a text was written. Damaged missing nages may indicate a strong reaction to the contents. A few years ago, conservators at the National Maritime Museum in Greenwich, England, discovered a concealed entry in the diary of a 17th-century British

sailor. In his diary, he originally confessed to committing a rape, but later wrote a different account of the event, pasting the new page so carefully over the original that it went unnoticed for more than 300 years.

DIGITAL YET MATERIAL

Every original mark in a diary reflects an impulse of the moment. As diary instructor Tristine Rainer says in "The New Diary," "At any time you can change your point of view, your style, your book, the pen you write with the direction you write on the pages, the language in which you write, the subjects you include. ... It's your book, yours alone."

With so many convenient features, digital

diaries remain a popular choice. This option, we might be surprised to learn, even has its own form of materiality.

In "How to Read a Diary," literature scholar Desirée Henderson notes that digital diaries, too, are objects, shaped by tools the diarist selects - in this case, software and hardware – to create the diary. The writer's design choices, such as site structure, networking parameters, embedding of graphics, image and audio files and hyperlinks, offer grist for interpretation not unlike reading the nonverbal signs of a traditional diary.

WRITING INTO THE FUTURE

As I thought about offering my students

the online option, I began to imagine them many years from now, coming upon that London diary from their college days. I remembered my first group of students drawing sketches on their pages, attaching a Travelcard, café napkin, or theater ticket. I remembered Anna Jackson with the kowhai flower. I couldn't shake my conviction that future diary readers will be less enthralled by a digital product even enhanced with multimedia - than by

their predecessors. In the end, I assigned my students – at least those who were physically able to create their London diaries by hand.

They could still use their phones to capture images or take preliminary notes, but in the end they would produce a material keepsake.

Several students decided to write in their notebooks while also keeping a digital diary. The dual process felt natural to them. To his blog Jonathan posted, "Like many children of the 21st century, I love the idea of keeping everything journaled online. This way I can make notes on my phone as I walk, have them automatically update on my computer, where I can expand with more time. If I wake up in the middle of the night with an idea, I don't need to wake up a roommate with a lamp. However, the course also requires an ana-

"Keeping an open communication, and including this topic in your parenting conversations can make all the difference for your child. Reinforce that you will always believe them and that they can tell you anything and will never get in trouble no matter what happens" says Psychologist and Certified Parenting Coach, Fathima, she further shared 6 body rules that every parent should teach their children, on her recent Instagram post.

Teach your kids to say "NO". If they don't want to kiss or hug someone they should be able to say no to a person. Teach them the difference between a good touch and a bad touch.

1. My body is my body and it belongs to me

2. I have a safety, people

Teach them they can trust five people. Make a list of 4-5 safety people whom they can come and tell if they feel worried, scared

3. The correct name for the private parts

Teach them the right name of the private parts. Teach them no one can touch their private parts and no one should ask them to touch it. They can always come and tell to their safety people if they feel uncomfortable about it.

4. Safe and unsafe touch

Teach them at an early age around 2.5 to 3 years to differentiate between safe and unsafe touch. Make them understand safe touch like hugging, high-fives makes them feel loved, safe and comfortable. Unsafe touch makes them feel uncomfortable and unsafe.

5. Early warning signs

Teach them the early warning signs. If they feel frightened or unsafe, they may sweat a lot, have a sick tummy, become shaky and their heart might beat fast.

6. No Body Secrets

Teach them they should never keep any secrets which make them uncomfortable or feel bad about it. Teach them they should come and tell the safety people about it if they feel unsafe or bad about it.



Abducted Girl Traced Within 24 Hours: Police

SRINAGAR: Jammu and Kashmir Police on Friday claimed to have recovered an abducted minor girl within 24 hours in Budgam and arrested an accused person involved in the commission of crime.

In a statement issued here, a police spokesperson said that on Thursday evening, Police Post Soibugh received a written complaint from a resident of Khan Mohalla Soibugh stating therein that his minor daughter did not return home after school hours and the school administration stated that she didn't attend the school today.

Accordingly, a case under FIR number 306/2022 under relevant sections of law was registered at Police Station Budgam and investigation was set into motion.

"Subsequently, a special Police team under the supervision of IC PP Soibugh was constituted to trace out the missing girl. During the course of investigation, the Police team acting swiftly and raided various suspected locations. After strenuous efforts and working on some leads, the special team learnt that the missing girl was abducted by one Salib Ahmad Hella son of Assadullah Hella resident of Khuri Batapora Kulgam. The Police party accordingly raided the specific location and recovered the abducted girl. The abductor has also been arrested within 24 hours after the complaint was lodged," the spokesperson said.

After fulfilling all legal formalities, he said, the girl was handed over to her legal heirs. "Further investigation into the case is going on," the spokesperson added.

Thousands of people from different parts of Jammu and Kashmir and elsewhere take part in it to seek blessings of Vasuki Nag.

This festival is not only the symbol of the religion but also depicts our proud historical background and mutual brotherhood, Naresh Gupta, the main organiser, told PTI

and appealed to the administration led by Lt Governor Manoj Sinha to announce the event as a heritage festival and ensure its inclusion in the annual tourism calendar.

English Football Flaunts Financial Power In \$2.2 Billion Spending Spree

record spending spree by Premier League clubs in the summer transfer market passed the \$2.2 billion mark before the window closed Thursday with Manchester United, Manchester City, Liverpool and — belatedly — Chelsea all signing players to conclude the reshaping of their squads.

The headline transfer on a typically frantic final day of trading was the arrival of Brazil winger Antony at United from Ajax for \$95 million, making him the fourth expensive player in Premier League history and football's most expensive deadlineday signing.

That took United's total spend in this wildest of transfer windows to about \$240 million - a figure only topped in the whole of Europe by Chelsea, which fistriker in Pierre-Emerick Aubameyang from Barcelona. In the club's first transfer window in the post-Roman Abramovich era, Chelsea spent a staggering \$280 million.

Man City's signing of Switzer-land center back Manuel Akanji for \$17.5 million felt low-key by comparison, while Liverpool's only move — the loan signing of Brazil international Arthur Melo from Juventus - was still significant as it strengthened the team's injury-hit midfield.

Fuelled by income from huge global broadcasting deals worth about 10 billion pounds (\$11.8 billion) over three seasons, Premier League clubs have reverted to pre-pandemic levels of spending - and then some - to leavethe rest of Europe in its wake.

England's top-flight clubs spent about the same on players as those in the top leagues in Spain (\$500 million), Italy (\$750 million), Germany (\$485 million) and France (\$540 million) combined, according to calculations by the Transfermarkt website.

The net spend of the Premier League teams was \$1.35 billion, compared to Italy (\$8 million) and Spain (\$64 million). In France and Germany, the leagues actually made a profit according to Transfermarkt.

Summing up the outrageous splurge by English clubs was the business conducted by Notnally signed an out-and-out tingham Forest since securing a return to the Premier League for the first time since 1999.

Forest signed three players on deadline day to take its total number of incomings across the window to a remarkable 21, at a cost of \$160 million.

The Premier League's record for spending in a single season – covering both summer and winter transfers windows — previously stood at 1.86 billion pounds (\$2.18 billion) in 2017-18.

That figure was surpassed in this transfer window alone.
