India Becomes 5th Largest Economy In The World

New Delhi: India has overtaken the UK to become the world's fifth-largest economy and is now behind only the US, China, Japan and Germany, according to IMF projections.

A decade back, India was ranked 11th among the large economies while the UK was at the fifth position.

With record beating expansion in the April-June quarter, the Indian economy has now overtaken the UK, which has slipped to the sixth spot.

The assumption of India over-taking the UK is based on calculations by Bloomberg using the IMF database and historic exchange rates on its terminal.

"On an adjusted basis and using the dollar exchange rate on the last day of the relevant quarter, the size of the Indian economy in 'nominal' cash terms in the quarter through March was USD 854.7 billion. On the same basis, the UK was USD 816 billion," stated a

Bloomberg report. With India being the world's fastest growing major economy, its lead over the UK will widen in the next few years.

"Proud moment for India to pip the UK, our colonial ruler, as the 5th largest economy: India \$3.5 trillion vs UK \$3.2 trillion. But a reality check of population denominator: India: 1.4 billion vs UK 0.068 billion. Hence, per capita GDP we at \$2,500 vs \$47,000. We have miles to go... Let's be at it!," Uday Kotak, CEO of Kotak Mahindra Bank, said in a tweet.

India has a population 20 times that of the UK and so its GDP per capita is lower.

Stage Set For Azad's First Power Show Today

Jammu: Ghulam Nabi Azad, who recently broke his five-decade-long association with the Congress, will begin his fresh political journey Sunday from Jammu where he would set up the first unit of his own party.

All preparations have been completed for Azad's first public rally in Jammu, a close aide of the former chief minister said on the eve of the public meeting.

Azad would be accorded a grand reception on his arrival from Delhi Sunday morning, and a procession would accompany him to the venue of the public meeting at the Sainik Colony, former minister G M Saroori said.

Saroori is among over two dozen prominent legislators who resigned from the Congress in support of Azad. The 73-year-old Azad is likely to announce the formation of his own political party.

Azad, 73, ended his five-decade association with the Congress on August 26, terming the party "comprehensively destroyed". He also lashed out at Rahul Gandhi for "demolishing" the party's entire consultative mechanism.



CEOs Missive To School Teachers Sparks Dress Code Debate

Srinagar: A letter shot by an officer of the School Education Department (SED) in Jammu and Kashmir has sparked a debate once again on whether teachers should follow a dress code in schools.

In a circular addressed to all the heads of the schools, the Chief Education Officer (CEO) Pulwama has said that all the teachers and staff of the schools and other offices are directed to maintain a dress code and become a role model for the students in particu-

lar and public in general. "It is impressed upon all the HOIs (Heads of Institutions) of the district in the education department to implement proper dress code of their staff. Any laxity in this regard shall be viewed seriously," reads the circular issued by CEO Pulwama, N A Reshi.



He said the department of education was also named as **Human Resource Development** which means all round development of the child including, psychological, moral, social. mental and overall behavioural.

Invoking old day practices, the CEO in his circular has stated that long back teachers were modestly dressed and used to wear Sheerwani, Turban and Shalwar which in-turn influenced the child's personality in a positive manner.

'Nowadays Teachers opt for casual wear and are wearing Jeans Pant and half sleeves shirts, and this has negatively affected the students' personality, behaviour and sense of thought," the circular reads.

Video Shows Students Carrying Cylinder Uphill, Probe Ordered

Jammu: Authorities in Jammu and Kashmir's Poonch district on Saturday said they were verifying a video purportedly showing students carrying a domestic cylinder to their school located on a hilltop.

The video, which has gone viral, shows the students of Government Middle School Upper Bhatidhar, Mendhar in uniform struggling as they pulled the LPG cylinder with a rope through a narrow track between green fields, passing obstacles along the way.

The person who shared the video questioned the school management for making the students take up such a task.

The sub-divisional magistrate has ordered a probe, a senior official said.

"Strict action as per law would be taken if anyone is



found guilty," he added.

Meanwhile, another video showing some students of Government Higher Secondary School Gali Kalaban pulling a big stone along with some labourers at a playground has also gone viral on social media.

Excess Blue Light From Phones, Tablets May Accelerate Ageing: Study



Excessive blue light emitted by devices such as smartphones, computers and tablets may accelerate the ageing process of the body, according to a study conducted in fruit flies.

Previously, studies have linked too much screen use to disorders such as obesity and psychological problems.

"Excessive exposure to blue light from everyday devices, such as TVs, laptops, and phones, may have detrimental effects on a wide range of cells in our body, from skin and fat cells, to sensory neurons," said Jadwiga Giebultowicz, a professor at Oregon State University, US, and senior author of the study.

"We are the first to show that the levels of specific metabolites -chemicals that are essential for cells to function correctly -- are altered in fruit flies exposed to blue



light, Giebultowicz said.

The study, published in the journal Frontiers in Aging, suggests that avoidance of excessive blue light

exposure may be a good anti-ageing strategy.

The researchers have previously shown that fruit flies exposed to light "turn on" stress protective genes, and that those kept in constant darkness lived longer.

"To understand why high-energy

blue light is responsible for accelerating ageing in fruit flies, we compared the levels of metabolites in flies exposed to blue light for two weeks to those kept in complete darkness," explained Giebultowicz.

Blue light exposure caused significant differences in the levels of metabolites measured by the researchers in the cells of fly heads.

In particular, they found that the levels of the metabolite succinate were increased, but glutamate levels were lowered.

Succinate is essential for producing the fuel for the function and growth of each cell. High levels of succinate after exposure to blue light can be compared to gas being in the pump but not getting into the car.

"Another troubling discovery was that molecules responsible for communication between neurons, such as glutamate, are at the lower level after blue light exposure, Giebultowicz said.

The changes recorded by the researchers suggest that the cells are operating at suboptimal level, and this may cause their premature death, and further, explain their previous findings that blue light accelerates ageing.

"LEDs have become the main illumination in display screens such as phones, desktops and TVs, as well as ambient lighting, so humans in advanced societies are exposed to blue light through LED lighting during most of their waking hours," explained Giebultowicz.

"The signalling chemicals in the cells of flies and humans are the same, so the there is potential for negative effects of blue light on humans," Giebultowicz said.

The researchers will carry further work to study the effects of blue light directly on human cells.

Water Crisis

he valley of Kashmir, otherwise known as the paradise on earth, is reeling under an acute, and perhaps unprecedented, shortage of drinking water these days. The public health engineering department has pressed into service its lousy tanker service in the capital city of Srinagar and may be some major towns to supply bucketfuls of water leaving the millions living in the countryside to fend for themselves as they have been so far. Over the recent weeks, the city witnessed massive demonstrations by irate citizens to protest the scarcity. As is its wont, the government's response was brutal, to say the least. At places, its policemen resorted to baton charge Batmaloo women injuring a dozen of them when they demonstrated outside the civil secretariat to jolt the callous government out of its deep slumber. Ironically, the water scarcity is being experienced when the administration is otherwise bracing up to meet any eventuality arising out of floods that threaten parts of the valley, Jammu's Doda and Jammu districts and Ladakh region. Even as the rivers and nullahs are in spate, the abundant water is elusive for those who need the most. The water from most rivers and streams is believed to have become unsafe for human consumption due to inflow of heavy pollution.

According to reports, the heavy rush of Amarnath cave-bound pilgrims via Baltal route is a matter of serious concern as they leave tones of human waste and litter into the Sindh river flowing through Baltal and Sonamarg, which feeds the city's Rangil water treatment plant. The Dal lake wherefrom water is lifted into the water supply system is no less contaminated.

Rubbing salt into the people's wounds is none other than the 'honourable' minister of public health engineering department, Qazi Muhammad Afzal. Instead of owning the moral responsibility for the prevailing crisis and quitting gracefully, he has the cheek to pass the buck thus: "The government spends huge amounts of money to filter and treat water reservoirs to make the water fit for human consumption. But people waste this water to irrigate flower beds and wash their cars". Even as his claim of expensive water treatment may be a matter of conjecture, who will ask

the minister to enlighten the public about the total number of car owners or those having lawns? Including the Qazi himself, they certainly must be a microscopic minority. The vast multitude of people, about whom the minister seems to be absolutely clueless, happen to be on the wrong side of the social divide. Going by the reports, the PHE authorities trace the crisis to obsolete pipes and treatment plants. On their part, its employees, allegedly starved of tools and implements, spilled the beans about the problem and held the engineers squarely responsible for it.

Agreed, the government has been spending money not merely on water treatment but primarily on execution of major and minor water supply schemes. It must have spent thousands of crores since the inception of the so-called planned development in the state alongside rest of India. Why then are most water supply schemes defunct? Where has all the money claimed to have been utilized on these works gone? In an era of transparency and `good governance,' it is time the government took the people into confidence on the issue and brought out a white paper on the PHE.

Unfortunately, all the successive governments here have seldom got their priorities right. Drinking water like oxygen is vital for sustenance of life. If the accusations and counter-accusations within the PHE were to be believed, the key sector in dire need of remodeling and upgradation has been starved of adequate funds. Instead, the scant resources available to the state are frittered away on totally irrelevant and frivolous pursuits. A government that wastes a few crore rupees on vandalizing a beautiful footpath along the Dal lake allegedly to benefit some blue-eyed boy or whose chief minister flies alongwith his elaborate paraphernalia from the winter capital to reach a remote village in his home district to cut the ribbon to inaugurate a small branch of a bank certainly cannot be expected to devote any attention to the critical PHE sector even if more than 50 per cent of diseases are said to be water-borne.

Revise Student Union for Student Welfare in Kashmir

ashmir University has been in the news lately for all the wrong reasons. A local newspaper has been publishing stories on the issues university students have been facing. To begin with, there had been no discussion with students on National Education Policy-2020. The two battery-operated vehicles for specially-abled students and research scholars had been put out of use because the university had failed to maintain the vehicles. These are just some of the issues that were brought to attention by the local newspaper. There are numerous other issues also that didn't make it to the media.

All these are essentially student issues that make them fundamental to the functioning of a good education system. Not to mention that the students are the primary stakeholders in the university. They should not have to go to media outlets to get their grievances redressed. There should be a mechanism within the university where the collective and individual grievances of students are heard. If students have to make a university hold discussion on NEP-2020 by informing the university authorities through a newspaper, it points out a sad state of affairs within the university. One can only assume that the university administration is not accessible to its students.

Since Kashmir University is a public university, the question raised here is, how does a public university become accessible to its students? One of the time-tested policies followed by universities in India and across the world is student unions. In this case, rather than the media, it is the students' that act as a bridge between students and the university administration. These unions aid university administrations in better governing the campus and resolving student concerns.

In the case of Kashmir, the state government has always crushed students' political activities. Student movements in Kashmir began in the early 1960s. It is said that in April 1964, when Sheikh Abdullah was released from prison, members of the Jammu and Kashmir Students' and Youth League joined the crowds that welcomed him. The league had put up a banner in support of Abdullah that read "Your Lead, Our Struggle". When he saw it, "he used his walking stick to pull it down as he passed by". Therefore, after Abdullah's release from jail, his "first action was this, against the students". The act says a lot about how Kashmiri politicians view student politics. This move clearly stated that even when in support, student politics should be discouraged.

As far as the contemporary context of student politics in Kashmir is concerned, it was banned after the onset of insurgency in Kashmir. However, after a long battle with authorities, Kashmir University Students Union (KUSU) was finally formed in 2007. After the 2008 agitation, the state pressured the university to curb political activities on its campus. Subsequently, the KUSU office was sealed in 2009. In 2010, Kashmir University demolished the KUSU

office. The varsity made it clear that whatever little student politics existed before would not be allowed to exist on the campus anymore. Ironically, the action came when Riyaz Punjabi was the Vice Chancellor of the university. He had been formerly associated with JNU, which is known to be the hub of student politics in India.

In October 2017, in an RTI reply, the university disclosed that it had not officially banned the student union. No order or circular was ever issued by the varsity to ban KUSU. However, on November 15, 2017, an order issued by the Chief Proctor's Office ordered students not to hold any political or religious debates inside the campus.

It is often argued that students should focus on education rather than politics. However, the facts point out that universities with solid student unions perform better. Take JNU for instance, which is one of the top-most ranked universities in India and produced brilliant scholars in multiple fields. It's no surprise that it also has a strong students' union. The positions its students hold- from ministers in the current ruling central government to the administration, speak for themselves.

A Student Union at Kashmir University would provide the students with a systematic and efficient way of asking for their basic rights as students. These rights are not necessarily always political in nature like the previous governments have feared. But it would at least allow the students to report any sort of exploita-

tion or discrimination at the hands of a superior or at the minimum rightfully demanding of the basic amenities in the hostels and classrooms.

The ban on student politics on university campuses has deprived Kashmir of its rightful share of intellectual mainstream politicians. A look at the list of all the politicians in Kashmir reveals very few of them might have chosen politics for the general well-being of the society. A majority of them are in politics because either their families were in politics (PDP and NC) or because of their "electability".

The current administration has often repeated that it is working to foster grassroots democracy in Jammu and Kashmir. While it has held elections for the urban and rural bodies of J&K, it would be interesting to see what the government thinks about the grassroots democracy in universities and colleges across Kashmir.

The main goal of Article 370, as stated by the government, was to bring Jammu and Kashmir on par with India. If that is true, the J&K administration should also bring its universities and colleges on par with Indian universities and colleges. It is high time that legitimate forms of student activities be allowed in Kashmir.

The Fed Is Overreacting

THACA – At this year's Jackson Hole symposium, a major event on the calendars of the world's central bankers, US Federal Reserve Chair Jerome Powell delivered an uncharacteristically strong message about how the Fed plans to combat today's high inflation.

The Fed raised interest rates sharply, by 75 basis points, in both June and July, but Powell made it clear that the rate hikes are unlikely to stop there or even to taper off. Instead, he said, "unusually large" rate increases will continue into the near future. The coming hikes will hurt US households and businesses, but "a failure to restore price stability would mean far greater pain."

Powell's hawkish remarks caused the S&P 500 to fall by 3.4%, with every sector of the index declining. Many fear that if the Fed continues to raise interest rates in large increments, as Powell suggested, investment will plummet and unemployment will rise. In fact, aggressive monetary tightening would cause the economy, financial markets, and people's well-being to suffer excessively. Like an overdose of steroids, it may cure the illness but at a disproportionately high cost.

The Fed's mistake reflects a misreading of the US labor market, which Powell noted "is particularly strong." And it is indeed true that US wages have been rising sharply. Average hourly wages increased by 5.2% year on year in July, and are rising faster than the prices of many goods.

But it is wrong to equate current strong wage increases with inflation. That is because the CO-

VID-19 pandemic has provided an intriguing twist to a standard economic argument in the form of the "Great Resignation." This strange phenomenon, whereby many Americans who left the labor market during the pandemic because of workplace and school closures are not returning, even as COVID-19 wanes, has revealed a labor-market equilibrium that keeps the hourly wage rate low, which in turn means both parents must continue working full-time. The equilibrium persists.

Now suppose there is a major pandemic, and children cannot go to school. Even in low-income households, at least one adult must stay home to look after small children.

was previously hidden from view. It is like seamount that becomes a visible island only when the water level recedes.

Consider a typical American family, with two adults and some children. When hourly wages are very low, both adults probably must work full-time to earn enough income to meet the household's basic needs. But if hourly wages were substantially higher, the adults would choose to work fewer hours, so that they could take turns to be at home in order to attend better to their children's needs. (Alternatively, one adult might stay at home altogether or do some light

Suppose that the economy is settled in the former, low-wage equilibrium in which both parents work full-time. Because all households do the same, there is a large supply of labor on the market. That

and children return to school, there is bound to be a lag in adults returning to in-person work. As creatures of habit, many people become accustomed to working from home, or just not working. So, as markets begin to return to normal, there is a shortage of labor and wages are bound to rise.

Eventually, even after the habit wanes, the economy can end up at the other, higher-wage equilibrium that always existed in dormancy. Once this equilibrium is reached, even though wages are high, the labor market will be tight, with no glut of job seekers, and it will remain there.

Many have noted that relatively few Americans are filing for unemployment benefits. This would be a surprise if the labor market was out of equilibrium, with many people looking for work. Clearly, that is not the case. The economy

has simply shifted to a higher-wage equilibrium, thanks to the big pandemic-induced jolt to the labor market.

Part of the rise in US wages reflects this adjustment. To overlook this and regard current wage increases solely as the result of inflation can lead to an excessive policy reaction. That is the mistake the Fed will make if it persists in raising interest rates sharply.

My argument is admittedly a theoretical one, but it can be easily assessed. The Fed has sufficient data and expertise to work out how much of the wage movement is simply a shift to the new equilibrium, and how much is a part of overall inflation.

My hunch is that, once the Fed completes this exercise, it will want to temper its policy response to today's inflation. A less hawkish stance would minimize the adverse side effects of the Fed's medicine and greatly benefit small and large US businesses, workers, and financial markets, and achieve the same results as far as inflation is concerned. Given that US monetary policy has a much bigger effect on other countries than vice versa, this could be a big relief for the global economy, too.

PAKISTAN FLOODS WHAT ROLE DID CLIMATE CHANGE PLAY?

akistan is experiencing the most devastating and widespread floods in its history, with the country's climate minister saying waters have reached across a third of the nation.

The growing tally of impacts is dire. More than 1,100 people have been killed, a million homes have been destroyed and 33 million people have been directly affected. Total damage estimates exceed US\$10 billion (£8.6 billion), and further disruption to the country's economy and critical food production is inevitable.

On August 25, the government declared a national emergency. António Guterres, the UN secretary-general, said that this is a signal to the world to step up climate action, warning: "Today, it's Pakistan. Tomorrow, it could be your country."

At a very broad level, this is certainly justified. According to the Intergovernmental Panel on Climate Change (IPCC), extreme rainfall is becoming more frequent and intense in many parts of the world due to human emissions of greenhouse gases. And this effect will continue to increase with emissions.

However, for individual events that have such profound impacts on society, it is critical to investigate the influence of climate change (or lack thereof) in more detail. While the IPCC statement holds globally, its most recent report states it has only "low confidence" in how much climate change is to blame for increased heavy rains in south Asia.

It is vital we better understand cause and effect in the observed changes, to help us make best use of our finite resources and



ultimately save lives and money.

RECORD-BREAKING MONSOON RAINFALL

It is tempting to ask if an extreme weather event was "caused by" climate change, but this is often the wrong question, at least if you expect a binary answer. Instead, scientists like us ask whether and by how much climate change affected the likelihood and intensity of the event. This is known as "extreme event attribution".

In this case, the flooding was caused by an extreme monsoon season. Pakistan is on the far western edge of the south Asian monsoon region, with a mostly arid desert climate. It is only sometimes affected by an offshoot of the monsoon, and generally receives far less rainfall than parts of India at the same latitudes.

However, record rainfall fell over Pakistan in several bursts from mid-June to late August with large swathes of the country receiving a completely unprecedented 500%-700% of their usual August rain.

YET ANOTHER COST OF CLIMATE CHANGE? Officials from the Pakistan Meteoro

Officials from the Pakistan Meteorological Department blamed climate change for the unusual monsoon activity and flooding, for a range of reasons.

In 2021, the IPCC reported that there has been a significant increase in heavy rainfall events in south Asia in recent decades. There is some evidence that this is due to human-caused climate change.

However, there is limited agreement

However, there is limited agreement between different assessed studies, and factors other than climate change, such as irrigation, are known to influence monsoons. Confidence is therefore too low to make any concrete attribution statements without further investigation.

Before a dedicated study is available,

similar events in the recent past can hold clues to current events. Pakistan last experienced flooding on a similar scale in 2010, which at the time was labelled by Guterres' predecessor at the UN, Ban Ki-moon, as the worst disaster he'd ever seen.

Two separate attribution studies assessed this event. Unfortunately, neither provided evidence that the models used were up to the task. Therefore, even though one of them found an increase due to human climate change, we cannot be very confident in this result.

Clues as to the role of climate change can also come from aspects that contributed to this disaster. There are three main factors.

First, extreme rainfall. A warmer atmosphere holds more moisture. For every degree the atmosphere warms it can hold about 6%-7% more moisture, which often results in more rain falling during the most extreme events (south Asia has warmed around 0.7°C since 1900). Had this event happened in a world where carbon dioxide concentrations were instead at pre-industrial levels, the rains probably would have been less intense.

Second, the monsoon itself, which is highly complex and variable. It forms in south Asia in the summer, when air over land warms faster than air over the sea, which creates a flow of air onto the land. The winds bring great volumes of moisture that precipitate into deluges when they meet higher ground, especially the Himalayas.

Unusual monsoon rains over Pakistan have some predictability. They occur when multiple phenomena coincide, including a La Niña event in the Pacific and large meanders in the high-altitude jet stream, as was the case in both 2010 and this year.

There is emerging evidence that this confluence of factors may occur more regularly as the climate changes. If such trends continue, then flooding in Pakistan and other simultaneous extremes across the northern Hemisphere will happen more often in the future.

Pakistan also experienced extended and brutal heatwaves in May and June this year, which were amplified by climate change. This heat amplified the monsoonal "thermal low" - a low-pressure system created by hot air rising rapidly - which greatly enhanced the flow of moisture-laden air onto southern Pakistan.



PROACTIVE IS FAR CHEAPER THAN REACTIVE

Pakistan is undoubtedly on the front lines of climate change. In the ongoing flooding, it is clear that climate change has at minimum played a role in amplifying this event. At worst, it created a compounding set of circumstances causing millions of additional people to suffer than otherwise might have.

Projections are very clear that with further climate change, Pakistan is a hotspot for increases in extreme rainfall. The country must prepare for future flooding to avoid similar or even worse disasters. To do so, international adaptation funding must increase to match rich countries' overwhelming contribution to this new climate.

Plea Claims Prominent Mosque In Badaun Is Site Of Shiva Temple, Seeks Permission For Hindus To Offer Prayers

Budaun: A plea has been in a court here claiming that Jama Masjid Shamsi in Badaun city is a temple of Lord Shiva and seeking permission for followers of the Sanatan Dharma to offer prayers at the site, a lawyer for the petitioners said on Saturday.

A separate application has been filed in the matter urging the court to appoint a commission for a survey of the site.

Civil judge (senior division) Vijay Gupta took up the matter on Friday and directed the Intezamia Committee managing the Shamsi Jama Masjid to present its side on September 15, when the court will next hear the matter

Ved Prakash Sahu, an advocate for the petitioners, said the plea contends that the building is not of Jama Masjid, but an ancient Ishaan mandir of Neelkanth Mahadev Maharaj.

The petitioners are the state convenor of Akhil Bharat Hindu Mahasabha, Mukesh Patel, advocate Arvind Parmar, Gyan Prakash, Anurag Sharma and Umesh Chandra Sharma, who have claimed in the structure is Neelkanth Mahadev temple located in the fort of Raja Mahipal.

One of the petitioners, Arvind Parmar, on Saturday said that the first party is the deity, Neelkanth Mahadev Maharaj, himself.

Parmar said that they have pleaded that the followers of the Sanatan Dharma should be allowed to offer prayers at the temple of Neelkanth Mahadev. Also, police and administration must be directed to ensure there is no objection, dispute or interference during worshipping.

He said that a separate application has been filed in this matter urging the court to appoint a commission to undertake a survey of the mosque

The petition has mentioned books that, it claims, say that the mosque is the Neelkanth Mahadev Mandir.

The diary published by the information department also contains this information, and this was also presented by the petitioner, Parmar claimed.

The mosque is built on an elevated area called Sotha Mohalla and is considered the highest structure in the town of Budaun. It is also believed to be the

third oldest existing and seventh largest mosque in the country, having a capacity of 23,500.

There have been several similar suits, including in Mathura and Varanasi, claiming that mosques there were sites of ancient Hindu temples.

Dalit Student Hit With Metal Rod For Touching Teacher's Bike

Ballia: A Dalit student here was allegedly locked up in a classroom and beaten with a metal rod by his teacher for touching the latter's motorcycle, police said on Saturday.

The SHO said the matter is being investigated.

Fuel Leak Ruins Nasa's 2nd Shot At Launching Moon Rocket

Cape Canaveral: NASA's new moon rocket sprang another dangerous fuel leak Saturday, forcing launch controllers to call off their second attempt to send a crew capsule into lunar orbit with test dummies.

The first attempt earlier in the week was also marred by escaping hydrogen, but those leaks were elsewhere on the 322-foot (98-meter) rocket, the most powerful ever built by NASA. NASA Administrator Bill Nelson said repair work could bump the launch into October.

Mission managers planned to meet later in the day to decide on a course of action.

After Tuesday, a two-week launch blackout period kicks in. Extensive leak inspections and repairs, meanwhile, could require that the rocket be hauled off the pad and back into the hangar; that would push the flight into October, Nelson said.

We'll go when it's ready. We don't go until then and especially now on a test flight, because we're going to stress this and test it ... and make sure it's right before we put four humans up on the top of it, Nelson said. He added: This is part of our space program: Be ready for the scrubs.

NASA wants to send the crew capsule atop the rocket around the moon, pushing it to the limit before astronauts get on the next flight. If the five-week demo with test dummies succeeds, astronauts could fly around the moon in 2024 and land on it in 2025. People last walked on the moon 50 years ago. Launch director Charlie Blackwell-Thompson and her team had barely started loading nearly 1 million gallons of fuel into the Space Launch System rocket at daybreak when the leak cropped up in the engine section at the bottom.

Ground controllers tried to plug it the way they handled previous leaks: stopping and restarting the flow of super-cold liquid hydrogen in hopes of closing the gap around a seal in the supply line.

Massive Eviction Drive Underway In Assam's Sonitpur Amid Heavy Security

Tezpur: A massive eviction drive to clear 330 acres of land in Assam's Sonitpur district began on Saturday morning amid heavy security, police said.

About 50 excavators, heavy machinery and a large number of workers were deployed for the drive to demolish houses in No 3 Chitalmari area in Barchalla on the northern bank of Brahmaputra river, they said.

The process has been peaceful so far with almost all the illegal residents having already left the place with their belongings after receiving the eviction notice, a police officer said.

The eviction drive has been incident-free so far. There has been no law and order situation," the officer, who is among those overseeing the exercise, said.

The drive began around 5 am and as most residents had already vacated their houses, the structures are being demolished with the help of excavators and other heavy machinery, he said.

The area to be cleared has been divided into three parts and the demolition in one part has been completed by 9 am, another police officer said.

About 1,200 security personnel, including those of Assam Police and para-military forces, have been deployed at the site, equipped with anti-riot gear.

As per government records, 299 families were living in the area, but more than 90 per cent of them have already left after receiving the notice around eight months back.

Some of the residents being evicted lamented that no rehabilitation has been provided to them by the government.

"We have been living here for decades. We have no jobs and live off the fields here. We don't know where we will go," a woman said, gathering the last of her belongings as the excavators approached the structure that used to be her

A district administration official said that patrolling in the area by security forces was on since August 31, and that prompted the people to vacate the land voluntarily. "We could not carry out the

eviction drive earlier due to various reasons. Now, most of the people have agreed that this is government land and it will be used for developmental work," the official told PTI.

Locals said that most of the

people had migrated to the area several decades ago from Nagaon and Morigaon districts on the southern bank of Brahmaputra following massive erosions.

When asked about the demography of the area, the district official said, "It is a mix of several communities. The most number of families are Bengalispeaking Muslims, followed by Bengali Hindus and Gorkhas."

Explaining the designs of the 12 carpets, Abdul Rahim, a carpet weaver from Khanpur village said that size of the design is very different from contemporary ones.

"It starts with less width and goes on to become broader. It's more like a triangle. Five artisans work to make the broader part of design, then 3 artisans work to create the middle portion and finally, two artisans sit together to enhance the design. It's such an exhilarating process. These carpets will help our industry a lot," Rahim told Kashmir Observer.

He said that most of the village has been earning wages through the carpet industry for over 5 decades now. 'However, most of the time we've to participate in part-time jobs as the normal wages to make carpets are very low. It ranges from Rs150-200 on a normal day," says Rahim

"But, since this parliament project was assigned, we're earning pretty good. On an average we're being paid 500 rupees per day. This project has helped to lift our fading artisan community," he added.

He further said that it is for the first time that they have received this kind of an order. "We've already given final touches to 9 carpets. As of now we're completing 3 other carpets. They'll be completed by the end of this month," says Rahim, adding that the width of these 12 carpets is 8 feet and 4 inch and the length is 10 feet and 5.5 inch with 24 knots per inch.

Notably, the iconic carpet industry of Kashmir has been facing a sharp decline in recent years, forcing most carpet weavers to take up odd jobs to earn their livelihood. The weavers say economic losses during the pandemic lockdowns have dealt a big blow to Kashmir's multi-crore carpet industry.

Echoing similar views, Shabir Ahmed, another artisan who has been in the carpet industry for the past 3 decades, says that he was on the brink of quitting before the parliament order gave a new lease of life to his career.

"We were facing major losses and not able to earn anything. We were not getting good rates for carpets, so we were about to stop making carpets". Ahmed told Kashmir Observer, adding that this project has saved his skills.

He said that the artisans from his village are hopeful that they'll receive more such orders that will eventually boost this traditional art and weavers'

"There goes a lot of hard work into making this rug as they're very intricate. Imagine a person sitting at one place for over 8 hours. But, if it wasn't for this project we would still be earning a very meager wage. This project has helped to lift our community. We're hopeful that the Government will give us more such projects so that we can live a peaceful life and keep this traditional art alive," Ahmed said. adding that the 12 carpets for the par-

liament have 12 different colors. It is pertinent to mention here that the artisans believe that this traditional art needs to be given due attention so that this artwork will live for generations to come. "90 percent of our village is involved with handicrafts. If an economic boost isn't given to our industry then our whole community will cease to exist," says Ahmed.

India Becomes 5th Largest

growth of 13.5 per cent year-on-year compares to a 20.1 percent expansion a year back and 4.09 per cent growth in the previous three months to March, according to official data released earlier this week.

The growth, though lower than the Reserve Bank of India (RBI) estimate of 16.2 per cent, was fuelled by consumption and signalled a revival of domestic demand, particularly in the services sector.

Pent-up demand is driving consumption as consumers, after two years of pandemic restrictions, are stepping out and spending. The services sector has seen a strong bounce back that will get a boost from the festival season next month.

But the slowing growth of the manufacturing sector at 4.8 per cent is an area of worry. Also, imports being higher than exports is a matter of concern.

Additionally, an uneven monsoon is likely to weigh upon agriculture growth and rural demand.

The GDP print will, however, allow the RBI to focus on controlling inflation, which has stayed above the comfort zone of 6 per cent for seven straight months.

The central bank has raised the benchmark policy rate by 140 basis points in three installments since May and has vowed to do more to bring inflation under control.

Besides tighter monetary conditions, Asia's third-largest economy faces headwinds from higher energy and commodity prices that are likely to weigh on consumer demand and companies' investment plans.

Also, consumer spending, which accounts for nearly 55 per cent of economic activity, has been hit hard by soaring food and fuel prices.

The GDP growth in the first quarter of the current fiscal was higher than China's 0.4 per cent expansion in April-June.

circumstances". His resignation came close on the heels of an ex-deputy chief minister, eight former ministers, an ex-MP, nine legislators and a large number of Panchayati Raj Institution members, municipal corporators and grassroots workers from across Jammu and Kashmir left the Congress to join the Ghulam Nabi Azad camp.

Azad, 73, ended his five-decade association with the Congress on August 26, terming the party "comprehensively destroyed". He also lashed out at Rahul Gandhi for "demolishing" the party's entire consultative mechanism.

In his letter, Sharma who had won the assembly elections from Kalakote constituency of Rajouri district in 1996, said, "I loved my party from the core of my heart and fought for building it at the grass-root level for decades together from smaller territorial units to many states of the country."

Meanwhile, the Jammu and Kashmir Apni Party on Saturday expelled a senior leader for "anti-party" activities.

"Farooq Ahmad Khayal, provincial secretary Jammu has failed to fulfil the aspirations of the party despite repeated requests made to him from time to time. On the other hand, he has been found indulging in anti-party activities," provincial president Manjit Singh said.

Expelling Khayal with immediate effect, Singh said the decision was taken in the interest of the party.

Pak Agent Arrested

"He used to provide secret information of various police establishments and security forces to a Pakistan-based handler through various social media platforms, police said in a statement.

Earlier, officials identified the arrested person as Qari Abdul Wahid (25), who was also performing the duties of a maulvi (prayer leader).

Wahid was staying at the madrassa at Dadpeth village along with his wife and a seven-month-old son. He was working as a teacher there, the officials said.

Terming his arrest a "major breakthrough", the officials said initially military intelligence gathered information about the presence of a suspect who was passing information across the border.

Wahid came on the radar of different security agencies that worked together to identify and arrest the accused. He was called for questioning last week, they said.

During interrogation by police, military intelligence and State Investigation Agency (SIA), Wahid admitted to having been working for lesser-known group Kashmir Janbaz Force (KJF) since December 2020 and passing on videos and photos of security installations, the officials said

Wahid was "inclined towards terrorism" and came in contact with selfstyled KJF commander Tayyab Farooqi alias Umar Khatab on social media. He became an active member of the group online, besides offering to be an

active terrorist, they said. He was in regular contact with some unidentified people, possibly Pakistani intelligence operatives, who offered him money and new phones for motivating local youth to join terrorism,

SRINAGAR: Taking the GI of Kashmir Handicrafts to the next level, the Director Handicrafts & Handloom Kashmir on Saturday held a detailed discussion with the authorities of Intellectual Property India; Patents, Designs, Trademarks, Geographical Indications, Chennai to speed up the process of GI registration of five crafts viz., Kashmir Namda, Wagguv, Shikara,

Gabba and Kashmir Willow Bat. The dossier for registration of these crafts has already been submitted to the Intellectual Property India, Chennai which is the apex level organization for the registration and better protection of geographical indications relating to goods in India, an official spokesperson said.

He said that the Assistant Registrar of Trade Marks & GI and Examiner of Trade Marks & GI who were representing Intellectual Property India, Chennai assured that the GI shall be conferred to these five crafts very soon.

"Director H&H also led the discussion regarding submission of three more dossiers for Copperware, Willow Wicker and Chain Stitch crafts of the valley which are already under consideration of the department for GI registration," he added.

"Pertinently, Kani hawl, Pashmina, Shawl, Sozni, Paper-Machie, Walnut Wood Carving, Khatamband, and Hand Knotted Carpets crafts from Kashmir have already been GI certified," he said.

"The testing and labelling of Pashmina has ramped up from last year and a half besides the department has also introduced the testing and labelling of Hand Knotted Carpets; a significant number of artisans, manufacturers and exporters are approaching the department for testing and labelling of the GI certified products. Moreover, the visitors have also shown much interest in purchasing exclusive GI certified crafts post these efforts of promoting Geographical Indication throughout the country and away," he added.

According to the spokesperson, the department is presently in the final stage of purchasing the Optical-based Fibre Diameter Analyser (OFDA) for accurate measurement of diameter, length, curvature (crimp), mean and distribution of different fibre types with thousands of fibre measurements per minute to speed up the testing process. World Cup 'Beer Policy' Finally Agreed By Qatari Organisers

GENEVA: Organisers of the World Cup in Qatar have finalized a policy to serve beer with alcohol to football fans at stadiums and fan zones in the Muslim-majority country.

FIFA said Saturday fans will be allowed to buy Budweiser beer with alcohol within the eight stadium compounds - though not at concourse concession stands before and after games, and during evenings only at the official "Fan Festival." That is being held in a downtown Doha park.

Game tickets promising access to Champagnes, wine, liquor and beer for hospitality clients at Qatari stadiums have been on sale since February 2021 as part of corporate packages offering "premium beverages.'

The beer policy affecting most fans was announced just 11 weeks before the first game and finally fulfills an expectation since Qatar campaigned 12 years ago to be the first World Cup host in the Middle East.

Budweiser has been the exclusive World Cup beer brand since 1986 and parent company AB InBev renewed its deal through 2022 with FIFA in a 2011 signing after Qatar was confirmed as host.

ticket holders will have access to non-alcoholic Budweiser Zero," soccer's world body said. "At the FIFA Fan Festival, Budweiser will be available to purchase from 6.30 p.m."

Qatar's organizing committee and AB InBev declined comment Saturday on the issue.

Alcohol is more available in Qatar than some Middle East states though it is served only in hotel restaurants and bars that have licenses. It is illegal to consume it elsewhere.

Still, Qatar has had to relax its regulation of alcohol for the 29day tournament starting Nov. 20. It is expected to attract more than 1 million visitors including fans from 31 other nations to the tiny Emirate.

Qatar has tested its alcohol policies at games soccer including the 2019 Club World Cup that featured Europe's thenchampion Liverpool, South American champion Flamengo and Mexican club Monterrey.

Qatar is not the first World Cup host to ease its stance on alcohol. Before the 2014 World Cup in Brazil, pressure from FIFA led local lawmakers to pass a special bill exempting the tournament from a ban on selling alcohol at stadiums.

Qatar beat four rival bids, including the United States, to win a World Cup hosting contest where candidates were expected to respect FIFA's deals with

Bhutia Shocked By Political Interference In AIFF Polls

NEW DELHI: Former India captain Bhaichung Bhutia on Saturday said he was shocked at the "high level" of political interference in the All India Football Federation (AIFF) elections, which didn't pan out as he would have liked.

Bhutia lost to BJP leader and former goalkeeper Kalyan Chaubey in the election for the president's post.

The 45-year-old Bhutia himself has dabbled in politics, having unsuccessfully contested Lok Sabha and state assembly elections on TMC ticket in 2014 and 2016 respectively and founded the Hamro Sikkim Party. But he said, the AIFF elections should have been fought without any "political interference", and purely on football matters.

"I was shocked because I personally did not expect that the political interference (in AIFF elections) would be of such a high level. I thought it's a football president election and I wanted to contribute with sincerity," Bhutia told PTI.

"If they (his opponents) were so confident of victory, why a powerful union minister had to come at the hotel (where the voters were staying) at 9pm (on Thursday) and stay there till 2am in the morning of election day (on Friday) and take all of them to a particular floor of the hotel," he said.

"Out of the 34 members of the electoral college, 33 (except Gopalakrishna Kosaraju) were taken to a floor of the hotel and access was denied to the whole floor. I could not contact any of the voters, the network was down.

"I tried calling the secretary of Rajasthan association, who is a voter and whose president (Manvendra Singh) was my seconder, but I could not reach him on phone.

The political interference was a shocking thing to me and it was very unfortunate and a sad thing for Indian football.'
