Extension Of Central Laws Established Equitable System Of Justice In J&K: Govt

Srinagar: With the extension of 890 central laws, repeal of 205 state laws and modification of 129 laws after the abrogation of Article 370 in Jammu and Kashmir, a system of equitable justice has been established across the Union Territory for all sections of people, an official spokesperson said Tuesday.

He said that the implementation of several path-breaking central legislations after the revocation of Article 370, like the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forests Rights)

Act, 2007, the Scheduled Caste and the Scheduled Tribes (Prevention of Atrocities) Act, 1954, among others, is bringing a new era of progress and development in Jammu and Kashmir.

Under the guidance of the Prime Minister, Jammu and Kashmir is witnessing a new dawn, the spokesperson said. He said that Tribals are getting land rights, thousands of government jobs have been provided within record time with complete transparency and major steps have been taken to ensure the empowerment of women, marginalised as well as weaker groups.

"In a major relief to socially



and educationally backward classes, the Jammu and Kashmir administration has enhanced their income ceiling from Rs 4.50 lakh to Rs 8 lakh allowing them to avail benefits of reservation according to provisions of the Jammu and Kashmir Reservation Act, 2004," he said.

3,072 Crime **Cases In 1 Year Reported in J&K**

Srinagar: Jammu and Kashmir has reported 3,072 violent crimes including 136 murder and 513 attempt to murder cases in 2021, NCRB data has revealed.

The report, according to news agency KNO, states that 3100 violent crime cases were reported in 2019, 2821 in 2020 and 3072 in 2021.

As per data the violent crime rate in J&K is 22.9 and charge sheeting rate is 67.2 percent.

The violent crime cases in I&K include 136 case of murder (U/S 302 IPC), 27 cases of culpable homicide not amounting to murder (U/S 304 IPC), four cases of infanticide, three cases of foeticide, 16 dowry deaths, 513 attempt to commit murder cases and 42 cases of grievous hurt incidents.

It said that the cases also include 1013 cases of murder, 315 cases of rape, 14 cases of attempt to rape, 751 cases of rioting, 104 cases of robbery, three cases of Dacoity and 131 cases of Arson.

The report added that 119 cases of murder were registered in J&K in year 2019, followed by 149 in 2020 and 136 in year 2021 and charge sheeting rate of murder cases in year 2021 is 79 percent.

As per data the motives behind murder includes personal vendetta or enmity in 13 cases, child/human sacrifice in one case, communal one case, political reasons in two cases, one honour killing, 10 cases of love affairs, three cases of illicit relationship, 30 cases of extremism/ insurgency, 15 cases of land/ property disputes, 18 cases of family dispute 4 cases of petty quarrel and 25 cases of blind murder where motive was unknown.


'Discrimination Was A Norm And Social Welfare Was An Exception'

Instagram Faces Penalty Of 405 Million Euros For **Privacy Breach**

rish regulators are slapping Instagram with a big fine after an investigation found the social media platform mishandled teenagers' personal data.

Ireland's Data Protection Commission said by email Monday that it made a final decision last week to fine the company 405 million euros (\$402 million), though the full details won't be released until next week.

The penalty is the second-biggest issued under the European Union's stringent privacy rules, after Luxembourg's regulators fined Amazon 746 million euros last year.

Instagram parent Meta, which also owns Facebook and can appeal the decision, didn't respond to a request for comment.


The Irish watchdog's investigation centred on how Instagram exposed the



personal details of users aged 13 to 17, including email addresses and phone numbers. The minimum age for Instagram users is 13.

Under the EU's data privacy rules, the Irish watchdog is the lead regulator for many US tech companies with European headquarters in Dublin.

The watchdog has a raft of other inquiries into Meta-owned companies. Last year, it fined WhatsApp 225 million euros for breaching rules on transparency about sharing people's data with other Meta companies.



Pollution Exposure In Infancy Alters Gut Microbes, May Increase Disease Risk: study

Exposure to air pollution in the first six months of life impacts a child's gut bacteria in ways that could increase risk of allergies, obesity and diabetes, and even influence brain development, a study has warned.

The research, published recently in the journal Gut Microbes, is the first to show a link between inhaled pollutants -- such as those from traffic, wildfires and industry -- and changes in infant microbial health during this critical window of development. Previous research by the same group found similar results in young adults. "This study adds to the growing body of literature showing that air pollution exposure, even during infancy, may alter the gut microbiome, with important implications for growth and development," said senior study author Tanya Alderete, an assistant professor at the University of Colorado Boulder, US.

At birth, an infant hosts little resident bacteria. Over the first two to three years of life, exposure to mother's milk, solid food, antibiotics and other environmental influences shape which microorganisms take hold.

Those microbes, and the metabolites, with a more inflammatory gut-mior byproducts, they produce when they break down food or chemicals in the gut, influence a host of bodily systems that shape appetite, insulin sensitivity, immunity, mood and cognition.

While many are beneficial, some microbiome compositions have been associated with Chrohn's disease, asthma, type 2 diabetes, and other chronic illnesses.

"The microbiome plays a role in nearly every physiological process in the body, and the environment that develops in those first few years of life sticks with you, said first author Maximilian Bailey, a medical student at Stanford University, US.

The researchers obtained fecal samples from 103 healthy, primarily breast-fed Latino infants enrolled in the Southern California Mother's Milk Study and used genetic sequencing to analyse them.

They estimated exposure to PM2.5 and PM10 -- fine inhalable particles from things like factories, wildfires and construction sites -- and Nitrogen Dioxide (NO2), a gas largely emitted from cars.

"Overall, we saw that ambient air pollution exposure was associated crobial profile, which may contribute to a whole host of future adverse health outcomes," said Alderete.

For instance, infants with the highest exposure to PM2.5 had 60 per cent less Phascolarctobacterium, a beneficial bacterium known to decrease inflammation, support gastrointestinal health and aid in neurodevelopment, the researchers said.

Those with the highest exposure to PM10 had 85 per cent more of the microorganism Dialister, which is associated with inflammation, they

In a previous study, Alderete found that pregnant Latino women exposed to higher levels of air pollution during pregnancy had babies who grew unusually fast in the first month after birth, putting them at risk for obesity and related diseases later in life.

The researchers noted that infants are particularly vulnerable to the health hazards of air pollution because they breathe faster and their gut microbiome is just taking shape. "This makes early life a critical window where exposure to air pollution may have disproportionately deleterious health effects," they added.

Harmful Substances Have Increased Significantly In Dal Lake: Study

Srinagar: In a major concern, the concentration of harmful substances like nitrate, phosphates, and chlorides have increased significantly in Dal Lake in the last 25 years

This has been stated in a recent study titled "The changing water quality of lakes—a case study of Dal Lake, Kashmir Valley," which was published by environmental monitoring and assessment journal in 2022.

The study has found that the concentration of harmful substances like phosphates, chlorides, and nitrates has tremendously increased over the last 25 years.

"Concentration of total phosphorus has increased from 0.1 to 0.4 mg/l in 1997 to about 6 mg/l in 2017. Similarly, chlorides have shown a steep increase from 2-2.7 mg/l 329 in 2007 to 10.3 mg/l in 2017. Other elements like calcium and magnesium, have also witnessed an increasing trend in the lake," it says.

The study has found that dissolved oxygen (DO) levels, on the other hand have shown signi cant de-"Annual DO values of the lake have decreased from 7.4 mg/l in 1997 to 6.9 mg/l in 2017," it says.

DO is the amount of oxygen present in water. It is essential for the survival of fish and other aquatic organisms.

It has witnessed extreme loss in water quality during the last four decades because of human

Javeed Ahmad, an environment researcher said there are various factors which have a ected the lake water quality.

"There is an urgent need to address the problems associated with lake restoration, management, and conservation by both authorities and the local population," he said. (KINS)

Valley Wide Alert As Experts Trace Adulterated Oil

rinagar- Officials of Food and Supplies Department and Srinagar Municipality in joint raids today seized tins of adulterated edible oil, capable of causing dreaded dropsy. Alert has been sounded and people warned not to use The joint teams today and yesterday fanned out in different

directions of capital Srinagar and raided various godowns and retail outlets of edible oil, leading to the seizure of 7800 tins of P. Mark and over 100 cannisters of Hira Brand mustard oil.

Sampling, followed by analysis on war footing of the seized' edible oil tins was done by assistant public analyst from State's Drug and Food Control organisation. The assistant public analyst, Mushtaq Ahmed Khateeb confirmed adulteration in Hira brand, packed under seal number 200-201/PFAK, Dated 4-9-1998.

P. Mark Bahadurgarh Haryana Brand was also found adulterated, as per the officials, who warned the general public this evening not to use the two contaminated brands. The analysis of other brands seized by the teams is underway and reports are expected by Sunday.

Out of 225 samples analysed in the laboratory till now, reports of only 140 were received by this evening. While 139 samples tested negative, one tested positive. That was the sample taken from Hira brand, manufactured and marketed by M/S Grower Oil Mills, Private Limited, Bari Brahamana, Jammu.

The raids were conducted by the teams at Court Road. Sarai Bala, Tankipora, Hazuribagh and other parts of the city. More teams will conduct raids tomor-row to trace out adulter


Eight tins of adulterated Hint brand were seized from a dealer at Court Road. Reports revealed that the said dealer has sold off hundreds of tins of

Hira brand to retailers all across Kashmir. Messages have been flashed to different districts to trace out the adulterated Two edible oil factories -situated at Zainakote, have also



Fresh truce violation

ollowing 18 months of calm, Pakistan Rangers broke the ceasefire along the Line of Control on Tuesday by firing at a BSF patrol in the Arnia sector of Jammu. A BSF spokesman said that its personnel gave a "befitting reply to the unprovoked firing from the Pakistani side. There was no loss of life or injury to BSF troops. The Indian and Pakistan Armies had on February 25, 2021 announced the ceasefire along the International Border and Line of Control which had since held. The move had come reportedly following an extended back-channel dialogue between the two countries.

The fresh truce violation is therefore a cause of grave concern. For the last one and a half years of the ceasefire, there was already ample evidence of life returning to normal among border dwellers on this side of the LoC. Similarly, there were similar reports from across the LoC. One example that stood out is Battal valley which over the years has been most impacted by the firing. The villagers on both sides also have since resumed economic and social activities.

With Tuesday's ceasefire violation, there are apprehensions among the people that things might go back to square one. More so among the people living alongside the LoC. There is already an example of what happened to the original ceasefire agreement between the two nations which was signed in November 2003. By 2010, the agreement had lost its relevance due to frequent ceasefire violations that touched an all-time high in 2020 with over 5,000 incidents of firing and shelling being recorded

It is true that the situation has improved remarkably over the last three years. Protests and stone-throwing have almost disappeared. But it hasn't changed much on the ground as militancy continues to pose a serious challenge. It was expected that the issue of militancy could be addressed if India and Pakistan went back to dialogue. The calm borders between 2003 to 2007 had become an important factor in the normalization of relations between the two neighbours, enabling them to start one of the most promising dialogue process which by the accounts of the top leaders of the two countries who helmed it was close to a breakthrough on Kashmir.

The singular failure of the two countries since the reinstatement of the ceasefire in February 2021 is that they couldn't restore the dialogue. The alleged back-channel process also seems to have ended. The vacuum, in turn, has further deepened the estrangement and created conditions for fresh bitterness and the consequent violence. It is time that the two neighbours reach out to each other and work towards a sustainable engagement. That will go a long way to usher in peace in the region. But as things stand, one can only hope against hope.

Rear guard action

erely days after the release of the National Crimes Records Bureau report that stated that those killed in road accidents — 1,55,622 in 2021- had reached the highest level since 2014, industrialist and the former chairman of Tata Sons, Cyrus Mistry, and a fellow passenger lost their lives on Sunday when the car they were travelling in met with an accident near Palghar, Maharashtra. Police sources were quoted as saying that the passengers were not wearing their seat belts. The tragic and avoidable accident should heighten awareness of the need for car safety deployments and their enforcement by road safety authorities. It is well understood today that the use of low-cost restraint systems such as seat belts and airbag equipment have helped reduce car passenger-related fatalities effectively. Studies, quoted in a road safety report prepared by the Transportation Research and Injury Prevention Centre, IIT Delhi, in November 2021, estimated that "air-bag deployment reduced mortality by 63%... lap-shoulder-belt use reduced mortality by 72%, and combined airbag and seatbelt use reduced mortality by more than 80%" While awareness about and enforcement of seat belt use have relatively increased over time despite stark numbers on non-compliance related deaths (the Road Transport Ministry estimated that 26,896 people had died due to non-use of seat belts in accidents in 2017), the enforcement for belt wearing for rear seat occupants has been almost non-existent. This is a shame as a study by the Insurance Institute for Highway Safety, U.S., shows that rear seat occupants were eight times more likely to suffer serious injuries in a mishap if they did not buckle up than if they did. Other aspects such as the proper use of headrests also help in reducing injuries due to whiplash during accidents.

Paving the Way Towards Affordable Healthcare in Kashmir

overnment is investing in healthcare and medical education so that the citizens and youth of the Union Territory have the best service and career options they deserve for a better tomorrow", reads a recent news report. This tiding comes at a time when, according to a report, "Public Health care institutions in Kashmir deliver care to almost 97% of population even though they are severely understaffed. The doctorpatient ratio is one of the lowest in India. The World Health Organization recommends one doctor for every thousand patients; Kashmir has a doctor-patient ratio of 1:2000". It is true that the valley fares well in disseminating health services and catering to the medical needs of people in comparison to most of the other states but the comparisons must not fool us into believing that all is well. There are sharp deviations from the national average in terms of trained workforce available, accessibility to latest diagnostic techniques and equipments and overwhelming saturation of hospitals. From the jarring inaccessibility of people to quality healthcare to the total absence of healthcare units in far flung areas, the problems posit a spectral diversity, a mammoth size puzzle and a conundrum of infinite dimensions. From the healthcare pangs of nomadic Gujjar and Bakarwal communities to the near absence of dedicated mental health institutions in rural and peripheral areas, everything presents a challenge of odd nature, multiplexing the inequities and violating the right to health of the majoritarian population. Of graver concern, in addition to the issues aforesaid, is the healthcare spectre along the national highway. We are well aware of the vulnerabilities that our highway poses in view of its tough terrain, ending in frequent accidents and vehicle skids, but these vulnerabilities and ensuing loss of life has done little to alarm the administration to establish well equipped emergency response units along highway. The absence of same often leads to the loss of lives for the want of treatment which could have been otherwise rescued with little

Easy access to quality healthcare and education has often been defined as the indicators of societies' level of advancement and prosperity. In a society of ours, we are flooded with reports, on a daily basis reporting mismanagement in healthcare, the unaddressed grievances of patients and inequities in access to healthcare stemming from socioeconomic inequalities. The standard medical practice suggests that a doctor ought to check up twenty patients a day and offer at least twenty minutes to each patient. But to our great dismay. doctors in UT are under a humongous burden of checking up to hundred and fifty patients a day, in addition to attending other official responsibilities. And when I speak of giving twenty minutes

to each patient I don't think any of us can recall an experience either at a government hospital or under a private setting having been evaluated so thoroughly. To my poor experience, the average time spent by a doctor with the patient even in private settings doesn't exceed five minutes. This is something that may not require statistical citation, because we are all a living testimony to this standard practice of under treatment. Maybe there are exceptions to this rule, but I have yet to come across any. The phenomenon aggravates in cases of psychological disorders where the moot point of treatment is listening to the patient and listening thoroughly, but more than often, doctors are seen pressing the prescription button even before the patient has finished his narration. The burden of mistake is not to be placed on doctors, as previously mentioned that our healthcare stands in a supersaturated state and doctors are to be applauded for their heroic services - doing away with isolated misgivings.

Government hospitals are a refuge and shelter to hundreds and thousands of people who can't afford private treatment, which as a matter of pragmatism fares marginally better than government hospitals. Having underscored the disequilibrium in doctor patient ratio, it becomes incumbent upon the government, as a part of its commitment to be a welfare state to expand the bandwidth of healthcare infrastructure in terms of multiplying hospitals, recruiting healthcare workers and aiming to provide essential medicines at affordable rates. Two developments in this direction under the present regime deserve a special mention. Golden card, to cover the poor, vulnerable and the economically weaker sections of the society and Prandhan Mantri Jan Aushadi outlets, providing medicines

at cheaper rates. But both these schemes suffer on ground and implementation. There have been cases where patients with Golden Cards were denied the promised benefits and the entire trajectory of PMJAY stands halted for numerous reasons, doing a great disfavour to those who could have otherwise benefited from it. Both the schemes per se are conducive and well conceived in Indian context and the only thing needed is government and bureaucratic push to make things happen and happen effectively.

A passing reference was made to private healthcare setups and those who are economically well placed prefer these centres both for their supposed efficiency and the social ascent. But there seems to be no or little administrative control on the charges levied by these institutions against the treatments offered and the whims and wishes of those running these units remains the sole factor in deciding the cost of treatment and the protocols followed or broken. By extension, there seems little regulation on the fee that a private health consultant can charge a fact which is vetted by varying fees charged by various doctors, spread across the scale. The writer had to many a times drop the idea of visiting a doctor for the exorbitant consultation fee that one had to pay and the scene is repetitive from cardiologists to neurologists and others in-between. These are not the things that are beyond the administrative control, but the question we keep asking each other is - who will bell the cat?

Addressing Obesity

T is well known that a large population of the country is battling obesity, the root of all diseases, due to which diseases like diabetes, thyroid, and high blood pressure have increased not only among adults, but also in adolescents and children. The good thing is that like the epidemic, now the government has also become alert about the increasing obesity. NITI Aayog, the country's policy-making body, has recommended to identify the major factors of its growth such as sugar, salt and fat-rich foods and increase the excise duty on these foods to make citizens free from obesity. In this episode, it has been said to take steps like 'front of the pack labeling' on products, so that people can be warned about the danger of obesity. The purpose is that people should be careful while choosing food items and they should know what is dangerous for their health. The report of the Research Institute of NITI Aayog for the year 2021-2022 warns that the problem of overweight and obesity among children, adolescents and women is increasing continuously in the country. NITI Aayog is taking steps in this direction in collaboration with the country's Institute of Economic Development and the Public Health Organization of India. In fact, Indian food has traditionally been a trend of namkeen, chips, bhujia, etc., but in recent years, in the name of snacks, there has been an increase in the popularity of such foods which are injurious to health. It should be a matter of our concern that according to the National Family Health Survey, the number of women suffering from obesity in the country has gone up to 24 percent, while the figure for men is 22.9%. In such a situation, the need of the hour should be said that the government should take steps in this direction. Undoubtedly, obesity is the root of all diseases and the Indian medical system feels the pressure due to the diseases caused by it.

Actually, due to change in urban lifestyle and eating habits, the problem of obesity has become worrying. Talks continued about this problem, but no serious initiative was seen in this direction. he word sensitivity is thrown around a lot in relation to a number of different things. It can refer both to the senses – that is, our ability to perceive the world around us – or to our tendency to be affected by the slightest action or attack from the outside world.

More than "sensitive", some are labelled "hypersensitive". People who fit this description are particularly emotive and readily shed a tear when watching romantic films or listening to sad songs, for instance.

The term hypersensitivity has become gradually more popular in recent years and is often applied, partly erroneously, to hyperaesthesia (a condition similar to sensory overload) or abnormally frequent intense emotions. With a view to avoiding these negative connotations of excess, we have opted to use the term heightened sensitivity in this article.

Sensitivity can occur either internally, in a physiological reaction or an emotion, or externally, in a movement of withdrawal, for example. In both cases, it is linked to internal (e.g., thoughts) or external (e.g., surroundings) triggers known as stimuli.

Taking on a variety of natures, stimuli can be social (e.g., a phone call from a friend, a colleague speaking to us or a stranger stopping us in the street), emotional (e.g., a memory of a loved one or a cuddle from a pet), physiological (e.g., a rumbling stomach or a racing heartbeat) or sensory (e.g., auditory, olfactory or visual)

Regardless of their form, we are continually exposed to them in our everyday lives. Relying on the resources in their environment to survive, humans are required to perceive, assimilate, and process all these stimuli to keep adapting.

However, not all of us react in the same way to each given stimulus...

WHY DO WE HAVE DIFFERENT LEVELS OF SENSITIVITY?

Most people react in roughly the same way when presented with the same stimulus, while those who exhibit a stronger reaction are said to be more sensitive. This difference is explored in a number of theories, which were consolidated in 2016 under the umbrella term of environmental sensitivity.

This definition takes in the concept of sensory processing sensitivity (SPS, as measured by the highly sensitive self-test), which corresponds most closely in theory to what we refer to as "hypersensitivity" or "high sensitivity" in everyday language. Coined in 1997 by Elaine and Arthur Aron, it presents sensitivity as a personality trait bearing the following



characteristics:

- greater depth of information
- heightened emotional reactiv-
- ity and empathy increased awareness of subtle
- changes in one's environment
 greater propensity for overstimulation

The concept of environmental sensitivity can also be seen as a metatrait, i.e., a higher-order personality trait that encompasses and justifies, to a certain extent, existing psychological concepts such as introversion, shyness, behavioural inhibition, or a reactive temperament.

This presents important implications for therapy, clinical diagnosis of mental pathologies, and research into the origins of certain mental disorders.

THE NEGATIVE EFFECTS OFTEN ASSOCIATED WITH HEIGHTENED SENSITIVITY

Historically, research on environmental sensitivity has focused mainly on determining individual vulnerabilities, which stem from many different factors (be them genetic, psychological, or physiological), and result in higher sensitivity to various stimuli.

In other words, our own inherent characteristics influence the way we are affected by our surroundings. For example, if an individual has a certain version of a gene associated with a lower production of the serotonin transporter molecule (a.k.a. the "feel-good hormone"), they are

more likely to exhibit symptoms of depression during stressful events.
As such, a genetic factor can produce

adverse effects when combined with

negative stimuli.

Nevertheless, these studies do present a certain bias. Given that a large proportion of the research links vulnerabilities to heightened sensitivity, the vast majority of studies associate negative environments (e.g., childhood abuse, insensitive parents or negative life events) with heightened sensitivity and its detrimental effects (e.g., predisposition to mental health problems or a poor quality of life).

quality of life).

As a result, heightened sensitivity is often associated with a form of vulnerability that offers very little benefit to daily life and encourages the emergence of complications in negative contexts, including social phobia, avoidant personal-

ity disorder, anxiety and depression, self-perceived stress, agoraphobia, alexithymia and autism spectrum disorder, and poor emotional regulation.

But are those with heightened sensitivity really predisposed to developing these adverse effects?

AN ADAPTIVE ADVANTAGE

A study on the heritability of sensitivity revealed that 47% of individual variations in sensitivity are genetically determined, while the remaining 53% are due to environmental influences. This means that sensitivity is a heritable trait. If heritable, it must therefore present some adaptive advantage (or at least, not be debilitating), however minor, to have been kept by natural selection down through the ages

This trait may even have been long

preserved through evolution, since it is also present in other mammals (as shown, for instance, by the reliable measurement of sensitivity in dogs published in 2017).

Moreover, numerical simulations and empirical research suggest that heightened sensitivity could be advantageous if present in 15 to 20% of the population as a negatively frequency-dependent trait. This means that individuals within a group can rely on their variations in sensitivity to employ diverse strategies, adapt more quickly to changes in their environment, and be more attentive.

EXPLORING POTENTIAL BENEFITS

For over a decade, an increasing amount of research has examined how beneficial environments can positively affect individuals with heightened sensitivity.

A 2015 study on the link between heightened sensitivity and responsiveness to a depression-prevention programme among teenagers showed that sensitive individuals were more responsive to the offered support. More importantly, such changes were considerably more noticeable in the highly sensitive subjects.

In 2018, another study revealed a link between heightened sensitivity and responsiveness to a school-based anti-bullying programme. In this case, not only was there a significant drop in bullying, but the phenomenon could be observed almost exclusively among highly sensitive individuals.

These studies suggest, therefore, that highly sensitive individuals have a better capacity for socialisation, reflective thinking, learning, and awareness.

These results are consistent with a brain imaging study that shows how, when exposed to positive or negative emotional stimuli, highly sensitive individuals experience increased activity in the areas of the brain linked to these same capacities (i.e., the hippocampus, parietal-frontal area, prefrontal cortex, etc.).

For example, showing them positive images (if they had a positive childhood) triggers increased activity in the centres associated with calmness, relating to others (i.e., the insular cortex) and reward responses (i.e., the ventral tegmental area, locus niger, and caudate nucleus). The latter of these acts as our basic survival motivator and can be involved in generating pleasure, including through substance use.

Similarly, presenting them with negative images causes overactivity in the areas associated with self-control (i.e., the medial prefrontal cortex), and cognitive and emotional self-regulation.

MAKING THE MOST OF HYPERSENSITIVITY

Research into addiction and mood disorders has shown that the medial prefrontal cortex plays an important role in self-control, and that greater impulse control in response to positive stimuli is linked to reduced risktaking and addictive behaviours.

This research suggests that heightened sensitivity, coupled with a healthy developmental environment, could be a factor in preventing addiction. This is because highly sensitive individuals may be less likely to exhibit abusive or problematic behaviours (related to Internet use, online gaming or gambling, etc.) or to become dependent after using narcotics.

All of these studies agree on the vital importance of a healthy child-hood and environment. Given that environmental factors account for around half of all individual variations in sensitivity, it is essential to limit any negative experiences (or mitigate deleterious effects) that can be exacerbated by a sensitive personality trait.

Properly identifying individual sensitivity levels could prove helpful in gauging the success of certain therapies and intervention programmes. In fact, the importance of this particular success factor is such that therapygenetics research is currently moving toward more personalised psychotherapy.

HOW TO THRIVE THROUGH HYPERSENSITIVITY

Studies on environmental sensitivity are already starting to understand individual developmental differences under specific contexts and the related susceptibility to certain psychopathologies. This research may also be useful in early intervention for preventing abnormal developments in highly sensitive individuals, while giving them the tools to thrive in our modern society, with its many challenging stimuli.

In time, these studies will help shed light on this trait, in terms of the neural mechanisms involved, as well as its origin or associations with certain disorders.

Heightened sensitivity or hypersensitivity can therefore be a precious asset! Far from a mental disorder, it plays a vital role in the way we adapt to our environment. Its myriad evolutionary, medical and social implications are already being outlined in many ongoing studies in psychology, genetic biology and neuroscience. It is our hope that such research will allow the individuals concerned to overcome the prejudices that are all too often attributed to them.

CLIMATE CRISIS

A Balance Of Payments Perspective

he Earth's average temperature has warmed by about one degree (10) Celsius above preindustrial levels, according to the most recent data by NASA. This change, although seemingly insignificant, has translated into a rapid global torrent of climate abnormality, followed by increasingly frequent and catastrophic natural disasters. On a macroeconomic level, climate change risks can be characterised as: (i) 'physical risks', arising from the economic losses and fatalities of unanticipated and extreme weather events, and (ii) 'transition risks', induced by uncertainty and policies during the transformation to a carbon-neutral economy. How would these two risks impact economic growth and trade, particularly in the many developing and climate-vulnerable nations in South Asia? This article intends to examine this question, along with its policy implications, with a focus on the BoP.

PHYSICAL RISKS: Rising temperatures, amid intensifying cyclones, flooding, and saltwater intrusion among others, threaten agricultural output in terms of both land and labour productivity. This paints out a vivid picture of Bangladesh, a lowlying country with an economically-significant agricultural sector - ranked in the Germanwatch's Global (Long-Term) Climate Risk Index 2021 as the seventh most vulnerable country to physical risks. An International Monetary Fund Country Report on 'Climate Change Mitigation and Adaptation in Bangladesh: Policy Options' (dated September 2019) outlines that in 2017, extreme flooding alone had impacted over 8 million people and led to severe crop destruction in Bangladesh. This, subsequently, prompted a drastic increase in food imports which largely contributed to the deterioration of its current account deficit in the fiscal year, FY2016-2017: from US\$1331 million to US\$9780 million; turning the overall BoP from a surplus of US\$3169 million to a deficit of US\$885 million (for the first time since FY2001).

Moreover, weather catastrophes would take a toll on the tourism industry as well. The destruction of natural heritages and tourism infrastructures lowers tourism demand and risks triggering insurance premium hikes - thus hampering the survival of small and medium-sized businesses in the industry. Accordingly, the prospective BoP complications driven by climate change can be illustrated by the COVID-19 pandemic shock that has affected many developing, tourism-dependent economies severely. Taking Vietnam as an example, the International Monetary Fund Country Report on the '2020 Article IV Consultation' with Vietnam highlights that a fall in the country's tourism receipts (and remittances) has led to a diminishing current account surplus throughout the FY2020 - starkly contrasting the increase from 1.9 to 3.8 per cent of GDP in the previous FY.

Altogether, collapsing agriculture and tourism exports may coincide with reduced local infrastructure investment (leading to lower future output) and weaker foreign exchange inflows - in turn, sowing potentially persistent BoP deficits through the current (trade) account. As argued in a Swiss Re Institute publication titled 'The economics of climate change: no action not an option': developing nations, owing to a high economic dependence on these sectors along with weak mitigation capacity, are often the ones to bear the brunt of such physical risks. This, by implication, dampens growth prospects while rein-

forcing vicious poverty cycles. TRANSITION RISKS: In much of current literature, the term 'transition risks', usually viewed at the firm level, depicts the situation in which fossil fuels are treated as 'stranded assets' in capital markets during the global shift toward cleaner, renewable energy sources - fuelled by concerns about structural and policy changes aimed at mitigating climate change. This would consequently erode the value of businesses and industries that produce or operate on such fossil fuel-based commodities. Thus, shedding light on the potentially dire macroeconomic problems that transition risks may introduce on an economy-wide level.

The latest statistics by the World Bank depict the proliferation of carbon pricing instruments as policymakers worldwide recognise the need to disincentivise (internalise the cost of) greenhouse gas emissions - namely, in 46 countries as of September 2022. This comprises of carbon taxes and cap-and-trade systems, which each directly translates into higher production costs and restricted supplies of fossil fuels, respectively. Simultaneously, they would dampen firm and export competitiveness in carbon-intensive industries, with repercussions on the rest of the economy (i.e., through higher input costs and utility bills). In addition, a group of researchers at the Boston University, in the policy brief titled 'Climate Change and IMF Surveillance: The Need for Ambition', coin the concept of 'spillover transition risks' to illustrate how transition risks can be further amplified by cross-border trade policies. A prime example is the European Union's proposal for a 'Carbon Border Adjustment Mechanism (CBAM)' that intends to adjust import prices based on their carbon footprints by as early as 2023. This has however been highly contentious, invoking strong accusations of protectionism and the likely trade diversion away from the developing to the developed world - where such carbon pricing mechanisms are already well-established domestically. Another probable implication is that as the

Another probable implication is that as the global economy embarks on phasing out fossil fuel consumption, coupled with uncertainty and low market sentiments

uncertainty and low market sentiments towards the industry, transition risks would weigh negatively against commodity currencies. Commodity currencies refer to currencies that tend to be closely linked with the world prices of primary commodities, including fossil fuel commodities

global economy embarks on phasing out fossil fuel consumption, coupled with uncertainty and low market sentiments towards the industry, transition risks would weigh negatively against commodity currencies. Commodity currencies refer to currencies that tend to be closely linked with the world prices of primary commodities, including fossil fuel commodities - owing to the importance of natural resources for aggregate income creation, such as in Malaysia (Malaysian Ringgit). This can be explained using the classic 'Dutch Disease model', devised by Max Corden and Peter Neary in 1982, which outlines that under an expected permanent fall in commodity prices and production, a reduction in natural resource income results in lower overall domestic demand. This lower demand is partly absorbed by lower demand in the internationally non-tradable sectors (services), giving rise to a shift of labor and capital to the internationally tradable sectors (agriculture and manufacturing) as facilitated by an exchange rate depreciation. In line with this, a more recent research paper by the BI Norwegian Business School titled 'Climate Risk and Commodity Currencies' presents empirical findings consistent with the argument that 'when transition risk is high, commodity currencies are likely to experience an episode of persistent depreciation along with a weakened

relationship with commodity prices'. From the perspective of a developing, fossil fuel-exporting country, a weaker currency may indicate cheaper but obsolete fossil fuel exports, while imports (typically associated with the high knowledge and technology content/spillovers vital for economic development) become more expensive. Hence, with a shrink in export value and rising import costs, such depreciation is unlikely to translate into an improvement but instead, a worsening of the current account and the BoP as a whole.

Given the 2015 Paris Agreement to pursue the target of limiting global warming to 1.5 degrees Celsius (and no more than 2 degrees Celsius) from pre-industrial levels, it has been estimated that approximately 80 per cent of fossil fuel reserves are needed to remain unextracted to put a brake on climate change – as reported in a Financial Times article titled 'Lex in depth: the \$900bn cost of 'stranded energy assets'. Thus, a move in this direction – giving rise to a shrinking global market for oil, coal, and natural gas – is likely to create a long-term strain on the BoP of 'fossil-fuelled' economies, particularly in less-developed nations generally associated with the 'resource curse' (low export diversification).

CLIMATE INACTION IS NOT A SOLUTION: The looming climate crisis highlights the urgency to devise prudent and well-targeted policies to cushion the economy against such damaging and possibly irrevocable consequences. On the one hand, the adaptation approach, including the development of more climate-resilient agricultural strategies (i.e., crop and livestock diversification) and infrastructure, is vital to sustain vulnerable industries and foster food security. In terms of mitigation measures, carbon-taxing systems should be commensurable with the provision of public finance and subsidies (or development aid) for the adoption of cleaner production methods and technologies. Namely, climate policies should incentivise environmentally friendly companies to enhance their profitability and competitiveness (such as through the selling of carbon quotas that could, in turn, be invested in greater productive capacity). In both cases, developed countries play a pivotal role in assisting those less developed to adapt and mitigate promptly against climate change-induced risks. Consequently, these climate policies would help to ensure BoP stability - by driving export growth, as well as overall development and innovation, in the 'right', sustainable direction.

Exams, Results Major Cause Of Anxiety Among School Students: NCERT survey

New Delhi: While studies, examination and results are major causes of anxiety among school students, over 33 percent comply with peer pressure most of the times, a survey on mental health and well-being of students by NCERT said.

The survey reported that at least 73 percent students are satisfied with their school life, while over 45 percent students are not satisfied with their body image.

The National Council of Educational Research and Training (NCERT) surveyed over 3.79 lakh students from 36 states and UTs.

The Manodarpan Cell of the NCERT undertook the task of conducting the survey to help understand the perceptions of school students on aspects related to their mental health and well-being. It collected information from students across gender and grades --middle state (6-8) and secondary stage (9 to 12) between

January to March 2022.

Anonymity of participants was ensured by making the name column optional, allowing students the comfort, privacy and independence to

respond, the NCERT said

"Decline in satisfaction with personal and school life is seen as students shift from middle to secondary stage. The secondary stage is marked by challenges of identity crisis, increased sensitivity towards relationships, peer pressure, fear of board examination, anxiety and uncertainty experienced by students for their future admissions, career etc," the survey report released on Tuesday said.

The survey found that 81 percent respondents attribute studies, exams and results as major causes of anxiety.

As many as 43 percent of the total respondents admitted being able to quickly adapt to changes and response of students at middle stage (46 percent) was higher than students at secondary stage (41 percent).

A total of 51 percent students face difficulty in learning online while 28 percent of the respondent students are hesitant in asking questions, as per the survey.

It found that "yoga and meditation, attempts to shift the way they think and writing journals were reported as frequently adopted strategies by students for coping with stress".

BILKIS BANO CASE

SC To Hear Pleas Of CPI (M), TMC Leaders Against Release Of 11 Convicts On Sep 9

New Delhi: The Supreme Court is scheduled to hear on Friday the two pleas challenging the release of 11 convicts in the 2002 case of Bilkis Bano's gang-rape and murder of her seven family members during the Gujarat riots.

According to the list of businesses uploaded on the apex court website, a bench of justices Ajay Rastogi and B V Nagarathna will hear the pleas filed by CPI(M) leader Subhashini Ali, journalist Revathy Laul and activist Roop Rekha Rani on September 9.

TMC MP Mahua Moitra has also filed a separate plea challenging the grant of remission to the convicts by the Gujarat government.

Earlier on August 25, a bench headed by then Chief Justice N V Ramana (since retired) had issued notices to the Centre and the Gujarat government on the pleas a day before demitting office.

The top court had also asked the petitioners to implead all 11, who have been granted remission, as parties.

Bilkis Bano was 21 years old and five-month pregnant when she was gang-raped while fleeing the riots that broke out after the Godhra train burning incident. Her three-year-old daughter was among the seven family members killed.

The 11 men convicted in the case walked out free from the Godhra sub-jail on August 15 after the Gujarat government allowed their release under its remission policy. They had completed more than 15 years in jail.

Deliberating on the issue that has led to a divisive debate on relief in such heinous cases, the court had said the question



is whether there was application of mind while considering remission and whether it was within the parameters of law.

"Day in day out, those who are convicted and complete their sentence, they are eligible for remission. What is the exception?" the bench had observed. Is that sufficient to say they are not entitled for remission, it had asked.

On August 23, the apex court had agreed to consider listing the plea challenging the grant of remission by the state to the life convicts.

The plea referred to the sequence of events of the case recorded in judicial files and said, "It is submitted that on such facts, no right thinking authority applying any test under any extant policy would consider it fit to grant remission to persons who are found to have been involved in the commission of such gruesome acts."

"It is further submitted that it would appear that the constitution of members of the competent authority of the respondent No.1 (state of Gujarat) also bore allegiance to a political party, and also was sitting MLAs. As

such, it would appear that the competent authority was not an authority that was entirely independent, and one that could independently apply its mind to the facts at hand," it said and quoted media reports to buttress its contention.

The apex court had earlier asked the Gujarat government to consider the plea of remission.

TMC MP Mahua Moitra has also filed a separate petition in the Supreme Court against the release of the convicts in the case. She alleged the remission "completely fails to bolster either social or human justice and does not constitute a valid exercise of the guided discretionary power of the State".

The investigation in the case was handed over to the CBI and the trial was transferred to a Maharashtra court by the Supreme Court.

A special CBI court in Mumbai had on January 21, 2008, sentenced the 11 to life imprisonment on charges of gang-rape and murder of seven members of Bilkis Bano's family. Their conviction was later upheld by the Bombay High Court and the Supreme Court.

Newly-Appointed PM Liz Truss Promises To Transform Britain Into 'Aspiration Nation'

London: Newly-appointed Prime Minister Liz Truss Tuesday pledged to "ride out the storm" of the cost-of-living crisis and transform Britain into an "aspiration nation", saying she has a "bold plan" to grow the battered economy through tax cuts and reform.

In her first speech as Prime Minister outside 10 Downing Street in London, she also said that she is honoured to take on the responsibility at a vital time for the country.

As the fourth Conservative Party leader in six years and the UK's third female Prime Minister, Truss focussed her inaugural televised address to the nation to promise to be hands-on with the energy crisis caused by Putin's war and get Britain working again.

She opened her address with praise for predecessor Boris Johnson, whom she described as a "hugely consequential" Prime Minister for getting Brexit done, the COVID vaccine rollout and support for Ukraine in its conflict with Russia.

"As strong as the storm may be, I know the British people are stronger; together we can ride out the storm, said Truss.

"I know we have what it takes to get Britain working again We will transform Britain into an aspiration nation with high-paying jobs, safe streets and where everyone everywhere has the opportunities they deserve. I will take action this day and action every day to make it happen," she said.

Speaking outside the famous black door of No. 10 Downing Street, her new office, the 47-year-old former foreign secretary was surrounded by scores of Tory MPs, aides and global media.

Heavy downpours abated just minutes before her cavalcade made its way from the

RAF Northolt Royal Air Force base where her flight landed after her audience with Queen Elizabeth II in Scotland. The showers are being viewed by many political commentators as symbolic of the headwinds Truss referenced in her speech.

"The British public has shown grit, courage and determination time and time again and we now face the global headwinds caused by the war in Ukraine and COVID, she said, spelling out three key priorities for her government: a bold plan to grow the economy through tax cuts and reform; dealing with the energy crisis with action this week; and making sure that people can get doctor's appointments and the National Health Service (NHS) support required.

The focus on the economy, energy and NHS, she said, would ensure the country's long-term success.

"United with our allies, we will stand up for freedom and democracy around the world, recognising that we can't have security at home without having security abroad," she added.

Truss assumed the office at a time when the country is facing a looming energy crisis and the focus is on her plan to address the challenge.

The current Chief Secretary to the Treasury Simon Clarke - who is tipped to become levelling up secretary - says Truss's plan to tackle soaring prices will provide certainly to families and businesses as the weather gets colder, the BBC reported.

She will spend the rest of Tuesday meeting civil servants at Downing Street, holding discussions with her aides and start rolling out ministerial appointments. On Wednesday, Truss will face off with Opposition Labour Leader Sir Keir Starmer for her first Prime Minister's Questions (PMQs) in the House of Commons.

Over-Speeding Caused Maximum Accident-Related Deaths In 2020: Govt Report

New Delhi: Over-speeding constituted the main traffic rule violation associated with accident related deaths (69.3 per cent) and injuries (73.4 per cent), followed by driving on wrong side, drunken driving, use of mobile phone and jumping red light in 2020, the road transport ministry said in a report.

According to the report titled 'Road accidents in India -- 2020', more than 11 per cent of deaths and injuries were caused due to non-usage of seat belts, while 30.1 per cent of deaths and 26 per cent of injuries were caused due to non-usage of helmets in 2020.

to non-usage of helmets in 2020. It has said that the number of persons killed and injured due to not wearing of seat belt during 2020 stood at 15,146 and

39,102 respectively.

A total of 2,65,343 road accidents occurred in India during the calendar year 2020 due to overspeeding, causing 91,239 deaths, while 20,228 road accidents happened due to driving on wrong side, claiming 7,332 lives.

As per the report, drunken driving was responsible for 8,355 road accidents and 3,322 deaths, while 6,753 road accidents occurred due to use of mobile phone while driving, causing 2,917 deaths.

While the report had noted that violation of any traffic rule constitutes human error or driver's fault, it has said that from the perspective of road safety strategy, violations such as overspeeding and driving on wrong



side does not constitute human error alone, but also possible fault in road design.

It had also claimed that the implementation of the Motor Vehicle Amendment Act(MVA) 2019, which became effective from September 1, 2019 contributed to reduce road accidents.

"The MVA Act 2019 included, inter-alia, provisions like stiff hike in penalties for traffic violations, electronic monitoring of the same, enhanced penalties

for juvenile driving etc. and the implementation of the same has enabled achieving the desired impact," the report had said.

Although not wearing seat belts by passengers sitting in the rear seats attracts a fine of Rs 1,000 under Rule 138 (3) of the Central Motor Vehicle Rules (CMVR), most people are either unaware of this mandatory rule or just ignore them.

Even traffic policemen seldom fine passengers sitting on rear seats for not wearing seat belts.

Commenting on issues related to traffic rules violations, Institute of Road Traffic Education(IRTE) President Rohit Baluja said road traffic violations are infringements or transgression of regulations under the Motor Vehicles Driving Regulations, as well as

the provisions of Motor Vehicles Act, Central and State Motor Vehicles Rules.

Baluja said studies conducted by IRTE have revealed that in Indian roadway conditions, a large percentage of violations are committed by drivers on account of faulty road environment, non-standard and faulty traffic control devices (signs, signals and markings).

He said as per studies carried out at IRTE, investigating officers of the police are generally not aware of the driving regulations and the provisions of the Motor Vehicles Act/Rules, as they by-default book the drivers of the motor vehicles quoting the sections of the Indian Penal Code relating to over-speeding, rash and negligent driving.

National Road Safety Council member Kamal Soi claimed that less than one per cent drivers who are caught for over-speeding are penalised, while in case of drunk driving, it is even less than 0.5 per cent.

Fear of being caught is not there at all in Indian population, he said. According to National Crime Records Bureau (NCRB) data, over 1.55 lakh lives were lost in road crashes across India in 2021 -- an average of 426 daily or 18 every single hour -- which is the highest death figures recorded in any calendar year so far.

SaveLIFE Foundation founder and CEO Piyush Tewari said the NCRB data revealed that traffic violations have become a routine occurrence in the country. "It is imperative that we mount a significant exercise to reduce speeding, especially on Indian highways and expressways, by ensuring effective and sustained enforcement," he added.

Tewari said driving at excessive speed attracts a fine of Rs 1,000-2,000 in case of light motor vehicles and Rs 2,000-4,000 in case of heavy motor vehicles under Section 183 of the Motor Vehicles (Amendment Act), 2019.

While driving by a drunken person or by a person under the influence of drugs attracts 6 months punishment or Rs 10,000 fine or both under section 185, in case of using a hand-held communication device while driving attracts imprisonment of six months to one year or a fine of Rs 1,000-5,000 or both.
