Malaria Booster Vaccine Shows Up To 80% Efficacy: Lancet Study

A malaria vaccine booster shot at one year following a primary three-dose regime maintained high efficacy of 70-80 per cent against the disease, according to a study published in The Lancet Infectious Diseases journal.

Researchers from the University of Oxford, UK and colleagues reported the findings from their Phase 2b trial following the administration of a booster dose of the candidate malaria vaccine, R21/ Matrix-M.

The vaccine, licensed to Serum Institute of India, previously demonstrated highlevel efficacy of 77 per cent over the following 12 months in young west African children in 2021.

In their latest findings, the researchers found that a vaccine booster dose at one year following a primary three-dose regime continued to meet the World Health Organization's Malaria Vaccine Technology Roadmap goal of a vaccine with at least 75 per cent efficacy.

A total of 450 participants aged five to 17 months were recruited from Burkina Faso, with 409 receiving the booster.

The participants were randomly assigned to three groups, with the first two groups receiving the R21/Matrix-M vaccine as a booster and the third a rabies vaccine as the control group.

Each child received the same booster vaccination as their primary series of vaccinations. Doses were administered in June 2020, largely prior to the peak malaria season.

The study reports a vaccine efficacy of 80 per cent in the higher-dose adjuvant group, and 70 per cent in the lower dose adjuvant group, over 12 months of follow-up.

"It is fantastic so see such high efficacy again after a single booster dose of vaccine. We are currently part of a very large phase III trial aimed at licensing this vaccine for widespread use next year," said Halidou Tinto, the trial Principal Investi-

"We are delighted to find that a standard four dose immunisation regime can now, for the first time, reach the high efficacy level over two years that has been an aspirational target for malaria vaccines for so many years," said Professor Adrian Hill, from the University of Oxford.

The trial has been extended for another two years to assess if further booster doses will be necessary to maintain high efficacy over time.

Results from the key ongoing Phase III licensure trial to assess large-scale safety and efficacy in 4,800 children aged five to 36 months across four African countries, are also expected later this year.



Two plane loads brought several Bollywood celebrities besides the union minister of information and broadcasting, Arun Jaitley, with hundreds of ministry officials in tow to grace' the occasion The gala function held at the city's Grand Palace hotel is believed to have cost the exchequer a fabulous Rs two to three crore.

Sources said no new Kashmiri programmes were likely to be produced for the channel. Proposals submitted by Kashmir producers, mostly Kashmiri pandits, were being returned due to non-availability of funds. Sources said 148 proposals, were approved by the Mandi House last month. India 'Running Out Of Weapons' Due To "Make In India" Policy: Report



Prime Minister Narendra Modi's push to boost domestic manufacturing of defense systems is leaving India vulnerable to persistent threats from China and Pakistan, according to officials with knowledge of the matter.

India's air force, army, and navy can no longer import some critical weapons systems to replace aging ones, the officials said. That risks leaving India critically short of helicopters by 2026 and with a shortfall of hundreds of fighter jets by 2030, they said.

Shortly after sweeping to power in 2014, PM Modi unveiled his "Make in India" policy to build everything from mobile phones to fighter jets in India to generate jobs and reduce outflows of foreign exchange. But eight years later, the world's biggest importer of military hardware still doesn't manufacture enough weapons locally to meet its needs -- and government rules are blocking imports.

PM Modi's program mandates between 30% to 60% of homemade components, depending on the nature of the military purchase or where it's purchased from. There were no such caps earlier and India used a system of plowing back a certain percentage of the cost of the purchase into domestic manufacturing.

As things stand, India's military readiness is set to further deteriorate just as it faces greater risks from Pakistan and China, which have soldiers deployed toe-to-toe against troops from India along their Himalayan border following deadly clashes in 2020. The weaker air force in particular means India will need twice the number of soldiers on the ground to deter aggression along the Chinese border, one person said.

Bloomberg spoke to multiple officials for this story across the three services in India. They asked not to be identified to discuss sensitive issues

India's Ministry of Defence did not respond to an email seeking comments.

While India's military has increased local purchases of some defense items, the country doesn't yet produce complex platforms like diesel-electric submarines and twin-engine fighters. Plans to buy fighters from foreign manufacturers were shelved because the Modi government wants the air force to opt for indigenously made single-engine fighters, which are in short supply, as well as twin-engine fighter planes that the country doesn't yet have in production.

The situation with the air force is particularly dire. By 2030, the Indian Air Force may be left with less than 30 fighter squadrons, well below the 42 the military says it needs to adequately protect borders with both China and Pakistan, officials said. Between now and then, the air force will be forced to ground about half-a-dozen squadrons -- each including 16 to 18 fighter jets -- that will reach the end of their flying life, one official said.

The Bengaluru-based stateowned defense manufacturer Hindustan Aeronautics Limited can only produce eight indigenous Tejas fighters each year, officials said, or roughly half a squadron. The company plans to double manufacturing capacity by 2026, they added, but delays are possible due to supply-chain disruptions caused by Russia's

US Approves \$2 Billion Military Loans And Grants To Ukraine, Neighbors



Washington: The United States on Thursday approved another \$2 billion in loans and grants for Ukraine and its neighbors to buy US military equipment, the State Department said.

The new aid from the Foreign Military Financing program is in addition to \$675 million in fresh direct aid to Ukraine announced earlier Thursday by Defense Secretary Lloyd Austin. Secretary of State Antony

Blinken informed Congress of the \$2 billion "to bolster the security of Ukraine and 18 of its neighbors, including... many of our NATO allies as well as other regional security partners who are most potentially at risk for future Russian aggression," a State Department official said, speaking on condition of anonymity.

The United States already authorized \$4 billion in loans and grants to Ukraine and its neighbors in the fiscal year that ended in June.

Don't Compare Sikh Turban, Kirpan With Hijab, Says Supreme Court: Report

New Delhi: The Supreme Court on Thursday said that there is no comparison between Kirpan and the turban of Sikhs with the hijab as a five-judge bench of the Supreme Court held that wearing a turban and kirpan is allowed for Sikhs.

The remarks came when a bench of Justices Hemant Gupta and Sudhanshu Dhulia heard various petitions challenging the Karnataka High Court judgment upholding the ban on hijab in educational institutes, according to news agency ANI.

Advocate Nizamuddin Pasha, appearing for one of the petitioners, who is a student of Islam and Arabic, tried to draw similarities between the Kirpan and turban with the hijab.

Mr Pasha said that the hijab is a part of the religious practice of Muslim girls and also asked if girls can be stopped from coming to school wearing hijab. He further argued that even Sikh students wear turbans.

Mr Pasha stressed that cultural practices should be protected. Justice Gupta said that comparison with Sikhs may not be proper as carrying of the kirpan is recognized by the Constitution. "So don't compare practices," the court remarked.

Justice Gupta said there are



statutory requirements on turbans and these are all practices well established in the culture of the country

Mr Pasha tries to cite examples of foreign countries like France. Justice Gupta said that we do not want to be according to France or Austria. "We are Indians and want to be in India," the court said.

Pasha while countering the Karnataka High Court judgement said that the hijab protects Muslim women.

Pasha said that the findings of the Karnataka High Court that the Hijab is a cultural practice are based on the assumption. He cited various religious books to support his arguments.

He also argued that it was a misreading of the footnote that the HC held that the Hijab is a "recommendation" and not "essential". Senior advocate Devadatt Kamat said that every religious practice is not essential but it is not that the state goes on restricting it.

During the hearing, Mr Kamat, appearing for another petitioner apprised the court that divergent views were taken by Karnataka, Kerala and Madras High Court judgments on whether the hijab is an essential religious practice. Madras and Kerala courts have held Hijab as an essential religious practice but Karnataka High Court differed, Mr Kamat said.

"Karnataka Government Order on the prescription of uniform in educational institutes suffers from non-application of mind,

he further added.

Human Progress Retreats To 2016 Levels By Covid, Other Crises: UN

Back-to-back global crises have set back human development by five years, a new report by a United Nations agency has warned.

The UN Development Programme (UNDP) said on Thursday that, for the first time since its creation in 1990, the Human Development Index (HDI) has declined for two consecutive years straight in 2020 and 2021 amid crises such as COVID-19 and the war in Ukraine - HDI being a measure of countries' life expectancies, education levels and standards of living.

"What we see is an unprecedented decline," the UNDP's Ulrika Modeer told Al Jazeera.

"The world has definitely seen such challenges before. We have more than one country actually the entire world. But what has happened now and what is represented in the report is an uncertainty complex," she said. "So many of these challenges happening at the same time".

HDI has steadily risen for decades, but began sliding in 2020 and continued its fall last year, erasing the gains of the preceding five years, the paper said.

The UNDP said nine out of 10 countries recorded a decline in their HDI score in either 2020 or 2021 and more than 40 percent declined in both years, with the lives of people in South Sudan, Chad and

Niger declining the most. 'If you look at the countries at the bottom of this list, there's one common factor – and that is conflicts," said Al Jazeera's Hiba Mor-



gan, who has extensively covered events in some of these countries.

'There is another factor that is common amongst those three countries that are on the bottom of the list and that is the impact of climate change. We've seen South Sudan facing floods for three consecutive years that has led to the displacement of tens of thousands of people that has submerged dozens of villages in various states around the country."

Life expectancy down

According to the ranking, Switzerland comes in as the most highly developed country in the world, with a value of 0.962, and nearly ties with Norway and Iceland.

In the first report in 1990, the United States came out on top, but has now slipped to 21st place.

"The world is scrambling to respond to back-to-back crises. We have seen with the cost of living and energy crises that, while it is tempting to focus on quick fixes like subsidising fossil fuels, immediate relief tactics are delaying the long-term systemic changes we must make," Achim Steiner, UNDP administrator, said.

in making these changes. In a world defined by uncertainty, we need a renewed sense of global solidarity to tackle our interconnected, common challenges."

The coronavirus pandemic was a major driver of the decline, but the report noted a compounding number of crises - political, financial and clmate-related - have not allowed time for populations to recover.

While some countries had begun to recover from the pandemic, many others in Latin America, Africa, South Asia and the Caribbean had not yet turned the corner before a new crisis hit: the war in Ukraine.

While the fallout from Russia's invasion of Ukraine on food and energy security has not yet been calculated into this year's index, "without any doubt, the outlook for 2022 is grim", Steiner said.

Israeli PM Opposes Prosecuting Soldier Who Shot Abu Akleh

srael's Prime Minister Yair Lapid has pushed back against suggestions of prosecuting a soldier who likely shot dead Al Jazeera journalist Shireen Abu Akleh while she was covering an Israeli army operation in the occupied West Bank in May.

The veteran Al Jazeera reporter was wearing a bulletproof vest marked "Press" and a helmet when she was shot in the head in the Jenin refugee camp. Her killing caused global outrage and calls for an independent investigation.

The Israeli army conceded on Monday for the first time that one of its soldiers had likely shot Abu Akleh, after having mistaken her for a fighter. It had initially blamed Palestinian gunmen for her killing.

'There is a high possibility that Ms Abu Akleh was accidentally hit by [Israeli military] gunfire that was fired toward suspects identified as armed Palestinian gunmen," said the army's final report into her May 11 death.

The acknowledgement came after months in which the army had insisted it was impossible to determine the source of the deadly shot that killed the celebrated Al Jazeera journalist.

"I will not allow an [Israeli military] soldier that was protecting himself from terrorist fire to be prosecuted just to receive applause from abroad,' Lapid told a military ceremony.'

'No one will dictate our rules of engagement to us," he said. "Our soldiers have the full backing of the government of Israel and the people of Israel."

US Department of State spokesman Vedant Patel had told a news briefing on Tuesday: "We're going to continue to press our Israeli partners to closely re-



view its policies and practices on rules of engagement and consider additional steps to mitigate the risk of civilian harm".

A United Nations investigation concluded in June that there was "no evidence of activity by armed Palestinians close by" when Abu Akleh was shot.

Israel's military advocate said on Monday that the circumstances of the incident "do not raise the suspicion of a crime having been committed which would justify the opening of a criminal investigation".

The Palestinians have accused Israel of deliberately targeting Abu Akleh. Israel has denied this.

"Israel has expressed sorrow over her death. It was a tragedy that transpired in an incident in which there was heavy enemy fire. The [Israeli military] never intentionally shoots at innocent people," Lapid said.

The Abu Akleh family said that Israel had "refused to take responsibility for the murder" of the journalist. Al Jazeera has denounced the

findings of the Israeli investigation and demanded a probe by an "independent international body".

US Department of State spokesman Ned Price on Monday underscored "the importance of accountability in this case ... to prevent similar incidents from occurring in the future."

Record Rains In Pakistan Damage Mohenjo Daro Archaeological Site

Islamabad: Pakistan – The devastating floods in Pakistan have caused significant damage to Mohenjo Daro, a famous 4,500-year-old archaeological site in the southeastern Sindh province which UNESCO has declared a World Heritage site.

The area in Sindh's Larkana district received more than 1.400mm of rain in the second week of August, damaging the the historic structures, Abdul Fatah Shaikh, the director of archeology and museum for the provincial government, told Al Ĵazeera on Wednesday.

That amount of rain, Shaikh said, has not been recorded on the 250 hectares (650 acres) since the ruins were discovered 100 years ago in 1922. 'The original structure is safe

by and large, including the stupa at the site. However, the protective layer, also called mud slurry, that we deployed suffered a lot of damage, causing exposure of the original walls, Shaikh said over the telephone from Karachi city.

Shaikh said the damage was caused mainly due to heavy rains and that there was no flooding, but added that urgent remedial work is required.

"The original structure is now exposed to the vagaries of nature and if immediate conservation work is not started, it can cause irreparable damage, he warned.

Mohenjo Daro ('Mound of the Dead' in Sindhi language) considered the best preserved urban settlement in South Asia - is situated on the bank of the Indus River, with Larkana being the nearest major city 30km (18 miles) away.

Repair work under way

Shaikh rejected media reports that claimed the site could he removed from the heritage list after the rains damaged it, saying there was no such immediate risk.

"If a site is not conserved or protected properly, they are given suggestions to improve. If the (UNESCO) committee is not satisfied, warning is issued to the host country. Often, these warnings are repeated for multiple years before a site is moved to a 'danger list'," Shaikh said.

He said there are currently 52 World Heritage sites across the globe on the danger list, but none of them are in Pakistan.

Doctors 'Concerned' For UK Queen's Health

LONDON: Fears grew on Thursday for Queen Elizabeth II after Buckingham Palace said her doctors were "concerned" for her health and recommended that she remain under medical supervision.

The 96-year-old head of state -- Britain's longest-serving monarch -- has been dogged by health problems since last October that has left her with difficulties walking and standing.

On Wednesday, she pulled out of a planned meeting with her senior political advisors, after being told to rest.

The previous day she held audiences at her Scottish Highlands retreat, Balmoral, with outgoing prime minister Boris Johnson and appointed his successor, Liz Truss.

'Following further evaluation this morning, the Queen's doctors are concerned for Her Majesty's health and have recommended she remain under medical super-



MacKenzie Scott, the former wife of Amazon founder Jeff Bezos, has donated two of her Beverly Hills mansions, valued at \$55 million, to a charitable foundation.

Ms Scott is among the billionaires who have signed a pledge to give away the majority of their wealth to charity. Now, she has taken her philanthropy a step further - by giving up her own longtime, and luxurious, homes.

The California Community Foundation (CCF) - a nonprofit philanthropic organisation - announced that Ms Scott donated "two single-family residences valued at \$55 million".

"We applaud and are grateful to MacKenzie Scott's extraordinary philanthropic investment in Los Angeles," said CCF President & CEO Antonia Hernandez, as per a press note.

"Her singular commitment here and across the country - to transformative philanthropy has already secured the long-term future of dozens of non-profits. With the California Community Foundation, her generosity will support organizations struggling to solve some of the most intractable issues facing our community. We are grateful for her partnership," the CCF President added. New York Post reported that

Ms Scott, who married high school teacher Dan Jewett in 2021, had received sole ownership of the homes following her divorce from Jeff Bezos in 2019. The former couple had purchased the first home back in 2017 for \$24.45 million. They then bought the second home on the same street 10 years later in 2017 for \$12.9 million.

Death On Foreign Soil: 'Things Take Time', But Delay Disquiets Kashmir

he Ganaie family of Katoo Bijbehara has been restlessly waiting since 6th September to hug their daughter Khushboo Manzoor one last time.

Khushboo, 22, was pursuing her MBBS degree at KhwajaYunus Ali Medical College, Bangladesh. She fell from a building on Tuesday and was subsequently moved to a hospital where she was admitted in ICU before passing away.

Her college friend told Kashmir Observer over phone from Bangladesh that the deceased suffered multiple

fractures, spinal cord compression, haemothorax, left kidney crush, pelvic and femur fracture besides shoulder

"She lost more than 65 per cent blood and was put on ventilator," Khushboo's friend said. "She was not responding to any treatment."

Khushboo was the only girl child of her family. Her mother Shameem Bano hasn't eaten anything since her tragic end.

"After every five minutes, she demands the status of her daughter's dead body," Sharif Hussain, Khusboo's cousin, told Kashmir Observer. "The

family is traumatized because of the delay in dispatching her body from Dhaka.

Sharif said that the family was asked by Bangladesh authorities to follow certain procedures including sending an affidavit which they did.

But despite that, the campus took its time sparking protest from hundreds of her fellow students demanding to send Khushboo's body back to her home.

Following the campus commotion and the legal formalities, Khushboo's body was finally cleared for homecoming on Thursday evening. It's arriving in the valley on

Friday. But the delay in dispatching dead bodies from abroad has now become a new distress for the Kashmiri families who lose their loved ones away from home.

"Even if the district administration was very cooperative and trying their best to bring back the body, Khushboo's parents were restless," Sharif

"It's a bigger torment for parents to wait for the dead body of their loved ones dying far away from home."

While launching a massive campaign on social media to bring back the body, many

Kashmiri netizenssaid thatit is not the first time that people "had top lead" for the return of dead bodies of students or employees from foreign soils.

In April 2022, a 25-year-old youth from north Kashmir's Baramulla district died in a similar way after falling from a building in Saudi Arabia.

The youth identified as Imran Ahmad Sheikh of Baramulla's Nehalpora area was working with Shahwarmar Company Taif.

The family then had to move from pillar to post for the early return of his body from Saudi Arabia so that they could perform his last rites.

Similarly, on 12 January 2022, a Kashmiri girl student from central Kashmir's Budgam district died of cardiac arrest in Bangladesh.

The deceased Seema Zehra was a second year MBBS student at Ad din Sakina Medical College Jessore. Her family also appealed to the Governor to help get her body back home.

"It takes some time to follow the proper procedure and clear the legal formalities of dead bodies that are supposed to be brought back from the other countries," Pandurang K. Pole, Divisional Commissioner Kashmir, told Kashmir

"In this [Khushboo's] case, the parents were not willing to get the post-mortem done,

however they finally agreed.' In most of the cases, Pole said, the administration has brought the bodies on time.

"We understand that friends, family and relatives are going through unimaginable pain, but some legal and medical formalities are mandatory," Nasir Khuehami, spokesperson of Jammu and Kashmir Students Association, told Kashmir Observer.

"It takes at least two days to bring back the dead bodies from other countries.

Very Few KPs Returning To Valley Due To Sense Of Fear: Karan Singh

NEW DELHI: Constant sense of fear and apprehension among Kashmiri Pandits is why very few of them are willing to return to their homeland in the Valley, veteran politician Karan Singh has said.

Army's Best Friend On The LoC In Kashmir: 'Gaddi' Dogs!

KERAN SECTOR: Unskilled and untrained but sharp like pro, the local canines known as 'Gaddi' dogs are a soldier's best friends and the first responders along the Line of Control (LoC) in Kashmir as they do a "fantastic job" of detecting any suspicious activity and alerting the troops of possible infiltration attempts.

'Gaddi' shepherds who rear them as guard dogs accompanying flocks of sheep and goats, this canine breed is a Himalayan sheepdog, also known by various other names including 'Bhotia' or 'Bangara' and sometimes called the Himalayan mastiff.

This local canine is native to the Himalayan foothills in eastern Nepal and Kashmir. The breed is primarily used as a livestock guardian, protecting flocks from various predators and as a property guard. They are also used to assist while hunting.

'These are local, but not stray dogs," an army official said at one of the forward posts on the mighty Shamsabari range in Keran sector in Jammu and Kash- and practically are a part of mir's northern district of Kupwara, as a black canine kept pacing along the fence, the first tier

system (AIOS). The official said while the Army uses hi-tech equipment for the round-the-clock surveillance of the fence with the combination of men and machinery, the 'Gaddi' dogs are invaluable to the soldiers in the fight against infiltration.

"They pick even the slightest of the movements. They can sniff or hear in case there is any movement. They promptly raise the alarm and alert the troops," he said

The officer, who cannot be named for strategic reasons, said the canine breed are the soldiers' eyes and ears and live with them like a family.

'They work with the troops the family. They are their best friends," he added.

Calming The LAC

India and China may be ending soon, the two countries on Thursday began disengaging from the Gogra-Hotsprings border area in Ladakh after reaching a consensus in the 16th round of India-China Corps Commander-level meeting. According to the union government, the disengagement is taking place in a "coordinated and planned" manner and is meant to maintain peace at the frontier. The move comes ahead of a meeting in Uzbekistan scheduled next week which is expected to be attended by Chinese President Xi Jinping and Indian Prime Minister Narendra Modi. The two countries have been engaged in a bitter standoff ever since the Chinese army staged incursions across the Line of actual Control in multiple areas in April-May 2020. The situation came to a head when 20 Indian soldiers lost their lives during a scuffle along the border. Ever since multiple Corps Commander-level talks and a few meetings between the foreign ministers of the two nations yielded little result.

Last year, in a first breakthrough in talks, India and China pulled back their troops from the south bank of Pangong lake area in eastern Ladakh following their agreement for "synchronised and organised disengagement". But subsequently, there was no progress on the other three points of friction - Galwan Valley, Hot Springs, and Gogra. Up until now they have proved difficult to sort out. But there is hope that like the three frictions points so far, the two countries will find a diplomatic solution to all the stand off at Calwan Valley, sooner than later.

The problem in the negotiations so far has been that China has been loathe to go back to the status quo ante and has asked for mutual withdrawal. The incursions in the first place have been staged by China and the communist giant was not ready to vacate it unless India also withdraws from a portion of the border on its side of the LAC. But New Delhi could hardly afford to do it, not least because it considers the area its own. Doing so would have been politically costly for the BJP government at the centre which was already facing severe flak for vacating Kailash ranges as part of its Pangong Tso agreement. But through sustained negotiations they have finally found an amicable way out. For a peaceful neighborhood it's important that India and China reach a modus-vivendi by resolving the issues dividing them.

shot in the arm muscle is no longer the only way of administering a Covid vaccine. In April, Russian drug regulators approved the use of vaccines that can be sprayed into the nose, but very little was known of their efficacy. Earlier this week, China became the first country to authorise the use of an inhaled vaccine for booster doses. On Tuesday, India's Central Drugs Standard Control Organisation (CDSCO) approved iNCOVACC, the country's first intra-nasal vaccine for primary inoculation. Developed by scientists at the Washington University and manufactured by the Hyderabad-based company, Bharat Biotech, the vaccine uses a harmless version of chimpanzee adenovirus to deliver the spike protein to the lining of the nose.

Many experts believe that needle-free vaccines are the future of Covid inoculation. It's now well-established that the first-generation vaccines protect against severe disease but they do not prevent breakthrough infections. A possible reason for this failure is the inability of the injectables to induce an immune response in the body's first line of defence against the coronavirus — the respiratory tract. Nasal vaccines like the Bharat Biotech-manufactured drops behave differently. They target the immune cells in the thin mucous membranes that line cavities in the nose. The body's defence mechanism, therefore, gets to work immediately after the coronavirus enters the body and stops the pathogen from using the respiratory tract to cause infection. That is why vaccines such as iNCOVACC can prevent mild cases of Covid and break the line of transmission of the disease. The vaccine has other advantages. A squirt in the nose is much easier to administer than conventional shots — in fact, trained healthcare workers are not required to deliver this needle-free vaccine. The vials can be stored easily at 2 to 8 degrees Celsius and Bharat Biotech claims that it can scale up production at short notice. All this means that though the drug regulator has approved iNCOVACC for the small section of the country's adult population that has not received primary inoculation, the vaccine could be a potential shield in case the unpredictable virus throws up another variant of concern — healthcare authorities can turn to it in case of an

emergency requirement for inoculation.

Non-injectable vaccines have proved to be a game changer in the battle against polio. But their record against influenza has, at best, been mixed. Researchers working on the Covid vaccine claim they have learnt lessons from the experiences of their counterparts who developed the influenza shots. The performance of iNCOVACC will be keenly watched.

Observing the real time experience one can clearly see how discouraging it is becoming for farmers to continue practicing agricultural activities. Citing an experience here, around 6 years ago, one A-Quality apple box (5 layer) used to be sold at around Rs. 1000 and A-Quality apple box (4 layer) used to be sold at Rs. 800 to 900. 6 years passed on the price of same apple boxes currently stands at around Rs.

900 and 700 respectively. This means the price has actually decreased over the years, while the price of agricultural equipment, service prices and prices of products of other two sectors increased manifold over the same period of time. This clearly indicates the deteriorating terms of trade between the sectors and against the agriculture sector, leaving agriculturists at absolute disadvantage.

Adding salt to injury is the transportation facilities which are there to transport the agricultural produce to outside states as well as outside the country. With only a drizzle worth of rainfall, the national highway which connects the Kashmir region to the rest of the country stands closed for days. Agriculture products are perishable in nature; hence need to be timely transported to markets in order to fetch acceptable prices. Besides these issues there are problems like availability of poor quality pesticides and insecticides due to least monitoring by responsible agencies.

Keeping in view the importance and potential of the agriculture sector, due care and intervention is needed on the part of the government in order to uplift the lives of people engaged in agriculture. Most importantly, a balance needs to be maintained between agriculture prices and the other related prices so that goals of self-sufficiency can be achieved along with sustainable & inclusive growth and development.



Poor Mental Health Of Employees Costs Indian Employers \$14 Bn Yearly: Survey

Poor mental health amongst employees costs Indian employers around USD 14 billion annually in absenteeism, lower productivity and attrition, according to Deloitte's Mental Health Survey.

Over the years, mental health issues have seen a steady rise globally, accentuated further by the onset of COVID-19.

According to World Health Organisation (WHO), India accounts for nearly 15 per cent of the global mental health burden.

To analyse the current state of mental well-being amongst Indian employees, Deloitte Touche Tohmatsu India LLP (DTTILLP) undertook a survey titled 'Mental health and well-being in the workplace', it said in a statement.

The survey dives into the top stressors from an employee's perspective, along with an estimate of the yearly economic cost to Indian

ployee mental health.

Around 47 per cent of professionals surveyed consider workplace-related stress as the biggest factor affecting their mental health, followed by financial and COVID-19 challenges.

These stressors manifest in multiple ways, affecting both the personal and professional facets of an individual's life; often with associated social and economic costs," it

The report estimates that "poor mental health amongst employees costs Indian employers around USD 14 billion per year due to absenteeism, presenteeism, and attrition".

Presenteeism is the phenomenon of attending to work while under mental stress and hence, performing at low productivity.

These costs build up over time and are incurred when poor mental health impacts how individuals deal with day-to-day stressors and environment," the statement said.

According to the survey, 80 per cent of the Indian workforce has reported mental health issues during the past one year.

Despite these alarming numbers, societal stigma prevents around 39 per cent of the affected respondents from taking steps to manage their symptoms.

Additionally, the survey found that at the workplace, 33 per cent of all respondents continued to work, despite poor mental health, while 29 per cent took time off and 20 per cent resigned to better manage their mental health.

Commenting on the findings of the study, Punit Renjen, Deloitte Global CEO, said, "Mental health has been a real issue. The challenges of the past two-plus years have brought conversations about mental health at work to the forefront".

The study, he said, demonstrates that businesses must pri-



oritise the mental health and wellbeing of their people.

'It is essential that senior leaders play a major role in destigmatising mental health challenges within their organisations. We need to take the necessary steps to create an environment where employees' well-being is prioritised, and they have access to the support they

need so that everyone can thrive,

he said Adds Charu Sehgal, Partner and Life Sciences and Health Care Leader, DTTILLP, that "mental health-related challenges are not new to the Indian workforce, but these have come to the forefront in light of COVID-19, and a younger workforce that is open to speaking

Not only is the number of impacted employees large, but the degree of the challenge is also high, accentuated by performance-oriented cultures anchored in long and demanding work schedules, economic uncertainty, and peer comparison (especially on social media platforms), she said.

She further added that while most Indian corporates have recognised the importance of employee well-being, the share of mental health measures at the workplace is still limited, with a few sporadic events and the use of third-party employee assistance programmes.

With the generational shift that we are witnessing in our workforce, employers have the opportunity to hit reset and fundamentally reevaluate the ways of working to address root causes and drive greater inclusion and well-being through enabling talent policies.

Google Warns Users To Quickly Update **Chrome To Avoid Hacking Risk**

oogle has advised its users to immediately install a security update in its Chrome browser to safeguard themselves against a serious bug being actively exploited by hackers.

The tech giant said it is aware of reports that an exploit for 'CVE-2022-3075' exists in the wild, mentioning the vulnerability as "Insufficient data validation in Mojo" reported by an anonymous security researcher.

The company said it has released a security patch for Google Chrome users on Windows, Mac and Linux operating systems that will roll out over the coming days/weeks.

"Access to bug details and links may be kept restricted until a majority of users are updated with a fix," Google said in a security update.

'We will also retain restrictions if the bug exists in a third party library that other projects similarly depend on, but haven't yet fixed," it added.

Finance Ministry To Kick-Start Budgetary Exercise From October 10

NEW DELHI: The finance ministry will kick-start the exercise to prepare the annual budget for 2023-24 from October 10, in the backdrop of revival of the Indian economy and fears of recession in developed countries.

The budget for the next year will have to address critical issues of high inflation, job creation, boosting demand, and putting the economy on a sustained 8 per cent-plus growth

On Wednesday, finance minister Nirmala Sitharaman said inflation is no longer "red-lettered" and the priority for the government now is job creation and boosting growth.

"Some of course are red-lettered (priorities), some may not be. Red-lettered ones would of course be jobs, equitable wealth distribution and making sure India is moving on the path

It will be the fifth budget of the Modi 2.0 government and Sitharaman and the last full budget before the general elections slated in April-May 2024. During the election year, the

The Budget for the current fiscal had projected a growth rate of about 7-7.5 per cent in real terms, while the fiscal deficit was pegged at 6.4 per cent of the gross domestic product (GDP).

Prime Minister Narendra Modi-led government scrapped a colonial-era tradition of presenting the Budget at the end of February. The then finance minister Arun Jaitley had for the first time presented the annual accounts on February 1, 2017.

With the preponement of the Budget, ministries are now allocated their budgeted funds from the start of the financial year beginning April. This gives government departments more leeway to spend, as well as allow companies time to adapt to business and taxation plans.

Previously, when the Budget was presented at the end of February, the three-stage Parliament approval process used to get completed some time in mid-May, weeks ahead of onset of monsoon rains.

This meant government departments would start spending on projects only from August-end or September, after liament's Budget session which the monsoon season ended.

Inflation Management Can't Be Singularly Left To RBI: FM Sitharaman

NEW DELHI: Finance Minister Nirmala Sitharaman on Thursday said inflation management cannot be "singularly" left to the monetary policy as a majority of activities are outside its purview in the current context.

Speaking at a seminar organised by economic think-tank Icrier, the finance minister said that both the fiscal policy and the monetary policy have to work together to contain inflation.

Consumer price index (CPI) based inflation or retail inflation is ruling above the Reserve Bank's comfort level of 6 per cent since January. The central bank, which has been tasked by the government to keep inflation within 2-4 per cent range, has hiked the key policy rate by 140 basis points since May with an aim to check the rate of price rise.

Inflation management cannot be singularly left to monetary policy, which has proved totally ineffective in many countries, she said.

"The RBI will have to synchronise somewhat, maybe not as much synchronised as other western developed countries would do. I am not prescribing anything to the Reserve Bank...

"I am not giving any forward direction to the RBI but it is the truth that India's solution to handling the economy, part of which is handling inflation also is an exercise where the fiscal policy, together with the monetary policy has to work," she said.

As part of inflation management, she said, India increased the import of crude oil from Russia at discounted prices despite sanctions imposed on Moscow due to the Russia-Ukraine war.

In a couple of months, she said, India ramped up its import from Russia from about 2 per cent of the total shipment of petroleum products to 12-13 per cent as part of inflation management.

Army Deploys Ultra-Light M-777 Howitzers In Forward Locations Along LAC In Arunachal Pradesh

Namsai (Arunachal Pradesh): The Indian Army has deployed a significant number of easily transportable M-777 ultralight howitzers in mountainous regions along the Line of Actual Control (LAC) in Arunachal Pradesh, military officials said on Thursday.

The Army's bolstering of firepower in the forward locations of Arunachal Pradesh comes after the howitzers were deployed in several sensitive areas in the Ladakh sector amid the lingering border standoff with China.

India has been ramping up its overall military might in all strategically key areas along the nearly 3,500-km-long LAC after the Galwan Valley clash in June 2020 that triggered a major escalation in tensions between the Indian and Chinese armies.

Army officials said the deployment of M-777 howitzers coupled with additional air assets including unmanned aerial vehicles, military aircraft and surveillance equipment has enhanced India's military preparedness in the Arunachal Pradesh sector.

The Army faced the difficulty of transporting heavy artillery guns in the mountainous regions but the deployment of ultra-light howitzers has addressed the challenge.

"The ultra-light M-777 can

"The ultra-light M-7// can be transported quickly in Chinook helicopters. We now have the flexibility of quickly moving them from one place to another based on operational requirements," a senior official told PTI.

"Now we are in a much better position to deal with any eventualities," he added.

The Army deployed M-777 guns in Bum-La last year but now the howitzers are being pressed into service in Arunachal Pradesh's RALP area, comprising several key mountainous regions.

The M-777 artillery guns, having a maximum range of 30 km and manufactured by the

BAE Systems, were first received by the Army in 2018. The procurement had come after a 30year wait for new artillery guns since the Bofors scandal.

India ordered 145 M-777 guns from the US under a USD 750 million deal in 2016.

The addition of upgraded L70 air defence guns to the existing Bofors guns in the forward locations in Arunachal Pradesh also added additional might to the Army's combat prowess.

The L-70 guns were originally manufactured by Swedish defence firm Bofors AB in the 1950s and India started inducting over 1,000 of them in the 1960s.

The guns have been upgraded by state-run Bharat Electronics Limited (BEL).

The Army has taken a series of measures to boost its operational capabilities in the eastern sector bordering China.

The Army has been putting an equal amount of focus on enhancing operational capability in the Northern as well as eastern sectors, officials said.

The eastern Ladakh border standoff between the Indian and Chinese militaries erupted on May 5, 2020, following a violent clash in the Pangong lake areas and both sides gradually enhanced their deployment by rushing in tens of thousands of soldiers as well as heavy weaponry.

The tension escalated following a deadly clash in Galwan Valley.

As a result of a series of

military and diplomatic talks, the two sides completed the disengagement process in the Gogra area and the north and south banks of the Pangong lake last year.

The last round of military talks in July ended in a stalemate as there was no forward movement in ending the standoff in remaining friction points in the region.

Each side currently has around 50,000 to 60,000 troops along the Line of Actual Control (LAC) in the sensitive sector.

Sonowal Lays Foundation Stone Of New Complex Of NISR Leh

The new infrastructure of NISR will spruce unlock the huge potential that Sowa Rigpa has to offer in the country. To be built at a cost of 25 Crores in the first phase, the revamped NISR complex will be further developed with hospital block, hostels, staff quarters etc. This planned investment along with eventual boost to the faculty strength at NISR is aimed at developing this institute as a Centre of Excellence to Sowa Rigpa locally, nationally and globally. The academic block is scheduled to be completed by 2023.

The Ministry of Ayush is also supporting NISR to set up a Herbal Medicinal Garden spread across an area of 10 hectares. This will not only help conserve valued medicinal plant from the trans Himalayan region but also help in research for further usage in treating human ailments and enriching human lives.

Speaking on the occasion, Sarbananda Sonowal, said, "The strength & immense potential that the traditional Indian medicinal practices possess must be fully utilised to help people recover from their ailments and



help them enjoy a quality life. Our rich heritage has given us practices like Sowa Rigpa which has benefitted people from the Himalayan region since time immemorial. Today, Sowa Rigpa has got a tremendous boost due to PM's constant effort to promote traditional Indian medicine for the greater good of human kind. We are confident that such steps will boost the popularity of Sowa Rigpa beyond the Himalayan region and help people across the world live a better, healthier and happier life."

The NISR was set up as per the decision of the Union Cabinet, under the Chairmanship of Prime Minister Narendra Modi, on 20 November, 2019. It was formally registered on 13 April, 2020.

The National Institute of Sowa-Rigpa has already signed MoUs with IIM (CSIR), TKDL (CSIR), FHRI, ICFRE, Amity University and Moraji Desai National Institute of Yoga (MDNIY) and started collaborative research work on Sowa-Rigpa and Medicinal Plants of Trans-Himalayas. The NISR has also started Under Graduate courses for students aspiring to study Sowa Rigpa from academic year 2021-22. The Bachelor of Sowa Rigpa Medicine & Surgery (BSRMS) is a 5.5 years course affiliated to University of Ladakh. A total of 10 students, selected through NEET exam, have already enrolled in this programme. This is especially encouraging to the people of

Arunachal Pradesh, Himachal Pradesh and Ladakh where this traditional medicinal practice is immensely popular.

SC To Hear On Sep 12 Pleas Challenging Constitutional Validity Of Citizenship Amendment Act

New Delhi: The Supreme Court would hear on September 12 a batch of pleas challenging the constitutional validity of the Citizenship (Amendment) Act (CAA) which seeks to grant citizenship to non-Muslim migrants who came here from Pakistan, Bangladesh, and Afghanistan on or before December 31, 2014.

While refusing to stay the operation of the law, the top court had on December 18, 2019, issued notices to the Centre on the pleas.

As per the list of businesses

uploaded on the apex court website, a bench comprising Chief Justice Uday Umesh Lalit and Justice S Ravindra Bhat has posted 220 petitions, including the lead plea of the Indian Union of Muslim League, for hearing on Monday.

The amended law seeks to grant citizenship to non-Muslim migrants belonging to Hindu, Sikh, Buddhist, Christian, Jain, and Parsi communities who came to the country from Pakistan, Bangladesh, and Afghanistan on or before December 31, 2014.

The top court had issued notice to the Centre and had sought its response by the second week of January 2020.

However, due to the COVID-19-induced restrictions, the matter could not come up for a full-fledged hearing as the matter involved a large number of lawyers and litigants. While issuing the no-

tice on pleas, the bench had asked Attorney General K K Venugopal, representing the Centre, to consider using audiovisual medium to make citizens aware of the legislation.

"We are not going to grant a

stay," the apex court had said. The Indian Union Muslim League (IUML), one of the petitioners which have challenged the CAA, said in its plea that it violates the fundamental Right to Equality and intends to grant citizenship to a section of illegal immigrants by making an exclusion based on religion.

The then President Ram Nath Kovind gave assent to the Citizenship (Amendment) Bill, 2019 on December 12, 2019, turning it into an Act.

The plea by IUML filed through advocate Pallavi Pratap seeks an interim stay on the operation of CAB and the Foreigner Amendment (Order), 2015, and Passport (Entry Into Rules), Amendment Rules, 2015.

The petition alleged that the government's CAB was against the basic structure of the Constitution and intended to explicitly discriminate against Muslims as the Act extended benefits only to Hindus, Sikhs, Buddhists, Jains, Parsis, and Christians.

The plea filed by Congress leader Jairam Ramesh has said that the Act is a "brazen attack" on core fundamental rights envisaged under the Constitution and treats "equals as unequal".

In his petition, Ramesh has said that substantial questions of law, including whether religion can be a factor in either acquiring or denying citizenship in India, arises for consideration of the court as it is a "patently unconstitutional" amendment to the Citizenship Act, 1955.

"The impugned Act creates two classifications, viz, classification on basis of religion and the classification on the basis of geography, and both the classifications are completely unreasonable and share no rational nexus to the object of the impugned Act i.e., to provide shelter, safety, and citizenship to communities who in their native country are facing persecution on grounds of religion," the plea has said.

Several petitions have been filed challenging the constitutional validity of the Citizenship (Amendment) Act, 2019, including by RJD leader Manoj Jha, Trinamool Congress MP Mahua Moitra, and AIMIM leader Asaduddin Owaisi.
