### 8 Years Later, Flood-Hit Houses Rendering Many Roofless In Kashmir

Farzana Bashir

n the window of her rented room in Srinagar's Nowpora area, Zareena Farooq is trying to visualize the fretful flood scenes of 2014. Although eight years have already passed since that catastrophic fall, she's still carrying the dreadful deluge with her.

"How can I forget it," says Zareena, almost choking with emotions. "I lost everything in that fall including my beautiful

In the beginning of 2014, Zareena's well-to-do husband had availed a bank loan for boosting his business but later that year he had lost everything

in floods. He couldn't pay his debt on time and ended up selling his properties, including his

"We were given some token relief by the government and left to fend for ourselves," Zareena says. "It was a natural calamity, a humanitarian crisis. The government should've helped us rebuild our lives, rather than letting banks dictate and devour our addresses in the name of interests."

While some people rebuilt their houses from scratch, others couldn't due to paucity of means. Many houses that withstood the deluge were eventually declared unfit for living. Among them was Mohammad

Munawarabad in our flood-hit house all these years until we

vacated it last year," says Shafi, a 57-year-old sales executive in a private company."But now, we're forced to live on rent

because our house has become

prone to accidents." After floods, the government distributed relief among the victims whose houses were damaged in the deluge. "The govern-ment did help us but our damage was much bigger than they estimated in their records," Shafi says.

"Our houses weren't considered damaged and we were forced to live in flood-stricken shelters. In all these years, government should've helped those who were not able to rebuild their residences."

As per a study-'A satellitebased rapid assessment on floods in Jammu & Kashmir-September, 2014—by the department of environment &

remote sensing and the ISRO, the 2014 floods inundated 557 sq-km of Kashmir and affected at least 22 lakh people. The natural fury stranded thousands of people inside their submerged homes and cost the economy more than Rs 100 crore.

Four years after that flood, government approved 4,442 houses in JK under its Pradhan Mantri Awas Yojana (urban). However, as of January 2018, hardly eight shelterless families were provided with the house- three in Budgam, four in Baramulla and one in Kupwara.

### **Govt Submits ATR On Wular Conservation In Court**

The government has submitted an action taken report (ACR) before the High Court of Jammu Kashmir and Ladakh highlighting a number of measures taken for the conservation and preservation of Wular lake— one of the largest freshwater lakes in South Asia.

The ATR was submit-ted by the Chief Executive Director Wular Conservation and Management Authority (WUCMA), T Rabi Kumar before the High Court of Jammu Kashmir and Ladakh.

On August 2, the court directed the government to file an Action Taken Report (ATR) regarding detailed status about utilisation of funds, encroachment status of Wular lake, staff strength of authority and latest position of lake conservation manners taken by said Authority to conserve the lake.

Hearing a Public Interest Litigation (PIL), filed by Kashmir Environmental Protection, a division bench of Chief Justice Pankaj Mithal and Justice Rajesh Sekhri observed that sufficient funds were being provided by the Centre for the conservation and preservation of the lake.


In response to the submission, the government submitted the latest progress with regards to encroachment status and lake conservation and management action programme.

The government submitted that the demarcation work was started with the establishment of WUCMA in the year 2012 and the whole exercise was completed by 2016 Wular lake is fully demarcated with concrete boundary pillars all along its periphery.

They said that the boundary line is digitized with each boundary pillar duly geo referenced.

The net area of Wular Lake at present is 130 square kilometer with an encroachment of 380 Kanals and 11 Marlas," the government said, adding that "the area under encroachment is 0.001% Eviction of 20 Kanals and 11 Marlas have been achieved More on P10

### **HC Scraps Govt Notification** On Land Acquisition

Srinagar: The High court of Jammu & Kashmir and ladakh on Wednesday declared a notification to acquire land issued under erstwhile state's land acquisition act for Srinagar ring road as null and void.

While disposing of the writ petition filed by residents of Wathoora Budgam, a division bench of Chief Justice Pankaj Mittal and Justice Puneet Gupta declared the land acquisition proceedings initiated in 2017 for construction of Srinagar Semi Ring Road as null and void.

The division bench said that the writ in the nature of mandamus is issued declaring that land acquisition proceedings pursuant to the notification



dated 20.03.2017 issued under Section 4 of the J&K Land Acquisition Act (now repealed) stands lapsed under Section 11-B of the Act for want of making an award within a period of two years from the date of declaration.

"The writ petition is, accordingly, allowed," the court observed. The court further said

that it is an admitted position that the urgency provisions under Section 17 of the Act were not invoked and the possession of the land continues to be with the petitioners.

'The respondents have not brought on record any possession memo to show that they have taken possession of land notified to be acquired in accordance with law so as to vest it with the State," the order reads

The court further observed that since the declaration under Section 6 was made on 08.08.2017, therefore, the award ought to have been made by 08.08.2019 i.e., within two years.

"No act of such type is acceptable", the police officer reiterated. The woman seen in the video has been accused of falsely suspecting a youth of stalking her daughter. "The woman will be produced before a magistrate for good behaviour bond under sec 107 of CrPC", sources said. (GNS)

Srinagar: Breastfeeding can help protect babies against some short and long-term illnesses and diseases and breastfeeding mothers have less chances of deadly diseases besides that breastfed babies have a lower risk of asthma, obesity, type 1 diabetes and sudden infant death syndrome (SIDS), said a senior paediatrician Dr Muzaffar Jan.

Dr Jan who is head of department of paediatrics Government Medical College Srinagar said that breastfeeding has no parallel and it is best for both mother and children as it helps in brain development of the baby.

"Babies who aren't breastfed often fall ill and the rate of exclusive breastfeeding is around 60 percent and we are making efforts to make it 100 percent." He said.

Mobile addiction of children affects their eyes besides that it creates weight problems and affects the holistic development of the children and gradually it affects their other things, he said adding that parents must involve their children in outdoor games and interact with them and minimize their screen time.

Dr Jan said that conferences help us in sharing knowledge and experiences and it will help in upgrading knowledge of our doctors which will help us in treatment of patients as well.

"As medicines keep on changing, we get updated about the latest medicines in such conferences which helps us in treatment of patients," he said. (KNO)

However, he said the job of the directorate of census is to dispatch the material to the concerned wards which has been completed in time. In Srinagar, the material had not been received by the staff in 15 segments, He said the position would become dear in a few days.

Official reports reaching here said the employees did not receive the material and did not take part in the operation. But officials in the divisional commissioner's office here claimed, that, employee turned up to collect the census material in Budgam. Anantnag and Kupwara districts. "The exact information from all over the Kashmir vallev is not known, especially in Srinagar", the officials said adding the director-of census has been summoned to obtain information

about progress of the operation. A PTI reporter who visited the directorate of census and other areas in the city found that out of 98 employees in Brain-Nishat in ward number one, only five employees turned up to

receive the material for the area. Two prominent government employees unions, State Employees Con¬ference and Employees and Workers Confederation had directed the staff not to endanger their lives by participating in the operation in view of militants' threat to

train their guns on those taking part in the exercise. Over 22,000 enumerators were trained to conduct the census, to be concluded on September 30, he said adding the first phase was undertaken from May 16 to June 5 this year. House listing with the civic and other amenities available at the household and locality levels was done during the first phase

which, however, went off without any problem.

An official handout issued here today said the divisional commissioner had a detailed discussion with the representatives of some employees' organisations and assured them the government would take all possible steps to ensure their security. The statement claimed the representatives informed the divisional commissioner that "they had neither issued any statement to boycott the census duty nor have intention to do so".

### India Issues Advisory Outlining Risks For Students Planning To Study Medicine In China

Beijing: India has issued a detailed advisory for prospective students wanting to study medicine in China, cautioning them of the pitfalls, including poor pass percentage, mandatory learning of official spoken language Putonghua and stringent norms to qualify to practise in India.

The advisory was issued as thousands of Indians studying in Chinese medical colleges are currently stuck at home for over two years due to Beijing's covid visa ban. According to official estimates, over 23,000 Indian students are currently enrolled in various Chinese universities. A vast majority of them are medical students.

After over two years of covid visa restrictions, China has recently started issuing visas to a select number of students to return. However, most of them struggled to return as there are no direct flights and the two countries are still in talks to work out limited flight facilities keeping in view Beijing's quarantine restrictions.

The Chinese medical colleges, meanwhile, began enrolment for new students from India and abroad.

Against this backdrop, the Indian Embassy in Beijing issued a comprehensive advisory on Thursday for students from India wanting to study medicine in China.

The advisory has results of the studies, which outlined difficulties faced by Indian students in China and the stringent norms they face to qualify

for practising medicine in India. A striking feature of the advisory is that only 16 per cent of the students passed the required test between 2015 and 2021 to qualify to practise in

Only 6,387 out of 40,417 students who appeared in FMG (Foreign Medical Graduate) Examination of the Medical Council of India (MCI) from 2015 to 2021 have cleared it.

The pass percentage of Indian students who have studied clinical medicine programmes in China in that period in 45 accredited universities was only 16 per cent, the advisory underlined.

"The prospective students and parents may please note this fact while deciding on seeking admission in Chinese universities for clinical medicine programme," it said.

On the costs, it said the fee structure is different for different universities and advised students to check from the university directly before taking admission.

The advisory listed 45 medical colleges designated by the Chinese government to provide medical degrees in five-year duration plus a one-year internship. Indian students are advised not to seek admission

other than in those 45 colleges. The Chinese government has "clearly mentioned in their official communication that foreign students can join medical programmes in only 45 universities in English language"

"They cannot join the clinical medicine programme in China which is offered in the Chinese language. They have also clearly stated that any university offering clinical medicine programmes in bilingual mode (English and Chinese language) is strictly forbidden," the advisory said.

London: King Charles III pledged to follow the "inspiring example" of his mother, late Queen Elizabeth II, as he was proclaimed Britain's new monarch on Saturday in a historic ceremony of the Accession Council that was televised for the first time in history.

"God save the King" were the words with which those gathered reaffirmed the proclamation made by the clerk of the council. Charles then made his proclamation speech, which began with the "most sorrowful duty" to announce the death of Queen Elizabeth II, "an example of lifelong love and selfless service."

"My mother's reign was unequalled in its dedication and its devotion. Even as we grieve we give thanks for this most faithful life," said King Charles III.

"In taking up these responsibilities I shall strive to follow the inspiring example I have been set in upholding constitutional government and to seek the peace, harmony and prosperity of the peoples of these islands, and of the Commonwealth realms and territories across the world," he said.

The throne had passed to the 73-year-old former Prince of Wales following the death of his mother, Oueen Elizabeth II, on Thursday and Saturday's ceremony marked his formal declaration and oath taking at St James's Palace in London.

King Charles was joined by his wife, Queen Consort Camilla, and his son and heir Prince William - the new Prince of Wales, who added their signatures to the formal proclamation documents.

Charles confirmed the tradition of surrendering all revenues and the Crown Estate to the country in return for the Sovereign Grant that covers royal costs in

The King had travelled back from Balmoral Castle in Scotland on Friday, where the Queen's health deteriorated and she breathed her last.

Flags lowered atop the palace



in mourning for the late Oueen were brought back up to full mast after the Accession Council proclamation, which followed a wave of further proclamations across the UK to go into Sunday - when flags will return to half-mast in a state of mourning for the Queen.

King Charles III Proclaimed Britain's Monarch In

**Historic Ceremony** 

"As the Queen herself did with such unswerving devotion, I too now solemnly pledge myself, throughout the remaining time God grants me, to uphold the constitutional principles at the heart of our nation," Charles said in his first televised address as King on Friday evening.

"And to my darling Mama, as you begin your last great journey to join my dear late Papa, I want simply to say this: thank you. Thank you for your love and devotion to our family and to the family of nations you have served so diligently all these years. May 'flights of Angels sing thee to thy rest'," he said.

Soon after a Principal Proclamation was read in public for the first time by the Garter King of Arms from the balcony overlooking Friary Court at St James's Palace, accompanied by a 41-gun salute fired by The King's Troop Royal Horse Artillery at Hyde Park in London.

The Privy Council, which includes politicians, senior members of the clergy and Supreme Court justices, first gathered without the King to proclaim the new monarch and arrange business relating to the proclamation.

Following the proclamation, King Charles III held his first Privv Council meeting and made his personal declaration to "assume the duties and responsibilities of sovereignty" and follow in the footsteps of his late mother.

On Friday, the King held his first audience with British Prime Minister Liz Truss at Buckingham Palace, soon after he was greeted with applause and cheers by large crowds gathered at the palace gates in mourning for the Queen and to catch a glimpse of the new monarch and his Queen Consort.

"It was so touching to see so many people... It's a moment I'd been dreading, but one must try and keep going," Charles was heard saying to Truss, in a brief clip released of his first audience as the Prime Minister expressed her condolences.

While formal details are to be released by Buckingham Palace, it is expected that the Queen will lie in state at Westminster Hall in London for the public to pay their respects.

In the coming days, the Queen's coffin will depart her Balmoral estate for the Palace of Holyroodhouse in Edinburgh – the official residence of the British monarch in Scotland.

From here, it will be taken in procession to St. Giles' Cathedral in the city, where the Queen will lie at rest, allowing the public to view her coffin. The coffin will then move to London, ready for lying in state for around four days before her funeral.

### Will Be More "Dangerous" If Jailed, Warns Imran Khan On Terror Charges

Islamabad: Pakistan Tehreek-e-Insaf (PTI) Chief Imran Khan on Thursday threatened that he would become more dangerous if sent to jail while expressing displeasure over the heavy deployment of police outside the Islamabad High Court during the hearing of a terrorism case filed against him.

PTI chief has been booked in a terrorism case on the complaint of Islamabad Saddar Magistrate Ali Javed for threatening a female judge of the federal capital, during the rally held on August 20.

Khan on Thursday arrived at the Islamabad High Court (IHC) amid tight security. Hundreds of security personnel had been deployed at the court since noon, The News International reported.

Before Imran left his Banigala residence, several PTI leaders arrived at the court, but security officials stopped Fawad Chaudhry, Shehzad Waseem and others as their names were not found on the list provided by the Registrar's Office.

Speaking to reporters, Imran expressed displeasure over the heavy deployment of police and other law enforcement agencies at the court. He wondered who the authorities feared, as they had deployed a heavy contingent of police outside the IHC.

Imran refused to speak more, saying his comments might be misconstrued by the court and said that he will speak after attending the hearing, The News International reported.

Talking to the media persons after the court decided to indict him in the contempt of court case, Imran told reporters that he wanted to contextualise his statement in the court regarding the woman judge but was not given the opportunity to do so.

"Every statement has a context. The country is regressing day by day, and the International Monetary Fund (IMF) report has shown it. They can do whatever they want, but the only solution to the instability is fresh elections," he added.

Imran said he did not victimise any of his opponents in his tenure adding there were some cases that were mishandled, but he came to know about them afterwards. The PTI chief rejected speculations about backdoor contacts with some 'important' figures, The News International reported.

Each year, a huge crowd of people flocks to Karbala, where the holy shrine of Imam Hussein (AS) is located, to perform mourning rituals.

This year Arbaeen falls on September 17. Before the outbreak of coronavirus, some 2 to 3 million Iranians attended annually in the

Arbaeen march. However, last year, the rituals were held virtually to avoid the transmission of the disease.

### 19 Dead In Maharashtra During **Immersion Of Ganesh Idols** valkar, was seriously injured in

t least 20 persons died, 14 of them due to drowning, in various incidents that occurred during the immersion of Ganesh idols in parts of Maharashtra, police said on Saturday.

The 10-day Ganesh festival, which had started on August 31, ended on Friday.

In Wardha district three persons drowned at Sawangi, while another one drowned at Devli, an official said. Two persons drowned in a pond in Yavatmal district when they went for immersion of idols, he said. In Ahmednagar district, two persons died of drowning in separate incidents at Supa and Belvandi, he said, adding that two others died in Jalgaon district of north Maharashtra.

One each died in Pune's rural part, Dhule, Satara and Solapur city, he said.

Four persons died in a road accident at Sakkardara area of Nagpur city during Ganesh immersion, he said.

In Thane, a 55-year-old woman was killed and four others injured after a tree collapsed on a Ganesh pandal in Kolbad area amid rains. The incident occurred on Friday night, a civic official said.

"A huge tree fell on the pandal while the aarti of the Lord Ganesh was going on as part of the immersion of the idol. The woman, Rajashri Wala-

Meanwhile, at least 11 persons, including a nine-year-old girl, were injured after suffering an electric shock at Panvel in Raigad district during a procession. **SRINAGAR:** Of total teachers posted at government-runschools of Jammu and Kashmir, at least 73 percent of educators were only teaching the Primary and Upper Primary Level students, reveals official figures.

It was leant that at least 37 percent of educators were teaching the Primary Level stu-

Besides, it also states that over 36 percent of the teachers were teaching the students of Upper Primary Level only.

According to the figures maintained by Unified District Information System for Education (UDISE), there were a total of 1,016,72 teachers in School Education Department across Jammu and Kashmir out of Upper Primary and Secondary which at least 38,300 teachers level respectively—(KNO)

were posted at Primary Level only followed by 36,908 at Upper Primary Level.

UDISE has also maintained that only 15,570 teachers were teaching the secondary level students in Jammu and Kashmir.

Likewise, the figures also reveal that only over seven percent of teachers were posted at senior secondary level. "At this stage, only 7839 teachers were teaching the students."

### Shades of Persia

rt and craft practices in Kashmir are not only markers but also the result of political, cultural, and artistic exchanges with erstwhile Persia and beyond. Over the past few centuries, these crafts have absorbed local tradition, resulting in a visual vocabulary that is Kashmir's own

The third generation of the handicrafts dynasty of Suffering Moses, Muzaffar Sadiq's familial history is a case in point. He recounts that his ancestors were brought from modern-day Iran to the Kashmir Valley at the mandate of the 13th century Muslim saint-reformer Shah-i-Hamdan and then the 15th century emperor known as Badshah (Sultan Zain-ul-Abidin) to teach the locals the finer handicrafts of papier-mâché and wood carving

Along with similarities in the linguistics, architecture, literature, art, cuisine, and the cultural traditions, the sartorial resemblance with Iran is also prominent.

"It is for these and other cultural influences that Kashmir is often termed as the Iran-e-Saghir in the academic parlance," states Prof. Mushtaq A. Kaw, Former Director, Centre of Central Asian Studies and Dean College Development Council, University of Kashmir.

"The Kashmiri dress has the Afghan, Bukharan and Iranian influence. However, it is distinguishable by needle, stitch or embroidery works of various sorts, motif and floral designs."

Traditionally, the kurta-salwar, made of wool, cotton and silk, resembling an Afghani Khan dress, layered with a woollen-cotton made pheran, going from the neck down to the knees, besides a Kashmiri pashmina or tus shawl spread over the shoulders and a skull-cap constituted the men's dress

the shoulders and a skull-cap constituted the men's dress.

For women, it was salwar-kameez made of wool, cotton and silk, designed with intricate embroideries, donned with a woollen-cotton made pheran, besides a dupatta or head-scarf called kasaba in Kashmiri, and a pashmina or tus shawl worn over the shoulders, notes Prof. Kaw.

Besides giving warmth, the pheran is roomy enough for the kangri, a winter essential, which generates additional heat to the body against chilly winters.

Sadiq points that the 8-9 months long extreme winter isn't the only natural influence on Kashmir's clothing traditions; the motifs used by karigars in papier-mâché and wood-carving as well as on textiles borrow heavily from the valley's biotic elements.

Along with the omnipresent paisley, gulaab (rose), pamposh (lotus), the kingfishers of the Dal Lake, and the Chinar leaves are some of the most recognisable motifs embroidered on Kashmiri clothing.

The founder of design house Raffughar, Wajahat Rather, notes how some artisans would refer to a certain colour scheme as 'harud', meaning 'autumn' in Kashmiri, indicating "how they follow and harmonise colours by looking at nature. They never get it wrong".

The climatic conditions in Kashmir also dictated the fabrics that were predominantly produced locally. While cotton cultivation was not productive due to its poor yield, extensive green regions provided an adequate grazing ground to sheep. As a result, wool was produced in a much larger ratio.

Beside this, there were abundant mulberry trees in the areas of Kishtwar whereupon silk worms were raised upon the mulberry tree's leaves. Presently, the majority of the fabrics used in Kashmir are made in mills, imported from different parts of India, as well as outside the country.

The luxurious and super-fine pashmina, raffel, and silk, however, continue to act as canvases for the painstaking embroidery practiced by Kashmiri karigars such as kashida, sozni, kani, and aari, among others.

One of these embroidery forms now coveted world over is the exquisite and exclusive tilla embroidery done on pherans using gold and silver metallic threads, a wedding trousseau essential for every Kashmiri Muslim bride.

However, Gulzar notes that tilla is now getting a contemporary spin for everyday wear. "5 out of 10 clients are asking for tilla embroidery nowadays, be it in their stoles, scarves, or kurtis in silk, georgette, crepe, or velvet," he says.

Gulzar also notes that an increasing share of his local clientele now opts for made-to-measure clothing in traditional textiles but contemporary silhouettes over readymade ensembles

Designer and stylist Shahid Rashid Bhat, whose designs are heavily informed by Kashmir's nature and its rich artistic history, agrees that contemporisation is key in order to sustain certain embroidery and clothing traditions of Kashmir.

He, too, observes that "the youth of Kashmir wants to amalgamate the old and the new. They want to flaunt Kashmiri traditions, but with a contemporary twist."

From using traditional embroidery outside shawls and the salwar kameez to rethinking the silhouette of the pheran for the modern clientele, there are multiple innovative design opportunities that contemporary Kashmiri designers are now exploring, albeit on the foundation of its perdurable artisanry.

For Wajahat Rather, the traditional pheran itself championed modern sartorial trends like sustainability, zero-waste, androgynous designs, and relaxed fits. "Even though this vocabulary was not there, pheran was all this, even when the fashion world wasn't talking about it," he says.

He also goes back to the pheran as well as the enduring embroidery forms of Kashmir for his collections with an effort to innovate them.

Both Rather and Bhat echo that even in the face of rampant mechanisation and replication in the handicrafts industry, the intricacy, quality, and durability of embroideries and art forms done by hand will continue to remain inimitable and coveted around the world. "Kashmiri handmade fabric has been sustaining despite the Industrial Revolution in the past and free market economy in the present," observes Prof. Kaw.

### Former Top Cop's Kashmir Chronicle

Late cop-governor Ved Marwah's 12-year-old book, "India in Turmoil", makes more sense than generic garbled opinions on Kashmir; however, a lot is left to be read in between the lines.

ne can imagine top cop and former governor Ved Marwah as a schoolboy in Peshawar during 1947. He must've been 13 years old when he saw the long convoys of trucks carrying Pathans from tribal areas of Pakistan. They were raising weapons in the air, vowing liberation of Kashmir. These people were revered by the government as was even apparent to his adolescent self, he claims.

He records such observations in the book, 'India in Turmoil'. It's the kind of hardcover you would rarely expect on the shelves of a quaint café situated thousands of kilometres away from Kashmir. I got my hands on this 2009 edition — a commentary on shortcomings of decision-making and internal security threats to India — at a coffee shop in Pune.

The intention of picking it up was simple: I wanted to know how Marwah, spent his child-hood in Pakistan, has observed the security issues of India (especially Kashmir), left-extremism and the quest for a solution.

Marwah does not mince words while describing India's posture in the introduction. He labels India a soft state where the rule of law is often shuttled around in vote-bank politics. He writes, "All pervasive corruption is eating into the vitals of the Indian state. In public perception, most, if not everyone, politics and administration are corrupt. Corruption flows from top to bottom, and one sees new acceptability to blatant corruption at the highest echelons in administration."

Concerning Kashmir, which comprises 100odd pages, the ex-cop laments the growing ineffectiveness of the government. He has described the chronology of problems through decades concisely.

He begins with Hari Singh "being cornered" into signing the Instrument of Accession, so that army could be sent to Srinagar in response to the "liberation army" from Pakistan. India then handed over the reins of Kashmir to Sheikh Abdullah, who demanded autonomy much to the horror of Jawaharlal Nehru, who wanted his "friend" on board to validate his secularistic stance.

Abdullah's arrest, Marwah says, incited the separatist movement and then on, birthed many internal issues and carnages.


In the solution section of the book, Marwah perhaps has said the most sensible thing anybody has in a while.

While rebuking division of Kashmir on any lines (he heavily criticises the proposal of seven regions based on ethnic lines), he states that New Delhi "should not interfere". Only if the governments over the decade had heard its worker bees!

Despite such laudable assertions, Marwah's account of Kashmir comes with its own set of problems.


The narrative lacks editorial deftness — a

lot is left for the reader to guess. For instance, while talking about the Hari Singh phase, the



ex-cop completely omits the Maharaja's intentions while acceding to accession. They've been perhaps best laid by Journalist KS Komireddi in his "Malevolent Republic: A Short History of the New India". He states, "He (Singh), anxious to keep the Muslim socialist out of power, insisted on retaining some of his royal prerogatives."

Moreover, Marwah — in his black-andwhite style of saying things — has employed the word Jihad in its most negative connotation, despite several researchers and linguists demanding decorum while using ambiguous



words (The Cambridge Companion to New Religious Movements states that Jihad is "a hard term to define").

Also, Marwah's nonchalant reference to Kashmir's sovereignty as a "mere theory" back in 1947 (which, he says, eventually escalated) impinges the narrative flow. His objective telling of events fails to capture the complexity of the sentiment that has become a genetic code of sorts.

The emotion was rife even during the Partition, as was described by American journalist Margaret Bourke-White, who was in Kashmir during that momentous time. She detailed the territory as "heaped with rubble and blackened with fire". Locals were mourning the martyrdom of a local leader, thus being far from the idea of ascension and closer to the notion of freedom and autonomy.

Further, the objectiveness derails in between when Marwah revers India. He claims that India had rejected the Two-Nation theory and still hopes that Hindu and Muslims will live in harmony on the land. The naïve thought is slightly outlandish since he chose to write it down after major communally violent milestones — Babri, Godhra, etc.

The flaws aside, the concise history is readable, but under supervision. With an inherent sense of responsibility missing among social media patrons, who feel Kashmir is inscrutably infested with violent ideas (a garish failure of mainstream media for having carved it in their minds), it has become all the more important to guard the sanctity of the subject.

I find myself going back to the initial thought: What was this book doing on a quaint café's shelf? Who put it there? From the copy in my hand, it could be safe to assume that the previous reader was interested in a few paragraphs. If any of those were read out of context, the picture would be different.

t's so disappointing to see how some vocal Muslim women are demanding equality at the cost of their true stature. I don't disregard advocating feminism, but I sincerely wonder over some icon choices.

### Kashmir's Aerospace Girl

■aiga Anbreen is an aerospace engineer pursuing doctorate in Engineering and Math-ematics in United States. As a young girl fascinated by physics and mathematics, she made up her mind to be "among stars" after watching televised crash of the celebrated Indian astronaut's space shuttle. Faiqa's resolve to make a name in a male-dominated profession has already made her an inspiration for many youngsters back home.

In a candid chat with Kashmir Observer, the aerospace girl talks about her passion and profession.

### **PLEASE TELL US SOMETHING ABOUT** YOUR CURRENT PROFESSIONAL **ENGAGEMENTS AND YOUR ACADEMIC JOURNEY?**

Well, I'm a Ph.D. student in aerospace engineering and computational mathematics at California State University and Claremont Graduate University. I also work for Safran as a proposal engineer.

Safran is an international hightechnology company catering to aviation, space and defense markets.

I did my initial schooling from Sheikh-ul-Alam Islamic Model (SIM) School, Charari Sharief and later on joined Delhi Public School (DPS), Srinagar where I passed my Senior Secondary School Examination.

Both these schools had a constructive role in shaping up who I am today. SIM offered a decent environment to be able to ask questions but DPS offered more resources and a platform to develop a multi-dimen-

sional personality.

Later on, I started my career at Amity University where I finished Bachelors in Aerospace Engineering, and then I came to US for Masters at California State University.

### **AEROSPACE IS ONE OF THE TOUGHEST ENGINEERING STREAMS, HOW DID YOU GET INTO IT?**

As a curious child, when someone used to ask me about my career goals, my response would be "a scientist".

When you start learning about great scientists like Isaac Newton and Albert Einstein, it gets quite fascinating to know how they came up with such complicated laws and equations. Only with time, one realizes that it takes an enormous effort and dedication to be a scientist.

I've always been interested in reading about planets, stars, and creation of the universe and would ask teachers questions to which sometimes they wouldn't even have

In 2003, I watched space shuttle Columbia disintegrating on re-entry into the earth's atmosphere. Returning from a snace mission it took need cious lives of six astronauts. It may sound counterintuitive that a disaster helped me shape up an idea in my head that I want to become an aerospace engineer.

Kalpana Chawla, the first Indian



astronaut, got killed in that accident. Reading her biography has always been exciting. What she studied and how she reached NASA always intrigued me. It was this event that in some way helped me to decide and pursue Aerospace Engineering as a career choice.

But now, all the research I am doing is more motivated by working on something that furthers the aerospace technology and solve some of the unexplored problems of computational fluid dynamics.

### THROUGHOUT YOUR ACADEMIC JOURNEY, WHAT KEPT YOU MOTIVATED, FOCUSED AND ENERGIZED TO KEEP GOING?

I feel as humans, we continue to keep finding the meaning of life. There's a curiosity and inquisition that keeps pushing you to know more about this universe and existence. And I consider science feeds to that curiosity within me.

Aerospace is all about physics and mathematics. Those things keep me interested and motivated.

I still sometimes go back to read Class 9 Physics textbook, where we start understanding physics at a detailed level. Physics is at the heart of the whole universe. The manifestations of the subject amaze me, from the order of the universe to the music; it keeps me glued to what I'm studying and what I want to do in

Besides, I have always tried to be well-balanced in everything I do.

### **DATA SHOWS THAT THERE AREN'T MANY WOMEN IN THIS AREA. SO HOW DOES IT FEEL TO CREATE A NICHE IN A MALE-DOMINANT FIELD?**

Taking up aerospace engineering after Class 12 was like jumping into a dark well. I didn't know anyone in this field I could consult, I hadn't checked any statistics. All I was doing was following my instincts and believing in myself. I always focused on the work rather than the difficulties and

Now when I look at the number of women in aerospace, I have had situations where I have been the only woman in a group of male engineers doing projects or working with them. This not only inspires me in many ways but also makes me realize that we should have more women in

When I look back, I don't see many precedents among women to follow from Kashmir but I think there are a lot in the coming generation who have demonstrated enormous interest in the field who look up to me as a precedent. And I try my best to pass on my experiences to whoever approaches me.

### **KNOWING YOURSELF IS THE BEGINNING** OF ALL WISDOM. WHAT'VE YOU LEARNED **ABOUT YOURSELF IN THIS JOURNEY?**

It's certain that we live life forwards but it's amusing that we learn and understand about life backwards.

When we look back at the phases of life we have lived, the reflections of those become the steps of the staircase of experiences we climb on, towards more meaningfulness. It has been a natural progression towards learning about sensitivities and human biases, only after being exposed by living on my own in foreign lands from the last 11 years.

The most important learning that I would like to share is being open to criticism and thank your critics for they are the people who help you in becoming better and bigger.

Taking criticism is very hard and people usually get offended by it, but for me, I've only realized how important feedback is for personal as well as professional growth.

Also, we are unknowingly wrapped up in a number of biases and the whole struggle is to take yourself out of them one by one.

I see life in pieces. For a mome I live in those small pieces. And it's only when you look back, you're able to see what the journey was about.

The work I have done so far is just the stepping stone, but to go to space one day I have a thousand miles to go. For now, it looks like a distant dream, but I will keep dreaming.

### WHAT'S THE BIGGEST CHALLENGE YOU'VE FACED AS A WOMAN IN

It's very important to have good self-esteem and to keep reminding yourself that you're not alone, and there're other women out there in diverse fields. You've to keep feeling it and be confident that you can

### HOW LONG WILL IT TAKE FOR THE **AEROSPACE INDUSTRY TO RECOVER** FROM THE IMPACTS OF COVID-19?

As per the estimates by the aircraft manufacturing giants Airbus and Boeing, the aerospace industry is expected to recover by 2023.

Already, the pandemic has impacted the aerospace industry very badly. We are seeing grounding of fleets, thousands of planes that should be in the sky are lying on the tarmac. There is the cancellation of orders of new planes, slashing down of expected aircraft deliveries for this year, and retiring of old fleets like Boeing767.

Also, airlines around the globe are seeking help from the governments to avoid a potential collapse. The number of aircrafts in passenger service fell by more than 60 percent from the start of the year. It will take time to bring the production rate back to what should have been now.

### ANY WORD FOR PEOPLE BACK HOME?

### In a NUTSHELL: Festive Fall in Kashmir

The walnut season starts every autumn and engages growers across the valley for the organic harvest. But the fear of fatal falls has paled some of these celebrations now.

th the arrival of autumn in Kashmir, Zameer Qadir gets eager for the 'labour of love'. By that time of year, dozens of his walnut trees in his hometown Harwan Srinagar bear the organic fruit. The harvest seaof his community members. But this year, the fear of fatal fall from trees has made it a somber season for his grower clan.

In the face of these deaths termed "occupational hazards", many are batting for adopting scientific methods to sustain the industry spread over 89,000 hectares of land in Jammu and Kashmir. With an export commodity Collected in wicker baskets, the walnuts then worth Rs 120 crore a year, walnuts constitute almost 98 per cent of the annual dry fruit in Kashmir.

But even though the seasonal casualties have casted their shadow on the harvest season, Qadir and clan are going traditional about it. The harvest cycle starts with the tree climbing. The grower plucks the walnuts by either shaking or striking the nut-laden branches. during the cleaning process. Some strike the tree with stick from the ensures maximum produce without much

damage to the tree. But this is where the entire process has bea wicker basket. "The very eagerness to relish the market.

these fresh nuts often leaves hennaed stains on one's hands and lips," Qadir says. "They're being relished for their rich taste and con-

But for the larger commercial purposes, the growers skin their green shell shortly after plucking. The process, Qadir says, is painstaking — testing the very patience of the grower son sends out festive vibes and engages most class. However, like in everything else in Kashmir life, the female folk remain at the forefront of this process as well.

"They make the job much easier for us," Qadir asserts. "They're best in separating chaff from grains - given their regular household habits." Once skinned, walnuts are taken out from the green stack and assemble separately. pass through the cleaning process at the fresh water stream. The growers huddle around the baskets to ensure the meticulous cleaning.
But the 'hard-nut-to-crack' leaves greasy

strains behind, and thus makes the entire cleaning process quite an arduous task for the growers. However, to avoid staining, the walnut growers wear a fresh pair of footwear

Once done with washing, the growers seep ground itself-but climbing, as Qadir explains, out water through porous basket base and take the harvest ashore. A basketful of washed walnuts are then taken out from the banks for the next step.

### **Antibiotic Resistance Can Take The Form Of A Pandemic In Future**

Sustained rise in antimicrobial resistance in India: ICMR study

big chunk of patients in India may no longer benefit from carbapenem, a powerful antibiotic administered mainly ■in ICU settings to treat pneumonia and septicemia, as they have developed antimicrobial resistance to it, an ICMR study has found.

The data analysis done between January 1 and December 31, 2021 pointed towards a sustained increase in drug-resistant pathogens, resulting in difficulty to treat certain infections with available medicines, senior Indian Council of Medical Research (ICMR) scientist Dr Kamini Walia, who led the study, said.

"Antibiotic resistance has the potential of taking the form of a pandemic in the near future if corrective measures are not taken immediately," she said.

The ICMR study report was released on Friday. The data collected from the network has enabled compilation of drug resistance data on six pathogenic groups on antimicrobial resistance from the country.

Data collected from the network is used to track resistance trends and to better understand mechanisms of resistance in the key priority pathogens using genotypic characterisation and whole genome sequencing (WGS).

This is the fifth detailed report on antimicrobial resistance (AMR) trends and patterns from the country published by the ICMR. This year's report also carries hospital-acquired surveillance data.

According to the ICMR report, resistance to Imipenem, which is used to treat infections caused by bacteria E coli, has increased from 14 per cent in 2016 to 36 per cent in 2021.

The trend of decreasing susceptibility of bacteria to specific antibiotics was also observed with Klebsiella pneumoniae as it came down from 65 per cent in 2016 to 45 per cent in 2020 and 43 per cent in 2021.

The susceptibility term here is used to describe



the vulnerability of the bacteria to the antibiotic.

Carbapenem resistance isolates of E coli and K pneumoniae are also resistant to other antimicrobials making it very challenging to treat carbapenem-resistant infections.

The resistance to broad-spectrum antibiotic carbapenem in respect to infections caused by Acinetobacter baumannii bacteria was recorded in 87.5 per cent of the patients who were part of the study, limiting the availability of treatment options, the ICMR report said.

Susceptibility of the same bacteria to minocycline is close to 50 per cent, making it the most susceptible antibiotic after colistin for Acinetobacter baumannii, it stated.

In Pseudomonas aeruginosa, another bacteria which causes infections in the blood, lungs (pneumonia), or other parts of the body after surgery, there is a consistent increase in susceptibility to all the major antipseudomonal drugs in the last few years, Dr Walia said.

"There is a need to strengthen and improve diagnostic labs to promote rational use of antibiotics. Antimicrobial prescriptions should be based on definitive diagnosis and not on presumptive diagnosis. Several broad-spectrum antimicrobials are being used for syndrome management," Dr

"The resistance level is increasing to 5 to 10 per cent every year for broad-spectrum antimicrobials which are highly misused. With no new antimicrobials in the pipeline to treat drug-resistant infections, it is very important that we use judiciously what we have. There is also increasing levels of resistance of antifungals. Previously not many labs were doing fungal cultures and antifungal suscep-

"The ICMR AMR network has developed this

over the last few years and now many labs are reporting antifungal susceptibility rates giving an idea on antifungal resistance rates. The use of antifungals was particularly high during the Covid pandemic," she said.

According to the ICMR report, in Staphylococcus aureus, which causes a wide variety of clinical diseases such as skin infections like abscesses and boils and sometimes pneumonia, endocarditis and osteomyelitis, susceptibility to erythromycin, clindamycin, ciprofloxacin, co-trimoxazole and high-level mupirocin was more evident in MSSA (Methicillin-Sensitive Staphylococcus Aureus) when compared to multi-drug resistant strains such as MRSA (Methicillin-Resistant Staphylococcus aureus).

MRSA rates are increasing each year from 2016 to 2021 (28.4 per cent to 42.6 per cent). Enterococci is another important pathogen which is quickly evolving and drug susceptibility has changed considerably in the last few years.

Several fungal pathogens like C. parapsilosis and C. glabrata are showing increasing resistance to commonly available antifungal medicines such as fluconazole, thus requiring close monitoring in the next few years.

Among diarrheal pathogens like Diarrheagenic E. coli, Shigella spp. and Salmonella that cause large proportions of diarrhoea cases in India, norfloxacin susceptibility was very poor. Empirical use of norfloxacin for the treatment of bacterial diarhhoea is strongly discouraged, Dr Walia said.

There has been no significant change in the overall antimicrobial susceptibility pattern of Salmonella Typhi or S Paratyphi A from India with the pattern remaining uniform across all the participating centres in the AMR network.

S. Typhi is 100 per cent susceptible to cephalosporins and azithromycin. Other drugs which retained good susceptibility for Salmonella Typhi or S. Paratyphi A are ampicillin, chloramphenicol and trimethoprim-sulfamethoxazole.

### **India's Rice Exports May Fall By 40-50 Lakh Tonnes Post Ban** On Broken Rice, 20% Duty

NEW DELHI: India's rice exports could fall by 4-5 million tonnes (MT) this fiscal year due to the ban on broken rice as well as export duty on non-basmati rice, except for parboiled grains, exporters said.

India, which commands 40% share in the global rice trade, exported 21.23 MT of rice in 2021-22 fiscal as against 17.78 MT in the previous year. Before exports were at 9.51 MT in the 2019-20 fiscal.

During April-August period of the current financial year, government data, showed that the country had already exported 9.35 MT as against 8.36 MT in the year-earlier period.

### **EU Nations Struggle To Find Joint Approach On Energy Prices As Russia Chokes Off Supplies**

**BRUSSELS:** European Union nations struggled to find common ground Friday on ways to shield the population from dramatically increasing energy prices that threaten to plunge millions into cold and poverty over the winter as Russia chokes off natural gas supplies.

As tensions with Moscow mount over the war in Ukraine, the energy ministers of the EU's 27 nations could not paper over differences on whether and how to impose a price cap on Russian natural gas, with ever-recalcitrant Hungary refusing to agree, saying it would go against its supply inter- and united," Sikela said. ests. Other countries differed on whether a price cap should apply only to Russia or to other produc-

An immediate solution had not been anticipated at Friday's meeting, but it indicated how Moscow's gas restrictions and threat of a full cutoff has dominated the political agenda of a rich bloc of nations struggling to ensure basic services like heat and light. "Russia has used its gas supplies as a weapon to foster an energy crisis next winter but also to weaken our economies and divide, politically, the European Union," EU Energy Commissioner Kadri Simson said.

"We have to ensure that their efforts will fail." Czech Industry Minister Jozef Sikela, chair of the month. emergency meeting, exhorted his colleagues: "We cannot be blackmailed."

He hoped to overcome other differing views on proposals to bring natural gas and electricity prices back to affordability.

The measures range from windfall levies on oil and gas companies whose profits have risen along with skyrocketing prices to boosting cash for companies to keep operating as they struggle with volatile energy markets.

### **Flood Losses Likely To Slash Pakistan's GDP**

**ISLAMABAD-** The massive losses from the catastrophic monsoon rains and floods in Pakistan, the war in Ukraine and other factors may force it to slash its GDP growth rate for the financial year 2022-2023 from five per cent to three per cent, according to media reports on Saturday.

Chairman of the National Flood Response and Coordination Centre (NFRCC), Major General Zafar Iqbal, during the joint briefing for Prime Minister Shehbaz Sharif and UN Secretary-General Antonio Guterres, said that at least one-third of Pakistan was inundated, while the overall damages would amount to over USD 30 billion.

The state-run Associated Press of Pakistan news agency quoted Iqbal as saying that Pakistan expected a two per cent cut in the Gross Domestic Product growth figure due to a combination of crises, chief among which were the floods, the delayed approval of IMF funds, and the economic situation emerging in the wake of the Russia-Ukraine war.

### **HC Dismisses Plea To Change Date For UPSC, FSSAI exams**

New Delhi: The Delhi High Court has dismissed a plea for a change in the examination date either for the Civil Services (Mains) or for FSSAI recruitment, both scheduled on September 24, saying doing so at this belated stage will cause grave inconvenience and prejudice to other candidates.

The petitioner submitted that he has worked hard for the examinations and was desirous of appearing in both. If the date for one of the two examinations is not changed, he will have to forego the opportunity to appear in one of them.

The high court said that even though the petitioner may be justified in urging that on account of the date of both the examinations being the same, he will have to forgo the opportunity to appear in one of them, it cannot be a ground for directing any change in the date of the exams.

Even otherwise, the date of September 24, 2022 for the Civil Services (Mains) examinations was announced at least two months ago and similarly the date for the examination for the post of Technical Officer and Central Food Safety Officer was made known to the candidates more than a month ago.

There is no justification by the petitioner in approaching the court at this belated stage with barely three weeks left for the examinations when all arrangements for holding the examinations in a large number of centres all across the country have already been made by the respondents, Justice Rekha Palli said in an order passed on September 2.

The high court said the authorities are justified in contending that any change in the date of examination at this belated stage will cause grave inconvenience and prejudice to the candidates as well.

The petitioner will, therefore, have to make a choice as to which of the two examinations he wishes to appear, it said, adding that there was no merit in the petition and dismissed it.

In his plea, the petitioner claimed to be a candidate for the Civil Services (Mains) Examination to be conducted by the Union Public Service Commission on September 24 as also for the examination for the post of Central Food Safety Officer and Technical Officer to be conducted by Food Safety and Standards Authority of India (FSSAI) on the same date.

He said either of the two authorities should be directed to change the date of the examinations to enable him to appear in both of them. The counsel for the authorities opposed the plea, contending that all arrangements for the smooth conduct of the examinations at various centres across the country have already been made and any change in the date of examinations will lead to total administrative chaos

### India's Eastern-Most Military Garrison Of Kibithu Named After Gen Bipin Rawat

Kibithu (Arunachal Pradesh): The strategically key Kibithu military garrison on the banks of Lohit Valley along the Line of Actual Control and a key road in this mountain hamlet were on Saturday named after India's first Chief of Defence Staff Gen Bipin Rawat, around nine months after he died in a helicopter crash.

As a young Colonel, Rawat commanded his Battalion 5/11 Gorkha Rifles at Kibithu from 1999-2000 and contributed immensely to strengthening the security structure in the area.

The military garrison looks after the Line of Actual Control (LAC) in the sensitive sector. Chinese People's Liberation Army's Rima post is just opposite the Indian garrison.

Nestled in the mountainous and arduous terrain of the Lohit Valley, Kibithu is located near the LAC and is the eastern-most military garrison of India.

The small hamlet is inhabited by Meyor and Jarkin tribes. Lack of surface connectivity with the nearest road head at Meshai precluded movement to Kibithu which was air maintained till as late as 1997. A foot suspension bridge (FSB 17)

was the sole link to the eastern

bank of the Lohit River.

The garrison and the 22 km-long road stretch from Walong to Kibithu were named after Gen Rawat at a ceremony attended by Governor of Arunachal Pradesh Brigadier (retd) BD Mishra, Chief Minister Pema Khandu, Eastern Army Commander Lt Gen Rana Pratap Kalita and Gen Rawat's daughter Tarini.

Speaking on the occasion, Chief Minister Khandu announced a financial package of Rs 10 crore to make the garrison one of the best military stations in forward locations.

Governor Mishra said Gen Rawat's contributions strengthening the country's defence structures are unparalleled.

The Kibithu military camp was renamed Gen Bipin Rawat Military Garrison wherein a grand gate built in local traditional architectural style was inaugurated by the governor.

The 22 km road stretch from Walong to Kibithu was dedicated as Gen Bipin Rawat Marg by Chief Minister Khandu.

A majestic life-size mural of Gen Rawat was also unveiled. Gen Rawat was killed in a helicopter crash near Coonoor in Tamil Nadu on December 8

last year along with his wife Madhulika and 12 armed

forces personnel.

Bad weather leading to a phenomenon called Controlled Flight Into Terrain (CFIT) was identified as the prime reason for the crash of the IAF helicopter.

Rawat was posthumously conferred India's secondhighest civilian honour Padma Vibhushan early this year.

The Army said Gen Rawat's vision and foresight were instrumental in implementing the infrastructural development and ensuring societal progress in the area. "Gen Bipin Rawat's untimely

demise in December 2021 left an irreplaceable void in the country," the Army said.

The event was attended by citizens of Kibithu and Walong.

The garrison is considered very important for its strategic location. Kibithu was first occupied by 2 Assam Rifles in December 1950 with one platoon. In 1959, the post was further strengthened with an additional Platoon.

Kibithu endured the initial onslaught of Chinese aggression during the 1962 Sino-India War.

On the termination of the War, Kibithu was reoccupied by 2 Assam Rifles in 1964. In 1985, 6 Rajput took over its

### **Indian Sikh Man Separated From His Family During Partition Meets His Pakistani Muslim Sister In Kartarpur**

Islamabad: Jalandhar-based Sikh man Amarjit Singh's happiness knew no bounds when he met his Muslim sister from Pakistan at Gurdwara Darbar Sahib in Kartarpur, 75 years after he was separated from his family at the time of Partition.

Singh was left out in India along with his sister while his Muslim parents migrated to Pakistan at the time of Partition.

All eyes went teary as wheelchair-bound Singh had an emotional meeting with his sister Kulsoom Akhtar at Gurdwara Darbar Sahib in Kartarpur in Pakistan's Punjab province on Wednesday.

Singh arrived in Pakistan via the Wagah border with a visa to meet his sister, The Express Tribune newspaper reported.

Kulsoom, 65, could not control her emotions after seeing Singh. Both hugged each other and kept crying. She had travelled from her hometown in Faisalabad along with her son Shahzad Ahmed and other family members to meet her brother. Talking to the newspaper,

Kulsoom said that her parents migrated to Pakistan from a suburb in Jalandhar in 1947, leaving behind her brother and a sister. Kulsoom said she was born in

Pakistan and used to hear about

her lost brother and sister from her mother. She said that her mother used to cry whenever she remembered her missing children.

She said that she did not expect that she would ever be able to meet her brother and sister. However, a few years ago, a friend of her father Sardar Dara Singh came to Pakistan from India and also met her.

Her mother2az told Sardar Dara Singh about her son and the daughter she left behind in India. She also told him the name of their village and the location of their house. Sardar Dara Singh then visited her house in Padawan village and informed her that her son was alive but her daughter was dead. Her son was named Amarjit Singh who was adopted by a Sikh family in 1947.

After getting the brother's information, Kulsoom connected with Singh on WhatsApp and later decided to meet.

Kulsoom, despite her severe back pain, mustered the courage to travel to Kartarpur just to meet her brother.

Singh said that when he first learned that his real parents were in Pakistan and were Muslims, it was a shock to him. However, he comforted his heart that many families were separated from each other in addition to his own family.

"So far 16.76 lakh plants have been planted in Madhumati and Erin catchments to rehabilitate the degraded catchment," the government said in

Regarding biodiversity conservation, the government said, focus has been given to conservation of wildlife

within and outside the lake. "Various measures have been undertaken such as patrolling on boats for the prevention of poaching. Waterbird census is being regularly conducted to monitor the abundance of the migratory bird population in the

Lake," the government said. It further added that an eco-friendly walkway is being constructed to realise the ecotourism potential of the lake. The walkway has a length of 2.5 Km which shall be completed in two

The government said WUCMA has organised many awareness programmes to involve stakeholders and local people in Wular conservation.

"The vision of WUCMA is the Conservation and sustainable development of Wular lake which is aimed at the restoration of Wular for ecological and economic security of the people dependent upon the lake resources for their livelihood," the response submitted by the government reads.

They further said that the dumping sites of Bandipora and Sopore towns have been shut down by WUCMA to prevent discharge of waste into the lake as these dumping sites were located close to Wular lake.

no award was made within the above period. The award was made on 11.08.2020 which is certainly beyond the period of two years from the date of declaration and could not have been made as by that time the proceedings have already lapsed," the division bench order reads

While coming hard on the respondents, including Government of J&K, the court noted that a bare reading of the Section 11-B of repealed Land Acquisition Act of J&K reveals that the award has to be made within a period of two years from the date of publication of declaration under Section 6 and if the award is not so made, the land acquisition proceedings would lapse.

While, in the objections, the respondents had stated that the final award was made on 11.08.2020, the court observed that there was no dispute to the fact that the notification under Section 4 proposing to acquire the above land was issued on 20.03.2017.

"It was followed by declaration under Section 6 dated 08.08.2017. According to the petitioners no award was passed at least within two years of the above declaration," the order further reads

It is pertinent to mention here that the court was hearing the basic challenge that were issued against the Land Acquisition Proceedings in pursuant to the notification dated 20.03.2017 issued under Section 4 of Jammu and Kashmir Land Acquisition Act. The petitioner in the case was Abdul Salam Bhat and others from Budgam's Wathora village.

The primary argument of learned counsel for the petitioners was that the land acquisition proceedings have lapsed by virtue of Section 11-B of the Act as no award within the period of two years was passed from the date the declaration under Section 6 was issued and published.

Pertinently, last year, the High Court of I&K and Ladakh had directed the National Highway Authority of India (NHAI) to maintain status quo on the land required for the construction of the Srinagar ring road project.

Notably, over 500 families from Central Kashmir's Budgam district await compensation for the land acquired by the government recently for the construction of the ambitious Semi Ring Road project. According to officials, over 590 acres of agricultural land has been acquired for a 62-kilometer road project which would connect Pulwama and Ganderbal districts via Budgam through Pampore, Wathoora, Budgam, Dharmuna and Narbal in western outskirts of summer capital Srinagar.

Major portion of the land measuring-400 acres of farmland was acquired in the Budgam district alone for the highway project

People familiar with Gen Pande's visit said he has been briefed about the fresh disengagement process besides the overall combat readiness of the Indian Army in the region.

Commander of the Leh-based Fire and Fury Corps Lt Gen Anindya Sengupta and other senior officials apprised Gen Pande about the overall security situation including the ongoing disengagement process in Patrolling Point 15, they said.

Gen Pande is scheduled to visit Siachen on Sunday.

The Indian and Chinese armies on Thursday announced that they have begun to disengage from the Patrolling Point 15 in the Gogra-Hotsprings area of eastern Ladakh, marking a significant forward movement in the stalled process to pull-out troops from the remaining friction points in the region where the two sides have been locked in a stand-off for over two years.

There has been no progress yet to resolve the standoff in Demchok and Depsang regions.

The beginning of the disengagement process in the Gogra-Hotsprings area is an outcome of the 16th round of high-level military talks in July, the two armies said in a statement on Thursday.

Affairs External Ministry Spokesperson Arindam Bagchi said on Friday that the disengagement process in Patrolling Point 15 will be

completed by Monday.

"As per the agreement, the disengagement process in this area started on September 8 at 0830 hours and will be completed by September 12. The two sides have agreed to cease forward deployments in this area in a phased, coordinated and verified manner, resulting in the return of the troops of both sides to their respective areas," he said.

"It has been agreed that all temporary structures and other allied infrastructure created in the area by both sides will be dismantled and mutually

"The landforms in the area will be restored to the pre-stand-off period by both sides," Bagchi added.

He said the agreement ensures that the Line of Actual Control (LAC) in this area will be strictly observed and respected by both sides and that there will be no unilateral change in the sta-

"With the resolution of the stand-off at PP-15, both sides mutually agreed to take the talks forward and resolve ne remaining issues along LAC and restore peace and tranquility in India-China border areas," he said.

Initially, around 30 soldiers from each side were locked in a face-off at PP-15 but the number of troops kept changing depending on the overall situation in the region. India has been consistently maintaining that peace and tranquillity along the LAC were key for the overall development of the bilateral ties.

The eastern Ladakh border standoff erupted on May 5, 2020, following a violent clash in the Pangong lake areas. Both sides gradually enhanced their deployment by rushing in tens of thousands of soldiers as well as heavy weaponry.

As a result of a series of military and diplomatic talks, the two sides completed the disengagement process last year on the north and south banks of the Pangong lake and in the Gogra

The disengagement in the Pangong Lake area had taken place in February last year while the withdrawal of troops and equipment in Patrolling Point 17 (A) in Gogra took place in August last year.


































































































































