**First Electric Train Between Baramulla-Banihal** On Oct 2

Electric Srinagar: train 137-kilometer for long Baramulla-Banihal railway corridor is all set to be inaugurated on October 2 with the

work going on at full swing. According to reports, the Jammu and Kashmir government, Indian Railways and Indian Railway Construction Company Limited are working together on this project since August 2019.

"The PCEE inspection of the project will be conducted on 26 September, 2022 and on October 2, the project will be inaugurated," Additional General Manager, Indian Railway Construction Company Limited Abid Amin Shah said.

He said the total project cost is 324 crore and the Budgam-Baramulla section is already complete while the inspection of Budgam-Banihal section will be conducted on September 26 and it will be inaugurated on October 2.

'Railways Department has already conducted three to four trails from Budgam-Baramulla while trails of Budgam-Banihal will be conducted from 20th of this ongoing month," Shah added.

According to him, the total route length for electrification is 137.73 kilometers with three main sub-stations of Qazigund, Budgam, and Baramulla from where power will be supplied to the overhead equipment of the rail line.

## **Rs 20-30L Paid For SI Examination Paper: CBI**

Searches Carried Out At 36 Spots, Including Premises Of Ex JKSSB Chairman

New Delhi: The CBI on Tuesday conducted searches at 36 locations in connection with alleged irregularities in Jammu and Kashmir sub-inspector posts' recruitment test in which some aspirants had allegedly coughed up Rs 20-30 lakh for accessing the question paper before the examination, officials said.

The searches were spread Jammu, Srinagar, across Karnal, Mahendergarh, Rewari, Gandhidham, Delhi, Ghaziabad and Bengaluru, they said.

During searches took place at the premises of former chairman of JKSSB Khalid Jahangir and the then controller of examination of JKSSB Ashok Kumar among others, they said. The CBI teams also raided alleged gang members based in Haryana, teachers, retired officials of Jammu and Kashmir and CRPF during which the agency recovered "incriminating documents" and digital evidence,

## **Panel Warns Private Schools Against Violating Fee Structure**

Srinagar: The Jammu and Kashmir Fee Fixation and Regulation Committee (FFRC) has directed private schools in the Union Territory not to charge excess of the panel-sanctioned amount even if they have obtained a stay from the high court. FFRC Chairman Justice (retired) Muzaffar Hussain Attar said a few school managements had got stay orders from the high court against the imple-mentation of the committeeapproved fee structure for their institutions and were now charging fees as per their wish. "The question of public and

legal importance arises when the hon'ble (high) court stays the

fee regulation order of FFRC, can a school be permitted to charge and collect the fee which it has fixed itself and which in view of the mandate of the judgements of the Hon'ble Supreme Court and high court and statute, is impermissible? Can such schools charge and collect such fee from the students?" Justice Attar said in an eight-page order clarifying the FFRC's stand on 'Legal position in respect of charging of fee by private schools'.

The answer in law is that such types of schools have no authority in law to charge and collect fees fixed by themselves," he said.

Justice Attar said the High Court of Jammu and Kashmir & Ladakh, in its judgement on June 1, 2015, gave the liberty to managements of unaided private schools to approach the committee to fix the fee structure for each standard. It also provided that till the committee fixes a new fee structure, the managements shall collect More on P10



## **Twice-Daily Nasal Saline Flushing May Reduce Covid-19 Severity: Study**

Starting twice daily flushing of the nasal cavity with a mild saline solution soon after testing positive for COVID-19 may reduce hospitalisation due to the viral disease, a study claims.

The technique involves mixing a half teaspoon each of salt and baking soda in a cup of boiled water and then putting it into a sinus rinse bottle, making it a safe, effective and inexpensive way that can have a vital public health impact. "By giving extra hydration to your sinuses, it makes them function better," said Amy Baxter, from Augusta University, US.

"If you have a contaminant, the more you flush it out, the better you are able to get rid of dirt, viruses and anything else," said Baxter, corresponding author of the study.

The research, published recently in Ear, Nose & Throat Journal found an 8.5-fold reduction in hospitalisations and no fatalities compared to controls.

Less than 1.3 per cent of the 79 subjects aged 55 and older who enrolled within 24-hours of testing positive for COVID-19 between September 24 and December 21, 2020, experienced hospitalisation, and no one died, the researchers said.

Among the participants, who were treated and followed for 28 days, one participant was admitted to



the hospital and another went to the emergency room but was not admitted, they said.

By comparison, 9.47 per cent of patients were hospitalised and 1.5 per cent died in a group with similar demographics reported by the US Centers for Disease Control and Prevention during the same timeframe, according to the research-

"If confirmed in other studies, the

potential reduction in morbidity and mortality worldwide could be profound," they said.

The SARS-CoV-2 virus is known to attach to the ACE2 receptor, which is pervasive throughout the body and in abundance in locations like the nasal cavity, mouth and lungs. Drugs that interfere with the virus' ability to attach to ACE2 have been pursued, and Baxter said the nasal irrigation with saline helps

decrease the usual robust attach-

ment. Saline appears to inhibit the virus' ability to essentially make two cuts in itself, called furin cleavage, so it can better fit into an ACE2 receptor once it spots one. Participants self-administered nasal irrigation using either antiseptic povidone-iodine, or baking

soda, mixed with water that had the same salt concentration normally found in the body.

While the researchers found the additives really added no value, previous research had indicated they might help, for example, make it more difficult for the virus to attach to the ACE2 receptor. However, the research indicates

the saline solution alone sufficed. "It is really just the rinsing and the quantity that matter," Baxter said. The researchers also wanted to know any impact on symptom severity, like chills and loss of taste and smell.

Twenty-three of the 29 participants who consistently irrigated twice daily had zero or one symptom at the end of two weeks compared to 14 of the 33 who were less diligent, the researchers said. Those who completed nasal irrigation twice daily reported quicker resolution of symptoms regardless of which of two common antiseptics they were adding to the saline water, they said.

Sixty-two of the participants completed a daily survey, reporting 1.8 irrigations daily; 11 reported irrigation-related complaints and four discontinued use.

Other studies have shown the nasal irrigation, also called lavage, can also be effective in reducing duration and severity of infection by a family of viruses that include the coronaviruses, as well as the influenza viruses, the researchers added.

It Takes Years To Fill Up Posts

rinagar-Believe it or not. It takes years for the State Government to fill up vaccant posts after advertising them. The J&K Government had advertised the posts of Range Officers in 1995 and all the formalities were completed during these three years. However, the selection is yet to be done.

Over 17 candidates who have done two years State Forest Service Post Graduation Diploma in Forestry and allied subjects have not been absorbed in the forest department as Assistant Conservator Forests despite most of them about to cross the upper age limit. Some of these candidates have completed their courses way back in 1991. Despite clear vacancies in the department the Government has not referred the posts to the Public Service Commission. Most of these candidates may not be able to apply for such posts in future as they are about to cross the upper age limit.One of the candidates, Imtiyaz Ahmad Zargar, 33, said that they should be appointed by the Government on adhoc basis so that they may not loose the chances of the Government job. After the appointments the posts should be referred to the Public Service Commission, he added.

These candidates are trained for the job as they have done State Forest Service courses at SFS college Dehradun and Coimbatore under the Ministry of Environment and Forests. As per the Schedule-II of the Jammu and Kashmir Forest Service (Gazetted) Recruitment rules, 1970, 50 per cent quota has been kept for direct recruitment of the forest officers and rest for the in-service candidates. The inservice candidates had prayed for the stay of the recruitment to the posts of Assistant Conservator of Forests last year. The High Court (Single Bench) vacated the interim order of the stay on 11-03-1998 and gave liberty to the state to go ahead with the appointments as per the recruitment norms. The inservice forest officers who were not satisfied with the decision of the single bench took the matter to the double bench. The double bench not only held that the 50:50 share of the recruitment as reasonable but also justified their appointment by saying that they are the young blood with better qualification and deserve to be put into the service for better and quicker understanding of the complex scientific problems necessary for the development of Forestry in the State.

## Mossad Chief: 'Israel' To **Attack Iran Regardless Of Nuclear Agreement**

n his first public speech since assuming his position as chief of Israeli Mossad in June 2021, Director David Barnea said "Israel" will not comply with any nuclear agreement between Iran and world powers, stating that even if the deal is signed, Mossad will continue to carry out operations inside Iran.

'The nuclear talks are not a restraining factor in any way," Barnea said.

Barnea renewed Israeli allegations that Iran aims to build a nuclear weapon, a claim that Iran has repeatedly denied in the past while the IAEA and other organizations found no evidence of following onsite inspections.

Pursuing the Israeli frenzy over Iran's nuclear deal, Barnea on Monday said "Israel" would not participate in what he dubbed the "charade" of a renewed nuclear deal between world powers and Iran, warning that the emerging agreement would "not provide immunity" for Tehran from the spy agency's operations, completely slamming international efforts in the course of a lasting nuclear deal. Barnea claimed that Mossad

thwarted attacks against Israelis in several countries, most recently in Turkey, an accusation that Iran labeled as fabrications and lies that lack any profound evidence.

Iran objected to those allegations, stating that "Israel" is attempting to sabotage Tehran-Ankara relations and divert regional attention from Palestine. On a visit to Washington days ago, as part of Israeli Prime Minister Yair Lapid's pressure campaign to deter the US from signing a nuclear deal with Iran, chief of Mossad David Barnea warned his US counterparts against signing the deal. This is not the first time that

an Israeli top official openly attacked the nuclear deal with Iran and declared that "Israel" is not obliged by the UN-sponsored agreement and will carry out operations against Iran re-

gardless of the deal. During an official visit to France last August, Israeli Prime Minister Yair Lapid told French President Emmanuel Macron that "Israel" won't be bound by nuclear deal if one is reached.

He met the Saudi Crown Prince in Jeddah on Sunday and handed over a written message from Prime Minister Modi, conveying greetings on the upcoming National Day of Saudi Arabia on September 23 and reiterating invitation to the Crown Prince to visit India at an early date, the press release said.

Crown Prince Mohammed paid his first State visit to India in February 2019. During the meeting, bilateral relations between the two countries and opportunities for enhancing them were reviewed and the latest regional and international developments, as well as the efforts being exerted towards them, were discussed, the official Saudi Press Agency reported. Earlier on Sunday in Riyadh, Jaishankar held talks with his



Saudi counterpart Prince Faisal bin Farhan and discussed current global political as well as economic issues and agreed to work closely together in G-20 and multilateral organisations.

The two ministers co-chaired the inaugural meeting of the Committee on Political, Security, Social and Cultural Cooperation (PSSC), under the framework of the India-Saudi Arabia Strategic Partnership Council.

Both ministers assessed the progress in bilateral relations positively across all domains including political, trade, energy, investments, defence, security and culture. Several areas were identified for further enhancing bilateral cooperation such as food security, healthcare, phar-maceuticals, defence industry and entertainment, the Indian embassy press release said.

## **Right To Contest Election Neither Fundamental Nor Common Law Right: SC**

The right to contest an elec-tion is neither a fundamental right nor a common law right, the Supreme Court has said while dismissing with a cost of Rs one lakh a petition which raised the issue regarding the filing of nomination for Rajya Sabha elections.

Observing that an individual cannot claim that he has a right to contest an election, the apex court noted that the Representation of People Act, 1950, read with the Conduct of Elections Rules, 1961, has contemplated the name of a candidate has to be proposed while filling the nomi-

nation form. A bench of Justices Hemant Gupta and Sudhanshu Dhulia

The petitioner claimed that since his candidature without the proposer was not accepted, his fundamental right to free speech and expression and his right to personal liberty was infringed.

"We find that the writ petition before the high court was entirely misconceived and so is the present special leave petition. The right to contest an election is neither a fundamental right nor a common law right. It is a right conferred by a statute," the apex court said in its order passed last week.

The bench, which referred to a previous judgement delivered by the top court, noted that the petitioner did not have any right to contest election to the Rajya Sabha in terms of the law made by Parliament.

"The Representation of People Act, 1950 read with the Conduct of Flections Rules, 1961 has con-

### Journalist Siddique Kappan Will Remain In Jail, Officer Cites Another Case

Lucknow: Kerala-based journalist Siddique Kappan, who was recently granted bail by the Supreme Court, will remain in a jail here as a case being probed by the Enforcement Directorate against him is still pending, officials of the prison department said.

A court here on Monday issued the release order of Mr Kappan, who was lodged in jail after his arrest in October 2020 while he was on his way to Hathras in Uttar Pradesh, where a Dalit woman had died after allegedly being raped.

"Kappan will continue to remain in jail as a case being probed by the Enforcement Directorate is still pending," DG Jail PRO Santosh Verma told PTI.

While ordering his re-lease, Additional Sessions Judge (ASJ) Anurodh Mishra had directed Kappan to furnish two sureties of lakh each and a personal bond of the same amount. The judge also sought an

The court had also taken note of the submissions of the Uttar Pradesh government and laid down several conditions for bail, including that he will have to remain in Delhi for the next six weeks after release from the prison and report to Nizamuddin police station in the national capital on Monday every week.

All the fake faith healers left the house while the woman was shocked after finding nothing in the Holy Quran.

"They (fake-faith-healers) decamped with 2 rings and two earrings of gold and cash worth Rs 5,000. We informed the police about the incident," one of the family members said.

Such incidents in the peripheries of Tral town are not uncommon. Fake-faith healers deceive naïve people and mint money at will. (KNT)

## Political Churning In India



Kejriwal is trying to fill in the vacuum created by the depletion of the Congress party as a viable opposition. Will AAP be able to position itself as an alternative in what is an all-important state for the BJP? Only time will tell. Congress is also in the process of rejuvenating itself by hitting the road. Congress leader Rahul Gandhi is currently undertaking a padyatra to reconnect Congress with the people. The public response has so far been good. It remains to be seen whether this public outreach could translate into any electoral gains for the party in the upcoming Assembly elections in Gujarat and Himachal Pradesh. And whether Congress could emerge as a viable alternative to the BJP in 2024, the chances of which at this time look very remote. Though only a small number of people will be formally a part of the yatra, its success will be determined by how many more people will join it across the twelve states through which it is due to travel. And also how many people will attend Gandhi's public interactions.

However, with its recent landslide victory in Punjab, the AAP is on a roll. It hopes to replicate the performance in Gujarat. Kejriwal has shown political skills to get his party up and running out of nowhere. He could very well do so in Gujarat. But it is also true that prime minister Narendra Modi's charisma is still fresh and abiding and that too in his home state where his remarkable journey began. So, it would be next to impossible to dislodge him in Gujarat. Ditto in Himachal. With every passing year, his political appeal and constituency have grown stronger and wider while that of Congress has correspondingly shrunk.

But there are still two years to go before the general elections are held, and much can change during this time. Two years is a long time in politics. Kejriwal could very well emerge as a dark horse in Gujarat. But at the national level, only a combined opposition could be expected to take on the BJP. Bihar Chief Minister Nitish Kumar who recently quit the alliance with the BJP, is trying to forge an opposition unity and there are indications that he has had some success in the endeavour. But it won't be easy to bring all the opposition parties together on one platform, more so, with several regional leaders nursing their personal ambitions. Gujarat and Himachal election outcomes will certainly offer some hint as to what is in store in 2024.

## Man Vs Wild

Have Wild Animals Made Srinagar and Its Outskirts Their New Habitat ?

THE Presentation Convent School had to issue an order to close down the school on Monday, September 12th 2022 after a small video clip of a bear and her cub roaming in Jawahar Nagar, Raj Bagh locality went viral.

The Presentation Convent school management in its press statement had said:

"The school will remain closed tomorrow (12/9/2022) and the exam scheduled for tomorrow will be conducted the day after tomorrow (13/9/2022). Praying for the safety of everyone"

The video had created a lot of chaos and confusion among the Srinagar residents in general and people of Rajbagh ,Jawahar Nagar and adjoining localities in particular as it is for the first time in recent history that wild animals had been found roaming in this area.

As per media reports, a 40 year old man was injured in the bear attack around Lal Mandi area which is located in between Rajbagh and Jawahar Nagar. The official sources say Fayaz Ahmad Bhat, a resident of Habba Kadal Srinagar who was working as a security guard in a private school had been attacked by the wild bear. It is presumed that same bear that had been roaming around the area for the last 2 days had attacked Fayaz. The said person was left severely injured as the wild animal attacked his face and upper limbs. He was shifted to SMHS hospital Srinagar where his condition is said to be stable now. The Srinagar Police in a tweet had asked people of Rajbagh , Jawahar Nagar and Lal Mandi to stay indoors until the bear and her cub were caught. After the wild animal was trapped along with the cub, the wildlife officials sent them to Dachigam national park where they were set free deep inside the forest area.

Similarly, the afforestation that has taken place in Srinagar and its surrounding areas like Shankaracharya hill or Zabarwan hills plus growth of stone fruit trees around Zabarwan foothills has given rise to bear population as well

Baghi Mehtab area of Srinagar when it was seen jumping from one boundary wall to another around a housing colony. The said colony is located merely 6 kms from Srinagar city centre. It was presumed that the leopard had come down from the Humhama area near the airport as more than a dozen leopards are believed to have made their habitat around Karewa Damodar area which is an elevated plateau-like area locally called Wodder. The Wodder is approximately spread over a 25 square kilometre area. Srinagar international airport is situated nearby. For the last 10 to 12 years, leopards were frequently seen around different locations of Karewa Damodar. Infact, the entire Karewa has been fenced by the Defence Estates Department and Airport Authority of India. However, there are many locations where we find thick forest-like patches. These are the areas that were developed by the Department of Social Forestry and J&K Forest Department in the last 30 to 35 years. These areas located around Humhama, Ompora Kralpora, Wathoora and Rangreth areas are like thick jungles which have now become a habitat for several leopards. Leopards can be seen roaming freely in villages located just outside Srinagar airport. Only two weeks back, a leopard with two cubs was seen in Banhar Wathoora village. The leopard had taken away some puppies from the village. For 3 days, the leopard would roam around the village and the video had gone viral on social media as well. This author who lives around the same area had informed Regional Wildlife Warden Rashid Nagash who sent a team of officials. They installed a trap but the wild animal could not be trapped even as the cage was kept in the area for several days Leopards don't attack humans except for when they are hungry and even then, they only attack small children. However, when it comes to bears, they attack even adult men and women. Such wild animals were typically adjusted to their habitats religiously. They feasted on the rich diversity that wildlife had to offer. However, over the years, with the meddling in their habitats, they have taken to developing new food habits. Wild animals such as bears have been found feasting near dumping sites and adapting to trash over berries. This loophole in our waste management techniques must be factored in while identifying the reasons behind the man vs. wild conflict.

#### Bear in Rajbagh

When we see old pictures of Shankaracharya hill (Sulieman Taing) we don't see any vegetation around it. Even in the old Bollywood movies of the 1960s or 70s which have been shot around Dal Lake, we can see the Shankar Acharaya hill looking completely barren with no vegetation. From the late 1980s, the Urban Forestry Division started planting Kail trees around this hill and now we can see a thick jungle around this hill from at least three sides i.e North , South and East. There is a substantial cover of vegetation and growth of forest around Shankaracharya hill and bears come down from the said hill to eat cherries in many personally owned lawns.

It is a possibility that the bear and her cub that were seen in Rajbagh recently, might have come towards this locality from the Shankar Acharaya hill via Gupkar road and then entered the Rajbagh area through Abdullah bridge. There is no other area in Srinagar uptown from where this wild animal would have gone to Rajbagh.

In Karewa Damodar(Airport side), only leopards are found and there is no evidence that any bear has ever even been spotted. This makes it quite plausible hat the said bear had entered Rajbagh from Shankar Acharaya mountain via Gupkar road.

### Hide and seek

India has recently overtaken the United Kingdom to become the fifth largest economy of the world. This higher rank is considered by the Government of India as a grand success. The nation, however, ought to reflect on this achievement more closely. First of all, the size of the gross domestic product hides more than it reveals. The absolute size does not tell the nation what is available to each citizen, even on average. It does not say how the goods and services are distributed, and the levels of poverty and unemployment. Finally, it does not reveal anything about the degradation of the natural environment. In other words, the focus on GDP does not help unveil the true nature of the economic condition of citizens and the long-term availability of natural resources. India's recent attainments in other measures of economic performance leave much to be desired.

In terms of the latest data on per capita incomes, India is ranked 144 out of 194 countries and has a rank of 33 among Asian nations. The richest country in per capita terms has an income 60 times higher than that of India. In terms of economic inequality, the World Inequality Report 2022 and an Oxfam study reveal that the top 10 per cent of Indians earned 57 per cent of all income and owned 77 per cent of national wealth. The bottom 50 per cent earned only 13 per cent of income. According to the International Monetary Fund, India's per capita income at current prices stood at \$2,191 in 2021 and was expected to increase to \$2,358 in 2022. If the degree of inequality is taken into account and the incomes of the top 10 per cent excluded, then the per capita income would fall to a little less than half the total. It is estimated that if a minimum-wage earner were to aspire to earn the remuneration of a senior CEO in the garment industry, it would take the person 941 years to do so. There cannot be starker evidence of embedded inequality in the country.

Then, there is the enduring challenge of poverty. According to Oxfam, 63 million Indians are pushed back into poverty due to lack of access to health facilities alone. Poverty has actually increased during the pandemic with estimates showing that between 200 to 250 million people fell below the poverty line. Finally, in today's world, the environmental performance of a nation is of great significance. It is a pity that India is ranked on this index at the bottom out of 180 countries in 2022. Becoming the fourth or even the third largest economy may not change matters for the average Indian citizen, especially the poor

Srinagar and Budgam: New Habitats for Wild Animals

The Himalayan Leopards are known for their shy and secretive behaviour. They live a solitary life, are nocturnal and spend their nights hunting instead of sleeping. However, in the last several years, their behaviour has changed especially in Kashmir valley.

These wild animals, typically found only in the alpine mountains and forests of Kashmir, are now seen in villages outside the demarcated forests since a decade. Ironically, they have made the outskirts of Srinagar their new habitat especially around the Budgam districts surrounding Srinagar airport area.

More than a year back, a four-year-old girl, Adha Skakeel, was mauled by a leopard near Ompora housing colony in Budgam. She was playing in the lawns of her house on the evening of June 5th last year when a leopard jumped from the boundary wall and snatched her away. A massive search operation was launched by the wildlife and police. After more than an hour, some local residents found the girl's necklace and slippers in the nearby forest. The next day, her mutilated body was found in a nearby newly grown forest.

Last year too, a leopard had created panic in

The wildlife officials and local residents living near Srinagar airport area told me on several occasions that leopards who live in Karewa Damodar or other Karewas of Budgam kill and eat dogs. This is their main diet and every night they go out to kill dogs. As there is enough dog population in Kashmir which is infact increasing day by day on a very large scale, the leopards from alpine forests come down to villages and get settled around secluded areas or thick manmade forests around Karewas. Similarly, the afforestation that has taken place in Srinagar and its surrounding areas like Shankaracharya hill or Zabarwan hills plus growth of stone fruit trees around Zabarwan foothills has given rise to bear population as well. Some decades back the leopards would hardly eat the dogs as they would kill and prey only wild animals like deers, wild goats or sheep but now it seems their food habits have changed with the change in their habitat. This change has also been facilitated by trash dumped in various parts which has now become a part of the wild animals' eating habits.

This makes it clear that the attack from wild animals is hardly a case of animals-gone-rogue. This combat is man-made and must be mitigated accordingly.

## Contemporary Life And The Possibility Of Moral Existence

RISTOTLE had declared

that the state existed for the moral perfection of human beings; implying that humans were morally imperfect creatures. Human existence embarks upon different "states of being". A "state of being" entails two concepts: one is state of "being as" (something) and second is a state of "doing" or a state of activity. Morality pervades both these spheres; "being" as well as "doing". This means morality is a constituent of character/personality -which realizes some form of presence (or present-ness), and also activity of negotiating with life; we can be morally good as well as do morally good.

An essential question with which humans have been constantly grappling concerns the nature of moral life. In other words, what does it mean to live a moral life? Different philosophies, religions, ideologies from times immemorial have dealt with this question and provided some generalized opinions, yet it remains unresolved and pertinent to the mystery of life. There is a tendency among people to be indolent and apathetic to such questions, still, we cannot escape them altogether. Our ignorance or indifference would not cease the existence of moral dilemmas, for example, which we all face at some point in our life. Thus in an attempt to live, it becomes a necessity to try and negotiate with morality, consciously or unconsciously, perhaps on an everyday basis.

As far as the reality of existence is concerned, it is an undisputed claim that human beings do not live in an empty space; rather we are grounded or embedded in a context governed by some social, moral, and political idea. Moral issues come forth in a contestation of individual moral beliefs with the already present 'ethos' of a society. Developing from Theodore Adorno, Judith Butler in her work Giving an Account of Oneself argues that the questions



about moral philosophy not only emerge in the context of social relations but also the form these questions take changes according to the context. What it means is that the occurrence of moral dilemmas, for example, is not only inevitable, it also keeps on upgrading itself. In other words, moral questions relevant to a certain context change their form only to be ever-present in a changed context. Imagine the question of abortion; it may be a moral catastrophe for some or freedom for others but the issue around its moral character still surfaces in public debates about abortion. Moral questions around abortion may have changed their form (as today we argue about the point at which life begins in such debates) but the importance and urgency of such questions don't fade away.

When it comes to our contemporary life, a pertinent question one needs to ask is: what is the status of our collective moral existence? Where does morality stand in our everyday life? If we suspend much clichéd Existential or Postmodern critique (which has its own complexities and counter critiques) for a while, we will find that this question forms an immense relevance for a "fluidly modern" society like ours. It's important because our experience of the 'modern' somewhere develops a tension with the 'traditional' or, the authentic mode of life. This authentic has an inherent meaning and purpose, an authentic life in other words is a life with a purpose which supplies it with a meaning. It is a life where ideals still sustain and constantly try to inform how to deal with our moral dilemmas, while on the other hand the 'modern' is where these ideals have lost their credibility and are no longer sustained because of an increased tendency towards a market oriented life. For the sake of argument let's understand friendship. In its ideal understanding friendship is perhaps an association wherein two or more people are emotionally related to one another by sharing some commonality of, maybe, interests or vulnerabilities. It has its sanctity in the virtue of being exclusive, closed, and trustworthy. But how does the 'modern' experience corrode the ideals of friendship? A website namely RentAFriend.com allows its users to rent a local friend if they find themselves lonely in some foreign place, in other words you can buy a friend for some bucks to do away with your loneliness. The question remains, if we buy a friend even if she is loyal will this association be called a friendship? The point is when we add money to rent a friend for some time it loses its meaning. Michel Sandel highlights many other such cases in his book What Money Can't Buy: The Moral Limits of Markets. It then means that modern market forces can intervene with the meaning of otherwise abstract and morally intelligible ideals. Slavoj Zizek, in one of his interviews, makes a similar comment about the nature of love. He argues that the act of 'falling in love' which otherwise involved bearing the risks and vulnerabilities of its spontaneity, has now disappeared. We tend to look for someone to love as an arrangement of preferences and choices that involves conscious decision-making and remaking of it. This proclivity towards having a mechanistic consciousness of the world and things within it

however abstract they are has a bearing on our moral existence. It makes cost-benefit analysis or sometimes even hedonistic calculus as the only metric of our ethics –a benchmark of making ethical judgements in the acts we do or the choices we make or even the ideals we hold.

This phenomenon is reductionist and minimalistic with respect to the complex human existence as it doesn't allow an inherently vibrant human nature to express itself. Some important aspects of being human like simplicity, subsistence, altruistic care... are lost in a mad race for frivolous pleasures. For instance, consider the case of Burj Al Arab hotel in Dubai, which was recently thrown public for common people to visit. The hotel is jeweled with kingly luxury where even toilets are plated with 24 karat gold. There is no utility of such a luxury other than creating a fetish around commodities and standardizing the cost of living in such places. The benchmark it creates leaves a variety of other human tendencies unentertained. We find people desire to visit such places and witness the luxury because the benchmark somehow even sets the sense of aesthetics for us.

This is precisely where the tension between the 'modern' and the authentic becomes apparent, which creates crises in our moral existence and makes us oscillate between being sensitive to the gravity of the situation and being apathetic to it altogether. The problem is; however insensitive we remain, these questions would resurface to us. The need of the hour is to have a deeper engagement with the question of moral and philosophical importance, and not shy away from the complexity of their nature. This is where a case for doing philosophy becomes almost inevitable.

## **Emerging Multipolar World Order**

With its economy still largely unerdeveloped, the c ontinent mense space for many services and products that can be initiated for the local markets to absorb. With sincere and committed political leadership, there is no reason why Africa cannot become an economic success story. True, this will not happen overnight or even in the next few years, but it is a plausible scenario in which the developing world should take keen interest and lend active support. Western hegemony should have taught developing countries one important lesson: not to place all their eggs in one basket. The basket owners have a tendency to weaponize their currency and adopt policies to accrue other economic advantages. By making sure that China does not hold all the economic cards, especially in manufacturing, the developing world, West Asia in particular, can avert a scenario where Beijing will utilize medium powers mainly as leverages against its bigger competitors. To avoid this scenario, Africa's economic advancement should be a key pillar of the strategy to balance out China's manufacturing monopoly. At the political level, multipolarity must develop a robust and practical mechanism of collective global cooperation and decision-making. Absent this concrete alternative, the declining western hegemonic order will appear as the only real and working global political framework. There is no need to reinvent the wheel. If countries like Venezuela, Iran, Bolivia, Turkey, Vietnam, Malaysia, Brazil, Algeria, South Africa and Ghana come together for a coordinated political push to reform the current UN security council system and increase the role of the UN General Assembly, multipolarity can reflect a more realistic and relevant picture of the world. If western powers refuse to play ball at the UN-and it is quite likely that is what will happen-there is no reason why a sizable bloc of countries cannot create an alternative political structure to replace the UN. Will power and political prudence can make this a reality. Another key political development which must take place for multipolarity to firmly set in is the normalization of local conflict resolution. Conflicts

When the discussion related to the emerging multipolar world order is concentrated on its general contours. It is important to look at some specific aspects of multipolarity which should be established for the new order to make itself relevant on the world stage and to deliver tangible results.

Let us first identify its opponents. They are not limited to NATO regimes only. While western powers will be the biggest losers of the creation of a multipolar world order—it means the loss of their hegemony—China and Russia are also not fully committed to a truly multipolar world order. This needs elaboration.

Speaking at the Diplomatic Academy in Moscow in 1998, then US Secretary of State Madeleine Albright made some positive remarks about multipolarity. At the same time, she asserted that the United States of America was an indispensable world power.

Careful reading and analysis of Chinese and Russian statements and policies reveals that they consider multipolarity simply as a means to enhance their influence in global affairs. They do not want to significantly reduce western hegemony if their interests can be accommodated within its parameters.

This was explained by one of the most astute Russia experts, Dmitri Trenin who articulated in the Washington Quarterly as early as 2009 the most accurate assessment of contemporary Russia-West relations. Trenin wrote: "Russia was not to be integrated into the core West but managed by it... Putin aimed at integration with it [West]. Unlike [Boris] Yeltsin, Putin put a price on his country's cooperation with the United States. Washington would have to recognize Moscow's primacy in the CIS [Commonwealth of Independent States, the Central Asian Republics that were part of the Soviet Union before its breakup]."

If one pays close attention to the reasons advanced by Russia for its invasion of Ukraine, whether one agrees with them or not, it becomes clear that had the west not expanded its influence into what Russia considers its sphere of influence, Moscow's objec-



tions to western hegemony would not be significant.

Keeping this in mind, let us return to the central question of the specifics of a truly multipolar world order.

Such a world order will have to reflect strategic diversification in economic, political and military fields. Thus, there needs to be a group of states which would balance each other out in economic, political and military fields. In a truly multipolar set up, China and Japan would achieve similar levels of growth and be equally crucial for a functioning global economy. Europe would be able to enter political and economic alliances without needing a green light from Washington. The US will not be able to give unconditional support to apartheid Israel without significant economic and political costs. All these factors do not have to play out in the exact way described above, but the leveling of economic, political and military fields in a diversified and multilateral way is essential.

Let us conduct a brief overview of some specific economic features which would have to be firmly established for the world order to be functional and truly multipolar.

From an economic standpoint, the key shift must take place in the entire

so-called neo-liberal economic narrative. It does not mean that all features of free trade and capitalism will be eliminated, but many of the key economic dogmas of neo-liberalism projected as economic truths will have to be called out for what they are, dogmas. This is already taking place and not only due to the economic rise of China which dismisses key tenets of western capitalism. Even in the US some key dogmas of the so-called free-market economy are being significantly reconfigured.

Joe Biden's decree to institute "Buy American" provision for the federal government when purchasing goods and services may appear to be a sensible economic policy, it is also an admission that Washington's global economic narrative has failed. For decades, western educational institutions, think-tanks and media outlets preached the virtues of free trade as the primary engine for world peace and global economic prosperity. The US was the principal political and military champion of free trade economic narrative. Now it admits serious shortcomings of its classical wavs.

Also, one should not dismiss the increasing appeal of the Scandinavian economic model. It has become a key example of how to do things better in many educational institutions and media headlines shaping global attitudes. Twenty years ago, the narrative of how economic activity should be managed was symbolized by the US economy, which brought with it certain economic dogmas. Today this is no longer the case. Scandinavian countries which chose to follow a different economic path have become the symbol of correct economic thinking.

Islamic banking is also gaining ground and even non-Muslim policy centers are looking at it as a serious alternative.

Other key economic factors that would need to be set in place for the durability and authenticity of a multipolar world order would be a significant movement away from the US dollar as global trade currency and the establishment of Africa as a manufacturing hub to counter China's dominance.

Since there is intense discussion about the supremacy of the US dollar, more attention needs to be paid to the necessity of Africa being the new global economic miracle. The African continent is a treasure-trove of many vital minerals. Further, its climatic diversity makes the continent an ideal hub for diverse economic sectors. involvement. Local and regional problems should be resolved by actors directly affected by them. While this has already started to a certain degree, as recent developments in Chad, Venezuela-Columbia and Iran-Saudi negotiations show, this needs to become the norm in all parts of the world. This will take time to become fully functional but the fact that this is already taking place is a positive development.

should be resolved without US, French,

In practical terms, this means the emergence of organizations like the African Union, BRICS, the Shanghai Cooperation Organization and others. This is the only way to win global public opinion on a broad scale by showing that multipolarity is acted upon at a practical level and can deliver positive results.

Political institutionalization of multipolarity will naturally eliminate the need for non-regional military involvement. This means that the interference of non-regional militaries around the world needs to be eliminated or at the very least reduced to a minimum. For this to happen, a realistic approach needs to be taken. It should be kept in mind that war is the perpetual vice of humanity. Therefore, regional military cooperation systems, not alliances, need to be formed.

If this sounds idealistic or utopian, it should be remembered that at some point in history, the abolition of slavery, minimum wage, the UN or emergence of a European Union were also considered utopian. Today such developments and institutions are a reality because people chose to work towards establishing them.

The same should apply to the establishment of a functional multipolar world order which is in the process of being formed. While the road will be bumpy, it seems to be an unstoppable process. For it to become a fully functional reality, the process must deliver real positive results, sooner the better.

## **Air Pollution May Trigger Lung Cancer** In Non-Smokers: Scientists

cientists have discovered a new mechanism through which very small pollutant particles in the air may trigger lung cancer in people who have never smoked, Particles linked to climate change also promote cancerous changes in airway cells, they found, paving the way to new approaches for lung cancer prevention and treatment.

Scientists of the Francis Crick Institute and University College London, funded by Cancer Research UK, presented the data at the 'ESMO Congress 2022'.

According to them, the particles which are typically found in vehicle exhaust and smoke from fossil fuels, are associated with non-small cell lung cancer (NSCLC) risk, accounting for over 250,000 lung cancer deaths globally per year.

The same particles in the air that derive from the combustion of fossil fuels, exacerbating climate change, are directly impacting human health via an important and previously overlooked cancer-causing mechanism in lung cells," they informed.

The risk of lung cancer from air pollu-



tion is lower than from smoking, "but we have no control over what we all breathe". "Globally, more people are exposed to

unsafe levels of air pollution than to toxic chemicals in cigarette smoke, and these new data link the importance of addressing climate health to improving human health," said Charles Swanton from the Francis Crick Institute.

The new findings are based on human and laboratory research on mutations in a gene called EGFR which are seen in about half of people with lung cancer who have never smoked.

In a study of nearly half a million people living in England, South Korea and Taiwan, exposure to increasing concentrations of airborne particulate matter (PM) 2.5 micrometres (Im) in diameter was linked to increased risk of NSCLC with EGFR mutations.

In the laboratory studies, scientists showed that the same pollutant particles (PM2.5) promoted rapid changes in airway cells which had mutations in EGFR and in another gene linked to lung cancer called KRAS, driving them towards a cancer stem cell like state.

"We found that driver mutations in EGFR and KRAS genes, commonly found in lung cancers, are actually present in normal lung tissue and are a likely consequence of ageing," said Swanton.

However, when lung cells with these mutations were exposed to air pollutants,

"we saw more cancers and these occurred more quickly than when lung cells with these mutations were not exposed to pollutants", suggesting that air pollution promotes the initiation of lung cancer in cells harbouring driver gene mutations.

'The next step is to discover why some lung cells with mutations become cancerous when exposed to pollutants while others don't," said Swanton.

Tony Mok from Chinese University of Hong Kong, who was not involved in the study, said that the research is intriguing and exciting.

"It means that we can ask whether, in the future, it will be possible to use lung scans to look for pre-cancerous lesions in the lungs and try to reverse them with medicines such as interleukin-11 inhibitors,' said Mok.

"We don't yet know whether it will be possible to use highly sensitive EGFR profiling on blood or other samples to find nonsmokers who are predisposed to lung cancer and may benefit from lung scanning, so discussions are still very speculative," he added.

## **Study Reveals Minimum Blood Sugar Levels To Avoid Diabetes-Related Problems?**

Long-term blood sugar levels, known as HbA1c, can be used to accurately predict the risk of a person with type 1 diabetes having eye and kidney problems. According to research, this level should be lower than 53 mmol/ mol (7%). The study tracked people for more than 30 years after they were diagnosed with type 1 diabetes. (Also read: World Diabetes Day: How diabetes can affect your mental health)

The results were published in Diabetes Care.

People with diabetes may experience damage to the small blood vessels in various organs. The reasons for this are unclear. but it has been known since the 1990s that good control of blood sugar levels reduces the risk of complications. It has, however, not been clear what level of long-term sugar, HbA1c, people with type 1 diabetes should have in order to avoid serious damage to blood vessels in the eyes and kidneys.

"Our study determines accurately the levels of long-term sugar that can avoid complications. This knowledge can increase a person's motivation to keep their blood sugar level under control," says Hans Arnqvist, professor emeritus at Linkoping University and leader

#### of the study.

Researchers in the current study, known as VISS (Vascular Diabetic Complications in Southeast Sweden), have followed all children and adults younger than 35 years who developed type 1 diabetes during the period 1983-1987, and who received care in the South-East Healthcare Region of Sweden. All 447 newly diagnosed persons in the region during this period were included in the study. The researchers followed the patients' HbA1c values, which reflect their average blood sugar levels during a longer period. They have also monitored the development

of eye- and kidney damage in these patients for a period of between 32 and 36 years after diagnosis.

The small blood vessels in the eye are particularly susceptible to damage in type 1 diabetes. Nearly all patients experience small haemorrhages in the eye that do not affect their vision. In some cases, new blood vessels develop in the retina. The latter is known as 'proliferative retinopathy and can lead to blindness. Another effect of diabetes concerns the area known as the 'macula' of the retina, where high-focus vision is located. Damage here leads to blurred vision.

The Journal of the Academy of Nutrition and Dietetics published the findings. One in five American women between 18 and 44 reported having at least one impairment that affects their ability to hear, see, think clearly, move around independently, or take care of themselves. The diets of women with impairments have received less attention from researchers, though.

"A healthy diet is essential for avoiding many chronic diseases. A nutritious diet can also help pregnant and postpartum outcomes for women of reproductive age, according to study author and associate professor of public health nutrition at NYU School of Global Public Health Andrea Deierlein. Women with disabilities may encounter challenges because of their medical issues or physical limits if they don't have access to healthy foods or the means to prepare them.

The researchers examined information from the Centers for Disease Control and Prevention's National Health and Nutrition Examination Surveys' 2013-2018 waves to gain a better understanding of the diets of women with impairments (CDC). 3,579 women between the ages of 18 and 44 were questioned about their daily dietary intake, which was used to determine their diet quality ratings, as well as other diet-related issues such as food security and involvement in food assistance programmes.

Whereas, in consequence to above, a revised select list for OM category was issued vide Notification No. 84-PSC (DR-S) of 2021 dated 03.11.2021, wherein Mr Asif Amin was deleted and in his place, the candidate next in merit was selected; and,

Whereas, the applicant filed an OA No. 430/2022 before the Hon'ble Central Administrative Tribunal Srinagar. The Hon'ble CAT while considering the matter vide its order dated 18.05.2022 directed as under:

#### "Meanwhile, the respondents are directed to dispose of the pending representation of the applicant".

Whereas, in her representation the applicant has alleged that some candidates have been given weightage for conferences and publications, when they do not have any such publications/conference attendance. However, the allegations have been made without any supportive evidence. The applicant has not even mentioned any specific name, as such, the allegations are vague and without proof; and,

Whereas, as regards, her allegation that her conference points and teaching experience have not been counted, it is stated that she had submitted 05 International conference papers at the time of interview, out of which 04 have been accepted. Besides, she had also submitted one National conference paper which has also been accepted, and for both the conferences she has been awarded 2.25 points. Assuming but not admitting that even her 5th international paper is also accepted she would be entitled to 0.5 additional points which could make her grade 61.95 i.e still less than the last selected candidate. As regards the counting of teaching experience is concerned, she had submitted 02 experience certificates related to the period 09.11.2016 to 31.03.2017 and 10.04.2017 to 31.12.2017. The total experience comes to 01 year, 01 month & 19 days, for which 01 point has been awarded to the applicant (petitioner). Thus, the allegations that conference & teaching experience have not been counted is also baseless; and,

Whereas, as regards the allegation that candidates who did not possess JRF have been given weightage, it is to state that due to an inadvertent error some candidates who did not possess the JRF were shortlisted. However, as soon as the mistake was noticed, the same was rectified and only such / candidates who fulfilled the eligibility criteria were recommended for

Whereas, the candidate has also filed application seeking information under RTI Act 2005 which has been disposed off and the relevant information stands provided.

Now, therefore, in compliance to the orders of the Hon'ble Central Administrative Tribunal dated 18.05.2022 passed in OA No. 430/2022 titled Dr Taseen Gul Vs UT of J&K, the case has been examined and found that the applicant has failed to make it to the select list as she has secured 61.45 marks, whileas, the last selected candidate, under OM category had secured 62.08 marks. Therefore, the applicant's prayer for re-conducting the interview by cancelling the select list cannot be accepted. Hence, the claim of the applicant being devoid of any merit is hereby rejected.

The Sensex surged 455.95 points or 0.76 per cent to close at a five-month high 60,571.08 points and 24 constituents of the 30-share index ended in the green.

In a reflection of strong investor sentiments, the broader Nifty climbed 133.70 points or 0.75 per cent to settle at 18,070.05 points. Previously, the Nifty had closed above the 18,000-mark on April 4 this year.

In four consecutive sessions, Sensex has gained over 1,540 points or 2.59 per cent while Nifty has risen by 445 points or 2.9 per cent. Analysts said the market rally was primarily driven by Foreign Institutional Investors (FIIs) who have turned net buyers of domestic equities. Retail investor participation also added to the momentum.

**Rupee Rallies 36 Paise** To Over 1-Month High On **Foreign Fund Inflows**

MUMBAI: The rupee appreciated by 36 paise to close at over one-month high of 79.17 against the US dollar on Tuesday, tracking the dollar's decline versus its major peers and foreign fund inflows.

At the interbank forex market, the local unit opened at 79.30 against the greenback. It witnessed an intra-day high of 79.03 and a low of 79.33 during the session. It finally ended at 79.17, the highest closing level since August 3. The rupee had closed at 79.53 on Monday. The dollar index, which measures the greenback's strength against a basket of six currencies, fell 0.40 per cent to 107.89. Brent crude futures, the global oil benchmark, advanced 0.96 per cent to USD 94.87 per barrel.

"The Indian rupee registered the biggest oneday gains after July 27, amid long unwinding in the dollar and risk-on sentiments. The dollar inflows from foreign institutions and corporates also supported the rupee," said Dilip Parmar, Research Analyst, HDFC Securities.

The application further said that despite the UTP being categorised as high-risk and the deployment of a large number of police personnel, there was a threat to his

security. In view of the safety and security of other UTPs, as well as police staff, it is humbly prayed that the above-mentioned UTP may be ordered to be produced only through video conferencing, the application said.

## **EC Delists 86 More Non-Existent Political Parties; Total Tally Stands At 537**

New Delhi: The Election Commission on Tuesday ordered deliwsting of another 86 'non-existent' registered unrecognised political parties, raising the number of such organisations red flagged by the poll panel for failing to comply with

electoral rules to 537. In a statement, the EC said "immediate corrective measures" were required to be taken in larger public interest as well as for the "purity" of electoral democracy and hence it has also declared an additional 253 registered unrecognised political parties (RUPPs) as "inactive". The decision was taken by Chief Election Commissioner Rajiv

Kumar and Election Commissioner Anup Chandra Pandey, it said. "The EC today further delisted 86 non-existent RUPPs and declared additional 253 as 'Inactive

RUPPs'. This action against 339 non-compliant RUPPs takes the tally to 537 defaulting RUPPs since May 25, 2022.' The Commission said the 86

RUPPs that have been delisted were found to be "non-existent either after a physical verification carried out by the respective Chief Electoral Officers (CEOs) of concerned states/UTs or based on report of undelivered letters/notices from postal authority sent to the registered

address of concerned RUPP". It had similarly delisted 87 and 111 RUPPs on May 25 and June 20 respectively.

The decision against 253 noncompliant RUPPs was taken based on reports received from CEOs of Bihar, Delhi, Karnataka, Maharashtra, Tamil Nadu, Telangana and Uttar Pradesh. They were categorised as inac-

tive, as they have "not responded to the letter/notice delivered to them and have not contested a single election either to the general assembly of a state or the Parliament election 2014 and 2019," the EC said.

These RUPPs have failed to comply with statutory requirements for more than 16 compliance steps since 2015 and are continuing to default, it said. The Income-tax department had last week conducted raids against certain RUPPs in some states as part of a tax evasion probe against them. The department is understood to have taken a decision on the basis of the EC action undertaken against the RUPPs in May-June following which it wrote to the Central Board of Direct Taxes (CBDT) to take "requisite action under extant legal framework." The CBDT is the administrative authority for the tax department.

After the latest EC action, the 86 non-existent RUPPs, it said, shall be "deleted from the list of register of RUPPs and render themselves liable to be not entitled to have benefits under the Symbols Order, 1968."

The 253 RUPPs marked as inactive "shall not be eligible to avail any benefit of the Election (Reservation Symbols and Allotment) Order, 1968.'

The Commission said it is pertinent that "privilege of a common symbol is given to RUPP based upon an undertaking for putting up at least 5 percent of total candidates with regard to said legislative assembly election of a state."

"Possibility of such parties occupying the available pre-election political space by taking benefits of admissible entitlements without contesting elections cannot be ruled out. This also tends to crowd out the political parties actually contesting elections and also creating confusing situations for the voters," it said.

The Commission explained the rationale behind taking the decision saying "it is cognizant that compliances of the birth conditions, which are a combination of mandated and self-acknowledged provisions, are sine qua non for maintaining financial discipline, propriety, public accountability, transparency."

"The compliances work as the building blocks of a transparency mechanism for informing the voters of the affairs of the political parties necessary for making informed choices." it said.

In the absence of required compliances, the statement said, the electorate and the Election Commission get blindsided and further, all these stated regulatory requirements have direct bearing on the Commission's constitutional mandate of conducting free, fair and transparent elections.

The EC said parties aggrieved from the latest order may approach the concerned CEO/ Election Commission within 30 days of the issue of this direction along with all evidences of existence, other legal and regulatory compliances including yearwise (for all years under default) annual audited accounts, contribution report, expenditure report, updating of office bearers including authorized signatories for financial transactions (including bank account).

### **Delhi Court Reserves Order On Plea By 'Heir' Of Former** Ruler Of 'United Agra **Province' On Qutub Row**

New Delhi: A court here on Tuesday reserved its order on an intervention application claiming the intervenor was a "necessary party" to an appeal seeking restoration of Hindu and Jain deities in an alleged temple complex inside Qutub Minar.

The court was hearing arguments of applicant Kunwar Mahender Dhwaj Pratap Singh, who has claimed he was an heir of the erstwhile ruler of the 'United Province of Agra' and the owner of land parcels in several cities in and around Delhi, including the property of Qutub Minar.

Heard arguments. To be listed for order on September 17, 2022, at 4 pm, Additional District Judge Dinesh Kumar said.

M L Sharma, the counsel for Singh, claimed the applicant was the heir of the erstwhile ruler of the United Province of Agra who ruled the region since the 16th century. The ruling family owned the territory between the rivers Ganga

and Yamuna, he said. Sharma alleged the government had encroached upon the entire area and three petitions regarding the matter were pending in the High Court of Allahabad. Singh also made representations to the Prime Minister, the President and the authorities concerned to settle the constitutional dispute", the counsel claimed. Without any merger, treaty or instrument of accession, or paying compensation, the government took over the intervenor's land which has been encroached upon by crores of people on behalf of the government, the

counsel claimed. Meanwhile, the counsel for the Archaeological Survey of India (ASI) said Singh had no locus standi in the case and the claim of ownership had lapsed by the principle of delay and laches. The doctrine says courts will not help people who sleep over their rights.

Noting that at the present stage of the trial the court cannot decide on the veracity of the claims made in the petition, the judge asked even if they were held to be true, how was Singh a necessary party in the case?

The law is settled (on this aspect). You have to show yourself as a lawful or necessary party, the judge said.

The government might be the encroacher, but you have to get your right settled through (a separate) court, the judge said, adding, This court cannot decide the question of ownership of land.

At the last hearing on August 24, the Archaeological Survey of India (ASI) had opposed the plea, saying the intervention petition was baseless and devoid of any logical or legal reasoning".

Before the petition was filed, the court had reserved the order on the appeal against a trial court order, dismissing the suit filed by advocate Hari Shankar Jain on behalf of Jain deity Tirthankar Lord Rishabh Dev, claiming that 27 temples were partly demolished by Qutubdin Aibak, a general in the army of Mohammad Gauri, and Quwwat-ul-Islam Mosque was raised inside the complex by reusing the material.

these students don't toil to cement their places in these exams, but while doing that-of course to please their parents-many of them end up giving up on their dreams.

Therefore, they struggle with their careers after Class 12th. One can't blame them as we hardly prepare them to handle a life without NEET or IIT.

Does that mean that either Kashmiri students have no say or end up choosing a wrong subject after Class 12th?

it's not for everyone.

The only way to simplify this career complexity is to catch them young. We need to prepare students beyond Medical and Non-Medical till Class 12th and beyond. We need to expose them to newer careers.

#### But how many students excel in their choicest careers in Kashmir anyway?

Not many. And one should blame the existing educational infrastructure in Kashmir for that. There aren't any drama schools here, neither many choices for engineering. Plus, there's a lack of research in Kashmir If someone, for instance, is doing B.SC, does he even know his field opportunities? Did he see any jobs where only a B.S.C graduate is needed? There is nothing like that. Students only want to follow the fields full of opportunities. Most of them queue up for banker jobs or Class-IV jobs at the end. This is sad, because it defeats the whole purpose of their careers and courses. Why occupy, let's say, a Media Masters Program at Kashmir University, if you only want to become a probationer officer in a bank tomorrow.

Sadly, that's how it is in Kashmir. After Class 12th, students easily get swayed by their friend's subject preferences. They also keep their family interest in mind. But a career option is a scientific process based on one's interest, caliber, creativity and determination. It's a totally influenced and unscientific choice in Kashmir.

#### How should one break this jinx?

See, students in Kashmir have different priorities in the order of Science, Engineering and Humanities. Although it's changing slightly, most of them still don't follow a scientific method. They need to rise above the random-picking.

#### That means they need to seek expert guidance for some clarity?

Yes, but Kashmiri students hardly go for counseling. They only seek it when they don't get any seat in Government colleges or want to study outside the state or the country. It's just that they've something in their minds and they go for that. None of them follow the scientific method. That's why Kashmir has an employment issue.

Most of these students end up as employees rather than employers. They religiously follow JEE AND NEET exams based on their high percentages in their budding years. While low-rank holders go for Commerce or Humanities.

#### But then the same subject-line develops tunnel vision in Kashmiri students?

They do, but we need to understand that students are always stressed to perform or perish in Kashmir. The whole learning system is somewhat brutal. Children are often left at the mercy of the system.

#### And what're the academic opportunities for students at the end?

Academic opportunities are very limited in Kashmir.

There aren't many central institutions here. IIT isn't complete, while IIM is in process. We've NIFT though, but

#### So, that means a career counselor becomes a go-to person here?

Of course, students need to figure out what's best for them and only a counselor can help them out. Taking a career is a huge decision. Any mistake can ruin it. For example, if you're a professor at Kashmir University, with a caliber of Harvard, then a timely career guidance can do wonders for your career.

Today, an army of our PHD scholars are sitting home when the Class 10th or 12th certificate-holders would previously get government jobs due to political favours. Time has changed and favours have faltered, but lack of career planning is still dooming us.

## 34 Drugs, Including Anti-Cancer Medication, Added To National Essential Medicines List

**New Delhi:** Thirty-four drugs, including some anti-infectives such as Ivermectin, Mupirocin and Nicotine Replacement Therapy, have been added to the National List of Essential Medicines taking the total drugs under it to 384.

Several antibiotics, vaccines and anti-cancer drugs will become more affordable by their addition to the list. However, 26 drugs such as Ra-

nitidine, Sucralfate, white petrolatum, Atenolol and Methyldopa have been deleted from the revised list. The deletion has been done based

on the parameters of cost effectiveness and availability of better drugs. Union Health Minister Mansukh Mandaviya, who released the list today, tweeted, "Released the National List of Essential Medicines 2022. It comprises 384 drugs across 27 categories. Several antibiotics, vaccines, anti-cancer drugs and many other important drugs will become more affordable & reduce patients'

out-of-pocket expenditure." Endocrine medicines and contraceptives Fludrocortisone, Ormeloxifene, Insulin Glargine and Teneli-



glitin have been added to the list. Montelukast, which acts on the

respiratory track, and ophthalmological drug Latanoprost figure in the list. Cardiovascular medicines Dabigatran and Tenecteplase also find place in the list besides medicines used in palliative care.

"Antinfectives such as Ivermectine, Meropenem, Cefuroxime, Amikacin, Bedaquiline, Delamanid, Itraconazole ABC Dolutegravir have been added to the NLM," Dr YK Gupta, Vice Chairman of the Standing National Committee on Medicines, said.

The drugs in NLEM are included in scheduled category and their price is regulated by the National Pharmaceutical Pricing Authority, Dr Gupta said.

A revised list of 399 formulations was submitted by an expert committee under the Indian Council of Medical Research (ICMR) last year. After detailed analysis of Indian requirements, major changes were sought by Mr Mandaviya.

## Man Claims He Did Mecca Pilgrimage For Queen, Arrested In Saudi Arabia

**Riyadh:** Saudi authorities have arrested a man who claimed to have travelled to the Muslim holy city of Mecca to perform an umrah pilgrimage on behalf of the late Queen Elizabeth II.

of the late Queen Elizabeth II. The man, a Yemeni national, on Monday published a video clip of himself on social media at the Grand Mosque in Mecca, Islam's holiest site, where non-Muslims are forbidden.

In the clip, he held up a banner saying: "Umrah for the soul of Queen Elizabeth II, we ask God to accept her in heaven and among the righteous." The footage was widely circulated on Saudi social media, with Twitter users calling for the man's arrest.

Saudi Arabia forbids pilgrims to Mecca from carrying banners or chanting slogans.

And while it is acceptable to perform umrah on behalf on dead Muslims, this does not apply to non-Muslims like the queen, who was supreme governor of the Church of England, the mother church of the worldwide Anglican commu-

State television broadcast segments about the incident that included the controversial video clip, but with the banner blurred.

The umrah is a pilgrimage that can be undertaken at any time -- distinct from the hajj, which takes place once annually and usually draws millions from around the globe.

The queen died on Thursday and her funeral is planned for September 19.

## Queen Elizabeth II's Funeral: Decades Of Meticulous Planning

**London:** The funeral service of Queen Elizabeth II at London's Westminster Abbey on September 19 will be the culmination of decades of meticulous planning. Here's what we know about how

the day will unfold.

#### Return to the abbey

The last time Westminster Abbey was used for a monarch's funeral was for George II in 1760.

Since then, the preferred church has been St George's Chapel at Windsor Castle, but Elizabeth opted for a larger venue.

On the morning of the funeral, the lying in state -- begun at Westminster Hall in parliament on Wednesday -- will continue until 6:30 am (0530 GMT).

The funeral will be conducted by the Dean of Westminster, David Hoyle, with Archbishop of Canterbury Justin Welby giving the sermon.

#### Gun carriage

At around 10:30 am a bearer party will transfer the coffin from the catafalque, a raised platform in Westminster Hall, to a gun carriage which will be waiting outside the north door of Westminster Hall.
