Rs 37.15 Cr Provided To Poor Girls In J&K Last Year: LG

Says Central Act For Welfare Of Senior Citizen Implemented Post August 2019



SRINAGAR: The Union Territory administration has provided financial assistance to the tune of Rs 37.15 crore to over 9000 poor girls in Jammu and Kashmir for marriage, Lieutenant Governor, Manoj Sinha said on Friday.

Sinha made these remarks while inaugurating free artificial limbs & calipers distribution camp at SKUAST, Jammu to mark birth centenary celebrations of late Dr Uttam Chand Shastri, an official spokesperson said Friday.

"Earlier, financial assistance for marriage of poor girls were provided to 100-200 beneficiaries, but we have covered 9309 such beneficiaries in one year with overall financial assistance of Rs 37.15 crore," Sinha said.

The LG also stated that the administration is making dedicated efforts to bridge the gap between the aspirations of the citizens and the administrative



delivery for the development of an inclusive society in Jammu and Kashmir.

Sinha, according to the spokesperson said, that there was no integrated system for physically and mentally challenged people and now Divyangjan in J&K have been brought under the ambit of Pension Scheme.

"For the first time, Jammu and Kashmir has been linked with the National Trust Portal so that they are given all the facilities and rights granted to them by the Central Government," Sinha said.

"Our objective is to achieve 100% saturation of schemes for Divyangjan, women, senior citizens in the current financial year," he added.

According to the spokesperson, the LG further said that the social welfare department is implementing a comprehensive plan to reach out to the beneficiaries and a special enrolment campaign was launched.

Sinha, he said, also asserted that with the dedicated efforts, the number of beneficiaries receiving the pension benefits has doubled.

"The Central Government Act for the welfare of the senior citizen which was not applicable in J&K prior to August 2019 has been implemented. Elderline helpline is meeting their needs and geriatric wards have also been started for the care of the elderly in all the district hospitals," the LG said.

"There has been an increase of 206% in the scholarship to the children of poor families as compared to 2018-19. Till 2018, only 9500 girl children got the benefit of Ladli Beti Scheme. In three years, more than 1 lakh girl children More on P6


'Decision Of Holiday Taken To Respect Sentiments Of Locals'

Humans Evolved With Their Microbiomes Like Genes, Your Gut Microbes Pass From One Generation To The Next

When the first humans moved out of Africa, they carried their gut microbes with them. Turns out, these microbes also evolved along with them.

The human gut microbiome is made up of hundreds to thousands of species of bacteria and archaea. Within a given species of microbe, different strains carry different genes that can affect your health and the diseases you're susceptible to.

There is pronounced variation in the microbial composition and diversity of the gut microbiome between people living in different countries around the world. Although researchers are starting to understand what factors affect microbiome composition, such as diet, there is still limited understanding on why different groups have different strains of the same species of microbes in their guts.

We are researchers who study microbial evolution and microbiomes. Our recently published study found that not only did microbes diversify with their early modern human hosts as they traveled across the globe, they followed human evolution by restricting themselves to life in the gut.

Microbes share evolutionary history with humans

We hypothesized that as humans fanned out across the globe and diversified genetically, so did the microbial species in their guts. In other words, gut microbes and their human hosts codiversified and evolved together just as human beings diversified so that people in Asia look different from people in Europe, so too did their microbiomes.

To assess this, we needed to pair human genome and microbiome data from people around



the world. However, data sets that provided both the microbiome data and genome information for individuals were limited when we started this study. Most publicly available data was from North America and Western Europe, and we needed data that was more representative of populations around the world. So our research team used existing data from Cameroon, South Korea and the United Kingdom, and additionally recruited mothers and their young children in Gabon, Vietnam and Germany. We collected saliva samples from the adults to ascertain their genotype, or genetic characteristics, and fecal samples to sequence the genomes of their gut microbes.

For our analysis, we used data from 839 adults and 386 children. To assess the evolutionary histories of humans and gut microbes, we created phylogenetic trees for each person and as well as for 59 strains of the most commonly shared microbial species. When we compared the human trees to the microbial trees, we discovered a gradient of how well they matched. Some bacterial trees didn't match the human trees at all, while some matched very well, indicating that these species codiversified with humans. Some microbial species, in fact, have been along for the evolutionary ride for over hundreds of thousands of years. We also found that microbes that evolved in tandem with people have a unique set of genes and traits compared with microbes that had not codiversified with people. Microbes that partnered up with humans have smaller genomes and greater oxygen and temperature sensitivity, mostly unable to tolerate conditions below human body temperature.

In contrast, gut microbes with weaker ties to human evolution have traits and genes characteristic of free-living bacteria in the external environment. This finding suggests that codiversified microbes are very much dependent on the environmental conditions of the human body and must be transmitted quickly from one person to the next, either passed down generationally or between people living in the same communities.

Confirming this mode of transmission, we found that mothers and their children had the same

strains of microbes in their guts. Microbes that were not codiversified, in contrast, were more likely to survive well outside of the body and may be transmitted more widely through water and soil.

Gut microbes and personalized medicine

Our discovery that gut microbes evolved right along with their human hosts offers another way to view the human gut microbiome. Gut microbes have passed between people over hundreds to thousands of generations, such that as humans changed, so did their gut microbes. As a result, some gut microbes behave as though they are part of the human genome: They are packages of genes that are passed between generations and shared by related individuals.

Personalized medicine and genetic testing are starting to make treatments more specific and effective for the individual. Knowing which microbes have had long-term partnerships with people may help researchers develop microbiome-based treatments specific to each population. Clinicians are already using locally sourced probiotics derived from the gut microbes of community members to treat malnutrition.

Our findings also help scientists better understand how microbes transition ecologically and evolutionarily from free-living in the environment to dependent on the conditions of the human gut. Codiversified microbes have traits and genes reminiscent of bacterial symbionts that live inside insect hosts. These shared features suggest that other animal hosts may also have gut microbes that codiversified with them over evolution.

Highway Horror: Hilly Terrain, Overloading; Rash Driving Claiming Lives Of Passengers

Srinagar: Hilly terrain, rash driving, overloading of passengers and dilapidated condition of roads are said to be the main reasons for the spike in deadly accidents in the Pir Panjal range and Chenab valley of the Jammu region.

In less than 24 hours, 16 people have lost their lives while 50 others sustained injuries in two different traffic incidents.

exposing the fault lines in the much hyped road safety measures of the traffic department.

Lately, government figures suggest that the deaths caused by road accidents in J&K in 2021 are much higher than those killed during the three decades of conflict. However, of late, the Chenab and Pin Panjal region of Jammu witnessed more traffic accidents and deaths than the Kashmir Valley.

According to figures, 896



people lost their lives due to traffic incidents in the year 2021 reported

in J&K. Among them, 676 were reported from Jammu region

and 220 from the Valley.

The recently released Crime
Gazette 2021 by Jammu and
Kashmir Police revealed that 4506
people were injured in Jammu

last year and 2317 in the Valley.
According to the data, sixtyfive percent of road accidents
(3585) were reported from the
Jammu division. Around 1876
mishaps occurred in Kashmir. In
2020, 728 people lost their lives
in the Union Territory.

The locals lamented from

time to time that the successive governments have failed to come-up with any preventive strategy to minimise loss of lives in the road rage.

"Apart from that, there is a very thick presence of traffic cops on the road to check the wrong doings," said Mohammad Taki, a resident of Doda.

Centre To Grant Land Ownership Rights To WPRs

Jammu: In a major decision, the Centre is set to grant land ownership rights to West Pakistan refugees (WPR) in Jammu and Kashmir.

After the abrogation of Article 370, the Centre has initiated an exercise through which the ownership rights will be granted to the WPRs over lands measuring 46,666 Kanals that were allotted to them before the abrogation of Article 370.

Officials said these lands are in Jammu, Samba and Kathua districts and were allotted to the WPRs in 1954 after they migrated to the Indian side of the International Border.

"The Union Home Ministry officials have discussed the matter with the revenue department officials of J&K who have initiated the exercise," official sources said. When J&K had special status under Article 370 and 34A, the West Pakistan refugees could neither own land nor apply for government jobs as they were not state subjects of J&K.

After coming to power in the Centre, the BJP government had given Rs 5.5 lakh per family as compensation to West Pakistan and Pakistan occupied Jammu and Kashmir (POJK) refugees. After Article 370 was scrapped, West Pakistan Refugees, POJK refugees, Gorkhas and Valmikis have been declared as domiciles of I&K.

The lands on which the ownership rights will be granted to these refugees exist in Akhnoor, R.S. Pura, Bishnah in Jammu district, in parts of Samba district and Hiranagar district. (IANS)

'Today's Era Is Not Of War': PM Modi Tells Putin

Ex-Governor Malik Drops Another BombSays Sajjad Lone Wanted To Be J&K CM With Just 6 MLAs

New Delhi: Peoples Conference leader Sajjad Lone wanted to be Jammu and Kashmir Chief Minister just before the dissolution of the Assembly in 2018 although he had only six MLAs, the erstwhile State's last Governor Satya Pal Malik has said.

Throwing light on behindthe-scenes political manoeuvring that preceded the dissolution of the Jammu and Kashmir Assembly by him in 2018, Malik, now the Governor of Meghalaya, described Lone as the "blueeyed boy" of the Centre.

He said he had asked Lone to write to him about the support



he enjoyed in the 87-member House. Lone said he had six MLAs but "told me if you administer me the oath, I will prove my majority in a week".

Malik spoke of the circumstances in which he dissolved the Assembly in November 2018 although PDP chief Mehbooba Mufti had staked claim to form a Government with the support of the Congress and the National Conference (NC).

The PDP-BJP Government headed by Mehbooba had earlier

collapsed in June 2018 after the BJP pulled out of the coalition.

Malik said he had told Lone.

Malik said he had told Lone, "That is not the governor's role and I will not do it. The Supreme Court will flog me. The next day the Supreme Court will say you summon the House. You will lose. I will not do this."

The Governor said it seemed that the PDP-NC-Congress combine may have had a majority but "foolishly" they had not held a formal meeting or passed a resolution or given a letter of support "to the lady (Mehbooba)".

Enter The Durbar

he durbar is back in town after six months alongwith its elaborate paraphernalia and with it the capital city readies for the seasonal nightmare that one of the surviving vestiges of the "bad old feudal days"

brings along. The town dwellers have had the taste of the things to come days ahead when the entire area around the civil secretariat was sealed off for the lesser mortals and the securitymen carried out an exhaustive drill to test the security bandobust.

Police and paramilitary personnel carried out extensive frisking of passers by while as sharp shooters and commandoes took positions at vantage points on rooftops in the immediate neighbourhood. If the reports and pictures appearing in local newspapers were any indication, the ordeal has begun in the right earnest. The exercise was carried out in

Batmaloo, Karan Nagar, Shaheed Gunj, Magarmal Bagh, Suthra Shahi, Jehangir Chowk and even in Budshah Chowk. The city localities in the close vicinity of the civil secretariat are the worst hit with the movement of their residents being watched stingingly by the men in khaki. A resident summed up the scenario thus, "After the opening of secretariat tomorrow, our lives will become a hell".

What difference does the half-yearly move of the state government offices make to the people in rest of the city and beyond in the valley's countryside could be anybody's guess. The main road outside the secretariat will be a mute witness to long queues of desperate people jostling with one another to gain entry into the heavily fortified complex to seek solution to their manifold problems. If the reports that make headlines in the media were to be believed, barring the chosen few enjoying proximity to those at the

helm, most such people leave the premises thoroughly disenchanted and dismayed, perhaps with the famous couplet, "boo-e-gul, nala-e-dil,

dood-e-chirag-e-mehfil / jo teri bazm se nikla, so paraishan nikla", echoing deep inside them. It may not be any different this time around, notwithstanding the tall claims of `good governance' and `return of

normalcy', the rulers are never tired of making to hood-

Going by the reports, not all the departments are involved in the half-yearly up and down trek between the two capital cities. Many of them have already been divisionalised giving the desired relief not only to the officials working in them but to the people as well. With their heads of department stationed in both the capitals, the day-to-day problems get sorted out quicker than those where moving offices are involved.

In spite of the communication revolution over the years, such departments continue to work in a primitive fashion with consequent inconvenience to the

people. Normally, on their bi-annual move, these offices take around a month to settle and become fully functional. The move order issued about a month

earlier has a sedative effect on the 10,000 odd officials working in them. Apart from that, the move entails a huge unproductive expenditure running into tens of crores of rupees on the move allowances, TA, transportation and carriage of men, material and records, without bringing about any perceptible

eptible improvement in performance.

One is reminded of the ill-fated decision the former chief minister, Dr Farooq Abdullah, took in the late '70s to truncate the exercise. He was forced to

withdraw the order following stiff resistance by the powerful Jammu lobby supported by those Kashmiri officials who have a vested interest in perpetuating the time and resource consuming practice. The stock

argument offered to justify it is that it promotes emotional integration between the two regions of Kashmir and Jammu. How much of it has been achieved so far could be a matter of debate. It is an open secret

the two regions, and their respective leaderships – NC, PDP and others in Kashmir and Congress, BJP, JKNPP et al in Jammu – have rarely been on the same wave length on matters of development, recruitments or

selections for coveted professional courses, or for that matter, on several other issues like the Permanent Residents (Disqualification) Bill, the

Resettlement Act, or the on-going turmoil in the state. Even as the advisability of the feudal practice would continue to engage saner minds across the regional divide, the

chaotic situation prevailing in the
capital city of Srinagar as a result of the durbar move is
of an immediate concern. It appears the city which, incidentally, is going to be host to lakhs of tourists, both domestic as
well as foreign, has been converted into a virtual prison with

most civil lines areas declared out of bounds for the common people.

The heavy and obtrusive presence of the men in khaki all over speaks volumes about the perceptions of the present rulers. Unless the chief minister has lost his touch with the

constituency he claims to represent and sees every Kashmiri as a militant, why at all should his administration restrict the movement of the general public

around the civil secretariat. There has to be a rationale behind this anti-people decision. In case there is none, he and the coalition government that he heads has no business whatsoever to be in the office. He must know the people of Kashmir are even

the people of Kashmir are even otherwise groaning under a repressive security situation and by adding to their misfortunes he would be doing them no service. If he cannot humanize his administration, he better spare the people of the miseries and take it back to Jammu.

Chinese BRI

A success or a failure?

he recent economic upheaval followed by the political disruption in Sri Lanka, has once again made the Chinese BRI, the focus of debate whether it is beneficial or insensitive to the participating countries besides being a success or a failure

The Chinese President Xi Jinping launched the BRI with much fanfare and high promises and grandiose plans for the participating countries in 2013. It was considered to be a centrepiece of Chinese foreign and trade policy.

Basically, Belt and Road Initiative (BRI) earlier also referred to as One Belt One Road or OBOR for short, is a global infrastructure development strategy to invest in nearly 150 countries and international organisations, around the globe.

The BRI formed a central component of Xi's "Major Country Diplomacy" strategy, which calls for China to assume a greater leadership role for global affairs in accordance with its rising power and status. As of August 2022, 149 countries were listed as having signed up to the BRI.

Xi originally announced the strategy as the "Silk Road Economic Belt" during an official visit to Kazakhstan in September 2013, referring to the proposed overland routes for road and rail transportation through landlocked Central Asia along the famed historical trade routes of the Western Regions; in addition to the "21st Century Maritime Silk Road", referring to the Indo-Pacific sea routes through Southeast Asia to South Asia, the Middle East and Africa. In fact the BRI was also considered a grandiose plan to challenge the American hegemony over global trade and diplomacy.

However, the recent events in Sri Lanka, with similar echoes being heard from Bangladesh, Nepal and Pakistan has led some China watchers to conclude that this is an indicator of the hit that the Chinese economy has taken during the Covid pandemic and the BRI appears to be under revaluation with recipient countries wary of the debt trap and its economic feasibility.

Let's take a closer look at the original intent of the BRI, its expansion and its long and short-term impacts on the aid recipient countries and whether it has been a success or a failure and how the U.S. could have countered it in a much better manner.

In his report in 2020, Rafiq Dossani, Director, RAND Centre for



Asia Pacific Policy opined that China's strongest motive behind the BRI was its long-term economic security. The maritime routes of the BRI would have helped the relatively underdeveloped, land-locked areas of China such as Yunnan and Xinjiang provinces by linking them with ports in the more rapidly growing areas of

At the same time, the emerging land routes of the BRI were marked as an alternative to the South China Sea, through which most of China's trade currently passes and which is becoming a zone of contestation between the United States and China.

Dossani further explaining the reasons for the initial welcome of BRI opined that traditionally, many countries prefer to work with the World Bank and other multilateral lenders, which pro-

vide borrowers with good practices, while making significant funding available on a meritocratic rather than political basis.

But, he says further that from a developing country's viewpoint, accessing the world's spare capital has been difficult because of the risk entailed in many such investments. The Asian Development Bank estimates that Asian countries face an infrastructure investment gap of \$459 billion a year.

This logic also explains the sentiments, which in the initial stages of the launch of the BRI seemed to be the main attractive reason for the BRI projects and Chinese funding. But nine years after its launch BRI seems to have lost its sheen, due to the economic meltdown in several countries, which borrowed heavily from China under the garb of infrastructure development, progress and prosperity.

Bangladesh Finance Minister AHM Mustafa Kamal has publicly blamed economically unviable Chinese BRI projects for exacerbating the economic crisis in Sri Lanka. He says that developing countries must think twice about taking more loans through BRI as global inflation and slowing growth add to the strains on indebted emerging markets.

In fact, Bangladesh has made it clear that it will not accept any further loans but only grants from Beijing. Nepal has also taken the same stand. Pakistan with some US \$ 53 billion being spent by Beijing under the aegis of BRI also faces the same fate.

China has also invested some US \$ 44 billion in Indonesia, US \$ 41 billion in Singapore, US \$ 39 billion in Russia, US \$ 33 billion in Saudi Arabia and US \$ 30 billion in Malaysia

The cry against Chinese BRI is not limited only to the Indian subcontinent as its reverberations can be heard in the stalled US \$ 4.7 billion railway project in Kenya, also. Five years after its launch, the project ends abruptly in an empty

field, 200 miles from its destination in Uganda.

As conflicts between the United States and China appear to mount, some experts have questioned the intentions of China's BRI. It has been viewed as a debt trap for impoverished states and a means for China to expand its territorial control, but is it a reality? Is the United States missing an opportunity to participate-in or initiate parallel activities?

BRI has been repeatedly labelled a debt trap and a power grab, and perhaps this seemed like a possible scenario. However, this concept has been debunked by recent research. Deborah Brautigam, director of the China Africa Research Initiative at Johns Hopkins University, found no evidence that Chinese banks over-lend or invest in loss-making projects to obtain a foothold in those countries, in one of her studies on Chinese lending to Africa.

There is further evidence that China is not engaging in debt trap diplomacy. Brautigam has noted that in some countries the IMF has been labelled as being vulnerable. Also Chinese loans were not responsible for pushing indebted countries above IMF debt sustainability limits.

Furthermore, it should be noted that not just impoverished nations, but East Asian and Europe countries have also been smitten by the BRI. Over 18 European Union countries have joined the BRI.

In fact, rather than decrying China, the United States should engage in infrastructure lending to poor countries, and/or make it easier for multilateral banks to lend for such projects, reducing bureaucratic requirements. It should also initiate similar activities in underdeveloped or developing countries.

To better its image, China should improve transparency around BRI deals. The World Bank and other bodies have also called for increased transparency. This would go a long way in improving U.S. and other countries' understanding of Chinese intentions about the BRI.

have a friend in the US who served that country's armed forces. Being a retired serviceman, he is interested in firearms and uses them for sporting activities. He often travels to a firing range near his house to keep his skills upto-date and joins competitions on a regular basis.

During a conversation with me some years ago, he described how firearm owners sometimes shoot themselves in the foot. He explained that in actuality, these people shoot themselves in the thigh, and the bullet makes its way unerringly down the rest of the leg and into the foot. This occurs when the owner of a firearm becomes overconfident about his or her abilities and carries a concealed firearm on their person. "Concealed Carry" is a special status sought after by American gun afficionados who usually must go through focused safety training before they are issued a license by the authorities to carry a concealed gun on their person.

Evidently, these trained carriers can sometimes become so overconfident that they start carrying a concealed gun on their hips, under their shirts or jackets, that is not only loaded, but also has a bullet in the firing chamber, with the gun cocked and ready to fire.

Despite all the training, accidents happen, as they often do, and even bumping the firearm into a hard surface can cause it to go off, and the bullet in the chamber sears down the cowboy or cowgirl's thigh and thence firmly lodges itself into the foot. Ouch! It seems to me that it would be far wiser to not have a bullet in the firing chamber, even if the firearm is loaded.

Discretion is after all the better part of valour.

Has Indian IT Shot Itself In The Foot?

IT is facing structural problems from ITS short-sighted approach to mid-level hiring.

At the risk of dating myself, I have to say I have been in and around the IT services industry for at least three major economic boom and bust cycles: the early 2000s' dotcom boom and bust, the Great Financial Crisis (GFC) of 2008, and the current Covidfueled crisis.

During the first dotcom crisis, I was a senior executive at an American IT services firm, and the crude joke in those circles was that the term "B2B" stood for all the Indian origin software programmers who had been retrenched and were going "Back to Bangalore".

But Indian IT services, despite its oft-heralded demise, went from strength to strength after the world realised that it could send work to the worker, and didn't necessarily have to bring the worker to the work.

After the dotcom bust, it did well during both the GFC of 2008 and the Covid crisis of 2020-21. This time, however, it may have overplayed its hand, or to use the gun analogy, may have

been walking around with a gun strapped to its side with a bullet in the firing chamber.

While it has kept the salary for fresh IT engineering graduates about the same level for 20 years, which has not even kept up with inflation,

the need for talent with a medium level of experience during the Covid crisis went up significantly.

So, these firms started a bidding war for such talent, and were poaching staff from one another over the last two years. Many IT engineers in the 3-6-year experience bracket were being routinely offered up to twice (2X) their current salaries to switch jobs.

The work from home environment, forced on us by the pandemic, has made the barriers to switching jobs much easier; after all, you stay at the same desk at home to churn out the same code, all you're doing now is to churn it out for a different employer for twice the money.

I challenge you to find a 26-yearold who is mature enough to understand that a 2X increase in salary is a fishy proposition; it is simply too good to be true, and even if true, certainly will not last.

Overconfidence is the wont of the young, and no amount of sage advice from an elder can stand in the face of a job offer that promises a youngster double his or her salary.

And last week, right on cue, there is news that India's IT majors have started indicating that variable pay will be cut, pyramids normalised (by bringing in more fresh graduates

whose salary levels have remained static while ejecting high-cost resources), and employees brought back to the office to foster more cohesion between the firm and its employees.

Almost all Indian IT services majors have seen a worsening demand environment, while the indiscriminate hiring and poaching has caused wage bubbles in their workforce. thereby bringing their margins down by several hundred basis points. The use of subcontractors has also gone up, and registrations on IT subcontractor marketplace platforms such as TopCoder have risen by up to 60%. Equity analysts have downgraded most of these stocks and are calling for further corrections in share prices; in many cases, their target prices are 20% lower than today.

While a 26-year-old can be expected to be immature about life-choices, one would expect more maturity from the head-honchos of such companies.

Both the last crises saw the printing of new money followed by later attempts to mop up excess liquidity through interest rate hikes—indicative of a slowdown. Didn't they see this coming? Why on earth were they poaching each other's resources at 2X compensation?

Indian IT is facing structural problems from this short-sighted and overconfident approach. The irrational exuberance of the last two years will take time to iron out of the system. Expect more pain before their feet begin to heal.

Redeemable Representation Of The Modern Muslimah

hen it comes to exploring the Muslim identity in the realm of fiction, one is hard-pressed to find a story that provides a realistic narrative for the lay Muslim. Whether it's the war-waging Jihadi, the pitiful oppressed victim, or the faith-renouncing liberal, such orientalist caricatures in literature perpetuate distasteful stereotypes and provide little to no characters for average Muslims to relate to.

In the past few decades, there has been an influx of literature authored by Muslim writers, a success championed by publishers who strive to include and amplify Muslim voices in the name of diversity. Likewise, there has been a slow but distinct shift in the Muslim narrative over time. Novels that debunk popular stereotypes and endeavor to reconcile the Muslim identity with the twenty-first century are finally on the rise. Young Adult Fiction in particular has been instrumental in challenging stereotypes and carving out storylines to empower the young Muslim reader. Though there is certainly much to celebrate, there are still problematic and potentially harmful narratives that impact our impressionable youth. This does not mean we should restrict creative integrity and limit showcasing diversity within the Ummah by any means, rather that we become more conscious about the ideas and morals we promote.

Certain publishers are more than happy to support Muslim writers who pitch a 'tolerant' and 'liberal' Islam, as if Islam is inherently archaic and in dire need of reformation. The hidden agendas, covert motives, and sly narratives further a secular-liberal worldview and assert that Muslims should be grateful for any morsel of representation they receive in mainstream media. More specifically, it seems that when Muslim women are not being sexualized and fetishized in real life, we are being sexualized and fetishized in literature. True freedom apparently lies in superficiality, that is, in abandoning our hijabs, dressing defiantly and allowing ourselves to be sexualized – enjoying it, even.

A prominent Muslim author has recently written a book starring a young Muslimah with a passion for breakdancing. Despite hostility and discrimination from her peers, she powers through and pursues her dreams. At first glance, the story sounds empowering: who said a hijabi couldn't breakdance? The catch, however, is the swift introduction of the white boy love interest. Books, movies, and TV shows thrive off showcasing the brown-skinned girl (Muslim or otherwise) fulfilling the exotic fantasy of the white man. There are exceptions to this rule however.

The Beauty of Your Face centers around the life of protagonist Afaf Rahman, a culturally conflicted Palestinian-American Muslim woman. Much of Afaf's life is spent in Chicago after her immigrant parents, Mahmood and Muntaha, are expelled from their homeland Palestine and migrate to the US. Afaf, her older sister Nada, and younger brother Majeed thus grow up

as first-generation Arab Americans.
Flitting between past and present, the novel largely details each major decade of Afaf's life. The episodic nature of the narrative is such that the events of her past are peppered by an alternative perspective. The sporadic

disruptions in the overall narrative track the actions of a school shooter who has suddenly infiltrated Nurrideen Islamic School for Girls where Afaf is the principal. The events that lead up to the convergence of past and present ultimately render Afaf in an intense standoff with the shooter as narratives collide.

THE ARAB-AMERICAN-MUSLIM AXIS

Literature exploring the immigrant/ diaspora identity is nothing new under the sun. There are plenty of writers who explore what it means to be the three-in-one Arab American Muslim. Unfortunately, it is the Muslim aspect that is often the first to be sacrificed. Remarkably, Mustafah carves a narrative that does not center around a compromised Muslim identity, and in fact is quite the opposite.

The Beauty of Your Face evidences just how many interpretations of this identity there can be, debunking the orientalist myth that Arabs and Muslims are a monolith. Each character is unique in his or her attempt to reconcile their internal/external conflicting identities. On one end there lies Nada, Afaf's older sister, who wholeheartedly embraces American culture and utterly dissociates from her Arab roots by running away from home early in the novel. She expresses her frustrations prior to her escape, exclaiming, "we're Americans but they don't want us to act like it." Nada is inclined towards fully embracing the one aspect of her identity she feels will provide her the freedom she desires. Contrastingly, their mother, Muntaha, harbors the opposite sentiment. Her intense disapproval of American culture stems from it being the land that tore her family apart and caused her favourite child to leave her. Muntaha's misery calls for nothing less than a return to the homeland. In the end, both culture and religion play a key role in shaping Afaf's adulthood, with the latter taking precedence.

SCHOOL SHOOTING

The school shooting is an integral part of the storyline. Although the storv would have been intriguing enough based on Afaf's religious journey alone, the shooting proves vital in showcasing her development as a protagonist. It is during her tenth year of teaching at the Islamic school that the shooting takes place. These scenes are written from the first-person perspective of the shooter, a middle-aged white man. Mustafah does a great job at providing a granular account of the motives behind the attack from his perspective. The shooter is exposed he truly is: a radicalized, xenophobic, perverted individual who harbors sick thoughts, especially towards women. The juxtaposition of his calm, mundane demeanor on the morning of the incident and his horrifying, dastardly actions later on in the day are chillingly relayed.

What's quite interesting about the school itself is that it was formerly Our Lady of Peace, a convent. The standoff between Afaf and the shooter happens to occur in the confessional, a dwelling Afaf frequents for prayer. Within this space, the shooter also reflects on his own rocky experience with religion. Interestingly, many parallels can be drawn between events that shaped both the protagonist and antagonist's lives.

IRRELIGIOUS CHILDHOOD

The Rahman family never cared for religion, neither Mahmoud nor



certain publishers are more than happy to support Muslim writers who pitch a 'tolerant' and 'liberal' Islam, as if Islam is inherently archaic and in dire need of reformation. The hidden agendas, covert motives, and sly narratives further a secular-liberal worldview and assert that Muslims should be grateful for any morsel of representation they receive in mainstream media

Muntaha expressed an affinity for faith or spirituality, and as such their offspring were raised with little to no knowledge about Islam. Palestinian culture therefore plays a big role in cementing the Rahman family's values and traditions. The writing incorporates common Levantine vernacular (unitalicized, thankfully) in a manner that flows coherently throughout the novel. Despite the parents being fluent in Arabic, the children are not, and thus the crisis of identity is even more so pronounced. In one scene, Afaf is mocked by her Arab brethren for her lack of Arabic competency. Nada's disappearance plays a major role in exacerbating unstable family dynamics. Afaf's irreligiosity is so deep-rooted that, "she never prayed to God, not even when her sister disappeared." Ultimately, it is this lack of faith paired with parental negligence that serves as the primer of Afaf's rebellion.

DISCOVERY OF FAITH

The uniqueness of The Beauty of Your Face lies in is its faithful portrayal of Islam. Mustafah's novel digs into the core of religion, that is, salvation from worldly misery. A sad reality for many immigrants is that their journey for a better life in a foreign land often results in faith being lost along the way. Does becoming an immigrant by

necessity confer leeway in blame for a deficiency of faith? Indeed, no one expects to one day be so abruptly expelled from their homeland, and a holy land at that. As Muntaha criticizes, "why has the Lord turned away from the suffering of the Muslimeen? Why has He forsaken the Palestinians?" A lackluster understanding of religion, coupled with the devastation of losing one's homeland results in a trauma that seems unsalvageable.

Afaf's irreligious upbringing causes her to express an interest in Islam only after witnessing her father's discovery of religion after a fateful accident – "it's like he's stumbled upon a spring of water and he wants them all to drink from it." Her father's transformation is exemplary in evidencing how changed behavior speaks louder than words. Rectification of his prior behavior is more inspiring to his daughter than harsh parenting.

Afaf's key transitory moment in becoming a practicing Muslimah occurs principally during her visit to the city's Islamic Center. It is here that she has her first taste of spirituality and a desire to be part of something greater – "[she] feels like a stranger who's finally come home." The contrast between the rejection she faces by her peers at school and the acceptance she receives from the wider Muslim community

strengthens her embrace of religion. The apprehension and edginess she feels during her visit exemplifies the feeling universally experienced during a first experience. It is seldom the glorious, idealistic moment one expects. It is here that Afaf ends up befriending Kowkab, the sole hijabi at her school Kowkab becomes a significant presence in Afaf's life, instrumental in supporting Afaf on her religious journey. This moment really emphasized the importance of good company (suhba) in aiding one's religious growth and spiritual development.

ADULTHOOD

As an adult Afaf begins her teaching career at the Islamic School and at a center for refugees. Her adoption of the hijab is a notable moment, signifying just how far she has come. No longer is she the faithless, confused teenager with no sense of direction in life. She is now firm in her beliefs and wishes to display her faith to the world. The novel depicts this honorary donning as a celebratory event, with Afaf surrounded by her friends congratulating her on this bold move. Afaf's marriage to a non-Palestinian man also marks a change in her mentality and growth as they support each other as a couple and even go on Hajj with Afaf's father. Her mother's battle with mental illness, however, takes a turn for the worse. Though Muntaha is an incredibly strong figure, the façade of stability can only be kept up for so long. As Afaf returns to religion, her mother returns to Palestine, and her father returns to God.

CHARACTERS

Oftentimes, secondary and tertiary characters in stories are overlooked as their sole purpose is usually to flesh out the protagonist, rather than being distinct characters in their own right. In The Beauty of Your Face, it is these characters that define the novel alongside the protagonist. There are several pivotal moments in the book that propel each family member into finding his or her own individual purpose. The characters in Mustafah's novel are three-dimensional, familiar, and personal:

Afaf – Afaf's initial demure nature is emphasized as the sibling living in her older sister's shadow, one that is perpetuated by her disappearance. Afaf faces much discrimination in school by both her Arab brethren and her white peers. The fetishization of brown women is touched upon in the narrative, its prevalence in Western society acknowledged and accounted for. The statement, "they think she's exoticnot beautiful" demonstrates the 'otherness' that is part and parcel of a nonwhite visage. Some storylines tend to climax here - the innocent brown girl inadvertently captures the attention of the white boy who frees her from her backwards culture. Whilst the story acknowledges this, the concept imminently wanes into irrelevancy. This is not the instrumental moment that shapes the rest of Afaf's life.

Muntaha – Of all the characters in this novel, Afaf's mother Muntaha is one of the most fascinating. Afaf's relationship with her mother is complex. On the one hand, Afaf adores the doting mother who endlessly strives to maintain the presence of Palestine in their lives. However, after Nada's disappearance, her mother becomes a shell of her former self, so intensely overcome by grief that she barely acknowledges her remaining children. Muntaha's every waking thought is punctuated by a

longing for the homeland, and eventually her wish is fulfilled. Though Nada's disappearance is indeed the root of her misery, it is not the only thing that deteriorates her sanity. Mahmood was no ideal husband, and her declining mental state can attest to that.

Mahmood – Afaf's father is the key player in the turning point of the plot. It is through his own discovery of Islam after a terrible accident that his daughter Afaf herself submits. The rekindling of the father-daughter relationship does not happen overnight, rather Afaf's observation of her father's changed behavior inspires her to abandon her rebellion. Grief-stricken Muntaha, however, is skeptical of her husband and daughter's newfound faith. She criticizes her husband's sudden zeal for a religion he never formerly cared for: "So you've found religion? After all these years you think God will ever forgive you? I certainly will not." Likewise, there seems to be a sense of betrayal in her daughter following her husband's footsteps and joining him in his reclamation of faith. An avid oud player, Mahmood's comfort is found in playing the traditional Arabic instrument, a hobby that was halted after his accident. The melody of the oud suffuses an appreciation for Palestinian culture throughout the novel.

Nada - Nada's absence for the majority of the book does not render her a forgotten presence. The gap she leaves in the collective life of the family is one that is unable to be reconciled. Instead of drawing the family closer together, it drives a rift between them, hitting Muntaha the hardest. It is often the most favorite child that ends up rebelling the hardest, the constant suffocating attention having the opposite desired effect. Afaf idolized her sister, describing her as 'bold and fearless.' Nada's return towards the end of the novel was heartwarming and emotional and provided closure to her family.

Majeed – A typical younger brother, Majeed experiences the same upbringing as Afaf. Where Afaf and her father are one, Majeed and his mother are one. Majeed's affinity to his mother is birthed from his perception of Mahmood as a negligent father and careless husband. Thus, the skepticism Muntaha harbors regarding Mahmood's discovery of faith are reflected in Majeed, who eventually resents his father and spends his adolescence living out in university far from family politics.

CONCLUSION

The novel ultimately drives home the importance of family ties and the impact a holistic understanding of Islam can have on the traditional ily structure. Up until this book, I had little faith in literature doing justice to Muslim women. It is not often that one finds a narrative so personal and relatable. Afaf's spiritually devoid upbringing, teenage rebellion, family trauma, and most importantly her rocky journey to Islam are experiences many diaspora Muslims can identify with. The exploration of her renewed faith in light of her traumatic childhood and life struggles are inspiring to the Muslim and non-Muslim reader alike.

The Beauty of Your Face succeeds at providing a narrative that does not only forgo falling into clichés, but demonstrates the beauty of Islam as a means of redemption in an increasingly irreligious, immoral and shameless world.

Indian Railways Taking Big Stride On e-Auctions Of Commercial Assets

New Delhi: Indian Railways has taken steps to bring Commercial Earning and Non-Fare Revenue contracts under the ambit of electronic auction through Indian Railway e-Procurement System (IREPS).

Ashwini Vaishnaw had launched e-auction for commercial earning in June 2022. This e-auction portal has increased Railways earning and helped in realization of true value of the assets.

Since the launch of e-auction portal for commercial assets, auctions have been conducted 1,200 contracts have been awarded covering 8,500 assets. Total value of contracts awarded: Rs 844 Crore. 68 Divisions have conducted e-Auctions.

Earning Assets: Van, Pay & Use Toilets, Advertisement rights on stacirculating area and coaches, AC waiting rooms, Cloak rooms, Parking lots, Plastic Bottle crushers, ATMs, Station co-branding, Video screens for content on demand etc. These assets will be mapped location-wise in the portal once, and the system will remember forever if it is covered for earning or not. This will improve monitoring of assets on real time basis and will minimize asset-idling.

Success Stories:

1) In Khurda Road division over East Coast Railway, the FSLR Comptt. of Train No. 15643 (PURI-KYQ Exp.) put on for e-Auction on 03.09.2022, and was awarded at 80% more than the last accepted rates. It is pertinent to mention that the normal tariff rate is much

less than the LAR.

2) Ahmedabad Division had conducted e-Auction for 2 lots Gandhidham Junction & Himmatnagar (GIMB and HMT) of Parking on 04th June 2022. For Gandhidham Junction (GIMB) 24 bids were received with the highest one being 12,60,000 (Per Annum) which is 38% above Conventional Bidding Price. For HMT 26 Bids were received with the highest one being 62,500 (Per Annum) which is 72% above price of conventional bidding.

CS Chairs 5th Governing Council Meeting Of Ayushman Bharat

Jammu: Chief Secretary, Dr Arun Kumar Mehta Friday chaired the 5th Governing Council Meeting of State Health Agency (SHA) and also reviewed its performance regarding the implementation of Ayushman Bharat Pradhan Mantri Jan Aarogya Yojana (AB-PMJAY)/ AB-PMJAY Sehat here in the UT.

The meeting was attended by Additional Chief Secretary, Finance; Commissioner Secretary, Labour and Employment; Secretary, Health; Secretary, IT; Principals of Medical Colleges, Srinagar/Jammu; Directors of Health Kashmir/Jammu, Nodal Officer, SHA; SGNO, SHA; and other officers of the concerned Departments.

Jammu based officers participated in the meeting through video conferencing.

Dr Mehta impressed upon the officers to ensure that each person is facilitated to obtain the available benefits. He asked them to work for registering each person under the scheme so that the end person receives free medical care as envisaged under the scheme.

The Chief Secretary also emphasized upon the health authorities to work towards creating health history of the patients starting from those of students in our schools. He urged them to make it convenient for every person to register for the scheme at his doorsteps. He maintained that the scheme should be saturated fully in both urban and rural areas.

He exhorted upon them to conduct the Governing body meetings quarterly for timely confirmation of intervening decisions taken during this period. He made out that both audit and accounting of the scheme should be strengthened at every level for maintaining transparency in

the effective implementation of this welfare scheme.

Dr Mehta advised the health agency to study the claims of other state to make the scheme more sustainable and promising for the beneficiaries. He asked them to work out the best sustainable model in consultation with different stakeholders for extending maximum benefit to the needy patients of the UT.

The ACS, Finance made out that the administration did best to extend the health benefits uninterruptedly to the people. He reiterated that it is the endeavour of the administration to devise policy that is in the best interest of people.

In this meeting the Council gave approval to SHA for introducing 'e-RUPI Concept'as a pilot project in selected Tertiary Care hospitals in the UT. It was given out that the primary objective of using e-RUPI is reducing out-of-pocket expenditures (OOPE) borne by the beneficiaries on diagnostic tests not performed in these government run health facilities.

The meeting was informed that among the 196149 received claims amounting to Rs 353.74 crores, 147180 claims amounting to Rs 236.84 crores had already been disbursed with 35536 claims under the process at various EHCPs.

It was further revealed that 25.74 lakh eligible beneficiary families has been insured for the current policy period. It was given out that apremium amount of Rs 1840 per family is paid by government to provide free health care in 209 local hospitals (118 public+91 private) to our population across the 20 districts of J&K. Highest average claim size of Rs 18004 has been registered in this policy period from 15th of March to 31st August this year, as was informed in the meeting.

Earlier in the 4th Governing Council meeting of State Health Agency, J&K held on 08.11.2021 it was decided that State Health Agency, J&K will go ahead with the fresh tendering process by using Model tender document issued by National Health Authority.

A tender document for selection of Insurance Company for implementation of AB PM-JAY/AB PM-JAY SEHAT was floated. Pre- Bid meeting was held on 23-11-2021 at NHM Office Old Secretariat Srinagar, in which following five insurance companies participated including IFFCO TOKIO General Insurance Co. Ltd, Reliance General Insurance Company Ltd, Bajaj Allianz General Insurance Company Pvt. Ltd, United India Insurance Company and National Insurance Company.

It was found that four Insurance Companies have submitted their bids including Bajaj Allianz General Insurance Company Pvt. Ltd, National Insurance Company, IFFCO Tokio General Insurance Company, Oriental Insurance Company, the meeting was apprised.

The committee had deliberation as per GFR 2017. The procurement process for selection of an insurance service provider for implementation of ABPMJAY/ABPMJAY SEHAT has followed the "transparency, competition, fairness and illumination of arbitrariness in the procurement process/NIT has been advertised widely. Further it was ensured that the qualification criteria indicated is very minimum and used the same qualification criteria notified by National Health Authority.

The text of the bidding document wasself-containing and comprehensive without any ambiguities besides all the clarifications, modifications have been notified to the bidders and also placed on the www.jktenders. gov.in. The bidders are provided sufficient time to prepare and submit their bids, in this case, 22 days of time has been provided.

surrounded by deep gorges and river bodies as a result of which chances of survival in accidents are very less.

"In most of the accidents, the vehicles fell in the rivers and it is difficult to locate the dead bodies even," Taki said.

Mohan Lal Kaith, Senior

Superintendent of Police, Traffic Rural Jammu, told Kashmir Observer that the frequent accidents are a challenge for them and there are several factors that need to be looked-up.

In the Poonch accident, he said, the

In the Poonch accident, he said, the driver couldn't control the vehicle because of the brake failure as a result the mini-bus which was overcrowded plunged into a deep gorge.

"The driver was also in our bad books as we had challaned him on at least six occasions," Kaith said. He further said the min-bus has the

seating capacity of over 29 people but the driver had carried over 38 people. "You need to understand that in re-

mote areas the buses are usually overloaded due to less public transport," Kaith added.

In Rajouri accident, he said, there

was no overcrowding but the driver also lost the control over his new vehicle apparently due to "human error" "It will get clear once the mechani-

cal report comes" he added.

In the backdrop of two back to back deadly accidents leading to public outcry, traffic police have tightened the noose against violators and are likely to intensify the road safety measures.

"We have directed all the SHO's to go for FIR's against the drivers who resort to overloading of passengers," Kaith added.

While rejecting the allegation, Javid Naik, who operates a tour and travel company from Doda region, said they don't resort to overloading and drive very sensibly.

"If the passenger vehicles are overloaded, what about the private vehicles that become the cause of accidents," Naik said, adding "These are mere allegations. The truth is that the government is not serious about the maintenance of roads and other infrastructure in the region"

Sources said that the traffic depart-

Sources said that the traffic department lacks manpower and faces a staff crunch.

"We don't have staff to deploy at vulnerable stretches, and to check the overloading of passengers at most of the places," said an SSP rank officer, who wished not to be named.

He further added that the department is not in a position to deploy traffic personnel on every route of the region

However, Shabir Ahmad Malik Superintendent of police (SSP) Traffic, NHW, Ramban argued that in 80 percent of the accident cases, the drivers are responsible. "First they overload the vehicle,

"First they overload the vehicle, then they either use mobile or do rash driving despite knowing well that the terrain is hilly," said Malik, who is overseeing the treacherous stretch of Srinagar-Jammu national highway.

He, however, said that "engineering fault" is also one of the factors that the government needs to look into.

"The hilly roads need to be guarded with crash barriers. The super elevation of the roads is to reduce the tendency of vehicles to overturn in transverse slopes," Malik added.

Malik further noted that the reason Chenab and Pir Panjal witnessed massive traffic causalities is that the vehicle falls in a deep gorge and ultimately goes into China River. "The number of the casualties are

high because it's very difficult and time consuming to rescue the injured," he added. However the locals said the lack of

infrastructure and less transport in the

region is one of the main reasons for

the spike in accidents.
"The government has never focused on Chenab and Pir Panchal. Their entire focus was always on Kashmir and Jammu city," Zubair Ahmad Khan, a

resident of Kishtwar alleged.

Khan said the people have no other option but to choose the overloaded bus because there is very less public transport in the district.
