Centre Gears Up To Rejuvenate River Jhelum

Prepares DPR, Proposes Forestry Interventions For Natural, Agricultural And Urban Landscapes

Srinagar: In a significant move aimed to restore the pristine glory of river Jhelum, the Government of India has prepared a detailed project report (DPR) for its rejuvenation through forestry interventions.

The DPR, has been prepared by the Himalayan Forestry Research Institute (HFRI), Shimla, one of the regional institutes of the Indian Council for Forest Research and Education (ICFRE), after the Union Ministry Environment, Forests & Climate Change (MOEF&CC) asked it to do so.

The draft was finalized after incorporating the feedback and

specific comments received from Jammu & Kashmir Union Territory, line departments,

ICFRE, and MOEF&CC. According to the proposal, the first phase of the project has been planned for a duration of five years with UT's forest depart-

ment acting as its nodal agency. The DPR proposes forestry interventions for natural, agricultural and urban landscapes.

"The 'natural landscape' constituted the largest zone among the various categories of land use/ land cover of the natural environment and represented in a larger part of the riverscape. A total of 10 models/ treatment plans have been proposed focusing on forests, More on P10



Srinagar-: The State Chief Minister, Dr. Farooq Abdullah has ordered his ministers and senior officers of the administration not to use pilot jeeps, except when they are on tour outside Jammu and Srinagar cities.

The Chief Minister also ordered the measures to economise manpower and to reduce inconvenience to general public. The CM's order states there shall be only one escort jeep for ministers and chief secretary while other senior officers shall be given only a PSO and a gunman for their security.

China Blocks Proposal At UN To Blacklist Pak-Based 26/11 Lashkar Handler

United Nations: China has blocked a proposal by the US and India at the United Nations to blacklist top Pakistan-based Lashkar-e-Taiba (LeT) terrorist Sajid Mir, one of India's most wanted terrorists and the main handler of the deadly 2008 Mumbai attacks, in the third such move by Beijing within four months.

It is learnt that Beijing put a hold on Thursday on the proposal moved by the US and co-designated by India to blacklist Mir under the 1267 Al-Qaeda Sanctions Committee of the UN Security Council as a global terrorist and subject him to assets freeze, travel ban and arms embargo. Mir is one of India's most wanted terrorists and has a cash reward of USD 5 million placed on his head by the US for his role in the 26/11 Mumbai terror attacks carried out by Pakistan-based LeT terrorists.

In June this year, he was jailed for over 15 years in a terror-financing case by an anti-terrorism court in Pakistan, which is struggling to exit the grey list of the Paris-based Financial Action Task Force (FATF). Pakistani authorities had in the

past claimed Mir had died, but Western countries remained unconvinced and demanded proof of his death. This issue became a major sticking point in FATF's assessment of Pakistan's progress on the action plan late last year.

Mir is a senior member of the Pakistan-based LeT and is wanted for his involvement in the November 2008 terrorist attacks in Mumbai.

"Mir was LeT's operations manager for the attacks, playing a leading role in their planning, preparation and execution," the US State Department has said.

Last month, China had put a hold on a proposal by the US and India at the United Nations to blacklist Abdul Rauf Azhar, the brother of Jaish-e Mohammed (JEM) chief Masood Azhar and a senior leader of the Pakistan-based terror organisation. Abdul Rauf Azhar, born in 1974 in Pakistan, was sanctioned by the US in December 2010.

Beijing, an all-weather friend of Islamabad, has repeatedly put holds on listings to blacklist Pakistan-based terrorists under the sanctions com-

mittee of the UN Security Council. In June this year, China had put a hold, at the last moment, on a joint proposal by India and the US to list Pakistan-based terrorist Abdul Rehman Makki under the 1267 Al-Qaeda Sanctions Committee of the UN Security Council. Makki is a US-designated terrorist and brother-in-law of Lashkar-e-Taiba head and 26/11 mastermind Hafiz Saeed. New Delhi and Washington had put a joint proposal to designate Makki as a global terrorist under the 1267 ISIL and Al-Qaida Sanctions Committee of the UN Security Council but Beijing placed a hold on this

proposal at the last minute. The US State Department had said that Mir has been a senior

member of LeT since approximately 2001. From 2006 to 2011, Mir was in charge of LeT's external operations and planned and directed various terrorist attacks on behalf of the group. Additionally, Mir allegedly conspired to commit a terrorist attack against a newspaper and its employees in Denmark between 2008 and 2009.

For his role in the Mumbai attacks, Mir was indicted in the United States in April 2011.

In August 2012, the US Department of the Treasury designated Mir as a Specially Designated Global Terrorist. As a result of this designation, among other consequences, all property and interests in the property of Mir that are subject to US jurisdiction are blocked, and US persons are generally prohibited from engaging in any transactions with Mir.

Twenty Million Pilgrims Observe Arba'een In Karbala In Homage To Imam Hussein's Sacrifices

t is the world's biggest religious gathering, keenly observed in Iraq, Iran, Bahrain, Lebanon and many other countries. The black-clad pilgrims gath-

ered at Imam Hussein's holy shrine in Karbala on Saturday to culminate a week-long procession in commemoration of the martyrdom anniversary of the Prophet Mohammad's grandson, who was killed along with his companions during the battle of

Karbala in 680 AD. Men, women, teens and elders came together in their millions in the Iraqi city to pay tribute and renew their allegiance to Imam Hussein (AS), who is the all-time icon of fighting injustice, oppres-

sion and despotism. The annual event, which is one of the largest religious congregations in the world, brings together a deluge of Imam Hussein's lovers and devotees from

various nationalities who undertake an 80-km walk between the holy cities of Najaf and Karbala. Tents and special stands called Moukeb in Arabic are set up on the path leading to the shrine to

provide pilgrims with food and

other services. In the past two years, attendance estimates were lower than usual due to coronavirus measures that limited the number of foreign pilgrims entering Iraq.

"We are happy to serve as many pilgrims as possible. We all noticed these exceptional numbers of pilgrims that came to Karbala after the coronavirus pandemic," said Ali al-Badri, an official in charge of Iraq's media services, adding that the teams covering departments such as cleaning and the provision of services were mobilized to cater for the needs of the pilgrims coming from Iraq and abroad.

"We distribute about 5000-6000 rations per meal, between breakfast, lunch and dinner and we are continuing, God willing, we are continuing, God whi-ing, we are happy," said Haider al-Kaabi, who heads a group providing pilgrims with shelter and food free of charge.

For the past weeks, pilgrims from countries including Iran, Afghanistan, Pakistan, Azerbaijan, Bahrain, Kuwait, and Saudi Arabia, have been arriving in Karbala, located about 100 kilometers southwest of the Iraqi capital of Baghdad.

Iran's government said on Wednesday that a record num-

ber of Iranian pilgrims, more than three million, flocked to Iraq to participate in the Arba'een commemorations.

Ali Bahadori Jahromi, a spokesman for the Iranian government, said around 1.5 million Iranian pilgrims have already returned from the pilgrimage.

The tradition, which attracts an average of 16 million people from across the world every year, is meant to sympathize with Imam Hussein (AS) on the pains he endured in the event of Karbala, where he and 72 of his companions were brutally slaughtered by Yazid's army.

The ceremony is also fervently observed by Muslims in their own countries across the world.

Millions of Iranians also flock to the holy shrines across the country and to local mosques to commemorate Arba'een.

People in the Iranian capital of Tehran, under the banner of 'Those left behind from Arba'een', take part in a symbolic march to the holy shrine of Hazrat Abdol Azim Hassani in the southern city of Rey.

World Leaders Begin Gathering In UK For Queen Elizabeth's Funeral

London: World leaders begin gathering in London from Saturdav for the funeral of Queen Elizabeth II, as princes William and Harry are set to lead a vigil of her grandchildren at her coffin.

The queen's death on Septem ber 8 aged 96, after a record-breaking 70 years on the throne, has sparked an outpouring of emotion. Members of the public braved waits that at one point were estimated to be up to 24 hours and chilly night-time temperatures to view her coffin.

Lines have snaked for miles along the River Thames since Wednesday when her coffin was brought to the UK parliament complex to lie in state. Police are mounting Britain's

biggest-ever security operation for Monday's funeral, as hundreds of dignitaries including US President Joe Biden are set to jet in.

The queen's successor, King Charles III, will meet on Saturday with the prime ministers of the Commonwealth realms -- the 14 former colonies over which he now reigns in addition to Britain. From Australia and New Zealand to Canada, they have formally proclaimed him their new sovereign. But republican movements are gaining ground, and efforts to keep them all in the royal fold will

likely be a feature of his reign. Charles on Friday wrapped up his maiden tour as monarch to the four nations of the United Kingdom with a visit to Wales, part of an operation dubbed "Spring Tide" to launch him in his new role.

Large crowds in Cardiff chanted "God save the king" as he shook hands with well-wishers following a multi-faith service in Llandaff Cathedral, and at Cardiff Castle.

Charles met Welsh First Minister Mark Drakeford, an avowed republican, and there was isolated booing on the streets after the new monarch was quick to declare his son William the new Prince of Wales. But Drakeford said questions over the future of the monarchy were "a footnote to the dominant feelings of the day". - 'Tide of emotion' -

Back in London, Charles held a 15-minute vigil with his siblings -- Princess Anne, Prince Andrew and Prince Edward -- around their mother's casket on Friday night.

They stood, eyes lowered and silent, while members of the public filed past. Andrew -- stripped this year of his royal titles over a sex assault scandal -- was allowed to wear military uniform for the only time during the 11-day mourning period.

The Duke of York, as he is also known, flew Royal Navy helicopters during the 1982 Falklands War with Argentina. The vigil will be repeated on Saturday evening by eight of the queen's grandchildren, including the new heir to the throne Prince William and his estranged brother Harry.

Harry -- who served two tours with the British army in Afghanistan -- has reportedly also been given special permission to wear his military uniform despite no longer being a working royal.

The move appeared to be the latest olive branch offered to Harry by the royals after he and his wife Meghan launched accusations of racism in interviews from their new home in the US.

The personal sorrow of the queen's family has been playing out in the glare of intense international attention.

But the queen's youngest son Edward said: "We have been overwhelmed by the tide of emotion that has engulfed us and the sheer number of people who have gone out of their way to express their own love, admiration and respect."

years ago but defects have never been rectified, the Supreme Court Registrar has decided not to register 13,147 matters that have had uncured defects since August 19, 2014.

In a notification, the top court Registrar, Chirag Bhanu Singh observed that "a bunch of 13,147 unregistered but diarized cases have been registered prior to the year 2014, to be precise before August 19 2014."

Bridge Collapse

illars of a bridge that connects more than 100 villages of Bandipore area in the north Kashmir district of Baramulla are reported to have given way just a day after it was thrown open for vehicular traffic. Constructed over a ferocious and flood prone nullah at Papchan on Srinagar – Bandipore road at a cost of Rs 10 lakh, it developed cracks shortly after a vehicle passed over it on 8th of this month. People of the area, who had awaited the inauguration of the facility rather eagerly over several months past, have accused officials of the roads and buildings department of being hand in glove with the local contractor in the use of sub-standard material in the bridge construction. They have sought a high-level investigation into it with exemplary punishment to the guilty. Confirming that a part of the bridge had development some "minor" cracks, the chief engineer of the department sought to belittle the damage by asserting that the bridge was in tact and that it was not a vital bridge. That itself reveals the complicity of the engineers in the fraud that has been perpetrated not as much on the public exchequer as on the people's faith in government. Nothing could be more ridiculous than seeking to under rate a major district road on which Papchan bridge is located. Even earlier, the vital road link has been in the news for all the wrong reasons. For several years, transporters had refused to ply vehicles on the road because of its horrible condition. As a result, passengers and commuters were forced to take detour via Sopore to reach their destinations. The renovation and upgrading of the road cost the exchequer crores of rupees after which the vehicular traffic on it has resumed. Incidentally, avenue trees worth tens of crores of rupees that lined the 50 odd kilometer long road were also mowed down, allegedly with official connivance. Instead of initiating steps to make good the huge loss, the government apparently acquiesced at the loot.

The collapse of Papchan bridge may not be the only case where the construction agencies and officials joined hands to loot the public exchequer. In this particular case, the lives of people too were put to risk had the bridge given way when a vehicle crossed over it. In fact, most engineering departments are notorious for pocketing the better part of the funds provided for various development works. The roads and buildings department alone gets lot of money as maintenance grant for the annual upkeep of various facilities like roads, bridges and buildings under its charge. Over the years, the outlays must have aggregated to crores of rupees. However, it should be anybody's guess how much the allocation has indeed been utilized for the purpose it was made. One certainly need not scrutinize the records of various divisions and sub divisions of the department. The very condition of roads, bridges and government buildings, particularly in the hinterland should suffice to unravel the truth. One is left with an inescapable impression that better part of the huge expenditure claimed to have been incurred on their maintenance has gone into amassing luxurious assets and raising mansions by officials of the department. Indeed, this is true also about other disciplines like the irrigation, flood control, hydraulic and mechanical engineering departments. Sadly, the high profile public accounts committee of the state legislature has seldom bothered itself with the physical check of the works claimed to have been executed by these departments. More often than not, its voluminous reports placed on the floor of the houses speak of an inconsequential exercise in beating about the bush. One would wish the committee, while scrutinizing the records, also took the trouble of ascertaining whether the works had actually been executed. Jammu and Kashmir is a poor state chronically dependent on grants and loans from the government of India to run its affairs and to implement various welfare programmes for its people. Because of the rampant corruption, however, the better part of the resources has been going down the drain with the result that the intended benefits did not accrue to the target groups. Instances are galore where the welfare projects executed by various government departments over the decades with heavy investments have gone defunct. Sadly, instead of going into the causes of their failures, the government has virtually written off the resultant losses. Now that the chief minister, Ghulam Nabi Azad, has committed himself to rooting out the canker of the allpervasive corruption and has even mounted an all out offensive for the purpose, the collapse of Papchan bridge could serve as a test case to initiate action against those allegedly involved in the loot that has been going on almost routinely. By bringing them all to justice, the government could send a strong message across the administration, more so to the corrupt elements present in all its outfits in abundance. He should know it better than anyone else that mere threat of action against the corrupt without actually taking the action will lead him nowhere in his crusade against the malaise that is eating into the vitals of the society.

Azad in J&K

Former Congress leader is gaining attention nationwide and in Jammu and Kashmir thanks to the momentum his dramatic resignation from the Congress has created

ormer Congress leader Ghulam Nabi Azad's decision to float a new party has suddenly redrawn the political landscape of Jammu and Kashmir. His recent rallies across Jammu and in the Vallev have witnessed a significant attendance of people. Riding on the momentum generated by his dramatic resignation from Congress, which saw him launch a blistering attack on Rahul Gandhi, Azad is wallowing in attention across the country and in J&K. And he is trying to make the most of it by rallying people around his soon to be named party. Considering the existing state of affairs in Jammu and Kashmir, he snugly slots into a political space that gives him wider acceptability. His biggest advantage, for example, is that he effortlessly straddles otherwise yawning political divides in both the regions.


In the Valley, his advantage is that no one expects him to be adversarial towards New Delhi, a characteristic that is expected of every Kashmir based leader. In fact, a Kashmiri leader's popularity is directly proportional to how aggressively he challenges New Delhi's hegemonistic policies - real and perceived - towards Kashmir. Azad is not burdened by such expectations and therein lies the secret of his modest acceptability in the Valley.

In Jammu, while Azad may have lost the last parliament election to the current union minister Jitendra Singh, he enjoys considerable goodwill in parts of the region, if not an easily identifiable support base. In the Hindu-dominated region, his pro-India credentials remain impeccable - an attribute now certified by Prime Minister Narendra Modi. Last year, when Azad's Rajya Sabha tenure came to an end, the PM teared up during his farewell speech while reminiscing about his long association with the former Congress leader.

Azad has also been smart enough to locate his politics at the only conceivable political meeting ground between the people in the Valley and the majority community in Jammu: He doesn't demand the restoration of Article 370 which faces opposition in Jammu's Hindu dominated areas but he wants protection for jobs and land, something that resonates with both the regions.

This is here that Azad threatens to upset the apple cart. And to his advantage, if things don't go well enough for the BJP, the saffron party would be content with a potential cameo role by Azad for one important reason: he could help splinter further Muslim vote and potentially stymie a Valley based party's or a coalition's bid to get a reasonable number of seats let alone a majority.

With Azad's entry, the political scene has become even more crowded. His will be the second political entity after the Apni Party to have come up after the abrogation of Article 370 in August 2019. Now, there are around eight parties - BJP, NC, PDP, Congress, PC, Apni Party,

AAP and Azad's party - helmed either by major leaders or the major political organizations jockeying for power. This excludes other minor organizations such as the Panthers Party, Communist Party, Engineer Rashid's party etc. Such a congested political space is unlike any other state in the country - some of which with a disproportionately larger population - where the principal electoral contest is largely confined to two to three parties.

So, who is going to come out on top? It is impossible to make a guess. But there are several scenarios that could play out. Azad, no doubt, has his political strengths, but it is difficult to predict what his party would actually end up doing: One possibility is that it would split the Muslim vote in Jammu and to a lesser extent in Kashmir Valley - a la Assadudin Owaisi in the UP. Or he could garner a significant number of seats in Jammu and a few more in the Valley, and thereby emerge a consensus candidate for chief ministership which even the BJP wouldn't grudge - a la Mufti Mohammad Sayeed in 2002.

As for the BJP, it is still favourite to win hands down in Jammu. In the event, Azad's party splits Muslim vote in Jammu, the BJP could again end up making a clean sweep in the division, something that could help it emerge as the single largest party in the union territory and thus in a position to install J&K's first Hindu chief minister in a coalition with some Kashmiri-based parties.

What about the People's Alliance for Gupkar Declaration which mainly comprises of the NC and the PDP? In the DDC election held last year, the alliance won a majority without even campaigning and without even people participating in large numbers. Would it repeat the performance in the Kashmir Valley and in Jammu's Muslim dominated areas. One can only make a guess. But much has changed since the DDC election and now. Sajad Lone's PC has separated from the alliance and it has now been buttressed by the influx of leaders from the PDP, some of whom can boast of independent constituencies.

Can there be consolidation around the demand for the restoration of Article 370? Again it is difficult to predict anything. Some people even doubt if the electoral contest itself will even be fair.

ver since Queen Elizabeth II passed away peacefully at a great age, the British public sphere has been engulfed by waves of cloying platitudes. On a seemingly interminable loop, we hear that she was the glue that held us together, a part of us that has been taken from us, and the only stable presence in our lives. What renders our social existence so fragile and unstable in the first place that only one woman, who we would never meet, could provide "continuity" and "reassurance"? You may not ask such questions, for the mildest dissent is immediately shut down. A handful of people have already been arrested merely for anti-monarchist placards or slogans.

Given the queen's visibility and longevity, it is understandable that many Britons feel a sense of sadness at this passing, though only the very few who actually knew her will be able to mourn the private person. Yet, we are repeatedly instructed that this death is a profoundly significant moment not just for the whole country but the Commonwealth and the entire world.

Most denizens of the Commonwealth – Britain's former colonies – live precarious existences of their own, many battling catastrophic floods or famines that are nowhere in the headlines. They are unlikely to be "reassured" by the existence of a distant queen or, frankly, troubled by her demise. Many vulnerable Britons, too, face far from peaceful illness and death this winter.

Self-absorbed grandstanding is perhaps to be expected from a British media not known for nurturing diversity of opinion in a country where large portraits of the queen are now plastered serially across billboards, bus stops, tube stations, malls, cinemas, and thoroughfares, accompanied by daily public ceremonies and costumed pageantry.

It is the kind of mandated devotional unanimity that the new King Charles III once described in relation to another, non-Western

Where the response is not outright denial, there is the suggestion that one can mourn the queen separately from the empire she headed as it disbanded slowly, though never entirely, from her accession onwards. One commentator believes her to be "the antithesis of stereotypes of Empire" and the sunny side of Britishness.

This is exactly how history gets airbrushed. In 1952, as the young Elizabeth, committed in her own words to "our great imperial family", was informed at a safari lodge in Kenya that she had acceded to the throne, Britain had commenced a long and brutal counterinsurgency in that country, one that would see thousands of innocents jailed, tortured, and executed. This was not atypical of decolonisation, which was far from always gradual and peaceful.

The first years of her reign would also see tremendous suppression of anticolonialism in Cyprus, Malaya, and elsewhere. Through resistance, peaceful and violent, Britain was forced, colony by colony, to abandon the imperial project. Although she never distanced herself from either the British Empire or its atrocities, the queen is known to have accepted the reality of anticolonial nationalism - or, as Prime Minister Harold Macmillan called it, "winds of change". This does not mean she gifted independence to subjugated states or that she eased them into nationhood.

As Britain's ruling classes scrambled to control the narrative of the loss of imperial power, they produced the myth of decolonisation as a managed and planned process. Elizabeth II's involvement was central to this myth and also in mediating between opposing groups like African nationalists and white settlers.

The "Commonwealth" to which she became deeply committed was not the antithesis of empire but part of the fudge by which the "great imperial family" overnight became a "Commonwealth of Nations" with the queen – and now Charles – at its head. This was not a retreat, the story goes, but a fulfilment of Britain's original civilising mission.

The trouble with myths is that they prevent an honest reckoning with history or what Elizabeth II euphemised as "difficult episodes in our past" which she was clear should not be revisited. Such an attitude simply consolidates Britain's ongoing imperial amnesia and tendency to praise the British Empire without acknowledging the many harmful consequences that still shape the lives of millions today. The descendants of the enslaved and the colonised are repeatedly exhorted to "move on from this painful legacy", to use former Prime Minister David Cameron's words.

those who announce themselves republicans should acknowledge that it is perfectly possible, indeed normative, to have elected heads of state and government while maintaining precisely as grotesquely unequal a society as in Britain. The American fascination with the British monarchy is in part explicable through the fact that a tiny number of multibillionaires, unanointed monarchs, own more than half that country's wealth. If we want a more democratic and equal world, it is not just the British monarchy that must be abolished but plutocracy itself.

Grapes in Kashmir FROM ABUNDANCE TO NEGLIGENCE

hroughout Kashmir's history, the ruling dynasties and monarchs from time to time took interest in the cultivation of grapes. But today it has entered the dark phase of history. Neither the government nor people take serious note to revive this age-old practice. The grape plant is found in almost all home gardens in Kashmir still but people still pay no attention to cultivating it extensively.

Harud, the harvesting season of Kashmir starts from mid-September to mid-November. During this period people are busy cutting paddy, picking fruits, unearthing underground veggies, etc. These days people harvest grapes to keep a share and give away the rest to neighbours, relatives and friends. You should know this except for a few areas of Kashmir grapes are not grown for commercial purposes.

The soil and climate have always been suitable for the progress of horticulture in Kashmir. Viticulture or winegrowing is the cultivation and harvesting of grapes. In old days Kashmir was known for its luscious grapes. Grapefruit its Kashmiri name- Dach is a fleshy citrus fruit, highly nutritious with numerous health benefits. It varies in taste, colour, size and shape quality, Akbar introduced new varieties like Sahibi, Kishmishi, etc. (Jahangir, Tuzuk-i- Jahangiri). Bagh-e-Dilawar Khan was a famous site for vine culture and there were more than 18 varieties raised in this orchard (Moorcraft & Trebeck, Travels in the Himalayan Provinces of Ladakh and Kashmir). Superior varieties were cultivated in Lar and Raipur (Hassan Shah, Tarikh-i- Kashmir).

While Abul Fazl praised some fruits and considered them better than the tropical fruits of the plains of India he held an adverse opinion about grapes. He said, " though grapes were in plenty, finer qualities were rare". This view is supported by Bernier when he says "with the introduction of better grafts from foreign countries and by paying more attention to planting and soil, the Kashmir fruit would attain the same degree of perfection as the French".

The quality of indigenous grapes was improved side by side. In 1590 CE Muhammad Quli Ifshar, the Daroga of the gardens, first of all, grafted Kashmir fruit trees with peaches brought from Kabul. The experiment succeeded and grafting has since then been widely practised. Zafar Khan Ahsan the governor under Shah Jahan also improved the quality and taste of the cherry, plum, peach, and grapes by using better grafts and planting imported saplings from Persia and Kabul (P N K Bamzai. Culture and Political His-

THE HEAVEN OF DELICIOUS GRAPES

Sind valley in the past as well as in the present day is known for its finest grapes. Walter R. Lawrence in his famous book The Valley Of Kashmir mentioned a few vineyards at the mouth of the Sind valley. He has also praised the white and red grapes of the state vineyard at Raipur during Dogra Period in Kashmir. Thakur Janak Singh the military commander had built a bungalow there known as Bungli Bagh which is now in ruins. This is the present-day Repora village located in Lar block in central Kashmir's district Ganderbal- The grape town of Kashmir. For many centuries now Sind valley has been known for its fresh, delicious and quality grapes.

FROM VINE TO WINE

Grapes were particularly valued as fruit and were also used in brewing wine. Drinking wine seems to have been quite popular since the ancient period. The wine and grapes in Kashmir were local products. The tantric ritual requires the use of liquor, hence as a prestigious item of consumption, Kashmir preserved its wine culture. Kalhana says, "both men and women were addicted to drinking". The wine, cooled and perfumed with flowers, was appreciated as a delicious drink. It is written in Nilmatpurana that wine has been recommended especially on ceremonial occasions. ism but drinking culture is often associated with Punjabi culture. G. T. Vigne who visited Kashmir in 1835 mentioned in his treatise, "When I was invited by Sikh governor Mihan Singh to join his party at Shalimar garden I found him along with his officers in a state of drunkenness. The colonel, as he was called in Kashmir, occasionally took a little of the strong spirit of the country, which is distilled from crushed grapes left to ferment, and is much preferred to the finest wine that Europe could produce, which would not be considered strong enough". Mihan Singh is said to have ordered all the grapes harvested in Kashmir to be brought to the city for manufacturing a generous wine. Khahad signifies a place where wine was made and deposited.

"In the surroundings of Brinial- Lamar of Devsar (Kulgam) the vine is to be seen hanging in festoons about the trees, nurtured and cultivated by the natives of the district, who formerly made wine there in great quantities. At Muskhahad (Devsar) a great number of very large forty-thief-power earthen jars have been dug up at different times, and are now used by the natives as receptacles for their grain, and it is supposed that many more are buried there, they being discoverable only by a search beneath the surface of the ground, and it is supposed that wine was buried preserved in them" writes G. T. Vigne

THE VALE OF VINEYARDS

A majority of historians agree with the fact that Kashmir produced many varieties of fruit in abundance from the head start. The kings, nobles, merchants and religious saints together planted every kind of tree whether fruit-bearing or shady tree to promote the garden culture of Kashmir. Fruit cultivation, especially grape cultivation,

in Kashmir has been practised since ancient times. We have a glimpse of the aristocratic asrama life of the Saiva gurus standing on a mandapa with a goblet full of wine in the middle of the vineyard (M. A. Wani, Islam in Kashmir). Many nobles had their fruit gardens. Raja Amar Singh and Diwan Amar Nath during the Dogra period maintained their vineyards.

Grapes, writes Kalhana, "which were scarce even in heaven, were common in Kashmir". There is a reference to grape, grapevine, and vineyards in many ancient chronicles of Kashmir. While Kalhana's Rajatarangini mentions 'The town of Martanda (present-day Matan) was swelling with grapes during king Lalitadityas time', Huen Tsang who visited Kashmir in the seventh century CE makes it clear that Kashmir produced abundant fruits and flowers (Samuel Beal, Si- Yu- Ki). The 11th-century Kashmiri poet Bilhana while praising the beauties of his homeland in his poetic verses mentioned grapes growing in abundance in Kashmir.

- One side of it yields saffron,

(Bilhaņa, Vikramānkadevacarita; trans. Whitney Cox) Fruit formed a regular diet. Among the principal fruits that were eaten during medieval times pears, cherries, plums, apricots, grapes, apples, and peaches were found in abundance. An excerpt from the book Kashmir Under The Sultans, "Fruits were grown in such abundance that they were rarely bought or sold. The owner of a garden and the man who had no garden were all alike, for the gardens had no walls, and no one was prevented from picking the fruits." This claim is supported by medieval records like Tarikh-e- Rushdi and Tarikhe-Firishta. Different kinds of drinks were made from fresh fruits among them Sharbat Angoor was quite famous. The grapes were also used in making jams (murabbha)

Grapes were cultivated all over Kashmir, and vineyards were found at every nook and corner of the valley. The vines were allowed to grow on the poplars and mulberry trees (Mutamad Khan, Iqbal Nama Jahangiri). Since the local grapes were not of superior tory of Kashmir, Vol 2).

During the Sikh and Dogra periods, thousands of acres were covered with vines in full bearing. Moorcraft proclaimed, "There are said to be eighteen or twenty varieties of grapes in Kashmir of which four were of foreign introduction. These are the Sahibi, of an oblong shape and red colour; the Maska, round and yellowish-white; the Hoseini, of the same colour but long; and the Kishmish, yellowish-white or green, round and seedless; this last is small but the other three are large, the Sahibi sometimes measuring four inches in its largest circumference. They are all thin-skinned, and grow in considerable bunches; those of the Maska is not infrequently of the weight of five or six pounds. The Sahibi and Maska are both fine table- grapes; wine and raisins might be made from the other two. These sorts are usually cultivated on high horizontal trellises of wood. The indigenous vines are generally planted at the foot of poplar and run up to the height of fifty or sixty feet, bearing an abundance of fruit. The grapes are commonly thickskinned and rather rough and astringent, but juicy". There are six varieties of grapes mentioned in 'A Gazetteer of Kashmir' by C. E. Bates which was published in 1873.

GRAPES IN MARKET

It seems the difficulty of terrain and transport discouraged fruit growers to export fruits from Kashmir. Besides, the fast perishing nature of pulpy fruits that lost their taste and texture within weeks of harvest did not attract the merchant class. These delicate fruits were too fragile to be transported from one place to another. Due to the long journey, they used to spoil before reaching the market.

We don't have enough sources to know about the export of fruits from Kashmir. But a few references are there to make us believe that grapes were exported from the beginning though not on a large scale but in limited quantities. Abul Fazl in his work Ain-i-Akbari mentions that "Kashmiris bring grapes on their backs in long baskets." Though not a primary source of trade, fresh fruits and dried raisins in limited quantities were included in the export list (Jahangir, Tuzuk-i-Jahangiri). It means both grapes and dried raisins were in demand in mainland India during the Mughal Period.

Niccolo Munucci an Italian traveller mentions large quantities of vegetables and fruit were exported to the Indian market. During the 17th century, the fruit merchants reached as far as south India with the fruits (Kalimatu Taibat, Ed. Inayatullah Khan). Grapes used to sell at 108 dams a maund in Mughal times (Abul Falz, Ain-e-Akbari). Throughout Kashmir's history, the ruling dynasties and monarchs from time to time took interest in the cultivation of grapes. But today it has entered the dark phase of history. Neither the government nor people take serious note to revive this age-old practice. The grape plant is found in almost all home gardens in Kashmir still but people still pay no attention to cultivating it extensively

There are many references which show that making and drinking wine was not prohibited during the Sultanate period even though it was strongly disapproved by the orthodox section of the society. It was a common sight to see laymen and Brahman priests alike in a state of drunkenness during Hindu festivals. Despite the Islamic ban on alcohol the Muslims, who participated in these festivals, also freely partook in wine. Most of the Sultans and their nobles imbibed liquor regularly (Jonaraja, Dvitiya Rajatarangini). Zainul Abidin took it in moderation, but Haider Shah was a confirmed drunkard, and as a result, neglected his state duties. Hasan shah was in the habit of arranging drinking parties in his palace, or in the boats on the Jehlam, and used to get drunk on these occasions (Srivara, Jaina Rajatarangini).

Locally, the liquor was called 'mas' (Jahangir, Tuzuk-i- Jahangiri). Soft liquor of various types was used by all (Mohammad Sadiq Kumbu, Amal-i-Salih). It was distilled from grapes, barley, rice and mulberries (Mutamad Khan, Iqbal Nama Jahangiri). On festive occasions, there was free consumption of liquor by the participants. Anguri and Qandi were the cherished drinks of singers (Nath Pandith, Gulshan-i-Dastur). But there appears to have been a substantial decrease in liquor consumption during the later half of the 17th century (Majid Mattoo, Kashmir Under The Mughals).

Although the Islamization of Kashmir took many centuries, this tradition gradually discontinued among people but was kept alive by the ruling class. For a short period, Afghans stopped making wine but the tradition was later restarted by Sikhs.

The consumption of alcohol is prohibited in Sikh-

Moorcraft writes, "After harvesting grapes in Oc-

tober, they were kept in shallow earthen vessels till spring, then they were applied to the fabrication of wine, vinegar and brandy. The manufacture is ill-conducted, and the liquor is kept in bottles, which are stopped only with plugs of wood, twisted bark, or paper. No wonder therefore that the beverage is indifferent, but such as it is, it is sufficiently good to show that, with proper treatment and care, the wines of Kashmir might be made to rival many of those of Europe."

Dogras took great interest by investing huge amounts to boost this industry. On the shore of Dal Lake, Dogra rulers occupied 389

acres of land for vine cultivation. The vines were introduced from the Bordeaux district (the famed wine-growing region in France) in Maharaja Ranbir Singh's time. To make as good as Medoc and Barsac varieties of wine, a high-priced distillery plant was imported and set up at Gupkar on Dal Lake. Two Italians namely Signor Benvenuti and Signor Bassi were employed to look after vineyards and wine factories (Walter R. Lawrence, The valley of Kashmir).

WHY THERE IS A NEED TO REVIVE THE VINE CULTURE IN THE VALLEY

Kashmir has great potential to evolve as a booming vine industry. It is high time to reintroduce this crop for some good reasons.

The growth of horticulture with the revival of grape cultivation will immensely contribute to the state's economy. It will play its role to absorb a large number of unemployed youth thus reducing the unemployment rate which is at an all-time high in the state.

If introduced in economically backward districts of Kashmir, it will help poverty-stricken to uplift their life. Should Kashmir once again became a centre of viticulture, then entrepreneurship in this field will surely work. The bumper crop will attract investors to apply new ideas with the latest techniques.

esearchers at the Del Monte Institute for Neuroscience have found that kids who experience a traumatic brain injury (TBI), even a mild one, have more emotional and behavioural problems than kids who do not.

"These hits to the head are hard to study because much of it depends on recall of an injury since the impacts do not all require a visit to a doctor," said Daniel Lopez, a PhD candidate in the Epidemiology program and first author of the study published in NeuroImage.

Daniel added, "But being able to analyze longitudinal data from a large cohort and ask important questions as this gives us valuable information into how a TBI, even a mild one, impacts a developing brain."

Researchers used MRI and behavioural data collected from thousands of children participating in the Adolescent Brain Cognitive Development (ABCD) Study. They revealed children with a mild TBI experienced a 15-per cent increased risk of an emotional or behavioural problem.

The risk was the highest in children around ten years old. Researchers found that children who had a significant hit to the head but did not meet diagnostic criteria for a mild TBI also had an increased risk of these behavioural and emotional problems.

The University of Rochester Medical Center is one of 21 research sites collecting data for the National Institutes of Health ABCD Study. Since 2017, 340

Researchers hope future ABCD Study data will better reveal the impact these head hits have on mental health and psychiatric problems. "We know some of the brain regions associated with increased risk of mental health problems are impacted during a TBI," said Ed Freedman, Ph.D., associate professor of Neuroscience and co-principal investigator of the ABCD Study at the University of Rochester. Freedman also led this study. "With more time and data, we hope to gain a better understanding of the long-term impact of even a mild TBI."

Another Planet In Universe? New **Evidence Shows Proof**

All astronomers concur that planets are created in protoplanetary disks, which are the bands of gas and dust that encircle newly-formed young stars. Even though the universe has hundreds of these disks, it has been challenging to observe genuine planetary birth and development in these settings

Currently, astronomers at the Center for Astrophysics, Harvard and Smithsonian, have created a novel method to find these elusive newborn planets, along with "smoking gun" proof of a small Neptune- or Saturn-like planet hiding in a disk. The Astrophysical Journal Letters on Thursday published a description of the findings.

According to Feng Long, a postdoctoral scholar at the Center for Astrophysics and project leader, "directly finding young planets is highly tough and has so far only been effective in one or two situations." As they are encased in substantial amounts of gas and dust, planets are always too dim for us to see them.

Instead, they must look for signs that planet is forming beneath the dust. Long notes that in recent years, "many structures have appeared on disks that we think are caused by the existence of a planet but it could be caused by something else too." "We need new methods to examine and provide evidence that a planet exists." Long chose to revisit the LkCa 15 protoplanetary disk for her research. The disc is situated in the Taurus constellation, 518 light years away. Previous research employing ALMA Observatory images showed proof of

planet formation in the disk.

Long dug over fresh, high-resolution ALMA data on LkCa 15, mostly from 2019, and found two faint characteristics that weren't there before. Long found a dusty ring with two

In this instance, the L4 and L5 Lagrange points are where Long found the arc and clump of material. A small planet hidden between them at an angle of 60 degrees is what is producing the build-up of dust between locations L4 and L5.

Long used computer simulations to analyse the situation and determine what was accumulating the material. She discovered that the objects' sizes and placements were consistent with the presence of a planet.

Centre Issues New Rules To Simplify, Streamline Trade **Certificate Regime**

NEW DELHI: In an endeavour to promote ease of doing business, the Union Ministry of Road Transport & Highways (MoRTH) has notified new rules to simplify and streamline the Trade Certificate regime under the Central Motor Vehicle Rules, 1989.

Due to certain anomalies in been fixed at 30 days, wherein the existing rules, the applicability of the Trade Certificate was open to interpretation in many cases, leading to harassment of many business establishments.

Moreover, an application was required to be filed physically at the RTO which was a time-consuming process.

The key provisions of the new rules say that a Trade Certificate will be required only in case of vehicles which are neither registered nor temporarily registered.

Such vehicles can only be in the possession of a dealer/manufacturer/importer of motor vehicles, or a test agency specified in rule 126.

RBI Ready To Bring Card Tokenisation Norms Into Effect From Oct 1

MUMBAI: The Reserve Bank of India (RBI) is ready to bring its card-on-file tokenisation norms into effect from October 1 after various complaints were filed regarding the misuse of debit or credit cards. Several people were cheated

in the last few years by cyber frauds because they have stored their card data on the merchants website for future payments.

Let's us understand what these new norms are and why you should tokenise your card. Firstly, tokenisation means

JMI Bans Entry Of 3 Ex-Students, Including Safoora Zargar's, For "Agitating" On Campus

New Delhi: Jamia Millia Islamia has banned the entry of its three former students, including the 2020 riots accused Safoora Zargar, on its campus for "agitating" in the university over an "irrelevant and objectionable" issue.

Signed by the chief proctor, the orders dated September 14 said the competent authority has approved a campus ban on ex-students for maintaining a peaceful academic environment.

An activist and scholar, Zargar made headlines due to her alleged involvement in the anti-CAA protests after the Citizenship Amendment Act was passed by the Parliament in December 2019.

Besides Zargar, the orders have been issued against two more ex-students of Jamia Millia Islamia, it said.

While the language in the orders against the two former students is similar, the notification against Zargar mentions her involvement in organising agitations, protests and marches on the campus "against the irrelevant and objectionable issues to disturb the peaceful academic environment".

"She is instigating innocent students of the University and trying to use the University platform for her malafide po-litical agenda along with some other students," the order read.

It further said that Safoora is hampering the normal functioning of the institution. The order has come days

after the university cancelled the admission of scholar Zargar due to "unsatisfactory"

progress in her thesis work. Zargar has refused to comment on the campus ban.

She along with several other students has been staging pro-tests against the cancellation of her admission.

"Safoora Zargar is an ex-student of M. Phil, Dept. of Sociology, Faculty of Social Sciences. She is one of the accused of conspiracy with other persons to instigate and start riots in northeast Delhi on 23.02.2020. She was booked under Unlawful Activities Prevention Act (UAPA), 1967 by Delhi Police..." the order stated. "Her name was removed from M. Phil because of nonsubmission of M. Phil disser-

tation within the given period despite giving several chances and she is not a student of Jamia Millia Islamia," it added. The notices issued against two former students stated that they were at the forefront of the unauthorised gatherings of

students on the campus several times including one which took place in the University's Central Canteen on August 30.

Speaking at the inauguration of paperless courts in 30 districts in Odisha, CJI Lalit said there are many advantages of technological advancement and now a common man sitting in the remotest part of the country can have access to justice.

The paperless courts were inaugurated in presence of Justices D Y Chandrachud and M R Shah and Orissa High Court Chief Justice S Muralidhar.

"COVID-19 pandemic has taught us to adapt, change and modernise ourselves. The advantages of technology are here for us not only to witness but assimilate into our life-style," CJI Lalit said.

SCO Plans Single List Of Terrorist, Separatist And Extremist Groups Banned On Territories Of Member States

Samarkand: In a bid to combat the security threat posed by militant groups, the members of the Shanghai Cooperation Organisation (SCO) plan to prepare a unified list of terrorist, separatist and extremist organisations whose activities are banned on their territories.

In a joint declaration issued at the end of the annual summit of the eight-member bloc in the historic Uzbek city of Samarkand on Friday, the leaders of the SCO member states, including Prime Minister Narendra Modi, expressed deep concern over the security threat posed by terrorism, separatism and extremism

and strongly condemned terrorist acts around the world.

"The member states, while reaffirming a strong commitment to fight terrorism, separatism and extremism, resolve to continue to take active measures to address the conditions conducive to the spread of terrorism, cut off terrorist financing channels, suppress terrorist recruitment and cross-border movement, counter extremism, the radicalisation of youth, the spread of terrorist ideology, and eliminate sleeper cells and places used as terrorist safe

havens," it said. "In accordance with their national legislation and on the basis of consensus, the member states will seek to develop comin all its forms and manifestations mon principles and approaches stress the importance of the early

to form a unified list of terrorist, separatist and extremist organisations whose activities are prohibited on the territo-

ries of the SCO member states," said the Samarkand declaration signed by the leaders of the eight-member grouping. Briefing reporters, Foreign

Secretary Vinay Kwatra said that each of the SCO member states was very very clear in recognising the threat that this challenge poses to the region and beyond. To counter the threat of chemi-

cal and biological terrorism, the SCO members called for the compliance with the Convention on the Prohibition of the Development, Production, Stockpiling and Use Weapons of Chemical "They

destruction of all declared stockpiles of chemical weapons," the declaration said.

On the Afghanistan issue, the leaders called for creating an inclusive government in the wartorn country, which is now ruled by the Taliban.

"The member states consider it extremely important to establish an inclusive government in Afghanistan with the participation of representatives of all ethnic, religious and political groups of Afghan society," the declaration said.

The grouping also advocated the formation of Afghanistan as an independent, neutral, united, democratic and peaceful state, free from terrorism war and drugs

that the SCO member states consider the sustained implementation of the Joint Comprehensive Plan of Action on the Iranian nuclear programme important and called upon all participants to

rigorously implement their commitments for the full and effective implementation of the document. It said the impacts of global climate change and the ongoing COVID-19 pandemic pose additional challenges to economic growth, social well-being and food security, as well as to the implementation of the 2030 Agenda for Sustainable Development.

"To this end, new approaches are required to promote more effective inequitable and

sustainable economic development," it added.

The member states reaffirmed their commitment to a more representative, democratic, just and multipolar world order based on the universally recognised principles of international law, multilateralism, equal, common, indivisible, comprehensive and sustainable

security. The SCO called for creating a transparent international energy market and reducing the existing trade barriers. It called for the effectiveness

of the World Trade Organisation (WTO) as the key forum for discussing the international trade agenda and adopting the rules of the multilateral trading system.

They emphasised the need for early and inclusive reform of the organisation, focusing on its development and adaptation to modern economic realities, as well as effective implementation of monitoring, negotiation and dispute settlement functions, the declaration said.

The SCO, seen as a counterweight to NATO, is an eightmember economic and security bloc and has emerged as one of the largest transregional international organisations. India and Pakistan became its permanent members in 2017.

The SCO was founded at a summit in Shanghai in 2001 by the presidents of Russia, China, the Kyrgyz Republic Kaza Tajikistan and Uzbekistan.

Sinha also announced to set-up Common Facilitation Centres - one each in Kashmir and Jammu Division for collection, grading, sorting and packaging of wool.

"We have made significant achievements in the sector but the Government is keen to push this sector to newer heights and plug all loopholes to make this sector more vibrant. profitable, market driven, employable and sustainable," the LG said.

The spokesperson said that addressing the demands and issues of the tribal community, the LG announced that his administration will build 1000 sheds for livestock of the tribal community.

But, it is not like we cannot deal with the radicalisation here and we have to send them outside where it can be dealt. So, it is an administrative exercise at best, the DG Prisons said.

He was responding to a question over the reports of 150 detenues, including terrorists, having been shifted to jails outside J-K after they were allegedly found involved in radicalising other prisoners.

Lohia said radicalisation inside jails was not a serious issue, and the department was taking care of it.

Radicalisation happens when their minds are filled with poison. Also, if they have suffered something wrong, then the chances of radicalisation are more. So, we have to keep that in mind and we have to keep them engaged with various constructive activities like we have music camps etc., here.

An idle mind can have such thoughts, but, if there are such elements, then we have their treatment and, we counsel them as well. So, it is not a very serious issue, but yes, we take care of that also, he said.

On the issue of jailed terrorists being able to communicate with their network outside the prisons to carry out certain activities, the DG Prisons said while such incidents cannot be denied, it was not like a free highway and the department was taking preventive measures.

If we say that every prisoner talks on phone like it is a free highway, then it is not like that. You experience poor network outside (jails) and you should understand the situation inside the iails.

"So, these are narratives which are being built Things are under control, but yes, it cannot be denied completely and whatever measures are required to be taken to curb that, we will take, he added.

Lohia said jails are like hospitals where the prisoners are treated to make them better.

Jail is a correctional place. Our endeavour is that those who leave from jails, do not return to them. We give them vocational training as well so that it helps them in their future life. We have taken a number of steps, several initiatives to provide them better facilities and we will continue to make better arrangements for them, he said.



BCCI To Introduce **'Impact** Player' Rule In **Domestic T20** IANS

WORLD PATIENT SAFETY DAY WHO Urges Ending Unsafe Medication Practices

New Delhi: On World Patient Safety Day, WHO on Saturday highlighted the need to prevent avoidable harm in healthcare systems with a focus on ending unsafe medication practices and errors. In addition to causing signifi-

cant disability and death, unsafe medication practices and errors cost an estimated USD 42 mil-

lion around the world annually. In low- and middle-income countries - including in the WHO South-East Asia Region patient harm due to unsafe care contributes to an estimated 134 million adverse events annually resulting in around 2.6 million deaths, WHO Regional Director for South-East Asia Dr Poonam Khetrapal Singh said. Unsafe medication practices



and errors can occur at different stages. It can result from weak medication systems or human factors such as fatigue, poor environmental conditions or staff shortages, she said in a statement. Since 2015, the WHO South-East Asia Region has made targeted efforts to reduce unsafe medication practices and errors with a focus on addressing counterfeit and substandard products and enhancing patient safety and reporting systems.

Specific region-wide attention is paid to reducing medication-related harm in elderly patient care, intensive care, highly specialised or surgical care, and emergency medicine, Dr Singh said in the statement.

WHO continues to support countries of the region to adopt a system-wide approach in promoting safe medication practices with a focus on several priorities.

This is done by supporting policymakers to establish patient safety incident reporting and learning systems. Second, by empowering healthcare leaders to develop standard operating procedures for safe medication use while increasing health worker training and adherence, she said.

Health workers are supported to stay up to date on safe medication practices. Also, both health professionals and patients are encouraged to be aware of and act on WHO's 'Know, Check, Ask' protocol which aims at increasing public awareness about the importance of using medication safely.

AIIMS Delhi To Be Renamed? Concerned Faculty Write To Health Minister

New Delhi: The Faculty Association of AIIMS has written to Union Health Minister Mansukh Mandaviya expressing concern over the proposal of assigning a new name to the All India Institute of Medical Sciences in Delhi, contending it will lead to a loss of the institute's identity.

The Faculty Association of AI-IMS (FAIMS) had recently sought the opinion of faculty members over the government's proposal to give new names to all the 23 All India Institute of Medical Sciences (AIIMS) across the country. The faculty members op-

posed the changing of name of AIIMS, Delhi, according to the letter written by the FAIMS to the minister on Thursday. The letter further said AIIMS,

Delhi was created in 1956 with a trinity of mission for medical education, research and patient care. "An identity is linked with the name. If the identity is lost, institutional recognition is lost both within the country and outside."

"That is why famous and established institutes have the same names for centuries - Oxford, Cambridge and Harvard



universities," the letter said.

The FAIMS said if the proposal is accepted, the esteemed medical institute will face a huge loss of identity and demoralisation.

"Hence, FAIMS requests you to please do not consider any proposal for changing the name of AIIMS Delhi. This will help to maintain the premier and mentor institute status of AIIMS Delhi with respect to others in the country," the letter said.

The FAIMS also sought an appointment to discuss long-pending issues related to autonomy, in-campus accommodation and administration reform (rotation of headship) at AIIMS, Delhi.

The Heath Ministry has drafted a proposal to give specific names to all the AIIMS, including that in Delhi, based on local or regional heroes of prominence, freedom fighters, historical events or monuments of the area or their distinct geographical identity.


