On Cusp Of Retirement, Kashmiri Lecturers Still Await Regularization

aiting for the regularization of their services, around 500 contractual teachers serving the Higher Education Department of Jammu and Kashmir from the last 20 years, have crossed their upper-age limit.

"We've reached the twilight of our careers," says Dr. Yousuf Nengroo, Vice President All Jammu and Kashmir Contractual Teachers Association (JKCCTA).

"Contractual college faculty is being tossed from pillar to post by the very department they have served.'

Many successive govern-ments, Dr. Yousuf said, have

kept these teachers in the loop with fake promises.

"During former chief minister Omer Abdullah's tenure, we went on hunger strike," he said."Omar's advisor Mubarak Gul assured regularization after seven years of service, but it never happened."

Many meetings were conducted during different governments till 2017, Dr. Yousuf said, but nothing changed.

"I'm 39-year-old with M.phil, Ph.D and NET qualifications, plus10 years of experience as a contractual teacher and yet I'm working only as need-based," Dr. Yousuf said.

"Similarly, our President, Fayaz Ahmad is 54 years old



and is 6 years behind the government fixed retirement age. Where will we go now? We have no other job option left," he told Kashmir Observer.

During the contract, these teachers are made to sign affidavits, for not claiming regularization of their services. "Being highly qualified and un-

employed, we're forced to sign that affidavit," Dr. Yousuf said."Even justice Magrey said that these affidavits are being used under hard situations. We serve in difficult places, be it Tanghdar or Keran. Our contractual lecturers go there with a meager salary of Rs. 18000 and teach students at border areas. No permanent lecturer goes there.

Officials To Face Heat For Feeders POWER WOES With Highest Power Losses

Smart Metering In Jammu-Srinagar To Be Done By March 2023

Jammu: The Union Territory administration on Tuesday directed the power development department (PDD) to repair dysfunctional meters to put an end to the flat-rate system of billing, besides identifying the feeders with highest power losses followed by action against the officials.

These directions were passed by Chief Secretary Dr Arun Kumar Mehta while chairing a review meeting of the power sector in Jammu & Kashmir

at the Civil Secretariat on Tuesday, an official spokesperson said.

The CS, he said, was informed about the status of 1.15 lakh smart meters being installed in Jammu and Srinagar cities in addition to the additional 6 lakh meters to be installed subsequently.

"It was informed that 91% of the installed smart meters are already communicating and more than 64 thousand of those meters have been billed by June 2022," he added.

Mehta, as per the spokesperson said that J&K is being given utmost

priority in installation of smart meters and stressed that all these 7 lakh meters must be installed and be made operational by March 2023. He said that the CS also called for repairing dysfunctional meters putting an end to the flat-rate system of billing by the department.

Study Reveals That Babies React To Taste And Smell In The Womb

cientists took 4D ultrasound scans of 100 pregnant women to see how their unborn babies responded to flavours from foods eaten by their mothers. The research team scanned some mothers to see fetal facial reactions to the kale and carrot flavours.

A study led by Durham University's Fetal and Neonatal Research Lab, UK, took 4D ultrasound scans of 100 pregnant women to see how their unborn babies responded after being exposed to flavours from foods eaten by their mothers.

Researchers looked at how the fetuses reacted to either carrot or kale flavours just a short time after the flavours had been ingested by the mothers.

Fetuses exposed to carrot showed more "laughter-face" responses while those exposed to kale showed more "cry-face" responses

Their findings could further our understanding of the development of human taste and smell receptors.

The researchers also believe that what pregnant women eat might influence babies' taste preferences after birth and potentially have implications for establishing healthy eating habits.

The study is published in the journal Psychological Science.

Humans experience flavour through a combination of taste and smell. In fetuses it

is thought that this might happen through inhaling and swallowing the amniotic fluid in the womb.

Lead researcher Beyza Ustun, a postgraduate researcher in the Fetal and Neonatal Research Lab, Department of Psychology, Durham University, said: "A number of studies have suggested that babies can taste and smell in the womb, but they are based on post-birth outcomes while our study is the first to see these reactions prior to birth.

"As a result, we think that this repeated exposure to flavours before birth could help to establish food preferences post-birth, which could be important when thinking about messaging around healthy eating and the potential for avoiding 'food-fussiness' when weaning.

"It was really amazing to see unborn babies' reaction to kale or carrot flavours during the scans and share those moments with their parents." The research team, which also included scientists from Aston University, Birmingham, UK, and the National Centre for Scientific Research-University of Burgundy, France, scanned the mothers, aged 18 to 40, at both 32 weeks and 36 weeks of pregnancy to see fetal facial reactions to the kale and carrot flavours.

Mothers were given a single capsule containing approximately 400mg of carrot or 400mg kale powder around 20 minutes before each scan. They were asked not to consume any food or flavoured drinks one hour before their scans.



The mothers also did not eat or drink anything containing carrot or kale on the day of their scans to control for factors that could affect fetal reactions.

Facial reactions seen in both flavour groups, compared with fetuses in a control group who were not exposed to either flavour, showed that exposure to just a small amount of carrot or kale flavour was enough to stimulate a reaction.

Co-author Professor Nadja Reissland, head of the Fetal and Neonatal Research Lab, Department of Psychology, Durham University, supervised Beyza Ustun's research. She said: "Previous research conducted in my lab has suggested that 4D ultrasound scans are a way of monitoring fetal reactions to understand how they respond to maternal health behaviours such as smoking, and their mental health including stress, depression, and anxiety.

"This latest study could have important implications for understanding the earliest evidence for fetal abilities to sense and

discriminate different flavours and smells from the foods ingested by their mothers.' Co-author Professor Benoist Schaal, of the National Centre for Scientific Research-University of Burgundy, France, said: "Looking at fetuses' facial reactions we can assume that a range of chemical stimuli pass through maternal diet into the fetal environment.

"This could have important implications for our understanding of the development of our taste and smell receptors, and related perception and memory." The researchers say their findings might also help with information given to mothers about the importance of taste and healthy diets during pregnancy.

They have now begun a follow-up study with the same babies post-birth to see if the influence of flavours they experienced in the womb affects their acceptance of different foods.

Research co-author Professor Jackie Blissett, of Aston University, said: "It could be argued that repeated prenatal flavour exposures may lead to preferences for those flavours experienced postnatally. In other words, exposing the fetus to less 'liked' flavours, such as kale, might mean they get used to those flavours in utero.

"The next step is to examine whether fetuses show less 'negative' responses to these flavours over time, resulting in greater acceptance of those flavours when babies first taste them outside of the womb."

Stargazers Capture Jupiter, Its 4 Moons In Rare Closest **Date With Earth**

targazers across the world were left mesmerised when they caught the closest glimpse of the giant gas planet with its four moons -some lucky ones saw it with just binoculars.

People took to Twitter with images and videos they captured of Jupiter along with its four largest moons --Io, Europa, Ganymede and Callisto, called the Galilean satellites.

"After staying up all night shooting it, here is my shot of Jupiter at 'Opposition'. This is the closest it has been to Earth in 59 years," tweeted Andrew McCarthy, a stargazer from Arizona state in the US.

From the viewpoint of Earth's surface, opposition happens when an astronomical object rises in the east as the Sun sets in the west, placing the object and the Sun on opposite sides of the Earth.

Aloke Kumar, Associate Professor at Indian Institute of Science, Bengaluru, tweeted: "Jupiter so bright. It is peering right through the clouds! You can even see three of the Galilean moons!"

Some people took the shots of Jupiter with highend cameras of their smartphones, and some with large telescopes were able to see the Great Red Spot Jupiter's opposition occurs every 13 months, making the planet appear larger and brighter than any other time of the year.

Recruitment Of Assistant Registrars, Junior Assistants

Aspirants Question Delay In Recruitment Process **From KU Authorities**

rinagar: In view of the alleged reports that said that the recruitment process for the posts of Assistant Registrar and Junior Assistant at University of Kashmir (KU) has been 'quashed by Raj Bhawan' following the allegations of some fraudulent activities, a dilemma has gripped among the aspirants for these vacancies

It has been learnt that the posts were advertised in 2019 but were not filled up within the stipulated time of two years as per the university's own recruitment rules.

"In 2021, the then Vice Chancellor Talat Ahmad has extended six months to the validity of the lapsed posts, the aspirants said. Many aspirants however said they have been told by some university officials unofficially that "these posts are being re-advertised because the recruitment process has been reportedly quashed by the Chancellor's office after serious allegations of fraud were inquired into and found to be prima-facie true"

We want to know the final decision. We will apply for some other posts if the recruitment process has been declared null and void," said a group of aspirants for posts of Assistant Registrar.

Political Strands in Jobs Racket Revealed

'NC Block President Has Earned Rs 40 Lakh Duping Jobless Youth'

RINAGAR-Several political strands appear to be attached to the recently unearthed fake jobs scandal in Shopyan, with a block president of a political party arrested along with a gazetted officer and four others so far.

Scores of fake appointment orders for government jobs are reported to have been seized from the arrested persons.

Investigations have revealed that the arrested political functionary has extracted Rs 40 lakh from jobless youth so far by luring them with promises of government jobs, and the network was spread all over the valley. The sensational racket come to light when a Chatragam resident, Abdul Ghaffar Bhat, filed a complaint with the Zainapora police that one Ali Muhammd Ganai of his village had demanded a bribe of Rs 1 lakh from his son for securing him a job in the Social Forestry Department, and gobbled up Rs 70.000 as advance.

The complaint said that to dupe people, Ganai used fake appointment orders prepared by his son, Altaf Ahmad. The Zainapora-police station registered a case under sec-

tions 419, 420 and 467 of the RPC, and handed the case over to the superintendent of police for Shopyan, Joginder Singh.

In the meantime, the police arrested Altaf Ahmad, and seized a Social Forestry uniform, an identity card and a fake appointment order from his possession. The superintendent of police said that a suspicious list of

200 employees under the name of the Social Forestry Department was published in a newspaper, and on investigations it was found to have been issued by a shopkeeper in Budshah Chowk, Srinagar, Manzoor Ahmad.

As the case was pursued, Manzoor told the police that the list had been given to him by an acquaintance who often came to his shop and passed himself off as a DFO.

The superintendent of police laid a trap and arrested the phony DFO when he next visited the shop. He was later identified as Ghulam Nabi Bhat of Kawoosa, Budgam, who was an employee of the forest department.

'Twenty fake appointment orders and a number of identity cards were seized on the instance of Bhat, and during interrogation he had revealed the names of several of his accomplices, following which a gazetted officer of the civil secretariat, Abdul Majeed Zargar of Neehama, Beeru, and Muhammad Yaqoob Sheikh of Makhdoom Sahib Srinagar and Ghulam Nabi Bhat of HMT were arrested.

A further 40 fake appointment orders, state subject certificates and educational certificates were recovered after their questioning.

The SP said that Zargar used to work in the secretariat's General Administrative Department, and had been suspended in a case of fictitious appointments, but had later been reinstated.

Supreme Court Reserves Verdict On Pleas Challenging Centre's 10% Quota For Poor



New Delhi: The Supreme Court today reserved its verdict on a batch of pleas challenging the validity of the 103rd Constitution amendment providing 10 per cent reservation to economically weaker sections (EWS) persons in admissions and government jobs.

A five-judge Constitution bench headed by Chief Justice Uday Umesh Lalit reserved the verdict on the legal question of whether the EWS quota violated the basic structure of the constitution after hearing a battery of senior lawyers including Attorney General KK Venugopal and Solicitor General Tushar Mehta in the marathon hearing that

lasted for six-and-half-day. Academician Mohan Gopal had opened the arguments in the case before the bench, which also comprised Justices Dinesh Maheshwari, S Ravindra Bhat, Bela M Trivedi, and JB Pardiwala, on September 13 and opposed the EWS quota amendment by terming it as "deceitful and a backdoor attempt" to destroy the concept of reservation.

Senior lawyers including Ravi Verma Kumar, P Wilson, Meenakshi Arora, Sanjay Parikh, and KS Chauhan and advocate Shadan Farasat also assailed the quota, saying it also excluded the poor belonging to the Scheduled Castes (SCs), Scheduled Tribes (STs), and Other Backward Classes (OBCs) categories, and defeats the creamy layer concept.

Tamil Nadu, represented by senior advocate Shekhar Naphade, also opposed the EWS quota, saying the economic criteria cannot be the basis for classification and the top court will have to revisit the Indira Sawhney (Mandal) judgement if it decides to uphold this reservation.

On the other hand, the attorney general and the solicitor general vehemently defended the amendment, saying the reservation provided under it was different and had been given without disturbing the 50 per cent quota meant for the socially and economically backward

classes (SEBC). Hence, the amended provision does not violate the basic structure of the Constitution, they said. The solicitor general argued in

detail about the state's power to take affirmative action to elevate the poor among the general category and said the constitutional amendment strengthens the basic feature of the Constitution and its validity cannot be tested on grounds of some statistics.

He said the EWS quota was "necessitated" to benefit the general category poor, a "large segment" of the population not covered under any existing reservation scheme.

Senior advocate Gopal Sankarnarayanan, appearing for NGO 'Youth for Equality', supported the EWS quota scheme, contending it was "long overdue" and a "right step in the right direction." The top court heard as many as 40 petitions and most of the pleas, including the lead one filed by 'Janhit Abhiyan' in 2019, challenged the validity of the Constitution Amendment (103rd) Act 2019.

The Central government had filed some petitions seeking the transfer of pending cases, challenging the EWS quota law, from various high courts to the top court for an authoritative pronouncement.

The bench, on September 8, had framed three broad issues for adjudication arising from the pleas challenging the Centre's decision to grant 10 per cent reservation to EWS in admissions and jobs.

The bench had said the three issues suggested by the attorney general for the decision "broady" covered all the aspects relating to the petitions on the constitutional validity of the de-

cision to grant the reservation. "Whether the 103rd Constitution amendment Act can be said to breach the basic structure of the Constitution by permitting the State to make special provisions, including reservation, based on economic criteria," read the first issue framed.

India, Pak Both Partners Of US With Different Points **Of Emphasis: Biden Admin**

ndia and Pakistan are both partners of the US with different points of emphasis, the Biden administration said Monday, a day after visiting External Affairs Minister S Jaishankar questioned the rationale behind the latest American F-16 security assistance to Islamabad. Referring to the argument

made by the US that F-16 sustenance package is to fight terrorism, Jaishankar had said everybody knows where and against whom F-16 fighter jets are used. "You're not fooling anybody by saying these things," he said in response to a question during an interaction with Indian-Americans.

"We don't view our relationship with Pakistan, and on the other hand, we don't view our relationship with India as in relation to one another. These are both partners of ours with different points of emphasis in each," State Department Spokesperson Ned Price told reporters at his

daily news conference. "We look to both as partners, because we do have in many cas-

es shared values. We do have in many cases shared interests. And the relationship we have with India stands on its own. The relationship we have with Pakistan stands on its own," he said. Early this month, the Biden administration approved a USD 450

million F-16 fighter jet fleet sustainment programme to Pakistan, re-



versing the decision of the previous Trump administration to suspend military aid to Islamabad for providing safe havens for the Afghan Taliban and the Haggani network.

we can to see to it that these neighbours have relations with one another that are as constructive as can be possible. So that's another point of emphasis," Price said in response to a question.

Responding to another question, Price said it is "not in Pakistan's interest to see instability and violence in Afghanistan".

Neo-Fascists Win Big In Italy, Meloni Set To Be Country's First Woman PM

party with neo-fascist A roots, the Brothers of Ita-ly, won the most votes in Italy's national elections, looking set to deliver the country's first far right government since World War II and make its leader, Giorgia Meloni, Italy's first woman premier, near-final results showed on Monday.

Italy's lurch to the far right immediately shifted Europe's geopolitical reality, placing a eurosceptic party in position to lead a founding member of the European Union and its thirdlargest economy.

Right-wing leaders across Europe immediately hailed Meloni's victory and her party's meteoric rise as sending a historic message to Brussels.

Near-final results showed the centre-right coalition netting some 44 per cent of the parliamentary vote, with Meloni's Brothers of Italy snatching some 26 per cent.

Her coalition partners divided up the remainder, with the antiimmigrant League of Matteo Salvini winning nearly nine per cent and the more moderate Forza Italia of ex-Premier Silvio Berlusconi taking around eight per cent. The centre-left Democratic

Party and its allies had around 26 per cent, while the 5-Star Movement – which had been the big-

gest vote-getter in the 2018 par-

liamentary elections - saw its share of the vote halved to some 15 per cent this time around.

Turnout was a historic low of 64 per cent. Pollsters suggested voters stayed home in part in protest and also because they were disenchanted by the backroom deals that had created the three governments since the previous election.

"If we are called to govern this nation, we will do it for evervone, we will do it for all Italians and we will do it with the aim of uniting the people (of this country)," Meloni said. "Italy chose us. We will not betray (the country) as we never have."

While the centre-right was the clear winner, the formation of a government is still weeks away and will involve consultations among party leaders and with President Sergio Mattarella. In the meantime, outgoing Premier Mario Draghi remains in a caretaker role. – AP

Foreign Companies Looting Yemen's Oil Must Heed Warnings: Ansarallah

Temen's Ansarallah resistance group renewed a warning to foreign oil companies operating in areas under the control of the Saudiled coalition and its allies about repercussions if oil revenues are not used to pay the salaries of public sector employees.

"Foreign companies that plunder our wealth should take the warning of the leader of the revolution [Abdul-Malik al-Houthi] seriously, if the salaries and the other points necessary to renew the truce are not complied with." the spokesman for the resistance, Brigadier General Yahya Saree, tweeted on 26 September.

One week ago, Ansarallah leader Abdul-Malik al-Houthi occused the coalition of looting

borders, facilitating the entry of 18 UN-approved fuel ships to the port of Hodeidah every two months, allowing two flights a week to and from Sanaa International Airport, holding a meeting between the warring sides to improve the freedom of movement of Yemenis, and using Yemen's oil revenue to pay government employees.

However, since the initial signing of the agreement in April, the government in Sanaa says the Saudi-led coalition has violated the terms thousands of times.

The violations did not only involve military attacks, but also the seizure of emergency fuel ships headed for the port of Hodeidah and the plundering of Yemen's natural resources.

During this time, Riyadh has also reportedly looted at least one billion dollars worth of Yemeni oil Earlier this month, Ansarallah officials communicated to the UN the US, and the EU that - if Riyadh continues to violate the terms of the truce - Sanaa's response "will not be limited to the normal military aspects," but will be commensurate to the suffering being inflicted on the Yemeni people.



Ukraine War Enters New Phase As Annexation Votes Draw To Close

referendums nnexation in four occupied areas of Ukraine will draw to a close later on Tuesday, paving the way for Moscow to officially seize more territory and expand its military operation, possibly within days.

The votes on whether to join Russia are being held in Kherson, Luhansk, Donetsk and Zaporizhzhia, four regions that make up about 15 percent of Ukraine's landmass.

While Kyiv and its Western allies dismiss the "sham" polls, Russian media are reporting high turnouts.

In rebel-held Luhansk, the voting rate was above 90 percent by early Tuesday, according to the Kremlin-backed RIA Novosti outlet.

Moscow insists voting is voluntary and the polls are fair, but the results will inevitably favour annexation

When Russia held a referendum in Crimea after seizing the peninsula in 2014, it declared that 97 percent of people had voted to ioin Russia.

But even traditional Russian allies such as Serbia and Kazakhstan have said they will not recognise the latest annexation votes.

The five-day exercise has been beset by irregularities, including reports of Russian troops taking ballot boxes door-to-door and coercing Ukrainians into voting.

"In no way, certainly according to the Ukrainians, are these votes legitimate or do they represent any



real kind of guide on what the people living in those occupied territories want," said Al Jazeera's Charles Stratford, reporting from Kyiv.

Kyiv has warned that Ukrainians who assist the votes and annexations will face treason charges and at least five years in jail.

'We have lists of names of people who have been involved in some way," presidential adviser Mikhailo Podolyak told Swiss newspaper Blick.

"We are talking about hundreds of collaborators. They will be prosecuted for treason. They face prison sentences of at least five years," he said.

However, Podolyak said, Ukrai-nians who were forced to vote would not be punished.

Faced with recent humiliating battlefield setbacks for his forces in Ukraine, President Vladimir Putin hopes the annexation ballot will boost Russia's performance in the war. As the votes were under way, the Kremlin cautioned Kyiv faces a devastating escalation of the conflict, all the way up to the use of its nuclear arsenal.

Dmitry Medvedev, deputy head of Russia's Security Council chaired by Putin, spelled out the threat in the bluntest terms yet on Tuesday.

"Let's imagine that Russia is forced to use the most powerful weapon against the Ukrainian regime that has committed a largescale act of aggression, which is dangerous for the very existence of our state," Medvedev wrote on his Telegram app channel. "I believe that NATO will steer clear from direct meddling in the conflict in that case.'

In A First, Supreme Court Live-Streams **Constitution Bench Proceedings**

New Delhi: In a first, the Supreme Court on Tuesday began livestreaming its constitution bench proceedings.

On September 27, 2018, the then Chief Justice of India Dipak Misra had delivered the landmark judgement on the live telecast or webcast of important proceedings in matters of constitutional importance, saying "sunlight is the best disinfectant".

The proceedings can be accessed at webcast.gov.in/scindia/, said an official. On Monday, a bench headed by Chief Justice Uday Umesh Lalit said the top court will soon have its own "platform" to livestream its proceedings instead of having to use the YouTube.

In a unanimous decision taken at a recent full court meeting headed by the CJI, the apex court decided



to live-stream proceedings of all constitution bench hearings from September 27, four years after the path-breaking announcement by Justice Misra.

The apex court may live-stream proceedings through YouTube and later host them on its server, sources had said. People will be able to access the proceedings on their cell

phones, laptops, and computers without any hassle.

On August 26, for the first time since its inception, the Supreme Court live-streamed proceedings of a bench headed by then Chief Justice (since retired) N V Ramana through a webcast portal. It was a ceremonial proceeding as Justice Ramana was to demit office that day.

Snowden Gets Russian Citizenship

President Vladimir Putin has granted Russian citizenship to US National Security Agency (NSA) whistleblower Edward Snowden, Russia's TASS news agency confirmed on Monday. The American's name was included without fanfare on a list of 72 foreigners who became citizens.

Snowden, who applied for citizenship in 2020 upon receiving permanent residency rights, has not commented on the decision as of Monday evening Moscow time. His wife will also apply for citizenship, according to his lawyer.

feverish social media speculation that Snowden might be drafted now that he was officially a Russian citizen of military age.

While the fact that Snowden has lived in Russia since fleeing the US in 2013 has been held up as "proof" he was undermining the US government on behalf of Moscow, he was marooned in Sheremetyevo Airport upon arriving from Hong Kong to catch a connecting flight to Cuba after the US canceled his passport midflight. King Charles' New Monogram Unveiled As Royal Mourning Ends In UK

London: The new monogram to be used by Charles as the UK's new monarch has been unveiled and used for the first time on Tuesday, as the royal family's mourning period for Queen Elizabeth II comes to an end.

King Charles III's new cypher is designed by the College of Arms and shows his initial - C - intertwined with the letter R for Rex, which is Latin for King, and III is marked within the letter R with the imperial crown above the letters.

The all-in-gold royal monogram will be added to various public offices, papers, and street furniture across the UK over the coming months and years, replacing the Queen's cypher E II R.

The Court Post Office at Buckingham Palace became the first to make a frank or stamp post using the new cypher.

"The post room at Buckingham Palace deals with around 200,000 items of mail each year, including invitations to events, responses to letters and cards received from members of the public and state business," the palace said.

The UK's College of Arms, founded in 1484, creates and maintains official registers of coats of arms and pedigrees. The new cypher design would be one of several options prepared by the College of Arms and then chosen by the King.

A Scottish version features the Scottish Crown and was approved by Lord Lyon King of Arms. The new monarch's monogram is intended for government buildings, state documents and some post boxes, with the decision to change the use of cyphers from the Queen to the King up to the discretion of individual organisations.

Acrimony At The UN

he speeches at the United Nations General Assembly by India and Pakistan leaders is a major annual event that attracts a lot of media and public attention in South Asia. One major point of interest is the lingering India-Pakistan animosity, largely driven by their long-standing fight over Jammu and Kashmir. Since revocation of Article 370 in August 2019, the speeches have assumed an even bigger news value. More so, in Kashmir, where people eagerly look forward to these speeches to see if there's anything in store for them.

Pakistan Prime Minister Shahbaz Sharif in his speech this year said that while Pakistan looks for peace with India, "sustainable peace and stability" in the region was contingent upon the resolution of the Kashmir issue. Sharif also alleged that India was seeking to turn the Muslim majority Jammu and Kashmir into a Hindu territory through "illegal demographic changes".

India in a hard-hitting reply said it was "regrettable" that he made false accusations against India. Indian diplomat, First Secretary Mijito Vinito, said during the 'Right of Reply' session that Sharif has made accusations against India "to obfuscate misdeeds in his own country and to justify actions against India that the world considers unacceptable." Vinito further said that a polity that claims it seeks peace with its neighbours would never sponsor cross border terrorism. nor would it shelter planners of the horrific Mumbai terrorist attack.

India always brings up terrorism sponsored from across the border and Pakistan makes counter accusations and also seeks to highlight the situation in Kashmir. This acrimonious exchange is a routine spectacle at the United Nations where the mutually antagonistic positions are ritualistically rehearsed at various meetings. Over the last three years, the positions on both sides have become even more rigid and bitter.

If anything, it also underlines the lingering estrangement between the neighbours that has further deepened since New Delhi's withdrawal of Article 370. Situation can be expected to improve if the leaders of the two countries deem it in their core interest to engage which doesn't seem the case now. This would need a huge leap of faith on both sides.

And if not then we can only hope that the current climate of distrust and antagonism doesn't lead to further escalation of tensions. More so, when due to suspended talks, the two countries lack the diplomatic tools to manage the fallout. It is therefore important that the two countries get back to the dialogue and work towards the resolution of their longstanding issues for durable peace in the region.

n 2015, the United Nations Educational Scientific and Cultural Organisation (UNESCO) declared 28 September as International Day for Universal Access to Information. Considering that several civil society organizations and government bodies in the world have adopted and currently celebrate this observance, the UN General Assembly also adopted 28 September 2019 as the International Day for Universal Access to Information. This year's theme is 'Artificial intelligence, e-governance and access to information'.

As recently highlighted by LG Sinha, e-governance in Kashmir is commendable especially in the context of the e-office project of J&K Government wherein more than 3 lakh files were digitized and work in the civil secretariat was made digital. The e-Office project of the Government is aimed at supporting governance by ushering in more effective and transparent inter and intragovernmental processes. This has transformed office work completely which has now become simplified, responsive, effective and above all, transparent.

While all this is applauseworthy, one cannot help but look at an integral part of the e-governance process that has damped the spirit of such changes. Accessing information online, under the RTI act 2005, is still difficult and with many roadblocks in the way.

On November 30th 2021, the then Information Technology Secretary Government of Jammu & Kashmir, Mr Amit Sharma, ing the facility to file RTI applications through a digital platform online). A Non-Governmental Organisation Pravasi Legal Cell, which works for legal empowerment of Non-Resident Indians (NRIs) and Indians working in foreign countries and has been doing advocacy to impress upon the state governments to allow filing of online RTI applications, had moved the PIL before the Supreme Court. Advocate Jose Abraham, the counsel of the NGO in the petition had described the RTI Act as a powerful tool but had said that its purpose is met only if applicants get information without delay and through the electronic mode.

or instance, under section 7 (1), the information related to life and liberty of a person is to be provided in 48 hrs instead of 30 days and that is only possible when the RTI application is received electronically and reply also provided in the same mode (online). However, when that service is not available to citizens in many states including Jammu & Kashmir, how can this legal provision be realised on ground?

This issue was raised by the NGO in its petition as well. The relevant para of the petition reads: "One of the most effective pro-

visions in the RTI Act is section 7(1) which states that 'information sought for concerns the life or liberty of a person, the same shall be provided within 48 hours of the receipt of the request' is not effective under the existing system and it severely affects the life and liberty of citizens" in bigger post offices. If a person from a remote village in Machil Kupwara wants to file an RTI application , he or she will have to travel all the way from Sogam or its surrounding village to Kupwara town to get the postal order. Is this citizen friendly?

Had online RTI service been available, as is the case in some states like Maharashtra, a resident of places like Machil, Teetwal or Padder in Kishtwar could have filed an application under RTI Act 2005 from a cell phone sitting in his own village.

This is so easy to do and most advisable, yet isn't being done here. RTI Act and Online Applications

There is a clear provision in the RTI Act 2005 that an applicant can seek information through a written application or electronically. The Section 6(1) of the RTI Act 2006 reads:

"A person, who desires to obtain any information under this Act, shall make a request in writing or through electronic means in English or Hindi in the official language of the area in which the application is being made, accompanying such fee as may be prescribed, to (a) the Central Public Information Officer or State Public Information Officer, as the case may be, of the concerned public authority."

When RTI Act 2005 says that applications can be accepted electronically (email etc) why are Govt offices reluctant to accept the applications under this mode or receive fees electronically?

elivering India's statement at the United Nations General Assembly (UNGA) this year, External Affairs Minister S. Jaishankar spoke of several challenges in India's past, present and future, with a special emphasis on the immediate "shocks" arising from the war in Ukraine, the COVID-19 pandemic, climate change, and terrorism. In stark contrast to the Pakistan Prime Minister Shehbaz Sharif, who made pejorative remarks about India, Mr. Jaishankar made no direct comment on Pakistan. Nor did he directly mention India's challenges at the Line of Actual Control, although he criticised China's habit of politicising and blocking UN Security Council terrorist designations. His comments on Ukraine were watched, as they came days after Prime Minister Narendra Modi was lauded by western countries for telling Russian President Vladimir Putin that the "era of war is over". Mr. Jaishankar expanded on Mr. Modi's theme without seeming to either criticise Russia or condone its actions: instead, he said, India stands on the side of peace, of respect for the UN charter, dialogue and diplomacy, and with all those now grappling with the "escalating costs of food, of fuel and fertilizers". His words were even-handed, and require global stakeholders to consider both the risks from the conflict in Ukraine, and from U.S.-EU led sanctions that could exacerbate global economic fragmentation and inflationary trends. The prognosis seems even bleaker, given that just prior to the UNGA, Mr. Putin delivered a speech committing to Russia's ability to use "all weapons", indicating nuclear options, while the Ukrainian President said no dialogue could bring an end to the war, calling instead for more weaponry and a global effort to "punish" Russia.

Above all, Mr. Jaishankar hailed what he called the "New India" under Mr. Modi, spelling out five pledges made at the 75th Independence day anniversary, which includes making India a developed nation by 2047. He added that India is ready to take on enhanced responsibility at the global body, and called for a reformed UN with an expanded Security Council, as a means at righting the "injustice" done to the global south. The year ahead, where India will host the G-20 summit, will, no doubt, test the will and the ability of the Modi government to play the role of global uniter, and what Mr. Jaishankar called a "bridge" between nations polarised by bitter divides. It is a goal which will only be achievable if New Delhi is able to play a similarly uniting role in its own neighbourhood, and bring polarising and divisive forces within India under control.

Is It Time For Your Flu Shot?

t this point in the COVID-19 pandemic, nearly everyone has experienced the panic and uncertainty that come with having mild COVID-like symptoms – such as a cough and sore throat – only to test negative day after day. With cold and flu season just around the corner, that state of frustrating uncertainty is likely to strike most of us again.

Both COVID-19 and the flu are contagious respiratory illnesses that have similar symptoms, making it difficult to distinguish between the two viral infections without a lab test. Testing is the only way to know which virus is causing your symptoms. In fact, labs are working to create one test that can detect both COVID-19 and the flu.

As a nursing professor with experience in public health promotion, I am often asked about the differences between the flu and COVID-19. This year I am fielding many questions about the timing of getting the new COVID-19 booster and the flu shot and whether they can be given together.

PARSING THE SYMPTOMS

Symptoms of both COVID-19 and the flu can range from mild – or no noticeable symptoms at all – to severe. While flu infection does not typically affect one's ability to taste or smell, loss of taste or smell has been a common symptom associated with COVID-19 infection. Both infections can cause fevers. chills, body aches and fatigue. More severe symptoms of either infection include difficulty breathing and subsequent infections like pneumonia.

During the 2021-2022 flu season, the term "flurona" made its way into the COVID-19 vernacular. Flurona refers to a simultaneous infection with both the flu and COVID-19. While only a few cases of co-infections have been reported, it would not be surprising to see more of them this coming flu season. Vaccination for both the flu and

COVID-19 is your best protection against both.

TIMING THE SHOTS

With the newly formulated CO-VID-19 booster shot now available and flu season just around the corner, a natural question is whether there is an optimal timing for the two shots.

The answer to that question is to get both as soon as possible. It is important to consider that it takes approximately two weeks after vaccination for the body to develop antibodies from both the COVID-19 vaccines and the flu vaccine.

As long as you have completed your primary COVID-19 vaccine series and it has been at least eight weeks since your last COVID-19 booster, now is the time to get the updated COVID-19 vaccine that targets both the original strain of SARS-CoV-2 – the virus that causes COVID-19 – and the most recent omicron subvariants. The original COVID-19 vaccines and booster series have dramatically reduced the number of COVID-19 infection and death rates, as well as cases of severe COVID-19 that lead to hospitalization.

While everyone 6 months of age and older are recommended to receive both the COVID-19 and flu vaccines, certain populations have a higher risk for severe infection, such as pregnant women, and should be extra vigilant about getting vaccinated.

Further, among those vaccinated against COVID-19, symptoms during an infection tend to be milder. However, due in part to the quickly evolving nature of the virus, it's become clear that immune protection from COVID-19 vaccination or infection does not last forever. While studies show that the primary COVID-19 series maintains efficacy against severe disease and death six months after vaccination, protection against infection decreases by between 20% to 30% by six months after vaccination.

This decline in immune protec-

tion is exactly why booster shots are so critical. Without a large uptake of booster shots in the population, COVID-19 infection rates could surge again.

A DIFFICULT FLU SEASON AHEAD

Due to lockdowns, reduced travel, school closures and mask mandates in the first and second years of the pandemic, both the 2020-2021 and 2021-2022 flu seasons were estimated to have fewer hospitalizations and deaths from the flu compared to many of the pre-pandemic years.

In the fall of 2021, experts became concerned about the potential for a COVID-19 and flu "twindemic," especially as COVID-19 restrictions were lifting and masks were coming off. Fortunately, the worst didn't bear out – flu numbers in the 2021-2022 season did not return to pre-pandemic levels. However, the possibility of a "twindemic" is not out of the picture for the coming flu season.

Flu seasons are inherently difficult to predict. With most people traveling again, schools open, mask mandates lifted and workers headed back to the office, people are undoubtedly going to be exposed to germs that they have been more protected from for the last two and a half years.

To further compound this, flu vaccine rates have been lower during the pandemic, suggesting that Americans may be out of the habit of getting their annual flu shot.

PAIRING THE SHOTS

Many are also wondering whether they can or should get both the

updated COVID-19 booster and the flu shot at the same time. The good news is, yes, it is safe for both adults and children 12 years of age and up who are eligible for the updated CO-VID-19 booster to get these vaccines simultaneously.

A recent study found that common vaccine side effects such as pain at the injection site occurred at slightly higher rates when someone received the flu vaccine and a COVID-19 vaccine at the same time, as opposed to receiving only a COVID-19 booster. However, those reactions, including fatigue and headache, were mild and resolved within a day or two.

You don't need to make two separate vaccine visits as long as you are due for your next COVID-19 shot. However, I don't recommend waiting to get your flu shot if you are not yet due for a COVID-19 booster. The Centers for Disease Control and Prevention suggests everyone receive their flu vaccine by the end of October. But if you miss that deadline, it is absolutely better to get vaccinated later in the season than not at all.

COMMUNITY MATTERS TOO

Getting the flu and COVID-19 vaccines isn't just about your own health, it's about family and community health too. Communities with higher vaccination rates have fewer opportunities to spread the virus.

Keep in mind that many people cannot be vaccinated because they have weakened immune systems or are undergoing treatments. They depend on those around them for protection. While one person may experience mild symptoms if they contract the flu or COVID-19, they could spread the virus to others who could become severely ill. Because it's impossible to predict how people will react if they get sick, getting the flu and COVID-19 vaccines is the best prevention strategy.

How To Stand Your Ground And Be Frugal With 'Sorry'

or the longest time now, my ambition has been to be remembered as a good human being when I am finally gone. In pursuit of this seemingly simple goal, I have acquired many habits and manners that have now become an intrinsic part of my quotidian dealings with people. It was probably towards this end that I infused the three magic words, 'Thank you', 'I am sorry' and 'Please' very early in my life, in the conviction that saying them automatically put me in the good books of people and made me a nice person in their eyes. At what point this practice became a flawed pattern, I don't know, but slowly I began to realise that I was overdoing it, especially the apology part, by adding the 'sorry' word as an appendage and a preamble to explain situations in my conversations and correspondences.

It was a stiff response from a friend who calls a spade a spade that knocked me back to my senses. 'Why are you sorry?' he once asked and I didn't know. Indeed, why? On another occasion, someone gave me an earful over something that had irked her and all I could do to defuse the situation was to apologise repeatedly, again without knowing why. Apparently, I had no idea what wrong I had done against her.

A couple of similar instances later, it began to occur to me that apologising was a positive trait, but when used beyond

wrongful accusation and undermined my self-esteem. It was time for me to review my apology policy for my own good, not because I had shifted my priority to be a nice person, but because it was robbing my confidence to confront people in a legitimate way. I suspected that it might even make people think less of me, if I indulged in saying 'sorry' where it wasn't even logically warranted.

Every time I feel an urge to change my habits that have been reigning for long, I first consider the reasons that makes me a slave to them. In this instance, I realized it was my absolute fear of antagonizing people that put me on the defensive. The last thing we want is to have our connections, which are already getting tenuous, to be snapped because of something we might have unwittingly said or done.

What I didn't comprehend was that instead of making me rise in the eyes of the other person, it actually gave them the power to treat me in a condescending way. I was shunning myself into an emotional corner by exposing my fear of offending them inadvertently. Subsequently, I also learned that this fear of offending people emerged from my habit of picking intentions and emotions in their words and actions, and therefore, to pre-empt any further flare-up, I used the sorry age to be our authentic selves. word profusely, sabotaging myself.

What do we lose if we apologise? Why let our ego play spoilsport in our relations? Nice people don't think twice bea limit and without plausible reason, it put me on the defen- fore saying 'sorry' because it reflects on their basic virtues

sive and exposed my vulnerability. It made me susceptible to and an appreciable level of humility. I slowly began to remove these sections from my charter of belief systems, convinced in the thought that my apologies have to be genuine and not just a casual utterance. If I am at fault, I must apologise and show remorse and even go an extra mile to make amends, but I must not say 'sorry' at the drop of the hat. I must not attach a 'sorry' when I turn down requests politely, because to say 'no' is my privilege. I must not say 'sorry' in the assumption that the other person might consider me aggressive and rude, when all I am doing is giving the right responses.

I must not take responsibility for things beyond my control and pretend that a certain eventuality was of my doing, unless I am certain about my conscious role in it. I shall not offer apologies anymore in anticipation of adverse reactions from the other side. It had already caused some serious dents to my social skills and I intended not to give it more clout.

Saying 'sorry' is a virtue when you know you are at fault. But to imagine that you are at fault at all times and making its utterance a superfluity can not only take away from its magic, but also reduce your brand value as a poised and positive person. Good people don't maintain relationships based on our capacity to yield, but based on our certitude and cour-

Life Expectancy Tool May Improve Quality Of Life For Dementia Patients

Mortality prediction model for dementia patients may aid clinicians in framing discussions with patients and families about end-of-life care options such as at-home care and nursing homes. Furthermore, the model may assist physicians in determining whether patients should continue with routine cancer screening or discontinue medications, such as insulin for Type 2 diabetes patients - interventions that may

cause more harm than good. Researchers led by UC San Francisco followed 4,267 participants with probable dementia who were not residents of nursing homes in their study, which was published in JAMA Internal Medicine on September 26, 2022, and found that 81% of them had died by the end of the follow-up period.

A prediction model was created based on a person's age, gender, BMI, chronic conditions, smoking status, and ability to walk several blocks and engage in vigorous activity. They also included the ability to perform daily living activities such as personal care, eating, and getting in and out of bed, as well as instrumental daily living activities such as meal preparation, grocery shopping, medication management, and money management. In approximately 75% of cases, the model correctly predicted who lived and who died over a 10-year period.

The participants, who were enrolled in the Health and Retirement Study, a nationally representative survey of adults over 50, had an average age of 82, 12% were Black, and 69% were female. A high accuracy algorithm determined their probable dementia diagnosis. The findings were validated in a separate group of people who took part in the National



Health and Aging Trends Study. Model May Prompt Conversa-

tions About Financial Resources, Treatment Preferences

According to the first author W. James Deardorff, MD, a geriatrician at UCSF and the San Francisco VA Health Care System, the prediction model can help guide discussions about what financial resources are required to support individuals with dementia.

"An estimate of an individual's prognosis can be an important factor in financial planning for families, especially as many people with dementia require increased support at home and are eventually admitted to nursing homes," he said, noting that previous studies have shown the average survival time from time of diagnosis to be between three and 12 years.

"Additionally, individuals with limited life expectancy may wish to focus on the quality of life and being comfortable, rather than trying to live as long as possible. This may lead them to forego certain interventions, such as cardiopulmonary resuscitation in the event of a cardiac arrest. Information about an individual's prognosis can help inform conversations about certain medical treatment preferences," he said.

Among the factors linked with mortality are older age, male sex, body mass index below 18.5, former or current smoking status, chronic diseases, difficulties walking several blocks, and performing activities of daily living and instrumental activities of daily living.

Colonoscopies, Insulin May No Longer Make Sense

"An estimate of an individual's prognosis can be an important factor in financial planning for families, especially because many people with dementia require increased support at home and are eventually admitted to nursing homes," he said, noting that previous studies have shown the average survival time from time of diagnosis to be between three and 12 years.

Patients with Type 2 diabetes may be advised to reduce or discontinue insulin, according to senior author Sei Lee, MD, UCSF professor of geriatrics and senior scholar for the San Francisco VA Quality Scholars fellowship. "Tight glycemic control in younger patients reduces the risk of vision loss and kidney failure 10 years later." However, in older patients, these benefits may not be realised, and the risks of low sugars caused by too much insulin can be severe."

In addition to the mortality prediction model, the researchers created an individualised mortality risk calculator for dementia patients, which is available online at ePrognosis.

Other mortality calculators and risk-versus-benefit cancer screening calculators are available, as are videos to help physicians talk with patients about life expectancy and treatment goals.

Stop Seeking Meaning And Purpose Via Smartphones: Researchers

Those seeking satisfaction and meaning from

their smartphones, it is time to shun this thinking. Researchers have found that those looking for meaning and purpose through their devices and social media could actually experience the opposite. Researchers at Baylor and

Campbell universities in the US found that smartphone attachment could "cause a breakdown in social values because of the unstructured and limitless options they provide for seeking meaning and purpose and inadvertently exacerbate feelings of despair while simultaneously promising to resolve them,"

"Seeking itself becomes the only meaningful activity, which is the basis of anomie and addiction," said Christopher M. Pieper, senior lecturer of sociology at Baylor University.

The results, published in the journal Sociological Perspectives, provide a sociological link to the psychological studies that point to connections between digital devices and media use with feelings of loneliness, depression, unhappiness, suicidal ideation and other poor mental health outcomes.

Lead author Justin J. Nelson, assistant professor of sociology at Campbell University and Pieper also found a connection between this search for meaning and feelings of attachment to one's smartphone - a possible precursor to tech addiction.

"Our research finds that meaning-seeking is associated with increased smartphone attachment -- a feeling that you would panic if your phone stopped working," Nelson said.

"Social media use is also correlated with increased feelings of attachment."

The research found that individuals seeking solace or connection through their phones in shorter spurts might exacerbate attachment.

"What we have uncovered is a social mechanism that draws us into smartphone use, and that might keep us hooked, exacerbating feelings of attachment and anomie, and even disconnection, while they promise the opposite," Pieper said.

Global Recession Ahead, Warns World **Trade Body Chief**

GENEVA: The World Trade Organization's chief said Tuesdav she believes the world is heading towards a global recession due to multiple colliding crises, and called for radical policies to revive growth.

WTO Director-General Ngozi Okonjo-Iweala said Russia's war in Ukraine, the climate crisis, food price and energy shocks plus the aftermath of the Covid-19 pandemic were creating the conditions for a world recession.

"Now we have to weather what looks like an oncoming recession," she told the opening of the global trade body's annual public forum in Geneva.

"I think a global recession. That's what I think we are edging into. But at the same time, we have to start thinking of the recovery. We have to restore growth."

She noted that the World Bank and the International Monetary Fund had both downgraded global growth forecasts, while indicators on trade numbers

were "not looking too good". Okonjo-Iweala added: "We have security shocks, we have climate shocks, we have energy shocks, we have food price shocks, and all of this hitting countries at the same time, so we cannot afford to do business as usual."

The former Nigerian finance and foreign minister said central banks were in a tight spot, with little choice over the course ahead.



"Central banks don't really have too much of a choice but to tighten and increase interest rates – but the repercussions on emerging markets and developing countries is quite severe, because they too are tightening an increase in interest rates," she said.

"But what happens in the de-veloped countries affects their debt burdens, affects what they have to pay to service debt, affects the flight of capital from their economies back into the developed countries.

"But right now, I think there's not much choice but for central banks to act because inflation really hits at the poor very badly." She stressed the need for central banks to determine whether inflation was being caused by strong demand or whether the rise in prices was linked to structural problems on the supply side. Okonjo-Iweala said her top concern was how to ensure food security, followed by access to

energy. "The spectre of not having enough food is one that worries me," she said. (AFP)

Rupee Rises 14 Paise To Close At 81.53 Against US Dollar

Mumbai- The rupee consolidated in a narrow range and settled 14 paise higher at 81.53 against the US dollar on Tuesday as the American currency retreated from its elevated levels. At the interbank forex market, the local unit opened at 81.45 against the greenback. It witnessed an intra-day high of 81.30 and a low of 81.64 during the session.

It finally ended at 81.53, up 14 paise from its previous close. This is the first gain after four consequent sessions of losses for the rupee, during which it lost 193 paise against the American dollar.

On Monday, the rupee plunged 58 paise to close at an all-time low of 81.67 against the dollar.

"Rupee consolidated in a narrow range after falling to fresh lows in Monday's session. There are some reports suggesting that India's inclusion into the key government bond index could get pushed back to next year," Gaurang Somaiya, Forex & Bullion Analyst, Motilal Oswal Financial Services, said. On the domestic front, the focus will be

on the RBI policy statement due on Friday. "Expectation is that the central bank could raise rates by 50 bps and maintain a hawkish stance. The pound plunged further after the Finance Minister sent the currency and its government bonds into freefall," Somaiya said.

Cong Issues Showcause Notices To 3 Gehlot Loyalists For Indiscipline; Sonia Ropes In Seniors To Resolve Crisis

New Delhi: The Congress on Tuesday night issued show-cause notices to three Ashok Gehlot loyalists - Rajasthan ministers Shanti Dhariwal and Mahesh Joshi, and Dharmendra Rathore - for their "grave indiscipline", as the party scampered to resolve the crisis that has cast a shadow on the party chief's election.

The party's disciplinary committee has asked the three to explain within 10 days why action should not be initiated against them after the observers for Rajasthan - Mallikarjun Kharge and Ajay Maken - in their report to party chief Sonia Gandhi charged them with "gross indiscipline" but did not seek any action against Chief Minister Ashok Gehlot.

The action came two days after 82 MLAs participated in a parallel meeting at Dhariwal's residence in Jaipur laying down conditions to the party and did not attend the official legislature party meeting convened for passing a resolu-tion authorising the Congress chief to appoint a successor to Gehlot, who was to contest the Congress presidential election.

The disciplinary panel's member secretary Tariq Anwar in his notice to Dhariwal, Joshi and Rathore, said Maken in his report to the party chief has reported 'grave indiscipline' on their part.

"Prima facie, the above charges are an act of grave indiscipline. Therefore, this show cause notice is being issued seeking your reply within 10 days as to why disciplinary action not be taken against you as per the provisions of the constitution of the Indian National Congress," the notice to all the three leaders said.

Anwar said Dhariwal has committed grave indiscipline by hosting a parallel MLAs meeting at his residence "pressuring them not to attend the official meeting".

He also accused Joshi, the chief whip in assembly of "grave indiscipline" on two counts - of boycotting the official CLP meeting and by participating and convening parallel meeting of the MLAs.

Anwar said Rathore, who is chairman of Rajasthan Tourism Corporation, Development "made all logistical arrangements and were behind the entire planning of the unofficial meeting of the MLAs, held parallel to the official Rajasthan CLP meeting" which is an act of "grave indiscipline".

With the Rajasthan episode posing a significant challenge before the party, Congress president Sonia Gandhi has initiated discussions with senior party leaders from across the country to resolve the crisis even as the fate of Gehlot who was considered frontrunner for the top party post remained uncertain. Several names have cropped up for the probable presidential candidate including Kharge, A K Antony, Kamal Nath, Digvijaya Singh, Ambika Soni and Pawan Kumar Bansal, though most of them ruled themselves out of the race.

The name of Gehlot for the top party post is, however, not completely ruled out yet, according to informed sources.

Among various senior leaders, Gandhi is learnt to have called Congress veterans A K Antony and Sushilkumar Shinde for consultations here. There is also a likelihood that fresh observers may be sent to Rajasthan and Shinde may be one of them. Gandhi is considering resolving the matter after consul-

tations with top party leaders who are keeping their fingers crossed on the situation. After the developments in Jaipur, sources said Gehlot has

reached out to Sonia Gandhi and is learnt to have explained his position, while his arch-rival Sachin Pilot rushed to Delhi ahead of any decision on Rajasthan.

New Delhi: Due to restrictions related to COVID-19 pandemic, the number of foreign tourist arrivals in India during 2021 decreased to 1.52 million, an over 44 per cent fall from the correspond-ing figures in 2020, according to

a report released by the Union Tourism Ministry on Tuesday. As per the report titled 'India Tourism Statistics 2022' released by Vice President Jagdeep Dhankhar on World Tourism Day at an event here, Taj Mahal in Agra was among the 10 most

popular centrally-protected ticketed monuments for domestic visitors in 2021-22, while Group of Monument at Mamallapuram in Tamil Nadu ranked on top among the 10 most popular centrally-protected ticketed monuments for domestic visitors for the same period.

India's ranking in the global Travel and Tourism Development Index (TTDI) was

54th in 2021, it said. Dhankhar also presented the main National Tourism Awards 2018-19 at Vigyan Bhawan here

during the event. The annual award ceremony took place after a gap of two years due to the Covid outbreak in India in early 2020. "Due to restriction related to COVID-19, the number of foreign tourist arrivals (FTAs) in India during 2021 decreased to 1.52 million as compared to 2.74 million in 2020, registering a negative growth of 44.5 per cent," the report said. The Vice President in his ad-

dress said the last two years were "very tough" due the pandemic and the tourism sector was impacted heavily.

But, in retrospect, one can say that India knows the way, and the country is "out of the difficult period", he said.

The 'India Tourism Statistics 2022' report also said while FTAs experienced a "negative growth rate" in 2021, non-resident Indians (NRIs) and international tourist arrivals (ITAs) experienced "positive growth". Arrivals of NRIs increased by 52.6 per cent from 2020 to 2021. In comparison to 2020, there was a 10.6 per cent increase in yearly international tourist ar-rivals in India in 2021, it added.

International tourism included both inbound and outbound tourism. Also, in 2021, the top 15 source markets for FTAs in India were the US, Bangladesh, the UK, Canada, Nepal, Afghanistan, Australia, Germany, Portugal, France, the Maldives, Sri Lanka, Russia, Iraq, and the Netherlands. In 2021, the top 15 nations accounted for approximately 80.9 per cent of total FTAs in India, the report stated.

Tourism continues to play an important role as a foreign exchange earner for the country, it said.

In 2021, foreign exchange earnings (FEE) from tourism were USD 8.797 billion as compared to USD 6.959 billion in 2020, registering a positive growth of 26.4 per cent, the report said.

In 2021, tourism grew steadily on a global scale despite the COVID-19 prohibition, it said. India received 677.63 million

domestic tourist visits in 2021, an increase of 11.05 percent from 610.22 million in 2020, the report said.

The two states with the most domestic tourists visiting are Tamil Nadu and Uttar Pradesh, with 140.65 million and 86.12 million, respectively. Maharashtra and Tamil Nadu have the highest numbers of foreign tourist visits, with 1.26 million and 1.23 million, respectively, the report said.

The Tourism Satellite Account (TSA), an accounting methodology used by the United Nations to quantify the goods and services related to tourism, is described in this publication, the ministry said.

Travel and tourism created 79.86 million (direct and indirect) jobs and 15.34 per cent of iobs in 2019 2020. In terms of GDP during 2019 2020, tourism contributed 5.19 percent (direct and indirect), the report said.

After the abrogation of Article 370, Kashmir-based contractual teachers were shown the door for a year.

"We were told that our service is no longer needed," Dr. Yousuf said. "But our Jammu colleagues attended their duties and got paid for the whole year."

After a year of hardship, the contractual lecturers were again hired in 2020 by the department. "Some of us were hoping that our services might be regularized after the pandemic," Yousuf said. "But we are still waiting for some miracle."

Back on 15 February 2021, Director Education in a verbal statement decided to take services from permanent staff on rotational basis.

"But in many Kashmir colleges," Yousuf said, "students are suffering as there is no permanent faculty available.

The disparity is not only confined to services, but also to salaries of these contractual teachers.

"After the abrogation of 370 and the formation of two successive Union Territories, the government should have fixed the basic salary for contractual lecturers as per the central law," Dr. Yousuf said.

"Ladakh fixed Rs. 57600 as a basic salary for contractual staff, however the I&K administration failed in doing so and kept giving excuses of insufficient funds. When Ladakh can have funds to provide basic salary, how come it is possible that J&K dosen't have funds?

Mehta, the spokesperson said, also stressed on putting in place the robust communication and information mechanism by Traffic Police so as to regulate HMVs traffic at critical points like Qazigund- Banihal, Banihal market, Sherbibi, Panthayal, Mehar etc.

"The traffic management authorities were asked to augment manpower requirements from all sources to regulate traffic in optimal manner, besides enforcing lane discipline in the critical stretches between Ramban and Banihal," he added.

For seasonal migration, the spokesperson said, Tribal Affairs Department and Deputy Commissioners were directed to ensure that no "Dera" is allowed to move on highway especially between Oazigund and Ramban and they are provided with suitable conveyance to carry their cattle and family members.

He said that the concerned DCs were asked to ensure that unattended cattle do not wander on the highway.

"In order to ensure hassle-free movement, it was decided that the down convoy of HMVs may be permitted from 11 A.M in the morning from Qazigund up till 9.00 P.M on alternate days," the spokesperson said.

"It was said that the Drivers should appropriately be made aware for not leaving their place of unloading and parking their vehicles anywhere on the highway," he added.

Moreover, the spokesperson said that the District Administration Ramban was instructed to ensure deployment of adequate manpower and traffic management team at Banihal market to ensure no roadside parking

"Further the NHAI was directed to follow timelines given during the last meeting for clearance of muck from CafteriaMorh and Mehar, blacktopping of potholed portion on NH between Banihal and Ramban, completion of T-5 Tunnel and widening of Ramsoo-Rampari-Sherbibi stretch of the road,' the spokesperson said.

He further said that the meeting also decided that suitable recommendations of joint study team of CBRI, Roorkee and IIT, Jammu be taken for measures to be undertaken for stabilizing Cafeteria-Mehar section of NH-44.

"It was said that the same be implemented by NHAI in a speedy manner so that the travel time on the highway gets reduced considerably," the spokesperson added.

Earlier on Tuesday the officials from IGP Traffic's office said, "After three continuous days of down HMV movement, all the stranded trucks at Qazigund were cleared yesterday."

They said as per the data collected by NHAI at the Qazigund toll plaza, since 1st September, 48,845 trucks including 30,786 apple laden trucks moved from Qazigund to other parts of the country via Jammu-Srinagar national highway.

"Because of the constraints of NH-44, which is a single lane for 12-14 stretches between Nashri and Banihal, the movement of HMVS happens on alternate days."

Further the movement of traffic on the NH is also subject to stoppage due to the frequent falling of "Shooting stones" at various locations like. Cafeteria More, Mahar, Sherbibi etc around Ramban town, officials said. "In particular, the Mahar passi, which became active on 18th July 2022, leads to the stoppage of the traffic several times during the day on account of shooting stones which makes it dangerous for traffic to pass."

THIRUVANANTHAPURAM: India will be looking to round off their T20 World Cup preparation with a marked improvement in their death bowling besides providing crucial game time to its untested players in the three-match series against South Africa, beginning here on Wednesday.

India skipper Rohit Sharma, expectedly, singled out death bowling as an area that requires improvement following the series win over Australia.

The hosts will be without two of their key bowlers, Hardik Pandya and Bhuvneshwar Kumar, who have been rested ahead of the ICC event next month.

Mohammad Shami, who is one of the World Cup reserves, is yet to recover from COVID-19 and will be missing the three games against the Proteas after being unavailable the rubber against Australia.

Harshal Patel did not have the best of times in his comeback series against Australia but he will be expected to get back to his best in the final three games before the World Cup.

Deepak Chahar, who is also on standby for the Word Cup, did not get a game in the previous series.



Arshdeep Singh will return to bolster the team's resources in the slog overs, making an effective combination alongside Jasprit Bumrah.

In the series decider against Australia, Yuzvendra Chahal showed what he can do if the ball is gripping and turning after looking flat in the first two games. As Rohit spoke about the importance of giving all the players game time ahead of the World Cup, R Ashwin could get a look in.

In the batting department, K L Rahul would like to make the most of these three games after missing out in the last two games against Australia.

With Virat Kohli and Rohit Sharma are looking in good touch, it is important that Rahul too is in full flow before the team travels to Australia.

Dinesh Karthik got to play all of eights balls against Australia and Rohit has already said the designated finisher in the squad needs more time in the middle.

World Cup bound Deepak Hooda will end up missing all the six games before the mega event as he has been ruled out of the South Africa T20s with a back injury.

Shreyas Iyer is expected to take Hooda's place in the squad.

Over the next week, India will be competing against a team they are yet to beat at home in a bilateral series. South Africa and India will face each other in a group game in Australia and though conditions are totally different here, both teams can pick out areas to target in the coming three games.

All eyes will also be on the young Tristian Stubbs who has made the World Cup squad on the back of his good show in franchise cricket.

World Chess Champion Carlsen Accuses Niemann Of Cheating

NEW DELHI: Chess World Champion Magnus Carlsen has accused fellow Grandmaster Hans Niemann of cheating "more and more" than what he has already admitted, saying that he will not play against any rival indulging in such wrongdoing.

Carlsen put out a statement late Monday night, a week after he withdrew against the American after just one move at the Iulius Baer Generation Cup.

Earlier, the 31-year-old Norwegian had quit the Sinquefield Cup in Saint Louis following his surprise defeat against Niemann.

"I believe that Niemann has cheated more and more recently- than he has publicly admitted," Carlsen wrote.

European champions Italy, who missed out on a place at the World Cup in Qatar, finished top on 11 points from six games, one point above second-placed Hungary who needed to avoid defeat to se-

cure a place in their first Nations League semi-finals. Raspadori took advantage of a mistake by the defence in the 27th minute to convert a re-

bound from the edge of the box. Midfielder Federico Dimarco made it 2-0 for the visitors in the 52nd minute when he blasted

Male-Female Character Ratio In Books 4:1, Says Study

epresentation of male characters in books is four times more than female ones, claims a new Al-aided study that examined more than 3,000 English-language works published from 1800 to 1950.

Researchers at the USC Viterbi School of Engineering used artificial intelligence to scan the books ranging from science fiction and adventure, to mystery and romance - across short stories, poetry and novels.

The study outlined several methods for defining female prevalence in literature. The researchers utilised named entity recognition, a prominent natural language processing method used to extract gender-specific characters.

"One of the ways we define this is through looking at how many female pronouns are in a book compared to male pronouns," said Mayank Kejriwal, a research lead at USC's Information Sciences Institute. The other technique is to quantify how many female characters are the main characters in it.

In the study, the differences between male and female characters prevalence were defined and measured using three robust measures of prevalence, on a corpus of copyright-expired literary



texts from the Project Gutenberg English-language corpus.

Using computationally replicable methodologies relying on modern natural language processing tools, it was found that female character prevalence is significantly lower than that of male character prevalence, although the difference declines (while still being significant) when controlling for the gender of the author. It was also found that male character ratios have not varied much over time in the sample.

Akarsh Nagaraj, co-author of the study, noted the importance of how their methods and the study's

findings imparted them with a greater understanding of biases in society and its implications. There was a 4:1 ratio of male versus female main characters,

the study found. There were also more negative terms used in connection to the female characters such as 'weak' and 'stupid' compared to 'strong' and 'power' for men.

team of scientists has completed the genome sequencing for pomegranate, known as a wonder fruit to many," ICAR-NRCP said in a statement. For the first time anywhere in India, the ICAR-NRCP team

has been able to identify all the bases of DNA material in perfect sequence. This led to unlocking of several genetic mysteries such as identifying particular genes responsible for sweetness, seed

softness or colour of the fruit, those responsible for disease and pest resistance, and those for the enlargement of the fruit size,
